## Arithmetic properties

## Algebraic series have almost integer coefficients

Theorem [Eisenstein, 1852], [Heine, 1853]
Any algebraic power series $f=\sum_{n \geq 0} a_{n} t^{n}$ in $\mathbb{Q}[[t]]$ is globally bounded:
there exists an integer $C>0$ such that $a_{n} C^{n}$ is an integer for all $n \geq 1$.
"A premature death prevented Eisenstein from presenting the proof of this important theorem"

## Algebraic series have almost integer coefficients

Theorem [Eisenstein, 1852], [Heine, 1853]
Any algebraic power series $f=\sum_{n \geq 0} a_{n} t^{n}$ in $\mathbb{Q}[[t]]$ is globally bounded: there exists an integer $C>0$ such that $a_{n} C^{n}$ is an integer for all $n \geq 1$.
$\triangleright$ In particular, denominators of $a_{n}$ 's admit only finitely many prime divisors
$\triangleright$ Proof idea: Furstenberg's theorem + "diagonals are globally bounded"
$\triangleright \sum t^{n} / n, \sum t^{n} /\left(n^{2}+1\right)$ and $\sum_{n} t^{n} / n!$ are transcendental
$\triangleright$ Research problems:

- Christol's conj. (1990): Is any D-finite glob. bounded series a diagonal?
- Concrete subproblem: is ${ }_{3} F_{2}\left(\begin{array}{ccc}\frac{1}{9} & \frac{4}{9} & \frac{5}{9} \\ \frac{1}{3} & 1 & 729 t) \text { a diagonal? } \\ & 1\end{array}\right.$


## Algebraic series have almost integer coefficients

Theorem [Eisenstein, 1852], [Heine, 1853]
Any algebraic power series $f=\sum_{n \geq 0} a_{n} t^{n}$ in $\mathbb{Q}[[t]]$ is globally bounded: there exists an integer $C>0$ such that $a_{n} C^{n}$ is an integer for all $n \geq 1$.
$\triangleright$ The smallest possible constant $C$ is called Eisenstein constant of $f$.
$\triangleright$ Best current bound [Dwork, van der Poorten 1992]

$$
C \leq 4.8\left(8 e^{-3} D^{4+2.74 \log D} e^{1.22 D}\right)^{D} \cdot H^{2 D-1}=e^{O\left(D^{2}\right)} \cdot H^{2 D-1}
$$

where $D$ is the degree of the (minpoly of) $f$, and $H$ the max of its coeffs.
$\triangleright$ Research problems:

- Is this bound (asymptotically) tight?
- Find a (fast) algorithm for computing C.

## The coefficient sequence of an algebraic series is $p$-automatic

Theorem [Christol, 1979], [Christol, Kamae, Mendès France, Rauzy, 1980] If $f=\sum_{n>0} a_{n} t^{n}$ in $\mathbb{Z}[[t]]$ is algebraic, then for any prime number $p$ the sequence $\left(a_{n} \bmod p\right)_{n \geq 0}$ is $p$-automatic, i.e., there exists a finite automaton with input the base- $p$ expansion of $n$ and output the value $a_{n} \bmod p$.
$\triangleright$ Converse is false:


A 5-automaton for the Apéry sequence $a_{n}=\sum_{k=0}^{n}\binom{n}{k}^{2}\binom{n+k}{k}^{2} \bmod 5$
$\triangleright$ E.g., $a_{40164320} \bmod 5=1$, since $40164320=(40240224240)_{5}$
$\triangleright$ More generally, $a_{n} \equiv 1 \bmod 5$ iff the base- 5 expansion of $n$ does not contain the digits 1 and 3 and if the number of 2's is a multiple of 4

$$
c_{0}(t) f(t)+c_{1}(t) f\left(t^{p}\right)+\cdots+c_{r}(t) f\left(t^{p^{r}}\right)=0, \quad \text { for some } c_{j} \in \mathbb{F}_{p}[t], c_{0} \neq 0
$$

(2) the coefficients sequence $\left(a_{n}\right)_{n \geq 0}$ is $p$-automatic;
(3) $f$ satisfies a Mahler equation

$$
c_{0}(t) f(t)+c_{1}(t) f\left(t^{p}\right)+\cdots+c_{r}(t) f\left(t^{p^{r}}\right)=0, \quad \text { for some } c_{j} \in \mathbb{F}_{p}[t], c_{0} \neq 0
$$

$\triangleright$ Useful in transcendence in conjunction with Cobham's Theorem [1969]: If a sequence on a finite set is both $a$-automatic and $b$-automatic, and if $\log a / \log b \notin \mathbb{Q}$, then the sequence is ultimately periodic.
$\triangleright$ [Allouche, 1995] The Thue-Morse series $T$ is algebraic over $\mathbb{F}_{q}(t)$ iff $q=2^{s}$
$\triangleright$ [Shallit, 1999] If a sequence $\left(a_{n}\right)$ only takes values 4 and 7 , and if $s_{2}(n)$ is the sum of the base- 2 digits of $n$, then $f=\sum_{n} 2^{s_{2}(n)} a_{n}^{n} t^{n}$ is transcendental.

## Fast computation of the $N$ th term modulo $p$

Problem: count 2-3-4 trees $\quad \longrightarrow \quad f_{n}=$ nb. of trees with $n$ internal nodes $\square$

$\triangleright \mathrm{GF}: f=\sum_{n} f_{n} t^{n}=1+3 t+27 t^{2}+333 t^{3}+4752 t^{4}+73764 t^{5}+\cdots$, root of $P(t, T)=T-1-t\left(T^{2}+T^{3}+T^{4}\right)$
$\triangleright$ Abel's theorem + linear recurrence $\Longrightarrow$ computation of $f_{N}$ in $O(N)$ ops.
$\triangleright$ Mahler equation $t+f(t)+\left(t^{2}+t+1\right) f\left(t^{2}\right)+t f\left(t^{4}\right)+t^{2} f\left(t^{8}\right)=0 \bmod 2$
$\triangleright f_{n} \bmod 2= \begin{cases}f_{(n-1) / 2} \bmod 2, & \text { if } n \equiv 3 \bmod 4 . \\ f_{(n-1) / 2}+f_{(n-1) / 4} \bmod 2, & \text { if } n \equiv 1 \bmod 4, \\ f_{n / 2}+f_{n / 2-1}+f_{(n-2) / 8} \bmod 2, & \text { if } n \equiv 2 \bmod 8, \\ f_{n / 2}+f_{n / 2-1} \bmod 2, & \text { else. }\end{cases}$
$\triangleright$ Computation of $f_{N}$ modulo 2 in $O(\log N)$ operations.

## Diagonals and Hadamard products modulo a prime

Just as in the midst of life there is death, so in the midst of algebraicity - at least over finite fields - there is transcendence.
[van der Poorten, 1991]
Theorem [Furstenberg, 1967], [Deligne, 1984] Modulo a prime number $p$ :

- The Hadamard product of algebraic series is algebraic
- The diagonal of a rational function of several variables is algebraic
- The diagonal of an algebraic function of several variables is algebraic

$$
\begin{aligned}
& \triangleright \operatorname{Diag}\left(\frac{1}{1-x-y-z}\right)=\sum_{n \geq 0} \frac{(3 n)!}{n!^{3}} t^{n}=\left(8 t^{3}+2 t^{2}+6 t+1\right)^{-\frac{1}{10}} \bmod 11 \\
& \triangleright \frac{1}{\sqrt{1-t}} \odot \frac{1}{\sqrt{1-t}}={ }_{2} F_{1}\left(\left.{ }^{\frac{1}{2}} 1^{\frac{1}{2}} \right\rvert\, t\right)=\left(t^{5}+3 t^{4}+t^{3}+t^{2}+3 t+1\right)^{-\frac{1}{10}} \bmod 11
\end{aligned}
$$



## The Grothendieck-Katz p-curvatures conjecture

Conjecture [Grothendieck, 1960's, unpublished; Katz, 1972]
Let $A \in \mathbb{Q}(t)^{r \times r}$. The following assertions are equivalent:

- The system (S) $y^{\prime}=A y$ has a full set of algebraic solutions
- For almost all prime numbers $p$, the system $\left(S_{p}\right)$ defined by reduction of $(\mathrm{S})$ modulo $p$ has a full set of algebraic solutions over $\mathbb{F}_{p}(t)$
- $A_{p}=0 \bmod p$ for almost all primes $p$, where $A_{p}=p$-curvature of (S):

$$
A_{0}=I_{r}, \quad \text { and } \quad A_{\ell+1}=A_{\ell}^{\prime}+A_{\ell} A \quad \text { for } \quad \ell \geq 0
$$

$\triangleright$ Proved by [Katz 1982] for Picard-Fuchs systems, but still widely open in the general case (even for $r=2$ )
$\triangleright$ For each $p$, the last condition can be checked algorithmically
$\triangleright$ [B., Caruso, Schost, 2015] Fast algorithms for the $p$-curvature

## A combinatorial application: Gessel's conjecture

- Gessel walks: walks in $\mathbb{N}^{2}$ using only steps in $\mathcal{S}=\{\nearrow, \swarrow, \leftarrow, \rightarrow\}$
- $g(i, j, n)=$ number of walks from $(0,0)$ to $(i, j)$ with $n$ steps in $\mathcal{S}$

Question: Nature of the generating function $G(x, y, t)=\sum_{i, j, n=0}^{\infty} g(i, j, n) x^{i} y^{j} t^{n} \in \mathbb{Q}[[x, y, t]]$


Theorem [B. \& Kauers 2010] $G(x, y, t)$ is an algebraic power series ${ }^{\dagger}$.
$\rightarrow$ Effective, computer-driven discovery and proof
$\longrightarrow$ Thursday
$\rightarrow$ Key step in discovery: $p$-curvature computation of two 11th order (guessed) differential operators for $G(x, 0, t)$, and $G(0, y, t)$
$\dagger$ Minimal polynomial $P(x, y, t, G(t ; x, y))=0$ has $>10^{11}$ terms; $\approx 30 \mathrm{~Gb}(!)$

## Algebraic and Gauss hypergeometric series

Theorem [Schwarz, 1873]
Let $a, b, c \in \mathbb{Q}$, s.t. $a, b, c-a, c-b \notin \mathbb{Z}$. Set $(\lambda, \mu, v)=(1-c, c-a-b, b-a)$. Up to permutations and sign changes of $\lambda, \mu, \nu$, and addition to $(\lambda, \mu, v)$ of $(\ell, m, n) \in \mathbb{Z}^{3}$ with $\ell+m+n$ even, a table gives all algebraic ${ }_{2} F_{1}\left(\begin{array}{cc}a & b \\ c & \end{array}\right) t$ 's.

$\triangleright$ Proof based on geometric arguments (sphere tilings by spherical triangles)
$\triangleright$ Basic case: ${ }_{2} F_{1}\left(\left.\begin{array}{cc}r & 1-r \\ \frac{1}{2}\end{array} \right\rvert\, t\right)=\frac{\cos ((1-2 r) \cdot \arcsin (\sqrt{t}))}{\sqrt{1-t}}, r \in \mathbb{Q}+$ sporadic cases

## Algebraic and Gauss hypergeometric series

Whatever the beauty of Schwarz's result, one must recognize that it is achieved through a long detour. [Kampé de Fériet, 1937]

Theorem [Landau, 1904], [Stridsberg, 1911], [Landau, 1911], [Errera, 1913]
Assume $a, b, c \in \mathbb{Q}$ such that $a, b, c-a, c-b \notin \mathbb{Z}$. Then ${ }_{2} F_{1}\left(\begin{array}{cc}a & b \\ c & \mid\end{array}\right)$ is algebraic if and only if for every $r$ coprime with the denominators of $a, b$ and $c$, either $\{r a\} \leq\{r c\}<\{r b\}$ or $\{r b\} \leq\{r c\}<\{r a\} . \quad(\{x\} \stackrel{\text { def }}{=} x-\lfloor x\rfloor)$
$\triangleright$ Proof based on Eisenstein's theorem.
$\triangleright \frac{{ }_{2} F_{1}\left(\left.-\frac{1}{2}{ }_{\frac{2}{3}}-\frac{1}{6} \right\rvert\, 16 t\right)-1}{2 t}=1+2 t+11 t^{2}+85 t^{3}+782 t^{4}+\cdots$ is algebraic $\triangleright_{2} F_{1}\left(\left.\begin{array}{l}\frac{1}{12} \\ \\ 1\end{array} \frac{5}{12} \right\rvert\, 1728 t\right)=1+60 t+39780 t^{2}+38454000 t^{3}+\cdots$ not algebraic

## Algebraic and generalized hypergeometric series

Theorem [Beukers, Heckman, 1989]
Let $\left\{a_{1}, \ldots, a_{k}\right\}$ and $\left\{b_{1}, \ldots, b_{k-1}, b_{k}=1\right\}$ be two sets of rational parameters, assumed disjoint modulo $\mathbb{Z}$. Let $D$ be their common denominator. Then
${ }_{k} F_{k-1}\left(\left.\begin{array}{cccc}a_{1} & a_{2} & \cdots & a_{k} \\ b_{1} & \cdots & b_{k-1}\end{array} \right\rvert\, t\right)$ is algebraic iff $\left\{e^{\left.2 i \pi r a_{j}, j \leq k\right\}}\right.$ and $\left\{e^{2 i \pi r b_{j}}, j<k\right\}$
interlace on the unit circle for all $1 \leq r<D$ with $\operatorname{gcd}(r, D)=1$.

$\triangleright \sum_{n} \frac{(30 n)!n!}{(15 n)!(10 n)!(6 n)!} t^{n}={ }_{8} F_{7}\left(\left.\begin{array}{c}\frac{1}{30} \frac{71}{30} \frac{11}{30} \frac{17}{30} \frac{19}{30} \frac{23}{39} \frac{1}{30} \\ 5 \frac{1}{3} \frac{2}{2} \frac{1}{2} \frac{2}{5} \frac{2}{3} \frac{4}{50}\end{array} \right\rvert\, 2^{14} 3^{9} 5^{5} t\right)$ is algebraic

## Ratios of factorials

Theorem [Rodriguez-Villegas, 2005]
Let $\left(\gamma_{\kappa}\right)_{\kappa \geq 0}$ an integer sequence with finitely many non-zero terms. Let

$$
a_{n}=\prod_{\kappa \geq 1}(\kappa n)!^{\gamma_{\kappa}}, \quad f=\sum_{n} a_{n} t^{n} \in \mathbb{Q}[[t]] .
$$

Then $f$ is algebraic if and only if $f \in \mathbb{Z}[[t]]$ and $\sum_{\kappa} \kappa \gamma_{\kappa}=0$ and $\sum_{\kappa} \gamma_{\kappa}=-1$.
$\triangleright$ If $\operatorname{gcd}(a, b)=1$, then $f=\sum_{n} \frac{(a n+b n)!}{(a n)!(b n)!} t^{n} \quad$ is algebraic of degree $\binom{a+b}{a}$.
$\triangleright f=\sum_{n} \frac{(2 n)!(5 n)!^{2}}{(3 n)!^{4}} t^{n}$ is transcendental.
$\triangleright f=\sum_{n} \frac{(30 n)!n!}{(15 n)!(10 n)!(6 n)!} t^{n} \quad$ is algebraic of degree $483,840(!)$
$\triangleright$ Bonus [Bober, 2009]: classification of integral ratios of factorial products

## Algebraic series with $p$-Lucas coefficients

A sequence $\left(a_{n}\right)_{n}$ of rational numbers is called $p$-Lucas ( $p$ prime number) if

- all the denominators of the $a_{n}$ 's are prime to $p$;
- $a_{p i+j} \equiv a_{i} a_{j} \bmod p$ for all $i \geq 0$ and $0 \leq j<p$.

Theorem [Allouche, Gouyou-Beauchamps, Skordev, 1998]
For $f=\sum_{n} a_{n} t^{n}$ in $\mathbb{Q}[[t]] \backslash\{0\}$, the following conditions are equivalent:
(1) $f$ is algebraic and $\left(a_{n}\right)$ has the $p$-Lucas property for all large primes $p$;
(2) There exists $P \in \mathbb{Q}[t]$ of degree at most 2 , with $P(0)=1$ and $f=\frac{1}{\sqrt{P(t)}}$;
(3) Either $\left(a_{n}\right)=\binom{2 n}{n} a^{n}$, or $a_{n}=P_{n}(a) b^{n}$ with $a b, b^{2} \in \mathbb{Q}, P_{n}=\frac{1}{2^{n} n!} \frac{\partial^{n}\left(t^{2}-1\right)^{n}}{\partial t^{n}}$.
$\triangleright$ Starting point: if $\left(a_{n}\right)_{n}$ is $p$-Lucas, then $f=\sum_{n} a_{n} t^{n}$ is algebraic over $\mathbb{F}_{p}(t)$ :

$$
f=\left(a_{0}+\cdots+a_{p-1} t^{p-1}\right) \times f^{p} .
$$

## Algebraic series with $p$-Lucas coefficients

Theorem [Allouche, Gouyou-Beauchamps, Skordev, 1998]
For $f=\sum_{n} a_{n} t^{n}$ in $\mathbb{Q}[[t]] \backslash\{0\}$, the following conditions are equivalent:
(1) $f$ is algebraic and $\left(a_{n}\right)$ has the $p$-Lucas property for all large primes $p$;
(2) There exists $P \in \mathbb{Q}[t]$ of degree at most 2 , with $P(0)=1$ and $f=\frac{1}{\sqrt{P(t)}}$;
(3) Either $\left(a_{n}\right)=\binom{2 n}{n} a^{n}$, or $a_{n}=P_{n}(a) b^{n}$ with $a b, b^{2} \in \mathbb{Q}, P_{n}=\frac{1}{2^{n} n!} \frac{\partial^{n}\left(t^{2}-1\right)^{n}}{\partial t^{n}}$.
$\triangleright$ Corollary: if $a_{n}=\sum_{k=0}^{n}\binom{n}{k}^{2}\binom{n+k}{k}^{2}$, then $f=\sum_{n} a_{n} t^{n}$ is transcendental
$\triangleright$ Corollary: if $r_{1}, \ldots, r_{m}$ are positive integers, then

$$
f=\sum_{n \geq 0}\binom{2 n}{n}^{r_{1}}\binom{3 n}{n}^{r_{2}} \cdots\binom{(m+1) n}{n}^{r_{m}} t^{n}
$$

is algebraic if and only if $m=1$ and $r_{1}=1$.

## Analytic properties

Es ist eine Tatsache, daß die genauere Kenntnis des Verhaltens einer analytischen Funktion in der Nähe ihrer singulären Stellen eine Quelle von arithmetischen Sätzen ist.

It is a fact that the exact knowledge of the behavior of an analytic function near their singular points is a source of arithmetic theorems.
[Hecke, 1923]

## Gap theorems for lacunary series

Roughly: "lacunary series" = series in which groups of arbitrarily many successive zero coefficients occur infinitely often

Theorem [Hadamard, 1892], [Fabry, 1896], [Faber, 1906]
Let $\left(\lambda_{n}\right)_{n}$ be an increasing sequence of natural numbers. If $\lambda_{n} / n \rightarrow \infty$, then any power series $f=\sum_{n \geq 0} a_{n} t^{\lambda_{n}}$ in $\mathbb{C}[[t]]$ with finite positive convergence radius admits the convergence circle as a natural boundary.
$\triangleright$ Bonus [Pólya, 1939]: the converse is also true, so the result is optimal
$\triangleright \sum_{n} t^{2^{n}}$ is transcendental
$\triangleright \sum_{n}{ }^{n!}$ is transcendental
$\triangleright$ the theta series $\sum_{n} t^{n^{2}}$ is transcendental
$\triangleright \sum_{n} t^{p_{n}}$ is transcendental, where $p_{n}$ is the $n$th prime number

## Algebraic series have small gaps

Theorem
Assume $\sum_{n \geq 0} a_{n} t^{\lambda_{n}} \in \mathbb{Q}[[t]]$ is algebraic, where $\left(\lambda_{n}\right)_{n}$ is an increasing sequence of integers. There is a $C>0$ such that $\lambda_{n+1}-\lambda_{n} \leq C$ for $n \geq 1$.
$\triangleright$ Same conclusion holds for any D-finite function
$\triangleright$ Arithmetic proof: consequence of rational approximation results
$\triangleright$ Analytic proof: consequence of Fabry's theorem
$\triangleright$ Algebraic proof: exploits linear recurrence on coefficients
$\triangleright$ Research problem: find tight bounds C (e.g., [Dutter, 2015])

## Bonus: puzzling gap conjectures

Rigidity Conjecture [Furter, 2015]
Let $f=t\left(1+a_{1} t+\cdots+a_{d} t^{m}\right) \in \mathbb{Q}[t]$. If $m$ consecutive coefficients of its compositional inverse $f^{[-1]} \in \mathbb{Q}[[t]]$ vanish, then $f=t$.
$\triangleright$ Only proved for $m=1$ and $m=2$.

Gap conjecture [B., 2015] Let $f(t)$ in $\mathbb{Q}[[t]] \backslash \mathbb{Q}(t)$ be algebraic, with minimal polynomial $P(t, T) \in \mathbb{Q}[t, T]$. Then $f$ admits at most $\operatorname{deg}_{t} P\left(\operatorname{deg}_{T} P-1\right)-1$ zero consecutive coefficients. Equality for $P=T^{D}-T+t^{d}, f=t^{d}+t^{d D}+\cdots$.

## Asymptotics

Theorem [Flajolet, 1987]
If $f(t)=\sum_{n} a_{n} t^{n} \in \mathbb{Q}[[t]]$ is algebraic, then $a_{n}$ has an asymptotic equivalent

$$
a_{n}=\frac{\rho^{n} n^{\alpha}}{\Gamma(\alpha+1)} \cdot \sum_{i=0}^{m} C_{i} \omega_{i}^{n}+O\left(\rho^{n} n^{\beta}\right),
$$

where $\alpha \in \mathbb{Q} \backslash\{-1,-2,-3, \ldots\} ; \quad \beta<\alpha ; \quad \rho \in \overline{\mathbb{Q}}_{>0} ; \quad C_{i}, \omega_{i} \in \overline{\mathbb{Q}}$ and $\left|\omega_{i}\right|=1$
Proof ingredients: Newton-Puiseux; transfer based on Cauchy's formula (from local behaviour at singularities to asymptotics of coefficients); and

$$
\left[t^{n}\right](1-t)^{d}=\binom{n+d-1}{d-1} \sim \frac{n^{d-1}}{\Gamma(d)} \quad \text { (Stirling) }
$$

Corollary If $a_{n} \sim \gamma \rho^{n} n^{\alpha}$ and either
(i) $\alpha \in \mathbb{Z}_{<0}$;
(ii) $\alpha \notin \mathrm{Q}$;
(iii) $\rho \notin \overline{\mathrm{Q}}$;
(iv) $\gamma \cdot \Gamma(\alpha+1) \notin \overline{\mathbb{Q}}$
then $f$ is transcendental.

## Asymptotics

$\triangleright \sum_{n} a_{n} t^{n}=\operatorname{Diag}\left(\frac{1}{1-x-y-z}\right)$ is transcendental: $a_{n}=\frac{(3 n)!}{n!!^{3}} \sim 3^{3 n} \frac{\sqrt{3}}{2 \pi n}$
$\triangleright$ GF of partitions $\sum_{n=0}^{\infty} p(n) t^{n}$ is transcendental: $p(n) \sim \frac{1}{4 n \sqrt{3}} \exp \left(\pi \sqrt{\frac{2 n}{3}}\right)$
$\triangleright f=\sum_{n} p_{n} t^{n}$ is transcendental by the prime number theorem $p_{n} \sim n \log n$.
$\triangleright$ The Apéry series $\sum a_{n} t^{n}$ with $a_{n}=\sum_{k=0}^{n}\binom{n}{k}^{2}\binom{n+k}{k}^{2}$ is transcendental, since

$$
a_{n} \sim \frac{(1+\sqrt{2})^{4 n+2}}{2^{9 / 4} \pi^{3 / 2} n^{3 / 2}}, \quad \text { and } \quad \frac{\Gamma(-1 / 2)}{\pi^{3 / 2}}=-\frac{2}{\pi} \quad \text { is transcendental }
$$

$\triangleright$ If $a_{0}=0, a_{1}=1,(2 n+1) a_{n+2}-(7 n+11) a_{n+1}+(2 n+1) a_{n}=0$, then $f=\sum_{n} a_{n} t^{n}$ is transcendental, since $a_{n} \sim C\left(\frac{7+\sqrt{33}}{4}\right)^{n} n^{\sqrt{75 / 44}}$ with $C \approx 0.56$.

# More Criteria: rational-transcendental dichotomies 

## Classifications of algebraic series

- Algebraic series with algebraic Hadamard inverse are rational
- Algebraic series with bounded integer coefficients are rational
- Algebraic series that satisfy Mahler equations are rational
- Algebraic series with coefficients in a finite set are rational
- Algebraic series with multiplicative coefficients are rational


## Resulting transcendence criteria

Let $f \in \mathbb{Q}[[t]]$ be an irrational power series.

- If $f$ has algebraic Hadamard inverse
- If $f$ has bounded integer coefficients
- If $f$ satisfies a Mahler equation
- If $f$ has coefficients in a finite set
- If $f$ has multiplicative coefficients

$$
\text { then } f \text { is transcendental }
$$

## Algebraic series that satisfy Mahler equations

Theorem [Nishioka, 1996]
Assume $f \in \mathbb{Q}[[t]]$ satisfies a $k$-Mahler equation $(k \geq 2)$

$$
c_{0}(t) f(t)+c_{1}(t) f\left(t^{k}\right)+\cdots+c_{r}(t) f\left(t^{k^{r}}\right)=0
$$

where $c_{i}(t) \in \mathbb{Q}[t]$ with $c_{0} c_{r} \neq 0$. Then $f$ is either transcendental, or rational.
$\triangleright$ Thue-Morse series $T$ is transcendental:

$$
\begin{array}{r}
T(t)=(1-t) T\left(t^{2}\right) \\
B(t)=t B\left(t^{2}\right)+B\left(t^{4}\right)
\end{array}
$$

$\triangleright$ Baum-Sweet series $B$ is transcendental:
$\triangleright$ Rudin-Shapiro series $R$ is transcendental:

$$
\begin{array}{r}
R(t)=(1-t) R\left(t^{2}\right)+2 t R\left(t^{4}\right) \\
t S(t)=\left(t^{2}+t+1\right) S\left(t^{2}\right)
\end{array}
$$

$\triangleright$ Stern series $S$ is transcendental:
$\triangleright$ Bonus: "transcendental" can be replaced by "non-D-finite" [Bézivin, 1994], and even by admits the unit circle as a natural boundary [Randé, 1992]
$\triangleright$ Bonus: algorithms for existence of rational solutions [Bell, Coons, 2015]

## Power series with (polynomially) bounded integer coefficients

Theorem [Borel, 1894], [Fatou, 1904]
Any $f=\sum_{n} f_{n} t^{n} \in \mathbb{Z}[[t]]$ with $f_{n}=O\left(n^{d}\right)$ for some $d \geq 0$ is
(1) either transcendental;
(2) or rational, of the form $P(t) /\left(1-t^{m}\right)^{n}$, with $P(t) \in \mathbb{Z}[t]$ and $m, n \in \mathbb{N}$.

Alternative form: Convergence radius of algebraic series in $\mathbb{Z}[[t]]$ is $\leq 1$; equality holds only for rational functions whose poles are all roots of unity.
$\triangleright$ The constant 1 is the best possible: for any $r<1$, there exists a power series $A_{r} \in \mathbb{Z}[[t]]$ algebraic irrational with convergence radius $r$.

$$
\frac{1}{\sqrt{1-4 t^{\ell}}}=\sum_{n}\binom{2 n}{n} t^{\ell n}
$$

$\triangleright$ Bonus [Pólya, 1916], [Carlson, 1916]: one can replace "is transcendental" in the conclusion by "is non-D-finite", and even by "admits the unit circle as a natural boundary" (i.e. "has no analytic continuation beyond the unit disc").

## Power series with coefficients in a finite set

Theorem [Carlson, 1918], [Szegö, 1922]
A power series $f \in \mathbb{Q}[[t]$ with only finitely many distinct coefficients is:
(1) either transcendental;
(2) or rational, of the form $P(t) /\left(1-t^{m}\right)$, with $P(t) \in \mathbb{Q}[t]$ and $m \in \mathbb{N}$.
$\triangleright$ One can replace "is transcendental" in the conclusion of the Carlson-Szegö theorem by "is non-D-finite", and even by "admits the unit circle as a natural boundary" (i.e. "has no analytic continuation beyond the unit disc").
$\triangleright$ Recent extension [Bell, Chen, 2016]: a multivariate D-finite power series with coefficients from a finite set is rational.

## Power series with multiplicative coefficients

Theorem [Sárközy, 1978], [Bézivin, 1995], [Bell, Bruin, Coons, 2012]
A series with multiplicative coefficients is either transcendental or rational: Let $a: \mathbb{N} \rightarrow \mathbf{Q}$ satisfy $a(m n)=a(m) a(n)$ for all coprime $m, n \in \mathbb{N} \backslash\{0\}$. If $F=\sum_{n} a(n) t^{n}$ is algebraic, then either $f$ is a polynomial, or there exist $k \in \mathbb{N}$ and a periodic multiplicative $\chi: \mathbb{N} \rightarrow \mathbf{Q}$ such that $a(n)=n^{k} \chi(n)$.
$\triangleright$ Holds over any field of characteristic zero.
$\triangleright$ Holds if "transcendental" is replaced by "non-D-finite".
$\triangleright$ Via [Banks, Luca, Shparlinski, 2005], proves transcendence of $\sum a(n) t^{n}$ for: $a \in\left\{\varphi\right.$ (Euler totient), $\mu$ (Möbius), $\lambda$ (Liouville), $\sigma_{k}$ (divisors power sum) $\}$.
$\triangleright$ Ramanujan's modular discriminant is transcendental.

## Bonus: Apéry-like sequences

Research problem: characterize all D-finite power series whose coefficient sequence has the $p$-Lucas property for "many" primes $p$.
$\triangleright$ For "generic" $a, b, c \in \mathbb{Z}$, the Apery-like differential equations (in $\theta=t \frac{d}{d t}$ )
$\theta^{2}-t\left(a \theta^{2}+a \theta+b\right)+c t^{2}(\theta+1)^{2}, \quad \theta^{3}-t(2 \theta+1)\left(\hat{a}^{2} \theta^{2}+\hat{a} \theta+\hat{b}\right)+\hat{c} t^{2}(\theta+1)^{3}$
do not admit any power series solution $\sum_{n} A_{n} t^{n}$ with integer coefficients.
$\triangleright$ Exceptions: sporadic binomial sums [Beukers, Zagier; Almkvist, Zudilin]
(a) $a=7, b=2, c=-8, \quad A_{n}=\sum_{k}\binom{n}{k}^{3}$;
(8) $\hat{a}=7, \hat{b}=3, \hat{c}=81$,
$A_{n}=\sum_{k}(-1)^{k 3^{n-3 k}}\binom{n}{3 k}\binom{n+k}{n} \frac{(3 k)!}{k!]^{3}} ;$
(b) $a=11, b=3, c=-1, \quad A_{n}=\sum_{k}\binom{n}{k}^{2}\binom{n+k}{n}$;
( 7 ) $\hat{a}=11, \hat{b}=5, \hat{c}=125$,
$A_{n}=\sum_{k}(-1)^{k}\binom{n}{k}^{3}\left(\binom{4 n-5 k-1}{3 n}+\binom{4 n-5 k}{3 n}\right) ;$
(c) $a=10, b=3, c=9, \quad A_{n}=\sum_{k}\binom{n}{k}^{2}\binom{2 k}{k}$;
(a) $\hat{a}=10, \hat{b}=4, \hat{c}=64, \quad A_{n}=\sum_{k}\binom{n}{k}^{2}\binom{2 k}{k}\binom{2 n-2 k}{n-k} ;$
(d) $a=12, b=4, c=32$,
$A_{n}=\sum_{k}\binom{n}{k}\binom{2 k}{k}\binom{2 n-2 k}{n-k}$;
( $\epsilon$ ) $\hat{a}=12, \hat{b}=4, \hat{c}=16, \quad A_{n}=\sum_{k}\binom{n}{k}^{2}\binom{2 k}{n}^{2} ;$
(f) $a=9, b=3, c=27, \quad A_{n}=\sum_{k}(-1)^{k 3^{n-3 k}}\binom{n}{3 k} \frac{(3 k)!}{k!]^{\prime}}$;
(与) $\hat{a}=9, \hat{b}=3, \hat{c}=-27$,
$A_{n}=\sum_{k, l}\binom{n}{k}^{2}\binom{n}{l}\binom{k}{l}\binom{k+l}{n} ;$
(g) $a=17, b=6, c=72$,
$A_{n}=\sum_{k, l}(-1)^{k} 8^{n-k}\binom{n}{k}\binom{k}{l}^{3}$.
(ү) $\hat{a}=17, \hat{b}=5, \hat{c}=1$,
$A_{n}=\sum_{k}\binom{n}{k}^{2}\binom{n+k}{n}^{2}$.

Theorem [Malik, Straub, 2015] All these 12 sequences are $p$-Lucas.
"Certain differential equations look better than others, at least arithmetically"

## Bonus: Constant-term sequences

Theorem [Samol, van Straten, 2009] Let $\Lambda\left(x_{1}, \ldots, x_{d}\right) \in \mathbb{Q}\left[x_{1}^{ \pm 1}, \ldots, x_{d}^{ \pm 1}\right]$ such that the Newton polyhedron of $\Lambda$ has the origin as its only interior integral point. Then the constant-term sequence

$$
a_{n}=\left[x_{1}^{0} \cdots x_{d}^{0}\right] \Lambda^{n}
$$

is $p$-Lucas for any prime $p$.

- $\sum_{n}\binom{n}{k}^{2}\binom{n+k}{k}$ for $\Lambda=\frac{(y+1)(x+1)(x+y+1)}{x y}=3+x+y+2\left(\frac{1}{x}+\frac{1}{y}\right)+\frac{x}{y}+\frac{y}{x}+\frac{1}{x y}$
- $\sum_{n}\binom{n}{k}^{2}\binom{n+k}{k}^{2}$ for $\Lambda=\frac{(x+y)(z+1)(x+y+z)(y+z+1)}{x y}$


## Bonus: Diagonal sequences

Theorem [Rowland, Yassawi, 2015] If $P\left(x_{1}, \ldots, x_{d}\right) \in \mathbb{Q}\left[x_{1}, \ldots, x_{d}\right]$ has degree at most 1 in each $x_{i}$, and $P(0, \ldots, 0)=0$, then the diagonal sequence

$$
a_{n}=\left[x_{1}^{n} \cdots x_{d}^{n}\right] \frac{1}{P}
$$

is $p$-Lucas for any prime $p$.

- $\sum_{n}\binom{n}{k}^{2}\binom{n+k}{k}$ is the diagonal sequence of $\frac{1}{(1-x-y)(1-z)-x y z}$
- $\sum_{n}\binom{n}{k}^{2}\binom{n+k}{k}^{2}$ is the diagonal sequence of $\frac{1}{(1-x-y)(1-z-t)-x y z t}$
- $\sum_{n}\binom{n}{k}^{d}$ is the diag. seq. of $\frac{1}{\left(1-x_{1}\right)\left(1-x_{2}\right) \cdots\left(1-x_{d}\right)-x_{1} x_{2} \cdots x_{d}}$
- $\sum_{n}\binom{n}{k}^{2}\binom{2 k}{n}^{2}$ is the diagonal sequence of $\frac{1}{1-e_{1}+2 e_{3}+4 e_{4}}$,
where $e_{j}$ is the $j$-th elementary symmetric function in $x_{1}, x_{2}, x_{3}, x_{4}$
- $\sum_{n}\binom{n}{k}^{2}\binom{n+k}{k}^{3}$ is the diag. seq. of $\frac{1}{1-(x y z+x y+x z+y z+z)(u v+u+v)}$
- $\sum_{n}\binom{n}{k}^{3}\binom{n+k}{k}^{2}$ diag. seq. of $\frac{1}{1-(x y z+x y+x z+y z+y+z)(u v+u+v)}$
