# Consecutive ones matrices for multi-dimensional orthogonal packing problems *

#### Abstract

The multi-dimensional orthogonal packing problem (OPP) is a well studied decisional problem. Given a set of items with rectangular shapes, the problem is to decide whether there is a non-overlapping packing of these items in a rectangular bin. The rotation of items is not allowed. A powerful caracterization of packing configurations by means of interval graphs was recently introduced. In this paper, we propose a new algorithm using consecutive ones matrices as data structure. This new algorithm is then used to solve the two-dimensional orthogonal knapsack problem. Computational results are reported, which show its effectiveness.


Keywords orthogonal packing problem • interval graph • consecutive ones matrices

## 1 Introduction

The two-dimensional orthogonal packing problem (2d-OPP) is a well studied NP-hard optimization problem [16, 21, 27]. Given a set of items $\mathscr{I}$ with rectangular shapes (each item $i \in \mathscr{I}$ has a width $w_{i}$ and an height $h_{i}$ ), the problem is to decide whether the set of items is feasible, that is whether there is a non-overlapping packing in a rectangular bin of width $W$ and height $H$. Rotation of items is not allowed (see Figure 1). The two-dimensional orthogonal knapsack problem (2d-OKP) is to compute the maximum value of a feasible set: if every item $i \in \mathscr{I}$ has a positive value $p_{i}$, the aim is to exhibit a feasible subset of items $\mathscr{I}^{\prime} \subset \mathscr{I}$ such that $\sum_{i \in \mathscr{I}^{\prime}} p_{i}$ is maximal (see Figure 1).

Many authors gave MIP formulations introducing a discretization of the space [3, 11, 4, 7], or relying on the relative position of items [10, 23, 24, 25]. Caprara and Monaci [8] gave a comparative study of several Branch \& Bound algorithms solving strip packing problem. Baldacci and Boschetti proposed a cutting plane approach to solve this problem [1]. Constraint programming was also used to provide exact algorithms [5, 6, 15, 22, 25, 26]. Dual feasible functions were also used by several authors (see [14] for a recent survey).

We consider the $D$-dimensional orthogonal packing problem and the $D$-dimensional orthogonal knapsack problem (with $D \geq 2$ ). Fekete and Schepers $[18,19]$ introduced a new approach using graph theory. Their algorithm is one of the fastest, even in the two dimensional case. They used some tuple of interval graphs as data structures to store a feasible packing. Though Fekete and Schepers's algorithm is very efficient, there are sill symmetry issues. We propose a new algorithm using some consecutive ones matrices as data structures, due to Fulkerson and Gross's characterization of interval graphs. Our approach is able to eliminate some of these symmetry issues.

This paper is organized as follows. In the first section, we introduce the model used to check if a set of items has a feasible packing. We describe also the algorithm to check feasibility and we exhibit several optimizations to handle symmetry issues. In the second section, we describe how the knapsack problem is solved, and give computational results with respect to standard benchmarks.

## 2 A new algorithm to solve orthogonal packing

### 2.1 Consecutive ones matrices for orthogonal packing

Let $n$ denote the number of items and $D$ be the dimension of the Euclidean space. Let $\mathscr{I}=\{1, \ldots, n\}$ be a set of items. For every $d \in\{1, \ldots, D\}$ and $i \in \mathscr{I}$, let $w_{i}^{d}$ be the width of item number $i$ w.r.t. dimension $d$. For every $d \in\{1, \ldots, D\}$, let $W^{d}$ be the width of the bin w.r.t. dimension $d$. The set of items $\mathscr{I}$ is feasible (see Figure 1 ) if there is a tuple of coordinates $\left(x_{i}^{1}, \ldots, x_{i}^{D}\right) \in \mathbb{R}_{D}^{+}$for every item $i \in \mathscr{I}$ such that:

\forall i \in \mathscr{I}, \forall d \in\{1, \ldots, D\}: x_{i}^{d}+w_{i}^{d} \leq W^{d},  \tag{1}\\
\forall i, j \in \mathscr{I}(i \neq j), \exists d \in\{1, \ldots, D\}:\left[x_{i}^{d}, x_{i}^{d}+w_{i}^{d}\right) \cap\left[x_{j}^{d}, x_{j}^{d}+w_{j}^{d}\right)=\emptyset . \tag{2}
\end{gather*}
$$

We denote by feasible packing, a set of tuple of coordinates of a feasible set of items satisfying the constraints (1) and (2). A feasible packing verifies touching assumption if every item is immediately to the "right" of an other item or touches the "left border" (w.r.t. every dimension):

$$
\begin{equation*}
x_{i}^{d} \in\{0\} \cup\left\{x_{j}^{d}+w_{j}^{d}: j \in \mathscr{I} \backslash\{i\}\right\}, \quad \forall i \in \mathscr{I}, d \in\{1, \ldots, D\} . \tag{3}
\end{equation*}
$$

Lemma 1 For every feasible set of items $\mathscr{I}$, there is an associated feasible packing which verifies touching assumption.
Proof Let $\left(x_{i}^{1}, \ldots, x_{i}^{D}\right)_{i \in \mathscr{I}} \in \mathbb{R}_{D}^{+}$be a feasible packing associated to the set of items $\mathscr{I}$, which does not satisfy touching assumption. There is an item $i \in \mathscr{I}$ and $d \in\{1, \ldots, D\}$ such that:

x_{i}^{d} \notin\{0\} \cup\left\{x_{j}^{d}+w_{j}^{d}: j \in \mathscr{I} \backslash\{i\}\right\} .
$$

Let $\tilde{x}_{i}^{d}=\max \left\{x_{j}^{d}+w_{j}^{d}: j \in \mathscr{I}, x_{j}^{d}+w_{j}^{d} \leq x_{i}^{d}\right\}$. And, for every $\left(d^{\prime}, i^{\prime}\right) \neq(d, i)\left(d^{\prime} \in\{1, \ldots, D\}, i^{\prime} \in \mathscr{I}\right)$, let $\tilde{x}_{i^{\prime}}^{d^{\prime}}=x_{i^{\prime}}^{d^{\prime}}$. Let us check that $\left(\tilde{x}_{j}^{1}, \ldots, \tilde{x}_{j}^{D}\right)_{j \in \mathscr{I}}$ is a feasible packing associated to $\mathscr{I}$.
We have, for every $\left(d^{\prime}, i^{\prime}\right), \tilde{x}_{i^{\prime}}^{d^{\prime}}+w_{i^{\prime}}^{d^{\prime}} \leq x_{i^{\prime}}^{d^{\prime}}+w_{i^{\prime}}^{d^{\prime}} \leq W^{d^{\prime}}$. Hence the constraint (1) is valid for these new coordinates.
It remains to check property (2). $\forall i^{\prime} \in \mathscr{I}\left(i^{\prime} \neq i\right)$, we have to prove that there is $d^{\prime} \in\{1, \ldots, D\}$ such that $\left[\tilde{x}_{i}^{d^{\prime}}, \tilde{x}_{i}^{d^{\prime}}+\right.$ $\left.w_{i}^{d^{\prime}}\right) \cap\left[\tilde{x}_{i^{\prime}}^{d^{\prime}}, \tilde{x}_{i^{\prime}}^{d^{\prime}}+w_{i^{\prime}}^{d^{\prime}}\right)=\emptyset$. But, for every $i^{\prime} \in \mathscr{I}\left(i^{\prime} \neq i\right)$, there is $d^{\prime}$ such that $\left[x_{i}^{d^{\prime}}, x_{i}^{d^{\prime}}+w_{i}^{d^{\prime}}\right) \cap\left[x_{i^{\prime}}^{d^{\prime}}, x_{i^{\prime}}^{d^{\prime}}+w_{i^{\prime}}^{d^{\prime}}\right)=\emptyset$. So,

- If $d^{\prime} \neq d$, then $\left[\tilde{x}_{i}^{d^{\prime}}, \tilde{x}_{i}^{d^{\prime}}+w_{i}^{d^{\prime}}\right) \cap\left[\tilde{x}_{i^{\prime}}^{d^{\prime}}, \tilde{x}_{i^{\prime}}^{d^{\prime}}+w_{i^{\prime}}^{d^{\prime}}\right)=\emptyset$ because $\tilde{x}_{i}^{d^{\prime}}=x_{i}^{d^{\prime}}$.
- For $d^{\prime}=d$, we have $x_{i^{\prime}}^{d^{\prime}}+w_{i^{\prime}}^{d^{\prime}} \leq x_{i}^{d^{\prime}}$ or $x_{i}^{d^{\prime}}+w_{i}^{d^{\prime}} \leq x_{i^{\prime}}^{d^{\prime}}$.
. If $x_{i^{\prime}}^{d^{\prime}}+w_{i^{\prime}}^{d^{\prime}} \leq x_{i}^{d^{\prime}}$, then $\tilde{x}_{i^{d^{\prime}}}^{d^{\prime}}+w_{i^{\prime}}^{d^{\prime}}=x_{i^{\prime}}^{d^{\prime}}+w_{i^{\prime}}^{d^{\prime}} \leq \max \left\{x_{j}^{d^{\prime}}+w_{j}^{d^{\prime}}: j \in \mathscr{I}, x_{j}^{d^{\prime}}+w_{j}^{d^{\prime}} \leq x_{i}^{d^{\prime}}\right\}=\tilde{x}_{i}^{d^{\prime}}$.
. If $x_{i}^{d^{\prime}}+w_{i}^{d^{\prime}} \leq x_{i^{\prime}}^{d^{\prime}}$, then $\tilde{x}_{i}^{d^{\prime}}+w_{i}^{d} \leq x_{i}^{d^{\prime}}+w_{i}^{d^{\prime}} \leq x_{i^{\prime}}^{d^{\prime}}=\tilde{x}_{i^{\prime}}^{d^{\prime}}$.
Therefore, $\left[\tilde{x}_{i}^{d^{\prime}}, \tilde{x}_{i}^{d^{\prime}}+w_{i}^{d^{\prime}}\right) \cap\left[\tilde{x}_{i^{\prime}}^{d^{\prime}}, \tilde{x}_{i^{\prime}}^{d^{\prime}}+w_{i^{\prime}}^{d^{\prime}}\right)=\emptyset$, for all $i^{\prime} \in \mathscr{I}\left(i^{\prime} \neq i\right)$. Furthermore, for every $i^{\prime}, i^{\prime \prime} \in \mathscr{I} \backslash\{i\}$, we have $\left[\tilde{x}_{i^{\prime}}^{d^{\prime}}, \tilde{x}_{i^{\prime}}^{d^{\prime}}+w_{i^{\prime}}^{d^{\prime}}\right) \cap\left[\tilde{x}_{i^{\prime \prime}}^{d^{\prime}}, \tilde{x}_{i^{\prime \prime}}^{d^{\prime}}+w_{i^{\prime \prime}}^{d^{\prime}}\right)=\emptyset$. Hence the constraint (2) is satisfied. Thus $\left(\tilde{x}_{i}^{1}, \ldots, \tilde{x}_{i}^{D}\right)_{i \in \mathscr{\mathscr { I }}}$ is a feasible packing associated to $\mathscr{I}$ with one item less not satisfying touching assumption than $\left(x_{i}^{1}, \ldots, x_{i}^{D}\right)_{i \in \mathscr{I}}$. By iterating, we build this way a feasible packing associated to $\mathscr{I}$ satisfying touching assumption.

[^1]Let $G=(V, E)$ be a simple undirected graph. A stable set of $G$ is a subset of $V$ such that every pair of vertices are not adjacent. For every vertex $i \in V$, let $w_{i} \in \mathbb{R}$ be its weight. The weighted stability number $\alpha(G, \mathbf{w})$ of $G$ is the maximal sum of weights of a stable set. Given a finite multi-set of intervals of $\mathbb{R}$, an interval graph $G=(V, E)$ is an undirected graph such that each interval corresponds to a vertex of the graph, and two vertices are adjacent if and only if the corresponding intervals overlap.

Following Fekete and Schepers [18, 19], a packing class is a collection of $D$ graphs $G_{1}, \ldots, G_{D}$ with (shared) vertex set $\mathscr{I}$ and edge sets $E\left(G_{d}\right)$ such that:

P1: for every $d \in\{1, \ldots, D\}, G_{d}$ is an interval graph,
P2: for every $d \in\{1, \ldots, D\}$, for every stable set $S$ of $G_{d}, \Sigma_{s \in S} w_{s}^{d} \leq W^{d}$ (equivalently $\alpha\left(G_{d}, \mathbf{w}^{\mathbf{d}}\right) \leq W^{d}$ ),
P3: $\bigcap_{d \in\{1, \ldots, D\}} E\left(G_{d}\right)=\emptyset$.
See Figure 2, for an illustration of the relationship between a feasible packing and a packing class.

Therefore to check whether a set of items is feasible, the algorithm of Fekete and Schepers enumerates all packing classes associated to $\mathscr{I}$. However, in some cases, there are distinct packings of a feasible set of items whose associated packing classes are different (see Figure 3). Hence there are still symmetry issues in this model. Furthermore Ferreira and Oliveira [20] noticed that some so-called degenerated packing classes are unnecessarily enumerated by Fekete and Schepers' algorithm.

A binary matrix $M \in \mathscr{M}_{n, m}(\mathbb{B})$ has the consecutive ones property if for every row $i$ and $k \leq k^{\prime}, M_{i k}=1$ and $M_{i k^{\prime}}=1$ implies $M_{i l}=1$ for all $k \leq l \leq k^{\prime}$ (for every row, the set of 1 s occur consecutively).

If $\mathbf{v}$ and $\mathbf{w}$ are two binary vectors of same size, we write $\mathbf{v}>\mathbf{w}$, if $\mathbf{v}$ is of lexicographic order greater or equal than w. Let $M^{\prime}$ and $M^{\prime \prime}$ be two matrices in $\mathscr{M}_{n, m}(\mathbb{B}) . M_{\text {lex }}^{\prime}>M^{\prime \prime}$ if $\exists l \in\{1, \ldots, m\}$ such that $\forall k<l, Q_{k}^{\prime}=Q_{k}^{\prime \prime}$ and $Q_{l}^{\prime}>Q_{l \text { lex }}^{\prime \prime}$. We write $M^{\prime} \sim M^{\prime \prime}$, if they have the same set of column vectors ( $M^{\prime \prime}$ can be obtained from $M^{\prime}$ by permuting columns). In this case, $M^{\prime}$ and $M^{\prime \prime}$ are said to be equivalent.

Let $G$ be a graph with $n$ vertices $\left(\mathscr{V}=\{1, \ldots, n\}\right.$ ) and $m$ maximal cliques $Q_{1}, \ldots, Q_{m}$. A matrix $M \in \mathscr{M}_{n, m}(\mathbb{B})$ is a vertex/clique matrix of $G$ if for every $1 \leq i \leq n$ and $1 \leq k \leq m$, the vertex $i$ belongs to the maximal clique $Q_{k}$ if and only if $M_{i k}=1$ (see Example 3), that is each column is the characteristic vector of a maximal clique.

We are now ready to state Fulkerson and Gross' characterization of interval graphs:
Theorem 2 (Fulkerson and Gross (1965)) A graph $G$ is an interval graph if and only if there is a vertex/clique matrix of $G$ which has the consecutive ones property.

Example 3 Let $G$ be the interval graph with the interval graph representation as depicted on the left part of the figure below. Then the matrix as defined on the right part is a vertex/clique matrix of $G$, which has the consecutive ones property.


Without loss of generality, let $\mathscr{I}$ be a set of items and $\forall d \in\{1, \ldots, D\}$, let $m^{d} \leq n$. From now on, for every $d \in$ $\{1, \ldots, D\}$, let $M^{d} \in \mathscr{M}_{n, m^{d}}(\mathbb{B})$ be a matrix with the consecutive ones property. $\forall k \in\left\{1, \ldots, m^{d}\right\}$, let $Q_{k}^{d}=\left\{i \in \mathscr{I}: M_{i k}^{d}=\right.$ $1\}$ be the set of items in column $k$ and let $C_{k}^{d} \in \mathbb{B}^{n}$ be the column $k$ of matrix $M^{d}\left(C_{k}^{d}\right.$ is the characteristic vector of $Q_{k}^{d}$; a column $C_{k}^{d}$ is said to be maximal if $Q_{k}^{d}$ is not included in $Q_{l}^{d}$ for every $l \neq k$. Let $Q_{m^{d}+1}^{d}=\emptyset$ and $\mathscr{Q}^{d}=\left\{Q_{1}^{d}, \ldots, Q_{m^{d}}^{d}\right\}$. We define the width $\lambda_{k}^{d}$ of $Q_{k}^{d}$ by:

\lambda_{k}^{d}=\max _{\substack{i \in \mathscr{G} \\ i \in Q_{k}^{d}, i \notin Q_{k+1}^{d}}}\left\{w_{i}^{d}-\sum_{1 \leq l<k / i \in Q_{l}^{d}} \lambda_{l}^{d}\right\} . \tag{4}
\end{equation*}
$$

A strip decomposition associated to $\mathscr{I}$ is a D-tuple of consecutive ones matrices $\left(M^{1}, \ldots, M^{D}\right) \in \mathscr{M}(\mathbb{B})$ with nonzero rows such that:

- For every dimension $d \in\{1, \ldots, D\}$,

$$
\begin{equation*}
\text { every column of } M^{d} \text { is maximal, } \tag{5}
\end{equation*}
$$

$$
\begin{equation*}
\forall i \in \mathscr{I}, \forall k \in\left\{1, \ldots, m^{d}\right\} \text { such that } i \in Q_{k}^{d} \text {, we have } w_{i}^{d}-\sum_{1 \leq l<k / i \in Q_{l}^{d}} \lambda_{l}^{d}>0 \text {, } \tag{6}
\end{equation*}
$$

$$
\begin{equation*}
\sum_{k \in\left\{1, \ldots, m^{d}\right\}} \lambda_{k}^{d} \leq W^{d} . \tag{7}
\end{equation*}
$$

- For every pair $i, j \in \mathscr{I}(i \neq j)$, there is a dimension $d \in\{1, \ldots, D\}$ such that:

$$
\begin{equation*}
\forall k \in\left\{1, \ldots, m^{d}\right\}, i \notin Q_{k}^{d} \text { or } j \notin Q_{k}^{d} \tag{8}
\end{equation*}
$$

Figure 4 gives an illustration of a strip decomposition and of cliques widths.
We have the following basic Lemma, which is useful for some proofs:
Lemma 4 For every $i \in \mathscr{I}$ and $d \in\{1, \ldots, D\}, w_{i}^{d} \leq \sum_{1 \leq k \leq m^{d} / i \in Q_{k}^{d}} \lambda_{k}^{d}$.
Proof For every $i \in \mathscr{I}$ and $d \in\{1, \ldots, D\}$, let $l \in\left\{1, \ldots, m^{d}\right\}$ such that $i \in Q_{l}^{d}$ and $i \notin Q_{l+1}^{d}$.
We have $\lambda_{l}^{d}=\max _{\substack{j \in \mathscr{I} \\ j \in Q_{l}^{d}, j \notin Q_{l+1}^{d}}}\left\{w_{j}^{d}-\sum_{1 \leq k<l / j \in Q_{k}^{d}} \lambda_{k}^{d}\right\} \geq w_{i}^{d}-\sum_{1 \leq k<l / i \in Q_{k}^{d}} \lambda_{k}^{d}$. Hence $w_{i}^{d} \leq \sum_{1 \leq k \leq m^{d} / i \in Q_{k}^{d}} \lambda_{k}^{d}$.
We now formally establish the link between feasible packings and strip decompositions (see Figure 4 again for an example).

Lemma 5 If we have a feasible packing for $\mathscr{I}$ with touching assumption then there is a strip decomposition associated to $\mathscr{I}$.

Proof By Lemma 1, there is an associated feasible packing $\left(x_{i}^{1}, \ldots, x_{i}^{D}\right) \in \mathbb{R}_{D}^{+}$for every item $i \in \mathscr{I}$, which satisfies touching assumption. For all $d \in\{1, \ldots, D\}$, let $X^{d}=\left\{x \in \mathbb{R}: \exists i \in \mathscr{I}, x=x_{i}^{d}\right\}$. Let $m^{d}=\left|X^{d}\right|$. Write $X^{d}=$ $\left\{X_{1}^{d}, \ldots, X_{m^{d}}^{d}\right\}$ with the convention $X_{1}^{d}<\cdots<X_{m^{d}}^{d}$. Since the feasible packing verifies touching assumption, for every $d \in\{1, \ldots, D\}, k \in\left\{2, \ldots, m^{d}\right\}$, there exists $i \in \mathscr{I}$ such that $X_{k}^{d}=x_{i}^{d}+w_{i}^{d}$. Moreover, $X_{1}^{d}=0$. Let $X_{m^{d}+1}^{d}=\max \left\{x_{i}^{d}+w_{i}^{d}\right.$ : $i \in \mathscr{I}\}$.
Obviously, for every $d \in\{1, \ldots, D\}$, there is a surjective function $\sigma^{d}: \mathscr{I} \rightarrow\left\{1, \ldots, m^{d}\right\}$ such that $\forall i \in \mathscr{I}, x_{i}^{d}=X_{\sigma^{d}(i)}^{d}$. $\forall d \in\{1, \ldots, D\}, k \in\left\{1, \ldots, m^{d}\right\}$, let $Q_{k}^{d}=\left\{i \in \mathscr{I} / x_{i}^{d} \leq X_{k}^{d}<x_{i}^{d}+w_{i}^{d}\right\}$. Let $M^{d} \in \mathscr{M}_{\left(n, m^{d}\right)}(\mathbb{B})$ be the boolean matrix such that $M_{i k}^{d}=1$ if and only if $i \in Q_{k}^{d}$.

- $M^{d}$ has the consecutive ones property. In fact, $\forall i \in \mathscr{I}$, let $k, l \in\left\{1, \ldots, m^{d}\right\}$, with $X_{k}^{d} \leq X_{l}^{d}$, such that $i \in Q_{k}^{d}$ and $i \in Q_{l}^{d}$. Then, by definition, $x_{i}^{d} \leq X_{k}^{d}<x_{i}^{d}+w_{i}^{d}$ and $x_{i}^{d} \leq X_{l}^{d}<x_{i}^{d}+w_{i}^{d}$. So, $\forall h \in\left\{1, \ldots, m^{d}\right\}$ such that $X_{k}^{d} \leq X_{h}^{d} \leq X_{l}^{d}$, we have this inequality: $x_{i}^{d} \leq X_{k}^{d} \leq X_{h}^{d} \leq X_{l}^{d}<x_{i}^{d}+w_{i}^{d}$. So, $i \in Q_{h}^{d}$. Thus $M^{d}$ verifies the consecutive ones property.
- Let us check that every column of $M^{d}$ is maximal. Let $1 \leq k<k^{\prime} \leq m^{d}$ and $C_{k}^{d}$ (resp. $C_{k^{\prime}}^{d}$ ) be the characteristic vector of $Q_{k}^{d}$ (resp. $Q_{k^{\prime}}^{d}$ ). Since the feasible packing verifies touching assumption, let $i$ (resp. $\left.i^{\prime}\right) \in \mathscr{I}$ be an item such that $x_{i}^{d}+w_{i}^{d}=X_{k+1}^{d}$ (resp. $x_{i^{\prime}}^{d}=X_{k^{\prime}}^{d}$ ). By definition, $X_{k}^{d}<X_{k^{\prime}}^{d}$. Obviously, $i^{\prime} \notin Q_{k}^{d}$ and $i^{\prime} \in Q_{k^{\prime}}^{d}$. Hence, $Q_{k^{\prime}}^{d} \notin Q_{k}^{d}$. Moreover, $X_{k+1}^{d} \leq X_{k^{\prime}}^{d}$. Hence, $i \in Q_{k}^{d}$ and $i \notin Q_{k^{\prime}}^{d}$. Thus, $Q_{k}^{d} \nsubseteq Q_{k^{\prime}}^{d}$ and so $C_{k}^{d}$ is maximal.

Thus, $\forall k \in\left\{1, \ldots, m^{d}\right\}$, by definition of $Q_{k}^{d}, i \notin Q_{k}^{d}$ or $j \notin Q_{k}^{d}$.
Therefore $\left(M^{1}, \ldots, M^{D}\right)$ is a strip decomposition associated to $\mathscr{I}$.
We now prove the converse:
Lemma 6 If we have a strip decomposition associated to $\mathscr{I}$ then there is a feasible packing for $\mathscr{I}$ with touching assumption.

### 2.2 The algorithm to check feasibility

Due to Lemmas 5 and 6, to check feasibility, we only have to design an algorithm which returns whether there is a strip decomposition associated to the set of items $\mathscr{I}$. We proceed dimension by dimension, by enumerating all consecutive ones matrices which satisfy the strip decomposition constraints (5), (6), (7) and (8).

The core of the recursion to enumerate consecutive ones matrices is described in Algorithm 1. Notice that the number of columns of a matrix of a strip decomposition is at most $n$ (the number of items), but we do not known it when we are looking for a strip decomposition. Therefore our algorithm enumerates square $n \times n$-matrices, such that there is an index $m$ implying all columns with index at most $m$ are maximal, and the remaining ones are 0 columns.

By applying algorithm 1, we consider at this stage only one dimension, and this is a main point of our approach: almost all the work is done in first dimension.

To ensure that constraint (8), is satisfied, we proceed like this: for every dimension $d \in\{1, \ldots, D-1\}$, let $S_{d}$ denote the set of all matrices output by Algorithm 1 w.r.t. dimension $d$. Then for the last dimension $d=D$, for every $(D-1)$ tuple of matrices $\left(M^{1}, \ldots, M^{D-1}\right) \in S_{1} \times \ldots \times S_{D-1}$, we look for a consecutive ones matrix by using Algorithm 1 , such that constraint (8) is satisfied. If any, we have a strip decomposition, and the set of items is feasible. If we fail to find out such a tuple of matrices, the set of items is not feasible.

### 2.3 Early detection of unfeasibility

Let $\mathscr{I}$ be a feasible set of items. In this subsection, we exhibit additional constraints which are valid for all strip decompositions associated to $\mathscr{I}$. These constraints are used in the algorithm to reduce the enumeration tree of strip decompositions.

Available width for items which are not packed yet Assume that the first $k$ columns in Algorithm 1 are set. Every item which has only 0 entries in these columns has to be packed in the remaining columns. Therefore, the following constraint is a valid constraint (see Figure 5).

"Height" of the column In the bi-dimensional case, a maximal clique $Q$ w.r.t. one dimension induces a stable set in the other dimension. Therefore, for every column $Q$, the sum of weights of the items of $Q$ (the "height" of $Q$ ) can not exceed the size of the container in the other dimension. In $D$ dimensions, we have this valid following constraint:

Available volume for items which are not packed yet Assume that the first $k$ columns in Algorithm 1 are set. The sum of all items volume which have only 0 entries in these columns has to be packed in the remaining volume. Therefore, the following constraint is a valid constraint (see Figure 6).

So, due to lemmas 7, 8, 9, we only have to generate columns satisfying constraints (9), (10) and (11).

### 2.4 Breaking some symmetry issues

Notice that the first matrix printed by Algorithm 1 is the biggest matrix satisfying strip decomposition constraints without 0 rows, with respect to the lexicographic order (as defined in Section 1). Hence, if during the recursion, we are able to detect that the packing is feasible, then a solution with biggest lexicographic order should have been already found, in which case we can safely stop it and return that the packing is infeasible.

Let us see a small example: assume that in the enumerating process, we are in step 1 below (the star (resp. - ) denotes current position (resp. unset positions))

Then step 2 must have been visited before by the recursion, hence a feasible solution, if any, should have been found before: in this case, there are no feasible solutions.

By detecting such configurations, this is how we handle symmetry issues. This contributed mainly to our algorithm's efficiency. This subsection is devoted to such breaking symmetries procedures.

Such symmetry issues arise naturally when two items are identical (they have same widths w.r.t. all dimensions), since the corresponding rows may be swapped safely. These symmetry issues are easily dealt with.

Let $M \in \mathscr{M}_{n, m}(\mathbb{B})$ be a $0 / 1$ matrix. For every $1 \leq p \leq m$ and $1 \leq q \leq m-p$, we denote by $\operatorname{SM}_{p, q}(M)$ the submatrix $M^{\prime}$ of $M$ made of the columns numbered from $p$ to $p+q-1$, that is for every $1 \leq i \leq n$ and $1 \leq j \leq q, M_{i, j}^{\prime}=M_{i, j+p-1}$.

A submatrix $\mathrm{SM}_{p, q}(M)$ is a block of $M$ if for every $i, j$ such that $M_{i, j}=1$ and $p \leq j \leq p+q-1$, we have $M_{i, 1}=$ $M_{i, 2}=\ldots, M_{i, p-1}=0$ and $M_{i, p+q}=M_{i, p+q+1}=\ldots=M_{i, m}=0$. We denote by $\mathrm{B}_{p, q}(M)$ a submatrix $\mathrm{SM}_{p, q}(M)$ of $M$ which is a block of $M$ (see Figure 7). Roughly speaking with respect to strip decompositions, every item which belongs to a clique of a block can not belong to the cliques outside of the block.

Lemma 10 Let $\left(M^{1}, \ldots, M^{D}\right)$ be a strip decomposition. For every $d \in\{1, \ldots, D\}$ such that $M^{d}$ has two blocks $B_{p_{1}, q_{1}}\left(M^{d}\right)$ and $B_{p_{2}, q_{2}}\left(M^{d}\right)$ with $p_{1}+q_{1} \leq p_{2}$ and $B_{p_{2}, q_{2}}\left(M^{d}\right)>B_{p_{1}, q_{1}}\left(M^{d}\right)$ then there is a matrix $M^{\prime d}$ such that $M^{\prime d}>M_{\text {lex }}^{d}$ and the D-tuple of matrices $\left(M^{1}, \ldots, M^{\prime d}, \ldots, M^{D}\right)$ is an equivalent strip decomposition (see Figure 8).

Proof Let $M^{\prime d}$ be the matrix obtained from $M^{d}$ by swapping the two blocks $B_{p_{1}, q_{1}}\left(M^{d}\right)$ and $B_{p_{2}, q_{2}}\left(M^{d}\right)$ : the columns $C_{k}^{\prime d}$ of $M^{\prime d}$ are given by

C_{k}^{\prime d}= \begin{cases}C_{k}^{d} & \text { if } k<p_{1} \\ C_{k+p_{2}-p_{1}}^{d} & \text { if } p_{1} \leq k<p_{1}+q_{2} \\ C_{k+q_{1}-q_{2}}^{d} & \text { if } p_{1}+q_{2} \leq k<p_{2}+q_{2}-q_{1} \\ C_{k+p_{1}+q_{1}-p_{2}-q_{2}}^{d} & \text { if } p_{2}+q_{2}-q_{1} \leq k<p_{2}+q_{2} \\ C_{k}^{d} & \text { if } p_{2}+q_{2} \leq k\end{cases}
$$

It is straightforward to check that $\left(M^{1}, \ldots, M^{\prime d}, \ldots, M^{D}\right)$ is an equivalent strip decomposition to $\left(M^{1}, \ldots, M^{d}, \ldots, M^{D}\right)$ such that $M^{\prime d} \underset{\text { lex }}{>} M^{d}$.

Hence, due to Lemma 10, we stop the main recursion when there are two blocks which are not in decreasing lexicographic order (right case in Figure 8).

Notice that given a block, it is possible to permute the columns such that the first column is bigger w.r.t. the lexicographic order than the last one (see Figure 9). We are going to push this argument further to a slightly more general structure than blocks.

A submatrix $\mathrm{SM}_{p, q}(M)$ is an inner block of $M$ if, for every $i, j$, such that $M_{i, j}=1$ and $p \leq j \leq p+q-1$, we have $\left(M_{i, 1}=M_{i, 2}=\ldots=M_{i, p-1}=0\right.$ and $\left.M_{i, p+q}=M_{i, p+q+1}=\ldots=M_{i, m}=0\right)$ or $\left(M_{i, p}=M_{i, p+1}, \ldots=M_{i, p+q-1}=1\right)$. We denote by $\mathrm{IB}_{p, q}(M)$ a submatrix $\mathrm{SM}_{p, q}(M)$ of $M$ which is an inner block of $M$ (see Figure 10). Roughly speaking with respect to strip decompositions, every item which belongs to a clique of an inner block must belong to all cliques of the inner block or can not belong to the cliques outside of the inner block. An inner block $I B_{p, q}(M)$ is minimal if $Q_{p}>Q_{\text {lex }} Q_{p+q-1}$.

Lemma 11 Let $\left(M^{1}, \ldots, M^{D}\right)$ be a strip decomposition associated to the set of items $\mathscr{I}$. For every $d \in\{1, \ldots, D\}$ such that $M^{d}$ an inner block $I B_{p, q}\left(M^{d}\right)$ not "minimal" then there is a matrix $M^{\prime d}$ such that $M^{\prime d}>M^{d}$ and the $D$-tuple of matrices $\left(M^{1}, \ldots, M^{\prime d}, \ldots, M^{D}\right)$ is another strip decomposition associated to $\mathscr{I}$ (see Figure 11).

Proof Let $d \in\{1, \ldots, D\}$ such that $M^{d}$ has an inner block matrix $I B_{p, q}\left(M^{d}\right)$ which is not minimal.
Let $\alpha_{p, q}^{d}=\sum_{k \in\{1, \ldots, p-1\}} \lambda_{k}^{d}$ and $\beta_{p, q}^{d}=\sum_{k \in\{1 \ldots, p+q-1\}} \lambda_{k}^{d}$. For every item $i \in \mathscr{I}$ and for every $\delta \in\{1, \ldots, D\}$, let $f_{i}^{\delta}$ (resp. $\left.l_{i}^{\delta}\right) \in\left\{1, \ldots, m^{\delta}\right\}$ be the smallest (resp. biggest) index $k \in\left\{1, \ldots, m^{\delta}\right\}$ such that $M_{i, k}^{\delta}=1$; and let $x_{i}^{\delta}=\sum_{k \in\left\{1, \ldots, f_{i}^{\delta}-1\right\}} \lambda_{k}^{\delta}$. According to the proof of Lemma $6,\left(x_{i}^{1}, \ldots, x_{i}^{D}\right)_{i \in \mathscr{I}}$ is a feasible packing. We are going to build another feasible packing $\left(x_{i}^{\prime 1}, \ldots, x_{i}^{\prime D}\right)_{i \in \mathscr{I}}$ with $x_{i}^{\prime \delta}=x_{i}^{\delta}$ whenever $\delta \in\{1, \ldots, D\}(\delta \neq d)$ and $i \in \mathscr{I}$ such that the associated strip decomposition, as defined in the proof of Lemma 5, has bigger lexicographic order, with respect to dimension $d$ :

- $\forall i \in \mathscr{I}$ and $\delta \in\{1, \ldots, D\}$ with $\delta \neq d$, let $x_{i}^{\prime \delta}=x_{i}^{\delta}$.
- $\forall i \in \mathscr{I}$ such that $f_{i}^{d}<p$ or $l_{i}^{d}>p+q-1$, let $x_{i}^{\prime d}=x_{i}^{d}=\sum_{k \in\left\{1, \ldots, f_{i}-1\right\}} \lambda_{k}^{d}$.
- $\forall i \in \mathscr{I}$ such that $f_{i}^{d} \geq p$ and $l_{i}^{d} \leq p+q-1$, let $x_{i}^{\prime d}=\alpha_{p, q}^{d}+\left(\beta_{p, q}^{d}-\sum_{k \in\left\{1, \ldots, l_{i}^{d}\right\}} \lambda_{k}^{d}\right)$. Hence, we have:

x_{i}^{\prime d}=\sum_{k \in\{1, \ldots, p-1\}} \lambda_{k}^{d}+\sum_{k \in\left\{l_{i}^{d}+1, \ldots, p+q-1\right\}} \lambda_{k}^{d} .

Let us check that inequalities (1) with respect to dimension $d$ of a feasible packing are satisfied :

- $\forall i \in \mathscr{I}$ such that $f_{i}^{d}<p$ or $l_{i}^{d}>p+q-1, x_{i}^{\prime d}+w_{i}^{d} \leq W^{d}$.
- $\forall i \in \mathscr{I}$ such that $f_{i}^{d} \geq p$ and $l_{i}^{d} \leq p+q-1$, due to Lemma (4), we have:

Let us check that constraints (2) of a feasible packing are satisfied. If $(i, j) \in \mathscr{I}^{2}(i \neq j)$ is a pair of items such that $\left[x_{i}^{d}, x_{i}^{d}+w_{i}^{d}\right) \cap\left[x_{j}^{d}, x_{j}^{d}+w_{j}^{d}\right) \neq \emptyset$, then there is nothing to prove. Assume that $(i, j) \in \mathscr{I}^{2}(i \neq j)$ is a pair of items such that $\left[x_{i}^{d}, x_{i}^{d}+w_{i}^{d}\right) \cap\left[x_{j}^{d}, x_{j}^{d}+w_{j}^{d}\right)=\emptyset$. We are going to show that $\left[x_{i}^{\prime d}, x_{i}^{\prime d}+w_{i}^{d}\right) \cap\left[x_{j}^{\prime d}, x_{j}^{\prime d}+w_{j}^{d}\right)=\emptyset$ (which implies that constraint (2) is satisfied for the pair $(i, j)$ ). There are four cases:

- If $\left(f_{i}^{d}<p\right.$ or $\left.l_{i}^{d}>p+q-1\right)$ and $\left(f_{j}^{d}<p\right.$ or $\left.l_{j}^{d}>p+q-1\right)$ then $x_{i}^{\prime d}=x_{i}^{d}$ and $x_{j}^{\prime d}=x_{j}^{d}$. Thus $\left[x_{i}^{\prime d}, x_{i}^{\prime d}+w_{i}^{d}\right) \cap\left[x_{j}^{\prime d}, x_{j}^{\prime d}+\right.$ $\left.w_{j}^{d}\right)=\emptyset$.
- If $\left(f_{i}^{d} \geq p, l_{i}^{d} \leq p+q-1\right)$ and $\left(f_{j}^{d}<p\right)$ then $x_{j}^{d}+w_{j}^{d} \leq x_{i}^{d}$. By definition of an inner block, we have $l_{j}^{d}<p$. Thus, due to Lemma (4), we have:

x_{j}^{\prime d}+w_{j}^{d}=x_{j}^{d}+w_{j}^{d} \leq \sum_{k \in\left\{1, \ldots, f_{j}^{d}-1\right\}} \lambda_{k}^{d}+\sum_{k \in\left\{f_{j}^{d}, \ldots, l_{j}^{d}\right\}} \lambda_{k}^{d} \leq \sum_{k \in\{1, \ldots, p-1\}} \lambda_{k}^{d} \leq x_{i}^{\prime d} .
$$

- If $\left(f_{i}^{d} \geq p, l_{i}^{d} \leq p+q-1\right)$ and $\left(l_{j}^{d}>p+q-1\right)$ then $x_{j}^{d} \geq x_{i}^{d}+w_{i}^{d}$. By definition of an inner block, we have $f_{j}^{d}>p+q-1$. Thus, due to Lemma (4), we have:

x_{j}^{\prime d}=x_{j}^{d} \geq \sum_{k \in\left\{1, \ldots, f_{j}^{d}-1\right\}} \lambda_{k}^{d} \geq \sum_{k \in\{1, \ldots, p+q-1\}} \lambda_{k}^{d} \geq x_{i}^{\prime d}+w_{i}^{d} .
$$

- If $\left(f_{i}^{d} \geq p, l_{i}^{d} \leq p+q-1\right)$ and $\left(f_{j}^{d} \geq p, l_{j}^{d} \leq p+q-1\right)$. We suppose $x_{j}^{d}+w_{j}^{d} \leq x_{i}^{d}$, then $l_{j}^{d}<f_{i}^{d}$. Due to Lemma (4), we have:

x_{i}^{\prime d}+w_{i}^{d} & \leq \sum_{k \in\{1, \ldots, p-1\}} \lambda_{k}^{d}+\sum_{k \in\left\{l_{i}^{d}+1, \ldots, p+q-1\right\}} \lambda_{k}^{d}+\sum_{k \in\left\{f_{i}^{d}, \ldots, l_{i}^{d}\right\}} \lambda_{k}^{d} \\
& \leq \sum_{k \in\{1, \ldots, p-1\}} \lambda_{k}^{d}+\sum_{k \in\left\{l_{j}^{d}+1, \ldots, p+q-1\right\}} \lambda_{k}^{d} \leq x_{j}^{\prime d} .
\end{aligned}
$$

Therefore, $\left(x_{i}^{\prime 1}, \ldots, x_{i}^{\prime D}\right)_{i \in \mathscr{I}}$ is a feasible packing. From Lemma 1, we get a feasible packing $\left(x_{i}{ }^{\prime 1}, \ldots, x_{i}{ }^{\prime \prime D}\right)_{i \in \mathscr{I}}$ with the touching assumption, such that $x_{i}^{\delta}=x_{i}^{\prime \prime}$ for all $i \in \mathscr{I}$, whenever $\delta \neq d$. As defined in the proof of Lemma 5 , we have an associated strip decomposition $\left(M^{1}, \ldots, M^{\prime \prime}, \ldots, M^{D}\right)$. The first $p-1$ columns of $M^{\prime \prime d}$ are identical to $M^{d}$ (as the coordinates of the first items are identical). By hypothesis, $Q_{p+q-1}^{d}>Q_{p=x}^{d}$. Let $a$ (resp. $b$ ) be the smallest item such that $M_{a, p}^{d}=1$ and $M_{a, p+q-1}^{d}=0$ (resp. $M_{b, p}^{d}=0$ and $M_{b, p+q-1}^{d}=1$ ). Due to the definition of inner block, $l_{b}^{d}=p+q-1$ and so $x^{\prime ⿰}{ }_{b}^{d}=\sum_{k \in\{1, \ldots, p-1\}} \lambda_{k}^{d}=x_{a}^{d}$. According to the touching assumption, there is $j \in \mathscr{I}$ such that $x_{a}^{d}=x_{j}^{d}+w_{j}^{d}$. So,


Hence, due to Lemma 11, we stop the main recursion when there is an inner block which is not minimal (right case in Figure 11).

## 3 The two-dimensional orthogonal knapsack problem

The main benchmarks are devoted to the bi-dimensional orthogonal knapsack problem. Our algorithm only checks if a given set of items admits a feasible packing. Therefore, to run these benchmarks, we used a branch-and-bound algorithm (see subsection 3.1), calling our algorithm to check feasibility.

### 3.1 Knapsack algorithm

To select a subset of items $\mathscr{I}$ among all items, we use a classical branch-and-bound enumeration of the knapsack problem where the knapsack constraint is that the overall area of the selected items is less or equal than the container's area. For a given selected subset of items, we apply some dual feasible functions in order to try to early detect unfeasibility: a function $f:[0,1] \rightarrow[0,1]$ is dual feasible (DFF) [17] if for every finite set $S$ of positive real numbers, we have $\sum_{x \in S} x \leq 1 \Rightarrow \sum_{x \in S} f(x) \leq 1$.

Carlier and Neron introduced discrete dual feasible functions [9], as follows: let $C \in E n s R^{+}$, a discrete dual feasible function $f_{C}$ is a function $f_{C}:[0, C] \rightarrow\left[0, C^{\prime}\right]$ (where $C^{\prime}=f_{C}(C)$ ) such that for every finite set $S$ of positive real numbers $\forall S, \quad \sum_{x \in S} x \leq C \Rightarrow \sum_{x \in S} f_{C}(x) \leq f_{C}(C)=C^{\prime}$. They proved the following necessary condition for a subset of items to be feasible.

Theorem 12 A subset of items I is feasible, only if for every D-tuple of discrete feasible function $\left(f_{W_{1}}^{1}, \ldots, f_{W_{D}}^{D}\right)$, we have

We apply Theorem 12 with the following discrete dual feasible functions ( $k=2,3,4$ ), for every dimension $d$ :

To solve the knapsack problem, we may use a classical solver such as IBM Ilog CPLEX, FICO Xpress or GLPK. This would not improve significantly the computional time as the main issue is to check the feasibility of the packing. Hence we implemented our own knapsack algorithm.
3.2 Computational results on standard benchmarks

The algorithm to check feasibility and the branch-and-bound procedure have been implemented in Java 6 and tested on a PC with a 3 GHz Pentium IV processor. Runtimes reported by Fekete \& Schepers in [19] were obtained from a similar PC, but their algorithm was developed in C++.

We used classical 2D-OKP benchmarks from $[3,11,19]$ and the two dimensional guillotine cutting problems benchmarks from [2, 12]. All these benchmarks are available at

In tables 1 and 2, the columns JP (resp. FS, resp BB, resp. A0, A1, A2 and A3) correspond to our algorithm (resp. Fekete \& Schepers' algorithm with data reported from [19], resp. Baldacci \& Boschetti's algorithm with data reported from [1], resp. Caprara \& Monaci's algorithms, as depicted in [8]). Table 1 gives the container sizes, the value of an optimal solution and the number of items of an optimal solution. The number of subset of items to be checked for feasibility (OKP nodes) and the number of effective calls (OPP nodes) to our algorithm to check feasibility (that is after the application of dual feasible functions) are reported.

Table 1 shows that the number of the OKP nodes of our algorithm is bigger than the number of OKP nodes of Fekete and Schepers' algorithm. This is due to the fact that our Branch-and-Bound is less sophisticated than Fekete and Schepers' to select a subset of items to be checked for feasibility. In particular, we do not make use of heuristics to try to guess a solution, in contrary to Fekete \& Schepers'.

We report in Table 2 the running times of the algorithms. We also report the number of unsolved benchmarks (within the time limit of 1800 seconds) and the average time (computed on the set of instances cgcut, gcut and okp), with the convention that an unsolved benchmark counts for 1800 seconds. For ngcut and hccut instances, every algorithm is fast. cgcut and gcut instances are more difficult to solve, as the size of the container and/or the number of items of an optimal solutions are bigger. On these instances, our algorithm seems to be significantly faster, especially in the case of instances cgcut2, gcut4, gcut8 and gcut12. This seems to indicate that we handle better symmetry issues due to items of same shape.

Results on the five okp instances are less conclusive: Fekete \& Schepers' algorithm is faster (with the exception of okp1). Notice that on these instances, the number of calls to the algorithm to check feasibility is far much bigger in our case than in Fekete \& Schepers'. Hence, as already noticed, Fekete \& Scheper's branch-and-bound algorithm to handle the knapsack problem is more efficient. An explanation of this difference is that some symmetry issues are eliminated more efficiently by Fekete and Schepers' algorithm on these instances.

The instance gcut 13 is still open. We were able to provide a feasible solution of value 8647565 (involving 17 items ), thus slightly improving Fekete \& Schepers's lower bound of value 8622498 [19].

## 4 Conclusion

In this paper, we gave an exact algorithm to solve the multi-dimensional orthogonal packing problem, which is based upon Fekete \& Schepers' characterization of feasible packings by so-called packing classes. This algorithm is used to solve the two-dimensional orthogonal packing problem with two stages: the first stage is a basic branch-and-bound algorithm to select a subset of items and the second stage checks whether this subset of items admits a feasible packing. Our main contribution is for the second stage: to check feasibility, we used consecutive ones matrices as data structures to store feasible packings. In contrary to Fekete \& Scheper's approach, by using consecutive ones matrices, we have a partial knowledge of the relative positions of the items and their coordinates. This enabled us to handle some symmetry issues in a close manner to the algorithms of Clautiaux, Moukrim and Carlier [13, 15].

Computer experiments on standard benchmarks show that this new algorithm is competitive. In a companion paper, we investigate the data structure of PQ-trees, as they were designed to store more efficiently the linear consecutive
ordering of the maximal cliques of interval graphs. Another matter of investigation is to derive from this algorithm an efficient mixed integer programming formulation for the multi-dimensional orthogonal knapsack problem. At last, this approach is suitable to solve other problems such as the orthogonal packing problem on a torus, by enumerating circulant consecutive-ones matrices.
