Fractional-step schemes for the coupling of distributed and lumped models in hemodynamics

Abstract: In three-dimensional (3D) blood flow simulations, lumped parameter models (0D) are often used to model the neglected parts of the downstream circulatory system. We analyze two 3D-0D coupling approaches in which a fractional-step projection scheme is used in the fluid. Our analysis shows that explicit approaches might yield numerical instabilities, particularly in the case of realistic geometries with multiple outlets. We introduce and analyze an implicitly 3D-0D coupled formulation with enhanced stability properties and which requires a negligible additional computational cost. Furthermore, we also address the extension of these methods to fluid-structure interaction problems. The theoretical stability results are confirmed by meaningful numerical experiments in patient specific geometries coming from medical imaging.

Key-words: Blood flows, Chorin-Temam projection method, fluid-structure interaction, lumped parameter models, 3D-0D coupling.

Schémas à pas fractionnaire pour le couplage de modèles distribués et localisés en hémodynamique

Résumé : Les modèles à paramètres localisés (0D) sont souvent utilisés dans les simulations tri-dimensionnelles (3D) d'écoulements sanguins pour modéliser l'effet des parties de l'appareil circulatoire négligées en aval. Dans cet article nous analysons deux approches pour le couplage de modèles 3D-0D, dans lesquelles un schéma à pas fractionnaire est utilisé dans le fluide. Notre analyse met en évidence que les schémas de couplage 3D-0D explicites peuvent donner des instabilités numériques dans le cas de sorties multiples. Nous introduisons et analysons une formulation 3D-0D implicite avec des propriétés de stabilité améliorées et un coût de calcul supplémentaire négligeable par rapport au cas explicite. Nous abordons également l'extension de ces méthodes à des problèmes d'interaction fluide-structure. Les résultats théoriques de stabilité sont confirmés par des expériences numériques dans des géométries et données réalistes.

Mots-clés : Écoulements sanguins, schéma de projection de Chorin-Temam, interaction fluide-structure, modèles à paramètres localisés, couplage 3D-0D.

1 Introduction

In 3D distributed models of blood flow (e.g., Navier-Stokes equations, fluid-structure interaction), downstream pressure boundary conditions are often used to represent the effect of the neglected portion of the vessels. In fact, since pressure measurements are invasive and not always available, the downstream circulation is usually modeled through *lumped parameter* (or 0D) models. This results in a set of algebraic-differential equations, relating fluxes and pressures at each outlet boundary of the fluid domain (see, e.g., [11, 20, 18, 22] and the references therein). A widely used lumped parameter model is the so-called three-element Windkessel system (see, e.g., [11, 12])

The 3D-0D coupling between distributed and lumped models is operated by interface conditions that guarantee the continuity of the fluxes and pressures on the outlet boundaries (3D-0D interfaces). It is well-known that, when this coupling is treated explicitly in time, the whole system might suffer from numerical instability, regardless of the solution scheme in the 3D compartment. This enforces restrictions on the time-step length, that can considerably increase computational cost in realistic applications (see, e.g., the discussion in [20]). On the other hand, implicit 3D-0D coupling schemes overcome this instability issue at the expense of solving a fully coupled 3D-0D system at each time step. The so-called partitioned approaches solve this system by sub-iterating between the 3D and 0D models, which might be inefficient in practice (see, e.g., [16]). Alternatively, monolithic procedures solve both models simultaneously and yield system matrices with a modified sparsity pattern, which might lead to preconditioning issues (see, e.g., [17]).

This work is devoted to the formulation and analysis of 3D-0D coupling schemes based on a fractional-step projection time-marching of the fluid (see, e.g., [6, 14, 21]). First, an advection-diffusion problem is solved to recover an intermediate approximation of the velocity field and, then, a suitable pressure field is recovered by solving a Poisson problem. We also consider the case of a 3D fluid-structure interaction modeling, time-discretized by the projection semi-implicit coupling scheme reported in [9]. In this fractional-step framework, the explicit and implicit treatments of the 3D-0D coupling lead to different formulations of the pressure-Poisson projection step. It can be discretized in an explicit fashion by time-advancing the 0D model from the previously computed intermediate velocity flux, which provides an explicit Dirichlet boundary data for the 3D pressure-Poisson problem. For a purely fluid 3D distributed modeling with two or more 3D-0D interfaces, our analysis shows that this approach might compromise stability. We also show that, in the case of fluid-structure interaction, numerical instabilities might appear even with a sole downstream boundary. We propose to overcome these instability issues through the introduction of an implicit 3D-0D formulation with enhanced energy balance across the 3D-0D interface, both for a fluid and a fluid-structure interaction modeling of blood flow. A salient feature of the proposed schemes is that they preserve the two-step velocity/pressure splitting of the original fractional-step scheme, characterized by a 3D-0D coupled problem of reduced size. Moreover, we show that this coupling strategy can be efficiently implemented by considering a single unknown per 3D-0D interface. This yields a computational complexity comparable to an explicit scheme and, hence, overcomes the above mentioned stability/complexity issues.

The rest of the paper is organized as follows. In Section 2 we introduce the 3D fluid equations, its corresponding time discretization (via a fractional-step projection scheme) and the considered Windkessel model. Section 3 is devoted to the formulation and analysis of explicit and implicit 3D-0D coupling schemes with a 3D distributed model based on the Navier-Stokes equations, while Section 4 consider the fluid-structure interaction case. In section 5 we present and discuss the performed numerical experiments, that is, the Navier-Stokes flow in a realistic aortic geometry and with measured clinical data, and the fluid-structure interaction in an ideal abdominal aortic

aneurism. At last, Section 6 draws some concluding remarks and lines of future work.

2 The 3D-0D model problem

We first summarize the main ingredients of a 3D-0D model of blood flow coupling the incompressible Navier-Stokes equation and a lumped parameter description of the downstream boundaries. We then present the time-marching schemes considered in each sub-system and introduce some notation for the spatial discretization of the fluid equations.

2.1 3D fluid equations

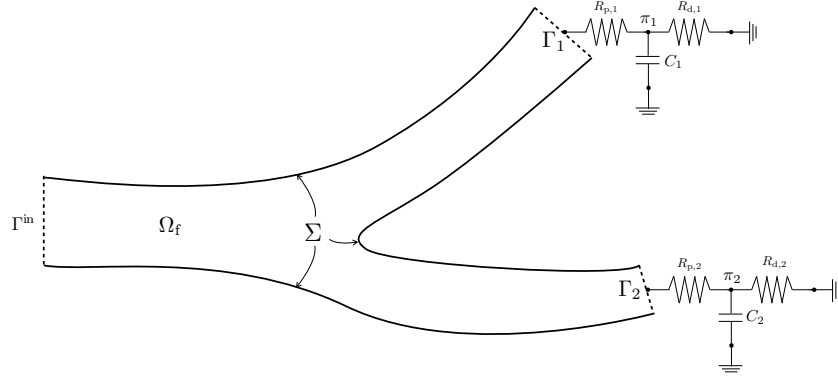


Figure 1: Sketch of the fluid domain Ω_f with two outlet boundaries $\Gamma^{\text{out}} = \Gamma_1 \cup \Gamma_2$, ($n_{0D} = 2$).

We consider a domain $\Omega_f \subset \mathbb{R}^3$ with the following partition of its boundary $\partial\Omega_f \stackrel{\text{def}}{=} \Gamma^{\text{in}} \cup \Sigma \cup \Gamma^{\text{out}}$. In the context of blood flow simulations, Ω_f will represent the lumen of the vessel (see Figure 1), with Γ^{in} , Σ and Γ^{out} denoting, respectively, the inlet, vessel wall and outlet boundaries. We

now consider the incompressible Navier-Stokes Equations for the velocity $\mathbf{u} : \Omega_f \times \mathbb{R}^+ \rightarrow \mathbb{R}^3$ and the pressure $p : \Omega_f \times \mathbb{R}^+ \rightarrow \mathbb{R}$:

$$\left\{ \begin{array}{ll} \rho_f \frac{\partial \mathbf{u}}{\partial t} + \rho_f \mathbf{u} \cdot \nabla \mathbf{u} - \nabla \cdot \boldsymbol{\sigma}(\mathbf{u}, p) = \mathbf{0} & \text{in } \Omega_f, \\ \nabla \cdot \mathbf{u} = 0 & \text{in } \Omega_f, \\ \mathbf{u} = \mathbf{u}_{\text{in}} & \text{on } \Gamma^{\text{in}}, \\ \mathbf{u} = \mathbf{0} & \text{on } \Sigma, \end{array} \right. \quad (1)$$

where ρ_f stands for the density of the fluid and the fluid Cauchy-stress tensor is given by $\boldsymbol{\sigma}(\mathbf{u}, p) \stackrel{\text{def}}{=} -p\mathbf{I} + 2\mu\boldsymbol{\epsilon}(\mathbf{u})$ and $\boldsymbol{\epsilon}(\mathbf{u}) \stackrel{\text{def}}{=} \frac{1}{2}(\nabla \mathbf{u} + \nabla \mathbf{u}^T)$, μ being the dynamic viscosity of the fluid and \mathbf{u}_{in} being a given inlet velocity field.

2.2 0D Windkessel model

In what follows, the outlet boundary Γ^{out} is assumed to be made of n_{0D} components

$$\Gamma^{\text{out}} = \bigcup_{l=1}^{n_{0D}} \Gamma_l,$$

such that $\bar{\Gamma}_i \cap \bar{\Gamma}_j = \emptyset$ for $i, j = 1, \dots, n_{0D}$ with $i \neq j$ (see, e.g., Figure 1). We will consider a *three-element Windkessel* model (see, e.g., [11, Chapter 10] and [12]), where the pressure $P_l : \mathbb{R}^+ \rightarrow \mathbb{R}$ and the flux $Q_l : \mathbb{R}^+ \rightarrow \mathbb{R}$ on the outlet Γ_l are related through the following algebraic-differential equations:

$$\begin{cases} C_l \frac{d\pi_l}{dt} + \frac{\pi_l}{R_{d,l}} = Q_l, \\ P_l = R_{p,l} Q_l + \pi_l, \end{cases} \quad (2)$$

for $l = 1, \dots, n_{0D}$. Here, $R_{p,l}$ and $R_{d,l}$ model the proximal and distal vasculature, respectively, and the capacity C_l , take into account the deformability of the downstream vessels. The values P_l and π_l are also called *proximal* and *distal* pressures, respectively.

2.3 3D-0D coupling conditions

The 3D-0D coupling between (1) and (2) is defined through the following relations on each Γ_l

$$\begin{cases} Q_l = \int_{\Gamma_l} \mathbf{u} \cdot \mathbf{n}_f, \\ \boldsymbol{\sigma}(\mathbf{u}, p) \mathbf{n}_f = -P_l \mathbf{n}_f \quad \text{on } \Gamma_l, \end{cases} \quad (3)$$

for $l = 1, \dots, n_{0D}$ and where \mathbf{n}_f denotes the exterior unit-vector normal of Ω_f .

Energy balance. Let the quantity

$$E(t) \stackrel{\text{def}}{=} \frac{\rho_f}{2} \|\mathbf{u}\|_{0,\Omega_f}^2 + \sum_{l=1}^{n_{0D}} \frac{C_l}{2} \pi_l^2$$

denote the total (kinetic + potential) energy of the 3D-0D coupled system given by (1)-(3), while

$$D(t) \stackrel{\text{def}}{=} 2\mu \int_0^t \|\boldsymbol{\epsilon}(\mathbf{u}(s))\|_{0,\Omega_f}^2 ds + \sum_{l=1}^{n_{0D}} \int_0^t \left(\frac{\pi_l^2(s)}{R_{d,l}} + R_{p,l} Q_l^2(s) \right) ds > 0 \quad (4)$$

represents the dissipative effects. Assuming that $\mathbf{u}_{\text{in}} = \mathbf{0}$ (free system) and using a standard energy argument, we get the following identity

$$E(t) + D(t) + \int_0^t \left(\int_{\Gamma_{\text{out}}} \frac{\rho_f}{2} |\mathbf{u}(s)|^2 \mathbf{u}(s) \cdot \mathbf{n}_f \right) ds = E(0). \quad (5)$$

Remark 2.1 *Since the last term of the left-hand side can be negative, this expression does not guarantee a correct energy balance across the 3D-0D interface Γ^{out} . This issue is well-known in computational hemodynamics. The interested reader is referred to [5] for a stabilization technique, and to [10] for a different 3D-0D coupling. The methods introduced in this paper can be easily adapted to these alternative formulations.*

2.4 Time semi-discretization

We consider a fractional-step time-marching of the fluid equations (1) and a backward Euler scheme for the lumped parameter model (2). In what follows, the parameter τ denotes the time-step size, we set $t_n \stackrel{\text{def}}{=} n\tau$ for $n \in \mathbb{N}$ and $\partial_\tau x^n \stackrel{\text{def}}{=} (x^n - x^{n-1})/\tau$ stands for the first-order backward difference.

2.4.1 Fractional-step fluid time-marching

Several variants of the original Chorin-Temam projection scheme [6, 21] have been proposed in the literature (see, e.g., [14] for a recent review). The methods presented and analyzed in section 3 below do not *a priori* depend on the specific formulation considered for the projection scheme. To fix the ideas and without generality loss, we consider the non-incremental pressure-correction version (see, e.g., [14, Section 4]). Hence, we set $\tilde{\mathbf{u}}^0 = \mathbf{u}^0 = \mathbf{u}_0$ and, for $n \geq 1$, we compute $(\mathbf{u}^n, p^n, \tilde{\mathbf{u}}^n)$ by solving:

1. Viscous step:

$$\left\{ \begin{array}{l} \rho_f \frac{\tilde{\mathbf{u}}^n - \mathbf{u}^{n-1}}{\tau} + \rho_f \tilde{\mathbf{u}}^{n-1} \cdot \nabla \tilde{\mathbf{u}}^n - 2\mu \nabla \cdot \boldsymbol{\epsilon}(\tilde{\mathbf{u}}^n) = \mathbf{0} \quad \text{in } \Omega_f, \\ \tilde{\mathbf{u}}^n = \mathbf{u}_{\text{in}}(t_n) \quad \text{on } \Gamma^{\text{in}}, \\ \tilde{\mathbf{u}}^n = \mathbf{0} \quad \text{on } \Sigma. \end{array} \right. \quad (6)$$

2. Projection step:

$$\left\{ \begin{array}{l} \rho_f \frac{\mathbf{u}^n - \tilde{\mathbf{u}}^n}{\tau} + \nabla p^n = \mathbf{0} \quad \text{in } \Omega_f, \\ \nabla \cdot \mathbf{u}^n = 0 \quad \text{in } \Omega_f, \\ \mathbf{u}^n \cdot \mathbf{n}_f = \mathbf{u}_{\text{in}}(t_n) \cdot \mathbf{n}_f \quad \text{on } \Gamma^{\text{in}}, \\ \mathbf{u}^n = \mathbf{0} \quad \text{on } \Sigma. \end{array} \right. \quad (7)$$

From the implementation point of view, the projection step (7) is usually reformulated by as the pressure-Poisson problem

$$\left\{ \begin{array}{l} -\frac{\tau}{\rho_f} \Delta p^n = -\nabla \cdot \tilde{\mathbf{u}}^n \quad \text{in } \Omega_f, \\ \frac{\tau}{\rho_f} \frac{\partial p^n}{\partial \mathbf{n}_f} = 0 \quad \text{on } \Gamma^{\text{in}} \cup \Sigma. \end{array} \right. \quad (8)$$

Then, the divergence free (or *end-of-step*) velocity \mathbf{u}^n can be eliminated in (6) using the following relation (from (7)₁)

$$\mathbf{u}^n = \tilde{\mathbf{u}}^n - \frac{\tau}{\rho} \nabla p^n. \quad (9)$$

2.4.2 Backward-Euler Windkessel time-marching

Without loss of generality, we consider a backward Euler time-discretization of (2), which yields

$$\left\{ \begin{array}{l} C_l \partial_\tau \pi_l^n + \frac{\pi_l^n}{R_{d,l}} = Q_l^n, \\ P_l^n = R_{p,l} Q_l^n + \pi_l^n \end{array} \right. \quad (10)$$

or, equivalently,

$$\left\{ \begin{array}{l} \pi_l^n = \alpha_l \pi_l^{n-1} + \beta_l Q_l^n, \\ P_l^n = \gamma_l Q_l^n + \alpha_l \pi_l^{n-1}, \end{array} \right. \quad (11)$$

with the notation $\alpha_l \stackrel{\text{def}}{=} \frac{R_{d,l} C_l}{R_{d,l} C_l + \tau}$, $\beta_l \stackrel{\text{def}}{=} R_{d,l} (1 - \alpha_l)$ and $\gamma_l \stackrel{\text{def}}{=} R_{p,l} + \beta_l$.

2.5 Spatial discretization

In what follows, we will consider the usual Sobolev space $H^1(\Omega)$, for a given domain $\Omega \subset \mathbb{R}^3$. Then, for $X \subset \partial\Omega$ (with $\text{meas}(X) > 0$), we define $H_X^1(\Omega)$ the subspace of $H^1(\Omega)$ with vanishing trace on X . The scalar product in $L^2(\Omega)$ is denoted by $(\cdot, \cdot)_\Omega$ and its associated norm by $\|\cdot\|_{0,\Omega}$.

We consider a family of triangulations $\{\mathcal{T}_{f,h}\}_{0 < h \leq 1}$ of the domain Ω_f satisfying the usual requirements of finite element approximations (see, e.g., [7]). The subscript $h \in (0, 1]$ refers to the level of refinement of the triangulations. In order to ease the presentation, we assume that the family of triangulations is quasi-uniform. For the discretization in space of (1), we consider continuous Lagrange finite element approximations \mathbf{V}_h and N_h of $[H^1(\Omega_f)]^3$ and $H^1(\Omega_f)$, respectively. Other choices of approximation spaces are possible for the projection method (see [15] for a discussion). For a given $X \subset \partial\Omega_f$ (with $\text{meas}(X) > 0$), we set

$$\mathbf{V}_{X,h} \stackrel{\text{def}}{=} \mathbf{V}_h \cap [H_X^1(\Omega_f)]^3, \quad N_{X,h} \stackrel{\text{def}}{=} N_h \cap H_X^1(\Omega_f).$$

3 Fractional-step time-marching and 3D-0D coupling schemes

In this section, we describe two coupling schemes (explicit and implicit) resulting from appropriate time discretizations of the coupling conditions (3).

3.1 Explicit 3D-0D coupling scheme

In this case the 3D-0D coupling conditions (3) are time discretized as follows

$$\begin{cases} Q_l^n = \int_{\Gamma_l} \tilde{\mathbf{u}}^n \cdot \mathbf{n}_f, \\ p^n = P_l^n \quad \text{on } \Gamma_l, \\ 2\mu\boldsymbol{\epsilon}(\tilde{\mathbf{u}}^n)\mathbf{n}_f = \mathbf{0} \quad \text{on } \Gamma_l, \end{cases} \quad (12)$$

for $l = 1, \dots, n_{0D}$. Note that the continuity of fluxes (3)₁ is treated explicitly by using the flux of the latest computed viscous velocity. For the relation (3)₂ we consider a Dirichlet boundary condition for the pressure, while the viscous part of the fluid stresses is set to zero. This is a usual procedure to decouple the projection and viscous steps in the framework of projection schemes with natural boundary conditions (see, e.g., [14]).

The resulting fully discrete time-marching procedure is reported in Algorithm 1. The 3D-0D explicit coupling given by (12) allows a fully uncoupled computation of the Windkessel state, fluid pressure and velocity. This is particularly appealing from the implementation and computational efficiency point of view. Nevertheless, as suggested in Section 3.1.1 below (and then confirmed by numerical experiments in Section 5), Algorithm 1 may suffer from stability issues.

3.1.1 Stability analysis

Let the quantities

$$E^n \stackrel{\text{def}}{=} \frac{\rho_f}{2} \|\tilde{\mathbf{u}}^n\|_{0,\Omega_f}^2 + \sum_{l=1}^{n_{0D}} \frac{C_l}{2} |\pi_l^n|^2,$$

$$D^n \stackrel{\text{def}}{=} 2\mu \sum_{m=1}^n \tau \|\boldsymbol{\epsilon}(\tilde{\mathbf{u}}^m)\|_{0,\Omega_f}^2 + \sum_{m=1}^{n-1} \sum_{l=1}^{n_{0D}} \tau \left(\frac{|\pi_l^m|^2}{R_{d,l}} + R_{p,l} |Q_l^m|^2 \right),$$

Algorithm 1 Explicit 3D-0D coupling scheme

Let $\mathbf{u}^0 \stackrel{\text{def}}{=} \mathbf{u}_0$, $\tilde{\mathbf{u}}^0 \in \mathbf{V}_h$ and $\pi_1^0, \dots, \pi_{n_{0D}}^0 \in \mathbb{R}$ be given initial data. For $n \geq 1$ perform:

1. Viscous step: Find $\tilde{\mathbf{u}}^n \in \mathbf{V}_{\Sigma, h}$ such that

$$\begin{cases} \tilde{\mathbf{u}}^n|_{\Gamma^{\text{in}}} = \mathbf{u}_{\text{in}}(t_n), \\ \frac{\rho_f}{\tau} (\tilde{\mathbf{u}}^n, \mathbf{v})_{\Omega_f} + \rho_f (\tilde{\mathbf{u}}^{n-1} \cdot \nabla \tilde{\mathbf{u}}^n, \mathbf{v})_{\Omega_f} + \frac{\rho_f}{2} ((\nabla \cdot \tilde{\mathbf{u}}^{n-1}) \tilde{\mathbf{u}}^n, \mathbf{v})_{\Omega_f} \\ + 2\mu (\boldsymbol{\epsilon}(\tilde{\mathbf{u}}^n), \boldsymbol{\epsilon}(\mathbf{v}))_{\Omega_f} = \frac{\rho_f}{\tau} (\mathbf{u}^n, \mathbf{v})_{\Omega_f} \end{cases} \quad (13)$$

for all $\mathbf{v} \in \mathbf{V}_{\Sigma \cup \Gamma^{\text{in}}, h}$. Thereafter set $\tilde{Q}_l^n \stackrel{\text{def}}{=} \int_{\Gamma_l} \tilde{\mathbf{u}}^n \cdot \mathbf{n}_f$.

2. Windkessel step: For $l = 1, \dots, n_{0D}$, compute $(Q_l^n, \pi_l^n, P_l^n) \in \mathbb{R}^3$ from

$$\begin{cases} Q_l^n = \tilde{Q}_l^n, \\ C_l \partial_\tau \pi_l^n + \frac{\pi_l^n}{R_{d,l}} = Q_l^n, \\ P_l^n = R_{p,l} Q_l^n + \pi_l^n. \end{cases} \quad (14)$$

3. Projection step: Find $p^n \in N_h$ such that

$$\begin{cases} p^n|_{\Gamma_l} = P_l^n, \quad l = 1, \dots, n_{0D}, \\ \frac{\tau}{\rho_f} (\nabla p^n, \nabla q)_{\Omega_f} = -(\nabla \cdot \tilde{\mathbf{u}}^n, q)_{\Omega_f} \end{cases} \quad (15)$$

for all $q \in N_{\Gamma^{\text{out}}, h}$. Thereafter set $\mathbf{u}^n \stackrel{\text{def}}{=} \tilde{\mathbf{u}}^n + \frac{\tau}{\rho_f} \nabla p^n \in [L^2(\Omega_f)]^d$.

for $n \geq 1$, denote the energy and physical dissipation of the discrete system. Let us also set

$$E^0 \stackrel{\text{def}}{=} \frac{\rho_f}{2} \|\mathbf{u}^0\|_{0, \Omega_f}^2 + \sum_{l=1}^{n_{0D}} \frac{C_l}{2} |\pi_0^l|^2,$$

We then have the following energy based result.

Theorem 3.1 *Let $\{(\tilde{\mathbf{u}}^n, p^n)\}_{n \geq 1}$ and $\{(Q_l^n, \pi_l^n, P_l^n)_{1 \leq l \leq n_{0D}}\}_{n \geq 1}$ be the approximated solution given by Algorithm 1 and assume that $\mathbf{u}_{\text{in}} = \mathbf{0}$ (free system). The following inequality holds for $n \geq 1$*

$$\begin{aligned} E^n + D^n + \sum_{m=1}^n \frac{\rho_f}{2} \tau (\tilde{\mathbf{u}}^{m-1} \cdot \mathbf{n}_f, |\tilde{\mathbf{u}}^m|^2)_{\Gamma^{\text{out}}} &\leq E^0 - \sum_{m=1}^{n-1} \frac{\tau^2}{2\rho_f} \|\nabla p^m\|_{0, \Omega_f}^2 \\ &+ \sum_{m=1}^{n-1} \tau (\nabla \cdot \tilde{\mathbf{u}}^m, \phi^m)_{\Omega_f} + \sum_{m=1}^{n-1} \frac{\tau^2}{\rho_f} (\nabla p^m, \nabla \phi^m)_{\Omega_f}, \end{aligned} \quad (16)$$

where $\phi^n \in N_h$ is an arbitrary discrete lifting of the (unknown) proximal pressures, namely,

$$\phi^n = P_l^n \quad \text{on } \Gamma_l, \quad l = 1, \dots, n_{0D}. \quad (17)$$

Proof. We first test (13) with $\mathbf{v} = \tilde{\mathbf{u}}^n$ and integrate by parts the convective term. This yields the identity

$$\begin{aligned} \frac{\rho_f}{2} \partial_\tau \|\tilde{\mathbf{u}}^n\|_{0,\Omega_f}^2 + \frac{\rho_f}{2\tau} \|\tilde{\mathbf{u}}^n - \tilde{\mathbf{u}}^{n-1}\|_{0,\Omega_f}^2 + 2\mu \|\boldsymbol{\epsilon}(\tilde{\mathbf{u}}^n)\|_{0,\Omega_f}^2 \\ + (\nabla p^{n-1}, \tilde{\mathbf{u}}^n)_{\Omega_f} + \frac{\rho_f}{2} (\tilde{\mathbf{u}}^{n-1} \cdot \mathbf{n}_f, |\tilde{\mathbf{u}}^n|^2)_{\Gamma_{\text{out}}} = 0 \end{aligned} \quad (18)$$

for $n \geq 2$, and for $n = 1$ we get

$$\frac{\rho_f}{2\tau} \left(\|\tilde{\mathbf{u}}^1\|_{0,\Omega_f}^2 - \|\mathbf{u}^0\|_{0,\Omega_f}^2 \right) + \frac{\rho_f}{2\tau} \|\tilde{\mathbf{u}}^1 - \mathbf{u}^0\|_{0,\Omega_f}^2 + 2\mu \|\boldsymbol{\epsilon}(\tilde{\mathbf{u}}^1)\|_{0,\Omega_f}^2 + \frac{\rho_f}{2} (\tilde{\mathbf{u}}^0 \cdot \mathbf{n}_f, |\tilde{\mathbf{u}}^1|^2)_{\Gamma_{\text{out}}} = 0. \quad (19)$$

Moreover, integration by parts in (15) at time step $n - 1$ gives

$$(\nabla p^{n-1}, \nabla q)_{\Omega_f} = \frac{\rho_f}{\tau} (\tilde{\mathbf{u}}^{n-1}, \nabla q)_{\Omega_f} - \frac{\rho_f}{\tau} \int_{\partial\Omega_f} \tilde{\mathbf{u}}^{n-1} \cdot \mathbf{n}_f q = \frac{\rho_f}{\tau} (\tilde{\mathbf{u}}^{n-1}, \nabla q)_{\Omega_f},$$

since $q \in N_{\Gamma_{\text{out}},h}$ and $\tilde{\mathbf{u}}^{n-1} \in \mathbf{V}_{\Gamma_{\text{in}} \cup \Sigma, h}$, for $n \geq 2$. Then, testing the last equation with $q = \frac{\tau}{\rho_f} (p^{n-1} - \phi^{n-1}) \in N_{\Gamma_{\text{out}},h}$ we get

$$\frac{\tau}{\rho_f} \|\nabla p^{n-1}\|_{0,\Omega_f}^2 - (\tilde{\mathbf{u}}^{n-1}, \nabla p^{n-1})_{\Omega_f} + \left(\tilde{\mathbf{u}}^{n-1} - \frac{\tau}{\rho_f} \nabla p^{n-1}, \nabla \phi^{n-1} \right)_{\Omega_f} = 0.$$

Equivalently, we have

$$\frac{\tau}{\rho_f} \|\nabla p^{n-1}\|_{0,\Omega_f}^2 - (\tilde{\mathbf{u}}^n, \nabla p^{n-1})_{\Omega_f} + (\tilde{\mathbf{u}}^n - \tilde{\mathbf{u}}^{n-1}, \nabla p^{n-1})_{\Omega_f} = - \left(\tilde{\mathbf{u}}^{n-1} - \frac{\tau}{\rho_f} \nabla p^{n-1}, \nabla \phi^{n-1} \right)_{\Omega_f}.$$

By using the Cauchy-Schwarz inequality and an arithmetic-geometric inequality, we get

$$\begin{aligned} \frac{\tau}{2\rho_f} \|\nabla p^{n-1}\|_{0,\Omega_f}^2 - \frac{\rho_f}{2\tau} \|\tilde{\mathbf{u}}^n - \tilde{\mathbf{u}}^{n-1}\|_{0,\Omega_f}^2 - (\tilde{\mathbf{u}}^n, \nabla p^{n-1})_{\Omega_f} \\ \leq - \left(\tilde{\mathbf{u}}^{n-1} - \frac{\tau}{\rho_f} \nabla p^{n-1}, \nabla \phi^{n-1} \right)_{\Omega_f}. \end{aligned} \quad (20)$$

On the other hand, integrating by parts the first term in the right-hand side of (20) and using (14) and (17), we infer that

$$\begin{aligned} \frac{\tau}{2\rho_f} \|\nabla p^{n-1}\|_{0,\Omega_f}^2 - \frac{\rho_f}{2\tau} \|\tilde{\mathbf{u}}^n - \tilde{\mathbf{u}}^{n-1}\|_{0,\Omega_f}^2 - (\tilde{\mathbf{u}}^n, \nabla p^{n-1})_{\Omega_f} \\ \leq - \sum_{l=1}^{n_{0D}} Q_l^{n-1} P_l^{n-1} + (\nabla \cdot \tilde{\mathbf{u}}^{n-1}, \phi^{n-1})_{\Omega_f} + \frac{\tau}{\rho_f} (\nabla p^{n-1}, \nabla \phi^{n-1})_{\Omega_f} \end{aligned} \quad (21)$$

for $n \geq 2$. As a result, the summation of (18) and (21) gives

$$\begin{aligned} \frac{\rho_f}{2} \partial_\tau \|\tilde{\mathbf{u}}^n\|_{0,\Omega_f}^2 + 2\mu \|\boldsymbol{\epsilon}(\tilde{\mathbf{u}}^n)\|_{0,\Omega_f}^2 + \frac{\rho_f}{2} (\tilde{\mathbf{u}}^{n-1} \cdot \mathbf{n}_f, |\tilde{\mathbf{u}}^n|^2)_{\Gamma_{\text{out}}} \\ \leq - \frac{\tau}{2\rho_f} \|\nabla p^{n-1}\|_{0,\Omega_f}^2 + (\nabla \cdot \tilde{\mathbf{u}}^{n-1}, \phi^n)_{\Omega_f} + \frac{\tau}{\rho_f} (\nabla p^{n-1}, \nabla \phi^{n-1})_{\Omega_f} - \sum_{l=1}^{n_{0D}} Q_l^{n-1} P_l^{n-1} \end{aligned} \quad (22)$$

for $n \geq 2$. At last, we multiply (14)₂ by π_l^n to obtain

$$\frac{C_l}{2} \partial_\tau |\pi_l^n|^2 + \frac{C_l}{2} |\pi_l^n - \pi_l^{n-1}|^2 + \frac{1}{R_{d,l}} |\pi_l^n|^2 = Q_l^n \pi_l^n, \quad (23)$$

which combined with (14)₃ yields

$$\frac{C_l}{2} \partial_\tau |\pi_l^n|^2 + \frac{1}{R_{d,l}} |\pi_l^n|^2 + R_{p,l} |Q_l^n|^2 \leq Q_l^n P_l^n. \quad (24)$$

We now proceed by inserting (24) into (22), multiplication by τ and summation over $m = 2, \dots, n$. This yields the following estimate

$$\begin{aligned} E^n + D^n + \sum_{m=2}^n \frac{\rho_f}{2} \tau (\tilde{\mathbf{u}}^{m-1} \cdot \mathbf{n}_f, |\tilde{\mathbf{u}}^m|^2)_{\Gamma^{\text{out}}} &\leq E^1 - \sum_{m=1}^{n-1} \frac{\tau^2}{2\rho_f} \|\nabla p^m\|_{0,\Omega_f}^2 \\ &+ \sum_{m=1}^{n-1} \tau (\nabla \cdot \tilde{\mathbf{u}}^m, \phi^m)_{\Omega_f} + \sum_{m=1}^{n-1} \frac{\tau^2}{\rho_f} (\nabla p^m, \nabla \phi^m)_{\Omega_f} \end{aligned}$$

for $n \geq 2$. The estimate (16) is then recovered by simply adding to this inequality the expression (19) multiplied by τ , which completes the proof.

The left-hand side of estimate (16) corresponds to the discrete counterpart of (5). Nevertheless, the artificial power introduced by the last two terms of (16),

$$\sum_{m=1}^{n-1} \tau (\nabla \cdot \tilde{\mathbf{u}}^m, \phi^m)_{\Omega_f} + \sum_{m=1}^{n-1} \frac{\tau^2}{\rho_f} (\nabla p^m, \nabla \phi^m)_{\Omega_f}, \quad (25)$$

cannot be controlled, so that this estimate does not guarantee the energy stability of the approximations provided by Algorithm 1. Two remarks are now in order.

Remark 3.2 *It is worth mentioning that the term (25) corresponds to the residual of the projection step (15) (note that $\phi^n \notin N_{\Gamma^{\text{out},h}}$). In fact, for the space continuous counterpart of (15) we have*

$$(\nabla \cdot \tilde{\mathbf{u}}^n, \phi^n)_{\Omega_f} + \frac{\tau}{\rho_f} (\nabla p^n, \nabla \phi^n)_{\Omega_f} = \frac{\tau}{\rho_f} \int_{\Gamma^{\text{out}}} \frac{\partial p^n}{\partial \mathbf{n}_f} \phi^n = - \sum_{l=1}^{n_{0D}} \left(\int_{\Gamma_l} \mathbf{u}^n \cdot \mathbf{n}_f - \int_{\Gamma_l} \tilde{\mathbf{u}}^n \cdot \mathbf{n}_f \right) P_l^n.$$

Hence, the uncontrolled artificial power involved in the energy estimate (16) is due to the time-lag in the flux ($\int_{\Gamma_l} \tilde{\mathbf{u}}^n \cdot \mathbf{n}_f$ instead of $\int_{\Gamma_l} \mathbf{u}^n \cdot \mathbf{n}_f$) introduced by the explicit treatment of the continuity of fluxes (12)₁ on the 3D-0D interfaces Γ_l .

Remark 3.3 *In the case of a single outlet (i.e., $n_{0D} = 1$), we can take $\phi^n = P^n$ in Ω_f , so that the right hand-side of (20) vanishes. From the proof of Proposition 3.1 we then recover the following energy estimate for the fluid*

$$\begin{aligned} \frac{\rho_f}{2} \|\tilde{\mathbf{u}}^n\|_{0,\Omega_f}^2 + 2\mu \sum_{m=1}^n \tau \|\epsilon(\tilde{\mathbf{u}}^m)\|_{0,\Omega_f}^2 + \sum_{m=1}^n \frac{\rho_f}{2} \tau (\tilde{\mathbf{u}}^{m-1} \cdot \mathbf{n}_f, |\tilde{\mathbf{u}}^m|^2)_{\Gamma^{\text{out}}} \\ \leq \frac{\rho_f}{2} \|\mathbf{u}^0\|_{0,\Omega_f}^2 - \sum_{m=1}^{n-1} \frac{\tau^2}{2\rho_f} \|\nabla p^m\|_{0,\Omega_f}^2. \end{aligned}$$

As a result, the energy stability of the fluid does not depend on the imposed outlet pressure.

3.2 Implicit 3D-0D coupling scheme

In this case the 3D-0D coupling conditions (3) are time-discretized as follows

$$\begin{cases} Q_l^n = \int_{\Gamma_l} \mathbf{u}^n \cdot \mathbf{n}_f, \\ p^n = P_l^n \quad \text{on } \Gamma_l, \\ 2\mu\epsilon(\tilde{\mathbf{u}}^n)\mathbf{n}_f = \mathbf{0} \quad \text{on } \Gamma_l, \end{cases} \quad (26)$$

for $l = 1, \dots, n_{0D}$. Note that, in comparison with (12), the above coupling scheme treats implicitly the continuity of fluxes on the outlet boundaries. This feature enhances stability, as we will show in Section 3.2.1. However, from the computational point of view, the relations (26)_{1,2} and (10) apparently couple the evaluation of (8) and (9). Fortunately, this difficulty can be circumvented via an appropriate reformulation of the pressure (26)₂ boundary condition for the projection step (8). Indeed, by inserting (9) into (26)₁, we get

$$Q_l^n = \tilde{Q}_l^n - \frac{\tau}{\rho_f} \int_{\Gamma_l} \frac{\partial p^n}{\partial \mathbf{n}_f}, \quad (27)$$

which with (11) and (26)₂ yields the following (implicit) boundary condition for the outlet pressures:

$$p^n|_{\Gamma_l} = \gamma_l \tilde{Q}_l^n - \frac{\gamma_l \tau}{\rho_f} \int_{\Gamma_l} \frac{\partial p^n}{\partial \mathbf{n}_f} + \alpha_l \pi_l^{n-1} \quad (28)$$

for $l = 1, \dots, n_{0D}$. Note that this expression still enforces p^n to be constant on each Γ_l .

Multiplying (8)₁ by $q \in N_h$, integrating by parts, using (8)₁ and the fact that $q|_{\Gamma_l}$ is constant, we get

$$\frac{\tau}{\rho_f} (\nabla p^n, \nabla q)_{\Omega_f} - \frac{\tau}{\rho_f} \sum_{l=1}^{n_{0D}} \left(\int_{\Gamma_l} \frac{\partial p^n}{\partial \mathbf{n}_f} \right) q|_{\Gamma_l} = - (\nabla \cdot \tilde{\mathbf{u}}^n, q)_{\Omega_f}$$

for all $q \in N_h$. We can eliminate the normal derivative of the pressure using (28), which yields the following modified variational formulation for the projection step: Find $p^n \in N_h$ such that

$$\frac{\tau}{\rho_f} (\nabla p^n, \nabla q)_{\Omega_f} + \sum_{l=1}^{n_{0D}} \frac{(p^n|_{\Gamma_l})(q|_{\Gamma_l})}{\gamma_l} = \sum_{l=1}^{n_{0D}} \left(\tilde{Q}_l^n + \frac{\alpha_l \pi_l^{n-1}}{\gamma_l} \right) q|_{\Gamma_l} - (\nabla \cdot \tilde{\mathbf{u}}^n, q)_{\Omega_f} \quad (29)$$

for all $q \in N_h$. We can then set $P_l^n = p^n|_{\Gamma_l}$ and retrieve (Q_l^n, π_l^n) from (11), for $l = 1, \dots, n_{0D}$.

Remark 3.4 *The well-posedness of the pressure-Poisson problem (29) follows from a generalized Poincaré's inequality, which guarantees the coercivity of the left-hand side of (29) in N_h .*

Remark 3.5 *Testing (29) with $q = 1$, and since $P_l^n = p^n|_{\Gamma_l}$, we have*

$$\sum_{l=1}^{n_{0D}} \frac{P_l^n - \alpha_l \pi_l^{n-1}}{\gamma_l} = \sum_{l=1}^{n_{0D}} \tilde{Q}_l^n + \int_{\Omega_f} \nabla \cdot \tilde{\mathbf{u}}^n.$$

Hence, integrating by parts in the last term, using (11)₂ and owing to (6)_{2,3} we get the following mass conservation for the Windkessel fluxes:

$$\sum_{l=1}^{n_{0D}} Q_l^n = - \int_{\Gamma^{\text{in}}} \mathbf{u}_{\text{in}}(t_n).$$

The complete time-marching procedures is reported in Algorithm 2.

Algorithm 2 3D-0D implicit coupling scheme

Let $\mathbf{u}^0 = \mathbf{u}_0$, $\tilde{\mathbf{u}}^0 \in \mathbf{V}_h$, and $\pi_1^0, \dots, \pi_{n_{0D}}^0 \in \mathbb{R}$ be given initial data. For $n \geq 1$ perform:

1. Viscous step: Find $\tilde{\mathbf{u}}^n \in \mathbf{V}_{\Sigma, h}$ such that

$$\begin{cases} \tilde{\mathbf{u}}^n|_{\Gamma^{\text{in}}} = \mathbf{u}_{\text{in}}(t_n), \\ \frac{\rho_f}{\tau} (\tilde{\mathbf{u}}^n, \mathbf{v})_{\Omega_f} + \rho_f (\tilde{\mathbf{u}}^{n-1} \cdot \nabla \tilde{\mathbf{u}}^n, \mathbf{v})_{\Omega_f} + 2\mu (\boldsymbol{\epsilon}(\tilde{\mathbf{u}}^n), \boldsymbol{\epsilon}(\mathbf{v}))_{\Omega_f} \\ + \frac{\rho_f}{2} ((\nabla \cdot \tilde{\mathbf{u}}^{n-1}) \tilde{\mathbf{u}}^n, \mathbf{v})_{\Omega_f} = \frac{\rho_f}{\tau} (\mathbf{u}^{n-1}, \mathbf{v})_{\Omega_f} \end{cases} \quad (30)$$

for all $\mathbf{v} \in \mathbf{V}_{\Sigma \cup \Gamma^{\text{in}}, h}$. Thereafter set $\tilde{Q}_l^n \stackrel{\text{def}}{=} \int_{\Gamma_l} \tilde{\mathbf{u}}^n \cdot \mathbf{n}_f$.

2. Projection-Windkessel step: Find $p^n \in N_h$ and such that

$$\frac{\tau}{\rho_f} (\nabla p^n, \nabla q)_{\Omega_f} + \sum_{l=1}^{n_{0D}} \frac{(p^n|_{\Gamma_l})(q|_{\Gamma_l})}{\gamma_l} = \sum_{l=1}^{n_{0D}} \left(\tilde{Q}_l^n + \frac{\alpha_l \pi_l^{n-1}}{\gamma_l} \right) q|_{\Gamma_l} - (\nabla \cdot \tilde{\mathbf{u}}^n, q)_{\Omega_f} \quad (31)$$

for all $q \in N_h$. Thereafter, set $P_l^n = p^n|_{\Gamma_l}$ and compute $(Q_l^n, \pi_l^n) \in \mathbb{R}^2$ from the relations

$$Q_l^n = \frac{P_l^n - \alpha_l \pi_l^{n-1}}{\gamma_l}, \quad \pi_l^n = \alpha_l \pi_l^{n-1} + \beta_l Q_l^n, \quad l = 1, \dots, n_{0D} \quad (32)$$

and set $\mathbf{u}^n \stackrel{\text{def}}{=} \tilde{\mathbf{u}}^n - \frac{\tau}{\rho_f} \nabla p^n \in [L^2(\Omega_f)]^d$.

3.2.1 Stability analysis

The focus of this section is to present the stability result of the formulation (30)-(32) summarized in the following proposition.

Theorem 3.6 *Let $\{(\tilde{\mathbf{u}}^n, p^n)\}_{n \geq 1}$ and $\{(Q_l^n, \pi_l^n, P_l^n)_{1 \leq l \leq n_{\text{OD}}}\}_{n \geq 1}$ be the approximated solution given by Algorithm 2 and assume that $\mathbf{u}_{\text{in}} = \mathbf{0}$ (free system). The following energy inequality holds*

$$E^n + D^n + \sum_{m=1}^n \frac{\rho_f}{2} (\tilde{\mathbf{u}}^{m-1} \cdot \mathbf{n}_f, |\tilde{\mathbf{u}}^m|^2)_{\Gamma_{\text{out}}} \leq E^0 - \sum_{m=1}^{n-1} \frac{\tau^2}{2\rho_f} \|\nabla p^m\|_{0,\Omega_f}^2. \quad (33)$$

Proof. We proceed as in the proof of Proposition 3.1. Testing the viscous step (30) with $\mathbf{v} = \tilde{\mathbf{u}}^n$ yields

$$\begin{aligned} \frac{\rho_f}{2} \partial_\tau \|\tilde{\mathbf{u}}^n\|_{0,\Omega_f}^2 + \frac{\rho_f}{2\tau} \|\tilde{\mathbf{u}}^n - \tilde{\mathbf{u}}^{n-1}\|_{0,\Omega_f}^2 + 2\mu \|\epsilon(\tilde{\mathbf{u}}^n)\|_{0,\Omega_f}^2 \\ + (\nabla p^{n-1}, \tilde{\mathbf{u}}^n)_{\Omega_f} + \frac{\rho_f}{2} (\tilde{\mathbf{u}}^{n-1} \cdot \mathbf{n}_f, |\tilde{\mathbf{u}}^n|^2)_{\Gamma_{\text{out}}} = 0 \end{aligned} \quad (34)$$

for $n \geq 2$ and, for $n = 1$, we get

$$\frac{\rho_f}{2\tau} (\|\tilde{\mathbf{u}}^1\|_{0,\Omega_f}^2 - \|\mathbf{u}^0\|_{0,\Omega_f}^2) + \frac{\rho_f}{2\tau} \|\tilde{\mathbf{u}}^1 - \mathbf{u}^0\|_{0,\Omega_f}^2 + 2\mu \|\epsilon(\tilde{\mathbf{u}}^1)\|_{0,\Omega_f}^2 + \frac{\rho_f}{2} (\tilde{\mathbf{u}}^0 \cdot \mathbf{n}_f, |\tilde{\mathbf{u}}^1|^2)_{\Gamma_{\text{out}}} = 0. \quad (35)$$

Thereafter, taking (31) at time step $n - 1$, testing with $q = \frac{\tau}{\rho_f} p^{n-1}$ and integrating by parts in its right-hand side it yields

$$\frac{\tau}{\rho_f} \|\nabla p^{n-1}\|_{0,\Omega_f}^2 + \sum_{l=1}^{n_{\text{OD}}} \frac{P_l^{n-1} - \alpha_l \pi_l^{n-2}}{\gamma_l} P_l^{n-1} = (\tilde{\mathbf{u}}^{n-1}, \nabla p^{n-1})_{\Omega_f}.$$

for $n \geq 2$. Hence, the addition and subtraction of suitable terms and the application of the Cauchy-Schwarz and arithmetic-geometric inequalities yields

$$\frac{\tau}{2\rho_f} \|\nabla p^{n-1}\|_{0,\Omega_f}^2 - \frac{\rho_f}{2\tau} \|\tilde{\mathbf{u}}^n - \tilde{\mathbf{u}}^{n-1}\|_{0,\Omega_f}^2 - (\tilde{\mathbf{u}}^n, \nabla p^{n-1})_{\Omega_f} + \sum_{l=1}^{n_{\text{OD}}} \frac{P_l^{n-1} - \alpha_l \pi_l^{n-2}}{\gamma_l} P_l^{n-1} \leq 0. \quad (36)$$

As a result, the summation of (34) and (36) gives

$$\begin{aligned} \frac{\rho_f}{2} \partial_\tau \|\tilde{\mathbf{u}}^n\|_{0,\Omega_f}^2 + 2\mu \|\epsilon(\tilde{\mathbf{u}}^n)\|_{0,\Omega_f}^2 + \frac{\rho_f}{2} (\tilde{\mathbf{u}}^{n-1} \cdot \mathbf{n}_f, |\tilde{\mathbf{u}}^n|^2)_{\Gamma_{\text{out}}} \\ + \sum_{l=1}^{n_{\text{OD}}} \frac{P_l^{n-1} - \alpha_l \pi_l^{n-2}}{\gamma_l} P_l^{n-1} \leq -\frac{\tau}{2\rho_f} \|\nabla p^{n-1}\|_{0,\Omega_f}^2 \end{aligned} \quad (37)$$

for $n \geq 2$. At last, from (32) and its equivalence to (11), we have

$$\begin{aligned} \frac{P_l^n - \alpha_l \pi_l^{n-1}}{\gamma_l} P_l^n &= Q_l^n P_l^n = R_{p,l} |Q_l^n|^2 + Q_l^n \pi_l^n \\ &\geq \frac{C_l}{2} \partial_\tau |\pi_l^n|^2 + \frac{1}{R_{d,l}} |\pi_l^n|^2 + R_{p,l} |Q_l^n|^2 \end{aligned} \quad (38)$$

for $n \geq 1$. Hence, by inserting the last inequality of (38) into (37), multiplying by τ and summing over $m = 2, \dots, n$ we get the estimate

$$E^n + D^n + \sum_{m=2}^n \frac{\rho_f}{2} (\tilde{\mathbf{u}}^{m-1} \cdot \mathbf{n}_f, |\tilde{\mathbf{u}}^m|^2)_{\Gamma^{\text{out}}} \leq E^1 - \sum_{m=1}^{n-1} \frac{\tau^2}{2\rho_f} \|\nabla p^m\|_{0, \Omega_f}^2.$$

for $n \geq 2$. We recover the estimate (33) by simply adding to this inequality the expression (35) multiplied by τ , which completes the proof.

The estimate (33) corresponds to the discrete counterpart of (5). Note that the right-hand side of (33) is a pure numerical dissipation term (the natural pressure stabilization of the projection scheme). Therefore, the 3D-0D coupling reported in Algorithm 2 does not introduce any uncontrolled artificial power and, hence, a guaranty of numerical stability. This feature will be illustrated in Section 5 via numerical experiments.

3.2.2 Implementation details

In this section we discuss the implementation of the pressure problem (31) in a finite element framework. For the sake of simplicity, and without loss of generality, we limit the discussion to the case of a single outlet. We define the arrays $P, V \in \mathbb{R}^N$ corresponding to the degrees of freedom (d.o.f.) of the pressure $p^n \in Q_h$ and of a general test function $q \in Q_h$, respectively. The bilinear form $(\nabla p^n, \nabla q)_{\Omega_f}$, without imposing Dirichlet boundary conditions to p^n , can be written in matrix form as

$$(\nabla p^n, \nabla q)_{\Omega_f} = V^T A P = \begin{bmatrix} V_I^T & V_O^T \end{bmatrix} \begin{bmatrix} A_{II} & A_{IO} \\ A_{OI} & A_{OO} \end{bmatrix} \begin{bmatrix} P_I \\ P_O \end{bmatrix},$$

where the subindexes O and I indicate the elements of the array corresponding to the d.o.f. on Γ^{out} and $\bar{\Omega} \setminus \Gamma^{\text{out}}$, respectively. Hence, the pressure-Poisson projection step with explicit Dirichlet data can be formulated as

$$A_{II} P_I = \tilde{F}_I - A_{IO} \mathbb{1}_O p_{|\Gamma^{\text{out}}}^n, \quad (39)$$

where the notation in right-hand side is such that

$$\begin{bmatrix} V_I^T & V_O^T \end{bmatrix} \begin{bmatrix} \tilde{F}_I \\ \tilde{F}_O \end{bmatrix} = \frac{\rho_f}{\tau} (\nabla \cdot \tilde{\mathbf{u}}^n, q)_{\Omega_f},$$

with $\mathbb{1}_O \in \mathbb{R}^{N_O}$ denoting a vector of ones, with N_O being the number of pressure d.o.f. on Γ^{out} . The linear system (39) is usually solved by means of a preconditioned conjugate gradient methods (PCG), with the preconditioning operator \hat{A}_{II}^{-1} given, for example, by an incomplete Cholesky factorization of A_{II} (alternative preconditioners could be used). With the notations introduced above, the stiffness matrix of the implicit formulation (31) can be derived straightforwardly. Indeed, since $V_O = \mathbb{1}_O q_{|\Gamma^{\text{out}}}$ and $P_O = \mathbb{1}_O p_{|\Gamma^{\text{out}}}^n$, we obtain

$$\begin{bmatrix} A_{II} & \mathbf{a} \\ \mathbf{a}^T & b \end{bmatrix} \begin{bmatrix} P_I \\ p_{|\Gamma^{\text{out}}}^n \end{bmatrix} = \begin{bmatrix} \tilde{F}_I \\ \mathbb{1}_O^T \tilde{F}_I + \frac{\rho_f}{\tau} \left(\tilde{Q}^n + \frac{\alpha \pi^{n-1}}{\gamma} \right) \end{bmatrix}, \quad (40)$$

with $\mathbf{a} \stackrel{\text{def}}{=} A_{IO} \mathbb{1}_O$ and $b \stackrel{\text{def}}{=} \mathbb{1}_O^T A_{OO} \mathbb{1}_O + \frac{\rho_f}{\tau \gamma}$. It should be noted that the matrix in (40) has a non-standard sparsity pattern. However, since we use a Krylov linear solver this matrix is never

assembled in practice (only matrix-vector products are evaluated). In the numerical experiments, we have considered the block-preconditioner given by

$$\begin{bmatrix} \hat{A}_{II}^{-1} & 0 \\ 0 & 1 \end{bmatrix},$$

which yielded practically the same number of PCG-iterations than in the solution of (39). In the general case of a domain Ω_f with multiple outlets, the aforementioned considerations can be extended by considering one additional equation for each 3D-0D interface.

4 Incompressible fluid-structure interaction

Fractional-step time-marching schemes have been a valuable tool for the design of efficient solution methods for incompressible fluid-structure interaction (FSI) problems, yielding the so-called projection semi-implicit coupling scheme [9] (see also the subsequent works [1, 2, 19]). This coupling approach is based on the following three basic ideas:

- treat explicitly the geometrical non-linearities and the viscous-structure coupling, which reduces computational complexity;
- treat implicitly the pressure-structure coupling, which avoids numerical instability;
- perform this explicit-implicit splitting through a projection scheme in the fluid.

So far, the stability of this method has been analyzed within a simplified framework which enforces null pressure on the outlet boundaries (see [1, 9]). In this section the analysis is extended to the case of a lumped parameter modeling of the outlet boundaries, with a pressure-Poisson formulation of the projection step, based on the methods of Section 3.

4.1 Model problem

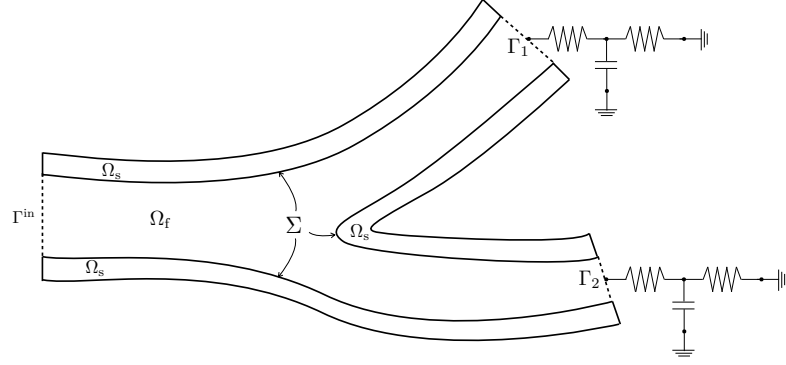


Figure 2: Examples of geometric configuration $\overline{\Omega_s} \neq \Sigma$ ($\overline{\Omega_s} = \Sigma$, see Figure 1).

For the sake of the analysis (see [9]), we consider as model problem a coupled linear system in which the fluid is described by the Stokes equations, in the fixed domain Ω_f , and the structure either by the classical linear elastodynamics equations or by equations based on linear thin-solid models (e.g., plate, shell, etc.). The reference domain of the solid is denoted by Ω_s . It will be either a domain or a 2-manifold of \mathbb{R}^3 (in this later case the elastic domain is identified to its mid-surface). We denote by $\Sigma \stackrel{\text{def}}{=} \partial\Omega_s \cap \partial\Omega_f$ the fluid-structure interface. In the case the structure is described by thin-solid model we have $\overline{\Omega_s} = \Sigma$ (see Figure 2). The resulting coupled system, describing the fluid velocity $\mathbf{u} : \Omega_f \times \mathbb{R}^+ \rightarrow \mathbb{R}^3$, fluid pressure $p : \Omega_f \times \mathbb{R}^+ \rightarrow \mathbb{R}$ and solid displacement $\mathbf{y} : \Omega_s \times \mathbb{R}^+ \rightarrow \mathbb{R}^3$, is given by

$$\begin{cases} \rho_f \partial_t \mathbf{u} - \nabla \cdot \boldsymbol{\sigma}(\mathbf{u}, p) = \mathbf{0} & \text{in } \Omega_f, \\ \nabla \cdot \mathbf{u} = 0 & \text{in } \Omega_f, \\ \mathbf{u} = \mathbf{u}_{\text{in}} & \text{on } \Gamma^{\text{in}}, \\ \mathbf{u} = \dot{\mathbf{y}} & \text{in } \Sigma, \end{cases} \quad (41)$$

$$\begin{cases} \rho_s (\partial_t \dot{\mathbf{y}}, \mathbf{v}_s)_{\Omega_s} + a_s(\mathbf{y}, \mathbf{v}_s) = -(\boldsymbol{\sigma}(\mathbf{u}, p) \mathbf{n}_f, \mathbf{v}_s)_{\Sigma} & \forall \mathbf{v}_s \in \mathbf{W}, \\ \dot{\mathbf{y}} = \partial_t \mathbf{y} & \text{in } \Omega_s, \end{cases} \quad (42)$$

completed with the lumped-parameter modeling (2)-(3) on the outlet boundary Γ^{out} (see Figure 2). Here, ρ_s denotes the solid density, the abstract bilinear form $a_s : \mathbf{W} \times \mathbf{W} \rightarrow \mathbb{R}$ describes

the elastic behavior of the structure and \mathbf{W} stands for its space of admissible displacements. It should be noted that the solid problem (42) has been written in weak form, which allows to treat in the same formulation the case of thin and thick solid models. The relations (41)₄ and (42)₁ enforce the so-called kinematic and kinetic interface coupling conditions, respectively. Note that the latter represents also the variational formulation of the structure subproblem. Though simplified, problem (41)-(42) features some of the main numerical issues that appear in complex nonlinear fluid-structure interaction problems involving an incompressible fluid (see, e.g., [8]).

Energy balance Let the quantity

$$E(t) \stackrel{\text{def}}{=} \frac{\rho_f}{2} \|\mathbf{u}\|_{0,\Omega_f}^2 + \frac{\rho_s}{2} \|\dot{\mathbf{y}}\|_{0,\Omega_s}^2 + \frac{1}{2} \|\mathbf{y}\|_s^2 + \sum_{l=1}^{n_{\text{OD}}} \frac{C_l}{2} \pi_l^2$$

denote the total (kinetic + potential) energy of the FSI-0D coupled system given by (41)-(42) and (2)-(3). Here, $\|\cdot\|_s$ stands for the elastic energy norm of the solid, defined as $\|\mathbf{y}\|_s^2 \stackrel{\text{def}}{=} a_s(\mathbf{y}, \mathbf{y})$. Assuming that $\mathbf{u}_{\text{in}} = \mathbf{0}$ (free system) and using a standard energy argument, we get the following identity

$$E(t) + D(t) = E(0), \quad (43)$$

with the dissipative term $D(t) > 0$ given as in (4).

4.1.1 Spatial discretization

Let $\{\mathcal{T}_{s,h}\}_{0 < h \leq 1}$ be a quasi-uniform family of triangulations of the domain Ω_s . In order to ease the presentation, we assume that the fluid and solid triangulations $\mathcal{T}_{f,h}$ and $\mathcal{T}_{s,h}$ match at the interface Σ . For the discretization in space of the solid problem (42), we consider continuous Lagrange finite element approximations, \mathbf{W}_h of \mathbf{W} , which match the fluid velocity discretizations at the interface. Hence,

$$\{\mathbf{v}|_{\Sigma} \mid \mathbf{v} \in \mathbf{V}_h\} = \{\mathbf{v}_s|_{\Sigma} \mid \mathbf{v}_s \in \mathbf{W}_h\}.$$

At last, we introduce the standard fluid-sided discrete lifting operator $\mathcal{L}_h : \mathbf{W}_h \rightarrow \mathbf{V}_h$, such that, the nodal values of $\mathcal{L}_h \mathbf{v}_s$ vanish out of Σ and $(\mathcal{L}_h \mathbf{v}_s)|_{\Sigma} = \mathbf{v}_s|_{\Sigma}$, for all $\mathbf{v}_s \in \mathbf{W}_h$. In what follows we shall make use of the following continuity estimates (from [9, Lemma 1]) for the discrete lifting operator \mathcal{L}_h :

$$\|\mathcal{L}_h \mathbf{v}_s\|_{0,\Omega_f} \leq C_L h^{\frac{1-\alpha}{2}} \|\mathbf{v}_s\|_{0,\Omega_s}, \quad \|\nabla \mathcal{L}_h \mathbf{v}_s\|_{0,\Omega_f} \leq C_L h^{-\frac{1+\alpha}{2}} \|\mathbf{v}_s\|_{0,\Omega_s} \quad (44)$$

for all $\mathbf{v}_s \in \mathbf{W}_h$ and with the notation

$$\alpha \stackrel{\text{def}}{=} \begin{cases} 0 & \text{if } \overline{\Omega_s} = \Sigma, \\ 1 & \text{if } \overline{\Omega_s} \neq \Sigma. \end{cases} \quad (45)$$

4.1.2 Semi-implicit FSI coupling scheme with implicit 3D-0D coupling scheme

In this case we consider numerical approximations of the coupled problem FSI-0D system (41)-(42) and (2)-(3) by combining the projection semi-implicit coupling scheme reported in [9] with the 3D-0D implicit coupling of Section 3.2. The resulting fully discrete time-marching procedure is reported in Algorithm 3. In the solid subproblem (49), the fluid residual terms are given by

$$\begin{aligned} \langle \mathcal{R}_\mu(\tilde{\mathbf{u}}^n, \mathbf{v}) \rangle &\stackrel{\text{def}}{=} \frac{\rho_f}{\tau} (\tilde{\mathbf{u}}^n, \mathbf{v})_{\Omega_f} + 2\mu (\boldsymbol{\epsilon}(\tilde{\mathbf{u}}^n), \boldsymbol{\epsilon}(\mathbf{v}))_{\Omega_f} - \frac{\rho_f}{\tau} (\mathbf{u}^{n-1}, \mathbf{v})_{\Omega_f}, \\ \langle \mathcal{R}_p(p^n, \mathbf{u}^n, \mathbf{v}) \rangle &\stackrel{\text{def}}{=} \frac{\rho_f}{\tau} (\mathbf{u}^n, \mathbf{v})_{\Omega_f} - \frac{\rho_f}{\tau} (\tilde{\mathbf{u}}^n, \mathbf{v})_{\Omega_f} - (p^n, \nabla \cdot \mathbf{v})_{\Omega_f}. \end{aligned}$$

Let the quantities

$$\begin{aligned} E^n &\stackrel{\text{def}}{=} \frac{\rho_f}{2} \|\mathbf{u}^n\|_{0,\Omega_f}^2 + \frac{\rho_s}{2} \|\dot{\mathbf{y}}^n\|_{0,\Omega_s}^2 + \frac{1}{2} \|\mathbf{y}^n\|_s^2 + \sum_{l=1}^{n_{\text{OD}}} \frac{C_l}{2} |\pi_l^n|^2, \\ D^n &\stackrel{\text{def}}{=} 2\mu \sum_{m=1}^n \tau \|\boldsymbol{\epsilon}(\tilde{\mathbf{u}}^m)\|_{0,\Omega_f}^2 + \sum_{m=1}^{n-1} \sum_{l=1}^{n_{\text{OD}}} \tau \left(\frac{|\pi_l^m|^2}{R_{d,l}} + R_{p,l} |Q_l^m|^2 \right) \end{aligned}$$

for $n \geq 1$, denote the energy and physical dissipation of the discrete FSI-0D system. We then have the following energy based result.

Theorem 4.1 *Let $\{(\tilde{\mathbf{u}}^n, p^n, \mathbf{y}^n, \dot{\mathbf{y}}^n)\}_{n \geq 1}$ and $\{(Q_l^n, \pi_l^n, P_l^n)_{1 \leq l \leq n_{\text{OD}}}\}_{n \geq 1}$ be the approximated solution given by Algorithm 3, and assume that $\mathbf{u}_{\text{in}} = \mathbf{0}$ (free system) and that the following condition holds*

$$\rho_s \geq 3C_L \left(\rho_f h^{1-\alpha} + \frac{\mu\tau}{h^{1+\alpha}} \right), \quad (51)$$

with α given by (45). Then, following energy inequality holds

$$E^n + D^n \lesssim E^0 - \sum_{m=1}^{n-1} \frac{\tau^2}{\rho_f} \|\Pi_h^\perp(\nabla p^m)\|_{0,\Omega_f}^2, \quad (52)$$

with $\Pi_h : \mathbf{L}^2(\Omega^f) \rightarrow \mathbf{V}_{\Sigma \cup \Gamma^{\text{in}},h}$ stands for the L^2 -projection operator into $\mathbf{V}_{\Sigma \cup \Gamma^{\text{in}},h}$, and $\Pi_h^\perp \stackrel{\text{def}}{=} I - \Pi_h$ for the corresponding orthogonal projection.

Proof. First, testing the viscous step (46) with $\mathbf{v} = \tilde{\mathbf{u}}^n - \mathcal{L}_h \dot{\mathbf{y}}^{n-1}$ yields

$$\begin{aligned} \frac{\rho_f}{2\tau} \left(\|\tilde{\mathbf{u}}^n\|_{0,\Omega_f}^2 - \|\mathbf{u}^{n-1}\|_{0,\Omega_f}^2 \right) + \frac{\rho_f}{2\tau} \|\tilde{\mathbf{u}}^n - \mathbf{u}^{n-1}\|_{0,\Omega_f}^2 \\ + 2\mu \|\boldsymbol{\epsilon}(\tilde{\mathbf{u}}^n)\|_{0,\Omega_f}^2 - \langle \mathcal{R}_\mu(\tilde{\mathbf{u}}^n), \mathcal{L}_h \dot{\mathbf{y}}^{n-1} \rangle = 0. \end{aligned} \quad (53)$$

On the other hand, testing (48) with $\mathbf{v} = \mathbf{u}^n - \mathcal{L}_h \dot{\mathbf{y}}^n$ yields

$$\begin{aligned} \frac{\rho_f}{2\tau} \left(\|\mathbf{u}^n\|_{0,\Omega_f}^2 - \|\tilde{\mathbf{u}}^n\|_{0,\Omega_f}^2 \right) + \frac{\rho_f}{2\tau} \|\mathbf{u}^n - \tilde{\mathbf{u}}^n\|_{0,\Omega_f}^2 \\ + (\nabla p^n, \mathbf{u}^n)_{\Omega_f} - (p^n, \dot{\mathbf{y}}^n \cdot \mathbf{n}_f)_\Sigma - \langle \mathcal{R}_p(p^n, \mathbf{u}^n), \mathcal{L}_h \dot{\mathbf{y}}^n \rangle = 0 \end{aligned} \quad (54)$$

Algorithm 3 Semi-implicit FSI coupling scheme with implicit 3D-0D coupling scheme

2. Implicit step (projection-Windkessel-solid step): Find $(p^n, \mathbf{u}^n, \mathbf{y}^n) \in N_h \times \mathbf{V}_h \times \mathbf{W}_h$ with $\dot{\mathbf{y}}^n = \partial_{\tau} \mathbf{y}^n$ and such that

$$\begin{cases} \frac{\tau}{\rho_f} (\nabla p^n, \nabla q)_{\Omega_f} + \sum_{l=1}^{n_{0D}} \frac{(p^n|_{\Gamma_l})(q|_{\Gamma_l})}{\gamma_l} = \sum_{l=1}^{n_{0D}} \left(\tilde{Q}_l^n + \frac{\alpha_l \pi_l^{n-1}}{\gamma_l} \right) q|_{\Gamma_l} \\ - (\nabla \cdot \tilde{\mathbf{u}}^n, q)_{\Omega_f} - ((\dot{\mathbf{y}}^n - \tilde{\mathbf{u}}^n) \cdot \mathbf{n}_f, q)_{\Sigma}, \end{cases} \quad (47)$$

$$\begin{cases} \mathbf{u}^n|_{\Gamma^{\text{in}}} = \mathbf{u}_{\text{in}}(t_n), \\ \mathbf{u}^n|_{\Sigma} = \dot{\mathbf{y}}^n|_{\Sigma}, \\ \frac{\rho_f}{\tau} (\mathbf{u}^n, \mathbf{v})_{\Omega_f} = \frac{\rho_f}{\tau} (\tilde{\mathbf{u}}^n, \mathbf{v})_{\Omega_f} - (\nabla p^n, \mathbf{v})_{\Omega_f}, \end{cases} \quad (48)$$

$$\rho_s (\partial_{\tau} \dot{\mathbf{y}}^n, \mathbf{v}_s)_{\Omega_s} + a_s (\mathbf{y}^n, \mathbf{v}_s) = - \langle \mathcal{R}_{\mu}(\tilde{\mathbf{u}}^n), \mathcal{L}_h \mathbf{v}_s \rangle - \langle \mathcal{R}_p(\mathbf{u}^n, p^n), \mathcal{L}_h \mathbf{v}_s \rangle \quad (49)$$

for all $(q, \mathbf{v}, \mathbf{v}_s) \in N_h \times \mathbf{V}_{\Sigma \cup \Gamma^{\text{out}}, h} \times \mathbf{W}_h$.

Thereafter, set $P_l^n = p^n|_{\Gamma_l}$ and compute $(Q_l^n, \pi_l^n) \in \mathbb{R}^2$ from the relations

$$Q_l^n = \frac{P_l^n - \alpha_l \pi_l^{n-1}}{\gamma_l}, \quad \pi_l^n = \alpha_l \pi_l^{n-1} + \beta_l Q_l^n, \quad l = 1, \dots, n_{0D}. \quad (50)$$

and taking $\mathbf{v}_s = \dot{\mathbf{y}}^n$ in (49) yields

$$\begin{aligned} \frac{\rho_s}{2} \partial_{\tau} \|\dot{\mathbf{y}}^n\|_{0, \Omega_s}^2 + \frac{\rho_s}{2\tau} \|\dot{\mathbf{y}}^n - \dot{\mathbf{y}}^{n-1}\|_{0, \Omega_s}^2 + \frac{1}{2} \partial_{\tau} \|\mathbf{y}^n\|_s^2 + \frac{1}{2\tau} \|\mathbf{y}^n - \mathbf{y}^{n-1}\|_s^2 \\ = - \langle \mathcal{R}_{\mu}(\tilde{\mathbf{u}}^n), \mathcal{L}_h \dot{\mathbf{y}}^n \rangle - \langle \mathcal{R}_p(p^n, \mathbf{u}^n), \mathcal{L}_h \dot{\mathbf{y}}^n \rangle. \end{aligned} \quad (55)$$

As a result, by adding the equalities (53)-(55) we get

$$\begin{aligned} \frac{\rho_f}{2} \partial_{\tau} \|\mathbf{u}^n\|_{0, \Omega_f}^2 + 2\mu \|\boldsymbol{\epsilon}(\tilde{\mathbf{u}}^n)\|_{0, \Omega_f}^2 + \frac{\rho_s}{2} \partial_{\tau} \|\dot{\mathbf{y}}^n\|_{0, \Omega_s}^2 + \frac{1}{2} \partial_{\tau} \|\mathbf{y}^n\|_s^2 \\ + \frac{\rho_s}{2\tau} \|\dot{\mathbf{y}}^n - \dot{\mathbf{y}}^{n-1}\|_{0, \Omega_s}^2 + \underbrace{(\nabla p^n, \mathbf{u}^n)_{\Omega_f} - (p^n, \dot{\mathbf{y}}^n \cdot \mathbf{n}_f)_{\Sigma}}_{T_1} - \underbrace{\langle \mathcal{R}_{\mu}(\tilde{\mathbf{u}}^n), \mathcal{L}(\dot{\mathbf{y}}^n - \dot{\mathbf{y}}^{n-1}) \rangle}_{T_2} \leq 0. \end{aligned} \quad (56)$$

Following the argument used in [1, Appendix A], from (47) we infer that

$$\tilde{\mathbf{u}}^n = \mathbf{u}^n + \Pi_h^{\perp} (\tilde{\mathbf{u}}^n - \mathcal{L}_h \dot{\mathbf{y}}^n) + \frac{\tau}{\rho_f} \Pi_h (\nabla p^n). \quad (57)$$

Thereafter, taking $q = \frac{\tau}{\rho_f} p^n$ in (31), integrating by parts in its right-hand side, and since $P_l^n = p^n|_{\Gamma_l}$, we have

$$\frac{\tau}{\rho_f} \|\nabla p^n\|_{0,\Omega_f}^2 + \sum_{l=1}^{n_{\text{OD}}} \frac{P_l^n - \alpha_l \pi_l^{n-1}}{\gamma_l} P_l^n - (\tilde{\mathbf{u}}^n, \nabla p^n)_{\Omega_f} + (p^n, \dot{\mathbf{y}}^n \cdot \mathbf{n}_f)_{\Sigma} = 0.$$

Now, by inserting (57) into this expression and using (38), we get

$$\begin{aligned} T_1 &= \frac{\tau}{\rho_f} \|\Pi_h^\perp(\nabla p^n)\|_{0,\Omega_f}^2 + \sum_{l=1}^{n_{\text{OD}}} \frac{P_l^n - \alpha_l \pi_l^{n-1}}{\gamma_l} P_l^n - (\Pi_h^\perp(\tilde{\mathbf{u}}^n - \mathcal{L}_h \dot{\mathbf{y}}^n), \nabla p^n)_{\Omega_f} \\ &\geq \frac{\tau}{\rho_f} \|\Pi_h^\perp(\nabla p^n)\|_{0,\Omega_f}^2 + \frac{C_l}{2} \partial_\tau |\pi_l^n|^2 + \frac{1}{R_{d,l}} |\pi_l^n|^2 + R_{p,l} |Q_l^n|^2 \\ &\quad - \underbrace{(\Pi_h^\perp(\tilde{\mathbf{u}}^n - \mathcal{L}_h \dot{\mathbf{y}}^n), \nabla p^n)_{\Omega_f}}_{T_3}. \end{aligned}$$

Therefore, by applying this lower bound to (56) we get

$$\begin{aligned} &\frac{\rho_f}{2} \partial_\tau \|\mathbf{u}^n\|_{0,\Omega_f}^2 + \frac{\rho_f}{2\tau} \|\tilde{\mathbf{u}}^n - \mathbf{u}^{n-1}\|_{0,\Omega_f}^2 + 2\mu \|\epsilon(\tilde{\mathbf{u}}^n)\|_{0,\Omega_f}^2 + \frac{\rho_s}{2} \partial_\tau \|\dot{\mathbf{y}}^n\|_{0,\Omega_s}^2 + \frac{1}{2} \partial_\tau \|\mathbf{y}^n\|_s^2 \\ &\quad + \frac{\rho_s}{2\tau} \|\dot{\mathbf{y}}^n - \dot{\mathbf{y}}^{n-1}\|_{0,\Omega_s}^2 + \frac{\tau}{\rho_f} \|\Pi_h^\perp(\nabla p^n)\|_{0,\Omega_f}^2 + \frac{C_l}{2} \partial_\tau |\pi_l^n|^2 + \frac{1}{R_{d,l}} |\pi_l^n|^2 + R_{p,l} |Q_l^n|^2 \\ &\leq T_2 + T_3. \end{aligned} \quad (58)$$

Term T_2 can be bounded as in [9], using (44), which yields

$$\begin{aligned} T_2 &\leq \frac{\rho_f}{\tau} \|\tilde{\mathbf{u}}^n - \mathbf{u}^{n-1}\|_{0,\Omega_f} \|\mathcal{L}_h(\dot{\mathbf{y}}^n - \dot{\mathbf{y}}^{n-1})\|_{0,\Omega_f} + 2\mu \|\epsilon(\tilde{\mathbf{u}}^n)\|_{0,\Omega_f} \|\epsilon(\mathcal{L}_h(\dot{\mathbf{y}}^n - \dot{\mathbf{y}}^{n-1}))\|_{0,\Omega_f} \\ &\leq \varepsilon_1 \frac{\rho_f}{2\tau} \|\tilde{\mathbf{u}}^n - \mathbf{u}^{n-1}\|_{0,\Omega_f}^2 + \varepsilon_2 \mu \|\epsilon(\tilde{\mathbf{u}}^n)\|_{0,\Omega_f}^2 \\ &\quad + C_L \left(\frac{\rho_f}{2\tau\varepsilon_1} h^{1-\alpha} + \frac{\mu}{\varepsilon_2} h^{-1-\alpha} \right) \|\dot{\mathbf{y}}^n - \dot{\mathbf{y}}^{n-1}\|_{0,\Omega_s}^2. \end{aligned} \quad (59)$$

Term T_3 can be bounded following the argument used in [1], which yields

$$\begin{aligned} T_3 &= (\Pi_h^\perp(\mathcal{L}_h(\dot{\mathbf{y}}^{n-1} - \dot{\mathbf{y}}^n)), \Pi_h^\perp(\nabla p^n))_{\Omega_f} \\ &\leq \varepsilon_3 \frac{\tau}{2\rho_f} \|\Pi_h^\perp(\nabla p^n)\|_{0,\Omega_f}^2 + \frac{\rho_f}{2\tau\varepsilon_3} C_L h^{1-\alpha} \|\dot{\mathbf{y}}^n - \dot{\mathbf{y}}^{n-1}\|_{0,\Omega_s}^2. \end{aligned} \quad (60)$$

Hence, by inserting (59)-(60) into (58) we get the energy estimate

$$\begin{aligned} &\frac{\rho_f}{2} \partial_\tau \|\mathbf{u}^n\|_{0,\Omega_f}^2 + \frac{\rho_f}{2\tau} (1 - \varepsilon_1) \|\tilde{\mathbf{u}}^n - \mathbf{u}^{n-1}\|_{0,\Omega_f}^2 + \mu(2 - \varepsilon_2) \|\epsilon(\tilde{\mathbf{u}}^n)\|_{0,\Omega_f}^2 + \frac{\rho_s}{2} \partial_\tau \|\dot{\mathbf{y}}^n\|_{0,\Omega_s}^2 \\ &\quad + \frac{1}{2} \partial_\tau \|\mathbf{y}^n\|_s^2 + \left[\frac{\rho_s}{2\tau} - C_L \frac{\rho_f}{2\tau} h^{1-\alpha} \left(\frac{1}{\varepsilon_1} + \frac{1}{\varepsilon_3} \right) - C_L \frac{\mu}{\varepsilon_2} h^{-1-\alpha} \right] \|\dot{\mathbf{y}}^n - \dot{\mathbf{y}}^{n-1}\|_{0,\Omega_s}^2 \\ &\quad + \frac{\tau}{\rho_f} \left(1 - \frac{\varepsilon_3}{2} \right) \|\Pi_h^\perp(\nabla p^n)\|_{0,\Omega_f}^2 + \sum_{l=1}^{n_{\text{OD}}} \left(\frac{C_l}{2} \partial_\tau |\pi_l^n|^2 + \frac{1}{R_{d,l}} |\pi_l^n|^2 + R_{p,l} |Q_l^n|^2 \right) \leq 0. \end{aligned}$$

At last, the energy estimate (52) follows by taking in the latter $\varepsilon_1 = \frac{1}{2}$, $\varepsilon_2 = \varepsilon_3 = 1$, summing over n and using (51), which completes the proof.

Proposition 4.1 guarantees the conditional stability of Algorithm 3. Note that the stability condition is similar to the one obtained in [9] with a Darcy-like formulation of the projection step. The estimate (52) corresponds to the discrete counterpart of (43), the right-hand side of (52) is a dissipative numerical term related to the natural pressure stabilization of the projection scheme.

4.1.3 Semi-implicit FSI coupling scheme with explicit 3D-0D coupling scheme

We now consider numerical approximations of the coupled problem FSI-0D system (41)-(42) and (2)-(3) by combining the projection semi-implicit coupling scheme reported in [9] with the 3D-0D explicit coupling of Section 3.1. The resulting fully discrete time-marching procedure is reported in Algorithm 4.

Algorithm 4 Semi-implicit FSI coupling scheme with explicit 3D-0D coupling scheme

Let $\mathbf{u}^0 = \mathbf{u}_0, \pi_1^0, \dots, \pi_{n_{0D}}^0 \in \mathbb{R}$ and $\mathbf{y}^0, \dot{\mathbf{y}}^0 \in \mathbf{W}_h$ be given initial data. For $n \geq 1$ perform:

1. Viscous step: Find $\tilde{\mathbf{u}}^n \in \mathbf{V}_h$ such that

$$\begin{cases} \tilde{\mathbf{u}}^n|_{\Sigma} = \dot{\mathbf{y}}^{n-1}|_{\Sigma}, \\ \tilde{\mathbf{u}}^n|_{\Gamma^{\text{in}}} = \mathbf{u}_{\text{in}}(t_n), \\ \frac{\rho_f}{\tau} (\tilde{\mathbf{u}}^n, \mathbf{v})_{\Omega_f} + 2\mu (\boldsymbol{\epsilon}(\tilde{\mathbf{u}}^n), \boldsymbol{\epsilon}(\mathbf{v}))_{\Omega_f} = \frac{\rho_f}{\tau} (\mathbf{u}^{n-1}, \mathbf{v})_{\Omega_f} \end{cases} \quad (61)$$

for all $\mathbf{v} \in \mathbf{V}_{\Sigma \cup \Gamma^{\text{in}}, h}$. Thereafter set $\tilde{Q}_l^n \stackrel{\text{def}}{=} \int_{\Gamma_l} \tilde{\mathbf{u}}^n \cdot \mathbf{n}_f$.

2. Windkessel step: For $l = 1, \dots, n_{0D}$, compute $(Q_l^n, \pi_l^n, P_l^n) \in \mathbb{R}^3$ from

$$\begin{cases} Q_l^n = \tilde{Q}_l^n, \\ C_l \partial_{\tau} \pi_l^n + \frac{\pi_l^n}{R_{d,l}} = Q_l^n, \\ P_l^n = R_{p,l} Q_l^n + \pi_l^n. \end{cases} \quad (62)$$

3. Implicit projection-solid step: Find $(p^n, \mathbf{u}^n, \mathbf{y}^n) \in N_h \times \mathbf{V}_h \times \mathbf{W}_h$ with $\dot{\mathbf{y}}^n = \partial_{\tau} \mathbf{y}^n$ and such that

$$\begin{cases} p^n|_{\Gamma_l} = P_l^n, \quad l = 1, \dots, n_{0D}, \\ \frac{\tau}{\rho_f} (\nabla p^n, \nabla q)_{\Omega_f} = -(\nabla \cdot \tilde{\mathbf{u}}^n, q)_{\Omega_f} - ((\dot{\mathbf{y}}^n - \tilde{\mathbf{u}}^n) \cdot \mathbf{n}_f, q)_{\Sigma} \end{cases} \quad (63)$$

$$\begin{cases} \mathbf{u}^n|_{\Gamma^{\text{in}}} = \mathbf{u}_{\text{in}}(t_n), \\ \mathbf{u}^n|_{\Sigma} = \dot{\mathbf{y}}^n|_{\Sigma}, \\ \frac{\rho_f}{\tau} (\mathbf{u}^n, \mathbf{v})_{\Omega_f} = \frac{\rho_f}{\tau} (\tilde{\mathbf{u}}^n, \mathbf{v})_{\Omega_f} - (\nabla p^n, \mathbf{v})_{\Omega_f}, \end{cases} \quad (64)$$

$$\rho_s (\partial_{\tau} \dot{\mathbf{y}}^n, \mathbf{v}_s)_{\Omega_s} + a_s(\mathbf{y}^n, \mathbf{v}_s) = -\langle \mathcal{R}_{\mu}(\tilde{\mathbf{u}}^n), \mathcal{L}_h \mathbf{v}_s \rangle - \langle \mathcal{R}_p(\mathbf{u}^n, p^n), \mathcal{L}_h \mathbf{v}_s \rangle \quad (65)$$

for all $(q, \mathbf{v}, \mathbf{v}_s) \in N_{\Gamma^{\text{out}}, h} \times \mathbf{V}_{\Sigma \cup \Gamma^{\text{in}}, h} \times \mathbf{W}_h$.

The following proposition provides an energy estimate for the approximations provided by Algorithm 4.

Theorem 4.2 *Let $\{(\tilde{\mathbf{u}}^n, p^n, \mathbf{y}^n, \dot{\mathbf{y}}^n)\}_{n \geq 1}$ and $\{(Q_l^n, \pi_l^n, P_l^n)_{1 \leq l \leq n_{\text{OD}}}\}_{n \geq 1}$ be the approximated solution given by Algorithm 4 and assume that $\mathbf{u}_{\text{in}} = \mathbf{0}$ (free system). Then, under the condition (51), the following energy inequality holds*

$$E^n + D^n \lesssim E^0 - \sum_{m=1}^{n-1} \frac{\tau^2}{2\rho_f} \|\Pi_h^\perp(\nabla p^m)\|_{0,\Omega_f}^2 + \sum_{m=1}^{n-1} \tau (\nabla \cdot \tilde{\mathbf{u}}^m, \phi^m)_{\Omega_f} + \sum_{m=1}^{n-1} \frac{\tau^2}{\rho_f} (\nabla p^m, \nabla \phi^m)_{\Omega_f} + \sum_{m=1}^{n-1} \tau (\dot{\mathbf{y}}^m \cdot \mathbf{n}_f, \phi^m)_\Sigma. \quad (66)$$

Proof. The result follows by combining the arguments involved in the proofs of Propositions 3.1 and 4.1. Hence, only partial details are given. The main difference lies on the estimation of term T_1 in (56). Since $q \in N_{\Gamma^{\text{out}},h}$, integration by parts in (63) gives

$$(\nabla p^n, \nabla q)_{\Omega_f} = \frac{\rho_f}{\tau} (\tilde{\mathbf{u}}^n, \nabla q)_{\Omega_f} - (\dot{\mathbf{y}}^n \cdot \mathbf{n}_f, q)_\Sigma,$$

so that by testing with $q = \frac{\tau}{\rho_f} (p^n - \phi^n) \in N_{\Gamma^{\text{out}},h}$ we get

$$\frac{\tau}{\rho_f} \|\nabla p^n\|_{0,\Omega_f}^2 - (\tilde{\mathbf{u}}^n, \nabla p^n)_{\Omega_f} + (\dot{\mathbf{y}}^n \cdot \mathbf{n}_f, p^n)_\Sigma + \left(\tilde{\mathbf{u}}^n - \frac{\tau}{\rho_f} \nabla p^n, \nabla \phi^n \right)_{\Omega_f} - (\dot{\mathbf{y}}^n \cdot \mathbf{n}_f, \phi^n)_\Sigma = 0. \quad (67)$$

As in the proof of Proposition 4.1, from (64) we get (57). Hence, inserting this expression into (67) we get

$$\begin{aligned} & -(\nabla p^n, \mathbf{u}^n)_{\Omega_f} + (p^n, \dot{\mathbf{y}}^n \cdot \mathbf{n}_f)_\Sigma + \frac{\tau}{\rho_f} \|\Pi_h^\perp(\nabla p^n)\|_{0,\Omega_f}^2 - (\Pi_h^\perp(\tilde{\mathbf{u}}^n - \mathcal{L}_h \dot{\mathbf{y}}^n), \nabla p^n)_{\Omega_f} \\ & = - \left(\tilde{\mathbf{u}}^n - \frac{\tau}{\rho_f} \nabla p^n, \nabla \phi^n \right)_{\Omega_f} + (\dot{\mathbf{y}}^n \cdot \mathbf{n}_f, \phi^n)_\Sigma \\ & - \sum_{l=1}^{n_{\text{OD}}} Q_l^n P_l^n + (\nabla \cdot \tilde{\mathbf{u}}^n, \phi^n)_{\Omega_f} + \frac{\tau}{\rho_f} (\nabla p^n, \nabla \phi^n)_{\Omega_f} + (\dot{\mathbf{y}}^n \cdot \mathbf{n}_f, \phi^n)_\Sigma \end{aligned} \quad (68)$$

and the estimate (66) follows using the same arguments than in the proof of Proposition 4.1.

Remark 4.3 *A comparison of the energy estimates (16) and (66) suggests that the fluid-solid interaction introduces an additional destabilizing effect in the explicit splitting of the 3D-0D coupling (12), due to the presence of the artificial interface term*

$$\sum_{m=1}^{n-1} \tau (\dot{\mathbf{y}}^m \cdot \mathbf{n}_f, \phi^m)_\Sigma.$$

In particular, it is worth noting that the observation made in Remark 3.3 for the case of a single outlet is not valid in the FSI framework, since the above term does not vanish for $\phi^m = P^m$ in Ω_f . This point will be illustrated through numerical experiments in Section 5.2.

5 Numerical experiments

In this section we present two numerical experiments that confirm the analysis of the previous sections.

5.1 Blood flow in a patient-specific aorta

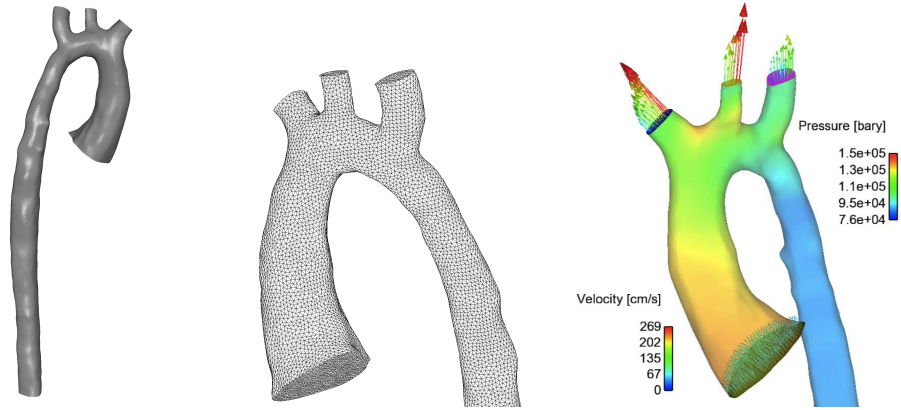


Figure 3: Patient-specific aorta. Left: geometry. Center: surface mesh. Right: simulation results for the aorta (vector velocity field and pressure distribution).

Our first example is a pure Navier-Stokes flow within a patient-specific aorta with repaired coarctation (see Figures 3-Left-Center). The geometry comes from the euHeart database¹. A segment growing registration algorithm (see [3, 4]) was used for the segmentation of the geometry from the medical image. The resulting surface was pre-processed with 3-matic (Materialise) and the final mesh was generated with Gmsh [13].

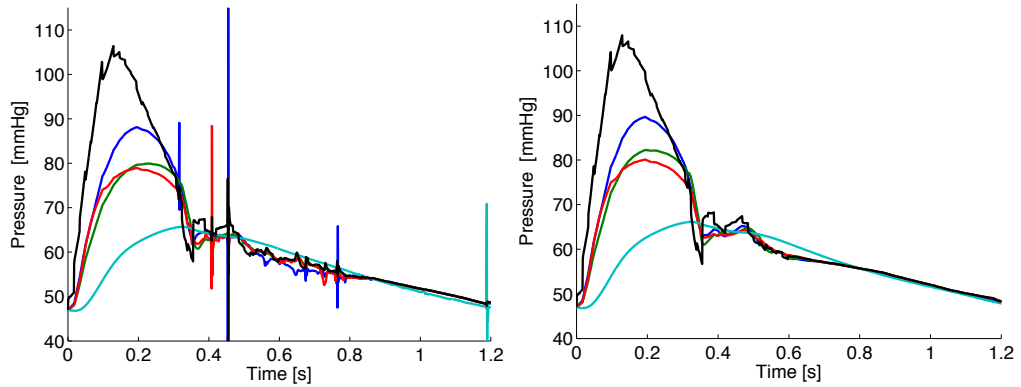


Figure 4: Mean pressures at inlet (black) and outlets 1 to 4 (blue, green, red, cyan). Explicit (left) and implicit (right) schemes.

The inflow curve used as boundary condition (Figure 4-Right, black-line) was obtained from the same patient with Phase Contrast MRI. The initial constant pressure was set to 62650 bary, and the Windkessel parameters (reported in Table 1) were calibrated in order to approximate the measured pressure at the coarctation and the measured flow on each outlet. The physical parameters of the fluid are $\mu = 0.035 \text{ Po}$ and $\rho_f = 1 \text{ gr/cm}^3$. For the numerical simulation, we

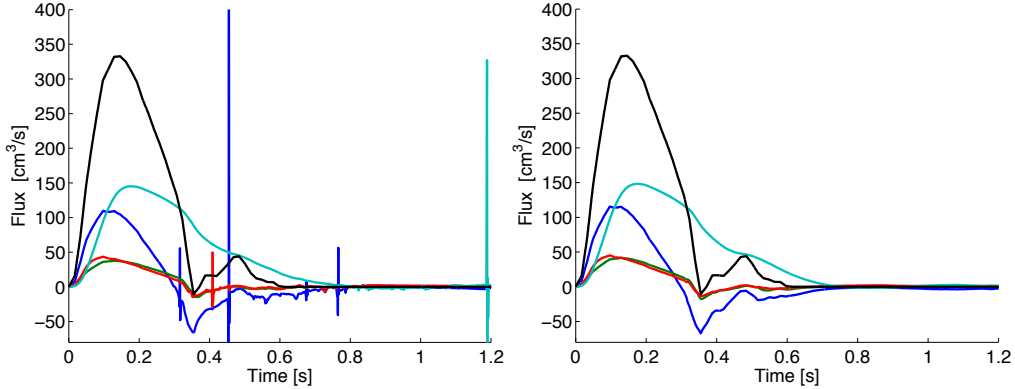


Figure 5: Fluxes for inlet (black) and outlets 1 to 4 (blue, green, red, cyan). Explicit (left) and implicit (right) schemes.

use \mathbb{P}_1 finite elements for both pressure and velocity fields (SUPG stabilization in the viscous-convective step) and a time step $\tau = 10^{-3}$ s. A snapshot of the simulation results is shown in Figure 3-Right. Figures 4 and 5 show the pressure and flow results for both schemes (Algorithms 1 and 2, respectively). The spurious oscillations in the approximation provided by the explicit 3D-0D coupling scheme are clearly visible, while the implicit formulation guarantees stability within the whole cardiac cycle. Hence, in agreement with the stability estimates provided by Theorems 3.1 and 3.6.

5.2 Fluid-structure interaction in an idealized AAA

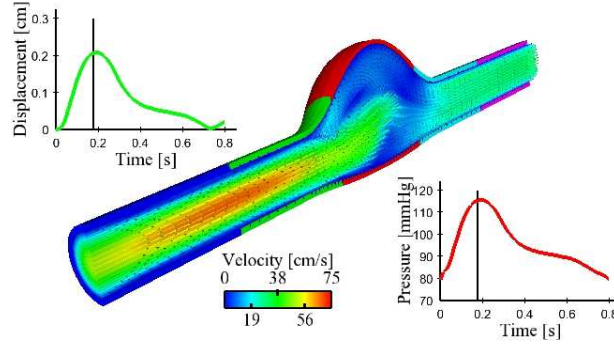


Figure 6: Snapshot of the velocity field inside the idealized AAA. The curves show outlet pressure and displacements of the aneurysm wall.

We consider an idealized abdominal aortic aneurysm (AAA) of length 22.95 cm, minimal diameter 1.7 cm (tubular part), maximal diameter 4.98 cm (aneurysm) and wall thickness 0.2 cm (see Figure 6). The structure is described by the linear elastodynamics equations and the fluid by the incompressible Navier-Stokes equations in a moving domain (ALE formalism). We considered the non-linear counterpart of Algorithms 3 and 4 using the projection semi-implicit coupling scheme reported in [9]. The solid has Young's modulus 1 MPa, Poisson ratio is 0.46 and density 1.2 g/cm³. The fluid viscosity is $\mu = 0.035$ Po and its density 1 g/cm³. The inlet and the outlet parts of the solid are clamped. In the fluid, a parabolic velocity profile is enforced at the inlet, with a realistic inflow (peak velocity ≈ 96 cm/s). The Windkessel parameters are $R_p = 700$ dyn · s · cm⁻⁵, $R_d = 5 \cdot 10^3$ dyn · s · cm⁻⁵ and $C = 2 \cdot 10^{-4}$ cm⁵ · dyn⁻¹. At $t = 0$, the pressure is constant and equal to 80 mmHg, whereas all the other state variables are zero. During the whole simulation, the stress received by the structure is corrected by the initial one,

and the solid only responds to the difference with the diastolic phase. This is a simple way to account for prestress in linear elastodynamics.

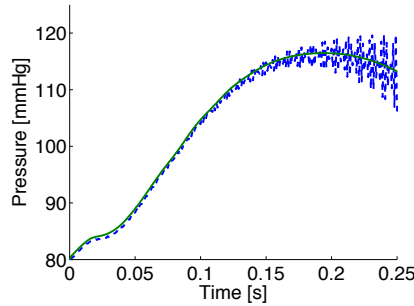


Figure 7: Windkessel pressure for the AAA: comparison between implicit (solid line) and explicit (dashed line) fluid-Windkessel coupling.

The results are summarized in Figure 7, showing the Windkessel pressures in time for a time step P for $\tau = 0.001$ s. Note that the semi-implicit algorithm with explicit 0D-3D coupling (Algorithm 4) is unstable whereas with the implicit 3D-0D treatment (Algorithm 3) the numerical solution remains stable. In fact, from the results one can infer that the interface term outlined in Remark 4.3, namely $(\dot{\mathbf{y}}^n, P^n \mathbf{n}_f)_\Sigma$, injects a positive artificial power into the system (an increased pressure $P^n > 0$ leads to $\dot{\mathbf{y}}^n \cdot \mathbf{n}_f > 0$).

6 Conclusions

In this paper we formulated and analyzed the treatment of a 3D-0D coupling between the 3D distributed (fluid, fluid-structure interaction) models and a set of Windkessel 0D models. The key ingredient in the proposed schemes is the use of a fractional-step time-marching in the 3D compartment. For purely fluid problems with multiple outlets, our energy based stability analysis showed that numerical instabilities might appear when using an explicit 3D-0D coupling. Interestingly, this result also holds with a single outlet in the case of fluid-structure interaction.

We proposed to overcome this issues via an implicit treatment of the 3D-0D coupling, which involves a negligible additional computational cost with respect to the explicit strategy. These theoretical expectations were confirmed by numerical experiments in realistic geometries and physiological data.
