Dihedral f-tilings of the sphere by rhombi and triangles

We classify, up to an isomorphism, the class of all dihedral f-tilings of $S²$, whose prototiles are a spherical triangle and a spherical rhombus. The equiangular case was considered and classified in [Breda and Santos \(2004\)](#page-19-0). Here we complete the classification considering the case of non-equiangular rhombi, see Tab. [1](#page-17-0) and Fig. [24.](#page-18-0)

Keywords: dihedral tilings, isometric foldings, spherical trigonometry, WCSQ

1 Introduction

An *isometric folding* is a non-expansive locally isometry that sends piecewise geodesic segments into piecewise geodesic segments of the same length. An isometric folding is a continuous map that need not to be differentiable. The points where it is not differentiable are called *singular points*. The foundations of isometric foldings of Riemannian manifolds are introduced by [Robertson \(1977\)](#page-19-1).

For surfaces, the set of singular points gives rise to *two colored tilings* (called *f-tilings*) with the property that each vertex has even valency and obey the *angle folding relation*, i.e., the sums of alternating angles around each vertex is π .

The classification of f-tilings started out by [Breda](#page-19-2) [\(1992\)](#page-19-2), where a complete classification of all monohedral f-tilings of the sphere by triangles was done.

The complete classification of monohedral tilings of the sphere by triangles (which, obviously, includes the monohedral triangular f-tilings) was made clear by [Ueno and Agaoka](#page-19-3) [\(2002\)](#page-19-3). This classification was partially done by [Sommerville \(1922\)](#page-19-4), and an outline of the proof was provided by [Davies \(1967\)](#page-19-5).

For additional information on tilings, see Grünbaum and Shephard (1986).

Our interest focuses in dihedral spherical f-tilings.

2 Preliminaries

Definition 2.1 Let S^2 be the euclidean 2-sphere of radius 1. A spherical moon L is said well centered if *its vertices belong to the great circle* $S^2 \cap \{(x, y, z) \in \mathbb{R}^3 \mid x = 0\}$ *and the semi-great circle bisecting* L *contains the point* $(1, 0, 0)$ *. If* L_1 *and* L_2 *are two well centered spherical moons with orthogonal vertices, then* L_1 *and* L_2 *are said to be orthogonal.*

Definition 2.2 *By a well centered spherical quadrangle (WCSQ) we mean a spherical quadrangle which is the intersection of two well centered spherical moons with distinct vertices.*

The properties of WCSQ was described by [Breda and Santos \(2003\)](#page-19-7), where was established that any spherical quadrangle with congruent opposite internal angles is congruent to a WCSQ.

Definition 2.3 *Let* Q *and* T *be, respectively, a spherical triangle and a spherical quadrangle. A dihedral tiling of the sphere* S ² *with prototiles* Q *and* T *is an edge-to-edge polygonal subdivision* τ *of* S 2 *, such that each tile (face) of* τ *is isometric either to* Q *or* T *.*

In addition, if the number of geodesic rays (edges) emanating from each vertex of τ *is even, making alternated angles* α_1 , β_1 , α_2 , β_2 , ..., α_n , β_n ($n \ge 2$), where

$$
\sum_{j=1}^{n} \alpha_j = \sum_{j=1}^{n} \beta_j = \pi
$$
 (angle folding relation)

then τ *is called a dihedral folding tiling or dihedral f-tiling for short.*

In short, *dihedral* means that every tile of τ is congruent to one of the fixed sets Q and T, called the prototiles of τ .

Definition 2.4 *Let* v *be a vertex of a (dihedral) f-tiling. The number of edges emanating from* v *is called the valency of* v*.*

In Fig. [1](#page-2-0) is illustrated a vertex v obeying the angle folding relation $(\alpha_1 + \alpha_2 + \alpha_3 = \beta_1 + \beta_2 + \beta_3 = \pi)$ with valency six.

In [Breda and Santos](#page-19-0) [\(2004\)](#page-19-0) the classification of dihedral f-tilings of $S²$ by spherical triangles and equiangular spherical quadrangles (i.e., spherical quadrangles that are congruent to a WCSQ which is the intersection of two orthogonal well centered spherical moons) was presented.

Here we extend the study of f-tilings presenting the classification of all dihedral f-tilings by spherical triangles and non-equiangular spherical rhombi, in other words, spherical quadrangles whose edges have the same length and with distinct pairs of opposite internal angles.

In [Breda and Santos \(2003\)](#page-19-7) it was shown that any non-equiangular spherical rhombus Q is congruent to a WCSQ which is the intersection of two non-orthogonal well centered spherical moons L_1 and L_2 with the same angle measure θ (Fig. [2\)](#page-3-0).

Definition 2.5 *The spherical tilings* τ_1 *and* τ_2 *are isomorphic if there exists an isometry* ϕ *of* S^2 , *such that* $\phi(\tau_1) = \tau_2$ *.*

Notation: We shall denote by $\Omega(Q,T)$ the set, up to an isomorphism, of all dihedral f-tilings of S^2 , whose prototiles are a non-equiangular spherical rhombus Q and a spherical triangle T .

Proposition 2.1 [\(Breda and Santos](#page-19-0) [\(2004\)](#page-19-0)) Let $\tau \in \Omega(Q, T)$. If $M > 0$ and $N > 0$ denote, respec*tively, the number of spherical quadrangles congruent to* Q *and the number of spherical triangles congruent to* T *of* τ *, and* E *and* V *denote, respectively, the number of edges and vertices of* τ *, then:*

- **i)** $N + 2M = 2V 4$, $3V = 6 + M + E$;
- **ii**) *there are at least* $6 + M$ *vertices of valency four;*
- **iii**) $\pi < \beta + \gamma + \delta < \frac{3\pi}{2}$ and $\alpha_1 + \alpha_2 > \pi$, where α_1 and α_2 are the pairs of opposite internal angles *of* Q*, and* β*,* γ *and* δ *are the internal angles of* T*.*

We shall describe $\Omega(Q, T)$, considering separately different cases depending on the nature of Q and T.

In order to get the dihedral f-tilings of Ω(Q, T) we find useful to start by considering one of its *planar representation* (*PR*), beginning with a common vertex to a spherical quadrangle and a spherical triangle in adjacent positions (it must be pointed out that there is always a vertex satisfying this condition).

Whenever a tiling is drown in one hemisphere, it means that the plane $x = 0$, say, is a plane of symmetry. The whole tiling is then obtained by reflecting the picture in this plane.

Spherical trigonometry is based on the following cosine rules: The internal angles α , β and γ of a spherical triangle T obey:

$$
\cos \alpha = \frac{\cos a - \cos b \cos c}{\sin b \sin c} \quad \text{and} \quad \cos a = \frac{\cos \alpha + \cos \beta \cos \gamma}{\sin \beta \sin \gamma},\tag{2.1}
$$

where a, b and c are the lengths of the edges opposite to α , β and γ , respectively. This formulas are of crucial interest to prove the results that follow. For a detailed discussion on spherical trigonometry, see [Berger](#page-19-8) [\(1996\)](#page-19-8).

3 Prototiles: Non-equiangular rhombus and equilateral triangle

Proposition 3.1 *If* Q *and* T *are, respectively, a non-equiangular spherical rhombus and an equilateral spherical triangle, then* $\Omega(Q, T)$ *is the empty set.*

Proof: Let Q be a non-equiangular spherical rhombus with pairs of opposite internal angles α_1 and α_2 $(\alpha_1 > \alpha_2)$, and let T be an equilateral spherical triangle with internal angle β .

Suppose that $\Omega(Q, T)$ is non empty. Let v be a vertex of Q surrounded by α_1 . As $\alpha_1 + \alpha_2 > \pi$ $(\alpha_1 > \frac{\pi}{2})$ and $\beta > \frac{\pi}{3}$, then v has valency four, and the cells surrounding v have, in cyclic order, angles measure $(\alpha_1, \alpha_1, \beta, \check{\beta})$, with $\alpha_1 + \beta = \pi$. A planar representation (*PR*) of a f-tiling $\tau \in \Omega(Q, T)$ near v is illustrated in Fig. [3-](#page-4-0)I. It follows that $\alpha_2 + \beta < \pi$ and $\alpha_2 + k\beta > (k+1)\beta > \pi$, for $k \ge 2$. Hence in order to have the angle folding relation satisfied we must have $\alpha_2 + \alpha_2 = \pi$, i.e., $\alpha_2 = \frac{\pi}{2}$. This information allows us to adjust some more cells to the initial *PR* leading to the *PR* illustrated in Fig. [3-](#page-4-0)II. In order to go on with the *PR* of τ we must analyze the angles behavior around v_1 . We already know that the cyclic sequence of their positions contains the sequence $(\ldots, \beta, \alpha_2, \beta, \ldots)$. As $2\beta < \pi$ and $2\beta + \rho > \pi$ for all $\rho \in {\beta, \alpha_1, \alpha_2}$, then there is no way to position another cells around v_1 in order to have the angle folding relation full filled. And so $\Omega(Q, T) = \emptyset$.

 \Box The argumentation used to prove the Propositions stated

in the following Sections are somehow similar to the one used on proof of Prop. [3.1.](#page-4-1) Thus, we decided to present only the proofs we consider more representative. A detailed study containing the proofs of those results can be found in a technical report placed in the web site

4 Prototiles: Non-equiangular rhombus and isosceles triangle

Through this section Q is a non-equiangular spherical rhombus with pairs of opposite internal angles α_1 and α_2 ($\alpha_1 > \alpha_2$), and T is an isosceles spherical triangle with internal angles β , γ , γ ($\beta \neq \gamma$).

Any element of $\Omega(Q, T)$ has, at least, two cells congruent, respectively, to Q and T, such that they are in adjacent positions in one of the situations illustrated in Fig. [4.](#page-5-0)

Next, by "unique f-tiling" we mean unique up to an isomorphism.

Proposition 4.1 *If* $\Omega(Q, T) \neq \emptyset$, then there cannot be a pair of tiles in the position of Fig. [4-](#page-5-0)A or Fig. 4-B.

Proposition 4.2 *If a f-tiling contains two cells in the position of Fig. [4-](#page-5-0)C, then* $\alpha_1 + \gamma = \pi$ *. Moreover,*

- **i)** *if* $\alpha_2 \neq \beta$, then $\Omega(Q, T) \neq \emptyset$ *iff* $\alpha_2 + \beta = \pi (\beta = \arccos(1 - 2 \cos \frac{\pi}{k}))$ and $\gamma = \frac{\pi}{k}$, for some $k \geq 4$. *In this situation for each* $k \geq 4$, $\Omega(Q,T)$ *contains a unique dihedral f-tiling, denoted by* R^k *, such that the angles around vertices are the ones represented at the head of the Fig. 7 (consider* $k \geq 4$ *)*;
- **ii**) *if* $\alpha_2 = \beta$ *,* then $\Omega(Q, T) \neq \emptyset$ iff $\alpha_1 = \frac{2\pi}{3}$, $\alpha_2 = \frac{\pi}{2}$ and $\gamma = \frac{\pi}{3}$. Besides, $\Omega(Q, T) = \{R^3, U_1, U_2, U_3, U_4\}$, where R^3 and U_i , $1 \leq i \leq 4$ are non-isomorphic dihedral f-tilings, such that the angles around ver*tices are the ones represented in Fig. [7.](#page-6-0)*

Proof: We only present the proof of the [i\)](#page-5-1) case.

In order to obtain a complete *PR* of an element $\tau \in \Omega(Q, T)$, the *PR* illustrated in Fig. [4-](#page-5-0)C is extended in a unique way to get the *PR* illustrated in Fig. [5,](#page-5-2) where $\alpha_1 + \gamma = \pi$, $\alpha_2 + \beta = \pi$ and $k\gamma = \pi$, for some $k \ge 4$. (Note that the case $k = 3$ implies $\alpha_2 = \beta = \frac{\pi}{2}$.)

The side length of T opposite to γ and the side length of Q are the same. Using the formulas [\(2.1\)](#page-3-1) we may show that

$$
\beta = \arccos\left(1 - 2\cos\frac{\pi}{k}\right) = 2\arccos\sqrt{1 - \cos\frac{\pi}{k}}, \ k \ge 4. \tag{4.1}
$$

3D representations for $k = 4$ and $k = 5$ are illustrated in Fig. [6.](#page-6-1)

Fig. [7](#page-6-0) exhibits the vertices in the dihedral f-tilings corresponding to the [i\)](#page-5-1) and [ii\)](#page-5-3) cases. In Fig. [8](#page-7-0)

5 Prototiles: Non-equiangular rhombus and scalene triangle

Here Q is a non-equiangular spherical rhombus with pairs of opposite internal angles α_1 and α_2 (α_1) α₂), and T is a scalene spherical triangle with internal angles $β, γ$ and $δ$, such that $β > γ > δ$.

If $\tau \in \Omega(Q, T)$, then there are necessarily two cells of τ congruent, respectively, to Q and T, such that they are in adjacent positions in one of the situations illustrated in Fig. [9.](#page-7-1)

Proposition 5.1 *If* $\Omega(Q, T) \neq \emptyset$, then there cannot be a pair of tiles in the position of Fig. [9-](#page-7-1)A or Fig. 9-B. **Proposition 5.2** *Let* $\tau \in \Omega(Q, T)$ *, such that* τ *has two cells in adjacent positions as illustrated in Fig.* [9-](#page-7-1) *C, then* τ *has six cells in adjacent positions as illustrated in Fig. [10.](#page-7-2)*

Suppose that the *PR* illustrated in Fig. [10](#page-7-2) is contained in a complete *PR* of any element $\tau \in \Omega(Q, T)$. It follows that $\alpha_2 + \gamma \leq \pi$. We shall consider separately the cases $\alpha_2 + \gamma < \pi$ and $\alpha_2 + \gamma = \pi$.

Proposition 5.3 *Let* $\alpha_2 + \gamma < \pi$ *.*

- **i**) *If* $\alpha_2 > \gamma$ *, then* $\tau = M^4$ *;*
- **ii**) *If* $\alpha_2 = \gamma$ *, then* $\tau = E^3$ *or* $\tau = S^3$ *;*
- **iii**) *If* $\alpha_2 < \gamma$ *, then* $\tau = M^{k+1}$ *or* $\tau = E^k$ *or* $\tau = S^k$ *,* $k \ge 4$ *,*

where the internal angles of the prototiles present in the dihedral f-tilings are:

$$
\alpha_1 = \frac{(k-1)\pi}{k} \quad \alpha_2 = \pi - 2\gamma \quad \beta = \frac{\pi}{2} \quad \cos \gamma = \sqrt{1 - \cos \frac{\pi}{k}} \qquad \delta = \frac{\pi}{k} \qquad \qquad M^k, \ k \ge 4;
$$

$$
\alpha_1 = \pi - \delta \qquad \alpha_2 = \frac{\pi}{2k - 3} \quad \beta = \frac{\pi}{2} \qquad \gamma = \frac{(k - 2)\pi}{2k - 3} \qquad \cos \delta = \cos^2 \frac{\pi}{4k - 6} \qquad E^k, \ k \ge 3;
$$

$$
\alpha_1 = \pi - \delta \qquad \alpha_2 = \frac{\pi}{k} \qquad \beta = \frac{\pi}{2} \qquad \gamma = \frac{(k - 1)\pi}{2k} \qquad \cos \delta = \cos^2 \frac{\pi}{2k} \qquad S^k, \ k \ge 3.
$$

The angles around vertices are positioned as illustrated in Fig. [11.](#page-8-0)

Proof: We only present the proof of the [i\)](#page-8-1) case.

The information given by the *PR* illustrated in Fig. [10](#page-7-2) leads to conclude that

$$
\alpha_1 > \beta = \frac{\pi}{2} > \alpha_2 > \gamma > \delta. \tag{5.1}
$$

Consider a vertex v surrounded by the cyclic sequence $(\alpha_2, \gamma, \gamma, \dots)$. Then the sum of alternating angles around v containing α_2 must be $\alpha_2 + \gamma + \alpha_2 = \pi$ or $\alpha_2 + 2\gamma = \pi$.

1. $\alpha_2 + \gamma + \alpha_2 = \pi$

In this case the *PR* illustrated in Fig. [10](#page-7-2) is extended as shown in Fig. [12](#page-9-0) (observe that all cells labelled from 2 to 8 are uniquely determined, since $\alpha_2 + \gamma < \alpha_2 + 2\gamma < \pi = 2\alpha_2 + \gamma < \alpha_2 + \gamma + 2\delta$). This leads to a

vertex surrounded by the cyclic sequence of angles $(\gamma, \gamma, \alpha_2, \gamma, \gamma, \ldots)$, where $2\gamma + \alpha_2 < \pi < 2\gamma + \alpha_2 + \rho$, for all $\rho \in {\alpha_1, \alpha_2, \beta, \gamma, \delta}$. And so there is no way to obey the angle folding relation at that vertex.

2. $\alpha_2 + 2\gamma = \pi$

In this case the cyclic sequence of angles around v is either $(\alpha_2, \gamma, \gamma, \alpha_2, \gamma, \gamma)$ or $(\alpha_2, \gamma, \gamma, \gamma, \gamma, \alpha_2)$.

2.1. The first situation leads us immediately to a contradiction as illustrates Fig. [13.](#page-9-1) In fact, this case gives rise to a vertex w surrounded by the cyclic sequence $(\alpha_2, \alpha_2, \alpha_2, \alpha_2, \ldots)$. As $\alpha_2 > \gamma$, then $2\alpha_2+\gamma > \pi = \alpha_2+2\gamma > 2\alpha_2$. And so the sums of alternating angles around w must obey $2\alpha_2+\delta = \pi$, as illustrated in the figure. This procedure gives rise to a vertex surrounded by α_1 and γ in adjacent positions, leading us to an incompatibility between angles around this vertex (see side length of the prototiles).

2.2. In the second case we may extend without more restrictions the *PR* illustrated in Fig. [10](#page-7-2) to get the one illustrated in Fig. [14.](#page-10-0) This construction leads to two antipodal vertices surrounded by at least six δ angles. It is a straightforward exercise to show that those vertices are enclosed exclusively by δ angles. Therefore $k\delta = \pi$, for some $k \ge 4$. On the other hand $\alpha_2 + 2\gamma = \pi$ with $\gamma < \alpha_2$. Hence $\gamma < \frac{\pi}{3} < \alpha_2$ and so $\delta = \frac{\pi}{4}$ or $\delta = \frac{\pi}{5}$, as $\gamma + \delta > \frac{\pi}{2}$.

Firstly, consider that $\delta = \frac{\pi}{4}$. Then $\alpha_1 = \frac{3\pi}{4}$ and the *PR* illustrated in Fig. [14](#page-10-0) is completely determined

as shown in Fig. [15.](#page-10-1) The sum of alternating angles around vertices verify

$$
\alpha_1+\delta=\pi, \quad \beta=\frac{\pi}{2}, \quad \alpha_2+2\gamma=\pi \;\; (\alpha_2>\gamma) \;\; \text{ and } \;\; \delta=\frac{\pi}{4}.
$$

Now, we need to verify that adjacent tiles have the same side length. Denoting by b the side length of T opposite to β , then

$$
\cos b = \frac{\cos \beta + \cos \delta \cos \gamma}{\sin \delta \sin \gamma} = \cot \gamma.
$$
 (5.2)

On the other hand b is also the side length of Q , therefore

$$
\cos b = \frac{\cos\frac{\alpha_2}{2}(1+\cos\alpha_1)}{\sin\frac{\alpha_2}{2}\sin\alpha_1} = \frac{\cos(\frac{\pi}{2}-\gamma)(1+\cos\alpha_1)}{\sin(\frac{\pi}{2}-\gamma)\sin\alpha_1} = \tan\gamma\frac{1-\cos\frac{\pi}{4}}{\sin\frac{\pi}{4}}.
$$
(5.3)

By [\(5.2\)](#page-10-2) and [\(5.3\)](#page-11-0) we conclude that

$$
\tan^2 \gamma = \frac{\cos \frac{\pi}{4}}{1 - \cos \frac{\pi}{4}}.
$$

And so

$$
\gamma = \arccos\sqrt{1 - \cos\frac{\pi}{4}} = \frac{1}{2}\arccos\left(1 - \sqrt{2}\right) \approx 57^{\circ}.
$$

To complete the proof we shall consider now that $\delta = \frac{\pi}{5}$ (Fig. [14\)](#page-10-0). As before the side length of T, b, opposite to β is common to Q, leading to conclude that $\gamma = \arccos\sqrt{1 - \cos\frac{\pi}{5}} = \arccos$ $\frac{\sqrt{3-\sqrt{5}}}{2}$ ≈ $64^{\circ} > \frac{\pi}{3}$, contradicting [\(5.1\)](#page-8-2).

3D representations of some of these f-tilings are illustrated in Fig. [16.](#page-11-1) For additional information see also **Tab. [1](#page-17-0)**.

Remark: A 3D representation of the dihedral f-tilings M^k , $k \geq 4$ is obtained from a 3D representation of R^k , $k \ge 4$ (Prop. [4.2](#page-5-4) [i\)](#page-5-1)) by adding some edges bisecting by $\beta = 2 \arccos \sqrt{1 - \cos \frac{\pi}{k}}$ any isosceles triangle of R^k and preserving the angle-folding relation. Compare, for instance, the f-tilings M^5 (above, Fig. [16\)](#page-11-1) and R^5 (Fig. [6\)](#page-6-1).

Proposition 5.4 *If* $\alpha_2 + \gamma = \pi$, then $\Omega(Q, T)$ is the family of f-tilings denoted by $(R_\delta^2)_{\delta \in]0, \frac{\pi}{3}]}$, where $\cos \gamma + \cos \delta = 1$ *. (Its 3D representation is illustrated in Fig. [17.](#page-12-0))*

Remark: If $\delta = \frac{\pi}{3}$, then $\gamma = \frac{\pi}{3}$ and so $\alpha_1 = \alpha_2 = \frac{2\pi}{3}$, giving rise to a dihedral f-tiling, which was established in [Breda and Santos](#page-19-0) [\(2004\)](#page-19-0).

Proposition 5.5 *Let* $\tau \in \Omega(Q, T)$ *, such that* τ *has two cells in adjacent positions as illustrated in Fig.* [9-](#page-7-1) *D, then* τ *has six cells in adjacent positions as illustrated in Fig. [18.](#page-12-1)*

Proposition 5.6 *If the PR illustrated in Fig. 18 is contained in a complete PR of an element* $\tau \in \Omega(Q, T)$ *, then:*

i) *If* $\alpha_2 \ge \frac{\pi}{2}$ *, then* $\alpha_1 = \frac{2\pi}{3}$ *,* $\alpha_2 = \frac{\pi}{2} = \beta$ *,* $\gamma = \frac{\pi}{3}$ *and* $\delta = \frac{\pi}{4}$ *;*

ii) If
$$
\alpha_2 < \frac{\pi}{2}
$$
, then $\alpha_1 = \frac{2\pi}{3}$, $\alpha_2 = \frac{2\pi}{5}$, $\beta = \frac{\pi}{2}$, $\gamma = \frac{\pi}{3}$ and $\delta = \frac{\pi}{5}$.

 M oreover, the first situation leads to two dihedral f-tilings denoted by M^3 and S^2 , and in the second case *one gets three dihedral f-tilings denoted by* G1*,* G² *and* G3*, respectively. In any case* Q *is decomposed in four triangles congruent to* T, bisecting Q *twice, by* α_1 *and by* α_2 *. The sum of alternating angles around vertices are represented in Fig. [19.](#page-13-0) For a 3D representation of the mentioned f-tilings, see Fig. [20.](#page-13-1)*

Finally we present the f-tilings obtained from the adjacency illustrated in Fig. [9-](#page-7-1)E or Fig. [9-](#page-7-1)F.

Proposition 5.7 *Let* τ *be an element of* $\Omega(Q, T)$ *, such that* τ *has two cells in adjacent positions as illustrated in Fig. [9-](#page-7-1)E or Fig. [9-](#page-7-1)F, then*

$$
\tau = R_{\phi}^{k}, \text{ for some } \phi \in \left] 0, \arccos \frac{1 - \cos \frac{\pi}{k}}{2} \right[\setminus \{ \pi / k \} \text{ and } k \ge 3.
$$

Any planar representation of R^k_{ϕ} has the configuration of Fig. [5](#page-5-2) (replacing one of the γ angles by δ) and *the sum of alternating angles around vertices are given by:*

i) $\alpha_1 + \delta = \pi$, $\alpha_2 + \beta = \pi$ ($\beta > \alpha_2$) and $\gamma = \frac{\pi}{k}$, $k \ge 3$, when considered the adjacency illustrated *in Fig.* [9-](#page-7-1)*E. In this case* $\phi = \delta \in]0, \frac{\pi}{k}[;$

or

ii) $\alpha_1 + \gamma = \pi$, $\alpha_2 + \beta = \pi$ and $\delta = \frac{\pi}{k}$, $k \ge 3$, when considered the adjacency illustrated in Fig. [9-](#page-7-1)F. *Here* $\phi = \gamma \in \left[\frac{\pi}{k}, \arccos \frac{1-\cos \frac{\pi}{k}}{2}\right].$

In both cases $\cos \beta + \cos \gamma + \cos \delta = 1$ *.*

Proof: We shall suppose that $\tau \in \Omega(Q, T)$ has two cells in adjacent positions as illustrated in Fig. [9-](#page-7-1)E (the other case is analogous). Using similar argumentation to the one used before we obtain in a unique way a planar representation with the configuration of Fig. [5](#page-5-2) (replacing one of the γ angles by δ), where $\alpha_1 + \delta = \pi$, $\alpha_2 + \beta = \pi$ and $\gamma = \frac{\pi}{k}$, for some $k \ge 3$.

Now, as Q has all congruent sides and distinct pairs of opposite internal angles, then Q is congruent to a WCSQ, as seen in [Breda and Santos \(2003\)](#page-19-7). This means that $Q = L_1 \cap L_2$, for some non-orthogonal well centered spherical moons L_1 and L_2 , with angle measure $\gamma = \frac{\pi}{k}$ ($k \ge 3$), see Fig. [21.](#page-14-0)

With the labelling of Fig. [21,](#page-14-0) one gets

$$
\cos \beta = \frac{1 - \cos \frac{\pi}{k}}{2} - \frac{1 + \cos \frac{\pi}{k}}{2} \sin x
$$
\n(5.4)

and

$$
\cos \delta = \frac{1 - \cos \frac{\pi}{k}}{2} + \frac{1 + \cos \frac{\pi}{k}}{2} \sin x,\tag{5.5}
$$

for some $x \in]0, \frac{\pi}{2} [$ and $k \ge 3$. And so $\cos \frac{\pi}{k} + \cos \beta + \cos \delta = 1$.

The relations [\(5.4\)](#page-14-1) and [\(5.5\)](#page-14-2) define, respectively, an increasing continuous bijection between $x \in]0, \frac{\pi}{2}[$ and $\beta \in]\arccos \frac{1-\cos \frac{\pi}{k}}{2}, \frac{(k-1)\pi}{k} [$, and a decreasing continuous bijection between $x \in]0, \frac{\pi}{2} [$ and $\delta \in]0, \frac{\pi}{2} [$ $]0, \arccos \frac{1-\cos \frac{\pi}{k}}{2} [$.

Note that $\gamma \leq \frac{\pi}{3} < \arccos \frac{1-\cos \frac{\pi}{k}}{2} < \frac{\pi}{2}$, for all $k \geq 3$. Now, as $\beta > \gamma = \frac{\pi}{k} > \delta$, then exists $x_k \in]0, \frac{\pi}{2}$, such that $0 < \delta = \delta(x) < \frac{\pi}{k}$, for all $x \in]\overline{x}_k, \frac{\pi}{2}[$ and $k \ge 3$. In fact,

$$
\delta < \frac{\pi}{k} \Leftrightarrow \cos \delta(x) > \cos \frac{\pi}{k} \Leftrightarrow \sin x > \frac{-1 + 3\cos \frac{\pi}{k}}{1 + \cos \frac{\pi}{k}}.
$$

And so

$$
x_k = \arcsin\left(3 - \frac{4}{1 + \cos\frac{\pi}{k}}\right).
$$

Taking $\beta_k = \beta(x_k)$ (i.e., $\delta = \frac{\pi}{k}$), then one gets $\beta_k = 2 \arccos \sqrt{1 - \cos \frac{\pi}{k}} = \arccos(1 - 2 \cos \frac{\pi}{k})$.

One has $\beta_3 = \frac{\pi}{2}$ and $\frac{\pi}{2} < \beta_k < \pi$, if $k \ge 4$. And so $\beta = \beta(x) > \beta_k \ge \frac{\pi}{2} > \alpha_2$, for all $x \in]x_k, \frac{\pi}{2}[$ and $k \geq 3$.

The graphic representation of β and δ is shown in Fig. [22.](#page-15-0)

In Fig. [23](#page-16-0) are illustrated 3D representations of R^3_ϕ and R^4_ϕ

Remark: In the [ii\)](#page-14-3) case of Prop. [5.7](#page-12-2) x runs the interval $]0, x_k[$. β and γ are determined by x. Besides, considering the limit case $x = 0$, then $\gamma = \beta = \beta_k^* = \arccos \frac{1-\cos \frac{\pi}{k}}{2}$ and so $\alpha_1 = \alpha_2$, giving rise to a dihedral f-tiling established in [Breda and Santos \(2004\)](#page-19-0). The case $x = x_k$ ($k \ge 3$) leads to the f-tiling R^k obtained in Prop. [4.2](#page-5-4) (see [\(4.1\)](#page-6-2)).

In **Tab. [1](#page-17-0)** it is shown a complete list of all dihedral f-tilings, whose prototiles are a spherical triangle T of angles β , γ , δ ($\beta > \gamma > \delta$) if T is scalene, or angles β , γ , γ ($\beta \neq \gamma$) if T is isosceles, and, a non-equiangular spherical rhombus Q with pairs of opposite internal angles α_1 and α_2 ($\alpha_1 > \alpha_2$). We have used the following notation:

- $\beta_k = \arccos(1 2\cos\frac{\pi}{k}), \beta_k^* = \arccos\frac{1-\cos\frac{\pi}{k}}{2}, \text{ and } \delta_k = \arccos(\cos^2\frac{\pi}{2k});$
- At f-tilings R_{δ}^2 , R_{ϕ}^k ($\phi = \delta$ or $\phi = \gamma$) one has $\cos \beta + \cos \gamma + \cos \delta = 1$;
- |V| is the number of distinct classes of congruent vertices (we shall say that vertices v_1 and v_2 are congruent if and only if there is a spherical isometry that maps the faces incidents to v_1 into the faces incidents to v_2);
- M and N are, respectively, the number of quadrangles congruent to Q , and the number of triangles congruent to T , used in such dihedral f-tilings.

In Fig. [24](#page-18-0) it is shown a 3D representation of the dihedral f-tilings described on **Tab. [1](#page-17-0)**. Observe that for the families M^k , E^k and S^{k-1} , $k \ge 3$ we have chosen M^5 , E^3 and S^3 as representatives for their 3D representations.
