Motivations

- · Assessment of step-size adaptation mechanisms often done on too restrictive scenarios (the sphere function): misleading
- · Introduce a methodology to assess step-size adaptation mechanisms more thoroughly

Conclusion / Summary

- · Testing only the sphere function is misleading, a methodology with more test functions is advisable
- · All methods assume too large step-sizes on the sphere function in small dimension
- · Self-adaptation (SA) often assumes (far) too small stepsizes, despite its bias

Proposed Methodology

- · Evaluate on functions with known optimal step-size
- What to analyse: convergence rate, step-size change, and/or normalised step-size, for each function

Random fitness

- Unbiased random walk of $\ln \sigma^{(t)}$ is desired

Linear function $f: x \mapsto x_1$

- · Test how quickly the step-size is increased
- Linear increase of $\ln \sigma^{(t)}$ is demanded: at least a factor of 1.1 (2) within *n* evaluations (iterations)
- · Step-size increment should be comparable to step-size decrement on the sphere

Sphere function $f: x \mapsto ||x||^2$

- · Test how quickly the step-size is decreased
- Limited loss in convergence rate: at most 3 times slower
- Optimal step-size: $\sigma^{(t)} = \frac{\sigma_{\text{opt}}^*(n)}{\sigma_{\text{opt}}^*(n)} \times f(\boldsymbol{x}^{(t)})^{1/2}$

Ellipsoid function $f: x \mapsto$

- · Test the ability to estimate the optimal step-size
- With two moderate values of the condition number $\alpha = 10$, 100

Stationary sphere

- · Test the ability to estimate the optimal step-size without approaching the optimum
- · Artificial model with stationary optimal step-size: at each iteration, the mean vector is projected on the unit sphere

Tested Algorithms

Two-Point Step-Size Adaptation (TPA)

- · Performs a coarse line-search along the direction of the last mean shift from $\boldsymbol{x}^{(t-1)}$ to $oldsymbol{x}^{(t)}$
- · Sample the first two offspring along this line
- $\begin{aligned} & \boldsymbol{x}_{1/2}^{(t)} = \boldsymbol{x}^{(t)} \, \pm \, \boldsymbol{\sigma}^{(t)} \times \|\mathcal{N}_t(\mathbf{0}, \mathbf{I})\| \frac{\boldsymbol{x}^{(t)} \boldsymbol{x}^{(t-1)}}{\|\boldsymbol{x}^{(t)} \boldsymbol{x}^{(t-1)}\|} \\ & \cdot \text{ If } \boldsymbol{x}_1^{(t)} \text{ is better than } \boldsymbol{x}_2^{(t)}, \text{ increase } \boldsymbol{\sigma}^{(t+1)}, \text{ otherwise decrease it} \end{aligned}$

$$\begin{split} &\sigma^{(t+1)} = \sigma^{(t)} \times \exp\left(\frac{s^{(t)}}{d_{\sigma}}\right) \\ &s^{(t)} = (1 - c_{\sigma})s^{(t-1)} + c_{\sigma}\frac{\operatorname{rank}(\boldsymbol{x}_{2}^{(t)}) - \operatorname{rank}(\boldsymbol{x}_{1}^{(t)})}{\lambda - 1}, \ d_{\sigma} = \sqrt{n}, \ c_{\sigma} = 0.3 \end{split}$$

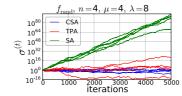
Cumulative Step-Size Adaptation (CSA) [1]

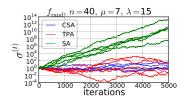
Self-Adaptation (SA) [2]

Results

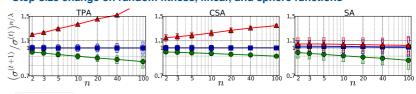
Random fitness





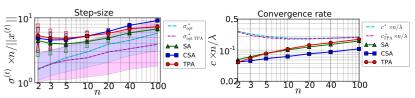
· Biased random walk for SA

Step-size change on random fitness, linear, and sphere functions



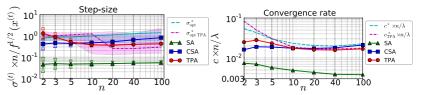
- On linear function
- TPA + CSA: an increment of at least 1.14 within n evaluations
 - SA: frequent decrements and an increment of a factor of only 1.05

Sphere function



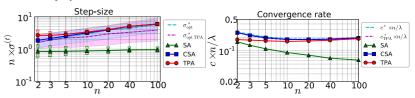
- · Shaded areas: values with at most 20% performance loss
- Small dimension: all algorithms are up to 5 times slower than optimal
- The gap to the optimal step-size decreases with increasing n

Ellipsoid function with a = 100



- TPA + CSA: close-to-optimal convergence rate in $n \ge 10$
- SA: performance deteriorates drastically compared to the sphere, step-size 20 times smaller than the optimal, convergence rate up to 6 times slower than the optimal

Stationary sphere



- TPA + CSA: close-to-optimal convergence rate in large dimensions, a moderate loss in small ones for TPA
- SA: step-size 2 to 6 times smaller than optimal, convergence rate 3 times slower than optimal only in n = 100
