Stability analysis of a metabolic model with sequential feedback inhibition

Abstract:

This paper deals with the stability analysis of a simple metabolic system with feedback inhibition. The system is a sequence of monomolecular enzymatic reactions. The last metabolite acts as a feedback regulator for the first enzyme of the pathway. The enzymatic reactions of the pathway satisfy Michaelis-Menten kinetics. The inhibition is described by an hyperbolic model. Without inhibition, it is clear that the system is cooperative and has a single globally asymptotically stable equilibrium. But, in the common situation where there is inhibition, the system is no longer cooperative and the stability analysis is more intricate. In this paper we exhibit sufficient conditions on the kinetic parameters in order to guarantee that this simple metabolic system with inhibition still has a single globally asymptotically stable equilibrium.

1 Introduction

The huge set of biochemical reactions which occur inside living cells is called the *Cellular Metabolism*. It is usually represented by an intricate network connecting the involved biochemical species (called "metabolites"). The pathways of the network are called "metabolic pathways". In the metabolic engineering literature, it is widely accepted that "despite their immense complexity, metabolic systems are characterized by their ability to reach stable steady states" (quoted from [6], Chapter 4). It should however be fair torecognize that a mathematical analysis of this fundamental stability property is a difficult question which was not much investigated. Our objective in this paper is to provide a modest contribution to this question. We shall limit ourselves to simple metabolic pathways which are made up of a sequence of mono-molecular enzyme-catalysed reactions as where X_i $(i = 1, \dots, n)$ represent the successive metabolites of the pathway:

$$X_1 \to X_2 \to \cdots \to X_n.$$

A typical situation is when such a simple pathway is located between two branch points of a complex metabolic network. We shall consider the case of a so-called *sequential feedback inhibition* (cf. [6]) where the last metabolite X_n acts as an inhibitor of the first reaction $X_1 \longrightarrow X_2$. This inhibition is represented by the dotted feedback arrow in Fig.1. The velocity of each enzymatic reaction $X_i \longrightarrow X_{i+1}$ is represented by a Michaelis-Menten kinetic function :

$$\varphi_i(x_i) = \frac{a_i x_i}{k_i + x_i},\tag{1.1}$$

where x_i denotes the intracellular molar fraction of the metabolite X_i , a_i is the maximal velocity and k_i the so-called *half-saturation* constant. It is assumed that the velocity of the first reaction $X_1 \longrightarrow X_2$ is inhibited by the last metabolite with a multiplicative hyperbolic inhibition function of the form:

$$\psi_{\alpha}(x_n) = \frac{1}{1 + \alpha x_n} \tag{1. 2}$$

In addition, it is assumed that the cell metabolism is analysed during a period of exponential cell growth with a constant specific growth rate μ . Under these assumptions and notations, a mass balance dynamical model is formulated as:

$$(\Sigma) \begin{cases} \dot{x}_1 = -\frac{a_1 x_1}{(k_1 + x_1)(1 + \alpha x_n)} - \mu x_1 + c, \\ \dot{x}_2 = \frac{a_1 x_1}{(k_1 + x_1)(1 + \alpha x_n)} - \frac{a_2 x_2}{(k_2 + x_2)} - \mu x_2, \\ \dot{x}_i = \frac{a_i - 1 x_i - 1}{(k_i - 1 + x_i - 1)} - \frac{a_i x_i}{(k_i + x_i)} - \mu x_i, \ 3 \le i \le n, \end{cases}$$
(1.3)

where $n \geq 3$ is a positive integer, $x = (x_1, \dots, x_n)^T \in \mathbb{R}^n$, and all the a_i, k_i 's, c, α, μ are positive constants.

In this model c denotes the inflow rate of the first metabolite X_1 of the sequence and is assumed to be constant. Without inhibition (i.e. $\alpha = 0$), the system Σ is clearly compartmental and cooperative which implies that it has a single globally asymptotically stable equilibrium. But if there is inhibition, the system is no longer cooperative and the stability analysis is more difficult. Our contribution in this paper will be to exhibit sufficient conditions on the kinetic parameters that guarantee that the simple metabolic system Σ with feedback inhibition still has a single globally asymptotically stable equilibrium.

2 Notations and statement of the theorem

2.1 Notations

Consider the metabolic system (Σ) with feedback inhibition (1. 3). Up to a change of variable (the x_i 's are multiplied by α) and a time reparameterization (the time is multiplied by μ), we may assume that $\mu = \alpha = 1$ and the model is rewritten:

$$(\Sigma) \begin{cases} \dot{x}_1 = -\varphi_1(x_1)\psi(x_n) - x_1 + c, \\ \dot{x}_2 = \varphi_1(x_1)\psi(x_n) - \varphi_2(x_2) - x_2, \\ \dot{x}_i = \varphi_{i-1}(x_{i-1}) - \varphi_i(x_i) - x_i, \ 3 \le i \le n, \end{cases}$$
(2.1)

where φ_i is defined in (1. 1) and $\psi := \psi_1$ in (1. 2). In this model, c stands for $\frac{\alpha c}{\mu}$ (with the original c in that last formula) and similarly, for $1 \le i \le n$, a_i stands for $\frac{\alpha a_i}{\mu}$ and k_i for αk_i .

We introduce some notations: for $2 \leq i \leq n$, $f_i(x) = x + \varphi_i(x)$ and $f_{1,x_n}(x) = x + \psi(x_n)\varphi_1(x)$. It is clear that the φ_i 's, $1 \leq i \leq n$, are strictly monotone functions on \mathbb{R}_+ and realize bijections between \mathbb{R}_+ and $[0, a_i)$. We use φ_i^{-1} to denote the inverse function. For $2 \leq i \leq n$, the f_i 's are strictly monotone functions on \mathbb{R}_+ and realize bijections from \mathbb{R}_+ to \mathbb{R}_+ ; f_i^{-1} denotes the inverse function of f_i and $g_i = \varphi_i \circ f_i^{-1}$. Let $M : \mathbb{R}_+ \to \mathbb{R}_+$ by $M = f_n^{-1} \circ g_{n-1} \circ \cdots \circ g_2$.

For every $x \ge 0$ and $2 \le i \le n$, we have

$$1 < f'_i(x) = 1 + \varphi'_i(x) \le 1 + \frac{a_i}{k_i}, \ \frac{k_i}{a_i + k_i} \le (f_i^{-1})'(x) = \frac{1}{1 + \varphi'_i(f_i^{-1}(x))} < 1.$$
(2.2)

Note that the f_i 's, the φ_i 's are concave functions on \mathbb{R}_+ (negative second derivative) for $2 \leq i \leq n$.

This implies that the g_i 's are also concave. Therefore, we have for $2 \le i \le n$ and every $x \ge 0$

$$0 < g'_i(x) = \frac{\varphi'_i(f_i^{-1}(x))}{1 + \varphi'_i(f_i^{-1}(x))} \le g'_i(0) = \frac{a_i}{k_i + a_i},$$
(2.3)

and since

$$M'(x) = (f_i^{-1})'(g_{n-1} \circ \cdots \circ g_2(x)) \left[\prod_{i=3}^{n-1} g_i'(g_{i-1} \circ \cdots \circ g_2(x))\right] g_2'(x),$$

we can then conclude from (2. 2) and (2. 3) that, for every $x \ge 0$

$$0 < M'(x) < \prod_{i=2}^{n-1} \frac{a_i}{k_i + a_i}.$$
(2.4)

As for f_{1,x_n} , for every $x_n \in \mathbb{R}_+$, it behaves like any f_i , $2 \leq i \leq n$. Define $z : \mathbb{R}_+ \to [0,c)$ by $z(b) = f_{1,b}^{-1}(c)$. Later we will study in more details that application. Let F be the vector field on \mathbb{R}^n simply defined by the right-hand side of (Σ) . Let $K = \mathbb{R}_+^n$ the non-negative orthant and K_+ the positive orthant. The positive cone K defines a closed partial order relation \leq on \mathbb{R}^n defined by $x \leq y$ if and only if $y - x \in K$. It means that $x_i \leq y_i$ holds for every $1 \leq i \leq n$. We write x < y if $x \leq y$ and $x \neq y$, and $x \ll y$ whenever $y - x \in Int(K) = K_+$. This notation extends trivially to subsets of \mathbb{R}^n . Moreover, if $x \leq y$, then the set $P_{x,y} = \{z \in \mathbb{R}^n, x \leq z \leq y\}$ is a parallellepiped. Let $v \in K_+$ defined by $v = (1, \dots, 1)$.

If $f : \mathbb{R}_+ \to \mathbb{R}$, set $\overline{\lim} f = \limsup_{t\to\infty} f$ and $\underline{\lim} f = \liminf_{t\to\infty} f$. This notation is naturally extended to the vectorial case using the partial order defined previously. We will also consider sometimes the function $V : \mathbb{R}^n \to \mathbb{R}$ defined by $V(x) = \sum_{i=1}^n x_i$. Let $T_d, d > 0$, be the simplex of Kdefined as the the set of $x \in K$ so that $V(x) \leq d$.

If $x, y \in X$, then [x, y] denotes the segment with extremities x and y, i.e. the set of points tx + (1 - t)y for $t \in [0, 1]$. A set $X \subset \mathbb{R}^n$ is said to be p-convex if for every $x, y \in X$ with $x \leq y$ then $[x, y] \subset X$. Let m be a positive integer. An $m \times m$ matrix $A = (a_{ij})$ is said to be irreductible if for every nonempty, proper subset $I \subset \{1, \dots, n\}$, there is an $i \in I$ and $j \in \{1, \dots, n\}/I$ such that $a_{ij} \neq 0$. There is a graph-theoretic formulation of irreducibility (cf. [5]): consider the directed graph \mathcal{G} whose set of vertices is $\{1, \dots, n\}$; two vertices i, j have a directed edge from i to j if $a_{ij} \neq 0$. Then A is irreducible if its directed graph \mathcal{G} is connected.

A dynamical system (G) given by $\dot{x} = G(x), x \in D$ with D open, $G: D \to \mathbb{R}^n$ of class C^1 is said to be cooperative (see [5]) if, for every $x \in D, 1 \leq i, j \leq n$ and $i \neq j$,

$$\frac{\partial G_i}{\partial x_j} \ge 0$$

If in addition the jacobian matrix DG(x) is irreducible for every $x \in D$, then (G) is said to be irreducible cooperative.

Remark 2. 1 It is worth noticing that (Σ) is not cooperative with respect to the partial order defined by K. It should be pointed out that the coefficient in the jacobian DF(x) that renders (Σ) non cooperative is $\frac{\partial f_2}{\partial x_n}$, which is indeed negative.

We will consider auxiliary systems $(\Sigma)_b, b \ge 0$, given by

$$(\Sigma)_{b} \begin{cases} \dot{x}_{1} = -\varphi_{1}(x_{1})\psi(x_{n}) - x_{1} + c, \\ \dot{x}_{2} = \varphi_{1}(x_{1})\psi(b) - \varphi_{2}(x_{2}) - x_{2}, \\ \dot{x}_{k} = \varphi_{k-1}(x_{k-1}) - \varphi_{k}(x_{k}) - x_{k}, \ 3 \le k \le n, \end{cases}$$

$$(2.5)$$

where the difference with (Σ) lies in the equation defining \dot{x}_2 : the variable x_n is frozen at the constant value b. We use $F_b(x)$ to denote the right-hand side of $(\Sigma)_b$. Now, the (2, n)-coefficient in $DF_b(x)$ is identically equal to zero. If $x \in K$, we use γ_x , γ_x^b respectively, to denote the trajectory of (Σ) , $(\Sigma)_b$ respectively, which starts at x.

2.2 Preliminary results and statement of the theorem

Proposition 2. 2 The system (Σ) has the following properties:

- (1) (Σ) has a unique equilibrium point $\bar{x} \in K_+$;
- (2) For every $x \in K$ and every t > 0, $\gamma_x(t) \in K_+$ i.e. K is a positively invariant set for (Σ) ;
- (3) For every $x \in K$, $\overline{\lim} V(\gamma_x) \leq c$; i.e. T_c is a global attractor of all the trajectories starting in K.

Remark 2. 3 Eventhough (Σ) is not cooperative, it has some of the basic features that are required for the investigation of the ω -limit sets of cooperative systems: an invariant cone with a repelling boundary, a bounded attractor and a unique equilibrium point.

Proof of Proposition 2. 2: we start with the argument of (1). Let $\bar{x} \in K$ an equilibrium point of (Σ) , i.e. $F(\bar{x}) = 0$. For $3 \leq k \leq n$, we have $\bar{x}_k = f_k^{-1} \circ \varphi_{k-1}(\bar{x}_{k-1})$. In addition, we deduce from

$$c - \bar{x}_1 = \varphi(\bar{x}_1)\psi(\bar{x}_n) = f_2(\bar{x}_2),$$

that $\bar{x}_2 = f_2^{-1}(c - \bar{x}_1)$. Then $\bar{x}_n = M(c - \bar{x}_1)$. Therefore, since M is strictly increasing, (Σ) admits as many equilibrium points in K as solutions in [0, c] of the equation

$$c = x + \varphi_1(x)\psi(M(c-x)).$$
 (2.6)

Define $J : [0, c] \to \mathbb{R}_+$ by $J(x) = x + \varphi_1(x)\psi(M(c-x))$. Since ψ is strictly decreasing, so is J. Moreover J(0) = 0 and $J(c) = c + \varphi_1(c) > c$. Then J takes the value c exactly once, which implies that equation (2. 6) has exactly one solution in (0, c). Claim (1) is proved.

To establish (2), it is enough to show that ∂K , the boundary of K is repelling for (Σ) . Let $y = (y_1, \dots, y_n)^T \in \partial K$ and $x = \gamma_y$. Let $i_0 = \max\{i, y_i = 0\}$. If $i_0 = 1$, then $\dot{x}_1(0) > 0$ and $x_1 > 0$ in a neighborhood of t = 0 and we are done.

Assume now that $i_0 > 1$. If $y_{i_0-1} > 0$, then $\dot{x}_{i_0}(0) > 0$ and the result follows. If not, then $y_{i_0-1} = \dot{x}_{i_0}(0) = 0$. The next alternative is whether $i_0 - 1 = 1$ or not. If $i_0 - 1 = 1$, then $\dot{x}_{i_0-1}(0) > 0$ and $\ddot{x}_{i_0}(0) > 0$; again the conclusion holds in this case. If $i_0 - 1 > 1$, we have a new alternative, whether $y_{i_0-2} > 0$ or not. If $y_{i_0-2} > 0$, then $\dot{x}_{i_0-1}(0) > 0$, case already studied. If $y_{i_0-2} = 0$, then $y_{i_0-l} = 0$ for l = 0, 1, 2. Proceeding in a similar manner, one can show that the last case to be treated corresponds to $y_{i_0-l} = 0$ for $l = 0, \dots, i_0$. It implies that $x_{i_0}^{(l)} = 0$ for $l = 0, \dots, i_0 - 1$. Since, anyhow $\dot{x}_1(0) > 0$, we must have $\dot{x}_{i_0}^{(i_0)} > 0$ and we are done.

Along trajectories of (Σ) , the derivative of V verifies

$$\dot{V} = c - V - \varphi_n(x_n). \tag{2.7}$$

Therefore, if $x = \gamma_x(0) \in K$ and taking into account (2), then $\varphi_n(\gamma_{x,n}(t)) \ge 0$. Then, $\dot{V} \le c - V$, which clearly implies (3).

Remark 2. 4 At the light of Proposition 2. 2, the relevance of the auxiliary systems $(\Sigma)_b$ for understanding the dynamics of (Σ) can be put forward. It is based on the two following remarks:

(a) for every b ≥ 0, (Σ)_b is an irreducible cooperative system (use the graph-theoretic formulation of irreducibility). This easily implies that (Σ)_b verifies (2) (cf. Theorem 1.1 p.56 of [5]) and (3) (with possibly another positive constant instead of c). In fact (Σ)_b is a hypercycle for which a Poincaré-Bendixon theory was developped for the compact ω-limit sets of (Σ)_b, regardless of the dimension of the system(cf. [4]). Then, we expect taking advantage of the many deep results relative to that class of irreducible cooperative systems (for an excellent reference, cf [5]).

(b) for every $x \in K$ and $0 \leq b_0 < b_1$, we have

$$b_0 \le x_n \le b_1 \Rightarrow F_{b_1}(x) \le F(x) \le F_{b_0}(x), \tag{2.8}$$

and, if $x_1 > 0$, then \leq can be replaced everywhere by < in the above equation. The monotonicity property expressed in (2.8) translates to the trajectories of F and F_b as explained next. Assume that we have shown the existence of $0 \leq b_0 < b_1$ such that for every $x \in K$, there is some $t_x > 0$ for which

$$b_0 \le x_n(t) \le b_1, \text{ if } t \ge t_x.$$
 (2.9)

(This is clearly the case by (3) of Proposition 2. 2.) Using (2.8), we have, for $t \ge t_x$,

$$F_{b_1}(\gamma_x(t)) \le F(\gamma_x(t)) \le F_{b_0}(\gamma_x(t))$$

Set $y_x = \gamma_x(t_x)$. Since F_b is a function of type K, we can apply a standard theorem of comparaison for differential inequalities (cf. for instance Theorem 10 p.29 of [2]): for $t \ge t_x$,

$$\gamma_{y_x}^{b_1}(t - t_x) \le \gamma_x(t) \le \gamma_{y_x}^{b_0}(t - t_x).$$
(2.10)

Assume now that, according to Part (a), the ω -limit sets of $(\Sigma)_{b_0}$ and $(\Sigma)_{b_1}$ are investigated in details and one is able to show e.g. that every trajectory of $(\Sigma)_{b_0}$ ($(\Sigma)_{b_1}$ respectively) starting in K converges to x^{b_0} (x^{b_1} respectively). In addition, assume that $b_0 \ll x^{b_0}$ and $x^{b_1} \ll b_1$. Then the pair ($x_n^{b_0}, x_n^{b_1}$) can be used in (2. 9) instead of (b_0, b_1) in the bounding process for $\gamma_x(t)$ described above. If that procedure can be reproduced, one may hope to get more and more precise information on the ω -limit sets of (Σ). It is even tempting to conjecture that every trajectory of (Σ) starting in K converges to \overline{x} . We prove it but for a restricted set of the problem's parameters.

Theorem 2.5 Under the following condition (C),

(C)
$$(a_1 + c) \prod_{i=2}^{n-1} \frac{a_i}{k_i + a_i} \le 1$$
 (2. 11)

the system (Σ) is globally asymptotically stable in K with respect to \bar{x} .

Remark 2. 6 We may express condition (C) in terms of the original parameters, i.e. with α and μ . Equation (2. 11) becomes

$$\frac{\alpha}{\mu}(a_1+c)\prod_{i=2}^{n-1}\frac{a_i}{\mu k_i+a_i} \le 1.$$
(2.12)

It is not surprising that if $\alpha = 0$ (i.e. no inhibition) or if μ is large enough then the condition expressed in (2. 12) holds true.

3 Proof of Theorem 2. 5

3.1 Technical lemmas

Before starting the proof of the theorem, we establish a series of useful lemmas. We first study the application $z : \mathbb{R}_+ \to [0, c)$ by $z(b) = f_{1,b}^{-1}(c)$. We have

Lemma 3.1

- (i) The application z is strictly increasing from \mathbb{R}_+ to [0, c);
- (ii) The application $\varphi_1 \circ z$ is strictly increasing from \mathbb{R}_+ to $[0, \varphi_1(c))$ and is concave.

Proof of Lemma 3. 1: The expression of z(y) comes from the equation $\dot{x}_1 = 0$. Differentiating this equation with respect to y results in an expression $z'(y) = l(z(y), \frac{1}{1+y})$ for some function l. We then isolate $\frac{1}{1+y}$ in the equation $\dot{x}_1 = 0$ and substitute the resulting expression into l, so that

$$z'(y) = \frac{(c - z(y))^2 (z(y) + k_1)^2}{a_1(z(y)^2 + ck_1)}$$
(3. 1)

and z'(y) > 0 for all $y \ge 0$ because z(y) < c for all $y \ge 0$. Item (i) is proved.

The expressions of $\frac{d\varphi_1(z(y))}{dy}$ and $\frac{d^2\varphi_1(z(y))}{dy^2}$ result from straightforward computations:

$$\frac{d\varphi_1(z(y))}{dy} = \varphi_1'(z)z'(y) = \frac{k_1(c-z(y))^2}{z(y)^2 + ck_1}$$
(3. 2)

$$\frac{d^2\varphi_1(z(y))}{dy^2} = \frac{d}{dz} \left(\frac{d\varphi_1(z(y))}{dy}\right) z'(y) = -\frac{2k_1c(c-z(y))^3(z(y)+k_1)^3}{(z(y)^2+ck_1)^3}$$
(3.3)

so that $\frac{d\varphi_1(z(y))}{dy} > 0$ and $\frac{d^2\varphi_1(z(y))}{dy^2} < 0$ because z(y) < c.

Next, we determine, for $b \in [0, c]$, the equilibrium set E_b of $(\Sigma)_b$, i.e. the set of the equilibrium points of $(\Sigma)_b$.

Lemma 3. 2 A point $e \in K$ is an element of E_b if and only if its *n*-th coordinate e_n is solution in \mathbb{R}_+ of the following equation in the unknown y

$$y = M(\varphi_1(z(y))\psi(b)).$$
(3. 4)

Moreover the previous equation has always solutions and it has exactly one if condition (C) holds.

Remark 3.3 We chose in this paper to investigate the sets E_b 's in an elementary way rather than using the deep work of [4] and [3]. Doing so leads to obtain results on E_b which are only valid under

condition (C) eventhough they are more general. The more complete characterization of the E_b 's will appear in the final version of the paper, see [1].

Proof of Lemma 3. 2: if $e \in E_b$, then $e_n = M(\varphi_1(e_1)\psi(b))$. Then (3. 4) follows by definition of z. When considering the solutions of (3. 4), we are looking for the zeros of the function $h_b : \mathbb{R}_+ \to \mathbb{R}$, defined by

$$h_b(y) = y - M(\varphi_1(z(y))\psi(b)).$$

Note that $h_b(0) < 0$ and h_b tends to $+\infty$ if y tends to $+\infty$ (indeed, $\varphi_1(z(y))\psi(b)$ is bounded). Therefore, if h_b is strictly increasing, then E_b will have a unique equilibrium point. We show next that this holds true under condition (C).

The derivative of h_b is

$$h_b'(y) = 1 - M'\Big(\varphi_1(z(y))\psi(b)\Big)\frac{d\varphi_1(z(y))}{dy}\psi(b), \qquad (3.5)$$

Equation (2.4) gives an upper bound on M' and concavity of $\varphi_1(z(y))$ implies that

$$\frac{d\varphi_1(z(y))}{dy}(y)\psi(b) \le \frac{d\varphi_1(z(y))}{dy}(0)\psi(b).$$

We also see from (3. 1) and (3. 3) that $\frac{d}{dz}\left(\frac{d\varphi_1(z(y))}{dy}\right) < 0$ so that

$$\frac{d\varphi_1(z(y))}{dy}_{|z=z(0)} < \frac{d\varphi_1(z(y))}{dy}_{|z=0} = c.$$

We then have a unique zero to h_b if

$$1 - \prod_{i=2}^{n-1} \frac{a_i}{k_i + a_i} c > 0$$

which is satisfied if condition (C) holds. The lemma is proved.

From now on, assume that condition (C) holds. Then, for every $b \ge 0$, $(\Sigma)_b$ has a unique equilibrium point e(b) in K_+ . All the assumptions of Theorem 3.1 of [5] are satisfied. Therefore, $(\Sigma)_b$ is globally (with respect to initial states in K) asymptotically stable with respect to e(b).

The next lemma studies the application $e : [0,c] \to K_+$ that associates to $b \in [0,c]$, e(b). Set $e_n : [0,c] \to \mathbb{R}_+$ for the application that associates to b the n-th coordinate of e(b). Note that \bar{x}_n is a fixed point of e_n .

Lemma 3. 4 Assume that condition (C) holds. Then

(1) e_n is a strictly decreasing function and \bar{x}_n is its unique fixed point;

(2) if $b_1 < b_2$, then $e(b_2) \ll e(b_1)$;

(3) if $b < \bar{x}_n$, then $b < \bar{x}_n < e_n(b)$ and $\bar{x} \ll e(b)$; similarly if $\bar{x}_n < b$, then $e_n(b) < \bar{x}_n < b$ and $e(b) \ll \bar{x}$.

Proof of Lemma 3. 4: Define $H(w, b) := h_b(w)$ for $(y, b) \in \mathbb{R}^2_+$. The differentiation of $H(e_n(b), b) = 0$ yields

$$\frac{de_n}{db} = -\frac{\partial_b H}{\partial_y H} = \frac{M' \Big(\varphi_1(z(e_n(b)))\psi(b)\Big)\varphi_1(z(e_n(b)))\psi'(b)}{h'_b(e_n(b))} < 0,$$
(3. 6)

since ψ is strictly decreasing. In addition, recall that $e_1(b) = z(e_n(b))$ and $e_k(b) = \varphi_k^{-1}(f_{k+1}(e_{k+1}(b)))$ for $2 \le k \le n-1$. Then (2) holds since z and the $\varphi_k^{-1} \circ f_{k+1}$'s are strictly increasing functions.

Part (3) is immediate by taking into account the facts that the function e_n is strictly decreasing, \bar{x}_n is its unique fixed point and (2).

Lemma 3.5 Consider (I^l) and (S^l) the sequences of points of K defined inductively as follows

$$\begin{cases} I^{l+1} = e(S_n^l), \\ S^{l+1} = e(I_n^l), \end{cases}$$
(3.7)

with $I^0 = 0$ and S^0 so that $e(0) \ll S^0$ and, for every $x \in T_c$, $x \ll S^0$. Here e(0) is the equilibrium point of $(\Sigma)_0$. Then, for every $l \ge 0$, we have $I^l \ll \overline{x} \ll S^l$ and

$$\lim_{l \to \infty} I^l = \lim_{l \to \infty} S^l = \bar{x}, \qquad (3.8)$$

where \bar{x} is the equilibrium point of (Σ) .

Proof of Lemma 3. 5: we first prove that for every $l \ge 0$, $I^l \ll \bar{x} \ll S^l$, (I^l) is increasing and (S^l) is decreasing with respect to the partial order \ll . The argument goes by induction. More precisely, we show by induction that, for every $l \ge 0$, the next proposition (P_l) holds,

$$(P_l) \ I^l \ll \bar{x} \ll S^l, \ I^l \ll I^{l+1}, \ S^{l+1} \ll S^l.$$
(3. 9)

Clearly (P_0) holds. Assume now that $(P_l), l \ge 0$ is true. Then $\bar{x}_n < S_n^l$. By Lemma 3. 4, (3) we have

$$I^{l+1} = e(S_n^l) \ll e(\bar{x}_n) = \bar{x}.$$

Similarly, we have $\bar{x} \ll S^{l+1}$. Since $I^l \ll I^{l+1}$, then $I^l_n < I^{l+1}_n$ and finally

$$S^{l+2} = e(I_n^{l+1}) \ll e(I_n^l) = S^{l+1}.$$

Similarly, $I^{l+1} \ll I^{l+2}$.

Since the sequences (I^l) and (S^l) are monotone (componentwise) they converge to I and S with $I \leq \bar{x} \leq S$. By passing to the limit in (3. 7), we have

$$I = e(S_n), \ S = e(I_n),$$
 (3. 10)

which implies that $I_n = e_n(S_n)$ and $S_n = e_n(I_n)$, i.e. I_n and S_n are fixed points of $e_n \circ e_n$. The derivative of that function is $\frac{de_n}{db}(e_n)\frac{de_n}{db} \ge 0$. If it is smaller than one then \bar{x}_n is the unique fixed point of $e_n \circ e_n$ on \mathbb{R}_+ and (3.8) is proved.

Finally to get $\frac{de_n}{db}(e_n)\frac{de_n}{db} \leq 1$, it is enough to have $\left|\frac{de_n}{db}\right| \leq 1$. Taking into account (3. 6), it is enough that, for every $b \in [0, c)$

$$M'\Big(\varphi_1(z(e_n(b)))\psi(b)\Big)\varphi_1(z(e_n(b)))|\psi'(b)| \le h'_b(e_n(b)),$$

which in turn follows from the next inequality

$$M'\Big(\varphi_1(z(e_n(b)))\psi(b)\Big)(\varphi_1(z(e_n(b))) + \frac{d\varphi(z(y))}{dy}(e_n(b)) \le 1.$$
(3. 11)

Because an upper bound of M' is given in equation (2. 4), φ_1 is bounded above by a_1 , and $\frac{d\varphi(z(y))}{dy}$ by c, then (3. 11) is implied by condition (C). Since the latter already holds true, the proof of the lemma is finished.

Lemma 3.6 Let $x \in K$. Then $0 \ll \underline{\lim} \gamma_x$

Proof of Lemma 3. 6: Without loss of generality, we take $0 \ll x$ (cf. Proposition 2. 2, (2)) and argue by contradiction. Then there exists $1 \le i \le n$ so that P_i holds:

$$(P_i): \quad \forall \varepsilon > 0, \ \forall t > 0, \ \exists t' > t, \ x_i(t') < \varepsilon, \tag{3. 12}$$

where $x_j := (\gamma_x)_j, \ 1 \le j \le n$.

Consider the largest interval I containing t' so that $x_i(s) \leq \varepsilon$ for $s \in I$. By taking ε small enough, the interval I is of the type $[t_0, \cdots$ with $t_0 > 0$. By continuity, $x_i(t_0) = \varepsilon$ and $\dot{x}_i(t_0) \leq 0$. Clearly, i cannot be equal to 1, otherwise, from $\dot{x}_i(t_0) \leq 0$, we would deduce that $c \leq a_1\varepsilon$, which is impossible for ε small enough.

If (P_2) holds, then $x_2(t_0) = \varepsilon$ and $\dot{x}_2(t_0) \le 0$ imply that $x_1(t_0) \le C_1 \varepsilon$, with C_1 only depending on the positive parameters a_1, a_2, k_2, k_1 . This means that (P_1) holds and we have a contradiction.

Replacing 2 by any index $i \ge 3$ in the previous sentence indicates that if (P_i) holds, then the same is true for (P_{i-1}) and by a trivial induction we again have (P_1) . Therefore, if any (P_i) holds, we get a contradiction. The proof of Lemma 3. 6 is complete.

3.2 Final part of the proof of Theorem 2.5

We are now ready to establish Theorem 2. 5. From what precedes, the conclusion is the consequence of the next statement: for every $x \in K$ and for every $l \ge 0$

$$(Q_l) \quad I^l \le \underline{\lim} \gamma_x \le \overline{\lim} \gamma_x \le S^l. \tag{3. 13}$$

Fix $x \in K$. Proposition (Q_l) is proved inductively. For l = 0, this is a consequence of Proposition 2. 2, (3). Applying Lemma 3. 6, there exists $\varepsilon > 0$ and $t_0(\varepsilon) > 0$ such that for every $t \ge t_0(\varepsilon)$,

$$\varepsilon v \le \gamma_x(t) \le S^0 - \varepsilon v. \tag{3. 14}$$

Then, passing to the limit we have

$$e(S_n^0 - \varepsilon) \le \underline{\lim} \gamma_x \le \overline{\lim} \gamma_x \le e(\varepsilon).$$
 (3. 15)

Note that, in equation (3. 14), ε may be replaced by any $0 < \eta \leq \varepsilon$. Since *e* is globally Lipschitz over \mathbb{R}_+ , equation (3. 15) implies (Q_1) but also the existence of $t_1(\varepsilon) > 0$ such that for every $t \geq t_1(\varepsilon)$,

$$I^{1} + C_{1}\varepsilon v \le \gamma_{x}(t) \le S^{1} - C_{1}\varepsilon v, \qquad (3. 16)$$

for some $0 < C_1 \leq 1$ independant of ε . Notice that equation (3. 16) is of the same type as equation (3. 14) and then leads to equations similar to (3. 15) and again (3. 16). In that way, we obtain, for every $l \geq 2$,

$$e(S_n^l - C_l \varepsilon) \le \underline{\lim} \gamma_x \le \overline{\lim} \gamma_x \le e(I_n^l + C_l \varepsilon), \qquad (3. 17)$$

and the existence of $t_l(\varepsilon)$ such that, for every $t \ge t_l(\varepsilon)$,

$$I^{l} + C_{l+1}\varepsilon v \le \gamma_{x}(t) \le S^{l} - C_{l+1}\varepsilon v,$$

with $C_{l+1} \leq C_l \leq 1$ independant of ε . Letting ε tend to zero in (3. 17), we get (Q_l) .
