Liquidity costs: a new numerical methodology and an empirical study^{*}

Abstract

We consider rate swaps which pay a fixed rate against a floating rate in presence of bid-ask spread costs. Even for simple models of bid-ask spread costs, there is no explicit optimal strategy minimizing a risk measure of the hedging error. We here propose an efficient algorithm, based on the stochastic gradient method, to obtain an approximate optimal strategy without solving a stochastic control problem. We validate our algorithm by numerical experiments. We also develop several variants of the algorithm and discuss their performances in terms of the numerical parameters and the liquidity cost.

1 Introduction

Classical models in financial mathematics usually assume that markets are perfectly liquid. In particular, each trader can buy or sell the amount of assets he/she needs at the same price (the "market price"), and the trader's decisions do not affect the price of the asset. In practice, the assumption of perfect liquidity is never satisfied but the error due to illiquidity is generally negligible with respect to other sources of error such as model error or calibration error, etc.

However, the perfect liquidity assumption cannot hold true for interest rates derivatives market: on the one hand, the underlying interest rate is not directly exchangeable; on the second hand, the liquidity costs to hedge interest rates derivatives are highly time varying (even though there exist maturities for which zerocoupon bonds are liquid, bonds at intermediate maturities may be extremely illiquid). Therefore, hedging of such derivatives absolutely needs to take liquidity risk into account. In this context, defining and computing efficient approximate perfect hedging strategies is a complex problem. The main purpose of this paper is to show that stochastic optimization methods are powerful tools to treat it without solving a necessarily high dimensional stochastic control problem, under the constraints that practitioners need to trade at prescribed dates and that relevant strategies depend on a finite number of parameters. More precisely, we construct and analyse an efficient original numerical method which provides strategies facing liquidity costs and minimizing hedging errors.

The outline of the paper is as follows. Section 2 introduces the model. In Section 3, we present our numerical method and analyse it from a theoretical point of view within the framework of a Gaussian yield curve model. Section 4 is devoted to numerical validation in the idealistic perfect liquidity context. In Section 5, we develop an empirical study of the efficiency of our algorithm in presence of liquidity cost.

2 Our settings: swaps with liquidity cost

2.1 A short reminder on swaps and swap options hedging without liquidity cost

One of the most common swaps on the interests rates market is as follows. The counterparts exchange two coupons: the first one is generated by a bond (with a constant fixed interest rate) and the second one is generated by a floating rate (e.g. a LIBOR).

Definition 1. In a perfectly liquid market, the price at time t of a zero-coupon bond paying 1 at time T is denoted by B(t,T). The linear forward rate $L(T_F, T_B, T_E)$ is the price decided at time T_F , paid at time T_B to receive 1 at time T_F . These two prices satisfy the relation

$$L(T_F, T_B, T_E) = \frac{1}{T_E - T_B} \left(\frac{B(T_F, T_B)}{B(T_F, T_E)} - 1 \right).$$
(1)

A swap contract specifies:

- an agreement date t
- a time line $(t \leq) T_0 < \cdots < T_N$
- a fixed interest rate r
- a floating interest rate
- the payoff at each time T_i $(1 \le i \le N)$ is

$$P(i) := (T_i - T_{i-1}) (r - L (T_{i-1}, T_{i-1}, T_i)).$$
(2)

From (1), we deduce the equivalent expression

$$P(i) = r \left(T_i - T_{i-1}\right) - \frac{1}{B(T_{i-1}, T_i)} + 1.$$
(3)

In the sequel, we consider that the fixed rate r is chosen at the money (thus the swap at time t has zero value), and that the swap fixed coupons are received by the trader.

In the idealistic framework of a market without liquidity cost, the trader buys or sells quantities of zero-coupon bonds at the same price (i.e. the *market price*), and there exists a discrete dynamic perfect hedging strategy which is independent of any model of interest rates. In view of (3), the replication of the payoff P(i) at time T_i can be split into three parts:

- the fixed part $r(T_i T_{i-1})$ is replicated statically at time t by selling $r(T_i T_{i-1})$ zero-coupon bonds with maturity T_i .
- the floating part $1/B(T_{i-1}, T_i)$ is replicated dynamically at time T_{i-1} by buying $1/B(T_{i-1}, T_i)$ zero-coupon bonds with maturity T_i . The price of this transaction is equal 1.
- the last (fixed) part 1 is used at time T_i to buy $1/B(T_i, T_{i+1})$ zero-coupon bonds with maturity T_{i+1} .

It is easy to see that this strategy is self-financing at time T_1, \dots, T_{N-1} . To make it self-financing at any time, at time t, 1 zero-coupon bond with maturity T_0 is bought and 1 zero-coupon bond with maturity T_N is sold.

To summarize, in the idealistic framework, we do not need hedging strategies within the set of all the $(\mathcal{F}_{\theta}^{R}, \theta \geq 0)$ adapted processes, where $(\mathcal{F}_{\theta}^{R}, \theta \geq 0)$ is the filtration generated by the interest rate $(R_{\theta}, \theta \geq 0)$, and we may restrict the admissible strategies to be adapted to the filtration generated by the rates at times $\{t, T_0, T_1, \cdots, T_N\}$.

2.2 Hypotheses on markets with liquidity costs

We now consider markets with liquidity costs and need to precise our liquidity cost model.

Hypothesis 2.

We assume that the numbers $\pi(j, i)$ of zero-coupon bonds with maturity T_i bought or sold at time T_j (j < i) are measurable with respect to the filtration generated by $(R_t, R_{T_0}, \dots, R_{T_j})$. It means that the admissible strategies do not depend on the evolution of the rate R_{θ} between two dates T_m and T_{m+1} .

Denote by $\Psi(T, U, \pi)$ the buy or sell price for π zero coupon bonds. In perfectly liquid markets, $\Psi(T, U, \pi)$ is the linear function $B(T, U)\pi$, where B(T, U) is defined in Definition 1. In the presence of liquidity costs, $\Psi(T, U, \pi)$ becomes a non-linear function of π .

Hypothesis 3.

For all T and U, the price $\Psi(T, U, \pi)$ is a $C^1(\mathbb{R})$, increasing, convex one-to-one map of π from \mathbb{R} to \mathbb{R} , and $\Psi(T, U, 0) = 0$.

Under the preceding hypothesis, the function Ψ is positive when $\pi > 0$ and negative when $\pi < 0$.

In the context of the swap options, we set

$$\Psi_{i,j}(\pi) := \Psi(T_i, T_j, \pi) \tag{4}$$

and we only consider self-financing strategies, that is, satisfying

$$\forall 0 \le j \le N - 1, \quad \sum_{-1 \le k < j} \pi(k, j) + P(j) = \sum_{j < i \le N} \Psi_{j,i}(\pi(j, i)), \tag{5}$$

where $\pi(j, i)$ denotes the quantity of zero-coupon bonds with maturity T_i bought or sold at time T_j and T_{-1} denotes t.

2.3 Risk minimization objective

In the presence of liquidity costs, the market is no more complete and the practitioners need to build a strategy which minimizes a risk measure. Such strategies are usually obtained by solving stochastic control problems. These problems require high complexity numerical algorithms which are too slow to be used in practice. We here propose an efficient and original numerical method to compute strategies which approximately minimize convex functions of the hedging errors. As the perfect hedging leads to a null portfolio at time T_N , we have to solve the optimization problem

$$\inf_{\boldsymbol{\pi}\in\Pi} \mathbb{E}\left[U(W^{\boldsymbol{\pi}})\right],\tag{6}$$

where W^{π} is the terminal wealth (at time T_N) given the strategy π in the set Π of admissible strategies, and U is a given risk function supposed to be convex.

3 Risk minimization method in a Gaussian framework

The methodology we introduce in this section is based on the two following key observations:

- (1) We consider strategies and portfolios with finite second moment, and thus optimize within $L^2(\mu)$ for some probability measure μ . The Gram-Schmidt procedure provides countable orthogonal basis \mathcal{B} of a separable Hilbert space $L^2(\mu)$. The set Π of admissible strategies is defined by truncation of the basis, which reduces the a priori infinite dimensional optimization problem (6) to a finite dimensional parametric optimization problem of the type $\inf_{\theta \in \Theta} \mathbb{E}\Psi(\theta, X)$, where Θ is a subset of \mathbb{R}^p , X is a given random variable, Ψ is a convex function of θ .
- (2) Robbins Monro algorithm and Chen's extension are stochastic alternatives to Newton's method to numerically solve such optimization problems. These algorithms avoid to compute $\frac{d}{d\theta} \mathbb{E} \Psi(\theta, X)$. They evolve as

$$\theta_{\gamma+1} = \theta_{\gamma} - \rho_{\gamma+1} \frac{\partial}{\partial \theta} \Psi(\theta_{\gamma}, X_{\gamma+1}), \tag{7}$$

where $(\rho_{\gamma}, \gamma \geq 1)$ is a decreasing sequence and $(X_{\gamma}, \gamma \geq 1)$ is an i.i.d. sequence of random variables distributed as X.

We here consider the case of swap options in the context of a Gaussian yield curve. This assumption is restrictive but is satisfied by widely used models such as Vasicek model or Gaussian affine models. In [1] it is shown that using a three dimensional Gaussian model is sufficient to fit the term structure of interest rates products.

3.1 Step 1: finite dimensional projections of the admissible controls space

Consider a Gaussian interest rates model $(R_{\theta}, \theta \geq 0)$. In view of Hypothesis 2, each control $\pi(j, i)$ belongs to the Gaussian space generated by $(R_t, R_{T_0}, \dots, R_{T_j})$ or, equivalently, to a space generated by $\ell(j)$ standard independent Gaussian random variables $G^{(0)}, G^{(1)}, \dots, G^{(\ell(j))}$ (with $\ell(j) = j$ for one-factor models, $\ell(j) = 2j + 1$ for two-factor models, etc.). An explicit L^2 orthonormal basis of the space generated by $G^{(0)}, G^{(1)}, \dots, G^{(\ell(j))}$ is

$$\left(\prod_{m=0}^{\ell(j)} \frac{H_{n_m}(G^{(m)})}{\sqrt{n_m!}}\right)_{(n_0,\cdots,n_{\ell(j)})\in\mathbb{N}^{\ell(j)+1}},\tag{8}$$

where $(H_n, n \ge 0)$ are the Hermite polynomials

$$H_n(x) = (-1)^n e^{x^2/2} \frac{d^n}{dx^n} e^{-x^2/2}$$

(see e.g. [9, p.236]).

Thus, the quantities of zero-coupon bonds bought by the trader can be written as

$$\sum_{\boldsymbol{n}_{(j)}\in\mathbb{N}^{\ell(j)+1}}\alpha^{\boldsymbol{n}_{(j)}}(j,i)\prod_{m=0}^{\ell(j)}\frac{H_{n_m}(G^{(m)})}{\sqrt{n_m!}},\quad \boldsymbol{n}_{(j)}=(n_0,\cdots,n_{\ell(j)}),\tag{9}$$

where the equality has an L^2 limit sense. A strategy can now be defined as a sequence of real numbers $\alpha^{\mathbf{n}_{(j)}}(j,i)$ for all $-1 \leq j < i \leq N-1$ and $\mathbf{n}_{(j)} \in \mathbb{N}^{\ell(j)+1}$.

In order to be in a position to solve a finite dimensional optimization problem, we truncate the sequence $(\alpha^{n_{(j)}}(j,i))$. Then a strategy is defined by a finite number of real parameters $\{\alpha^{n_{(j)}}(j,i), -1 \leq j < i \leq N-1\}$ where, for all j, $n_{(j)}$ belongs to a finite subset $\Lambda^{(j)}$ of $\mathbb{N}^{\ell(j)+1}$. The truncated quantities of zero-coupon bonds bought by the trader write

$$\pi(j,i) = \sum_{\boldsymbol{n}_{(j)} \in \Lambda^{(j)}} \alpha^{\boldsymbol{n}_{(j)}}(j,i) \prod_{m=0}^{\ell(j)} \frac{H_{n_m}(G^{(m)})}{\sqrt{n_m!}}.$$
 (10)

We discuss the efficiency of this truncation and its convergence in Sec. 3.4 and show numerical results in Sec. 4.1.

To simplify, we denote by $\boldsymbol{\alpha} = (\alpha^{\boldsymbol{n}_{(j)}}(j,i))_{i,j,\boldsymbol{n}_{(j)}}$ the parameters to optimize in \mathbb{R}^p (where the dimension p is known for each truncation $(\Lambda^{(j)}, j = -1, 0, \cdots, N - 1)$

1)), by $\boldsymbol{\pi}(\boldsymbol{\alpha})$ (or, when no confusion is possible, simply $\boldsymbol{\pi}$) the hedging strategy corresponding to a vector $\boldsymbol{\alpha} \in \mathbb{R}^p$, see (10). Given the strategy $\boldsymbol{\pi} = \boldsymbol{\pi}(\boldsymbol{\alpha})$, the terminal wealth $W^{(\boldsymbol{\alpha})}$ (at time T_N) satisfies

$$W^{(\alpha)} = \sum_{-1 \le j < N} \pi(\alpha)(j, N) + P(N) = \sum_{-1 \le j < N} \pi(j, N) + P(N).$$
(11)

The problem (6) is now formulated as

$$\inf_{\boldsymbol{\alpha}\in\mathbb{R}^p}\mathbb{E}\left[U\left(W^{(\boldsymbol{\alpha})}\right)\right].$$
(12)

3.2 Step 2: stochastic optimization

Using the self-financing equation (5) one can express $W^{(\alpha)}$ as a function of α and $(G^{(0)}, \dots, G^{(\ell(N))})$. Therefore one needs to minimize the expectation of a deterministic function of a parameter α in \mathbb{R}^p and the random vector $(G^{(0)}, \dots, G^{(\ell(N))})$. Such problems can be solved numerically by classical stochastic optimization algorithms, such as those introduced in the pioneering work of Robbins and Monro [10] and its extensions (e.g. Chen and Zhu [3]). We refer the interested reader to the classical references [5, 2, 6]

In our context (12), the Robbins Monro algorithm (7) works as follows. Start with an arbitrary initial condition $\boldsymbol{\alpha}_0$ in \mathbb{R}^p . At step $\gamma + 1$, simulate independent Gaussian random variables $(G_{\gamma+1}^{(0)}, \cdots, G_{\gamma+1}^{(\ell(N))})$ and compute the terminal wealth $W^{(\boldsymbol{\alpha}_{\gamma})}$. Then, update the parameter $\boldsymbol{\alpha}$ by the induction formula

$$\boldsymbol{\alpha}_{\gamma+1} = \boldsymbol{\alpha}_{\gamma} - \rho_{\gamma+1} \nabla_{\boldsymbol{\alpha}} \left[U(W^{(\boldsymbol{\alpha}_{\gamma})}) \right], \qquad (13)$$

where (ρ_{γ}) is a decreasing sequence. In addition, one can use an improvement of this algorithm due to Chen and Zhu in [3]. Let $(K_l, l \ge 0)$ be a sequence of compact sets such that

$$K_l \subset \operatorname{Int}(K_{l+1})$$
 and $\lim_l K_l = \mathbb{R}^p$. (14)

The initial condition α_0 is assumed to be in K_0 and we set l(0) = 0. At each step γ in (13), if $\alpha_{\gamma+1} \in K_{l(\gamma)}$, we set $l(\gamma+1) = l(\gamma)$ and go to step $\gamma + 1$. Otherwise, that is if $\alpha_{\gamma+1} \notin K_{l(\gamma)}$, we set $\alpha_{\gamma+1} = \alpha_0$ and $l(\gamma+1) = l(\gamma) + 1$. This modification avoids that the stochastic algorithm may blow up during the first steps and, from a theoretical point of view, allows to prove its convergence under weaker assumptions than for the standard Robbins Monro method.

3.3 Summary of the method

Setting

• The interest rate model satisfies: for all $0 \leq j < N$, there exist an integer $\ell(j)$ and a function Φ_j such that

$$(R_t, R_{T_0}, \cdots, R_{T_j}) \stackrel{\mathcal{L}}{=} \Phi_j(R_t, G^{(0)}, \cdots, G^{(\ell(j))}).$$

- For all $0 \le j < N$, a finite truncation $\Lambda^{(j)} \subset \mathbb{N}^{\ell(j)+1}$ is given and $\Lambda^{(-1)} = \{0\}$.
- A strategy $\boldsymbol{\pi} = \boldsymbol{\pi}(\boldsymbol{\alpha})$ is defined by $\boldsymbol{\alpha} = (\alpha^{\boldsymbol{n}_{(j)}}(j,i), -1 \leq j < i \leq N 1, \boldsymbol{n}_{(j)} \in \Lambda^{(j)})$. More precisely, the number of zero-coupon bonds with maturity T_i bought or sold at time T_j is

$$\pi(j,i) = \sum_{\boldsymbol{n}_{(j)} \in \Lambda^{(j)}} \alpha^{\boldsymbol{n}_{(j)}}(j,i) \prod_{m=0}^{\ell(j)} \frac{H_{n_m}(G^{(m)})}{\sqrt{n_m!}}, \quad \text{for } i \le N-1,$$
(15)

and $\pi(j, N)$ is deduced from the self-financing equation

$$\sum_{i < j} \pi(i, j) + P(j) = \sum_{i > j} \Psi_{j,i}(\pi(j, i))$$
(16)

(one possibly needs to use a classical iterative procedure to solve this equation numerically).

• One is given an increasing sequence of compact sets $(K_l, l \ge 0)$ satisfying (14).

Stochastic optimization algorithm

Assume that the parameter $\boldsymbol{\alpha}_{\gamma} = (\alpha_{\gamma}^{\boldsymbol{n}_{(j)}}(j,i), -1 \leq j < i \leq N-1, \boldsymbol{n}_{(j)} \in \Lambda^{(j)})$ and l_{γ} are given at step γ . At step $\gamma + 1$:

- 1. Simulate a Gaussian vector $(G_{\gamma+1}^{(0)}, \cdots, G_{\gamma+1}^{(\ell(N))})$.
- 2. Deduce the quantities of zero-coupon bonds from (15) and (16)

$$\pi_{\gamma+1}(j,i) = \sum_{\boldsymbol{n}_{(j)} \in \Lambda^{(j)}} \alpha_{\gamma}^{\boldsymbol{n}_{(j)}}(j,i) \prod_{m=0}^{\ell(j)} \frac{H_{n_m}(G_{\gamma+1}^{(m)})}{\sqrt{n_m!}}, \quad \text{for } i \le N-1,$$

and get $\pi_{\gamma+1}(j, N)$ from the self-financing equation

$$\sum_{i < j} \pi_{\gamma+1}(j, i) + P(j) = \sum_{i > j} \Psi_{j,i}(\pi_{\gamma+1}(j, i)).$$

3. Compute the terminal wealth

$$W_{\gamma+1}^{(\boldsymbol{\alpha}_{\gamma})} = \sum_{j < N} \pi_{\gamma+1}(j, N) + P(N).$$

4. Update the parameters

$$\boldsymbol{\alpha}_{\gamma+1} = \boldsymbol{\alpha}_{\gamma} - \rho_{\gamma+1} \nabla_{\boldsymbol{\alpha}} \left[U(W^{(\boldsymbol{\alpha}_{\gamma})}) \right].$$

- 5. If $\boldsymbol{\alpha}_{\gamma+1} \notin K_{l_{\gamma}}$, set $\boldsymbol{\alpha}_{\gamma+1} = \boldsymbol{\alpha}_0$ and $l(\gamma+1) = l(\gamma) + 1$.
- 6. Go to 1.

3.4 Error analysis

In this subsection we study the convergence (Theorem 4) and convergence rate (Theorem 6) of the stochastic algorithm used in Step 2, when the number of steps k tends to infinity. We introduce some notation. Recall (13) and write

$$\boldsymbol{\alpha}_{\gamma+1} = \boldsymbol{\alpha}_{\gamma} - \rho_{\gamma+1} \mathbb{E} \left[\nabla_{\boldsymbol{\alpha}} U(W^{(\boldsymbol{\alpha}_{\gamma})}) \right] - \rho_{\gamma+1} \delta M_{\gamma+1} + \rho_{\gamma+1} p_{\gamma+1}.$$
(17)

Here, $\delta M_{\gamma+1}$ is given by

$$\delta M_{\gamma+1} = \nabla_{\boldsymbol{\alpha}} U(W^{(\boldsymbol{\alpha}_{\gamma})}) - \mathbb{E}\left[\nabla_{\boldsymbol{\alpha}} U(W^{(\boldsymbol{\alpha}_{\gamma})})\right].$$
(18)

The last term in (17) represents the *reinitialization* of the algorithm if $\alpha_{\gamma+1} \notin K_{l(\gamma)}$.

Let us now recall the convergence theorem obtained by Lelong [7, Th. 1] in our setting.

Theorem 4. Assume

- (A1) The function $\boldsymbol{\alpha} \mapsto \mathbb{E}[U(W^{(\boldsymbol{\alpha})})]$ is strictly concave or convex,
- (A2) $\sum_{\gamma} \rho_{\gamma} = \infty, \sum_{\gamma} \rho_{\gamma}^2 < \infty,$
- (A3) The function $\boldsymbol{\alpha} \mapsto \mathbb{E}[\|\nabla_{\boldsymbol{\alpha}} U(W^{(\boldsymbol{\alpha})})\|^2]$ is bounded on compact sets.

Then the sequence $(\boldsymbol{\alpha}_{\gamma}, \gamma \geq 1)$ converges a.s. to the unique optimal parameter $\boldsymbol{\alpha}^*$ minimizing (12).

We first check that $W^{(\alpha)}$ is a concave function of α and then describe situations where assumptions (A1), (A2) and (A3) are fulfilled.

Proposition 5. The terminal wealth $W^{(\alpha)}$ is a concave function of the parameter α .

Proof. Recall that the terminal wealth is given by (11). The payoff of the swap P(N) does not depend on $\boldsymbol{\alpha}$. We only have to deal with the quantities $\pi(i, N)$ of the zero-coupon bonds with maturity T_N bought at time T_i . They solve the self-financing equation (5) and thus

$$\pi(i,N) = \Psi_{i,N}^{(-1)} \left(\sum_{j < i} \pi(j,i) - \sum_{i < j < N} \Psi_{i,j} \left(\pi(i,j) \right) + P(i) \right),$$
(19)

where $\Psi_{i,N}^{(-1)}$ is the inverse of the price function $\Psi_{i,N}$ (see (4)). Moreover, quantities $\pi(i,j), i < j \leq N-1$ are linear in $\boldsymbol{\alpha}$ (see (9)).

Recall that $\Psi_{i,j}$ is convex, thus $-\Psi_{i,j}$ is concave and the argument in (19) is a concave function of $\boldsymbol{\alpha}$. Finally $\Psi_{i,N}^{(-1)}$ is an increasing concave function, from which $\pi(i, N)$ is a concave function of $\boldsymbol{\alpha}$.

In view of the previous result, if the utility function U is increasing and concave, then $\boldsymbol{\alpha} \mapsto U(W^{(\boldsymbol{\alpha})})$ is almost surely concave and (A1) is obviously satisfied.

Finally, in view of Hypothesis 3 and of (15) (A3) is obviously satisfied.

Theorem 4 proves that the algorithm presented in this paper converges to the optimal parameters. The following theorem gives the rate of convergence of the algorithm (see [8]).

Theorem 6. For this result, we assume the sequence $(\rho_{\gamma}, \gamma \geq 1)$ is chosen with $\beta \in (1/2, 1)$ (see (26)). Denote Δ_{γ} the renormalized and centered error

$$\Delta_{\gamma} = \frac{\boldsymbol{\alpha}_{\gamma} - \boldsymbol{\alpha}^*}{\sqrt{\rho_{\gamma}}}.$$

Assume

(A1) The function $\boldsymbol{\alpha} \mapsto \mathbb{E}[U(W^{(\boldsymbol{\alpha})})]$ is concave or convex,

(A4) For any q > 0, the series

$$\sum_{\gamma} \rho_{\gamma+1} \delta M_{\gamma+1} \mathbb{1}_{\{|\boldsymbol{\alpha}_{\gamma}-\boldsymbol{\alpha}^*| \leq q\}}$$

converges almost surely.

(A5) There exist two real numbers $A_1 > 0$ and $A_2 > 0$ such that

$$\sup_{\gamma} \mathbb{E}\left[|\delta M_{\gamma}|^{2+A_1} \mathbb{1}_{\{|\boldsymbol{\alpha}_{\gamma}-\boldsymbol{\alpha}^*| \leq A_2\}} \right] < \infty$$

(A6) There exists a symmetric positive definite matrix Σ such that

$$\mathbb{E}\left[\delta M_{\gamma}\delta M_{\gamma}^{\mathsf{t}}\big|\mathcal{F}_{\gamma-1}\right]\mathbb{1}_{\{|\boldsymbol{\alpha}_{\gamma-1}-\boldsymbol{\alpha}^{*}|\leq\eta\}}\xrightarrow[\gamma\to\infty]{\mathbb{P}}\Sigma.$$

(A7) There exists $\mu > 0$ such that $\forall n \ge 0$, $d(\boldsymbol{\alpha}^*, K_n) \ge \mu$.

Then, the sequence $(\Delta_{\gamma}, \gamma \geq 1)$ converges in distribution to a normal random variable with mean 0 and covariance

$$V = \int_0^\infty \exp(-At) \Sigma \exp(-A^t t) dt.$$

Remark 7. As explained in details in [8, Sec. 2.4], the assumptions of Theorem 6 are satisfied as soon as

• There exists A > 0 and C > 0 such that satisfies

$$\mathbb{E}\left[\sup_{|\boldsymbol{\alpha}|\leq C}\left|U\left(W^{(\boldsymbol{\alpha})}\right)\right|^{2+A}\right]<\infty.$$

• The function $\boldsymbol{\alpha} \mapsto \mathbb{E}[U(W^{(\boldsymbol{\alpha})})]$ is strictly concave or convex.

3.5 Performance of the optimal truncated strategy without liquidity costs

The numerical error on the optimal wealth decreases when the $\Lambda^{(j)}$'s tend to $\mathbb{N}^{\ell(j)+1}$. In this subsection, we provide a theoretical estimate on the error resulting from the truncation in (9) in the idealistic context of no liquidity costs and general Gaussian affine models (see [4]). In [4], general Gaussian affine models are introduced for which, for any times s < t, there exist standard independent Gaussian random variables $G^{(0)}, \dots, G^{(M)}$ and real numbers $\mu, \lambda_0, \dots, \lambda_M$ such that the prices of zero-coupon bonds have the form

$$B(s,t) = \exp\left(-\mu - \lambda_0 G^{(0)} - \dots - \lambda_M G^{(M)}\right).$$

A control of the error of truncation is given in the following proposition.

Proposition 8. In the above context, if the truncation set defined in (10) is $\Lambda^{(j)} := \{n_0 + \cdots + n_{\ell(j)} \leq d\}$, then

$$\mathbb{E}\left(W^{(\boldsymbol{\alpha}^*)}\right)^2 \leqslant C_0 \frac{C_1^{d+1}}{(d+1)!},\tag{20}$$

where C_0 and C_1 are some positive constants.

The proposition is a straightforward consequence of (11) and the next lemma applied to $X = \pi(\alpha^*)$. This lemma also allows one to precise the values of C_0 and C_1 .

Lemma 9. Consider the random variable

$$X := \exp\left(\mu + \sum_{m=0}^{M} \lambda_m G^{(m)}\right),\,$$

where $\mu, \lambda_0, \dots, \lambda_M$ are real numbers, and $G^{(0)}, \dots, G^{(M)}$ are independent standard Gaussian random variables. Consider the projection X^d of X on the subspace of $L^2(G^{(1)}, \dots, G^{(M)})$ generated by

$$\left(\prod_{m=0}^{M} \frac{H_{n_m}(G^{(m)})}{\sqrt{n_m!}}, \quad n_0 + \dots + n_M \le d\right).$$

We have

$$||X - X^d||_2 \leq \exp\left(\mu + \lambda_0^2 + \dots + \lambda_M^2\right) \frac{\left(\lambda_0^2 + \dots + \lambda_M^2\right)^{\frac{d+1}{2}}}{\sqrt{(d+1)!}}.$$
 (21)

We postpone the proof of this lemma to the Appendix.

4 Numerical validation of the optimization procedure: an example without liquidity costs

In this section we study the accuracy of our algorithm in the no liquidity costs case, in which a perfect replication strategy is known (see Section 2.1). The bond market model is the Vasicek model which is the simplest Gaussian model:

$$dR_{\theta} = A(r_{\infty} - R_{\theta})d\theta + \sigma dB_{\theta}, \qquad (22)$$

where A is the mean reverting rate, r_{∞} is the mean of the equilibrium measure, σ is the volatility and $(B_{\theta}, \theta \ge 0)$ is a one-dimensional Brownian motion.

Notice that

$$\forall u < v, \quad R_v = r_{\infty} + (R_u - r_{\infty})e^{-A(v-u)} + \sigma e^{-A(v-u)} \int_u^v e^{A(\theta-u)} dB_{\theta}.$$
(23)

Therefore, there exists a sequence $(G^{(0)}, G^{(1)}, \cdots, G^{(N)})$ the sequence of *i.i.d.* $\mathcal{N}(0, 1)$ Gaussian random variables such that (with the convention $T_{-1} = t$)

$$\forall k = 0, \cdots, N, \quad R_{T_k} = \Phi(T_k - T_{k-1}, R_{T_{k-1}}, G^{(k)}),$$
 (24)

where

$$\Phi(\eta, r, G) = r_{\infty} + e^{-A\eta}(r - r_{\infty}) + G\sigma \sqrt{\frac{1 - e^{-2A\eta}}{2A}}.$$

In our numerical experiments, we have chosen the following typical values of the parameters A = 10%, $r_{\infty} = 5\%$, $\sigma = 5\%$. With this choice of parameters, the mean yearly interest zero-coupon rates with maturity less than 10 years take values between 3% and 5%.

We limit our numerical validation to the minimization of the mean quadratic hedging error, which corresponds to the choice $U(x) = x^2$ in (12). However, many other risk measures could have been chosen: the only limitation is that the right-hand side of (12) is a convex function of the parameter α .

Our truncation $\Lambda^{(j)}$ is chosen as

$$\Lambda_d^{(j)} := \{ \boldsymbol{n}_{(j)} = (n_0, \cdots, n_j) \in \mathbb{N}^{j+1}, n_0 + n_1 + \dots + n_j \le d \},$$
(25)

for a degree d of truncation. We have to optimize the real valued parameters $\alpha^{\mathbf{n}_{(j)}}(j,i)$ for j < i and $\mathbf{n}_{(j)} \in \Lambda_d^{(j)}$ and the quantities of zero-coupon bonds to exchange are given by (10).

The choice of the sequence $(\rho_{\gamma}, \gamma \ge 1)$ in (13) is crucial. In this paper, we have chosen

$$\rho_{\gamma} = \frac{v_1}{(v_2 + \gamma)^{\beta}},\tag{26}$$

for some positive v_1, v_2 and $\beta \in (1/2, 1]$. The effect of these parameters is examined in section 4.2.2. We also discuss the sensitivity of the results to the number Γ of steps.

In all the sequel, we use the following notation.

Notation For all vector $\boldsymbol{\alpha} = (\alpha^{\boldsymbol{n}_{(j)}}(j, i), -1 \leq j < i \leq N-1)$, we set

$$v(\boldsymbol{\alpha}) := \mathbb{E}\left[W^{(\boldsymbol{\alpha})}\right]^2,\tag{27}$$

where the expectation is computed with respect to the Gaussian distribution $(G^{(0)}, \dots, G^{(\ell(N))})$.

4.1 Empirical study of the truncation errors (Step 1)

In this subsection we develop an empirical validation of the projection step presented in Section 3.1

We observe that the hedging error decreases very fast to 0 when the degree of the truncation increases. For a notional of 1, the error is of the order of one basis point (a hundredth of percent) for a degree d = 3 and a small number of dates N and for d = 4 and for larger values of N.

Figure 1 below shows $v(\boldsymbol{\alpha}^{*,d})$, with the optimal parameter $\boldsymbol{\alpha}^{*,d}$ for truncation set given by (25). We have used the explicitly known finite dimensional projections of the optimal strategies without liquidity cost to obtain $\boldsymbol{\alpha}^{*,d}$, and a Monte Carlo procedure to compute v. Table 1 shows some values used to plot Figure 1.

4.2 Empirical study of the optimization step (Step 2)

We know theoretically that the stochastic algorithm converges almost surely to the optimal coefficient α^* . In this part, we empirically study the convergence rate in terms of the number of steps Γ and the choice of the sequence (ρ_{γ}) .



4.2.1 A typical evolution of (α_{γ})




Figure 2: Evolution of the parameters $\alpha_{\gamma}^{0}(-1,0)$, $\alpha_{\gamma}^{0}(-1,1)$, $\alpha_{\gamma}^{0}(0,1)$, $\alpha_{\gamma}^{1}(0,1)$ in terms of γ .

In this subsection, we consider a swap with two payment dates (N = 2). We consider the truncation set $\Lambda^{(0)} = \{0, 1\}$. The objective is to approximate $\boldsymbol{\alpha}^* = (\alpha^{0,*}(-1,0), \alpha^{0,*}(-1,1), \alpha^{0,*}(0,1), \alpha^{1,*}(0,1))$. In Figure 2, the four parameters $\boldsymbol{\alpha} = (\alpha^{0}(-1,0), \alpha^{0}(-1,1), \alpha^{0}(0,1), \alpha^{1}(0,1))$ evolve according to (13) where the sequence $(\rho_{\gamma}, \gamma \geq 1)$ is defined by (26) with $v_1 = 10^7$, $v_2 = 1$ and $\beta = 1$.

As expected, the sequence (α_{γ}) converges to α^* . However, the evolution is quite *slow* although we have empirically chosen the parameters v_1 , v_2 and β in a favourable way.




Figure 3: Red surface: $-v(\bullet, \bullet, \alpha^{0,*}(0, 1), \alpha^{1,*}(0, 1))$. Green curve: evolution of $(\alpha^0 \gamma(-1, 0), \alpha^0_{\gamma}(-1, 1), -v(\alpha^0_{\gamma}(-1, 0), \alpha^0_{\gamma}(-1, 1), \alpha^{0,*}(0, 1), \alpha^{1,*}(0, 1))$ in terms of $\gamma = 1, \cdots, 10000$ ($v_1 = 10, v_2 = 1$ and $\beta = 0.6$).

In Figure 3, we plot (in red) $v(\alpha^0(-1,0), \alpha^0(-1,1), \alpha^{0,*}(0,1), \alpha^{1,*}(0,1))$ as a function of $\alpha^0(-1,0)$ and $\alpha^0(-1,1)$. We also plot in green the path $(v(\boldsymbol{\alpha}_{\gamma}), 0 \leq \gamma \leq \Gamma)$. The figure shows that after $\Gamma = 10000$ steps the hedging error is small though the optimal parameters have not been approximated accurately (notice that the red surface is flat).

4.2.2 Sensitivity to the choice of the sequence (ρ_{γ})

Theorem 4 states the convergence of the optimization method for all sequence (ρ_{γ}) satisfying (A2). We here study the sensitivity of the results to the parameters v_1 , v_2 , β of sequences of type (26) and to the total number of steps Γ .

Tables 2 and 3 show the expected value function obtained after $\Gamma = 10E4$, 10E5 and 10E6 steps. The expected value function is estimated by means of a classical Monte Carlo procedure.

Table 4 shows the same results with a sequence $\rho_{\gamma} = v_1$ which does not satisfy condition (A2).

We observe that the efficiency of the algorithm depends on the choice of the parameters v_1 , v_2 , β and is really sensitive to it when the total number of steps Γ is small.

When Γ becomes large (e.g $\Gamma = 10E6$), then the algorithm may seem to diverge if β is chosen careless. In fact, the sequence $(\rho_{\gamma}, \gamma \geq 1)$ satisfies hypotheses (A2) of Theorem 4, thus the algorithm converges to the optimal parameters but it is far from α^* after 10E6 steps. However, for each value β , there exists a choice for v_1 which reduces the mean square hedging error v to 5 E-12.

5 An empirical study of the bid-ask spread costs impact

We here present numerical results corresponding to two piecewise linear cost functions Ψ :

$$\Psi_{\lambda}^{1}(T, U, \pi) = (1 + \lambda \operatorname{sign}(\pi))B(T, U)\pi$$
(28)

$$\Psi_{\lambda,C}^{2}(T,U,\pi) = \begin{cases} B(T,U)\pi \text{ for } |\pi| \ge C\\ B(T,U)(C+(1+\lambda)(\pi-C) \text{ for } \pi > C\\ B(T,U)(-C+(1-\lambda)(\pi+C) \text{ for } \pi < -C. \end{cases}$$
(29)

Despite the fact that we know there is no perfect hedging strategy in this context, we suppose the holder receives a null cash at time t (which is the price of the swap in a no liquidity cost market).

Notice that Theorem 4 does not apply to this context since Ψ_{λ}^{1} and Ψ_{λ}^{2} are piecewise linear and therefore are not continuously differentiable everywhere. Replace Ψ_{λ}^{1} and Ψ_{λ}^{2} by smooth approximations obtained by convolutions of the type $1/\sqrt{2\pi\varepsilon}\exp(-x^{2}/(2\varepsilon))$, ε small. Let $\boldsymbol{\alpha}_{\varepsilon}^{*}$ be the unique optimal parameter corresponding to the new cost functions (existence and uniqueness of $\boldsymbol{\alpha}_{\varepsilon}^{*}$ are provided by Theorem 4). In view of Rockafellar and Wets in [11, Th 7.33] ($\boldsymbol{\alpha}_{\varepsilon}^{*}$) tends to $\boldsymbol{\alpha}^{*}$ when ε tends to 0.

The preceding consideration is more theoretical than practical: in practice, the numerical results do not differ in the case small ε and $\epsilon = 0$.

5.0 Optimizing is really necessary

Consider two different strategies: (i) the strategy obtained with optimal parameters in the idealistic model without liquidity costs α_0 and (ii) the null strategy δ_0 defined as

$$\boldsymbol{\delta}_0^{\boldsymbol{n}_{(j)}}(j,i) = 0, \quad \text{ for all } -1 \le j < 1 \le N-1 \text{ and } \boldsymbol{n}_{(j)} \in \Lambda^{(j)}.$$

To satisfy the self-financing assumption (5), at time T_j the payoff P(j) of the swap (2) is used to buy zero-coupon bonds with maturity T_N .




Figure 4: (green) $-v(\boldsymbol{\delta}_0)$ (red) $-v(\boldsymbol{\alpha}_0)$ in terms of the liquidity cost λ

Figure 4 shows $-v(\boldsymbol{\alpha}_0)$ and $-v(\boldsymbol{\delta}_0)$ in terms of the parameter λ where the cost function Ψ is as (28). The mean square hedging error dramatically increases when the trader uses the optimal strategy in the no liquidity cost context, for λ larger than 4%.

5.1 Probability distribution of the hedging error in the case (28)

In this section, the liquidity cost Ψ is chosen as in (28).

After Γ steps of the stochastic optimization procedure with a sample ω of the Gaussian vector $((G_{\gamma}^{(0)}, \cdots, G_{\gamma}^{(N)}), \gamma = 1, \cdots, \Gamma)$, one obtains a random approximation $\boldsymbol{\alpha}_{\Gamma}(\omega)$ of the optimal parameter $\boldsymbol{\alpha}^*$.




Figure 5: Empirical density of $-v(\boldsymbol{\alpha}_{\Gamma}(\omega))$ $(v_1 = v_2 = \beta = 1, \Gamma = 10000, \lambda = 0.04)$. The red vertical line corresponds to the $v(\boldsymbol{\alpha}^*)$.

Figure 5 shows the probability distribution of the random variable $v(\boldsymbol{\alpha}_{\Gamma}(\omega))$ for $\Gamma = 10000$ and Table 5 shows its mean and standard deviation for different values of λ .

5.2 Hedging error in the case (29)

In this section, the liquidity cost Ψ is chosen as in (29).




Figure 6: Red surface: $-v(\boldsymbol{\alpha}_{\Gamma})$ ($\Gamma = 10E6$, $v_1 = v_2 = 100$, $\beta = 0.6$) for a liquidity cost (29) in terms of the value λ of the cost and the size C of the compact. Green surface: $-v(\boldsymbol{\alpha}_0)$.

Figure 6 shows $-v(\boldsymbol{\alpha}_{\Gamma})$ for $\Gamma = 0$ (green) and $\Gamma = 10E6$ (red). The initial parameter $\boldsymbol{\alpha}_0$ is the optimal one for a market without liquidity cost.




Figure 7: A zoom on the red surface of Figure 6

We observe that the main part of the loss is saved thanks to the optimization procedure. In Figure 7, we zoom on the surface resulting from the optimization procedure.

5.3 Influence of the initial values of the optimization procedure




Figure 8: (green) $-v(\boldsymbol{\delta}_{\Gamma})$ (red) $-v(\boldsymbol{\alpha}_{\Gamma})$, in terms of the liquidity cost λ ($\Gamma = 10E6$, $v_1 = 0.1, v_2 = 100, \beta = 0.6, d = 3$).

We now show that, as expected, the optimized strategies are more efficient than the strategies which do not take liquidity cost into account. In figure 8, we draw two functions of the liquidity cost λ : $-v(\boldsymbol{\alpha}_{\Gamma})$ and $-v(\boldsymbol{\delta}_{\Gamma})$, where $(\boldsymbol{\alpha}_{\Gamma})$ and $(\boldsymbol{\delta}_{\Gamma})$ are the parameters obtained after Γ steps of the optimization procedure but with different initial values $\boldsymbol{\alpha}_0$ and $\boldsymbol{\delta}_0$ as described in Subsec. 5.0. The performance of the strategies obtained after $\Gamma = 10E6$ steps are quite similar. It means that the sensitivity to the arbitrary initial parameter $\boldsymbol{\alpha}_0$ is no more observable after $\Gamma = 10E6$ steps.

5.4 Reducing the set of admissible strategies

Recall Hypothesis 2. So far, our admissible strategies at time T_j depend on all the pas and present rates R_t, \dots, R_{T_j} . Thus the number of parameters $\alpha^{n_{(j)}}(j, i)$ to optimize is at least of the order of magnitude of the binomial coefficient $\binom{N}{d}$, where N is the number of dates and the degree of truncation is defined as in (25). This order of magnitude is a drastically increasing function of N. This crucial drawback leads us to try to simplify the complexity of the control problem (6) by reducing the size of the set of the admissible strategies Π . Observe that the optimal strategy under the perfect liquidity assumption has the property that $\pi^*(j, i)$ only depends on R_{T_j} . This observation suggests to face large numbers of dates by reducing the set of controls to controls depending only on a small number of recent interest rates $R_{T_j}, R_{T_{j-1}}, \dots, R_{T_{j-q}}$.




Figure 9: $-v(\boldsymbol{\alpha}_{\Gamma})$ in terms of λ for strategies depending only on recent rates $R_{T_j}, \cdots, R_{T_{j-q}}$ $(q = 0, 1, 2, N = 5, \Gamma = 10E6, v_1 = 0.1, v_2 = 100, \beta = 0.6, d = 3).$

Figures 9 and 10 illustrate that the optimal control problem (6) with admissible strategies defined as in hypothesis 2 may be used as benchmarks to possibly simpler to solve control problems. Indeed, we here consider swaps with N = 5 and N = 10 dates of payment. In each one of these two cases, we study the effect of choosing

q = 0 (that is at time T_j , admissible strategies only depend on R_{T_j}), q = 1 (admissible strategies depend on R_{T_j} and $R_{T_{j-1}}$), q = 2.

Figure 9 shows the performance of the strategies obtained after $\Gamma = 10E6$ steps of the optimization algorithm for a SWAP with N = 5 dates of payments for q = 0, 1 and 2.

Figure 10, shows similar quantities for a SWAP with N = 10 dates of payment. We observe that the numerical computation of the optimal strategy is quite unstable when q is too big, which reflects the difficulty to solve a high dimensional optimization problem. Therefore, one necessarily must choose q small in order to get accurate approximations of optimal strategies belonging to reduced sets of admissible strategies.




Figure 10: $-v(\boldsymbol{\alpha}_{\Gamma})$ in terms of λ for strategies depending only on recent rates $R_{T_j}, \cdots, R_{T_{j-q}}$ $(q = 0, 1, 2, N = 10, \Gamma = 10E6, v_1 = 0.1, v_2 = 100, \beta = 0.6, d = 3).$

6 Conclusion

Stochastic control problems have no explicit solutions and are difficult to solve numerically. In this paper, we have proposed an efficient algorithm to approximate optimal allocation strategies to hedge interest rates derivatives.

As discussed above, our methodology is constructive and efficient in a Gaussian paradigm. We optimize the projection of the allocation strategy to the space generated by the first Hermite polynomial and use a classical stochastic algorithm to optimize the coefficients of the projection.

We have illustrated this general approach by studying swaps in the presence of liquidity costs. We have discussed the performances of the numerical method in terms of all its algorithmic components.

We emphasize that our methodology can be applied to many control problems in Gaussian settings, e.g., the computation of indifference prices.

7 Appendix

Proof of Lemma 9

Proof. Let us first prove the result for M = 0, that is $X = \exp(\mu + \lambda G)$.

$$X = \sum_{n=0}^{+\infty} \alpha(n) \frac{H_n(G)}{\sqrt{n!}}$$

where

$$\alpha(n) = \mathbb{E}\left[X\frac{H_n(G)}{\sqrt{n!}}\right] = \exp(\mu)\mathbb{E}\left[\exp(\lambda G)\frac{H_n(G)}{\sqrt{n!}}\right].$$

We then use the identity: $e^{\lambda x - \lambda^2/2} = \sum_{j \ge 0} \frac{\lambda^j}{j!} H_j(x)$ and obtain

$$\alpha(n) = \exp(\mu + \lambda^2/2) \mathbb{E}\left[\sum_j \frac{\lambda^j}{j!} H_j(G) \frac{H_n(G)}{\sqrt{n!}}\right]$$

As $(H_j(G)/\sqrt{j!}, j \ge 0)$ is an orthonormal basis of $L^2(G)$ we have

$$\alpha(n) = \exp(\mu + \lambda^2/2) \frac{\lambda^n}{\sqrt{n!}}.$$

Let X^d be the projection of X on the subspace generated by the H_0, \cdots, H_d :

$$X^{d} = \sum_{n=0}^{d} \alpha(n) \frac{H_{n}(G)}{\sqrt{n!}} = e^{\mu + \lambda^{2}/2} \sum_{n=0}^{d} \frac{\lambda^{n}}{\sqrt{n!}} \frac{H_{n}(G)}{\sqrt{n!}}$$
$$X - X^{d} = e^{\mu + \lambda^{2}/2} \sum_{n=d+1}^{\infty} \frac{\lambda^{n}}{\sqrt{n!}} \frac{H_{n}(G)}{\sqrt{n!}}.$$

The truncation error is

$$||X - X^{d}||_{2}^{2} = e^{2\mu + \lambda^{2}} \sum_{n=d+1}^{\infty} \frac{\lambda^{2n}}{n!}$$
$$\leq e^{2\mu + \lambda^{2}} \frac{\lambda^{2(d+1)}}{(d+1)!} \sum_{n=0}^{\infty} \frac{\lambda^{2n}}{n!}$$
$$\leq e^{2\mu + 2\lambda^{2}} \frac{\lambda^{2(d+1)}}{(d+1)!}.$$

The desired result is thus obtained for M = 0. For an arbitrary M, we have

$$||X - X^{d}||_{2}^{2} = e^{2\mu + \lambda_{0}^{2} + \dots + \lambda_{M}^{2}} \sum_{n_{0} + \dots + n_{M} > d} \prod_{m=0}^{M} \frac{\lambda_{m}^{2n_{m}}}{(n_{m})!}$$

Recall the classical identity

$$\frac{(a_0 + \dots + a_L)^N}{N!} = \sum_{n_0 + \dots + n_L = N} \prod_{m=0}^L \frac{a_m^{n_m}}{(n_m)!}.$$
(30)

Thus,

$$\sum_{n_0+\dots+n_M>d} \prod_{m=0}^M \frac{\lambda_m^{2n_m}}{(n_m)!} = \sum_{N=d+1}^\infty \sum_{n_0+\dots+n_M=N} \prod_{m=0}^M \frac{\lambda_m^{2n_m}}{(n_m)!}$$
$$= \sum_{N=d+1}^\infty \frac{(\lambda_0^2+\dots+\lambda_M^2)^N}{N!}$$
$$\leq \frac{(\lambda_0^2+\dots+\lambda_M^2)^{d+1}}{(d+1)!} \exp\left(\lambda_0^2+\dots+\lambda_M^2\right).$$

This ends the proof for an arbitrary M.
