# A Pragmatic Type System for Deductive Verification

#### Abstract

In the context of deductive verification, it is customary today to handle programs with pointers using either separation logic, dynamic frames, or explicit memory models. Yet we can observe that in numerous programs, a large amount of code fits within the scope of Hoare logic, provided we can statically control aliasing. When this is the case, the code correctness can be reduced to simpler verification conditions which do not require any explicit memory model. This makes verification conditions more amenable both to automated theorem proving and to manual inspection and debugging. In this paper, we devise a method of such static aliasing control for a programming language featuring nested data structures with mutable components. Our solution is based on a type system with singleton regions and effects, which we prove to be sound.


## 1 Introduction

In this paper, we explore how far we can go with the simplicity behind Hoare logic [1]. This simplicity, which is not just the simplicity of the rules, but foremost, of the proof obligations that stem whereof, is embodied in the rule for assignment:

$$
\{P[x \leftarrow E]\} x:=E\{P\}
$$

Here, we presume that the memory location referred to by $x$ has no other name in $P$. Once we abandon this hypothesis, that is, when we allow aliases, this simplicity is lost. Over the years, numerous approaches to deductive verification in presence of aliases have been proposed, including explicit memory models [2], separation logic [3], or dynamic frames (4).

However, we can observe that a vast majority of code we may consider verifying still fits in Hoare logic. The secret is abstraction. A structure implementing a mutable set may use arbitrary pointers (e.g. AVL tree or hash table). Yet client code using a mutable set need not be aware of this complexity: it manipulates the set using abstract functions as if it were a single mutable variable, in the sense of Hoare logic. Consequently, we can expect at least some parts of the program to be verified using simple techniques à la Hoare logic. How large can this part

[^0]be? It is not realistic to require it to be completely alias-free. However, we can still adapt and adopt the assignment rule above, provided we know statically all aliases for variable $x$. In contrast with the above-mentioned approaches, which embed the frame conditions into proof obligations, we want to perform a static control of aliases prior to generation of verification conditions. In this way, we regain the simplicity of Hoare logic.

In this paper, we develop such a static control of aliases for a programming language featuring nested data structures with mutable components. Our solution is based on a type system with singleton regions and effects. In practice, these regions can be inferred automatically, thus hiding the added complexity of the typing rules from the programmer. This is how this type system is implemented in the verification tool Why3 [5], where user-written type expressions do not contain regions at all.

This paper is organized as follows. Section 2 explains our approach informally. Section 3 introduces a small language with nested regions and gives a formal description of its semantics and typing system. Section 4 states the main theorem for correctness of our typing system and gives its proof. We conclude with related work in Section 5 and perspectives in Section 6.

## 2 Our Approach

Our approach to static control of aliases consists in using a type system with singleton regions. The identity of a mutable value is in its type, rather than its name. For instance, consider a hash table implementation as a structure with at least a field data (an array) containing the hash table entries. Given a hash table $h$, assigning the array $h . d a t a$ to a new variable $a$

gives to $a$ the same type as h.data, accounting for the fact they both refer to the same array. Let us see what happens if we change the alias structure by assigning to h.data a different array:

One possible solution consists in changing the type of h.data, and thus $h$, in the rest of the computation. This is known as strong update. However, this approach requires dependent types once we start handling assignments under conditions. In the following example

array $a$ is dissociated from h.data if and only if the condition is true, which we cannot know statically. Moreover, the conditional itself may be hidden inside a function call.

Instead of making strong updates, we opt for a different solution. We detect potential aliasing conflicts between two names-either two names of the
same type that become unaliased, or two names of different types that become aliased-and we prohibit the further use of one of these names in the rest of the computation. For instance, the following code snippet

contains two aliasing conflicts. First, $a$ and h.data have the same type (hence the same region) but are no longer aliased. Second, $b$ and h.data inhabit distinct regions (according to their types) but are now aliased. To ensure consistency, our type system makes it illegal to mention both $a$ and $b$ after the assignment. However, we can still refer to h.data, which now does not have to change its type, since there is no other name to claim it.

Note that we could have invalidated $h . d a t a$, and thus $h$, instead, and preserved $a$ and $b$. However, since the aliasing conflict came as the result of a modification of $h$, we presume that the programmer's intention is to keep $h$.

Technically, the invalidation is expressed as a reset effect of the assignment $h . d a t a \leftarrow b$. Assuming $\rho_{1}$ is the region of both $a$ and h.data, $\rho_{2}$ is the region of $b$, and $\rho$ is the region of $h$, the type system associates to the assignment the effect (writes $\{\rho\}$ • reset $\left\{\rho_{1}, \rho_{2}\right\}$ ). This effect makes it illegal to use in the subsequent code any existing variable from which $\rho_{1}$ or $\rho_{2}$ are reachable without passing through $\rho$. In this way, $a$ and $b$ are invalidated whereas $h$ is not.

Interestingly enough, the freshness of a region $\rho$ can be expressed in our type system with the effect (writes $\varnothing$ - reset $\{\rho\}$ ). Indeed, this prohibits all existing names which refer to $\rho$. Consequently, it makes no difference whether it was mentioned earlier or not.

## 3 A Small Language with Regions

In this section, we give a formal presentation of our approach. We introduce a small programming language featuring nested data structures with mutable components. This language is purposely small and limited to expressions. Nevertheless, it exhibits all the relevant features to illustrate our method. First, we give the syntax and the formal semantics. Then we define the typing system with regions and effects that formalizes the ideas presented in the previous section.

### 3.1 Syntax

The syntax of the language is given in Fig. 1. Expressions are either atomic or compound terms like conditional,local binding, dynamic allocation, and parallel assignment. The latter allows us to simultaneously assign several fields of several records. Note that compound terms obey a variant of $A$-normal form [6]. That is, in compound expressions, except local binding and conditional branches, all sub-terms must be atomic. This does not reduce expressiveness, since expressions such as $p\left(p_{1}(42)\right)$ can be rewritten as let $x=p_{1}(42)$ in $p(x)$. Yet, to make

the presentation more readable, we often relax the A-normal form in examples. For instance, the following expression allocates two fresh records, respectively bound to variables $x$ and $y$, and then swaps the contents of fields $x$.f and $y . g$.

$$
\text { let } x=\{f=1\} \text { in let } y=\{g=2\} \text { in } x .\{f \leftarrow y \cdot g\}, y \cdot\{g \leftarrow x . f\}

For a given expression $e$, we denote the sets of free variables, function names, and locations in $e$ with $\mathcal{F}_{v}(e), \mathcal{F}_{p}(e)$ and $\mathcal{F}_{\ell}(e)$, respectively. Notice that locations, unlike variables, cannot be bound in expressions. We call e closed when $\mathcal{F}_{v}(e)$ is empty.

Finally, we presume to dispose of a fixed set $P$ of global, mutually recursive functions. Each function $p$ in $P$ is given a definition, denoted $p\left(x_{1}, \ldots, x_{n}\right) \mapsto e$, where we require $\mathcal{F}_{v}(e) \subseteq\left\{x_{1}, \ldots, x_{n}\right\}, \mathcal{F}_{\ell}(e)=\varnothing$, and $\mathcal{F}_{p}(e) \subseteq P$.

### 3.2 Semantics

We equip our language with a small-step operational semantics, given in Fig. 2 . It defines a non-deterministic relation $\mu \cdot e \longrightarrow \mu^{\prime} \cdot e^{\prime}$ where $\mu, \mu^{\prime}$ are memory stores and $e, e^{\prime}$ are closed expressions. A memory store $\mu$ is a partial map that, given a location $\ell$ and a field $f$, returns a value, written $\mu(\ell . f)$.

Rules for allocation and assignment impose that fields are pairwise distinct within each record. This removes any ambiguity in the resulting store. The semantics allows us to share field names among records, so that it is fine to allocate $\{f=1 ; g=2\}$ and $\{f=1 ; h=3\}$. Rules for conditional and local binding are standard. Note that evaluation does not necessarily terminate on a value, since there are irreducible expressions such as $\{f=1\}$.g. Our type system will later rule out such expressions.

We call a sequence (possibly empty) of field names a path. Paths are denoted with letter $\pi$. An empty path is denoted $\epsilon$. We write $\pi_{1} \preceq \pi_{2}$ to denote that $\pi_{1}$

is a prefix (not necessarily proper) of $\pi_{2}$. We generalize the store access function to paths as follows:

$$
\mu(\ell . \pi) \triangleq \begin{cases}\ell & \text { if } \pi=\epsilon \text { and } \ell \in \operatorname{dom} \mu \\ \mu\left(\ell^{\prime} . \pi^{\prime}\right) & \text { if } \pi=f \pi^{\prime} \text { and } \mu(\ell . f)=\ell^{\prime}\end{cases}
$$

A location $\ell^{\prime}$ is said to be accessible from $\ell$ in $\mu$ when there exists a path $\pi$ such that $\mu(\ell . \pi)=\ell^{\prime}$. Given a set of locations $L$, we denote the set of locations accessible from locations in $L$ with $\mathcal{A}_{\ell}(\mu \cdot L)$. By abuse of notation, we write $\mathcal{A}_{\ell}(\mu \cdot e)$ for $\mathcal{A}_{\ell}\left(\mu \cdot \mathcal{F}_{\ell}(e)\right)$.

### 3.3 Type System

The purpose of the type system is to ensure that "well-typed programs cannot go wrong" (Milner, 1978). Beyond the standard soundness property, type systems usually ensure that some additional properties are preserved by evaluation of well-typed terms. In our case, such a property is the static control of aliases. For that purpose, we introduce a type system with effects, where the typing judgment is

$$
\Gamma \cdot \Sigma \vdash e: \tau \cdot \varepsilon
$$

Here, expression $e$ is assigned a type $\tau$ and an effect $\varepsilon$ with respect to a variable typing environment $\Gamma$ (a total mapping from variables to types) and a store typing environment $\Sigma$ (a total mapping from locations to regions). For convenience,
we extend store typing to scalar constants: For any $c, \Sigma(c)$ stands for the type of $c$. This provides us with a uniform notation for the type of store contents.

Types are defined in Fig. 3. Constant values are assigned scalar types: integer, Boolean, and unit type. Store locations are assigned structured data types which we call regions. A region consists of a set of fields $f_{1}, \ldots, f_{n}$, each field $f_{i}$ being assigned a type $\tau_{i}$. Every region carries a unique identifier $r$. This identifier does not have any special meaning and only serves to distinguish types of distinct store locations. In other words, regions are singleton types. The intention behind this is to provide a one-to-one correspondence between regions and memory locations used inside a program. Given a record type $\rho=\{\ldots, f: \tau, \ldots\}_{r}$, we write $\rho . f$

to denote $\tau$. If $\rho$ does not contain field $f, \rho . f$ is undefined. Similarly, $\nu . f$ is undefined for any scalar type $\nu$. We extend this notation to paths: $\tau . \epsilon \triangleq \tau$ and $\tau . f \pi \triangleq(\tau . f) . \pi$. We write $\mathcal{R}(\tau)$ to denote the set of all regions occurring in $\tau$.

We say that two types $\tau_{1}$ and $\tau_{2}$ are structurally equal when they are equal up to region identifiers, and we write then $\tau_{1} \simeq \tau_{2}$. Equivalently, two types $\tau_{1}$ and $\tau_{2}$ are structurally equal when for any path $\pi, \tau_{1} . \pi$ is defined if and only if $\tau_{2} . \pi$ is defined, and if $\tau_{1} . \pi$ or $\tau_{2} . \pi$ is a scalar type then $\tau_{1} . \pi=\tau_{2} . \pi$.

A region substitution $\theta$ is a finite bijection between structurally equal types such that for every region $\rho \in \operatorname{dom} \theta$ and every path $\pi$, either $\theta(\rho . \pi)=\theta(\rho) . \pi$ or both $\rho . \pi$ and $\theta(\rho) . \pi$ are undefined.

Along with its type, every expression carries an effect $\varepsilon$, defined as a pair $(\omega \cdot \varphi)$, where $\omega$ is the set of regions possibly modified in $e$ (write effect) and $\varphi$ is the set of regions whose use is restricted in the subsequent computation (reset effect). We require $\omega$ and $\varphi$ to be disjoint. When the expression $e$ is pure, both sets are empty, and we write $\varepsilon=\perp$.

Every defined function $p$ is given a type signature $\tau_{1} \times \ldots \times \tau_{n} \rightarrow \tau \cdot(\omega \cdot \varphi)$, where $\tau_{1}, \ldots, \tau_{n}$ are the types of formal parameters, $\tau$ is the type of the result, and $(\omega \cdot \varphi)$ is the latent effect of the function. We require that $\omega \subseteq \mathcal{R}\left(\tau_{1}, \ldots, \tau_{n}\right)$, $\varphi \subseteq \mathcal{R}\left(\tau_{1}, \ldots, \tau_{n}, \tau\right)$, and $\mathcal{R}(\tau) \backslash \mathcal{R}\left(\tau_{1}, \ldots, \tau_{n}\right) \subseteq \varphi$. The former two conditions limit the latent effect to the exposed regions, and the last one requires every fresh region in the result to be reset.

We also require the signature to be consistent with the function definition $p\left(x_{1}, \ldots, x_{n}\right) \mapsto e$, namely that $\Gamma\left[x_{i} \hookleftarrow \tau_{i}{ }^{i \in\{1, \ldots, n\}}\right] \cdot \Sigma \vdash e: \tau \cdot\left(\omega \cdot \varphi \cup \varphi^{\prime \prime}\right)$, where $\varphi^{\prime \prime}$ is the additional reset effect that accounts for the regions introduced in $e$ and not exposed in the signature, i.e., $\varphi^{\prime \prime} \cap \mathcal{R}\left(\tau_{1}, \ldots, \tau_{n}, \tau\right)=\varnothing$. The invariant on effects (disjointness of write and reset effects) and the properties

of the effect union ensure that any writes into these regions disappear from the effect of $e$. Since locations cannot occur in function definitions and any region in a function body either comes from a parameter or is allocated locally (possibly via a function call) and thus is reset, this justifies the condition $\omega \subseteq \mathcal{R}\left(\tau_{1}, \ldots, \tau_{n}\right)$.

The typing rules are given in Fig. 4. The rule for let $x=e_{1}$ in $e_{2}$ ensures that regions in $e_{2}$ are valid with respect to the effects of $e_{1}$, according to the following definition:

Definition 1. A type $\tau$ is valid with respect to effect $(\omega \cdot \varphi)$, written $(\omega \cdot \varphi) \triangleright \tau$, if and only if every path from $\tau$ to a region in $\varphi$ passes through a region in $\omega$. Formally, $(\omega \cdot \varphi) \triangleright \nu$ is defined inductively by the following rules:

Notice that $\omega$ and $\varphi$ are disjoint, since $(\omega \cdot \varphi)$ is an effect. Consequently, reset regions cannot be valid:

Lemma 1. For any effect $(\omega \cdot \varphi)$ and any region $\rho,(\omega \cdot \varphi) \triangleright \rho \Longrightarrow \rho \notin \varphi$.
In the typing rules for let-bindings and conditionals, the overall effect is the union of the effects of sub-expressions, according to the following definition:

Definition 2. The union of two effects $\varepsilon_{1}=\left(\omega_{1} \cdot \varphi_{1}\right)$ and $\varepsilon_{2}=\left(\omega_{2} \cdot \varphi_{2}\right)$, denoted $\varepsilon_{1} \sqcup \varepsilon_{2}$, is the pair $\left(\left\{\rho \in \omega_{1} \mid \varepsilon_{2} \triangleright \rho\right\} \cup\left\{\rho \in \omega_{2} \mid \varepsilon_{1} \triangleright \rho\right\} \cdot \varphi_{1} \cup \varphi_{2}\right)$

The resulting effect is well-formed, that is, the two sets of regions are disjoint by Lemma 1. Notice that the write effect in $\varepsilon_{1} \sqcup \varepsilon_{2}$ is only a subset of $\omega_{1} \cup \omega_{2}$. Indeed, we must take into account that there may be a path from some region $\rho$ in $\omega_{1}$ to $\varphi_{2}$ that does not pass through $\omega_{2}$. The existence of such path invalidates $\rho$. Therefore, in the definition above the joint write effect is the co-restriction of $\omega_{1}$ by $\varepsilon_{2}$ and $\omega_{2}$ by $\varepsilon_{1}$.

To provide some intuition behind this, let us consider a conditional expression if $a$ then $e_{1}$ else $e_{2}$. Since we do not know which of the two branches will be realized, the resulting reset effect must be the union of the reset effects of $e_{1}$ and $e_{2}$. However, we cannot do the same for the write effects. Consider the expression

$$
\text { if ... then } h_{1} .\left\{\text { data } \leftarrow h_{2} \text {.data\} else } h_{2} \text {.\{data } \leftarrow h_{1}\right. \text {.data\} }
$$

where $h_{1}$. data and $h_{2}$. data are distinct. Let the type of $h_{1}$ be $\rho_{1}=\left\{\text { data : } \rho_{1}^{\prime}\right\}_{r_{1}}$ and the type of $h_{2}$ be $\rho_{2}=\left\{\text { data : } \rho_{2}^{\prime}\right\}_{r_{2}}$. The effect of the first branch is $\left(\left\{\rho_{1}\right\}\right.$. $\left.\left\{\rho_{1}^{\prime}, \rho_{2}^{\prime}\right\}\right)$, which invalidates $\rho_{2}$. The effect of the second branch is $\left(\left\{\rho_{2}\right\} \cdot\left\{\rho_{1}^{\prime}, \rho_{2}^{\prime}\right\}\right)$, which invalidates $\rho_{1}$. Without knowing which branch is going to be executed, we have to invalidate both $\rho_{1}$ and $\rho_{2}$ after the conditional. We achieve this by removing them from the joint write effect, so that they can no more provide valid access to the reset regions. It may seem that we just lost information about the actual effect of the expression, but for our purposes it does not matter as we prohibit any further mention of $h_{1}, h_{2}, h_{1}$.data, $h_{2}$.data anyway.

The lemma below shows that type validity distributes over the effect union.
Lemma 2. For any $\varepsilon_{1}, \varepsilon_{2}$, and $\tau, \varepsilon_{1} \sqcup \varepsilon_{2} \triangleright \tau$ if and only if $\varepsilon_{1} \triangleright \rho$ and $\varepsilon_{2} \triangleright \tau$.
Effects possess some nice algebraic properties.
Lemma 3. Effects form a bounded join-semilattice over $\sqcup$ and $\perp$.
Consequently, we have an order relation on effects as follows:
Definition 3. We say that an effect $\varepsilon_{1}$ is a sub-effect of $\varepsilon_{2}$, denoted $\varepsilon_{1} \sqsubseteq \varepsilon_{2}$, when $\varepsilon_{2}=\varepsilon_{1} \sqcup \varepsilon_{2}$.

The rule T-Alloc assigns $\left\{f_{i}=a_{i}{ }^{i \in[1, \ldots, n]}\right\}$ a region $\rho=\left\{f_{i}: \tau_{i}{ }^{i \in[1, \ldots, n]}\right\}_{r}$ where each $\tau_{i}$ matches the type of the corresponding expression $a_{i}$. Notice that the index $r$ can be chosen arbitrarily and is not necessarily distinct from the indices of regions in the environments $\Gamma$ and $\Sigma$. Indeed, resetting $\rho$ in the effect for $\left\{f_{i}=a_{i}{ }^{i \in[1, \ldots, n]\}}\right.$ prohibits the further use of previous inhabitants of $\rho$, if any. For instance, in the expression let $x=\{f=41\}$ in let $y=\{f=43\}$ in $e$, the variables $x$ and $y$ can be assigned two distinct regions and then both can
be used in $e$. It is also possible to give to $x$ and $y$ the same region. In this case, $x$ is invalidated by the second allocation and consequently cannot be used in $e$. Incidentally, this shows that our typing system does not possess the principal typing property.

In the T-Assign rule, the operation $\Phi$ verifies the validity of an assignment and computes the corresponding reset effect. To define $\Phi$, we shall need several intermediate definitions. Below, we write $A$ to refer to the parameter of $\Phi$, that is the projection of the assignment expression into types: Given a region $\rho_{i}$ and a field $f_{i, j}$ involved in the assignment, $A\left(\rho_{i}, f_{i, j}\right)$ denotes $\tau_{i, j}^{\prime}$, the type of the value assigned to field $f_{i, j}$. For all $\rho$ and $f$ not affected by $A, A(\rho, f)$ stands for $\rho$.f. We extend this notation to paths as usual: $A(\rho, \epsilon) \triangleq \rho, A(\rho, f \pi) \triangleq A(A(\rho, f), \pi)$ when $A(\rho, f)$ is itself a region, and $A(\rho, f \pi) \triangleq A(\rho, f) . \pi$ when $A(\rho, f)$ is a scalar type (then $\pi$ has to be empty). Since the T-Assign rule requires the assigned types to be structurally equal to the original field types, $A(\rho, \pi)$ is defined if and only if $\rho . \pi$ is defined, and if $\rho . \pi$ or $A(\rho, \pi)$ is a scalar type, then $A(\rho, \pi)=\rho . \pi$. We now define a binary relation $\sigma_{A}$ as follows:

$$
\sigma_{A} \triangleq\{\langle A(\rho, \pi), \rho . \pi\rangle \mid \rho \text { is affected by } A \text { and } \rho . \pi \text { is defined }\}
$$

An assignment $A$ is valid if and only if $\sigma_{A}$ is bijective. Intuitively, if $\sigma_{A}$ is not bijective, then the assignment contains an alias conflict that cannot be resolved. For instance, given a region $\rho$, if $\rho . h_{1}$ and $\rho . h_{2}$ are regions themselves, they may be aliased. Modifying $\rho . h_{2}$ by some region $\rho_{4}$, without modifying the $\rho . h_{1}$ results in a $\sigma_{A}$ which is not bijective, as shown in the Fig. 55. Symmetrically, as shown in the Fig. 6] if some regions $\rho_{1}$ and $\rho_{4}$ are structurally equal, but do not have the same alias structure ( $\rho_{1} \cdot f \neq \rho_{1} \cdot g$ and $\rho_{4} \cdot f=\rho_{4} \cdot g$ ), then replacing $\rho_{1}$ by $\rho_{4}$ results in an invalid $A$.

The reset effect of a valid assignment $A$, denoted $\Phi(A)$, is defined as follows:

$$
\Phi(A) \triangleq\left\{\rho \mid \text { there exists } \rho^{\prime} \neq \rho \text { such that }\left\langle\rho, \rho^{\prime}\right\rangle \in \sigma_{A} \text { or }\left\langle\rho^{\prime}, \rho\right\rangle \in \sigma_{A}\right\}
$$

In other words, we reset every region, on the left or on the right side of an assignment, which is not mapped to itself by $\sigma_{A}$.

Typing a computation state. Let us now define what it means for a particular state of computation $\mu \cdot e$ to be well-typed. Since we only evaluate closed program expressions, the variable-typing environment $\Gamma$ is irrelevant and we omit it below.

Definition 4. We say that a store $\mu$ is well-typed in $\Sigma$ on a set of locations $L$, denoted $\Sigma \models \mu \cdot L$, if and only if for every location $\ell \in L$ and every path $\pi$, either $\Sigma(\ell) . \pi=\Sigma(\mu(\ell . \pi))$, or both $\Sigma(\ell) . \pi$ and $\mu(\ell . \pi)$ are undefined.
Definition 5. We say that a store typing $\Sigma$ is injective on $\mu \cdot L$, denoted $\Sigma \ltimes \mu \cdot L$, if and only if, for any locations $\ell_{1}, \ell_{2} \in L$, and paths $\pi_{1}, \pi_{2}$ such that $\Sigma\left(\ell_{1}\right) \cdot \pi_{1}$ and $\Sigma\left(\ell_{2}\right) \cdot \pi_{2}$ are the same region, we have $\mu\left(\ell_{1} \cdot \pi_{1}\right)=\mu\left(\ell_{2} \cdot \pi_{2}\right)$.

We write $\Sigma \models \mu \cdot e$ for $\Sigma \models \mu \cdot \mathcal{F}_{\ell}(e)$, and $\Sigma \ltimes \mu \cdot e$ for $\Sigma \ltimes \mu \cdot \mathcal{F}_{\ell}(e)$.

## 4 Correctness

To demonstrate that our type system is sound and adequate for static control of aliases, we need to show that a single step of execution of a well-typed program preserves the type of the program, the well-typedness of the store, and the injectivity of the store typing.

Theorem 1 (Subject Reduction). For any reduction step $\mu \cdot e \longrightarrow \mu^{\prime} \cdot e^{\prime}$,

\begin{array}{cl}
\Gamma \cdot \Sigma \vdash e: \tau \cdot \varepsilon \\
\Sigma \models \mu \cdot e \\
\Sigma \ltimes \mu \cdot e
\end{array} \quad \Longrightarrow \quad \exists \Sigma^{\prime}, \varepsilon^{\prime}, \varphi^{\prime \prime} \cdot \begin{aligned}
& \Gamma \cdot \Sigma^{\prime} \vdash e^{\prime}: \tau \cdot \varepsilon^{\prime} \sqcup\left(\varnothing \cdot \varphi^{\prime \prime}\right) \\
& \Sigma^{\prime} \models \mu^{\prime} \cdot e^{\prime} \\
& \Sigma^{\prime} \ltimes \mu^{\prime} \cdot e^{\prime}
\end{aligned}
$$

where $\varepsilon^{\prime} \sqsubseteq \varepsilon$ and $\varphi^{\prime \prime} \cap \Sigma^{\prime}\left(\operatorname{dom} \mu^{\prime}\right)=\varnothing$.
Proof. First of all, let us determine an effect $\varepsilon_{0}=\left(\omega_{0} \cdot \varphi_{0}\right)$ which is realized during the reduction step together with the "remaining" effect $\varepsilon^{\prime}=\left(\omega^{\prime} \cdot \varphi^{\prime}\right)$. We can do this by recursion over the derivation of the evaluation step $\mu \cdot e \longrightarrow \mu^{\prime} \cdot e^{\prime}$ as follows.

If $e$ is a record allocation or a parallel assignment, then the realized effect $\varepsilon_{0}$ is simply the effect of $e$, that is $\varepsilon$, and the remaining effect $\varepsilon^{\prime}$ is empty. Indeed, both expressions reduce to values.

If $e$ is a conditional, then the realized effect $\varepsilon_{0}$ is empty and the remaining effect is the effect of the chosen branch.

If $e$ is a function call, then the reduction step consists in definition expansion and does not produce any effect, so that $\varepsilon_{0}$ is empty. We define the remaining effect $\varepsilon^{\prime}$ to be the effect of the call, $\varepsilon$. Notice that we do not include the additional reset effects of the function body in $\varepsilon^{\prime}$ : they will become $\varphi^{\prime \prime}$.

If $e$ is a let-expression let $x=e_{1}$ in $e_{2}$, where $e_{1}$ is a reducible expression, then $\varepsilon_{0}$ is the realized effect of $e_{1}$ and $\varepsilon^{\prime}$ is $\varepsilon_{1}^{\prime} \sqcup \varepsilon_{2}$, where $\varepsilon_{1}^{\prime}$ is the remaining effect of $e_{1}$ and $\varepsilon_{2}$ is the effect of $e_{2}$.

In all other cases, both $\varepsilon_{0}$ and $\varepsilon^{\prime}$ are empty: indeed, the redex is $e$ itself and does not contain any effects at all.

It is easy to show that $\varepsilon^{\prime} \sqsubseteq \varepsilon$. Indeed, when we reduce a conditional to one of its branches, $\varepsilon=\varepsilon^{\prime} \sqcup \hat{\varepsilon}$ where $\hat{\varepsilon}$ is the effect of the discarded branch. When we reduce under a let-expression, $\varepsilon_{1}^{\prime} \sqsubseteq \varepsilon_{1}$ implies $\varepsilon^{\prime}=\varepsilon_{1}^{\prime} \sqcup \varepsilon_{2} \sqsubseteq \varepsilon_{1} \sqcup \varepsilon_{2}=\varepsilon$. The other cases are trivial. Similarly, $\varepsilon_{0} \sqsubseteq \varepsilon$.

We can also see that for any location $\ell \in \operatorname{dom} \mu$ that appears in $e^{\prime}, \varepsilon_{0} \triangleright \Sigma(\ell)$. Indeed, if $e$ is a record allocation, then the resulting location is not in $\mu$. If $e$ is an assignment, then it reduces to the unit constant () which does not contain any locations. Finally, if $e$ is let $x=e_{1}$ in $e_{2}$ with reducible $e_{1}$, then every location in $e_{2}$ has a valid type with respect to $\varepsilon_{1}$. Since $\varepsilon_{0} \sqsubseteq \varepsilon_{1}$, we obtain $\varepsilon_{0} \triangleright \Sigma(\ell)$ by Lemma 2. In all other cases, $\varepsilon_{0}$ is empty and the claim is trivial.

Let us now define the new store typing $\Sigma^{\prime}$. If the redex sub-expression is a parallel assignment, we consider its typing derivation and the corresponding relation $\sigma_{A}$. Then for every location $\ell$,

$$
\Sigma^{\prime}(\ell) \triangleq \begin{cases}\rho & \text { if }\langle\Sigma(\ell), \rho\rangle \in \sigma_{A} \\ \Sigma(\ell) & \text { otherwise }\end{cases}
$$

If the redex is a record allocation of type $\rho$ reduced to a fresh location $\ell$, then $\Sigma^{\prime} \triangleq \Sigma[\ell \leftrightarrow \rho]$. If the redex is neither an assignment nor an allocation, $\Sigma^{\prime} \triangleq \Sigma$.

Notice that for any location $\ell \in \operatorname{dom} \mu$, if $\Sigma^{\prime}(\ell) \neq \Sigma(\ell)$ then both $\Sigma(\ell)$ and $\Sigma^{\prime}(\ell)$ are in $\varphi_{0}$ by definition of $\Phi(A)$. Consequently, for every $\ell \in \operatorname{dom} \mu$ that appears in $e^{\prime}$, we have $\Sigma^{\prime}(\ell)=\Sigma(\ell)$, due to $\varepsilon_{0} \triangleright \Sigma(\ell)$ and Lemma 1 .

Before we proceed, we need to establish a variant of the frame property, namely that all "observable" store modifications and region resets are covered by the realized write effect $\omega_{0}$.

Lemma 4. Let $\ell$ be a location in $e^{\prime}$. Let $\pi$ be a path such that $\mu(\ell . \pi)$ is defined and for every proper prefix $\bar{\pi} \prec \pi$, $\Sigma(\ell) . \bar{\pi}$ is not in $\omega_{0}$. Then $\Sigma(\ell) . \pi \notin \varphi_{0}$ and $\mu^{\prime}(\ell . \pi)=\mu(\ell . \pi)$.

Now we are ready to attack the main theorem. We prove the desired properties by induction over the derivation of the reduction step. Looking at the last reduction rule in the derivation, we have four interesting cases.

Case E-Ctx. Assume $e$ is of the form let $x=e_{1}$ in $e_{2}$ and $e_{1}$ reduces to $e_{1}^{\prime}$. For every location $\ell$ in $e_{2}, \Sigma^{\prime}(\ell)=\Sigma(\ell)$, since $\ell \in \operatorname{dom} \mu$ and occurs in $e^{\prime}$.

Type preservation. By induction hypothesis on $\mu \cdot e_{1} \longrightarrow \mu^{\prime} \cdot e_{1}^{\prime}$, we have $\Gamma \cdot \Sigma^{\prime} \vdash e_{1}^{\prime}: \tau_{1} \cdot \varepsilon_{1}^{\prime} \sqcup\left(\varnothing \cdot \varphi^{\prime \prime}\right)$, where $\tau_{1}$ is the type of $e_{1}, \varepsilon_{1}^{\prime}$ is the remaining effect of $e_{1}$, and $\varphi^{\prime \prime} \cap \Sigma^{\prime}\left(\operatorname{dom} \mu^{\prime}\right)=\varnothing$. Notice that $\Sigma^{\prime}$ is the same as defined above, since it only depends on the redex expression inside $e_{1}^{\prime}$.

Let $\tau_{2}$ and $\varepsilon_{2}$ be, respectively, the type and the effect of $e_{2}$ in the typing derivation for $e$. Since $\Sigma^{\prime}$ coincides with $\Sigma$ on every location in $e_{2}$, we obtain $\Gamma\left[x \longleftarrow \tau_{1}\right] \cdot \Sigma^{\prime} \vdash e_{2}: \tau_{2} \cdot \varepsilon_{2}$.

Let us now show that for every location $\ell$ in $e_{2}$, we have $\varepsilon_{1}^{\prime} \sqcup\left(\varnothing \cdot \varphi^{\prime \prime}\right) \triangleright \Sigma^{\prime}(\ell)$. First, we know that $\varepsilon_{1}^{\prime} \triangleright \Sigma^{\prime}(\ell)$. Indeed, since $e$ is well-typed and $\Sigma^{\prime}(\ell)=\Sigma(\ell)$, we have $\varepsilon_{1} \triangleright \Sigma^{\prime}(\ell)$. Since $\varepsilon_{1}^{\prime} \sqsubseteq \varepsilon_{1}$, we obtain $\varepsilon_{1}^{\prime} \triangleright \Sigma^{\prime}(\ell)$ by Lemma 2. Also, $\varphi^{\prime \prime} \cap \Sigma^{\prime}\left(\operatorname{dom} \mu^{\prime}\right)=\varnothing$ implies that $\Sigma^{\prime}(\ell) \notin \varphi^{\prime \prime}$, so $\left(\varnothing \cdot \varphi^{\prime \prime}\right) \triangleright \Sigma^{\prime}(\ell)$ holds. Therefore, since $e$ is closed, $\mathcal{F}_{v}\left(e_{2}\right) \backslash\{x\}$ is empty, and Lemma 2 gives us the third premise of the T-LeT rule for $e^{\prime}$. Finally, by Lemma 3. $\varepsilon_{1}^{\prime} \sqcup\left(\varnothing \cdot \varphi^{\prime \prime}\right) \sqcup \varepsilon_{2}=\varepsilon^{\prime} \sqcup\left(\varnothing \cdot \varphi^{\prime \prime}\right)$. Altogether, we obtain $\Gamma \cdot \Sigma^{\prime} \vdash e^{\prime}: \tau \cdot \varepsilon^{\prime} \sqcup\left(\varnothing \cdot \varphi^{\prime \prime}\right)$.

Well-typedness of $\mu^{\prime}$. By induction hypothesis, $\Sigma^{\prime} \models \mu^{\prime} \cdot e_{1}^{\prime}$. Let $\ell$ be a location in $e_{2}$ and $\pi$, an arbitrary path. We need to show that either $\Sigma^{\prime}(\ell) \cdot \pi=\Sigma^{\prime}\left(\mu^{\prime}(\ell . \pi)\right)$ or both are undefined.

Let $\pi^{\prime}$ be the longest prefix of $\pi$ such that $\mu\left(\ell . \pi^{\prime}\right)$ is defined and for all $\bar{\pi} \prec \pi^{\prime}$, $\Sigma(\ell) . \bar{\pi} \notin \omega_{0}$. Such a prefix exists, since $\Sigma \models \mu \cdot e$ and therefore $\mu(\ell . \epsilon)$ is defined. By Lemma $4, \Sigma(\ell) . \pi^{\prime} \notin \varphi_{0}$ and $\mu^{\prime}\left(\ell . \pi^{\prime}\right)=\mu\left(\ell . \pi^{\prime}\right)$. Since $\Sigma(\ell) \cdot \pi^{\prime}=\Sigma\left(\mu\left(\ell . \pi^{\prime}\right)\right)$ (by well-typedness of $\mu), \Sigma(\ell) . \pi^{\prime} \notin \varphi_{0}$ implies $\Sigma\left(\mu\left(\ell \cdot \pi^{\prime}\right)\right)=\Sigma^{\prime}\left(\mu\left(\ell . \pi^{\prime}\right)\right)$. Overall, we obtain $\Sigma^{\prime}(\ell) \cdot \pi^{\prime}=\Sigma(\ell) \cdot \pi^{\prime}=\Sigma\left(\mu\left(\ell \cdot \pi^{\prime}\right)\right)=\Sigma^{\prime}\left(\mu\left(\ell \cdot \pi^{\prime}\right)\right)=\Sigma^{\prime}\left(\mu^{\prime}\left(\ell \cdot \pi^{\prime}\right)\right)$.

Now we have three cases to consider. If $\pi^{\prime}=\pi$, then $\Sigma^{\prime}(\ell) . \pi=\Sigma^{\prime}\left(\mu^{\prime}(\ell . \pi)\right)$. If $\pi^{\prime} \prec \pi$ and for every path $\bar{\pi}$ such that $\pi^{\prime} \prec \bar{\pi} \preceq \pi, \mu(\ell . \bar{\pi})$ is undefined, then $\Sigma^{\prime}(\ell) \cdot \pi=\Sigma(\ell) \cdot \pi$ is undefined by well-typedness of $\mu$, and $\mu^{\prime}(\ell . \pi)$ is undefined, since $\mu^{\prime}\left(\ell . \pi^{\prime}\right)=\mu\left(\ell . \pi^{\prime}\right)$.

Otherwise, $\Sigma(\ell) \cdot \pi^{\prime} \in \omega_{0}$. Then the redex expression is an assignment, and we can consider the corresponding relation $\sigma_{A}$. Let $\ell^{\prime}$ denote the location $\mu\left(\ell . \pi^{\prime}\right)$. Since $\mu$ is well-typed and $\Sigma$ is injective on $\mu \cdot e$, no location in $e$ other than $\ell^{\prime}$ can have type $\Sigma\left(\ell^{\prime}\right)=\Sigma(\ell) \cdot \pi^{\prime}$. Consequently, we know that the store is modified at $\ell^{\prime}$ at this reduction step.

Let $\pi=\pi^{\prime} \pi^{\prime \prime}$. If $\Sigma\left(\ell^{\prime}\right) \cdot \pi^{\prime \prime}$ is defined, then $\left\langle A\left(\Sigma\left(\ell^{\prime}\right), \pi^{\prime \prime}\right), \Sigma\left(\ell^{\prime}\right) \cdot \pi^{\prime \prime}\right\rangle$ is in $\sigma_{A}$. The first component is $\Sigma\left(\mu^{\prime}\left(\ell^{\prime} \cdot \pi^{\prime \prime}\right)\right)$, the $\Sigma$-type of the value found in the store at $\ell^{\prime} . \pi^{\prime \prime}$ after the assignment. The second component is $\Sigma^{\prime}\left(\mu^{\prime}\left(\ell^{\prime} . \pi^{\prime \prime}\right)\right)$, the type given to this value in $\Sigma^{\prime}$. Notice that $\Sigma\left(\ell^{\prime}\right) \cdot \pi^{\prime \prime}=A\left(\Sigma\left(\ell^{\prime}\right), \pi^{\prime \prime}\right)=\Sigma\left(\mu^{\prime}\left(\ell^{\prime} . \pi^{\prime \prime}\right)\right)=$ $\Sigma^{\prime}\left(\mu^{\prime}\left(\ell^{\prime} \cdot \pi^{\prime \prime}\right)\right)$ when $\mu^{\prime}\left(\ell^{\prime} \cdot \pi^{\prime \prime}\right)$ is a scalar. We get $\Sigma^{\prime}(\ell) \cdot \pi=\Sigma(\ell) \cdot \pi=\Sigma\left(\ell^{\prime}\right) \cdot \pi^{\prime \prime}=$ $\Sigma^{\prime}\left(\mu^{\prime}\left(\ell^{\prime} \cdot \pi^{\prime \prime}\right)\right)=\Sigma^{\prime}\left(\mu^{\prime}\left(\mu\left(\ell \cdot \pi^{\prime}\right) \cdot \pi^{\prime \prime}\right)\right)=\Sigma^{\prime}\left(\mu^{\prime}\left(\mu^{\prime}\left(\ell \cdot \pi^{\prime}\right) \cdot \pi^{\prime \prime}\right)\right)=\Sigma^{\prime}\left(\mu^{\prime}(\ell \cdot \pi)\right)$.

If $\Sigma^{\prime}(\ell) \cdot \pi=\Sigma(\ell) \cdot \pi=\Sigma\left(\ell^{\prime}\right) \cdot \pi^{\prime \prime}$ is undefined, then $\mu\left(\ell^{\prime} \cdot \pi^{\prime \prime}\right)$ is also undefined. In a parallel assignment, the types of the affected fields are structurally equal to the types of the corresponding assigned values. Since $\mu$ is well-typed, this means that $\ell^{\prime}$ in $\mu$ (before the reduction step) admits exactly the same paths as in $\mu^{\prime}$ (after the reduction step). Therefore, $\mu^{\prime}\left(\ell^{\prime} \cdot \pi^{\prime \prime}\right)=\mu^{\prime}(\ell . \pi)$ is undefined.

Injectivity of $\Sigma^{\prime}$. Consider $\ell_{1}$ and $\ell_{2}$ in $e^{\prime}$ and two paths $\pi_{1}$ and $\pi_{2}$ such that $\Sigma^{\prime}\left(\ell_{1}\right) \cdot \pi_{1}$ and $\Sigma^{\prime}\left(\ell_{2}\right) \cdot \pi_{2}$ are the same region. We need to prove that $\mu^{\prime}\left(\ell_{1} \cdot \pi_{1}\right)=$ $\mu^{\prime}\left(\ell_{2} . \pi_{2}\right)$. We have three cases to consider.

If neither $\ell_{1}$ nor $\ell_{2}$ are in $\mu$, then they are allocated during the reduction step, and therefore both appear in $e_{1}^{\prime}$. Then we conclude by induction hypothesis.

Assume $\ell_{1} \notin \operatorname{dom} \mu$ and $\ell_{2} \in \operatorname{dom} \mu$ (the symmetric case is handled in the same way). Then the redex is a record allocation and $\ell_{1}$ is the new location. This implies that $\omega_{0}=\varnothing$ and $\Sigma^{\prime}\left(\ell_{1}\right) \in \varphi_{0}$. Since $\mu$ is well-typed, $\mu\left(\ell_{2} . \pi_{2}\right)$ is defined, and we get $\Sigma^{\prime}\left(\ell_{2}\right) \cdot \pi_{2}=\Sigma\left(\ell_{2}\right) \cdot \pi_{2} \notin \varphi_{0}$ and $\mu^{\prime}\left(\ell_{2} \cdot \pi_{2}\right)=\mu\left(\ell_{2} \cdot \pi_{2}\right)$ by Lemma 4 . Therefore $\pi_{1}$ can not be $\epsilon$. Let $\pi_{1}=f \pi^{\prime}$. Then there exists a location $\ell^{\prime}$ in $e_{1}$ such that $\Sigma^{\prime}\left(\ell_{1}\right) \cdot f=\Sigma\left(\ell^{\prime}\right)$ and $\mu^{\prime}\left(\ell_{1} \cdot f\right)=\ell^{\prime}$. By injectivity of $\Sigma, \mu\left(\ell^{\prime} \cdot \pi^{\prime}\right)=\mu\left(\ell_{2} \cdot \pi_{2}\right)$. Moreover, since record allocation does not modify the existing entries in the store, $\mu^{\prime}\left(\ell^{\prime} . \pi^{\prime}\right)=\mu\left(\ell^{\prime} \cdot \pi^{\prime}\right)$, and we obtain $\mu^{\prime}\left(\ell_{1} \cdot \pi_{1}\right)=\mu^{\prime}\left(\ell_{2} \cdot \pi_{2}\right)$.

Now, let both $\ell_{1}$ and $\ell_{2}$ be in $\mu$. Since $\Sigma^{\prime}\left(\ell_{1}\right)=\Sigma\left(\ell_{1}\right)$ and $\Sigma^{\prime}\left(\ell_{2}\right)=\Sigma\left(\ell_{2}\right)$, we have $\mu\left(\ell_{1} . \pi_{1}\right)=\mu\left(\ell_{2} . \pi_{2}\right)$ by injectivity of $\Sigma$. Indeed, if $\ell_{1}$ is in $e$, the injectivity applies immediately. If $\ell_{1}$ is not in $e$, then it could only appear in $e^{\prime}$ after reducing some $\ell_{0} . f$ in $e$, in which case we apply injectivity to $\ell_{0} . f \pi_{1}$ and $\ell_{2} . \pi_{2}$.

Let $\pi_{1}^{\prime}$ be the longest prefix of $\pi_{1}$ such that for all $\bar{\pi} \prec \pi_{1}^{\prime}, \Sigma(\ell) \cdot \bar{\pi} \notin \omega_{0}$. Let $\pi_{2}^{\prime}$ be the longest prefix of $\pi_{2}$ such that for all $\bar{\pi} \prec \pi_{2}^{\prime}, \Sigma(\ell) . \bar{\pi} \notin \omega_{0}$. By Lemma 4, we have $\Sigma\left(\ell_{1}\right) \cdot \pi_{1}^{\prime} \notin \varphi_{0}, \Sigma\left(\ell_{2}\right) \cdot \pi_{2}^{\prime} \notin \varphi_{0}, \mu^{\prime}\left(\ell_{1} \cdot \pi_{1}^{\prime}\right)=\mu\left(\ell_{1} \cdot \pi_{1}^{\prime}\right)$, and $\mu^{\prime}\left(\ell_{2} . \pi_{2}^{\prime}\right)=\mu\left(\ell_{2} \cdot \pi_{2}^{\prime}\right)$.

If $\pi_{1}^{\prime}=\pi_{1}$ and $\pi_{2}^{\prime}=\pi_{2}$, then $\mu^{\prime}\left(\ell_{1} \cdot \pi_{1}\right)=\mu^{\prime}\left(\ell_{2} \cdot \pi_{2}\right)$ immediately. Otherwise, $\Sigma\left(\ell_{1}\right) \cdot \pi_{1}^{\prime}$ or $\Sigma\left(\ell_{2}\right) \cdot \pi_{2}^{\prime}$ or both are in $\omega_{0}$. This means that the redex expression is an assignment, and we can consider the corresponding relation $\sigma_{A}$.

Assume $\Sigma\left(\ell_{1}\right) . \pi_{1}^{\prime} \in \omega_{0}$. Let $\ell_{1}^{\prime}$ be $\mu\left(\ell_{1} \cdot \pi_{1}^{\prime}\right)$ and $\pi_{1}=\pi_{1}^{\prime} \pi_{1}^{\prime \prime}$. Then $\sigma_{A}$ contains a pair $\left\langle A\left(\Sigma\left(\ell_{1}^{\prime}\right), \pi_{1}^{\prime \prime}\right), \Sigma\left(\ell_{1}^{\prime}\right) \cdot \pi_{1}^{\prime \prime}\right\rangle$. The first component is $\Sigma\left(\mu^{\prime}\left(\ell_{1}^{\prime} \cdot \pi_{1}^{\prime \prime}\right)\right)$, the $\Sigma$-type of the location found in the store at $\ell_{1}^{\prime} \cdot \pi_{1}^{\prime \prime}$ after the assignment. The second component is $\Sigma^{\prime}\left(\mu^{\prime}\left(\ell_{1}^{\prime} \cdot \pi_{1}^{\prime \prime}\right)\right)$, the type given to this location in $\Sigma^{\prime}$. Once again, we have three cases to consider.

If $\pi_{2}^{\prime}=\pi_{2}$ and $A\left(\Sigma\left(\ell_{1}^{\prime}\right), \pi_{1}^{\prime \prime}\right) \neq \Sigma\left(\ell_{1}^{\prime}\right) \cdot \pi_{1}^{\prime \prime}$, then $\Sigma\left(\ell_{1}^{\prime}\right) \cdot \pi_{1}^{\prime \prime} \in \varphi_{0}$ by definition of $\Phi(A)$. Since $\varepsilon_{0} \triangleright \Sigma\left(\ell_{2}\right)$ and $\Sigma\left(\ell_{2}\right) \cdot \pi_{2}=\Sigma\left(\ell_{1}\right) \cdot \pi_{1}=\Sigma\left(\ell_{1}^{\prime}\right) \cdot \pi_{1}^{\prime \prime}$ is in $\varphi_{0}$, there must be some $\bar{\pi} \prec \pi_{2}$ such that $\Sigma\left(\ell_{2}\right) \cdot \bar{\pi} \in \omega_{0}$, which contradicts the definition of $\pi_{2}^{\prime}$.

If $\pi_{2}^{\prime}=\pi_{2}$ and $\Sigma\left(\mu^{\prime}\left(\ell_{1}^{\prime} \cdot \pi_{1}^{\prime \prime}\right)\right)=A\left(\Sigma\left(\ell_{1}^{\prime}\right), \pi_{1}^{\prime \prime}\right)=\Sigma\left(\ell_{1}^{\prime}\right) \cdot \pi_{1}^{\prime \prime}=\Sigma\left(\mu\left(\ell_{1}^{\prime}, \pi_{1}^{\prime \prime}\right)\right)$, then $\mu^{\prime}\left(\ell_{1}^{\prime} \cdot \pi_{1}^{\prime \prime}\right)=\mu\left(\ell_{1}^{\prime}, \pi_{1}^{\prime \prime}\right)$ by injectivity of $\Sigma$. Indeed, the location $\mu^{\prime}\left(\ell_{1}^{\prime} \cdot \pi_{1}^{\prime \prime}\right)$ is reachable in $\mu$ from the right-hand side of the reduced assignment in $e$. We obtain $\mu^{\prime}\left(\ell_{1} \cdot \pi_{1}\right)=\mu^{\prime}\left(\mu^{\prime}\left(\ell_{1} \cdot \pi_{1}^{\prime}\right) \cdot \pi_{1}^{\prime \prime}\right)=\mu^{\prime}\left(\mu\left(\ell_{1} \cdot \pi_{1}^{\prime}\right) \cdot \pi_{1}^{\prime \prime}\right)=\mu^{\prime}\left(\ell_{1}^{\prime} \cdot \pi_{1}^{\prime \prime}\right)=\mu\left(\ell_{1}^{\prime}, \pi_{1}^{\prime \prime}\right)=$ $\mu\left(\ell_{1}, \pi_{1}\right)=\mu\left(\ell_{2}, \pi_{2}\right)=\mu^{\prime}\left(\ell_{2}, \pi_{2}\right)$.

Otherwise, $\pi_{2}^{\prime} \prec \pi_{2}$ and $\Sigma\left(\ell_{2}\right) . \pi_{2}^{\prime} \in \omega_{0}$. Let $\ell_{2}^{\prime}$ be $\mu\left(\ell_{2} . \pi_{2}^{\prime}\right)$ and $\pi_{2}=\pi_{2}^{\prime} \pi_{2}^{\prime \prime}$. Then $\sigma_{A}$ contains $\left\langle A\left(\Sigma\left(\ell_{2}^{\prime}\right), \pi_{2}^{\prime \prime}\right), \Sigma\left(\ell_{2}^{\prime}\right) \cdot \pi_{2}^{\prime \prime}\right\rangle$. Since $\Sigma\left(\ell_{1}^{\prime}\right) \cdot \pi_{1}^{\prime \prime}=\Sigma\left(\ell_{2}^{\prime}\right) \cdot \pi_{2}^{\prime \prime}$ and $\sigma_{A}$ is a bijection, we have $\Sigma\left(\mu^{\prime}\left(\ell_{1}^{\prime} \cdot \pi_{1}^{\prime \prime}\right)\right)=A\left(\Sigma\left(\ell_{1}^{\prime}\right), \pi_{1}^{\prime \prime}\right)=A\left(\Sigma\left(\ell_{2}^{\prime}\right), \pi_{2}^{\prime \prime}\right)=\Sigma\left(\mu^{\prime}\left(\ell_{2}^{\prime} \cdot \pi_{2}^{\prime \prime}\right)\right)$. Both $\mu^{\prime}\left(\ell_{1}^{\prime} \cdot \pi_{1}^{\prime \prime}\right)$ and $\mu^{\prime}\left(\ell_{2}^{\prime} \cdot \pi_{2}^{\prime \prime}\right)$ are reachable in $\mu$ from the reduced assignment in $e$, and we can conclude by injectivity of $\Sigma$ that they are actually the same location. We obtain $\mu^{\prime}\left(\ell_{1} \cdot \pi_{1}\right)=\mu^{\prime}\left(\ell_{1}^{\prime} \cdot \pi_{1}^{\prime \prime}\right)=\mu^{\prime}\left(\ell_{2}^{\prime} \cdot \pi_{2}^{\prime \prime}\right)=\mu^{\prime}\left(\ell_{2}, \pi_{2}\right)$.
Case E-Alloc. Let $e$ be a record allocation. Then the type of $e$ is some region $\rho$ and $e^{\prime}$ is a fresh location $\ell$. Type preservation is trivial, since $\Sigma^{\prime}(\ell)=\rho$ by construction, $\varepsilon^{\prime}=\perp$, and we set $\varphi^{\prime \prime}=\varnothing$.

We now show that $\mu^{\prime}$ is well-typed. Let $\pi$ be an arbitrary path. If $\pi=\epsilon$ then $\mu^{\prime}(\ell . \epsilon)=\ell$ and thus $\Sigma^{\prime}(\ell) . \epsilon=\Sigma^{\prime}\left(\mu^{\prime}(\ell . \epsilon)\right)$. Let $\pi=f \pi^{\prime}$. If there is no field $f$ in the record $e$, then $\mu^{\prime}(\ell . \pi)$ and $\Sigma^{\prime}(\ell) . \pi=\rho . \pi$ are both undefined. If $f$ is initialized in $e$ with a scalar constant $c$ of type $\nu$, then $\mu^{\prime}\left(\ell . f \pi^{\prime}\right)$ and $\Sigma^{\prime}(\ell) . f \pi^{\prime}$ are only defined when $\pi^{\prime}=\epsilon$, in which case $\Sigma^{\prime}(\ell) . f=\nu=\Sigma^{\prime}(c)=\Sigma^{\prime}\left(\mu^{\prime}(\ell . f)\right)$. Finally, if $f$ is initialized in $e$ with a location $\ell^{\prime}$, then $\Sigma\left(\ell^{\prime}\right) \cdot \pi^{\prime}=\Sigma\left(\mu\left(\ell^{\prime} \cdot \pi^{\prime}\right)\right)$ (or both are undefined) by well-typedness of $\mu$. Then we have $\Sigma^{\prime}(\ell) \cdot \pi=\rho \cdot f \pi^{\prime}=\Sigma\left(\ell^{\prime}\right) \cdot \pi^{\prime}=$ $\Sigma\left(\mu\left(\ell^{\prime} \cdot \pi^{\prime}\right)\right)=\Sigma^{\prime}\left(\mu\left(\ell^{\prime} \cdot \pi^{\prime}\right)\right)=\Sigma^{\prime}\left(\mu^{\prime}\left(\ell^{\prime} \cdot \pi^{\prime}\right)\right)=\Sigma^{\prime}\left(\mu^{\prime}(\ell . \pi)\right)$.

As for injectivity of $\Sigma^{\prime}$, since $\ell$ is the only location in $e^{\prime}$, it is enough to take two distinct paths $\pi_{1}$ and $\pi_{2}$ such that $\rho . \pi_{1}=\rho . \pi_{2}$. Neither of two paths can be empty, as $\rho$ cannot be equal to a part of $\rho$. Assuming $\pi_{1}=f_{1} \pi_{1}^{\prime}$ and $\pi_{2}=f_{2} \pi_{2}^{\prime}$, we obtain $\left(\rho . f_{1}\right) \cdot \pi_{1}^{\prime}=\left(\rho . f_{2}\right) \cdot \pi_{2}^{\prime}$, where $\rho \cdot f_{1}=\Sigma\left(\ell_{1}^{\prime}\right)$ and $\rho . f_{2}=\Sigma\left(\ell_{2}^{\prime}\right)$ for some $\ell_{1}^{\prime}$ and $\ell_{2}^{\prime}$ occurring in $e$. Then we can use the injectivity of $\Sigma$ and obtain $\mu^{\prime}\left(\ell, \pi_{1}\right)=\mu\left(\ell_{1}^{\prime} \cdot \pi_{1}^{\prime}\right)=\mu\left(\ell_{2}^{\prime} \cdot \pi_{2}^{\prime}\right)=\mu^{\prime}\left(\ell \cdot \pi_{2}\right)$.

Case E-Assign. Let $e$ be an assignment. Then the type of $e$ is Unit, $e^{\prime}$ is (), $\varepsilon^{\prime}=\perp$, and $\varphi^{\prime \prime}=\varnothing$. The claim trivially holds, in particular, since $\mathcal{F}_{\ell}\left(e^{\prime}\right)=\varnothing$.

Case E-Call. Let $e$ be of the form $p\left(v_{1}, \ldots, v_{n}\right)$ with $p\left(x_{1}, \ldots, x_{n}\right) \mapsto \hat{e}$. Then the reduct $e^{\prime}$ is $\hat{e}\left[x_{i} \leftrightarrow v_{i}{ }^{i \in\{1, \ldots, n\}}\right]$. Since $\mathcal{F}_{\ell}(\hat{e})=\varnothing$, all locations in $e^{\prime}$ occur in $e$. Moreover, the reduction step does not modify the store and $\Sigma^{\prime}=\Sigma$. Consequently, the well-typedness of $\mu^{\prime}$ and injectivity of $\Sigma^{\prime}$ trivially hold.

Let us prove the type preservation. Let $\hat{\tau}_{1} \times \ldots \times \hat{\tau}_{n} \rightarrow \hat{\tau} \cdot(\hat{\omega} \cdot \hat{\varphi})$ be the signature of $p$. By hypothesis, $\Gamma\left[x_{i} \leftarrow \hat{\tau}_{i}{ }^{i \in\{1, \ldots, n\}}\right] \cdot \Sigma \vdash \hat{e}: \hat{\tau} \cdot\left(\hat{\omega} \cdot \hat{\varphi} \cup \hat{\varphi}^{\prime \prime}\right)$ where $\hat{\varphi}^{\prime \prime}$ is disjoint with $\mathcal{R}\left(\hat{\tau}_{1}, \ldots, \hat{\tau}_{n}, \hat{\tau}\right)$. It is easy to show that every region that occurs in the type inference for $\hat{e}$ belongs one of these two sets. Indeed, every such region either comes from the type of a formal parameter, or is introduced through a record allocation or a function call, and therefore is reset.

Since $e$ is well-typed, there exists a region substitution $\theta$ that maps $\hat{\tau}$ to $\tau,(\hat{\omega} \cdot \hat{\varphi})$ to $\varepsilon$, and each $\hat{\tau}_{i}$ to $\Sigma\left(v_{i}\right)$. Let $\theta^{\prime}$ be an extension of $\theta$ where every region of $\varphi^{\prime \prime}$ is mapped to a fresh region in such a way that $\theta^{\prime}$ remains a region substitution, that is bijective and consistent with respect to sub-regions. Now, we can apply $\theta^{\prime}$ throughout the type inference tree for $\hat{e}$, and obtain a valid type judgement $\Gamma\left[x_{i} \leftarrow \Sigma\left(v_{i}\right)^{i \in\{1, \ldots, n\}}\right] \cdot \Sigma \vdash \hat{e}: \tau \cdot\left(\omega \cdot \varphi \cup \theta^{\prime}\left(\hat{\varphi}^{\prime \prime}\right)\right)$ where $(\omega \cdot \varphi)=\epsilon$. We define $\varphi^{\prime \prime}$ to be $\theta^{\prime}\left(\hat{\varphi}^{\prime \prime}\right)$. It is easy to see that $\left(\omega \cdot \varphi \cup \varphi^{\prime \prime}\right)=(\omega \cdot \varphi) \sqcup\left(\varnothing \cdot \varphi^{\prime \prime}\right)$ and $\varphi^{\prime \prime} \cap \Sigma^{\prime}\left(\operatorname{dom} \mu^{\prime}\right)=\varnothing$, since every region in $\varphi^{\prime \prime}$ is fresh.

Finally, by standard substitution lemma ([7] p.106]), replacing formal parameters $x_{1}, \ldots, x_{n}$ by the corresponding argument values $v_{i}$ in $\hat{e}$ results in a valid typing judgement $\Gamma \cdot \Sigma^{\prime} \vdash \hat{e}\left[x_{i} \leftrightarrow v_{i}{ }^{i \in\{1, \ldots, n\}}\right]: \tau \cdot \varepsilon \sqcup\left(\varnothing \cdot \varphi^{\prime \prime}\right)$.

In all other cases, the reduction step does not produce any effect $\left(\varepsilon_{0}=\perp\right)$, the store and the store typing do not change, and all locations in $e^{\prime}$ are accessible from locations in $e$. Type preservation can then be proved in a usual way, and the two other properties are trivial.

## 5 Related Work

Our approach is to track and control aliasing statically, using a type system with regions and effects. Such a methodology originates from the work of Baker [8], Lucassen and Gifford [9, and region-based memory management of Tofte and Talpin [10]. In our case, though, a region does not denote a set of memory locations, but a single location. This allows us to describe statically the exact shape of the memory store, two symbolic names being aliased if and only if they are assigned the same region.

Our use of singleton regions to describe the store accurately, together with the requirement for the store typing to be injective on allocated memory locations, is similar to how pointer identity is encoded in alias types [11 and typed regions 12 . However, both approaches rely on strong updates, which, in the case of alias types, imposes limitations on the control flow or, in the case of typed regions, introduces the complex machinery of dependent types.

Our reset effect has some connections with the concept of unique variable [13]14]15. A unique variable is either null or refers to some unshared object. In our case, an effect for record allocation $\left\{f_{i}=v_{i}\right\}$ is (writes $\varnothing \cdot$ reset $\{\rho\}$ ) prohibits all existing names which refer to $\rho$. Assuming this record is bound to a
variable $x$, our system makes $x$ a unique variable. This is very similar to Boyland's "alias burying" [16]. In Boyland's work, when a field annotated as unique is read, all existing aliases are required to be dead.

## 6 Conclusion and Perspectives

This type system is implemented in Why3 [17], a platform for deductive verification. In addition to what is presented in this paper, the implementation also features functions, type- and region-polymorphism, type and region inference, ghost code [18], algebraic data types, and abstract data types. Thanks to region inference, users do not have to manipulate regions explicitly.

We intend to extend this type system with the ability to refine a data type by adding new fields. In particular, this will allow users to refine interfaces into implementations, to prove the latter correct.

## A Proofs for Lemmas

Lemma 1. For any effect $(\omega \cdot \varphi)$ and any region $\rho,(\omega \cdot \varphi) \triangleright \rho \Longrightarrow \rho \notin \varphi$.
Proof. Let $\rho$ be a region, and $(\omega \cdot \varphi)$ be an effect such that $(\omega \cdot \varphi) \triangleright \rho$. Either $\rho \in \omega$, then the invariant on effects (disjointness of write and reset effects) ensures that $\rho \notin \varphi$. Otherwise, $\rho \notin \omega$, so $\rho \notin \varphi$ by the inference rule premise.

Lemma 2. For any $\varepsilon_{1}, \varepsilon_{2}$, and $\tau, \varepsilon_{1} \sqcup \varepsilon_{2} \triangleright \tau$ if and only if $\varepsilon_{1} \triangleright \rho$ and $\varepsilon_{2} \triangleright \tau$.
Proof. Let $\tau$ be a type, and $\varepsilon_{1}=\left(\omega_{1} \cdot \varphi_{1}\right), \varepsilon_{2}=\left(\omega_{2} \cdot \varphi_{2}\right)$ a two effects. Below we note $(\omega \cdot \varphi)$ for the union $\varepsilon_{1} \sqcup \varepsilon_{2}$.

Let us first prove that $\varepsilon_{1} \sqcup \varepsilon_{2} \triangleright \tau$ implies $\varepsilon_{1} \triangleright \rho$ and $\varepsilon_{2} \triangleright \tau$. We proceed by induction on the derivation of $\varepsilon_{1} \sqcup \varepsilon_{2} \triangleright \tau$. If $\varepsilon_{1} \sqcup \varepsilon_{2} \triangleright \nu$, the result trivially holds.

Assume now $\varepsilon_{1} \sqcup \varepsilon_{2} \triangleright \rho$ with $\rho \in \omega$. We have two sub-cases to consider. Either $\rho \in \omega_{1}$ and $\varepsilon_{2} \triangleright \rho$, in which case we derive $\varepsilon_{1} \triangleright \rho$ by a second clause in the definition 1, so the result holds. Otherwise, $\rho \in \omega_{2}$ and $\varepsilon_{1} \triangleright \rho$, in which case we derive $\varepsilon_{2} \triangleright \rho$ alike and again the result holds.

Finally, assume $\varepsilon_{1} \sqcup \varepsilon_{2} \triangleright \rho$ with $\rho \notin \omega, \rho \notin \varphi$, and $\forall i . \varepsilon_{1} \sqcup \varepsilon_{2} \triangleright \rho . f_{i}$. Since $\omega_{1}$ and $\varphi_{1}$ are subsets of $\omega, \varphi$ respectively, $\rho \notin \omega_{1}$ and $\rho \notin \varphi_{1}$. Moreover, by induction hypothesis, we have $\varepsilon_{1} \triangleright \rho . f_{i}$, so $\varepsilon_{1} \triangleright \rho$ holds by the third inference rule in the definition 1. By the similar reasoning, $\varepsilon_{2} \triangleright \rho$ also holds, which allows us to conclude.

Let us now prove the other direction. Assume that $\left(\omega_{1} \cdot \varphi_{1}\right) \triangleright \tau$ and $\left(\omega_{2} \cdot \varphi_{2}\right) \triangleright \tau$. We proceed by induction on $\left(\omega_{1} \cdot \varphi_{1}\right) \triangleright \tau$. If $\tau=\nu$, the result trivaily holds.

Assume now that $\left(\omega_{1} \cdot \varphi_{1}\right) \triangleright \rho$ and $\rho \in \omega_{1}$. Then $\rho \in\left\{\hat{\rho} \in \omega_{1} \mid \varepsilon_{2} \triangleright \hat{\rho}\right\} \subseteq \omega$, so we get $(\omega \cdot \varphi) \triangleright \rho$ using the second inference rule.

Otherwise, $\left(\omega_{1} \cdot \varphi_{1}\right) \triangleright \rho$ and $\rho \notin \omega_{1}, \rho \notin \varphi_{1}$, and $\forall i .\left(\omega_{1} \cdot \varphi_{1}\right) \triangleright \rho . f_{i}$. We have two sub-cases to consider. Either $\left(\omega_{2} \cdot \varphi_{2}\right) \triangleright \rho$ holds with $\rho \in \omega_{2}$. Then
$\rho \in\left\{\hat{\rho} \in \omega_{2} \mid \varepsilon_{1} \triangleright \hat{\rho}\right\} \subseteq \omega$, so again we get $(\omega \cdot \varphi) \triangleright \rho$ using the second inference rule. Otherwise, $\left(\omega_{2} \cdot \varphi_{2}\right) \triangleright \rho$ holds with $\rho \notin \omega_{2}, \rho \notin \varphi_{2}$, and $\forall i$. $\left(\omega_{2} \cdot \varphi_{2}\right) \triangleright \rho . f_{i}$. We can thus apply the induction hypothesis on each $\left(\omega_{1} \cdot \varphi_{1}\right) \triangleright \rho . f_{i}$ and get $\forall i$. $(\omega \cdot \varphi) \triangleright \rho$. $f_{i}$. Moreover, $\rho \notin \omega$ and $\rho \notin \varphi$, so we get $(\omega \cdot \varphi) \triangleright \rho$ using the third inference rule.

Lemma 3. Effects form a bounded join-semilattice over $\sqcup$ and $\perp$.
Proof. Clearly, for any effect $\varepsilon, \varepsilon \sqcup \perp=\varepsilon$, so $\perp$ is the identity element.
The idempotency and commutativity of effects holds since the definition of the union effect is symmetric and for any effect $(\omega \cdot \varphi)$, by definition of $(\omega \cdot \varphi) \triangleright \rho$, we have $\omega=\{\rho \in \omega \mid(\omega \cdot \varphi) \triangleright \rho\}$.

Let us now prove the associativity of effects.

Lemma 4. Let $\ell$ be a location in $e^{\prime}$. Let $\pi$ be a path such that $\mu(\ell . \pi)$ is defined and for every proper prefix $\bar{\pi} \prec \pi$, $\Sigma(\ell) . \bar{\pi}$ is not in $\omega_{0}$. Then $\Sigma(\ell) . \pi \notin \varphi_{0}$ and $\mu^{\prime}(\ell . \pi)=\mu(\ell . \pi)$.

Proof. We proceed by induction on $\pi$. For $\pi=\epsilon$, we obtain $\Sigma(\ell) . \epsilon=\Sigma(\ell) \notin \varphi_{0}$. We also have $\mu^{\prime}(\ell . \epsilon)=\mu(\ell . \epsilon)=\ell$, since reduction rules do not remove locations from the store.

Let $\pi$ be a non-empty path $\pi^{\prime} f$ such that $\mu(\ell . \pi)$ is defined and for all $\bar{\pi} \prec \pi$, $\Sigma(\ell) . \bar{\pi} \notin \omega_{0}$. Since $\varepsilon_{0} \triangleright \Sigma(\ell)$ and no region on the path from $\Sigma(\ell)$ to $\Sigma(\ell) . \pi$ is in $\omega_{0}$, we obtain $\Sigma(\ell) . \pi \notin \varphi_{0}$. By induction hypothesis, $\mu^{\prime}\left(\ell . \pi^{\prime}\right)=\mu\left(\ell . \pi^{\prime}\right)$. Since nothing was written into the field $f$ of $\mu\left(\ell . \pi^{\prime}\right)$ during the reduction step (otherwise, $\Sigma\left(\mu\left(\ell \cdot \pi^{\prime}\right)\right)=\Sigma(\ell) \cdot \pi^{\prime}$ would appear either in $\omega_{0}$ or in $\varphi_{0}$ ), we conclude that $\mu^{\prime}(\ell . \pi)=\mu(\ell . \pi)$.
