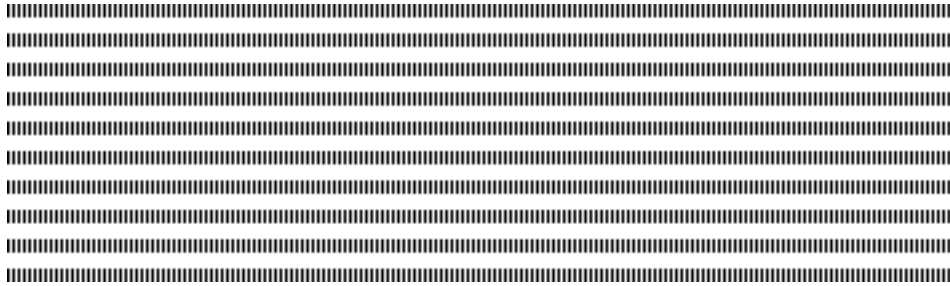

# A posteriori error estimates for non conforming approximation of quasi Stokes problem

**ABSTRACT.** We derive and analyze an a posteriori error estimator for nonconforming finite element approximation for the quasi-Stokes problem, which is based on the solution of local problem on stars with low cost computation, this indicator is equivalent to the energy error norm up to data oscillation, neither saturation assumption nor comparison with residual estimator are made.

**RÉSUMÉ.** Nous dérivons et analysons un estimateur d'erreur a posteriori pour les approximations par éléments finis non conformes du problème de quasi-Stokes, il est basé sur la résolution de problèmes locaux à faible coût de calcul. L'estimateur est équivalent à l'erreur en norme d'énergie augmentée d'oscillations des données, sans hypothèse de saturation ni de comparaison avec l'estimateur par résidu.

## 1. Introduction

The need for accurate solutions of large scale problems in computational fluid dynamics has made the use of adaptive, automatic re-meshing very attractive for nonconforming finite element approximations to solution of partial differential equation. A posteriori error estimate was introduced in order to provide an information about the local and global quality of the computed finite element solution. One of the most popular a posteriori error estimators is the hierarchical estimator introduced by Bank et al. in [8] for symmetric elliptic problems and generalized after by Achchab et al. in [2] and Hoppe et al. in [14] for conforming and nonconforming mixed finite elements. An abstract setting is developed in ([1, 4, 5, 6, 15]).

In this paper we developed and analyzed an error estimate for the quasi-Stokes problem which is based on the solution of a local quasi-Stokes problem in star, this estimate is shown to both a global upper and lower bound of the discretization error ([7],[8],[13],[15]).

The advantage of using the solution of the local problem on star is control error without influence on the regions near the singularity which introduces less degree of freedom and the optimality of cost calculation ([3],[9],[10],[15]).

We test this estimate on several classical problems and demonstrate its efficiency in grid adaptation. The quasi Stokes problem modeling the fluid flows, and flows in porous media.

## 2. Setting of the problem

We consider the quasi Stokes problem :

$$\left\{ \begin{array}{l} \text{Find } (u, p) \text{ such that} \\ -\Delta u + \sigma u + \nabla p = f \quad \text{in } \Omega, \\ \operatorname{div} u = 0 \quad \text{in } \Omega, \\ u = 0 \quad \text{on } \Gamma = \partial\Omega, \end{array} \right.$$

where  $f \in (L^2(\Omega))^d$ . We assume that  $\sigma \in L^\infty(\Omega)$  and  $\Omega \subset \mathbf{R}^d$ ,  $d = 2, 3$ , is a simply connected polygonal domain,  $u$  is the velocity,  $p$  is the pressure. Let  $(\mathcal{T}_h)_h$  be a family of conforming shape-regular triangulation of  $\Omega$  by d-simplex. We denote by  $E_I$  the set of interior edges (faces), and by  $E_f$  the set of all edges (faces) included in  $\Gamma$ .

We denote by  $\{x_i\}_{i \in \mathcal{N}}$  the set of all nodes of the triangulation  $\mathcal{T}_h$ . For each  $i \in \mathcal{N}$ ,  $\phi_i$  denotes the canonical continuous piecewise linear basis function associated to  $x_i$ . The star  $\omega_i$  is the interior relative to  $\Omega$  of the support of  $\phi_i$ , and  $h_i$  is the maximal size of the elements constituting  $\omega_i$ . Finally,  $\Gamma_i$  denotes the union of the sides touching  $x_i$  that are contained in  $\Omega$ , and  $\bar{\Gamma}_i$  the union of the sides touching  $x_i$  that are contained in  $\bar{\Omega}$ .

Let  $V_h(\Omega)$  be the lowest order non-conforming Crouzeix-Raviart finite element space defined by

$V_h(\Omega) = \{v_h \in L^2(\Omega); \forall T \in \mathcal{T}_h, v_h|_T \in P_1(T), \forall E \in E_I, \int_E [v_h]_E d\sigma = 0 \text{ and } \forall E \in E_f, \int_E v_h d\sigma = 0\}$ .

and

$$Q_h = \{q_h \in L_0^2(\Omega), q_h|_T \in P_0(T), \forall T \in \omega_i \text{ and } \omega_i \in \mathcal{T}_h\}.$$

where  $[\cdot]_E$  denotes the jump of the argument across  $E$ .

For each star  $\omega_i, i \in \mathcal{N}$ , if  $x_i$  is an interior node, we introduce the space defined by

$$V(\omega_i) = \{v \in (H_{loc}^1(\omega_i))^d : \int_{\omega_i} v \phi_i dx = 0 \text{ and } \int_{\omega_i} |\nabla v|^2 \phi_i < \infty\},$$

and if  $x_i$  is a boundary node, by

$$V(\omega_i) = \{v \in (H_{loc}^1(\omega_i))^d : v = 0 \text{ on } \partial\omega_i \cap \Gamma \text{ and } \int_{\omega_i} |\nabla v|^2 \phi_i < \infty\}.$$

There exists a constant  $C$ , only depending on the minimum angle of the triangulation but independent of the star being considered, such that (see Prop. 2.4 of [15]) :

$$\forall v \in V(\omega_i) ; \quad \|v\|_{0,\omega_i} \leq Ch_i \left( \int_{\omega_i} |\nabla v|^2 \phi_i dx \right)^{1/2}. \quad [1]$$

We define the finite dimensional local space  $\mathcal{P}_0^2(\omega_i)$  as follows,

**Definition 1** For  $i \in \mathcal{N}$ , let  $\mathcal{P}^2(\omega_i)$  denote the space of continuous piecewise quadratic functions on star  $\omega_i$  that vanish on  $\partial\omega_i$ . The spaces  $\mathcal{P}_0^2(\omega_i)$  are defined by  $\mathcal{P}_0^2(\omega_i) = \mathcal{P}^2(\omega_i) \cap V(\omega_i)$ .

We consider the approximate solution  $(u_h^{NC}, p_h) \in (V_h(\Omega))^d \times Q_h$  defined by:

$$\begin{cases} \forall v_h \in (V_h(\Omega))^d, \\ \sum_{T \in \mathcal{T}_h} \left\{ \int_T \nabla u_h^{NC} : \nabla v_h dx + \int_T \sigma u_h^{NC} \cdot v_h dx - \int_T p_h \operatorname{div} v_h dx \right\} = \int_\Omega f \cdot v_h dx, \\ \forall q_h \in Q_h, \quad \sum_{T \in \mathcal{T}_h} \int_T q_h \operatorname{div} u_h^{NC} dx = 0 \end{cases}$$

Note that the second equation means that for every  $T \in \mathcal{T}_h$ ,  $\operatorname{div}((u_h^{NC})|_T) = 0$ . Let  $v_h \in (V_h(\Omega))^d$  be fixed. We define  $\nabla_h v_h$  and  $\operatorname{div}_h v_h$  by:

$$\forall T \in \mathcal{T}_h; \quad \nabla_h v_h = \nabla v_h \text{ on } T.$$

and

$$\forall T \in \mathcal{T}_h; \quad \operatorname{div}_h v_h = \operatorname{div} v_h \text{ on } T.$$

For each  $i \in \mathcal{N}$ , we consider the local problems :

$$(SP_i) \left\{ \begin{array}{l} \text{Find } \eta_i \in (\mathcal{P}_0^2(\omega_i))^d, \text{ such that } \forall \mu_i \in (\mathcal{P}_0^2(\omega_i))^d, \\ \int_{\omega_i} (\nabla \eta_i : \nabla \mu_i) \phi_i dx = \int_{\omega_i} \nabla_h u_h^{NC} : \nabla(\mu_i \phi_i) dx + \int_{\omega_i} \sigma u_h^{NC} \cdot \mu_i \phi_i dx \\ \quad - \int_{\omega_i} p_h \operatorname{div}(\mu_i \phi_i) dx - \int_{\omega_i} (f \cdot \mu_i) \phi_i dx. \end{array} \right.$$

It is obvious that these local problems admit unique solutions.

We introduce for all  $i \in \mathcal{N}$  the three indicators,

$$\eta_{1,i}(u_h^{NC}, p_h) = \left( \sum_{T \in \omega_i} \|\operatorname{div} u_h^{NC} \phi_i^{\frac{1}{2}}\|_{0,\omega_i}^2 \right)^{\frac{1}{2}},$$

$$\eta_{2,i}(u_h^{NC}, p_h) = \left( \int_{\omega_i} |\nabla \eta_i|^2 \phi_i dx \right)^{\frac{1}{2}},$$

and

$$\eta_{3,i}^2(u_h^{NC}, p_h) = \sum_{E \in E_I} h^{-1} \|[u_h^{NC}]\|_{0,E}^2,$$

and set the problem data oscillation,

$$\operatorname{osc}(f) = \left( \sum_{i \in \mathcal{N}} h_i^2 \|(f - f_i) \phi_i^{\frac{1}{2}}\|_{0,\omega_i}^2 \right)^{\frac{1}{2}}.$$

where  $f_i = \frac{\int_{\omega_i} (f - \sigma u_h^{NC}) \phi_i dx}{\int_{\omega_i} \phi_i dx}$  for interior nodes  $i$ , and  $f_i = 0$  otherwise.

## 2.1. Upper bound

We consider first the upper bound of the error and we step the process to the main theorem by the following intermediate lemmas. The first lemma is an adaptation of arguments given in [15], and so the proof will be skipped.

**Lemma 2** *For interior nodes  $i \in \mathcal{N}$ , there exists an operator*

$$\Pi_i : (V(\omega_i))^d \longrightarrow (\mathcal{P}_0^2(\omega_i))^d,$$

*such that for any  $v \in V(\omega_i)$  the following conditions hold:*

$$1) \text{ For all edge(face) } E \subset \Gamma_i, \int_E (v - \Pi_i v) \phi_i d\gamma = 0.$$

$$2) \text{ Moreover, } \int_{\omega_i} (v - \Pi_i v) \phi_i dx = 0, \text{ if } x_i \text{ is an interior node.}$$

$$3) \left( \int_{\omega_i} |\nabla \Pi_i v|^2 \phi_i \right)^{\frac{1}{2}} \leq C \left( \int_{\omega_i} |\nabla v|^2 \phi_i \right)^{\frac{1}{2}}.$$

where  $C$  is a positive constant depending only on the minimum angle of  $\mathcal{T}_h$ .

**Lemma 3** *For interior nodes  $i \in \mathcal{N}$ , each  $v \in (V(\omega_i))^d$  and  $u_h^{NC} \in (V_h(\Omega))^d$ , we have*

$$\int_{\omega_i} \nabla_h u_h^{NC} : \nabla((\Pi_i v) \phi_i) dx = \int_{\omega_i} \nabla_h u_h^{NC} : \nabla(v \phi_i) dx.$$

**Proof.** If we denote by  $[\frac{\partial u_h^{NC}}{\partial n_E}] \in P_0(E)$  the jump of the normal derivative across  $E$ , we have by applying Green formula and subsequently using the property 1 of lemma 2,

$$\int_{\omega_i} \nabla_h u_h^{NC} : \nabla((\Pi_i v)\phi_i) dx = \sum_{E \subset \omega_i} \int_E [\frac{\partial u_h^{NC}}{\partial n_E}] (\Pi_i v)\phi_i d\gamma = \sum_{E \subset \omega_i} \int_E [\frac{\partial u_h^{NC}}{\partial n_E}] v \phi_i d\gamma.$$

Applying again Green formula yields the result. We give the following lemmas [9]

**Lemma 4** *There exists a linear operator  $I: (V_h(\Omega))^d \rightarrow (V_h(\Omega))^d \cap (H_0^1(\Omega))^d$ , satisfying the following estimate.*

$$\begin{aligned} \forall u_h^{NC} \in V_h(\Omega), \forall \omega_i \in \mathcal{T}_h, k = 0, 1, \\ \|u_h^{NC} - Iu_h^{NC}\|_{k, \omega_i} \leq C \sum_{\substack{E \in E_I \\ \overline{E} \cap \omega_i \neq \emptyset}} h_E^{\frac{1}{2}-k} \| [u_h^{NC}]_E \|_{0, E}. \end{aligned}$$

where  $h_E$  is the diameter of face (edge)  $E$ .

We have also, the following result:

**Lemma 5** *For each node  $i \in \mathcal{N}$ , there exists a linear operator*

$$\Pi_i : (H_0^1(\Omega))^d \rightarrow (V_h(\Omega))^d,$$

such that for any  $v \in (H_0^1(\Omega))^d(\Omega)$  and  $\forall T \in \omega_i \in \mathcal{T}_h$  the following assumptions hold:

- 1) For all edge  $E \subset \Gamma_i$ ,  $\int_E (v - \Pi_i v)\phi_i d\sigma = 0$ , and
- 2) For all edge  $s_h \in (P_0(T))^{d \times d}$ ,  $\int_{\omega_i} s_h \cdot \nabla (v - \Pi_i v)\phi_i dx = 0$
- 3) For all edge  $q_h \in P_0(T)$ ,  $\int_{\omega_i} q_h \operatorname{div}(v - \Pi_i v)\phi_i dx = 0$ .

The following theorem gives the star-based a posteriori error estimate for the nonconforming finite element approximation of quasi Stokes problem solution.

**Theorem 6** *There exists a positive constant  $C$  depending on the minimum angle of the triangulation such that:*

$$\left( \sum_{i \in \mathcal{N}} \|u - u_h^{NC}\|_{1, \omega_i}^2 \right)^{\frac{1}{2}} + \|p - p_h\|_{0, \Omega} \leq C \left\{ \left[ \left( \sum_{i \in \mathcal{N}} \eta_{1,i}^2 + \eta_{2,i}^2 \right) + \eta_3^2 \right]^{\frac{1}{2}} + \operatorname{osc}(f) \right\}.$$

where, for more readability, we have skipped the arguments of  $\eta_{1,i}$ ,  $\eta_{2,i}$  and  $\eta_3$ , and so will be done in the sequel.

**Proof** Since  $(Iu_h^{NC}, p_h) \in (H_0^1(\Omega))^d \times L_0^2(\Omega)$ , by standard finite element analysis arguments we state

$$\begin{aligned} & \left( \sum_{i \in \mathcal{N}} \|u - Iu_h^{NC}\|_{1,\omega_i}^2 \right)^{\frac{1}{2}} + \|p - p_h\|_{0,\Omega} \\ & \leq C \sup_{\substack{(v,q) \in (H_0^1(\Omega))^d \\ \times L_0^2(\Omega)}} \frac{|a((u,p);(v,q)) - a((Iu_h^{NC},p_h);(v,q))|}{|v|_{1,\Omega} + \|q\|_{0,\Omega}}, \end{aligned}$$

where  $a(\cdot; \cdot)$  is defined by

$$\begin{aligned} & \forall (u,p), (v,q) \in (H_0^1(\Omega))^d \times (L_0^2(\Omega))^d, \\ & a((u,p);(v,q)) = \int_{\Omega} \nabla u \cdot \nabla v dx + \int_{\Omega} \sigma uv dx - \int_{\Omega} p \operatorname{div} v dx + \int_{\Omega} q \operatorname{div} u dx. \end{aligned}$$

Then

$$\begin{aligned} a((u,p);(v,q)) - a((Iu_h^{NC},p_h);(v,q)) &= \int_{\Omega} (\nabla u - \nabla Iu_h^{NC}) : \nabla v dx + \int_{\Omega} \sigma (u - Iu_h^{NC}) v dx \\ &\quad - \int_{\Omega} (p - p_h) \operatorname{div} v dx + \int_{\Omega} q \operatorname{div} (u - Iu_h^{NC}) dx. \end{aligned}$$

On one hand, since  $\operatorname{div} u = 0$  on  $\Omega$ ,  $\sum_{i \in \mathcal{N}} \phi_i = 1$  and  $\phi_i$  being bounded we have

$$\left| \int_{\Omega} q \operatorname{div} (u - Iu_h^{NC}) dx \right| \leq C \sum_{\omega_i \in \mathcal{T}_h} \|q\|_{0,\omega_i} \|\operatorname{div} Iu_h^{NC} \phi_i^{\frac{1}{2}}\|_{0,\omega_i}.$$

By virtue of Lemma 4 with  $k = 1$  we have

$$\begin{aligned} \forall \omega_i \in \mathcal{T}_h, \|\operatorname{div} Iu_h^{NC} \phi_i^{\frac{1}{2}}\|_{0,\omega_i} &\leq \|\operatorname{div} u_h^{NC} \phi_i^{\frac{1}{2}}\|_{0,\omega_i} + \|(\operatorname{div} u_h^{NC} - \operatorname{div} Iu_h^{NC}) \phi_i^{\frac{1}{2}}\|_{0,\omega_i}, \\ &\leq \|\operatorname{div} u_h^{NC} \phi_i^{\frac{1}{2}}\|_{0,\omega_i} + C \sum_{E \in E_I} h^{-\frac{1}{2}} \|[u_h^{NC}]_E\|_{0,E}. \end{aligned}$$

Summing up the contributions, using given indicators definitions and the inequality

$$\sum_i \alpha_i \beta_i \leq \left( \sum_i \alpha_i^2 \right)^{\frac{1}{2}} \left( \sum_i \beta_i^2 \right)^{\frac{1}{2}},$$

we get

$$\left| \int_{\Omega} q \operatorname{div} (u - Iu_h^{NC}) dx \right| \leq C \left( \sum_{i \in \mathcal{N}} \|q\|_{0,\omega_i} \right) \left( \sum_{i \in \mathcal{N}} \eta_{1,i}^2 + \eta_3^2 \right)^{\frac{1}{2}}.$$

On the other hand, let  $v$  be an element of  $(H_0^1(\Omega))^d$  and set  $\tilde{v} := \sum_{i \in \mathcal{N}} v_i \phi_i$ , where

$$v_i = \frac{\int_{\omega_i} v \phi_i dx}{\int_{\omega_i} \phi_i dx} \text{ for interior nodes and } 0 \text{ otherwise.}$$

$$\begin{aligned}
A &= \int_{\Omega} (\nabla u - \nabla Iu_h^{NC}) : \nabla v dx + \int_{\Omega} \sigma(u - Iu_h^{NC}) v dx - \int_{\Omega} (p - p_h) \operatorname{div} v dx \\
&= \sum_{\omega_i \in \mathcal{T}_h} \int_{\omega_i} (\nabla u - \nabla u_h^{NC}) : \nabla v dx + \int_{\omega_i} (\nabla u_h^{NC} - \nabla Iu_h^{NC}) : \nabla v dx \\
&\quad + \int_{\Omega} \sigma(u - u_h^{NC}) v dx - \int_{\omega_i} (p - p_h) \operatorname{div} v dx + \int_{\Omega} \sigma(u_h^{NC} - Iu_h^{NC}) v dx, \\
&= - \sum_{\omega_i \in \mathcal{T}_h} \int_{\omega_i} (\nabla u_h^{NC}) : \nabla v dx - \int_{\omega_i} \sigma u_h^{NC} v dx + \int_{\omega_i} p_h \operatorname{div} v dx + \int_{\omega_i} f v dx \\
&\quad + \sum_{\omega_i \in \mathcal{T}_h} \int_{\omega_i} (\nabla u_h^{NC} - \nabla Iu_h^{NC}) : \nabla v dx + \int_{\Omega} \sigma(u_h^{NC} - Iu_h^{NC}) v dx.
\end{aligned}$$

Knowing that  $\tilde{v} \in (V_h(\Omega))^d \cap (H_0^1(\Omega))^d$ ,

$$\begin{aligned}
A &= - \sum_{\omega_i \in \mathcal{T}_h} \int_{\omega_i} (\nabla u_h^{NC}) : \nabla (v - \tilde{v}) dx - \int_{\omega_i} \sigma u_h^{NC} (v - \tilde{v}) dx \\
&\quad + \int_{\omega_i} p_h \operatorname{div} (v - \tilde{v}) dx + \int_{\omega_i} f (v - \tilde{v}) dx \\
&\quad + \sum_{\omega_i \in \mathcal{T}_h} \int_{\omega_i} (\nabla u_h^{NC} - \nabla Iu_h^{NC}) : \nabla v dx + \int_{\Omega} \sigma (u_h^{NC} - Iu_h^{NC}) (v - \tilde{v}) dx.
\end{aligned}$$

Stating that  $v - \tilde{v} = \sum_{i \in \mathcal{N}} (v - v_i) \phi_i$ , and using  $\sum_{i \in \mathcal{N}} \phi_i = 1$ .

Since  $(v - v_i) \in (V(\omega_i))^d$ , adding and removing same quantities in the two last terms and use item 2 of Lemma 5 we obtain

$$\begin{aligned}
A &= - \sum_{\omega_i \in \mathcal{T}_h} \int_{\omega_i} (\nabla u_h^{NC}) : \nabla \Pi(v - v_i) \phi_i dx - \int_{\omega_i} \sigma u_h^{NC} \Pi(v - v_i) \phi_i dx \\
&\quad + \int_{\omega_i} p_h \operatorname{div} \Pi(v - v_i) \phi_i dx + \int_{\omega_i} f \Pi(v - v_i) \phi_i dx \\
&\quad - \int_{\omega_i} \sigma u_h^{NC} (v - v_i - \Pi(v - v_i)) \phi_i dx + \int_{\omega_i} p_h \operatorname{div} (v - v_i - \Pi(v - v_i)) \phi_i dx \\
&\quad + \sum_{\omega_i \in \mathcal{T}_h} \int_{\omega_i} (\nabla u_h^{NC} - \nabla Iu_h^{NC}) : \nabla v dx + \int_{\omega_i} f (v - v_i - \Pi(v - v_i)) \phi_i dx.
\end{aligned}$$

Finally, using the definition of local problems  $(SP_i)$ ,

$$\begin{aligned}
A &= - \sum_{\omega_i \in \mathcal{T}_h} \int_{\omega_i} (\nabla \eta_i) : \nabla (v - v_i) \phi_i dx - \int_{\omega_i} \sigma u_h^{NC} (v - v_i - \Pi(v - v_i)) \phi_i dx \\
&\quad + \int_{\omega_i} p_h \operatorname{div} (v - v_i - \Pi(v - v_i)) \phi_i dx \\
&\quad + \sum_{\omega_i \in \mathcal{T}_h} \int_{\omega_i} (\nabla u_h^{NC} - \nabla Iu_h^{NC}) : \nabla v dx + \int_{\omega_i} f (v - v_i - \Pi(v - v_i)) \phi_i dx.
\end{aligned}$$



We now process successively with each term of the right-hand side. On one hand, using Cauchy-Schwarz and item 2 of Lemma 2 we have

$$\begin{aligned} \sum_{i \in \mathcal{N}} \left[ \int_{\omega_i} \nabla \eta_i : \nabla \Pi_i(v - v_i) \phi_i dx \right] &\leq \left( \sum_{i \in \mathcal{N}} \int_{\omega_i} |\nabla \eta_i|^2 \phi_i dx \right)^{\frac{1}{2}} \left( \sum_{i \in \mathcal{N}} \int_{\omega_i} |\nabla \Pi_i(v - v_i)|^2 \phi_i dx \right)^{\frac{1}{2}}, \\ &\leq C \left( \sum_{i \in \mathcal{N}} \eta_{2,i}^2(u_h^{NC}, p_h) \right)^{\frac{1}{2}} \left( \sum_{i \in \mathcal{N}} \int_{\omega_i} |\nabla(v - v_i)|^2 \phi_i dx \right)^{\frac{1}{2}}, \\ &\leq C \left( \sum_{i \in \mathcal{N}} \eta_{2,i}^2(u_h^{NC}, p_h) \right)^{\frac{1}{2}} \|v\|_{1,\Omega}, \end{aligned}$$

on the other hand, since both of  $(v - v_i)$  and  $\Pi_i(v - v_i)$  belong to  $V(\omega_i)$ , using definition of  $V(\omega_i)$  and coefficients  $f_i$  give

$$\int_{\omega_i} (f - \sigma u_h^{NC})(v - v_i - \Pi_i(v - v_i)) \phi_i dx = \int_{\omega_i} (f - f_i - \sigma u_h^{NC})(v - v_i - \Pi_i(v - v_i)) \phi_i dx,$$

for any constant  $f_i \in \mathbf{R}$  for all interior nodes. Defining  $f_i = 0$  for boundary nodes, we have

$$\begin{aligned} \int_{\omega_i} (f - \sigma u_h^{NC})(v - v_i - \Pi_i(v - v_i)) \phi_i dx &\leq \|(f - f_i)(\phi_i)^{\frac{1}{2}}\|_{0,\omega_i} \left( \|(v - v_i)(\phi_i)^{\frac{1}{2}}\|_{0,\omega_i} \right. \\ &\quad \left. + \|(\Pi_i(v - v_i))(\phi_i)^{\frac{1}{2}}\|_{0,\omega_i} \right), \end{aligned}$$

for every nodes. Using Cauchy-Schwarz then the inequality (1) and once more  $\sum_{i \in \mathcal{N}} \phi_i = 1$  we get

$$\begin{aligned} &\sum_{i \in \mathcal{N}} \left[ \int_{\omega_i} (f - \sigma u_h^{NC})(v - v_i - \Pi_i(v - v_i)) \phi_i dx \right] \\ &\leq C \left( \sum_{i \in \mathcal{N}} \|h_i(f - f_i)(\phi_i)^{\frac{1}{2}}\|^2 \right)^{\frac{1}{2}} \left( \sum_{i \in \mathcal{N}} h_i^{-2} \left( \|(v - v_i)(\phi_i)^{\frac{1}{2}}\|_{0,\omega_i} \right. \right. \\ &\quad \left. \left. + \|(\Pi_i(v - v_i))(\phi_i)^{\frac{1}{2}}\|_{0,\omega_i} \right) \right), \\ &\leq C \operatorname{osc}(f) \|v\|_{1,\Omega}, \end{aligned}$$

where  $C$  is a generic constant only depending on the minimum angle of triangulation.

Using successively item 3. of Lemma 5 and Lemma 4 with  $k = 1$  we get

$$A \leq \left\{ \left( \sum_{i \in \mathcal{N}} \eta_{2,i}^2 + \eta_3^2 \right)^{\frac{1}{2}} + \operatorname{osc}(f) \right\} |v|_{1,\Omega}.$$

Summing up the contributions gives,

$$\begin{aligned} &|a((u, p); (v, q)) - a((Iu_h^{NC}, p_h); (v, q))| \\ &\leq \left( \sum_{i \in \mathcal{N}} \|q\|_{0,\omega_i} \right) \left( \sum_{i \in \mathcal{N}} \eta_{1,i}^2 + \eta_3^2 \right)^{\frac{1}{2}} + \left\{ \eta_{2,i}^2 + \eta_3^2 \right\}^{\frac{1}{2}} + \operatorname{osc}(f) \right\} |v|_{1,\Omega}, \end{aligned}$$

which finally gives us:

$$\begin{aligned} \sum_{i \in \mathcal{N}} \|u - u_h^{NC}\|_{1, \omega_i}^2 &\leq \sum_{i \in \mathcal{N}} \|u - Iu_h^{NC}\|_{1, \omega_i}^2 + \sum_{i \in \mathcal{N}} \|u_h^{NC} - Iu_h^{NC}\|_{1, \omega_i}^2 \\ &\leq C\eta_3^2 + \sum_{i \in \mathcal{N}} \|u - Iu_h^{NC}\|_{1, \omega_i}^2. \end{aligned}$$

and yields the result.

## 2.2. Efficiency of the estimator

This section is devoted to the estimator efficiency. Hence, we first need the following theorem:

**Theorem 7** *There exists a positive constant  $C$  depending on the minimum angle of the triangulation such that :  $\forall \omega_i \in \mathcal{T}_h$ , we have*

$$\| \operatorname{div} u_h^{NC} \|_{0, \omega_i} \leq C \|u - u_h^{NC}\|_{1, \omega_i}, \quad [2]$$

$$\eta_2 \leq C \|u - u_h^{NC}\|_{1, \omega_i} + \|p - p_h\|_{0, \omega_i}, \quad [3]$$

and

$$\eta_3 \leq C \|u - u_h^{NC}\|_{1, \omega_i}. \quad [4]$$

**Proof.** It is clear that:

$$\| \operatorname{div} u_h^{NC} \phi_i^{\frac{1}{2}} \|_{0, \omega_i} \leq C \|u - u_h^{NC}\|_{1, \omega_i}.$$

For each  $i \in \mathcal{N}$ , by definition of  $\eta_{2,i}(u_h^{NC})$  and taking test function  $\mu_i = \eta_i$  in local problem  $(SP_i)$  give

$$\begin{aligned} \eta_{2,i}^2(u_h^{NC}, p_h) &= \int_{\omega_i} (|\nabla \eta_i|^2 \phi_i dx), \\ &= \int_{\omega_i} \nabla u_h^{NC} : \nabla (\eta_i \phi_i) dx + \int_{\omega_i} (\sigma u_h^{NC} \eta_i) \cdot \phi_i dx - \int_{\omega_i} (p_h \operatorname{div}(\eta_i \phi_i)) dx - \int_{\omega_i} f \eta_i \phi_i dx. \end{aligned}$$

Since  $(\eta_i \phi_i) \in (H_0^1(\Omega))^d$ , we can state

$$\begin{aligned} \eta_{2,i}^2(u_h^{NC}, p_h) &= \int_{\omega_i} (\nabla u_h^{NC} - \nabla u) : \nabla (\eta_i \phi_i) dx + \int_{\Omega} \sigma (u_h^{NC} - u) \cdot \eta_i \phi_i dx - \int_{\omega_i} (p_h - p) \operatorname{div}(\eta_i \phi_i) dx, \\ &= \int_{\omega_i} (\nabla u_h^{NC} - \nabla u) : \nabla (\eta_i \phi_i) dx + \int_{\omega_i} (\nabla u_h^{NC} - \nabla u) \cdot \eta_i \cdot \nabla (\phi_i) dx \\ &\quad + \int_{\Omega} \sigma (u_h^{NC} - u) \eta_i \phi_i dx - \int_{\omega_i} (p_h - p) \operatorname{div}(\eta_i \phi_i) dx. \end{aligned}$$

Applying Cauchy-Schwarz inequality gives

$$\begin{aligned} \eta_{2,i}^2(u_h^{NC}, p_h) &\leq \|u - u_h^{NC}\|_{1, \omega_i} \eta_{2,i}(u_h^{NC}, p_h) + \|u - u_h^{NC}\|_{1, \omega_i} \|\eta_i\|_{0, \omega_i} \|\phi\|_{W^{1, \infty}(\omega_i)} \\ &\quad + \|\sigma\|_{0, \infty} \|u - u_h^{NC}\|_{0, \omega_i} \|\eta_i\|_{L^\infty(\omega_i)} + \|p - p_h\|_{0, \omega_i} \eta_{2,i}(u_h^{NC}, p_h), [5] \end{aligned}$$

where  $\phi$  is bounded in  $\omega_i$ . Now since  $\eta_i \in V(\omega_i)$ , using (1), we have

$$\|\eta_i\|_{0,\omega_i} \leq C h_i \eta_{(2,i)}(u_h^{NC}, p_h).$$

Finally using the property  $|\phi_i|_{W^{1,\infty}(\omega_i)} \leq \frac{C}{h_i}$ , we get

$$\eta_{2,i}(u_h^{NC}, p_h) \leq C(1 + \|\sigma\|_{L^\infty(\omega_i)} h_i) \|u - u_h^{NC}\|_{1,\omega_i} + \|p - p_h\|_{0,\omega_i}.$$

We refer for a proof of third estimate to [9], which concludes the proof.

### 3. Mesh adaption procedure and Numerical results.

For the numerical illustration of the efficiency of the error estimator and the based adaption process, we consider tree examples for different singularity geometry.

#### 3.1. Example 1.

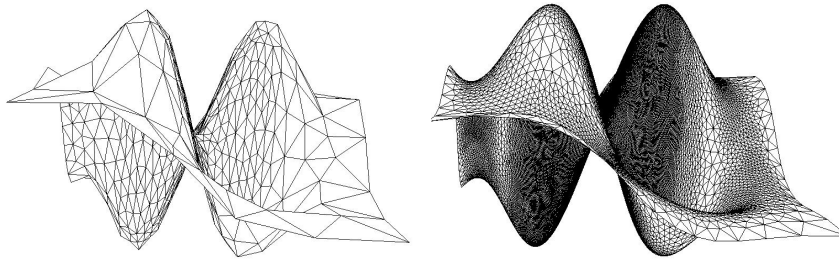
**Figure 1.** *Adaptively refined mesh after 1 (top left), 3 (top right), 6 (bottom left), and 9 (bottom right) refinement steps.*

In this example, we consider a simple problem with a homogeneous data on the computational domain  $[0, 1]^2$ , as shown in figure 1, with the source term  $f$  given by the exact solution  $u = [u_1, u_2]$  and the pressure  $p$ .

$$u_1 = 250000x^4y^3(1-y)^5(4(1-5y+9y^2-7y^3+2y^4)-5y+24y^2-42y^3+32y^4-9y^5)+0.3x$$

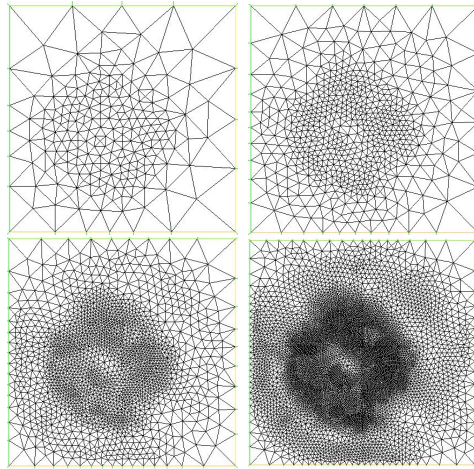
$$u_2 = 250000y^4x^3(1-x)^5(4(1-5x+9x^2-7x^3+2x^4)-5x+24x^2-42x^3+32x^4-9x^5)+0.3y$$

$$p_1 = 2510^4y^4x^3(1-y)^5(4-20x+36x^2-28x^3+8x^4-5x+24x^2-42x^3+32x^4-9x^5)$$

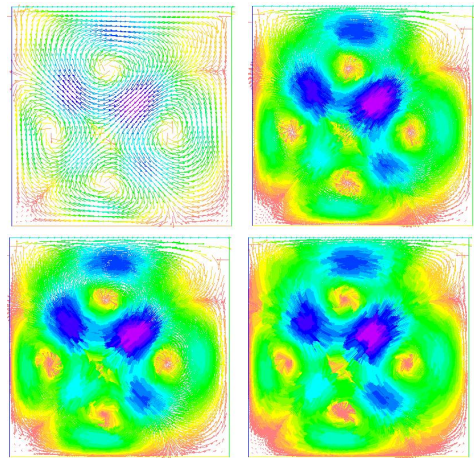
$$p_2 = (4(1-5y+9y^2-7y^3+2y^4)-5y+24y^2-42y^3+32y^4-9y^5)$$

$$p = p_1p_2$$

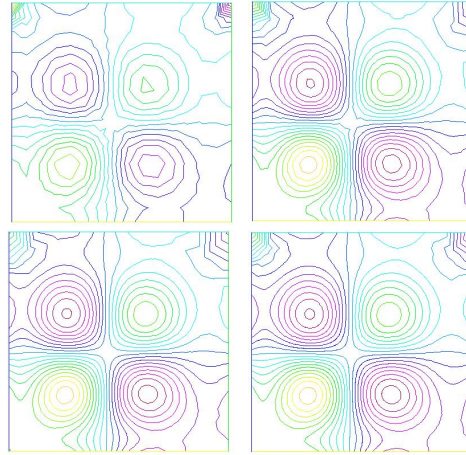

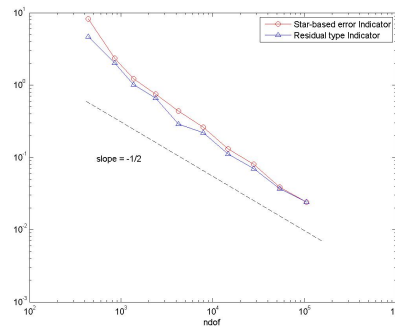
**Figure 2.** *The Velocity distribution corresponds to the meshes shown in figure 1.*

We perform nonconforming finite element discretization on it, and we report on Figures 1, 2, 3 and 4 a sequence of adapted meshes using the proposed refinement indicators and corresponding computed velocity and pressure respectively.

**Figure 4.** approximate pressure. On the left, the first iteration with 467 DOF, on the right the last iteration with 5667 DOF.

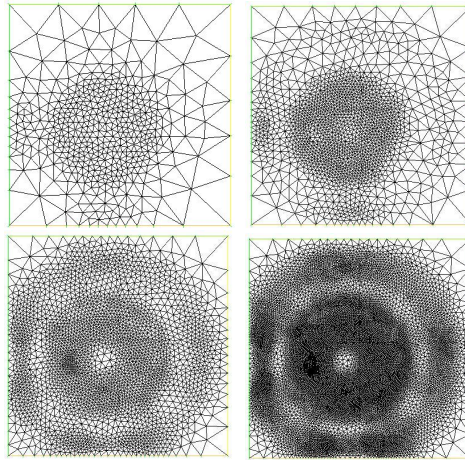


**Figure 5.** Evolution of residual error indicator and star-based error indicator for quasi-Stokes example.

In figure 5, we have included the error indicator behavior against the number of degree of freedom. Let us remark that the error decreases in energy norm as the number of DOF increases, compared with a slope  $-\frac{1}{2}$ .

**A comparison with residual type estimator:**

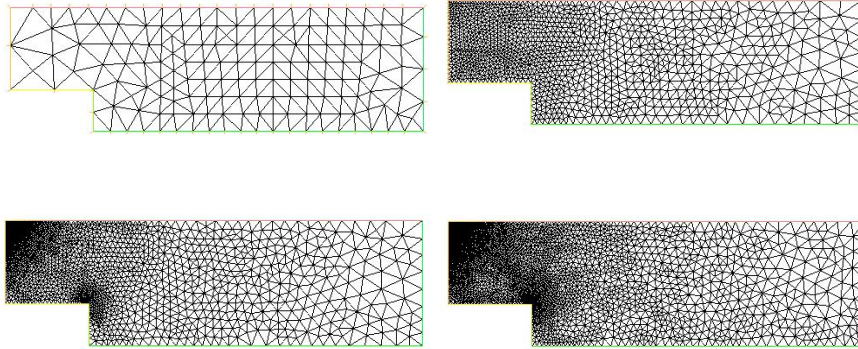

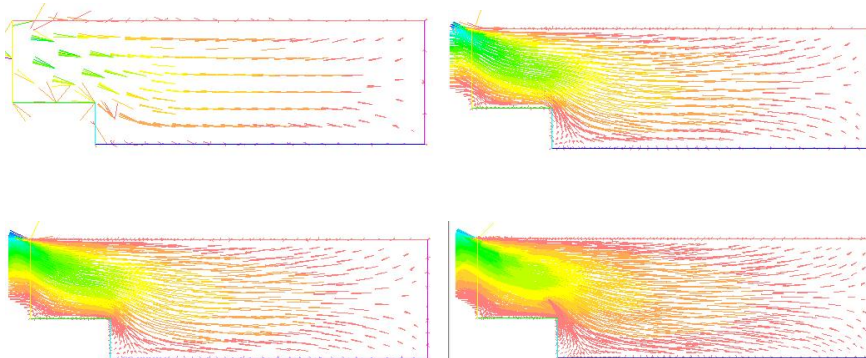
**Figure 6.** *Adaptively refined mesh after 1 (top left), 3 (top right), 6 (bottom left), and 9 (bottom right) refinement steps.*

The new estimator is compared now with the residual type estimator [16]. We will take the same quasi-Stokes example as above. Successive iterations of adapted mesh are represented in Figure 6 for the residual type estimator, and Figure 5 gives comparison of asymptotic decays of the two estimators versus the number of degrees of freedom (ndof). We observe analogous behavior of the two estimators for this example.

**3.2. Example 2, Backward facing Step.**

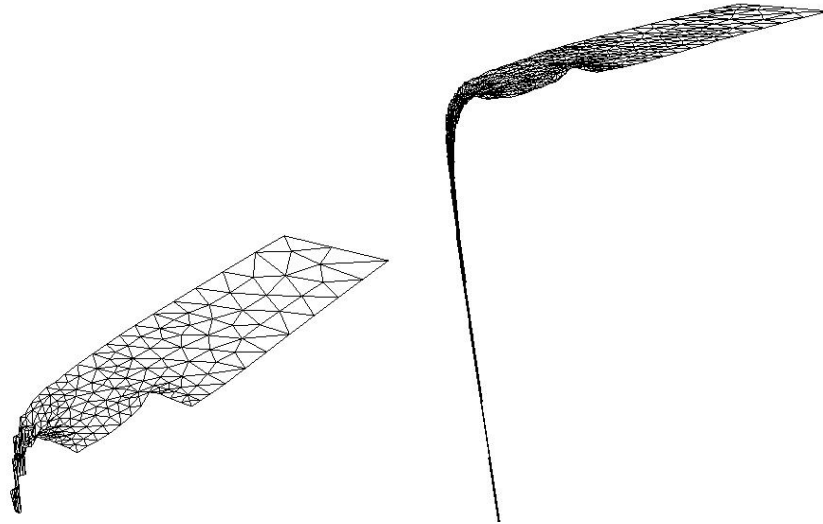

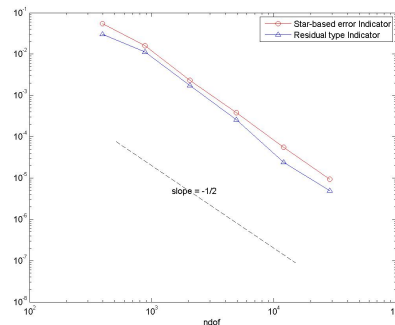
**Figure 7.** Adaptively refined mesh after 1 (top left), 3 (top right), 6 (bottom left), and 9 (bottom right) refinement steps.

In this example, we consider the Backward facing Step. Here, the spikes in the pressure are noted due to a discontinuity in the boundary conditions, but to a discontinuity in the geometry of the boundary. The figures 7, 8 and 9 show the adaptive meshes, corresponding velocity and pressure elevation [10].

The initial grid is uniformly refined, 4 levels of refinement, or adaptively refined based on the error estimate computed from the solution. In the last case triangles were added near the re-entrant corner to resolve the discontinuity, profiles of the velocity field are very similar this time but the drop in pressure is better represented with the adaptive strategy done near the boundary.

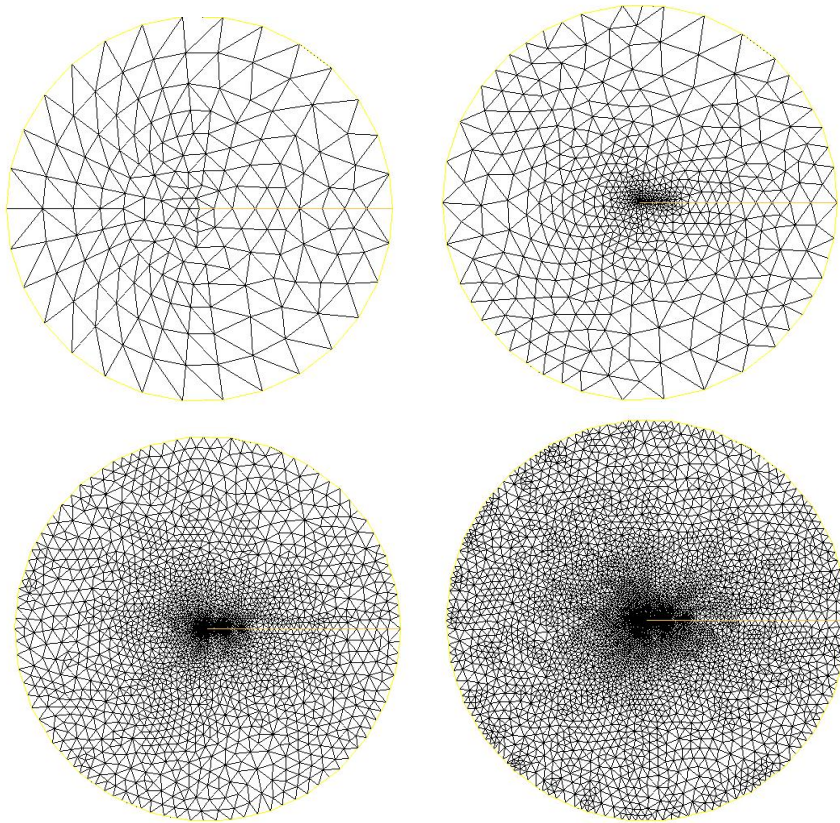
In figure 10, we have included the error indicator behavior against to the number of degree of freedom, compared with a slope  $-\frac{1}{2}$ , and gives a comparison with the residual type estimators.



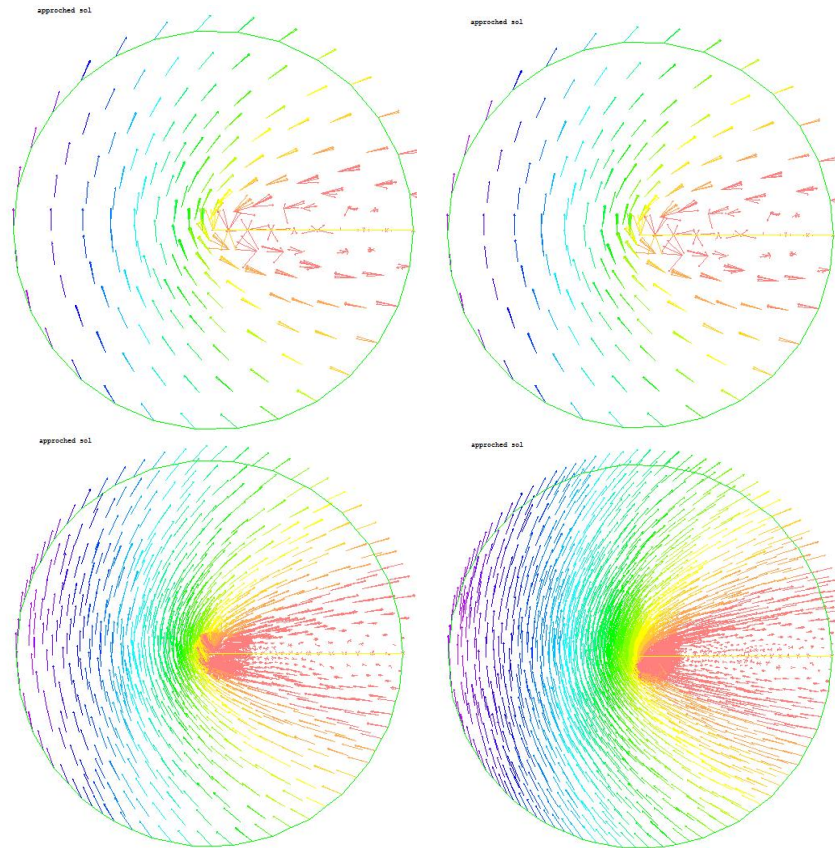
### 3.3. Example 3: Disk with a Crack.

Finally, we test our error estimate on a quasi Stokes flow in a disk of radius 1 with a crack joining the center to the boundary [10].

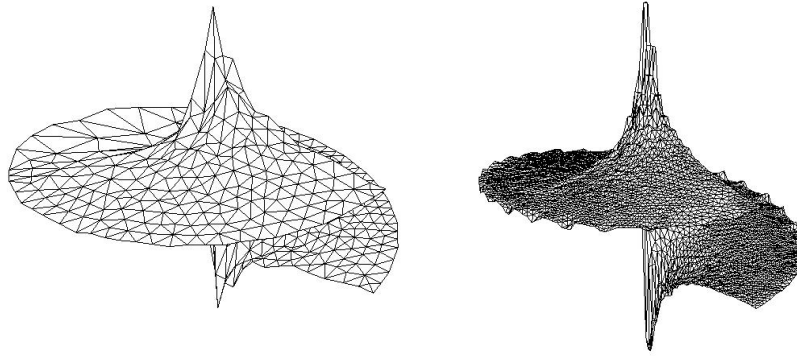
- The right-hand side  $f$  is 0 .
- The boundary conditions are  $u^t = \frac{3}{2}(\cos \frac{\theta}{2} - \cos \frac{3\theta}{2}, 3 \sin \frac{\theta}{2} - \sin \frac{3\theta}{2})$ .
- $(r, \theta)$  is a polar representation of a point in the disk.
- The exact solution is:  
 $u^t = \frac{3}{2}\sqrt{r}(\cos \frac{\theta}{2} - \cos \frac{3\theta}{2}, 3 \sin \frac{\theta}{2} - \sin \frac{3\theta}{2})$ , and  $p = \frac{6}{\sqrt{r}} \cos \frac{\theta}{2}$ .



**Figure 11.** Adaptively refined mesh after 1 (top left), 3 (top right), 6 (bottom left), and 9 (bottom right) refinement steps.

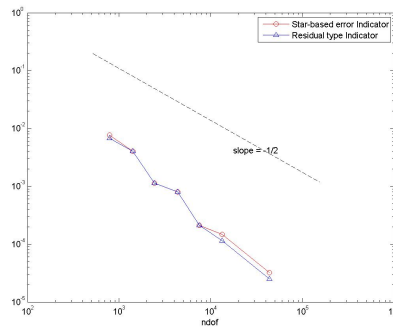


**Figure 12.** *The velocity distribution corresponds to the meshes shown in figure .*

The solution was computed on each grid, along with error estimates, during the refinement process, (Figures 11, 12, 13 and 14), these estimates were computed using an interpolation scheme for the values at the new nodes, consequently their accuracy deteriorates along with the number of refinement steps. However, we used intermediate recalculations based on the computation of the estimates, we would have a mesh with more levels of refinement around the singularity (hence giving higher level for the pressure). In that regard, the use of interpolated values instead of computed solution values had a grid smoothing effect, and the figure 14 gives a comparison with the residual type estimators.

## 4. Conclusion

In this work, we have presented a posteriori error analysis for a nonconforming finite element method to approximate the quasi Stokes problem. The a posteriori error analysis of this scheme give the global upper bound and local lower bound. The perspec-

tive of this work is to adapt this technique to the Navier Stokes problem and the evolution Stokes problem.
