# Supplemental Material for: <br> A Semi-Implicit Material Point Method for the Continuum Simulation of Granular Materials

## 1 Energy considerations

We can decompose the total energy of the system as the sum of its potential and kinetic energies, i.e., $E_{t}=E_{p}+E_{c}$, with

$$
\begin{aligned}
E_{p} & :=-\int_{\Omega} \rho \phi(\mathbf{x} \cdot \boldsymbol{g}) \\
E_{c} & :=\int_{\Omega} \frac{1}{2} \rho \phi(\mathbf{u} \cdot \mathbf{u}) .
\end{aligned}
$$

Since we are using homogeneous Dirichlet boundary conditions, their evolution follows

$$
\begin{aligned}
\frac{d E_{p}}{d t} & =-\rho \int_{\Omega} \frac{\partial \phi}{\partial t}(\mathbf{x} \cdot \boldsymbol{g})=\rho \int_{\Omega} \nabla \cdot[\phi \mathbf{u}](\mathbf{x} \cdot \boldsymbol{g}) \\
& =-\rho \int_{\Omega} \phi(\mathbf{u} \cdot \mathbf{g})+\rho \underbrace{\int_{\partial \Omega} \phi\left(\mathbf{u} \cdot \boldsymbol{n}_{\Omega}\right)(\boldsymbol{x} \cdot \mathbf{g})}_{=0}
\end{aligned}
$$

and

$$
\begin{aligned}
\frac{d E_{c}}{d t}= & \int_{\Omega} \rho \phi\left(\frac{D \mathbf{u}}{D t} \cdot \mathbf{u}\right) \\
= & \int_{\Omega} \eta(\nabla \cdot[\phi \dot{\varepsilon}] \cdot \mathbf{u})-(\nabla \cdot[\phi \boldsymbol{\lambda}] \cdot \mathbf{u})+\rho \phi(\boldsymbol{g} \cdot \mathbf{u}) \\
= & \rho \int_{\Omega} \phi(\mathbf{u} \cdot \mathbf{g})-\eta \underbrace{\int_{\Omega} \phi \dot{\varepsilon}: \dot{\varepsilon}}_{\geq 0}+\int_{\Omega} \phi \boldsymbol{\lambda}: \dot{\varepsilon} \\
& +\underbrace{\int_{\partial \Omega} \phi\left(\mathbf{u} \cdot(\eta \dot{\varepsilon}-\boldsymbol{\lambda}) \boldsymbol{n}_{\Omega}\right)}_{=0}
\end{aligned}
$$

Therefore $\frac{d E_{t}}{d t} \leq \int_{\Omega} \phi \boldsymbol{\lambda}: \dot{\boldsymbol{\varepsilon}}$. For the system to be dissipative, it suffices that $(\boldsymbol{\lambda} ; \boldsymbol{\gamma}) \in \mathcal{D} \mathcal{P}(\hat{\mu}) \Longrightarrow \phi \boldsymbol{\lambda}: \dot{\boldsymbol{\varepsilon}} \leq 0$, which can be easily verified.

Indeed, let $(\boldsymbol{\lambda} ; \gamma) \in \mathcal{D} \mathcal{P}(\hat{\mu})$, we will show that

$$
\left\{\begin{aligned}
\operatorname{Dev} \boldsymbol{\lambda}: \operatorname{Dev}(\phi \dot{\varepsilon}) & \leq 0 \\
\operatorname{Tr} \boldsymbol{\lambda} \operatorname{Tr}(\phi \dot{\varepsilon}) & \leq 0
\end{aligned}\right.
$$

Since $\operatorname{Dev}(\phi \dot{\varepsilon})=\operatorname{Dev} \gamma$, (a) is trivial; either $\operatorname{Dev}(\phi \dot{\varepsilon})=0$, or $\operatorname{Dev}(\phi \dot{\boldsymbol{\varepsilon}}) \neq 0$ and $\operatorname{Dev} \boldsymbol{\lambda}=-\left(\mu \frac{\operatorname{Tr} \boldsymbol{\lambda}}{\sqrt{6}}\right) \frac{\operatorname{Dev} \boldsymbol{\gamma}}{|\operatorname{Dev} \boldsymbol{\gamma}|}$ with $\operatorname{Tr} \boldsymbol{\lambda} \geq 0$.
Now, for (a), the complementarity condition implies either $\operatorname{Tr} \boldsymbol{\lambda}=$ 0 , or ${ }^{‘} \operatorname{Tr} \boldsymbol{\lambda}>0$ and $\operatorname{Tr} \gamma=0$. Since $\beta \geq 0$, $\operatorname{Tr}(\phi \dot{\boldsymbol{\varepsilon}}) \leq 0$, and $\operatorname{Tr} \boldsymbol{\lambda} \operatorname{Tr}(\phi \dot{\boldsymbol{\varepsilon}}) \leq 0$.

## 2 Derivation of variational formulation

Multiplying both sides of the definition of $\gamma$ from Equation (8) by a test function $\boldsymbol{\tau}$ and integrating over $\Omega$ yields

$$
\begin{aligned}
\int_{\Omega} \boldsymbol{\gamma}: \boldsymbol{\tau} & =\int_{\Omega} \phi \dot{\boldsymbol{\varepsilon}}: \boldsymbol{\tau}+\int_{\Omega} \frac{\phi_{\max }-\phi}{3 \Delta_{t}} \mathbf{I}: \boldsymbol{\tau} \\
& =\sum V_{p}\left(\boldsymbol{\tau}\left(\boldsymbol{x}_{p}^{n}\right): \dot{\boldsymbol{\varepsilon}}\left(\boldsymbol{x}_{p}^{n}\right)-\frac{\mathbf{I}: \boldsymbol{\tau}\left(\boldsymbol{x}_{p}^{n}\right)}{3 \Delta_{t}}\right)+\int_{\Omega} \frac{\phi_{\max }}{3 \Delta_{t}} \mathbf{I}: \boldsymbol{\tau} \\
& =b(\boldsymbol{\tau}, \mathbf{u})+k(\boldsymbol{\tau})
\end{aligned}
$$

We retrieve Equation $(11), s(\boldsymbol{\gamma}, \boldsymbol{\tau})=b(\boldsymbol{\tau}, \mathbf{u})+k(\boldsymbol{\tau})$.
We can proceed similarly for the discrete-time momentum balance equation (9),

$$
\frac{\rho}{\Delta_{t}} \phi \mathbf{u}+\nabla \cdot[\phi(\boldsymbol{\lambda}-\eta \dot{\boldsymbol{\varepsilon}})]=\rho \phi\left(\boldsymbol{g}+\frac{\mathbf{u}^{p \rightarrow g}}{\Delta_{t}}\right)
$$

and get

$$
\begin{aligned}
\int_{\Omega}\left(\frac{\rho}{\Delta_{t}} \phi \mathbf{u} \cdot \mathbf{v}\right) & =m(\mathbf{u}, \mathbf{v}) \\
\int_{\Omega}\left(\rho \phi\left(\boldsymbol{g}+\frac{\mathbf{u}^{p \rightarrow g}}{\Delta_{t}}\right) \cdot \mathbf{v}\right) & =l(\mathbf{v})
\end{aligned}
$$

Using the Stokes formula with our homogeneous Dirichlet boundary conditions, we also have

$$
\begin{aligned}
\int_{\Omega}(\nabla \cdot[\phi \boldsymbol{\lambda}-\eta \phi \dot{\boldsymbol{\varepsilon}}] \cdot \mathbf{v}) & =\int_{\Omega}(\eta \phi \dot{\boldsymbol{\varepsilon}}-\phi \boldsymbol{\lambda}): \mathrm{D}(\mathbf{v}) \\
& =\sum V_{p}\left(\eta \dot{\varepsilon}\left(\boldsymbol{x}_{p}^{n}\right)-\boldsymbol{\lambda}\left(\boldsymbol{x}_{p}^{n}\right)\right): \mathrm{D}(\mathbf{v})\left(\boldsymbol{x}_{p}^{n}\right) \\
& =a(\mathbf{u}, \mathbf{v})-b(\mathbf{v}, \boldsymbol{\lambda})
\end{aligned}
$$

and retrieve Equation (10), $m(\mathbf{u}, \mathbf{v})+a(\mathbf{u}, \mathbf{v})=b(\boldsymbol{\lambda}, \mathbf{v})+l(\mathbf{v})$.

## 3 Frictional boundary condition

Suppose that $\left(\boldsymbol{\lambda}_{\mathrm{RB}} ; \boldsymbol{\gamma}_{\mathrm{RB}}\right) \in \mathcal{D} \mathcal{P}\left(\mu_{\mathrm{RB}}\right)$, with $\gamma_{\mathrm{RB}}:=$ $\frac{1}{2}\left(\overline{\boldsymbol{v}} \boldsymbol{n}_{\mathrm{RB}}^{\top}+\boldsymbol{n}_{\mathrm{RB}} \overline{\boldsymbol{v}}^{\top}\right)$, and $\left\|\boldsymbol{n}_{\mathrm{RB}}\right\|=1$.
The force induced by a stress $\boldsymbol{\sigma}$ through a plane with normal $\boldsymbol{n}$ is computed as $\boldsymbol{\sigma} \boldsymbol{n}$; the reaction force induced by the material on the frictional boundary is therefore $\boldsymbol{r}=\boldsymbol{\lambda}_{\mathrm{RB}} \boldsymbol{n}_{\mathrm{RB}}$. In the following, we investigate the relationship between $\boldsymbol{r}$ and $\overline{\boldsymbol{v}}$, the relative velocity of the boundary w.r.t. the granular material.

### 3.1 Signorini condition

First, remark that $\operatorname{Tr} \boldsymbol{\gamma}_{\mathrm{RB}}=\left(\overline{\boldsymbol{v}} \cdot \boldsymbol{n}_{\mathrm{RB}}\right)=\overline{\boldsymbol{v}}_{\mathrm{N}}$,

$$
\boldsymbol{r}_{\mathrm{N}}=\frac{1}{3}\left(\operatorname{Tr} \boldsymbol{\lambda}_{\mathrm{RB}}\right)+\left(\operatorname{Dev} \boldsymbol{\lambda}_{\mathrm{RB}}\right):\left(\boldsymbol{n}_{\mathrm{RB}} \boldsymbol{n}_{\mathrm{RB}}^{\top}\right)
$$

and

$$
\begin{aligned}
\left(\operatorname{Dev} \boldsymbol{\lambda}_{\mathrm{RB}}\right):\left(\boldsymbol{n}_{\mathrm{RB}} \boldsymbol{n}_{\mathrm{RB}}^{\top}\right) & \leq 2\left|\operatorname{Dev} \boldsymbol{\lambda}_{\mathrm{RB}}\right|\left|\boldsymbol{n}_{\mathrm{RB}} \boldsymbol{n}_{\mathrm{RB}}^{\top}\right| \\
& \leq \frac{\mu_{\mathrm{RB}}}{\sqrt{6}} \operatorname{Tr} \boldsymbol{\lambda}_{\mathrm{RB}} \times \frac{2}{\sqrt{2}} \\
& \leq \frac{\mu_{\mathrm{RB}}}{\sqrt{3}} \operatorname{Tr} \boldsymbol{\lambda}_{\mathrm{RB}} .
\end{aligned}
$$

Therefore,

$$
\left(\frac{1-\sqrt{3} \mu_{\mathrm{RB}}}{3}\right) \operatorname{Tr} \boldsymbol{\lambda}_{\mathrm{RB}} \leq \boldsymbol{r}_{\mathrm{N}} \leq\left(\frac{1+\sqrt{3} \mu_{\mathrm{RB}}}{3}\right) \operatorname{Tr} \boldsymbol{\lambda}_{\mathrm{RB}}
$$

For $\mu_{\mathrm{RB}}<\frac{1}{\sqrt{3}}$, we thus have

$$
0 \leq \operatorname{Tr} \boldsymbol{\gamma}_{\mathrm{RB}} \perp \operatorname{Tr} \boldsymbol{\lambda}_{\mathrm{RB}} \geq 0 \Longrightarrow 0 \leq \overline{\boldsymbol{v}}_{\mathrm{N}} \perp \boldsymbol{r}_{\mathrm{N}} \geq 0
$$

i.e., the Signorini condition is satisfied.

### 3.2 Tangential reaction

Notice that

$$
\begin{aligned}
\operatorname{Dev}\left(\boldsymbol{\gamma}_{\mathrm{RB}}\right) \boldsymbol{n}_{\mathrm{RB}} & =\frac{1}{2} \overline{\boldsymbol{v}}+\left(\frac{1}{2}-\frac{1}{3}\right)\left(\overline{\boldsymbol{v}} \cdot \boldsymbol{n}_{\mathrm{RB}}\right) \boldsymbol{n}_{\mathrm{RB}} \\
& =\frac{1}{2} \overline{\boldsymbol{v}}_{\mathrm{T}}+\frac{2}{3} \overline{\boldsymbol{v}}_{\mathrm{N}} \boldsymbol{n}
\end{aligned}
$$

Sliding case First suppose that $\overline{\boldsymbol{v}}_{\mathrm{T}} \neq 0$, therefore $\operatorname{Dev} \boldsymbol{\gamma}_{\mathrm{RB}} \neq 0$, and $\mathcal{D P}\left(\mu_{\mathrm{RB}}\right)$ imposes that $\operatorname{Dev} \boldsymbol{\lambda}_{\mathrm{RB}}=-\alpha \operatorname{Dev} \gamma_{\mathrm{RB}}, \alpha>0$. Since $\boldsymbol{r}=\frac{1}{3} \operatorname{Tr} \boldsymbol{\lambda}_{\mathrm{RB}} \boldsymbol{n}+\operatorname{Dev} \boldsymbol{\lambda}_{\mathrm{RB}} \boldsymbol{n}$, we can identity that

$$
\boldsymbol{r}_{\mathrm{T}}=-\frac{1}{2} \alpha \overline{\boldsymbol{v}}_{\mathrm{T}}
$$

i.e. the tangential friction force is opposed to the tangential relative velocity. Now, let us show that $\boldsymbol{r}$ lies on the boundary of the secondorder cone of aperture $\sqrt{\frac{3}{2}} \mu_{\mathrm{RB}}$, i.e., $\left\|\boldsymbol{r}_{\mathrm{T}}\right\|=\sqrt{\frac{3}{2}} \mu_{\mathrm{RB}} \boldsymbol{r}_{\mathrm{N}}$.
From the Signori condition, $\overline{\boldsymbol{v}}_{\mathrm{N}}>0$ implies $\boldsymbol{r}_{\mathrm{N}}=0$, and therefore $\operatorname{Tr} \boldsymbol{\lambda}_{\mathrm{RB}}=0$. This means $\left|\operatorname{Dev} \boldsymbol{\lambda}_{\mathrm{RB}}\right|=0$, and consequently $\left\|\boldsymbol{r}_{\mathrm{T}}\right\|$. Our relation $\left\|\boldsymbol{r}_{\mathrm{T}}\right\|=\sqrt{\frac{3}{2}} \mu_{\mathrm{RB}} \boldsymbol{r}_{\mathrm{N}}$ is trivially satisfied.
We now have to study the case $\overline{\boldsymbol{v}}_{\mathrm{N}}=0 . \operatorname{Dev} \boldsymbol{\lambda}_{\mathrm{RB}}=-\alpha \operatorname{Dev} \boldsymbol{\gamma}_{\mathrm{RB}}$ means that

$$
\left\|\boldsymbol{r}_{\mathrm{T}}\right\|=\left\|\operatorname{Dev} \boldsymbol{\lambda}_{\mathrm{RB}} \boldsymbol{n}\right\|=\left|\operatorname{Dev} \boldsymbol{\lambda}_{\mathrm{RB}} \boldsymbol{n}\right| \frac{\left\|\operatorname{Dev} \boldsymbol{\gamma}_{\mathrm{RB}} \boldsymbol{n}_{\mathrm{RB}}\right\|}{\left|\operatorname{Dev} \boldsymbol{\gamma}_{\mathrm{RB}}\right|} .
$$

Since $\overline{\boldsymbol{v}} \cdot \boldsymbol{n}_{\mathrm{RB}}=0$,

$$
\left\|\operatorname{Dev}\left(\boldsymbol{\gamma}_{\mathrm{RB}}\right) \boldsymbol{n}_{\mathrm{RB}}\right\|=\frac{1}{2}\left\|\overline{\boldsymbol{v}}_{\mathrm{T}}\right\|
$$

and

$$
\begin{aligned}
\left|\operatorname{Dev}\left(\boldsymbol{\gamma}_{\mathrm{RB}}\right)\right|^{2} & =\left|\boldsymbol{\gamma}_{\mathrm{RB}}\right|^{2}=\left|\overline{\boldsymbol{v}} \boldsymbol{n}_{\mathrm{RB}}^{\top}\right|^{2}-\frac{1}{4}\left|\overline{\boldsymbol{v}} \boldsymbol{n}_{\mathrm{RB}}^{\top}-\boldsymbol{n}_{\mathrm{RB}} \overline{\boldsymbol{v}}^{\top}\right|^{2} \\
& =\frac{1}{2}\|\overline{\boldsymbol{v}}\|^{2}-\frac{1}{4}\left\|\overline{\boldsymbol{v}} \wedge \boldsymbol{n}_{\mathrm{RB}}\right\|^{2}=\frac{1}{2}\|\overline{\boldsymbol{v}}\|^{2}-\frac{1}{4}\left\|\overline{\boldsymbol{v}}_{\mathrm{T}}\right\|^{2} \\
& =\frac{1}{4}\left\|\overline{\boldsymbol{v}}_{\mathrm{T}}\right\|^{2}=\left\|\operatorname{Dev}\left(\boldsymbol{\gamma}_{\mathrm{RB}}\right) \boldsymbol{n}_{\mathrm{RB}}\right\|^{2} .
\end{aligned}
$$

This means

$$
\left\|\boldsymbol{r}_{\mathrm{T}}\right\|=\left|\operatorname{Dev} \boldsymbol{\lambda}_{\mathrm{RB}}\right|=\frac{\mu_{\mathrm{RB}}}{\sqrt{6}} \operatorname{Tr} \boldsymbol{\lambda}_{\mathrm{RB}}=\sqrt{\frac{3}{2}} \mu_{\mathrm{RB}} \boldsymbol{r}_{\mathrm{N}} .
$$

The sliding case thereforce satisfies the Coulomb law with coefficient $\sqrt{\frac{3}{2}} \mu_{\text {RB }}$.

Sticking When $\overline{\boldsymbol{v}}=0$, we cannot conclude without more information about the relationship between $\boldsymbol{\lambda}_{\mathrm{RB}}$ and $\boldsymbol{\gamma}_{\mathrm{RB}}$. Indeed, we can only verify that

$$
\begin{aligned}
\left\|\boldsymbol{r}_{\mathrm{T}}\right\| & \leq\left\|\operatorname{Dev} \boldsymbol{\lambda}_{\mathrm{RB}} \boldsymbol{n}\right\| \leq \sqrt{2}\left|\operatorname{Dev} \boldsymbol{\lambda}_{\mathrm{RB}}\right| \\
& \leq \frac{\mu_{\mathrm{RB}}}{\sqrt{3}} \operatorname{Tr} \boldsymbol{\lambda}_{\mathrm{RB}} \leq \frac{\sqrt{3} \mu_{\mathrm{RB}}}{1-\sqrt{3} \mu_{\mathrm{RB}}} \boldsymbol{r}_{\mathrm{N}}
\end{aligned}
$$

i.e the reaction force has to lie inside a second-order cone of aperture $\frac{\sqrt{3} \mu_{\mathrm{RB}}}{1-\sqrt{3} \mu_{\mathrm{RB}}}$.
This last bound does not correspond to the one derived for the sliding case (except when $\mu_{\mathrm{RB}}=0$ ), but nevertheless models a coupling between the tangential and normal reaction forces.

### 3.3 Reverse inclusion

For any $(\boldsymbol{r} ; \overline{\boldsymbol{v}}) \in \mathcal{C}^{3}\left(\sqrt{\frac{3}{2}} \mu\right)$ - i.e., satisfying the 3D Coulomb law with friction coefficient $\sqrt{\frac{3}{2}} \mu$-we can construct a symmetric tensor $\boldsymbol{\lambda}_{\mathrm{RB}}$ such that $\left(\boldsymbol{\lambda}_{\mathrm{RB}} ; \boldsymbol{\gamma}_{\mathrm{RB}}\right) \in \mathcal{D} \mathcal{P}(\mu)$. Indeed, let

$$
\boldsymbol{\lambda}_{\mathrm{RB}}:=\left(\boldsymbol{r}_{\mathrm{T}} \boldsymbol{n}_{\mathrm{RB}}^{\top}+\boldsymbol{n}_{\mathrm{RB}} \boldsymbol{r}_{\mathrm{T}}^{\top}\right)+\boldsymbol{r}_{\mathrm{N}} \mathbf{I}
$$

We have

$$
\begin{aligned}
\operatorname{Tr} \boldsymbol{\lambda}_{\mathrm{RB}} & =3 \boldsymbol{r}_{\mathrm{N}}=\sqrt{6} \sqrt{\frac{3}{2}} \boldsymbol{r}_{\mathrm{N}} \\
\boldsymbol{\lambda}_{\mathrm{RB}} \boldsymbol{n}_{\mathrm{RB}} & =\boldsymbol{r}_{\mathrm{T}}+\boldsymbol{n}_{\mathrm{RB}}\left(\boldsymbol{r}_{\mathrm{N}}\right)=\boldsymbol{r} \\
\operatorname{Dev}\left(\boldsymbol{\lambda}_{\mathrm{RB}}\right) \boldsymbol{n}_{\mathrm{RB}} & =\boldsymbol{r}_{\mathrm{T}} \\
\left|\operatorname{Dev}\left(\boldsymbol{\lambda}_{\mathrm{RB}}\right)\right| & =\left|\boldsymbol{r}_{\mathrm{T}} \boldsymbol{n}_{\mathrm{RB}}^{\top}+\boldsymbol{n}_{\mathrm{RB}}\left(\boldsymbol{r}-\boldsymbol{r}_{\mathrm{N}} \boldsymbol{n}_{\mathrm{RB}}\right)^{\top}\right| \\
& =\left\|\boldsymbol{r}_{\mathrm{T}}\right\|
\end{aligned}
$$

It can be easily verified that for any case of the $\mathcal{C}^{3}\left(\sqrt{\frac{3}{2}} \mu\right)$ disjunctive formulation satisfied by $\boldsymbol{r}$ and $\overline{\boldsymbol{v}}$, the corresponding case of $\mathcal{D P}(\mu)$ is satisfied by $\left(\boldsymbol{\lambda}_{\mathrm{RB}} ; \boldsymbol{\gamma}_{\mathrm{RB}}\right)$.
