Multi-Person Tracking Problem

Multi-Person Tracking Problem

Problem:

- Unknown and time-varying number of moving persons
- Persons may appear/disappear
- Person detectors are not 100% reliable

Solution:

- Combine person detection with person tracking
- Efficient solution based on variational Bayesian algorithm
- Person tracking and visual servoing are combined to optimize long trajectories

Existing Multi-Person Tracking Methods

Sampling methods:

- Markov chain Monte Carlo (MCMC) Sampling, e.g. [Choi et al. 2015]
- Probability Hypothesis Density (PHD) filters, e.g. [Vo et al. 2003]

Problems:

- No closed-form solutions
- Non deterministic methods
- Algorithms with high computational cost

Our Solution: Variational Bayesian framework

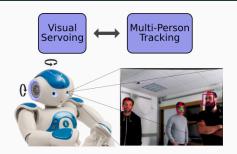
Variational Bayesian:

 Mathematical framework for approximating intractable posterior distributions, e.g. the filtering distribution associated with multiple person tracking.

Why choose variational Bayesian methods?

- Closed-form solution
- Efficient algortihms
- Deterministic method

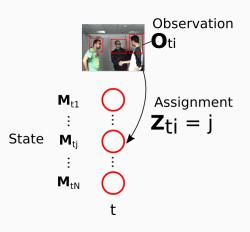
Multi-Person Tracking and Visual Servoing



- Problems arise whenever persons move out of field of view, e.g. identity changes when a person reappears
- Tracking can be more robust if visual servoing is used
- We propose a formal method to incorporate motor information into tracking

Variational Tracking Model

Notations

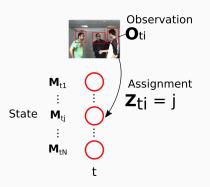


- Observation: detected face position
- Assignment:

 $Z_{ti} = j$ assigns face detection i to the identity j

 State: the tracked person's position and velocity

Notations

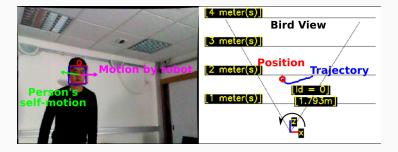

Joint observation likelihood

$$p(Z_t, \mathbf{M}_t | \mathbf{o}_{1:t}) \propto$$

State dynamics



Predicted person location is the combination of:

- person self-motion
- motion by robot
- previous location

$$\begin{split} p(Z_t, \mathbf{M}_t | \mathbf{o}_{1:t}) &\propto \\ p(\mathbf{o}_t | Z_t, \mathbf{M}_t) p(Z_t) \int & p(\mathbf{M}_t | \mathbf{M}_{t-1}) \underbrace{\sum_{Z_{t-1}} p(Z_{t-1}, \mathbf{M}_{t-1} | \mathbf{o}_{1:t-1})}_{\text{filtering distribution at } t-1} d\mathbf{M}_{t-1}. \end{split}$$

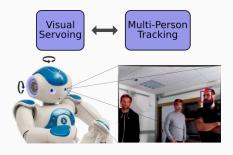
Variational Inference

• Using variational factorization, we have

$$ho(\mathsf{Z}_t,\mathsf{M}_t|\mathbf{o}_{1:t})pprox q(\mathsf{Z}_t)q(\mathsf{M}_t)$$

 Variational Expectation Maximization (VEM) algorithm derived a closed-form expression for each factorized distribution

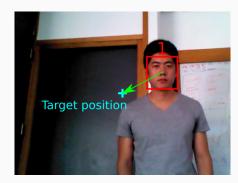
Combine Multi-Person Tracking with Visual Servoing



Visual Servoing

Using visual information, we can:

 Control the robot-head velocity to keep the selected person at the target position



keep person at target position

Visual Servoing

Using motor information, we can:

 Predict the velocity due to robot-motion. (distinguish person's self-motion from robot-motion)



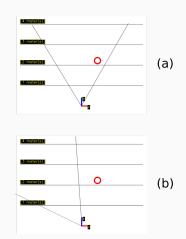


green arrow: person's self-motion magenta arrow: motion due to robot-motion

Visual Servoing

Using motor information, we can:

- Predict the velocity due to robot-motion. (distinguish person's self-motion from robot-motion)
- Give to the tracker additional person information even if the person is out of field-of-view



Robot rotates head, making the person out of the field-of-view

Table 1: Comparison of tracking result without (w/o) and with (w) control using MOT metrics on three sequences of increasing complexity. \uparrow : the higher the better \downarrow : the lower the better

Conclusions

Conclusions

- A multi-person tracker incorporates motor information to encompass the effect of the robots ego-motion
- Variational approximation allows to effectively solve the problem with low computational cost
- NAO implementation: 10 FPS (due to hardware limitations)
