# An extreme quantile estimator for the log-generalized Weibull-tail model

#### Abstract

We propose a new estimator for extreme quantiles under the log-generalized Weibull-tail model, introduced by Cees de Valk. This model relies on a new regular variation condition which, in some situations, permits to extrapolate further into the tails than the classical assumption in extreme-value theory. The asymptotic normality of the estimator is established and its finite sample properties are illustrated both on simulated and real datasets.


Keywords: Extreme quantiles, Extreme-value theory, Extended regular variation.

## 1 Introduction

Let $X$ be a random variable with distribution function $F(\cdot)=\mathbb{P}(X \leq \cdot)$ and survival function $S:=1-F$. Starting from a $n$-sample from $X$, our goal is to estimate extreme quantiles from $S$ of level $1-\beta_{n}$ with $\beta_{n} \rightarrow 0$ as $n \rightarrow \infty$. Recall that a quantile of level $1-\beta$ is given by $Q(\beta):=\inf \{y ; S(y) \leq \beta\}$. The rate of convergence of $\beta_{n}$ to zero drives the difficulty of the estimation problem. Indeed, if $n \beta_{n} \rightarrow 0$ as $n \rightarrow \infty$, then $Q\left(\beta_{n}\right)$ is asymptotically almost surely larger than the sample maxima. In finance or assurance contexts, an extreme quantile is interpreted as the Value-at-Risk associated with an extreme loss, see [10, 19] for links between extreme-value theory and risk theory. In environmental applications, an extreme quantile coincides with the return level associated with an exceptional climatic event (extreme rainfalls [6], extreme wind velocities [16], extreme wave heights [18], river peak flows [17],...).

Dedicated methods have been designed to address the estimation of extreme quantiles, see $[9$, Chapter 6] or [15, Chapter 4], for an overview. Most of them rely on an extended regular variation assumption on the function $Q$. Recently, an alternative method has been initiated by Cees de Valk in a series of papers [21, 22], the goal being to estimate "more" extreme quantiles i.e. associated with sequences $\beta_{n}$ tending to zero at a faster rate than in the previously mentioned

[^0]approaches $[9,15]$. The idea is to put the extended regular variation assumption on the function $V(\cdot):=\ln Q(1 / \exp \cdot)$ rather than on $Q(\cdot)$, see Paragraph 1.1 for technical details and Paragraph 1.2 for examples. Dedicated estimation methods are introduced in [23]. The goal of this work is to contribute to the popularity of this model by proposing alternative estimators, which are more efficient in some situations.

### 1.1 Tail model

Let $X$ be a random variable with survival function $S$. For the sake of simplicity, we assume in what follows that $S(1)=1$ i.e. $\mathbb{P}(X \geq 1)=1$. The tail model considered in this work is given by

$$
\begin{equation*}
S(x)=\exp \left[-V^{\leftarrow}(\ln x)\right] \tag{1}
\end{equation*}
$$

where $V^{\leftarrow}(\cdot):=\inf \{y ; V(y) \geq \cdot\}$ is the generalized inverse of $V(\cdot):=\ln Q(1 / \exp \cdot)$ with $Q$ the quantile function. The function $V$ is supposed to be of extended regular variation with index $\theta \in \mathbb{R}$. More specifically, there exists a positive function $a$ (called the auxiliary function) such that, for all $t>0$

$$
\begin{equation*}
\lim _{y \rightarrow \infty} \frac{V(t y)-V(y)}{a(y)}=\int_{1}^{t} u^{\theta-1} d u=: L_{\theta}(t) \tag{2}
\end{equation*}
$$

The class of extended regularly varying functions is denoted by $\mathcal{E R} \mathcal{V}(\theta)$. Model (1) is referred to as the "log-generalized Weibull-tail model" [21, 22, 23]. From [15, Corollary 1.1.10], a sufficient condition for (2) is
(A1) $V$ is differentiable with derivative $V^{\prime}$ satisfying

$$
\begin{equation*}
\lim _{x \rightarrow \infty} \frac{V^{\prime}(t x)}{V^{\prime}(x)}=t^{\theta-1} \tag{3}
\end{equation*}
$$

Such a function $V^{\prime}$ is said to be regularly varying with index $\theta-1$ and this property is denoted by $V^{\prime} \in \mathcal{R} \mathcal{V}(\theta-1)$. We refer to [5] for a general account on regular variation theory. Moreover, under (A1), a possible choice in (2) is $a(y)=y V^{\prime}(y)$.

### 1.2 Properties and examples

Condition (A1) generalizes the tail model introduced in $[8,12]$ where it is assumed that the function $V$ in (2) is asymptotically proportional to $L_{\tau}$ for some $\tau \in[0,1]$. One can then easily show that such a tail parameter $\tau$ coincides with the index $\theta$ of extended regular variation in the situation where $\theta \in[0,1]$. In terms of Maximum Domain of Attraction (MDA), the following result has been established in [2, Proposition 4]:

Lemma 1 Assume $F$ is twice differentiable.
(i) If (A1) holds with $\theta<1$ then $F \in M D A$ (Gumbel).
(ii) If $F \in M D A$ (Fréchet) then (A1) holds with $\theta=1$.
(iii) If (A1) holds with $\theta>1$ then $F$ does not belong to any $M D A$.

It thus appears that model (A1) with $\theta \leq 1$ is of particular interest since it is associated with most distributions in MDA(Gumbel) $\cup \operatorname{MDA}$ (Fréchet). The situation $\theta>1$ which does not correspond to any domain of attraction is sometimes referred to as super-heavy tails, see for instance [3]. The following examples are taken from [2, Proposition 3]:

Example 1 Let $x^{*}:=\sup \{x \geq 1, F(x)<1\}$ be the endpoint of $F$. Then, under some monotonicity assumptions:
(i) If $V^{\leftarrow}(\ln \cdot) \in \mathcal{R} \mathcal{V}(1 / \beta), \beta>0$, then $(\mathbf{A 1})$ holds with $\theta=0$. In this case, $F$ is referred to as a Weibull tail-distribution, see for instance [4, 11, 14]. Such distributions encompass Gaussian, Gamma, Exponential and strict Weibull distributions.
(ii) $V^{\leftarrow} \in \mathcal{R} \mathcal{V}(1 / \beta), 0<\beta<1$ if and only if (A1) holds with $\theta=\beta>0$. Here, $F$ is called a log-Weibull tail-distribution, see [3, 8, 12], the most popular example being the lognormal distribution.
(iii) $1 \leq x^{*}<\infty$ and $V^{\leftarrow}\left(\ln x^{*}+\ln (1-1 / \cdot)\right) \in \mathcal{R} \mathcal{V}_{-1 / \beta}, \beta<0$ if and only if (A1) holds with $\theta=\beta<0$. This case corresponds to distributions with a Weibull tail behavior in the neighborhood of a finite endpoint.

We also refer to Table 1 for examples of distributions corresponding to the three above families: $\theta=0, \theta>0$ and $\theta<0$.

### 1.3 Outline

The inference aspects associated with model (1) are examined in Section 2: Estimators for extreme quantiles are introduced as well as estimators for the extended regular variation index $\theta$ and the auxiliary function $a$. The asymptotic distributions of these estimators are established in Section 3. Their finite sample performance are investigated in Section 4 on simulated data and compared to the proposals introduced in [23]. Finally, an illustration on real data is presented in Section 5. Proofs are postponed to Section 6.

## 2 Inference

Let $X_{1}, \ldots, X_{n}$ be $n$ independent copies of a random variable $X$ distributed as in (1). The associated ordered statistics are denoted by $X_{1, n} \leq \ldots \leq X_{n, n}$ throughout the paper. Starting from this random sample, we focus on the estimation of extreme quantiles i.e. $Q(u):=S^{\leftarrow}(u)=$ $\exp [V(\ln (1 / u))]$ when $u \rightarrow 0$. Two situations for the level $u$ are considered.

Intermediate case. If $u=\alpha_{n}$ where $\alpha_{n}$ is an intermediate level satisfying $\alpha_{n} \rightarrow 0$ and $n \alpha_{n} \rightarrow \infty$ as $n \rightarrow \infty$, a natural estimator is obtained by replacing $Q$ by its empirical counterpart $\hat{Q}_{n}$. More precisely, $Q\left(\alpha_{n}\right)$ is estimated by $\hat{Q}_{n}\left(\alpha_{n}\right)=X_{n-\left\lfloor n \alpha_{n}\right\rfloor, n}$.

Extreme case. If $u=\beta_{n}$ where $\beta_{n}$ is an extreme level such that $n \beta_{n} \rightarrow c \geq 0$ as $n \rightarrow \infty$, a simple order statistics cannot be used. Extrapolation beyond the sample should be performed.

Starting from an intermediate level $\alpha_{n}:=k_{n} / n$ where $k_{n} \rightarrow \infty$ and $k_{n} / n \rightarrow 0$, we propose to estimate $Q\left(\beta_{n}\right)$ by

$$
\begin{equation*}
\check{Q}_{n}\left(\beta_{n}\right):=\hat{Q}_{n}\left(\frac{k_{n}}{n}\right) \exp \left[\hat{a}_{n}\left[\ln \left(n / k_{n}\right)\right] L_{\hat{\theta}_{n}}\left(\frac{\ln \beta_{n}}{\ln \left(k_{n} / n\right)}\right)\right], \tag{4}
\end{equation*}
$$

where $\hat{\theta}_{n}$ and $\hat{a}_{n}\left[\ln \left(n / k_{n}\right)\right]$ are suitable estimators of $\theta$ and $a\left[\ln \left(n / k_{n}\right)\right]$. The rationale behind (4) is based on (2) which basically means that for $\alpha$ close to 0 and for all $t>0$,

$$
\ln Q(t \alpha) \approx \ln Q(\alpha)+a[\ln (1 / \alpha)] L_{\theta}\left(1+\frac{\ln (t)}{\ln (\alpha)}\right)
$$

Estimator (4) is then obtained by taking $\alpha=k_{n} / n$ and $t=n \beta_{n} / k_{n}$ and by replacing the unknown quantities $Q\left(k_{n} / n\right), a\left[\ln \left(n / k_{n}\right)\right]$ and $\theta$ by their corresponding estimators. Since $k_{n} / n$ is an intermediate level, $Q\left(k_{n} / n\right)$ is estimated by $\hat{Q}_{n}\left(k_{n} / n\right)=X_{n-k_{n}, n}$.

Parameters estimation. Let us now propose new estimators of $\theta$ and $a\left[\ln \left(n / k_{n}\right)\right]$. To this end, for $j \in\{1,2\}$, consider the statistic

$$
M_{n}^{(j)}:=\frac{1}{k_{n}} \sum_{i=0}^{k_{n}-1}\left[\ln _{2}\left(X_{n-i, n}\right)-\ln _{2}\left(X_{n-k_{n}, n}\right)\right]^{j}
$$

where $\ln _{2}:=\ln \ln$, as well as the functions

$$
\mu_{b}(t, \zeta):=\int_{0}^{1}\left[L_{\zeta}\left(1+\frac{\ln (1 / s)}{t}\right)\right]^{b} d s \text { and } \Psi_{t}(\zeta):=\frac{\mu_{1}^{2}(t, \zeta)}{\mu_{2}(t, \zeta)}
$$

defined for $t>0, b \in \mathbb{N} \backslash\{0\}$ and $\zeta<1$. Let us mention that $\mu_{1}(t, 0)=\mathrm{e}^{t} E_{1}(t)$ where $E_{1}(t):=$ $\int_{t}^{\infty} u^{-1} \mathrm{e}^{-u} d u$ is the exponential integral, see for instance [1, eq 5.1.1]. Furthermore, it can be shown (see Lemma 5) that $\Psi_{t}$ is a decreasing function, at least for $t$ large enough, and thus its generalized inverse $\Psi_{t}^{\leftarrow}$ is well defined for $t$ large enough. The following statistics are then introduced:

$$
\begin{align*}
\hat{\theta}_{n,+}^{(M)} & :=\frac{M_{n}^{(1)}}{\mu_{1}\left[\ln \left(n / k_{n}\right), 0\right]},  \tag{5}\\
\hat{\theta}_{n,-}^{(M)} & :=\Psi_{\ln \left(n / k_{n}\right)}^{\leftarrow}\left(\frac{\left[M_{n}^{(1)}\right]^{2}}{M_{n}^{(2)}}\right),  \tag{6}\\
\hat{\theta}_{n}^{(M)} & :=\hat{\theta}_{n,+}^{(M)}+\hat{\theta}_{n,-}^{(M)},  \tag{7}\\
\hat{a}_{n}^{(M)}\left[\ln \left(n / k_{n}\right)\right] & :=\frac{\ln X_{n-k_{n}, n}}{\mu_{1}\left[\ln \left(n / k_{n}\right), \hat{\theta}_{n,-}^{(M)}\right]} M_{n}^{(1)} \tag{8}
\end{align*}
$$

We conclude this section by giving the main ideas leading to the estimators (7) and (8) of respectively $\theta$ and $a\left[\ln \left(n / k_{n}\right)\right]$. The estimator (7) is similar in spirit to the moment estimator introduced in [7]. Its construction is based on the following two results. Letting $\theta_{+}:=\theta \vee 0$ and $\theta_{-}:=\theta \wedge 0$, for any increasing function $V \in \mathcal{E} \mathcal{R} \mathcal{V}(\theta)$,

$$
\begin{equation*}
\lim _{x \rightarrow \infty} \frac{V(x)}{a(x)} \ln \frac{V(t x)}{V(x)}=L_{\theta_{-}}(t) \tag{9}
\end{equation*}
$$

locally uniformly in $(0, \infty)$, see [15, Lemma B.3.16]. Moreover, one has (see for instance [15, Eq. 3.5.5]),

$$
\lim _{x \rightarrow \infty} \frac{a(x)}{V(x)}=\theta_{+}
$$

Plugging $x:=\ln (1 / \alpha)$ and $t:=1+\ln (s) / \ln (\alpha)$ in (9) yields the approximation

$$
\ln _{2} Q(s \alpha)-\ln _{2} Q(\alpha) \approx \theta_{+} L_{0}\left(1+\frac{\ln s}{\ln \alpha}\right)
$$

as $\alpha \rightarrow 0$ and for all $s \in(0,1)$. Integrating with respect to $s$ on $(0,1)$ leads to

$$
\int_{0}^{1}\left[\ln _{2} Q(s \alpha)-\ln _{2} Q(\alpha)\right] d s / \int_{0}^{1} L_{0}\left(1+\frac{\ln s}{\ln \alpha}\right) d s \approx \theta_{+}
$$

Considering $\alpha=k_{n} / n$ where $k_{n}$ is an intermediate sequence such that $k_{n} \rightarrow \infty$ and $k_{n} / n \rightarrow 0$ and replacing $Q$ by its empirical estimator $\hat{Q}_{n}$ lead to the estimator (5) of $\theta_{+}$. Similarly, remark that (9) leads to the approximation

$$
\left\{\int_{0}^{1}\left[\ln _{2} Q(s \alpha)-\ln _{2} Q(\alpha)\right] d s\right\}^{2} / \int_{0}^{1}\left[\ln _{2} Q(s \alpha)-\ln _{2} Q(\alpha)\right]^{2} d s \approx \Psi_{\ln (1 / \alpha)}\left(\theta_{-}\right)
$$

as $\alpha \rightarrow 0$. Replacing again in the previous approximation $\alpha$ by $k_{n} / n$ and $Q$ by its empirical counterpart suggests to estimate $\theta_{-}$by (6). Finally, estimator (8) is obtained by remarking that, from (9)

$$
\frac{\ln Q(\alpha)}{a[\ln (1 / \alpha)]} \int_{0}^{1} \ln \frac{\ln Q(s \alpha)}{\ln Q(\alpha)} d s \approx \mu_{1}\left[\ln (1 / \alpha), \theta_{-}\right]
$$

for $\alpha$ close to 0 . Replacing $\alpha$ by $k_{n} / n, Q$ by $\hat{Q}_{n}$ and $\theta_{-}$by $\hat{\theta}_{n,-}^{(M)}$ gives (8).

## 3 Main results

### 3.1 Quantile estimation: Intermediate case

Let us first focus on the asymptotic behavior of the quantile estimator in the intermediate case.
Theorem 1 Under model (1), assume that (A1) holds. For all intermediate level $\alpha_{n}$ (i.e. such that $\alpha_{n} \rightarrow 0$ and $n \alpha_{n} \rightarrow \infty$ as $\left.n \rightarrow \infty\right)$, one has

$$
\frac{\left(n \alpha_{n}\right)^{1 / 2} \ln \left(1 / \alpha_{n}\right)}{a\left[\ln \left(1 / \alpha_{n}\right)\right]} \ln \left(\frac{\hat{Q}_{n}\left(\alpha_{n}\right)}{Q\left(\alpha_{n}\right)}\right) \stackrel{d}{\longrightarrow} \mathcal{N}(0,1)
$$

First, remark that introducing $k_{n}=\left\lfloor n \alpha_{n}\right\rfloor$ and choosing $a(t)=t V^{\prime}(t)$ (see Section 1), the above asymptotic normality result can be rewritten as

$$
\frac{k_{n}^{1 / 2}}{V^{\prime}\left[\ln \left(n / k_{n}\right)\right]} \ln \left(\frac{\hat{Q}_{n}\left(k_{n} / n\right)}{Q\left(k_{n} / n\right)}\right) \xrightarrow{d} \mathcal{N}(0,1) .
$$

If, moreover,

$$
\begin{equation*}
k_{n}^{1 / 2} / V^{\prime}\left[\ln \left(n / k_{n}\right)\right] \rightarrow \infty \text { as } n \rightarrow \infty \tag{10}
\end{equation*}
$$

then

$$
\frac{k_{n}^{1 / 2}}{\left(n / k_{n}\right) U^{\prime}\left(n / k_{n}\right)}\left(\hat{Q}_{n}\left(k_{n} / n\right)-Q\left(k_{n} / n\right)\right) \xrightarrow{d} \mathcal{N}(0,1),
$$

where $U(\cdot)=Q(1 / \cdot)$ is the tail quantile function. This result coincides with [15, Theorem 2.2.1] established under a von Mises' condition for the maximum domain of attraction of an extreme-value distribution. Clearly, (10) holds when $\theta<1$ since, in this case, $V^{\prime}(t) \rightarrow 0$ as $t \rightarrow \infty$. Moreover, if $F \in \operatorname{MDA}($ Fréchet ) then $\theta=1$ from Lemma 1(ii) and $U \in \mathcal{R} \mathcal{V}(\gamma)$ for some $\gamma>0$. It thus follows that $V^{\prime}(\ln t)=t U^{\prime}(t) / U(t) \rightarrow \gamma$ as $t \rightarrow \infty$ and (10) is verified. The case $\theta>1$ is not relevant here, since, in this case, $F$ does not belong to any domain of attraction, see Lemma 1(iii).
Second, under additional conditions,

$$
\frac{\hat{a}_{n}^{(M)}\left[\ln \left(1 / \alpha_{n}\right)\right]}{a\left[\ln \left(1 / \alpha_{n}\right)\right]} \xrightarrow{\mathbb{P}} 1,
$$

see Theorem 4 below, and thus

$$
\frac{\left(n \alpha_{n}\right)^{1 / 2} \ln \left(1 / \alpha_{n}\right)}{\hat{a}_{n}^{(M)}\left[\ln \left(1 / \alpha_{n}\right)\right]} \ln \left(\frac{\hat{Q}_{n}\left(\alpha_{n}\right)}{Q\left(\alpha_{n}\right)}\right) \xrightarrow{d} \mathcal{N}(0,1)
$$

which provides a way for constructing asymptotic confidence interval for intermediate quantiles $Q\left(\alpha_{n}\right)$ based on $\hat{Q}_{n}\left(\alpha_{n}\right)$. Letting $u_{\zeta}$ the $(1+\zeta) / 2$ th quantile from a standard Gaussian distribution,

$$
\left[\hat{Q}_{n}\left(\alpha_{n}\right) \exp \left(-\frac{\hat{a}_{n}^{(M)}\left[\ln \left(1 / \alpha_{n}\right)\right]}{\left(n \alpha_{n}\right)^{1 / 2} \ln \left(1 / \alpha_{n}\right)} u_{\zeta}\right) ; \hat{Q}_{n}\left(\alpha_{n}\right) \exp \left(\frac{\hat{a}_{n}^{(M)}\left[\ln \left(1 / \alpha_{n}\right)\right]}{\left(n \alpha_{n}\right)^{1 / 2} \ln \left(1 / \alpha_{n}\right)} u_{\zeta}\right)\right]
$$

is a confidence interval for $Q\left(\alpha_{n}\right)$ of asymptotic level $\zeta$.

### 3.2 Quantile estimation: Extreme case

Our next goal is to establish the asymptotic normality of $\check{Q}_{n}\left(\beta_{n}\right)$ for an extreme level $\beta_{n}$ satisfying $n \beta_{n} \rightarrow c \geq 0$. A second-order condition is needed on $V \in \mathcal{E} \mathcal{R} \mathcal{V}(\theta)$ to control the rate of convergence in (2):
(A2) There exist a function $\tilde{A}$ with $\tilde{A}(x) \rightarrow 0$ as $x \rightarrow \infty$ and $\rho<0$ such that for all $t>0$,

$$
\lim _{x \rightarrow \infty} \frac{1}{\tilde{A}(x)}\left[\frac{V(t x)-V(x)}{a(x)}-L_{\theta}(t)\right]=H_{\theta, \rho}(t):=\int_{1}^{t} s^{\theta-1} L_{\rho}(s) d s
$$

locally uniformly for $t>0$.
Note that (A2) also provides the rate of convergence in (9). Indeed, from [15, Lemma B.3.16], condition (A2) with $\theta \neq \rho$ entails that there exists a function $A$ with $A(x) \rightarrow 0$ as $x \rightarrow \infty$ such that

$$
\begin{equation*}
\lim _{x \rightarrow \infty} \frac{1}{A(x)}\left[\frac{V(x)}{a(x)} \ln \frac{V(t x)}{V(x)}-L_{\theta_{-}}(t)\right]=H_{\theta_{-}, \rho^{\prime}}(t) . \tag{11}
\end{equation*}
$$

The function $|A|$ is regularly varying with index $\rho^{\prime} \leq 0$ where, according to [15, Lemma B.3.16],

$$
\rho^{\prime}= \begin{cases}\rho & \text { if } \theta<\rho,  \tag{12}\\ \theta & \text { if } \rho<\theta \leq 0, \\ -\theta & \text { if }(0<\theta<-\rho \text { and } l \neq 0), \\ \rho & \text { if }(0<\theta<-\rho \text { and } l=0) \text { or }(\theta \geq-\rho) .\end{cases}
$$

with, for $\theta>0$,

$$
l:=\lim _{x \rightarrow \infty}\left[V(x)-\frac{a(x)}{\theta}\right]
$$

Let us also introduce the positive function $B$ defined by $B(x):=\max (|\tilde{A}(x)|,|A(x)| / x)$. It is easily checked that $B$ is regularly varying with index $\max \left(\rho, \rho^{\prime}-1\right)$. We are now in position to establish the asymptotic distribution of $\check{Q}_{n}\left(\beta_{n}\right)$ for general estimators of $\theta$ and $a\left[\ln \left(n / k_{n}\right)\right]$ satisfying the condition:
(A3) There exist a sequence $\sigma_{n} \rightarrow 0$ and a random vector $(B, \Theta, \Lambda)$ such that

$$
\sigma_{n}^{-1}\left\{\frac{\ln X_{n-k_{n}, n}-\ln Q\left(k_{n} / n\right)}{a\left[\ln \left(n / k_{n}\right)\right] H_{\theta, 0}\left(d_{n}\right)}, \hat{\theta}_{n}-\theta, \frac{L_{\theta}\left(d_{n}\right)}{H_{\theta, 0}\left(d_{n}\right)}\left(\frac{\hat{a}_{n}\left[\ln \left(n / k_{n}\right)\right]}{a\left[\ln \left(n / k_{n}\right)\right]}-1\right)\right\} \xrightarrow{d}(B, \Theta, \Lambda),
$$

where $d_{n}:=\ln \left(1 / \beta_{n}\right) / \ln \left(n / k_{n}\right)$.
Theorem 2 Under model (1), assume conditions (A2), (A3) hold. Let ( $k_{n}$ ) and ( $\beta_{n}$ ) be two sequences such that $n \beta_{n} \rightarrow c \geq 0, k_{n} \rightarrow \infty, k_{n} / n \rightarrow 0, d_{n} \rightarrow d \in[1, \infty], \sigma_{n} \ln \left(d_{n}\right) \rightarrow 0$ and $\sigma_{n}^{-1} \tilde{A}\left[\ln \left(n / k_{n}\right)\right] \rightarrow 0$ as $n \rightarrow \infty$. Then,

$$
\frac{\sigma_{n}^{-1}}{a\left[\ln \left(n / k_{n}\right)\right] H_{\theta, 0}\left(d_{n}\right)} \ln \left(\frac{\check{Q}_{n}\left(\beta_{n}\right)}{Q\left(\beta_{n}\right)}\right) \xrightarrow{d} B+\Theta+\lambda .
$$

Under the conditions of Theorem 2, three situations can arise for the extreme quantile level $\beta_{n}$. The first one is when $d_{n} \rightarrow 1$ which corresponds to the least extreme case. This condition is achieved for instance when $n \beta_{n} \rightarrow c>0$. In this situation,

$$
\begin{equation*}
H_{\theta, 0}\left(d_{n}\right) \stackrel{d_{n} \rightarrow 1}{\sim}\left(d_{n}-1\right)^{2} / 2 \rightarrow 0 \tag{13}
\end{equation*}
$$

The second case corresponds to the situation where $d_{n} \rightarrow d \in(1, \infty)$. Here,

$$
\begin{equation*}
H_{\theta, 0}\left(d_{n}\right) \xrightarrow{d_{n} \rightarrow d} H_{\theta, 0}(d)>0 \tag{14}
\end{equation*}
$$

Note that for these two situations, $\sigma_{n} \ln \left(d_{n}\right) \rightarrow 0$ is a consequence of the assumption $\sigma_{n} \rightarrow 0$ as $n \rightarrow \infty$. Finally, the most extreme case occurs when $d_{n} \rightarrow \infty$ leading to

$$
H_{\theta, 0}\left(d_{n}\right) \stackrel{d_{n} \rightarrow \infty}{\sim} \begin{cases}d_{n}^{\theta} \ln \left(d_{n}\right) / \theta & \text { if } \theta>0  \tag{15}\\ \ln ^{2}\left(d_{n}\right) / 2 & \text { if } \theta=0 \\ 1 / \theta^{2} & \text { if } \theta<0\end{cases}
$$

As expected, the rate of convergence in Theorem 2 is getting worse when the quantile level $\beta_{n}$ is getting more extreme. Let us also highlight that, when $\theta<0$, the rates of convergence in situations $d_{n} \rightarrow d>1$ and $d_{n} \rightarrow \infty$ are of the same order.
To conclude this section, let us give the following consistency result.
Proposition 1 Under the conditions of Theorem 2,

$$
\begin{equation*}
\frac{\hat{a}_{n}\left[\ln \left(n / k_{n}\right)\right]}{a\left[\ln \left(n / k_{n}\right)\right]} \xrightarrow{\mathbb{P}} 1 \text { and } \frac{H_{\hat{\theta}_{n}, 0}\left(d_{n}\right)}{H_{\theta, 0}\left(d_{n}\right)} \xrightarrow{\mathbb{P}} 1 . \tag{16}
\end{equation*}
$$

and therefore

$$
\frac{\sigma_{n}^{-1}}{\hat{a}_{n}\left[\ln \left(n / k_{n}\right)\right] H_{\hat{\theta}_{n}, 0}\left(d_{n}\right)} \ln \left(\frac{\check{Q}_{n}\left(\beta_{n}\right)}{Q\left(\beta_{n}\right)}\right) \xrightarrow{d} B+\Theta+\lambda .
$$

Proposition 1 can be used to construct asymptotic confidence intervals for extreme quantiles $Q\left(\beta_{n}\right)$ based on $\check{Q}_{n}\left(\beta_{n}\right)$, see (18).

### 3.3 Parameters estimation

First, the asymptotic distribution of the estimator of $\theta$ proposed in (7) is provided.
Theorem 3 Under model (1), assume that condition (A2) holds with $\theta \neq \rho$. Let $\left(k_{n}\right)$ be a sequence such that $k_{n} / \ln ^{2}(n) \rightarrow \infty, k_{n} / n \rightarrow 0$ and $k_{n} A^{2}\left[\ln \left(n / k_{n}\right)\right] / \ln ^{2}\left(n / k_{n}\right) \rightarrow 0$ as $n \rightarrow \infty$. Then,

$$
\frac{k_{n}^{1 / 2}}{\ln \left(n / k_{n}\right)}\left(\hat{\theta}_{n}^{(M)}-\theta\right) \xrightarrow{d} \mathcal{N}(0,1) .
$$

Note that from [13, Lemma 1], condition $k_{n} A^{2}\left[\ln \left(n / k_{n}\right)\right] / \ln ^{2}\left(n / k_{n}\right) \rightarrow 0$ implies $\ln \left(k_{n}\right) / \ln (n) \rightarrow 0$ as $n \rightarrow \infty$ and thus $\ln \left(n / k_{n}\right) \sim \ln (n)$. Second, the asymptotic distribution of the estimator of $a\left[\ln \left(n / k_{n}\right)\right]$ proposed in (8) is established in the following theorem.

Theorem 4 Under model (1), assume that condition (A2) holds with $\theta \neq \rho$. Let $\left(k_{n}\right)$ be a sequence such that $k_{n} / \ln ^{2}(n) \rightarrow \infty, k_{n} / n \rightarrow 0$ and $k_{n} B^{2}\left[\ln \left(n / k_{n}\right)\right] \rightarrow 0$ as $n \rightarrow \infty$. Then,

$$
k_{n}^{1 / 2}\left(\frac{\hat{a}_{n}^{(M)}\left[\ln \left(n / k_{n}\right)\right]}{a\left[\ln \left(n / k_{n}\right)\right]}-1\right) \xrightarrow{d} \mathcal{N}(0,2) .
$$

Note that, if $\rho>-1$ and $k_{n} \tilde{A}^{2}[\ln (n)] \rightarrow 0$, then $k_{n} / \ln ^{2}(n) \rightarrow 0$. Hence, Theorem 4 does not apply when $\rho \in(-1,0)$. Let us stress that this limitation also appears in [8, Theorem 1]. As a straightforward consequence of Theorems $1-4$, the asymptotic normality of the extreme quantile estimator $\breve{Q}_{n}^{(M)}\left(\beta_{n}\right)$ is obtained by considering $\hat{\theta}_{n}=\hat{\theta}_{n}^{(M)}$ and $\hat{a}_{n}\left[\ln \left(n / k_{n}\right)\right]=\hat{a}_{n}^{(M)}\left[\ln \left(n / k_{n}\right)\right]$ in (4).

Corollary 1 Under model (1), assume that (A2) holds with $\theta \neq \rho$. Let $\left(k_{n}\right)$ and $\left(\beta_{n}\right)$ be two sequences such that $n \beta_{n} \rightarrow c \geq 0, k_{n} / n \rightarrow 0, k_{n} B^{2}\left[\ln \left(n / k_{n}\right)\right] \rightarrow 0, d_{n} \rightarrow d \in[1, \infty]$ and $\left[\ln (n) \max \left(1, \ln \left(d_{n}\right)\right)\right]^{2} / k_{n} \rightarrow 0$ as $n \rightarrow \infty$. Then,

$$
\frac{k_{n}^{1 / 2} / \ln \left(n / k_{n}\right)}{a\left[\ln \left(n / k_{n}\right)\right] H_{\theta, 0}\left(d_{n}\right)} \ln \left(\frac{\check{Q}_{n}^{(M)}\left(\beta_{n}\right)}{Q\left(\beta_{n}\right)}\right) \xrightarrow{d} \mathcal{N}(0,1) .
$$

It appears that $\ln \left(n / k_{n}\right) a\left[\ln \left(n / k_{n}\right)\right] H_{\theta, 0}\left(d_{n}\right) / k_{n}^{1 / 2} \rightarrow 0$ is a sufficient condition to ensure that $\check{Q}_{n}^{(M)}\left(\beta_{n}\right)$ is a relatively consistent estimator of $Q\left(\beta_{n}\right)$, i.e. such that $\check{Q}_{n}^{(M)}\left(\beta_{n}\right) / Q\left(\beta_{n}\right) \xrightarrow{\mathbb{P}} 1$. Recalling that $\ln \left(n / k_{n}\right) \sim \ln n$ as $n \rightarrow \infty$, that $B \in \mathcal{R V}\left(\max \left(\rho, \rho^{\prime}-1\right)\right)$ and $a \in \mathcal{R V}(\theta)$, we end up with a set of three conditions on the sequences $\left(k_{n}\right)$ and $\left(\beta_{n}\right): k_{n} B^{2}(\ln n) \rightarrow 0$, $\left[\ln (n) \max \left(1, \ln \left(d_{n}\right)\right)\right]^{2} / k_{n} \rightarrow 0$ and $\left[\ln (n) a(\ln n) H_{\theta, 0}\left(d_{n}\right)\right]^{2} / k_{n} \rightarrow 0$ as $n \rightarrow \infty$. Let us illustrate how these conditions may limit the extrapolation range $\beta_{n}$ depending on the index $\theta$ of extended regular variation in three typical situations:

- Let $\beta_{n}=c / n, c \in(0,1)$. Here $d_{n} \rightarrow 1$ as $n \rightarrow \infty$, this is the least extreme case considered in Subsection 3.2, and, in view of (13), $H_{\theta, 0}\left(d_{n}\right) \sim\left[\ln \left(k_{n}\right) / \ln (n)\right]^{2} / 2$. Two constraints arise on the distribution parameters: $\rho \leq-1$ and $\theta \leq \min \left(1-\rho, 2-\rho^{\prime}\right)$. The first one, $\rho \leq-1$, was already imposed by Theorem 4. The second one is fulfilled as soon as $\theta \leq 2$ including MDA(Fréchet), see Lemma 1(ii), Finite endpoint, Weibull-tail, log-Weibull tail distributions (see Example 1) and some super-heavy tail distributions.
- Let $\beta_{n}=n^{-\tau}, d>1$. Here, $d_{n}=\tau$, this is the second extreme case considered in Subsection 3.2, and, as a particular case of (14), $H_{\theta, 0}\left(d_{n}\right)$ is constant. The constraints are: $\rho \leq-1$ and $\theta \leq-\max \left(1+\rho, \rho^{\prime}\right)$. The condition on $\theta$ is fulfilled by Finite endpoint (Example 1(iii)), Weibull-tail distributions (Example 1(i)) and some log-Weibull tail distributions (Example 1(ii)). In MDA(Fréchet), $\theta=1$ and thus the condition on the second order parameters is strengthened: $\rho \leq-2$ and $\rho^{\prime} \leq-1$.
- Let $\beta_{n}=\exp (-c n), c>0$. Here $d_{n} \rightarrow \infty$ as $n \rightarrow \infty$, this is the most extreme case considered in Subsection 3.2. In view of (15), three subcases have to be considered. If $\theta<0$ then $H_{\theta, 0}\left(d_{n}\right)$ is asymptotically constant and the conditions are $\rho \leq-2$ and $\rho^{\prime} \leq-1$. If $\theta=0$ then necessarily $\rho^{\prime}=0$ in view of $(12), H_{\theta, 0}\left(d_{n}\right) \sim(\ln n)^{2} / 2$ and it is not possible to find sequences satisfying the constraints. If $\theta>0$ then $H_{\theta, 0}\left(d_{n}\right) \sim\left(c^{\theta} / \theta\right) n^{\theta}(\ln n)^{1-\theta}$ and it is not possible either to find sequences satisfying the constraints.

In the second case where $\beta_{n}=n^{-\tau}, \tau>1$, it is possible to compare the asymptotic standard deviation of $\ln \breve{Q}_{n}^{(M)}\left(\beta_{n}\right)$, denoted by $\sigma_{n}$, to the one associated with the estimator introduced in [23], denoted by $\sigma_{n}^{\prime}$. Our Corollary 1 and [23, Corollary 2] yield:

$$
\begin{aligned}
\sigma_{n} & \sim H_{\theta, 0}(\tau) k_{n}^{-1 / 2}(\ln n) a(\ln n) \\
\sigma_{n}^{\prime} & \sim\left(L_{\theta}^{2}(\tau)+H_{\theta, 0}^{2}(\tau)\right)^{1 / 2} k_{n}^{-1 / 2}(\ln n) a(\ln n) .
\end{aligned}
$$

As a consequence, the asymptotic standard deviations are equivalent up to a multiplicative constant:

$$
\begin{equation*}
\frac{\sigma_{n}}{\sigma_{n}^{\prime}} \rightarrow\left(1+\frac{L_{\theta}^{2}(\tau)}{H_{\theta, 0}^{2}(\tau)}\right)^{-1 / 2}=: \Lambda_{\theta}(\tau) \leq 1 \text { as } n \rightarrow \infty \tag{17}
\end{equation*}
$$

The behavior of $\Lambda_{\theta}(\tau)$ with respect to $\theta$ and $\tau$ is illustrated on Figure 1. It appears that $\Lambda_{\theta}(\tau)$ is an increasing function of $\tau$ and $\theta$. As expected $\Lambda_{\theta}(\tau) \leq 1$ meaning that $\check{Q}_{n}^{(M)}\left(\beta_{n}\right)$ is asymptotically more efficient than [23]'s competitor, all the more so as $\theta$ is small.
Finally, in view of Proposition 1, the unknown quantities $H_{\theta, 0}\left(d_{n}\right)$ and $a\left[\ln \left(n / k_{n}\right)\right]$ can be replaced by their corresponding estimators $H_{\hat{\theta}_{n}^{(M)}, 0}\left(d_{n}\right)$ and $\hat{a}_{n}^{(M)}\left[\ln \left(n / k_{n}\right)\right]$ without changing the asymptotic distribution in Corollary 1. As mentioned before, the obtained result can then lead to asymptotic confidence intervals. Letting $u_{\zeta}$ the $(1+\zeta) / 2$ th quantile from a standard Gaussian distribution,

$$
\begin{equation*}
\check{Q}_{n}^{(M)}\left(\beta_{n}\right)\left[\exp \left(-\frac{\hat{a}_{n}^{(M)}\left[\ln \left(n / k_{n}\right)\right] H_{\hat{\theta}_{n}^{(M)}, 0}\left(d_{n}\right)}{k_{n}^{1 / 2} / \ln \left(n / k_{n}\right)} u_{\zeta}\right) ; \exp \left(\frac{\hat{a}_{n}^{(M)}\left[\ln \left(n / k_{n}\right)\right] H_{\hat{\theta}_{n}^{(M)}, 0}\left(d_{n}\right)}{k_{n}^{1 / 2} / \ln \left(n / k_{n}\right)} u_{\zeta}\right)\right] \tag{18}
\end{equation*}
$$

is a confidence interval for $Q\left(\beta_{n}\right)$ of asymptotic level $\zeta$.

## 4 Validation on simulations

The finite-sample behavior of the quantile estimator $\check{Q}_{n}^{[1]}\left(\beta_{n}\right):=\check{Q}_{n}\left(\beta_{n}\right)$ defined in (4) is investigated on $N=500$ simulated random samples of size $n=5000$, in the case where $\beta_{n}=n^{-2}=$ $4.10^{-8}$.

Estimators. Three competitors are considered:

1. The first one, $\check{Q}_{n}^{[2]}\left(\beta_{n}\right)$ is deduced from (4) by letting $\hat{\theta}_{n,-}^{(M)}:=0$ in $\hat{a}_{n}^{(M)}\left[\ln \left(n / k_{n}\right)\right]$ and $\hat{\theta}_{n}^{(M)}$, see (8) and (7). The resulting estimator $\check{Q}_{n}^{[2]}\left(\beta_{n}\right)$ should perform well for estimating extreme quantiles from distributions with associated $\theta \geq 0$.
2. Similarly, the second one is also obtained by letting $\hat{\theta}_{n}^{(M)}:=0$ in (4) and $\hat{\theta}_{n,-}^{(M)}:=0$ in (8). We thus obtain:

$$
\check{Q}_{n}^{[3]}\left(\beta_{n}\right):=X_{n-k_{n}, n} \exp \left[\hat{a}_{n}\left[\ln \left(n / k_{n}\right)\right] \ln \left(\frac{\ln \beta_{n}}{\ln \left(k_{n} / n\right)}\right)\right],
$$

which is exactly the estimator dedicated to extreme quantiles from Weibull-tail distributions introduced in [13]. It should perform well for estimating extreme quantiles from distributions with associated $\theta=0$.
3. Finally, the third estimator was introduced in [23]:

$$
\check{Q}_{n}^{[4]}\left(\beta_{n}\right):=X_{n-\ell_{n}, n} \exp \left[\hat{a}_{\ell_{n}, n}^{[4]} L_{\hat{\theta}_{k_{n}, n}^{[4]}}\left(\frac{\ln \left(1 / \beta_{n}\right)}{\nu_{\ell_{n}+1, n}}\right)\right]
$$

with

$$
\begin{aligned}
\hat{a}_{\ell_{n}, n}^{[4]} & :=\frac{\hat{\gamma}_{\ell_{n}, n}}{\frac{1}{\ell_{n}} \sum_{j=1}^{\ell_{n}} L_{\hat{\theta}_{k_{n}, n}^{[4]}}\left(\frac{\nu_{j, n}}{\nu_{\ell_{n}+1, n}}\right)}, \\
\hat{\theta}_{k_{n}, n}^{[4]} & :=1+\frac{\sum_{i=1}^{k_{n}-1}\left(\ln \hat{\gamma}_{i, n}-\ln \hat{\gamma}_{k_{n}, n}\right)}{\sum_{i=1}^{k_{n}-1}\left(\ln \nu_{i+1, n}-\ln \nu_{k_{n}+1, n}\right)}, \\
\hat{\gamma}_{i, n} & :=\frac{1}{i} \sum_{j=1}^{i}\left(\ln X_{n-j+1, n}-\ln X_{n-i, n}\right),
\end{aligned}
$$

where $\nu_{i, n}:=\sum_{j=i}^{n} j^{-1}$ and $\ell_{n}=k_{n} \nu_{k_{n}+1, n}^{2}$.
Distribution functions. The estimators are compared on the 8 distributions described in Table 1: $\operatorname{Gamma}(a=1.5, s)$, Weibull $\left(k=0.5, \lambda_{1}\right)$, $\operatorname{Gaussian}\left(\mu_{1}, \sigma=1\right), \operatorname{Lognormal}\left(\mu_{2}, \sigma=1\right)$, $\operatorname{Burr}\left(\lambda_{2}, c=0.5, k=0.5\right)$, Pareto-like, super heavy-tail and finite endpoint $\left(x^{*}\right)$. Note that the Pareto-like distribution is taken from [23]. The position parameters $\mu_{1}, \mu_{2}$ as well as the scaling parameters $s, \lambda_{1}, \lambda_{2}$ and the finite endpoint $x^{*}$ are chosen such that the simulated data points are all larger than 1 .

Results. The $\log$ ratio errors $\check{\nu}_{n}^{[q]}:=\ln \left(\check{Q}_{n}^{[q]}\left(\beta_{n}\right) / Q_{n}\left(\beta_{n}\right)\right)$ are computed for all 4 estimators $(q=1, \ldots, 4)$, for each of the 500 datasets from the 8 distributions. The bias of each estimator is then estimated (on a logarithmic scale) by averaging the $\check{\nu}_{n}^{[q]}$ over the $N=500$ replications. Similarly, the mean-squared error (MSE) is evaluated (on a logarithmic scale) by averaging the squared $\check{\nu}_{n}^{[q]}$ over the $N=500$ replications.

The resulting bias and MSE associated are displayed on Figures $2-5$ as functions of $k_{n}$. In terms of bias, it appears that $\check{Q}_{n}^{[1]}\left(\beta_{n}\right)$ show pretty good results with a small bias over a large range of $k_{n}$ values for Gamma, Weibull, Gaussian, Lognormal, super heavy-tail and finite endpoint
distributions. The bias behavior of $\check{Q}_{n}^{[1]}\left(\beta_{n}\right)$ is less satisfying on Burr and Pareto-like distributions ( $\theta=1$ in both cases) where $\check{Q}_{n}^{[4]}\left(\beta_{n}\right)$ is the best in terms of bias stability. From the MSE point of view, $\check{Q}_{n}^{[1]}\left(\beta_{n}\right)$ achieves better performances than $\check{Q}_{n}^{[4]}\left(\beta_{n}\right)$ on almost all distributions except the Pareto-like where the results are similar and the Burr distribution where $\check{Q}_{n}^{[4]}\left(\beta_{n}\right)$ is better than $\check{Q}_{n}^{[1]}\left(\beta_{n}\right)$.

Let us also note that assuming $\theta=0$ improves the results only on the strict Weibull distribution, the results of $\check{Q}_{n}^{[3]}\left(\beta_{n}\right)$ being disappointing for other Weibull tail-distributions such as Gaussian or Gamma. Similarly, assuming $\theta>0$ improves the results only on the Gamma distribution, the results of $\check{Q}_{n}^{[2]}\left(\beta_{n}\right)$ are not convincing on other distributions. This phenomenon indicates that $\hat{\theta}_{n,-}^{(M)}$ is useful even in case where $\theta>0$, since it may temper the positive bias associated with $\hat{\theta}_{n,+}^{(M)}$.

## 5 Illustration on real data

In this section, the extreme quantile estimators $\check{Q}_{n}^{[1]}\left(\beta_{n}\right)$ and $\check{Q}_{n}^{[4]}\left(\beta_{n}\right)$ are compared on the average daily river flows (in $m^{3} / s$ ) of the Rhône river (France). The dataset covers the period 1915-2013, and for stationarity reasons, only the winter and spring seasons were considered (from December, 1st to May, 31st), leading to $n=18043$ measures. We focus on the extreme quantile $Q\left(\beta_{n}\right)$ with $\beta_{n}=5.5 \times 10^{-6}$ which is exceeded with a frequency of $10^{-3}$ per year. Figure 6 displays the index estimates $\hat{\theta}_{n}^{(M)}$ and $\hat{\theta}_{k_{n}, n}^{[4]}$ as well as the estimates $\check{Q}_{n}^{[1]}\left(\beta_{n}\right)$ and $\check{Q}_{n}^{[4]}\left(\beta_{n}\right)$ of the extreme quantile together with their corresponding $95 \%$ asymptotic confidence intervals.

In both cases, the index estimates seem fairly stable as a function of $k_{n}$, suggesting a positive value for $\theta \in[0.3,0.4]$ associated with a log-Weibull tail-distribution. The behavior of extreme quantile estimates $\check{Q}_{n}^{[1]}\left(\beta_{n}\right)$ and $\check{Q}_{n}^{[4]}\left(\beta_{n}\right)$ are also similar, $\check{Q}_{n}^{[1]}\left(\beta_{n}\right)$ being more stable with respect to $k_{n}$ than $\check{Q}_{n}^{[4]}\left(\beta_{n}\right)$. The first estimator $\check{Q}_{n}^{[1]}\left(\beta_{n}\right)$ points towards a constant value $Q\left(\beta_{n}\right) \approx 10,000 \mathrm{~m}^{3} / \mathrm{s}$ while the second one $\check{Q}_{n}^{[4]}\left(\beta_{n}\right)$ exhibits a trend from 8000 to $12000 \mathrm{~m}^{3} / \mathrm{s}$ as $k_{n}$ vary from 100 to 2000 . At the opposite, the widths of the $95 \%$ asymptotic confidence intervals associated with both estimators are significantly different. Indeed, the interval associated with $\check{Q}_{n}^{[1]}\left(\beta_{n}\right)$ is 10 times narrower than the one associated with $\check{Q}_{n}^{[4]}\left(\beta_{n}\right)$. This result is in accordance with (17) since here $\tau \simeq 1.24$ yields $\Lambda_{\theta}(\tau) \simeq 0.1$ for a large range of $\theta$ values, see Figure 1 .

## 6 Appendix: Proofs

### 6.1 Preliminary lemmas

We first give a general tool for establishing the convergence in distribution of random vectors.
Lemma 2 For $p \in \mathbb{N} \backslash\{0\}$ and $n \in \mathbb{N}$, let $W_{n}:=\left(W_{n, 1}, \ldots, W_{n, p}\right)^{\top}$ and $W:=\left(W_{1}, \ldots, W_{p}\right)^{\top}$ be two random vectors in $\mathbb{R}^{p}$. If there exist a sequence $\sigma_{n} \rightarrow 0$ and $\lambda:=\left(\lambda_{1}, \ldots, \lambda_{p}\right)^{\top} \in \mathbb{R}^{p}$ such that $\sigma_{n}^{-1}\left(W_{n}-\lambda\right) \xrightarrow{d} W$ then, for all $q \in \mathbb{N} \backslash\{0\}$ and all continuously differentiable functions $\varphi_{1}, \ldots, \varphi_{q}$ from $\mathbb{R}^{p}$ to $\mathbb{R}$,

$$
\sigma_{n}^{-1}\left[\left(\varphi_{1}\left(W_{n}\right), \ldots, \varphi_{q}\left(W_{n}\right)\right)^{\top}-\left(\varphi_{1}(\lambda), \ldots, \varphi_{q}(\lambda)\right)^{\top}\right] \stackrel{d}{\longrightarrow}\left(W^{\top} \nabla \varphi_{1}(\lambda), \ldots, W^{\top} \nabla \varphi_{q}(\lambda)\right)
$$

where, for all $i \in\{1, \ldots, q\}, \nabla \varphi_{i}(\lambda)$ is the gradient of $\varphi_{i}$ evaluated at point $\lambda$.
The following lemma is the cornerstone for establishing the asymptotic normality of the quantile estimator in the intermediate case.

Lemma 3 Let $Z_{1}, \ldots, Z_{n}$ be $n$ independent copies of a random variable $Z$. Denote by $S_{Z}$ the survival function of $Z$ and by $Q_{Z}=S_{Z}^{\overleftarrow{ }}$ the associated quantile function. Assume $Q_{Z}$ is differentiable and that $-Q_{Z}^{\prime}(1 / \cdot)$ is regularly varying. Then, for all sequence $\left(\alpha_{n}\right)$ such that $\alpha_{n} \rightarrow 0$ and $n \alpha_{n} \rightarrow \infty$,

$$
\frac{n^{1 / 2}}{\alpha_{n}^{1 / 2} Q_{Z}^{\prime}\left(\alpha_{n}\right)}\left(Z_{n-\left\lfloor n \alpha_{n}\right\rfloor, n}-Q_{Z}\left(\alpha_{n}\right)\right) \xrightarrow{d} \mathcal{N}(0,1) .
$$

An elementary result on ordered statistics from standard uniform random variables is provided below.

Lemma 4 Let $U_{1}, \ldots, U_{n}$ be independent standard uniform variables. For all intermediate sequence $\left(k_{n}\right)$, i.e. such that $k_{n} \rightarrow \infty$ and $k_{n} / n \rightarrow 0$, one has
(i) $U_{k_{n}+1, n} \xrightarrow{\mathbb{P}} 0$.
(ii) Let $\left\{F_{1}, \ldots, F_{k_{n}}\right\}$ and $\left\{E_{1}, \ldots, E_{n}\right\}$ be two independent samples of independent standard exponential random variables. Then,

$$
\left\{\frac{\ln \left(U_{i+1, n} / U_{k_{n}+1, n}\right)}{\ln \left(U_{k_{n}+1, n}\right)}, i=0, \ldots, k_{n}-1\right\} \stackrel{d}{=}\left\{\frac{F_{k_{n}-i, k_{n}}}{E_{n-k_{n}, n}}, i=0, \ldots, k_{n}-1\right\},
$$

where $\left\{F_{1}, \ldots, F_{k_{n}}\right\}$ are independent from $E_{n-k_{n}, n}$.
(iii)

$$
\max _{i \in\left\{0, \ldots, k_{n}-1\right\}} \frac{\ln \left(U_{i+1, n} / U_{k_{n}+1, n}\right)}{\ln \left(U_{k_{n}+1, n}\right)} \xrightarrow{\mathbb{P}} 0
$$

Let us introduce some additional notations. For $J \in \mathbb{N} \backslash\{0\}, \zeta:=\left(\zeta_{1}, \ldots, \zeta_{J}\right)^{\top} \in(-\infty, 1)^{J}$ and $t>0$, consider the functions

$$
S_{n}(\zeta):=\frac{1}{k_{n}} \sum_{i=0}^{k_{n}-1} \prod_{j=1}^{J} L_{\zeta_{j}}\left(\frac{\ln U_{i+1, n}}{\ln U_{k_{n}+1, n}}\right) \text { and } \mu(t, \zeta):=\int_{0}^{1} \prod_{j=1}^{J} L_{\zeta_{j}}\left(1-\frac{\ln s}{t}\right) d s
$$

and remark that, for $J=1$ and $\zeta<1, \mu(t, \zeta)=\mu_{1}(t, \zeta)$ and, for $J=2, \mu[t,(\zeta, \zeta)]=\mu_{2}(t, \zeta)$. Let us also recall that, from Section $2, \Psi_{t}(\zeta)=\mu_{1}^{2}(t, \zeta) / \mu_{2}(t, \zeta)$ for all $t>0$ and $\zeta<1$. The next result is of analytical nature. It provides first-order asymptotic expansions as $t \rightarrow \infty$ for functions $\mu(t, \zeta)$ and $\Psi_{t}(\zeta)$ locally uniformly on $\zeta$.

Lemma 5 (i) Let $J \in \mathbb{N} \backslash\{0\}$. For all hyper-rectangle $\mathcal{R}_{J} \subset(-\infty, 1)^{J}$, one has

$$
\lim _{t \rightarrow \infty} \sup _{\zeta \in \mathcal{R}_{J}}\left|t^{J} \mu(t, \zeta)-J!\right|=0
$$

(ii) Denoting by $\Psi_{t}^{\prime}$ the first derivative of $\Psi_{t}$, one has, for all closed interval $I \subset(-\infty, 1)$,

$$
\lim _{t \rightarrow \infty} \sup _{\zeta \in I}\left|t \Psi_{t}^{\prime}(\zeta)+\frac{1}{2}\right|=0
$$

As a consequence of Lemma $5(\mathrm{ii})$, the function $\Psi_{t}$ is decreasing at least for $t$ large enough. Lemma 6 below states Law of Large Numbers type results dedicated to particular triangular arrays of random variables.

Lemma 6 Let $\left(t_{m}\right)$ be a sequence such that $\log (m) / t_{m} \rightarrow 0$ as $m \rightarrow \infty$ and let $F_{1}, \ldots, F_{m}$ be independent copies of a standard exponential random variable.
(i) For all $\delta>0$ and $\zeta \in(-\infty, 1)^{J}$ with $J \in \mathbb{N} \backslash\{0\}$, one has

$$
\frac{t_{m}^{J-1}}{m} \sum_{i=1}^{m} F_{i}\left(1+\frac{F_{i}}{t_{m}}\right)^{\zeta_{1}-1} \prod_{j=2}^{J} L_{\zeta_{j}}\left(1+\frac{F_{i}}{\delta t_{m}}\right) \xrightarrow{\mathbb{P}} J!/ \delta^{J-1}
$$

(ii) For all $\delta>0$, $\left(\xi_{1}, \ldots, \xi_{4}\right) \in(-\infty, 1)^{4}$ with $\xi_{3}>\xi_{4}$ and $J_{i} \in \mathbb{N}$, $i \in\{1,2,3\}$, one has for $J=J_{1}+J_{2}+2 J_{3}$ that
$\frac{t_{m}^{J}}{m} \sum_{i=1}^{m} L_{\xi_{1}}^{J_{1}}\left(1+\frac{F_{i}}{\delta t_{m}}\right) L_{\xi_{2}}^{J_{2}}\left(1+\frac{F_{i}}{\delta t_{m}}\right)\left[L_{\xi_{3}}\left(1+\frac{F_{i}}{\delta t_{m}}\right)-L_{\xi_{4}}\left(1+\frac{F_{i}}{\delta t_{m}}\right)\right]^{J_{3}} \xrightarrow{\mathbb{P}} \frac{J!}{\delta^{J}}\left(\frac{\xi_{3}-\xi_{4}}{2}\right)^{J_{3}}$.
Finally, Lemmas 7 and 8 are the key tools for establishing the joint asymptotic normality of the random pair $\left(M_{n}^{(1)}, M_{n}^{(2)}\right)$.

Lemma 7 Let $\left(k_{n}\right)$ be an intermediate sequence such that $k_{n} \rightarrow \infty$ and $\ln \left(k_{n}\right) / \ln (n) \rightarrow 0$ as $n \rightarrow \infty$. For $J_{1}, J_{2} \in \mathbb{N} \backslash\{0\}$ and for all $\zeta^{(1)} \in(-\infty, 1)^{J_{1}}, \zeta^{(2)} \in(-\infty, 1)^{J_{2}}$, the random vector

$$
k_{n}^{1 / 2}\left\{\frac{S_{n}\left(\zeta^{(1)}\right)}{\mu\left(\ln \left(n / k_{n}\right), \zeta^{(1)}\right)}-1, \frac{S_{n}\left(\zeta^{(2)}\right)}{\mu\left(\ln \left(n / k_{n}\right), \zeta^{(2)}\right)}-1\right\}
$$

converges in distribution to a centered Gaussian random vector with covariance matrix

$$
\left(\begin{array}{cc}
\left(2 J_{1}\right)!/\left(J_{1}!\right)^{2}-1 & \left(J_{1}+J_{2}\right)!/\left(J_{1}!J_{2}!\right)-1 \\
\left(J_{1}+J_{2}\right)!/\left(J_{1}!J_{2}!\right)-1 & \left(2 J_{2}\right)!/\left(J_{2}!\right)^{2}-1
\end{array}\right)
$$

Lemma 8 Let $\left(k_{n}\right)$ be an intermediate sequence such that $k_{n} \rightarrow \infty$ and $\ln \left(k_{n}\right) / \ln (n) \rightarrow 0$ as $n \rightarrow \infty$. For all $\left(\xi_{1}, \ldots, \xi_{4}\right) \in(-\infty, 1)^{4}$ with $\xi_{3}>\xi_{4}$ and $J_{i} \in \mathbb{N}, i \in\{1,2,3\}$, one has for $J=J_{1}+J_{2}+2 J_{3}$ that

$$
\frac{\left[\ln \left(n / k_{n}\right)\right]^{J}}{k_{n}} \sum_{i=0}^{k_{n}-1} L_{\xi_{1}}^{J_{1}}\left(\frac{\ln U_{i+1, n}}{\ln U_{k_{n}+1, n}}\right) L_{\xi_{2}}^{J_{2}}\left(\frac{\ln U_{i+1, n}}{\ln U_{k_{n}+1, n}}\right)\left[L_{\xi_{3}}\left(\frac{\ln U_{i+1, n}}{\ln U_{k_{n}+1, n}}\right)-L_{\xi_{4}}\left(\frac{\ln U_{i+1, n}}{\ln U_{k_{n}+1, n}}\right)\right]^{J_{3}}
$$

converges in probability to $J!\left(\frac{\xi_{3}-\xi_{4}}{2}\right)^{J_{3}}$.

### 6.2 Proofs of main results

Proof of Theorem 1 Let $\left\{Z_{i}:=\ln \left(X_{i}\right), i=1, \ldots, n\right\}$. These random variables are independent with common quantile function $Q_{Z}(u)=V[\ln (1 / u)], u \in(0,1)$. Under (A1), $Q_{Z}$ is differentiable with first derivative verifying $-Q_{Z}^{\prime}(1 / x)=x V^{\prime}[\ln (x)] \in \mathcal{R} \mathcal{V}(1)$. One can thus apply Lemma 3 to obtain

$$
\frac{\left(n \alpha_{n}\right)^{1 / 2}}{V^{\prime}\left[\ln \left(\alpha_{n}^{-1}\right)\right]}\left(Z_{n-\left\lfloor n \alpha_{n}\right\rfloor, n}-Q_{Z}\left(\alpha_{n}\right)\right) \xrightarrow{d} \mathcal{N}(0,1) .
$$

Now, since $a(x) \sim x V^{\prime}(x)$ as $x \rightarrow \infty$ in view of [15, Corollary 1.1.10], it follows that

$$
\frac{\left(n \alpha_{n}\right)^{1 / 2} \ln \left(\alpha_{n}^{-1}\right)}{a\left[\ln \left(\alpha_{n}^{-1}\right)\right]}\left(Z_{n-\left\lfloor n \alpha_{n}\right\rfloor, n}-Q_{Z}\left(\alpha_{n}\right)\right) \xrightarrow{d} \mathcal{N}(0,1) .
$$

The result is then proved by remarking that $Z_{n-\left\lfloor n \alpha_{n}\right\rfloor, n}=\ln \left(X_{n-\left\lfloor n \alpha_{n}\right\rfloor, n}\right)$ and $Q_{Z}=\ln Q$.

Proof of Proposition 1 - Let us first show that

$$
\frac{\hat{a}_{n}\left[\ln \left(n / k_{n}\right)\right]}{a\left[\ln \left(n / k_{n}\right)\right]} \xrightarrow{\mathbb{P}} 1 .
$$

In view of

$$
\sigma_{n}^{-1} \frac{L_{\theta}\left(d_{n}\right)}{H_{\theta, 0}\left(d_{n}\right)}\left(\frac{\hat{a}_{n}\left[\ln \left(n / k_{n}\right)\right]}{a\left[\ln \left(n / k_{n}\right)\right]}-1\right) \xrightarrow{d} \Lambda
$$

it is sufficient to prove that $\sigma_{n}^{-1} L_{\theta}\left(d_{n}\right) / H_{\theta, 0}\left(d_{n}\right) \rightarrow \infty$ as $n \rightarrow \infty$.
Let us first assume that $d_{n} \rightarrow 1$ as $n \rightarrow \infty$. Since $L_{\theta}(1+u) \sim u$ and $H_{\theta, 0}(1+u) \sim u^{2} / 2$ as $u \rightarrow 0, L_{\theta}\left(d_{n}\right) / H_{\theta, 0}\left(d_{n}\right) \sim 2 /\left(d_{n}-1\right)$ and $\sigma_{n}^{-1} L_{\theta}\left(d_{n}\right) / H_{\theta, 0}\left(d_{n}\right) \rightarrow \infty$ as $n \rightarrow \infty$. Second, if $d_{n} \rightarrow d \in(1, \infty)$ then $L_{\theta}\left(d_{n}\right) / H_{\theta, 0}\left(d_{n}\right) \rightarrow L_{\theta}(d) / H_{\theta, 0}(d)>0$ and the result is proved. Finally, if $d_{n} \rightarrow \infty$, remarking that, as $t \rightarrow \infty$,

$$
\frac{L_{\theta}(t)}{H_{\theta, 0}(t)} \sim \begin{cases}1 / \ln (t) & \text { if } \theta>0  \tag{19}\\ 2 / \ln (t) & \text { if } \theta=0 \\ -\theta & \text { if } \theta<0\end{cases}
$$

implies $\sigma_{n}^{-1} L_{\theta}\left(d_{n}\right) / H_{\theta, 0}\left(d_{n}\right) \rightarrow \infty$ by assumption.

Let us now prove the second part of Proposition 1. The following equality holds:

$$
\begin{equation*}
H_{\hat{\theta}_{n}, 0}\left(d_{n}\right)-H_{\theta, 0}\left(d_{n}\right)=\left(\hat{\theta}_{n}-\theta\right) \int_{1}^{d_{n}} s^{\theta-1} \ln ^{2}(s) \frac{\exp \left[\left(\hat{\theta}_{n}-\theta\right) \ln (s)\right]-1}{\left(\hat{\theta}_{n}-\theta\right) \ln (s)} d s \tag{20}
\end{equation*}
$$

Since for all $s \in\left(1, d_{n}\right),\left|\left(\hat{\theta}_{n}-\theta\right) \ln (s)\right| \leq\left|\hat{\theta}_{n}-\theta\right| \ln \left(d_{n}\right)=O_{\mathbb{P}}\left(\sigma_{n} \ln d_{n}\right)=o_{\mathbb{P}}(1)$ by assumption, it is easy to check that

$$
H_{\hat{\theta}_{n}, 0}\left(d_{n}\right)-H_{\theta, 0}\left(d_{n}\right)=\left(\hat{\theta}_{n}-\theta\right) \int_{1}^{d_{n}} s^{\theta-1} \ln ^{2}(s) d s\left(1+o_{\mathbb{P}}(1)\right)
$$

or equivalently,

$$
\frac{H_{\hat{\theta}_{n}, 0}\left(d_{n}\right)}{H_{\theta, 0}\left(d_{n}\right)}-1=\sigma_{n}^{-1}\left(\hat{\theta}_{n}-\theta\right) \times \frac{\sigma_{n}}{H_{\theta, 0}\left(d_{n}\right)} \int_{1}^{d_{n}} s^{\theta-1} \ln ^{2}(s) d s\left(1+o_{\mathbb{P}}(1)\right)
$$

The three situations $d_{n} \rightarrow 1, d_{n} \rightarrow d>1$ and $d_{n} \rightarrow \infty$ are again considered separately. First, since

$$
\int_{1}^{1+u} s^{\theta-1} \ln ^{2}(s) d s \sim \frac{u^{3}}{3} \text { and } H_{\theta, 0}(u) \sim \frac{u^{2}}{2}
$$

as $u \rightarrow 0$, one has for $d_{n} \rightarrow 1$ that

$$
\frac{H_{\hat{\theta}_{n}, 0}\left(d_{n}\right)}{H_{\theta, 0}\left(d_{n}\right)}-1 \sim \sigma_{n}^{-1}\left(\hat{\theta}_{n}-\theta\right) \times \frac{2}{3} \sigma_{n}\left(d_{n}-1\right) \xrightarrow{\mathbb{P}} 0
$$

The case $d_{n} \rightarrow d$ is straightforward. Finally, when $d_{n} \rightarrow \infty$,

$$
\frac{1}{H_{\theta, 0}\left(d_{n}\right)} \int_{1}^{d_{n}} s^{\theta-1} \ln ^{2}(s) d s \sim \begin{cases}\ln \left(d_{n}\right) & \text { if } \theta>0 \\ 3 \ln \left(d_{n}\right) / 2 & \text { if } \theta=0 \\ -2 / \theta & \text { if } \theta<0\end{cases}
$$

Collecting conditions $\sigma_{n} \ln \left(d_{n}\right) \rightarrow 0$ and $\sigma_{n}^{-1}\left(\hat{\theta}_{n}-\theta\right) \xrightarrow{d} \Theta$ concludes the proof.

Proof of Theorem 2 - Let us start with the expansion:

$$
\frac{\sigma_{n}^{-1}}{a\left[\ln \left(n / k_{n}\right)\right] H_{\theta, 0}\left(d_{n}\right)} \ln \frac{\check{Q}_{n}\left(\beta_{n}\right)}{Q\left(\beta_{n}\right)}=T_{1, n}+T_{2, n}+T_{3, n}+T_{4, n}
$$

with

$$
\begin{aligned}
T_{1, n} & =\frac{\sigma_{n}^{-1}}{a\left[\ln \left(n / k_{n}\right)\right] H_{\theta, 0}\left(d_{n}\right)}\left[\ln X_{n-k_{n}, n}-\ln Q\left(k_{n} / n\right)\right] \\
T_{2, n} & =\frac{\hat{a}_{n}\left[\ln \left(n / k_{n}\right)\right]}{a\left[\ln \left(n / k_{n}\right)\right] H_{\theta, 0}\left(d_{n}\right)} \sigma_{n}^{-1}\left[L_{\hat{\theta}_{n}}\left(d_{n}\right)-L_{\theta}\left(d_{n}\right)\right] \\
T_{3, n} & =\frac{L_{\theta}\left(d_{n}\right)}{H_{\theta, 0}\left(d_{n}\right)} \sigma_{n}^{-1}\left[\frac{\hat{a}_{n}\left[\ln \left(n / k_{n}\right)\right]}{a\left[\ln \left(n / k_{n}\right)\right]}-1\right] \\
T_{4, n} & =\frac{\sigma_{n}^{-1}}{H_{\theta, 0}\left(d_{n}\right)}\left[\frac{\ln Q\left(k_{n} / n\right)-\ln Q\left(\beta_{n}\right)}{a\left[\ln \left(n / k_{n}\right)\right]}+L_{\theta}\left(d_{n}\right)\right]
\end{aligned}
$$

Clearly, under (A3), $T_{1, n} \xrightarrow{d} B$ and $T_{3, n} \xrightarrow{d} \Lambda$. Next, remark that Proposition 1 entails that the asymptotic distribution of $T_{2, n}$ is the same as the one of

As a consequence, $T_{2, n} \xrightarrow{d} \Theta$. Finally, since $\ln Q(\alpha)=V[\ln (1 / \alpha)]$, it follows that

First, if $d_{n} \rightarrow 1$, the second order condition (A2) entails $H_{\theta, 0}\left(d_{n}\right) \sigma_{n} T_{4, n} \sim H_{\theta, \rho}\left(d_{n}\right) \tilde{A}\left[\ln \left(n / k_{n}\right)\right]$. Since for all $\rho \leq 0, H_{\theta, \rho}(1+u) \sim H_{\theta, 0}(1+u) \sim u^{2} / 2$ as $u \rightarrow 0$, it follows that $T_{4, n} \sim$ $\sigma_{n}^{-1} \tilde{A}\left[\ln \left(n / k_{n}\right)\right]=o(1)$ by assumption.
Next, if $d_{n} \rightarrow d>1$, conditions (A2) and $\sigma_{n}^{-1} \tilde{A}\left[\ln \left(n / k_{n}\right)\right] \rightarrow 0$ imply that $T_{4, n} \rightarrow 0$ as $n \rightarrow \infty$. Finally, when $d_{n} \rightarrow \infty$, [15, Lemma 4.3.5] entails that

\end{aligned}

+ & \frac{2 A\left(\ln U_{k_{n}+1, n}^{-1}\right)}{k_{n} \mu_{2}\left[\ln \left(n / k_{n}\right), \theta_{-}\right]} \sum_{i=0}^{k_{n}-1} L_{\theta_{-}}\left(\frac{\ln U_{i+1, n}}{\ln U_{k_{n}+1, n}}\right) H_{\theta_{-}, \rho^{\prime}}\left(\frac{\ln U_{i+1, n}}{\ln U_{k_{n}+1, n}}\right)\left(1+o_{\mathbb{P}}(1)\right) \\
+ & \frac{A^{2}\left(\ln U_{k_{n}+1, n}^{-1}\right)}{k_{n} \mu_{2}\left[\ln \left(n / k_{n}\right), \theta_{-}\right]} \sum_{i=0}^{k_{n}-1} H_{\theta_{-}, \rho^{\prime}}^{2}\left(\frac{\ln U_{i+1, n}}{\ln U_{k_{n}+1, n}}\right)\left(1+o_{\mathbb{P}}(1)\right)
\end{aligned}

From Rényi's representation, $\ln \left(1 / U_{k_{n}+1, n}\right) / \ln \left(n / k_{n}\right) \xrightarrow{\mathbb{P}} 1$ and since $|A|$ is regularly varying, it follows that

= & {\left[\ln \left(n / k_{n}\right)\right]^{2} \dot{\mu}\left[\ln \left(n / k_{n}\right), \theta_{n,-}^{*}\right] \frac{k_{n}^{1 / 2}}{\ln \left(n / k_{n}\right)}\left(\hat{\theta}_{n,-}^{(M)}-\theta_{-}\right) \xrightarrow{d} 2 P_{1}-P 2 }
\end{aligned}
$$

from (26). Lemma 5(i) yields

L_{\xi_{3}}\left(1+\frac{F_{i}}{\delta t_{m}}\right)-L_{\xi_{4}}\left(1+\frac{F_{i}}{\delta t_{m}}\right)=\frac{\xi_{3}-\xi_{4}}{2}\left(\frac{F_{i}}{\delta t_{m}}\right)^{2}\left(1+o_{\mathbb{P}}(1)\right)
$$

The rest of the proof follows the same lines as the one of (i) and is thus omitted.
Proof of Lemma 7 - Using the Cramér-Wold device, it suffices to obtain the asymptotic distribution of

for $i=1, \ldots, k_{n}$ and where $F_{1}, \ldots, F_{k_{n}}$ are independent standard exponential random variables. Lemma 4(ii) yields

& +2 \beta_{1} \beta_{2} \frac{\mu\left(\ln \left(n / k_{n}\right),\left(\zeta^{(1)}, \zeta^{(2)}\right)\right)}{\mu\left(\ln \left(n / k_{n}\right), \zeta^{(1)}\right) \mu\left(\ln \left(n / k_{n}\right), \zeta^{(2)}\right)}
\end{aligned}

As a direct consequence of Lemma 5(i), one has

& +\frac{\beta_{2}}{t^{2} \mu\left(\ln \left(n / k_{n}\right), \zeta^{(2)}\right)} \sum_{l=1}^{J_{2}}\left[\frac{1}{k_{n}} \sum_{i=1}^{k_{n}} F_{i}\left(1+\frac{F_{i}}{t}\right)^{\zeta_{l}^{(2)}-1} \prod_{j \neq l} L_{\zeta_{j}^{(2)}}\left(1+\frac{F_{i}}{t}\right)\right] .
\end{aligned}
$$

Hence, we have to deal with random terms proportional to $T_{3, n}(t, t)$ where

with $J \in \mathbb{N} \backslash\{0\}$ and $\zeta \in \mathbb{R}^{J}$. To prove (46) let us check that

\end{equation*}

For all $\eta>0$, let $0<\varepsilon<\min \left\{\eta_{+}, \eta_{-}\right\}$where $\eta_{+}=1-[(1+\eta / 2) /(1+\eta)]^{1 / 2}$ and $\eta_{-}=[(1-$ $\eta / 2) /(1-\eta)]^{1 / 2}-1$. Let us also introduce the Borel set

Using the inequality $K+\varepsilon-K /(1+\varepsilon)^{J} \geq \varepsilon$ yields
