# Weighted Automata Computation of Edit Distances with Consolidations and Fragmentations

#### Abstract

We study edit distances between strings, based of based on operations of character substitutions, insertions, deletions and additionally consolidations and fragmentations. The two latter operations transform a sequence of characters into one character and vice-versa. They correspond to the compression and expansion in Dynamic Time-Warping algorithms for speech recognition and are also used for the formal analysis of written music.

Such edit distances are not computable in general. We propose weighted automaton constructions to compute in polynomial time an edit distance taking into account both consolidations and deletions, or both fragmentations and insertions. We finally show that the optimal weight of sequences made of consolidations chained with fragmentations, in that order, is computable in polynomial time, and not computable if we reverse the order of fragmentations and consolidations.


## 1 Introduction

Edit distances measure similarity between two sequences of symbols, usually with substitution, insertion and deletion operations. Each of these operations is given a weight (or cost), and the edit distance is defined as the minimal weight of a transformation of one sequence into the other using the operations. For the Levenshtein distance [15], all operations have a weight of 1 , but more elaborated weights schemes are also used: In bioinformatics, to compare proteins seen as sequences over the 20letter alphabet of amino acids, the BLOSUM62 substitution matrix [4] reflects the probability of substitution of any two amino acids. Edit distances are also applied in computer music to measure melodic similarity. This is particularly useful in a digital humanities context, for assistance to the analysis of written music. In 1990, Mongeau and Sankoff [12] proposed to extend edit distance with consolidation and fragmentation operations to account for common transformations between melodic patterns - see Figure 1. These operations correspond to the compression and expansion in dynamic time-warping algorithms for e.g. speech recognition [7].

Edit distances between strings are usually computed with dynamic programming [15. More generic algorithms have been proposed to compute the edit distance

between two regular languages [11] with construction and composition of weighted transducers. These approaches are applied to standard Levenshtein edit-distance and are applicable to more general edit-distance defined by arbitrary sets of edit operations, provided that these operations are expressed as weighted string transducers [11]. In an unweighted context, it has been shown that some class of string rewriting rules including consolidation (but much more general) effectively preserves regularity [5]. This means that given a finite automaton $\mathcal{A}$ and such a set of string rewriting operations $E$, it is possible to compute a finite automaton recognising the closure of the language of $\mathcal{A}$ by $E$.

In this paper, after defining edit distances with consolidation and fragmentation operations, we show that they are not computable in general (Section 2). We then propose a construction of weighted automata to compute the optimal weight of edit operations sequences including usual operations together with consolidations, or either with fragmentations, but not both in the same time (Section 3). We finally show how to account for edit operations sequences that include consolidations chained with fragmentations (Section 4).

## 2 Edit Distance with Consolidations and Fragmentations

In this section, we define extended edit distances between finite sequences of symbols, that can include generic consolidation or fragmentation operations and where the weights are values in a semiring with some properties.
Let us consider a fixed finite alphabet $\Sigma$. We use letters $a, b \ldots$ to denote symbols of $\Sigma$. The monoid of words (strings) over $\Sigma$ is denoted $\Sigma^{*}, \varepsilon$ is the empty sequence and $u v$ denotes the concatenation of $u \in \Sigma^{*}$ and $v \in \Sigma^{*}$. For a string $s=a_{1} \ldots a_{n} \in \Sigma^{*}$, and $0 \leq i \leq n, s_{1 . .}$ denotes the prefix of $s$ of length $i: s_{1 . . i}=a_{1} \ldots a_{i}$ when $0<i \leq n$, and $u_{1 . .0}=\varepsilon$.

### 2.1 Edit Operations and Rulesets

The Levenshtein edit distance [15] between two strings $s$ and $t$ is defined as the minimum number of elementary editions transforming $s$ into $t$, using operations of substitution (replacement of one character by another), single-character insertion and deletion. Here, we consider more general edition operations ranged in two families, and which include substitution, insertion and deletion.

An edit operation is a pair $u \rightarrow v$ with $u, v \in \Sigma^{*}$. Note that both $u$ and $v$ can be $\varepsilon$, and that this is generally not the case for $u$ in the string rewriting theory [1]. The operations of the first family, called fragmentations, have the form

(fragmentation)
where $a, b_{1}, \ldots, b_{n} \in \Sigma$ and $n \geq 0$. When $n=0$, the fragmentation operation is called (deletion), and when $n=1$, it is a (substitution). The operations of the second family, called consolidations, have the form

where $a_{1}, \ldots, a_{n}, b \in \Sigma$ and $n \geq 0$. When $n=0$, the consolidation operation is called (insertion). The case $n=1$ still corresponds to the above case of substitution. A ruleset $E$ is a finite set of edit operations. Its size $\|E\|$ is the sum of the size of the strings in its rules.
Its symmetric is $E^{-1}=\{v \rightarrow u \mid u \rightarrow v \in E\}$.
Example 1. The ruleset $E_{0}=\{a \rightarrow b, \varepsilon \rightarrow b, a \rightarrow \varepsilon \mid a, b \in \Sigma, a \neq b\}$ contains all the substitution, insertion, and deletion operations over $\Sigma$.

Example 2. Figure 2 describes, on a 3-letter alphabet, the rulesets $E_{0}=E_{3, \mathrm{~s}} \cup$ $E_{3, \mathrm{i}} \cup E_{3, \mathrm{~d}}$ (substitutions, insertions, deletions), $E_{3, \mathrm{c}}$ (same-letter consolidations up to 3 letters) and $E_{3, f}$ (same-letter fragmentations up to 3 letters),

In music analysis, consolidation/fragmentation rules are used to transform a note into several ones, typically preserving the total duration (See Figure 1). In speech processing, compression and expansion are used in time-wrapping techniques for comparing time series subject to variations in speed [7]. In both of these cases, it is preferable to define these operations rather than using several insertions/deletions.

### 2.2 Weight Domains

An edit distance is defined by assigning every edit operation in a ruleset $E$ with a weight value. In the case of usual edit distances based on $E_{0}$, these weight values are strictly positive real numbers ( 1 for the Levenshtein distance) and the weight of a sequence of edit operations is the sum of the individual weights of the rules

involved. The edit distance between two strings $s$ and $t$ is then the minimal weight of a sequence transforming $s$ into $t$.

We consider here abstract domains for weight values, as semirings with an operator $\otimes$, for the composition of weights in a sequence of edit operations, and an operator $\oplus$ for the selection of the optimal sequence in the definition of the edit distance. This generalisation simplifies the proofs and enables identification of the algebraic properties of the weight domain which are necessary for ensuring the correctness of automata construction for the computation of edit distances.
Definition 1. $A$ semiring $\mathcal{S}=\langle\mathbb{S}, \oplus, \otimes, \mathbb{0}, \mathbb{1}\rangle$ is a structure with a domain $\mathbb{S}=$ $\operatorname{dom}(\mathcal{S})$ equipped with two binary operators $\oplus$ and $\otimes$ such that: $\langle\mathbb{S}, \oplus, \mathbb{0}\rangle$ is a commutative monoid: $\oplus$ is associative and commutative and $\mathbb{D} \in \mathbb{S}$ is a neutral element for $\oplus ;\langle\mathbb{S}, \otimes, \mathbb{1}\rangle$ is a monoid: $\otimes$ is associative and $\mathbb{1} \in \mathbb{S}$ is a neutral element for $\otimes ; \otimes$ distributes over $\oplus: \forall x, y, z \in \mathbb{S}, x \otimes(y \oplus z)=(x \otimes y) \oplus(x \otimes z)$ and $(x \oplus y) \otimes z=(x \otimes z) \oplus(y \otimes z)$; and $\mathbb{0}$ is absorbing wrt $\otimes: \forall x \in \mathbb{S}, \mathbb{0} \otimes x=x \otimes \mathbb{O}=\mathbb{0}$.

We may simply write $x \in \mathcal{S}$ to mean $x \in \mathbb{S}$. A semiring $\mathcal{S}$ is commutative if $\otimes$ is commutative. It is idempotent if for all $x \in \operatorname{dom}(\mathcal{S}), x \oplus x=x$. It is $k$-closed if for all $x \in \operatorname{dom}(\mathcal{S}), \bigoplus_{n=0}^{k+1} x^{n}=\bigoplus_{n=0}^{k} x^{n}$. Following [10], if $\mathcal{S}$ is 0 -closed, i.e. when $\forall x \in \operatorname{dom}(\mathcal{S}), \mathbb{1} \oplus x=\mathbb{1}$ then it is called bounded. Note that every bounded semiring is idempotent (by boundedness, $\mathbb{1} \oplus \mathbb{1}=\mathbb{1}$, and idempotency follows by multiplying both sides by $x$ ).
A semiring $\mathcal{S}$ is complete when every infinite (countable) sum of elements of $\operatorname{dom}(\mathcal{S})$ is well-defined and in $\operatorname{dom}(\mathcal{S})$, and the following properties hold for every $I \subset \mathbb{N}$ :
associativity: for every partition $\left(I_{j}\right)_{j \in J}$ of $I, \bigoplus_{j \in J} \bigoplus_{i \in I_{j}} x_{i}=\bigoplus_{i \in I} x_{i}$
commutativity: for all permutation $I^{\prime}$ of $I, \bigoplus_{i \in I^{\prime}} x_{i}=\bigoplus_{i \in I} x_{i}$
distributivity of product over infinite sum: for all $I$,

$$
\bigoplus_{i \in I}\left(x \otimes y_{i}\right)=x \otimes \bigoplus_{i \in I} y_{i}, \text { and } \bigoplus_{i \in I}\left(x_{i} \otimes y\right)=\left(\bigoplus_{i \in I} x_{i}\right) \otimes y .
$$

Every idempotent semiring $\mathcal{S}$ induces an ordering relation $\leq_{\mathcal{S}}$ called natural ordering of $\mathcal{S}$ and defined as, for all $x$ and $y, x \leq_{\mathcal{S}} y$ iff $x \oplus y=x$. In that case, $\mathcal{S}$ is monotonic wrt $\leq_{\mathcal{S}}$ : for all $x, y, z, x \leq \mathcal{S} y$ implies $x \oplus z \leq_{\mathcal{S}} y \oplus z, x \otimes z \leq_{\mathcal{S}} y \otimes z$, and $z \otimes x \leq_{\mathcal{S}} z \otimes y$.
From now on, we assume that $\mathcal{S}$ is a commutative semiring, which is complete and bounded (hence idempotent). This is the case for the three common semirings shown on Figure 3 .

### 2.3 Weighted Edit Operations, Optimal Weight and Edit Distance

A weighted ruleset $E$ is a ruleset $E$ equipped with a weight function, which is a mapping weight : $E \rightarrow \mathcal{S} \backslash\{0\}$ such that the triangle inequality holds: for all $u, v, w \in \Sigma^{*}$ such that $u \rightarrow v \in E, v \rightarrow w \in E$, and $u \rightarrow w \in E$,

$$
\begin{equation*}
\text { weight }(u \rightarrow w) \leq_{\mathcal{S}} \text { weight }(u \rightarrow v) \otimes \operatorname{weight}(v \rightarrow v) \tag{1}
\end{equation*}
$$

By abuse of notation, we write $u \xrightarrow{x} v \in E$ when $x=\operatorname{weight}(u \rightarrow v)$. A weighted ruleset $E$ is symmetric when $E=E^{-1}$ and for every operation $u \rightarrow v \in E$, weight $(v \rightarrow u)=\operatorname{weight}(u \rightarrow v)$.

A positioned operation $\pi$ of $E$ is a pair $\langle u \rightarrow v, i\rangle$ made of an edit operation of $E$ and a natural number, meaning that $u \rightarrow v$ is applied at position $i$ in a string. We write $s \xrightarrow{\pi} t$ when for some $w, w^{\prime} \in \Sigma^{*}, s=w u w^{\prime}, t=w v w^{\prime}$, and $i=|w|$. For all $s, t \in \Sigma^{*}$, we write $s \vec{E} t$ when $s \xrightarrow{\langle u \rightarrow v, i\rangle} t$ for some $u \rightarrow v \in E$, and $s \xrightarrow[E]{*} t$ for the transitive closure of this relation, called edition.

Let $\sigma=\pi_{1} \pi_{2} \ldots \pi_{n}$ be a finite sequence of positioned operations of $E$ (called edition sequence), with $\pi_{j}=\left\langle u_{j} \rightarrow v_{j}, i_{j}\right\rangle$ for all $j=1$..n. We write $s \xrightarrow{\sigma} t$ if $s=s_{0} \xrightarrow{\pi_{1}} s_{1} \ldots \xrightarrow{\pi_{n}} s_{n}=t$ for some $s_{0}, \ldots, s_{n}$. The weight of the sequence $\sigma$ is defined by

$$
\text { weight }(\sigma)= \begin{cases}\mathbb{1}_{n} & \text { if } \sigma \text { is empty }(n=0) \\ \bigotimes_{i=1}^{n} \text { weight }\left(u_{i} \rightarrow v_{i}\right) & \text { otherwise. }\end{cases}
$$

Then we define the optimal weight between $s$ and $t$ wrt $E$ by

$$
D_{E}(s, t)= \begin{cases}\mathbb{1} & \text { if } \mathrm{s}=\mathrm{t}, \\ \bigoplus_{s \xrightarrow{\sigma} \rightarrow t} \text { weight }(\sigma) & \text { otherwise. }\end{cases}
$$

When $s \neq t$ and the above sum is empty, then $D_{E}(s, t)=\mathbb{0}$. Note that the sum may be infinite, hence the hypothesis of completeness of $\mathcal{S}$ is important in our context. In general, we use the term optimal weight fo $D_{E}$ as this measure may not be a distance. When $E$ is symmetric, $D_{E}$ is a distance called edit distance.

Example 3. On the tropical semiring and assuming that all edit operations have a weight of $x_{\mathrm{s}}=x_{\mathrm{i}}=x_{\mathrm{d}}=x_{\mathrm{c}}=x_{\mathrm{f}}=1, D_{E_{0}}$ is the Levenshtein distance, and $D_{E_{0}}($ tutti, ti) $)=3$ (three deletions), whereas $D_{E_{0} \cup E_{3, c}}($ tutti, ti) $)=2$ (with one deletion of u followed by one consolidation $\mathrm{ttt} \rightarrow \mathrm{t}$ ).

### 2.4 Computability of $D_{E}$

Proposition 2. In general, $D_{E}(s, t)$ is not computable for a ruleset $E$ containing fragmentation and consolidation rules.

Proof. By definition, the problem whether $D_{E}(s, t) \neq \mathbb{O}$ for two strings $s$ and $t$ is equivalent to the problem of reachability $s \underset{E}{\stackrel{*}{E}} t$, which is undecidable when $E$ is a set of fragmentation and consolidation rules. This can be shown by reduction of e.g. the Post Correspondence Problem (PCP).

Let us consider an instance of PCP $\mathcal{P}=\left\{\left\langle u_{i}, v_{i}\right\rangle \mid i \leq n, u_{i}, v_{i} \in \Sigma^{*}\right\}$. The problem is to find a sequence $i_{1}, \ldots, i_{k} \leq n$ such that $u_{i_{1}} \ldots u_{i_{k}}=v_{i_{1}} \ldots v_{i_{k}}$. Let us add two marker symbols $\#$ and $\emptyset$ to $\Sigma$.

Intuitively in the reduction of PCP, the fragmentation operations are used for generating a candidate solution (to the problem) from a constant symbol $\sharp$, and the consolidation operations are used for checking that a candidate is indeed a solution, by reduction to another constant symbol $\downarrow$.
More precisely, let the ruleset $E_{\mathrm{f}}$ contain one fragmentation $\sharp \rightarrow \widetilde{u_{i}} \sharp v_{i}$ for each pair $\left\langle u_{i}, v_{i}\right\rangle \in \mathcal{P}\left(\widetilde{u_{i}}\right.$ is the mirror image of $\left.u_{i}\right)$. And let the ruleset $E_{\mathrm{c}}$ contain two consolidations $a \sharp a \rightarrow \sharp$ and $a \nmid a \rightarrow \natural$ for each $a \in \Sigma$. We assign to all these edit operations a non-null weight in $\mathcal{S}$, say $\mathbb{1}$, and call $E=E_{\mathrm{f}} \cup E_{\mathrm{c}}$.

Then it holds that $D_{E}(\sharp, \natural) \neq 0$ iff $\sharp \frac{*}{E} \sharp$ iff $\mathcal{P}$ has a solution.
When $E$ is $E_{0}, D_{E_{0}}$ can be computed using dynamic programming equations 13, 15, 14 by tabulating $\Delta(i, j)=D_{E}\left(s_{1 . .}, t_{1 . . j}\right)$ with $\Delta(0,0)=\mathbb{1}$ and

\Delta(i-1, j) & \otimes \operatorname{weight}\left(s_{i} \rightarrow \varepsilon\right) & \text { (deletion) } \\
\Delta(i, j-1) & \otimes \operatorname{weight}\left(\varepsilon \rightarrow t_{j}\right) & \text { (insertion) }
\end{array}\right.
$$

Adding lines for fragmentations and consolidations to this equation, as what was done by [12], do not always compute the optimal weight of edit operations sequences, such as the correct value of $D_{E_{0} \cup E_{3, c}}$ (tutti, ti) (see Example 3). The following section proposes a construction of a weighted automaton to correctly compute the optimal weight $D_{E}(s, t)$ for some rulesets $E$ larger than $E_{0}$.

## 3 Weighted Automata Algorithm Computing $D_{E}$

Intuitively, $D_{E}(s, t)$ is the smallest weight (wrt $\leq_{\mathcal{S}}$ ) of a path in the edit graph associated to $E$. More precisely, we can associate to $E$ and $s \in \Sigma^{*}$ a graph $\mathcal{G}_{E, s}$ whose vertices are the descendants of $s$ wrt $E\{w \mid s \xrightarrow{*} w\}$ and where each edge describes one positioned operation of $E$ with its associated weights. $D_{E}(s, t)$ is then the smallest weight of a path between $s$ and $t$ in $\mathcal{G}_{E, s}$. However, we cannot simply construct $\mathcal{G}_{E}$ and apply a shortest-path algorithm, like in [10], to compute the optimal weight, because $\mathcal{G}_{E}$ is not finite in general (consider e.g. the case where $E$ contains insertions). Instead, we use as a finite representation of $\mathcal{G}_{E}$ a weighted automaton $\mathcal{A}_{s}^{E}$ computing the optimal weight.

### 3.1 Weighted Automata

The purpose of a weighted automaton [3] over the alphabet $\Sigma$ and the semiring $\mathcal{S}$ is to define a mapping from the strings of $\Sigma^{*}$ into weights of $\mathcal{S}$.

Definition 3. A weighted automaton $\mathcal{A}$ over the alphabet $\Sigma$ and the semiring $\mathcal{S}$ is a tuple $\langle Q$, in, weight, out $\rangle$ where $Q$ is a finite set of states, in : $Q \rightarrow \mathcal{S}$, resp. out : $Q \rightarrow \mathcal{S}$ is a function defining the weight for entering, resp. leaving, a state, and weight : $Q \times \Sigma \times Q \rightarrow \mathcal{S}$ is a transition weight function.

The functions defining $\mathcal{A}$ might be subscripted by $\mathcal{A}$ when needed. A state $q \in Q$ such that $\operatorname{in}(q) \neq \mathbb{O}$, resp. out $(q) \neq \mathbb{O}$, is called initial, resp. final. The set of transitions of $\mathcal{A}$ is $\left\{\left\langle q, a, q^{\prime}\right\rangle \mid q, q^{\prime} \in Q, a \in \Sigma\right\}$. The size of $\mathcal{A}$ is $\|\mathcal{A}\|=|Q|+$ $\left|\left\{\left\langle q, a, q^{\prime}\right\rangle \mid \operatorname{weight}\left(q, a, q^{\prime}\right) \neq \mathbb{O}\right\}\right|$. We denote the source of a transition $\tau=\left\langle q, a, q^{\prime}\right\rangle$ by $\operatorname{src}(\tau)=q$, its target by $\operatorname{trg}(\tau)=q^{\prime}$ and its label by $\operatorname{lab}(\tau)=a$. By abuse, we shall write $\tau$ as $q \xrightarrow[\mathcal{A}]{a, x} q^{\prime}$ when $x=\operatorname{weight}(\tau)$. $\mathcal{A}$ may be omitted when clear from context.

A run of the weighted automaton $\mathcal{A}$ is a finite sequence $\rho=\tau_{1} \ldots \tau_{n}$ of transitions, with $n>0$ and such that for all $1 \leq i<n$, $\operatorname{trg}\left(\tau_{i}\right)=\operatorname{src}\left(\tau_{i+1}\right)$. We write $\operatorname{src}(\rho)=\operatorname{src}\left(\tau_{1}\right)$ and $\operatorname{trg}(\rho)=\operatorname{trg}\left(\tau_{n}\right)$. The run $\rho$ is called a cycle when $\operatorname{src}(\rho)=\operatorname{trg}(\rho)$. The length of the run $\rho$ is len $(\rho)=n$, its label is the concatenation $\operatorname{lab}(\rho)=\operatorname{lab}\left(\tau_{1}\right) \ldots \operatorname{lab}\left(\tau_{n}\right)$ (we also say that $\rho$ is a run over $\left.\operatorname{lab}(\rho)\right)$ and its weight is weight $(\rho)=\bigotimes_{i=1}^{n}$ weight $\left(\tau_{i}\right)$.

For a string $u \in \Sigma^{*}$ and $q, q^{\prime} \in Q$, we denote by $R_{\mathcal{A}}\left(q, u, q^{\prime}\right)$ the set of all runs $\rho$ of $\mathcal{A}$ such that $\operatorname{src}(\rho)=q, \operatorname{trg}(\rho)=q^{\prime}$ and $\operatorname{lab}(\rho)=u$, and define

When $u=\varepsilon, R_{\mathcal{A}}\left(q, u, q^{\prime}\right)=\emptyset$, and we define by convention weight ${ }_{\mathcal{A}}(q, \varepsilon, q)=\mathbb{1}$ for all $q \in Q$ and weight ${ }_{\mathcal{A}}\left(q, \varepsilon, q^{\prime}\right)=\mathbb{O}$ for all $q, q^{\prime} \in Q, q \neq q^{\prime}$. Then, the output of $\mathcal{A}$ on $u \in \Sigma^{*}$ is the following. It can be computed in $O(|u| \cdot\|\mathcal{A}\|)$.

### 3.2 Generalised Levenshtein Automaton Construction

The goal of this section is to show that given a ruleset $E$ containing only consolidation and deletion edit operations and a string $s \in \Sigma^{*}$, one can compute a weighted automaton $\mathcal{A}_{s}^{E}$ over $\Sigma$ and $\mathcal{S}$ that computes $D_{E}(s, t)$, i.e. such that $\forall t \in \Sigma^{*}, \mathcal{A}_{s}^{E}(t)=D_{E}(s, t)$.
The construction starts with an automaton $\mathcal{A}_{s}^{0}$ such that $\mathcal{A}_{s}^{0}(s)=\mathbb{1}$ and updates its transition weight function in order to compute the optimal weight.

Example 4. Figure 4 shows an example of $\mathcal{A}_{s}^{0}$ for $s=$ tutti in the Tropical semiring (where $\mathbb{1}=0$ ).

Initial Automaton Let $s=s_{1} \ldots s_{m} \in \Sigma^{*}$ and let us define a weighted automaton over $\Sigma$ and $\mathcal{S}$

weight $_{0}\left(q_{i}, s_{i+1}, q_{i+1}\right)=\mathbb{1}$ for all $0 \leq i<m$, and
weight $_{0}\left(q_{i}, s_{j}, q_{k}\right)=\mathbb{0}$ for all other transitions.
The following lemma is an immediate consequence of the definition of $\mathcal{A}_{s}^{0}$.
Lemma 4. It holds that $\mathcal{A}_{s}^{0}(s)=\mathbb{1}$ and $\mathcal{A}_{s}^{0}(u)=\mathbb{0}$ for all $u \neq s$.
Automata Transformation The weighted automaton construction starts with $\mathcal{A}_{s}^{0}$, and the state set $Q$ is not changed but the weight functions are updated, in a way that the obtained weighted automaton $\mathcal{A}$ satisfies the following properties:
$\left(c_{1}\right)$ For any consolidation $a_{1} \ldots a_{n} \xrightarrow{x} b \in E$ with $a_{1}, \ldots, a_{n}, b \in \Sigma$ and $n \geq 0$, for all states $q_{i}, q_{j} \in Q$, with $0 \leq i \leq j \leq m$,

Figure 5 illustrates the intuitions behind these weight updates. The case ( $c_{1}$ ) expresses that $\mathcal{A}$ must take into account the possibility to edit $a_{1} \ldots a_{n}$ into $b$. To that end, the weight of the transition $q_{i} \xrightarrow{b} q_{j}$ is updated with the weight $x$ of the consolidation. The case ( $\mathrm{c}_{2}$ ) corresponds to the addition of an $\varepsilon$-transition $q_{\ell} \xrightarrow{\varepsilon} q_{j}$ in place of the transition labeled by $a$, and the on-the-fly suppression of this $\varepsilon$ transition, following a technique similar to e.g. [9, 8].
The updated weights in the automaton transitions are computed using recursive equations over $\mathcal{S}$.

All edition rules have here a weight of 1 . Solving $w_{0, a, 3}$ variables is done by the case (ent).2. For example, $\mathrm{w}_{0, \mathrm{t}, 3}=\min \left(+\infty, e, g+\mathrm{w}_{0, \mathrm{t}, 3}\right)$, where $e=\min \left(\mathrm{w}_{0, \mathrm{t}, 1}+\right.$ $\left.\mathrm{w}_{1, \mathrm{t}, 2}+x_{\mathrm{c}}, \ldots\right)$ contains the weight of the best path and $g=\min \left(\mathrm{w}_{3, \mathrm{t}, 3}+x_{\mathrm{d}}, \ldots\right)$ corresponds to cycles that will not improve the weight.

Example 5. Figure $\sqrt{6}$ shows an example of the construction of $\mathcal{A}_{\mathrm{tutti}}^{E}$ by updating the transition weights of $\mathcal{A}_{\mathrm{tutti}}^{0}$ (in the Tropical semiring).

For all $0 \leq i \leq j \leq m$ (remember that $m=|Q|-1$ is the length of $s)$ and $a \in \Sigma$, we consider a variable $\mathrm{w}_{i, a, j}$ representing weight ${ }_{\mathcal{A}}\left(q_{i}, a, q_{j}\right)$, and a variable $\mathrm{y}_{i}$ representing $\operatorname{in}_{\mathcal{A}}\left(q_{i}\right)$. We call $\mathcal{S}$-expression an expression made of the binary operators of $\mathcal{S}$, elements in $\operatorname{dom}(\mathcal{S})$ and the above variables. The following equations associate an $\mathcal{S}$-expression to each variable.

The first line in (eresponds to the case ( $c_{1}$ ) (consolidation) and the second line corresponds to second part of the case ( $\mathrm{c}_{2}$ ) (deletion) - the inequality concerned with weight ${ }_{\mathcal{A}}\left(q_{i}, b, q_{j}\right)$. The equation ( $\left(\mathrm{e}_{2}^{\prime}\right)$ corresponds to first part of the case $\left(\mathrm{c}_{2}\right)$ (deletion) - the inequality concerned with in $\left(q_{j}\right)$.
An assignation $\phi$ is a mapping

We consider the homomorphic extension of an assignation $\phi$, also denoted $\phi$, mapping $\mathcal{S}$-expressions to $\mathcal{S}$, defined by $\phi\left(e \oplus e^{\prime}\right)=\phi(e) \oplus \phi\left(e^{\prime}\right), \phi\left(e \otimes e^{\prime}\right)=\phi(e) \otimes \phi\left(e^{\prime}\right)$ and $\phi(x)=x$ for all $x \in \operatorname{dom}(\mathcal{S})$. We associate to an assignation $\phi$ the weighted
automaton $\mathcal{A}_{\phi}=\left(Q\right.$, in $_{\phi}$, out $_{0}$, weight $\left.{ }_{\phi}\right)$ where for all $0 \leq i \leq j \leq m$ and $a \in \Sigma$, weight $_{\phi}\left(q_{i}, a, q_{j}\right)=\phi\left(\mathrm{w}_{i, a, j}\right)$ and $\operatorname{in}_{\phi}\left(q_{i}\right)=\phi\left(\mathrm{y}_{i}\right)$.

Lemma 5. If $\phi$ is a solution of ( $\mathrm{e}_{12}$ ), ( $\mathrm{e}_{2}^{\prime}$ ), then $\mathcal{A}_{\phi}$ satisfies $\left(\mathrm{c}_{1}\right)$ and $\left(\mathrm{c}_{2}\right)$.
Proof. Let $\mathcal{A}=\mathcal{A}_{\phi}$ (to simplify notations).
For $\left(c_{1}\right)$, if weight ${ }_{\mathcal{A}}\left(q_{i}, b, q_{j}\right)=\phi\left(w_{i, b, j}\right)=\mathbb{1}$, then we are done by boundedness of $\mathcal{S}$. Otherwise, for $a_{1} \ldots a_{n} \xrightarrow{x} b \in E$, the sum $\bigoplus_{\left(i_{0}, \ldots, i_{n}\right)} x \otimes \bigotimes_{p=0}^{n-1} \phi\left(\mathrm{w}_{i_{p}, a_{p+1}, i_{p+1}}\right)$ in $\left(\mathrm{e}_{12}\right.$ is equal to $x \otimes$ weight $_{\mathcal{A}}\left(q_{i}, a_{1} \ldots a_{n}, q_{j}\right)$ by definition of $\mathcal{A}_{\phi}$ and weight ${ }_{\mathcal{A}}$, and the inequality of $\left(c_{1}\right)$ follows, using commutativity of $\mathcal{S}$.
For $\left(c_{2}\right)$ (case of deletion $b \xrightarrow{x} \varepsilon$ ), the principle is the same:

Let us build a solution $\psi$ of $\mathrm{e}_{12}$ and ( $\mathrm{e}_{2}^{\prime}$, by analysing for each variable $\mathrm{w}_{i, b, j}$ (resp. $y_{j}$ ), the equation (esp. (eere ) with this variable in left-hand side.
(e $\mathrm{e}_{12}$ ). 1 for weight ${ }_{0}\left(q_{i}, b, q_{j}\right)=\mathbb{1}$, let $\psi\left(\mathrm{w}_{i, b, j}\right)=\mathbb{1}$.
Otherwise, weight ${ }_{0}\left(q_{i}, b, q_{j}\right)=\mathbb{0}$ :

Otherwise, $\mathrm{in}_{0}\left(q_{j}\right)=\mathbb{0}$ :

Lemma 6. $\psi$ is a solution of $\left(\mathrm{e}_{12}\right.$ and $\left(\mathrm{e}_{2}^{\prime}\right.$ in $\mathcal{S}$.
Proof. First, let us observe that $\left(\mathrm{e}_{12}\right) \cdot 1-3$ and $\left(\mathrm{e}_{2}^{\prime}\right) \cdot 1-3$ cover all the cases of equations ( $\mathrm{e}_{12}$ ), (éa). Indeed, weight $\left(q_{i}, b, q_{j}\right)$ and $\mathrm{in}_{0}\left(q_{j}\right)$ can only take the values $\mathbb{0}$ and $\mathbb{1}$ and, as there are no backward transitions in the automaton, the (variable) left-hand-side of an equation can only occur at most once in the right-hand-side.

We show now that the definition of $\psi$ is well-founded. Let us define a partial ordering $\prec$ on variables as follows:

It uses the consolidation $\mathrm{ttt} \rightarrow \mathrm{t}$, giving $D_{E_{0} \cup E_{3, c}}(\mathrm{tutti}, \mathrm{ti})=x_{d}+x_{c}=2$. and also in $\left(q_{4}\right)=2+x_{d}=3$, giving $D_{E_{0} \cup E_{3, c}}($ tutti, $\mathbf{i})=3$.
for all $0 \leq i \leq i^{\prime} \leq j^{\prime} \leq j \leq m$ such that $\left(i^{\prime}, j^{\prime}\right) \neq(i, j)$, and all $a, b \in \Sigma$, $\mathrm{w}_{i^{\prime}, a, j^{\prime}} \prec \mathrm{w}_{i, b, j}$,
for all $0 \leq i \leq j \leq m, 0 \leq k \leq m$, and all $a \in \Sigma, \mathrm{w}_{i, a, j} \prec \mathrm{y}_{k}$.
We can observe that:
for the equations of the form ( $e_{12}$ ) 3 and (ex $) \cdot 3$, the variable in $l h s$ is greater wrt $\succ$ to every variable in the rhs,
for the equations of the form $\left(\begin{array}{l}e_{12}\end{array}\right) \cdot 2$, and $\left(\begin{array}{l}e_{2}^{\prime}\end{array}\right) \cdot 2$, the variable $\mathrm{w}_{i, b, j}$ in $l h s$ is $\succeq$ to every variable $\mathrm{w}_{i^{\prime}, a, j^{\prime}}$ in the $r h s$, and $\psi\left(\mathrm{w}_{i, b, j}\right)$ only depends on $\psi\left(\mathrm{w}_{i^{\prime}, a, j^{\prime}}\right)$ for $\mathrm{w}_{i, b, j} \succ \mathrm{w}_{i^{\prime}, a, j^{\prime}}$

It follows that $\psi$ is well defined. And we show now that it is a solution of $\mathrm{e}_{12}$ and ( $e_{2}^{\prime}$ ).
In the case $\mathrm{e}_{12}$.1, the equation has the form $\mathrm{w}_{i, b, j}=\mathbb{1} \oplus e$, and whatever in $e$, $\psi(\mathbb{1} \oplus e)=\mathbb{1} \oplus \psi(e)=\mathbb{1}$ since $\mathcal{S}$ is bounded.
The case ( $e_{2}^{\prime}$. 1 is similar.
In the case $\mathrm{e}_{12} \cdot 2, \psi\left(0 \oplus e \oplus g \otimes \mathrm{w}_{i, b, j}\right)=\psi(e) \oplus \psi(g) \otimes \psi\left(\mathrm{w}_{i, b, j}\right)=\psi(e) \otimes(\mathbb{1} \oplus \psi(g))=$ $\psi(e)$ since $\mathcal{S}$ is bounded.
The case ( $\mathrm{e}_{2}^{\prime}$. 2 is similar.
The two last cases $\mathrm{e}_{12} \cdot 3$ and $\left(\begin{array}{l}\mathrm{e}_{2}^{\prime} \\ \hline\end{array} \cdot 3\right.$ are immediate.

Completeness and Correctness of Construction Let us show now that the construction of the above automaton $\mathcal{A}_{\psi}$ enables to compute $D_{E}(s, t)$ in polynomial time.

Theorem 7. Assume that $\mathcal{S}$ is a commutative semiring, complete and bounded. Let $E$ be a ruleset over $\mathcal{S}$ containing only consolidation and deletion edit operations, and let $s \in \Sigma^{*}$. One can build in polynomial time a weighted automaton $\mathcal{A}_{s}^{E}$ over $\Sigma$ and $\mathcal{S}$ such that for all $t \in \Sigma^{*}, \mathcal{A}_{s}^{E}(t)=D_{E}(s, t)$.

Let $\mathcal{A}_{s}^{E}$ over $\mathcal{S}$ and $\Sigma$ be $\mathcal{A}_{\psi}$ constructed as above by updating the weights of the initial automaton $\mathcal{A}_{s}^{0}$ with the solution $\psi$ of the equations ( $\mathrm{e}_{12}$ ) and ( $\mathrm{e}_{2}^{\prime}$. Remember that $\mathcal{A}_{s}^{0}$ has $n+1$ states $q_{0}, \ldots, q_{m}$ where $m$ is the length of $s$. Assuming that $\Sigma$ is constant, the size of $\mathcal{A}_{s}^{E}$ is $O\left(|s|^{2}\right)$ and its construction time is in $O\left(|s|^{4} \cdot\|E\|\right)$.

We decompose below the rest of the proof of Theorem 7 into two directions, respectively in Lemma 8,9 (completeness) and Lemma 10 (correctness).

Lemma 8. For all $t \in \Sigma^{*}$, and all edition sequence $\sigma$ such that $s \underset{E}{\sigma}$, it holds that $\mathcal{A}_{s}^{E}(t) \leq_{\mathcal{S}}$ weight $(\sigma)$.

Proof. By induction on the length of the edition sequence $\sigma$. For convenience, we write $\mathcal{A}$ instead of $\mathcal{A}_{s}^{E}$.
If $\sigma$ is empty, then $t=s$ and weight $(\sigma)=\mathbb{1}$. There exists run a $\rho$ of $\mathcal{A}_{s}^{0}$ over $t$ such that weight $(\rho)=\mathbb{1}$. More precisely, $\rho=\tau_{1}, \ldots, \tau_{m}$ (remember that $m$ is the length of $s$ ), and for all $1 \leq k \leq m, \tau_{k}=\left\langle q_{k-1}, s_{k}, q_{k}\right\rangle$ and weight ${ }_{\mathcal{A}_{s}^{0}}\left(\tau_{k}\right)=\mathbb{1}$. By construction, $\rho$ is also a run of $\overline{\mathcal{A}}$ and for all $k$, weight ${ }_{\mathcal{A}}\left(\tau_{k}\right)=\psi\left(\mathrm{w}_{k-1, s_{k}, k}\right)=\mathbb{1}$ (case ( $\mathrm{e}_{12}$ ) 1 of the definition of $\psi$ ). Hence weight ${ }_{\mathcal{A}}\left(q_{0}, t, q_{m}\right)=\mathcal{A}(t)=\mathbb{1}=\operatorname{weight}(\sigma)$.
Assume that $\sigma=\sigma^{\prime} \pi$ where $\pi=\langle e, p\rangle$ is a positioned operation of $E$, and let $x=$ weight $(e)$.
We consider first the case of a consolidation: $e=a_{1} \ldots a_{n} \rightarrow b(n \geq 0)$. The edition $s \xrightarrow[E]{\sigma} t$ can be decomposed into:

$$
s \xrightarrow[E]{\sigma^{\prime}} t^{\prime}:=w a_{1} \ldots a_{n} w^{\prime} \xrightarrow[E]{\pi} w b w^{\prime}=: t
$$

By definition, $\mathcal{A}(t)=\bigoplus_{q, q^{\prime} \in Q} \bigoplus_{\rho \in R_{\mathcal{A}}\left(q, t, q^{\prime}\right)} \operatorname{in}(q) \otimes$ weight $(\rho) \otimes \operatorname{out}\left(q^{\prime}\right)$.
For a run $\rho=\tau_{1} \ldots \tau_{k}$ of $\mathcal{A}$ and $1 \leq i_{1} \leq i_{2} \leq k$, we write $\rho_{i_{1} . . i_{2}}$ for the subrun $\tau_{i_{1}} \ldots \tau_{i_{2}}$.
Every run $\rho^{\prime} \in R_{\mathcal{A}}\left(q, t^{\prime}, q^{\prime}\right)$ can be decomposed into $\rho^{\prime}=\left.\left.\left.\rho^{\prime}\right|_{w} \rho^{\prime}\right|_{a_{1} \ldots a_{n}} \rho^{\prime}\right|_{w^{\prime}}$ where

$$
\begin{aligned}
& \left.\rho^{\prime}\right|_{w}=\rho_{1 . .|w|}^{\prime}\left(\text { prefix subrun of } \rho^{\prime} \text { over } w\right), \\
& \left.\left.\rho^{\prime}\right|_{a_{1} \ldots a_{n}}=\rho_{|w|+1 . .|w|+n}^{\prime} \text { (subrun of } \rho^{\prime} \text { over } a_{1} \ldots a_{n}\right), \\
& \left.\rho^{\prime}\right|_{w^{\prime}}=\rho_{|w|+n+1 . .\left|t^{\prime}\right|}^{\prime}\left(\text { suffix subrun of } \rho^{\prime} \text { over } w^{\prime}\right) .
\end{aligned}
$$

It holds that weight $\left(\rho^{\prime}\right)=\operatorname{weight}\left(\left.\rho^{\prime}\right|_{w}\right) \otimes \operatorname{weight}\left(\left.\rho^{\prime}\right|_{a_{1} \ldots a_{n}}\right) \otimes$ weight $\left(\left.\rho^{\prime}\right|_{w^{\prime}}\right)$, and that $\rho=\left.\left.\rho^{\prime}\right|_{w}\left\langle\operatorname{trg}\left(\left.\rho^{\prime}\right|_{w}\right), b, \operatorname{src}\left(\left.\rho^{\prime}\right|_{w^{\prime}}\right)\right\rangle \rho^{\prime}\right|_{w^{\prime}}$, is a run of $R_{\mathcal{A}}\left(q, t, q^{\prime}\right)$, because $\left\langle\operatorname{trg}\left(\left.\rho^{\prime}\right|_{w}\right), b, \operatorname{src}\left(\left.\rho^{\prime}\right|_{w^{\prime}}\right)\right\rangle$ is a transition of $\mathcal{A}$.

Similarly, every run $\rho \in R_{\mathcal{A}}\left(q, t, q^{\prime}\right)$ can be decomposed into

$$
\rho=\left.\left.\rho^{\prime}\right|_{w}\left\langle\operatorname{trg}\left(\left.\rho^{\prime}\right|_{w}\right), b, \operatorname{src}\left(\left.\rho^{\prime}\right|_{w^{\prime}}\right)\right\rangle \rho^{\prime}\right|_{w^{\prime}}
$$

where $\rho^{\prime}$ is a run in $R_{\mathcal{A}}\left(q, t^{\prime}, q^{\prime}\right)$ as above and $\left\langle\operatorname{trg}\left(\left.\rho^{\prime}\right|_{w}\right), b, \operatorname{src}\left(\left.\rho^{\prime}\right|_{w^{\prime}}\right)\right\rangle$ is a transition of $\mathcal{A}$. It holds then that

$$
\text { weight }(\rho)=\operatorname{weight}\left(\left.\rho^{\prime}\right|_{w}\right) \otimes \text { weight }_{\mathcal{A}}\left(\operatorname{trg}\left(\left.\rho^{\prime}\right|_{w}\right), b, \operatorname{src}\left(\left.\rho^{\prime}\right|_{w^{\prime}}\right)\right) \otimes \operatorname{weight}\left(\left.\rho^{\prime}\right|_{w^{\prime}}\right)
$$

We can thus switch from runs over $t\left(\rho \in R_{\mathcal{A}}\left(q, t, q^{\prime}\right)\right)$ to runs over $t^{\prime}\left(\rho^{\prime} \in R_{\mathcal{A}}\left(q, t, q^{\prime}\right)\right)$ :

$$
\begin{aligned}
& \mathcal{A}(t)=\bigoplus_{q, q^{\prime} \in Q} \bigoplus_{\rho \in R_{\mathcal{A}}\left(q, t, q^{\prime}\right)} \quad \operatorname{in}(q) \otimes \operatorname{weight}(\rho) \otimes \operatorname{out}\left(q^{\prime}\right) \\
& =\bigoplus_{q, q^{\prime} \in Q} \bigoplus_{\rho^{\prime} \in R_{\mathcal{A}}\left(q, t^{\prime}, q^{\prime}\right)} \operatorname{in}(q) \otimes \operatorname{weight}\left(\left.\rho^{\prime}\right|_{w}\right) \\
& \otimes \text { weight }_{\mathcal{A}}\left(\operatorname{trg}\left(\left.\rho^{\prime}\right|_{w}\right), b, \operatorname{src}\left(\left.\rho^{\prime}\right|_{w^{\prime}}\right)\right) \\
& \otimes \text { weight }\left(\left.\rho^{\prime}\right|_{w^{\prime}}\right) \otimes \operatorname{out}\left(q^{\prime}\right) \\
& \leq \mathcal{S} \bigoplus_{q, q^{\prime} \in Q} \bigoplus_{\rho^{\prime} \in R_{\mathcal{A}}\left(q, t^{\prime}, q^{\prime}\right)} \quad \operatorname{in}(q) \otimes \operatorname{weight}\left(\left.\rho^{\prime}\right|_{w}\right) \\
& \otimes \text { weight }_{\mathcal{A}}\left(\operatorname{trg}\left(\left.\rho^{\prime}\right|_{w}\right), a_{1} \ldots a_{m}, \operatorname{src}\left(\left.\rho^{\prime}\right|_{w^{\prime}}\right) \otimes x\right. \\
& \otimes \text { weight }\left(\left.\rho^{\prime}\right|_{w^{\prime}}\right) \otimes \operatorname{out}\left(q^{\prime}\right) \\
& =\bigoplus \quad \bigoplus \quad \operatorname{in}(q) \otimes \text { weight }\left(\rho^{\prime}\right) \otimes x \otimes \operatorname{out}\left(q^{\prime}\right) \\
& q, q^{\prime} \in Q \rho^{\prime} \in R_{\mathcal{A}}\left(q, t^{\prime}, q^{\prime}\right) \\
& =\mathcal{A}\left(t^{\prime}\right) \otimes x \\
& \leq_{\mathcal{S}} \quad \text { weight }\left(\sigma^{\prime}\right) \otimes x=\operatorname{weight}(\sigma)
\end{aligned}
$$

The first inequality follows from $\left(c_{1}\right)$, and the last inequality holds by induction hypothesis and monotony of $\mathcal{S}$ wrt $\leq_{\mathcal{S}}$.
The case of a deletion: $e=a \rightarrow \varepsilon$ is treated similarly, using ( $\mathrm{c}_{2}$ ).
Making the summation of the inequalities from Lemma 8 for all $\sigma$, and using the hypotheses that $\mathcal{S}$ is complete and idempotent, the completeness of $\mathcal{A}_{s}^{E}$ follows:

Lemma 9. For all $t \in \Sigma^{*}$, it holds that $\mathcal{A}_{s}^{E}(t) \leq_{\mathcal{S}} D_{E}(s, t)$.
The correctness of the construction of $\mathcal{A}_{s}^{E}$ follows from the next lemma.
Lemma 10. For all $t \in \Sigma^{*}$, it holds that $D_{E}(s, t) \leq \mathcal{S} \mathcal{A}_{s}^{E}(t)$.
Proof. Every value $\mathcal{A}_{s}^{E}(t)$ returned by $\mathcal{A}_{s}^{E}$ has the form of a sum, by $\oplus$, of products, by $\otimes$, of weights of edit operations in $E$. Moreover, each of these products has the same form as weight $(\sigma)$ for some edit sequence $\sigma$ such that $s \xrightarrow{\sigma} t$. In other terms, there exists a set $P(t)$ of edit sequences $\sigma$ such that $s \xrightarrow{\sigma} t$, with $\mathcal{A}_{s}^{E}(t)=$ $\bigoplus_{\sigma \in P(t)}$ weight $(\sigma)$. This can be shown by induction on the variables, using the ordering $\prec$ introduced in the proof of Lemma 6. Thus, by idempotence for $\mathcal{S}$, it holds that:

$$
\begin{aligned}
\mathcal{A}_{s}^{E}(t) \oplus D_{E}(s, t) & =\bigoplus_{\sigma \in P(t)} \operatorname{weight}(\sigma) \oplus \bigoplus_{s}{ }_{\sigma} \rightarrow t \\
& =\bigoplus_{s} \xrightarrow{\sigma} \text { weight }(\sigma) \\
& \text { weight }(\sigma)=D_{E}(s, t)
\end{aligned}
$$

It follows that $D_{E}(s, t) \leq \mathcal{S} \mathcal{A}_{s}^{E}(t)$.
Note that $\mathcal{A}_{s}^{E}$ is constructed for a given $s$. Hence if we need to compute $D_{E}(s, t)$ for a fixed $s$ and several $t$, we only need to compute $\mathcal{A}_{s}^{E}$ once and compute $\mathcal{A}_{s}^{E}(t)$ for each $t$.

Corollary 11. Given a semiring $\mathcal{S}$ as in Theorem 7, a ruleset $E$ over $\mathcal{S}$ containing only fragmentation and insertion edit operations, and $t \in \Sigma^{*}$, one can build in polynomial time a weighted automaton $\widehat{\mathcal{A}_{t}^{E}}$ over $\Sigma$ and $\mathcal{S}$ such that for all $s \in \Sigma^{*}$, $\widetilde{\mathcal{A}_{t}^{E}}(s)=D_{E}(s, t)$.


Proof. When $E$ contains only fragmentations and insertions, the symmetric ruleset $E^{-1}$ contains only consolidations and deletions. The construction of the Theorem 7 can thus be applied to $E^{-1}$ and $t$, giving the automaton $\widetilde{\mathcal{A}_{t}^{E}}=\mathcal{A}_{t}^{E^{-1}}$. Then $\widetilde{\mathcal{A}_{t}^{E}}(s)=$ $\mathcal{A}_{t}^{E^{-1}}(s)=D_{E^{-1}}(t, s)=D_{E}(s, t)$ by commutativity of $\mathcal{S}$.

Computation of $\mathcal{A}_{s}^{E}(t)=D_{E}(s, t) \quad$ As there is no backward transition in $\mathcal{A}_{s}^{E}$, the computation of $\mathcal{A}_{s}^{E}(t)=D_{E}(s, t)$, given $\mathcal{A}_{s}^{E}$ can be done in a greedy way (Figure 8).
Corollary 12. Given a semiring $\mathcal{S}$ as in Theorem 7, a ruleset $E$ over $\mathcal{S}$ containing only consolidation and deletion edit operations, and $s, t \in \Sigma^{*}, D_{E}(s, t)$ can be computed in polynomial time.
Proof. Let $\mathcal{A}_{s}^{E}$ be computed as in Theorem 7. For $0 \leq i \leq|s|$ and $0 \leq j \leq|t|$, we define $\Delta(i, j)$ recursively by

$$
\begin{aligned}
& \Delta(i, 0)=\operatorname{in}\left(q_{i}\right) \\
& \Delta(i, j)=\bigoplus_{i^{\prime}<i} \Delta\left(i^{\prime}, j-1\right) \otimes \text { weight }_{\mathcal{A}_{s}^{E}}\left(q_{i^{\prime}}, t_{j}, q_{i}\right) \quad 1 \leq j \leq|t| .
\end{aligned}
$$

When $\mathcal{A}_{s}^{E}$ is given, the values of $\Delta$ can be computed and stored in a table in time $O\left(|s|^{2} \cdot|t|\right)$. It holds that $\Delta(|s|, j)=\mathcal{A}_{s}^{E}\left(t_{1 . . j}\right)$. Hence, by Theorem $7, \Delta(|s|,|t|)=$ $D_{E}(s, t)$.

Altogether, this gives a $O\left(|s|^{4} \cdot\|E\|+|s|^{2} \cdot|t|\right)$ algorithm to compute $D_{E}(s, t)$. Note that these times could be reduced by tabulating the $|E| \cdot|s|^{2}$ values used in the first line of ${ }^{e_{12}}$.

## 4 Chaining Consolidations with Fragmentations

According to Proposition 2, one cannot generalise the automata construction of Section 3 to rulesets mixing arbitrarily consolidation and fragmentation edit operations. However, the above construction can be used to compute the optimal weight of sequences chaining operations from a ruleset $E_{\mathrm{c}}$, containing consolidations and deletions, with operations from a ruleset $E_{\mathrm{f}}$ containing fragmentation and insertions, in that order. Given such rulesets, we define the optimal weight $D_{E_{\mathrm{c}}, E_{\mathrm{f}}}$ as follows:

$$
\begin{aligned}
D_{E_{\mathrm{c}}, E_{\mathrm{f}}}(s, t) & =\bigoplus_{o \in \Sigma^{*}} D_{E_{\mathrm{c}}}(s, o) \otimes D_{E_{\mathrm{f}}}(o, t) \\
& =\bigoplus_{s \xrightarrow{\sigma} \xrightarrow{\sigma^{\sigma^{\prime}} \rightarrow t}} \operatorname{weight}(\sigma) \otimes \operatorname{weight}\left(\sigma^{\prime}\right)
\end{aligned}
$$

where $\sigma$ is an edit sequence of $E_{\mathrm{c}}$ and $\sigma^{\prime}$ is an edit sequence of $E_{\mathrm{f}}$.
Lemma 13. When $E_{\mathrm{c}}$ and $E_{\mathrm{f}}$ are symmetric, $D_{E_{\mathrm{c}}, E_{\mathrm{f}}}$ is a distance.
Proof. By commutativity of $\otimes$ and idempotence of the semiring.
Theorem 7 (and Corollary 11) can be generalised to compute $D_{E_{\mathrm{c}}, E_{\mathrm{f}}}$.
Theorem 14. Given a commutative semiring $\mathcal{S}$, complete and bounded, $E_{\mathrm{c}}$ (resp. $E_{f}$ ) a ruleset over $\mathcal{S}$ containing only consolidation and deletion (resp. fragmentation and insertion) edit operations, and $s, t \in \Sigma^{*}$, the optimal weight $D_{E_{\mathrm{c}}, E_{\mathrm{f}}}(s, t)$ can be computed in polynomial time.

Proof. The principle is to apply the construction of Theorem 7 on the one side to $s$ and $E_{\mathrm{c}}$, giving $\mathcal{A}_{s}^{E_{\mathrm{c}}}$ (denoted $\mathcal{A}_{s}^{\mathrm{c}}$ below) and on the other side, Corollary 11 to $t$ and $E_{\mathrm{f}}$, giving $\widetilde{\mathcal{A}_{t}^{E_{\mathrm{f}}}}=\mathcal{A}_{t}^{E_{f}^{-1}}$ (denoted $\widetilde{\mathcal{A}}_{t}^{\mathrm{f}}$ below). Altogether, $\forall o \in \Sigma^{*} \mathcal{A}_{s}^{\mathrm{c}}(o)=D_{E_{\mathrm{c}}}(s, o)$ and $\widetilde{\mathcal{A}}_{t}^{\mathrm{f}}(o)=D_{E_{\mathrm{f}}^{-1}}(t, o)=D_{E_{\mathrm{f}}}(o, t)$.

We now construct, in quadratic time, the Hadamard product $\mathcal{A}_{s, t}^{\mathrm{c}, \mathrm{f}}$ of $\mathcal{A}_{s}^{\mathrm{c}}$ and $\widetilde{\mathcal{A}}_{t}^{\mathrm{f}}$ which is a weighted automaton such that $\forall o \in \Sigma^{*}, \mathcal{A}_{s, t}^{\mathrm{c}, \mathrm{f}}(o)=\mathcal{A}_{s}^{\mathrm{c}}(o) \otimes \widetilde{\mathcal{A}}_{t}^{\mathrm{f}}(o)$ (see [3]). Let $m$ be the element of $\mathcal{S}$ such that $\mathcal{A}_{s, t}^{\mathrm{c}, \mathrm{f}}(m)$ has minimal weight $w r t \leq \mathcal{S}$. This element $m$ can be computed by a Viterbi algorithm on $\mathcal{A}_{s, t}^{\mathrm{c}, \mathrm{f}}$ (see e.g. [6]). It holds then that $\mathcal{A}_{s, t}^{\mathrm{c}, \mathrm{f}}(m)=D_{E_{\mathrm{c}} \circ E_{\mathrm{f}}}(s, t)$.

Note that following Proposition 2, it is not possible to iterate this procedure an arbitrary number of times. Moreover, the optimal weight of fragmentations chained with consolidations, in this order, is not computable.

Proposition 15. In general, $D_{E_{\mathrm{f}}, E_{\mathrm{c}}}(s, t)$ is not computable for a ruleset $E_{\mathrm{f}}$ containing fragmentation rules and for a ruleset $E_{\mathrm{c}}$ containing consolidation rules.

Proof. We consider the rulesets $E_{\mathrm{f}}$ and $E_{\mathrm{c}}$ constructed in the proof of Proposition 2 , They are like in the hypothesis of Proposition 15 , and it holds that $\sharp \underset{E_{\mathrm{f}}}{\forall} o \xrightarrow[E_{\mathrm{c}}]{*} \natural$ for some $o$ iff $D_{E_{\mathrm{f}}, E_{\mathrm{c}}}(s, t) \neq \mathbb{O}$ iff $\mathcal{P}$ has a solution.

Hence the result of Theorem 14, though polynomial, is close to undecidability.
The above construction can be applied to rulesets such as $E_{3, \mathrm{c}} \cup E_{0}$ and $E_{3, \mathrm{f}} \cup E_{0}$. As substitution, insertion, and deletion operations of $E_{0}$ appear in both rulesets, these operations can thus be used anywhere in $D_{E_{c}, E_{\mathrm{f}}}$. Such a computation of $D_{E_{\mathrm{c}}, E_{\mathrm{f}}}$ may be used in computational music analysis. Back to the Figure1, a transformation of the Variation 1 into the Variation 7 can be expressed as a sequence of consolidation operations followed by another sequence of fragmentation operations. One could thus evaluate the distance between two variations without knowing the underlying theme.

## 5 Conclusion and Perspectives

We have shown how to compute in polynomial time extended optimal weights and edit distances, for rulesets mixing consolidations and deletions on the one side, and
fragmentations and insertions on the other side, using weighted automata constructions, in a generic semiring framework. We also shown both how to compute optimal weights of sequences of consolidations followed by fragmentations and that, in general, optimal weights of sequences of fragmentations followed by consolidations are not computable. To our knowledge, this is the first time an algorithm is proposed to compute this distance (for which dynamic programming techniques used for Levenshtein edit-distance do not apply). These results can be applied to music similarity questions that motivated the Mongeau-Sankoff algorithm as tropical semirings satisfy our assumptions of boundedness.

In [11], Mohri proposed weighted transducers to compute the Levenshtein distance between regular languages, and explained that this technique can compute more complex edit distances as long as the operations are defined by transducers. Applying it in the context of an edit distance with consolidations and fragmentations reduces to express the application of these operations with transducers - a problem that we did not try to address. Generalising the results of this paper to the computation of the extended edit distances between regular languages (or a language and a string) instead of between two strings $s$ and $t$, is an open question.

The generalisation of the construction to $k$-closed semirings, instead of bounded ones ( 0 -closed [10]), is another open problem.

The complexity of our procedure depends on the size of $E$, and this may cause scalability issues for practical applications to the analysis of written music. Indeed, in this context $E$ may be big, as edit operations depends on pitch or intervals and rhythms... In this case, it could makes sense to generalise our approach to a symbolic framework such as the one of [2].
