Propagule pressure and density dependence

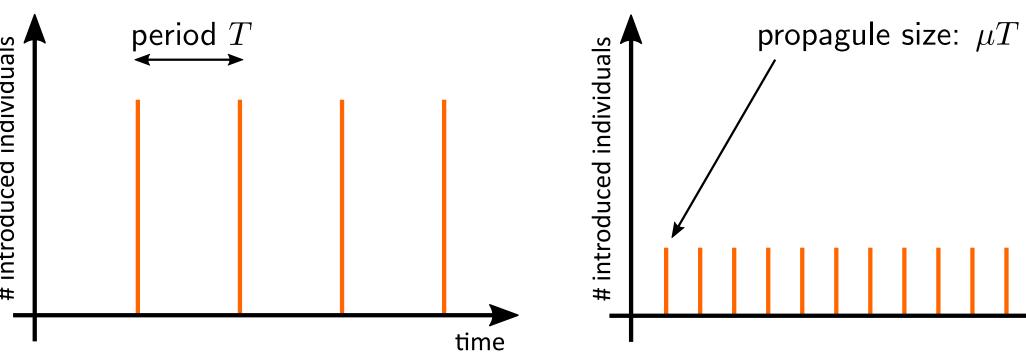
Conservation biology and biological control both involve the **introduction** of **populations** in the environment. These introductions aim to reinforce or **reintroduce** a species for patrimonial/ecological reasons, or to **combat pest** infestations with their natural enemies.

Propagule pressure quantifies the overall introduction effort; it encompasses:

- propagule size (number of individuals per introduction)
- propagule frequency (frequency of introductions)
- patterns of introductions (distribution of introductions in time)

A general prediction is that **increasing** propagule **size** or propagule **frequency** favors the **success** of the introduction programme, because both increase the rate of introduction (Simberloff, 2009).

For a **given rate** of **introduction** μ , mathematical models (pulsed differential equations) asserted that **patterns** of **introduction** interact with **density dependence** in population dynamics.



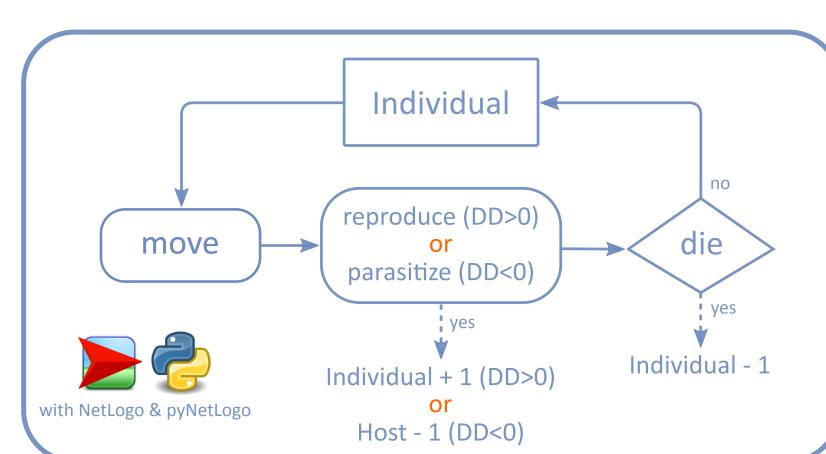
- Positive density dependence: large size and rare introductions are better (Mailleret & Lemesle 2009; Bajeux et al. 2017)
- Negative density dependence: small size and frequent introductions are better (Nundloll et al. 2010a, 2010b)

Positive density dependence: reintroduction

- one population
- random movements of individuals
- density dependent **reproduction**: probability of reproducing at each time step increases with N (# neighboring conspecifics)

$$P(\mathsf{repro}) = 1 - \exp(-m_s N)$$

• objective: time to establishment ($p_{\pm} = 50\%$)



Negative density dependence: biocontrol

- host (pest) and parasitoid populations
- hosts still, random movements of parasitoids
- ullet interference competition in **parasitism**: probability of parasitising a host at each time step decreases with N

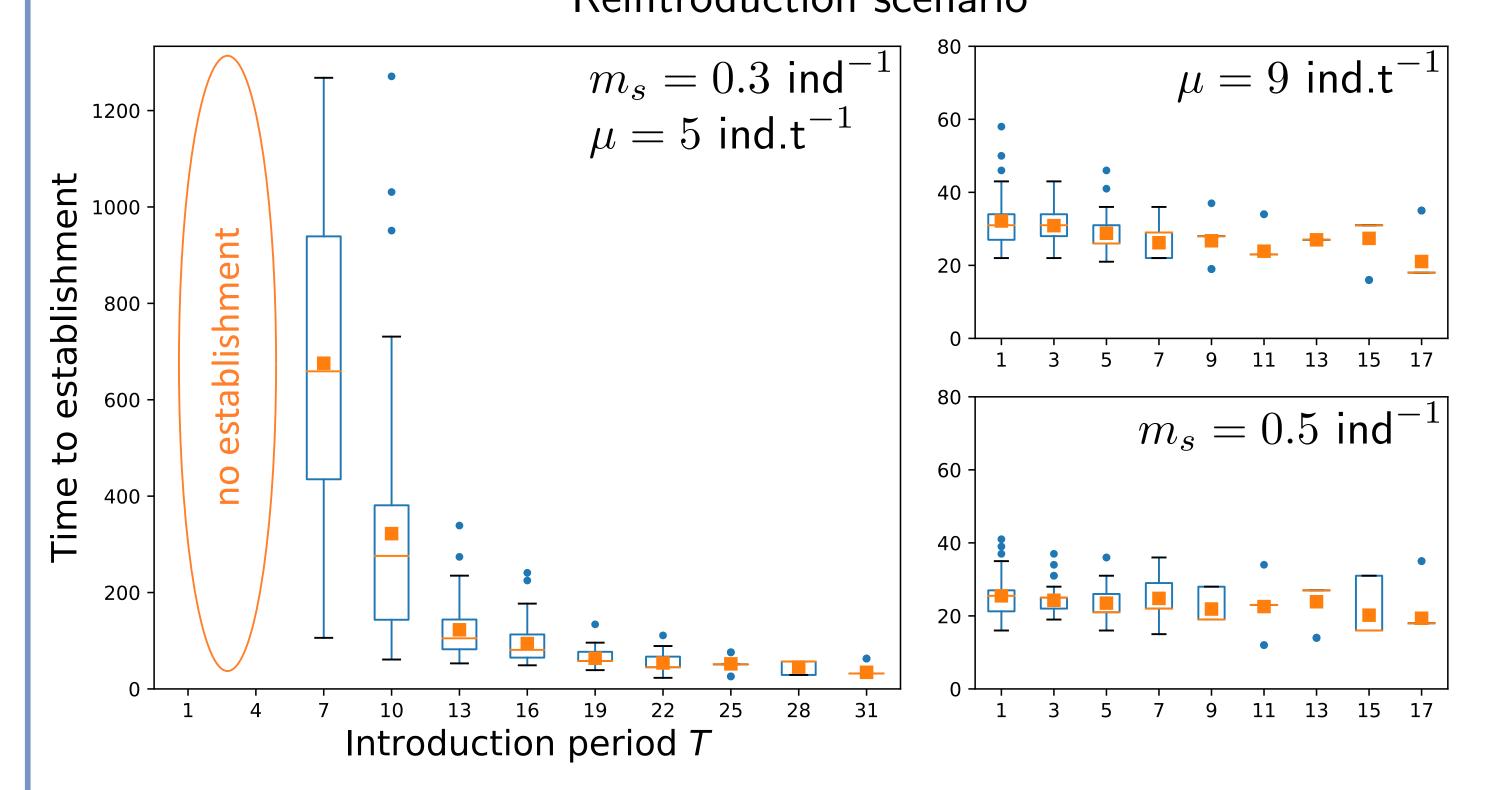
$$P(\mathsf{parasit}) = \exp(-c_i N)$$

• objective: **time** to **suppress host** pop. by 90%

Same introduction policies in both models: every T unit time, introduce X_T individuals, with X_T drawn from a Poisson law:

$$X_T \sim \mathcal{P}(\mu T)$$

Reintroduction scenario



- rare and large introductions lead to faster pop. establishment
- small and frequent introductions can even fail
- effect fades out for large μ or smaller positive density dep.

Conclusions

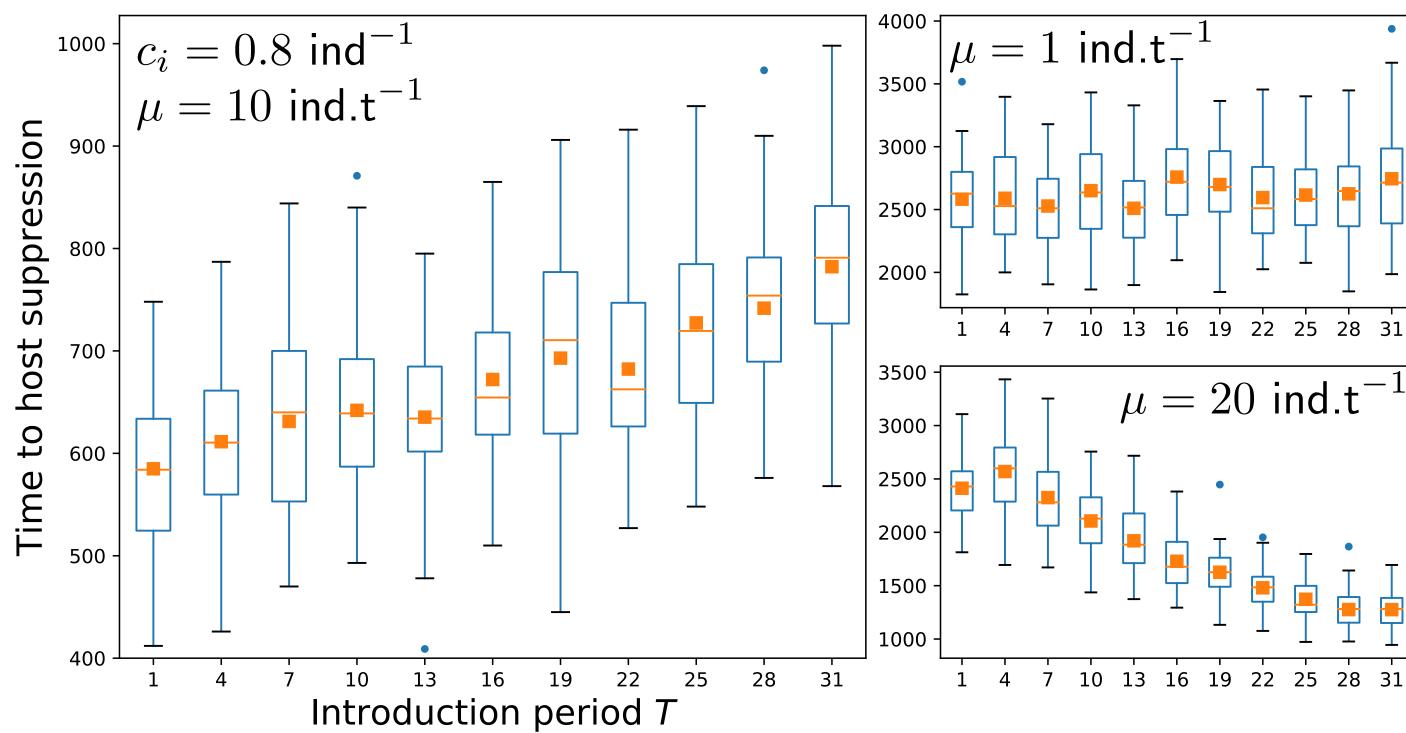
Trends **predicted** by theory were **identified** in stochastic IBM simulations. Yet these trends only show up for **limiting** μ or **strong density dependence**. **Emerging patterns** have also been detected.

 μ is the introduction rate of individuals or parasitoids T is the period between two introduction events

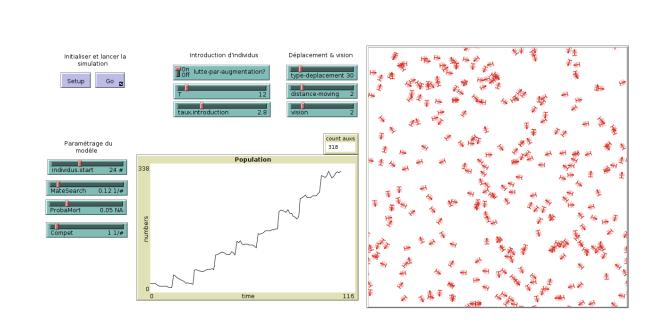
⇒ compute the **time** to achieve the **objective** (Monte Carlo approach)

Results

Biological control scenario



- small and frequent introductions allow faster host suppression
- ullet effect fades out for small μ or smaller competition (not shown)
- ullet effect is **reversed** for large μ , rare and frequent intro. more efficient
