# STABILITY AND ROBUSTNESS ANALYSIS FOR A MULTISPECIES CHEMOSTAT MODEL WITH DELAYS IN THE GROWTH RATES AND UNCERTAINTIES

#### Abstract

We study a chemostat model with an arbitrary number of competing species, one substrate, and constant dilution rates. We allow delays in the growth rates and additive uncertainties. Using constant inputs of certain species, we derive bounds on the sizes of the delays that ensure asymptotic stability of an equilibrium when the uncertainties are zero, which can allow persistence of multiple species. Under delays and uncertainties, we provide bounds on the delays and on the uncertainties that ensure input-to-state stability with respect to uncertainties.


## 1. Introduction.

1.1. Preliminaries. This paper continues our work (which we began in $[8,9,22$, $25,26,27,28,30,39]$ ) on control and other methods to ensure desired asymptotic behaviors in chemostat models, such as the coexistence of multiple competing species, convergence to equilibria, or input delay compensation. Our work is strongly motivated by the ubiquity of chemostats in biological and engineering settings that are of compelling ongoing interest. The chemostat is a laboratory device and a mathematical model for the continuous culture of microorganisms. It was introduced primarily in the works [34] of Monod and [37] of Novick and Szilard from 1950. In the past few decades, chemostat models have been studied extensively, because

[^0]of their role in biotechnology, ecology, and microbiology as ideal representations for modeling cell or microorganism growth, natural environments such as lakes, and wastewater treatment processes [5]; see [42] for an overview of the chemostat literature.

The classical model of competition in the chemostat is described by the system

where $n \geq 2$ microbial species (whose concentrations are denoted by $x_{1}, \ldots, x_{n}$ ) are in competition for a nutrient with concentration $s$ [42]. The positive constants $s_{\text {in }}$ and $D$ are called the input nutrient concentration and the dilution rate, respectively, and $Y_{i}$ is a positive yield constant related to the conversion rate of the substrate into new biomass for each $i$. The continuously differentiable functions $\mu_{i}$ for $i=$ $1, \ldots, n$ are strictly increasing, satisfy $\mu_{i}(0)=0$, and describe the consumption of the nutrient by species $i$. The model also assumes that the growth of the $i$ th species is proportional to the consumption of the nutrient.

It is well known (e.g., from [12, 42]) that if the preceding conditions hold, and if

which is the competitive exclusion principle $[12,15,33,35]$. The constant $\mu_{i}^{-1}(D)$ is called the break-even concentration for the $i$ th species, namely the minimal nutrient concentration that ensures a positive growth for the $i$ th species. Condition (2) says that the species can be ordered by their competitive ability, which is determined by their break-even concentrations. Condition (3) implies that only the $n$th species persists, because it only requires the lowest concentration of the nutrient to have positive growth.

However, it is commonly observed in experiments that multiple competing species can persist in chemostats with one limiting substrate. Numerous methods and theories have been developed to generate or explain coexistence in chemostats, such as crowding effects, feedback controls in which the inputs are functions of the state variables instead of being constant (e.g., in [8, 27]), flocculation [11], heterogeneity properties of the medium (as noted in [10, 16, 36, 38]), impulsive use of substrates (as explained in [31, 32, 47]), intra-species competition [22], multiple substrates [10, 20], and deterministic or stochastic time-varying inputs (as explained, e.g., in $[2,3,7,14,19,29,30,41,45])$. In this work, we study another approach, based on an alternative model that we describe next.
1.2. Description of Our Model. The work [39] modifies the model described by (1) by introducing microbial inputs of the form

in order to promote the coexistence of all species and provides sufficient conditions on the nonnegative constant species inputs $x_{i}^{0}$ for $i=1, \ldots, n$ that can ensure the coexistence of multiple species, which puts [39] outside the scope of the previously
cited works. One approach that was used in [39] involved polytopic Lyapunov functions [9], which are related to other types of piecewise continuous or piecewise differentiable Lyapunov functions such as those in [46].

The system (4) can be seen as a limiting dynamics for a chain of interconnected chemostats, by the following argument. If we consider the system (1) with $n=2$ under condition (2), then the competitive exclusion principle will imply that the concentration of the first species will converge to 0 as $t \rightarrow+\infty$. To promote the coexistence of the two species, the first species (which is the less advantaged competitor) is cultivated in a first chemostat, whose dynamics is described by the system

whose asymptotic behavior is described by (3) with $n=1$, that is

$$
\lim _{t \rightarrow+\infty} s_{1}(t)=s^{*}=\mu_{1}^{-1}(D), \quad \lim _{t \rightarrow+\infty} x_{11}(t)=x_{1}^{*}=Y_{1}\left[s_{\mathrm{in}}-\mu_{1}^{-1}(D)\right] .
$$

If the output of (5) becomes the input of (1) with $n=2$, then we obtain the coupled system

where $x_{i j}$ is the concentration of the $i$ th species in the $j$ th chemostat, while $s_{i}$ is the concentration of the same nutrient in the $i$ th chemostat. The last three equations of (6) can be written as the perturbed system

where the perturbations $q_{0}(t)=D\left[s_{1}(t)-s^{*}\right]$ and $q_{1}(t)=D\left[x_{11}(t)-x_{1}^{*}\right]$ converge to zero as $t \rightarrow+\infty$, so (7) is asymptotically autonomous to

which is a particular case of (4) with $n=2, s_{\text {in }}=s^{*}, x_{1}^{0}=x_{1}^{*}$ and $x_{2}^{0}=0$. A generalization for a chain of $n$ chemostats can be done in a recursive way, by considering the competitive abilities described in (2).

In this article, we propose a generalization of the model (4) by taking into in account (i) the presence of additive perturbations and (ii) the effect of delays in the growth responses [31, 46]. Therefore, the system (4) is changed to

\dot{x}_{i}(t) & =x_{i}(t) \mu_{i}\left(s\left(t-\tau_{i}\right)\right)+D\left[x_{i}^{0}-x_{i}(t)\right]+\delta_{i}(t) \text { for } i=1, \ldots, n
\end{align*}\right.

The functions $\delta_{i}:[0,+\infty) \rightarrow\left[\underline{d}_{i}, \bar{d}_{i}\right]$ are measurable and essentially bounded (for $i=0,1, \ldots, n)$ and have known constant lower and upper bounds $\underline{d}_{i}$ and $\bar{d}_{i}$, respectively. The system (7) is a particular case of (9) but the functions $\delta_{i}$ can
describe uncertainties such as unmodeled features (for example, disturbances in the chain of chemostats mentioned above), external perturbations, or uncertainties in the input concentrations which commonly occur in applications. For example, a perturbed biomass input $x_{i}^{0}+\Delta_{i}(t)$ can be represented by an additive perturbation $\delta_{i}(t)=D \Delta_{i}(t)$. Also, a disturbance $\Delta_{D}$ added to the dilution rate can be captured by setting $\delta_{0}(t)=\Delta_{D}(t)\left[s_{\text {in }}-s(t)\right]$ and $\delta_{i}(t)=\Delta_{D}(t)\left[x_{i}^{0}-x_{i}(t)\right]$ for $i=1,2, \ldots, n$, and uncertainties in the uptake functions $\mu_{i}$ or in $s_{\text {in }}$ can be modeled in an analogous way using suitable choices of the $\delta_{i}$ 's.

Our assumptions will imply that $\underline{d}_{0}>-D s_{\text {in }}$ and $\underline{d}_{i} \geq-D x_{i}^{0}$ for $i=1,2, \ldots, n$; see Section 2 for our assumptions, in which the lower bounds $\underline{d}_{i}$ are allowed to be negative for each $i \geq 1$ such that $x_{i}^{0}>0$ (so the disturbances need not be positive valued). Therefore, all solutions of (9) with positive valued initial conditions are in the positive orthant for all positive instants, so (9) has the state space $\mathcal{X}=$ $(0,+\infty)^{n+1}$. A key component of our analysis is that we will prove a uniform persistence condition, where we compute positive lower bounds on the $x_{i}(t)$ values for all $i$ such that $x_{i}^{0}>0$ and for sufficiently large $t$; see Lemma 3.3.

The model (9) assumes the existence of a time interval $\left[0, \tau_{i}\right]$ necessary for the $i$ th microbial species metabolize the nutrient. The delays $\tau_{i}$ have been reported experimentally in several works, including [ $1,4,40$ ]. Other delays can arise in our model but will not be considered in this note (but their effects can be incorporated into our $\delta_{i}$ 's). For example, in $[13,17,23]$ it is assumed that there is mortality of microbial biomass and a fraction is recycled into nutrient with some time delay. The mortality is also considered in [6, 21, 44], where the growth of biomass term $x_{i}(t) \mu_{i}\left(s\left(t-\tau_{i}\right)\right)$ of (9) is replaced by $e^{-d_{i} \tau_{i}} x_{i}\left(t-\tau_{i}\right) \mu_{i}\left(s\left(t-\tau_{i}\right)\right)$. Through a change of coordinates (based on a scaling the $x_{i}$ 's, $x_{i}^{0}$ 's, and $\delta_{i}$ 's for $i \geq 1$ ), the model (9) becomes

where for simplicity we kept the same notation, and (10) will be the subject of this paper.
1.3. Structure of Article. In the next section, we provide our theorem for (10), which we prove in Section 3 and illustrate in an example in Section 4. Our work is novel in its use of the more general model (10) (which we believe had not been studied in the presence of nonzero delays or uncertainties) and our use of a new Lyapunov-Krasovskii functional method that is beyond the scope of our prior Lyapunov function designs (such as those in [24, 39], which were confined to undelayed systems). Also, the equilibrium that we stabilize is in the boundary of the state space $\mathcal{X}$ when at least one of the $x_{i}^{0}$ 's is 0 . Moreover, while our previous work [39] required that the $n$th species input be $x_{n}^{0}=0$, here we allow a range of possible $x_{n}^{0}$ values, so we cover a much broader class of equilibria than [39].
2. Definitions, Assumptions, and Main Result. Our main result provides sufficient conditions ensuring input-to-state stability (or ISS) properties for the dynamics for the error variable

with respect to the disturbance vector $\delta=\left(\delta_{0}, \delta_{1}, \ldots, \delta_{n}\right)$, for a large class of possible equilibrium points $\mathcal{E}_{*}=\left(s_{*}, x_{*}\right)$, where $x_{*}=\left(x_{1 *}, \ldots, x_{n *}\right)$ and $x=\left(x_{1}, \ldots, x_{n}\right)$. The ISS framework is used extensively across engineering; see [18] for the definition of ISS for undelayed systems without state constraints. To allow delays and state constraints, we use a variant of the usual ISS property. To explain this variant, we first need several definitions. Let $\mathcal{K}_{\infty}$ be the set of all continuous strictly increasing unbounded functions $\gamma:[0,+\infty) \rightarrow[0,+\infty)$ such that $\gamma(0)=0$. Also, $\mathcal{K} \mathcal{L}$ is the set of all continuous functions $\bar{\beta}:[0,+\infty) \times[0,+\infty) \rightarrow[0,+\infty)$ such that (i) for each $t \geq 0$, the function $f(s)=\bar{\beta}(s, t)$ is of class $\mathcal{K}_{\infty}$ and (ii) for each $s \geq 0$, the function $g(t)=\bar{\beta}(s, t)$ is nonincreasing and satisfies $\lim _{t \rightarrow+\infty} g(t)=0$. We also set $q_{t}(\ell)=q(t+\ell)$ for all $\ell \leq 0, t \geq 0$, and functions $q$ for which the equality is defined. By ISS of a delay system of the form $\dot{q}(t)=\mathcal{F}\left(q_{t}, \delta(t)\right)$ with respect to a pair $(\mathcal{D}, \mathcal{S})$, we mean that there exist functions $\beta \in \mathcal{K} \mathcal{L}$ and $\gamma \in \mathcal{K}_{\infty}$ such that

|q(t)| \leq \beta(|q(0)|, t)+\gamma\left(|\delta|_{[0, t]}\right) \tag{12}
\end{equation*}

holds for all $t \geq 0$, all solutions $q(t)$ of the system that have initial states $q(0) \in \mathcal{S}$, and all measurable essentially bounded functions $\delta:[0,+\infty) \rightarrow \mathcal{D}$. Here and in the sequel, we assume that the initial conditions of our systems are constant, $|\cdot|$ is the usual Euclidean norm, $|\cdot|_{[0, t]}$ is the essential supremum over $[0, t]$, and $|\cdot|_{\infty}$ is the essential supremum. Later we specialize the preceding definitions to cases where $q=\mathcal{E}$, and where $q$ is an error vector in a different set of variables that we introduce later. Our first assumption is:

Assumption 1. The constants $s_{*}>0$ and $s_{\text {in }}>0$ are such that

and the constants $x_{i}^{0}$ are all nonnegative. Also, the constant $D$ satisfies $0<D<$ $\mu_{n}\left(s_{\text {in }}\right)$.

Assumption 1 can always be satisfied for all choices of the constant

$$
D \in\left(0, \sup _{s \geq 0} \mu_{n}(s)\right)
$$

by first fixing $s_{*}$ such that $\mu_{i}\left(s_{*}\right)<D$ for all $i$, and then choosing the $x_{i}^{0}$ 's such that $D<\mu_{n}\left(s_{\text {in }}\right)$ and $s_{\text {in }}>0$, i.e., we view the $x_{i}^{0}$ 's and $s_{\text {in }}$ as constant controls. Although this differs from the usual treatment of controls where the controls depend on time (i.e., open loop controls) or on the state (as in feedback controls), our use of constant controls is sufficient for our delays and robustness analysis (and is included in the usual framework of open loop or feedback controls, by specializing the usual framework to cases where the controls are constant ones). By the symmetry of the dynamics for the $x_{i}$ 's, we can replace the condition $D<\mu_{n}\left(s_{\text {in }}\right)$ by the requirement that $D<\mu_{i}\left(s_{\text {in }}\right)$ for some $i$, by renumbering the species. Assumption 1 implies that when the $\delta_{i}$ 's and $\tau_{i}$ 's are 0 , the system (10) admits the equilibrium $\mathcal{E}_{*}=\left(s_{*}, x_{*}\right)$, where

Then $\mathcal{E}_{*} \in[0,+\infty)^{n+1}$, and when the $x_{i}^{0}$ 's are all positive, we have $\mathcal{E}_{*} \in(0,+\infty)^{n+1}$. From Assumption 1, we have $\mu_{n}\left(s_{*}\right)<\mu_{n}\left(s_{\text {in }}\right)$, so since $\mu_{n}$ is strictly increasing, we have $s_{*} \in\left(0, s_{\text {in }}\right)$. Our assumption on the measurable essentially bounded uncertainties $\delta_{i}(t)$ is as follows, where $\mathcal{P}=\left\{i \in\{1, \ldots, n\}: x_{i}^{0}>0\right\}$ :

Assumption 2. We have $\delta(t) \in\left[\underline{d}_{0}, \bar{d}_{0}\right] \times \ldots \times\left[\underline{d}_{n}, \bar{d}_{n}\right]$ for almost all $t \geq 0$, where the known constants $\underline{d}_{i}$ and $\bar{d}_{i} \geq 0$ are such that $D s_{\text {in }}+\underline{d}_{0}>0, \bar{d}_{0}<0.5 D s_{*}$, $D x_{i}^{0}+\underline{d}_{i}>0$ for all $i \in \mathcal{P}$, and $\underline{d}_{i}=0$ for all $i \in\{1,2, \ldots, n\} \backslash \mathcal{P}$.

Assumption 2 allows $\underline{d}_{i}=\bar{d}_{i}=0$ for $i=0,1, \ldots, n$ which corresponds to cases where the $\delta_{i}$ 's are all zero, but is far more general, e.g., because the $\bar{d}_{i}$ 's for $i \geq 1$ can be as large as we want. Notice that in important cases where the $x_{i}^{0}$ 's are all positive, there is no systematic positive bias in the disturbance values, since for instance, we can allow $\delta$ to be take its values in sets such as $\left[\underline{d}_{0}, \bar{d}_{0}\right] \times \ldots \times\left[\underline{d}_{n}, \bar{d}_{n}\right]=$ $\left[-\min \left\{0.25 D s_{*}, 0.5 D x_{*}^{0}\right\}, \min \left\{0.25 D s_{*}, 0.5 D x_{*}^{0}\right\}\right]^{n+1}$ where $x_{*}^{0}=\min \left\{x_{i}^{0}: 1 \leq i \leq\right.$ $n\}$ that are symmetric hypercubes centered at the origin. To state our assumption on the constant delays $\tau_{i}$, we assume that the $\mu_{i}$ 's have the Monod's form

with $m_{i}>0$ and $a_{i}>0$ being respectively the maximal growth rate and the half saturation constants for all $i \in\{1,2, \ldots, n\}$, and we set

where the constant $\bar{s} \geq s_{\text {in }}$ will be specified later. Finally, we use the positive constants

The motivation for the constant $\Gamma_{0}$ is that it is a lower bound for the function

Theorem 2.1. If Assumptions 1-2 hold, and if there exists a constant $\bar{s} \geq s_{\mathrm{in}}$ such that each of the constant delays $\tau_{i}$ satisfies

then for all constants $\underline{x}>0$, the dynamics for the error (11) are ISS with respect to $(\mathcal{D}, \mathcal{S})$ with the disturbance set $\mathcal{D}=\left[\underline{d}_{0}, \bar{d}_{0}\right] \times \ldots \times\left[\underline{d}_{n}, \bar{d}_{n}\right]$ and $\mathcal{S}=\left\{\mathcal{E}: \mathcal{E}+\mathcal{E}_{*} \in\right.$ $\left.(0, \bar{s}] \times(0,+\infty)^{n-1} \times(\underline{x},+\infty)\right\}$.

Our proof of Theorem 2.1 will show how the constants $\underline{s}_{1}$ and $\underline{\alpha}_{i}$ described in (17) are related to the lower bounds of the solutions of (10) for arbitrarily large values of $t$. Note also that $M$ depends on the $\tau_{i}$ 's for all $i=1, \ldots, n$ and is equal to zero when these delays are 0 , which implies that there are positive values $\bar{\tau}_{i}$ such that (19) is satisfied when the delays $\tau_{i}$ all satisfy $0 \leq \tau_{i} \leq \bar{\tau}_{i}$.

Since $\mathcal{E}(t)+\mathcal{E}_{*}=(s(t), x(t))$ for all $t \geq 0$, our choice of $\mathcal{S}$ in Theorem 2.1 corresponds to the requirement that $(s(0), x(0)) \in(0, \bar{s}] \times(0,+\infty)^{n-1} \times(\underline{x},+\infty)$. However, since $\bar{s} \geq s_{\text {in }}$ and $\underline{x}>0$ are arbitrary, it follows that when the $\delta_{i}$ 's are zero, Theorem 2.1 implies that all solutions $(s(t), x(t))$ of (10) starting in $\mathcal{X}=(0,+\infty)^{n+1}$ remain in $\mathcal{X}$ at all positive times and satisfy $\lim _{t \rightarrow+\infty}(s(t), x(t))=\left(s_{*}, x_{*}\right)$. This ensures uniform persistence of the $i$ th species for all $i \in \mathcal{P}$, i.e., $x_{i}$ has a positive lower bound (and $\lim _{t \rightarrow+\infty} x_{i}(t)=0$ for all $i \in\{1, \ldots, n\} \backslash \mathcal{P}$ ). Our results are new, even in the special cases where the delays $\tau_{i}$ or the uncertainties $\delta_{i}$ are all zero, because [39] did not include delays or uncertainties. Since we do not restrict the values of $\bar{d}_{i} \geq 0$ for $i \geq 1$, we obtain ISS under arbitrarily large upper bounds on the disturbances $\delta_{i}$ in the $x$ subdynamics. The functions $\beta \in \mathcal{K} \mathcal{L}$ and $\gamma \in \mathcal{K}_{\infty}$ in the final ISS estimate will depend on $\bar{s}, \underline{x}$, and the disturbance bounds $\bar{d}_{i}$ and $\underline{d}_{i}$ from Assumption 2, and our proof of Theorem 2.1 can be used to provide an algorithm for constructing $\beta$ and $\gamma$. Moreover, as noted in Section 1.2, several types of uncertainties (including in the dilution rate or in the concentration of species input) can be captured by our additive uncertainties $\delta_{i}$, so our ISS results can estimate or measure the effects of these types of uncertainties.

## 3. Proof of Theorem 2.1.

3.1. Changes of Variables and Preliminary State Bounds. We set $\bar{\tau}=$ $\max _{i} \tau_{i}$. Since (10) is forward complete on $\mathcal{X}=(0,+\infty)^{n+1}$, we can first fix any solution $(s(t), x(t))$ of the system all of whose components are positive for all $t \geq 0$, with $x_{n}(0)>\underline{x}$. Then Assumption 2 implies that $s(t) \leq \bar{s}^{\sharp}$ for all $t \geq 0$, since we would have $\dot{s}(t)<0$ for all $t$ for which $s(t)>\bar{s}^{\sharp}$ and $s(0) \leq \bar{s}$. We use the new variables

in our new variables, where we also set $\Delta_{0}=\delta_{0}$ for consistency. We next prove three lemmas which produce three functions $T_{i} \in \mathcal{K}_{\infty}$ for $i=1,2,3$, whose class
$\mathcal{K}_{\infty}$ properties will be used later to build an ISS estimate that is valid for all times $t \geq 0$. Set $(\tilde{s}, \tilde{x})=\left(s-s_{*}, x-x_{*}\right)$. Our first lemma is:

Lemma 3.1. There is a function $T_{1} \in \mathcal{K}_{\infty}$ such that $s(t) \leq s_{\mathrm{in}}+\bar{d}_{0} / D$ for all $t \geq T_{1}(|\tilde{s}(0)|)$.

Proof. Assumptions 1-2 imply that for all $t \geq 0$, we have $s(t)>0$ and $\alpha_{i}(t)>0$ for all $i \in\{1, \ldots, n\}$. If there is a time $t_{l} \geq 0$ such that $s\left(t_{l}\right) \leq s_{\text {in }}+\bar{d}_{0} / D$, then for all $t>t_{l}$, we have $s(t) \leq s_{\text {in }}+\bar{d}_{0} / D$, since $\dot{s}(t)<0$ at all times $t \geq 0$ such that $s(t) \geq s_{\text {in }}+\bar{d}_{0} / D$. Hence, to prove the lemma, it suffices to consider the case where $s(0)>s_{\text {in }}+\bar{d}_{0} / D$ and consequently $\tilde{s}(0) \neq 0$. In this case, it follows that for all $t \geq 0$ such that $s(\ell)>s_{\text {in }}+\bar{d}_{0} / D$ for all $\ell \in[0, t]$, we also have $\dot{s}(\ell)<0$. Therefore, for any such $t$, we can use the facts that $D<\mu_{n}\left(s_{\text {in }}\right)$ and $\mu_{n}$ is nondecreasing, combined with the inequalities $D x_{n}^{0}+\underline{d}_{n} \geq 0$ and $s_{*}<s_{\text {in }} \leq s(\ell)$ for all $\ell \in[0, t]$, to deduce that for all $\ell \in[0, t]$, we have $\alpha_{n}(\ell) \geq \alpha_{n}(0) \geq \underline{x} e^{-\mu_{n}\left(s_{*}\right) \tau_{n}}$ and $D\left(s_{\text {in }}-s(\ell)\right)+\Delta_{0}(\ell) \leq 0$, so

Then the constants $\mathcal{L}_{i}$ satisfy $\mathcal{L}_{i} \leq \overline{\mathcal{L}}_{i}$ for all $i$, where the constant $\overline{\mathcal{L}}_{i}$ 's were defined in (17); this follows from our assumptions that the initial conditions are constant combined with the facts that $\mu_{i}$ 's are nondecreasing and $s(\ell) \leq \bar{s}^{\sharp}$ for all $\ell \geq 0$, which gives $\mu_{i}(s(\ell)) \leq \mu_{i}\left(\bar{s}^{\sharp}\right)$ for all $\ell \geq-\tau_{i}$ and all $i$. Pick any constant $\lambda_{1}>1$ such that our delay upper bounds from (19) are satisfied with $C$ replaced by $\lambda_{1} C$ in the formulas from (17). Such a $\lambda_{1}$ exists, because of the strictness of the inequalities in (19), by picking $\lambda_{1}>1$ close enough to 1 . We next prove:

Lemma 3.2. If Assumptions 1-2 hold, then there is a $T_{2} \in \mathcal{K}_{\infty}$ such that $\sigma(t) \leq$ $\lambda_{1} C$ for all $t \geq T_{2}(|\mathcal{E}(0)|)$.

Proof. By (22),

Therefore, the lemma will follow once we find a function $T_{2} \in \mathcal{K}_{\infty}$ such that $T_{2}(|\mathcal{E}(0)|) \geq T_{2}^{b}(\sigma(0))$ for all solutions of (10) such that $\sigma(0)>\lambda_{1} C$. To find $T_{2}$, first notice that (25) and our formula for $s_{\text {in }}$ in (13) give

Case 2: If $|\mathcal{E}(0)|>\left(s_{\text {in }}+x_{1}^{0}+\ldots+x_{n}^{0}\right) /(n+1)$, then we use the fact that the last equality in (28) gives $T_{2}^{b}\left((n+1)|\mathcal{E}(0)|+s_{\text {in }}+x_{1}^{0}+\ldots+x_{n}^{0}\right) \geq T_{2}^{b}(\sigma(0))$. We now fix a constant $\lambda_{2} \in(0,1)$ such that our delay bounds from (19) hold with $C$ replaced by $\lambda_{1} C$ in (17) and with $\underline{s}_{1}$ and the $\underline{\alpha}_{i}$ 's replaced by

The following lemma provides useful positive lower bounds on $s(t)$, and on the $\alpha_{i}(t)$ 's for all $i \in \mathcal{P}$ :

Lemma 3.3. If Assumptions 1-2 hold, then there is a function $T_{3} \in \mathcal{K}_{\infty}$ such that $s(t) \geq \underline{s}_{\lambda}$ and $\alpha_{i} \geq \underline{\alpha}_{i \lambda}$ hold for all $t \geq T_{3}(|\mathcal{E}(0)|)-\bar{\tau}$ and all $i \in \mathcal{P}$.

Also, for each $i \in \mathcal{P}$, the right side of (32) is bounded below by the positive value $\left(1-\lambda_{2}\right)\left(D x_{i}^{0}+\underline{d}_{i}\right) e^{-\mu_{i}\left(s_{*}\right) \tau_{i}}$ if $t$ is such that $\alpha_{i}(t) \leq \underline{\alpha}_{i \lambda}$. Hence, for any $t_{0} \geq 0$ such that $s\left(t_{0}\right) \geq \underline{s}_{\lambda}$, we have $s(t) \geq \underline{s}_{\lambda}$ for all $t \geq t_{0}$. Also, for each $i \in \mathcal{P}$, and for any $t_{0} \geq 0$ such that $\alpha_{i}\left(t_{0}\right) \geq \underline{\alpha}_{i \lambda}$, we have $\alpha_{i}(t) \geq \underline{\alpha}_{i \lambda}$ for all $t \geq t_{0}$. Hence, to construct $T_{3}$, it suffices to choose $T_{3} \in \mathcal{K}_{\infty}$ such that the following conditions hold: (i) If $s(0)<\underline{s}_{\lambda}$, then $s(t) \geq \underline{s}_{\lambda}$ for some $t \in\left(0, T_{3}(|\mathcal{E}(0)|)-\bar{\tau}\right]$ (which implies that $s(t) \geq \underline{s}_{\lambda}$ for all $t \geq T_{3}(|\mathcal{E}(0)|)-\bar{\tau}$, by the preceding argument) and (ii) for each $i \in \mathcal{P}$ such that $\alpha_{i}(0)<\underline{\alpha}_{i \lambda}$, we have $\alpha_{i}(t) \geq \underline{\alpha}_{i \lambda}$ for some $t \in\left(0, T_{3}(|\mathcal{E}(0)|)-\bar{\tau}\right]$ (which implies that $\alpha_{i}(t) \geq \underline{\alpha}_{i \lambda}$ for all $t \geq T_{3}(|\mathcal{E}(0)|)-\bar{\tau}$, also by the preceding argument).

To satisfy the preceding conditions (i)-(ii), first note that if we choose any constant $T_{L}>0$ such that

Conditions (A)-(B) follow because $s(\ell) \geq s(0)+\ell\left(D s_{\text {in }}+\underline{d}_{0}\right)\left(1-\lambda_{2}\right)$ for all $\ell$ such that $\max _{r \in[0, \ell]} s(r)<\underline{s}_{\lambda}$, and $\alpha_{i}(\ell) \geq \alpha_{i}(0)+\ell\left(1-\lambda_{2}\right)\left(D x_{i}^{0}+\underline{d}_{i}\right) e^{-\mu_{i}\left(s_{*}\right) \tau_{i}}$ for all $\ell$ such that $\max _{r \in[0, \ell]} \alpha_{i}(r)<\underline{\alpha}_{i \lambda}$, so $\ell \leq T_{L}-\bar{\tau}$. On the other hand, if $|\mathcal{E}(0)| \leq T_{M}$ where $T_{M}=\left(1-\lambda_{2}\right) \min \left\{s_{*}, \min \left\{x_{i *}: i \in \mathcal{P}\right\}\right\}$, then $s(0)-s_{*} \geq\left(\lambda_{2}-1\right) s_{*}$, and for all $i \in \mathcal{P}$, we have $x_{i}(0)-x_{i *} \geq\left(\lambda_{2}-1\right) x_{i *}$, so our definition of the $\alpha_{i}$ 's in (21)
gives $s(0) \geq \lambda_{2} s_{*} \geq \underline{s}_{\lambda}$ and $\alpha_{i}(0) \geq x_{i}(0) e^{-\tau_{i} \mu_{i}\left(s_{*}\right)} \geq \lambda_{2} x_{i *} e^{-\tau_{i} \mu_{i}\left(s_{*}\right)} \geq \underline{\alpha}_{i \lambda}$ for all $i \in \mathcal{P}$, which imply that $s(t) \geq \underline{s}_{\lambda}$ and $\alpha_{i}(t) \geq \underline{\alpha}_{i \lambda}$ all hold for all $t \geq 0$ and $i \in \mathcal{P}$. Hence, we can choose

Our choice of $V_{1}$ is motivated by the fact that if the delays and uncertainties are all 0 , then $V_{1}$ is a Lyapunov function for the system (41).

and where we also applied the inequality $c_{1} c_{2} \leq \frac{1}{2} c_{1}^{2}+\frac{1}{2} c_{2}^{2}$ and then Young's inequality $c_{1} c_{2} \leq \frac{1}{4} c_{1}^{2}+c_{2}^{2}$, with $c_{1}$ and $c_{2}$ being the corresponding terms in curly braces in (49) in both applications, and we used the fact that $s(\ell) \leq \bar{s}^{\sharp}$ for all $\ell \geq 0$ to get

Our bound (19) from Theorem 2.1 and our choices of the $\lambda_{i}$ 's imply that $\bar{\tau} \mathcal{M}_{\lambda}(\tau) \lambda_{1}<$ $\Gamma_{0} / 2$, by choosing $\lambda_{2} \in(0,1)$ and $\lambda_{1}>1$ close enough to 1 . Therefore, there is a constant $v_{0}$ such that along all solutions of (35) in our state space $\mathcal{X}=(0, \infty)^{n+1}$ and for all times $t \geq T_{3}(|\mathcal{E}(0)|)$, the time derivative of the function

to find $v_{0}$. The remainder of the proof consists of converting (53) into an ISS estimate in the transformed error variable $\hat{\mathcal{E}}(t)=\left(\tilde{s}(t), \tilde{\alpha}_{1}(t), \ldots, \tilde{\alpha}_{n}(t)\right)$ that is valid for all $t \geq 0$, which we then convert into an ISS estimate in the original error variable $\mathcal{E}=(s, x)-\mathcal{E}_{*} ;$ for details for the completion of the proof, see the appendix below.
4. Illustration. Consider the system (10) with $n=2, D=0.4, s_{*}=0.5, x_{1}^{0}=1$, and $x_{2}^{0}=0.55$ and the growth functions

We apply our theorem with the choice $\bar{s}=s_{\text {in }}$. Then Assumption 1 is satisfied with $s_{\text {in }}=1.34412$, and the corresponding equilibria (14) are $x_{1 *}=1.29412$ and $x_{2 *}=1.1$. In this illustration, we will use the vectors $\delta(t)$ to model uncertainties in applying the constant input concentrations (which may occur in applications, because it may be difficult to maintain the inputs $x_{i}^{0}$ at constant levels), so we can set $\delta_{0}(t)=0$ and therefore choose $\underline{d}_{0}=\bar{d}_{0}=0$. To isolate the effects of delays in one of the species, we assume that $\tau_{1}$ is positive but that $\tau_{2}=0$ (but analogous results can be obtained if the delay is in the dynamics for the second species, or in the dynamics for both species). Then Assumption 2 is satisfied with $\bar{d}_{1}=-\underline{d}_{1}=\bar{d}_{2}=-\underline{d}_{2}=0.1$, and our requirements (19) on the delays $\tau_{i}$ are satisfied with the choice $\bar{s}=s_{\text {in }}$ for all values $\tau_{1} \in[0,0.145)$.

We simulated the dynamics (10) using the command NDSolve in Mathematica [43], with the preceding choices of the parameters, the delays $\tau_{1}=0.14$ and $\tau_{2}=0$, and the disturbance vector $\delta(t)=\left(\delta_{0}(t), \delta_{1}(t), \delta_{2}(t)\right)=(0,-0.1 \sin (t), 0.1 \cos (t))$, to isolate the effects of uncertainties in applying the constant input concentrations $x_{i}^{0}$ in the $x$ subdynamics. We report our results in the figures below, with the initial state $\left(s(0), x_{1}(0), x_{2}(0)\right)=(0.2,0.1,1)$, and then with the initial state $\left(s(0), x_{1}(0), x_{2}(0)\right)=(1.3,0.2,0.1)$. The figures show rapid convergence towards an oscillatory steady state, with a deviation from the equilibrium point $\left(s_{*}, x_{1 *}, x_{2 *}\right)=$ $(0.5,1.29412,1.1)$ that can be explained by the presence of the uncertainties $\delta_{1}$ and $\delta_{2}$, and therefore help illustrate our theory.
5. Boundedness of Solutions of (10) for All Delays $\tau_{i}$. Theorem 2.1 leaves open the question of whether all solutions of (10) are bounded when our Assumptions 1-2 are satisfied. Therefore, we prove the following result on boundedness of solutions of (10):

Proposition 1. Let Assumptions 1-2 hold and the growth functions $\mu_{i}$ satisfy $\mu_{i}(0)=0$ and be $C^{1}$ and strictly increasing for all $i \in\{1,2, \ldots, n\}$. Assume that $D<\sup _{s \geq 0} \mu_{i}(s)$ for all $i \in\{1,2, \ldots, n\}$. Then for all constant delays $\tau_{i} \geq 0$, all solutions of (10) starting in $(0,+\infty)^{n+1}$ are bounded.

Proof. Choose any constant $s_{d} \geq s_{\text {in }}+\left(\bar{d}_{0} / D\right)$ such that $\mu_{i}\left(s_{d}\right)>D$ for all $i \in\{1,2, \ldots, n\}$, and fix any solution $(s(t), x(t))$ of (10) whose initial value is componentwise positive. Then Lemma 3.1 provides a constant $t_{a} \geq 0$ such that $s(t) \leq s_{d}$ for all $t \geq t_{a}$, and our assumptions ensure that all components of $(s(t), x(t))$ are nonnegative valued for all $t \geq 0$. Hence, $s(t)$ is bounded. Set $D_{*}=D s_{\text {in }}+\bar{d}_{0}$. Then our assumptions give $\dot{s}(t) \leq D_{*}$ for all $t \geq 0$, which gives

for all values $a_{1} \geq 0$ and $a_{2} \geq 0$ such that $t_{a}+\tau \leq a_{1} \leq a_{2}$. Since $s(t)$ is bounded, it remains to show that $x_{i}(t)$ is a bounded function of $t$ for all $i \in\{1,2, \ldots, n\}$, which we prove by contradiction.

Suppose that there were a $j \in\{1, \ldots, n\}$ such that $x_{j}$ is unbounded. For later use, we define the constant $s_{0}>0$ by $\mu_{j}\left(s_{0}\right)=D / 2$. Since $x_{j}(t)$ is unbounded, there is a sequence of values $t_{k} \geq t_{a}+2 \tau+\left(s_{0} /\left(2 D_{*}\right)\right.$ such that $t_{k+1} \geq t_{k}+2 \tau+s_{0} /\left(2 D_{*}\right)$ for all $k \geq 1$, and such that the following four conditions hold: (i) $x\left(t_{k}\right)$ is increasing, (ii) $\lim _{k \rightarrow \infty} x_{j}\left(t_{k}\right)=+\infty$, (iii) $\dot{x}_{j}\left(t_{k}\right) \geq 0$ for all $k \geq 1$, and (iv) the inequality

We can satisfy the preceding conditions (i)-(iv) by first choosing the $t_{k}$ 's such that (i)-(ii) and (iv) are all satisfied, then replacing $t_{2}$ by a value $t_{2 *} \in\left[t_{1}, t_{2}\right]$ such that $\dot{x}_{j}\left(t_{2 *}\right) \geq 0$ (in case $\dot{x}_{j}\left(t_{2}\right)<0$, by setting $t_{2 *}=\inf \{t \in$ $\left[t_{1}, t_{2}\right]: \dot{x}_{j}(r)<0$ for all $\left.r \in\left(t, t_{2}\right]\right\}$, and such a $t_{2 *}$ exists because $\left.x_{j}\left(t_{1}\right) \leq x_{j}\left(t_{2}\right)\right)$, then replacing $t_{3}$ by a value $t_{i}$ such that $i>3$ and $x_{j}\left(t_{i}\right)>x_{j}\left(t_{2 *}\right)$ and deleting $t_{2}, \ldots, t_{i-1}$ from the sequence, then repeating the preceding process with $t_{1}$ replaced by $t_{i}$, and then reasoning inductively. Since $\dot{x}_{j}\left(t_{k}\right) \geq 0$ for all $k \geq 1$, it follows that $x_{j}\left(t_{k}\right) \mu_{j}\left(s\left(t_{k}-\tau\right)\right)+D\left[x_{j}^{0}-x_{j}\left(t_{k}\right)\right]+\delta_{j}\left(t_{k}\right) \geq 0$, which we can rearrange to obtain

Consider the intervals

As an immediate consequence of (10) and (62), we deduce that $\dot{s}(t) \leq D_{*}-\mu_{j}\left(s_{0} / 2\right) x_{j}(t)$ for all $t \in I_{k}$, which we can integrate over $I_{k}$ to obtain

by using the lower bound on the $t_{k}$ 's and our choice of $s_{d}$, and noting that the lower limit of integration in (63) satisfies $t_{k}-\tau-\left(s_{0} /\left(2 D_{*}\right)\right) \geq t_{a}$ to obtain $s\left(t_{k}-\tau-\right.$ $\left.\left(s_{0} /\left(2 D_{*}\right)\right)\right) \leq s_{d}$.

We can also use (57) to conclude that for all $m \in I_{k}$, we have

Since $\lim _{k \rightarrow \infty} x_{j}\left(t_{k}\right)=+\infty$, it follows from (65) that there is $k_{p}>0$ such that for all $k \geq k_{p}$, we have

Since $\lim _{k \rightarrow \infty} x_{j}\left(t_{k}\right)=+\infty$, it follows that there is a $k \geq k_{p}$ such that $s\left(t_{k}-\tau\right)<0$. This yields a contradiction with the fact that $s(t) \geq 0$ for all $t \geq 0$.
6. Conclusions. We solved an input-to-state stabilization problem for a chemostat model with one limiting substrate, an arbitrary number of competing species, a constant dilution rate, delays in the uptake functions, and uncertainties. We used the constant species inputs and the input nutrient concentration as constant controls, and these controls can be chosen to input-to-state stabilize a large class of possible equilibria. In the special case where all of the constant inputs $x_{i}^{0}$ are positive and the disturbances are zero, we first proved (in Lemma 3.3) that all solutions whose initial states are in the positive orthant are uniformly persistent, meaning, there is a positive lower bound on the species levels. Then by using a Lyapunov functional, we proved that the solutions asymptotically converge towards a positive equilibrium, which generalizes [39]. We use the $x_{i}^{0}$ 's and the input nutrient concentration $s_{\mathrm{in}}$ as constant controls.

To cope with delays in uptake functions or uncertainties, we used a new Lyapunov functional approach. The decay estimate for our Lyapunov-like function made it possible to prove robustness to uncertainties. We hope to generalize our work to larger classes of models with multiple species and multiple limiting substrates. Our choices of the uptake functions (15) made it possible to obtain lower and upper bounds in several intermediate steps of the construction of the Lyapunov functional. The Michaelis-Menten growth functions that we used provide a wide range of generality for our results, since the growth rates of many species are described by such functions. A more general result is still unsolved for more general uptake functions, due to the technical difficulties induced by the lack of monotonicity and more complex nonlinearities.

Appendix: Completing the Proof of Theorem 2.1. We complete the proof of Theorem 2.1, by converting the decay estimate (53) into an ISS estimate in the transformed error variable $\hat{\mathcal{E}}(t)=\left(\tilde{s}(t), \tilde{\alpha}_{1}(t), \ldots, \tilde{\alpha}_{n}(t)\right)$ that is valid for all $t \geq 0$, which we then convert into an ISS estimate in the original error variable $\mathcal{E}$ from the statement of the theorem. To this end, first note that we can use our three lemmas to find a function $\underline{\gamma} \in \mathcal{K}_{\infty}$ such that

and therefore also $\dot{V}_{2}\left(\hat{\mathcal{E}}_{t}\right) \leq-\underline{\gamma}\left(V_{2}\left(\hat{\mathcal{E}}_{t}\right)\right)+\bar{N}|\delta|_{[0, t]}$ along all trajectories of the $\mathcal{E}$ dynamics starting in our set $\mathcal{S}$ of initial states from the statement of our theorem, and for all $t \geq T_{3}(|\mathcal{E}(0)|)$ (by using the known positive upper and lower bounds for
$s(t)$ and the $\alpha_{i}(t)$ 's for $i \in \mathcal{P}$ that are valid for all $\left.t \geq T_{3}(|\mathcal{E}(0)|)\right)$. One method for finding $\underline{\gamma}$ is as follows. First, pick a function $\underline{\gamma}_{0} \in \mathcal{K}_{\infty}$ such that

for all $i \in\{1, \ldots, n\}$ and all $\hat{\mathcal{E}}=\left(\tilde{s}, \tilde{\alpha}_{1}, \ldots \tilde{\alpha}_{n}\right)$ such that the following conditions hold: $\tilde{s} \in\left[\underline{s}_{\lambda}-s_{*}, \lambda_{1} C-s_{*}\right], \tilde{\alpha}_{i} \in\left[\underline{\alpha}_{i \lambda}-x_{i *}, \lambda_{1} C \overline{\mathcal{L}}_{i}-x_{i *}\right]$ for all $i \in \mathcal{P}$, and $\tilde{\alpha}_{i} \in\left(0, \lambda_{1} C \overline{\mathcal{L}}_{i}\right]$ for all $i \in\{1, \ldots, n\} \backslash \mathcal{P}$. Then $V_{1}(\hat{\mathcal{E}}(t)) \leq \underline{\gamma}_{0}(|\hat{\mathcal{E}}(t)|)$ for all $t \geq T_{3}(|\mathcal{E}(0)|)$. Hence, Lemma 3.2 gives

$$
\begin{equation*}
\left(\underline{\gamma}_{0}^{-1}\left(V_{1}(\hat{\mathcal{E}}(t))\right)\right)^{2} \leq|\hat{\mathcal{E}}(t)|^{2} \leq \lambda_{1} C\left(\frac{\tilde{s}^{2}(t)}{s(t)}+\max _{i} \overline{\mathcal{L}}_{i} \sum_{i=1}^{n} \frac{\tilde{\alpha}_{i}^{2}(t)}{\alpha_{i}(t)}\right) \tag{A.3}
\end{equation*}
$$

since $\max \left\{s(t), \max \left\{\alpha_{i}(t) / \overline{\mathcal{L}}_{i}: 1 \leq i \leq n\right\}\right\} \leq \lambda_{1} C$ for all $t \geq T_{3}(|\mathcal{E}(0)|)$. Therefore, the function

$$
\begin{equation*}
\Theta(r)=\min \left\{\left(\underline{\gamma}_{0}^{-1}\left(\frac{r}{2}\right)\right)^{2}, \frac{r}{2 \lambda_{1}\left(\mathcal{M}_{\lambda}(\tau)+1\right)}\right\} \tag{A.4}
\end{equation*}
$$

satisfies

$$
\begin{align*}
& \Theta\left(V_{2}\left(\hat{\mathcal{E}}_{t}\right)\right) \leq \Theta\left(2 V_{1}(\hat{\mathcal{E}}(t))\right)+\Theta\left(2 \lambda_{1} \mathcal{M}_{\lambda}(\tau) \mathcal{D}_{I}(t)\right) \\
& \leq\left(\underline{\gamma}_{0}^{-1}\left(V_{1}(\hat{\mathcal{E}}(t))\right)\right)^{2}+\mathcal{D}_{I}(t) \leq \lambda_{1} C \max _{i} \overline{\mathcal{L}}_{i}\left(\frac{\tilde{s}^{2}(t)}{s(t)}+\sum_{i=1}^{n} \frac{\tilde{\alpha}_{i}^{2}(t)}{\alpha_{i}(t)}\right)  \tag{A.5}\\
& +\mathcal{D}_{I}(t)
\end{align*}
$$

where $\mathcal{D}_{I}(t)$ is the double integral in (A.1), and where the first inequality in (A.5) used the fact that $\Theta(a+b) \leq \Theta(2 a)+\Theta(2 b)$ where $a$ and $b$ are the two terms in our formula (52) for $V_{2}$, and where the last inequality in (A.5) used the fact that $\max _{i} \overline{\mathcal{L}}_{i} \geq 1$. Therefore, we can choose $\underline{\gamma}=\Theta v_{0} / v_{a}$, where $v_{a}=$ $\max \left\{\lambda_{1} C \max _{i} \overline{\mathcal{L}}_{i}, 1\right\}$. Hence, standard ISS arguments ${ }^{-}$(e.g., from [18]) provide functions $\beta_{0} \in \mathcal{K} \mathcal{L}$ and $\gamma_{0} \in \mathcal{K}_{\infty}$ such that

V_{2}\left(\hat{\mathcal{E}}_{t}\right) \leq \beta_{0}\left(V_{2}\left(\hat{\mathcal{E}}_{T_{3}(|\mathcal{E}(0)|)}\right), t\right)+\gamma_{0}\left(|\delta|_{[0, t]}\right) \tag{A.6}
\end{equation*}
$$

for all $t \geq T_{3}(|\mathcal{E}(0)|)$. Then the structure of $V_{2}$ provides functions $\beta_{1} \in \mathcal{K} \mathcal{L}$ and $\gamma_{1} \in \mathcal{K}_{\infty}$ such that

$$
\begin{equation*}
|\hat{\mathcal{E}}(t)| \leq \beta_{1}\left(\left|\hat{\mathcal{E}}_{T_{3}(|\mathcal{E}(0)|)}\right|_{[-\bar{\tau}, 0]}, t\right)+\gamma_{1}\left(|\delta|_{\infty}\right) \tag{A.7}
\end{equation*}
$$

for all $t \geq T_{3}(|\mathcal{E}(0)|)$.
To extend (A.7) to obtain an ISS estimate that is valid for all $t \geq 0$, first note that the structure (38) of the $\hat{\mathcal{E}}$ dynamics and the Mean Value Theorem estimate (46), combined with our bounds on the $\mu_{i}$ 's, $s(t)$, and $\Gamma$ and the global Lipschitzness of the $\mu_{i}$ 's, provide a constant $\bar{L}$ (that is independent of the choice of the solution) such that

$$
\begin{equation*}
\left|\frac{d}{d \ell} \hat{\mathcal{E}}(\ell)\right| \leq \bar{L}\left(\max \left\{\left|\hat{\mathcal{E}}_{\ell}(r)\right|: r \in[-\bar{\tau}, 0]\right\}+|\delta|_{[0, \ell]}\right) \tag{A.8}
\end{equation*}
$$

for all $\ell \in\left[0, T_{3}(|\mathcal{E}(0)|)\right]$; this can be done by rewriting both occurrences of $\alpha_{i}(t)$ in the dynamics (38) for $\hat{\mathcal{E}}$ in the form $\tilde{\alpha}_{i}(t)+x_{i *}$, and $\hat{\mathcal{E}}_{\ell}$ is defined over the entire interval $[-\bar{\tau}, 0]$ for all choices of $\ell \in\left[0, T_{3}(|\mathcal{E}(0)|)\right]$ because of our assumption that the initial functions are constant, which allows us to extend their domains to include
all negative real values). Integrating (A.8) over $[0, t]$ for any $t \in\left[0, T_{3}(|\mathcal{E}(0)|)\right]$ and applying the Fundamental Theorem of Calculus to $\hat{\mathcal{E}}$ gives

\mathcal{F}(t) \leq \mathcal{F}(0)+\bar{L} \int_{0}^{t} \mathcal{F}(\ell) \mathrm{d} \ell+\bar{L} T_{3}(|\mathcal{E}(0)|)|\delta|_{\infty} \tag{A.9}
\end{equation*}
$$

where $\mathcal{F}(\ell)=|\hat{\mathcal{E}}|_{[\ell-\bar{\tau}, \ell]}$.
We now apply Gronwall's inequality to $\mathcal{F}$ and use the constantness of the initial functions to get

\begin{align*}
|\hat{\mathcal{E}}(t)| \leq \mathcal{F}(t) \leq & \left(\mathcal{F}(0)+\bar{L} T_{3}(|\mathcal{E}(0)|)|\delta|_{\infty}\right) e^{\bar{L} T_{3}(|\mathcal{E}(0)|)} \\
= & |\hat{\mathcal{E}}(0)| e^{\bar{L} T_{3}(|\mathcal{E}(0)|)}+\left\{\bar{L} T_{3}(|\mathcal{E}(0)|) e^{\bar{L} T_{3}(|\mathcal{E}(0)|)}\right\}\left\{|\delta|_{\infty}\right\}  \tag{A.10}\\
\leq & e^{T_{3}(|\mathcal{E}(0)|)-t}\left[|\hat{\mathcal{E}}(0)| e^{\bar{L} T_{3}(|\mathcal{E}(0)|)}\right. \\
& \left.+\frac{1}{2} \bar{L}^{2} T_{3}^{2}(|\mathcal{E}(0)|) e^{2 \bar{L} T_{3}(|\mathcal{E}(0)|)}\right]+\frac{1}{2}|\delta|_{\infty}^{2}
\end{align*}
$$

for all $t \in\left[0, T_{3}(|\mathcal{E}(0)|)\right]$, by applying the triangle inequality to the terms in curly braces in (A.10). The final ISS estimate in the original error variable $\mathcal{E}=\left(s-s_{*}, x-\right.$ $x_{*}$ ) now follows from adding (A.7) and (A.10) (using (A.10) to upper bound the $\left|\hat{\mathcal{E}}_{T_{3}(|\mathcal{E}(0)|)}\right|_{[-\bar{\tau}, 0]}$ in the right side of (A.7), and the fact that $\hat{\mathcal{E}}(t)$ only depends on values of $\delta(r)$ for times $r \leq t$, which allows us to replace $|\delta|_{\infty}$ by $|\delta|_{[0, t]}$ throughout (A.7) and (A.10), to get an ISS estimate in the variable $\hat{\mathcal{E}}$ that is valid for all $t \geq 0$ ), and using the fact that $T_{3} \in \mathcal{K}_{\infty}$ and the fact that there are constants $c_{*}>0$ and $c_{* *}>0$ such that for all solutions of that $\mathcal{E}$ dynamics with initial states in $\mathcal{S}$, we have

$$
\begin{equation*}
|\mathcal{E}(t)| \leq c_{* *}|\hat{\mathcal{E}}|_{[t-\bar{\tau}, t]} \text { for all } t \geq 0 \text { and }|\hat{\mathcal{E}}(0)| \leq c_{*}|\mathcal{E}(0)| \tag{A.11}
\end{equation*}
$$

To find values for $c_{*}$ and $c_{* *}$, first note that for each $i \in\{1,2, \ldots, n\}$ and $t \geq 0$ and any global Lipschitz constant $L_{i}$ for $\mu_{i}$, the Mean Value Theorem estimate (46) and the constantness of the initial functions give

\begin{align*}
\left|\tilde{x}_{i}(t)\right| & =\left|\alpha_{i}(t) e^{\int_{t-\tau_{i}}^{t}\left(\mu_{i}\left(s_{*}\right)-\mu_{i}(s(\ell))\right) \mathrm{d} \ell}-x_{i *}\right| \\
& =\left|\left(\tilde{\alpha}_{i}(t)+x_{i *}\right) e^{\int_{t-\tau_{i}}^{t}\left(\mu_{i}\left(s_{*}\right)-\mu_{i}(s(\ell))\right) \mathrm{d} \ell}-x_{i *}\right|  \tag{A.12}\\
& \leq\left|\tilde{\alpha}_{i}(t)\right| e^{2 \tau_{i} \mu_{i}\left(\bar{s}^{\sharp}\right)}+x_{i *}\left|e^{\int_{t-\tau_{i}}^{t}\left(\mu_{i}\left(s_{*}\right)-\mu_{i}(\ell)\right) \mathrm{d} \ell}-1\right| \\
& \leq\left|\tilde{\alpha}_{i}(t)\right| e^{2 \tau_{i} \mu_{i}\left(\bar{s}^{\sharp}\right)}+x_{i *} L_{i} e^{2 \mu_{i}\left(\bar{s}^{\sharp}\right) \bar{\tau}} \tau_{i}|\tilde{s}|_{\left[t-\tau_{i}, t\right]}
\end{align*}
$$

and

$$
\begin{align*}
\left|\tilde{\alpha}_{i}(0)\right| & =\left|x_{i}(0) e^{\tau_{i}\left(\mu_{i}(s(0))-\mu_{i}\left(s_{*}\right)\right)}-x_{i *}\right| \\
& =\left|\tilde{x}_{i}(0) e^{\tau_{i}\left(\mu_{i}(s(0))-\mu_{i}\left(s_{*}\right)\right)}+x_{i *}\left(e^{\tau_{i}\left(\mu_{i}(s(0))-\mu_{i}\left(s_{*}\right)\right)}-1\right)\right|  \tag{A.13}\\
& \leq e^{2 \mu_{i}\left(\bar{s}^{\sharp}\right) \tau_{i}}\left(\left|\tilde{x}_{i}(0)\right|+x_{i *} L_{i} \tau_{i}|\tilde{s}(0)|\right) .
\end{align*}
$$

Then we can check that we can choose

$$
\begin{align*}
& c_{* *}=1+n e^{2 \bar{\tau} \max _{i} \mu_{i}\left(\bar{s}^{\sharp}\right)}+n \bar{\tau} \max _{i}\left\{L_{i} x_{i *} e^{2 \tau_{i} \mu_{i}\left(\bar{s}^{\sharp}\right)}\right\} \text { and }  \tag{A.14}\\
& c_{*}=1+n \max _{i}\left\{e^{2 \tau_{i} \mu_{i}\left(\bar{s}^{\sharp}\right)} x_{i *} L_{i} \tau_{i}\right\}+n e^{2 \bar{\tau} \max _{i} \mu_{i}\left(\bar{s}^{\sharp}\right)},
\end{align*}
$$

where the maxima are over all $i \in\{1,2, \ldots, n\}$; this can be checked by comparing the formulas for the components of $\mathcal{E}$ and $\hat{\mathcal{E}}$. This proves the theorem.
