THE RELATIVE ACCURACY OF (x+y)*(x-y)

ABSTRACT. We consider the relative accuracy of evaluating (x + y)(x - y) in IEEE floating-point arithmetic, when x and y are two floating-point numbers and rounding is to nearest. This expression can be used, for example, as an efficient cancellation-free alternative to $x^2 - y^2$ and (at least in the absence of underflow and overflow) is well known to have low relative error, namely, at most about 3u with u denoting the unit roundoff. In this paper we propose to complement this traditional analysis with a finer-grained one, aimed at improving and assessing the quality of that bound. Specifically, we show that if the tie-breaking rule is to away then the bound 3u is asymptotically optimal (as the precision tends to ∞). In contrast, if the tie-breaking rule is to even, we show that asymptotically optimal bounds are now 2.25u for base two and 2u for larger bases, such as base ten. In each case, asymptotic optimality is obtained by the explicit construction of a certificate, that is, some floatingpoint input (x, y) parametrized by u and such that the error of the associated result is equivalent to the error bound as u tends to zero. We conclude with comments on how (x+y)(x-y) compares with x^2 in the presence of floatingpoint arithmetic, in particular showing cases where the computed value of (x+y)(x-y) exceeds that of x^2 .

1. Introduction

In IEEE floating-point arithmetic, the evaluation of $x^2 - y^2$ in the most natural way—as the difference of two squares—is well known to be prone to damaging cancellation: if the floating-point numbers x and y are close enough to each other then the subtraction mostly reveals the rounding error(s) due to squaring and this can yield a totally wrong result. This phenomenon still happens when a fused multiply-add operation is available and used to compute $x^2 - y^2$ as fma(x, x, -y * y)or -fma(y, y, -x * x). In practice, this implies for example that when squaring the complex number x + iy with any of these schemes, then, even in the absence of underflow and overflow, the computed real part may be very inaccurate. A classical workaround consists in evaluating the factored form (x+y)(x-y) instead, as suggested by Sterbenz [15, p. 118] and Kahan and Thomas [9]. This alternative formula retains the simplicity of the previous ones and, barring underflow and overflow, now ensures high relative accuracy. Specifically, if each of the three operations $+, -, \times$ is performed with relative error at most the unit roundoff u then the computed result \hat{r} has the form $\hat{r} = (x^2 - y^2)(1 + \theta)$ with $(1 - u)^3 \le 1 + \theta \le (1 + u)^3$ and, therefore, has its relative error $|\theta|$ bounded as

$$|\theta| \leqslant (1+u)^3 - 1.$$

For simplicity and assuming u is small enough, the expression $(1+u)^3 - 1$ can then be approximated by 3u or rewritten as $3u + O(u^2)$ or bounded further by $3u/(1-3u) =: \gamma_3$ or 3.03u. This kind of analysis is typical of Wilkinson's traditional approach [18, 19] and has been done by various authors, including Stoer [17] (see also Stoer and Bulirsch [16]), Goldberg [2], and Higham [3].

In this paper we propose to complement this traditional analysis with a finergrained one, aimed at improving and assessing the quality of such error bounds in the context of IEEE floating-point arithmetic. To do this, the implementation of the formula (x + y)(x - y) that we shall study can be described as follows:

(1)
$$x, y \in \mathbb{F}$$
: $\widehat{r}_1 := \text{fl}(x+y)$, $\widehat{r}_2 := \text{fl}(x-y)$, $\widehat{r} := \text{fl}(\widehat{r}_1\widehat{r}_2)$,

where \mathbb{F} is a set of floating-point numbers in base β and precision p, defined as

(2)
$$\mathbb{F} = \{0\} \cup \{M \cdot \beta^E : M, E \in \mathbb{Z}, \ \beta^{p-1} \leqslant |M| < \beta^p\},$$

and where fl denotes a round-to-nearest function from \mathbb{R} to \mathbb{F} , such that

(3)
$$|f(t) - t| = \min_{x \in \mathbb{F}} |x - t| \quad \text{for all } t \in \mathbb{R}.$$

We shall assume that β is even, $p \ge 2$, and the tie-breaking rule for fl is either to even or to away: if fl breaks ties to even, then every real number lying halfway between two consecutive elements of $\mathbb F$ in (2) is rounded to the one whose integral significand M is even; if fl breaks ties to away, then it is rounded to the one for which |M| is largest. In practice these assumptions are very mild and will be enough to cover simultaneously the possibilities offered by the IEEE standard 754-2008 [4], where $\beta \in \{2,10\}$ and fl $\in \{\text{roundTiesToEven}, \text{roundTiesToAway}\}$. Furthermore, since the definition of $\mathbb F$ imposes no restriction on the exponent range, our results will hold as long as underflows and overflows do not occur.

As a first and easy step towards a fine-grained accuracy analysis of (1), we can exploit the main consequence of (2) and (3), that says that the relative error due to rounding is bounded as follows [10, p. 232]:

$$(4) \quad \text{ for all } t \in \mathbb{R}, \qquad \mathrm{fl}(t) = t \cdot (1+\delta), \qquad |\delta| \leqslant \frac{u}{1+u}, \qquad u := \frac{1}{2}\beta^{1-p}.$$

Applying this inequality three times to (1), we deduce that

(5)
$$\widehat{r}_1 = (x+y)(1+\delta_1), \quad \widehat{r}_2 = (x-y)(1+\delta_2), \quad \widehat{r} = \widehat{r}_1\widehat{r}_2(1+\delta_3)$$

for some rational numbers δ_i such that $|\delta_i| \leq u/(1+u)$ and, writing

$$\hat{r} = (x^2 - y^2)(1 + \theta), \qquad \theta := (1 + \delta_1)(1 + \delta_2)(1 + \delta_3) - 1,$$

we can then easily check using u > 0 that the relative error of \hat{r} satisfies

$$|\theta| < 3u$$
.

This simple analysis already refines the traditional bound $(1+u)^3-1$ slightly, showing that the $O(u^2)$ term can be removed and that the commonly used alternative forms $3u+O(u^2)$ and γ_3 mentioned before are in fact not needed. However, this says nothing about the quality of all these bounds and, therefore, raises the following question: Can the leading constant 3 be reduced further, and if so by which value should it be replaced?

We show with Theorem 1.1 that the answer actually depends on the tie-breaking rule and the base: if ties are broken to away, then 3 is indeed best possible; otherwise, this constant can be decreased down to 2.25 for binary arithmetic and 2 for larger bases, these new constants now being best possible as well. Here "best possible" means the following: the relative error $|\theta|$ is upper bounded by λu (with λ either 3, 2.25 or 2) and there exists an input $(x_0, y_0) \in \mathbb{F}^2$ that is parametrized by u and such that the corresponding error $|\theta_0| \to \lambda u$ as $u \to 0$. We will say that such a bound is asymptotically optimal and may call the input (x_0, y_0) a certificate of asymptotic optimality for that bound. In our case, the certificates will be provided explicitly, as pairs of simple functions of u.

Theorem 1.1. Let $x, y \in \mathbb{F}$ and let fl denote a round-to-nearest map from \mathbb{R} to \mathbb{F} . Then, when evaluating $x^2 - y^2$ as $\hat{r} = \text{fl}(\text{fl}(x+y)\text{fl}(x-y))$, the returned value \hat{r} satisfies

$$\widehat{r} = (x^2 - y^2)(1 + \theta), \qquad |\theta| < \begin{cases} 3u & \text{if fl breaks ties to away,} \\ \frac{9}{4}u & \text{if fl breaks ties to even and } \beta = 2, \\ 2u & \text{if fl breaks ties to even and } \beta \neq 2. \end{cases}$$

Furthermore, each of these bounds on the relative error $|\theta|$ is asymptotically optimal.

In practice this result implies that for default IEEE floating-point arithmetic—which has base 2 and ties broken to even, the overall relative error of evaluating (x+y)(x-y) can never get close to the traditional bound 3u and will at worst approach 2.25u. Our analysis can also be seen as a typical example of fine-grained accuracy analysis, as surveyed in [6] and whose goal is to provide not only a priori, worst-case error bounds but also certificates of the quality of such bounds. Other examples include optimal bounds for the five basic operations [8] and for summation in high dimension [12, 11], as well as asymptotically optimal bounds in the context of complex arithmetic [1, 7].

1.1. Ingredients for the proof. To establish Theorem 1.1 we shall exploit (4) as well as several other, lower level properties of IEEE floating-point arithmetic that are most often straightforward consequences of (2) and (3) and which we briefly review in this subsection. It turns out that several of these properties are conveniently expressed in terms of the unit roundoff $u = \frac{1}{2}\beta^{1-p}$ and also via the real functions ufp (unit in the first place, introduced in [14]) and ulp (unit in the last place), defined by ufp(0) = ulp(0) = 0 and

$$\text{for } t \in \mathbb{R}_{\neq 0}, \quad \text{ufp}(t) = \beta^{\lfloor \log_\beta |t| \rfloor} \quad \text{and} \quad \text{ulp}(t) = 2u \, \text{ufp}(t).$$

Clearly, these two functions are even (that is, independent of the sign of t) and non-decreasing over $\mathbb{R}_{>0}$: if $|t| \leq |t'|$ then $\operatorname{ufp}(t) \leq \operatorname{ufp}(t')$ and $\operatorname{ulp}(t) \leq \operatorname{ulp}(t')$.

Some properties of \mathbb{F} . Note first that if $x \in \mathbb{F}$ then $-x \in \mathbb{F}$ (symmetry) and $x\beta^k \in \mathbb{F}$ for all $k \in \mathbb{Z}$ (auto-similarity).

Furthermore, since $2u = \beta^{1-p}$, any nonzero $x \in \mathbb{F}$ can be rewritten as

$$x=\pm m\beta^e, \qquad m=1+j\cdot 2u, \qquad j\in \left\{0,1,2,\ldots,(\beta-1)\beta^{p-1}-1\right\}, \qquad e\in \mathbb{Z}.$$

Here, $\beta^e = \text{ufp}(x)$ and, for example, the subset for which ufp(x) = 1 is

$$\mathbb{F} \cap [1, \beta) = \{1, 1 + 2u, 1 + 4u, \dots, \beta - 2u\}.$$

It is worth noting that the *midpoints* associated with \mathbb{F} , that is, the rational numbers lying halfway between two consecutive elements of \mathbb{F} , can be expressed in a similar way as $\pm (1 + j \cdot 2u + u)\beta^e$. Their set will be written \mathbb{M} and, in particular,

$$\mathbb{M} \cap [1, \beta) = \{1 + u, 1 + 3u, 1 + 5u, \dots, \beta - u\}.$$

From the definition of ufp, it follows that

for all
$$t \in \mathbb{R}_{\neq 0}$$
, $\operatorname{ufp}(t) \leq |t| < \beta \operatorname{ufp}(t)$.

Combining this with the structure of \mathbb{F} just described, we deduce that over \mathbb{F} the strict inequality can be refined:

for all
$$x \in \mathbb{F}$$
, $\operatorname{ufp}(x) \leq |x| \leq (\beta - 2u)\operatorname{ufp}(x)$.

Finally, it will be useful to exploit the fact that floating-point numbers are integral multiples of their ulp: if $x \in \mathbb{F}$ then

$$x \in \text{ulp}(x)\mathbb{Z}$$
.

Conversely, if a nonzero real number t satisfies $|t| \in \text{ulp}(t)\mathbb{Z}$ and $|t|/\text{ulp}(t) \leq \beta^p$, then $t \in \mathbb{F}$.

Some properties of fl. A first important property of rounding to nearest is that it is a non-decreasing function over \mathbb{R} : for any $t, t' \in \mathbb{R}$ such that $t \leq t'$, we have $fl(t) \leq fl(t')$.

Another property, made possible by the fact that our tie-breaking rules are independent of both the sign and the order of magnitude of the number to be rounded, is that

(6)
$$fl(\pm t\beta^k) = \pm fl(t)\beta^k, \qquad t \in \mathbb{R}, \qquad k \in \mathbb{Z}.$$

Third, the relative error due to rounding a real number can be bounded by means of the ufp function as follows:

for all
$$t \in \mathbb{R}_{\neq 0}$$
, $f(t) = t \cdot (1 + \delta)$, $|\delta| \le u \frac{\text{ufp}(t)}{|t|}$.

This bound, which improves upon the bound u/(1+u) given in (4) as soon as |t| > (1+u) ufp(t), can be as small as about u/β when $|t| \approx \beta \text{ufp}(t)$.

Finally, fl(t) = t whenever $t \in \mathbb{F}$. This obvious fact, which is not implied by (4), may be used under the form $t \notin \mathbb{F} \Rightarrow \delta \neq 0$.

Sufficient conditions to ensure $|\theta| < 2u$. In addition to the low-level features that we have just recalled, we will use the following two facts:

(7)
$$\delta_i \delta_j \leqslant 0 \quad \Rightarrow \quad |\theta| < 2u$$

and

$$(8) \hspace{1cm} x,y \in \mathbb{F} \,:\, 0 \leqslant y \leqslant x \leqslant y + \beta \mathrm{ufp}(y) \hspace{1cm} \Rightarrow \hspace{1cm} x-y \in \mathbb{F}.$$

The implication in (7) follows immediately from $\theta = (1 + \delta_1)(1 + \delta_2)(1 + \delta_3) - 1$ and the bounds $|\delta_i| \leq u/(1+u)$ for i = 1, 2, 3.

On the other hand, the implication in (8) can be referred to as the *Sterbenz-Ziv* property [15, 20] and says that if two floating-point numbers are close enough to each other, then their exact difference is itself a floating-point number.

Proving this result is particularly simple thanks to the properties of \mathbb{F} , ufp, and ulp seen above: when y=0 it is obvious; otherwise, ulp(y) divides ulp(x) because $y \leq x$, so that x and y and x-y are integral multiples of ulp(y). Hence

 $x-y=M\mathrm{ulp}(y)$ for some integer M that by assumption satisfies $0\leqslant M\leqslant \beta\mathrm{ufp}(y)/\mathrm{ulp}(y)=\beta^p$. Therefore, $x-y\in\mathbb{F}$.

Note also that the condition in (8) is essentially best possible in the sense that if $x > y + \beta \text{ufp}(y)$, then x - y need not be in \mathbb{F} anymore. For example, taking $x = \beta + 1 + \beta \cdot 2u$ and y = 1 + 2u gives $x > \beta + 1 + 2u = y + \beta \text{ufp}(y)$ and $x - y = \beta + (\beta - 1) \cdot 2u \notin \mathbb{F}$.

Finally, remark that $x-y \in \mathbb{F}$ is equivalent to $\delta_2 = 0$, which by (7) implies $|\theta| < 2u$. Consequently, both (7) and (8) will be used as ways to filter out various easy sub-cases that occur during the proof of the upper bounds 2.25u and 2u in Theorem 1.1.

1.2. **Outline.** The rest of the paper is mostly devoted to the proof of Theorem 1.1. We begin, in section 2, by setting up a certificate showing that if ties are broken to away then the bound 3u is asymptotically optimal. We go on to consider round to nearest even in the next two sections. First, we show in section 3 that for this choice of tie-breaking rule smaller upper bounds are possible, namely, 2.25u when $\beta = 2$ and 2u for larger bases: after a preliminary range reduction on the input x and y, we focus on the resulting three sub-cases, which are $x \pm y \in [1, \beta)$, $x + y > \beta$, and x - y < 1, and provide for each of them a detailed analysis. We then present in section 4 the construction of two certificates of asymptotic optimality, one for the bound 2.25u in the case where $\beta = 2$, and one for the bound 2u. We conclude briefly in section 5 by noting that despite its high accuracy and unlike $x^2 - y^2$, the factored form (x + y)(x - y) can yield values that slightly exceed $fl(x^2)$ regardless of the base and tie-breaking rule.

2. Asymptotic optimality of the error bound 3u when rounding ties to away

Lemma 2.1. Assume that $p \ge 4$, and let

$$j = \left\lceil \frac{1}{2\sqrt{u}} \right\rceil, \quad x = 1 + j \cdot 2u, \quad y = u.$$

Then $x, y \in \mathbb{F}$ and, when rounding ties to away, $\theta = 3u - \epsilon$ for some positive $\epsilon = O(u^{3/2})$.

Proof. Note first that $y \in \mathbb{F}$ for β even. On the other hand, for $p \ge 4$, we have $u \le 1/16$, which together with $1 \le j < \frac{1}{2\sqrt{u}} + 1$ implies that both $x = 1 + j \cdot 2u$ and the expression $1 + (2j + 1) \cdot 2u$ are in $(1, \beta)$ and, thus, in $\mathbb{F} \cap (1, \beta)$.

We deduce from $x \in \mathbb{F} \cap (1, \beta)$ and y = u that

$$x + y = 1 + j \cdot 2u + u,$$
 $x - y = 1 + j \cdot 2u - u$

are midpoints in $(1, \beta)$; furthermore, since ties are broken to away, they are rounded up to

$$\hat{r}_1 = 1 + (j+1) \cdot 2u, \qquad \hat{r}_2 = 1 + j \cdot 2u,$$

respectively. Now, using $j = \frac{1}{2\sqrt{u}} + O(1)$, we see that $x \pm y = 1 + O(\sqrt{u})$ and that the associated relative errors have the form

$$\delta_i = u - \epsilon_i, \quad 0 < \epsilon_i = O(u^{3/2}), \quad i = 1, 2.$$

Consider now the relative error δ_3 that occurs when rounding $\hat{r}_1\hat{r}_2$. We have

$$\hat{r}_1\hat{r}_2 = 1 + (2j+1) \cdot 2u + j(j+1) \cdot 4u^2$$

where, as noted above, $1+(2j+1)\cdot 2u$ belongs to $\mathbb{F}\cap[1,\beta)$ and where it can be checked that $j(j+1)\cdot 4u^2\in(u,2u)$ for all $p\geqslant 4$: the lower bound follows from $j\geqslant\frac{1}{2\sqrt{u}}$; for the upper bound we use $j<\frac{1}{2\sqrt{u}}+1$ to deduce that

$$j(j+1) \cdot 4u^2 < u + 6u^{3/2} + 8u^2,$$

which is at most 2u if $p \ge 6$; if $p \in \{4, 5\}$, then $\varphi_{\beta,p} := j(j+1) \cdot 4u^2$ satisfies for all $\beta \ge 3$, $\varphi_{\beta,p} < \varphi_{2,p} = \frac{3}{4} \cdot 2u < 2u$. Consequently, the exact product $\widehat{r}_1 \widehat{r}_2$ is rounded up to

$$\widehat{r} = 1 + (2j + 2) \cdot 2u;$$

since it also has the form $\hat{r}_1\hat{r}_2 = 1 + O(\sqrt{u})$ and since $j(j+1) \cdot 4u^2 = u + O(u^{3/2})$, we deduce that

$$\delta_3 = u - \epsilon_3, \qquad 0 < \epsilon_3 = O(u^{3/2}).$$

The conclusion then follows from $3u > \theta = \hat{r}/(x^2 - y^2) - 1 = \delta_1 + \delta_2 + \delta_3 + O(u^2)$.

Rounding ties to away is not the only directed tie-breaking rule. For example, we could consider the variant of Riedy and Demmel [13, §3] called roundTiesToZero, which in case of a tie always rounds to the nearest floating-point number of smaller magnitude; this tie-breaking rule applies in particular to the augmented operations $+,-,\times$ that are now recommended, for binary formats, by the 2019 revision of IEEE 754 [5, §9.5]. It turns out that for (x+y)(x-y) the traditional bound 3u is asymptotically optimal in this case as well, and this can be shown by reasoning as in the proof of Lemma 2.1 with (x-2u,y) instead of (x,y).

3. New error bounds when rounding ties to even

The goal of this section is to establish the following theorem, which says that when the rounding map breaks ties to even the traditional bound 3u can be reduced further, depending on the value of the base.

Theorem 3.1. If fl breaks ties to even, then

$$|\theta| < \begin{cases} 2.25u & if \beta = 2, \\ 2u & otherwise. \end{cases}$$

In the rest of this section, we first reduce the range of both x and y. This yields the following three regimes: $x \pm y \in [1, \beta)$, $x + y > \beta$, and x - y < 1. Then, for each of them, we eliminate the easy subcases corresponding to (7) and (8), and deal finally with the remaining, nontrivial subcases with Lemmas 3.1, 3.2, 3.3, respectively.

3.1. Range reduction. Letting $\varphi:(x,y)\mapsto \mathrm{fl}(\mathrm{fl}(x+y)\mathrm{fl}(x-y))$, we deduce from the property of rounding in (6) that $\varphi(x,y)=\varphi(-x,y)=\varphi(x,-y)=-\varphi(y,x)$ and that $\varphi(x\beta^k,y\beta^k)=\varphi(x,y)\beta^{2k}$ for any $k\in\mathbb{Z}$. Since these equalities hold for the exact expression x^2-y^2 as well and since $\varphi(0,0)=0$ is the exact result when x=y=0, we can restrict our error analysis to the pairs (x,y) such that

$$0 \leqslant y \leqslant x$$
 and $1 \leqslant x < \beta$.

Two further restrictions can be made. First, if $y \ge 1$ then ufp(y) = 1 and, by the Sterbenz–Ziv property in (8), we obtain $\delta_2 = 0$; hence in this case $|\theta| < 2u$ and Theorem 3.1 is proved. Second, if y < u then $(\hat{r}_1, \delta_3) = (1, 0)$ for x = 1 and

 $\delta_1 \leq 0 \leq \delta_2$ for $x \geq 1 + 2u$. Thus, y < u implies $|\theta| < 2u$ as well. Consequently, we can reduce the range of y accordingly and assume from now on that

$$(9) u \leqslant y < 1 \leqslant x < \beta.$$

This reduced range for x and y has several implications. First, ufp(x) = 1 and the range of ufp(y) is itself reduced: using $u \ge \beta^{-p}$ for $\beta \ge 2$, we see that $\beta^{-p} \le \text{ufp}(y) \le \beta^{-1}$, or, equivalently,

$$1 \leqslant e \leqslant p$$
, $\operatorname{ufp}(y) =: \beta^{-e} \leqslant y < \beta^{1-e}$.

Second, since $y \in \mathbb{F}_{<1}$ implies $y \leq 1 - 2u/\beta = 1 - \beta^{-p}$, we deduce from (9) that

$$x + y \in [1, \beta) \cup [\beta, \beta^2)$$
 and $x - y \in [\beta^{-p}, 1) \cup [1, \beta)$.

If $x+y=\beta$, then $\delta_1=0$ and so $|\theta|<2u$. Consequently, we are left with the following three nontrivial cases, which we shall analyze separately in the next subsections:

$$x \pm y \in [1, \beta)$$
 or $x + y > \beta$ or $x - y < 1$

3.2. **Analysis when** $x \pm y \in [1, \beta)$. Since x belongs to $\mathbb{F} \cap [1, \beta)$, it has the form $x = 1 + j \cdot 2u$ for some integer j and, on the other hand, setting $k = \lfloor y/(2u) \rfloor$ gives $y = k \cdot 2u + \epsilon$ for some $\epsilon \in [0, 2u)$. Thus

$$x \pm y = 1 + (j \pm k) \cdot 2u \pm \epsilon, \qquad j \pm k \in \mathbb{Z}_{\geqslant 0}, \qquad 0 \leqslant \epsilon < 2u.$$

We now consider two cases. If $\epsilon < u$ or if $\epsilon = u$ with j + k even, then x + y is rounded down, while x - y is rounded up, that is, $\delta_1 \leq 0 \leq \delta_2$. Likewise, if $\epsilon > u$ or if $\epsilon = u$ with j + k odd, then $\delta_2 \leq 0 \leq \delta_1$. Hence $\delta_1 \delta_2 \leq 0$ in all cases and, recalling (7), we arrive at the following result.

Lemma 3.1. Let $x, y \in \mathbb{F}$ be as in (9) and such that $x \pm y \in [1, \beta)$. If fl breaks ties to even, then

$$|\theta| < 2u$$
.

3.3. **Analysis when** $x + y > \beta$. If $x - y \le 1$ then $y = \frac{1}{2}(x + y - (x - y)) \ge \frac{\beta - 1}{2}$. Together with y < 1, this requires $\beta = 2$ and ufp(y) = 1/2. We can thus rewrite the assumption $x - y \le 1$ as $x \le y + 2$ ufp(y) and, using the Sterbenz–Ziv property in (8), we deduce that in this case $\delta_2 = 0$ and $|\theta| < 2u$.

Let us now assume that x-y>1, so $x\pm y$ are in two consecutive open intervals:

(10)
$$x - y \in (1, \beta), \quad x + y \in (\beta, \beta^2).$$

In this case, the next lemma shows how to bound the overall relative error $|\theta|$ depending on the value of the base β .

Lemma 3.2. Let $x, y \in \mathbb{F}$ be as in (9) and (10). If fl breaks ties to even, then

$$|\theta| < \begin{cases} 2.25u & if \beta = 2, \\ 2u & otherwise. \end{cases}$$

We give a detailed proof of this result in the rest of this subsection. We focus only on the case where all the δ_i have the same sign, for otherwise the result follows immediately from (7).

3.3.1. Preliminaries. Note that 0 < y < x implies that $x \pm y$ are integral multiples of $ulp(y) = 2u \, ufp(y)$. Defining, for simplicity,

$$\eta := \mathrm{ufp}(y)$$

and using the strict inequality $x + y > \beta$ together with x - y = (x + y) - 2y and $y \leq (\beta - 2u)\eta$, we deduce that

(11)
$$x + y \geqslant \beta + 2u\eta, \qquad x - y \geqslant \beta - 2\beta\eta + 6u\eta.$$

(We shall use the latter bound only when $\beta > 2$ or $e \ge 2$, that is, only in the cases where it is larger than the lower bound $1 + 2u\eta$ resulting from x - y > 1.)

Let $x = 1 + j \cdot 2u$ and, to handle the fact that $x + y \ge \beta$, let us also consider the decompositions $y = k \cdot 2u + \epsilon$ and $j + k = k_1\beta + k_0$, where

(12) $k := \lfloor y/(2u) \rfloor$, $k_1 := \lfloor (j+k)/\beta \rfloor$, $k_0 \in \{0, 1, \dots, \beta - 1\}$, $0 \le \epsilon < 2u$. It follows from (10) and (12) that

(13)
$$x + y = \underbrace{1 + k_1 \cdot \beta \cdot 2u}_{\in \mathbb{F} \cap [\beta, \beta^2)} + \underbrace{k_0 \cdot 2u + \epsilon}_{\in [0, \beta \cdot 2u)}, \qquad x - y = \underbrace{1 + (j - k) \cdot 2u}_{\in \mathbb{F} \cap (1, \beta]} - \epsilon.$$

We will also rely on the following specific properties. The first one will be useful for large bases, while the second one holds only for base 2.

Property 3.1. Assume that $\beta > 2$. If $\delta_1 \leq 0$ or $\delta_3 > 0$, then

$$|\delta_3| \leqslant \frac{u}{\beta - 2}.$$

Proof. Since $0 < \eta \leqslant \beta^{-1}$ and $\beta, \beta - 2 \in \mathbb{F}$, the lower bounds in (11) imply $\hat{r}_1 \geqslant \beta$ and $\hat{r}_2 \geqslant \beta - 2$. Hence

$$|\delta_3| \leqslant u \frac{\operatorname{ufp}(\widehat{r}_1 \widehat{r}_2)}{\beta(\beta - 2)}.$$

To conclude, it suffices to prove that $\operatorname{ufp}(\widehat{r}_1\widehat{r}_2) \leq \beta$, that is,

$$\widehat{r}_1\widehat{r}_2 < \beta^2$$

which can be done as follows. The ranges of $x \pm y$ in (10) imply that

$$\widehat{r}_1 \leqslant x + y + \beta u, \qquad \widehat{r}_2 \leqslant x - y + u.$$

Using $x \leq \beta - 2u$ then gives $\hat{r}_1 \hat{r}_2 \leq (\beta(1+u) - 2u + y)(\beta - u - y) = (\beta(1+u) - 2u)(\beta - u) - (\beta - 1)uy - y^2$, which for $\beta \geq 2$ and u, y > 0 implies

$$\widehat{r}_1\widehat{r}_2 < (1+u)\beta^2$$
.

If $\delta_3 > 0$, then the latter bound suffices to ensure $\hat{r}_1 \hat{r}_2 < \beta^2$ (for otherwise that product is rounded down to β^2 , a contradiction). If $\delta_1 \leq 0$, then we start instead with

$$\widehat{r}_1 \leqslant x + y;$$

this leads to $\widehat{r}_1\widehat{r}_2 \leq (\beta - 2u + y)(\beta - u - y) = (\beta - 2u)(\beta - u) + y(u - y) < \beta^2$ for $u \leq y$.

Property 3.2. Assume that $\beta = 2$ and that fl breaks ties to even. If $\delta_1 \delta_2 \geqslant 0$ then $\epsilon \neq u$ and, more precisely, either

$$\epsilon \leqslant (1 - 2\eta)u \quad or \quad \epsilon \geqslant (1 + 2\eta)u.$$

Proof. Assume for contradiction that $\epsilon = u$. According to (13), this means x - y is halfway between the two consecutive floating-point numbers $1 + (j - k - 1) \cdot 2u$ and $1 + (j - k) \cdot 2u$. If j - k is even, then the choice of tie-breaking rule implies

$$\delta_2 > 0$$
:

furthermore, $k_0 = (j+k) \mod 2$ is then equal to zero, which implies $k_0 \cdot 2u + \epsilon < 2u$ and thus, due to the form of x + y in (13),

$$\delta_1 < 0.$$

If j-k is odd then, using the same reasoning, we deduce that $\delta_2 < 0$ and $\delta_1 > 0$. This shows that if δ_1 and δ_2 have the same sign, then $\epsilon \neq u$.

Now, from $y = k \cdot 2u + \epsilon$ and ufp $(y) = \eta = 2^{-e} < 1$ for $e \ge 1$, we deduce that

$$\epsilon = \ell \cdot 2u\eta$$
 for some $\ell \in \mathbb{Z}_{\geq 0}$.

Hence $\epsilon \neq u$ is equivalent to $\ell \neq 1/(2\eta)$. Since $e \geqslant 1$ implies that $1/(2\eta) = 2^{e-1}$ is an integer, we conclude that either $\ell \leqslant 1/(2\eta) - 1$ or $\ell \geqslant 1/(2\eta) + 1$.

3.3.2. Case where $\delta_i > 0$ for all i. In this case x + y and x - y are rounded up in \mathbb{F} . Because of (13), this implies that

$$k_0 \cdot 2u + \epsilon \geqslant \beta u, \qquad \epsilon \leqslant u,$$

and that the associated relative errors can be expressed exactly as

$$\delta_1 = \frac{\beta \cdot 2u - (k_0 \cdot 2u + \epsilon)}{x + y}, \qquad \delta_2 = \frac{\epsilon}{x - y}.$$

Since $\epsilon \leq u$, we must have $2k_0 \geq \beta - 1$, which for β even is equivalent to $k_0 \geq \beta/2$. Hence the overall error θ is bounded as

(14)
$$1 + \theta \leqslant \left(1 + \frac{\beta u - \epsilon}{x + y}\right) \left(1 + \frac{\epsilon}{x - y}\right) (1 + \delta_3) =: F(x, y, \epsilon, \delta_3).$$

Note that F increases with ϵ , since $\partial F/\partial \epsilon = (2y + \beta u - 2\epsilon)(1 + \delta_3)/(x^2 - y^2)$ is positive for all $\delta_3 > -1$, x > y > 0, $\beta \ge 2$, and $\epsilon \le u$.

■ Assume first that $\beta \ge 4$. In this case, because of $\eta \le \beta^{-1}$ and (11) and, on the other hand, because of $\delta_3 > 0$ and Property 3.1, we have the bounds

$$\epsilon \leqslant u, \qquad x+y > \beta, \qquad x-y > \beta - 2, \qquad \delta_3 \leqslant \frac{u}{\beta - 2},$$

which, when applied to (14), lead to

$$1 + \theta \leqslant \left(1 + \left(1 - \frac{1}{\beta}\right)u\right)\left(1 + \frac{u}{\beta - 2}\right)^2.$$

It can be checked that the latter bound decreases with $\beta \geqslant 4$, and we conclude that

$$1 + \theta \le \left(1 + \frac{3}{4}u\right)\left(1 + \frac{1}{2}u\right)^2 = 1 + \frac{7}{4}u + u^2 + \frac{3}{16}u^3$$

$$< 1 + 2u.$$

This completes the proof of Lemma 3.2 in the case where $\delta_i > 0$ for all i and $\beta \ge 4$.

■ Assume now that $\beta = 2$. Using (11) and Property 3.2, we see that we can take

$$\epsilon \leqslant (1-2\eta)u, \qquad x+y \geqslant 2+2u\eta, \qquad x-y \geqslant 2-4\eta+6u\eta, \qquad \delta_3 \leqslant \frac{u}{1+u} =: u_1,$$

and, applying these bounds to (14), we arrive at

$$1 + \theta \leqslant \left(1 + \frac{1 + 2\eta}{2 + 2u\eta}u\right) \left(1 + \frac{1 - 2\eta}{2 - 4\eta + 6u\eta}u\right) (1 + u_1) =: G(\eta).$$

Now, $\delta_2 > 0$ implies that ϵ cannot be zero, so that $0 < \epsilon \le (1 - 2\eta)u$. Since $\eta = 2^{-e}$, this forces $e \ge 2$ or, equivalently,

$$\eta \leqslant 1/4$$
.

On the other hand, using x+y>2 and $x\leqslant 2-2u$ yields the refined lower bound $y>2u=2^{1-p}$, which implies $\eta\geqslant 2u$ (that is, $e\leqslant p-1$). Hence $2u\leqslant \eta\leqslant 1/4$ and, consequently,

$$u \leq 1/8$$
.

For $u \leq 1/8$, one can now check that the derivative of G has the form $G'(\eta) = (1+u_1) \cdot H(\eta)/(\cdots)^2$, where H is a degree-2 polynomial in η (whose coefficients are polynomials in u), and that H is positive for all $\eta \leq 1/4$. (It is positive at 0 and has two positive roots, the smallest one being larger than 1/4.) Hence G increases with η over (0, 1/4] and, consequently, $1 + \theta \leq G(1/4)$, that is,

$$1 + \theta \leqslant \left(1 + \frac{\frac{3}{4}u}{1 + \frac{u}{4}}\right) \left(1 + \frac{\frac{u}{2}}{1 + \frac{3}{2}u}\right) (1 + u_1) = 1 + \frac{9}{4}u - \frac{5}{16}u^2 + O(u^3)$$

$$< 1 + \frac{9}{4}u.$$

Thus we have proved Lemma 3.2 in the case where $\delta_i > 0$ for all i and $\beta = 2$.

3.3.3. Case where $\delta_i < 0$ for all i. In this case, we consider $\widetilde{\theta}$ defined by

$$(15) 1 + \widetilde{\theta} := (1 + |\delta_1|)(1 + |\delta_2|)(1 + |\delta_3|)$$

and, noting that $-\widetilde{\theta} < \theta < 0$ and $\widetilde{\theta} - |\theta| = O(u^2)$, we focus on determining an upper bound on $\widetilde{\theta}$.

Since δ_1 and δ_2 are negative, x + y and x - y are rounded down in \mathbb{F} and, recalling (13), we see that this implies

$$k_0 \cdot 2u + \epsilon \leqslant \beta u, \qquad \epsilon \geqslant u,$$

and that the (negative) relative errors δ_1 and δ_2 satisfy

$$|\delta_1| = \frac{k_0 \cdot 2u + \epsilon}{x + y}, \qquad |\delta_2| = \frac{2u - \epsilon}{x - y}.$$

Since $\epsilon \geqslant u$ and β is even, the constraint $k_0 \cdot 2u + \epsilon \leqslant \beta u$ seen above implies that the integer k_0 satisfies $k_0 \leqslant \beta/2 - 1$. Consequently, $\widetilde{\theta}$ can be bounded in terms of the function F in (14) as follows:

$$1 + \widetilde{\theta} \leqslant F(x, y, \widetilde{\epsilon}, |\delta_3|), \qquad \widetilde{\epsilon} := 2u - \epsilon.$$

Note that $u \leqslant \epsilon < 2u$ implies $0 < \widetilde{\epsilon} \leqslant u$, and recall that F increases with $\widetilde{\epsilon}$ in [0,u]. We can then conclude using the same analysis as in §3.3.2—where all the δ_i were assumed to be positive, and arrive at exactly the same bounds. Simply note that when $\beta \geqslant 4$, Property 3.1 can still be applied because now $\delta_1 < 0$. When $\beta = 2$, Property 3.2 now implies $\epsilon \geqslant (1+2\eta)u$ and thus $\widetilde{\epsilon} \leqslant (1-2\eta)u$; also, it is the fact that $\epsilon < 2u$ (by definition) which implies $\widetilde{\epsilon} > 0$ and thus forces η to satisfy $\eta \leqslant 1/4$.

This terminates the analysis of the case where $\delta_i < 0$ for all i and, therefore, concludes the proof of Lemma 3.2.

3.4. Analysis when x - y < 1. Here we will show that $|\theta|$ is always less than 2u. Assume first that the integer e such that $\mathrm{ufp}(y) = \beta^{-e}$ satisfies e = 1. In this case x - y < 1 is equivalent to $x < y + \beta \mathrm{ufp}(y)$ and we deduce from the Sterbenz–Ziv property in (8) that $\delta_2 = 0$ and thus $|\theta| < 2u$.

Let us now consider the situation where

$$e \geqslant 2$$

The inequalities in (9) can then be replaced by

$$(16) u \leqslant y < \beta^{-1}, 1 \leqslant x < \beta,$$

which together with $\beta \ge 2$ and x - y < 1 lead to the lower bound $x - y > 1 - \beta^{-1} \ge \beta^{-1}$ and to the upper bound $x + y = (x - y) + 2y < 1 + 2\beta^{-1} \le \beta$. We are thus in a situation where x - y and x + y belong to the following consecutive open intervals:

(17)
$$x - y \in (\beta^{-1}, 1), \quad x + y \in (1, \beta).$$

The next lemma tells us that when ties are broken to even, then the bound 2u holds in this case too.

Lemma 3.3. Let $x, y \in \mathbb{F}$ be as in (16) and (17). If fl breaks ties to even, then $|\theta| < 2u$.

The rest of this subsection is devoted to the proof of this result. As before, the only nontrivial cases are those where the δ_i are either all positive or all negative.

3.4.1. Preliminaries. We write $x = 1 + j \cdot 2u$ as in the previous subsections, but since x - y is now below 1, we decompose y as $y = k_1 \cdot 2u + k_0 \cdot 2u/\beta + \epsilon$, where

(18)
$$k_1 := |y/(2u)|, \quad k_0 \in \{0, 1, \dots, \beta - 1\}, \quad 0 \le \epsilon < 2u/\beta.$$

(The values of j, k_1, k_0, ϵ are determined uniquely by those of x and y.) Then, using (17) and (18), we can check that the exact sum and difference have the form

(19a)
$$x + y = \underbrace{1 + (j + k_1) \cdot 2u}_{\in \mathbb{F} \cap [1, \beta)} + \underbrace{k_0 \cdot 2u/\beta + \epsilon}_{\in [0, 2u)}$$

and

(19b)
$$x - y = \underbrace{1 + (j - k_1) \cdot 2u - k_0 \cdot 2u/\beta}_{\in \mathbb{F} \cap (\beta^{-1}, 1]} - \epsilon.$$

Recall that $\eta = \text{ufp}(y) = \beta^{-e}$. When $\beta = 2$, the following two properties will turn out to be useful.

Property 3.3. Assume that $\beta = 2$ and that fl breaks ties to even. If $\delta_1 \delta_2 \geqslant 0$ then either

$$\epsilon \leqslant (1 - 4\eta) \frac{u}{2}$$
 or $\epsilon \geqslant (1 + 4\eta) \frac{u}{2}$.

Proof. We can proceed in the same way as for Property 3.2. First, if $\epsilon = u/2$ then $x - y \in \mathbb{M}$, which due to (19) and the tie-breaking rule implies that δ_1 and δ_2 are nonzero and of opposite signs; this contradicts the assumption $\delta_1 \delta_2 \geq 0$, and so $\epsilon \neq u/2$. Then, since y is an integral multiple of $\text{ulp}(y) = 2u\eta = 2^{1-e}u$, so is ϵ , and the conclusion follows from applying this fact together with $\eta = 2^{-e} \leq 1/4$ to each of the strict inequalities $\epsilon < u/2$ and $\epsilon > u/2$.

Property 3.4. Assume that $\beta = 2$ and x = 1. If $\delta_1 \delta_3 > 0$ then

$$|\delta_3| \leqslant \frac{u}{(1+2u)^2}.$$

Proof. Since $\beta = 2$, we deduce from (17) and the monotonicity of rounding that $\hat{r}_1 \geqslant 1$ and $\hat{r}_2 \geqslant 1/2$. Furthermore, $\delta_3 \neq 0$ implies that $\hat{r}_1 \neq 1$ and $\hat{r}_2 \neq 1/2$. Hence, recalling that the successor of 1 in \mathbb{F} is 1 + 2u, we must have $\hat{r}_1\hat{r}_2 \geqslant (1 + 2u)^2/2$ and, consequently,

$$|\delta_3| \leqslant 2u \frac{\operatorname{ufp}(\widehat{r}_1\widehat{r}_2)}{(1+2u)^2}.$$

Let now check that $ufp(\widehat{r}_1\widehat{r}_2) \leq 1/2$, that is,

$$\widehat{r}_1\widehat{r}_2 < 1$$
,

by specializing (19) to j = 0 and $\beta = 2$. If $\delta_1 > 0$ then $\hat{r}_1 = 1 + (k_1 + 1) \cdot 2u$ and $k_0 = 1$. Therefore, $\hat{r}_2 \leq 1 - (2k_1 + 1)u$ and $\hat{r}_1\hat{r}_2 \leq 1 + u - (k_1 + 1)(2k_1 + 1) \cdot 2u^2 < 1 + u$ for $k_1 \geq 0$. It then follows from $\delta_3 > 0$ that $\hat{r}_1\hat{r}_2 < 1$.

If $\delta_1 < 0$ then $\hat{r}_1 = 1 + k_1 \cdot 2u$. Furthermore, $x - y \leqslant 1 - k_1 \cdot 2u \in \mathbb{F}$, so that $\hat{r}_2 \leqslant 1 - k_1 \cdot 2u$ as well. Hence $\hat{r}_1 \hat{r}_2 \leqslant 1 - k_1^2 \cdot 4u^2 \leqslant 1$ and, using $\delta_3 \neq 0$, we must have $\hat{r}_1 \hat{r}_2 < 1$.

3.4.2. Case where $\delta_i > 0$ for all i. Here $x \pm y$ are rounded up, which by (19) gives

$$k_0 \cdot 2u/\beta + \epsilon \geqslant u, \qquad \epsilon \leqslant u/\beta, \qquad \delta_1 = \frac{2u - (k_0 \cdot 2u/\beta + \epsilon)}{x + y}, \qquad \delta_2 = \frac{\epsilon}{x - y}.$$

For β even, it follows that $k_0 \geqslant \beta/2$ and, therefore,

(20)
$$1 + \theta \leqslant \left(1 + \frac{u - \epsilon}{x + y}\right) \left(1 + \frac{\epsilon}{x - y}\right) (1 + \delta_3) =: f(x, y, \epsilon, \delta_3).$$

Note that f increases with ϵ , since $\partial f/\partial \epsilon = (2y+u-2\epsilon)(1+\delta_3)/(x^2-y^2)$ is positive for all $\delta_3 > -1$, x > y > 0, and $\epsilon \le u/\beta \le u/2$.

■ If $\beta \ge 4$, then by combining (20) with $\epsilon \le u/\beta$, $x \ge 1$, and $\delta_3 \le u/(1+u) =: u_1$, we obtain

(21)
$$1 + \theta \leqslant \left(1 + \frac{1 - \beta^{-1}}{1 + y}u\right) \left(1 + \frac{\beta^{-1}}{1 - y}u\right) (1 + u_1) =: g(y).$$

Now, the derivative of g has the form $g'(y) = -u(1+u_1)/(\beta(1-y^2))^2 \cdot h(y)$, where h(y) is the following quadratic polynomial:

$$h(y) = h_0(1+y^2) - h_1y$$
, $h_0 = \beta(\beta-2)$, $h_1 = 2\beta^2 + (\beta-1) \cdot 2u$.

Applying $\beta - 2 \ge 2$ and $y \ge u$ to $h_0(1 + y^2)$, and $y \le (\beta - 2u)\beta^{-2}$ to h_1y , one can check that

$$h(y) \geqslant (2 + 2\beta^{-1})u + (2\beta + 4\beta^{-1} - 4\beta^{-2})u^2$$

which is positive for $\beta \geqslant 2$. Hence g decreases with $y \geqslant u$ and thus

$$1 + \theta \leqslant q(u)$$
.

Finally, it can be checked that $\beta \geqslant 4$ and $p \geqslant 2$ imply

$$g(u) < 1 + 2u.$$

■ Assume now that $\beta = 2$. In this case the function g(y) introduced in (21) does not suffice, as it can now be larger than 1 + 2u (namely, as large as about $1 + \frac{7}{3}u$

when y = (1-u)/2—and thus even larger than the uniform bound $1 + \frac{9}{4}u$ we target). Hence, instead of $\epsilon \leq u/2$, we shall apply to (20) the refined bound $\epsilon \leq (1-4\eta)u/2$ from Property 3.3:

$$1 + \theta \leqslant \left(1 + \frac{\frac{1}{2} + 2\eta}{x + y}u\right) \left(1 + \frac{\frac{1}{2} - 2\eta}{x - y}u\right) (1 + \delta_3) =: g_2(x, y, \eta, \delta_3).$$

One can check that $\partial g_2/\partial y$ has the form $(1+\delta_3)u/(x^2-y^2)^2\cdot P(x,y,\eta)$, where

$$P(x, y, \eta) = -4(x^2 + y^2)\eta + 2xy + (\frac{1}{2} - 8\eta^2)uy.$$

Using $x^2 \geqslant x \geqslant 1$, $y^2 \geqslant u^2$, $y \leqslant (1-u) \cdot 2\eta < 2\eta$, and $-8\eta^2 < 0$, we deduce that

$$P(x, y, \eta) < -4(x + u^2)\eta + 2x \cdot (1 - u) \cdot 2\eta + \frac{u}{2} \cdot 2\eta = (1 - 4x)u\eta - 4u^2\eta,$$

which is negative for $x \ge 1$. Hence g_2 decreases with $y \ge \eta$, and thus $1 + \theta \le g_2(x, \eta, \eta, \delta_3) =: h(x, \eta, \delta_3)$. Now, it can be checked that $\partial h/\partial \eta$ equals $-u(1 + \delta_3)/(x^2 - \eta^2)^2 \cdot (2x - 1/2)(4x + u + 4xu)\eta$ and, therefore, is negative for $x \ge 1$. Consequently, h decreases with $\eta \ge u$ and thus $1 + \theta \le h(x, u, \delta_3)$ or, equivalently,

(22)
$$1 + \theta \leqslant \left(1 + \frac{\frac{1}{2} + 2u}{x + u}u\right) \left(1 + \frac{\frac{1}{2} - 2u}{x - u}u\right) (1 + \delta_3).$$

From $x \ge 1$ and $\delta_3 < u$, it then follows immediately that

$$1 + \theta \leqslant 1 + 2u + O(u^2).$$

To get rid of the $O(u^2)$ term, we may proceed as follows, with two separate cases. If $x \ge 1 + 2u$, then applying the general bound $\delta_3 \le u/(1+u)$ to (22) suffices to conclude that $1 + \theta < 1 + 2u$. If x = 1, this yields only $1 + 2u + \frac{1}{4}u^2$, but then the term $\frac{1}{4}u^2$ can be removed using the refined bound $\delta_3 \le u/(1+2u)^2$ from Property 3.4.

This concludes the proof of Lemma 3.3 in the case where $\delta_i > 0$ for all i.

3.4.3. Case where $\delta_i < 0$ for all i. Using again θ as in (15) together with the fact that $-\widetilde{\theta} < \theta < 0$, it suffices to check that $\widetilde{\theta} < 2u$.

From $\delta_1 < 0$ and $\delta_2 < 0$ we deduce that

$$k_0 \leqslant \beta/2 - 1, \qquad |\delta_1| = \frac{k_0 \cdot 2u/\beta + \epsilon}{x + y}, \qquad \epsilon \geqslant u/\beta, \qquad |\delta_2| = \frac{2u/\beta - \epsilon}{x - y}.$$

Consequently,

$$|\delta_1| \leqslant \frac{u - \widetilde{\epsilon}}{x + y}, \qquad |\delta_2| = \frac{\widetilde{\epsilon}}{x - y}, \qquad \widetilde{\epsilon} := 2u/\beta - \epsilon \in (0, u/\beta].$$

Thus, for f as in (20), we arrive at

$$1 + \widetilde{\theta} \leqslant f(x, y, \widetilde{\epsilon}, |\delta_3|).$$

For $\beta \geqslant 4$, using $x \geqslant 1$, $y \geqslant u$, $\widetilde{\epsilon} \in (0, u/\beta]$, and $|\delta_3| \leqslant u/(1+u)$, we can show as in the previous section that $1 + \widetilde{\theta} \leqslant g(y) \leqslant g(u) < 1 + 2u$.

For $\beta=2$, Property 3.3 tells us that $\epsilon\geqslant (1+4\eta)u/2$, which means $\widetilde{\epsilon}\leqslant (1-4\eta)u/2$, and we obtain as before $1+\widetilde{\theta}\leqslant g_2(x,y,\eta,|\delta_3|)\leqslant g_2(x,\eta,\eta,|\delta_3|)\leqslant g_2(x,u,u,\delta_3)$. We conclude in the same way, using the fact (given by Property 3.4) that $|\delta_3|\leqslant u/(1+2u)^2$ in the special case where x=1.

This concludes the proof of Lemma 3.3 and, therefore, the proof of Theorem 3.1 as well.

4. Asymptotic optimality of the New Error Bounds when rounding ties to even

We give now two lemmas showing that the upper bounds established in the previous section (Theorem 3.1) are asymptotically optimal; this completes the proof of Theorem 1.1.

Lemma 4.1. Assume that $\beta = 2$ and $p \ge 5$, and let

$$j = \left[1/\sqrt{8u}\right], \qquad x = \frac{3}{2} + (2j+1) \cdot 2u, \qquad y = \frac{1}{2} - \frac{7}{2}u.$$

Then $x, y \in \mathbb{F}$ and $\theta = \frac{9}{4}u - \epsilon$ for some positive $\epsilon = O(u^{3/2})$.

Proof. Since $u=2^{-p}$, we have $x=X\cdot 2^{1-p}$ and $y=Y\cdot 2^{-p-1}$, where $X=\frac{3}{4u}+2j+1$ and $Y=2^p-7$ are integers. Using $1\leqslant j<\frac{1}{\sqrt{8u}}+1$ gives $0< X<\frac{3}{4u}+\frac{1}{\sqrt{2u}}+3$, and it can be checked that for $p\geqslant 5$ the upper bound on X is less than $1/u=2^p$; on the other hand, $p\geqslant 5$ clearly implies $0< Y<2^p$, and we conclude that $x,y\in \mathbb{F}$.

To show that θ is asymptotically equivalent to $\frac{9}{4}u$, note first that because of $1 \le j < 1/\sqrt{8u} + 1$ and $p \ge 5$ each of the three quantities

$$1 + (j-1) \cdot 2u$$
, $1 + (2j+2) \cdot 2u$, $1 + (3j+3) \cdot 2u$

belongs to [1,2) and, therefore, to $\mathbb{F} \cap [1,2)$.

Consequently,

$$x + y = \underbrace{2 + (j - 1) \cdot 4u}_{\in \mathbb{F} \cap [2, 4)} + \underbrace{\frac{5}{2}u}_{,} \qquad x - y = \underbrace{1 + (2j + 2) \cdot 2u}_{\in \mathbb{F} \cap [1, 2)} + \underbrace{\frac{3}{2}u}_{,}$$

and, using $\frac{5}{2}u \in (2u, 4u)$ and $\frac{3}{2}u \in (u, 2u)$, we deduce that x + y and x - y are rounded up to

$$\hat{r}_1 = 2 + j \cdot 4u, \qquad \hat{r}_2 = 1 + (2j + 3) \cdot 2u,$$

respectively. On the other hand, x + y > 2 and x - y > 1, and since $j = 1/\sqrt{8u} + O(1)$, we have also $x + y = 2 + O(u^{1/2})$ and $x - y = 1 + O(u^{1/2})$. Hence the associated relative errors δ_1 and δ_2 satisfy

$$\delta_1 = \frac{3}{4}u - \epsilon_1, \qquad \delta_2 = \frac{1}{2}u - \epsilon_2, \qquad 0 < \epsilon_1, \epsilon_2 = O(u^{3/2}).$$

It remains to estimate the third relative error, δ_3 , that occurs when rounding the product $\hat{r}_1\hat{r}_2$. The expressions given above for \hat{r}_1 and \hat{r}_2 lead to

$$\widehat{r}_1\widehat{r}_2 = \underbrace{2 + (3j+3) \cdot 4u}_{\in \mathbb{F} \cap [2,4)} + j(2j+3) \cdot 8u^2.$$

Furthermore, one can check that $j(2j+3)\cdot 8u^2$ is in (2u,4u): the lower bound follows from $j\geqslant 1/\sqrt{8u}$; for the upper bound, using $j<1/\sqrt{8u}+1$ leads to

$$j(2j+3) \cdot 8u^2 < 2u + 7\sqrt{8}u^{3/2} + 40u^2$$

which is at most 4u for all $p \ge 8$; if $p \in \{5,6,7\}$, then the ratio $(j(2j+3) \cdot 8u^2)/(4u)$ is in $\{7/8, 27/32, 11/16\}$ and thus less than 1, as wanted. Therefore, $\hat{r}_1\hat{r}_2$ is rounded up to

$$\widehat{r} = 2 + (3i + 4) \cdot 4u$$

and, using again $j = 1/\sqrt{8u} + O(1)$, we deduce that $\hat{r}_1 \hat{r}_2 - \hat{r} = j(2j+3) \cdot 8u^2 - 4u = -2u + O(u^{3/2})$ and $\hat{r}_1 \hat{r}_2 = 2 + O(u^{1/2})$. Hence

$$\delta_3 = u - \epsilon_3, \qquad 0 < \epsilon_3 = O(u^{3/2}).$$

Using $\theta = \delta_1 + \delta_2 + \delta_3 + O(u^2)$, we obtain $\theta = \left(\frac{3}{4} + \frac{1}{2} + 1\right)u - \epsilon$ with $\epsilon = O(u^{3/2})$. To check that $\epsilon > 0$, one can use the expressions of x, y, and \hat{r} together with $j = 1/\sqrt{8u} + j_0$, $j_0 \in [0, 1)$, in order to rewrite $\theta = \hat{r}/(x^2 - y^2) - 1$ as a function of j_0 and u, and verify that it is less than $\frac{9}{4}u$. Alternatively, we could notice that the value of \hat{r} has been deduced from x and y independently of the tie-breaking rule, making it possible to apply the bound $\theta < \frac{9}{4}u$ established in Theorem 3.1 for the special case of rounding ties to even.

Lemma 4.2. Assume that $p \ge 4$ and let

$$x = 1 + 2u, \qquad y = 3u - 4u^2.$$

Then $x, y \in \mathbb{F}$ and $\theta = -2u + \epsilon$ for some positive $\epsilon = 13u^2 + O(u^3)$.

Proof. The fact that $x \in \mathbb{F}$ is clear and, on the other hand, it is easily checked that $y \in \mathbb{F}$ for β even. Now, the exact sum and difference can be written

$$x + y = (1 + 4u) + (u - 4u^{2}),$$
 $x - y = (1 - u) + 4u^{2},$

where $1 + 4u \in \mathbb{F} \cap [1, \beta)$ and $1 - u \in \mathbb{F} \cap [\beta^{-1}, 1)$. Since $u - 4u^2 \in (0, u)$ for p > 2 and $4u^2 \in (0, \beta^{-1}u)$ for $p \ge 4$, we deduce that x + y and x - y must be rounded down, so that

$$\hat{r}_1 = 1 + 4u, \qquad \hat{r}_2 = 1 - u.$$

Hence $\widehat{r}_1\widehat{r}_2 = (1+2u) + (u-4u^2)$, which is rounded down to $\widehat{r} = 1+2u$. The conclusion follows from $\theta = \widehat{r}/(x^2-y^2)-1$ and $x^2-y^2=1+4u-5u^2+24u^3-16u^4$.

5. Concluding remarks

We conclude by noting that while the factored form (x+y)(x-y) ensures high accuracy in floating-point arithmetic, the algebraic inequality $(x+y)(x-y) \leq x^2$ need not be preserved. The next property shows that this failure is in fact possible regardless of the base and the tie-breaking rule. This is in contrast with the classical scheme x^2-y^2 , where the monotonicity of the rounding map fl together with the fact that $\mathrm{fl}(t)=t$ whenever $t\in\mathbb{F}$ imply immediately that all three variants $\mathrm{fl}(\mathrm{fl}(x^2)-\mathrm{fl}(y^2))$, $\mathrm{fl}(x^2-\mathrm{fl}(y^2))$, and $\mathrm{fl}(\mathrm{fl}(x^2)-y^2)$ produce values not exceeding $\mathrm{fl}(x^2)$.

Property 5.1. Assume that $p \ge 4$ and let

$$x = \beta - 2u,$$
 $y = (1 + \beta/2 + 4u) \cdot 2u.$

Then $x, y \in \mathbb{F}$ and $\widehat{r} = \text{fl}(\text{fl}(x+y)\text{fl}(x-y))$ satisfies $\widehat{r} > \text{fl}(x^2)$.

Proof. Clearly, $x \in \mathbb{F}$ and, for $\beta = 2$, $y = (1 + 2u) \cdot 4u \in \mathbb{F}$. For $\beta > 2$ even and $p \geq 2$, we see that $1 + \beta/2 + 4u \in 2u\mathbb{Z} \cap [1, \beta]$, so $y \in \mathbb{F}$ in this case too. The exact sum and difference are

$$x + y = (1 + u + 8\beta^{-1}u^{2})\beta,$$
 $x - y = \beta - (\beta/2 + 2) \cdot 2u - 8u^{2}.$

From $1 + u \in \mathbb{M} \cap [1, \beta)$ and $8\beta^{-1}u^2 \in (0, u)$ for $p \ge 3$, we deduce that x + y is rounded up to $\widehat{r}_1 = (1+2u)\beta$. Similarly, x-y is rounded up to $\widehat{r}_2 = \beta - (\beta/2+2) \cdot 2u$, since $\beta - (\beta/2+2) \cdot 2u \in \mathbb{F} \cap [1, \beta)$ for $p \ge 3$, and $8u^2 \in (0, u)$ for $p \ge 4$. Therefore,

$$\hat{r}_1 \hat{r}_2 = (\beta + (\beta/2 - 2) \cdot 2u - (\beta/2 + 2) \cdot 4u^2)\beta.$$

Using $(\beta/2 - 2) \cdot 2u \geqslant -2u$ for $\beta \geqslant 2$ together with $(\beta/2 + 2) \cdot 4u^2 < u$ for $p \geqslant 4$, we obtain the strict lower bound

$$\widehat{r}_1\widehat{r}_2 > (\beta - 3u)\beta.$$

On the other hand, the exact square is $x^2 = (\beta - 4u + 4\beta^{-1}u^2)\beta$, and using $4\beta^{-1}u^2 < u$ gives the strict upper bound $x^2 < (\beta - 3u)\beta$. In other words, x^2 and $\widehat{r}_1\widehat{r}_2$ are (strictly) separated by the midpoint $(\beta - 3u)\beta$, which implies that $f(x^2) \neq f(\widehat{r}_1\widehat{r}_2)$ whatever the tie-breaking rule, and, since $x^2 < \widehat{r}_1\widehat{r}_2$, that $f(x^2) < f(\widehat{r}_1\widehat{r}_2)$.

Since \hat{r} is highly accurate, it can exceed $\mathrm{fl}(x^2)$ only slightly: $\hat{r} \leqslant (x^2 - y^2)(1 + 3u) \leqslant x^2(1 + 3u) \leqslant \mathrm{fl}(x^2) \cdot (1 + 4u + O(u^2))$. Also, this can occur only in very special circumstances. More precisely, assuming 0 < y < x, we deduce from the monotonicity of rounding and from the relative error bound in (4) that a necessary condition to have $\mathrm{fl}(x^2) < \hat{r}$ is that x and y satisfy $x^2 < \hat{r}_1 \hat{r}_2 \leqslant (x+y)(x-y)(1+\frac{u}{1+u})^2$ and, therefore,

(23)
$$\frac{y^2}{x^2} < \frac{2u + 3u^2}{(1+2u)^2} < 2u.$$

In other words, \hat{r} can exceed $\mathrm{fl}(x^2)$ only when $y/x < \sqrt{2u}$, that is, only when y is much smaller than x.

In this regime, however, the schemes based on x^2-y^2 are perfectly accurate: it is easy to show by repeated applications of (4) that if $y/x < \sqrt{2u}$ then the relative errors of $\mathrm{fl}(\mathrm{fl}(x^2)-\mathrm{fl}(y^2))$, $\mathrm{fl}(x^2-\mathrm{fl}(y^2))$, and $\mathrm{fl}(\mathrm{fl}(x^2)-y^2)$ are at most $\lambda u + O(u^2)$ with λ equal to 2, 1, and 2, respectively, and this whatever the base and the tie-breaking rule. Similarly, for small values of y as in (23), it can be checked that $\mathrm{fl}(x^2) = (x^2-y^2)(1+\theta)$ with $|\theta| < 3u$, so that simply squaring x already approximates x^2-y^2 with high relative accuracy.

These error bounds suggest that if we need approximations to x^2-y^2 that are both highly accurate and not exceeding $\mathrm{fl}(x^2)$, then the factored form (x+y)(x-y) could be combined with one of the four alternatives above. For example, one could compute $\widehat{r}=\mathrm{fl}(\mathrm{fl}(x+y)\mathrm{fl}(x-y))$ and $\mathrm{fl}(x^2)$ and then return $\min(\widehat{r},\mathrm{fl}(x^2))$. How to best combine such schemes in practice will depend on the context and it would be interesting to study the fine-grained accuracy of the resulting methods.

APPENDIX A. ALTERNATIVE TIE-BREAKING RULES²

The tie-breaking rules considered so far are those appearing in the latest revision of IEEE 754 standard: to even, to away, and to zero [5, pp. 27, 68]. Other tie-breaking rules exist³ and in this appendix we study what happens when ties are broken up, down, or to odd.

Recalling that fl denotes a round-to-nearest map from \mathbb{R} to \mathbb{F} and that the nonzero elements of \mathbb{F} have the form $M \cdot \beta^E$ with $M, E \in \mathbb{Z}$ and $\beta^{p-1} \leq |M| < \beta^p$, one can define these tie-breaking rules as follows: if fl breaks ties to odd, then every real number lying midway between two successive elements of \mathbb{F} is rounded to the one whose integral significand M is odd; if fl breaks ties up (resp. down), then it is rounded to the one for which M is largest (resp. smallest).

For ties to odd, fl satisfies all the properties recalled in section 1.1 and especially the one in (6); for ties up or down the same holds, except that (6) must be modified slightly in order to account for the fact that $\mathrm{fl}^{(\mathrm{ties\ up})}(-t) = -\mathrm{fl}^{(\mathrm{ties\ down})}(t)$ for every midpoint t. Consequently, in each case the relative error θ committed when evaluating $x^2 - y^2$ as $\mathrm{fl}(\mathrm{fl}(x+y)\mathrm{fl}(x-y))$ is amenable to an analysis similar to the ones already performed in sections 2 and 3 for IEEE roundings. As the next theorem shows, when the chosen tie-breaking rule is directed (up or down) or when it is parity-based (to odd) and the base is large, then the best possible constants are the same as those obtained before (namely, 3 and 2, respectively); however, when breaking ties to odd and in base 2, the constant 2.25 obtained for rounding to nearest even must now be replaced by the larger value 2.5. As we shall see in the proof of the theorem, the reason for this larger bound is that Properties 3.2 and 3.3 do not hold anymore when ties are broken to odd (namely, $\epsilon = y \mod 2u$ (resp. p mod p mod p can now be equal to p (resp. p mod p).

Theorem A.1. Assume that the tie-breaking rule of fl is either up, down, or to odd. Asymptotically-optimal bounds on the relative error θ of fl(fl(x + y)fl(x - y)) are then as follows:

$$|\theta| < \begin{cases} 3u & \text{if fl breaks ties up,} \\ 3u & \text{if fl breaks ties down,} \\ \frac{5}{2}u & \text{if fl breaks ties to odd and } \beta = 2, \\ 2u & \text{if fl breaks ties to odd and } \beta \neq 2. \end{cases}$$

A.1. Proof of Theorem A.1 for directed tie-breaking rules. Recall first from section 1 that the bound $|\theta| < 3u$ holds for any tie-breaking rule and thus, in particular, for directed rules such as up and down. Furthermore, when restricted to nonnegative inputs, the induced maps fl coincide with those obtained for the to-away and to-zero rules, respectively:

$$t \in \mathbb{R}_{\geqslant 0} \quad \Rightarrow \quad \text{fl}^{\text{(ties up)}}(t) = \text{fl}^{\text{(ties to away)}}(t), \quad \text{fl}^{\text{(ties down)}}(t) = \text{fl}^{\text{(ties to zero)}}(t).$$

By inspecting the proof of Lemma 2.1, we can see that the only midpoints involved are x + y and x - y and, for the specific expressions chosen there for x and y, are positive. Hence, by the property above, $\hat{r} = \text{fl}(\text{fl}(x+y)\text{fl}(x-y))$ will be the same for

ties up as for ties to away. In other words, the certificate of asymptotic optimality of the bound 3u provided by Lemma 2.1 under the assumption that fl breaks ties to away remains valid when fl breaks ties up.

Similarly, the certificate we have given for the to-zero rule at the end of section 2 is easily seen to involve only positive midpoints and, therefore, remains valid when fl breaks ties down.

We thus have shown the first half of Theorem A.1: when the tie-breaking rule chosen for fl is up or down, then the relative error θ is bounded according to $|\theta| < 3u$ and this bound is asymptotically optimal.

A.2. Proof of Theorem A.1 when fl breaks ties to odd. Our derivation of the upper bounds 2u and $\frac{5}{2}u$ will follow closely what we have done in section 3. Note that the range reduction performed in section 3.1 only requires (6) and thus still holds when breaking ties to odd. Consequently, we are again left with $x, y \in \mathbb{F}$ as in (9) and with the three cases $x \pm y \in [1, \beta)$, $x + y > \beta$, and x - y < 1.

Analysis when $x \pm y \in [1, \beta)$. The same reasoning as in section 3.2 shows that for ties to odd, either x + y and x - y are both in \mathbb{F} or they will be rounded in opposite directions. Hence the product of the corresponding relative errors satisfies $\delta_1 \delta_2 \leq 0$, which similarly to Lemma 3.1 leads to $|\theta| < 2u$ regardless of the value of the base β .

Analysis when $x+y>\beta$. If $x-y\leqslant 1$ or $\beta\neq 2$, it is easily checked that the analysis in section 3.3 is independent of the tie-breaking rule and can thus be reused here to show that $|\theta|<2u$. Recalling (7), note that we also have this bound independently of the tie-breaking rule when $\delta_i\delta_j\leqslant 0$ for some i,j. Hence it remains to handle the situation where x-y>1 and $\beta=2$ and the δ_i are either all positive or all negative.

Assume first that $\delta_i > 0$ for all i. In this case the bounds in Property 3.2 do not hold anymore, since when $\beta = 2$ and $\delta_1 \delta_2 \geqslant 0$ the quantity $\epsilon = y \mod 2u$ introduced in (12) can be equal to u (as shown for example by the certificates given below). Therefore, we shall apply (14) with $\epsilon \leqslant u$ instead of $\epsilon \leqslant (1 - 2\eta)u$ with $\eta = \text{ufp}(y)$, which together with $\beta = 2$ and $\delta_3 \leqslant u_1$ leads to

(24)
$$1 + \theta \leqslant \left(1 + \frac{u}{x+y}\right) \left(1 + \frac{u}{x-y}\right) (1 + u_1).$$

Using x + y > 2 and x - y > 1, we deduce that $\theta \leq \frac{5}{2}u + O(u^2)$. In order to further remove the $O(u^2)$ term, we consider the following three sub-cases, depending on the value of η .

If $\eta \le 1/8$ then y < 1/4 and, since x+y > 2, this gives x-y = (x+y)-2y > 3/2. Applying these lower bounds on $x \pm y$ to the right-hand side of (24), we obtain

$$1 + \theta \leqslant \left(1 + \frac{1}{2}u\right)\left(1 + \frac{2}{3}u\right)(1 + u_1) = 1 + \frac{13}{6}u + \frac{1}{2}u^2 + O(u^2)$$
$$< 1 + \frac{5}{2}u.$$

If $\eta = 1/4$, then the refined lower bounds on $x \pm y$ given in (11) become $x + y \ge 2 + u/2$ and $x - y \ge 1 + 3u/2$. Hence (24) gives now

(25)
$$1 + \theta \leqslant \left(1 + \frac{u}{2 + \frac{u}{2}}\right) \left(1 + \frac{u}{1 + \frac{3}{2}u}\right) (1 + u_1) = 1 + \frac{5}{2}u - \frac{5}{8}u^2 + O(u^3)$$
$$< 1 + \frac{5}{2}u.$$

If $\eta = 1/2$, then $y \in u\mathbb{Z}$. Hence $x \pm y \in u\mathbb{Z}$ and the strict inequalities x + y > 2 and x - y > 1 are equivalent to $x + y \ge 2 + u$ and $x - y \ge 1 + u$. Thus, using (24),

(26)
$$1 + \theta \leqslant \left(1 + \frac{u}{2+u}\right) \left(1 + \frac{u}{1+u}\right)^2 = 1 + \frac{5}{2}u - \frac{1}{4}u^2 + O(u^3)$$
$$< 1 + \frac{5}{2}u.$$

From these three sub-cases we conclude that if $\delta_i > 0$ for all i, then $0 < \theta < \frac{5}{2}u$.

If $\delta_i < 0$ for all i, then $1 + \widetilde{\theta}$ with $\widetilde{\theta}$ as in (15) is also upper bounded by the right-hand side in (24) and, therefore, by $1 + \frac{5}{2}u$ as well. Consequently, $-\frac{5}{2}u < -\widetilde{\theta} < \theta < 0$.

Analysis when x - y < 1. When e = 1 or $\beta \neq 2$ or $\delta_i \delta_j \leq 0$ for some i, j, we perform exactly the same analysis as in section 3.4, which for such cases yields the bound $|\theta| < 2u$ no matter what the tie-breaking rule.

When $e \geqslant 2$ and $\beta = 2$ and the δ_i are either all positive or all negative, we cannot rely on Property 3.3 anymore and, instead, allow $\epsilon = y \mod u$ to be equal to u/2. (This value of ϵ is obtained for example with $x = 3/2 - j \cdot 2u$ and y = 1/2 - u/2 and j such that $x + y \in (1, 2), x - y \in (1/2, 1), \delta_1 > 0$, and $\delta_2 > 0$.)

Assume first that that $\delta_i > 0$ for all i. Applying (20) with $\epsilon \leqslant u/2$, $x \geqslant 1$ and $\delta_3 \leqslant u_1$ then leads to

(27)
$$1 + \theta \leqslant \left(1 + \frac{u/2}{1+y}\right) \left(1 + \frac{u/2}{1-y}\right) (1+u_1).$$

From $e \ge 2$ it follows that $\eta \le 1/4$ and thus y < 1/2. Noting that the right-hand side of (27) is an increasing function of y, we deduce that

$$1 + \theta < \left(1 + \frac{1}{3}u\right)(1 + u)(1 + u_1) = 1 + \frac{7}{3}u + \frac{2}{3}u^2$$

$$\leq 1 + \frac{5}{2}u.$$

Assume now that $\delta_i < 0$ for all i. It is then easily checked that $1 + \widetilde{\theta}$ is upper bounded as in (27). Hence $1 < 1 + \widetilde{\theta} \leqslant 1 + \frac{5}{2}u$ and $-\frac{5}{2}u < \theta < 0$, which concludes the proof of the upper bounds in Theorem A.1 when fl breaks ties to odd.

Certificates of asymptotic optimality. Lemma 4.2 holds whatever the tie-breaking rule and can thus be used here to provide a certificate of asymptotic optimality of the bound $|\theta| < 2u$ when fl breaks ties to odd and $\beta \neq 2$.

When fl breaks ties to odd and $\beta = 2$, Lemma 4.1 (which, too, holds whatever the tie-breaking rule) only yields a lower bound of about 2.25u. To show that the upper bound 2.5u is asymptotically optimal we propose the following variant of that lemma, obtained simply by shifting y from $\frac{1}{2} - \frac{7}{2}u$ to $\frac{1}{2} + u$.

Lemma A.1. Assume that $\beta = 2$ and $p \ge 5$, and let

$$j = \left\lceil 1/\sqrt{8u} \,\right\rceil, \qquad x = \frac{3}{2} + (2j+1) \cdot 2u, \qquad y = \frac{1}{2} + u.$$

Then $x, y \in \mathbb{F}$ and, if fl breaks ties to odd, $\theta = \frac{5}{2}u - \epsilon$ for some positive $\epsilon = O(u^{3/2})$.

Proof. The proof is similar to that of Lemma 4.1. First, we have as before $x \in \mathbb{F}$ for $p \ge 5$, and it is clear that the new y is also in \mathbb{F} . Then

$$x+y=\underbrace{2+j\cdot 4u}_{\in\ \mathbb{F}\cap\left[2,4\right)}+3u,\qquad x-y=\underbrace{1+2j\cdot 2u}_{\in\ \mathbb{F}\cap\left[1,2\right)}+u.$$

Using 2u < 3u < 4u, we deduce that x+y is rounded up to $\widehat{r}_1 = 2 + (j+1) \cdot 4u$ and this regardless of the tie-breaking rule. On the other hand, the expression above for x-y shows that it is halfway between the consecutive floating-point numbers $1+2j\cdot 2u$ and $1+(2j+1)\cdot 2u$. Since 2j is even and we have assumed that fl breaks ties to odd, we deduce that x-y is rounded up to $\widehat{r}_2 = 1+(2j+1)\cdot 2u$. It is then easy to check that the associated relative errors δ_1 and δ_2 satisfy

$$\delta_1 = \frac{1}{2}u - \epsilon_1, \quad \delta_2 = u - \epsilon_2, \quad 0 < \epsilon_1, \epsilon_2 = O(u^{3/2}).$$

From the expressions of \hat{r}_1 and \hat{r}_2 just obtained we deduce that

$$\widehat{r}_1 \widehat{r}_2 = \underbrace{2 + (3j+2) \cdot 4u}_{\in \mathbb{F} \cap [2,4)} + \underbrace{(j+1)(2j+1) \cdot 8u^2}_{\in (2u,4u)},$$

where the strict upper bounds 4 and 4u need $p \ge 5$. Hence, regardless of the tiebreaking rule, $\hat{r}_1\hat{r}_2$ is rounded up to $\hat{r} = 2 + (3j + 3) \cdot 4u$. The associated relative error is

$$\delta_3 = u - \epsilon_3, \qquad 0 < \epsilon_3 = O(u^{3/2}).$$

Recalling that $\theta = \delta_1 + \delta_2 + \delta_3 + O(u^2)$, we arrive at $\theta = (\frac{1}{2} + 1 + 1)u - \epsilon$ with $\epsilon = O(u^{3/2})$, and the fact that $\epsilon > 0$ follows from the third inequality in Theorem A.1.

The certificate we have given in Lemma A.1 has y in [1/2,1), which corresponds to the case $\eta=1/2$ and the bound in (26). Note, however, that a certificate corresponding to the case $\eta=1/4$ and the bound (25) can be obtained as well, for example by taking y=1/2-3u.
