# Coulomb friction with rolling resistance as a cone complementarity problem

#### Abstract

Coulomb friction model with unilateral contact is a basic, but reliable, model to represent the resistance to sliding between solid bodies. It is nowadays well-known that this model can be formulated as a second-order cone complementarity problem, or equivalently, as a variational inequality. In this article, the Coulomb friction model is enriched to take into account the resistance to rolling, also known as rolling friction. Introducing the rolling friction cone, an extended Coulomb's cone and its dual, a formulation of the Coulomb friction with rolling resistance as a cone complementarity problem is shown to be equivalent to the standard formulation of the Coulomb friction with rolling resistance. Based on this complementarity formulation, the maximum dissipation principle and the bi-potential function are derived. Several iterative numerical methods based on projected fixed point iterations for variational inequalities and block-splitting techniques are given. The efficiency of these method strongly relies on the computation of the projection onto the rolling friction cone. In this article, an original closed-form formulae for the projection on the rolling friction cone is derived. The abilities of the model and the numerical methods are illustrated on the examples of a single sphere sliding and rolling on a plane, and of the evolution of spheres piles under gravity.


## 1. Introduction and rolling friction model

Rolling friction has a long history; see for instance [13] and references therein. Like the standard Coulomb friction, the threshold effect of rolling friction is the main physical phenomenon that is required to be modeled for a basic friction law as described in [28, Chapter 1, §20]. Although it may be considered as a naive model from a triboligical point of view, the simplest rolling friction model postulates the existence of an upper bound of the norm of the resistive moment in the tangent plane at contact $m_{\mathrm{T}}$ that is proportional to the normal pressure $r_{\mathrm{N}}$ :

\end{equation*}

[^0]where $\mu_{r}$ is the rolling friction coefficient. Such a simple model has been used successfully in analytical nonlinear dynamics [24, 23] and in [31, 20, 10, 9, 16] for numerical computations of granular materials. For a discussion on more complex models of rolling friction, we refer to [22, 21, 16] in the context of nonlinear dynamics.

Our goal is to formulate the rolling friction model as a set-valued force law in a nonsmooth setting following the seminal work of Moreau [25]. For a good account on set-valued force laws approach and nonsmooth mechanics, we refer to [27, 12, 6]. This approach enables to compute solutions with efficient numerical methods that come mainly from mathematical programming techniques, especially complementarity problems, normal cone inclusions, and variational inequalities 11.

In [22, 21, the Coulomb-Contensou friction model is formulated in terms of normal cones inclusions, but the model of dry friction with simple rolling resistance was not investigated. In [15, [30], the rolling friction is addressed with the help of second-order cone complementarity problem, but the friction flow rule is associated. In other words, the relative velocities at contact are chosen such that they are orthogonal to the friction cone yielding a dilatance in case of sliding and no dissipation. The problem becomes a convex relaxation of the initial model, but does not represent standard Coulomb friction without dilatancy.

The article is organized as follows. After the presentation of the model in Section 2, a formulation of the Coulomb friction with unilateral contact and rolling resistance with no-dilatancy as a cone complementarity problem is given in Section 3. Following the work on the bi-potential method [8, 29], the modified velocity at contact is introduced to avoid dilatancy. The formulation is proved to be equivalent to disjuntive (or modal) description of the rolling friction. In Section 4 , optimization formulations are exhibited that lead to the principle of maximum dissipation for a given normal reaction and to the definition of a bipotential for the rolling friction. Numerical schemes based on projected fixed iterations and block-splitting techniques are presented in Section 5 to solve the problem with multiple contact points. Especially, the explicit formulae for the projection onto the rolling friction cone, that is crucial for the efficiency of the numerical methods, is derived in Section 5.3. The article is concluded by two simple numerical applications that emphasize the capacities of the rolling friction model : the motion of a sphere rolling on a plane and the creation of a pile of spheres using a pluviation process.

Notation: For a set $X \subset \mathbb{R}^{n}, \bar{X}, \dot{X}$ and $\partial X$ will respectively denotes the closure, the interior and the boundary of $X$. For a convex set $C \subset \mathbb{R}^{n}$, the normal cone to $C$ at $x \in \mathbb{R}^{n}$ is defined by $\mathrm{N}_{C}(x):=\left\{y \mid y^{\top}(z-x) \leq 0, \forall z \in C\right\}$. The indicator function $\mathrm{i}_{C}$ is defined by $\mathrm{i}_{C}(x)=0$, if $x \in C$ and $\mathrm{i}_{C}(x)=+\infty$, if $x \notin C$ For a cone $K$, its dual cone $K^{\star}$ is defined by $K^{\star}:=\left\{y \mid y^{\top} p \geq 0, \forall p \in\right.$ $K\}$ and its polar by $K^{\circ}=-K^{\star}$. For a convex fonction $f: \mathbb{R}^{n} \rightarrow \mathbb{R}$, the subdifferential of $f$ is defined by $\partial f=\left\{\gamma \in \mathbb{R}^{n} \mid f(y)-f(x) \geq \gamma^{T}(y-x)\right.$ for all $\left.y \in \mathbb{R}^{n}\right\}$.

## 2. Rolling friction model

### 2.1. Standard Coulomb friction model with unilateral contact.

Coulomb friction model with unilateral contact is a basic, but reliable model to represent the mechanical behavior of interfaces between solid bodies. Let us recall its formulation. In Figure 1, we represent two bodies, labeled by $A$ and $B$, potentially in contact at points $C_{A}$ and $C_{B}$ in a three-dimensional configuration space $\rrbracket^{1}$ Let assume that we can uniquely define an orthonormal contact frame at $C_{A}$ denoted by $\left(C_{A}, \mathrm{~N}, \mathrm{~T}_{1}, \mathrm{~T}_{2}\right)$, where $\mathrm{N} \in \mathbb{R}^{3}$ defines an outward unit normal vector to $A$ at point $C_{A}$ and $\mathrm{T}_{1} \in \mathbb{R}^{3}, \mathrm{~T}_{2} \in \mathbb{R}^{3}$ are unit tangent vectors. The gap between $C_{A}$ and $C_{B}$ reads as

\begin{equation*}
g_{\mathrm{N}}:=\left(C_{B}-C_{A}\right)^{\top} \mathrm{N} . \tag{2}
\end{equation*}

The reaction force exerted by $A$ on $B$ is denoted by $r \in \mathbb{R}^{3}$. It can be decomposed in the contact frame as

r:=r_{\mathrm{N}} \mathrm{~N}+r_{\mathrm{T}_{1}} \mathrm{~T}_{1}+r_{\mathrm{T}_{2}} \mathrm{~T}_{2}, \quad \text { with } r_{\mathrm{N}} \in \mathbb{R} \text { and } r_{\mathrm{T}}:=\left[r_{\mathrm{T}_{1}}, r_{\mathrm{T}_{2}}\right]^{\top} \in \mathbb{R}^{2} . \tag{3}
\end{equation*}
$$

The Signorini condition expresses the unilateral contact as a complementarity condition between the gap and the normal reaction force as

$$
\begin{equation*}
0 \leq g_{\mathrm{N}} \perp r_{\mathrm{N}} \geq 0 \tag{4}
\end{equation*}
$$

[^1]Since we want to deal with friction, the relative velocity at contact $u \in \mathbb{R}^{3}$ is used as natural way to formulate friction. It is also decomposed as

$$
\begin{equation*}
u:=u_{\mathrm{N}} \mathrm{~N}+u_{\mathrm{T}_{1}} \mathrm{~T}_{1}+u_{\mathrm{T}_{2}} \mathrm{~T}_{2} \quad \text { with } u_{\mathrm{N}} \in \mathbb{R} \text { and } u_{\mathrm{T}}=\left[u_{\mathrm{T}_{1}}, u_{\mathrm{T}_{2}}\right]^{\top} \in \mathbb{R}^{2} \tag{5}
\end{equation*}

At the velocity level, the Signorini condition is written

$$
\begin{cases}0 \leq u_{\mathrm{N}} \perp r_{\mathrm{N}} \geq 0 & \text { if } g_{\mathrm{N}} \leq 0  \tag{6}\\ r_{\mathrm{N}}=0 & \text { otherwise }\end{cases}
$$

The Moreau's viability Lemma [26] ensures that (6) implies (4) if $g_{\mathrm{N}} \geq 0$ holds in the initial configuration. In the sequel, we will focus our attention on closed contact ( $g_{\mathrm{N}} \leq 0$ ) since the other case is trivial. Equivalently, the complementarity condition can be written as a normal cone inclusion, or a variational inequality:

-u_{\mathrm{N}} \in \mathrm{~N}_{\mathbb{R}_{+}}\left(r_{\mathrm{N}}\right) \Longleftrightarrow u_{\mathrm{N}}\left(s-r_{\mathrm{N}}\right) \geq 0, \forall s \in \mathbb{R}_{+} \tag{7}
\end{equation*}

If needed, an impact law must be added to complete the interface model. This is particularly the case when we deal with rigid solid bodies. The Newton impact law might be chosen as a basic impact model. Considering the post-impact velocity $u_{\mathrm{N}}^{+}$, and the pre-impact velocity $u_{\mathrm{N}}^{-}$, the Newton impact law can be written as

\begin{equation*}
u_{\mathrm{N}}^{+}=-e_{n} u_{\mathrm{N}}^{-} \tag{8}
\end{equation*}

where $e_{n} \geq 0$ is the coefficient of restitution. As in [26], the Newton impact law can be included in the complementary condition at the velocity level as

$$
\begin{equation*}
0 \leq \bar{u}_{\mathrm{N}} \perp r_{\mathrm{N}} \geq 0 \tag{9}
\end{equation*}

with $\bar{u}_{\mathrm{N}}:=u_{\mathrm{N}}^{+}+e_{n} u_{\mathrm{N}}^{-}$. In order to simplify the presentation, we will consider in the sequel that $e_{n}=0$ and $\bar{u}_{\mathrm{N}}=u_{\mathrm{N}}^{+}=u_{\mathrm{N}}$.

In the tangent plane at contact, Coulomb friction is based on the postulate of an admissible set for the reaction force, called the Coulomb's cone:

$$
\begin{equation*}
K=\left\{r \in \mathbb{R}^{3} \mid\left\|r_{\mathrm{T}}\right\| \leq \mu r_{\mathrm{N}}\right\} \tag{10}
\end{equation*}
$$

where $\mu$ is the coefficient of friction.
In the sticking case, Coulomb's law states

$$
\begin{equation*}
u_{\mathrm{T}}=0, \quad r \in K \tag{11}
\end{equation*}
$$

and for the sliding case

$$
\begin{equation*}
u_{\mathrm{T}} \neq 0, \quad\left\|r_{\mathrm{T}}\right\|=\mu r_{\mathrm{N}} \quad \text { and }\left\|r_{\mathrm{T}}\right\| u_{\mathrm{T}}=-\left\|u_{\mathrm{T}}\right\| r_{\mathrm{T}} \tag{12}
\end{equation*}
$$

Introducing the disk $D(c):=\left\{x \in \mathbb{R}^{2} \mid\|x\| \leq c\right\}$ of radius $c \geq 0$, the Coulomb model can be written as an inclusion

$$
\begin{equation*}
-u_{\mathrm{T}} \in \mathrm{~N}_{D\left(\mu r_{\mathrm{N}}\right)}\left(r_{\mathrm{T}}\right) \tag{13}
\end{equation*}
$$

Using definition of the normal cone, an equivalent variational inequality can be written

$$
\begin{equation*}
u_{\mathrm{T}}^{\top}\left(z-r_{\mathrm{T}}\right) \geq 0, \quad \forall z \in D\left(\mu r_{\mathrm{N}}\right) \tag{14}
\end{equation*}
$$

The latter formulation is often related to Moreau's maximum dissipation principle of the frictional behavior:

$$
\begin{equation*}
r_{\mathrm{T}} \in \underset{\|z\| \leq \mu r_{\mathrm{N}}}{\operatorname{argmax}}-z^{\top} u_{\mathrm{T}} \tag{15}
\end{equation*}
$$

which is completely equivalent to the inclusion (13). This principle postulates that, for a given relative tangent velocity $u_{\mathrm{T}}$, the reaction $r_{\mathrm{T}}$ maximizes the dissipation $-r_{\mathrm{T}} u_{\mathrm{T}}$ over all the admissible tangent reactions. It is noteworthy to remark that this principle does not claim that $r$ is chosen such that is maximizes the dissipation $r^{\top} u$. This is related to the non-associated character of Coulomb friction.

### 2.2. Rolling friction model.

In order to formulate the rolling friction at contact, we introduce the relative angular velocity $\omega_{\mathrm{T}} \in \mathbb{R}^{2}$ and the rolling friction reaction moment $m_{\mathrm{T}} \in \mathbb{R}^{2}$ at contact. Following [28], a rolling friction model can be defined with two following modes

$$
\begin{cases}\omega_{\mathrm{T}}=0,\left\|m_{\mathrm{T}}\right\| \leq \mu_{r} r_{\mathrm{N}}  \tag{16}\\ \omega_{\mathrm{T}} \neq 0,\left\|m_{\mathrm{T}}\right\|=\mu_{r} r_{\mathrm{N}}, \text { and }\left\|m_{\mathrm{T}}\right\| \omega_{\mathrm{T}}=-\left\|\omega_{\mathrm{T}}\right\| m_{\mathrm{T}} & \text { (no-rolling) } \\ \text { (rolling) }\end{cases}
$$

where $\mu_{r}$ is the rolling friction coefficient which has the dimension of a length.
As for the Coulomb friction, the model (16) can be expressed as a normal cone inclusion into the disk of rolling friction as

$$
\begin{equation*}
-\omega_{\mathrm{T}} \in \mathrm{~N}_{D\left(\mu_{r} r_{\mathrm{N}}\right)}\left(m_{\mathrm{T}}\right) \tag{17}
\end{equation*}
$$

Again, a maximum dissipation principle can be written as

$$
\begin{equation*}
m_{\mathrm{T}} \in \underset{\|z\| \leq \mu_{\mathrm{r}} r_{\mathrm{N}}}{\operatorname{argmax}}-z^{\top} \omega_{\mathrm{T}} \tag{18}
\end{equation*}
$$

### 2.3. Compact formulation

In order to obtain a compact formulation of the model, we denote the local variables at contact by

The rolling friction cone, as the cone of admissible reaction forces and torques, is denoted by

$$
\begin{equation*}
K_{r}=\left\{p \in \mathbb{R}^{5} \mid\left\|r_{\mathrm{T}}\right\| \leq \mu r_{\mathrm{N}}, \quad\left\|m_{\mathrm{T}}\right\| \leq \mu_{r} r_{\mathrm{N}}\right\} \subset \mathbb{R}^{5} \tag{20}
\end{equation*}
$$

which is a closed convex cone. The Coulomb friction model with unilateral contact and rolling resistance is formulated in a disjunctive form for $g_{\mathrm{N}} \leq 0$ as

$$
\left\{\begin{array}{llr}
p=0, u_{\mathrm{N}} \geq 0, & \text { (take-off) }  \tag{21}\\
p \in K_{r}, u=0, \omega_{\mathrm{T}}=0, & \text { (sticking and no-rolling) } \\
p \in \partial K_{r}, u_{\mathrm{N}}=0,\left\|r_{\mathrm{T}}\right\|=\mu r_{\mathrm{N}},\left\|m_{\mathrm{T}}\right\|<\mu_{r} r_{\mathrm{N}}, & \left\|r_{\mathrm{T}}\right\| u_{\mathrm{T}}=-\left\|u_{\mathrm{T}}\right\| r_{\mathrm{T}}, \omega_{\mathrm{T}}=0, & \text { (sliding and no-rolling) } \\
p \in \partial K_{r}, u_{\mathrm{N}}=0,\left\|r_{\mathrm{T}}\right\|<\mu r_{\mathrm{N}},\left\|m_{\mathrm{T}}\right\|=\mu_{r} r_{\mathrm{N}}, & \left\|m_{\mathrm{T}}\right\| \omega_{\mathrm{T}}=-\left\|\omega_{\mathrm{T}}\right\| m_{\mathrm{T}}, u_{\mathrm{T}}=0, & \text { (sticking and rolling) } \\
p \in \partial K_{r}, u_{\mathrm{N}}=0,\left\|r_{\mathrm{T}}\right\|=\mu r_{\mathrm{N}},\left\|m_{\mathrm{T}}\right\|=\mu_{r} r_{\mathrm{N}}, & \left\|r_{\mathrm{T}}\right\| u_{\mathrm{T}}=-\left\|u_{\mathrm{T}}\right\| r_{\mathrm{T}}, & \\
& \left\|m_{\mathrm{T}}\right\| \omega_{\mathrm{T}}=-\left\|\omega_{\mathrm{T}}\right\| m_{\mathrm{T}} . & \text { (sliding and rolling) }
\end{array}\right.
$$

In the disjunctive form 21), the model is hardly tractable from the computational point of view. In the sequel, we propose a formulation of the model as a single normal cone inclusion to the rolling friction cone $K_{r}$ and we prove its equivalence with the disjunctive formulation of the model.

## 3. Formulation as a cone complementarity problem

One of the objective of the article is to formulate the rolling friction as a unique inclusion to the normal cone to $K_{r}$. Using the normal cone inclusions (7), (13) and (17), the rolling friction model is given by the following set of inclusions,

\left\{\begin{array}{l}
-u_{\mathrm{N}} \in \mathrm{~N}_{\mathbb{R}_{+}}\left(r_{\mathrm{N}}\right)  \tag{22}\\
-u_{\mathrm{T}} \in \mathrm{~N}_{D\left(\mu r_{\mathrm{N}}\right)}\left(r_{\mathrm{T}}\right) \\
-\omega_{\mathrm{T}} \in \mathrm{~N}_{D\left(\mu_{r} r_{\mathrm{N}}\right)}\left(m_{\mathrm{T}}\right)
\end{array}\right.
$$

that appears to be a quasi-variational inequality. Unfortunately, it is not possible to deduce from 22 a complementarity problem, since the disks $D\left(\mu r_{\mathrm{N}}\right)$ and $D\left(\mu_{r} r_{\mathrm{N}}\right)$ are not cones. A single normal cone inclusion to $K_{r}$ enables to write a complementarity problem, and then, to take benefit from the theory and numerical methods for complementarity problems [11.

In the case of standard Coulomb friction and following the seminal work of De Saxcé and Feng [29], both normal cone inclusions (7) and $\sqrt{13}$ ) can be joined into one normal cone inclusion as

\end{equation*}

where the modified relative velocity is defined by

$$
\begin{equation*}
\hat{u}:=u+\left[\mu\left\|u_{\mathrm{T}}\right\|, 0,0\right]^{\top} . \tag{24}
\end{equation*}
$$

The modified relative velocity takes into account the non-associated character of the friction rule with no dilatancy. Since $K$ is the second-order cone, the inclusion can expressed as a second-order complementarity condition as

$$
\begin{equation*}
K^{\star} \ni \hat{u} \perp r \in K \tag{25}
\end{equation*}
$$

where $K^{\star}$ is the dual cone of $K$. For more details on this reformulation, we refer to [5].
As we remark in (25), the first step is to characterize the dual cone of $K_{r}$.

Lemma 3.1 ( $K_{r}^{\star}$ dual cone of $K_{r}$ ). The dual cone of $K_{r}$ is given by

K_{r}^{\star}=\left\{\left.y=\left[\begin{array}{l}
u_{N}  \tag{26}\\
u_{T} \\
\omega_{T}
\end{array}\right] \right\rvert\, \mu\left\|u_{T}\right\|+\mu_{r}\left\|\omega_{T}\right\| \leq u_{N}\right\}

Proof: Let us introduce the following convex cone

$$
\begin{equation*}
L=\left\{y=\left[u_{\mathrm{N}}, u_{\mathrm{T}}^{\top}, \omega_{\mathrm{T}}^{\top}\right]^{\top} \mid \mu\left\|u_{\mathrm{T}}\right\|+\mu_{r}\left\|\omega_{\mathrm{T}}\right\| \leq u_{\mathrm{N}}\right\} \tag{27}
\end{equation*}
$$

The goal is to prove that $K_{r}^{\star}=L$. Let us choose $y \in L$ and $p \in K_{r}$. We obtain

$$
\begin{equation*}
y^{\top} p=u_{\mathrm{N}} r_{\mathrm{N}}+u_{\mathrm{T}}^{\top} r_{\mathrm{T}}+\omega_{\mathrm{T}}^{\top} m_{\mathrm{T}} \geq u_{\mathrm{N}} r_{\mathrm{N}}-\left\|u_{\mathrm{T}}\right\|\left\|r_{\mathrm{T}}\right\|-\left\|\omega_{\mathrm{T}}\right\|\left\|m_{\mathrm{T}}\right\|, \tag{28}
\end{equation*}
$$

by the reverse Cauchy-Schwarz inequality that ensures $u_{\mathrm{T}}^{\top} r_{\mathrm{T}} \geq-\left\|u_{\mathrm{T}}\right\|\left\|r_{\mathrm{T}}\right\|$ and $\omega_{\mathrm{T}}^{\top} m_{\mathrm{T}} \geq-\left\|\omega_{\mathrm{T}}\right\|\left\|m_{\mathrm{T}}\right\|$. Since $y \in L$ and $p \in K_{r}$, we obtain

y^{\top} p \geq u_{\mathrm{N}} r_{\mathrm{N}}-\mu r_{\mathrm{N}}\left\|u_{\mathrm{T}}\right\|-\mu_{r} r_{\mathrm{N}}\left\|\omega_{\mathrm{T}}\right\| \geq r_{\mathrm{N}}\left(u_{\mathrm{N}}-\mu\left\|u_{\mathrm{T}}\right\|-\mu_{r}\left\|\omega_{\mathrm{T}}\right\|\right) \geq 0 \tag{29}
\end{equation*}
$$

and then $r_{\mathrm{N}} \geq 0$ implies $L \subset K_{r}^{\star}$. Let us choose $y \notin L$ such that $\mu\left\|u_{\mathrm{T}}\right\|+\mu_{r}\left\|\omega_{\mathrm{T}}\right\|>u_{\mathrm{N}}$. Let us choose a special element on the boundary of $K_{r}$ but in the opposite direction to $y$, that is, $p$ such that

\left\|r_{\mathrm{T}}\right\|=\mu r_{\mathrm{N}}, \quad\left\|m_{\mathrm{T}}\right\|=\mu_{r} r_{\mathrm{N}}, \quad\left\|r_{\mathrm{T}}\right\| u_{\mathrm{T}}=-\left\|u_{\mathrm{T}}\right\| r_{\mathrm{T}}, \quad\left\|m_{\mathrm{T}}\right\| \omega_{\mathrm{T}}=-\left\|\omega_{\mathrm{T}}\right\| m_{\mathrm{T}} \tag{30}
\end{equation*}
$$

Let us now compute the scalar product

$$
\begin{align*}
y^{\top} p & =u_{\mathrm{N}} r_{\mathrm{N}}+u_{\mathrm{T}}^{\top} r_{\mathrm{T}}+\omega_{\mathrm{T}}^{\top} m_{\mathrm{T}}=u_{\mathrm{N}} r_{\mathrm{N}}-\left\|r_{\mathrm{T}}\right\| \frac{u_{\mathrm{T}}^{\top}}{\left\|u_{\mathrm{T}}\right\|} u_{\mathrm{T}}-\left\|m_{\mathrm{T}}\right\| \frac{\omega_{\mathrm{T}}^{\top}}{\left\|\omega_{\mathrm{T}}\right\|} \omega_{\mathrm{T}} \\
& =u_{\mathrm{N}} r_{\mathrm{N}}-\left\|r_{\mathrm{T}}\right\|\left\|u_{\mathrm{T}}\right\|-\left\|m_{\mathrm{T}}\right\|\left\|\omega_{\mathrm{T}}\right\|  \tag{31}\\
& =u_{\mathrm{N}} r_{\mathrm{N}}-\mu r_{\mathrm{N}}\left\|u_{\mathrm{T}}\right\|-\mu_{r} r_{\mathrm{N}}\left\|\omega_{\mathrm{T}}\right\|=r_{\mathrm{N}}\left(u_{\mathrm{N}}-\mu\left\|u_{\mathrm{T}}\right\|-\mu_{r}\left\|\omega_{\mathrm{T}}\right\|\right)<0
\end{align*}
$$

so $y \notin K_{r}^{\star}$.

Inspired by the definition of the dual cone in Lemma 3.1, the following proposition defines the rolling friction model as a complementarity problem over the cone $K_{r}$ and proves the equivalence between the formulations 21 and 22 .

Proposition 3.1. Let us define the modified velocity as

$$
\begin{equation*}
\hat{y}:=y+\left[\mu\left\|u_{T}\right\|+\mu_{r}\left\|\omega_{T}\right\|, 0,0,0,0\right]^{\top} . \tag{32}
\end{equation*}
$$

Let us consider the following cone complementarity problem.

$$
\begin{equation*}
K_{r}^{\star} \ni \hat{y} \perp p \in K_{r} \Longleftrightarrow-\hat{y} \in \mathrm{~N}_{K_{r}}(p) \tag{33}
\end{equation*}
$$

Then, the models in (21), (22) and (33) are equivalent.

Proof : Let us introduce the notation $\hat{u}_{\mathrm{N}}:=u_{\mathrm{N}}+\mu\left\|u_{\mathrm{T}}\right\|+\mu_{r}\left\|\omega_{\mathrm{T}}\right\|$. If $\hat{y} \in K_{r}^{\star}$, then $\hat{u}_{\mathrm{N}} \geq$ $\mu\left\|u_{\mathrm{T}}\right\|+\mu_{r}\left\|\omega_{\mathrm{T}}\right\|$ or equivalently $u_{\mathrm{N}} \geq 0$, so we have

$$
\begin{equation*}
\hat{y} \in K_{r}^{\star} \Longleftrightarrow u_{\mathrm{N}} \geq 0 \tag{34}
\end{equation*}
$$

Let us show that (21) implies (22). From (21, we have either $r_{\mathrm{N}}=0$ and $u_{\mathrm{N}} \geq 0$ or $r_{\mathrm{N}} \geq 0$ and $u_{\mathrm{N}}=0$ so the complementarity between $u_{\mathrm{N}}$ and $r_{\mathrm{N}}$ in 22) is satisfied. If $r_{\mathrm{N}}=0$, the model in 21) implies that $r_{\mathrm{T}}=0, m_{\mathrm{T}}=0$ and the velocities are free to evolve in $\mathbb{R}^{2}$. In 22 , the normal cone to the disk is given by $\mathrm{N}_{D(0)}=\mathbb{R}^{2}$ for $r_{\mathrm{N}}=0$. For $r_{\mathrm{N}}>0$, let us recall the definition of $\mathrm{N}_{D(c)}$ with $c>0$ :

$$
\mathrm{N}_{D(c)}(x)=\left\{\begin{array}{cc}
0 & \text { if }  \tag{35}\\
\frac{x}{0}< \\
\lambda \frac{x}{\|x\|}, \lambda \geq 0 & \text { if }
\end{array}\right.
$$

In the sticking and no-rolling case $(r \in K, u=0)$, it is trivial since $u=0$ belongs to the normal cone $\mathrm{N}_{D\left(\mu r_{n}\right)}$. For the sticking cases, we have $\left\|r_{\mathrm{T}}\right\|<\mu r_{\mathrm{N}}$ and $u_{\mathrm{T}}=0$ so $-u_{\mathrm{T}} \in \mathrm{N}_{D\left(\mu r_{\mathrm{N}}\right)}\left(r_{\mathrm{T}}\right)$ is satisfied. For the sliding cases, we have $\left\|r_{\mathrm{T}}\right\|=\mu r_{\mathrm{N}}$ and $\left\|r_{\mathrm{T}}\right\| u_{\mathrm{T}}=-\left\|u_{\mathrm{T}}\right\| r_{\mathrm{T}}$ so $-u_{\mathrm{T}}=\left\|u_{\mathrm{T}}\right\| \frac{r_{\mathrm{T}}}{\left\|r_{\mathrm{T}}\right\|}$ so that $-u_{\mathrm{T}} \in \mathrm{N}_{D\left(\mu r_{\mathrm{N}}\right)}\left(r_{\mathrm{T}}\right)$ is satisfied. The same argumentation applies to show that $-\omega_{\mathrm{T}} \in$ $\mathrm{N}_{D\left(\mu_{\mathrm{r}} r_{\mathrm{N}}\right)}\left(m_{\mathrm{T}}\right)$.

Let us show that (22) implies (33). Since $-u_{\mathrm{N}} \in \mathrm{N}_{\mathbb{R}_{+}}\left(r_{\mathrm{N}}\right)$ holds, we have $u_{\mathrm{N}} \geq 0$ and then $\hat{y} \in K_{r}^{\star}$. If 22 is satisfied, then $p \in K_{r}$. It remains to check the orthogonality in the different cases.

Starting from the constraints $p \in K_{r}$, let us enumerate the different cases:
a) $r_{N}=0$. In that case, the model 22 implies $r_{\mathrm{T}}=0$ and $m_{\mathrm{T}}=0$ that is $p=0$. The orthogonality condition is then trivially satisfied for all $\hat{y} \in K_{r}^{\star}$. We conclude that (33) is satisfied.
b) $r_{N}>0,\left\|r_{T}\right\|<\mu r_{N},\left\|m_{T}\right\|<\mu_{r} r_{N}$. In that case, it is obvious that $p \in \stackrel{\circ}{K}_{r}$. The relations in 22) imply that $u_{\mathrm{N}}=0, u_{\mathrm{T}}=0$ and $\omega_{\mathrm{T}}=0$. So we have $\hat{y}=y=0$, the orthogonality is also trivially satisfied.
c) $r_{N}>0,\left\|r_{T}\right\|=\mu r_{N},\left\|m_{T}\right\|<\mu_{r} r_{N}$. From (22), we conclude that $u_{\mathrm{N}}=0$ and $\omega_{\mathrm{T}}=0$. Since $\left\|r_{\mathrm{T}}\right\|=\mu r_{\mathrm{N}}$, from the definition of the normal cone in (35), we have $-u_{\mathrm{T}}=\lambda \frac{r_{\mathrm{T}}}{\left\|r_{\mathrm{T}}\right\|}, \lambda \geq 0$. Taking the norm of the last expression yields $\lambda=\left\|u_{\mathrm{T}}\right\|$, and then $\left\|r_{t}\right\| u_{\mathrm{T}}=-\left\|u_{\mathrm{T}}\right\| r_{\mathrm{T}}$ and $u_{\mathrm{T}}^{\top} r_{\mathrm{T}}=$ $-\left\|u_{\mathrm{T}}\right\|\left\|r_{\mathrm{T}}\right\|$. The orthogonality condition is

$$
\begin{equation*}
\hat{y}^{\top} p=\hat{u}_{\mathrm{N}} r_{\mathrm{N}}+u_{\mathrm{T}} r_{\mathrm{T}}=u_{\mathrm{N}} r_{\mathrm{N}}+\mu\left\|u_{\mathrm{T}}\right\| r_{\mathrm{N}}-\left\|u_{\mathrm{T}}\right\|\left\|r_{\mathrm{T}}\right\|=u_{\mathrm{N}} r_{\mathrm{N}}+\left(\mu r_{\mathrm{N}}-\left\|r_{\mathrm{T}}\right\|\right)\left\|u_{\mathrm{T}}\right\|=0 \tag{36}
\end{equation*}
$$

and we conclude that $\sqrt[33]{ }$ is satisfied.
d) $r_{N}>0,\left\|r_{T}\right\|<\mu r_{N},\left\|m_{T}\right\|=\mu_{r} r_{N}$. From (22), we conclude that $u_{\mathrm{N}}=0$ and $u_{\mathrm{T}}=0$. Since $\left\|m_{\mathrm{T}}\right\|=\mu_{r} r_{\mathrm{N}}$, we have $-\omega_{\mathrm{T}}=\lambda \frac{m_{\mathrm{T}}}{\left\|m_{\mathrm{T}}\right\|}, \lambda \geq 0$. Similarly as the previous case, we have $\lambda=\left\|\omega_{\mathrm{T}}\right\|$ and then $\omega_{\mathrm{T}}^{\top} m_{\mathrm{T}}=-\left\|\omega_{\mathrm{T}}\right\|\left\|m_{\mathrm{T}}\right\|$. The orthogonality condition is

$$
\begin{equation*}
\hat{y}^{\top} p=\hat{u}_{\mathrm{N}} r_{\mathrm{N}}+\omega_{\mathrm{T}} m_{\mathrm{T}}=u_{\mathrm{N}} r_{\mathrm{N}}+\mu_{r}\left\|\omega_{\mathrm{T}}\right\| r_{\mathrm{N}}-\left\|\omega_{\mathrm{T}}\right\|\left\|m_{\mathrm{T}}\right\|=u_{\mathrm{N}} r_{\mathrm{N}}+\left(\mu_{r} r_{\mathrm{N}}-\left\|m_{\mathrm{T}}\right\|\right)\left\|\omega_{\mathrm{T}}\right\|=0 \tag{37}
\end{equation*}
$$

and we conclude that $(33)$ is satisfied.
e) $r_{N}>0,\left\|r_{T}\right\|=\mu r_{N},\left\|m_{T}\right\|=\mu_{r} r_{N}$. From 22), we have $u_{\mathrm{N}}=0, u_{\mathrm{T}}^{\top} r_{\mathrm{T}}=-\left\|u_{\mathrm{T}}\right\|\left\|r_{\mathrm{T}}\right\|$ and $\omega_{\mathrm{T}}^{\top} m_{\mathrm{T}}=-\left\|\omega_{\mathrm{T}}\right\|\left\|m_{\mathrm{T}}\right\|$. The orthogonality condition is

$$
\begin{equation*}
\hat{y}^{\top} p=\hat{u}_{\mathrm{N}} r_{\mathrm{N}}+u_{\mathrm{T}} r_{\mathrm{T}}+\omega_{\mathrm{T}} m_{\mathrm{T}}=u_{\mathrm{N}} r_{\mathrm{N}}+\mu\left\|u_{\mathrm{T}}\right\| r_{\mathrm{N}}-\left\|u_{\mathrm{T}}\right\|\left\|r_{\mathrm{T}}\right\|+\mu_{r}\left\|\omega_{\mathrm{T}}\right\| r_{\mathrm{N}}-\left\|\omega_{\mathrm{T}}\right\|\left\|m_{\mathrm{T}}\right\|=0 \tag{38}
\end{equation*}
$$

we conclude that $\sqrt[33]{ }$ is satisfied.

Let us finally show that (33) implies (21). From (33), we have $r \in K_{r}$ and $u_{\mathrm{N}} \geq 0$. Let us again enumerate the cases.
a) $p=0$. Since we have $u_{\mathrm{N}} \geq 0$ so it implies the take-off condition in 21.
b) $p \in \dot{K}_{r}$. In that case, the complementarity implies $\hat{y}=0$, and then $u_{\mathrm{T}}=\omega_{\mathrm{T}}=0$ and finally $u_{\mathrm{N}}=0$ so it implies the sticking and no-rolling case.
c) $p \in \partial K_{r},\left\|r_{T}\right\|=\mu r_{N},\left\|m_{T}\right\|<\mu_{r} r_{N}$ Let us compute the normal cone to $K_{r}$ at $p$ :

$$
\mathrm{N}_{K_{r}}(p)=\left\{y=\lambda_{1}\left[\begin{array}{c}
-\mu  \tag{39}\\
\frac{r_{\mathrm{T}}}{\left\|r_{\mathrm{r}}\right\|} \\
0
\end{array}\right], \lambda_{1} \geq 0\right\}
$$

From $-\hat{y} \in \mathrm{~N}_{K_{r}}(p)$, we conclude that

$$
\begin{equation*}
u_{\mathrm{T}}=\lambda_{1} \frac{r_{\mathrm{T}}}{\left\|r_{\mathrm{T}}\right\|}, \lambda_{1} \geq 0 \text { and } \omega_{\mathrm{T}}=0 \tag{40}
\end{equation*}
$$

Taking the norm of the first expression in yields $\lambda_{1}=\left\|u_{\mathrm{T}}\right\|$, and then $\left\|r_{\mathrm{T}}\right\| u_{\mathrm{T}}=-\left\|u_{\mathrm{T}}\right\| r_{\mathrm{T}}$.
d) $p \in \partial K_{r},\left\|r_{T}\right\|<\mu r_{N},\left\|m_{T}\right\|=\mu_{r} r_{N}$. This case is similar to the previous one.
e) $p \in \partial K_{r},\left\|r_{T}\right\|=\mu r_{N},\left\|m_{T}\right\|=\mu_{r} r_{N}$. Let us compute the normal cone to $K_{r}$ at $p$ :

$$
\mathrm{N}_{K_{r}}(p)=\left\{y=\lambda_{1}\left[\begin{array}{c}
-\mu  \tag{41}\\
\frac{r_{\mathrm{T}}}{\left\|r_{\mathrm{T}}\right\|} \\
0
\end{array}\right]+\lambda_{2}\left[\begin{array}{c}
-\mu_{r} \\
0 \\
\frac{m_{\mathrm{T}}}{\left\|m_{\mathrm{T}}\right\|}
\end{array}\right], \lambda_{1} \geq 0, \lambda_{2} \geq 0\right\}
$$

From $-\hat{y} \in \mathrm{~N}_{K}(p)$, we conclude

$$
\begin{equation*}
u_{\mathrm{T}}=\lambda_{1} \frac{r_{\mathrm{T}}}{\left\|r_{\mathrm{T}}\right\|}, \lambda_{1} \geq 0 \text { and } \omega_{\mathrm{T}}=\lambda_{2} \frac{m_{\mathrm{T}}}{\left\|m_{\mathrm{T}}\right\|}, \lambda_{2} \geq 0 \tag{42}
\end{equation*}
$$

Taking the norm of the expressions in (42) yields $\lambda_{1}=\left\|u_{\mathrm{T}}\right\|$ and $\lambda_{2}=\left\|\omega_{\mathrm{T}}\right\|$, and then $\left\|r_{\mathrm{T}}\right\| u_{\mathrm{T}}=$ $-\left\|u_{\mathrm{T}}\right\| r_{\mathrm{T}}$ and $\left\|m_{\mathrm{T}}\right\| \omega_{\mathrm{T}}=-\left\|\omega_{\mathrm{T}}\right\| m_{\mathrm{T}}$.

## 4. Maximum dissipation principle, optimization formulation and the bipotential method

Proposition 3.1 shows that the model of rolling friction is equivalent to a cone complementarity problem. In this section, we are interested in showing that the maximum dissipation principle can be deduced easily from the complementarity condition. In the formulation of the maximum dissipation principle for standard Coulomb friction, only the tangent variables $u_{\mathrm{T}}, r_{\mathrm{T}}$ are involved. With a single inclusion into the normal cone to $K_{r}$, it is also possible to write a maximum dissipation principle over the whole variable $y:=\left[u_{\mathrm{N}}, u_{\mathrm{T}}^{\top}, \omega_{\mathrm{T}}^{\top}\right]^{\top}$ and $p:=\left[r_{\mathrm{N}}, r_{\mathrm{T}}^{\top}, m_{\mathrm{T}}^{\top}\right]^{\top}$.

To state dissipation principles, the power of the contact reaction $p$ with the relative velocity $y$ is computed as $y^{\top} p$. In the sequel, we show that this power is equal to the dissipated power at contact and is maximal over the choice of $y$ and $p$. This principle is closely related to the notion of bipotential function that is introduced and computed at the end of the section.

If the problem (33) has a solution, then we have $\hat{y}^{\top} p=0$ by the complementarity condition. Coming back to the original variable $y$ and $p$, we get

$$
\begin{equation*}
-y^{\top} p=\left(\mu\left\|u_{\mathrm{T}}\right\|+\mu_{r}\left\|\omega_{\mathrm{T}}\right\|\right) r_{\mathrm{N}} \tag{43}
\end{equation*}
$$

which corresponds to the energy dissipation at contact by the friction forces and moments.
By maximizing the inner product of $\hat{y}$ and $p$ in (33), the following optimization problem can be written

$$
\begin{array}{ll}
\max _{\hat{y}, p} & -\hat{y}^{\top} p \\
\text { s.t. } & \hat{y} \in K_{r}^{\star}  \tag{44}\\
& p \in K_{r}
\end{array}
$$

The problem is feasible since $K_{r} \neq \emptyset$. Since $\hat{y} \in K_{r}^{\star}$ and $p \in K_{r}$, we have $-\hat{y}^{\top} p \leq 0$. The maximizer exists since the cost function is bounded from above. If the problem (33) has a solution, then it also solution of the optimization problem with $-\hat{y}^{\top} p=0$.

Let us now have a look at the rolling friction law in original variables $y$ and $p$. Using (34) and substituting $\hat{y}$ in the cost function, we get an equivalent optimization problem as

$$
\begin{align*}
\max _{y, p} & -\left(\mu\left\|u_{\mathrm{T}}\right\|+\mu_{r}\left\|\omega_{\mathrm{T}}\right\|\right) r_{\mathrm{N}}-y^{\top} p \\
\text { s.t. } & u_{\mathrm{N}} \geq 0  \tag{45}\\
& p \in K_{r} .
\end{align*}
$$

For a given value of $y$ such that $u_{\mathrm{N}}=0$ and a given value of $r_{\mathrm{N}} \geq 0$, the maximization problem (45) reduces to

$$
\begin{array}{ll}
\max _{r_{\mathrm{T}}, m_{\mathrm{T}}} & -r_{\mathrm{T}} u_{\mathrm{T}}-m_{\mathrm{T}} \omega_{\mathrm{T}} \\
\text { s.t. } & \left\|r_{\mathrm{T}}\right\| \leq \mu r_{\mathrm{N}}  \tag{46}\\
& \left\|m_{\mathrm{T}}\right\| \leq \mu_{r} r_{\mathrm{N}}
\end{array}
$$

The problem (46) corresponds to the maximum dissipation principle for the rolling friction problem.

Remark 1. The assumption of an associated law of friction yields the following model of rolling friction

$$
\begin{equation*}
K^{\star} \ni y \perp p \in K \Longleftrightarrow-y \in N_{K_{r}}(p) . \tag{47}
\end{equation*}
$$

This model has several drawbacks from the modeling point of view that can be listed:

- The first drawback is the dilatancy of the model when the contact slides and/or rolls ( $\left\|u_{T}\right\|>$ $\left.0,\left\|\omega_{T}\right\|>0\right)$. Indeed, we get from the definition of the normal cone in 39) that

$$
\begin{equation*}
u_{N}=\mu\left\|u_{t}\right\|+\mu_{r}\left\|\omega_{T}\right\|>0 \tag{48}
\end{equation*}
$$

In other words, the normal relative velocity is positive with sliding and/or rolling.

- The second drawback is the fact the model does not dissipate energy at contact. Indeed the orthogonality condition in 47), $y^{\top} p=0$ implies that the dissipation vanishes.

Let us now have a look how to define the bipotential for the rolling friction model. Firstly, let us recall now the definition of a bipotential in $\mathbb{R}^{n}$ with the standard scalar product.

Définition 4.1 (Bipotential mapping and extremal points [7]). Let $b: \mathbb{R}^{n} \times \mathbb{R}^{n} \mapsto \mathbb{R} \cup+\infty$ such that $v \mapsto b(v, f)$ and $f \mapsto b(v, f)$ are convex. This function is called a bipotential if

$$
\begin{equation*}
b\left(v^{\prime}, f^{\prime}\right) \geq v^{\prime \top} f^{\prime}, \quad v^{\prime} \in \mathbb{R}^{n}, f^{\prime} \in \mathbb{R}^{n} \tag{49}
\end{equation*}
$$

A couple $(v, f)$ is said to be extremal if it satisfies

$$
\begin{equation*}
b(v, f)=v^{\top} f \tag{50}
\end{equation*}
$$

For an extremal couple $(v, f)$, we verify easily that

$$
\begin{array}{ll}
b\left(v^{\prime}, f\right)-b(v, f) \geq f^{\top}\left(v^{\prime}-v\right), & \forall v^{\prime} \\
b\left(v, f^{\prime}\right)-b(v, f) \geq v^{\top}\left(f^{\prime}-f\right), & \forall f^{\prime} \tag{51}
\end{array}
$$

Using the definition of the subdifferential, the extremal couple satisfies

$$
\begin{equation*}
v \in \partial_{f} b(v, f), \text { and } f \in \partial_{v} b(v, f) \tag{52}
\end{equation*}
$$

The relations (51) and (52) can also be related to optimization problems. An extremal point is also a solution of

$$
\begin{equation*}
(v, f)=\operatorname{argmin} \quad b(v, f)-v^{\top} f \tag{53}
\end{equation*}
$$

since the cost function $b(v, f)-v^{\top} f$ is positive from 49) and vanishes at the extremal points from (50). Taking the optimality conditions of (53) we get 52 .

Coming back to the rolling friction problem and introducing $\mathrm{i}_{\mathbb{R}_{+}}$and $\mathrm{i}_{K_{r}}$, respectively the indicator functions of $\mathbb{R}_{+}$and $K_{r}$, the optimization problem 45) can be written as

$$
\begin{equation*}
\min _{y, p} \quad\left(\mu\left\|u_{\mathrm{T}}\right\|+\mu_{r}\left\|\omega_{\mathrm{T}}\right\|\right) r_{\mathrm{N}}+y^{\top} p+\mathrm{i}_{\mathbb{R}_{+}}\left(u_{\mathrm{N}}\right)+\mathrm{i}_{K_{r}}(p) \tag{54}
\end{equation*}
$$

By inspecting (53) and (54), we propose to define the bipotential for the rolling friction by taking $v=-y$ and $f=p$ and $b(-y, p):=\left(\mu\left\|u_{\mathrm{T}}\right\|+\mu_{r}\left\|\omega_{\mathrm{T}}\right\|\right) r_{\mathrm{N}}+\mathrm{i}_{\mathbb{R}_{+}}\left(u_{\mathrm{N}}\right)+\mathrm{i}_{K_{r}}(p)$.

Proposition 4.2. The mapping defined by

$$
\begin{equation*}
b(-y, p):=\left(\mu\left\|u_{T}\right\|+\mu_{r}\left\|\omega_{T}\right\|\right) r_{N}+\mathrm{i}_{\mathbb{R}_{+}}\left(u_{N}\right)+\mathrm{i}_{K_{r}}(p) \tag{55}
\end{equation*}
$$

is a bi-potential. Furthermore, an extremal point of $b$ satisfies the rolling friction problem 33.).
Proof: The mapping $p \mapsto b(-y, p)$ is the sum of a convex function as an indicator function of a convex set and a linear function. The mapping $-y \mapsto b(-y, p)$ is the sum of a convex function $\left(\mu\left\|u_{\mathrm{T}}\right\|+\mu_{r}\left\|\omega_{\mathrm{T}}\right\|\right) r_{\mathrm{N}}$ for $r_{\mathrm{N}}>0$ and the indicator function of $\mathbb{R}_{+}$. It remains to prove that

b\left(-y^{\prime}, q^{\prime}\right) \geq-y^{\prime \top} q^{\prime}, \quad \forall y^{\prime}, p^{\prime} \tag{56}
\end{equation*}

If $y^{\prime} \notin K_{r}^{\star}$ i.e. $u_{\mathrm{N}}<0$ or $p^{\prime} \notin K_{r}$, it is trivial. Let us assume that $y^{\prime} \in K_{r}^{\star}$ and $p^{\prime} \in K_{r}$. The bipotential is then reduced to

$\left(\mu\left\|u_{\mathrm{T}}^{\prime}\right\|+\mu_{r}\left\|\omega_{\mathrm{T}}^{\prime}\right\|\right) r_{\mathrm{N}}^{\prime} \geq\left\|u_{\mathrm{T}}^{\prime}\right\|\left\|r_{\mathrm{T}}^{\prime}\right\|+\left\|\omega_{\mathrm{T}}^{\prime}\right\|\left\|m_{\mathrm{T}}^{\prime}\right\| \geq\left\|u_{\mathrm{T}}^{\prime}\right\|\left\|-r_{\mathrm{T}}^{\prime}\right\|+\left\|\omega_{\mathrm{T}}^{\prime}\right\|\left\|-m_{\mathrm{T}}^{\prime}\right\| \geq-u_{\mathrm{T}}^{\prime \top} r_{\mathrm{T}}^{\prime}-\omega_{\mathrm{T}}^{\prime \top} m_{\mathrm{T}}^{\prime}$

Since $y^{\prime} \in K_{r}^{\star}$ and $p^{\prime} \in K_{r}$, we have also $-u_{n}^{\prime} r_{n}^{\prime} \geq 0$. The inequality 56 is then proved and $b$ is a bipotential.

Let us consider a solution of (33). Then the equation (43) is satisfied and we have $b(-y, p)=$ $-y^{\top} p$ so it is an extremal point. The first inclusion in 52 yields

## 5. Projected based numerical methods for solving rolling friction problems

Projected based numerical methods for solving standard Coulomb friction problem are based on reformulation of the complementarity condition as a projection operator. Let us first recall the following result.

Proposition 5.1 ([14]). Let $K$ a closed convex cone. Then $p=\operatorname{proj}_{K}(\bar{p})$ if and only if

K^{\star} \ni p-\bar{p} \perp p \in K \Longleftrightarrow-(p-\bar{p}) \in \mathrm{N}_{K}(p) \tag{60}
\end{equation*}

From the definition of the complementarity problem in Proposition 3.1 and the characterization of the projection in Proposition 5.1. we get the following equivalence

The last term is an equality formulation of the complementarity problem based on the natural map [11]. This equation is prone to the development of numerical method based on fixed-point iterations or semi-smooth Newton techniques [1].

Let us assume that the local relative velocity $y$ is related to the reaction torque $p$ by a linear relation of the form

This relation can be obtained from the linearization of quasi-static balance equations or the timediscretization and a linearization of equations of motion and a reduction to local variables (see [3, 4)

Altogether, we obtain a nonlinear cone complementarity to solve:

\hat{y}=y+g(y) \\
K_{r}^{\star} \ni \hat{y} \perp p \in K_{r}
\end{array}\right.
$$

where $g(y)=\left[\mu\left\|u_{\mathrm{T}}\right\|+\mu_{r}\left\|\omega_{\mathrm{T}}\right\|, 0,0,0,0\right]^{\top}$. This problem is usually a nonsmooth and nonlinear complementarity problem for which it is rather difficult to state very general result of existence and uniqueness. Nevertheless, existence results should follow the line in [5].

For a finite set of $n_{c}$ contact points and their associated local frames, it is possible to write exactly the same problem as in where $y \in \mathbb{R}^{5 n_{c}}, p \in \mathbb{R}^{5 n_{c}}$ collects the contact variables for each contacts, $K_{r}^{\star} \subset \mathbb{R}^{5 n_{c}}$ and $K_{r} \subset \mathbb{R}^{5 n_{c}}$ are the Cartesian product of local contact cones and $W \in \mathbb{R}^{5 n_{c} \times 5 n_{c}}, q \in \mathbb{R}^{5 n_{c}}, \mu \in \mathbb{R}^{n_{c}}$ are the problem data.

### 5.1. Projected fixed point techniques

Projected fixed point techniques are standard methods to solve non-linear variational inequalities, and especially, complementarity problems. The method is based on the following iterations

$$
\begin{equation*}
p_{k+1} \leftarrow \operatorname{proj}_{K_{r}}\left(p_{k}-\rho_{k}\left(W p_{k}+q+g\left(W p_{k}+q\right)\right)\right), \tag{64}
\end{equation*}
$$

with $\rho_{k}>0$. The fact that the projection is given in closed form in the sequel, is crucial for the implementation of the method that will not be related to an optimization at each iteration. The method can be improved by using the so-called extra-gradient algorithm :

with $\rho_{k}>0$. The choice of $\rho_{k}$ is also important for the convergence and the efficiency of the method. Some self-adaptive rule that try to guess the Lipschitz constant of $p \mapsto W p+q+g(W p+q)$ are available in the literature. For more details in the context of contact friction problems, we refer to [1].

### 5.2. Block-splitting techniques

As in the standard Gauss-Seidel technique for frictional contact problems [18, 19], a way to improve the efficiency of the projected fixed methods is to perform a block splitting of the matrix $W$ contact by contact. The linear relation $\sqrt[62]{ }$ for a contact $\alpha \in \llbracket 1, n_{c} \rrbracket$ reads as

With provisional values for $p^{\beta}, \beta \in \llbracket 1, n_{c} \rrbracket, \beta \neq \alpha$, a one-contact problem

$$
\left\{\begin{array}{l}
y^{\alpha}=W^{\alpha \alpha} p^{\alpha}+\bar{q}^{\alpha},  \tag{67}\\
\hat{y}^{\alpha}=y^{\alpha}+g\left(y^{\alpha}\right) \\
K_{r}^{\alpha, \star} \ni \hat{y}^{\alpha} \perp p^{\alpha} \in K_{r}^{\alpha}
\end{array}\right.
$$

is formulated with $\bar{q}^{\alpha}=q^{\alpha}+\sum_{\beta \in \llbracket 1, n_{c} \rrbracket, \beta \neq \alpha} W^{\alpha \beta} p^{\beta}$. This problem can be solved with fixed iterations solvers described in Section 5.1. The Gauss-Seidel technique is based on iterating over the contact points.

### 5.3. Closed-form formulae for the projection onto the rolling friction cone

As it can observed in the previous sections, a key element of the projected based numerical methods is the computation of the projection on $K_{r}$. This computation must be efficient and a closed-form formulae for the projection is not straightforward. In this section, we derive it in the following proposition using Convex Analysis tools.

Proposition 5.2. The projection onto $K_{r}$ of a vector $\bar{p}=\left[\bar{r}_{N}, \bar{r}_{T}^{\top}, \bar{m}_{T}^{\top}\right]^{\top}$ denoted by $p=\operatorname{proj}_{K_{r}}(\bar{p})$ is given by

1. if $\bar{p} \in K_{r}$, then $p=\operatorname{proj}_{K_{r}}(\bar{p})=\bar{p}$,
2. if $-\bar{p} \in K_{r}^{\star}$ then $p=\operatorname{proj}_{K_{r}}(\bar{p})=0$,
3. if $\mu r_{N}-\left\|\bar{r}_{T}\right\|<0$ and $\mu_{r} r_{N}-\left\|\bar{m}_{T}\right\|<0$ with $r_{N}=\frac{\bar{r}_{N}+\mu\left\|\bar{r}_{T}\right\|+\mu_{r}\left\|\bar{m}_{T}\right\|}{1+\mu^{2}+\mu_{r}^{2}}$, then

\end{array}\right]
$$

4. if $\mu r_{N}-\left\|\bar{r}_{T}\right\|<0$ and $\mu_{r} r_{N}-\left\|\bar{m}_{T}\right\|>0$ with $r_{N}=\frac{\bar{r}_{N}+\mu\left\|\bar{r}_{T}\right\|}{1+\mu^{2}}$, then

m_{T}=\bar{m}_{T}
\end{array}\right] .

5. if $\mu_{r} r_{N}-\left\|\bar{m}_{T}\right\|<0$ and $\mu r_{N}-\left\|\bar{r}_{T}\right\|>0$ with $r_{N}=\frac{\bar{r}_{N}+\mu_{r}\left\|\bar{m}_{T}\right\|}{1+\mu_{r}^{2}}$, then

p=\operatorname{proj}_{K_{r}}(\bar{p})=\left[\begin{array}{c}
r_{N}=\frac{\bar{r}_{N}+\mu_{r}\left\|\bar{m}_{T}\right\|}{1+\mu_{r}^{2}}  \tag{70}\\
r_{T}=\bar{r}_{T} \\
m_{T}=\mu_{r} r_{N} \frac{\bar{m}_{T}}{\left\|\bar{m}_{T}\right\|}
\end{array}\right]
$$

Proof: For the proof, we extensively use the characterization of the projection by complementarity given in Proposition 5.1. Let us distinguish the various cases

1) $\bar{p} \in K_{r}$, then the projection $p=\bar{p}$ satisfies the condition trivially.
2) $\bar{p} \in K_{r}^{\mathrm{o}}$, then the projection $p=0$ satisfies the condition trivially.

Let us now consider the case where $\bar{p} \notin K_{r}$ and $\bar{p} \notin K_{r}^{\circ}$. We know that the projection will lie the boundary of $K_{r}$ denoted by $\partial K_{r}$ with $r_{\mathrm{N}}>0$. The case $r_{\mathrm{N}}=0$ is excluded by contradiction : if $r_{n}=0$, then $p=0$, and by $28, \bar{p} \in K_{r}^{\star}$.

We have three options depending on the faces of the boundary on which we project:

- $r_{\mathrm{N}}>0,\left\|r_{\mathrm{T}}\right\|=\mu r_{\mathrm{N}}$ and $\left\|m_{\mathrm{T}}\right\|<\mu_{r} r_{\mathrm{N}}$,
- $r_{\mathrm{N}}>0,\left\|m_{\mathrm{T}}\right\|=\mu_{r} r_{\mathrm{N}}$ and $\left\|r_{\mathrm{T}}\right\|<\mu r_{\mathrm{N}}$,
- $r_{\mathrm{N}}>0,\left\|r_{\mathrm{T}}\right\|=\mu r_{\mathrm{N}}$ and $\left\|m_{\mathrm{T}}\right\|=\mu_{r} r_{\mathrm{N}}$.

3) $r_{N}>0, \mu r_{N}-\left\|\bar{r}_{T}\right\|<0$ and $\mu_{r} r_{N}-\left\|\bar{m}_{T}\right\|<0$. Let us assume for a while that $\left\|r_{\mathrm{T}}\right\|=\mu r_{\mathrm{N}}$ and $\left\|m_{\mathrm{T}}\right\|=\mu_{r} r_{\mathrm{N}}$. From the normal cone definition, the inclusion $-(p-\bar{p}) \in \mathrm{N}_{K_{r}}(p)$ implies

From the first expression in (71), we get

Since $\lambda_{1} \geq 0$, the vectors are colinear and in the same direction. Since $\left\|r_{\mathrm{T}}\right\|=\mu r_{\mathrm{N}}$, we obtain $r_{\mathrm{T}}=\mu r_{\mathrm{N}} \frac{\bar{r}_{\mathrm{T}}}{\left\|\bar{r}_{\mathrm{T}}\right\|}$. The same manipulations can be made for the second expression in 71) leading to

& =r_{\mathrm{N}}^{2}\left(1+\mu^{2}+\mu_{r}^{2}\right)-r_{\mathrm{N}} \bar{r}_{\mathrm{N}}-r_{\mathrm{T}}^{\top} \bar{r}_{\mathrm{T}}-m_{\mathrm{T}}^{\top} \bar{m}_{\mathrm{T}} .
\end{align*}
$$

Substituting (73) in 74, we obtain

& =r_{\mathrm{N}}\left(r_{\mathrm{N}}\left(\left(1+\mu^{2}+\mu_{r}^{2}\right)\right)-\left(\bar{r}_{\mathrm{N}}+\mu\left\|\bar{r}_{\mathrm{T}}\right\|+\mu_{r}\left\|\bar{m}_{\mathrm{T}}\right\|\right)\right)
\end{align*}
$$

and then, for $r_{\mathrm{N}}>0$,

Let us check now that $p-\bar{p} \in K_{r}^{\star}$. Since $0=p^{\top}(p-\bar{p})$, we must have $p-\bar{p} \in \partial K_{r}^{\star}$, that is

On the other side, we get using 73 )

This assumption means that the value $\left\|\bar{m}_{\mathrm{T}}\right\|$ and $\left\|\bar{r}_{\mathrm{T}}\right\|$ must be outside the disks of radius $\mu r_{\mathrm{N}}$ and $\mu_{r} r_{\mathrm{N}}$, where $r_{\mathrm{N}}$ is the forecast value given by 76 .
4) $r_{N}>0,\left\|r_{T}\right\|=\mu r_{N}$ and $\left\|m_{T}\right\|<\mu_{r} r_{N}$. Let us assume for a while that $\left\|r_{\mathrm{T}}\right\|=\mu r_{\mathrm{N}}>0$ and $m_{\mathrm{T}}=\bar{m}_{\mathrm{T}}$. From $-(p-\bar{p}) \in \mathrm{N}_{K_{r}}(p)$, we conclude as before

r_{\mathrm{N}}-\bar{r}_{\mathrm{N}}=\mu\left(\left\|\bar{r}_{\mathrm{T}}\right\|-\mu r_{\mathrm{N}}\right) \tag{86}
\end{equation*}

On the other side we get

\mu\left\|r_{\mathrm{T}}-\bar{r}_{\mathrm{T}}\right\|+\mu_{r}\left\|m_{\mathrm{T}}-\bar{m}_{\mathrm{T}}\right\|=\mu\left\|r_{\mathrm{T}}-\bar{r}_{\mathrm{T}}\right\|=\mu \mid \mu r_{\mathrm{N}}-\left\|\bar{r}_{\mathrm{T}}\right\| \| \tag{87}
\end{equation*}

If the assumption

is satisfied, then the equality 60 holds.
5) $r_{N}>0,\left\|r_{T}\right\|<\mu r_{N}$ and $\left\|m_{T}\right\|=\mu_{r} r_{N}$. Doing as in the previous case, we get the definition of the projection.

## 6. Applications of the rolling friction model

In this section, the abilities of the rolling friction model to dissipate energy by friction and/or rolling friction are illustrated on simple numerical examples. The simulations have been realized with the Moreau-Jean time-stepping scheme [17, 3] based on a $\theta$-method for the smooth terms and the projected Gauss-Seidel presented in Section 5.2 for the discrete frictional contact problems. The numerical methods are implemented in the Siconos software v4.3.0 [2] and are freely available together with the simulation scripts.

### 6.1. A sphere rolling on a plane

The problem of a sphere of radius $R$ rolling on a plane with initial tangential and rotational velocities is chosen to illustrate the predictive capacity of the rolling friction model compared with the classical friction one. The sphere is initially located on an horizontal planar surface with a tangential velocity $U_{X}(t=0)$ and a rotational velocity $\Omega_{Y}(t=0)$. The simulation has been made with $\theta=1 / 2$ for the parameter of the Moreau-Jean scheme, a time-step of $10^{-4} s$ and a relative tolerance of the Gauss-Seidel algorithm of $10^{-12}$.

Under these conditions, the sphere does not stop to roll with a classical friction model. In the case of initial sliding at the contact point $u_{\mathrm{T}}(0)>0$, the norm of the tangential reaction $\left\|r_{\mathrm{T}}\right\|$ is equal to $\mu r_{n}$ and is in the opposite direction to $u_{\mathrm{T}}$, which induces a decrease of the sliding velocity till the slip-free rolling condition $u_{\mathrm{T}}(t)=U_{X}(t)-R \Omega_{Y}(t)=0$ is reached. Once this condition is reached, $r_{\mathrm{T}}$ jumps to 0 and the sphere velocities $U_{x}$ and $\Omega_{Y}$ are constant, which prevents the sphere to stop.

The rolling friction model is first investigated for initial sphere velocities fulfilling the slipfree rolling conditions $\left(U_{X}(0)-R \Omega_{Y}(0)=0\right)$. In this case, the maximum propagation distance $X_{m a x}$ reached by the sphere depends on both the friction $(\mu)$ and of the rolling friction $\left(\mu_{r}\right)$ coefficients (see Figure 2). For $\mu_{r} \rightarrow 0$, as expected, the stopping distance goes to infinity. Similarly, large propagation distances are observed for $\mu \rightarrow 0$. Indeed, although the resistive moment $m_{\mathrm{T}}$ progressively reduces the sphere rotational velocity, the small values of $r_{\mathrm{T}}$ do not allow to reduce $U_{X}$ which finally entails block sliding without rotational velocity. The propagation distance is strongly influenced by the values of $\mu$ and $\mu_{r}$ for $\mu \in[0,0.15]$ and $\mu_{r} \in[0,0.01]$. In this domain, $X_{\max }$ strongly decreases if $\mu$ or $\mu_{r}$ increase. For larger values of both $\mu$ and $\mu_{r}$, the propagation distance is much less sensitive to these coefficients.

We choose to illustrate the details of the rolling friction model behavior through three representative configurations. The first configuration (Figure 3 a ) corresponds to initial slip-free rolling conditions with large values of both $\mu$ and $\mu_{r}$. The resistive moment $m_{\mathrm{T}}$ entails a decrease in both $U_{X}$ and $\Omega_{Y}$ and the slip-free condition is conserved (Figure 3 ) till the sphere stops. The second configuration is very simlar to the first one, except that slippage initially occurs at the contact

point (Figure 3b), which results in velocities changes before reaching the slip-free condition. Afterwards, the decrease in both $U_{X}$ and $\Omega_{Y}$ entails sphere stopping. At the transition from slippage to slip-free rolling condition, the tangential force jumps from $\left\|r_{\mathrm{T}}\right\|=\mu r_{n}$ to $\left\|r_{\mathrm{T}}\right\|<\mu r_{n}$. Let us note that $r_{\mathrm{T}}$ does no vanish as in the case of standard friction without rolling resistance. The third example (Figure 3 c) illustrates the case where the rotational velocity vanishes $\Omega_{Y}$ before the sphere stopping because $\mu$ is small compared to $\mu_{r}$. In this case, the vanishing of $\Omega_{Y}$ induces a jump of the resitive moment from $\left\|m_{\mathrm{T}}\right\|=\mu_{r} r_{n}$ to $\left\|m_{\mathrm{T}}\right\|<\mu_{r} r_{n}$.

### 6.2. Spheres piles

In this section, the interest of the rolling friction model for the simulation of a granular material made of spheres is illustrated. To this end, we consider a small sample of 250 spheres of diameter $\phi=0.02 m$, dropped at a constant rate from a constant height of $10 \phi$ on a square fixed rigid plane of $60 \phi$ width. To avoid the constitution of artificial columns in the sample, the initial horizontal coordinates of the spheres are randomly sampled in the range $[-\phi / 2 ; \phi / 2]$. The density of the spheres is $1300 \mathrm{~kg} \cdot \mathrm{~m}^{-3}$, the gravity is equal to $9.81 \mathrm{~m} \cdot \mathrm{~s}^{-2}$ and the coefficient of restitution is equal to 0 . The campaign of simulations was carried out with three values of the coefficient of friction $\mu \in\{0.1,0.3,1.0\}$ and with values of the coefficient of rolling friction ranging in $\left[10^{-5}, 1\right]$. The simulation has been made with $\theta=1$ for the parameter of the Moreau-Jean scheme, a time-step of $10^{-3} s$ over a time interval of $20 s$, and a relative tolerance of the Gauss-Seidel algorithm of $10^{-4}$.

In Figure 4, the final state of the pile when the kinetic energy vanishes is depicted for different values of the coefficients of friction. We can observe that the height and the width of the pile depend

strongly on both coulomb's friction and rolling friction. In Figure 5, some measurements of the height of the pile and its mean radius are reported. The mean radius of the pile is computed by selecting the spheres that are in contact with the horizontal surface, which constitute the bottom of the pile. The centroid of the assembly of these spheres is computed in the horizontal plane and the mean radius is the average distance to the centroid of these spheres. In Figure 5(a), the height of the pile is plotted with respect to the coefficient of rolling friction $\mu_{r}$ for the three values of the coefficient of friction $\mu$. As expected, the height of the pile is generally increasing with the coefficient of rolling friction since the spheres are subjected to the rolling resistance torque. Three regimes can be observed for all the values of the coefficient of friction $\mu$. In a first regime, for low coefficients of rolling friction, the ratio between the height and the diameter is equal to one, meaning that there is no superposition of spheres. In a second regime, after a critical value of the rolling friction coefficient, the height of the pile quickly increased up to a third regime where the height of the pile is stabilized around a value that does not depend on the coefficient of rolling friction. In this third regime, the height of the pile is higher when the coefficient of friction increases. This can be explained by the fact that for too small friction coefficients, the spheres in contact with the plane slide under the action of the weight of the pile. If the coefficient of friction increases, the slope angle of the pile is higher as it is illustrated on Figures 4(a)-(c)-(e). Let us note that the graph of the height with respect to the coefficient of rolling friction is not strictly monotone. This is mainly due to the random character of the building of the pile that may generate avalanches of the spheres that are not really controlled by the process (as it can be seen in Figure 4(d)). The mean radius of the piles plotted in Figure 5(a) corroborates the observation on the height of the pile. We observe that the mean radius of the bottom of the pile quickly decreases in the second regime and is stable in the third regime.

## 7. Conclusion

In this article, the model of Coulomb's friction with unilateral contact is enriched with a resistance to rolling that is proportional to the normal pressure. With the goal of designing a tractable model from the computational point of view, the model is formulated as a cone complementarity problem over a single rolling friction cone. To this aim a modified relative velocity at contact has been introduced following the seminal work in [8]. The formulation is proved to be equivalent to the disjunctive form of the model and the model with three separate inclusions. The principle of maximal dissipation and the bipotential function have been delineated for the rolling friction, that allows us to understand the dissipation generated by the model. Two projected based numerical methods are given that are based on the projection onto the rolling friction cone. We give a closed-form formulae of the projection that is crucial for the efficiency of these numerical

methods. The abilities of the model and the numerical techniques are shown on two examples of a sphere rolling on a plane and the study of a granular sample made of spherical particles.
