## Equivalence of local-best and global-best approximations in $\boldsymbol{H}(\operatorname{curl})^*$

#### Abstract

We derive results on equivalence of piecewise polynomial approximations of a given function in the Sobolev space H(curl). We namely show that the global-best approximation of a given H(curl) function in a H(curl)-conforming piecewise polynomial space imposing the continuity of the tangential trace can be bounded above and below by the Hilbertian sum of the respective local approximations from the elementwise spaces without any inter-element continuity requirement. In other words, the approximation of a H(curl) function by tangential-trace-continuous and discontinuous piecewise polynomials has comparable precision. We consider approximations of the curl of the target function in the  $L^2$ -norm, as well as approximations of the target function in the  $L^2$ -norm with a constraint on the curl; in the latter case, the constraint is removed in the local approximations. These best-approximation localizations hold under the minimal H(curl) regularity, on arbitrary shape-regular tetrahedral meshes, and involve imposition of conditions on a part of the boundary. They extend to the H(curl) context some recent results from the  $H^1$  and H(div) spaces and have direct applications to a priori and a posteriori error analysis of numerical discretizations related to the H(curl) space, namely the Maxwell equations.

**Key words:** Sobolev space H(curl), tangential trace continuity, minimal regularity, constrained approximation, unconstrained approximation, a priori error estimate, a posteriori error estimate, finite element method, edge elements

#### 1 Introduction

Let  $\Omega \subset \mathbb{R}^3$  be an open, Lipschitz, simply-connected polyhedron. Let  $v \in H^1(\Omega)$  be given, together with a polynomial degree  $p \geq 1$  and a tetrahedral mesh of  $\Omega$  (see below in Section 2 for the details of the notation and setting we use). Then the error in the approximation of the function v by trace-continuous ( $H^1(\Omega)$ -conforming) piecewise p-degree polynomials is up to a generic constant equivalent to the approximation of v by discontinuous (no inter-element continuity required) piecewise p-degree polynomials. This result was first formulated by Veeser [33], extending some earlier contributions by Carstensen  $et\ al.\ [8$ , Theorem 2.1 and inequalities (3.2), (3.5), and (3.6)] and Aurada  $et\ al.\ [3$ , Proposition 3.1]. Bank and Yserentant [5] have obtained a similar result where, however, the target function has to be smoother than  $H^1(\Omega)$  and a sufficiently refined mesh is needed; further extensions are presented in Veeser [34] and Tantardini  $et\ al.\ [32]$ . We recall this result in details in Corollary 3.1 below.

Similarly, let  $v \in H(\operatorname{div}, \Omega)$  be given. Then the error in the approximation of the function v by normal-trace-continuous  $(H(\operatorname{div}, \Omega)\text{-conforming})$  piecewise polynomials with a divergence constraint is up to a generic constant equivalent to the approximation of v by discontinuous (no inter-element continuity required) piecewise polynomials without any divergence constraint. This result was recently obtained in Ern et al. [17], in the philosophy of the above  $H^1(\Omega)$ -result, cf. also [9] for some early ideas on the removal

of the divergence constraint. In Bank and Ovall [4], again a sufficiently smooth target function and a sufficiently refined mesh are needed for a similar result. We recall this result in details in Corollary 3.2 below.

The two results above are fundamental with numerous direct applications to a priori and a posteriori error analysis related to the  $H^1(\Omega)$  and  $H(\operatorname{div},\Omega)$  spaces. To the best of our knowledge, such a result is not available for the Sobolev space  $H(\operatorname{curl},\Omega)$ , and it is our purpose to obtain it here. We actually show that it can be easily derived from the two above ones. Indeed, in addition to Corollaries 3.1 and 3.2, we will merely use the fundamental properties that 1) each function from the  $H^1(\Omega)$  space whose weak gradient vanishes is a real constant; 2) each function from the  $H(\operatorname{curl},\Omega)$  space whose weak curl vanishes is a gradient of a function from  $H^1(\Omega)$ ; and 3) each function from the  $H(\operatorname{div},\Omega)$  space whose weak divergence vanishes is a curl of a function from  $H(\operatorname{curl},\Omega)$ , which is summarized in the exact sequence

$$\mathbb{R} \hookrightarrow H^1(\Omega) \xrightarrow{\nabla} \boldsymbol{H}(\operatorname{curl}, \Omega) \xrightarrow{\nabla \times} \boldsymbol{H}(\operatorname{div}, \Omega) \xrightarrow{\nabla \cdot} L^2(\Omega), \tag{1.1}$$

see, e.g., Arnold *et al.* [2] and the references therein; we will also consider discrete versions of (1.1) and imposition of conditions on a part of the boundary in (1.1), which can be accommodated following Girault and Raviart [23], Fernandes and Gilardi [22], and the references therein.

The question of equivalence of local-best and global-best approximations is related to (quasi-)interpolation operators. The canonical  $H(\text{curl},\Omega)$  interpolation operator [7, 27] maps any function that is sufficiently smoother than  $H(\text{curl}, \Omega)$  to a piecewise polynomial, finite-dimensional Nédélec [27] subspace of  $H(\text{curl},\Omega)$  via prescribing degrees of freedom. The canonical interpolation operator is heavily used but its main deficiency is that it cannot be applied to a function only having the minimal  $H(\text{curl}, \Omega)$  regularity. This can, for instance, be overcome via mollification, see Schöberl [29, 30], Christiansen and Winther [11], Falk and Winther [21], Ern and Guermond [18], or Licht [24]; employing integral moments in the spirit of the Clément [13] or Scott-Zhang [31] interpolation operator, cf. Bernardi and Hecht [6]; by splitting of the target function and its curl into a regular part and a gradient as in Ciarlet [12]; or employing local projections and averaging as in Ern and Guermond [19]. A special care has to be taken if approximation properties both in the mesh size h and the polynomial degree p are important, see, e.g., Demkowicz and Buffa [16], Demkowicz [15], and most recently Melenk and Rojik [25]; we do not address this point here. One of the main uses of (quasi-)interpolation operators is to derive optimal a priori error estimates in numerical approximations; for the application of the above results in the context of the Maxwell equations (cf. Monk [26]) under low regularity, we refer to Ciarlet [12], Ern and Guermond [20], and the references therein. Our main results, Theorems 4.1 and 4.2, can immediately be used for this purpose, and this under the minimal  $H(\text{curl},\Omega)$  regularity, on arbitrary shape-regular tetrahedral meshes, and for essential conditions only imposed on a part of the boundary. More generally, our results can serve as building blocks for developments of minimal-regularity quasi-interpolation operators in a priori error analysis, and they also provide sharper and simpler characterization of equivalence classes used in convergence and optimality proofs of finite element schemes using a-posteriori-steered mesh refinement, cf. the discussion in [33] and the references therein.

This contribution is organised as follows. In Section 2, we introduce the continuous- and discrete-level spaces we work with. In Section 3, we recall the known  $H^1(\Omega)$  and  $H(\operatorname{div},\Omega)$  local-global equivalences from [33] and [17], respectively. Section 4 introduces our two main results, the equivalences of global- and local-best approximations in  $H(\operatorname{curl},\Omega)$ , in the  $L^2(\Omega)$ -norm for the curl without any constraint and in the  $L^2(\Omega)$ -norm with a constraint on the curl. Finally, Appendix A extends an important technical result on constrained-unconstrained equivalence on a tetrahedron of [17, Lemma A.1], based on Costabel and McIntosh [14, Proposition 4.2], to the  $H(\operatorname{curl},\Omega)$  setting.

#### 2 Setting and notation

This section introduces continuous- and discrete-level functional spaces we will be working with.

#### 2.1 Basic continuous-level spaces

We denote by  $L^2(\Omega)$  the space of square-integrable functions defined on  $\Omega$  and we set  $L^2(\Omega) := [L^2(\Omega)]^3$ .  $H^1(\Omega)$  is the space of scalar-valued  $L^2(\Omega)$  functions with weak gradients in  $L^2(\Omega)$ ,  $H^1(\Omega) := \{v \in \mathbb{R} \mid v \in \mathbb{R}$ 

 $L^2(\Omega)$ ;  $\nabla v \in L^2(\Omega)$ }. We refer the reader to [1] for an in-depth description of these spaces. Next,  $\boldsymbol{H}(\operatorname{curl},\Omega)$  is the space of vector-valued  $\boldsymbol{L}^2(\Omega)$  functions with weak curls in  $\boldsymbol{L}^2(\Omega)$ ,  $\boldsymbol{H}(\operatorname{curl},\Omega) := \{\boldsymbol{v} \in \boldsymbol{L}^2(\Omega); \nabla \times \boldsymbol{v} \in \boldsymbol{L}^2(\Omega)\}$ . We will also need  $\boldsymbol{H}(\operatorname{div},\Omega)$ , the space of vector-valued  $\boldsymbol{L}^2(\Omega)$  functions with weak divergences in  $L^2(\Omega)$ ,  $\boldsymbol{H}(\operatorname{div},\Omega) := \{\boldsymbol{v} \in \boldsymbol{L}^2(\Omega); \nabla \cdot \boldsymbol{v} \in L^2(\Omega)\}$ . Finally, let  $\boldsymbol{H}^1(\Omega) := \{\boldsymbol{v} \in \boldsymbol{L}^2(\Omega); \boldsymbol{v}_i \in H^1(\Omega), i = 1, \ldots, 3\}$ . The reader will find a complete description of this vector-valued Sobolev spaces in [23]. Below, we denote by  $\|\cdot\|_{\omega}$  the  $L^2(\omega)$  or  $\boldsymbol{L}^2(\omega)$  norm; we drop the index when  $\omega = \Omega$ .

#### 2.2 Continuous-level spaces with conditions on a part of the boundary

In the sequel, we will allow for prescribing boundary conditions on part of the boundary  $\partial\Omega$ . Let  $\Gamma_D$ ,  $\Gamma_N$  be two disjoint open, possibly empty, subsets of  $\partial\Omega$  such that  $\partial\Omega = \overline{\Gamma_D} \cup \overline{\Gamma_N}$ ; moreover, each boundary face of the mesh defined below is requested to lie entirely either in  $\overline{\Gamma_D}$  or in  $\overline{\Gamma_N}$ . Then  $H^1_{0,D}(\Omega)$  is the the subspace of  $H^1(\Omega)$  formed by functions vanishing on  $\Gamma_D$  in the sense of traces,  $H^1_{0,D}(\Omega) := \{v \in H^1(\Omega); v = 0 \text{ on } \Gamma_D\}$ . In particular,  $H^1_{0,D}(\Omega) = H^1(\Omega)$  when  $\Gamma_D = \emptyset$ . Let T = D or N; then  $H_{0,T}(\text{curl},\Omega)$  is the subspace of  $H(\text{curl},\Omega)$  formed by functions with vanishing tangential trace on  $\Gamma_T$ ,  $H_{0,T}(\text{curl},\Omega) := \{v \in H(\text{curl},\Omega); v \times n = 0 \text{ on } \Gamma_T\}$ , where  $v \times n = 0$  on  $\Gamma_T$  means that  $(\nabla \times v, \varphi) - (v, \nabla \times \varphi) = 0$  for all functions  $\varphi \in H^1(\Omega)$  such that  $\varphi \times n = 0$  on  $\partial\Omega \setminus \Gamma_T$ . Finally,  $H_{0,N}(\text{div},\Omega)$  is the subspace of  $H(\text{div},\Omega)$  formed by functions with vanishing normal trace on  $\Gamma_N$ ,  $H_{0,N}(\text{div},\Omega) := \{v \in H(\text{div},\Omega); v \cdot n = 0 \text{ on } \Gamma_N\}$ , where  $v \cdot n = 0$  on  $\Gamma_N$  means that  $(v, \nabla \varphi) + (\nabla \cdot v, \varphi) = 0$  for all functions  $\varphi \in H^1_{0,D}(\Omega)$  ( $H_{0,D}(\text{div},\Omega)$ ) will also occasionally be used). We refer the reader to [22] for a thorough characterization of tangential (respectively normal) traces of  $H(\text{curl},\Omega)$  (resp.  $H(\text{div},\Omega)$ ) on a part of the boundary.

#### 2.3 Tetrahedral mesh

Let  $\mathcal{T}_h$  be a simplicial mesh of the domain  $\Omega$ , i.e.,  $\bigcup_{K \in \mathcal{T}_h} K = \overline{\Omega}$ , any element  $K \in \mathcal{T}_h$  is a tetrahedron with nonzero measure, and the intersection of two different tetrahedra is either empty, a vertex, an edge, or a face; all these geometrical objects are supposed to be closed. As mentioned above, we assume that each boundary mesh face is entirely contained either in  $\overline{\Gamma}_D$  or in  $\overline{\Gamma}_N$ . The shape-regularity parameter of the mesh  $\mathcal{T}_h$  is the positive real number

$$\kappa_{\mathcal{T}_h} := \max_{K \in \mathcal{T}_h} \frac{h_K}{\rho_K},$$

where  $h_K$  is the diameter of the tetrahedron K and  $\rho_K$  is the diameter of the largest ball contained in K.

#### 2.4 Discrete-level spaces

Let an integer  $p \geq 0$  and a tetrahedron  $K \in \mathcal{T}_h$  be fixed. We denote by  $\mathbb{P}_p(K)$  the space of scalar-valued polynomials on K of total degree at most p and by  $[\mathbb{P}_p(K)]^3$  is the space of vector-valued polynomials on K whose each component lies in  $\mathbb{P}_p(K)$ . The Nédélec [7, 27] space of degree p on K is then given by

$$\mathbf{N}_p(K) := [\mathbb{P}_p(K)]^3 + \mathbf{x} \times [\mathbb{P}_p(K)]^3. \tag{2.1}$$

Similarly, the Raviart–Thomas [7, 28] space of degree p on K is given by

$$\mathbf{RT}_{p}(K) := [\mathbb{P}_{p}(K)]^{3} + \mathbb{P}_{p}(K)\mathbf{x}; \tag{2.2}$$

we note that (2.1) and (2.2) are equivalent to the writing with a direct sum and only homogenous polynomials in the second term. We will extensively use below the broken, piecewise polynomial spaces formed from these element spaces

$$\mathbb{P}_p(\mathcal{T}_h) := \{ v_h \in L^2(\Omega); v_h|_K \in \mathbb{P}_p(K) \quad \forall K \in \mathcal{T}_h \}, 
\mathbf{N}_p(\mathcal{T}_h) := \{ \mathbf{v}_h \in \mathbf{L}^2(\Omega); \mathbf{v}_h|_K \in \mathbf{N}_p(K) \quad \forall K \in \mathcal{T}_h \}, 
\mathbf{R} \mathbf{T}_p(\mathcal{T}_h) := \{ \mathbf{v}_h \in \mathbf{L}^2(\Omega); \mathbf{v}_h|_K \in \mathbf{R} \mathbf{T}_p(K) \quad \forall K \in \mathcal{T}_h \}.$$

Finally, to form the usual finite-dimensional subspaces of the spaces of Sections 2.1 and 2.2, we will write  $\mathbb{P}_p(\mathcal{T}_h) \cap H^1(\Omega)$  (for  $p \geq 1$ ),  $N_p(\mathcal{T}_h) \cap H(\text{curl}, \Omega)$ ,  $RT_p(\mathcal{T}_h) \cap H(\text{div}, \Omega)$  (for  $p \geq 0$ ), and similarly subspaces reflecting the different boundary conditions.

## 3 Equivalence of local-best and global-best approximations in $H^1$ and H(div)

We recall here the known  $H^1(\Omega)$ - and  $\boldsymbol{H}(\operatorname{div},\Omega)$ -local/global equivalences from [33] and [17], respectively. Hereafter, we will use the notation  $a \lesssim b$  when there exists a positive real constant C such that  $a \leq Cb$ . Similarly,  $a \approx b$  means that  $a \lesssim b$  and  $b \lesssim a$  simultaneously. The possible dependencies of C will always be explicitly stated.

#### 3.1 The $H^1$ case

The following result can be easily seen along the lines of [33, Corollaries 1 and 2], where  $\Gamma_D = \partial \Omega$  or  $\Gamma_D = \emptyset$  is considered

Corollary 3.1 (Equivalence of local-best and global-best approximations in  $H^1$ ). Let  $p \geq 1$ . Then there exists a constant only depending on the mesh shape-regularity  $\kappa_{\mathcal{T}_h}$  of the mesh  $\mathcal{T}_h$  and the polynomial degree p such that for any  $v \in H^1_{0,D}(\Omega)$ ,

$$\min_{v_h \in \mathbb{P}_p(\mathcal{T}_h) \cap H^1_{0,\mathcal{D}}(\Omega)} \|\nabla(v - v_h)\|^2 \approx \sum_{K \in \mathcal{T}_h} \min_{v_h \in \mathbb{P}_p(K)} \|\nabla(v - v_h)\|_K^2.$$
(3.1)

Note that the minimization terms in the right-hand side of (3.1) are completely local in each tetrahedron and do not involve any constraint on the value on faces in  $\partial K \cap \overline{\Gamma_{\rm D}}$ . The approximation by continuous piecewise polynomials is thus comparable to that by discontinuous piecewise polynomials whenever the target function has  $H^1(\Omega)$ -regularity.

#### 3.2 The H(div) case

The following result is proved in [17, Theorem 3.3]:

Corollary 3.2 (Equivalence of local-best and global-best approximations in H(div)). Let  $p \geq 0$ . Then there exists a constant only depending on the mesh shape-regularity  $\kappa_{\mathcal{T}_h}$  of the mesh  $\mathcal{T}_h$  and the polynomial degree p such that for any  $\mathbf{v} \in H_{0,N}(\text{div}, \Omega)$  with  $\nabla \cdot \mathbf{v} \in \mathbb{P}_p(\mathcal{T}_h)$ ,

$$\min_{\substack{\boldsymbol{v}_h \in \boldsymbol{RT}_p(\mathcal{T}_h) \cap \boldsymbol{H}_{0,N}(\operatorname{div},\Omega) \\ \nabla \cdot \boldsymbol{v}_h = \nabla \cdot \boldsymbol{v}}} \|\boldsymbol{v} - \boldsymbol{v}_h\|^2 \approx \sum_{K \in \mathcal{T}_h} \min_{\substack{\boldsymbol{v}_h \in \boldsymbol{RT}_p(K)}} \|\boldsymbol{v} - \boldsymbol{v}_h\|_K^2. \tag{3.2}$$

Above, the requirement on  $\nabla \cdot \boldsymbol{v}$  to be a piecewise p-degree polynomial is only employed for clarity of presentation; the genal case is treated upon addition of appropriate hp-data oscillation terms of  $\nabla \cdot \boldsymbol{v}$ . Note that, importantly, the minimization terms in the right-hand side of (3.2) are completely local in each tetrahedron and do not involve any constraint on the divergence in K nor on the normal component value on faces in  $\partial K \cap \overline{\Gamma_N}$ . Thus, the approximation by normal-component-continuous piecewise polynomials is comparable to that by discontinuous piecewise polynomials whenever the target function has  $\boldsymbol{H}(\operatorname{div},\Omega)$ -regularity, and, moreover, the divergence constraint can be relaxed.

#### 3.3 Other best-approximations in $H^1$ and H(div)

We will derive below two equivalence results in  $\mathbf{H}(\operatorname{curl},\Omega)$ : in  $\mathbf{L}^2(\Omega)$  for the differential operator and in  $\mathbf{L}^2(\Omega)$  under a constraint on the differential operator. The following remarks clarify such complementary possible best-approximations in  $\mathbf{H}^1(\Omega)$  and  $\mathbf{H}(\operatorname{div},\Omega)$ .

**Remark 3.3** ( $L^2$  best-approximations in  $H^1$  under the constraint on the gradient). In  $H^1(\Omega)$ , Corollary 3.1 only presents the result in  $L^2(\Omega)$  for the differential operator. The other form is, for  $v \in H^1_{0,D}(\Omega)$ 

$$\min_{\substack{v_h \in \mathbb{P}_p(T_h) \cap H_{0,\mathcal{D}}^1(\Omega) \\ \nabla v_h = \mathbf{\Pi}_p \nabla v}} \|v - v_h\|^2, \tag{3.3}$$

where  $\Pi_p$  is the  $L^2(\Omega)$ -orthogonal projector onto  $\nabla(\mathbb{P}_p(\mathcal{T}_h) \cap H^1_{0,D}(\Omega))$ . This constraint alone, however, already fixes the minimizer unless  $\Gamma_D = \emptyset$  (in which case only one degree of freedom is left); a simple one-dimensional example shows that (3.3) is not equivalent to

$$\sum_{K \in \mathcal{T}_h} \min_{\substack{v_h \in \mathbb{P}_p(K) \\ \nabla v_h = \Pi_{p,K}(\nabla v|_K)}} \|v - v_h\|_K^2,$$

where  $\Pi_{p,K}$  is the  $L^2(K)$ -orthogonal projector onto  $\nabla(\mathbb{P}_p(K))$ , and even less so to

$$\sum_{K \in \mathcal{T}_h} \min_{v_h \in \mathbb{P}_p(K)} ||v - v_h||_K^2.$$

Remark 3.4 ( $L^2$  best-approximations for the divergence in  $\mathbf{H}(\operatorname{div})$ ). In  $\mathbf{H}(\operatorname{div}, \Omega)$ , Corollary 3.2 only presents the result in  $\mathbf{L}^2(\Omega)$  under a constraint on the differential operator; the other form localizes trivially, since for any  $\mathbf{v} \in \mathbf{H}_{0,N}(\operatorname{div}, \Omega)$ ,

$$\begin{split} \min_{\boldsymbol{v}_h \in \boldsymbol{RT}_p(\mathcal{T}_h) \cap \boldsymbol{H}_{0,\mathrm{N}}(\mathrm{div},\Omega)} &\|\nabla \cdot (\boldsymbol{v} - \boldsymbol{v}_h)\|^2 = \sum_{K \in \mathcal{T}_h} \min_{\boldsymbol{v}_h \in \boldsymbol{RT}_p(K)} &\|\nabla \cdot (\boldsymbol{v} - \boldsymbol{v}_h)\|_K^2 \\ &= \sum_{K \in \mathcal{T}_h} &\|\nabla \cdot \boldsymbol{v} - \Pi_p(\nabla \cdot \boldsymbol{v})\|_K^2, \end{split}$$

where  $\Pi_p$  is the  $L^2(\Omega)$ -orthogonal projector onto  $\mathbb{P}_p(\mathcal{T}_h)$ .

### 4 Equivalence of local-best and global-best approximations in H(curl)

We present in this section our two main results.

#### 4.1 Equivalence in the H(curl)-seminorm

We first consider  $\boldsymbol{H}(\operatorname{curl},\Omega)$  approximations of the curl in the  $\boldsymbol{L}^2(\Omega)$ -norm without any constraint. Recall the partition of the boundary  $\partial\Omega = \overline{\Gamma_D} \cup \overline{\Gamma_N}$ , with  $\Gamma_N$  possibly empty.

**Theorem 4.1** (H(curl)-seminorm local-global equivalence). Let  $p \geq 0$  be fixed. Then there exists a constant only depending on the shape-regularity  $\kappa_{\mathcal{T}_h}$  of the mesh  $\mathcal{T}_h$  and the polynomial degree p such that for any  $v \in H_{0,N}(\text{curl},\Omega)$ ,

$$\min_{\boldsymbol{v}_h \in \boldsymbol{N}_p(\mathcal{T}_h) \cap \boldsymbol{H}_{0,N}(\text{curl},\Omega)} \|\nabla \times (\boldsymbol{v} - \boldsymbol{v}_h)\|^2 \approx \sum_{K \in \mathcal{T}_h} \min_{\boldsymbol{v}_h \in \boldsymbol{N}_p(K)} \|\nabla \times (\boldsymbol{v} - \boldsymbol{v}_h)\|_K^2. \tag{4.1}$$

*Proof.* There trivially holds

$$\min_{\boldsymbol{v}_h \in \boldsymbol{N}_p(\mathcal{T}_h) \cap \boldsymbol{H}_{0,\mathrm{N}}(\mathrm{curl},\Omega)} \lVert \nabla \times (\boldsymbol{v} - \boldsymbol{v}_h) \rVert^2 \geq \sum_{K \in \mathcal{T}_h} \min_{\boldsymbol{v}_h \in \boldsymbol{N}_p(K)} \lVert \nabla \times (\boldsymbol{v} - \boldsymbol{v}_h) \rVert_K^2,$$

since the broken minimization set is (much) larger. This establishes one inequality.

Let  $\boldsymbol{v} \in \boldsymbol{H}_{0,\mathrm{N}}(\operatorname{curl},\Omega)$  be fixed. Since the  $\nabla \times$  operator maps from  $\boldsymbol{H}_{0,\mathrm{N}}(\operatorname{curl},\Omega)$  onto the space  $\{\boldsymbol{\varphi} \in \boldsymbol{H}_{0,\mathrm{N}}(\operatorname{div},\Omega); \nabla \cdot \boldsymbol{\varphi} = 0\}$ , see (1.1) and [22] for general boundary conditions, we can set  $\boldsymbol{w} := \nabla \times \boldsymbol{v}$  and have  $\boldsymbol{w} \in \boldsymbol{H}_{0,\mathrm{N}}(\operatorname{div},\Omega)$  with  $\nabla \cdot \boldsymbol{w} = 0$ . Since, similarly,  $\nabla \times$  maps from  $\boldsymbol{N}_p(\mathcal{T}_h) \cap \boldsymbol{H}_{0,\mathrm{N}}(\operatorname{curl},\Omega)$  onto the space  $\{\boldsymbol{\varphi}_h \in \boldsymbol{RT}_p(\mathcal{T}_h) \cap \boldsymbol{H}_{0,\mathrm{N}}(\operatorname{div},\Omega); \nabla \cdot \boldsymbol{\varphi}_h = 0\}$ , see [2] or [7, Section 2.5.6], we see

$$\min_{\substack{\boldsymbol{v}_h \in \boldsymbol{N}_p(\mathcal{T}_h) \cap \boldsymbol{H}_{0,\mathrm{N}}(\mathrm{curl},\Omega)}} \|\nabla \times (\boldsymbol{v} - \boldsymbol{v}_h)\|^2 = \min_{\substack{\boldsymbol{w}_h \in \boldsymbol{RT}_p(\mathcal{T}_h) \cap \boldsymbol{H}_{0,\mathrm{N}}(\mathrm{div},\Omega) \\ \nabla \cdot \boldsymbol{w}_h = 0}} \|\boldsymbol{w} - \boldsymbol{w}_h\|^2 =: A.$$

Now Corollary 3.2 yields

$$A \lesssim \sum_{K \in \mathcal{T}_h} \min_{\boldsymbol{w}_h \in \boldsymbol{RT}_p(K)} \|\boldsymbol{w} - \boldsymbol{w}_h\|_K^2 \leq \sum_{K \in \mathcal{T}_h} \min_{\boldsymbol{w}_h \in \boldsymbol{RT}_p(K)} \|\boldsymbol{w} - \boldsymbol{w}_h\|_K^2$$
$$= \sum_{K \in \mathcal{T}_h} \min_{\boldsymbol{v}_h \in \boldsymbol{N}_p(K)} \|\nabla \times (\boldsymbol{v} - \boldsymbol{v}_h)\|_K^2,$$

where the last equality is obtained as above, since

$$\nabla \times \mathbf{N}_p(K) = \{ \mathbf{v}_h \in \mathbf{R} \mathbf{T}_p(K); \, \nabla \cdot \mathbf{v}_h = 0 \}, \tag{4.2}$$

see, e.g., [7, equation (2.3.62)]. This establishes the other inequality.

#### 4.2 Equivalence in the $L^2$ -norm removing the constraint on the curl

We next consider  $\boldsymbol{H}(\operatorname{curl},\Omega)$  approximations in the  $\boldsymbol{L}^2(\Omega)$ -norm with a constraint on the curl. Recall that  $\partial\Omega = \overline{\Gamma_{\rm D}} \cup \overline{\Gamma_{\rm N}}$ , with  $\Gamma_{\rm D}$  possibly empty. Below, we for simplicity of presentation only treat functions  $\boldsymbol{v}$  with piecewise polynomial curls,  $\boldsymbol{v} \in \boldsymbol{H}_{0,{\rm D}}(\operatorname{curl},\Omega)$  with  $\nabla \times \boldsymbol{v} \in [\mathbb{P}_p(\mathcal{T}_h)]^3$ . Note that since then there exits  $\boldsymbol{h}_h \in \boldsymbol{N}_p(\mathcal{T}_h) \cap \boldsymbol{H}_{0,{\rm D}}(\operatorname{curl},\Omega)$  such that  $\nabla \times \boldsymbol{h}_h = \nabla \times \boldsymbol{v}$  (see, e.g., [7, equation (2.5.41)]) and since  $\nabla \times (\boldsymbol{N}_p(\mathcal{T}_h) \cap \boldsymbol{H}_{0,{\rm D}}(\operatorname{curl},\Omega)) = \{\varphi_h \in \boldsymbol{RT}_p(\mathcal{T}_h) \cap \boldsymbol{H}_{0,{\rm D}}(\operatorname{div},\Omega); \nabla \cdot \boldsymbol{\varphi}_h = 0\}$ , this requirement could be equivalently written as asking

$$\nabla \times \boldsymbol{v} \in \{ \boldsymbol{\varphi}_h \in \boldsymbol{RT}_p(\mathcal{T}_h) \cap \boldsymbol{H}_{0,D}(\operatorname{div}, \Omega); \ \nabla \cdot \boldsymbol{\varphi}_h = 0 \}. \tag{4.3}$$

**Theorem 4.2** ( $L^2$ -norm local-global equivalence removing the constraint on the curl). Let  $p \geq 0$  be fixed. Then there exists a constant only depending on the shape-regularity  $\kappa_{\mathcal{T}_h}$  of the mesh  $\mathcal{T}_h$  and the polynomial degree p such that for any  $\mathbf{v} \in \mathbf{H}_{0,D}(\text{curl},\Omega)$  with  $\nabla \times \mathbf{v} \in [\mathbb{P}_p(\mathcal{T}_h)]^3$ ,

$$\left\| \min_{\substack{\boldsymbol{v}_h \in \boldsymbol{N}_p(\mathcal{T}_h) \cap \boldsymbol{H}_{0,D}(\operatorname{curl},\Omega) \\ \nabla \times \boldsymbol{v}_h = \nabla \times \boldsymbol{v}}} \|\boldsymbol{v} - \boldsymbol{v}_h\|^2 \approx \sum_{K \in \mathcal{T}_h} \min_{\boldsymbol{v}_h \in \boldsymbol{N}_p(K)} \|\boldsymbol{v} - \boldsymbol{v}_h\|_K^2. \right]$$
(4.4)

*Proof.* There trivially holds

$$\min_{\substack{\boldsymbol{v}_h \in \boldsymbol{N}_p(\mathcal{T}_h) \cap \boldsymbol{H}_{0,\mathrm{D}}(\mathrm{curl},\Omega) \\ \nabla \times \boldsymbol{v}_h = \nabla \times \boldsymbol{v}}} \|\boldsymbol{v} - \boldsymbol{v}_h\|^2 \ge \sum_{K \in \mathcal{T}_h} \min_{\substack{\boldsymbol{v}_h \in \boldsymbol{N}_p(K)}} \|\boldsymbol{v} - \boldsymbol{v}_h\|_K^2,$$

since the broken minimization set is (much) larger. This establishes one inequality.

Fix  $\mathbf{v} \in \mathbf{H}_{0,D}(\operatorname{curl},\Omega)$  with  $\nabla \times \mathbf{v} \in [\mathbb{P}_p(\mathcal{T}_h)]^3$ . Choose any  $\mathbf{h}_h \in \mathbf{N}_p(\mathcal{T}_h) \cap \mathbf{H}_{0,D}(\operatorname{curl},\Omega)$  such that  $\nabla \times \mathbf{h}_h = \nabla \times \mathbf{v}$ . Then  $\mathbf{v} - \mathbf{h}_h \in \mathbf{H}_{0,D}(\operatorname{curl},\Omega)$  is such that  $\nabla \times (\mathbf{v} - \mathbf{h}_h) = \mathbf{0}$ , so that there exists (a unique, up to a constant when  $\Gamma_D = \emptyset$ )  $q \in H^1_{0,D}(\Omega)$  such that  $\nabla q = \mathbf{v} - \mathbf{h}_h$ , see (1.1) and [22] for general boundary conditions. Similarly, for any  $\mathbf{v}_h \in \mathbf{N}_p(\mathcal{T}_h) \cap \mathbf{H}_{0,D}(\operatorname{curl},\Omega)$  such that  $\nabla \times \mathbf{v}_h = \nabla \times \mathbf{v}$ ,  $\mathbf{v}_h - \mathbf{h}_h \in \mathbf{N}_p(\mathcal{T}_h) \cap \mathbf{H}_{0,D}(\operatorname{curl},\Omega)$  is such that  $\nabla \times (\mathbf{v}_h - \mathbf{h}_h) = 0$ , so that there exists (a unique, up to a constant when  $\Gamma_D = \emptyset$ )  $q_h \in \mathbb{P}_{p+1}(\mathcal{T}_h) \cap H^1_{0,D}(\Omega)$  such that  $\nabla q_h = \mathbf{v}_h - \mathbf{h}_h$ , see [2] or [7, Section 2.5.6]. Consequently,

$$\min_{\substack{\boldsymbol{v}_h \in \boldsymbol{N}_p(\mathcal{T}_h) \cap \boldsymbol{H}_{0,\mathrm{D}}(\mathrm{curl},\Omega) \\ \nabla \boldsymbol{v}_h = -\nabla \boldsymbol{v}_h}} \|\boldsymbol{v} - \boldsymbol{v}_h\|^2 = \min_{\substack{\boldsymbol{v}_h \in \mathbb{P}_{p+1}(\mathcal{T}_h) \cap H_{0,\mathrm{D}}^1(\Omega)}} \|\nabla(q - v_h)\|^2 =: A.$$

Now, using the localization of Corollary 3.1, we infer

$$A \lesssim \sum_{K \in \mathcal{T}_h} \min_{v_h \in \mathbb{P}_{p+1}(K)} \|\nabla(q - v_h)\|_K^2 = \sum_{K \in \mathcal{T}_h} \min_{\substack{\boldsymbol{v}_h \in N_p(K) \\ \nabla \times \boldsymbol{v}_h = \nabla \times \boldsymbol{v}}} \|\boldsymbol{v} - \boldsymbol{v}_h\|_K^2,$$

where, in the equality, we have used the fact that for any  $v_h \in \mathbb{P}_{p+1}(K)$ , there exists a unique  $\boldsymbol{v}_h \in \boldsymbol{N}_p(K)$  with  $\nabla \times \boldsymbol{v}_h = (\nabla \times \boldsymbol{v})|_K$  such that  $\nabla v_h = \boldsymbol{v}_h - \boldsymbol{h}_h$  (following [7, equation (2.3.56)],  $\boldsymbol{v}_h = \nabla v_h + \boldsymbol{h}_h$ ). Finally, employing Lemma A.1 below which crucially allows to remove the curl constraint establishes the other inequality.

### A Equivalence of constrained and unconstrained best-approximation in H(curl) on a tetrahedron

The following important lemma follows along the lines of [17, Lemma A.1], on the basis of the breakthrough result of Costabel and McIntosh in [14, Proposition 4.2]. Interestingly enough, the constant hidden in the inequality is here independent of the polynomial degree p.

**Lemma A.1** (Equivalence of constrained and unconstrained best-approximation on a tetrahedron). Let a polynomial degree  $p \geq 0$  and a tetrahedron K be fixed. Then there exists a constant only depending on the the shape-regularity  $\kappa_K := h_K/\rho_K$  of K such that for any  $\mathbf{v} \in \mathbf{H}(\text{curl}, K)$  with  $\nabla \times \mathbf{v} \in [\mathbb{P}_p(K)]^3$ ,

$$\min_{\boldsymbol{v}_h \in \boldsymbol{N}_p(K)} \|\boldsymbol{v} - \boldsymbol{v}_h\|_K \le \min_{\substack{\boldsymbol{v}_h \in \boldsymbol{N}_p(K) \\ \nabla \times \boldsymbol{v}_h = \nabla \times \boldsymbol{v}}} \|\boldsymbol{v} - \boldsymbol{v}_h\|_K \lesssim \min_{\boldsymbol{v}_h \in \boldsymbol{N}_p(K)} \|\boldsymbol{v} - \boldsymbol{v}_h\|_K. \tag{A.1}$$

*Proof.* The first inequality in (A.1) is trivial, so we focus on the second one. Denote respectively

$$\tau_h := \arg \min_{\substack{\boldsymbol{v}_h \in \boldsymbol{N}_p(K) \\ \nabla \times \boldsymbol{v}_h = \nabla \times \boldsymbol{v}}} \|\boldsymbol{v} - \boldsymbol{v}_h\|_K, \tag{A.2a}$$

$$\widetilde{\boldsymbol{\tau}}_h := \arg\min_{\boldsymbol{v}_h \in \boldsymbol{N}_p(K)} \|\boldsymbol{v} - \boldsymbol{v}_h\|_K$$
 (A.2b)

the constrained and unconstrained minimizers. We then need to show

$$\|\boldsymbol{v} - \boldsymbol{\tau}_h\|_K \lesssim \|\boldsymbol{v} - \widetilde{\boldsymbol{\tau}}_h\|_K. \tag{A.3}$$

Using (4.2)–(4.3), on the element K,  $\nabla \times (\boldsymbol{v} - \tilde{\boldsymbol{\tau}}_h) \in \{\boldsymbol{v}_h \in \boldsymbol{RT}_p(K); \nabla \cdot \boldsymbol{v}_h = 0\}$ . Thus, we can use [14, Proposition 4.2], cf. also the equivalent reformulation in [10, Theorem 2], stipulating the existence of  $\boldsymbol{w}_h \in \boldsymbol{N}_p(K)$  with  $\nabla \times \boldsymbol{w}_h = \nabla \times (\boldsymbol{v} - \tilde{\boldsymbol{\tau}}_h)$  such that

$$\|\boldsymbol{w}_h\|_K \lesssim \min_{\substack{\boldsymbol{\varphi} \in \boldsymbol{H}(\operatorname{curl},K) \\ \nabla \times \boldsymbol{\varphi} = \nabla \times (\boldsymbol{v} - \tilde{\boldsymbol{\tau}}_h)}} \|\boldsymbol{\varphi}\|_K. \tag{A.4}$$

Shifting now the right-hand side of (A.4) by  $\tilde{\tau}_h$ , we arrive at

$$\|\boldsymbol{w}_h\|_K \lesssim \min_{\substack{\boldsymbol{\varphi} \in \boldsymbol{H}(\operatorname{curl},K) \\ \nabla \times \boldsymbol{\varphi} = \nabla \times \boldsymbol{v}}} \|\boldsymbol{\varphi} - \tilde{\boldsymbol{\tau}}_h\|_K \le \|\boldsymbol{v} - \tilde{\boldsymbol{\tau}}_h\|_K, \tag{A.5}$$

where the last inequality is trivial. Note that  $(\boldsymbol{w}_h + \widetilde{\boldsymbol{\tau}}_h) \in \boldsymbol{N}_p(K)$  with  $\nabla \times (\boldsymbol{w}_h + \widetilde{\boldsymbol{\tau}}_h) = \nabla \times \boldsymbol{v}$ . Thus, from the minimization property (A.2a) of  $\boldsymbol{\tau}_h$ , by virtue of the triangle inequality, and using (A.5), we infer

$$\|v - \tau_h\|_K \le \|v - (w_h + \widetilde{\tau}_h)\|_K \le \|v - \widetilde{\tau}_h\|_K + \|w_h\|_K \lesssim \|v - \widetilde{\tau}_h\|_K$$

i.e., (A.3), and the proof is finished.
