- 3. The conjunction of non linearities and regular structure can produce a highly *disordered spatio-temporal* dynamics.

4. The retina is sensitive to *changes in its physiology* (development, pharmacology, pathologies). These changes can be addressed from the point of view of *bifurcations theory*.

sAHP current

- Four Ca^{2+} ions bound to calmodulin open the channel
- *I*_{SAHP} current depends on gating variable R as follows:

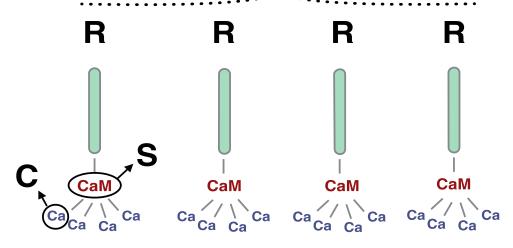


The conductance is proportional to the fourth power of R because four terminals are needed to open the channel.

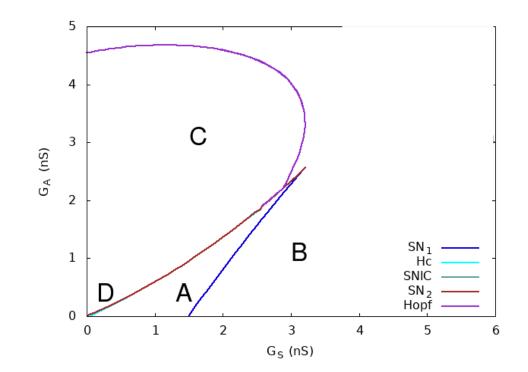


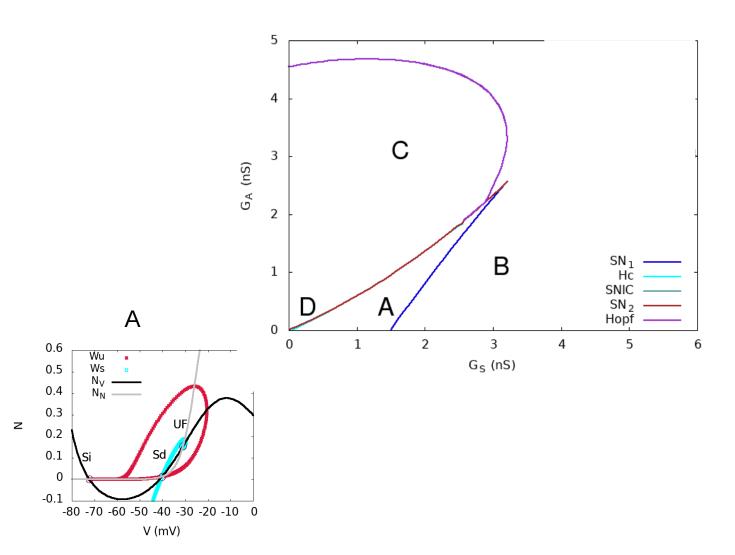


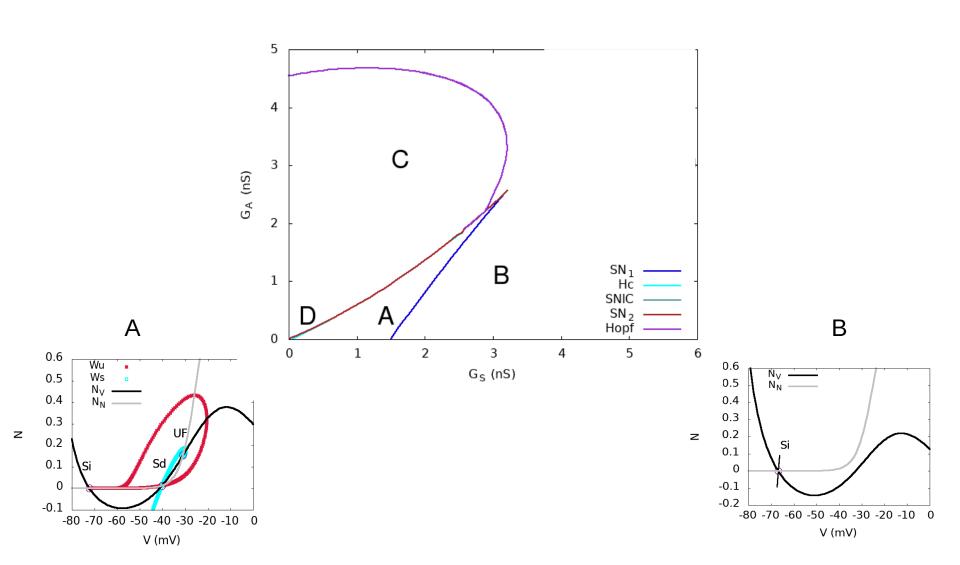


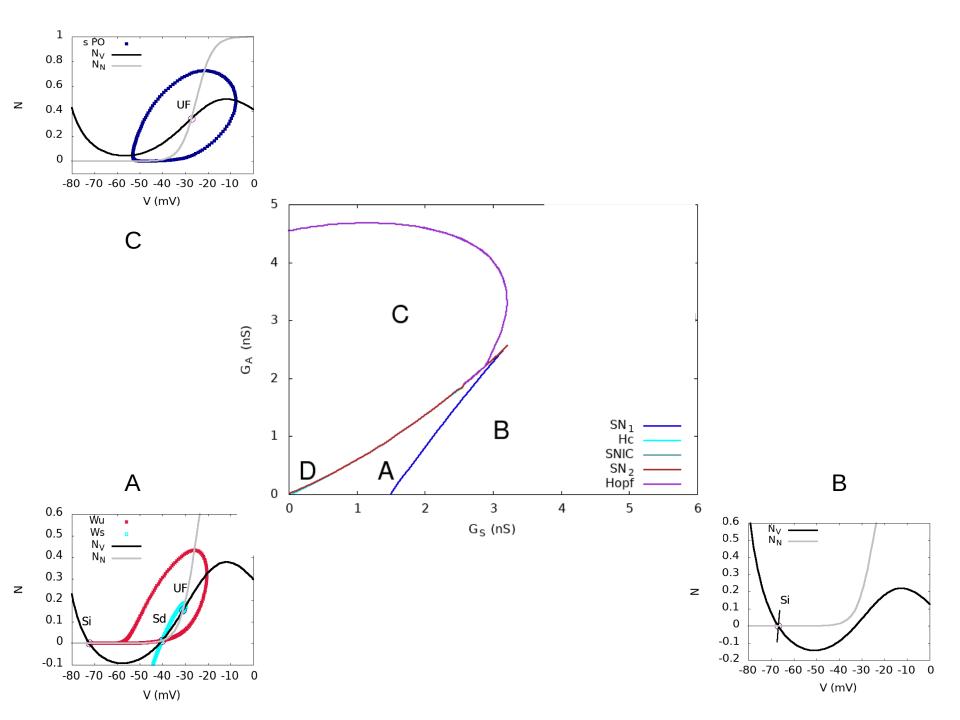


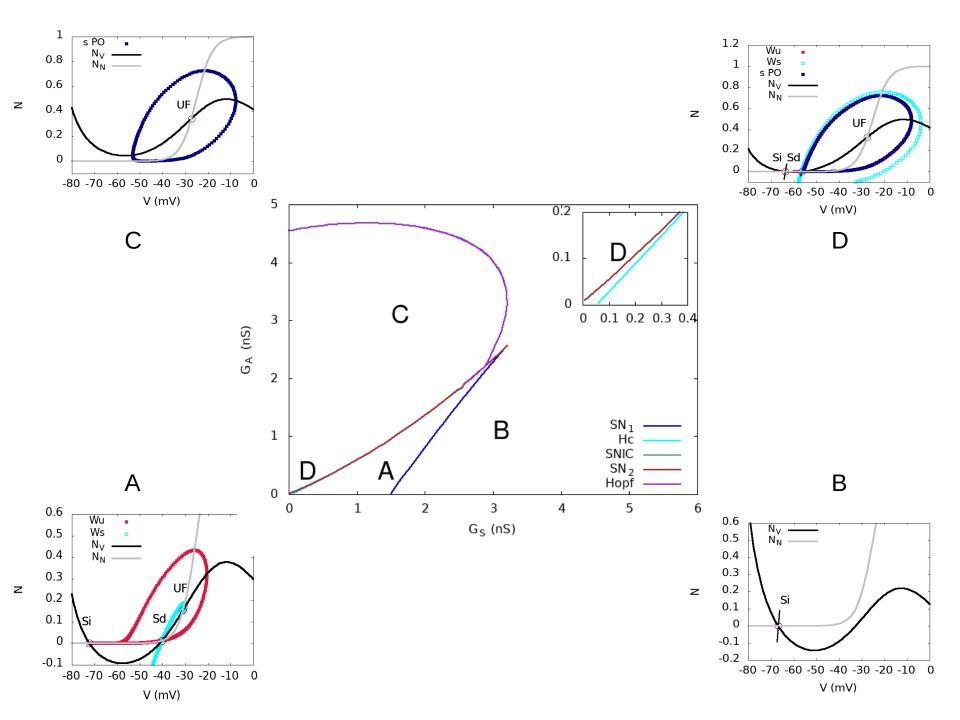


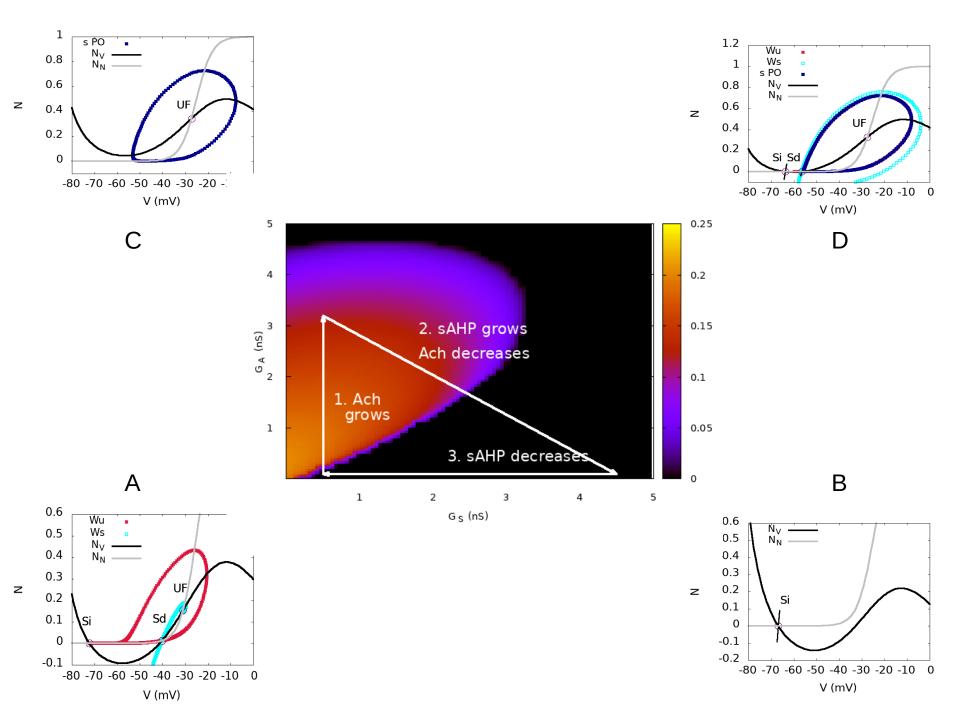


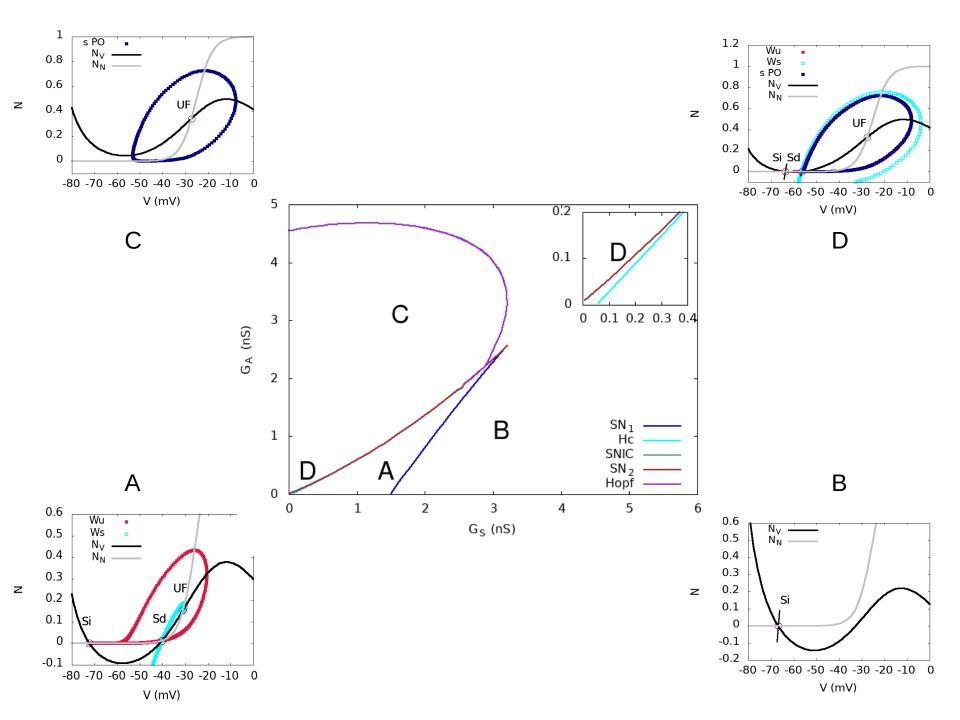


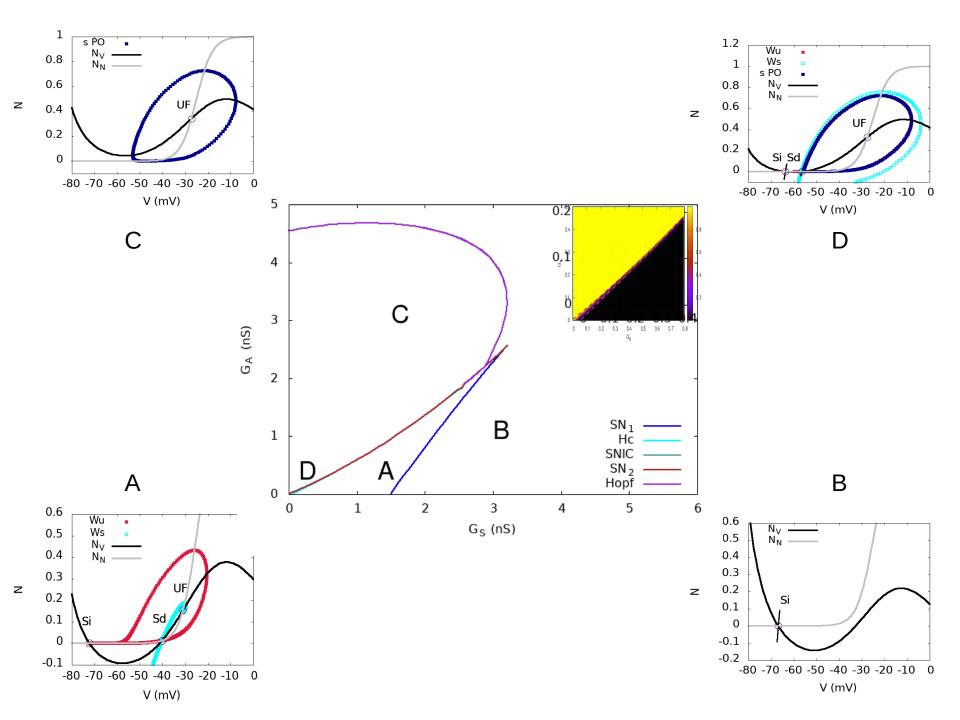


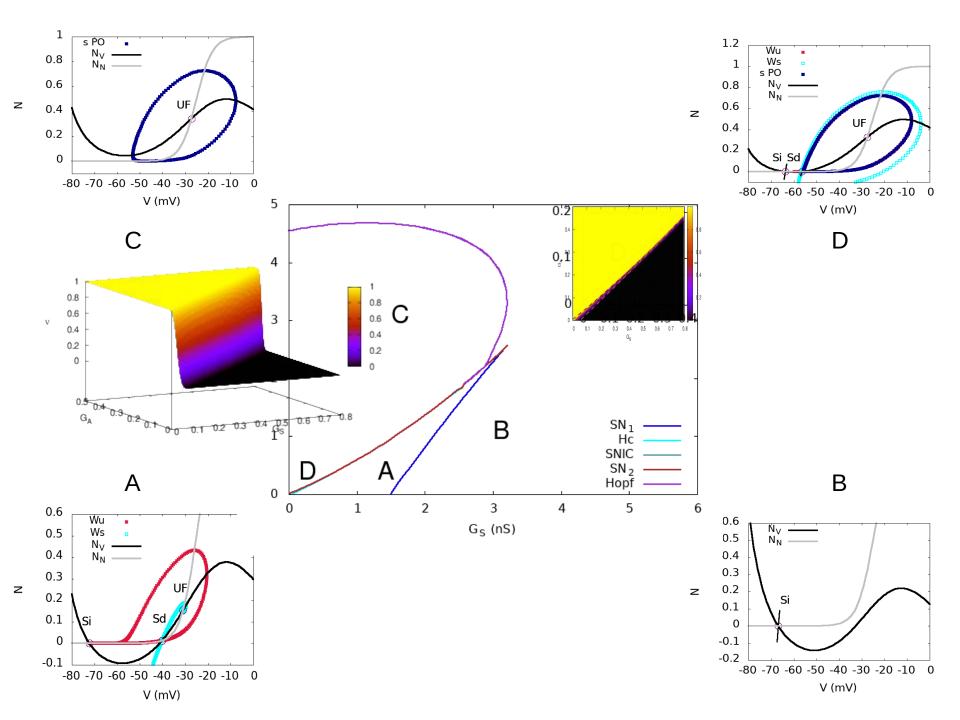


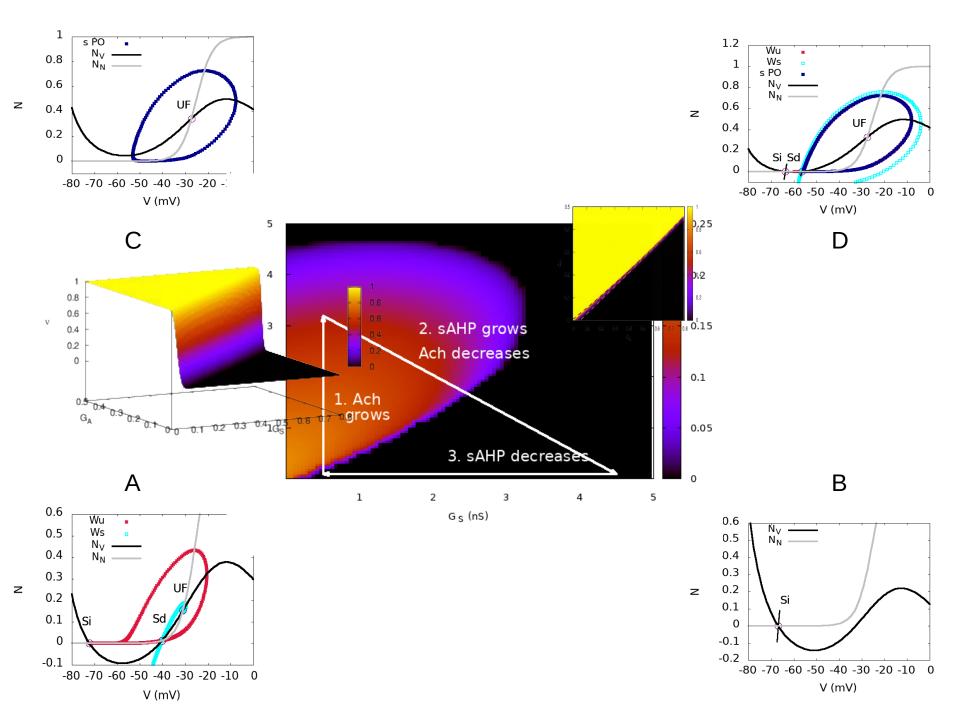


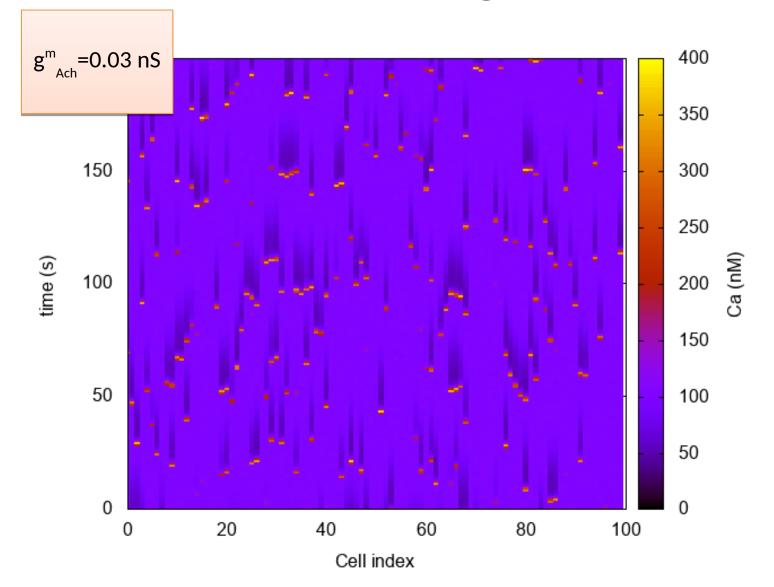


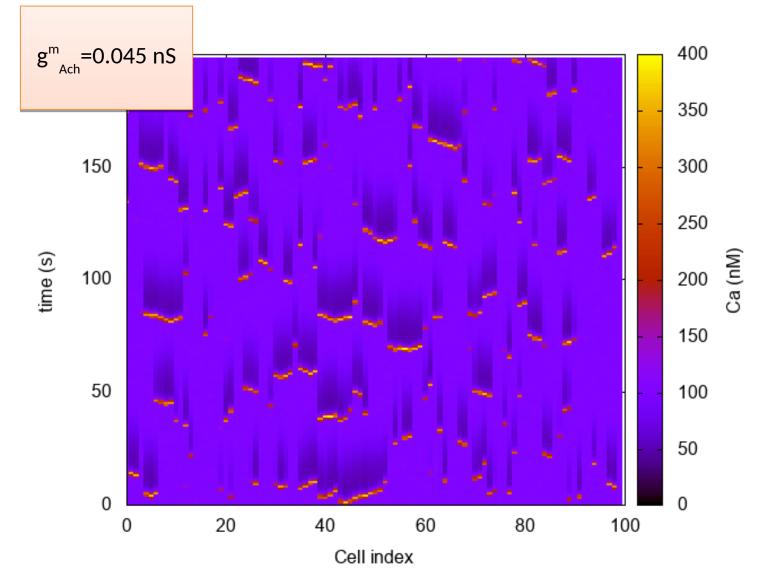


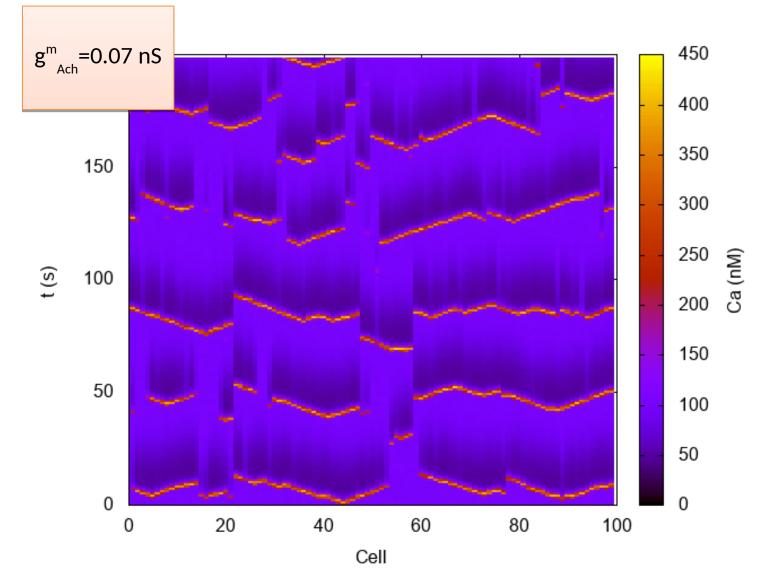


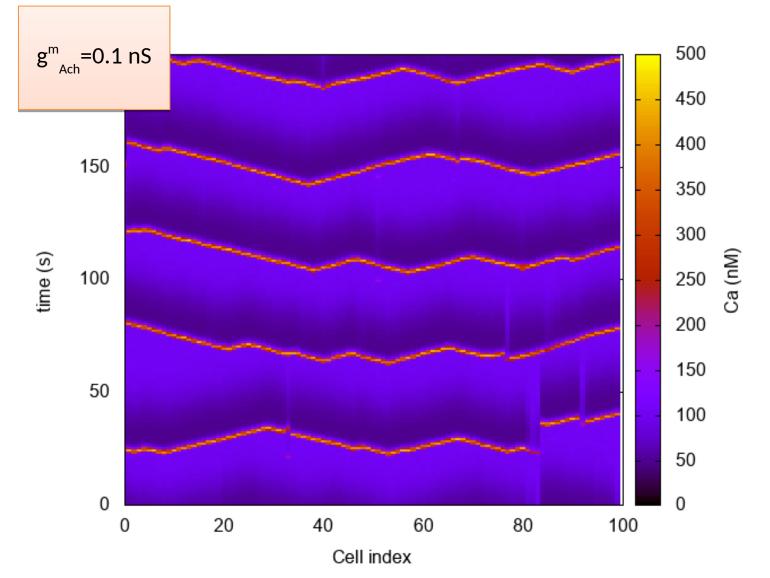


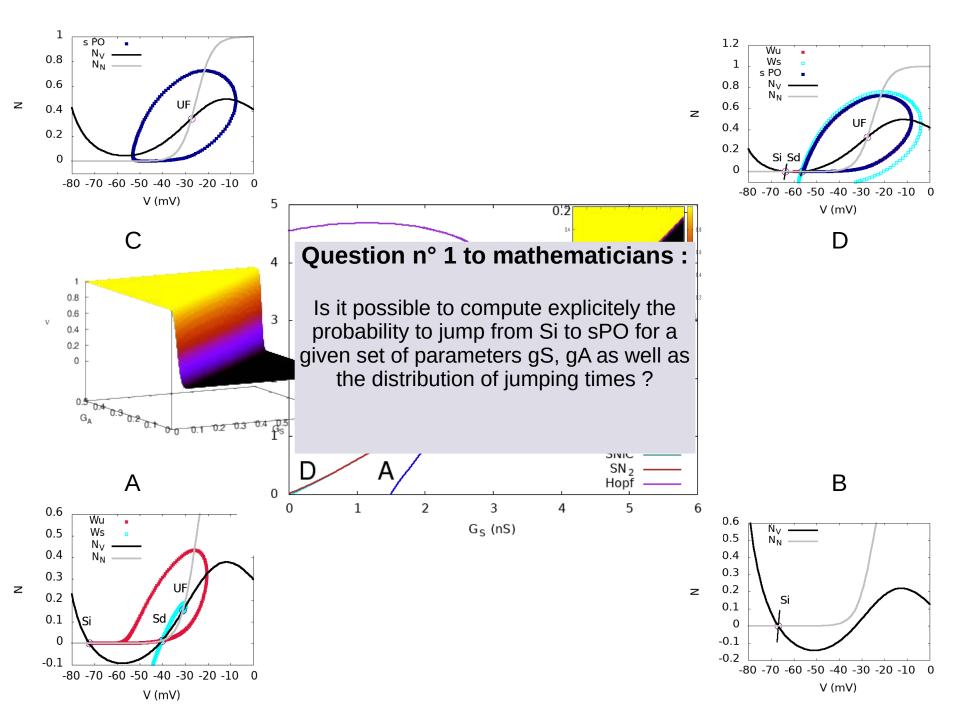


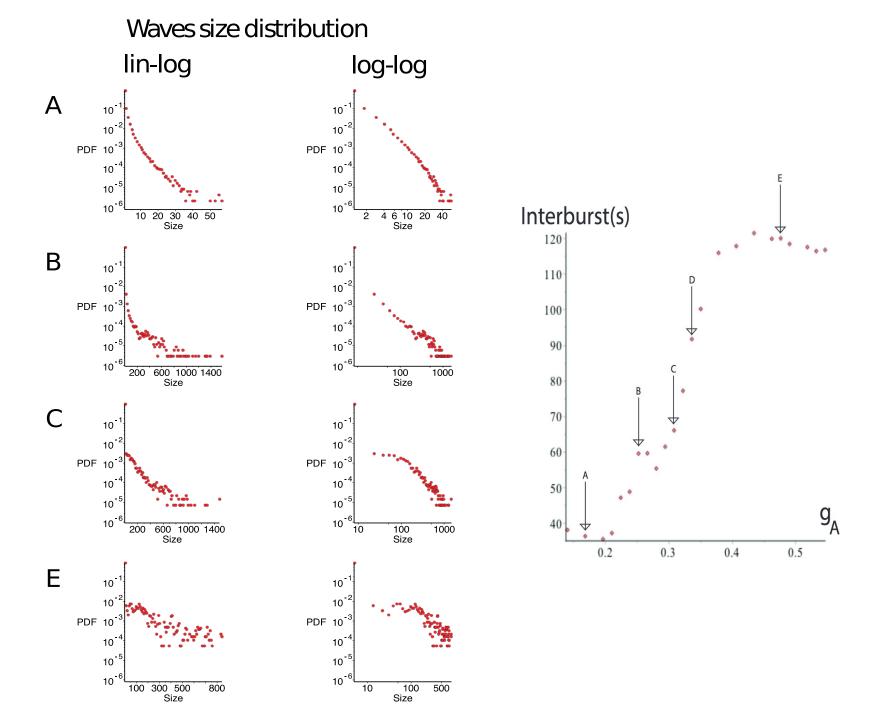






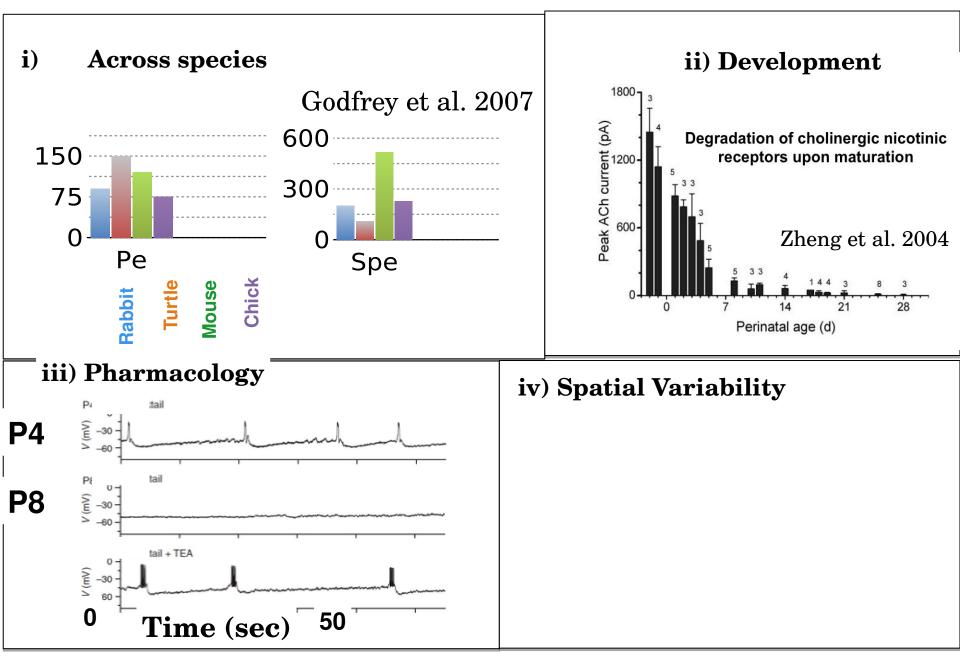


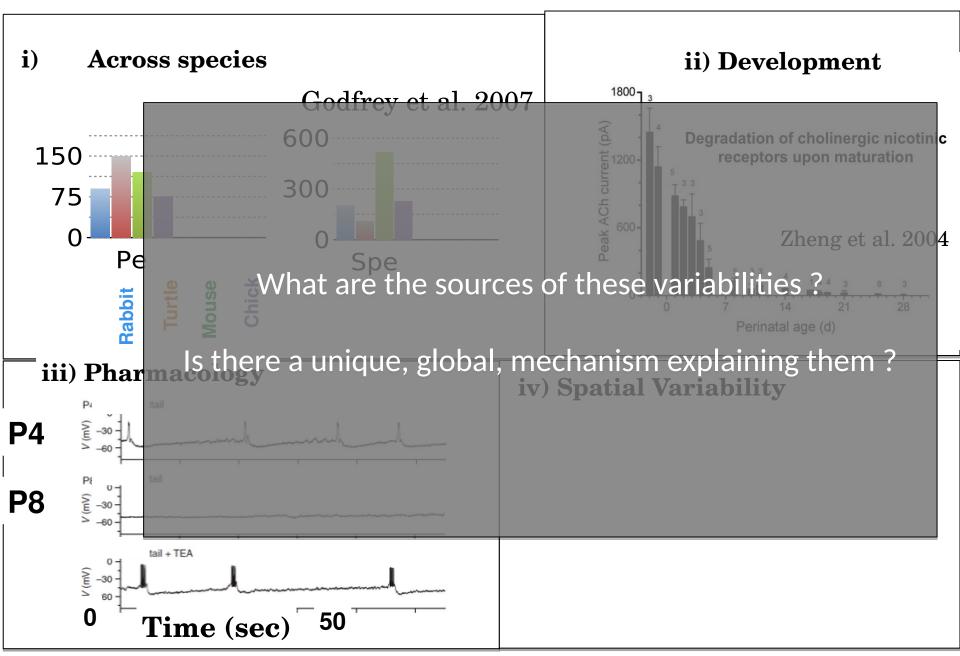


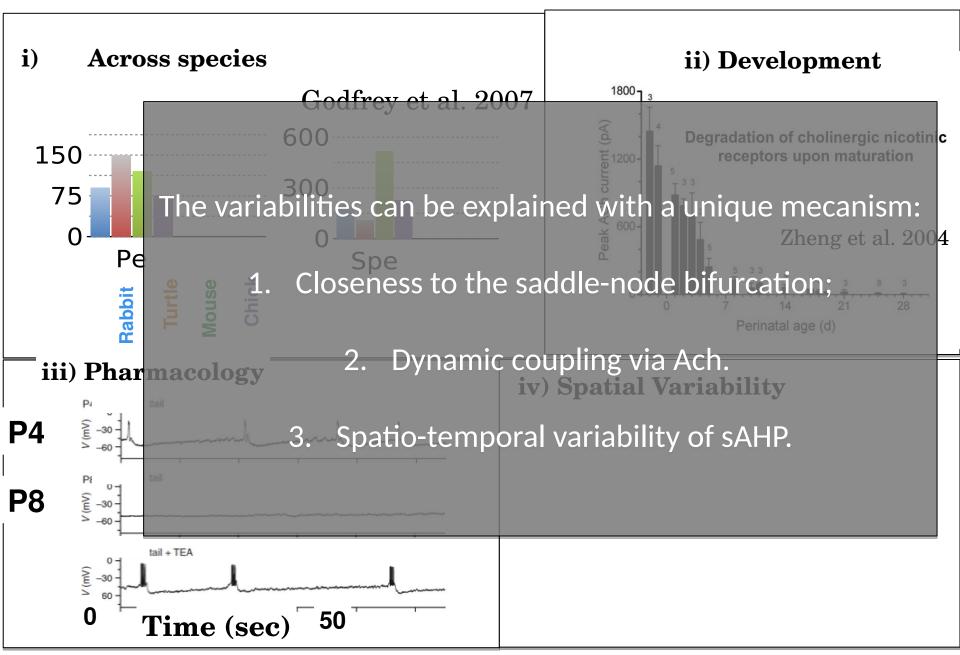


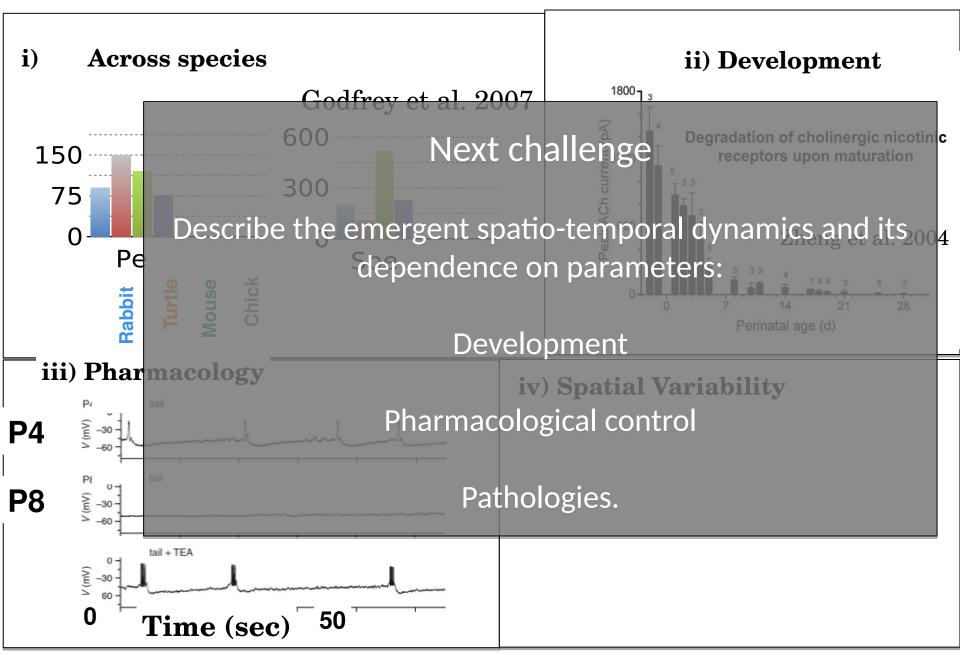
N-neuron model

- There is a **competition** between 2 mechanisms:
 - Period variability which tends to desynchronise
 - Acetylcholine which tends to synchronise
- There is an intermediate regime of coupling, where **variability** is maximum
- Therefore there is a wide repertoire of patterns
 - Weak coupling leads to small localised activity
 - Moderate coupling leads to propagating patterns
 - Strong coupling leads to complete synchrony of neurons

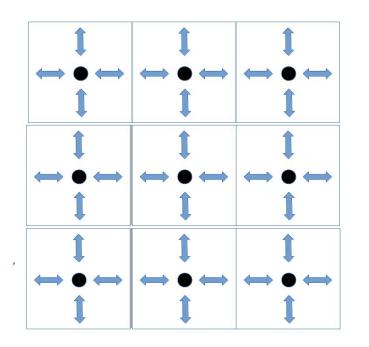


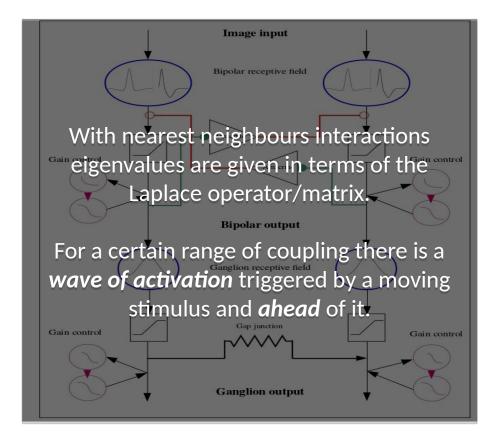
Fig 7. Starbust anteorine cells as stained with tactler yellow in wholemount rabbit tetra.



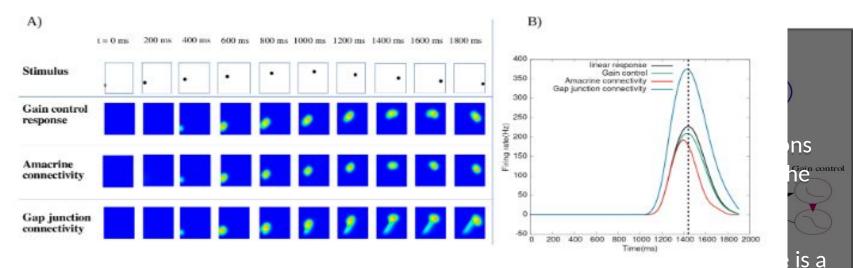








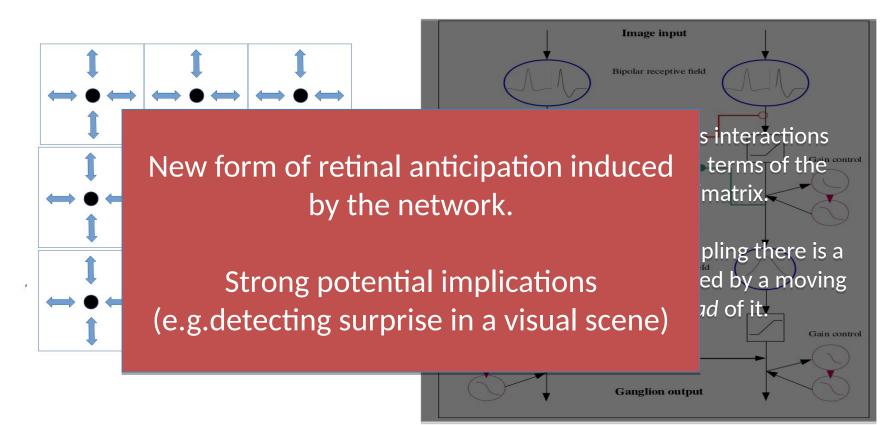

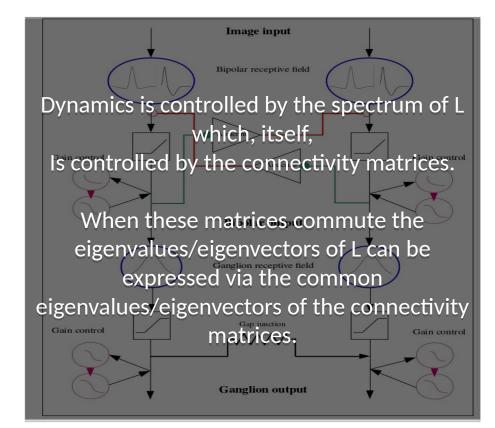
Figure 15: Effect of anticipatory mechanisms on a parabolic trajectory. A) Response to a dot moving along a parabolic trajectory. The first line shows the stimulus, the second line shows the GCells response with gain control, the third line presents the effect of lateral ACells connectivity with $w = 0.3 m s^{-1}$, and the last line shows the effect of asymmetric gap junctions with $v_{gap} = 9 mm/s$. B) Time course response of a cell responding to the dot near the trajectory turning point. Linear response corresponds to the response to the stimulus without gain control.

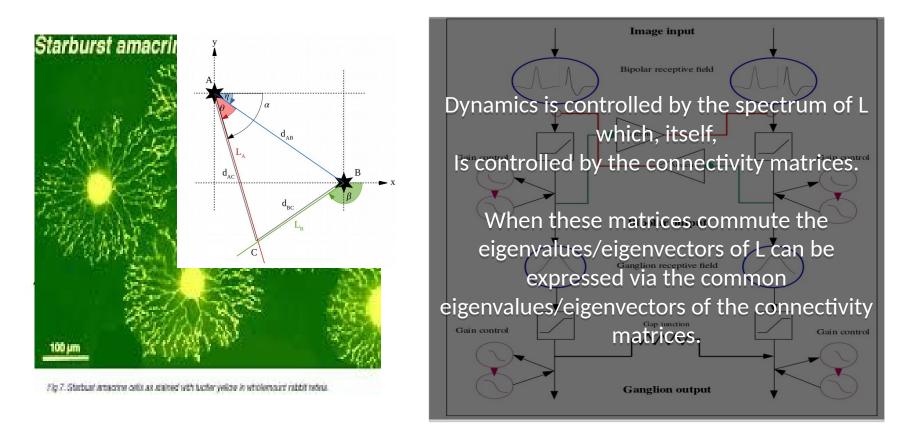


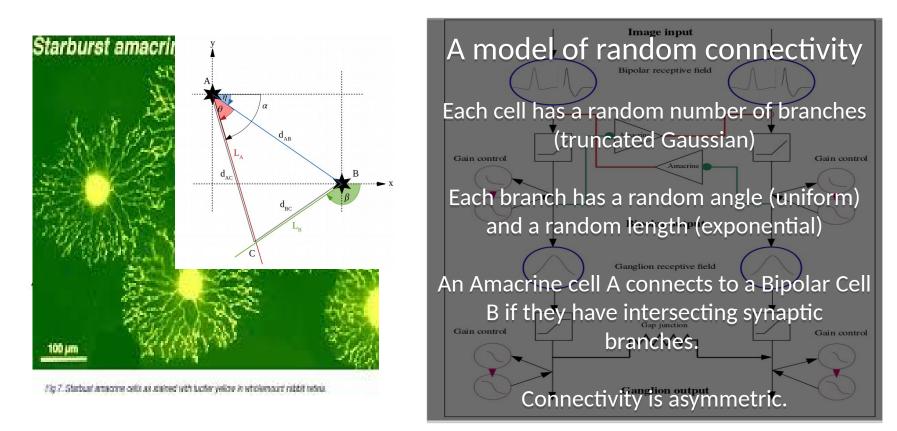

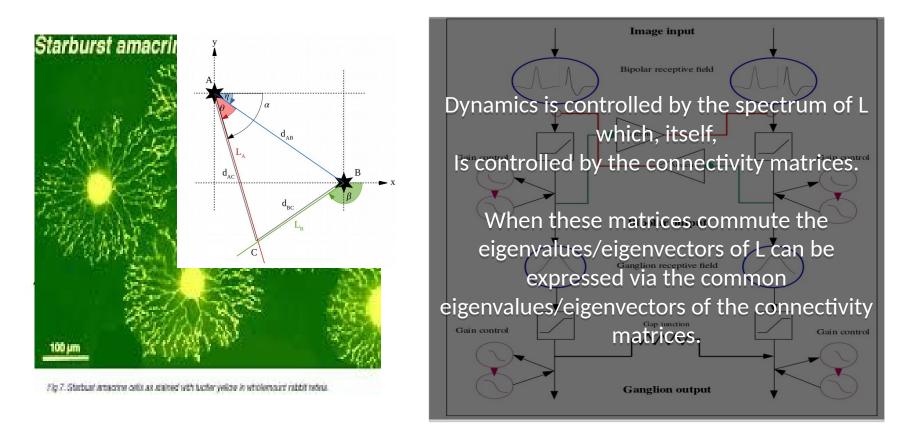


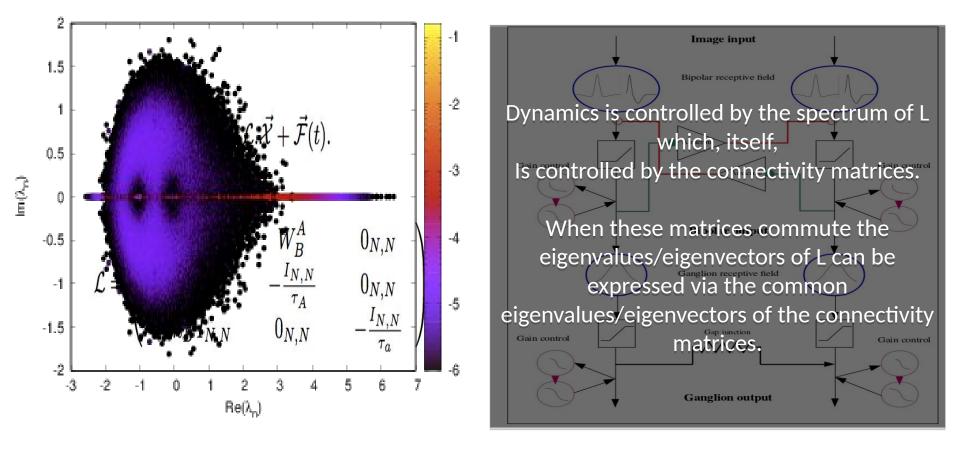
Fig 7. Starbust anteorine cells as stained with tactler yellow in wholemount rabbit tetra.





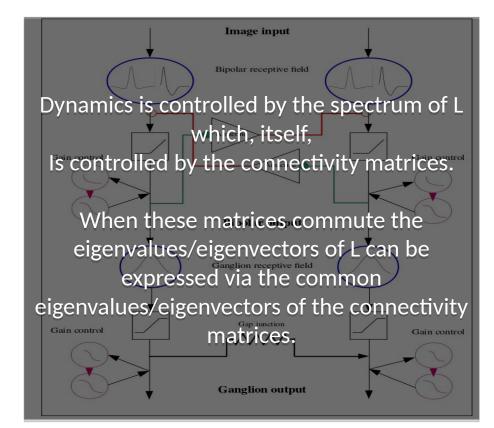


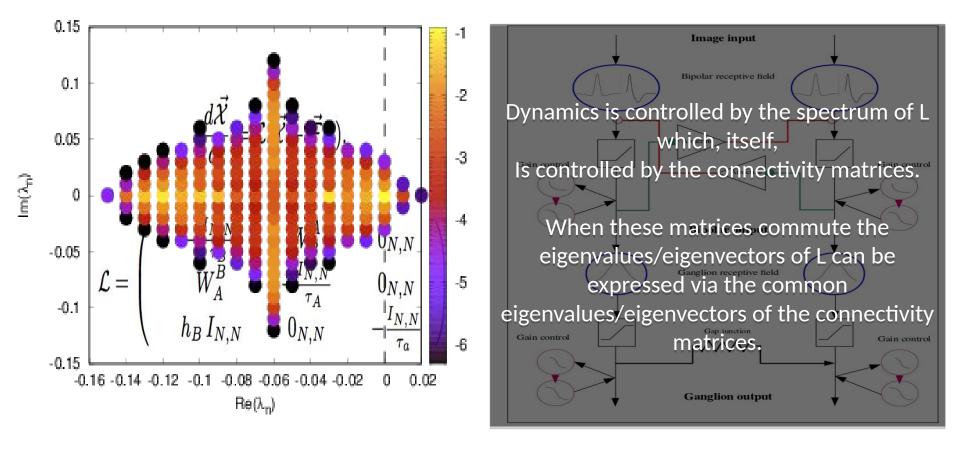


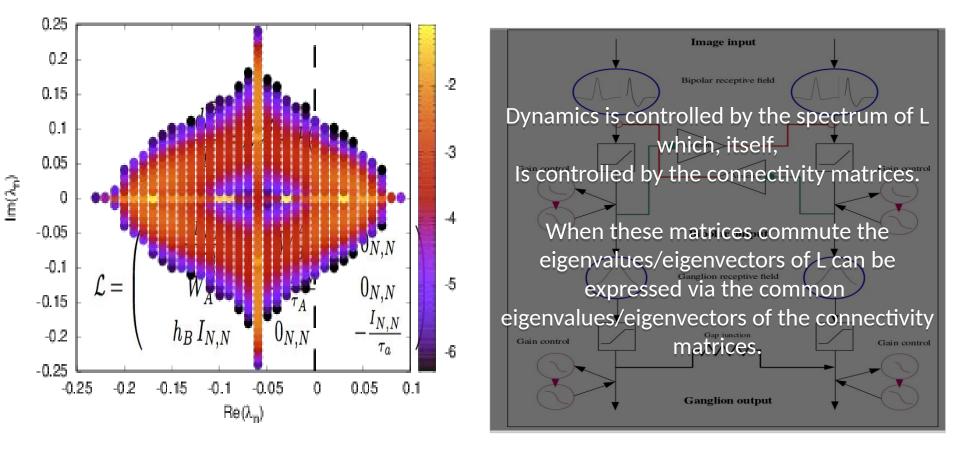


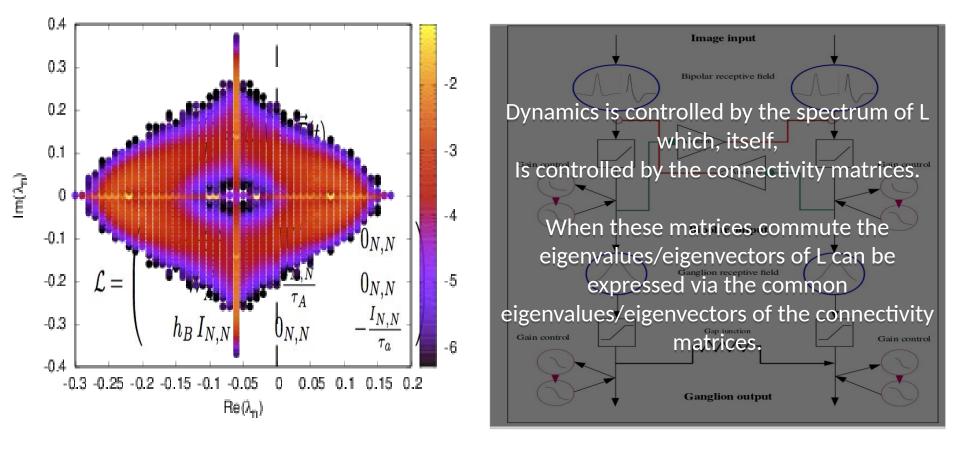

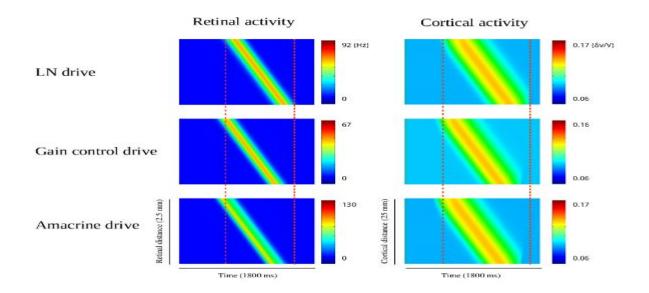


Figure 11: Comparing the spatio-temporal activity with the different drives. Left column figures display the spatiotemporal retinal activity with different anticipatory mechanisms, and the right column displays the corresponding spatio-temporal cortical activity. The red dashed lines denote the start and the end times of the LN retinal and cortical activities, as a reference base.

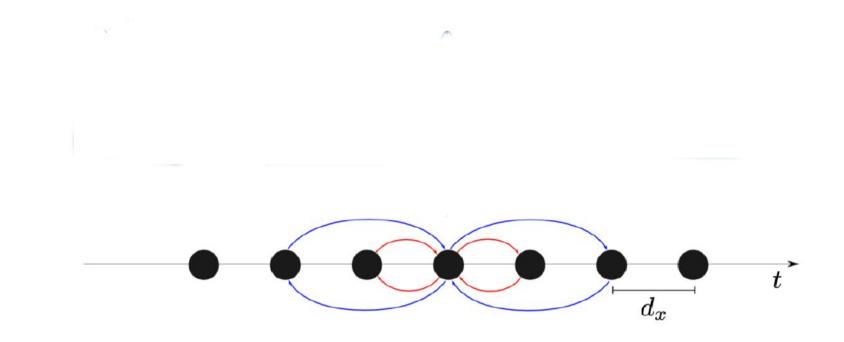

time-dependent stimulus $S(t) \Rightarrow$ non stationary Gibbs distribution.

How is the average of an observable $f(\omega, t)$ affected by the stimulus ?

If S is weak enough: $\delta \mu [f(t)] = [\kappa_f * S](t)$, (linear response).

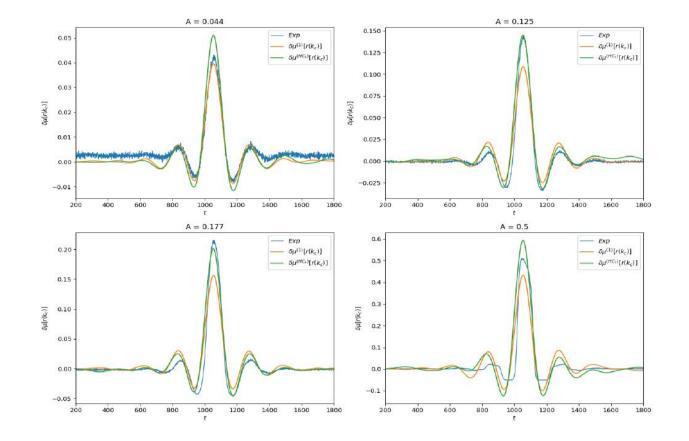


Figure: Linear response of $f(\omega, n) = \omega_{k_c}(n)$ for different values of stimulus amplitude A.

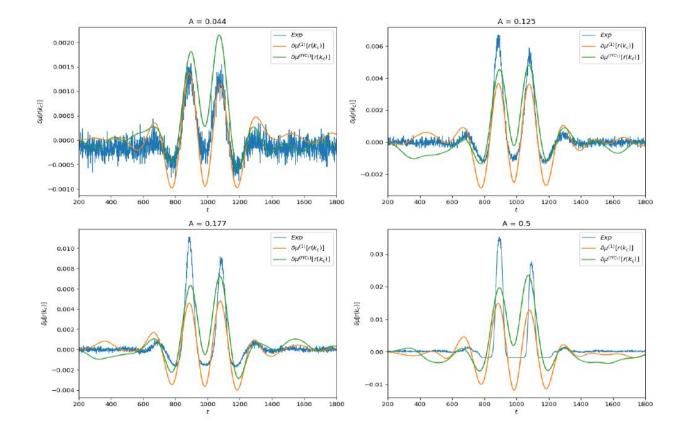


Figure: Linear response of the observable $f(n, \omega) = \omega_{k_c-2}(n-3)\omega_{k_c}(n)$.
