The Poisson problem

Poisson problem

Consider a Lipschitz polyhedral domain Ω and $f \in L^2(\Omega)$.

Our first model problem is to find $\mathbf{u} \in H^1_0(\Omega)$ such that

$$(\nabla \mathbf{u}, \nabla \mathbf{v})_{\Omega} = (\mathbf{f}, \mathbf{v})_{\Omega}$$

for all $v \in H_0^1(\Omega)$.

 u_h is the Lagrange FEM approximation of u with degree p+1.

For the sake of simplicity, I will assume that $f = f_h \in \mathcal{P}_p(\mathcal{T}_h)$.

The idea of flux equilibration

Assume that we have a field $\sigma_h \in \mathcal{H}(\text{div}, \Omega)$ such that

$$\nabla \cdot \boldsymbol{\sigma}_h = \boldsymbol{f}_h$$
 in Ω

at our disposal.

Then, we have

$$(\nabla(\mathbf{u} - \mathbf{u}_h), \nabla \mathbf{v})_{\Omega} = (\mathbf{f}_h, \mathbf{v})_{\Omega} - (\nabla \mathbf{u}_h, \nabla \mathbf{v})$$
$$= (\nabla \cdot \boldsymbol{\sigma}_h, \mathbf{v})_{\Omega} - (\nabla \mathbf{u}_h, \nabla \mathbf{v})$$
$$= -(\boldsymbol{\sigma}_h + \nabla \mathbf{u}_h, \nabla \mathbf{v}),$$

for all $v \in H_0^1(\Omega)$ and in particular

$$\|\nabla(\mathbf{u}-\mathbf{u}_h)\|_{\Omega} \leq \|\boldsymbol{\sigma}_h + \nabla \mathbf{u}_h\|_{\Omega}.$$

Prager-Synge theorem

Equilibrated flux

$$\sigma_h \in H(\text{div}, \Omega); \quad \nabla \cdot \sigma_h = f_h \text{ in } \Omega$$

Error estimate

$$\|\nabla(\mathbf{u}-\mathbf{u}_h)\|_{\Omega} \leq \|\boldsymbol{\sigma}_h + \nabla \mathbf{u}_h\|_{\Omega}.$$

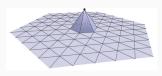
The particular choice $\sigma:=-\nabla u$ saturates the bound.

Local flux constructions

The idea flux would be $\sigma:=-\nabla u$. Let's characterize it locally and cook up a discrete computable version.

Let us set

$$\sigma^a := \psi_a \sigma$$



where ψ_{a} is the "hat function" associated with the vertex a, so that

$$\sigma = \sum_{a \in \mathcal{V}_b} \sigma^a$$
.

Characterization of the local contributions

We know that $\sigma^a := -\psi_a \nabla u$. So that in particular

$$\sigma^a \in H_0(\operatorname{div}, \omega_a)$$

where ω_a is the set of tetrahedra $K \in \mathcal{T}_h$ sharing the vertex a, and

$$\nabla \cdot \boldsymbol{\sigma}^{\boldsymbol{a}} = \psi_{\boldsymbol{a}} f_{\boldsymbol{b}} - \nabla \psi_{\boldsymbol{a}} \cdot \nabla \boldsymbol{u}.$$

As a result, we have the characterization

$$\sigma^{\mathbf{a}} = \arg \min_{\substack{\mathbf{v} \in H_0(\operatorname{div}, \omega_{\mathbf{a}}) \\ \nabla \cdot \mathbf{v} = \psi_{\mathbf{a}} f_{\mathbf{b}} - \nabla \psi_{\mathbf{a}} \cdot \nabla \mathbf{u}}} \|\mathbf{v} + \psi_{\mathbf{a}} \nabla \mathbf{u}\|_{\omega_{\mathbf{a}}},$$

since the minimum is zero and achieved when ${m v}=-\psi_{{m a}}{m
abla}_{{m u}}.$

Discrete construction

Recall that

As a discrete counterpart, we set

$$\begin{array}{l} \pmb{\sigma_h^a} := \arg \min_{\substack{\pmb{v_h} \in RT_{\rho+1}(\mathcal{T}_h^a) \cap H_0(\operatorname{div}, \omega_a) \\ \nabla \cdot \pmb{v_h} = \psi_a f_h - \nabla \psi_a \cdot \nabla \underline{u_h}}} \| \pmb{v_h} + \psi_a \nabla \underline{u_h} \|_{\omega_a}. \end{array}$$

This is indeed well-defined since

$$(\psi_{\mathbf{a}}\mathbf{f} - \nabla\psi_{\mathbf{a}}\cdot\nabla\mathbf{u_h}, 1)_{\omega_{\mathbf{a}}} = (\mathbf{f}, \psi_{\mathbf{a}})_{\Omega} - (\nabla\mathbf{u_h}, \nabla\psi_{\mathbf{a}})_{\omega_{\mathbf{a}}} = 0$$

whenever $\mathbf{a} \notin \partial \Omega$.

Reliability and efficiency

Summation provides an equilibrated flux:

$$oldsymbol{\sigma}_h := \sum_{oldsymbol{a} \in \mathcal{V}_h} oldsymbol{\sigma}_h^{oldsymbol{a}},$$

and reliability follows from the Prager-Synge theorem.

Efficiency

$$\|\boldsymbol{\sigma}_h + \nabla \boldsymbol{u}_h\|_{\mathcal{K}} \lesssim \|\nabla (\boldsymbol{u} - \boldsymbol{u}_h)\|_{\widetilde{\mathcal{K}}}$$

The hidden constant does not depend on p.

The curl-curl problem

The curl-curl problem

For the sake of simplicity, assume that Ω is simply connected, and consider a divergence-free right-hand side $J_h \in RT_p(\mathcal{T}_h)$.

Our model problem is then to find $\mathbf{A} \in \mathbf{H}_0(\mathbf{curl}, \Omega)$ such that

$$(\nabla \times \mathbf{A}, \nabla \times \mathbf{v})_{\Omega} = (\mathbf{J}_h, \mathbf{v})_{\Omega}, \qquad (\mathbf{A}, \nabla q)_{\Omega} = 0,$$

for all $\mathbf{v} \in \mathbf{H}_0(\mathbf{curl}, \Omega)$ and $q \in H_0^1(\Omega)$.

 $\mathbf{A}_h \in \mathbf{N}_p(\mathcal{T}_h) \cap \mathbf{H}_0(\mathbf{curl}, \Omega)$ is the Nédélec approximation of \mathbf{A} .

Prager-Synge theorem

Equilibrated flux

$$\boldsymbol{B}_h \in \boldsymbol{H}(\operatorname{curl},\Omega); \quad \nabla \times \boldsymbol{B}_h = \boldsymbol{J}_h$$

Error estimate

$$\|\mathbf{\nabla} \times (\mathbf{A} - \mathbf{A}_h)\|_{\Omega} \leq \|\mathbf{B}_h - \mathbf{\nabla} \times \mathbf{A}_h\|_{\Omega}$$

The "ideal" flux $\mathbf{B} := \nabla \times \mathbf{A}$ saturates the bound.

The issue with localization (1/2)

We follow the same steps than for the Poisson problem.

The ideal flux is $\mathbf{B} := \nabla \times \mathbf{A}$. If we set $\mathbf{B}^{\mathbf{a}} := \psi_{\mathbf{a}} \nabla \times \mathbf{A}$, then

$$\nabla \times \mathbf{B}^{\mathbf{a}} = \psi_{\mathbf{a}} \mathbf{J}_{\mathbf{h}} + \nabla \psi_{\mathbf{a}} \times \nabla \times \mathbf{A},$$

so that

The issue with localization (2/2)

Recall that

Unfortunately, we can not set

$$\begin{array}{c} \boldsymbol{B_h^a} := \arg \min_{ \begin{subarray}{c} \boldsymbol{v_h} \in \boldsymbol{N_{p+1}}(T_h^a) \cap \boldsymbol{H_0}(\boldsymbol{\operatorname{curl}}, \boldsymbol{\omega_a}) \\ \nabla \times \boldsymbol{v_h} = \boldsymbol{\psi_a} \boldsymbol{J_h} + \nabla \boldsymbol{\psi_a} \times \nabla \times \boldsymbol{A_h} \end{subarray}} \| \boldsymbol{v_h} - \boldsymbol{\psi_a} \nabla \times \boldsymbol{A_h} \|_{\boldsymbol{\omega_a}} \end{array}$$

as the minimization set is empty: the field

$$\psi_{\mathbf{a}} \mathbf{J}_{\mathbf{h}} + \nabla \psi_{\mathbf{a}} \times \nabla \times \mathbf{A}_{\mathbf{h}}$$

is not divergence-free!

Here, I will detail the last construction.

The idea

Let $\theta^a := \nabla \psi_a \times \nabla \times A$. There are two important properties:

$$\sum_{\pmb{a}\in\mathcal{V}_{\pmb{h}}} \pmb{\theta}^{\pmb{a}} = \pmb{0}, \qquad \nabla \cdot \pmb{\theta}^{\pmb{a}} = -\nabla \psi_{\pmb{a}} \cdot \pmb{J}_{\pmb{h}}.$$

At the discrete level, we have

$$\sum_{\boldsymbol{a}\in\mathcal{V}_{\boldsymbol{b}}}(\boldsymbol{\nabla}\psi_{\boldsymbol{a}}\times\boldsymbol{\nabla}\times\boldsymbol{\boldsymbol{A}}_{\boldsymbol{b}})=\boldsymbol{0},\qquad\boldsymbol{\nabla}\cdot(\boldsymbol{\nabla}\psi_{\boldsymbol{a}}\times\boldsymbol{\nabla}\times\boldsymbol{\boldsymbol{A}}_{\boldsymbol{b}})\neq-\boldsymbol{\nabla}\psi_{\boldsymbol{a}}\cdot\boldsymbol{\boldsymbol{J}}_{\boldsymbol{b}}.$$

It is tempting to set

$$\begin{array}{l} \boldsymbol{\theta_h^a} := \arg \min_{\substack{\boldsymbol{v} \in \boldsymbol{RT}_p(\mathcal{T}_a^h) \cap \boldsymbol{H}_0(\operatorname{div}, \omega_a) \\ \nabla \cdot \boldsymbol{v} = -\nabla \psi_a \cdot \boldsymbol{J}_h}} \|\boldsymbol{v} - \nabla \psi_a \times \nabla \times \boldsymbol{A}_h\|_{\omega_a}, \end{array}$$

but it does not sum up to zero.

Trick #1: Over-constrained minimization

We instead set

$$\begin{aligned} \widehat{\boldsymbol{\theta}_h^a} &:= \arg \min_{ \substack{\boldsymbol{v} \in RT_p(\mathcal{T}_h^a) \cap H_0(\operatorname{div}, \omega_a) \\ (\boldsymbol{v} - \nabla \psi_a \times \nabla \times \mathbf{A_h}, r)_{\omega_a} = 0 \ \forall r \in \mathcal{P}_0(\mathcal{T}_h^a) \\ \nabla \cdot \mathbf{v} = - \nabla \psi_a \cdot J_h} } \| \boldsymbol{v} - \nabla \psi_a \times \nabla \times \mathbf{A_h} \|_{\omega_a}, \end{aligned}$$

where the mean-value constrain works because A_h solves the discrete problem. We then set

$$\widehat{\boldsymbol{\theta}}_h := \sum_{\boldsymbol{a} \in \mathcal{V}_h} \widehat{\boldsymbol{\theta}}_h^{\boldsymbol{a}}.$$

Importantly, we have

$$(\widehat{\boldsymbol{\theta}}_{h}, \boldsymbol{r})_{\Omega} = 0 \quad \forall \boldsymbol{r} \in \boldsymbol{\mathcal{P}}_{0}(\mathcal{T}_{h}).$$

Trick #2: Divergence-free decomposition of $\widehat{\theta}$ (1/2)

The $\widehat{\boldsymbol{\theta}}_h^a$ have the correct divergence, but does not sum up to zero. We need a divergence-free decomposition of $\widehat{\boldsymbol{\theta}}_h$ into contributions $\widetilde{\boldsymbol{\theta}}_h^a$.

We set for each $\mathbf{a} \in \mathcal{V}_{\mathbf{h}}$ and $K \in \mathcal{T}_{\mathbf{h}}^{\mathbf{a}}$

This is indeed well-posed since

$$(\psi_{\mathbf{a}}\widehat{\boldsymbol{\theta}}_{h} \cdot \boldsymbol{n}_{K}, 1)_{\partial K} = (\psi_{\mathbf{a}}, \widehat{\boldsymbol{\theta}}_{h} \cdot \boldsymbol{n}_{K})_{\partial K}$$
$$= (\nabla \psi_{\mathbf{a}}, \widehat{\boldsymbol{\theta}}_{h})_{K} + (\nabla \cdot \widehat{\boldsymbol{\theta}}_{h}, \psi_{\mathbf{a}})_{K}$$
$$= 0.$$

Trick #2: Divergence-free decomposition of $\hat{\theta}$ (2/2)

We can then actually show that

$$\sum_{\mathbf{a}\in\mathcal{V}_h}\widetilde{\boldsymbol{\theta}}_h^{\mathbf{a}}=\widehat{\boldsymbol{\theta}}_h,$$

so that setting

$$\boldsymbol{\theta_h^a} := \widehat{\boldsymbol{\theta}_h^a} - \widetilde{\boldsymbol{\theta}_h^a} \in \boldsymbol{H}_0(\operatorname{div}, \omega_a),$$

we have

$$\nabla \cdot \boldsymbol{\theta}_h^a = -\nabla \psi_a \cdot \boldsymbol{J}_h, \qquad \sum_{a \in \mathcal{V}_h} \boldsymbol{\theta}_h^a = \mathbf{0}.$$

Local flux contruction and efficiency

Since the θ_h^a have all the required properties, we can now set

$$\begin{array}{l} \boldsymbol{B_h^a} := \arg \min_{\substack{\boldsymbol{v}_h \in \boldsymbol{N}_{p+1}(\mathcal{T}_h^a) \cap \boldsymbol{H}_0(\boldsymbol{\operatorname{curl}}, \omega_a) \\ \nabla \times \boldsymbol{v}_h = \psi_a \boldsymbol{J}_h + \boldsymbol{\theta}_h^a}} \|\boldsymbol{v}_h - \psi_a \nabla \times \boldsymbol{A}_h\|_{\omega_a}, \end{array}$$

and we construct an equilibrated flux as

$$\mathbf{B}_h := \sum_{\mathbf{a} \in \mathcal{V}_h} \mathbf{B}_h^{\mathbf{a}}.$$

Efficiency

$$\|\mathbf{B}_h - \nabla \times \mathbf{A}_h\|_K \lesssim \|\nabla \times (\mathbf{A} - \mathbf{A}_h)\|_{\widetilde{K}}$$

The hidden constant does not depend on p.
