New Fixed Time and Fast Converging Reduced Order Observers

Abstract—For nonlinear continuous-time systems with continuous measurements of the output, we provide new reduced order observers that converge in finite time. The convergence time is independent of the initial state. For cases where the measurements are discrete, we provide asymptotically converging observers, whose rate of convergence is proportional to the negative of the logarithm of the size of the sampling interval. Our observers are based on the observability Gramian.

I. Introduction

As explained in [11], finite time observers offer considerable promise for an ever-growing range of practical applications, because of their ability to compute exact values of states in a finite time, and many contributions are devoted to the design of observers of this type. Some of them use delays, dynamic extensions, homogenous functions, sliding mode, or unbounded gains; see for instance, [2], [3], [5], [7], [14], and [17]. The works [11] and [15] are different because they use observers with impulses and no delay.

In this paper, we continue our work on the design of fixed time observers. Fixed time convergence means that the convergence time is independent of the initial state. This differs from semi-global works such as [18] whose finite convergence time depends on the initial state. As in [11], we provide new reduced order observers for continuous-time nonlinear systems, first when there are continuous output measurements and next in the case where there are only discrete output measurements. When continuous measurements are available, we provide observers that converge in finite time. When only discrete measurements are available, we provide observers that do not converge in finite time, but which do converge asymptotically with a rate of convergence that is proportional to the negative of the logarithm of the size of the sampling interval. This ensures arbitrarily fast convergence, by picking the sampling interval small enough.

The fundamental difference between [11] and the present paper is that the observer we introduce is not based on the one proposed in [15]. Instead, the observer we propose here uses discrete variables and the observability Gramian and the solutions of the observer are continuous. It is also very different from those of [1], [4], [9], [12], and [16], which are based on observers with delays. By not using the delays that occur in earlier observer designs, we obtain simpler reduced order controllers that still enjoy the required fixed

time or arbitrarily fast convergence of the observation error to zero. Our convergence proof for our second observer uses the trajectory based approach, which was introduced in [10] and developed in several papers such as [13].

The paper is organized as follows. Our observer result under continuous measurements is stated and proven in Section II, and Section III provides our analog for cases where only discrete measurements are available. We illustrate our approach in Section IV, using a pendulum example. We summarize our results and our suggestions for further research in Section V.

Notation. We use standard notation, which we simplify when no confusion would arise. The dimensions of our Euclidean spaces are arbitrary, unless we indicate otherwise. The standard Euclidean 2-norm, and its induced matrix norm, are denoted by $|\cdot|$, $|\cdot|_S$ denotes the essential supremum over any set S, $\mathbb{N} = \{1, 2, \ldots\}$, and $\mathbb{Z}_{\geq 0} = \{0\} \cup \mathbb{N}$. We let I denote the identity matrix of any dimension.

II. OBSERVERS FOR CONTINUOUS MEASUREMENTS

A. Statement of Result

We consider the system

$$\begin{cases} \dot{\xi}(t) &= \mathcal{A}\xi(t) + \mathcal{F}(\mathcal{C}\xi(t), u(t)) + \kappa(t) \\ Y(t) &= \mathcal{C}\xi(t) + \epsilon(t) \end{cases}$$
 (1)

where ξ is valued in \mathbb{R}^n , the piecewise continuous locally bounded function u is valued in \mathbb{R}^p , the output Y is valued in \mathbb{R}^q , κ and ϵ are locally bounded and piecewise continuous and represent disturbances, and \mathcal{F} is a nonlinear locally Lipschitz function such that (1) is forward complete. Assume:

Assumption 1: The pair
$$(A, C)$$
 is observable.

Then (e.g. from [8, pp. 304-306]) with an appropriate decomposition of the state vector ξ , we obtain

$$\begin{cases} \dot{\xi}_{1}(t) &= A_{1}\xi_{1}(t) + F_{1}(\xi_{2}(t), u(t)) + \kappa_{1}(t) \\ \dot{\xi}_{2}(t) &= A_{2}\xi_{1}(t) + F_{2}(\xi_{2}(t), u(t)) + \kappa_{2}(t) \\ Y(t) &= \xi_{2}(t) + \epsilon(t) \end{cases}$$
(2)

where F_1 and F_2 are locally Lipschitz functions, and where the pair (A_1,A_2) is observable. By a change of coordinates, we can assume that $A_1 \in \mathbb{R}^{(n-q)\times (n-q)}$ is an invertible matrix. (If A_1 were not invertible, then we could replace it by a new one $A_2 + LA_2$ where L is such that $A_2 + LA_2$ is Hurwitz, by applying the change of coordinates $\xi_3(t) = \xi_1(t) + L\xi_2(t)$, using the fact that if (A_1,A_2) is observable then so is $(A_1 + LA_2,A_2)$.) Observability of (A_1,A_2) and the invertibility of A_1 imply that for any constant $\nu > 0$ and with the choice

$$H = A_2 A_1^{-1} \in \mathbb{R}^{q \times (n-q)},$$
 (3)

the $(n-q) \times (n-q)$ matrix

$$W = \left(\int_0^{\nu} \left(e^{A_1^{\top} \ell} - I \right) H^{\top} H \left(e^{A_1 \ell} - I \right) d\ell \right)^{-1} \tag{4}$$

is invertible. This follows from the fact that if there were a nonzero vector V such that $H\left(e^{A_1\ell}-I\right)V=0$ for all $\ell\in[0,\nu]$ then all of the derivatives of $H\left(e^{A_1\ell}-I\right)V$ with respect to ℓ are equal to zero, which implies that $HA_1V=0$, $HA_1^2V=0$, ..., $HA_1^nV=0$, which yields a contradiction with the fact that (A_1,A_2) is observable.

Let $\alpha: \mathbb{R} \to \mathbb{R}^{(n-q) \times q}$ be defined by

$$\alpha(\ell) = W\left(e^{A_1^{\top}\ell} - I\right)H^{\top}.$$

Let $t_i = i\nu$ for all $i \in \mathbb{Z}_{\geq 0}$ and σ be the function defined by $\sigma(t) = t_i$ when $t \in [t_i, t_{i+1})$. We define $\zeta : \mathbb{R} \to \mathbb{R}^{n-q}$ by

$$\zeta(t) = \int_{\sigma(t)}^{t} e^{A_{1}(t-s)} \kappa_{1}^{\sharp}(s) ds
-e^{A_{1}(t-\sigma(t))} \int_{\sigma(t)}^{t} \alpha(s-\sigma(t)) \left[\int_{\sigma(t)}^{s} \kappa_{2}^{\sharp}(\ell) d\ell
+A_{2} \int_{\sigma(t)}^{s} \int_{\sigma(t)}^{m} e^{A_{1}(m-\ell)} \kappa_{1}^{\sharp}(\ell) d\ell dm \right] ds
-e^{A_{1}(t-\sigma(t))} \int_{\sigma(t)}^{t} \alpha(s-\sigma(t)) (\epsilon(s) - \epsilon(\sigma(t))) ds$$
(6)

where for i = 1 and 2,

$$\kappa_i^{\sharp} = \kappa_i + \Delta_i \text{ and}$$

$$\Delta_i(t) = F_i(\xi_2(t), u(t)) - F_i(Y(t), u(t)).$$
(7)

We propose a candidate observer:

$$\begin{cases} \dot{\xi}_{\star,1}(t) &= A_1 \xi_{\star,1}(t) + F_1(Y(t), u(t)) \\ \dot{\xi}_{\star,2}(t) &= A_2 \xi_{\star,1}(t) + F_2(Y(t), u(t)) \\ \dot{\hat{x}}_1(t) &= A_1 \hat{x}_1(t) + e^{A_1(t-t_i)} \alpha(t-t_i) \left[Y(t) - \xi_{\star,2}(t) - Y(t_i) + \xi_{\star,2}(t_i) - H \left(e^{A_1(t-t_i)} - I \right) \hat{x}_1(t_i) \right], \\ &- H \left(e^{A_1(t-t_i)} - I \right) \hat{x}_1(t_i) \right], \\ &\text{for all } t \in [t_i, t_{i+1}) \text{ and } i \in \mathbb{Z}_{\geq 0}, \end{cases}$$
(8)

whose first two equations are solved for all $t \geq 0$, and whose last equation is solved successively on the intervals $[t_i,t_{i+1})$ for all $i \in \mathbb{Z}_{\geq 0}$ with the initial state $\hat{x}_1(t_0) = 0$ at time $t_0 = 0$ and the initial states for \hat{x}_1 at the times t_i for $i \geq 1$ given by the left limits $\hat{x}_1(t_i^-)$ for $i \geq 1$ (which we write more concisely as $\hat{x}_1(t_i)$ in our observer formula).

We are ready to state and prove the following result:

Theorem 1: Let Assumption 1 hold. Then for all initial states of (2), the solutions of (2) and (8) are such that

$$\xi_1(t) = \hat{x}_1(t) + \xi_{\star,1}(t) + \zeta(t) \tag{9}$$

for all $t \ge \nu$, where ζ is defined by (6).

Remark 1: In order to describe how precisely $\hat{x}_1(t) + \xi_{\star,1}(t)$ estimates $\xi_1(t)$, let us define the constant

$$\bar{\alpha} = |\alpha|_{[0,\nu]} \tag{10}$$

and observe that

$$|\zeta(t)| \leq \nu e^{|A_{1}|\nu} \overline{\alpha} \left[\int_{\sigma(t)}^{t} |\kappa_{2}^{\sharp}(\ell)| d\ell + \nu |A_{2}| e^{\nu |A_{1}|} \int_{\sigma(t)}^{t} |\kappa_{1}^{\sharp}(\ell)| d\ell \right] ds + e^{\nu |A_{1}|} \int_{\sigma(t)}^{t} |\kappa_{1}^{\sharp}(\ell)| d\ell + e^{\nu |A_{1}|} \overline{\alpha} \int_{\sigma(t)}^{t} |\epsilon(s) - \epsilon(\sigma(t))| ds$$

$$(11)$$

for all $t \geq 0$. Consequently, if there are constants $K_i \geq 0$ that satisfy the requirements from Assumption 2, then

$$\begin{aligned} &|\zeta(t)| \leq \overline{\zeta}_1 \int_{\sigma(t)}^t (|\kappa_1(\ell)| + |\kappa_2(\ell)|) d\ell + \overline{\zeta}_2 \int_{\sigma(t)}^t |\epsilon(\ell)| d\ell \\ &+ e^{\nu|A_1|} \bar{\alpha} \int_{\sigma(t)}^t |\epsilon(s) - \epsilon(\sigma(t))| ds \end{aligned} \tag{12}$$

for all $t \geq 0$, where

$$\overline{\zeta}_1 = \max\left\{\nu^2\overline{\alpha}|A_2|e^{2\nu|A_1|} + e^{\nu|A_1|}, \nu e^{|A_1|\nu}\overline{\alpha}\right\} \text{ and } (13)$$

$$\overline{\zeta}_2 = \max \left\{ \nu^2 \overline{\alpha} |A_2| e^{2\nu |A_1|} K_1, \nu e^{|A_1|\nu} \overline{\alpha} K_2 \right\}. \tag{14}$$

Thus,

$$\begin{aligned} &|\xi_{1}(t) - \hat{x}_{1}(t) - \xi_{\star,1}(t)| \leq \nu \overline{\zeta}_{2} \sup_{\ell \in [\sigma(t),t]} |\epsilon(\ell)| \\ &+ \nu \overline{\zeta}_{1} \sup_{\ell \in [\sigma(t),t]} (|\kappa_{1}(\ell)| + |\kappa_{2}(\ell)|) \\ &+ \nu e^{\nu|A_{1}|} \overline{\alpha} \sup_{\ell \in [\sigma(t),t]} |\epsilon(\ell) - \epsilon(\sigma(t))| \end{aligned} \tag{15}$$

for all $t > \nu$.

B. Proof of Theorem 1

We introduce the variables

$$x_1(t) = \xi_1(t) - \xi_{\star,1}(t), \ x_2(t) = \xi_2(t) - \xi_{\star,2}(t),$$

$$\tilde{x}_1(t) = x_1(t) - \hat{x}_1(t), \ H^{\sharp}(t,s) = H\left(e^{A_1(t-s)} - I\right), \ (16)$$
and $\epsilon^{\sharp}(t,s) = -e^{A_1(t-s)}\alpha(t-s)[\epsilon(t) - \epsilon(s)].$

We observe that

$$\dot{\hat{x}}_1(t) = A_1 \hat{x}_1(t) + e^{A_1(t-t_i)} \alpha(t-t_i) \left[y(t) - y(t_i) - H \left(e^{A_1(t-t_i)} - I \right) \hat{x}_1(t_i) \right]$$
(17)

with $y(t) = x_2(t) + \epsilon(t)$ and

$$\begin{cases} \dot{x}_{1}(t) &= A_{1}x_{1}(t) + \kappa_{1}^{\sharp}(t) \\ \dot{x}_{2}(t) &= A_{2}x_{1}(t) + \kappa_{2}^{\sharp}(t) \\ \dot{\tilde{x}}_{1}(t) &= A_{1}\tilde{x}_{1}(t) + \epsilon^{\sharp}(t, t_{i}) \\ &- e^{A_{1}(t - t_{i})}\alpha(t - t_{i})\left[x_{2}(t) - x_{2}(t_{i}) + H\left(e^{A_{1}(t - t_{i})} - I\right)\hat{x}_{1}(t_{i})\right] + \kappa_{1}^{\sharp}(t). \end{cases}$$
(18)

By applying variation of parameters to the x_1 -subsystem in (18), then integrating the result, we obtain

$$x_{2}(t) = x_{2}(t_{i}) + H\left(e^{A_{1}(t-t_{i})} - I\right)x_{1}(t_{i}) + \int_{t_{i}}^{t} \kappa_{2}^{\sharp}(\ell)d\ell + A_{2}\int_{t_{i}}^{t} \int_{t_{i}}^{m} e^{A_{1}(m-\ell)}\kappa_{1}^{\sharp}(\ell)d\ell dm$$
(19)

for all $t \in [t_i, t_{i+1}]$. By combining (18)-(19), we get

$$\dot{x}_{1}(t) = A_{1}\tilde{x}_{1}(t) - e^{A_{1}(t-t_{i})}\alpha(t-t_{i}) \left[H^{\sharp}(t,t_{i})x_{1}(t_{i}) - H^{\sharp}(t,t_{i})\hat{x}_{1}(t_{i})\right] + \epsilon^{\sharp}(t,t_{i}) \\
-e^{A_{1}(t-t_{i})}\alpha(t-t_{i}) \left[\int_{t_{i}}^{t} \kappa_{2}^{\sharp}(\ell)d\ell + A_{2}\int_{t_{i}}^{t} \int_{t_{i}}^{m} e^{A_{1}(m-\ell)}\kappa_{1}^{\sharp}(\ell)d\ell dm\right] + \kappa_{1}^{\sharp}(t) \quad (20) \\
= A_{1}\tilde{x}_{1}(t) - e^{A_{1}(t-t_{i})}\alpha(t-t_{i})H^{\sharp}(t,t_{i})\tilde{x}_{1}(t_{i}) \\
+\epsilon^{\sharp}(t,t_{i}) - e^{A_{1}(t-t_{i})}\alpha(t-t_{i}) \left[\int_{t_{i}}^{t} \kappa_{2}^{\sharp}(\ell)d\ell + A_{2}\int_{t_{i}}^{t} \int_{t_{i}}^{m} e^{A_{1}(m-\ell)}\kappa_{1}^{\sharp}(\ell)d\ell dm\right] + \kappa_{1}^{\sharp}(t).$$

By integrating this equation over $[t_i, t_{i+1}]$, we obtain

$$\tilde{x}_{1}(t) = e^{A_{1}(t-t_{i})} \tilde{x}_{1}(t_{i}) + \zeta(t) - \int_{t_{i}}^{t} e^{A_{1}(t-m)} e^{A_{1}(m-t_{i})} \alpha(m-t_{i}) H^{\sharp}(m,t_{i}) dm \tilde{x}_{1}(t_{i})$$
(21)

with ζ defined in (6). Thus

$$\tilde{x}_1(t) = \zeta(t)
+ e^{A_1(t-t_i)} \left[I - \int_{t_i}^t \alpha(m-t_i) H^{\sharp}(m,t_i) \mathrm{d}m \right] \tilde{x}_1(t_i)$$
(22)

and so also

$$\tilde{x}_1(t) = \zeta(t) + e^{A_1(t-t_i)} \left[I - \int_{t_i}^t W^{\sharp}(m, t_i) H^{\top} H^{\sharp}(m, t_i) \mathrm{d}m \right] \tilde{x}_1(t_i)$$
(23)

for all $t \in [t_i, t_{i+1}]$ and $i \ge 0$, where

$$W^{\sharp}(m, t_i) = W(e^{A_1^{\top}(m - t_i)} - I), \tag{24}$$

and where the last equality in (23) is a consequence of the definition in (5) of α . Thus in particular, since

$$\zeta(t_{i+1}) = 0, \tag{25}$$

we can specialize (23) to the case where $t = t_{i+1}$ to get

$$\tilde{x}_1(t_{i+1}) =
= e^{A_1 \nu} \left[I - W \int_0^{\nu} (H^{\sharp}(m,0))^{\top} H^{\sharp}(m,0) dm \right] \tilde{x}_1(t_i)$$
(26)

for all $i \in \mathbb{Z}_{\geq 0}$. The definition (4) of W ensures that

$$\tilde{x}_1(t_{i+1}) = 0. (27)$$

From this equality and (23), we deduce that for all $t \ge \nu$

$$\tilde{x}_1(t) = \zeta(t). \tag{28}$$

Since $\tilde{x}_1 = \xi_1 - \xi_{\star,1} - \hat{x}_1$, this allows us to conclude.

III. OBSERVERS FOR DISCRETE MEASUREMENTS

A. Statement of Result

In this part, we consider the case where instead of having continuous measurements of the output, the measurements are only available at discrete instants. For simplicity, we assume that the additive uncertainty ϵ on the measurements is zero, but this section can be generalized to cases where this uncertainty is nonzero. We introduce the sequence $s_k = k\varsigma$ for all $k \in \mathbb{Z}_{>0}$ with a constant $\varsigma > 0$. Consider the system

$$\begin{cases} \dot{\xi}_{1}(t) &= A_{1}\xi_{1}(t) + F_{1}(\xi_{2}(t), u(t)) + \kappa_{1}(t) \\ \dot{\xi}_{2}(t) &= A_{2}\xi_{1}(t) + F_{2}(\xi_{2}(t), u(t)) + \kappa_{2}(t) \\ Y(t) &= \xi_{2}(s_{k}) \text{ for all } t \in [s_{k}, s_{k+1}) \\ &\text{and } k \in \mathbb{Z}_{\geq 0} \end{cases}$$

$$(29)$$

with ξ_1 valued in \mathbb{R}^{n-q} , ξ_2 valued in \mathbb{R}^q , and κ_1 and κ_2 being piecewise continuous and locally bounded. As in Section II, we let (A_1, A_2) be observable and A_1 be invertible. We assume:

Assumption 2: The functions F_1 and F_2 are locally Lipschitz and there are two constants $K_1 \geq 0$ and $K_2 \geq 0$ such that

$$|F_1(a,u) - F_1(b,u)| \le K_1|a-b|$$
 and $|F_2(a,u) - F_2(b,u)| \le K_2|a-b|$ (30)

for all $a \in \mathbb{R}^q$, $b \in \mathbb{R}^q$ and $u \in \mathbb{R}^p$.

Assumption 2 (which is also used in [13]) ensures that (29) is forward complete. However, the main reason why we

impose Assumption 2 is that it will be needed in the proof of Theorem 2. We introduce the candidate observer:

$$\begin{cases} \dot{\xi}_{\star,1}(t) &= A_{1}\xi_{\star,1}(t) + F_{1}(\omega(t), u(t)) \\ \dot{\xi}_{\star,2}(t) &= A_{2}\xi_{\star,1}(t) + F_{2}(\omega(t), u(t)) \\ \dot{\hat{x}}_{1}(t) &= A_{1}\hat{x}_{1}(t) \\ &+ e^{A_{1}(t-t_{i})}\alpha(t-t_{i})\left[\omega(t) - \xi_{\star,2}(t) - \omega(t_{i}) + \xi_{\star,2}(t_{i}) - H\left(e^{A_{1}(t-t_{i})} - I\right)\hat{x}_{1}(t_{i})\right] \\ &- H\left(e^{A_{1}(t-t_{i})} - I\right)\hat{x}_{1}(t_{i}) \\ \dot{\omega}(t) &= A_{2}[\hat{x}_{1}(t) + \xi_{\star,1}(t)] + F_{2}(\omega(t), u(t)) \\ &\text{for all } t \in [s_{k}, s_{k+1}) \text{ and } k \in \mathbb{Z}_{\geq 0} \\ \omega(s_{k}) &= \xi_{2}(s_{k}) \text{ for all } k \in \mathbb{Z}_{\geq 0} \end{cases}$$

with α defined in (5) and $H=A_2A_1^{-1}$ as before, and where the solutions of (5) are defined analogously to those of (8) with $\omega(0)=0$. This observer is inspired by the one used in [6]. We also use the constant $\overline{\alpha}$ from (10), and W from (4). Let us introduce the function $\beta:\mathbb{R}\to\mathbb{R}^{(n-q)\times(n-q)}$ defined by

$$\beta(\ell) = e^{A_1 \ell} \left[I - W \int_0^\ell (H^{\sharp}(m,0))^{\top} H^{\sharp}(m,0) \mathrm{d}m \right]$$
 (32)

with $H^{\sharp}(t,s) = H\left(e^{A_1(t-s)} - I\right)$ as before, and the constant

$$\overline{\beta} = |\beta|_{[0,\nu]}.\tag{33}$$

In terms of our sample rates ν and ς for the t_i 's and s_k respectively, the constant $\overline{\alpha}$ from (10), and the constants

$$\overline{c}_1 = |A_2| \max{\{\overline{\beta}, 1\}} e^{|A_1|\nu} \overline{c}_5(\varsigma + 2\nu) + K_2, \tag{34}$$

$$\overline{c}_2 = 2 \max{\{\overline{\beta}, 1\}} \overline{c}_5 e^{|A_1|\nu + \frac{\ln(\varsigma \overline{c}_1)}{3\nu + \varsigma}(-6\nu - \varsigma)}, \quad (35)$$

$$\overline{c}_3 = 2\max\{\overline{\beta},1\}e^{|A_1|\nu}\overline{c}_5\varsigma \frac{\nu|A_2|\overline{c}_4+1}{1-\varsigma\overline{c}_1} + \overline{c}_4, \tag{36}$$

$$\overline{c}_4 = e^{|A_1|\nu} \max \left\{ \nu \overline{\alpha}, \nu^2 \overline{\alpha} |H| (e^{|A_1|\nu} - 1) + 1 \right\}, \quad (37)$$

and

$$\overline{c}_5 = e^{|A_1|\nu} \overline{\alpha} \nu \left[|H| K_1 \left(e^{|A_1|\nu} - 1 \right) + K_2 \right]
+ K_1 + 2e^{|A_1|\nu} \overline{\alpha},$$
(38)

our main result of this section is:

Theorem 2: Let (29) satisfy Assumption 2 and let

$$\varsigma \overline{c}_1 < 1$$
(39)

hold. Then all solutions of (29) and (31) are such that

Remark 2: Condition (40) gives an exponential convergence rate of $-\ln(\varsigma \overline{c}_1)/(3\nu + \varsigma)$, which converges to $+\infty$ as the sample rate ς for the sequence $\{s_k\}$ converges to 0. Hence, we can ensure arbitrarily fast convergence. Condition (39) imposes a constraint on the size of the sampling interval length ς , and ν can be chosen by the designer of the observer.

In the second step, we perform a stability analysis for the error variables. In the final step, we use the trajectory based approach from [10] and the contractivity condition from (39) to obtain the final error estimation from our theorem.

$$|\tilde{x}_{1}(t)| \leq 2 \max\{\overline{\beta}, 1\} e^{|A_{1}|\nu} \overline{c}_{5} \nu |r|_{[0, \varsigma + 3\nu]} e^{\frac{\ln(\varsigma \overline{c}_{1})}{3\nu + \varsigma} (t - 6\nu - \varsigma)} + \nu \left[2 \max\{\overline{\beta}, 1\} e^{|A_{1}|\nu} \overline{c}_{5} \varsigma \frac{\nu |A_{2}| \overline{c}_{4} + 1}{1 - \varsigma \overline{c}_{1}} + \overline{c}_{4} \right] |\tilde{\kappa}|_{[0, t]}.$$

This allows us to conclude the proof.

IV. ILLUSTRATIONS

As in [11], we first study a pendulum model

$$\begin{cases}
\dot{a}_1(t) &= a_2(t) \\
\dot{a}_2(t) &= -\sin(a_1(t)), \\
z(t) &= a_1(s_j) \text{ if } t \in [s_j, s_{j+1})
\end{cases}$$
(71)

with the a_i 's valued in \mathbb{R} .

The change of coordinates given by $\xi_1(t) = a_1(t) + a_2(t)$ and $\xi_2(t) = a_1(t)$ transforms the system (71) into

$$\begin{cases} \dot{\xi}_{1}(t) = \xi_{1}(t) - \xi_{2}(t) - \sin(\xi_{2}(t)) \\ \dot{\xi}_{2}(t) = \xi_{1}(t) - \xi_{2}(t) \\ y(t) = \xi_{2}(s_{i}) \text{ if } t \in [s_{i}, s_{i+1}) \end{cases}$$
(72)

which is covered by Theorem 2.

Then, with the notation of the previous section, we take $A_1=A_2=1$, $F_1(\xi_2)=-\xi_2-\sin(\xi_2)$ and $F_2(\xi_2)=-\xi_2$, $K_1=2$, and $K_2=1$. Simple calculations show that in this case, the function α that we defined in (5) is

$$\alpha(m) = \frac{e^m - 1}{\frac{e^{2\nu - 1}}{2} - 2(e^{\nu} - 1) + \nu}$$
 (73)

and therefore also the observer

$$\begin{cases} \dot{\xi}_{\star,1}(t) &= \xi_{\star,1}(t) - \omega(t) - \sin(\omega(t)) \\ \dot{\xi}_{\star,2}(t) &= \xi_{\star,1}(t) - \omega(t) \\ \dot{\hat{x}}_{1}(t) &= \hat{x}_{1}(t) \\ &+ \frac{2e^{t-t_{i}}(e^{t-t_{i}}-1)}{e^{2\nu-1-4(e^{\nu-1})+2\nu}} \left[\omega(t) - \omega(t_{i}) \right. \\ &- \xi_{\star,2}(t) + \xi_{\star,2}(t_{i}) \\ &- \left(e^{(t-t_{i})} - I\right) \hat{x}_{1}(t_{i}) \right] \\ &\text{for all } t \in [t_{i}, t_{i+1}) \text{ and } i \in \mathbb{Z}_{\geq 0} \\ \dot{\omega}(t) &= \hat{x}_{1}(t) + \xi_{\star,1}(t) - \omega(t) \\ &\text{for all } t \in [s_{k}, s_{k+1}) \text{ and } k \in \mathbb{Z}_{\geq 0} \\ \omega(s_{k}) &= \xi_{2}(s_{k}) \text{ for all } k \in \mathbb{Z}_{\geq 0} \end{cases}$$

which differs from the observers in [11] which have delays.

We can also apply Theorem 1 to design observers for the single link robotic manipulator dynamics in [11], to achieve a similar advantage of having observers that are free of delay terms while providing a fixed convergence time (which is a stronger result than the finite time convergence result in [18]), but without requiring the use of delayed output measurements that were required in [11].

V. CONCLUSION

We provided a new class of observers for which the finite convergence time of the observer value to the true unknown state value is independent of the initial state, when continuous measurements of the output are available. By not requiring delayed output values in the observer, and by providing a reduced order observer structure, our methods may offer computational advantages as compared with earlier methods. Our methods apply to a a family of continuous-time systems, and are based on the observability Gramian. We adapted this observer to cases where only discrete time measurements are available, where one instead obtains arbitrarily fast convergence. Extensions including new robustness results can be proved and time-varying version are expected.
