- Question: Is nivolumab treatment safe and effective in HIV-infected patients with pretreatedadvanced non-small cell lung cancer (NSCLC)?
- 57 Findings: In this nonrandomized, open-label, phase 2 study of 16 patients with HIV infection
- and previously treated advanced NSCLC, nivolumab was well-tolerated and beneficial.
- 59 Disease control rate was 62.5% at 8 weeks. Most treatment-related adverse events were of
- 60 grade 1 and 2. One patient had a treatment-related serious adverse event. HIV viral load
- 61 remained undetectable (or controlled) throughout the study.
- 62 Meaning: Patients with controlled HIV infection can benefit from nivolumab treatment for
- 63 pretreated advanced NSCLC. Studies in first-line settings are required in this population.

- 66 **Importance:** Therapies targeting immune checkpoints, such as the programmed cell death 1
- 67 (PD-1) receptor, have become the standard-of-care for patients with non-small cell lung
- 68 cancer (NSCLC), but people living with HIV (PLWH) were excluded from these studies.
- 69 Objective: To evaluate the efficacy and tolerability of nivolumab in PLWH with advanced70 NSCLC.

Design: The CHIVA2 study was a nonrandomized, open-label, phase 2 clinical trial in
PLWH with previously treated advanced NSCLC.

73 Setting: National multicenter prospective study.

Participants: patients had viral load of <200 copies/mL, regardless of their CD4+ T-cell</li>
count.

76 Intervention: Nivolumab was administered in second or third line, as monotherapy

intravenously at 3 mg/kg every 2 weeks, until disease progression or limiting toxicity.

Main Outcomes and Measures: The primary endpoint was disease control rate, evaluated
using the Response Evaluation Criteria in Solid Tumors, version 1.1. Adverse events were
graded using the National Cancer Institute Common Terminology Criteria for Adverse
Events, version 4.0.

82 Results: Sixteen patients with advanced NSCLC were enrolled: 14 (88%) were men, median 83 age was 58 years (range: 44-71), and all were smokers. The median duration of nivolumab treatment was 3.5 months (range: 0.5-26.5). The median follow-up was 23.6 months. Disease 84 control rate was 62.5% for 15 evaluable patients at 8 weeks (2 with partial response, 8 with 85 86 stable disease, and 5 with disease progression). Twelve (75%) patients had treatment-related adverse events, which were mild or moderate, except for one patient experiencing severe 87 pruritus, onycholysis, and pemphigoid. There were no opportunistic infections or unexpected 88 89 immune-related events. HIV viral load was stable during treatment. An increase in proliferating CD8+ and CD4+ T-cells was observed after 3 nivolumab cycles in a subgroup 90 of 9 patients. 91

92	Conclusions and Relevance: Second/third-line nivolumab treatment was well-tolerated and
93	beneficial in PLWH with NSCLC. Future trials should investigate immune checkpoint
94	inhibitors in first-line settings.

#### 103 Introduction

Antiretroviral therapy (ART) has significantly extended life expectancy for people living with human immunodeficiency virus (HIV) infection (PLWH). In parallel, mortality due to non-acquired immune deficiency syndrome-defining cancers, particularly lung cancer, has risen<sup>1</sup>. In these patients, immunosuppressive cancer therapies such as chemotherapy and radiotherapy can cause an initial decline in CD4<sup>+</sup> T-cell counts, which is associated with an increased mortality hazard<sup>2</sup>.

110 Cancer therapy targeting immune checkpoint (IC) pathways, including the programmed cell 111 death 1 (PD-1) receptor/programmed cell death ligand (PD-L)1/2 pathway, has become the 112 standard-of-care for non-small cell lung cancer (NSCLC) in the general population, initially 113 as second-line, then as first-line treatment in patients with PD-L1 expression on  $\geq$ 50% of 114 tumor cells, and in combination with chemotherapy in all patients, except those with 115 oncogene-driven NSCLC<sup>3</sup>. However, PLWH were excluded from these clinical trials due to

- 116 concerns that T-cell stimulation may reactivate HIV infection or exacerbate immune
- 117 responses to HIV-related opportunistic infections<sup>4</sup>.

118 In vitro studies show that HIV-infected memory CD4<sup>+</sup> T-cells preferentially express PD-1,

- suggesting that IC inhibitors (ICIs) could reinvigorate the CD4<sup>+</sup> T-cell HIV reservoir<sup>5</sup>.
- 120 PD-1/PD-L1 blockade facilitates latency reversal in cells from ART-treated individuals,
- 121 leading to increased virus production<sup>6</sup>. It also restores specific CD8<sup>+</sup> and CD4<sup>+</sup> T-cell
- 122 functions i.e. cytokine and cytotoxic molecules' production and cell proliferation<sup>7,8</sup>.
- 123 Retrospective studies have shown that ICIs are generally well-tolerated in PLWH with
- advanced stage NSCLC, with no or transient effects on HIV viral load (VL) observed<sup>4,9</sup>. At
- the time of initiating this trial, only case reports and studies in small cohorts were reported,
- 126 but no phase 2 trial had been conducted in this setting.
- 127 We conducted a phase 2 prospective study to investigate the tolerability and efficacy of
- nivolumab, a fully human anti-PD-1 antibody, in PLWH with advanced NSCLC, after prior
- 129 platinum-based doublet chemotherapy.

#### 130 Methods

Sixteen patients with combined (c)ART-controlled HIV-1 infection (VL <200 copies/mL), 131 regardless of their CD4<sup>+</sup> T-cell count, and histologically/cytologically proven NSCLC stage 132 IIIB or IV at diagnosis or after relapse post-surgery were included. Patients had received at 133 134 least one prior platinum-based doublet chemotherapy regimen. Full inclusion and exclusion criteria are provided in the trial's protocol (Supplement 1). Nivolumab was administered 135 intravenously over 30 minutes at 3 mg/kg every 2 weeks, until disease progression or limiting 136 137 toxicity. The protocol was approved by an independent ethics committee and the French health authorities (ANSM). Written informed consent was obtained from each patient. 138

The primary endpoint was disease control rate (DCR) at 8 weeks. Secondary endpoints
included progression free survival (PFS) and overall survival (OS). Adverse events (AEs)
were graded using the National Cancer Institute Common Terminology Criteria for AEs v4.0.
Phenotypes of T-cell activation/proliferation were explored in a subgroup of 9 patients at
baseline, at cycle (C) C2, C3, C9, C15, C27, and C51, and at the end of treatment. The
complete study objectives, assessments, and statistical analyses are provided in the eMethods
(Supplement 2).

## 146 **Results**

147 Sixteen patients were enrolled between December 2017 and July 2019 (eFigure 1,

148 Supplement 3). Baseline characteristics are presented in **Table 1** and eTable 1, Supplement 3.

149 Fourteen (88%) patients were men, median age was 58 years (range: 44-71), and 16 (100%)

150 were smokers. Ten (63%) patients had adenocarcinoma. PD-L1 expression was negative in

151 9/14 (64%) tumors and positive in 5/14 (36%) tumors, with 3 expressing PD-L1 on  $\geq$  50% of

152 cells. Median CD4<sup>+</sup> T-cell count was 385 cells/µL (range: 187-778) and HIV-VL was

153 25 copies/mL (range: 0-44). Patients received nivolumab as second- (69%) or third-line

154 (31%) treatment for a median duration of 3.5 months (range: 0.5-26.5). The median

155 follow-up was 23.6 months (95% confidence interval [CI95%]: 13.9-30).

156 DCR was 62.5% (CI95%: 39-86%) for 15 evaluable patients at 8 weeks, including 2 patients

157 with partial response, 8 with stable disease, and 5 with progressive disease. Median PFS and

158 OS were 3.4 months (CI95%: 1.8-5.6, n=14) and 10.9 months (CI95%: 2.2-not reached,

n=10), respectively (eFigure 2, Supplement 3). Among 9 PD-L1-negative patients, 1 had a

160 partial response, 3 were stable, 4 progressed, and 1 was not determined. Among

161 5 PD-L1-positive patients, 1 had a partial response and 4 were stable.

Twelve (75%) patients had treatment-related AEs, mostly of grade 1 and 2, except for one 162 patient experiencing grade 3 pruritus, onycholysis, and pemphigoid (Table 2). The AE of 163 pemphigoid (grade 2) was also reported as serious. No opportunistic infections or unexpected 164 immune-related events were observed. There were no significant changes in CD4<sup>+</sup> and CD8<sup>+</sup> 165 T-cell counts, and HIV-VL was globally stable during nivolumab treatment (Figure 1). 166 167 In the 9 patients selected for exploratory studies, there was a significant increase in the proportion of CD8<sup>+</sup>Ki67<sup>+</sup> T-cells at C3 compared to C1 (p=0.047) and in the proportion of 168 CD4+Ki67+ T-celles at C3 compared to C1 (p=0.0313) (eFigure 3, Supplement 3). These 169 changes were not associated with better tumor response, since among 4 patients with the 170 highest proportion of CD8<sup>+</sup>Ki67<sup>+</sup> T-cells, tumor progression occurred in 2 cases. 171 PD-1 was almost undetectable on CD4<sup>+</sup> and CD8<sup>+</sup> T-cells from C2 onwards, suggesting high 172 receptor occupancy, whereas T-cell immunoglobulin and mucin domain-containing protein 3 173 (TIM-3) and cytotoxic T-lymphocyte-associated protein 4 (CTLA-4) expression significantly 174 increased at C3 on CD4<sup>+</sup> (p=0.031) and CD8<sup>+</sup> (p=0.015) T-cells, respectively (eFigure 3, 175 Supplement 3). Notably, most of the patients with TIM-3 or CTLA-4 upregulation at C3 were 176 progressing (3/4 and 3/3 patients, respectively). 177

## 178 **Discussion**

In this phase 2 prospective study, the only one focusing on NSCLC, nivolumab was not
associated with HIV-VL rebound, replication blip, or unexpected treatment-emergent safety
signals, in agreement with two other prospective studies in ART-controlled PLWH with solid
tumors<sup>10,11</sup>. Efficacy findings (62.5% DCR at 8 weeks, 3.4 months PFS, and 10.9 months OS)
are consistent with phase 3 studies in the general population<sup>3</sup> and better than in real-life
settings in the same regional population of NSCLC<sup>12</sup>. Patients with PD-L1-positive tumors

seemed to respond better, although this should be confirmed in a larger cohort. Mosttreatment-related AEs were mild or moderate.

As previously observed<sup>7,8</sup>, PD-1 blockade rapidly induced peripheral CD8<sup>+</sup>/CD4<sup>+</sup> T-cell activation, which may reflect a boost in T-cell immunity against the tumor and/or the HIV infection (tissue biopsies were unavailable at this stage to confirm this). However, only 2/4 patients with increased peripheral T-cell counts were responders, supporting preliminary data that suggest independent immune responses elicited by viral infections and within the tumor microenvironment, and imply that antitumor and antiviral treatments may be safely combined<sup>13</sup>.

194 TIM-3 and CTLA-4 were significantly upregulated on CD4<sup>+</sup> and CD8<sup>+</sup> T-cells, respectively,

at C3. This seemed to be associated with tumor progression, suggesting a compensatory
mechanism whereby alternative ICs are upregulated following PD-1/PD-L1 blockade, thus
inhibiting antitumoral T-cell responses. Upregulation of alternative ICs has been observed *in vitro* on activated CD4<sup>+</sup> T-cells and regulatory T-cells in the presence of cancer cells in the
context of ICIs<sup>14</sup>.

### 200 Limitations

Our study is limited by the small sample size, which was due to difficulties in recruiting patients with the rare HIV-NSCLC combination, the study independent data monitoring committee recommended that patient inclusion be stopped in January 2020. The use of ICIs as first-line standard-of-care also rapidly evolved during this trial and led to the premature discontinuation of the study.

## 206 Conclusions

In summary, nivolumab treatment after prior chemotherapy was well-tolerated and beneficial
in PLWH with advanced NSCLC. Future studies should investigate first-line immunotherapy,

- as monotherapy or in combination with chemotherapy or a second ICI. Since the strength of
- our conclusions was limited by the small sample size, we endorse recent recommendations to
- extend inclusion criteria to patients with controlled HIV infection in future trials $^{15}$ .

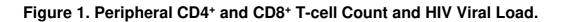

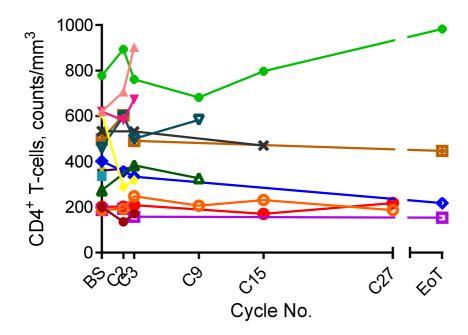
