- Observations lead to the following power spectrum (used as reference for the inverse problem)
- The full models are too complicated for numerical simulation, two main approaches for computational heliosesimolgy:
  - Aeroacoustics: magnetic effects are neglected (us)
  - Magnetoacoustics: hydrodynamics effects are neglected

# HDG methods for harmonic wave problems with convection

## From CG... to DG... to HDG

#### From CG to DG:

- Continuity of the solution between two elements is not enforced by the choice of approximation spaces anymore
- Continuity and stability come from the choice of numerical flux between two elements (similar to the finite volume method)
- Advantages
  - hp-adaptativity
  - high-order
  - parallelization
- Disadvantage
  - large number of degrees of freedom



Figure 2: Degrees of freedom for degree 3

## From DG to HDG:

- Introduce a new unknown on the skeleton of the mesh
- Interior degrees of freedom can be eliminated through static condensation
- Keep the advantages of DG for a reduced cost

## From DG to HDG:

- Introduce a new unknown on the skeleton of the mesh
- Interior degrees of freedom can be eliminated through static condensation
- Keep the advantages of DG for a reduced cost

#### HDG methods have a dual citizenship:

- Static condensation of DG methods
- Also related to the hybridization of mixed FEM (eg Raviart-Thomas or Brezzi-Douglas-Marini methods)

#### Model problem :

$$\rho_0 \left( -\omega^2 \boldsymbol{p} - 2i\omega \, \boldsymbol{v_0} \cdot \nabla \boldsymbol{p} + \, \boldsymbol{v_0} \cdot \nabla (\boldsymbol{v_0} \cdot \nabla \boldsymbol{p}) \right) - \operatorname{div} \left( \rho_0 \, \boldsymbol{c_0}^2 \nabla \boldsymbol{p} \right) = \boldsymbol{s}$$

where

- p: pressure perturbation
- $\triangleright \rho_0$ : mass density
- ► V<sub>0</sub>: velocity field
- ► c<sub>0</sub>: sound speed
- s: acoustic source



$$\rho_0 \left( -\omega^2 \boldsymbol{p} - 2i\omega \, \boldsymbol{v_0} \cdot \nabla \boldsymbol{p} \right) - \operatorname{div} \left( \boldsymbol{M_0} \nabla \boldsymbol{p} \right) = \boldsymbol{s}$$

where  $M_0 = \rho_0 c_0^2 \text{Id} - \rho_0 v_0 v_0^T$ .

#### Model problem :

$$W_0 \boldsymbol{q} + \nabla \boldsymbol{p} = 0$$
$$-\rho_0 \omega^2 \boldsymbol{p} - 2i\omega\rho_0 \boldsymbol{v}_0 \cdot \nabla \boldsymbol{p} + \operatorname{div}(\boldsymbol{q}) = \boldsymbol{s}$$

where  $\mathbf{q} = -\mathbf{M}_0 \nabla \mathbf{p}$  and  $\mathbf{W}_0 = \mathbf{M}_0^{-1}$ . To use HDG methods, we need a first-order in space formulation.

Model problem : Seek  $(\boldsymbol{q}, \boldsymbol{p}) \in \boldsymbol{H}_{div}(\Omega) \times H^{1}(\Omega)$  such that  $\int_{\Omega} \boldsymbol{W}_{0} \boldsymbol{q} \cdot \boldsymbol{r}^{*} dx - \int_{\Omega} \boldsymbol{p} div (\boldsymbol{r}^{*}) dx + \int_{\partial \Omega} \boldsymbol{p} \boldsymbol{r}^{*} \cdot \boldsymbol{n} d\sigma = 0$   $-\omega^{2} \int_{\Omega} \rho_{0} \boldsymbol{p} w^{*} dx + 2i\omega \int_{\Omega} \boldsymbol{p} \rho_{0} \boldsymbol{v}_{0} \cdot \nabla w^{*} dx$   $-\int_{\Omega} \boldsymbol{q} \cdot \nabla w^{*} dx + \int_{\partial \Omega} w^{*} \boldsymbol{q} \cdot \boldsymbol{n} - 2i\omega \boldsymbol{p} w^{*} \rho_{0} \boldsymbol{v}_{0} \cdot \boldsymbol{n} d\sigma = \int_{\Omega} \boldsymbol{s} w^{*} dx$ 

for all  $(\mathbf{r}, \mathbf{w}) \in \mathbf{H}_{div}(\Omega) \times H^1(\Omega)$ .

Model problem : Seek  $(\boldsymbol{q}, \boldsymbol{p}) \in \boldsymbol{H}_{div}(\Omega) \times H^{1}(\Omega)$  such that

$$-\omega^{2} \int_{\Omega} \rho_{0} \boldsymbol{p} \boldsymbol{w}^{*} d\mathbf{x} + 2i\omega \int_{\Omega} \boldsymbol{p} \rho_{0} \boldsymbol{v}_{0} \cdot \nabla \boldsymbol{w}^{*} d\mathbf{x}$$
$$-\int_{\Omega} \boldsymbol{q} \cdot \nabla \boldsymbol{w}^{*} d\mathbf{x} + \int_{\partial \Omega} \boldsymbol{w}^{*} \boldsymbol{q} \cdot \boldsymbol{n} - 2i\omega \boldsymbol{p} \boldsymbol{w}^{*} \rho_{0} \boldsymbol{v}_{0} \cdot \boldsymbol{n} d\sigma = \int_{\Omega} \boldsymbol{s} \boldsymbol{w}^{*} d\mathbf{x}$$

for all  $(\mathbf{r}, \mathbf{w}) \in \mathbf{H}_{div}(\Omega) \times H^1(\Omega)$ . Well-posedness: if the carrier flow is subsonic

$$\inf_{\Omega} \left( {c_0}^2 - |\mathbf{v_0}|^2 \right) > 0$$

then the problem is of Fredholm type with  $(\boldsymbol{q}, \boldsymbol{p}) \in \boldsymbol{H}_{div}(\Omega) \times H^{1}(\Omega)$ .

We will compare the HDG and HDG+ methods for time-harmonic convected waves.

# HDG(+) methods

Approximation spaces:

Variable	Space	HDG	HDG+
Pressure p <sub>h</sub>	$W_h(K)$	$\mathcal{P}_k(K)$	$\mathcal{P}_{k+1}(K)$
Flux <b>q</b> <sub>h</sub>	$V_h(K)$	$\mathcal{P}_k(K)$	
Trace $\lambda_h$	$M_h(e)$	$\mathcal{P}_k(e)$	

Together with the weak formulation: leads to the discrete local problem (*ie* on an element  $K \in T_h$ ) :

$$\mathbb{A}^{K}\begin{bmatrix}\boldsymbol{p_{h}}^{K}\\\boldsymbol{q_{h}}^{K}\end{bmatrix} + \mathbb{C}^{K}\begin{bmatrix}\boldsymbol{\lambda_{h}}^{K}\end{bmatrix} = \mathbb{S}^{K}$$

All of this is done by choosing the numerical flux, so that

$$\sum_{e \in \mathcal{E}_h} \int_e \llbracket \widehat{\boldsymbol{q}_h} - 2i\omega \boldsymbol{n} \cdot \widehat{\boldsymbol{v}_0 \boldsymbol{p}_h} \boldsymbol{n} \rrbracket \mu^* \mathrm{d}\sigma = 0, \quad \forall \mu \in M_h$$

where  $\llbracket \cdot \rrbracket$  is the DG-jump operator.

- $\tau$ : penalization parameter
- $\tau_{upw} = max(v_0 \cdot n, 0)$ : optional upwinding parameter

$$\sum_{e \in \mathcal{E}_h} \int_e \llbracket \widehat{\boldsymbol{q}_h} - 2i\omega \boldsymbol{n} \cdot \widehat{\boldsymbol{v}_0 \boldsymbol{p}_h} \boldsymbol{n} \rrbracket \mu^* \mathrm{d}\sigma = \boldsymbol{0}, \quad \forall \mu \in M_h$$

where  $\left[\!\left[\cdot\right]\!\right]$  is the DG-jump operator.

- Convergence rate: (q, p) : exact solution
  - ▶ for HDG: (optimal X)

$$\|\boldsymbol{p}_h - \boldsymbol{p}\| = \mathcal{O}(h^{k+1})$$
 and  $\|\boldsymbol{q}_h - \boldsymbol{q}\| = \mathcal{O}(h^{k+\frac{1}{2}})$ 

▶ for HDG+: (optimal ✓)

$$\|\boldsymbol{p}_h - \boldsymbol{p}\| = \mathcal{O}(h^{k+2})$$
 and  $\|\boldsymbol{q}_h - \boldsymbol{q}\| = \mathcal{O}(h^{k+1})$

• Local solvability: invertibility of  $\mathbb{A}^{K}$ ,  $\checkmark$  if

 $\omega h_{\mathcal{K}} < C(\rho_0, \mathbf{v_0}, \mathbf{c_0}, \mathsf{element geometry})$ au well chosen

- Convergence rate: (q, p) : exact solution
  - ► for HDG: (optimal X) no super-convergence !

$$\|\boldsymbol{p}_h - \boldsymbol{p}\| = \mathcal{O}(h^{k+1})$$
 and  $\|\boldsymbol{q}_h - \boldsymbol{q}\| = \mathcal{O}(h^{k+\frac{1}{2}})$ 

▶ for HDG+: (optimal ✓)

$$\|\boldsymbol{p}_h - \boldsymbol{p}\| = \mathcal{O}(h^{k+2})$$
 and  $\|\boldsymbol{q}_h - \boldsymbol{q}\| = \mathcal{O}(h^{k+1})$ 

using:

- L<sup>2</sup>-orthogonal projections
- a duality estimate only valid for regular solutions

## Some results on the methods

We performed the numerical analysis of the method:

▶ Local solvability: invertibility of  $\mathbb{A}^{K}$ , ✓ if

▶ for HDG+: (optimal ✓)

 $\|\boldsymbol{p}_h - \boldsymbol{p}\| = \mathcal{O}(h^{k+2})$  and  $\|\boldsymbol{q}_h - \boldsymbol{q}\| = \mathcal{O}(h^{k+1})$ 

Global solvability: invertibility of M, ✓ if ω is not a resonant frequency.
