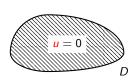

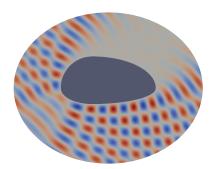

Time-harmonic scattering

It is about "sending" a wave on a obstacle D, and modeling the reflections.





Time-harmonic means that we assume that wave has the form $u(x)e^{ikt}$, where k > 0 is a fixed frequency.

Stability

Mathematically, this is modeled by a PDE problem that looks like

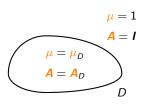
$$\left\{ \begin{array}{rcl} -k^2 {\color{red} u} - \Delta {\color{blue} u} & = & f & \text{outside } D, \\ {\color{blue} u} & = & 0 & \text{on } \partial D, \\ {\color{blue} u} & \text{"radiates"} & \text{at infinity.} \end{array} \right.$$

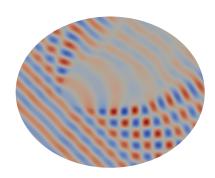
"Fredholm + UCP" shows that there exists a unique u, and

$${\color{red} \textit{k}}^2 \| {\color{red} \textit{u}} \| \leq \textit{C}_{\mathrm{s}}({\color{blue} \textit{k}}) \| {\color{blue} \textit{f}} \|.$$

Frequency-explicit stability is about understanding how $C_s(k)$ depends on k.

Penetrable obstacles



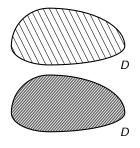


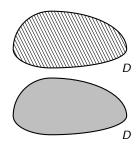
Mathematically, the problem now reads:

$$\left\{ \begin{array}{l} -k^2 \mu \mathbf{u} - \boldsymbol{\nabla} \cdot (\mathbf{A} \boldsymbol{\nabla} \mathbf{u}) = \mathbf{f}, \\ \\ \mathbf{u} \text{ "radiates" at infinity,} \end{array} \right.$$

and still, we are interested in $C_s(k)$.

(Highly) Heterogeneous composite obstacles





We now write this as

$$\left\{ \begin{array}{l} -k^2 \mu_{\varepsilon} u_{\varepsilon} - \nabla \cdot (\textbf{A}_{\varepsilon} \nabla u_{\varepsilon}) = f, \\ \\ u_{\varepsilon} \text{ "radiates" at infinity,} \end{array} \right.$$

where ε denote the size of the layer. We want to analyze

$$|\mathbf{k}^2||\mathbf{u}_{\varepsilon}|| \leq C_{\mathrm{s}}(\mathbf{k}, \varepsilon)||\mathbf{f}||$$

"uniformly" as $k \to \infty$ and/or $\varepsilon \to 0$, and understand " $\lim_{\varepsilon \to 0} u_{\varepsilon}$ ".

Heterogeneous Poisson problem

We will start with the "easy" problem: find $u_{\varepsilon}:D\to\mathbb{R}$ such that

$$\begin{cases}
-\nabla \cdot (\mathbf{A}^{\varepsilon} \nabla \mathbf{u}_{\varepsilon}) &= f & \text{in } D, \\
\mathbf{u}_{\varepsilon} &= 0 & \text{on } \partial D.
\end{cases}$$

Formally, we assume that $f \in L^2(D)$, $A^{\varepsilon} \in C^{\infty}(D, \mathbb{R}^{d \times d})$, and we search $u_{\varepsilon} \in H_0^1(D)$ such that

$$a^{\varepsilon}(\mathbf{u}_{\varepsilon}, \mathbf{v}) = (\mathbf{f}, \mathbf{v})_{D} \quad \forall \mathbf{v} \in H_{0}^{1}(D)$$

with

$$a^{\varepsilon}(\mathbf{u}_{\varepsilon}, \mathbf{v}) := (\mathbf{A}^{\varepsilon} \nabla \mathbf{u}_{\varepsilon}, \nabla \mathbf{v})_{D}.$$

Periodic coefficient

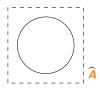
We will assume that A^{ϵ} is periodic, meaning that there exists \widehat{A} s.t.

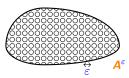
$$\mathbf{A}^{\varepsilon}(\mathbf{x}) := \widehat{\mathbf{A}}\left(\left\{\frac{\mathbf{x}}{\varepsilon}\right\}\right).$$

We will also assume uniform continuity and ellipticity:

$$0 < a_{\star} \leq \widehat{A}(y) \leq a^{\star} < +\infty$$

for a.e. y in $(0,1)^d$.





Uniform stability

Poincaré inequality ensures that

$$\left\| \textbf{\textit{u}}_{\epsilon} \right\|^{2}_{H^{1}(D)} \lesssim \left\| \boldsymbol{\nabla} \textbf{\textit{u}}_{\epsilon} \right\|^{2}_{L^{2}(D)} \leq \frac{1}{\textbf{\textit{a}}_{\star}} \int_{\Omega} \textbf{\textit{A}}^{\epsilon} \boldsymbol{\nabla} \textbf{\textit{u}}_{\epsilon} \cdot \boldsymbol{\nabla} \textbf{\textit{u}}_{\epsilon} = (\textbf{\textit{f}}, \textbf{\textit{u}}_{\epsilon})_{D}.$$

Hence, we have

$$\|\mathbf{u}_{\varepsilon}\|_{H^1(D)} \lesssim \|\mathbf{f}\|_{L^2(D)}$$

uniformly in ε , where the hidden constant depend only on D, a_{\star} .

In particular, the compact injection $H^1(D)\subset L^2(D)$ immediately ensures

$$u_{\varepsilon'} \to u_0$$
 in $L^2(D)$.

The two-scale expansion ansatz

We assume the following ansatz

$$\label{eq:uepsilon} \begin{split} & \underline{u}_{\epsilon}(x) = \underline{u}_{0}\left(x, \left\{\frac{x}{\epsilon}\right\}\right) + \epsilon \underline{u}_{1}\left(x, \left\{\frac{x}{\epsilon}\right\}\right) + \epsilon^{2}\underline{u}_{2}\left(x, \left\{\frac{x}{\epsilon}\right\}\right) + \ldots, \end{split}$$

where $u_0(x, y)$, $u_1(x, y)$ and $u_2(x, y)$ are y-periodic.

The y-periodicity assumption is "natural", since A^{ε} is y-periodic.

First-order corrector and homogeneized problem

Plugging the two-scale expansion in the PDE, and using the above identity, we obtain a cascade of equations for the u_i 's by identifying powers of ε .

Specfically, we formally obtain that

$$\underline{\mathbf{u}}_{1}(\mathbf{x},\mathbf{y}) = \sum_{j=1}^{d} \widehat{\chi}_{j}(\mathbf{y}) \frac{\partial \underline{\mathbf{u}}_{0}}{\partial \mathbf{x}_{j}}(\mathbf{x}),$$

where the $\widehat{\chi}_i$ only depend on \widehat{A} , and

$$-\nabla \cdot (\mathbf{A}^{\mathrm{H}} \nabla \mathbf{u}_0) = \mathbf{f} \text{ in } \Omega,$$

with

$$oldsymbol{A}_{j\ell}^{
m H} := \int_{(0,1)^d} \widehat{oldsymbol{A}}_{j\ell} + rac{\partial \widehat{\chi}_j}{\partial oldsymbol{y}_\ell} doldsymbol{y}.$$

What have we achieved so far?

By itself, the two-scale ansatz does not do much.

It gives us "feel" of the correct quantities to look at. In particular, $\hat{\chi}$, \mathbf{A}^{H} , \mathbf{u}_{0} and \mathbf{u}_{1} are "correctly" defined.

But we still need to rigorously show that $u_{\varepsilon} \rightarrow u_0!$

Main ideas toward an error estimate

The first step is to observe that

$$a^{\varepsilon}(\mathbf{u}_{\varepsilon}-\mathbf{u}_{0},v)=(\mathbf{f},v)-a^{\varepsilon}(\mathbf{u}_{0},v)=((\mathbf{A}^{H}-\mathbf{A}^{\varepsilon})\nabla\mathbf{u}_{0},\nabla v)_{D}.$$

It means that we can identify the error as a solution of our starting PDE.

The stability of the oscillatory problem (involving a^{ε}) will be important!

Correctors

We have that

$$a^{\varepsilon}(\mathbf{u}_{\varepsilon}-\mathbf{u}_{0},v)=((\mathbf{A}^{\mathrm{H}}-\mathbf{A}^{\varepsilon})\mathbf{\nabla}\mathbf{u}_{0},\mathbf{\nabla}v)_{D},\quad\forall v\in H_{0}^{1}(D).$$

The problem is that $\mathbf{A}^{\varepsilon} \to \mathbf{A}^{\mathrm{H}}$ only in a very weak sense (H- or G-convergence).

Employing u_1 and a "boundary" corrector θ_{ε} , we arrive at

$$|a^{\varepsilon}(\mathbf{u}_{\varepsilon} - (\mathbf{u}_{0} + \varepsilon \mathbf{u}_{1}^{\varepsilon} + \theta_{\varepsilon}), v)| \lesssim \varepsilon \|\mathbf{u}_{0}\|_{H^{2}(D)} \|v\|_{H^{1}(D)}$$

showing that

$$\|\mathbf{u}_{\varepsilon} - (\mathbf{u}_{0} + \varepsilon \mathbf{u}_{1}^{\varepsilon} + \mathbf{\theta}_{\varepsilon})\|_{H^{1}(D)} \lesssim \varepsilon \|\mathbf{u}_{0}\|_{H^{2}(D)} \lesssim \varepsilon \|f\|_{L^{2}(D)},$$

and in particular

$$\|\mathbf{u}_{\varepsilon}-\mathbf{u}_{0}\|_{L^{2}(D)}+\|\mathbf{u}_{\varepsilon}-(\mathbf{u}_{0}+\varepsilon\mathbf{u}_{1}^{\varepsilon})\|_{H^{1}(D)}\lesssim \varepsilon^{1/2}\|f\|_{L^{2}(D)}.$$

Importance of stability

The fact that the oscillating PDE problem is stable uniformly in ε is paramount.

For elliptic problems, it is trivial: only the min and max of A are important.

The situation is, unfortunately, more complicated for wave propagation: each "new layer" can create a reflection, which may trap the waves.

Mathematical setting

Let

$$\mu(\mathbf{x}) = \left\{ \begin{array}{ll} \mu_D(\mathbf{x}) & \text{in } D, \\ 1 & \text{outside}, \end{array} \right. \qquad \mathbf{A}(\mathbf{x}) = \left\{ \begin{array}{ll} \mathbf{A}_D(\mathbf{x}) & \text{in } D, \\ \mathbf{I} & \text{outside}. \end{array} \right.$$

Let Ω be a ball of radius ℓ containing D and supp f. Then, we consider:

$$\begin{cases}
-k^2 \mu \mathbf{u} - \nabla \cdot (\mathbf{A} \nabla \mathbf{u}) &= \mathbf{f} & \text{in } \Omega, \\
\nabla \mathbf{u} \cdot \mathbf{n} - i \mathbf{k} \mathbf{u} &= 0 & \text{on } \partial \Omega.
\end{cases}$$

Here, I will use a first-order abosrbing BC on $\partial\Omega$ for the sake of simplicity. The "real" DtN operator can handled as well, but it is slightly more technical.

Two assumptions

We will need a technical assumption on the geometry of D. To simplify for the moment, let us just assume that D is convex.

We also assume that $\mu_D \leq 1$ and $I \leq A_D$ inside D. It means that the wavespeed is higher inside D:

$$c_D = \sqrt{rac{\mathsf{min}\, \mathbf{A}_D}{\mathsf{max}\, \mu_D}} \geq 1 = c_{\mathrm{out}}.$$

Rays and semi-classical analysis

Our assumptions concern the geometry of D and the wavespeed inside.

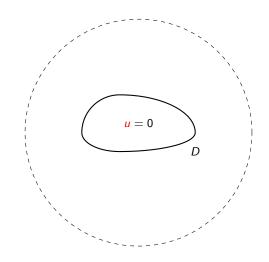
These two assumptions are actually very natural. They can be explained by considering geometrical optics.

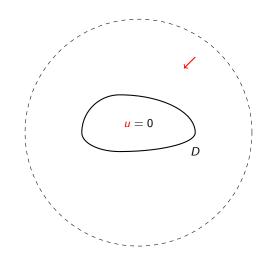
Here, I just want to give an "intuitive" feel of what's going on.

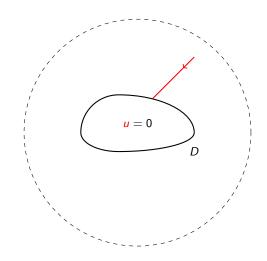
However, a rigorous link between rays and stability of high-frequency problems can be established via semi-classical analysis.

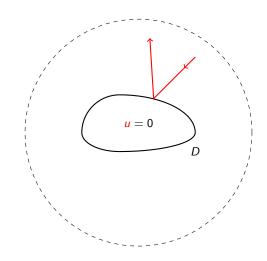


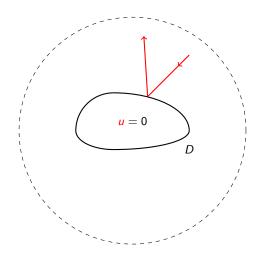

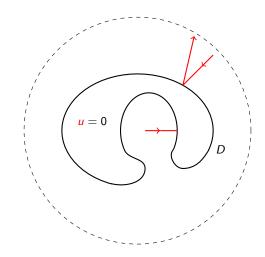


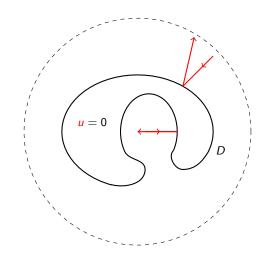


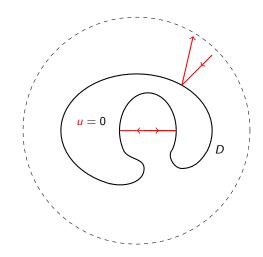


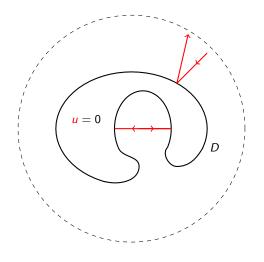




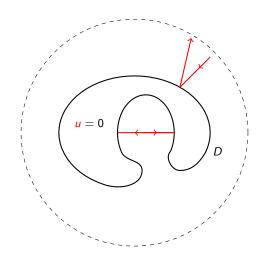




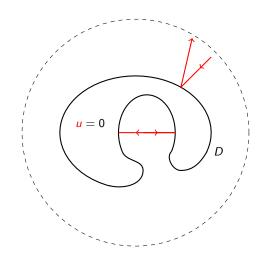




Some rays are trapped.

$$|\mathbf{k}|^2 \|\mathbf{u}\|_{\Omega} \lesssim \exp(\alpha \mathbf{k}\ell) \|\mathbf{f}\|_{\Omega}$$

Our assumption on the geometry

Our assumption on the geometry of ${\it D}$ prevents strongly trapped rays.

It avoids the "exponential only" stability.

We won't need ε "exponentially small" as k increases.

Penatrable obstacles

How do the rays behave when leaving the obstacle? The answer is provided by Snell's law.

Recalling that c = 1 outside D, Snell's law reads

$$sin(\theta_{in}) = c_D sin(\theta_{out}).$$

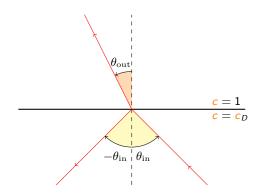
It will be important to distinguish between the cases where $c_D > 1$ and $c_D < 1$.

Leaving the obstacle when $c_D > 1$

Given θ_{in} , the equation

$$\mathsf{sin}(heta_{\mathrm{in}}) = {\color{red} c_{D}} \, \mathsf{sin}(heta_{\mathrm{out}})$$

is always solvable for $\theta_{\mathrm{out}}.$

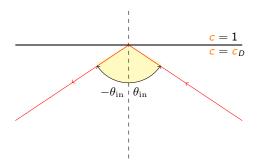


Leaving the obstacle when $c_D < 1$

Now, the equation

$$\sin(\theta_{\mathrm{in}}) = c_D \sin(\theta_{\mathrm{out}})$$

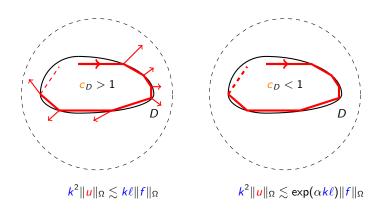
does not have a solution if $sin(\theta_{in}) > c_D$.



In such case, total reflection occurs, similar to a Dirichlet boundary.

Whispering gallery modes

When $c_{\mathcal{D}} < 1$ rays can be trapped inside can be trapped inside the obstacle.



Our assumption on the wavespeed

We assume that $\mu_D \leq 1$ and $I \leq A_D$, which actually implies that $c_D \geq 1$.

This second assumption rules out whispering gallery modes, and again prevents "exponential only" stability.

Lack of coercivity

For all $\mathbf{u} \in H^1(\Omega)$, it holds that

$$b(\mathbf{u},\mathbf{u}) = -\mathbf{k}^2 \|\mathbf{u}\|_{\Omega}^2 - i\mathbf{k}\|\mathbf{u}\|_{\partial\Omega}^2 + \|\nabla\mathbf{u}\|_{\Omega}^2.$$

The imaginary part gives us control over the boundary

$$-\operatorname{Im} b(\underline{u},\underline{u}) = \underline{k} \|\underline{u}\|_{\partial\Omega}^2.$$

The real part does not give immediate information, as it is indefinite

$$\operatorname{Re} b(\mathbf{u}, \mathbf{u}) = \|\nabla \mathbf{u}\|_{\Omega}^{2} - \mathbf{k}^{2} \|\mathbf{u}\|_{\Omega}^{2}.$$

Other test functions are needed to obtain more information.

The Morawetz multiplier in homogeneous media

The Morawetz multiplier is the test function $\mathbf{x} \cdot \nabla \mathbf{u}$.

Let us first consider a homogeneous media.

It integrates by parts as follows in the (u, v) term

$$2\, \text{Re} \int_{\Omega} \underline{\textbf{\textit{u}} \, \textbf{\textit{x}} \cdot \boldsymbol{\nabla} \textbf{\textit{u}}} = \int_{\Omega} \textbf{\textit{x}} \cdot \boldsymbol{\nabla} |\textbf{\textit{u}}|^2 = \int_{\partial \Omega} \textbf{\textit{x}} \cdot \textbf{\textit{n}} |\textbf{\textit{u}}|^2 - 2 \int_{\Omega} |\textbf{\textit{u}}|^2,$$

and in the $(\nabla u, \nabla v)$ term

$$2\operatorname{Re}\int_{\Omega} \nabla \mathbf{u} \cdot \nabla (\overline{\mathbf{x} \cdot \nabla \mathbf{u}}) = \int_{\partial \Omega} \mathbf{x} \cdot \mathbf{n} |\nabla \mathbf{u}|^{2}.$$

The Morawetz multiplier in homogeneous media

Using the variational formulation

$$b(\mathbf{u}, \mathbf{x} \cdot \nabla \mathbf{u}) = (\mathbf{f}, \mathbf{x} \cdot \nabla \mathbf{u})_{\Omega},$$

we arrive at the "Morawetz identity"

$$2k^{2}\|\mathbf{u}\|_{\Omega}^{2} + \int_{\partial\Omega} |\nabla \mathbf{u}|^{2} \mathbf{x} \cdot \mathbf{n} =$$

$$2\operatorname{Re}(\mathbf{f}, \mathbf{x} \cdot \nabla \mathbf{u})_{\Omega} + 2\operatorname{Re}\{ik(\mathbf{u}, \mathbf{x} \cdot \nabla \mathbf{u})_{\partial\Omega}\} + k^{2} \int_{\partial\Omega} |\mathbf{u}|^{2} \mathbf{x} \cdot \mathbf{n},$$

and the rhs can be controlled using b(u, u) = (f, u), leading to

$$k^2 \| \mathbf{u} \|_{\Omega} \lesssim k \ell \| \mathbf{f} \|_{\Omega}.$$

What happens in heterogeneous media?

Let us consider, for simplicity, that A = I, but that μ varies.

Then, the $(\nabla u, \nabla v)$ term does not change. For the $(\mu u, v)$ term, we have

$$2\,\mathsf{Re}\int_{\Omega}\frac{\mu \textbf{\textit{u}}\overline{\textbf{\textit{x}}}\cdot\boldsymbol{\nabla}\overline{\textbf{\textit{u}}}}{-\int_{\Omega}\mu\textbf{\textit{x}}\cdot\boldsymbol{\nabla}|\textbf{\textit{u}}|^2}=\int_{\partial\Omega}\mu\textbf{\textit{x}}\cdot\textbf{\textit{n}}|\textbf{\textit{u}}|^2-\int_{\Omega}\boldsymbol{\nabla}\cdot(\mu\textbf{\textit{x}})|\textbf{\textit{u}}|^2,$$

Then, $\nabla \cdot (\mu x) = 2\mu + x \cdot \nabla \mu$, leading to

$$2\operatorname{Re}\int_{\Omega} \frac{\mu u}{x \cdot \nabla u} \int_{\partial \Omega} \frac{\mu x \cdot \boldsymbol{n} |\boldsymbol{u}|^2}{-2 \int_{\Omega} \mu |\boldsymbol{u}|^2} - \underbrace{\int_{\Omega} (\boldsymbol{x} \cdot \nabla \mu) |\boldsymbol{u}|^2}_{\text{Additional term}}.$$

The new term is not a problem if $\mathbf{x} \cdot \nabla \mu \geq 0$, i.e.

$$\frac{\partial \mu}{\partial r} \geq 0.$$

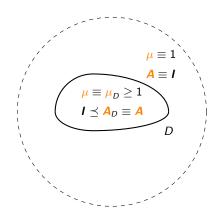
The Morawetz multiplier in heterogeneous media

Under the assumption that

$$\frac{\partial \mu}{\partial r} \ge 0 \qquad \frac{\partial \mathbf{A}}{\partial r} \le 0$$

the following estimate holds true

$$k^2 \| \mathbf{u} \|_{\Omega} \lesssim k \ell \| \mathbf{f} \|_{\Omega}.$$



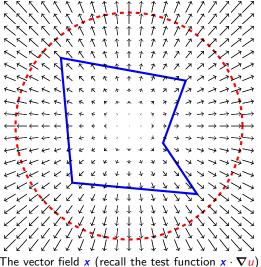
This technique gives the correct estimate for an homogeneous obstacle.

Still, we cannot handle oscillating coefficients with this technique.

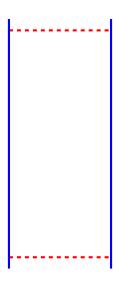

Morawetz multiplier

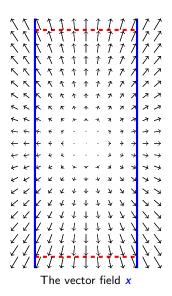


The vector field \mathbf{x} (recall the test function $\mathbf{x} \cdot \nabla \mathbf{u}$)

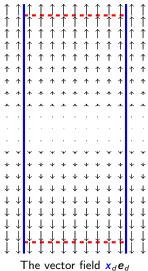
Directional multiplier in a waveguide

Integration by parts for the directional multiplier

Observe that $(\mathbf{x}_d \mathbf{e}_d) \cdot \nabla \mathbf{u} = \mathbf{x}_d \partial_d \mathbf{u}$. Then

$$2\operatorname{Re}\int_{\Omega} \underline{u}\overline{x_d\partial_d u} = \int_{\Omega} x_d\partial_d |u|^2 = \int_{\partial\Omega} x_d \boldsymbol{n}_d |u|^2 - \int_{\Omega} |u|^2$$

and

$$2\operatorname{Re}\int_{\Omega} \nabla \underline{\mathbf{u}} \cdot \nabla (\overline{\mathbf{x}_{d}} \partial_{d} \underline{\mathbf{u}}) = \int_{\partial \Omega} \mathbf{x}_{d} \mathbf{n}_{d} |\nabla \underline{\mathbf{u}}|^{2} - \int_{\Omega} |\partial_{1} \underline{\mathbf{u}}|^{2}$$

 $\mathbf{x} \cdot \mathbf{n}$ is replaced by $\mathbf{x}_d \mathbf{n}_d$ in the boundary terms.

We have no boundary terms when $n_d = 0$ (vertical boundaries on the slide).

Stability estimate for the waveguide

Using that $b(\mathbf{u}, \mathbf{x}_d \partial_d \mathbf{u}) = (f, \mathbf{x}_d \partial_d \mathbf{u})$, we have

$$\begin{aligned} k^2 \| \mathbf{u} \|_{\Omega}^2 + \int_{\partial \Omega} |\nabla \mathbf{u}|^2 \mathbf{x}_d \mathbf{n}_d &= \underbrace{\|\partial_1 \mathbf{u}\|_{\Omega}^2}_{\text{new term}} \\ + 2 \operatorname{Re}(f, \mathbf{x}_d \partial_d \mathbf{u})_{\Omega} + 2 \operatorname{Re}\{ik(\mathbf{u}, \mathbf{x}_d \partial_d \mathbf{u})_{\partial \Omega}\} + k^2 \int_{\partial \Omega} |\mathbf{u}|^2 \mathbf{x}_d \mathbf{n}_d, \end{aligned}$$

and we eventually arrive at

$$\mathbf{k}^2 \| \mathbf{u} \|_{\Omega} \lesssim (\mathbf{k} \ell)^3 \| \mathbf{f} \|_{\Omega}.$$

We loose two powers $k\ell$, but we can handle other geometries.

What about heterogenoues media?

With the Morawetz multiplier, we had requirements of the form

$$\mathbf{x} \cdot \nabla \mu \geq 0$$
 $0 \leq \mathbf{x} \cdot \nabla \mathbf{A}$,

leading to radial growth conditions.

Here, we only integrate by part along x_d , leading to the conditions

$$x_d \frac{\partial \mu_d}{\partial x_d} \ge 0$$
 $0 \le x_d \frac{\partial A_d}{\partial x_d}$.

The coefficients are free to oscillate in d-1 directions:

- finely layered obstacles in 2D,
- finely fibred obstacles in 3D.

Mixing the two kinds of multipliers

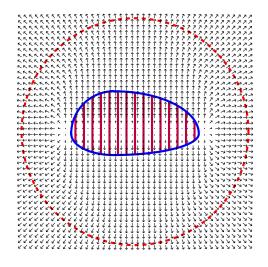
The last key idea consists in mixing the two multipliers.

Introducing a cutoff χ , we multiply the PDE with

$$\chi(|\mathbf{x}|)\mathbf{x}\cdot\nabla\mathbf{u}+(1-\chi(|\mathbf{x}|))\mathbf{x}_d\partial_d\mathbf{u}.$$

That way, we have the "usual" multiplier close to the absorbing boundary, and we have the directional multiplier close to the obstacle.

Mixing the two kind of multipliers: finely layered obstacle

 $A|_D$ is a $L^{\infty}(D,\mathbb{R}^{d\times d})$ symmetric matrix such that

$$\mathbf{x}_d(\mathbf{A}(\mathbf{x}+h\mathbf{e}_d)-\mathbf{A}(\mathbf{x})) \leq 0 \quad h>0, \ \mathbf{x}\in D,$$

and $\mathbf{A}_{\ell,d}=0$ if $\ell \neq d$, i.e.

$$\mathbf{A}|_{D} = \left(\begin{array}{cc} \times & \mathbf{0} \\ \mathbf{0} & \times \end{array} \right) \quad \text{ or } \quad \mathbf{A}|_{D} = \left(\begin{array}{ccc} \times & \times & \mathbf{0} \\ \times & \times & \mathbf{0} \\ \mathbf{0} & \mathbf{0} & \times \end{array} \right).$$

Main stability result

Let $f \in L^2(\mathbb{R}^d)$ with supp $f \subset \Omega := B(0,\ell)$. Let T_k be the DtN operator with radiation condition outside Ω . Assume that $k\ell \geq C_{\mathrm{wave}}$.

Under the above assumptions, there is a unique $\mathbf{u} \in H^1(\Omega)$ such that

$$-\textbf{k}^2(\mu\textbf{u},\textbf{v})_{\Omega} - \langle \textit{T}_\textbf{k}\textbf{u},\textbf{v}\rangle_{\partial\Omega} + (\textbf{A}\boldsymbol{\nabla}\textbf{u},\boldsymbol{\nabla}\textbf{v})_{\Omega} = (\textbf{f},\textbf{v})_{\Omega} \quad \forall \textbf{v} \in \textit{H}^1(\Omega).$$

In addition, the following stability estimate holds true

$${\color{red} \textbf{\textit{k}}^2}\|{\color{red} \textbf{\textit{u}}}\|_{\Omega} \leq C_{\mathrm{stab}}({\color{red} \textbf{\textit{k}}\ell})^3\|{\color{blue} \textbf{\textit{f}}}\|_{\Omega},$$

where $C_{\rm stab}$ only depends on the minimum and maximum values of μ and A.

Mathematical setting

We assume that ∂D is $C^{1,1}$ with $\mathbf{x}_d \mathbf{n}_d \geq 0$ on ∂D .

We consider coefficients of the form

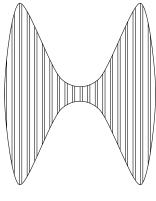
$$\mu_{\varepsilon}(\mathbf{x}) = \begin{cases} \widehat{\mu}(\{\mathbf{x}/\varepsilon\}) & \text{in } D \\ 1 & \text{outside} \end{cases}$$

$$\mathbf{A}_{\varepsilon}(\mathbf{x}) = \begin{cases} \widehat{\mathbf{A}}(\{\mathbf{x}/\varepsilon\}) & \text{in } D \\ \mathbf{I} & \text{outside} \end{cases}$$

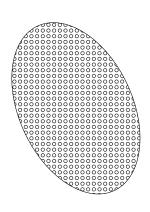
where $\widehat{\mu}$ and $\widehat{\mathbf{A}}$ are independent of \mathbf{y}_d , piecewise smooth, and $\widehat{\mathbf{A}}_{\ell,d}=0$ if $\ell \neq d$.

We further assume that $\widehat{\mu} \geq 1$ and $I \leq \widehat{A}$.

Stability

Assume that $k\ell \geq C_{\mathrm{wave}}$ and let $f \in L^2(\Omega)$.

For all $\varepsilon>0$, there exists a unique ${\color{red} u_{\varepsilon}}\in H^1(\Omega)$ such that

$$-k^2(\underline{\mu}_{\varepsilon}\underline{\mathbf{u}}_{\varepsilon},v)_{\Omega}-\langle T_{k}\underline{\mathbf{u}}_{\varepsilon},v\rangle_{\partial\Omega}+(\underline{A}_{\varepsilon}\nabla\underline{\mathbf{u}}_{\varepsilon},\nabla v)_{\Omega}=(f,v)_{\Omega}\quad\forall v\in H^1(\Omega).$$

In addition, we have

$${\color{red} k^2\| \textcolor{red}{\textbf{\textit{u}}_{\varepsilon}}\|_{\Omega}} \leq C_{\mathrm{stab}} (\textcolor{red}{\textbf{\textit{k}}\ell})^3 \| \textbf{\textit{f}} \|_{\Omega},$$

where $\mathcal{C}_{\mathrm{stab}}$ does not depend on $\varepsilon.$

Homogenized solution

Consider the usual homogenized coefficients

$$\boldsymbol{\mu}^H|_D := \int_{(0,1)^d} \widehat{\boldsymbol{\mu}}, \qquad \boldsymbol{A}_{j\ell}^H|_D := \int_{(0,1)^d} \widehat{\boldsymbol{A}}_{j\ell} + \frac{\partial \chi_j}{\partial \boldsymbol{y}_\ell},$$

with $\mu^{H} = 1$ and $A^{H} = I$ outside D.

The homogenized solution u_0 is the only element of $H^1(\Omega)$ such that

$$-\textbf{\textit{k}}^2(\mu^H\textbf{\textit{u}}_0,\textbf{\textit{v}})_{\Omega} - \langle \textit{T}_{\textbf{\textit{k}}}\textbf{\textit{u}}_0,\textbf{\textit{v}}\rangle_{\partial\Omega} + (\textbf{\textit{A}}^H\nabla\textbf{\textit{u}}_0,\nabla\textbf{\textit{v}})_{\Omega} = (\textbf{\textit{f}},\textbf{\textit{v}})_{\Omega} \quad \forall \textbf{\textit{v}} \in \textit{H}^1(\Omega).$$

The homogenized solution satisfies

$$|\mathbf{k}|^2 \|\mathbf{u}_0\|_{\Omega} \leq C_{\mathrm{stab}} (|\mathbf{k}|^2)^3 \|\mathbf{f}\|_{\Omega}.$$

Error estimate

We also obtain the usual error estimate using the first-order corrector.

Specficially, the following estiamte holds true:

$$k^2\|\underline{u}_{\varepsilon}-\underline{u}_0\|_{\Omega}+k\|\nabla(\underline{u}_{\varepsilon}-(\underline{u}_0+\varepsilon\underline{u}_1^{\varepsilon})\|_{\Omega}\lesssim (k\ell)^6(k\varepsilon)^{1/2}\|f\|_{\Omega}.$$

Importantly, we obtain frequency-explicit constants.

$$(k\ell)^6 = (k\ell)^3 \times (k\ell)^3 \Rightarrow$$
 we used the stabilty estimate twice!

Key physical quantites

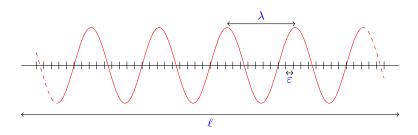
Recall the estimate

$$\textbf{k}^2\|\textbf{u}_{\varepsilon}-\textbf{u}_0\|_{\Omega}\lesssim (\textbf{k}\ell)^6(\textbf{k}\varepsilon)^{1/2}\|\textbf{f}\|_{\Omega}.$$

Since $k \simeq \lambda^{-1}$, $k\varepsilon \ll 1$ means that $\varepsilon \ll \lambda$: the size of the layers (or fibers) is small w.r.t. the wavelength.

On the other hand, we have $k\ell\gg 1$, if $\lambda\ll\ell$: the obstacle and/or the support of f are big w.r.t to the wavelength.

Key physical quantites



The presence of $k\varepsilon \simeq \varepsilon/\lambda$ is "intuitively" expected in the estimate.

 $\emph{k}\ell \simeq \ell/\lambda$ appears because the error accumulates over wavelengths.

Interpretation and sharpness of error estimate

Recall the error estimate

$$k^2 \| \mathbf{u}_{\varepsilon} - \mathbf{u}_0 \|_{\Omega} \lesssim (k\ell)^6 (k\varepsilon)^{1/2} \| f \|_{\Omega}.$$

We can make the following interpretation

$$(k\ell)^{1/2}(k\varepsilon)^{1/2}\simeq \sqrt{\text{``\# wavelengths''}\times \text{``}\varepsilon/\lambda\text{''}}.$$

The presence of both $k\ell$ and $k\varepsilon$ seems to be natural, but it is not clear whether the exponent 6 in our estimate is sharp.

$$|k^2||\mathbf{u}_{\varepsilon} - \mathbf{u}_0|| + k||\nabla \mathbf{u}_{\varepsilon} - (\mathbf{u}_0 + \varepsilon \mathbf{u}_1^{\varepsilon})|| \lesssim (k\ell)^6 (k\varepsilon)^{1/2} ||f||,$$

and the sharpness of the exponent 6 is an open question.
