Importantly, we assume that f is smooth in time.

We (semi) discretize the problem with finite element in space. This yields discrete solution  $u_h : \mathbb{R}_+ \to V_h$  smooth in time.

We want to find a suitable norm  $||\cdot||$  such that estimates like

$$\int_{0}^{+\infty} \| (u-u_{h})(t) \|_{\Omega}^{2} \leq \int_{0}^{+\infty} \eta(t)^{2} dt$$

and

 $\eta_{\kappa}(t) \lesssim |||(u-u_h)(t)|||_{\widetilde{\kappa}}$ 

hold true for a fully-computable estimator  $\eta$ .

The associated residual-based estimator would be

The associated residual-based estimator would be

 $\eta_{\mathcal{K}}(t) := h_{\mathcal{K}} \|f(t) - \ddot{u}_{h}(t) + \Delta u_{h}(t)\|_{\mathcal{K}} + h_{\mathcal{K}}^{1/2} \| \llbracket \nabla u_{h}(t) \rrbracket \cdot \boldsymbol{n} \|_{\partial \mathcal{K} \setminus \Gamma}.$ 

Here, we use an equilibrated flux  $\sigma(t)$  with  $\nabla \cdot \sigma(t) = f(t) - \ddot{u}_h(t)$ , and

$$\eta_{\kappa}(t) := \|\boldsymbol{\sigma}(t) + \boldsymbol{\nabla}\boldsymbol{u}_{h}(t)\|_{\kappa}.$$

# The proposed error estimates

The norm

Let  $\xi_h := u - u_h$ . The "instantaneous" error measure is  $\| \xi_h(t) \|_{\Omega}^2 := \underbrace{\mathcal{T}^2 \| \ddot{\xi}_h(t) \|_{\Omega}^2}_{\text{optional}} + \underbrace{\| \dot{\xi}_h(t) \|_{\Omega}^2 + \| \nabla \xi_h(t) \|_{\Omega}^2}_{\text{physical energy}}.$ 

Let  $\xi_h := u - u_h$ . The "instantaneous" error measure is  $\|\xi_h(t)\|_{\Omega}^2 := \underbrace{\mathcal{T}^2 \|\ddot{\xi}_h(t)\|_{\Omega}^2}_{\text{optional}} + \underbrace{\|\dot{\xi}_h(t)\|_{\Omega}^2 + \|\nabla\xi_h(t)\|_{\Omega}^2}_{\text{physical energy}}.$ 

The "accumulated" measure is

$$\int_0^{+\infty} \| \xi_h(t) \|_{\Omega}^2 e^{-2t/T} dt.$$

Let  $\xi_h := u - u_h$ . The "instantaneous" error measure is  $\| \xi_h(t) \|_{\Omega}^2 := \underbrace{\mathcal{T}^2 \| \ddot{\xi}_h(t) \|_{\Omega}^2}_{\text{optional}} + \underbrace{\| \dot{\xi}_h(t) \|_{\Omega}^2 + \| \nabla \xi_h(t) \|_{\Omega}^2}_{\text{physical energy}}.$ 

The "accumulated" measure is

$$\int_0^{+\infty} \|\xi_h(t)\|_{\Omega}^2 e^{-2t/T} dt.$$

The exponantial weight means that we essentially control up to  $t \sim T$ .

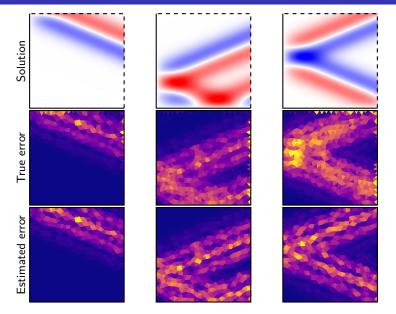

 $osc(f) = h^{p+1} \times$  "high power of T"  $\times$  "high order time derivatives of f".

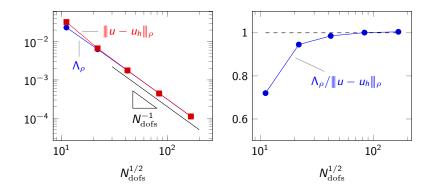

A quick detour: the Poisson problem

Consider the Poisson problem

$$(\nabla \boldsymbol{u}, \nabla \boldsymbol{v})_{\Omega} = (\boldsymbol{f}, \boldsymbol{v})_{\Omega} \quad \forall \boldsymbol{v} \in H^1_0(\Omega)$$

and its conforming FEM discretization  $u_h$ .

With constructions for  $\eta$  similar to what I presented, we have

$$|(\nabla \xi_h, \nabla v)_{\Omega}| \leq \eta \|\nabla v\|_{\Omega} \quad \forall v \in H^1_0(\Omega).$$

Because  $(\nabla \cdot, \nabla \cdot)_{\Omega}$  is actually an energy norm, we have

 $\|\boldsymbol{\nabla}\boldsymbol{\xi}_h\|_{\Omega} \leq \boldsymbol{\eta}.$ 

What makes the wave equation tough is the lack of inf-sup stability.

The Helmholtz problem

We next consider the Helmholtz problem with complex frequency  $\mathbf{s}:= \mathbf{v} + i

$$-s^{2}(\boldsymbol{u},\boldsymbol{v})_{\Omega}+(\boldsymbol{\nabla}\boldsymbol{u},\boldsymbol{\nabla}\boldsymbol{v})_{\Omega}=(\boldsymbol{f},\boldsymbol{v})_{\Omega}\quad\forall\boldsymbol{v}\in H^{1}_{0}(\Omega).$$

The sesquilinear form is not an energy norm. We only have

$$\|oldsymbol{s}\|^2 \|oldsymbol{\xi}_h\|^2_\Omega + \|oldsymbol{
abla}oldsymbol{\xi}_h\|^2_\Omega \leq \left(1+rac{|
u|^2}{
ho^2}
ight)\eta^2.$$

Using duality techniques, this may be improved to

$$|s|^2 \|\boldsymbol{\xi}_h\|_{\Omega}^2 + \|\boldsymbol{\nabla}\boldsymbol{\xi}_h\|_{\Omega}^2 \leq \underbrace{\left(1 + C\frac{|\nu|}{\rho}\frac{|\nu|h}{c}\right)^2}_{\text{pre factor}} \eta^2.$$

A glance at the proofs

The wave equation

Key observation: letting  $ho:=1/\mathit{T}$ , we have

$$\int_{0}^{+\infty} \|\xi(t)\|_{\Omega}^{2} e^{-2t/T} dt = \int_{\rho-i\infty}^{\rho+i\infty} \left(\frac{|s|^{4}}{\rho^{2}} \|\widehat{\xi}(s)\|_{\Omega}^{2} + |s|^{2} \|\widehat{\xi}(s)\|_{\Omega}^{2} + \|\nabla\widehat{\xi}(s)\|_{\Omega}^{2}\right) ds.$$

The Laplace transform  $\hat{u}(s)$  of u(t) solves a Helmholtz problem:

$$\frac{|\boldsymbol{s}|^4}{\rho}\|\widehat{\boldsymbol{\xi}}_{\boldsymbol{h}}(\boldsymbol{s})\|_{\Omega}^2+|\boldsymbol{s}|^2\|\widehat{\boldsymbol{\xi}}_{\boldsymbol{h}}(\boldsymbol{s})\|_{\Omega}^2+\|\boldsymbol{\nabla}\widehat{\boldsymbol{\xi}}_{\boldsymbol{h}}(\boldsymbol{s})\|_{\Omega}^2\leq \left(1+C\frac{|\boldsymbol{\nu}|^2}{\rho^2}|\boldsymbol{\nu}|\boldsymbol{h}\right)^2\widehat{\boldsymbol{\eta}}(\boldsymbol{s})^2.$$

Problem: the pre factor is not bounded as  $\nu \to +\infty$ . Solution: use a cutoff frequency  $\omega$  and do something else for  $|\nu| > \omega$ .

For the high-frequency content, we simply use "plain" stability:

$$\|\widehat{\xi}(s)\|_{s} \leq \|\widehat{u}(s)\|_{s} + \|\widehat{u}_{h}(s)\|_{s} \leq 4\frac{|s|^{2}}{\rho^{2}}\|\widehat{f}(s)\|_{\Omega} \leq 4\frac{1}{\rho^{2}}\|\widehat{f}^{(2)}(s)\|_{\Omega}$$

Next, we use that

$$\int_{\rho-i\infty}^{\rho+i\infty} \|\widehat{\phi}\|_{\Omega}^2 \chi_{|s|>\omega} ds \leq \frac{1}{\omega^{2r}} \int_0^{+\infty} \|\phi^{(r)}(t)\|_{\Omega}^2 e^{-2\rho t} dt$$

It easily follows that term

$$\int_{\rho-i\infty}^{\rho+i\infty} \|\widehat{\xi}_{\hbar}\|_{\Omega}^2 \chi_{|s|>\omega} ds \leq \frac{1}{\omega^{2r}} \int_0^{+\infty} \|f^{(r+2)}(t)\|_{\Omega}^2 e^{-2\rho t} dt$$

can be made small by approxiately picking  $\omega$  and r.

Reliability follows by regrouping the low- and high-frequency terms:

$$\int_{0}^{+\infty} \|\xi_{h}(t)\|^{2} e^{-2\rho t} dt = \int_{\rho-i\infty}^{\rho+i\infty} \|\widehat{\xi}_{h}\|_{\Omega}^{2} \chi_{|s|<\omega} ds + \int_{\rho-i\infty}^{\rho+i\infty} \|\widehat{\xi}_{h}\|_{\Omega}^{2} \chi_{|s|>\omega} ds$$

$$\leq \left(1 + C \frac{\omega^{2}}{\rho^{2}} \frac{\omega h}{c}\right) \int_{0}^{+\infty} \eta(t)^{2} e^{-2\rho t} dt + \frac{4}{\rho^{2}} \frac{1}{\omega^{2r}} \int_{0}^{+\infty} \|f^{(r+1)}(t)\|_{\Omega}^{2} e^{-2\rho t} dt.$$

The estimates I presented earlier simply rely on a clever choice of  $\omega$  and r.

# Concluding remarks

This is a new framework to derive a posteriori estimates for the wave equation.

It can handle space-varying coefficients and disspative terms (with  $\dot{u}$ ).

With equilibration, it gives asymptotically constant-free and *p*-robust estimates.

Similar (slightly weaker) results are possible with residual-based estimators.

Future challenges include time-discretization and adaptivity.
