A LOW-RANK TENSOR METHOD FOR PARAMETERIZED LINEAR FLUID-STRUCTURE INTERACTION PROBLEMS

SUMMARY

This talk will present a low-rank tensor method for parameterized linear fluid-structure interaction problems. In this work, the fluid is governed by the incompressible Stokes equations, and we assume a thick-walled solid model. In order to reduce the computational cost associated with the coupled problem, we develop a low-rank tensor method based on the low-rank Generalized Minimal Residual method. This one is then employed in an uncertainty quantification task to perform a large number of simulations. The preliminary results show the significant reduction of the computational cost provided by the proposed method.

Key words: fluid-structure interaction problem, low-rank method, cardiovascular mathematics

1 INTRODUCTION

In cardiovascular modeling, the patient-specific data needed to simulate blood flow may be uncertain or even unavailable. The choice of appropriate parameters is therefore crucial since a small variation can strongly affect the hemodynamic indicators of clinical interest. However, uncertainty quantification tasks require efficient models due to the large number of simulations to perform for the different queried parameters. For theses reasons, we develop a low-rank tensor method to significantly reduce the computational cost associated with cardiovascular simulations. This low-rank tensor method is then employed to evaluate the hemodynamic indicators for a large number of parameters in order to assimilate patient-specific data.

2 METHODOLOGY

Let Ω^f be an open set representing the fluid domain, Ω^s be an open set representing the solid domain, and Σ be the interface between Ω^f and Ω^s . In this work, the fluid is governed by the incompressible Stokes equations

where ρ^f denotes the fluid density, \boldsymbol{u} denotes the fluid velocity, p denotes the fluid pressure, $\boldsymbol{\sigma}_f$ denotes the fluid Cauchy stress tensors, given by $\boldsymbol{\sigma}_f = 2\mu\boldsymbol{\epsilon}(\boldsymbol{u}) - p\boldsymbol{I}$ with $\boldsymbol{\epsilon}(\boldsymbol{u}) = \frac{1}{2}(\nabla \boldsymbol{u} + \nabla \boldsymbol{u}^T)$ and μ the fluid viscosity. In the solid domain, we assume a thick-walled model

where ρ^s denotes the solid density, \boldsymbol{d} denotes the solid displacement, $\boldsymbol{\sigma}_s$ denotes the solid Cauchy stress tensors, given by $\boldsymbol{\sigma}_s = 2\lambda_1\boldsymbol{\epsilon}(\boldsymbol{d}) + \lambda_2\mathrm{div}(\boldsymbol{d})\boldsymbol{I}$ with λ_1 and λ_2 the Lamé parameters. The coupling conditions between the fluid and solid domains read

$$\begin{cases} \boldsymbol{u} = \dot{\boldsymbol{d}} & \text{on} \quad \Sigma \times \mathbb{R}^+, \\ \boldsymbol{\sigma}_f \cdot \boldsymbol{n} = \boldsymbol{\sigma}_s \cdot \boldsymbol{n} & \text{on} \quad \partial \Sigma \times \mathbb{R}^+, \end{cases}$$

where n is the outward unit normal. Completed with appropriate initial and boundary conditions, the coupled problem (1, 2, 3) is discretized by an affine finite-element method using the Brezzi-Pitkäranta pressure stabilization in the fluid in order to avoid the inf-sup compatibility issues and a Nitsche treatment of the surface coupling. The resulting semi-discrete system is solved in time by the implicit Euler scheme, leading at each time step t_n to the resolution of the linear system

where $\boldsymbol{\theta} = [\rho^f, \mu, \rho^s, \lambda_1, \lambda_2] \in \mathbb{R}^5$ denotes the input parameter and $\boldsymbol{y} = [\boldsymbol{u}, p, \boldsymbol{d}] \in \mathbb{R}^{N_{\boldsymbol{x}}}$ denotes the solution.

The first part of this work concerns the evaluation of the solution y corresponding to a possibly large number of input parameters $\theta_1, \dots, \theta_{N_{\theta}}$. For this purpose, since

system (4) is first written in matrix notation as follows

Then, the solution Y is approximated by a low-rank tensor in order to significantly reduce the number of degrees of freedom:

$$\widetilde{\boldsymbol{Y}}(t_n) = \boldsymbol{U}(t_n) \boldsymbol{V}(t_n)^T,$$

where $U(t_n) \in \mathbb{R}^{N_x \times N_r}$ and $V(t_n) \in \mathbb{R}^{N_\theta \times N_r}$ with $N_r \ll N_x, N_\theta$. The approximate solution is finally determined at low cost by the low-rank Generalized Minimal RESidual (GMREST) method [1].

In the second part of this work, the previous low-rank tensor method is employed in an uncertainty quantification task.

3 RESULTS AND CONCLUSIONS

The proposed method is evaluated on the propagation of a pressure-wave within a straight tube in two-dimensions. The parameter space is defined in accordance with cardiovascular applications as $\boldsymbol{\theta} \in [0.9, 1.1] \times [0.03, 0.04] \times [1, 1.2] \times [1.1 \cdot 10^6, 1.2 \cdot 10^6] \times [1.6 \cdot 10^6, 1.8 \cdot 10^6]$. The preliminary results show the significant reduction of the computational cost provided by the low-rank tensor method.
