# LOW-ORDER FICTITIOUS DOMAIN METHOD WITH ENHANCED MASS CONSERVATION FOR AN INTERFACE STOKES PROBLEM\*

**Abstract**. One of the main difficulties that has to be faced with fictitious domain approximation of incompressible flows with immersed interfaces is related to the potential lack of mass conservation across the interface. In this paper, we propose and analyze a low order fictitious domain stabilized finite element method which mitigates this issue with the addition of a single velocity constraint. We provide a complete a priori numerical analysis of the method under minimal regularity assumptions. A comprehensive numerical study illustrates the capabilities of the proposed method, including comparisons with alternative fitted and unfitted mesh methods.

**Résumé**. Nous nous intéressons à la simulation numérique d'un problème mettant en jeu deux fluides incompressibles représentés par les équations de Stokes et séparés par une interface fine. Nous considérons une discrétisation basée sur une méthode éléments finis d'ordre bas de type domaine fictif. La principale difficulté d'une telle méthode est la mauvaise conservation de la masse près de l'interface. Pour y remédier, nous ajoutons une constrainte scalaire supplémentaire sur l'inconnue vitesse. Nous proposons une analyse numérique de la méthode ainsi obtenue, et établissons notamment des bornes d'erreur a priori sur la solution sous des hypothèses de régularité minimales. Des simulations numériques permettent de juger de l'efficacité de la méthode. Une comparaison avec d'autres méthodes de type domaine fictif est également fournie.

#### 1. Introduction

The simulation of incompressible flows with immersed moving interfaces plays a fundamental role in a wide variety of engineering fields: from the biomechanics of heart valves to the aeroelasticity of parachutes (see, e.g., [41, 42, 48, 50, 52]). The spatial approximation of this type of problems typically falls into one of the following two categories: fitted and unfitted mesh numerical methods.

In fitted mesh methods, the computational mesh has an explicit representation of the immersed interface. This facilitates the enforcement of the interface conditions and, furthermore, (weak and strong) discontinuities of

the solution can be straightforwardly incorporated at the discrete level, yielding an optimally accurate method. Nevertheless, the body-fitted nature of the mesh can become cumbersome for large interface deflections, due to highly distorted meshes which may require remeshing or topological modifications of the mesh (see, e.g., [1,49]) and thus increase computational cost.

Unfitted mesh methods are a widespread approach to avoid these issues. In these approaches, the immersed interface is, by construction, free to move independently of the background computational mesh. This flexibility comes however at a price: the lack of interfacial representation within the computational mesh can lead to accuracy issues. Among these types of methods, the immersed boundary and fictitious domain methods (see, e.g., [8,11,30,44,47]) are ones of the most widespread, due to their simplicity of implementation. Basically, the idea consists in enforcing the interface Dirichlet condition as an additional constraint, using Lagrange multipliers, or penalization. In general, these methods have the reputation of being sub-optimally accurate and of suffering from interfacial mass conservation issues. This is a consequence of the fact that the discrete velocity and pressure do not allow for weak and strong discontinuities, respectively, across the interface. Different approaches have been proposed in the literature to circumvent these two different issues.

In the fictitious domain control approach proposed in [4,24,51], optimal accuracy is obtained by constructing a smooth extension which removes the weak discontinuity in the velocity. The method introduces, however, additional unknowns and lacks complete numerical analysis. Cut-FEM approaches achieve optimal accuracy by integrating the equations only in the physical region and by adding suitable stabilization terms for robustness (see, e.g., [14,33,35]), but they require a more involved computer implementation due to the specific tracking of the interface intersections and quadrature over arbitrary polygons. Recent approaches, such as the shifted boundary method or the  $\phi$ -FEM method (see, e.g., [21,22,39]) avoid these computational geometry difficulties, but their interface formulation is not straightforward (due to the introduction of additional unknowns or the need of a level-set description of the interface).

Penalized grad-div interfacial stabilization is known to enhance mass conservation across the interface (see, e.g., [12,16,28,37,40]), but at the price of degradation of the system matrix conditioning, which drastically limits the applicability of the method. The extended finite element method (XFEM) is an elegant way of guaranteeing interfacial mass conservation by introducing strong pressure discontinuities across the interface at the discrete level (see, e.g., [2,7,38,45,53]), but this requires the integration over cut-elements and the number of degrees of freedom (and hence the size of the system matrix) may change between different interface locations. Enhancing mass conservation in fictitious domain methods by using globally discontinuous pressure is an alternative to XFEM, but inf-sup stability prevents the use of low order elements for the velocity (see, e.g., [5,9,10]). Similar observations can be made on the combination of unfitted mesh methods and divergence free approximations (see, e.g., [17,40]), with the exception of the cut-FEM method reported in [15] based on the minimal divergence free element introduced in [18].

Numerical evidence (see, e.g., [12]) suggests that, in practice, the inaccuracies of traditional fictitious domains methods for incompressible flows are mainly driven by the artificial interfacial mass loss, rather than by the sub-optimality of the convergence rate. In this paper, we introduce a new low order fictitious domain finite element method based on continuous piecewise affine approximations. We consider as model problem the Stokes equations with an immersed Dirichlet interface condition. At the discrete level, the interface condition is enforced via Lagrange multipliers and mass conservation across the interface is enhanced by enforcing an additional velocity constraint. This constraint can be interpreted as an enrichment of the pressure approximation space with a single Heaviside function across the interface. Similar ideas have been advocated in [36], but for a different fictitious domain method (involving discrete Dirac delta functions) and without error analysis. Suitable stabilization terms are introduced to guarantee inf-sup stability (Lemma 4.8) and a priori error estimates for the velocity and pressure are also derived (Theorem 4.11). These error estimates are robust with respect to the magnitude of the pressure jump across the interface, due to the additional basis function. Finally, a comprehensive numerical study provides numerical evidence on the error analysis and illustrates the capabilities of the proposed method. This method is compared with different fitted and unfitted mesh methods in two benchmarks. The numerical results show, in particular, that the present approach provides a simple and robust

low order method that mitigates the accuracy issues of traditional fictitious domain methods for incompressible flows with immersed interfaces.

The rest of the paper is organized as follows. The continuous setting is introduced in Section 2. Section 3 presents the proposed numerical method. A priori stability and error estimates of the method are derived in Section 4. Section 5 is devoted to the numerical investigations. Finally, some conclusions and lines of future work are drawn in Section 6.

#### 2. Problem setting

Let  $\Omega \subset \mathbb{R}^d$ , d=2 or 3, be a bounded polygonal/polyhedral domain and  $\Sigma$  be a polygonal oriented manifold of co-dimension 1 fully immersed in  $\Omega$  and with unit normal vector  $\mathbf{n}_{\Sigma}$ . We assume that  $\Sigma$  divides  $\Omega$  into two sub-domains  $\Omega_1$  and  $\Omega_2$  such that  $\Omega_1 \cap \Omega_2 = \emptyset$ ,  $\partial \Omega_1 \cap \partial \Omega_2 = \Sigma$  and  $\partial \Omega = (\partial \Omega_1 \cup \partial \Omega_2) \setminus \Sigma$ , where  $\partial \Omega_i$  and  $\partial \Omega$  stand for the boundaries of  $\Omega_i$  and  $\Omega$ , respectively. Moreover,  $\partial \Omega$  is partitioned as  $\partial \Omega = \Gamma_D \cup \Gamma_N$  with  $\Gamma_D$  (respectively  $\Gamma_N$ ) being the part of the boundary on which Dirichlet (respectively Neumann) conditions are enforced. The symbol  $\mathbf{n}_i$  denotes the unit outward normal to  $\Omega_i$ . Note that  $\Omega_1$  and  $\Omega_2$  are arbitrarily chosen so that  $\mathbf{n}_1 = \mathbf{n}_{\Sigma}$  and  $\mathbf{n}_2 = -\mathbf{n}_{\Sigma}$  on  $\Sigma$ . We also denote by  $\mathbf{n}$  the outward unit normal vector to  $\partial \Omega$ .

In order to ease the presentation, we shall make use of the following assumption.

**Assumption 2.1.** The Neumann boundary  $\Gamma_N$  is away from the interface  $\Sigma$ ; i.e.  $\Gamma_N \cap \Sigma = \emptyset$ . Moreover, both sub-domains have a Neumann boundary; i.e.  $\forall i \in \{1,2\}, \partial \Omega_i \cap \Gamma_N \neq \emptyset$ .

**Remark 2.2.** This assumption is chosen to deal with a configuration of two heart cavities separated by a closed valve. The case of one or both sub-domains not having a Neumann boundary can be easily treated by changing the spaces representing the pressure at continuous and discrete levels in order to take into account a zero-mean constraint.




FIGURE 1. Left: an admissible geometric configuration. Right: a non-admissible configuration (see Assumption 2.1 and Remark 2.2).

An illustration of admissible and non-admissible configurations is given in Figure 1. The following notation will be extensively used in the paper. Let  $\phi$  be a scalar or tensorial field defined in  $\Omega$  and possibly discontinuous across  $\Sigma$ , we define its sided restrictions, denoted by  $\phi_1$  and  $\phi_2$ , as

and the following jump operators across the interface  $\Sigma$ :

$$\llbracket \phi \rrbracket \stackrel{\text{def}}{=} \phi_1 - \phi_2, \qquad \llbracket \phi \boldsymbol{n} \rrbracket \stackrel{\text{def}}{=} \phi_1 \boldsymbol{n}_1 + \phi_2 \boldsymbol{n}_2 = \llbracket \phi \rrbracket \boldsymbol{n}_{\Sigma}.$$

For any subset  $\omega \subset \Omega$ , we will use the standard Sobolev spaces  $H^{m}(\omega)$   $(m \geq 0)$ , equipped with the standard norm  $\|\cdot\|_{H^m(\omega)}$ , while  $(\cdot,\cdot)_{\omega}$  denotes the usual  $L^2(\omega)$ -scalar product. We also denote by  $|\omega|$  the usual Lebesgue measure of  $\omega$ . For  $S \subset \partial\Omega \cup \Sigma$ , the closed subspace  $H_S^1$  represents the space of  $H^1$  functions with zero value on

Let  $\boldsymbol{f} \in [L^2(\Omega)]^d$ ,  $\boldsymbol{g} \in [L^2(\Gamma_N)]^d$  and  $\boldsymbol{u}_{\Sigma} \in [H_0^1(\Sigma)]^d$  be given fields. We consider the following Stokes problem in  $\Omega$  with an immersed Dirichlet condition: Find  $u:\Omega\to\mathbb{R}^d$  and  $p:\Omega\to\mathbb{R}$ , fluid velocity and pressure respectively, such that:

$$\begin{cases}

\nabla \cdot \boldsymbol{u} = 0 & \text{in } \Omega_i, \\

\boldsymbol{\sigma}(\boldsymbol{u}, p) \boldsymbol{n} = \boldsymbol{g} & \text{on } \Gamma_N, \\

\end{cases} \tag{1}$$

for i = 1, 2. Here, the symbol  $\sigma(u, p)$  stands for the Cauchy stress tensor of the fluid, given by

$$\boldsymbol{\sigma}(\boldsymbol{u},p) \stackrel{\text{def}}{=} 2\mu \boldsymbol{\varepsilon}(\boldsymbol{u}) - p\boldsymbol{I}, \quad \boldsymbol{\varepsilon}(\boldsymbol{u}) \stackrel{\text{def}}{=} \frac{1}{2} \left( \boldsymbol{\nabla} \boldsymbol{u} + \boldsymbol{\nabla} \boldsymbol{u}^{\mathrm{T}} \right),$$

where  $\mu > 0$  denotes the fluid dynamic viscosity.

Note that system (1) corresponds to two independent Stokes problems with a shared Dirichlet condition on the interface  $\Sigma$ . This kind of problems arises, for instance, in fluid-structure interaction problems with immersed thin-walled solids (see, e.g., [12]). The goal of the present paper is to propose and analyze a fictitious domain approximation of (1) in which the underlying computational mesh is not fitted to  $\Sigma$ . To this purpose, we first introduce a global variational formulation of (1) and we use Lagrange multipliers to enforce the Dirichlet constraint on  $\Sigma$ .

We consider the following velocity and pressure functional spaces

$$\boldsymbol{V} \stackrel{\text{def}}{=} [H^1_{\Gamma_{\mathbf{D}}}(\Omega)]^d, \quad Q \stackrel{\text{def}}{=} L^2(\Omega),$$

respectively. We make use of the standard Stokes bilinear form  $a: (V \times Q) \times (V \times Q) \to \mathbb{R}$  and the linear

For the weak treatment of the Dirichlet interface condition on  $\Sigma$ , we consider the Lagrange multiplier  $\mathbf{\Lambda} \stackrel{\text{def}}{=} \left( [H_{00}^{\frac{1}{2}}(\Sigma)]^d \right)'$ , defined as the dual space of  $\left[ H_{00}^{\frac{1}{2}}(\Sigma) \right]^d$ , and the bilinear form  $b : \mathbf{\Lambda} \times \left[ H_{00}^{\frac{1}{2}}(\Sigma) \right]^d \to \mathbb{R}$ , given by

where  $\langle \cdot, \cdot \rangle$  denotes the duality pairing between  $\Lambda$  and  $[H_{00}^{\frac{1}{2}}(\Sigma)]^d$ . The weak formulation of problem (1) then reads as follows: Find  $(\boldsymbol{u}, p, \boldsymbol{\lambda}) \in \boldsymbol{V} \times Q \times \Lambda$  such that

$$\mathcal{A}((\boldsymbol{u}, p, \boldsymbol{\lambda}), (\boldsymbol{v}, q, \boldsymbol{\xi})) = \mathcal{F}(\boldsymbol{v}, \boldsymbol{\xi}), \tag{2}$$

for all  $(v, q, \xi) \in V \times Q \times \Lambda$ , where the operators A and F are defined as follows:

$$\mathcal{A}((\boldsymbol{u}, p, \boldsymbol{\lambda}), (\boldsymbol{v}, q, \boldsymbol{\xi})) \stackrel{\text{def}}{=} a((\boldsymbol{u}, p), (\boldsymbol{v}, q)) - b(\boldsymbol{\lambda}, \boldsymbol{v}) + b(\boldsymbol{\xi}, \boldsymbol{u}), \quad \mathcal{F}(\boldsymbol{v}, \boldsymbol{\xi}) \stackrel{\text{def}}{=} \ell(\boldsymbol{v}) + b(\boldsymbol{\xi}, \boldsymbol{u}_{\Sigma}).$$

Using a standard argument of integration by parts in  $\Omega_i$ , it can be shown that problem (1) is equivalent to problem (2) with

$$\lambda = [\![ \sigma(u, p) n ]\!] \quad \text{on} \quad \Sigma.$$
 (4)

In other words, the unknown Lagrange multiplier represents the jump of the fluid stress across the interface  $\Sigma$  resulting from the enforcement of the Dirichlet condition on  $\Sigma$ . Moreover, it is classical to show that problem (2) is well-posed.

As regards the regularity of the solution  $(\boldsymbol{u},p)$ , it should be noted that the Dirichlet constraint in (1) does not ensure continuity of the pressure or of the velocity gradient. Concerning the functional framework of problem (1), the potential presence of discontinuities on the interface  $\Sigma$  for the solution (resp. its gradient) reduces the regularity of p (resp.  $\boldsymbol{u}$ ). More precisely, instead of the standard spaces  $H^1(\Omega)$  and  $[H^2(\Omega)]^d$  for the pressure and velocity, we use the spaces  $H^{1/2-\varepsilon}(\Omega)$  and  $[H^{3/2-\varepsilon}(\Omega)]^d$ , for some  $\varepsilon \in (0, \frac{1}{2})$ . Furthermore, the regularity of p (resp.  $\boldsymbol{u}$ ) in each subdomain  $\Omega_i$ , with i=1,2, is limited to  $H^{\frac{1}{2}+\varepsilon}(\Omega_i)$  (resp.  $[H^{\frac{3}{2}+\varepsilon}(\Omega_i)]^d$ ) due to the potential presence of reentrant corners on the interface and corners between  $\Gamma_D$  and  $\Gamma_N$  (see Figure 1). For further details on these aspects the reader is referred to [32, 43]. Accordingly, we introduce the following spaces:

$$\mathbf{V}_{\varepsilon} = \left\{ \mathbf{v} \in [H_{\Gamma_{D}}^{\frac{3}{2} - \varepsilon}(\Omega)]^{d} \middle| \mathbf{v} \middle|_{\Omega_{i}} \in [H^{\frac{3}{2} + \varepsilon}(\Omega_{i})]^{d}, \ i = 1, 2 \right\}, 
Q_{\varepsilon} = \left\{ q \in H^{\frac{1}{2} - \varepsilon}(\Omega) \middle| q \middle|_{\Omega_{i}} \in H^{\frac{1}{2} + \varepsilon}(\Omega_{i}), \ i = 1, 2 \right\}.$$

Note that the traces of elements of these spaces are well defined on each sub-domain boundary  $\partial\Omega_i$ .

#### 3. Discrete Problem

Let us introduce  $\{\mathcal{T}_h^{\Omega}\}_{0< h<1}$  and  $\{\mathcal{T}_{\mathcal{H}}^{\Sigma}\}_{0< \mathcal{H}<1}$  two families of quasi uniform simplicial meshes (see, e.g., [23]) of  $\Omega$  and  $\Sigma$ , respectively. The symbol h (respectively  $\mathcal{H}$ ) denotes the mesh parameter for  $\Omega$  (respectively  $\Sigma$ ). We assume that  $\mathcal{T}_h^{\Omega}$  is fitted to  $\partial\Omega$  but, in general, not to  $\Sigma$ . We consider the two following standard spaces of continuous piecewise affine functions:

$$X_h^{\Omega} \stackrel{\text{def}}{=} \left\{ \chi_h \in C^0(\overline{\Omega}) \middle| \ \chi_h|_K \in \mathbb{P}_1(K), \quad \forall K \in \mathcal{T}_h^{\Omega} \right\}, \quad X_{\mathcal{H}}^{\Sigma} \stackrel{\text{def}}{=} \left\{ \chi_{\mathcal{H}} \in C^0(\overline{\Sigma}) \middle| \ \chi_{\mathcal{H}}|_K \in \mathbb{P}_1(K), \quad \forall K \in \mathcal{T}_{\mathcal{H}}^{\Sigma} \right\}.$$

Finally, we introduce the discrete space  $\widetilde{Q}_h \stackrel{\text{def}}{=} X_h^{\Omega} \subset Q$  and the discrete spaces  $V_h, Q_h, \Lambda_{\mathcal{H}}$  for the approximation of the velocity, pressure and Lagrange multiplier as follows:

$$V_h \stackrel{\text{def}}{=} [X_h^{\Omega}]^d \cap V, \quad Q_h \stackrel{\text{def}}{=} \widetilde{Q}_h \oplus \langle 1_{\Omega_1} \rangle \subset Q, \quad \Lambda_{\mathcal{H}} \stackrel{\text{def}}{=} [X_{\mathcal{H}}^{\Sigma}]^d \subset \Lambda, \tag{6}$$

where the symbol  $1_{\Omega_1}$  denotes the characteristic function of  $\Omega_1$  and  $\langle 1_{\Omega_1} \rangle$  the vector space spanned by  $1_{\Omega_1}$ . We recall that the choice of  $\Omega_1$  and  $\Omega_2$  is arbitrary, so that the characteristic function could have been taken over  $\Omega_2$  instead of over  $\Omega_1$ .

As mentioned in the introduction, it is well known that the approximation of the pressure in (2) with continuous finite elements guarantees global mass conservation in the computational fluid domain  $\Omega$ , but does not prevent spurious leakage across the interface  $\Sigma$  (see, e.g., Section 5.2, and particularly Figure 8a). The choice of the non-standard pressure space  $Q_h$  can be considered as the simplest enrichment of the usual discrete continuous space  $\widetilde{Q}_h$  in order to overcome the artificial interfacial mass loss induced by the continuous nature of the pressure approximation. Further advanced enrichment techniques have been suggested. Notably, the extended finite element method (XFEM) (see, e.g., [33]) involves the addition of supplementary basis function for each cut cell. Notice that, in the present method, by using a single supplementary basis function for the pressure space, the size of the linear system is independent of the interface position.

Owing to the definition of the discrete pressure space (6), every  $q_h \in Q_h$  can be decomposed into the sum of two contributions, namely,

$$q_h = \widetilde{q}_h + \widehat{q}_h, \tag{7}$$

where  $\widetilde{q}_h \in \widetilde{Q}_h$  is a continuous piecewise affine function over the whole computational domain  $\Omega$  and  $\widehat{q}_h \in \langle 1_{\Omega_1} \rangle$  is a Heaviside function that allows strong discontinuities across the interface  $\Sigma$ . Moreover, the following relations hold

$$\widehat{q}_h = [\![q_h]\!] 1_{\Omega_1}, \quad \widetilde{q}_h = q_h - [\![q_h]\!] 1_{\Omega_1},$$
(8)

where  $[q_h]$  is the constant jump of  $q_h$  across  $\Sigma$ .

In order to overcome the instability of the saddle-point problem due to the choice of the Lagrange multiplier finite element space (6) and to avoid any constraint on the ratio between the fluid mesh size h and the solid mesh size  $\mathcal{H}$  (as can, for instance, be seen in [11]), we introduce the following stabilization term (in the spirit of the Barbosa-Hughes stabilization [6]):

$$s_h^{\mathrm{BH}}((p_h, \boldsymbol{\lambda}_{\mathcal{H}}), (q_h, \boldsymbol{\xi}_{\mathcal{H}})) \stackrel{\mathrm{def}}{=} \frac{h}{\gamma_{\lambda} \mu} (\boldsymbol{\lambda}_{\mathcal{H}} + [\![p_h]\!] \boldsymbol{n}_{\Sigma}, \boldsymbol{\xi}_{\mathcal{H}} + [\![q_h]\!] \boldsymbol{n}_{\Sigma})_{\Sigma}, \tag{9}$$

with  $\gamma_{\lambda} > 0$  a user-defined dimensionless parameter. Furthermore, the following Brezzi-Pitkäranta stabilization [13] is considered to overcome the lack of inf-sup compatibility between the velocity and pressure spaces  $V_h$  and  $Q_h$ :

$$s_h^{\mathrm{BP}}\left(p_h,q_h\right) \stackrel{\mathrm{def}}{=} \frac{\gamma_{\mathrm{p}}h^2}{\mu} \left(\boldsymbol{\nabla}\widetilde{p}_h,\boldsymbol{\nabla}\widetilde{q}_h\right)_{\Omega},$$

with  $\gamma_{\rm p} > 0$  a user-defined dimensionless parameter. Note that the pressure stabilization operator  $s_h^{\rm BP}$  only acts on the continuous part,  $\widetilde{p}_h$ , of the discrete pressure,  $p_h$ .

The proposed discrete approximation of (2) reads as follows: Find  $(u_h, p_h, \lambda_H) \in V_h \times Q_h \times \Lambda_H$  such that

$$\mathcal{A}_{h}((\boldsymbol{u}_{h}, p_{h}, \boldsymbol{\lambda}_{\mathcal{H}}), (\boldsymbol{v}_{h}, q_{h}, \boldsymbol{\xi}_{\mathcal{H}})) = \mathcal{F}(\boldsymbol{v}_{h}, \boldsymbol{\xi}_{\mathcal{H}}), \tag{10}$$

for all  $(\boldsymbol{v}_h, q_h, \boldsymbol{\xi}_{\mathcal{H}}) \in \boldsymbol{V}_h \times Q_h \times \boldsymbol{\Lambda}_{\mathcal{H}}$ , with the notation

$$\mathcal{A}_{h}((\boldsymbol{u}_{h}, p_{h}, \boldsymbol{\lambda}_{\mathcal{H}}), (\boldsymbol{v}_{h}, q_{h}, \boldsymbol{\xi}_{\mathcal{H}})) \stackrel{\text{def}}{=} \mathcal{A}((\boldsymbol{u}_{h}, p_{h}, \boldsymbol{\lambda}_{\mathcal{H}}), (\boldsymbol{v}_{h}, q_{h}, \boldsymbol{\xi}_{\mathcal{H}})) + s_{h}^{\text{BP}}(p_{h}, q_{h}) + s_{h}^{\text{BH}}((p_{h}, \boldsymbol{\lambda}_{\mathcal{H}}), (q_{h}, \boldsymbol{\xi}_{\mathcal{H}})).$$
(11)

**Remark 3.1.** It is worth noticing that the stabilization operator (9) is only weakly consistent since, according to (4), the Lagrange multiplier  $\lambda$  is not necessarily equal to  $-\llbracket p \rrbracket n_{\Sigma}$ . In the spirit of [6], a consistent version of the stabilization would be

$$\frac{h}{\gamma_{\lambda}\mu} (\boldsymbol{\lambda}_{\mathcal{H}} - [\![\boldsymbol{\sigma}(\boldsymbol{u}_h, p_h) \, \boldsymbol{n}]\!], \boldsymbol{\xi}_{\mathcal{H}} - [\![\boldsymbol{\sigma}(\boldsymbol{v}_h, q_h) \, \boldsymbol{n}]\!])_{\Sigma}.$$

The reason of excluding the normal component of the strain tensor  $\llbracket \varepsilon (v_h) \rrbracket n_{\Sigma}$  is related to the fact that for piecewise affine velocity approximations, this contribution vanishes in any cut element whose boundary is not conformal to the interface.

**Remark 3.2.** Due to the choice of the finite element space  $Q_h$  in (6), we have

$$\left(\boldsymbol{\nabla}\cdot\boldsymbol{v}_{h},q_{h}\right)_{\Omega}=\left(\boldsymbol{\nabla}\cdot\boldsymbol{v}_{h},\widetilde{q}_{h}\right)_{\Omega}+\llbracket q_{h}\rrbracket\left(\boldsymbol{v}_{h}\cdot\boldsymbol{n}_{1},1\right)_{\partial\Omega_{1}}=\left(\boldsymbol{\nabla}\cdot\boldsymbol{v}_{h},\widetilde{q}_{h}\right)_{\Omega}+\llbracket q_{h}\rrbracket\int_{\partial\Omega_{1}}\boldsymbol{v}_{h}\cdot\boldsymbol{n}_{1}$$

for all  $(v_h, q_h) \in V_h \times Q_h$ . Therefore, owing to (7)-(8), the system matrix associated to (10) can be assembled as a combination of two mass conservation constraints. The first corresponds to the traditional divergence free constraint imposed via continuous piecewise affine pressures, namely,

$$\left(\boldsymbol{\nabla}\cdot\boldsymbol{u}_{h},\widetilde{q}_{h}\right)_{\Omega}=0\quad\forall\widetilde{q}_{h}\in\widetilde{Q}_{h},\tag{12}$$

which guaranties global mass conservation in  $\Omega$ , while the second enhances interfacial mass conservation by enforcing

$$\int_{\partial\Omega_1} \boldsymbol{u}_h \cdot \boldsymbol{n}_1 = 0,\tag{13}$$

which guaranties global mass conservation in  $\Omega_1$  (and also in  $\Omega_2$ , thanks to (12)). The constraint (13) is imposed via the corresponding Lagrange multiplier  $\llbracket p_h \rrbracket$ , which also represents the value of the discrete pressure jump across the interface. To the best of our knowledge, the introduction of the additional constraint (13) for enhancing interfacial mass conservation was reported for the first time in [36], for a different fictitious domain method and without error analysis.

## 4. Numerical analysis

This section is devoted to the a priori stability and error analysis of the numerical method provided by (10) and is organized as follows. We first introduce several interpolation operators, based on quasi-interpolation. Then, we prove inf-sup stability of the bilinear form  $\mathcal{A}_h$ . We then bound the consistency error of the scheme. Finally, we combine all these results to establish the desired a priori error bounds fulfilled by the numerical solution.

In what follows, we write  $A \lesssim B$  (resp.  $A \gtrsim B$ ) to abbreviate the inequality  $A \leq CB$  (resp.  $CA \geq B$ ) for positive real numbers A and B, where the constant C > 0 does not depend on h,  $\mathcal{H}$ , neither on the way the interface mesh  $\mathcal{T}^{\Sigma}_{\mathcal{H}}$  cuts the fluid mesh  $\mathcal{T}^{\Omega}_h$  nor on the solutions of the continuous and discrete problems. We also use the notation  $\mathbf{H}^s(\omega) \stackrel{\text{def}}{=} [H^s(\omega)]^d$  for all s > 0 and all  $\omega \subset \Omega$ .




FIGURE 2. In gray the fluid domain triangulation  $\mathcal{T}_h^{\Omega}$  and in black the interface domain triangulation  $\mathcal{T}_{\mathcal{H}}^{\Sigma}$ . The elements of  $\mathcal{T}_h^{\mathrm{c}}$  are marked in \_\_\_\_\_, the elements of  $\mathcal{T}_h^{\mathrm{e}}$  are marked in \_\_\_\_\_ and the nodes in  $\mathcal{N}_h^{\mathrm{c}}$  are marked by \_\_\_\_\_.

We now introduce some geometric definitions that are widely used in the current section. Let K be an element of  $\mathcal{T}_h^{\Omega}$  and  $\boldsymbol{x}_{K,i}$  its i-th node. We denote by  $\mathcal{T}_h^{c} \stackrel{\text{def}}{=} \{K \in \mathcal{T}_h^{\Omega} : K \cap \Sigma \neq \emptyset\}$  the set of elements of  $\mathcal{T}_h^{\Omega}$  cut by the interface  $\Sigma$ , by  $\mathcal{N}_h \stackrel{\text{def}}{=} \{\boldsymbol{x}_{K,i} : K \in \mathcal{T}_h^{\Omega}\}$  the set of nodes, by  $\mathcal{N}_h^{c} \stackrel{\text{def}}{=} \{\boldsymbol{x}_{K,i} : K \in \mathcal{T}_h^{c}\}$  the set of nodes belonging to at least one cut element and by  $\mathcal{T}_h^{e} \stackrel{\text{def}}{=} \{K \in \mathcal{T}_h^{\Omega} : \{\boldsymbol{x}_{K,i}\} \cap \mathcal{N}_h^{c} \neq \emptyset\}$  the set of elements of  $\mathcal{T}_h^{\Omega}$  sharing at least one node with a cut element. See Figure 2. Let us now introduce the following assumptions.

**Assumption 4.1.** We assume that the interface is well resolved by  $\mathcal{T}_h^{\Omega}$ , i.e.  $h |\Sigma \cap K| \lesssim |K| \ \forall K \in \mathcal{T}_h^{\Omega}$ .

**Assumption 4.2.** We assume that every cut cell  $K \in \mathcal{T}_h^c$  shares at least one vertex with an uncut cell  $\widetilde{K}_1 \subset \Omega_1$  and at least another one with an uncut cell  $\widetilde{K}_2 \subset \Omega_2$ , with  $\widetilde{K}_1, \widetilde{K}_2 \in \mathcal{T}_h^{\Omega} \setminus \mathcal{T}_h^c$ .

These assumptions are fulfilled when the mesh is fine enough.

### 4.1. Approximability

In this section, quasi-interpolation operators are considered to approximate non-smooth functions (see, e.g., [23, Chapter 22]). We recall that the exact solution of (2) has a low regularity due to the presence of weak and strong discontinuities across the interface (velocity and pressure, respectively). This is why we propose the following adapted approximation operators, based on quasi-interpolation, that are defined even for low-regularity functions.

- (1)  $\Pi_h: V \to V_h$  is a given quasi-interpolation operator onto  $V_h$ ;
- (2)  $\Pi_h: Q_{\varepsilon} \to Q_h$ , is defined as

$$\Pi_h q \stackrel{\text{def}}{=} \widetilde{\Pi}_h q + \widehat{\Pi}_h q \quad \forall q \in Q_{\varepsilon},$$

with

$$\widehat{\Pi}_h q \stackrel{\text{def}}{=} \left( \frac{1}{|\Sigma|} \int_{\Sigma} \llbracket q \rrbracket \right) 1_{\Omega_1}, \tag{14}$$

the mean value of the pressure jump across the interface  $\Sigma$ , and

$$\widetilde{\prod}_h q \stackrel{\text{def}}{=} \overline{\prod}_h (q - \widehat{\prod}_h q),$$

with  $\bar{\Pi}_h: Q_{\epsilon} \to \widetilde{Q}_h$  a given quasi-interpolation operator onto  $\widetilde{Q}_h$ . (3)  $\mathbf{\Pi}_{\mathcal{H}}: [L^2(\Sigma)]^d \to \mathbf{\Lambda}_{\mathcal{H}}$ , a given quasi-interpolation operator onto  $\mathbf{\Lambda}_{\mathcal{H}}$ .

Owing to the properties of the quasi-interpolation operators (see, e.g., [23, Chapter 22]), we have the following result.

**Lemma 4.3.** Let  $\varepsilon \in (0, \frac{1}{2})$ . Assume that  $p \in Q_{\varepsilon}$  and  $\lambda \in [L^2(\Sigma)]^d$ . For the above defined operators the following estimates hold:

$$\| \llbracket \Pi_h \, p \rrbracket \|_{L^2(\Sigma)} \le \| \llbracket p \rrbracket \|_{L^2(\Sigma)} \,,$$
 (15)

$$\|\mathbf{\Pi}_{\mathcal{H}} \lambda\|_{L^{2}(\Sigma)} \lesssim \|\lambda\|_{L^{2}(\Sigma)}, \tag{16}$$

$$h \| \boldsymbol{\nabla} \, \widetilde{\Pi}_h \, p \|_{L^2(\Omega)} \lesssim h^{\frac{1}{2} - \varepsilon} \| p - \widehat{\Pi}_h \, p \|_{H^{\frac{1}{2} - \varepsilon}(\Omega)}, \tag{17}$$

$$\left\| \mathbf{\Pi}_{\mathcal{H}} \left( \boldsymbol{\lambda} + \left[ \widehat{\boldsymbol{\Pi}}_{h} \, p \right] \, \boldsymbol{n}_{\Sigma} \right) \right\|_{L^{2}(\Sigma)} \lesssim \left\| \boldsymbol{\lambda} + \left[ \widehat{\boldsymbol{\Pi}}_{h} \, p \right] \, \boldsymbol{n}_{\Sigma} \right\|_{L^{2}(\Sigma)}. \tag{18}$$

Proof. The estimates (16) and (18) are standard (see, e.g., [23, Corollary 22.8]). We focus on estimate (17). Let  $K \in \mathcal{T}_h^{\Omega}$  and  $\overline{p}_K$  be the mean value of  $p - \widehat{\prod}_h p$  over S(K), the patch of elements around K. Using the definition of  $\widetilde{\Pi}_h$ , we have

$$\begin{split} h \left\| \boldsymbol{\nabla} \, \widetilde{\boldsymbol{\Pi}}_h \, p \right\|_{L^2(K)} &= \left\| h \left\| \boldsymbol{\nabla} (\widetilde{\boldsymbol{\Pi}}_h \, p - \overline{p}_K) \right\|_{L^2(K)} \lesssim \right\| \widetilde{\boldsymbol{\Pi}}_h \, p - \overline{p}_K \right\|_{L^2(K)} \lesssim \left\| \overline{\boldsymbol{\Pi}}_h \left( p - \widehat{\boldsymbol{\Pi}}_h \, p \right) - \overline{p}_K \right\|_{L^2(K)} \\ &\lesssim \left\| \overline{\boldsymbol{\Pi}}_h (p - \widehat{\boldsymbol{\Pi}}_h \, p - \overline{p}_K) \right\|_{L^2(K)} \lesssim \left\| p - \widehat{\boldsymbol{\Pi}}_h \, p - \overline{p}_K \right\|_{L^2(S(K))} \lesssim \left\| h^{\frac{1}{2} - \varepsilon} \left\| p - \widehat{\boldsymbol{\Pi}}_h \, p \right\|_{H^{\frac{1}{2} - \varepsilon}(S(K))}, \end{split}$$

where we used an inverse inequality, the local stability of  $\bar{\Pi}_h$  (see, e.g., [23, Corollary 22.8]) and approximation properties of the mean value. Summing the square of this relation over all  $K \in \mathcal{T}_h^{\Omega}$  and using the quasi-uniformity of the mesh gives (17). For (15), we use the fact that  $\llbracket \Pi_h p \rrbracket$  is a constant and that  $\llbracket \Pi_h p \rrbracket 1_{\Omega_1} = \widehat{\Pi}_h p$ , so that we have

$$\| [\![ \Pi_h \, p ]\!] \|_{L^2(\Sigma)}^2 = |\Sigma| \, |\![ \Pi_h \, p ]\!] |^2 = |\Sigma|^{-1} \left( \int_{\Sigma} [\![ p ]\!] \right)^2 \le \| [\![ p ]\!] \|_{L^2(\Sigma)}^2 \,,$$

where for the last inequality we used Cauchy-Schwarz on the squared term. This completes the proof.  For  $u \in V$ ,  $p \in Q_{\varepsilon}$  and  $\lambda \in [L^2(\Sigma)]^d$ , we introduce the following approximation errors

$$e_u \stackrel{\text{def}}{=} u - \Pi_h u, \quad e_p \stackrel{\text{def}}{=} p - \Pi_h p, \quad e_\lambda \stackrel{\text{def}}{=} \lambda - \Pi_{\mathcal{H}} \lambda.$$
 (19)

We have the following approximation result.

**Lemma 4.4.** Let  $\varepsilon \in (0, \frac{1}{2})$ . Assume that  $\mathbf{u} \in \mathbf{V} \cap \mathbf{H}^{\frac{3}{2} - \varepsilon}(\Omega)$ ,  $p \in Q_{\varepsilon}$  and  $\lambda \in \mathbf{H}^{\frac{1}{2} - \varepsilon}(\Sigma)$ . The following estimates hold:

$$\|\nabla \cdot \boldsymbol{e}_{u}\|_{L^{2}(\Omega)} \lesssim \|\varepsilon\left(\boldsymbol{e}_{u}\right)\|_{L^{2}(\Omega)} \lesssim h^{\frac{1}{2}-\varepsilon} \|\boldsymbol{u}\|_{H^{\frac{3}{2}-\varepsilon}(\Omega)}, \tag{20}$$

$$\|e_u\|_{L^2(\Sigma)} \lesssim h^{1-\varepsilon} \|u\|_{H^{\frac{3}{2}-\varepsilon}(\Omega)},$$
 (21)

$$\|\boldsymbol{e}_{\lambda}\|_{L^{2}(\Sigma)} \lesssim \mathcal{H}^{\frac{1}{2}-\varepsilon} \|\boldsymbol{\lambda}\|_{H^{\frac{1}{2}-\varepsilon}(\Sigma)},$$
 (22)

$$\|e_p\|_{L^2(\Omega)} \lesssim h^{\frac{1}{2}-\varepsilon} \|p - \widehat{\Pi}_h p\|_{H^{\frac{1}{2}-\varepsilon}(\Omega)},$$
 (23)

$$\|\boldsymbol{\lambda} + \|\widehat{\boldsymbol{\Pi}}_h p\|\boldsymbol{n}_{\Sigma} - \boldsymbol{\Pi}_{\mathcal{H}} \left(\boldsymbol{\lambda} + \|\widehat{\boldsymbol{\Pi}}_h p\|\boldsymbol{n}_{\Sigma}\right)\|_{L^2(\Sigma)} \lesssim \mathcal{H}^{\frac{1}{2} - \varepsilon} \|\boldsymbol{\lambda} + \|\widehat{\boldsymbol{\Pi}}_h p\|\boldsymbol{n}_{\Sigma}\|_{H^{\frac{1}{2} - \varepsilon}(\Sigma)}.$$
(24)

Proof. Estimates (20)–(22) and (24) can be easily proven using the approximation properties of quasi-interpolators (see, e.g., [23, Theorem 22.6]). For (23), we use the definition of  $\widetilde{\Pi}_h$  to get

$$||e_{p}||_{L^{2}(\Omega)} = ||p - \Pi_{h} p||_{L^{2}(\Omega)} = ||p - \widehat{\Pi}_{h} p - \widetilde{\Pi}_{h} p||_{L^{2}(\Omega)} = ||p - \widehat{\Pi}_{h} p - \overline{\Pi}_{h} (p - \widehat{\Pi}_{h} p)||_{L^{2}(\Omega)}$$

$$\lesssim h^{\frac{1}{2} - \varepsilon} ||p - \widehat{\Pi}_{h} p||_{H^{\frac{1}{2} - \varepsilon}(\Omega)},$$

where we used the approximation properties of the quasi-interpolation operator  $\Pi_h$ , so that the proof is complete.

#### 4.2. Stability

In this section we establish inf-sup stability of the bilinear form  $\mathcal{A}_h$  (see Lemma 4.8 below). The associated proof is based on two main steps: first, the proof of an inf-sup condition for the bilinear form  $(p_h, \nabla \cdot v_h)_{\Omega}$ , see Proposition 4.6; second, the extension of inf-sup stability to the full bilinear form  $\mathcal{A}_h$ . Even if these steps are standard in the context of fitted meshes, some intermediate lemmas have to be proven in the present context of unfitted meshes. In Proposition 4.5, we introduce an ad hoc interpolation operator vanishing on the elements intersected by the interface  $\Sigma$ . This interpolation is used to establish the inf-sup stability of the bilinear form  $(p_h, \nabla \cdot v_h)_{\Omega}$ , where the pressure is decomposed into a constant and a zero-mean valued function. More particularly, this interpolation operator is used to construct an adequate test function for the zero-mean part of the pressure. In Proposition 4.7, we extend the well-known discrete trace inequality on fitted meshes [23, Lemma 12.8] to our unfitted setting. Similar propositions are also employed in [26, 34].

#### 4.2.1. Preliminary results

We start by constructing an adequate interpolation operator that will be used to establish the inf-sup condition.

**Proposition 4.5.** There exists a linear operator  $\Pi_h^0: V \to V_h$  such that for every  $v \in V$ , we have:

- $\Pi_h^0 v = 0$  on  $\Sigma$ ;  $\Pi_h^0 v = 0$  on  $\partial \Omega$  if v = 0 on  $\partial \Omega$ .

Moreover, for each  $v \in V$  such that v = 0 on  $\Sigma$ , it holds

$$\|\boldsymbol{v} - \boldsymbol{\Pi}_h^0 \boldsymbol{v}\|_{L^2(\Omega)} \lesssim h \, |\boldsymbol{v}|_{H^1(\Omega)},$$
 (25)

$$\left\| \mathbf{\Pi}_{h}^{0} \mathbf{v} \right\|_{H^{1}(\Omega)} \lesssim \left\| \mathbf{v} \right\|_{H^{1}(\Omega)}. \tag{26}$$

*Proof.* We start by considering the Scott-Zhang interpolation operator  $\Pi_h^{\mathbf{Z}}: \mathbf{V} \to \mathbf{V}_h$  (see, e.g., [46]). For all  $\mathbf{v} \in \mathbf{V}$ ,  $\Pi_h^0 \mathbf{v}$  is defined as the sole element of  $\mathbf{V}_h$  satisfying

$$\Pi_h^0 \boldsymbol{v}(\boldsymbol{x}) = \mathbf{0} \quad \forall \boldsymbol{x} \in \mathcal{N}_h^c, \tag{27}$$

$$\Pi_h^0 v(x) = \Pi_h^{\mathbf{Z}} v(x) \quad \forall x \in \mathcal{N}_h \setminus \mathcal{N}_h^{\mathbf{c}}.$$
(28)

Note that, by construction, we have  $\Pi_h^0 v = 0$  on  $\Sigma$  and

$$\mathbf{\Pi}_{h}^{\mathbf{Z}} \mathbf{v}|_{K} = \mathbf{\Pi}_{h}^{0} \mathbf{v}|_{K} \quad \forall K \in \mathcal{T}_{h}^{\Omega} \setminus \mathcal{T}_{h}^{\mathbf{e}}. \tag{29}$$

Furthermore, owing to the preservation of homogeneous Dirichlet boundary conditions by the Scott–Zhang interpolation (see, e.g., [46, Theorem 2.1]), we have that  $\Pi_h^0 \mathbf{v} = \mathbf{0}$  on  $\partial \Omega$  for all  $\mathbf{v} \in \mathbf{V}$  with  $\mathbf{v} = \mathbf{0}$  on  $\partial \Omega$ .

Let us now consider  $v \in V$  such that v = 0 on  $\Sigma$ . We start with the proof of (25). By using the triangle inequality and the approximation properties of the Scott-Zhang operator (see, e.g., [46, Theorem 4.1]), it follows that

$$\|\boldsymbol{v} - \boldsymbol{\Pi}_{h}^{0} \boldsymbol{v}\|_{L^{2}(\Omega)} \leq \|\boldsymbol{v} - \boldsymbol{\Pi}_{h}^{\mathbf{Z}} \boldsymbol{v}\|_{L^{2}(\Omega)} + \|\boldsymbol{\Pi}_{h}^{\mathbf{Z}} \boldsymbol{v} - \boldsymbol{\Pi}_{h}^{0} \boldsymbol{v}\|_{L^{2}(\Omega)}$$
$$\lesssim h |\boldsymbol{v}|_{H^{1}(\Omega)} + \|\boldsymbol{\Pi}_{h}^{\mathbf{Z}} \boldsymbol{v} - \boldsymbol{\Pi}_{h}^{0} \boldsymbol{v}\|_{L^{2}(\Omega)}.$$
(30)

It only remains to control the last term in the previous bound. Owing to (29), we can focus only on the mesh elements in  $\mathcal{T}_h^e$ . Let  $K \in \mathcal{T}_h^e$ , from [23, Proposition 12.5], (27) and (28), we have

$$\|\mathbf{\Pi}_{h}^{\mathbf{Z}}\boldsymbol{v} - \mathbf{\Pi}_{h}^{0}\boldsymbol{v}\|_{L^{2}(K)} \lesssim h^{\frac{d}{2}} \max_{i} \|\mathbf{\Pi}_{h}^{\mathbf{Z}}\boldsymbol{v}(\boldsymbol{x}_{K,i}) - \mathbf{\Pi}_{h}^{0}\boldsymbol{v}(\boldsymbol{x}_{K,i})\|$$

$$\lesssim h^{\frac{d}{2}} \max_{i: \boldsymbol{x}_{K,i} \in \mathcal{N}_{h}^{c}} \|\mathbf{\Pi}_{h}^{\mathbf{Z}}\boldsymbol{v}(\boldsymbol{x}_{K,i}) - \mathbf{\Pi}_{h}^{0}\boldsymbol{v}(\boldsymbol{x}_{K,i})\|$$

$$\lesssim h^{\frac{d}{2}} \max_{i: \boldsymbol{x}_{K,i} \in \mathcal{N}_{h}^{c}} \|\mathbf{\Pi}_{h}^{\mathbf{Z}}\boldsymbol{v}(\boldsymbol{x}_{K,i})\| \lesssim h^{\frac{d}{2}} \max_{i} \|\mathbf{\Pi}_{h}^{\mathbf{Z}}\boldsymbol{v}(\boldsymbol{x}_{K,i})\|$$

$$\lesssim \|\mathbf{\Pi}_{h}^{\mathbf{Z}}\boldsymbol{v}\|_{L^{2}(K)}.$$
(31)

In addition, from the stability of the Scott-Zhang interpolation operator (see, e.g., [46, Theorem 3.1]), we have

$$\left\|\boldsymbol{\Pi}_{h}^{\mathbf{Z}}\boldsymbol{v}\right\|_{L^{2}(K)} \leq C\left(\left\|\boldsymbol{v}\right\|_{L^{2}(S(K))} + h\left|\boldsymbol{v}\right|_{H^{1}(S(K))}\right),$$

where S(K) denotes the patch of elements around K. Finally, since  $\boldsymbol{v}$  vanishes on  $\Sigma \cap S(K) \neq \emptyset$ , the Poincaré's inequality  $\|\boldsymbol{v}\|_{L^2(S(K))} \lesssim h \, |\boldsymbol{v}|_{H^1(S(K))}$  holds (see [23, Lemma 3.30]), so that from (31) we get

$$\left\| \mathbf{\Pi}_{h}^{\mathbf{Z}} \boldsymbol{v} - \mathbf{\Pi}_{h}^{0} \boldsymbol{v} \right\|_{L^{2}(K)} \lesssim h \left| \boldsymbol{v} \right|_{H^{1}(S(K))} \quad \forall K \in \mathcal{T}_{h}^{\mathbf{e}}. \tag{32}$$

Since from (29) the estimate (32) holds for every  $K \in \mathcal{T}_h^{\Omega}$ , we can sum (32) over all  $K \in \mathcal{T}_h^{\Omega}$  and, by using the quasi-uniformity of the mesh, we finally get

$$\left\| \mathbf{\Pi}_{h}^{\mathbf{Z}} \boldsymbol{v} - \mathbf{\Pi}_{h}^{0} \boldsymbol{v} \right\|_{L^{2}(\Omega)} \lesssim h \left| \boldsymbol{v} \right|_{H^{1}(\Omega)}. \tag{33}$$

The estimate (25) simply follows by inserting (33) into (30).

In order to prove (26), we first notice that owing to (29), it suffices to consider the elements K in  $\mathcal{T}_h^e$ . By combining (31) with the triangle inequality, we have

$$\left\| \mathbf{\Pi}_{h}^{0} \mathbf{v} \right\|_{L^{2}(K)} \lesssim \left\| \mathbf{\Pi}_{h}^{\mathbf{Z}} \mathbf{v} \right\|_{L^{2}(K)} \quad \forall K \in \mathcal{T}_{h}^{\mathbf{e}}. \tag{34}$$

Similarly, using inverse inequalities and (32), for the gradient we have

$$\begin{aligned} \left\| \boldsymbol{\nabla} \boldsymbol{\Pi}_{h}^{0} \boldsymbol{v} \right\|_{L^{2}(K)} &\lesssim h^{-1} \left\| \boldsymbol{\Pi}_{h}^{\mathbf{Z}} \boldsymbol{v} - \boldsymbol{\Pi}_{h}^{0} \boldsymbol{v} \right\|_{L^{2}(K)} + \left\| \boldsymbol{\nabla} \boldsymbol{\Pi}_{h}^{\mathbf{Z}} \boldsymbol{v} \right\|_{L^{2}(K)} \\ &\lesssim \left| \boldsymbol{v} \right|_{H^{1}(S(K))} + \left\| \boldsymbol{\nabla} \boldsymbol{\Pi}_{h}^{\mathbf{Z}} \boldsymbol{v} \right\|_{L^{2}(K)} \quad \forall K \in \mathcal{T}_{h}^{\mathbf{e}}. \end{aligned} \tag{35}$$

Owing to (29), the relations (34) and (35) hold for every  $K \in \mathcal{T}_h^{\Omega}$ , so that by summing over K and using the  $H^1$ -stability of the Scott-Zhang interpolator (see, e.g., [46, Corollary 4.1]), we finally get

$$\left\|\boldsymbol{\Pi}_{h}^{0}\boldsymbol{v}\right\|_{H^{1}(\Omega)}^{2}\lesssim\left\|\boldsymbol{\Pi}_{h}^{\mathrm{Z}}\boldsymbol{v}\right\|_{H^{1}(\Omega)}^{2}+\left|\boldsymbol{v}\right|_{H^{1}(\Omega)}^{2}\lesssim\left\|\boldsymbol{v}\right\|_{H^{1}(\Omega)}^{2},$$

which completes the proof.

In the sequel, for  $i \in \{1,2\}$  and for any element  $q_h$  of  $Q_h$ , we denote by  $q_{h,i} \stackrel{\text{def}}{=} q_h|_{\Omega_i}$  the restriction of  $q_h$  to  $\Omega_i$ . In a similar way, we denote by  $Q_{h,i} \stackrel{\text{def}}{=} \{q_h|_{\Omega_i} \mid q_h \in Q_h\}$  the set of such restrictions. Then, for every  $q_h \in Q_h$  we have

$$q_h = \sum_{i=1}^{2} q_{h,i} 1_{\Omega_i}.$$

We can now prove the following intermediate result, which is a first inf-sup condition.

**Proposition 4.6.** Under Assumption 2.1, there holds

$$\sup_{\mathbf{0} \neq \boldsymbol{v}_h \in \boldsymbol{V}_h \cap [H_{\Sigma}^1(\Omega)]^d} \frac{(q_h, \boldsymbol{\nabla} \cdot \boldsymbol{v}_h)_{\Omega}}{\|\boldsymbol{v}_h\|_{H^1(\Omega)}} + h \|\boldsymbol{\nabla} \widetilde{q}_h\|_{L^2(\Omega)} \gtrsim \|q_h\|_{L^2(\Omega)}$$
(36)

for all  $q_h \in Q_h$ .

*Proof.* We proceed in a classical way by decomposing  $q_{h,i}$  as

$$q_{h,i} = \bar{q}_{h,i} + \mathring{q}_{h,i}, \quad \bar{q}_{h,i} \stackrel{\text{def}}{=} \frac{1}{|\Omega_i|} \int_{\Omega_i} q_{h,i}, \quad \mathring{q}_{h,i} \stackrel{\text{def}}{=} q_{h,i} - \bar{q}_{h,i} \in L_0^2(\Omega_i) \cap Q_{h,i}.$$
 (37)

Note that, by restricting the decomposition (7) to each sub-domain  $\Omega_i$ , we also have  $q_{h,i} = \widetilde{q}_{h,i} + \widehat{q}_{h,i}$  with  $\widetilde{q}_{h,i} \stackrel{\text{def}}{=} \widetilde{q}_{h}|_{\Omega_i}$  and  $\widehat{q}_{h,i} \stackrel{\text{def}}{=} \widehat{q}_{h}|_{\Omega_i}$ . Furthermore, the fact that  $\mathring{q}_{h,i} + \overline{q}_{h,i} = q_{h,i} = \widetilde{q}_{h,i} + \widehat{q}_{h,i}$  yields

$$\nabla \widetilde{q}_{h,i} = \nabla \widetilde{q}_{h,i}. \tag{38}$$

We start by treating the zero-mean contributions in (37), namely,  $\mathring{q}_h \stackrel{\text{def}}{=} \sum_i \mathring{q}_{h,i} 1_{\Omega_i}$ . Since  $\mathring{q}_{h,i} \in L_0^2(\Omega_i)$ , there exists  $\mathbf{0} \neq \mathring{\boldsymbol{v}}_i \in \boldsymbol{H}_0^1(\Omega_i)$  such that (see, e.g., [29])

$$(\mathring{q}_{h,i}, \nabla \cdot \mathring{v}_i)_{\Omega_i} = \|\mathring{q}_{h,i}\|_{L^2(\Omega_i)}^2, \qquad \|\mathring{v}_i\|_{H^1(\Omega_i)} \lesssim \|\mathring{q}_{h,i}\|_{L^2(\Omega_i)}.$$
 (39)

By setting  $\boldsymbol{v} \stackrel{\text{def}}{=} \sum_{i} \boldsymbol{v}_{i} 1_{\Omega_{i}}$ , we get

$$\overset{*}{\boldsymbol{v}} \in \boldsymbol{H}_{\partial\Omega \cup \Sigma}^{1}(\Omega), \quad (\overset{*}{q}_{h}, \boldsymbol{\nabla} \cdot \overset{*}{\boldsymbol{v}})_{\Omega} = \left\| \overset{*}{q}_{h} \right\|_{L^{2}(\Omega)}^{2}, \quad \left\| \overset{*}{\boldsymbol{v}} \right\|_{H^{1}(\Omega)} \lesssim \left\| \overset{*}{q}_{h} \right\|_{L^{2}(\Omega)}. \tag{40}$$

By using the properties of  $\Pi_h^0$  (Proposition 4.5), the fact that  $(\bar{q}_{h,i}, \nabla \cdot \Pi_h^0 \mathring{v}_i)_{\Omega_i} = 0$  and (38), we have

$$\begin{split} \left\| \mathring{q}_{h,i} \right\|_{L^{2}(\Omega_{i})}^{2} &= (\mathring{q}_{h,i}, \boldsymbol{\nabla} \cdot \mathring{\boldsymbol{v}}_{i})_{\Omega_{i}} = \left( \mathring{q}_{h,i}, \boldsymbol{\nabla} \cdot (\mathring{\boldsymbol{v}}_{i} - \boldsymbol{\Pi}_{h}^{0} \mathring{\boldsymbol{v}}_{i}) \right)_{\Omega_{i}} + \left( \mathring{q}_{h,i}, \boldsymbol{\nabla} \cdot \boldsymbol{\Pi}_{h}^{0} \mathring{\boldsymbol{v}}_{i} \right)_{\Omega_{i}} \\ &= - \left( \boldsymbol{\nabla} \mathring{q}_{h,i}, \mathring{\boldsymbol{v}}_{i} - \boldsymbol{\Pi}_{h}^{0} \mathring{\boldsymbol{v}}_{i} \right)_{\Omega_{i}} + (\mathring{q}_{h,i}, \boldsymbol{\nabla} \cdot \boldsymbol{\Pi}_{h}^{0} \mathring{\boldsymbol{v}}_{i})_{\Omega_{i}} \\ &\lesssim h \left\| \boldsymbol{\nabla} \mathring{q}_{h,i} \right\|_{L^{2}(\Omega_{i})} \left\| \mathring{\boldsymbol{v}}_{i} \right\|_{H^{1}(\Omega_{i})} + (q_{h,i}, \boldsymbol{\nabla} \cdot \boldsymbol{\Pi}_{h}^{0} \mathring{\boldsymbol{v}}_{i})_{\Omega_{i}} \\ &= h \left\| \boldsymbol{\nabla} \widetilde{q}_{h,i} \right\|_{L^{2}(\Omega_{i})} \left\| \mathring{\boldsymbol{v}}_{i} \right\|_{H^{1}(\Omega_{i})} + (q_{h,i}, \boldsymbol{\nabla} \cdot \boldsymbol{\Pi}_{h}^{0} \mathring{\boldsymbol{v}}_{i})_{\Omega_{i}}. \end{split}$$

Notice that here we have made a little abuse of notation in  $\Pi_h^0 \mathring{\boldsymbol{v}}_i$ , since it has to be understood as  $\Pi_h^0$  applied to the extension of  $\mathring{\boldsymbol{v}}_i$  by zero out of  $\Omega_i$ .

By summing the above relation over  $i \in \{1, 2\}$  and that  $\Pi_h^0 \mathring{\boldsymbol{v}} = \Pi_h^0 \mathring{\boldsymbol{v}}_1 + \Pi_h^0 \mathring{\boldsymbol{v}}_2$  (which follows from the linearity of  $\Pi_h^0$  and Proposition 4.5), we get

$$\|\mathring{q}_h\|_{L^2(\Omega)}^2 \lesssim h \|\nabla \widetilde{q}_h\|_{L^2(\Omega)} \|\mathring{v}\|_{H^1(\Omega)} + (q_h, \nabla \cdot \Pi_h^0 \mathring{v})_{\Omega},$$

which, with (40), yields,

$$\|\mathring{q}_h\|_{L^2(\Omega)} \lesssim h \|\nabla \widetilde{q}_h\|_{L^2(\Omega)} + \frac{(q_h, \nabla \cdot \Pi_h^0 \mathring{v})_{\Omega}}{\|\mathring{v}\|_{H^1(\Omega)}}.$$
 (41)

Let us now handle the constant part of the pressure  $\bar{q}_{h,i}$ . Let  $\widehat{\Omega}_i$  be a subdomain of  $\Omega_i$  such that  $\Gamma_{\rm N} \cap \overline{\Omega}_i \subset \widehat{\Omega}_i$  and such that the mesh is fitted to  $\widehat{\Omega}_i$ . From [20, Lemma 3.3] (see also [27, Lemma 3.3]), there exists a constant  $C_i > 0$  and  $\mathbf{0} \neq \widehat{\mathbf{v}}_{h,i} \in \{\mathbf{w}_h|_{\widehat{\Omega}_i} \mid \mathbf{w}_h \in \mathbf{V}_h\} \cap [H^1_{\partial \widehat{\Omega}_i \setminus \Gamma_{\rm N}}(\widehat{\Omega}_i)]^d$ , such that

$$C_i \|\bar{q}_{h,i}\|_{L^2(\widehat{\Omega}_i)} \|\widehat{\boldsymbol{v}}_{h,i}\|_{H^1(\widehat{\Omega}_i)} \le (\bar{q}_{h,i}, \nabla \cdot \widehat{\boldsymbol{v}}_{h,i})_{\widehat{\Omega}_i}. \tag{42}$$

Notice that, since  $\widehat{\Omega}_i$  is fitted to the mesh, the constant  $C_i$  is independent from the way the unfitted interface cuts the mesh. Moreover, denoting by  $\bar{\boldsymbol{v}}_{h,i} \in \{\boldsymbol{w}_h|_{\Omega_i} \mid \boldsymbol{w}_h \in \boldsymbol{V}_h\} \cap [H^1_{\partial \Omega_i \setminus \Gamma_N}(\Omega_i)]^d$  the extension by zero of  $\widehat{\boldsymbol{v}}_{h,i}$  to the whole domain  $\Omega_i$ , the estimate (42) holds with  $\widehat{\Omega}_i = \Omega_i$ ,  $\widehat{\boldsymbol{v}}_{h,i} = \bar{\boldsymbol{v}}_{h,i}$  and with the constant  $C_i$  rescaled by  $|\widehat{\Omega}_i|/|\Omega_i|$ . According to Assumption 2.1,  $\widehat{\Omega}_i$  can be chosen in a way that the ratio  $|\widehat{\Omega}_i|/|\Omega_i|$  does not vanish when h tends to zero. We established

$$\|\bar{q}_{h,i}\|_{L^2(\Omega_i)} \lesssim \frac{(\bar{q}_{h,i}, \nabla \cdot \bar{v}_{h,i})_{\Omega_i}}{\|\bar{v}_{h,i}\|_{H^1(\Omega_i)}}.$$
 (43)

We now consider

$$\bar{\boldsymbol{z}}_h \stackrel{\text{\tiny def}}{=} \sum_i \frac{1}{\sqrt{2} \left\| \bar{\boldsymbol{v}}_{h,i} \right\|_{H^1(\Omega_i)}} \bar{\boldsymbol{v}}_{h,i} \boldsymbol{1}_{\Omega_i},$$

so that  $\|\bar{z}_h\|_{H^1(\Omega)} = 1$ , and summing (43) for  $i \in \{1,2\}$  we have

$$\|\bar{q}_h\|_{L^2(\Omega)} \lesssim (\bar{q}_h, \boldsymbol{\nabla} \cdot \bar{\boldsymbol{z}}_h)_{\Omega} = \frac{(\bar{q}_h, \boldsymbol{\nabla} \cdot \bar{\boldsymbol{z}}_h)_{\Omega}}{\|\bar{\boldsymbol{z}}_h\|_{H^1(\Omega)}} \lesssim \frac{(q_h, \boldsymbol{\nabla} \cdot \bar{\boldsymbol{z}}_h)_{\Omega}}{\|\bar{\boldsymbol{z}}_h\|_{H^1(\Omega)}} + \|\mathring{q}_h\|_{L^2(\Omega)}. \tag{44}$$

Setting  $\boldsymbol{w}_h = \|\boldsymbol{\dot{v}}\|_{H^1(\Omega)}^{-1} \boldsymbol{\Pi}_h^0 \boldsymbol{\dot{v}} + \delta \|\bar{\boldsymbol{z}}_h\|_{H^1(\Omega)}^{-1} \bar{\boldsymbol{z}}_h$ , with  $\delta > 0$  sufficiently small, results in  $\boldsymbol{w}_h \in \boldsymbol{V}_h \cap [H^1_{\Sigma}(\Omega)]^d$  and  $\|\boldsymbol{w}_h\|_{H^1(\Omega)} \lesssim 1 + \delta$ . The relation (36) follows from (41) and (44), which completes the proof.

**Proposition 4.7.** Under Assumptions 4.1 and 4.2, we have

$$h^{\frac{1}{2}} \| [q_h] \|_{L^2(\Sigma)} \lesssim \| q_h \|_{L^2(\Omega)} + h \| \nabla \widetilde{q}_h \|_{L^2(\Omega)}$$
 (45)

for all  $q_h \in Q_h$ .

*Proof.* Let us introduce the operators  $E_h^1: Q_h \to \widetilde{Q}_h$  and  $E_h^2: Q_h \to \widetilde{Q}_h$  defined as

$$E_h^1(q_h) \stackrel{\text{def}}{=} \widetilde{q}_h + \llbracket q_h \rrbracket, \quad E_h^2(q_h) \stackrel{\text{def}}{=} \widetilde{q}_h$$

for all  $q_h \in Q_h$ . We recall that by construction of the pressure space  $Q_h$  in (6), the pressure jump  $[\![q_h]\!]$  is constant. In particular, we have

$$E_h^i(q_h) = q_{h,i} \quad \text{in} \quad \Omega_i. \tag{46}$$

Let  $K \in \mathcal{T}_h^c$  be given. Since,  $[q_h]$  is constant on  $\Sigma$ , using Assumption 4.1 and the triangle inequality, we have

$$h^{\frac{1}{2}} \| \llbracket q_h \rrbracket \|_{L^2(\Sigma \cap K)} = h^{\frac{1}{2}} | \Sigma \cap K |^{\frac{1}{2}} | \llbracket q_h \rrbracket | \lesssim \| \llbracket q_h \rrbracket \|_{L^2(K)} = \| E_h^1(q_h) - E_h^2(q_h) \|_{L^2(K)} \leq \sum_i \| E_h^i(q_h) \|_{L^2(K)}. \quad (47)$$

In order to bound  $||E_h^i(q_h)||_{L^2(K)}$  for every  $i \in \{1,2\}$ , we first note that since  $E_h^i(q_h)$  is affine in K, we have

$$E_h^i(q_h)(\boldsymbol{x}) = E_h^i(q_h)(\boldsymbol{x}_{K,j}) + \nabla E_h^i(q_h) \cdot (\boldsymbol{x} - \boldsymbol{x}_{K,j}),$$

where  $x_{K,j}$  denotes one of the nodes of the element K. Thus, using an inverse inequality we get

$$||E_h^i(q_h)||_{L^2(K)} \lesssim h^{\frac{d}{2}} ||E_h^i(q_h)||_{L^{\infty}(K)} \lesssim h^{\frac{d}{2}} ||E_h^i(q_h)(\boldsymbol{x}_{K,j})| + h^{1+\frac{d}{2}} ||\nabla E_h^i(q_h)||_{L^{\infty}(K)}.$$

$$(48)$$

Furthermore, owing to Assumption 4.2, relation (46) and [23, Proposition 12.5], we have

$$h^{\frac{d}{2}} \left| E_h^i(q_h)(\boldsymbol{x}_{K,j}) \right| \le h^{\frac{d}{2}} \max_{l} \left\| q_{h,i}(\boldsymbol{x}_{\widetilde{K}_i,l}) \right\| \lesssim \|q_{h,i}\|_{L^2(\widetilde{K}_i)}. \tag{49}$$

In addition, since  $\nabla E_h^i(q_h)$  is constant in K and  $\nabla E_h^1(q_h) = \nabla E_h^2(q_h) = \nabla \widetilde{q}_h$ , we have

$$h^{\frac{d}{2}} \left\| \boldsymbol{\nabla} E_h^i(q_h) \right\|_{L^{\infty}(K)} \lesssim \left\| \boldsymbol{\nabla} \widetilde{q}_h \right\|_{L^2(K)}. \tag{50}$$

By inserting the bounds (48)-(50) into (47), we have

$$h^{\frac{1}{2}}\left\|\left\|q_{h}\right\|\right\|_{L^{2}(K\cap\Sigma)}\lesssim\sum_{i}\left\|E_{h}^{i}(q_{h})\right\|_{L^{2}(K)}\lesssim\left(\left\|q_{h}\right\|_{L^{2}\left(\widetilde{K}_{1}\right)}+\left\|q_{h}\right\|_{L^{2}\left(\widetilde{K}_{2}\right)}+h\left\|\nabla\widetilde{q}_{h}\right\|_{L^{2}(K)}\right).$$

The estimate (45) then follows by exploiting the quasi-uniformity of the mesh and summing the above relation over all  $K \in \mathcal{T}_h^c$ , which completes the proof.

#### 4.2.2. Main stability result

We now have all the ingredients to state the main result of this section. To this purpose, we introduce the following norm

$$\|(\boldsymbol{v}_h,q_h,\boldsymbol{\xi}_{\mathcal{H}})\| \stackrel{\text{def}}{=} \left(\|\boldsymbol{\varepsilon}\left(\boldsymbol{v}_h\right)\|_{L^2(\Omega)}^2 + h^2 \|\boldsymbol{\nabla}\widetilde{q}_h\|_{L^2(\Omega)}^2 + \|q_h\|_{L^2(\Omega)}^2 + h \|\boldsymbol{\xi}_{\mathcal{H}}\|_{L^2(\Sigma)}^2\right)^{\frac{1}{2}}$$

for all  $(\boldsymbol{v}_h, q_h, \boldsymbol{\xi}_{\mathcal{H}}) \in \boldsymbol{V}_h \times Q_h \times \boldsymbol{\Lambda}_{\mathcal{H}}$ . The following lemma provides the inf-sup stability for the full bilinear form  $\mathcal{A}_h$ .

**Lemma 4.8.** Under Assumptions 2.1, 4.1 and 4.2, there exists a mesh-independent constant  $\beta > 0$  such that

$$\inf_{(\boldsymbol{u}_{h}, p_{h}, \boldsymbol{\lambda}_{\mathcal{H}}) \in \boldsymbol{V}_{h} \times Q_{h} \times \boldsymbol{\Lambda}_{\mathcal{H}} \setminus (\boldsymbol{0}, 0, \boldsymbol{0})} \sup_{(\boldsymbol{v}_{h}, q_{h}, \boldsymbol{\xi}_{\mathcal{H}}) \in \boldsymbol{V}_{h} \times Q_{h} \times \boldsymbol{\Lambda}_{\mathcal{H}} \setminus (\boldsymbol{0}, 0, \boldsymbol{0})} \frac{\mathcal{A}_{h} ((\boldsymbol{u}_{h}, p_{h}, \boldsymbol{\lambda}_{\mathcal{H}}), (\boldsymbol{v}_{h}, q_{h}, \boldsymbol{\xi}_{\mathcal{H}}))}{\|(\boldsymbol{u}_{h}, p_{h}, \boldsymbol{\lambda}_{\mathcal{H}})\| \|(\boldsymbol{v}_{h}, q_{h}, \boldsymbol{\xi}_{\mathcal{H}})\|} \ge \beta.$$

*Proof.* The inf-sup condition (51) is a consequence of the following estimate

$$\stackrel{\text{def}}{=} \mathcal{S}$$
(52)

for all  $(\boldsymbol{u}_h, p_h, \boldsymbol{\lambda}_{\mathcal{H}}) \in \boldsymbol{V}_h \times Q_h \times \boldsymbol{\Lambda}_{\mathcal{H}} \setminus (\boldsymbol{0}, 0, \boldsymbol{0})$ . In order to prove (52), let  $(\boldsymbol{u}_h, p_h, \boldsymbol{\lambda}_{\mathcal{H}}) \in \boldsymbol{V}_h \times Q_h \times \boldsymbol{\Lambda}_{\mathcal{H}} \setminus (\boldsymbol{0}, 0, \boldsymbol{0})$ . From (11), we have

$$2\mu \|\boldsymbol{\varepsilon}(\boldsymbol{u}_{h})\|_{L^{2}(\Omega)}^{2} + \frac{\gamma_{p}h^{2}}{\mu} \|\boldsymbol{\nabla}\widetilde{p}_{h}\|_{L^{2}(\Omega)}^{2} + \frac{h}{\gamma_{\lambda}\mu} \|\boldsymbol{\lambda}_{\mathcal{H}} + [\![p_{h}]\!]\boldsymbol{n}_{\Sigma}\|_{L^{2}(\Sigma)}^{2} = \mathcal{A}_{h}((\boldsymbol{u}_{h}, p_{h}, \boldsymbol{\lambda}_{\mathcal{H}}), (\boldsymbol{u}_{h}, p_{h}, \boldsymbol{\lambda}_{\mathcal{H}}))$$

$$\leq \mathcal{S} \|(\boldsymbol{u}_{h}, p_{h}, \boldsymbol{\lambda}_{\mathcal{H}})\|.$$

Moreover, using the triangle inequality and Proposition 4.7 (under Assumptions 4.1 and 4.2), we get

Now, using Assumption 2.1, we can invoke Proposition 4.6. Let  $\boldsymbol{w}_h \in \boldsymbol{V}_h \cap \boldsymbol{H}^1_{\Sigma}(\Omega)$  be a function for which the supremum in (36) is attained (for  $q_h = p_h$ ). We have

$$(p_h, \nabla \cdot \boldsymbol{w}_h)_{\Omega} = \mathcal{A}_h ((\boldsymbol{u}_h, p_h, \boldsymbol{\lambda}_{\mathcal{H}}), (-\boldsymbol{w}_h, 0, \boldsymbol{0})) + 2\mu(\varepsilon(\boldsymbol{u}_h), \varepsilon(\boldsymbol{w}_h))_{\Omega}$$

$$\lesssim \mathcal{S} \|(\boldsymbol{w}_h, 0, \boldsymbol{0})\| + \|\varepsilon(\boldsymbol{u}_h)\|_{L^2(\Omega)} \|\varepsilon(\boldsymbol{w}_h)\|_{L^2(\Omega)}$$

$$\lesssim (\mathcal{S} + \|\varepsilon(\boldsymbol{u}_h)\|_{L^2(\Omega)}) \|\boldsymbol{w}_h\|_{H^1(\Omega)},$$

so that (55) yields

We now conclude by inserting (54) and (56) into (53), which yields

Corollary 4.9. The discrete problem (10) admits a unique solution.

#### 4.3. A priori error estimates

We first introduce the following discrete errors

where  $(\boldsymbol{u}, p, \boldsymbol{\lambda})$  is the solution to the continuous problem (2),  $(\boldsymbol{u}_h, p_h, \boldsymbol{\lambda}_{\mathcal{H}})$  is the solution to the discrete problem (10) and the interpolation operators  $\Pi_h$ ,  $\Pi_h$  and  $\Pi_{\mathcal{H}}$  are defined in Section 4.1. The following result provides an estimate for the consistency error.

**Lemma 4.10.** Assume that  $(\boldsymbol{u}, p, \boldsymbol{\lambda}) \in V_{\varepsilon} \times Q_{\varepsilon} \times \boldsymbol{H}^{\frac{1}{2} - \varepsilon}(\Sigma)$  with  $\varepsilon \in (0, \frac{1}{2})$ . The following estimate holds

 (57)

for all  $(v_h, q_h, \xi_H) \in V_h \times Q_h \times \Lambda_H$ . Moreover, this estimate can be improved to

$$\begin{aligned} \left| \mathcal{A}_{h} \left( \left( \boldsymbol{e}_{u,h}, \boldsymbol{e}_{p,h}, \boldsymbol{e}_{\lambda,h} \right), \left( \boldsymbol{v}_{h}, q_{h}, \boldsymbol{\xi}_{\mathcal{H}} \right) \right) \right| \\ & \lesssim \left[ \left. \max \left\{ h, \mathcal{H} \right\}^{\frac{1}{2} - \varepsilon} \left( \left\| \boldsymbol{u} \right\|_{H^{\frac{3}{2} - \varepsilon}(\Omega)} + \left\| p - \widehat{\Pi}_{h} p \right\|_{H^{\frac{1}{2} - \varepsilon}(\Omega)} + \left\| \boldsymbol{\lambda} + \left\| \widehat{\Pi}_{h} p \right\| \boldsymbol{n}_{\Sigma} \right\|_{H^{\frac{1}{2} - \varepsilon}(\Sigma)} \right) \right. \\ & + \left\| \left\| p \right\| \right\|_{L^{2}(\Sigma)} \left\| \boldsymbol{n}_{\Sigma} - \boldsymbol{\Pi}_{\mathcal{H}} \boldsymbol{n}_{\Sigma} \right\|_{L^{2}(\Sigma)} \left\| \boldsymbol{v}_{h}, q_{h}, \boldsymbol{\xi}_{\mathcal{H}} \right\|. \end{aligned} (58)$$

= \mathcal{A}_{h}((\boldsymbol{\Pi}_{h} \boldsymbol{u}, \boldsymbol{\Pi}_{h} p, \boldsymbol{\Pi}_{\mathcal{H}} \boldsymbol{\lambda}), (\boldsymbol{v}_{h}, q_{h}, \boldsymbol{\xi}_{\mathcal{H}})) - \mathcal{A}((\boldsymbol{u}, p, \boldsymbol{\lambda}), (\boldsymbol{v}_{h}, q_{h}, \boldsymbol{\xi}_{\mathcal{H}})) 
= -2\mu(\boldsymbol{\varepsilon}(\boldsymbol{e}_{u}), \boldsymbol{\varepsilon}(\boldsymbol{v}_{h}))_{\Omega} + (\boldsymbol{e}_{p}, \boldsymbol{\nabla} \cdot \boldsymbol{v}_{h})_{\Omega} - (q_{h}, \boldsymbol{\nabla} \cdot \boldsymbol{e}_{u})_{\Omega} + (\boldsymbol{e}_{\lambda}, \boldsymbol{v}_{h})_{\Sigma} 
- (\boldsymbol{\xi}_{\mathcal{H}}, \boldsymbol{e}_{u})_{\Sigma} + s_{h}^{\mathrm{BP}}(\boldsymbol{\Pi}_{h} p, q_{h}) + s_{h}^{\mathrm{BH}}((\boldsymbol{\Pi}_{h} p, \boldsymbol{\Pi}_{\mathcal{H}} \boldsymbol{\lambda}), (q_{h}, \boldsymbol{\xi}_{\mathcal{H}})).$$

We now proceed by estimating term by term. Using the Cauchy-Schwarz inequality and the approximation error bounds (20), (21) and (23), we have

For the pressure stabilization term, we use Cauchy-Schwarz inequality and (17) to get

It only remains to estimate the terms  $(e_{\lambda}, v_h)_{\Sigma}$  and  $s_h^{\mathrm{BH}}((\Pi_h p, \Pi_{\mathcal{H}} \lambda), (q_h, \xi_{\mathcal{H}}))$ .

<u>Proof of (57)</u>. For the term  $(e_{\lambda}, v_h)_{\Sigma}$ , using the Cauchy-Schwarz, trace and Korn's inequalities and (22), we have

Finally, for the term  $s_h^{\rm BH}((\Pi_h\,p,\Pi_{\mathcal{H}}\,\boldsymbol{\lambda}),(q_h,\boldsymbol{\xi}_{\mathcal{H}}))$ , we use once more the Cauchy-Schwarz inequality, Proposition 4.7, (15) and (16), to get

The estimate (57) then follows from (59) and the estimates (60)–(63).

The bound (57) then follows from (59) and the estimates (60), (61), (64) and (65). This completes the proof.  $\Box$ 

We now have all the ingredients to derive an a priori error estimate. This is stated in the next theorem.

**Theorem 4.11.** Under Assumptions 2.1, 4.1 and 4.2, let  $\varepsilon \in (0,1/2)$  and assume that  $(\boldsymbol{u},p,\boldsymbol{\lambda}) \in \boldsymbol{V}_{\varepsilon} \times Q_{\varepsilon} \times \boldsymbol{H}^{\frac{1}{2}-\varepsilon}(\Sigma)$  is the solution to the continuous problem (2) and that  $(\boldsymbol{u}_h,p_h,\boldsymbol{\lambda}_{\mathcal{H}})$  is the solution to the discrete problem (10). The following a priori error bounds hold:

$$\|\varepsilon\left(\boldsymbol{u}-\boldsymbol{u}_{h}\right)\|_{L^{2}(\Omega)} + \|p-p_{h}\|_{L^{2}(\Omega)} + h^{\frac{1}{2}} \|\boldsymbol{\lambda}-\boldsymbol{\lambda}_{\mathcal{H}}\|_{L^{2}(\Sigma)}$$

$$\lesssim \max\{h,\mathcal{H}\}^{\frac{1}{2}-\varepsilon} \left(\|\boldsymbol{u}\|_{H^{\frac{3}{2}-\varepsilon}(\Omega)} + \|p-\widehat{\Pi}_{h}p\|_{H^{\frac{1}{2}-\varepsilon}(\Omega)} + \|\boldsymbol{\tilde{l}}p\|_{L^{2}(\Sigma)} + \|\boldsymbol{\lambda}\|_{H^{\frac{1}{2}-\varepsilon}(\Sigma)}\right), \quad (66)$$

$$\|\boldsymbol{\varepsilon} \left(\boldsymbol{u} - \boldsymbol{u}_{h}\right)\|_{L^{2}(\Omega)} + \|p - p_{h}\|_{L^{2}(\Omega)} + h^{\frac{1}{2}} \|\boldsymbol{\lambda} - \boldsymbol{\lambda}_{\mathcal{H}}\|_{L^{2}(\Sigma)}$$

$$\lesssim \max\{h, \mathcal{H}\}^{\frac{1}{2} - \varepsilon} \left(\|\boldsymbol{u}\|_{H^{\frac{3}{2} - \varepsilon}(\Omega)} + \|p - \widehat{\Pi}_{h} p\|_{H^{\frac{1}{2} - \varepsilon}(\Omega)} + \|\boldsymbol{\lambda} + \|\widehat{\Pi}_{h} p\| \boldsymbol{n}_{\Sigma}\|_{H^{\frac{1}{2} - \varepsilon}(\Sigma)}\right)$$

$$+ \|\|p\|\|_{L^{2}(\Sigma)} \|\boldsymbol{n}_{\Sigma} - \boldsymbol{\Pi}_{\mathcal{H}} \boldsymbol{n}_{\Sigma}\|_{L^{2}(\Sigma)}. \quad (67)$$

*Proof.* The estimate (66) follows immediately using the classical error decomposition

$$\begin{split} \|\varepsilon\left(\boldsymbol{u}-\boldsymbol{u}_{h}\right)\|_{L^{2}(\Omega)} + \|p-p_{h}\|_{L^{2}(\Omega)} + h^{\frac{1}{2}} \|\boldsymbol{\lambda}-\boldsymbol{\lambda}_{\mathcal{H}}\|_{L^{2}(\Sigma)} \\ &\leq \|\varepsilon\left(\boldsymbol{e}_{u}\right)\|_{L^{2}(\Omega)} + \|e_{p}\|_{L^{2}(\Omega)} + h^{\frac{1}{2}} \|\boldsymbol{e}_{\lambda}\|_{L^{2}(\Sigma)} + \|(\boldsymbol{e}_{u,h},e_{p,h},\boldsymbol{e}_{\lambda,\mathcal{H}})\|. \end{split}$$

Indeed, using Lemmas 4.8 and 4.10, we have

$$\begin{aligned} \|\boldsymbol{e}_{u,h}, \boldsymbol{e}_{p,h}, \boldsymbol{e}_{\boldsymbol{\lambda}, \mathcal{H}}\| &\lesssim \sup_{(\boldsymbol{v}_h, q_h, \boldsymbol{\xi}_{\mathcal{H}}) \in \boldsymbol{V}_h \times Q_h \times \boldsymbol{\Lambda}_{\mathcal{H}} \setminus (\boldsymbol{0}, 0, \boldsymbol{0})} \frac{\mathcal{A}_h \left( (\boldsymbol{e}_{u,h}, \boldsymbol{e}_{p,h}, \boldsymbol{e}_{\boldsymbol{\lambda}, \mathcal{H}}) ; (\boldsymbol{v}_h, q_h, \boldsymbol{\xi}_{\mathcal{H}}) \right)}{\|\boldsymbol{v}_h, q_h, \boldsymbol{\xi}_{\mathcal{H}}\|} \\ &\lesssim \max\{h, \mathcal{H}\}^{\frac{1}{2} - \varepsilon} \left( \|\boldsymbol{u}\|_{H^{\frac{3}{2} - \varepsilon}(\Omega)} + \|\boldsymbol{p} - \widehat{\boldsymbol{\Pi}}_h \boldsymbol{p}\|_{H^{\frac{1}{2} - \varepsilon}(\Omega)} + \|\boldsymbol{\tilde{l}}\boldsymbol{p}\|_{L^2(\Sigma)} + \|\boldsymbol{\lambda}\|_{H^{\frac{1}{2} - \varepsilon}(\Sigma)} \right). \end{aligned}$$

The estimate (66) then follows from (20), (22) and (23). Finally, the error estimate (67) follows similarly, by using (58) instead of (57). This completes the proof.  $\Box$ 

Estimate (66) corresponds to the expected sub-optimal a priori error bound. Since the degrees of freedom are not doubled in the cut cells (like in XFEM), we cannot hope for a better convergence rate which exploits the local regularity (5) in each of the two sub-domains. Numerical evidence of this is provided in Section 5.1. Estimate (67) is an improved version of (66) in the presence of high pressure drops through the interface. Indeed, the mean value of the pressure jump  $[\widehat{\Pi}_h p]_{\Sigma}$  is subtracted to the Lagrange multiplier, which is expected to improve the constant of the error bound. Moreover, the term  $||[p]||_{L^2(\Sigma)} ||n_{\Sigma} - \Pi_{\mathcal{H}} n_{\Sigma}||_{L^2(\Sigma)}$  that carries the pressure jump has an improved convergence rate in this estimate, assuming that  $n_{\Sigma}$  has a better regularity than  $H^{\frac{1}{2}-\varepsilon}(\Sigma)$ . The numerical results of Section 5.2.1 illustrate this improved behavior.

**Remark 4.12.** The result stated in Theorem 4.11 does not provide convergence for the Lagrange multiplier in  $L^2$ -norm. We could however prove convergence of the multiplier in its natural norm, i.e.  $H^{-\frac{1}{2}}(\Sigma)$ . Element of such a proof is given in [3, Propositions A.1, A.2].

#### 5. Numerical experiments




FIGURE 3. Geometric configurations considered in the numerical tests.

In this section, we illustrate the behavior of the numerical method (10) in three different two-dimensional examples. In all these test cases, we consider a rectangular domain  $\Omega = (-1,1) \times (0,1)$ . Dirichlet boundary conditions are imposed at the top and bottom boundaries  $\Gamma_D = (-1,1) \times \{0,1\}$ , and Neumann boundary conditions are enforced on the remaining boundary  $\Gamma_N = \{-1,1\} \times (0,1)$ . A different interface  $\Sigma$  is considered for each test case, as shown in Figure 3. Without loss of generality, the interface is oriented so that the subdomain  $\Omega_1$  (resp.  $\Omega_2$ ) lies on the left (resp. right) side of the interface. For any  $N \in \{5, 10, 20, 40, 80, 160\}$ ,

the mesh  $\mathcal{T}_h^{\Omega}$  is generated through a uniform subdivision of  $\Gamma_{\rm D}$  into 2N+1 segments and of  $\Gamma_{\rm N}$  into N+2 segments, and the mesh  $\mathcal{T}_{\mathcal{H}}^{\Sigma}$  is obtained by uniformly subdividing the domain  $\Sigma$  into 3N segments. In the subsequent sections, all physical quantities and parameters are expressed in the centimeter-gram-second (CGS) unit system, the stabilization parameters are  $\gamma_{\rm p} = 10^{-2}$  and  $\gamma_{\lambda} = 10$ .

#### 5.1. Convergence study for a non-trivial solution

This first example aims at providing numerical evidence of the convergence rate stated in Theorem 4.11. For the sake of simplicity, a straight interface  $\Sigma = \{0\} \times (0,1)$  is considered (see Figure 3a). A non-trivial analytical solution is considered and numerical errors are computed separately for the velocity, the pressure and the Lagrange multiplier.

For  $i \in \{1, 2\}$ , the velocity field  $u_i \stackrel{\text{def}}{=} u|_{\Omega_i}$  in (1) is chosen as

$$\boldsymbol{u}_{1} = \begin{bmatrix} \frac{\partial}{\partial y} \phi_{1}\left(x,y\right), & -\frac{\partial}{\partial x} \phi_{1}\left(x,y\right) \end{bmatrix}, \qquad \boldsymbol{u}_{2} = \begin{bmatrix} \frac{\partial}{\partial y} \phi_{2}\left(x,y\right), & -\frac{\partial}{\partial x} \phi_{2}\left(x,y\right) \end{bmatrix}$$

with the function  $\phi_i(x,y)$  defined as

$$\phi_{i}(x,y) \stackrel{\text{def}}{=} (x - x_{l,i})^{2} (x - x_{r,i})^{2} (y - y_{b,i})^{2} (y - y_{t,i})^{2} \varphi_{i}(x,y),$$

with  $\varphi_1(x,y) \stackrel{\text{def}}{=} x$ ,  $\varphi_2(x,y) \stackrel{\text{def}}{=} y$  and the parameters  $(x_{l,i},x_{r,i},y_{b,i},y_{t,i})$  are chosen as (-1,0,0,1) and (0,1,0,1) for i=1 and i=2, respectively. The resulting analytical solution to problem (1) reads:

$$\mathbf{u}_{1}(x,y) = \begin{pmatrix} 20(x+1)^{2}x^{3}y(y-1)(2y-1) \\ 10(x+1)x^{2}y^{2}(y-1)^{2}(3-5x) \end{pmatrix}, \quad \mathbf{u}_{2}(x,y) = \begin{pmatrix} 10(y-1)x^{2}y^{2}(x-1)^{2}(5y-3) \\ 20(y-1)^{2}y^{3}x(x-1)(1-2x) \end{pmatrix}, \quad \mathbf{p}_{1}(x,y) = x+1, \qquad p_{2}(x,y) = y,$$
(68)




FIGURE 4. Convergence histories for the velocity, pressure and Lagrange multiplier.

where the pressure profile has been chosen to provide a non-constant jump through the interface. The right-hand side functions f, g and  $u_{\Sigma}$  are chosen so that (1) holds with (68). In particular, zero velocity  $u_{\Sigma} = 0$  is prescribed on the interface. The expression for the Lagrange multiplier  $\lambda$  is obtained by plugging the exact solution (68) into (4). The fluid dynamic viscosity is set to  $\mu = 0.035$ .

The relative error in  $L^2$ -norm for the velocity strain tensor, for the pressure and for the Lagrange multiplier depending on the mesh refinement level are reported in Figure 4. As predicted by Theorem 4.11, a convergence rate of  $\frac{1}{2}$  is observed for the approximation errors of both the velocity strain tensor and the pressure, as illustrated in Figures 4a and 4b, respectively. Although Theorem 4.11 does not predict the convergence of the Lagrange multiplier in  $L^2$ -norm (see Remark 4.12), a convergence rate of  $\frac{1}{2}$  is observed in Figure 4c.

#### 5.2. A constant pressure jump through a curved interface

As second example we consider the classical benchmark of two fluids separated by a curved interface (see Figure 3b) under a constant pressure drop (see, e.g., [33,37]). This yields a very simple analytical solution: the two fluids are at rest with a constant pressure (in each sub-domain). This problem is critical for an unfitted mesh numerical method in terms of mass conservation, since continuous pressure approximations are known to generate spurious (non-zero) velocity approximations (which are proportional to the amount of pressure drop

across the interface). We first study the convergence of the present method and then compare its behavior on a fixed mesh with respect to alternative methods.

In this example, the interface is given by  $\Sigma = \{(0.2\sin(\pi t), t) | t \in [0, 1]\}$ . A traction force  $\mathbf{g} = -3 \cdot 10^5 \, \mathbf{n}$  is imposed at the channel inlet  $\{-1\} \times (0, 1)$ , while no traction  $\mathbf{g} = \mathbf{0}$  is prescribed at the outlet  $\{1\} \times (0, 1)$ . Additionally, we consider a null right-hand side function  $\mathbf{f} = \mathbf{0}$  for the Stokes equation (1) and the velocity profile on the immersed interface  $\Sigma$  is set to be  $\mathbf{u}_{\Sigma} = \mathbf{0}$ . The fluid dynamic viscosity is set to  $\mu = 10$ . The solution to problem (1) reads

$$u_1 = 0, u_2 = 0, 
 p_1 = 3 \cdot 10^5, p_2 = 0.$$
(69)

The continuous solution for the Lagrange multiplier  $\lambda$  is computed by replacing (69) into (4) so that  $\lambda = -[p]n_{\Sigma}$ .

#### 5.2.1. Convergence study




FIGURE 5. Geometric approximation of the normal vectors to the interface  $\Sigma$ . In gray the interface  $\Sigma$  and in black the mesh  $\mathcal{T}^{\Sigma}_{\mathcal{H}}$ .


Since the interface is curved, we consider different discrete representations for the normal, see Figure 5. In practice, the choice of the normal approximation has an impact on the stabilization term  $s_h^{\rm BH}$ , as well as the incompressibility constraint for the additional basis function (see Remark 3.2). The interface is discretized using a mesh  $\mathcal{T}_h^{\Sigma}$ , which is constituted of points linked by segments. The simplest way of representing the normal is then to define it by a piecewise constant function that takes the value of the exact normal to  $\mathcal{T}_{\mathcal{H}}^{\Sigma}$ . This piecewise constant normal will be denoted by  $n_{\Sigma}^{\Omega}$ . We also consider a  $\mathbb{P}^1$ -approximation, denoted  $n_{\Sigma}^1$ , as a weighted average of  $n_{\Sigma}^{\Omega}$  with respect to the length of the surrounding elements.






FIGURE 7. Convergence histories for the  $\mathbb{P}^0$  and  $\mathbb{P}^1$  interface normals.

For the present method, the errors obtained with the two normal representations for the velocity, the pressure and the Lagrange multiplier are reported in Figure 6. The error of the normal discrete representation is given in Figure 7.

We observe improved convergence rates for all the variables compared to what was obtained in Section 5.1. For the velocity and the pressure, we reach a convergence rate of 2 if a piecewise constant representation  $\boldsymbol{n}_{\Sigma}^0$  of the normal is used, while we reach 3 if  $\boldsymbol{n}_{\Sigma}^1$  if used instead. This is a consequence of the fact that, assuming the geometry is exactly represented, the exact solution  $(\boldsymbol{u}, p, \boldsymbol{\lambda})$  belongs to the discrete space  $\boldsymbol{V}_h \times Q_h \times \boldsymbol{\Lambda}_{\mathcal{H}}$ . The error observed is then due to geometry approximation only. More precisely, taking into account the discrete normal representation  $\boldsymbol{n}_{\Sigma}^i$  ( $i \in \{0,1\}$ ) and the actual value of the exact solution, estimate (67) can be modified as


$$\|\boldsymbol{\varepsilon}\left(\boldsymbol{u}-\boldsymbol{u}_{h}\right)\|_{L^{2}(\Omega)}+\|p-p_{h}\|_{L^{2}(\Omega)}+h^{\frac{1}{2}}\left\|\boldsymbol{\lambda}-\boldsymbol{\lambda}_{\mathcal{H}}\right\|_{L^{2}(\Sigma)}\\ \lesssim \|\llbracket p\rrbracket\|_{L^{2}(\Sigma)}\left(\|\boldsymbol{n}_{\Sigma}-\boldsymbol{\Pi}_{\mathcal{H}}\,\boldsymbol{n}_{\Sigma}\|_{L^{2}(\Sigma)}+\left\|\boldsymbol{n}_{\Sigma}^{i}-\boldsymbol{\Pi}_{\mathcal{H}}\,\boldsymbol{n}_{\Sigma}\right\|_{L^{2}(\Sigma)}\right).$$


This shows that the approximation errors are bounded by the geometric error on the normals. We observe this effect in Figure 6 where the convergence rate of the solution is linked to the convergence rate of the normal

representation geometric error, see Figure 7. We also observe that a  $\mathbb{P}_1$ -representation for the normal is more efficient.

In addition, we have also considered test case (69) with a straight interface  $\Sigma = \{0\} \times (0,1)$  (see Figure 3a). In this geometrical setting,  $\boldsymbol{n}_{\Sigma} = \boldsymbol{n}_{\Sigma}^1 = \boldsymbol{n}_{\Sigma}^0$ , thus the geometry of the interface is exactly represented by the mesh  $\mathcal{T}_{\mathcal{H}}^{\Sigma}$  and  $\boldsymbol{n}_{\Sigma}$  belongs to  $\boldsymbol{\Lambda}_{\mathcal{H}}$ . As expected by Theorem 4.11 the numerical solution corresponds to the analytical solution up to machine error.

#### 5.2.2. Comparison with other fictitious domain methods

We now propose to compare the behavior of the proposed unfitted mesh method (10) with two alternative fictitious domain approaches. In these two methods the discrete velocity and pressure are based on continuous piecewise affine functions (i.e., the spaces  $V_h$  and  $\widetilde{Q}_h$  of Section 3) and the interface Dirichlet constraint is treated in a collocated-penalized fashion (see, e.g., [12, Section 3.2.1]). This amounts to consider in (2) the following non-conforming approximation of the Lagrange multiplier space  $\Lambda$ :

$$oldsymbol{\Lambda}^{ ext{C}}_{\mathcal{H}} = \left\{ oldsymbol{\xi}_{\mathcal{H}} = \sum_{i=1}^{N_{\mathcal{H}}} oldsymbol{\xi}_i \delta_{oldsymbol{x}^{ ext{s}}_i} \, ig| \, oldsymbol{\xi}_i \in \mathbb{R}^2, \quad i = 1, \dots, N_{\mathcal{H}} 
ight\},$$

where  $\{x_i^{\rm s}\}_{i=1}^{N_{\mathcal{H}}}$  are the points of the interface mesh  $\mathcal{T}_{\mathcal{H}}^{\Sigma}$  and  $\delta_{x_i^{\rm s}}$  denotes the Dirac's measure at point  $x_i^{\rm s}$  (see, e.g., [19,25,31]). The discrete treatment of the Dirichlet constraint takes the penalized-collocated form

$$\boldsymbol{u}_h(\boldsymbol{x}_i^{\mathrm{S}}) = \boldsymbol{u}_{\Sigma}(\boldsymbol{x}_i^{\mathrm{S}}) + \varepsilon \boldsymbol{\lambda}_i \quad \forall i = 1, \dots, N_{\mathcal{H}},$$
 (70)

where  $\varepsilon > 0$  is a given (non-dimensionless) user-defined parameter. Note that the relation (70) enables the elimination of the Lagrange multiplier  $\lambda$ , so that the first alternative fictitious domain method reads: Find  $(\boldsymbol{u}_h, \widetilde{p}_h) \in \boldsymbol{V}_h \times \widetilde{Q}_h$  such that

$$a_{h,\varepsilon}^{\text{FD}}(\left(\boldsymbol{u}_{h},\widetilde{p}_{h}\right),\left(\boldsymbol{v}_{h},\widetilde{q}_{h}\right)) = \ell_{\varepsilon}\left(\boldsymbol{v}_{h}\right)$$
 (71)

for all  $(\boldsymbol{v}_h, \widetilde{q}_h) \in \boldsymbol{V}_h \times \widetilde{Q}_h$ , with the notations

$$a_{h,\varepsilon}^{\mathrm{FD}}((\boldsymbol{u}_{h},\widetilde{p}_{h}),(\boldsymbol{v}_{h},\widetilde{q}_{h})) \stackrel{\text{def}}{=} a((\boldsymbol{u}_{h},\widetilde{p}_{h}),(\boldsymbol{v}_{h},\widetilde{q}_{h})) + s_{h}^{\mathrm{BP}}(\widetilde{p}_{h},\widetilde{q}_{h}) + d_{\varepsilon}(\boldsymbol{u}_{h},\boldsymbol{v}_{h}),$$

$$\ell_{\varepsilon}(\boldsymbol{v}_{h}) \stackrel{\text{def}}{=} \ell(\boldsymbol{v}_{h}) + d_{\varepsilon}(\boldsymbol{u}_{\Sigma},\boldsymbol{v}_{h}),$$

$$d_{\varepsilon}(\boldsymbol{u}_{h},\boldsymbol{v}_{h}) \stackrel{\text{def}}{=} \frac{1}{\varepsilon} \sum_{i=1}^{N_{\mathcal{H}}} \boldsymbol{u}_{h}(\boldsymbol{x}_{i}^{\mathrm{s}}) \cdot \boldsymbol{v}_{h}(\boldsymbol{x}_{i}^{\mathrm{s}}).$$

In the above definitions, the bilinear form a and the linear functional  $\ell$  are those defining the weak formulation of the Stokes problem (1), in Section 2. The results of the method (71) have been obtained with  $\varepsilon = 10^{-5}$  and  $\gamma_{\rm p} = 10^{-2}$ . This method will be denoted by FD<sub>\varepsilon</sub> in the sequel.

The second considered approach is a variant of (71) with an enhanced interfacial mass conservation. This is achieved by modifying the pressure and grad-div stabilizations in the neighborhood  $\mathcal{T}_h^e$  of the interface  $\Sigma$  as follows (see, e.g., [16, 28, 37]):

$$s^{\text{BP-GD}}((\boldsymbol{u}_{h}, \widetilde{p}_{h}), (\boldsymbol{v}_{h}, \widetilde{q}_{h})) \stackrel{\text{def}}{=} \sum_{K \in \mathcal{T}_{h}^{\Omega}} \int_{K} \delta_{h} \frac{\gamma_{\text{p}} h^{2}}{\mu} \boldsymbol{\nabla} \widetilde{p}_{h} \cdot \boldsymbol{\nabla} \widetilde{q}_{h} + \sum_{K \in \mathcal{T}_{h}^{\Omega}} \int_{K} \frac{\gamma_{\text{d}} \mu}{\delta_{h}} \boldsymbol{\nabla} \cdot \boldsymbol{u}_{h} \boldsymbol{\nabla} \cdot \boldsymbol{v}_{h},$$

$$\delta_{h} \stackrel{\text{def}}{=} \begin{cases} 1 & K \in \mathcal{T}_{h}^{\Omega} \setminus \mathcal{T}_{h}^{e}, \\ \gamma_{\text{gd}} & K \in \mathcal{T}_{h}^{e}, \end{cases}$$

where  $\gamma_{\rm d} > 0$  and  $0 < \gamma_{\rm gd} \ll 1$  are user-defined parameter. The fundamental idea of the method hence consists in boosting the grad-div stabilization (which enhances mass conservation) while reducing the pressure

stabilization near the interface (which limits the impact of the interfacial pressure gradient inconsistencies). The resulting discrete problem reads as follows: Find  $(\boldsymbol{u}_h, \widetilde{p}_h) \in \boldsymbol{V}_h \times \widetilde{Q}_h$  such that

$$a_{h,\varepsilon}^{\text{FD-GD}}(\left(\boldsymbol{u}_{h},\widetilde{p}_{h}\right),\left(\boldsymbol{v}_{h},\widetilde{q}_{h}\right)) = \ell_{\varepsilon}\left(\boldsymbol{v}_{h}\right)$$
(72)

for all  $(\boldsymbol{v}_h, \widetilde{q}_h) \in \boldsymbol{V}_h \times \widetilde{Q}_h$ , where

$$a_{h,\varepsilon}^{\mathrm{FD-GD}}\left(\left(\boldsymbol{u}_{h},\widetilde{p}_{h}\right),\left(\boldsymbol{v}_{h},\widetilde{q}_{h}\right)\right)\overset{\mathrm{def}}{=}a\left(\left(\boldsymbol{u}_{h},\widetilde{p}_{h}\right),\left(\boldsymbol{v}_{h},\widetilde{q}_{h}\right)\right)+s_{h}^{\mathrm{BP-GD}}\left(\left(\boldsymbol{u}_{h},\widetilde{p}_{h}\right),\left(\boldsymbol{v}_{h},\widetilde{q}_{h}\right)\right)+d_{\varepsilon}\left(\boldsymbol{u}_{h},\boldsymbol{v}_{h}\right).$$

The results of the method (72) have been obtained with  $\gamma_{\rm d}=1,~\gamma_{\rm gd}=10^{-4},~\varepsilon=10^{-5}$  and  $\gamma_{\rm p}=10^{-2}.$  We will refer to this method as FD – GD<sub> $\epsilon$ </sub> in the sequel.




FIGURE 8. Snapshots of the velocity magnitude.




FIGURE 9. Snapshots of the pressure.

Figures 8 and 9 report snapshots of the velocity magnitude and pressure obtained with the three considered fictitious domain methods, using the meshes defined at the beginning of Section 5 for N=40. We recall that the exact solution is given by (69). Figure 8a shows the poor robustness that characterises the FD<sub> $\varepsilon$ </sub> method.

Though the interface Dirichlet condition  $u_{\Sigma} = 0$  is correctly imposed, the lack of additional mass conservation constraints results in a significant mass loss which appears as a spurious velocity field in the whole computational domain  $\Omega$ . This issue is overcome in both the FD – GD<sub> $\varepsilon$ </sub> method (Figure 8b) and the method proposed in this

article (Figure 8c). These last two methods provide an adequate solution for the velocity and the pressure for this test case. As shown in Figure 9, due to the enrichment of the finite element space with an Heaviside function, the present method is, among the three, the only one capable of capturing the sharp pressure jump at the interface (see Figure 9c). Nevertheless, a good approximation of the pressure profile is also obtained for the  $FD_{\varepsilon}$  and  $FD - GD_{\varepsilon}$  methods (see Figures 9a and 9b).

## 5.3. Open interface

The last example is motivated by applications related to fluid-structure interaction problems involving topological changes, such as in cardiac valve simulations which involve both closed and open interfacial configurations. In the case of an open configuration, the separation between the two sub-domains  $\Omega_1$  and  $\Omega_2$  is not clear anymore. We propose to cope with this difficulty by adding a fictitious interface  $\Sigma_{\rm fic}$  closing  $\Sigma$ , as shown in Figure 3c.

In this example, the interface is made of two distinct parts, which are attached to the channel boundary but are disconnected in the middle, as illustrated in Figure 3c. More precisely, we set

$$\Sigma = \left\{ \left( 0.2 \left( 1 - \cos(2\pi t) - 0.1 \right), t \right) \mid t \in [0, 0.4] \cup [0.6, 1] \right\}.$$

The Neumann boundary is given by  $\Gamma_{\rm N} = \{1\} \times (0,1)$  and a Poiseuille velocity profile  $\boldsymbol{u} = -5y(1-y)\boldsymbol{n}$  is prescribed on  $\{-1\} \times (0,1)$ . Additionally, a traction-free boundary condition  $\boldsymbol{g} = \boldsymbol{0}$  is imposed on  $\{1\} \times (0,1)$ . We also consider a null right-hand side function  $\boldsymbol{f} = \boldsymbol{0}$  for the Stokes equation (1) and a velocity profile  $\boldsymbol{u}_{\Sigma} = \boldsymbol{0}$  on the immersed interface  $\Sigma$ . The fluid dynamic viscosity is set to  $\mu = 0.035$ .




FIGURE 10. Snapshots of the velocity magnitude.

As mentioned above, in order to facilitate the definition of the discrete pressure space (6) in the present geometrical setting, we introduce a fictitious interface  $\Sigma_{\rm fic}$  that connects the two endpoints of  $\Sigma$  immersed in  $\Omega$ . The sub-domain  $\Omega_1$  (resp.  $\Omega_2$ ) is then defined as the left (resp. right) side of the closed interface  $\Sigma \cup \Sigma_{\rm fic}$ .

In the present test case, we consider the straight line

$$\Sigma_{\text{fic}} = \{ (0.2 (1 - \cos (0.8\pi) - 0.1), y) \mid y \in [0.4, 0.6] \},$$

as shown in Figure 3c.

It should be noted that, since no unknowns are attached to  $\Sigma_{\rm fic}$ , this fictitious interface can be arbitrarily chosen, depending on the specific geometry of the problem, and its purpose is solely to facilitate the definition of  $\Omega_1$ . Nevertheless, from a computational perspective, when replacing the mass conservation contraint on  $\Omega_1$  with its equivalent on  $\partial\Omega_1$ , as highlighted in Remark 3.2, it is essential to choose an appropriate discretization of  $\Sigma_{\rm fic}$  that enables the constraint to be accurately imposed. In this regard, a straight fictitious interface is a good choice.

In the sequel, we compare the results obtained using the method introduced in Section 3, with the two fictitious domain methods,  $\mathrm{FD}_{\varepsilon}$  and  $\mathrm{FD} - \mathrm{GD}_{\varepsilon}$ , discussed in Section 5.2.2. As a reference solution, we consider the numerical approximation obtained through a fitted mesh approach using a highly refined mesh  $(h \approx 6.25 \times 10^{-3})$ . The results for the three fictitious domain methods, are obtained with the meshes defined at the beginning of Section 5 for N=40, and with  $\Sigma_{\mathrm{fic}}$  discretized using 120 segments. The value of the user defined parameter  $\varepsilon$  is set to  $10^{-5}$  and  $\gamma_{\mathrm{p}}=10^{-2}$ . Furthermore, for the  $\mathrm{FD}-\mathrm{GD}_{\varepsilon}$  method, we have  $\gamma_{\mathrm{d}}=1$  and  $\gamma_{\mathrm{gd}}=10^{-4}$ . In the present method, the normal is represented by  $\boldsymbol{n}_{\Sigma}^1$  defined in Section 5.2.1 at the discrete level. Similar results are obtained when considering  $\boldsymbol{n}_{\Sigma}^0$ .




FIGURE 11. Snapshots of the velocity.




FIGURE 12. Snapshots of the pressure.

Figures 10–12 display the velocity and pressure fields obtained with the three methods. For comparison purposes, the reference solution obtained with the fitted mesh method is also reported. Figure 10b shows that the  $FD_{\varepsilon}$  method exhibits significant lack of mass conservation across the interface. This is particularly

noticeable in the velocity profile near the interface, by comparing Figures 11a and 11b. In the  $FD_{\varepsilon}$  method the fluid passes through the interface, resulting in a lower velocity of the jet and the absence of vortex behind the valve. On the contrary, the other two methods are able to capture the dynamics of the reference solution, as it can be inferred from Figures 11c and 11d. Figure 12c shows however that the grad-div penalty term induces an important perturbation of the pressure field in the  $FD - GD_{\varepsilon}$  method.

The pressure provided by the present method in  $\Omega_1$  is slightly lower than the reference solution (compare Figures 12a and 12d). A slight pressure discontinuity is noticeable across the fictitious interface  $\Sigma_{\rm fic}$ . Indeed, as discussed in Remark 3.2, the amplitude  $[p_h]$  of the additional Heaviside function of  $Q_h$  can be interpreted as the Lagrange multiplier enforcing the mass conservation constraint in  $\Omega_1$  and also as the mean of the pressure jump through the interface, which must not be zero in order to prevent mass leakage at the interface.

#### 6. Conclusion

In this paper, we have proposed and analyzed a new fictitious domain method for a Stokes problem with a Dirichlet constraint on an immersed interface. Although simplified, this setting appears in more complex fluid-solid interaction problems with immersed thin-walled solids. This work was motivated by numerical evidence showing that inaccuracy issues in standard fictitious domain methods for incompressible flows are mainly driven by the lack of mass conservation across the interface. We have shown that this difficulty can be mitigated by adding a single global velocity constraint in one side of the interface, enforced via a scalar Lagrange multiplier. Another salient feature of the method is that the size of the system matrix is constant irrespectively of the location of the interface with respect to the background computational mesh, which is particularly appealing for the case of moving interfaces. A complete a priori numerical analysis of the method has been provided. The additional basis function leads to a priori error bounds that are robust with respect to the magnitude of the pressure jump. As expected, sub-optimal convergence rate of order  $\frac{1}{2} - \varepsilon$  is obtained for both the velocity and pressure, under minimal regularity assumptions. The numerical results of Section 5 show that

the present method provides similar or superior accuracy to alternative fictitious domain methods, without the need of resorting to penalty terms which jeopardize the conditioning of the resulting system matrix. Current investigations are devoted to the application of the present method to the simulation of fluid-structure interaction of heart valves.
