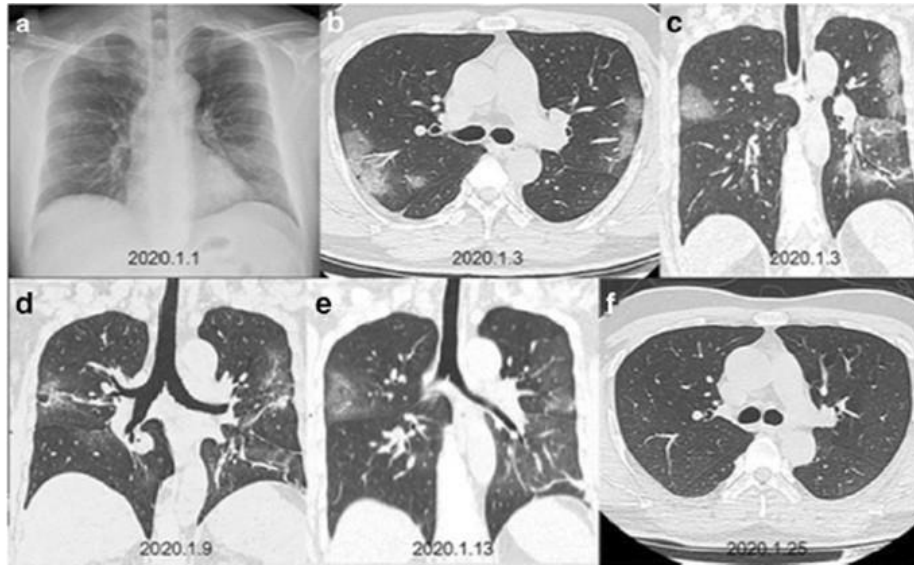


Fig. 1. : CT chest images of a COVID-19 positive patient over time

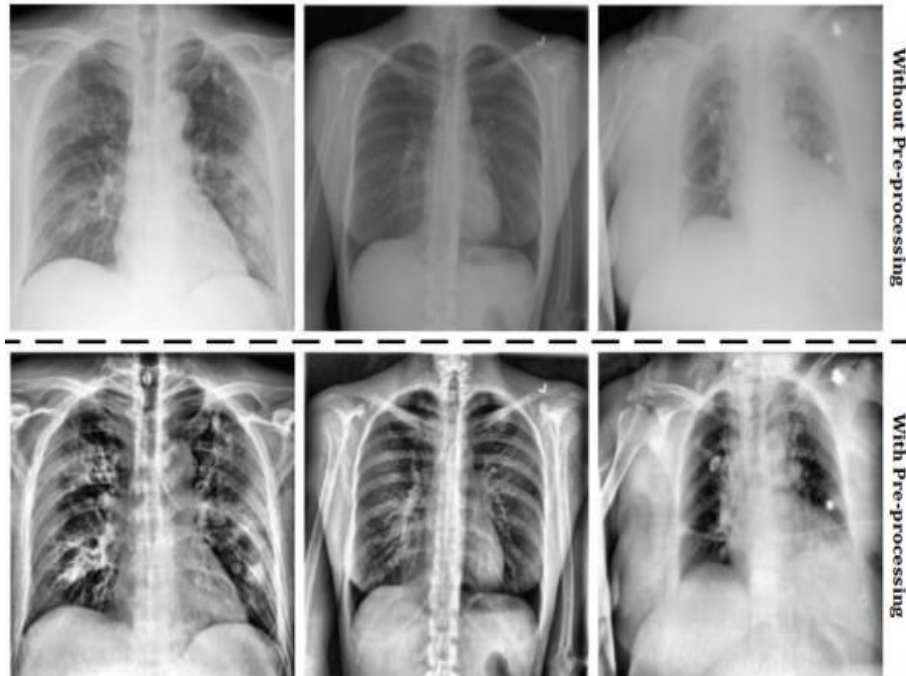


Fig. 2. X-ray pictures of patients

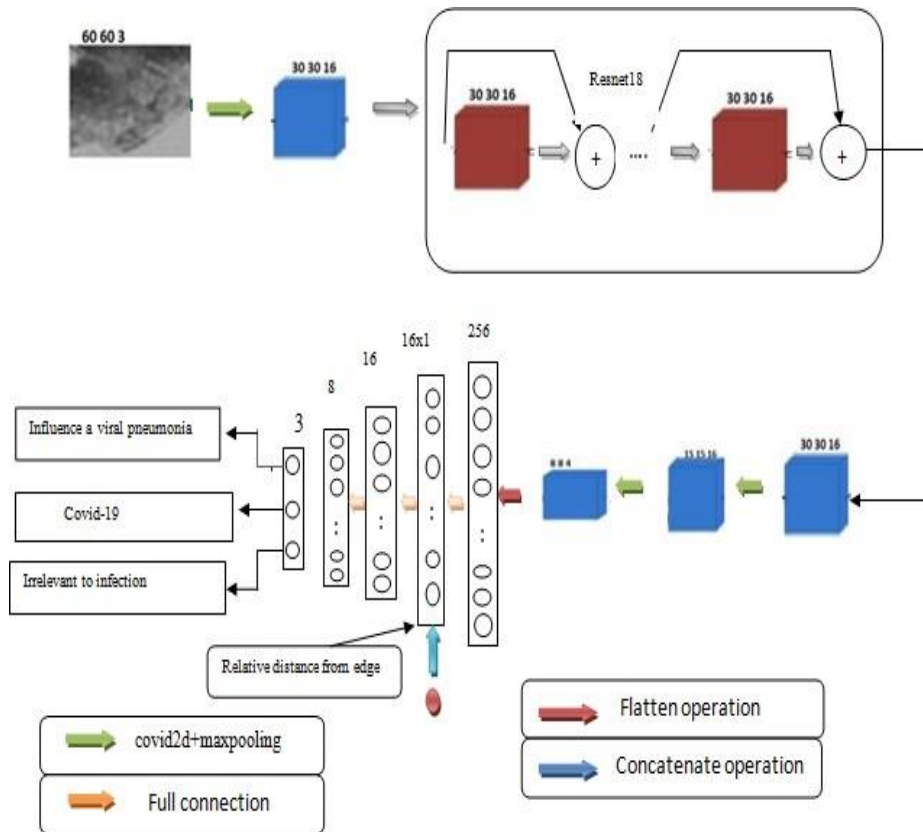


Fig 3: Methodology used for detection of COVID

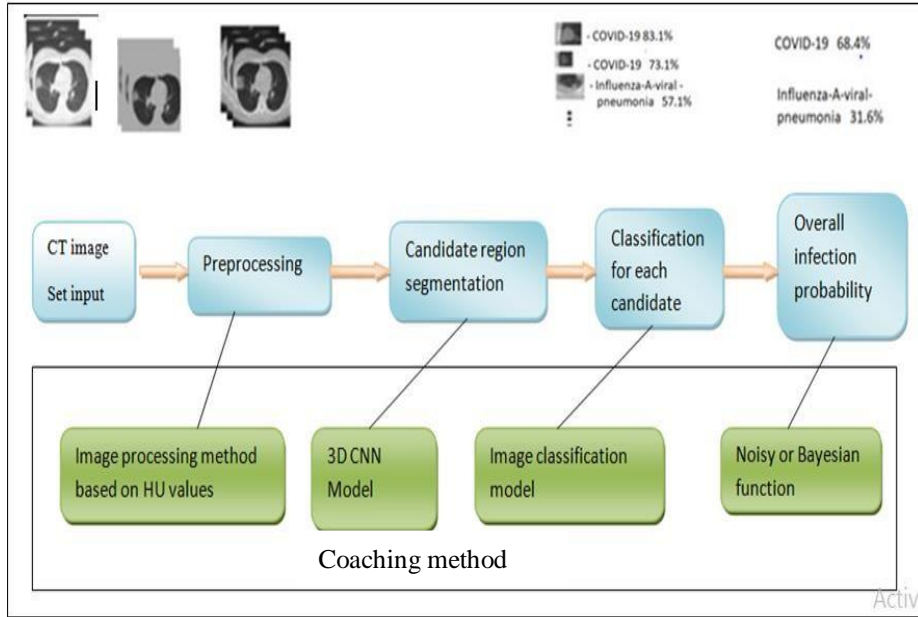


Fig 4: process flow chart of deep learning model for classification

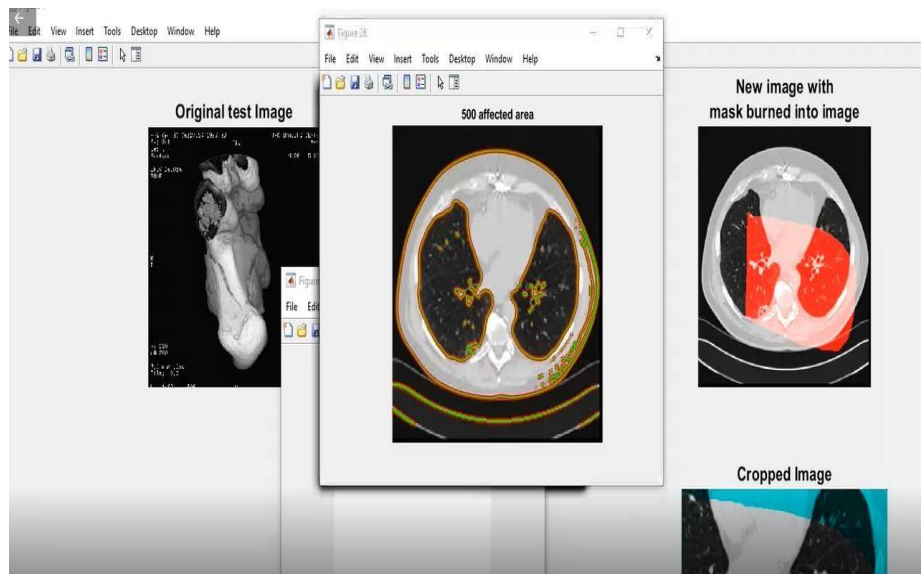


Fig 5: selecting the frame of scanning picture to detect the pneumonia

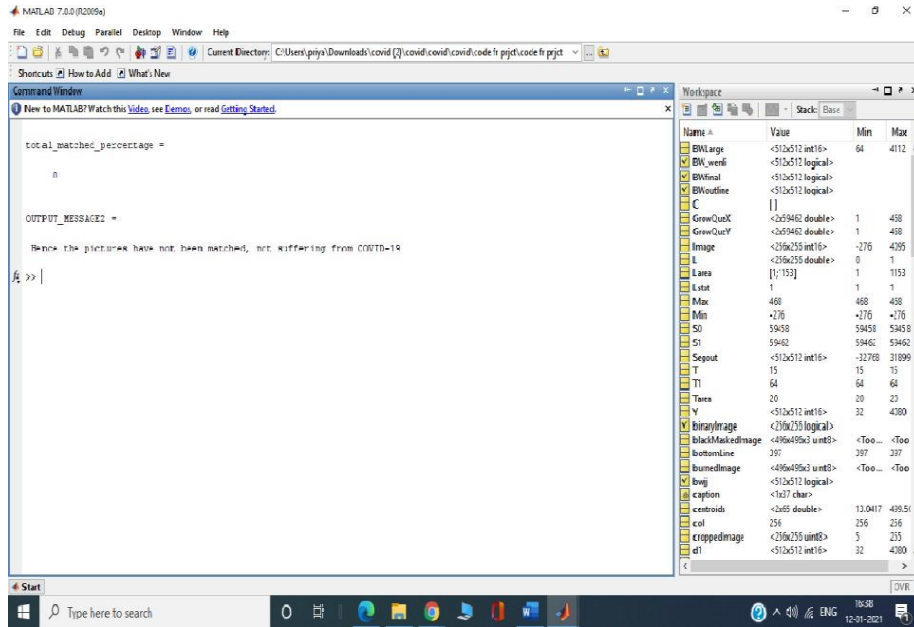


Fig 6: Output displayed in command window

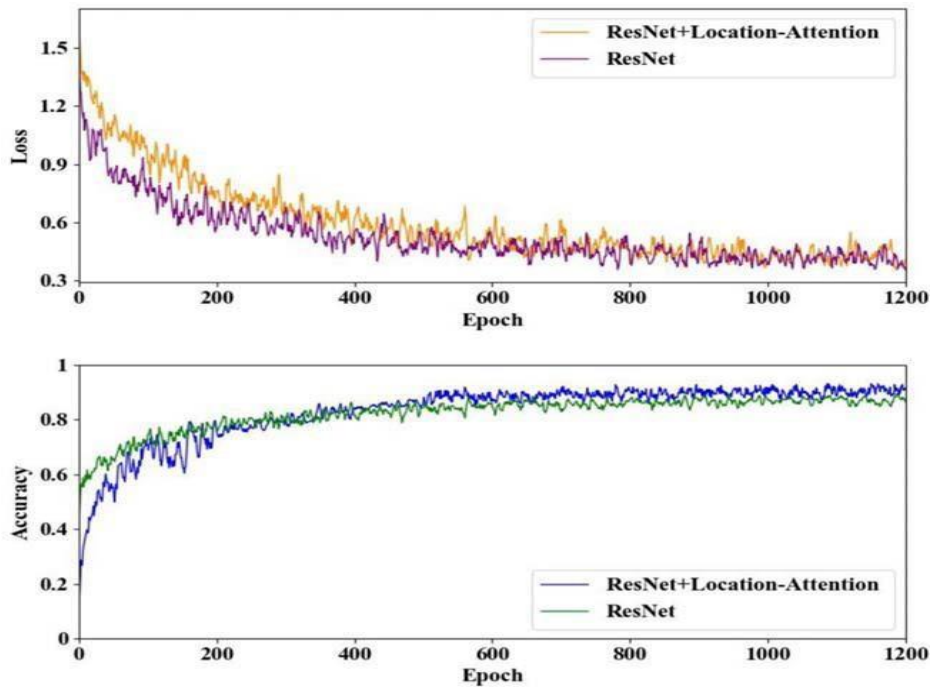


Fig 7: Output waveforms
