# Quadratic Short Division

#### Abstract

In Modern Computer Arithmetic [1], the authors describe a quadratic division with remainder, and mention a factor of two speedup can be obtained when only the quotient is needed. We give an explicit quadratic algorithm that computes an approximate quotient.


We first recall the quadratic division with remainder algorithm from [1]:

Algorithm 1 BasecaseDivRem
Input: \(A=\sum_{0}^{n+m-1} a_{i} \beta^{i}, B=\sum_{0}^{n-1} b_{j} \beta^{j}, B\) normalized, \(m \geq 0\)
Output: quotient \(Q\) and remainder \(R\) of \(A\) divided by \(B\)
    if \(A \geq \beta^{m} B\) then \(q_{m} \leftarrow 1, A \leftarrow A-\beta^{m} B\) else \(q_{m} \leftarrow 0\)
    for \(j\) from \(m-1\) downto 0 do
        \(q_{j}^{*} \leftarrow\left\lfloor\left(a_{n+j} \beta+a_{n+j-1}\right) / b_{n-1}\right\rfloor \quad \triangleright\) quotient selection
        \(q_{j} \leftarrow \min \left(q_{j}^{*}, \beta-1\right)\)
        \(A \leftarrow A-q_{j} \beta^{j} B\)
        while \(A<0\) do
            \(q_{j} \leftarrow q_{j}-1\)
            \(A \leftarrow A+\beta^{j} B\)
    return \(Q=\sum_{0}^{m} q_{j} \beta^{j}, R=A\).
```

We propose the following algorithm to compute an approximate quotient:

Algorithm 2 BasecaseShortDiv
Input: \(A=\sum_{0}^{n+m-1} a_{i} \beta^{i}, B=\sum_{0}^{n-1} b_{j} \beta^{j}, B\) normalized, \(m \geq 0, n \geq 1\)
Output: approximate quotient \(Q\) of \(A\) divided by \(B\)
    if \(A \geq \beta^{m} B\) then \(q_{m} \leftarrow 1, A \leftarrow A-\beta^{m} B\) else \(q_{m} \leftarrow 0\)
    for \(j\) from \(m-1\) downto 0 do
        write \(\beta^{j} B=H_{j} \beta^{n-1}+L_{j}\) with \(0 \leq L_{j}<\beta^{n-1}\)
        \(q_{j}^{*} \leftarrow\left\lfloor\left(a_{n+j} \beta+a_{n+j-1}\right) / b_{n-1}\right\rfloor \quad \triangleright\) quotient selection
        \(q_{j} \leftarrow \min \left(q_{j}^{*}, \beta-1\right)\)
        \(A \leftarrow A-q_{j} H_{j} \beta^{n-1}\)
        while \(A<0\) do
            \(q_{j} \leftarrow q_{j}-1\)
            \(A \leftarrow A+H_{j} \beta^{n-1}\)
        if \(A \geq \beta^{j} B\) then \(q_{j} \leftarrow \beta, q_{j-1}, \ldots, q_{0} \leftarrow 0\); break
    return \(Q=\sum_{0}^{m} q_{j} \beta^{j}\)
```

Theorem 1 The approximate quotient $Q$ returned by Algorithm BasecaseShortDiv satisfies:

$$
-1<Q-A / B<2 \min (m, n-1) .
$$

Proof: We first prove that the value $A$ at the beginning of the for-loop with index $j$ satisfies $A<\beta^{j+1} B$. If we have $A \geq \beta^{m} B$ initially, then since $B \geq \beta^{n} / 2,2 \beta^{m} B \geq \beta^{n+m}>A$ thus the new value of $A$ is $A-\beta^{m} B<\beta^{m} B$, and $A<\beta^{j+1} B$ holds for $j=m-1$. Since when $A \geq \beta^{j} B$, we exit the for-loop at step 10, when $A<\beta^{j} B$ we have $A<\beta^{j+1} B$ at the next iteration.

Let $j_{0}$ be the last index for which the for-loop is processed. Let $A_{j+1}$ (resp. $A_{j}$ ) be the value of $A$ at the beginning (resp. end) of the loop for index $j$, and $q_{j}$ the value after the potential corrections at step 9 . We thus have $A_{j}=A_{j+1}-q_{j} H_{j} \beta^{n-1}$. Since $\beta^{j} B=H_{j} \beta^{n-1}+L_{j}$, it follows:

$$
A_{j}=A_{j+1}-q_{j}\left(\beta^{j} B-L_{j}\right),
$$

and thus:

$$
\begin{equation*}
A_{j_{0}}=A-Q B+\sum_{j=j_{0}}^{m-1} q_{j} L_{j} \tag{1}
\end{equation*}
$$

If $A \geq \beta^{j} B$ and we exit the for-loop early, since $\beta^{j} B \geq H_{j} \beta^{n-1}$, we could not have entered the while-loop, thus we already had $A \geq \beta^{j} B$ before the while-loop. If $q_{j}=q_{j}^{*}$, we can see that $A<\beta^{j} B$ before the while loop. Indeed, write $a_{n+j} \beta+a_{n+j-1}=q_{j} b_{n-1}+r$ with $0 \leq r<b_{n-1}$. Since $H_{j}$ has the same $j+1$ upper words as $\beta^{j} B$, we can write $H_{j} \beta^{n-1}=b_{n-1} \beta^{n+j-1}+S$ with $0 \leq S<\beta^{n+j-1}$. It follows:

$$
\begin{align*}
A-q_{j} H_{j} \beta^{n-1} & =\left(q_{j} b_{n-1}+r\right) \beta^{n+j-1}+R-q_{j}\left(b_{n-1} \beta^{n+j-1}+S\right)  \tag{2}\\
& \leq r \beta^{n+j-1}+R-q_{j} S \\
& <\left(b_{n-1}-1\right) \beta^{n+j-1}+\beta^{n+j-1}=b_{n-1} \beta^{n+j-1} \leq \beta^{j} B .
\end{align*}
$$

Thus if we exit the for-loop early, necessarily we had $A \geq \beta^{j} B$ before the while-loop, and $q_{j}^{*} \geq \beta$, thus $q_{j}=\beta-1$. Then since $A-q_{j} H_{j} \beta^{n-1} \geq \beta^{j} B$ :

$$
\begin{aligned}
A & \geq(\beta-1) H_{j} \beta^{n-1}+\beta^{j} B \\
& =(\beta-1)\left(\beta^{j} B-L_{j}\right)+\beta^{j} B \\
& \geq \beta^{j+1} B-(\beta-1) L_{j}>\beta^{j+1} B-\beta^{n} \geq \beta^{j+1} B-2 B .
\end{aligned}
$$

Since we had $A<\beta^{j+1} B$ at the beginning of the loop, we deduce $\beta^{j+1} B-2 B<A<\beta^{j+1} B$, which can be written $A_{j_{0}}=A_{j_{0}+1}-\beta^{j+1} B+T$ with $A_{j_{0}}=0$ and $0<T<2 B$. This matches Eq. (1), with the term $q_{j_{0}} L_{j_{0}}$ replaced by $T$, where both terms share the same bounds: $0 \leq q_{j_{0}} L_{j_{0}}, T<2 B$.

Now assume we don't exit the for-loop early. Since for $j=0$ the condition $A \geq \beta^{j} B$ is not fulfilled, we have $A_{0}<B$. Now for $j \geq n-1$, we have $\beta^{j} B=\left(\beta^{j-(n-1)} B\right) \beta^{n-1}$, thus $H_{j}=\beta^{j-(n-1)} B$ and $L_{j}=0$. The term $q_{j} L_{j}$ is thus zero for $j \geq n-1$. Since we proved $0 \leq A_{0}<B$, we have:

$$
-2 \min (m, n-1) \leq-\min (m, n-1) \beta \beta^{n-1} / B<A / B-Q<1
$$

Remark 1: since $H_{j}$ has $j+1$ words, the multiplication $q_{j} H_{j} \beta^{n-1}$ at step 6 reduces to a multiplication of $j+1$ words by 1 word, instead of $n$ words by 1 word in BasecaseDivRem, which yields a potential factor of two speedup. Similary at step 9 , the addition $A+H_{j} \beta^{n-1}$ only involves $j+1$ words.
Remark 2: for the integer quotient $\lfloor A / B\rfloor$, Theorem 1 yields $A / B-1<Q<A / B+2 \min (m, n-1)$ thus:

$$
\lfloor A / B\rfloor \leq Q \leq\lfloor A / B\rfloor+2 \min (m, n-1)-1 .
$$

Algorithm BasecaseShortDiv can thus be used to replace Algorithm Div in [2], since Div has $m=n$, and expects an approximate quotient $Q$ satisfying $\lfloor A / B\rfloor \leq Q \leq\lfloor A / B\rfloor+2 n$.

REMARK 3: if one wants to reduce the upper bound $2 \min (m, n-1)$, one can take one more word in $H_{j}$, say $\beta^{j} B=H_{j} \beta^{n-2}+L_{j}$ with $0 \leq L_{j}<\beta^{n-2}$. The upper bound will become $2 \min (m, n-1) / \beta$, which in most usual cases will be less than 1. This will however induce more operations at steps 6 and 9 .
REmARK 4: the number of iterations of the while-loop at steps 7-9 is at most 2. Indeed, from Eq. (2) we have

$$
\begin{aligned}
A-q_{j} H_{j} \beta^{n-1}+2 H_{j} \beta^{n-1} & \geq-q_{j} S+2 H_{j} \beta^{n-1} \geq-\beta S+2\left(b_{n-1} \beta^{n+j-1}+S\right) \\
& \geq-(\beta-2) S+2 b_{n-1} \beta^{n+j-1} \geq-(\beta-2) \beta^{n+j-1}+\beta \cdot \beta^{n+j-1} \geq 0
\end{aligned}
$$

REMARK 5: the average number of corrections in the while-loop (per value of $j$ ) is about 0.35 for $m=n=100$ (same value for BasecaseDivRem). To decrease the number of corrections, one should compute a more accurate partial quotient $q_{j}$ by dividing the upper 3 words from $A$ by the upper 2 words from $H_{j} \beta^{n-1}$ :

$$
q_{j}^{*} \leftarrow\left\lfloor\left(a_{n+j} \beta^{2}+a_{n+j-1} \beta+a_{n+j-2}\right) /\left(b_{n-1} \beta+b_{n-2}^{\prime}\right)\right\rfloor,
$$

where $b_{n-2}^{\prime}$ is the second most significant word of $H_{j}$. This is what function mpfr_divhigh_n_basecase from GNU MPFR does, for which corrections are extremely rare.
REmARK 6: the condition $A \geq \beta^{j} B$ at step 10 can be replaced by $A \geq \beta^{n+j}$, which is easier to check. Indeed, if $\beta^{j} B \leq A<\beta^{n+j}$, the next iteration will get $q_{j-1}^{*} \geq \beta$, thus $q_{j-1}=\beta-1$, and

$$
A-q_{j-1} H_{j-1} \beta^{n-1} \geq \beta^{j} B-(\beta-1) \beta^{j-1} B=\beta^{j-1} B
$$

thus the condition for early termination will hold at the next iteration, and setting $q_{j}=\beta$ and $q_{j-1}=0$ has the same effect as $q_{j}=\beta-1$ and $q_{j-1}=\beta$. (The invariant $A<\beta^{j+1} B$ is no longer satisfied, but this does not matter in this case.)
