# Choosability of the square of planar subcubic graphs with large girth

#### Abstract

We first show that the choose number of the square of a subcubic graph with maximum average degree less than $18 / 7$ is at most 6 . As a corollary, we get that the choose number of the square of a planar graph with girth at least 9 is at most 6 . We then show that the choose number of the square of a subcubic planar graph with girth at least 13 is at most 5 .

## Choisissabilité du carré des graphes planaires subcubiques de grande maille

Résumé : Nous montrons que le nombre de choix du carré d'un graphe subcubique de degré moyen maximum inférieur à $18 / 7$ est au plus 6 . Ceci implique que le carré d'un graphe planaire subcubique de maille au moins 9 est 6 -choisissable. Ensuite, nous montrons que le nombre de choix du carré d'un graphe planaire subcubique de maille au moins 13 est au plus 5 .

## 1 Introduction

Let $G$ be a (simple) graph.
Let $v$ be a vertex of $G$. Its neighbourhood, denoted $N_{G}(v)$ is the set of its neighbours, i.e. is vertices $y$ such that $x y$ is an edge. The degree of a vertex $v$ in $G$, denoted $d_{G}(v)$, is its number of neighbours. Often, when the graph $G$ is clearly understood from the context, we omit the subscript $G$.

A graph is subcubic if every vertex has degree at most 3 .
Let $p: V(G) \rightarrow \mathbb{N}$. A $p$-list-assignment is a list-assignment $L$ such that $L(v)=p(v)$ for any $v \in V(G) . G$ is $p$-choosable if it is $L$-colourable for any $p$-list-assignment. By extension , if $k$ is an integer, we say that $G$ is $k$-choosable if it is $p$-choosable when $p$ is the constant function with value $k$ (i. e. $p(v)=k$ for all $v \in V$ ). The choose number of $G$ is the smallest integer $k$ such that $G$ is $k$-choosable. Clearly the choose number of $G$ is at least as large as $\chi(G)$ the chromatic number of $G$.

The square of $G$, is the graph $G^{2}$ with vertex set $V(G)$ such that two vertices are linked by an edge of $G^{2}$ if and only if $x$ and $y$ are at distance at most 2 in $G$ (either $x y$ is an edge or $x$ and $y$ share a neighbour). Formally, $E\left(G^{2}\right)=\{x y,(x y \in E(G)$ or $\exists z \in N(x) \cap N(y))\}$.

Wegner [4] proved that the square of a subcubic planar is 8-colourable. He also conjectured it is 7-colourable.

Conjecture 1 (Wegner [4]) Let $G$ be a subcubic planar graph. Then $\chi\left(G^{2}\right) \leq 7$.
The average degree of $G$, denoted $A d(G)$ is $\frac{\sum_{v \in V(G)} d(v)}{|V(G)|}=\frac{2|E(G)|}{|V(G)|}$.
The maximum average degree of $G$, denoted $\operatorname{Mad}(G)$, is $\max \{\operatorname{Ad}(H), H$ subgraph of $G\}$.
In [1], Dvořák, Skrekovski and Tancer proved that the choose number of the square of a subcubic graph $G$ is at most 4 if $\operatorname{Mad}(G)<24 / 11$ and $G$ has no 5 -cycle, at most 5 if $\operatorname{Mad}(G)<7 / 3$ and at most 6 if $\operatorname{Mad}(G)<5 / 2$.

A graph is called planar if it can be embedded in the plane. The girth of a graph is the smallest length of a cycle in $G$. Planar graph with presrcibed girth have bounded maximum average degree:

Proposition 2 Every planar graph with girth at least $g$ has maximum average degree less than $2+\frac{4}{g-2}$.

Hence the results of Dvořák, Škrekovski and Tancer imply that the choose number of the square of a planar graph with girth $g$ is at most 6 if $g \geq 13$, at most 5 if $g \geq 14$ and at most 4 if $g \geq 24$. The two later results had been previously proved by Montassier and Raspaud [3].

In this paper, we improve some of these results. We first show (Theorem 4) that the choose number of the square of a subcubic graph with maximum average degree less than $18 / 7$ is at most 6 . As a corollary, we get that the choose number of the square of a planar graph with girth at least 9 is at most 6 . We then show (Theorem 9 ) that the choose number of the square of a subcubic planar graph with girth at least 13 is at most 5 .

## 2 The main results

The general frame of the proofs are classical. We consider a $k$-minimal graph, that is a subcubic graph such that its square is not $k$-choosable, but the square of every proper subgraph is $k$-choosable. We prove that some configurations (i.e. induced subgraphs) are forbidden in such a graph and then deduce a contradiction.

An $i$-vertex is a vertex of degree $i$. We denote by $V_{i}$ the set of $i$-vertices of $G$ and by $v_{i}$ its cardinality. Let $v$ be a vertex. An $i$-neighbour of $v$ is a neighbour of $v$ with degree $i$. The $i$-neighbourhood of $v$ is $N_{i}(v)=N(v) \cap V_{i}$ and its $i$-degree is $d_{i}(v)=\left|N_{i}(v)\right|$.

Some properties of 6 - and 5 -minimal graphs have already been proved in [1]. The easy first one is that $V_{0} \cup V_{1}=\emptyset$, so $G$ has minimum degree 2 . This will allow us to use the following definitions for 6 - and 5 -minimal graphs.

Definition 3 Let $G$ be a subcubic graph with minimum degree 2 .
A thread of $G$ is a maximal induced path of $G$. In other words, it is a a path whose endvertices are 3 -vertices and whose internal vertices are 2 -vertices.

The kernel of $G$ is the weighted graph $K$ such that $V(K)=V_{3}(G)$ and $x y$ is an edge in $K$ with weight $l$ if and only if $x$ and $y$ are connected by a thread of length $l$ in $G$. An edge of weight $l$ is also called $l$-edge.

Let $x$ be a 3-vertex of $G$. The type of $x$ is the triple $\left(l_{1}, l_{2}, l_{3}\right)$ such that $l_{1} \leq l_{2} \leq l_{3}$ and the three edges (A loop is counted twice.) incident to $x$ have weight $l_{1}, l_{2}$ and $l_{3}$ in $K$. We denote by $Y_{l_{1}, l_{2}, l_{3}}$ the set of 3 -vertices of type ( $l_{1}, l_{2}, l_{3}$ ) and $y_{l_{1}, l_{2}, l_{3}}$ its cardinality. Moreover, for every integer $i$, we define $Z_{i}:=\bigcup_{l_{1}+l_{2}+l_{3}=i} Y_{l_{1}, l_{2}, l_{3}}$ and $z_{i}=\left|Z_{i}\right|$.

The number of vertices and edges and thus the average degree of a subcubic graph $G$ with minimum degree 2 may be easily expressed in terms of the $z_{i}$ :

\begin{align*}
|V(G)| & =\sum_{i \geq 3} \frac{i-1}{2} z_{i} \\
2|E(G)| & =\sum_{i \geq 3} i . z_{i} \\
A d(G) & =\frac{\sum_{i \geq 3} i . z_{i}}{\sum_{i \geq 3} \frac{i-1}{2} z_{i}} \tag{1}
\end{align*}
$$

### 2.1 6-choosability

The aim of this subsection is to prove the following result.
Theorem 4 Let $G$ be a subcubic graph of maximum average degree $d<18 / 7$. Then $G^{2}$ is 6 -choosable.

In order to prove this theorem, we need to establish some properties of 6 -minimal graphs. Some of them have been proved in [1].

Lemma 5 (Dvořák, Škrekovski and Tancer [1]) Let $G$ be a 6-minimal graph. Then the following hold:

1) all the edges of $K$ have weight at most 2;
2) every 3-cycle of $G$ has its vertices in $V_{3}$;
3) every 4-cycle of $G$ has at least three vertices in $V_{3}$;
4) a vertex of $Y_{2,2,2}$ is not adjacent to a vertex of $Y_{1,2,2} \cup Y_{2,2,2}$.

We will prove in Subsection 3.2 some new properties.
Lemma 6 Let $G$ be a 6-minimal graph. Then the following hold:
5) if $\left(v_{1}, v_{2}, v_{3}, v_{4}, v_{1}\right)$ is a 4-cycle with $v_{2} \in V_{2}$ then $v_{1}$ or $v_{3}$ is not in $Z_{5}$;
6) a vertex of $Y_{1,2,2}$ is adjacent to at most one vertex of $Y_{1,2,2}$ by 2-edges.

Proof of Theorem 4. Let $G$ be a 6 -minimal planar graph. $G$ has minimum degree 2, so its kernel $K$ is defined. Moreover by Lemma $5-1$ ), $Z_{i}$ is empty for $i \geq 7$ and $Z_{6}=Y_{2,2,2}$ and $W_{5}=Y_{1,2,2}$.

Let us consider a vertex of $Z_{4}=Y_{1,1,2}$. Its neighbour via the 2-edge is in $Z_{4} \cup Z_{5} \cup Z_{6}$ because a vertex of $Z_{3}=Y_{1,1,1}$ is incident to no edge of weight 2.

For $i=4,5,6$, let $Z_{4}^{i}$ be the set of vertices of $Z_{4}$ which are incident to a vertex of $Z_{i}$ by their unique 2-edge and $z_{4}^{i}$ its cardinality. $\left(Z_{4}^{4}, Z_{4}^{5}, Z_{4}^{6}\right)$ is a partition of $Z_{4}$ so $z_{4}=z_{4}^{4}+z_{4}^{5}+z_{4}^{6}$.

Hence Equation (1) becomes

$$
A d(G)=\frac{6 z_{6}+5 z_{5}+4 z_{4}^{6}+4 z_{4}^{5}+4 z_{4}^{4}+3 z_{3}}{\frac{5}{2} z_{6}+2 z_{5}+\frac{3}{2} z_{4}^{6}+\frac{5}{2} z_{4}^{5}+\frac{3}{2} z_{4}^{4}+z_{3}}
$$

By Lemma 5-4), the three neighbours of a vertex of $Z_{6}$ is not in $Z_{6} \cup Z_{5}$. So they must be in $Z_{4}^{6}$. It follows that $3 z_{6}=z_{4}^{\prime}$. So

$$
A d(G)=\frac{5 z_{5}+6 z_{4}^{6}+4 z_{4}^{5}+4 z_{4}^{4}+3 z_{3}}{2 z_{5}+\frac{7}{3} z_{4}^{6}+\frac{5}{2} z_{4}^{5}+\frac{3}{2} z_{4}^{4}+z_{3}}
$$

By Lemma 6-6), a vertex of $Z_{5}$ is adjacent to at least one vertex of $Z_{4}^{5}$. Thus $z_{5} \leq z_{4}^{5}$.
But $\operatorname{Ad}(G)$ is decereasing as a function of $z^{5}$ since $z_{4}^{6}, z_{4}^{5}, z_{4}^{4}$ and $z_{3}$ are non-negative. It follows that

$$
A d(G) \geq \frac{6 z_{4}^{6}+9 z_{4}^{5}+4 z_{4}^{4}+3 z_{3}}{\frac{7}{3} z_{4}^{6}+\frac{7}{2} z_{4}^{5}+\frac{3}{2} z_{4}^{4}+z_{3}} \geq \frac{18}{7}
$$



Figure 1: The graph $J_{7}$

Remark 7 Theorem 4 is tight. Indeed, the graph $J_{7}$ depicted Figure 1 has average degree $18 / 7$ and its square is the complete graph on seven vertices $K_{7}$ which is not 6 -choosable (nor 6 -colourable).

Theorem 4 and Proposition 2 yield that the square of a planar graph with girth 9 is 6 -choosable.

Corollary 8 The square of a planar graph with girth 9 is 6 -choosable.

### 2.2 5-choosability

Dvořák, Škrekovski and Tancer [1] proved that the square of a subcubic graph $G$ with maximum average degree less than $7 / 3$ is 5 -choosable. This result is tight since the graph $J_{6}$ depicted Figure 2 has average degree $7 / 3$ and its square is the complete graph on six vertices $K_{6}$ which is not 5 -choosable (nor 5 -colourable).


Figure 2: The graph $J_{6}$

However, we will prove that the square of a planar graph with girth at least 13 is 5 choosable, which improves the result of Montassier and Raspaud.

Theorem 9 The square of a planar graph with girth 13 is 5 -choosable.
In order to prove this theorem, we need to establish some properties of 6-minimal graphs. Some of them have been proved in [1].

Lemma 10 (Dvořák, Škrekovski and Tancer [1]) Let $G$ be a 5-minimal graph of girth 13. Then the following hold:

1) all the edges of $K$ have weight at most 3 ;
2) if $i \geq 8, Z_{8}$ is empty.

We will prove in Subsection 3.3 some new properties.
Lemma 11 Let $K$ be the $G$ be a 5-minimal graph of girth at least 13. Then the following holds:
3) A vertex of $Y_{2,2,3}$ and a vertex of $Y_{1,2,3} \cup Y_{2,2,3}$ are not linked by a 2-edge.
4) A vertex of $Y_{1,3,3}$ and a vertex of $Y_{1,2,3} \cup Y_{1,3,3}$ are not linked by a 1-edge.
5) A vertex of $Y_{2,2,2}$ is not adjacent to three vertices of $Y_{2,2,3}$ (by 2-edges).

Proof of Theorem 9. Let $G$ be a 5 -minimal planar graph with girth at least 13. $G$ has minimum degree 2, so its kernel $K$ is defined. Moreover, by Lemma 10-1), $Z_{7}=Y_{2,2,3} \cup Y_{1,3,3}$, so

$$
\begin{equation*}
z_{7}=y_{2,2,3}+y_{1,3,3} . \tag{2}
\end{equation*}
$$

Let us count the number $e_{2}$ of 2-edges incident to vertices of $Y_{2,2,3}$. Since 2-edges may not link two vertices of type $(2,2,3)$ according to Lemma 11-3), we have $e_{2}=2 y_{2,2,3}$. Moreover, the end of such edges which is not in $Y_{2,2,3}$ has to be in $Y_{2,2,2} \cup Y_{1,2,2} \cup Z_{4}$ by Lemmas 10 and 11-3). Furthermore, a vertex of $Y_{2,2,2}$ is incident to at most two edges of $e_{2}$ according to Lemma 11-5) and a vertex of $Y_{1,2,2}$ (resp. $Z_{4}$ ) is incident to at most two (resp. one) 2-edges. Therefore $e_{2} \leq 2 y_{2,2,2}+2 y_{1,2,2}+z_{4}$. So,

$$
\begin{equation*}
2 y_{2,2,3} \leq 2 y_{2,2,2}+2 y_{1,2,2}+z_{4} \tag{3}
\end{equation*}
$$

Let us now count the number $e_{1}$ of 1-edges incident to vertices of $Y_{1,3,3}$. Since 1-edges may not link two vertices of type $(1,3,3)$ according to Lemma 11-4), we have $e_{1}=y_{1,3,3}$. Moreover, the end of such edges which is not in $Y_{2,2,3}$ has to be in $Y_{1,2,2} \cup Y_{1,1,3} \cup Z_{4} \cup Z_{3}$ by Lemmas 10 and 11-4). Furthermore, vertices of $Y_{1,2,2}$ (resp. $Y_{1,1,3} \cup Z_{4}, Z_{3}$ ) are incident to at most one (resp. two, three) 1-edges. Thus $e_{1} \leq y_{1,2,2}+2 y_{1,1,3}+2 z_{4}+3 z_{3}$. So,

$$
\begin{equation*}
y_{1,3,3} \leq y_{1,2,2}+2 y_{1,1,3}+2 z_{4}+3 z_{3} \tag{4}
\end{equation*}
$$

$2 \times(4)+(3)$ yields $2 y_{2,2,3}+2 y_{1,3,3} \leq 2 y_{2,2,2}+4 y_{1,2,2}+4 y_{1,1,3}+5 z_{4}+6 z_{3}$. Hence by Equation $2,2 z_{7} \leq 2 z_{6}+4 z_{5}+5 z_{4}+6 z_{3}$, so

$$
z_{7} \leq z_{6}+2 z_{5}+\frac{5}{2} z_{4}+3 z_{3}
$$

Now by Equation 1 the average degree of $G$ is

$$
A d(G)=\frac{7 z_{7}+6 z_{6}+5 z_{5}+4 z_{4}+3 z_{3}}{3 z_{7}+\frac{5}{2} z_{6}+2 z_{5}+\frac{3}{2} z_{4}+z_{3}}
$$

As a function of $z_{7}$ this is a decreasing function $\left(\right.$ on $\left.\mathbb{R}^{+}\right)$, so it is minimum when $z_{7}$ is maximum that is equal to $z_{6}+2 z_{5}+\frac{5}{2} z_{4}+3 z_{3}$. So, :

$$
A d(G) \geq \frac{13 z_{6}+19 z_{5}+\frac{43}{2} z_{4}+24 z_{3}}{\frac{11}{2} z_{6}+8 z_{5}+9 z_{4}+10 z_{3}} \geq \frac{26}{11}
$$

This contradicts the fact that $G$ has girth 13 by Proposition 2.
It is very likely that using the method below, one can prove that a graph $G$ with maximum average degree less than $\frac{26}{11}$ is 5 -choosable unless it contains $J_{6}$ as an induced subgraph. However, this will require the tedious study of a large number of configurations.

## 3 Proofs of Lemmas 6 and 11

In order, to prove Lemmas 6 and 11, we need the following lemma proved in [1]. Let $S$ be a set of vertices of a $k$-minimal graph $G$. The function $p_{S}: S \rightarrow N$ is defined by $p_{S}(v)=k-\left|N_{G^{2}}(v) \backslash S\right|$. Then $p_{S}(v)$ represents the minimum number of available colours at a vertex $v \in S$ once we have precoloured the square of $G-S$. Hence if $(G-S)^{2}$ is 6-choosable, $(G-S)^{2}=G^{2}-S$ (in particular, it happens when two distinct vertices of $G-S$ have no common neighbour in $S$ ) and $G[S]^{2}$ is $p_{S}$-choosable, one can extend any $k$-list-colouring of $G-H$ into a $k$-list-colouring of $G$.

Lemma 12 (Dvořák, Škrekovski and Tancer [1]) Let $S$ be a set of vertices of a $k$ minimal graph $G$. If $(G-S)^{2}=G^{2}-S$, then $G^{2}[S]$ is not $p_{S}$-choosable.

In order to use Lemma 12, we need some results on the choosability of some graphs.

### 3.1 Some choosability tools

Definition 13 Let $x$ and $y$ be two vertices of a graph $G$. An $(x-y)$-ordering of $G$ is an ordering such that $x$ is the minimum and $y$ the maximum. An $(x, y-z)$-ordering is an ordering such that $x$ is minimum, $y$ is the second minimum and $z$ is maximum.

Let $\sigma=\left(v_{1}<v_{2}, \ldots<v_{n}\right)$ be an ordering of the vertices of $G$. $\sigma$ is $p$-greedy if for every $i$, $\left|N\left(v_{i}\right) \cap\left\{v_{1}, \ldots, v_{i-1}\right\}\right|<p\left(v_{i}\right)$. It is $p$-nice if for every $i$ except $n,\left|N\left(v_{i}\right) \cap\left\{v_{1}, \ldots, v_{i-1}\right\}\right|<$ $p\left(v_{i}\right)$ and $d\left(v_{n}\right)=p\left(v_{n}\right)$. It is $p$-good if for every $3 \leq i \leq n,\left|N\left(v_{i}\right) \cap\left\{v_{1}, \ldots, v_{i-1}\right\}\right|-\epsilon\left(v_{i}\right)<$ $p\left(v_{i}\right)$ with $\epsilon\left(v_{i}\right)=1$ if $v_{i}$ is adjacent to both $v_{1}$ and $v_{2}$ and $\epsilon\left(v_{i}\right)=0$ otherwise.

The greedy algorithm according to greedy, nice and good orderings yields the following three lemmas.

Lemma 14 If $G$ has a p-greedy ordering then $G$ is $p$-choosable.
Proof. Applying the greedy algorithm according to the $p$-greedy ordering gives the desired colouring.

Lemma 15 Let $x y$ be an edge of graph $G$ and $L$ be a p-list-assignment of $G$. If $L(x) \not \subset L(y)$ and $G$ has a $p$-nice $(x-y)$-ordering, then $G$ is $L$-colourable.

Proof. Let $a$ be a colour in $L(x) \backslash L(y)$. Proceed the greedy algorithm starting by assigning $a$ to $x$. The only vertex which has not more colour in its list than previously coloured neighbours is $y$ for which $|L(y)|=d(y)$. But since $a \notin L(y)$, at most $d(y)-1$ colours of $L(y)$ are assigned to the neighbours of $y$. Hence one can colour $y$.

Lemma 16 Let $x, y$ and $z$ be three vertices of a graph $G=(V, E)$ such that $x y \notin E$, $x z, y z \in E$. If $L(x) \cap L(y) \neq \emptyset$ and $G$ has a $p$-good $(x, y-z)$-ordering, then $G$ is $L$ colourable.

Proof. Let $a$ be a colour in $L(x) \cap L(y)$ and $\sigma=\left(v_{1}<v_{2}, \ldots<v_{n}\right)$ be a $p$-good $(x, y-z)$ ordering. (In particular, $v_{1}=x, v_{2}=y$ and $v_{n}=z$.) Proceed the greedy algorithm according to $\sigma$ starting by assigning $a$ to $x$ and $y$. For every $3 \leq i \leq n$, the number of colours assigned to already coloured neighbours of $v_{i}$ is at most $\left|N\left(v_{i}\right) \cap\left\{v_{1}, \ldots, v_{i-1}\right\}\right|-\epsilon\left(v_{i}\right)$ since $v_{1}$ and $v_{2}$ are coloured the same. Hence the greedy algorithm gives an $L$-colouring.

Remark 17 Note that under the condition $x z, y z \in E$, a $p$-nice ordering is also a $p$-good ordering.

Definition 18 The blocks of a graph are its maximal 2-connected components. A connected graph is said to be a Gallai tree if each of its blocks are either complete graphs or odd cycles.

Theorem 19 (trouver si c'est Lovasz, Borodin, erdos et al) Let $G$ be a connected graph. Then $G$ is d-choosable if and only if $G$ is not a Gallai tree.

Lemma 20 Let $G=(V, E)$ be a graph and $p: V(G) \rightarrow \mathbb{I N}$. Let $S$ be a set of vertices such that $p(v) \geq d(v)$ for all $v \in S$. If $G[S]$ is not a Gallai tree and $G-S$ is p-choosable then $G$ is p-choosable.

Proof. Let $L$ be a $p$-list-assignment of $G$. Since $G-S$ is $p$-choosable, its admits a $p$ colouring $c$. Let us now extend it to $S$. The list $I(v)=L(v) \backslash\{c(w), w \in N(v) \backslash S\}$ of available colours of a vertex $v \in S$ is of size at least $p^{\prime}(v)=p(v)-|N(v) \backslash S| \geq d_{G[S]}(v)$. Since $G[S]$ is not a Gallai tree, by Theorem $19, G[S]$ is $p^{\prime}$-choosable and thus $I$-colourable. So, $G$ is $L$-colourable.

A 4-regular graph is cycle+triangles if it is the edge union of a Hamiltonian cycle and triangles.

Theorem 21 (Fleishner and Stiebitz [2]) Every cycle + triangles graph is 3 -choosable.

### 3.2 Proof of Lemma 6

Lemma 22 Let $q \geq 4$ and $C_{2 q}=\left(v_{1}, \ldots, v_{2 q}, v_{1}\right)$ be the $2 q$-cycle and $p$ defined by $p\left(v_{i}\right)=4$ if $i$ is odd and $p\left(v_{i}\right)=3$ otherwise. Then $C_{2 q}^{2}$ is p-choosable.

Proof. The set $S$ of vertices $v$ for which $p(v) \geq d_{C_{2 q}^{2}}(v)$ is the set of $v_{i}$ with odd indices. $C_{2 q}^{2}[S]$ is a $q$-cycle and thus is not a Gallai tree if $q \geq 4$. Moreover $C_{2 q}^{2}-S$ is also a $q$-cycle and is 3 -choosable. Hence Lemma 20 gives the result.

Proposition 23 Let $P_{7}=\left(v_{1}, \ldots, v_{7}\right)$ be a path and $p$ the function defined by $p\left(v_{1}\right)=$ $p\left(v_{2}\right)=p\left(v_{6}\right)=p\left(v_{7}\right)=2, p\left(v_{3}\right)=p\left(v_{5}\right)=4$ and $p\left(v_{4}\right)=3$. Then $P_{7}^{2}$ is $p$-choosable.

Proof. Since ( $v_{2}<v_{4}<v_{6}<v_{7}<v_{5}<v_{3}<v_{1}$ ) is $p$-nice, by Lemma 15, we may assume that $L\left(v_{1}\right)=L\left(v_{2}\right)$, and by symmetry of $P_{7}$ and $p$ that $L\left(v_{6}\right)=L\left(v_{7}\right)$.

Since $\left(v_{1}<v_{4}<v_{2}<v_{6}<v_{7}<v_{5}<v_{3}\right)$ is $p$-good, by Lemma 16 , we may assume that $L\left(v_{1}\right) \cap L\left(v_{4}\right)=\emptyset$, and by symmetry $L\left(v_{7}\right) \cap L\left(v_{4}\right)=\emptyset$.

Now one can find $c\left(v_{1}\right) \in L\left(v_{1}\right), c\left(v_{2}\right)$ in $L\left(v_{2}\right) \backslash\left\{c\left(v_{1}\right)\right\}, c\left(v_{6}\right)$ in $L\left(v_{6}\right), c\left(v_{7}\right)$ in $L\left(v_{7}\right) \backslash$ $\left\{c\left(v_{6}\right)\right\}, c\left(v_{3}\right)$ in $L\left(v_{3}\right) \backslash\left\{c\left(v_{1}\right), c\left(v_{2}\right)\right\}$, and $c\left(v_{5}\right)$ in $L\left(v_{5}\right) \backslash\left\{c\left(v_{3}\right), c\left(v_{6}\right), c\left(v_{7}\right)\right\}$. Now since $L\left(v_{1}\right) \cap L\left(v_{4}\right)=\emptyset$ and $L\left(v_{1}\right)=L\left(v_{2}\right), c\left(v_{2}\right) \notin L\left(v_{4}\right)$. Analogously, $c\left(v_{6}\right) \notin L\left(v_{4}\right)$. Hence, $=L\left(v_{4}\right) \backslash\left\{c\left(v_{2}\right), c\left(v_{3}\right), c\left(v_{5}\right), c\left(v_{6}\right)\right\}=L\left(v_{4}\right) \backslash\left\{c\left(v_{3}\right), c\left(v_{5}\right)\right\} \neq \emptyset$. So, one can choose $c\left(v_{4}\right)$ in this set to get an $L$-colouring $c$ of $P_{7}^{2}$.

Lemma 24 For $1 \leq i \leq 17$, let $F_{i}$ be the graphs and $p_{i}$ be the function depicted Figure 3.
a) $F_{1}^{2} \cup\left\{v_{4} v_{5}, v_{5} v_{6}, v_{6} v_{4}\right\}$ is $p_{1}$-choosable.
b) $F_{2}^{2} \cup\left\{v_{1} v_{4}\right\}$ and $F_{2}^{2} \cup\left\{v_{4} v_{7}\right\}$ are $p_{2}$-choosable.
c) $F_{3}^{2} \cup\left\{v_{4} v_{8}\right\}$ is $p_{3}$-choosable.
d) $F_{4}^{2}$ is 6-choosable.
e) $F_{5}^{2} \cup\left\{v_{1} v_{5}\right\}$ is $p_{5}$-choosable.
f) $F_{6}^{2} \cup\left\{v_{1} v_{4}\right\}$ and $F_{6}^{2} \cup\left\{v_{4} v_{7}\right\}$ are $p_{6}$-choosable.
g) $F_{7}^{2} \cup\left\{v_{4} v_{8}\right\}$ is $p_{7}$-choosable.
h) $F_{8}^{2}$ is 6-choosable.
i) $F_{9}^{2}$ is $p_{9}$-choosable.
j) $F_{10}^{2} \cup\left\{v_{9} v_{10}\right\}$ is $p_{10}$-choosable.
k) $F_{11}^{2}$ is $p_{11}$-choosable.
l) $F_{12}^{2} \cup\left\{v_{2} v_{9}\right\}$ and $F_{12}^{2} \cup\left\{v_{6} v_{9}\right\}$ are $p_{12}$-choosable.
m) $F_{13}^{2} \cup\left\{v_{4} v_{8}\right\}$ is $p_{13}$-choosable.
n) $F_{14}^{2} \cup\left\{v_{4} v_{8}, v_{8} v_{9}, v_{9} v_{4}\right\}$ is $p_{14}$-choosable.
o) $F_{15}^{2} \cup\left\{v_{4} v_{8}\right\}$ is $p_{15}$-choosable.
p) $F_{16}^{2}$ is 6-choosable.
q) $F_{17}^{2}$ is $p_{17}$-choosable.

## Proof.

a) In $F_{1}^{2} \cup\left\{v_{4} v_{5}, v_{5} v_{6}, v_{6} v_{4}\right\},\left(v_{6}<v_{5}<v_{4}<v_{3}<v_{1}<v_{2}\right)$ is $p_{1}$-greedy. So by Lemma 14, $F_{1}^{2} \cup\left\{v_{4} v_{5}, v_{5} v_{6}, v_{6} v_{4}\right\}$ is $p_{1}$-choosable.
b) In $F_{2}^{2} \cup\left\{v_{4} v_{7}\right\},\left(v_{2}<v_{4}<v_{7}<v_{6}<v_{5}<v_{3}<v_{1}\right)$ is $p_{2}$-nice and $p_{2}\left(v_{2}\right)>p_{2}\left(v_{1}\right)$. So by Lemma $15, F_{2}^{2} \cup\left\{v_{4} v_{7}\right\}$ is $p_{2}$-choosable.
By symmetry, one shows that $F_{2}^{2} \cup\left\{v_{1} v_{4}\right\}$ is $p_{2}$-choosable.
c) In $F_{3}^{2} \cup\left\{v_{4} v_{8}\right\},\left(v_{2}<v_{8}<v_{4}<v_{7}<v_{6}<v_{5}<v_{3}<v_{1}\right)$ is $p_{3}$-nice and $p_{3}\left(v_{2}\right)>p_{3}\left(v_{1}\right)$. So by Lemma $15, F_{3}^{2} \cup\left\{v_{4} v_{7}\right\}$ is $p_{3}$-choosable.
d) Let $L$ be a 6-list-assignment of $F_{4}^{2}$. $\left(v_{3}<v_{2}<v_{4}<v_{6}<v_{8}<v_{5}<v_{7}<v_{1}\right)$ is 6-nice. Thus, by Lemma 15, we may assume that $L\left(v_{3}\right)=L\left(v_{1}\right)$. Now, $\left(v_{5}<v_{1}<v_{2}<v_{4}<\right.$ $\left.v_{6}<v_{8}<v_{7}<v_{3}\right)$ is 6-nice. Hence $F_{4}^{2}$ is $L$-colourable according to Lemma 16 if $L\left(v_{5}\right) \cap L\left(v_{1}\right) \neq \emptyset$ or Lemma 15 otherwise.
e) In $F_{5}^{2} \cup\left\{v_{1} v_{5}\right\},\left(v_{1}<v_{5}<v_{2}<v_{4}<v_{3}\right)$ is $p_{5}$-greedy. So by Lemma $14, F_{5}^{2} \cup\left\{v_{1} v_{5}\right\}$ is $p_{5}$-choosable.
f) In $F_{6}^{2} \cup\left\{v_{4} v_{7}\right\},\left(v_{2}<v_{4}<v_{7}<v_{6}<v_{5}<v_{3}<v_{1}\right)$ is $p_{6}$-nice and $p_{6}\left(v_{2}\right)>p_{6}\left(v_{1}\right)$. So by Lemma $15, F_{6}^{2} \cup\left\{v_{4} v_{7}\right\}$ is $p_{6}$-choosable.
By symmetry, one shows that $F_{6}^{2} \cup\left\{v_{1} v_{4}\right\}$ is $p_{6}$-choosable.
g) In $F_{7}^{2} \cup\left\{v_{4} v_{8}\right\} .\left(v_{2}<v_{4}<v_{8}<v_{5}<v_{7}<v_{6}<v_{3}<v_{1}\right)$ is $p_{7}$-nice and $p_{7}\left(v_{2}\right)>p_{7}\left(v_{1}\right)$. So by Lemma $15, F_{7}^{2} \cup\left\{v_{4} v_{8}\right\}$ is $p_{7}$-choosable.
h) Let $L$ be a $p_{8}$-list-assignment of $F_{8}^{2},\left(v_{1}<v_{2}<v_{4}<v_{6}<v_{8}<v_{7}<v_{5}<v_{3}\right)$ is $p_{8}$-greedy, so by Lemma 15, we may assume that $L\left(v_{1}\right)=L\left(v_{3}\right)$. Now ( $v_{3}<v_{1}<v_{2}<$ $v_{4}<v_{6}<v_{8}<v_{7}<v_{5}$ ), so by Lemma $16, F_{8}^{2}$ is $L$-colourable.
i) In $F_{9}^{2},\left(v_{4}<v_{2}<v_{8}<v_{1}<v_{3}<v_{5}\right)$ is $p_{9}$-nice and $p_{9}\left(v_{4}\right)>p_{9}\left(v_{5}\right)$. So by Lemma 15 , $F_{9}^{2}$ is $p_{9}$-choosable.

j) Let $L$ be a $p_{10}$-list-assignment of $F_{10}^{2} \cup\left\{v_{9} v_{10}\right\}$. $\left(v_{2}<v_{9}<v_{10}<v_{8}<v_{6}<v_{4}<v_{7}<\right.$ $\left.v_{5}<v_{3}<v_{1}\right)$ is $p_{10}$-nice. Thus, by Lemma 15 , we may assume that $L\left(v_{2}\right) \subset L\left(v_{1}\right)$. Analogously, by symmetry, we may assume that $L\left(v_{2}\right) \subset L\left(v_{3}\right)$ and $L\left(v_{4}\right) \subset L\left(v_{3}\right)$. It follows that $L\left(v_{1}\right) \cap L\left(v_{4}\right) \neq \emptyset$. Because $\left(v_{1}<v_{4}<v_{10}<v_{9}<v_{2}<v_{8}<v_{6}<v_{7}<\right.$ $\left.v_{5}<v_{3}\right)$ is $p_{10}$-good, by Lemma 16, $F_{10}^{2} \cup\left\{v_{9} v_{10}\right\}$ is $L$-colourable.
k) In $F_{11}^{2},\left(v_{6}<v_{5}<v_{7}<v_{9}<v_{8}<v_{4}<v_{3}<v_{2}<v_{1}\right)$ is $p_{11}$-greedy. So by Lemma 14, $F_{11}^{2}$ is $p_{11}$-choosable.
l) Let $L$ be a $p_{12}$-list-assignment of $F_{12}^{2} \cup\left\{v_{2} v_{9}\right\}$. Then $\left(v_{2}<v_{9}<v_{6}<v_{4}<v_{8}<\right.$ $\left.v_{7}<v_{5}<v_{3}<v_{1}\right)$ and $\left(v_{2}<v_{9}<v_{6}<v_{4}<v_{8}<v_{7}<v_{5}<v_{1}<v_{3}\right)$ are $p_{12}$-nice so by Lemma 15 , we may assume that $L\left(v_{2}\right) \subset L\left(v_{3}\right) \cap L\left(v_{1}\right)$. Moreover, $\left(v_{4}<v_{2}<v_{9}<v_{6}<v_{8}<v_{7}<v_{5}<v_{1}<v_{3}\right)$ is $p_{12}$-nice so by Lemma 15 , we may assume that $L\left(v_{4}\right) \subset L\left(v_{3}\right)$. It follows that $L\left(v_{1}\right) \cap L\left(v_{4}\right) \neq \emptyset$. Thus, by Lemma 16 , since $\left(v_{1}<v_{4}<v_{2}<v_{9}<v_{8}<v_{6}<v_{7}<v_{5}<v_{3}\right)$ is $p_{12}$-good, $F_{12}^{2} \cup\left\{v_{2} v_{9}\right\}$ is $L$-colourable.
By symmetry, one shows that $F_{12}^{2} \cup\left\{v_{6} v_{9}\right\}$ is $p_{12}$-choosable.
m) In $F_{13}^{2} \cup\left\{v_{4} v_{8}\right\},\left(v_{2}<v_{8}<v_{4}<v_{6}<v_{7}<v_{5}<v_{3}<v_{1}\right)$ is $p_{13}$-nice and $p_{13}\left(v_{2}\right)>$ $p_{13}\left(v_{1}\right)$. So by Lemma $15, F_{13}^{2} \cup\left\{v_{4} v_{8}\right\}$ is $p_{13}$-colourable.
n) Let $L$ be a $p_{14}$-list-assignment of $F_{14}^{2} \cup\left\{v_{4} v_{8}, v_{8} v_{9}, v_{9} v_{4}\right\}\left(v_{1}<v_{8}<v_{9}<v_{4}<v_{2}<\right.$ $\left.v_{6}<v_{7}<v_{5}<v_{3}\right)$ is $p_{14}$-nice. So by Lemma 15, $L\left(v_{1}\right)=L\left(v_{3}\right)$. Now, $\left(v_{4}<v_{1}<\right.$ $\left.v_{8}<v_{9}<v_{2}<v_{6}<v_{7}<v_{5}<v_{3}\right)$ is $p_{14}$-nice. Hence $F_{14}^{2} \cup\left\{v_{4} v_{8}, v_{8} v_{9}, v_{9} v_{4}\right\}$ is $L$-colourable according to Lemma 16 if $L\left(v_{4}\right) \cap L\left(v_{1}\right) \neq \emptyset$ or Lemma 15 otherwise.
o) In $F_{15}^{2} \cup\left\{v_{4} v_{8}\right\} .\left(v_{6}<v_{8}<v_{4}<v_{2}<v_{1}<v_{3}<v_{5}<v_{7}\right)$ is $p_{15}$-nice and $p_{15}\left(v_{6}\right)>$ $p_{15}\left(v_{7}\right)$. So by Lemma $15, F_{15}^{2} \cup\left\{v_{4} v_{8}\right\}$ is $p_{15}$-choosable.
p) Let $L$ be a 6-list-assignment of $F_{16}^{2} .\left(v_{2}<v_{9}<v_{10}<v_{8}<v_{6}<v_{4}<v_{7}<v_{5}<v_{3}<\right.$ $\left.v_{1}\right)$ is 6 -nice. Thus, by Lemma 15 , we may assume that $L\left(v_{2}\right)=L\left(v_{1}\right)$. Analogously, by symmetry, we may assume that $L\left(v_{2}\right)=L\left(v_{3}\right)=L\left(v_{4}\right)$. It follows that $L\left(v_{1}\right)=L\left(v_{4}\right)$. Because ( $v_{1}<v_{4}<v_{10}<v_{9}<v_{2}<v_{8}<v_{6}<v_{7}<v_{5}<v_{3}$ ) is 6-good, by Lemma 16 , $F_{16}^{2}$ is $L$-colourable.
q) In $F_{17}^{2}$. $\left(v_{9}<v_{8}<v_{2}<v_{6}<v_{4}<v_{5}<v_{3}<v_{7}<v_{1}\right)$ is $p_{17}$-greedy, so by Lemma 14, $F_{17}^{2}$ is $p_{17}$-choosable.

## Proof of Lemma 6.

5)] Suppose for a contradiction that $v_{1}$ and $v_{3}$ are in $Z_{5}$. Let $v_{5}$ (resp. $v_{6}$ ) be the neighbour of $v_{1}$ (resp. $v_{3}$ ) distinct from $v_{2}$ and $v_{4}$. By Lemma 5-2), $v_{5} \neq v_{6} . \quad\left(G[S], p_{S}\right)=$ $\left(F_{1}, p_{1}\right)$ and $G^{2}[S] \subset F_{1}^{2} \cup\left\{v_{4} v_{5}, v_{5} v_{6}, v_{6} v_{4}\right\}$. So Lemma 24 contradicts Lemma 12.

Suppose for a contradiction that, in $K$, a vertex $v_{4}$ of $Y_{1,2,2}$ is adjacent to two vertices of $Y_{1,2,2} v_{2}$ and $v_{6}$ by 2-edges. According to 5$), v_{2} \neq v_{6}$. Let $v_{3}$ and $v_{5}$ be the 2-neighbours of $v_{4}$ common with $v_{2}$ and $v_{6}$ respectively, and $v_{1}$ (resp. $v_{7}$ ) be the neighbour of $v_{2}$ (resp. $v_{6}$ ) not adjacent to $v_{4}$. Set $S=\left\{v_{1}, \ldots, v_{6}, v_{7}\right\}$.

- Assume that $v_{2} v_{4}$ is an edge. For $i \in\{1,4,7\}$, let $w_{i}$ be the neighbour of $v_{i}$ not in $S$. $\left(G[S], p_{S}\right)=\left(F_{2}, p_{2}\right)$ and $G^{2}[S] \subset F_{2}^{2} \cup\left\{v_{1} v_{4}, v_{4} v_{7}, v_{1} v_{7}\right\}$. Thus, by Lemmas 24 and $12, w_{1}=w_{7}=v_{8}$. Let $T=S \cup\left\{v_{8}\right\}$. If $v_{8} \neq w_{4}$, then $\left(G[T], p_{T}\right)=\left(F_{3}, p_{3}\right)$ and $G^{2}[T] \subset F_{3}^{2} \cup\left\{v_{4} v_{8}\right\}$. So Lemma 24 contradicts Lemma 12. If not then $G[T]=G=F_{4}$, so $G$ is 6 -choosable, by Lemma 24 . This is a contradiction.
- Assume that $v_{1}=v_{7}$. Clearly $(G-S)^{2}=G^{2}-S$ because every vertex of $C$ has at most one neighbour in $G-S$. Moreover $C$ has no chord by Lemma $5-2), C^{2}=G^{2}[S]$. Finally $p_{S}\left(v_{i}\right)=4$ if $i$ is even and $p_{S}\left(v_{i}\right)=3$ otherwise. $C^{2}$ is a cycle + triangle graph, thus, by Theorem 21, it is 3 -choosable and so $p_{S}$-choosable. This contradicts Lemma 12.
- Assume that $v_{1} \neq v_{7}$. For $i \in\{1,2,4,6,7\}$, let $w_{i}$ be the neighbour of $v_{i}$ not in $S$. Let $W=\left\{w_{1}, w_{2}, w_{4}, w_{6}, w_{7}\right\}$.

Suppose first that $W \cap S \neq \emptyset$. Since $G$ is simple, $w_{1} \neq v_{2}$ and $w_{7} \neq v_{6}$ and by Lemma 5-3), $w_{1} \neq v_{4}$ and $w_{7} \neq v_{4}$. Moreover, by (5), $w_{1} \neq v_{6}$ and $w_{7} \neq v_{2}$. Then, by symmetry, we only need to consider the cases $w_{2}=v_{4}$ and $w_{2}=v_{6}$.

- Suppose that $w_{2}=v_{4}$. Set $R=\left\{v_{1}, v_{2}, v_{3}, v_{4}, v_{3}\right\}$, then $\left(G[R], p_{R}\right)=\left(F_{2}, p_{2}\right)$ and $G^{2}[R] \subset F_{2}^{2} \cup\left\{v_{1} v_{5}\right\}$. Thus Lemma 24 contradicts Lemma 12 .
- Suppose that $w_{2}=v_{6}$. Then $\left(G[S], p_{S}\right)=\left(F_{3}, p_{3}\right)$. If $w_{1} \neq w_{7}$ then $G^{2}[S] \subset$ $F_{3}^{2} \cup\left\{v_{1} v_{4}\right\}$ or $G^{2}[S] \subset F_{3}^{2} \cup\left\{v_{4} v_{7}\right\}$. So Lemma 24 contradicts Lemma 12.
Hence we may assume that $w_{1}=w_{7}=v_{8}$. Let $T=S \cup\left\{v_{8}\right\}$. If $v_{8} \neq w_{4}$, then $\left(G[T], p_{T}\right)=\left(F_{4}, p_{4}\right)$ and $G^{2}[T] \subset F_{4}^{2} \cup\left\{v_{4} v_{8}\right\}$. So Lemma 24 contradicts Lemma 12. If $v_{8}=w_{4}$ then $G=G[T]=F_{5}$ which, according to Lemma 24, is 6 -choosable, a contradiction.

Hence, we may assume that $W \cap S=\emptyset$.
Note that by Lemma $5-2), w_{1} \neq w_{2}$ and $w_{6} \neq w_{7}$.
Suppose $w_{1}=w_{4}=v_{8}$. Then let $R=\left\{v_{1}, v_{2}, v_{3}, v_{4}, v_{5}, v_{8}\right\}$ and $w_{8}$ the neighbour of $v_{8}$. Then $\left(G[R], p_{R}\right)=\left(F_{6}, p_{6}\right)$. Recall that $w_{2} \neq v_{6}$. So $G^{2}[R]=F_{6}^{2}$. Thus Lemma 24 contradicts Lemma 12.

Therefore, we may assume that $w_{1} \neq w_{4}$ and, by symmetry, $w_{4} \neq w_{7}$.
Suppose $w_{1}=w_{7}$. Let $T=S \cup\left\{v_{8}\right\}$. Then $G[T]$ is the cycle $C_{8}$ and $p_{T}$ is the function $p$ defined in Lemma 22. So by Lemmas 22 and $12, G^{2}[T] \neq C_{8}^{2}$. It follows that either $w_{2}=w_{6}$ or $w_{4}=w_{8}$ with $w_{8}$ be the neighbour of $v_{8}$ not in $S$.

- Suppose $w_{2}=w_{6}=v_{9}$ and $w_{4}=w_{8}=v_{10}$. Set $W=\left\{v_{1}, \ldots v_{10}\right\}$. If $v_{9} v_{10} \notin$ $E(G)$ then $\left(G[W], p_{W}\right)=\left(F_{7}, p_{7}\right)$ and $G^{2}[W] \subset F_{7}^{2} \cup\left\{v_{9} v_{10}\right\} ;$ so Lemma 24 contradicts Lemma 12. If not, $G=G[W]=F_{13}$, so $G^{2}$ is 6 -choosable, according to Lemma 24, a contradiction.
- Suppose $w_{2}=w_{4}=w_{6}=v_{9}$. Setting $U=\left\{v_{1}, \ldots v_{9}\right\}$, we have $G[U]=F_{8}$ and $G^{2}[U]=F_{8}^{2}$. Hence Lemma 24 contradicts Lemma 12 .
By symmetry, we get a contradiction if $w_{2}=w_{6}=w_{8}, w_{2}=w_{4}=w_{8}$ or $w_{4}=w_{6}=w_{8}$.
- Suppose $w_{4}=w_{8}=v_{9}, w_{2} \neq v_{9}, w_{6} \neq v_{9}$ and $w_{2} \neq w_{6}$. Setting $U=\left\{v_{1}, \ldots v_{9}\right\}$, we have $\left(G[U], p_{U}\right)=\left(F_{9}, p_{9}\right)$ and $G^{2}[U] \subset F_{9}^{2} \cup\left\{v_{2} v_{9}\right\}$ or $G^{2}[U] \subset F_{9}^{2} \cup\left\{v_{6} v_{9}\right\}$. Hence Lemma 24 contradicts Lemma 12.
By symmetry, we get a contradiction if $w_{2}=w_{6}=v_{9}, w_{4} \neq v_{9}, w_{8} \neq v_{9}$ and $w_{4} \neq w_{8}$.

Therefore, we may assume that $w_{1} \neq w_{7}$.
Suppose that $w_{2}=w_{6}=v_{8}$. Let $T=S \cup\left\{v_{8}\right\}$. Then $\left(G[T], p_{T}\right)=\left(F_{10}, p_{10}\right)$, and $G^{2}[T] \subset F_{10}^{2} \cup\left\{v_{4} v_{8}\right\}$, since $w_{1}, w_{4}$ and $w_{7}$ are distinct vertices. Hence Lemma 24 contradicts Lemma 12.
Therefore, we may assume that $w_{2} \neq w_{6}$.
Suppose that $w_{1}=w_{6}=v_{8}$ and $w_{2}=w_{7}=v_{9}$. Let $U=S \cup\left\{v_{8}, v_{9}\right\}$. If $v_{8} v_{9} \notin$ $E(G)$ then $\left(G[U], p_{U}\right)=\left(F_{11}, p_{11}\right)$, and $G^{2}[U] \subset F_{11}^{2} \cup\left\{v_{4} v_{8}, v_{8} v_{9}, v_{9} v_{4}\right\}$. If not, then $\left(G[U], p_{U}\right)=\left(F_{14}, p_{14}\right)$, and $G^{2}[U]=F_{14}^{2}$. In both cases, Lemma 24 contradicts Lemma 12.

Therefore, we may assume that $w_{1} \neq w_{6}$ or $w_{2} \neq w_{7}$. By symmetry, we may assume that $w_{2} \neq w_{7}$.
Suppose $w_{1}=w_{6}=v_{8}$. Let $T=S \cup\left\{v_{8}\right\}$ and let $w_{8}$ be the neighbour of $v_{8}$ not in $S$. Then $\left(G[T], p_{T}\right)=\left(F_{12}, p_{12}\right)$ and $G^{2}[T] \subset F_{12}^{2} \cup\left\{v_{4} v_{8}\right\}$. Hence Lemma 24 contradicts Lemma 12.
Therefore, we may assume that $w_{1} \neq w_{6}$.
Hence we have $w_{1} \neq w_{4}, w_{6}, w_{7}, w_{2} \neq w_{6}, w_{7}$ and $w_{4} \neq w_{7}$ then $G[S]^{2}=G^{2}[S]$. Thus Proposition 23 contradicts Lemma 12.

### 3.3 Proof of Lemma 11

Definition 25 For $1 \leq j \leq 4$, let $I_{j}$ and $q_{j}$ be the graphs and function depicted Figure 4
Lemma 26 For $1 \leq j \leq 4, I_{j}^{2}$ is $q_{j}$-choosable.

## Proof.



Figure 4: The graphs $I_{j}$ and functions $q_{j}, 1 \leq j \leq 4$

- Let $L$ be a $q_{1}$-list-assignment of $I_{1}^{2} .\left(v_{4}<v_{3}<v_{1}<v_{2}\right)$ and $\left(v_{1}<v_{3}<v_{4}<v_{2}\right)$ are $q_{1}$-nice, so by Lemma 15 , we may assume that $L\left(v_{1}\right) \cup L\left(v_{4}\right) \subset L\left(v_{2}\right)$. Hence $L\left(v_{1}\right) \cap L\left(v_{4}\right) \neq \emptyset$. But $\left(v_{4}<v_{1}<v_{3}<v_{2}\right)$ is $q_{1}$-good. Thus by Lemma $16, I_{1}^{2}$ is $L$-colourable.
- Let $L$ be a $q_{2}$-list-assignment of $I_{2}^{2}$.

Suppose first that $L\left(v_{3}\right) \not \subset L\left(v_{1}\right) \cup L\left(v_{6}\right)$. Then choose $c\left(v_{3}\right)$ in $L\left(v_{3}\right) \backslash\left(L\left(v_{1}\right) \cup\right.$ $\left.L\left(v_{6}\right)\right)$ and $c\left(v_{4}\right) \in L\left(v_{4}\right) \backslash\left\{c\left(v_{3}\right)\right\}$. Since $I_{1}^{2}$ is $q_{1}$-choosable, one can extend $c$ to $\left\{v_{5}, v_{6}, v_{7}, v_{8}\right\}$. Then one can find $c\left(v_{2}\right) \in L\left(v_{2}\right) \backslash\left\{c\left(v_{3}\right), c\left(v_{4}\right), c\left(v_{5}\right)\right\}$ and $c\left(v_{1}\right) \in$ $L\left(v_{1}\right) \backslash\left\{c\left(v_{2}\right), c\left(v_{3}\right)\right\}=L\left(v_{1}\right) \backslash\left\{c\left(v_{2}\right)\right\}$. So, we may assume that $L\left(v_{3}\right) \subset L\left(v_{1}\right) \cup L\left(v_{6}\right)$, so $L\left(v_{3}\right)=L\left(v_{1}\right) \cup L\left(v_{6}\right)$ and $L\left(v_{1}\right) \cap L\left(v_{6}\right)=\emptyset$.
Now colour $v_{3}$ and $v_{6}$ the same colour $c_{6} \in L\left(v_{6}\right)$. Then proceed greedily according to $\left(v_{4}<v_{8}<v_{7}<v_{5}<v_{2}<v_{1}\right)$. It is possible since $c_{6} \notin L\left(v_{1}\right)$.

- Let $L$ be a $q_{3}$-list-assignment of $I_{3}^{2}$. Assign to $v_{5}$ a colour $c_{5}$ in $L\left(v_{5}\right) \backslash\left(L\left(v_{1}\right) \cup L\left(v_{9}\right)\right)$ and to $v_{6}$ a colour in $L\left(v_{6}\right) \backslash\left(L\left(v_{8}\right) \cup\left\{c_{5}\right\}\right)$. Then colour the remaining vertices greedily according to ( $v_{3}<v_{4}<v_{2}<v_{1}<v_{1}<v_{9}<v_{7}<v_{8}$ ) to get an $L$-colouring of $I_{3}^{2}$.
- Let $L$ be $q_{4}$-list-assignment of $I_{4}^{2}$. Pick $c\left(y_{1}\right)$ in $L\left(y_{1}\right) \backslash L\left(w_{1}\right), c\left(y_{2}\right)$ in $L\left(y_{2}\right) \backslash\left(L\left(w_{2}\right) \cup\right.$ $\left.\left\{c\left(v_{1}\right)\right\}\right), c\left(y_{3}\right)$ in $L\left(y_{3}\right) \backslash\left(L\left(w_{3}\right) \cup\left\{c\left(v_{1}\right), c\left(v_{2}\right)\right\}\right)$ and $c(x)$ in $L(x) \backslash\left\{c\left(v_{1}\right), c\left(v_{2}\right), c\left(v_{3}\right)\right\}$. Since $I_{1}^{2}$ is $q_{1}$-choosable, one can extend $c$ to a colouring of $I_{4}^{2}$.


## Proof of Lemma 6.

3) Suppose that a vertex $v_{3}$ of $Y_{2,2,3}$ and $v_{6}$ of $Y_{1,2,3}$ are adjacent via a 2-edge in $K$. Then the subgraph of $G$ induced by $v_{3}, v_{6}$ and the 2 -vertices of their incident threads is $I_{2}$. Since $G$ has girth at least 13, then $G^{2}\left[I_{2}\right]=I_{2}^{2}$ and $\left(G-V\left(I_{2}\right)\right)^{2}=G^{2}-V\left(I_{2}\right)$, so Lemma 26 contradicts Lemma 12.
4) Suppose that a vertex $v_{5}$ of $Y_{1,3,3}$ and $v_{6}$ of $Y_{1,2,3}$ are adjacent via a 1-edge in $K$. Then the subgraph of $G$ induced by $v_{5}, v_{6}$ and the 2 -vertices of their incident threads is $I_{3}$. Then Lemma 26 contradicts Lemma 12.
5) Suppose that a vertex $x$ of $Y_{2,2,2}$ is adjacent to three vertices $v_{1}, v_{2}$ and $v_{3}$ of $Y_{2,2,3}$ in $K$. Then the subgraph of $G$ induced by $x, v_{1}, v_{2}, v_{3}$ and the 2 -vertices of their incident threads is $I_{4}$. Then Lemma 26 contradicts Lemma 12.
