Résumé

On considère un Système Différentiel Stochastique bilinéaire, dont la solution partant de x est notée $(X(t, x))$; on suppose que son (plus grand) exposant de Lyapounov existe.

On montre que, pour plusieurs schémas de discrétisation $(\bar{X}_p^h(x), p \in \mathbb{N})$, les exposants de Lyapounov associés $\bar{\lambda}^h$ sont bien définis, et on estime en fonction du pas de discrétisation h l'erreur théorique $|\lambda - \bar{\lambda}^h|$.

Puis on présente une application des résultats précédents à un problème d'ingénierie : l'étude de stabilité du mouvement des pales d'hélicoptère avec prise en compte des effets de la turbulence due au vent.

Abstract

We consider a bilinear Stochastic Differential System, whose solution starting from x is denoted by $(X(t, x))$; we suppose that its (upper) Lyapunov exponent λ exists.

We show that, for Markov chains defined by several approximation schemes $(\bar{X}_p^h(x), p \in \mathbb{N})$, the Lyapunov exponents $\bar{\lambda}^h$ are well defined, and we give estimates in terms of the discretization step h of the theoretical error $|\lambda - \bar{\lambda}^h|$.

Then we present an application of these results to an engineering problem : the stability of the motion of helicopter rotor blades in a turbulent wind.

1 INTRODUCTION

Let us consider a bilinear stochastic differential system in \mathbb{R}^d , written in the Stratonovich sense :

$$dX(t) = AX(t)dt + \sum_{i=1}^r B_i X(t) \circ dW_i(t) \quad (1)$$

where $\{W_i(t); 1 \leq i \leq r\}$ are mutually independent standard Wiener processes.

The solution starting at $x \in \mathbb{R}^d$ will be denoted by $(X(t, x))$.

Below we will state some hypotheses ensuring the following property of the process $(X(t))$:

$$\exists \lambda \in \mathbb{R}, \forall x \in \mathbb{R}^d, \lambda = \lim_{t \rightarrow +\infty} \frac{1}{t} \log |X(t, x)|, \text{ a.s.}$$

The constant λ is called the (upper) Lyapunov exponent of the system (1); the system is said to be stable if λ is strictly negative : in that case, $|X(t, x)|$ decreases to 0 exponentially fast.

In the fifth Section, we will discuss extensively on an engineering problem, which has motivated this work : a study of stability for the motion of a helicopter rotor blade in turbulent winds. The mechanical model is a bilinear stochastic differential equation of dimension 4, whose coefficients depend on different parameters such as the velocity of the helicopter or some geometrical characteristics of the blade. The problem is to determine whether the turbulent winds may destabilize the system, for each interesting value of each parameter. In other terms, one is interested in the behaviour of the Lyapunov exponent w.r.t. the physical parameters of the system and the intensity of the noise.

But, except in some very particular cases (as the examples of Baxendale [4]), there exists no explicit formula permitting to get the exact value of λ .

In the presence of a small noise, and when $(X(t))$ is a 2-dimensional process, Auslender & Milshtein [3], Pardoux & Wihstutz [20] have given asymptotic expansions of λ in powers of the intensity of the noise.

To treat the general case, we propose to discretize in time the system (1), in order to get an approximate process which can easily be simulated on a

computer, denoted by $(\bar{X}_t^h(x))$ (h being the discretization step and x the initial value), and to numerically compute for some large T :

$$\frac{1}{T} \log |\bar{X}_T^h(x)|$$

Pardoux & Pignol [19] have proposed a discretization scheme, and shown the convergence towards λ of the almost sure limit :

$$\lim_{p \rightarrow +\infty} \frac{1}{ph} \log |\bar{X}_{ph}^h(x)|$$

But the convergence rate was not estimated (under our hypotheses, our results below show that this method is of order $O(h)$).

Here we propose discretization methods such that :

$$\exists \bar{\lambda}^h \in \mathbb{R} \ , \ \forall x \in \mathbb{R}^d \ : \ \bar{\lambda}^h = \lim_{p \rightarrow +\infty} \frac{1}{ph} \log |\bar{X}_{ph}^h(x)| \ , \ a.s. \quad (2)$$

and, moreover :

$$|\lambda - \bar{\lambda}^h| = O(h) \ \text{or} \ O(h^2)$$

The organization of the paper is as follows : in Section 2, we recall a fundamental Theorem on the existence of λ ; in Section 3, we present two discretization methods ; in Section 4, we state our main result, which concerns the convergence rate of these two schemes ; in Section 5, we present the engineering problem of the helicopter rotor blades, the application of the previous results to solve that problem, and we discuss the obtained numerical results ; in Section 6, we introduce a class of second-order schemes.

2 LYAPUNOV EXPONENTS

The purpose of this Section is to introduce the material necessary for the sequel, essentially 2 Theorems concerning the Lyapunov exponents of products of random matrices and of stochastic dynamical systems (we do not present them in their most general versions).

The theory of products of random matrices is presented in Bougerol & Lacroix [6] or Ledrappier [13], e.g.

The main aspects of the theory of Lyapunov exponents of stochastic dynamical systems are developed in the contributions to the Workshop held in Bremen (1984): in particular, those of Arnold, Kliemann and Oeljeklaus [1], and Arnold, Oeljeklaus and Pardoux [2], which will be often referred to. A review of the theory and of recent results can also be found in Pardoux & Talay [22].

Let $S^{d-1} = \{x \in \mathbb{R}^d ; |x| = 1\}$ be the unit sphere of \mathbb{R}^d , and P^{d-1} be the projective space of \mathbb{R}^d , i.e. the quotient of S^{d-1} with respect to the relation : $u \sim v$ iff $u = -v$.

Let $Gl(\mathbb{R}^d)$ be the set of invertible real $d \times d$ matrices. A given subset S of $Gl(\mathbb{R}^d)$ is called *irreducible* if there does not exist a proper linear subspace of \mathbb{R}^d , V , such that :

$$\forall M \in S, M(V) = V$$

Theorem 2.1 (Furstenberg) *Let (M_n) be a sequence of independent random matrices in $Gl(\mathbb{R}^d)$ with common distribution ν , such that :*

- (i) $E \log^+ |M_1| < +\infty$ and $E \log^+ |M_1^{-1}| < +\infty$
- (ii) *the smallest sub-group of $Gl(\mathbb{R}^d)$ containing the support of ν is irreducible.*

Then there exists a real number γ such that, for any x in $\mathbb{R}^d - \{0\}$:

$$\gamma = \lim_{n \rightarrow +\infty} \frac{1}{n} \log |M_n \dots M_1 x|, \text{ a.s.}$$

and for any ν -invariant distribution μ on P^{d-1} :

$$\gamma = \int \int \log \frac{|Mx|}{|x|} d\nu(M) d\mu(\bar{x})$$

(where \bar{x} is the class of x in P^{d-1}).

For the continuous time case, we will use a result concerning a less general situation.

Let $s(t)$ be the process on P^{d-1} defined as the equivalence class of $\frac{X(t)}{|X(t)|}$.

The process $s(t)$ is the solution of the following Stratonovich stochastic differential equation, describing a diffusion process in P^{d-1} :

$$ds(t) = h(A, s(t))dt + \sum_{j=1}^r h(B_j, s(t)) \circ dW_j(t) \quad (3)$$

where :

$$h(C, s) := Cs - (Cs, s)s$$

Let us introduce $\Lambda = L.A.\{h(A, \cdot), h(B_1, \cdot), \dots, h(B_k, \cdot)\}$, i.e. the smallest vector space of differential operators containing the operators

$$\sum_i h^i(A, \cdot)\partial_i \quad , \quad \sum_i h^i(B_j, \cdot)\partial_i \quad (j = 1, \dots, r)$$

and closed under the brackett operation $[P_1, P_2] = P_1 \circ P_2 - P_2 \circ P_1$.

For s in P^{d-1} , the space $\Lambda(s)$ will be the space obtained by considering all the elements of Λ with all the coefficients of the operators frozen at their value in s .

In Arnold, Oeljeklaus and Pardoux [2] is proved the following Theorem (see also Bougerol & Lacroix [6]) :

Theorem 2.2 *Let us suppose :*

$$(H) \dim \Lambda(s) = d - 1 \quad , \quad \forall s \in P^{d-1}$$

Then the process $(s(t))$ on P^{d-1} has a unique invariant probability measure μ , and :

(i) *there exists a real number λ such that, for any x in $\mathbb{R}^d - \{0\}$:*

$$\lambda = \lim_{t \rightarrow +\infty} \frac{1}{t} \log |X(t, x)| \quad , \quad a.s.$$

(ii) *moreover, λ satisfies :*

$$\lambda = \int_{P^{d-1}} Q(s) d\mu(s)$$

where

$$Q(s) := (As, s) + \frac{1}{2} \sum_{i=1}^r [(B_i^2 s, s) + |B_i s|^2 - 2(B_i s, s)^2] \quad (4)$$

3 DISCRETIZATION SCHEMES

The rates of convergence of several discretization schemes have already been established, according to various criteria of convergence, including quadratic mean approximation (Clark and Cameron [7], Milshtein [14], Platen [24], Rumelin [25]), pathwise approximation (Talay [26]), approximation of expectations of the solution (Milshtein [15], Milshtein [16], Talay [27], Talay [28]), asymptotical efficiency for the minimization of the normalized quadratic mean error (Clark [8], Newton [17]), and approximation of the invariant probability measure in the ergodic case (Talay [29]).

A review of the main results concerning the first three points can be found in Pardoux & Talay [21].

In this Section, we will consider 2 particular schemes, applied to the bilinear system (1). In the Appendix Section (6), we will explain why these schemes have been chosen, and we will study a larger family of schemes.

3.1 Notations and definitions

- I will be the $d \times d$ identity matrix.
- \tilde{A} will be the matrix $A + \frac{1}{2} \sum_{i=1}^r B_i^2$
- for any matrix σ , σ_j will denote the j^{th} column of σ ; if $\sigma(x_1, \dots, x_d)$ is a matrix-valued application, $\partial \sigma_j$ denotes the matrix-valued application whose element of the i^{th} line and k^{th} row is $\partial_k \sigma_j^i$.

The discretization schemes below will depend on 3 families of random variables : (U_{p+1}^j) , (Z_{p+1}^{kj}) , and (S_{p+1}^{kj}) . The hypotheses concerning the family (U_{p+1}^j) will be stated later on. Moreover, in all the sequel :

the sequence

$$(U_{p+1}^j, Z_{p+1}^{kj}, j, k = 1, \dots, r, p \in \mathbb{N})$$

will be a family of independent random variables ; the (Z_{p+1}^{kj}) are i.i.d., their common law being defined by :

$$P(Z_p^{kj} = \frac{1}{2}) = P(Z_p^{kj} = -\frac{1}{2}) = \frac{1}{2} \quad (5)$$

the family (S_p^{kj}) is defined by :

$$\begin{aligned} S_{p+1}^{kj} &= \frac{1}{2} U_{p+1}^k U_{p+1}^j + Z_{p+1}^{kj} , & k < j \\ S_{p+1}^{kj} &= \frac{1}{2} U_{p+1}^k U_{p+1}^j - Z_{p+1}^{jk} , & k > j \\ S_{p+1}^{jj} &= \frac{1}{2} [(U_{p+1}^j)^2 - 1] \end{aligned}$$

3.2 Two discretization schemes

Let us consider the two schemes defined by :

$$\bar{X}_{p+1}^h = M_{p+1}^h \bar{X}_p^h$$

with

$$M_{p+1}^h = I + \sum_{j=1}^r B_j U_{p+1}^j \sqrt{h} + Ah + \frac{1}{2} \sum_{j=1}^r B_j^2 (U_{p+1}^j)^2 h + \sum_{\substack{j,k=1 \\ j \neq k}}^r B_j B_k S_{p+1}^{kj} h \quad (6)$$

or

$$\begin{aligned} M_{p+1}^h &= I + \sum_{j=1}^r B_j U_{p+1}^j \sqrt{h} + Ah + \frac{1}{2} \sum_{j=1}^r B_j^2 (U_{p+1}^j)^2 h + \sum_{\substack{j,k=1 \\ j \neq k}}^r B_j B_k S_{p+1}^{kj} h \\ &\quad + \frac{1}{2} \sum_{j=1}^r (\bar{A} B_j + B_j \bar{A}) U_{p+1}^j h^{\frac{3}{2}} + \frac{1}{2} \bar{A}^2 h^2 \end{aligned} \quad (7)$$

These 2 schemes will be tested numerically in Section (5.3). The first one will be called the Milshtein scheme.

Except in the Appendix Section, $(\bar{X}_p^h(x))$ will denote the Markov chain defined by one of these schemes, with initial value x .

3.3 Example : the one-dimensional case

Let us consider the elementary case $d = r = 1$.

The system is written again under the form (with a and b scalar constants) :

$$dX(t) = aX(t)dt + bX(t) \circ dW(t)$$

The solution is $X(t) = X(0) \exp(at + bW(t))$, thus $\lambda = a$.

With the particular choice $\sqrt{h}U_{p+1}^j = \Delta_{p+1}^h W$, the Milstein scheme becomes :

$$\bar{X}_{p+1}^h = (1 + b\Delta_{p+1}^h W + ah + \frac{1}{2}b^2(\Delta_{p+1}^h W)^2)\bar{X}_p^h$$

The strong law of large numbers implies the existence of $\bar{\lambda}^h$ (defined as in (2)). Moreover, one can easily check that for any non zero initial condition :

$$\exists C \in \mathbb{R} , \frac{1}{p^2 h^2} E(\log |\bar{X}_p^h(x)|)^2 < C$$

so that the sequence $(\frac{1}{p} \log |\bar{X}_p^h(x)|)$ is uniformly integrable, and therefore $\bar{\lambda}^h$ satisfies :

$$\bar{\lambda}^h = \lim_{p \rightarrow +\infty} \frac{1}{ph} E \log |\bar{X}_p^h(x)| , \quad \forall x \in \mathbb{R} - \{0\}$$

But, for h small enough :

$$\begin{aligned} E \log |\bar{X}_p^h(x)| - \log |x| &= p E \log |1 + b\Delta_1^h + ah + \frac{1}{2}b^2(\Delta_1^h)^2| \\ &= \frac{p}{\sqrt{2\pi h}} \int_{\mathbb{R}} \log |1 + by + ah + \frac{1}{2}b^2 y^2| \exp(-\frac{y^2}{2h}) dy \\ &= \frac{p}{\sqrt{2\pi}} \int_0^{+\infty} \log(1 - by\sqrt{h} + ah + \frac{1}{2}b^2 y^2 h) \exp(-\frac{y^2}{2}) dy \\ &\quad + \frac{p}{\sqrt{2\pi}} \int_0^{+\infty} \log(1 + by\sqrt{h} + ah + \frac{1}{2}b^2 y^2 h) \exp(-\frac{y^2}{2}) dy \\ &= \frac{p}{\sqrt{2\pi}} \int_0^{+\infty} \log(1 + 2ah + (a + \frac{1}{2}b^2 y^2)^2 h^2) \exp(-\frac{y^2}{2}) dy \\ &= pah + pO(h^2) \end{aligned}$$

Therefore :

$$\bar{\lambda}^h = a + O(h) = \lambda + O(h)$$

An analogous computation for the scheme (7) would lead to

$$\bar{\lambda}^h = a + O(h^2) = \lambda + O(h^2)$$

4 THEORETICAL RESULTS

In this Section, our aim is to prove that the Milstein scheme (6) is of first order for the approximation of the Lyapunov exponents, whereas the scheme (7) is of second-order.

4.1 Hypotheses

Hypothesis (H0)

The system (3) can be viewed as describing a diffusion on S^{d-1} . We will suppose :

(H0) *the infinitesimal generator \mathcal{L} of the process $(s(t))$ on S^{d-1} is uniformly elliptic, i.e there exists a strictly positive constant α such that, for any x in S^{d-1} and any vector ξ in the tangent space $T_{S^{d-1}}(x)$:*

$$\sum_{i=1}^r (h(B_i, x), \xi)^2 \geq \alpha |\xi|^2$$

This condition is more restrictive than (H). Nevertheless, let us show a very simple example of situation where (H0) is fulfilled : $r = 1$ and

$$B = \begin{bmatrix} 0 & -1 \\ 1 & 0 \end{bmatrix}$$

Hypothesis (HU)

For our proofs, we need a technical hypothesis on the random variables U_{p+1}^j 's involved by the discretization schemes, which is not limitative from a practical point of view ; (ii) was unnecessary for the theoretical results concerning the approximation of the law or of the invariant law of diffusion processes (cf the Appendix Section (6)).

(HU) (i) *the (U_{p+1}^j) 's are i.i.d., and the following conditions on the moments are fulfilled :*

$$E[U_{p+1}^j] = E[U_{p+1}^j]^3 = E[U_{p+1}^j]^5 = 0$$

$$\begin{aligned}
E[U_{p+1}^j]^2 &= 1 \\
E[U_{p+1}^j]^4 &= 3 \\
E[U_{p+1}^j]^n &< +\infty, \quad \forall n > 5 \quad (8)
\end{aligned}$$

- (ii) *the common law of the (U_{p+1}^j) 's has a continuous density w.r.t. the Lebesgue measure ; the support of this density contains an open interval including 0 and is compact.*

4.2 Existence of the Lyapunov exponent

Let us begin by showing the existence of the upper Lyapunov exponent for the Markov chains defined by the discretization schemes.

Proposition 4.1 *Let us suppose that the system (3) satisfies (H0).*

Let $(\bar{X}_p^h, p \in \mathbb{N})$ be defined by the Milshstein scheme (6) or the scheme (7).

Then, under (HU) :

- (i) *for any h small enough, there exists a real number $\bar{\lambda}^h$ satisfying :*

$$\forall x \in \mathbb{R}^d - \{0\} : \bar{\lambda}^h = \lim_{p \rightarrow +\infty} \frac{1}{ph} \log |\bar{X}_p^h(x)|, \text{ a.s.}$$

- (ii) *moreover :*

$$\forall x \in \mathbb{R}^d - \{0\} : \bar{\lambda}^h = \lim_{p \rightarrow +\infty} \frac{1}{ph} E \log |\bar{X}_p^h(x)|$$

Proof of Proposition (4.1)

Let us prove (i).

Our aim is to apply the Furstenberg Theorem (2.1).

Let us suppose the existence of a step-size h such that the smallest semi-group of $Gl(\mathbb{R}^d)$ containing the support of the law of M_1^h is not irreducible.

Then, there would exist a proper linear subspace of \mathbb{R}^d , V^h , such that ;

$$M_1^h(V^h) = V^h, \text{ a.s.}$$

Let x any vector of V^h .

Then, for all j , $E[U_1^j M_1^h x]$ and $E[M_1^h x]$ would belong to V^h , therefore we would have $B_j(V^h) \subset V^h$ and $A(V^h) \subset V^h$.

In that case, the system (3) with an initial condition x belonging to V^h can be viewed as a system on V^h , and for any time t , $X(t, x)$ would belong to V^h .

This assertion cannot be true even under the Hypothesis (H), weaker than (H0) (see the Section 1 of Arnold, Oeljeklaus & Pardoux [2] : under (H), the semi-group of $(s(t))$ leaves no sub-manifold of dimension less than $d - 1$ in P^{d-1} invariant).

Finally, all the hypotheses of the Theorem (2.1) are fulfilled, and (i) is proved for the Milshtein scheme.

Now, let us consider the scheme (7).

Let us suppose that, for all step-size h_0 , there exists $h < h_0$ such that the smallest semi-group of $Gl(\mathbb{R}^d)$ containing the support of the law of M_1^h is not irreducible, and let us prove that, in that case, there would exist a proper linear sub-space V such that :

$$A(V) \subset V \quad \text{and} \quad B_j(V) \subset V \quad , \quad (j = 1, \dots, r) \quad (9)$$

(as mentioned, this property contradicts our hypotheses).

Thus, for any integer n , let us choose $h_n < \frac{1}{n}$ and V^n a proper linear sub-space satisfying :

$$M_1^{h_n}(V^n) = V^n \quad , \quad a.s.$$

Let x any vector of V^n .

Then, for all j , $E[(U_1^j)^2 M_1^{h_n} x]$, $E[(U_1^j) M_1^{h_n} x]$ and $E[M_1^{h_n} x]$ would belong to V^n , therefore we would have :

$$\begin{aligned} B_j^2(V_n) &\subset V_n \\ (A + \frac{1}{2} \tilde{A}^2 h_n)(V_n) &\subset V_n \\ (B_j + \frac{1}{2} (\tilde{A} B_j + B_j \tilde{A}) h_n)(V_n) &\subset V_n \end{aligned} \quad (10)$$

Let us define :

$$l = \liminf_n \dim(V_n)$$

and (m_n) the sub-sequence of indices such that V_{m_n} is l -dimensional.

For each V_{m_n} , we choose a basis of unit-normed and orthogonal vectors $(e_{m_n}^k, k = 1, \dots, l)$.

We can choose a new subsequence (again denoted (m_n)) such that $((e_{m_n}^k, k = 1, \dots, l), n \in \mathbb{N})$ converges for the strong topology on \mathbb{R}^l ; let $(u^k, k = 1, \dots, l)$ be the limit.

Let us fix k in $\{1, \dots, l\}$; we may write (as a consequence of (10)) :

$$(A + \frac{1}{2}\bar{A}^2 h_{m_n})e_{m_n}^k = \sum_{j=1}^l \alpha_{m_n}^j(k) e_{m_n}^j$$

Now, for each $j = 1, \dots, l$, the previous equality implies :

$$((A + \frac{1}{2}\bar{A}^2 h_{m_n})e_{m_n}^k, e_{m_n}^j) = \alpha_{m_n}^j(k)$$

so that the sequence $(\alpha_{m_n}^j(k), n \in \mathbb{N})$ converges to (Au^k, u^j) , and therefore :

$$Au^k = \sum_{j=1}^l (Au^k, u^j) u^j$$

V being the sub-space generated by $(u^k, k = 1, \dots, l)$, we have just proved (9) for A ; but similar arguments and (10) permit to obtain the whole result.

To prove (ii), it just remains to check that the sequence $(\frac{1}{p^h} \log |\bar{X}_p^h(x)|, p \in \mathbb{N})$ is uniformly integrable.

Actually, using the inequality $|a_1 + \dots + a_p|^2 \leq p(a_1^2 + \dots + a_p^2)$:

$$\begin{aligned} \frac{1}{p^2 h^2} E(\log |\bar{X}_p^h(x)|)^2 &\leq \frac{1}{p^2 h^2} E(\log \prod_{j=1}^p |M_j^h| + \log |x|)^2 \\ &\leq \frac{2}{h^2} E(\log |M_1^h|)^2 + \frac{2}{p^2 h^2} (\log |x|)^2 \end{aligned}$$

That ends the proof. \square

4.3 Convergence Rates

Let us give estimates for $|\lambda - \bar{\lambda}^h|$.

Theorem 4.2 *Let us suppose that the system (3) satisfies the hypothesis (H0).*

Let $(\bar{X}_p^h, p \in \mathbb{N})$ be defined by the Milshstein scheme (6) or the scheme (7), and let us suppose (HU).

Then, if λ is the upper Lyapunov exponent of (1) :

- (i) *for (\bar{X}_p^h) defined by the Milshstein scheme, $|\lambda - \bar{\lambda}^h| = O(h)$;*
- (ii) *for (\bar{X}_p^h) defined by the scheme (7), $|\lambda - \bar{\lambda}^h| = O(h^2)$.*

4.3.1 Remark

Under (HU), the process (\bar{s}_p^h) defined on S^{d-1} by :

$$\bar{s}_p^h = \frac{\bar{X}_p^h}{|\bar{X}_p^h|}$$

is ergodic ; let $\bar{\mu}^h$ be its unique invariant probability measure ; if the function \bar{Q}^h is defined by :

$$\bar{Q}^h(s) = \frac{1}{h} E \log |\bar{X}_1^h(s)|$$

we may write (cf the Furstenberg Theorem (2.1)) :

$$\bar{\lambda}^h = \int_{S^{d-1}} \bar{Q}^h(s) d\bar{\mu}^h(s)$$

so that :

$$\lambda - \bar{\lambda}^h = \int_{S^{d-1}} Q(s)(d\mu(s) - d\bar{\mu}^h(s)) + \int_{S^{d-1}} (Q(s) - \bar{Q}^h(s))d\bar{\mu}^h(s)$$

We will see below that, for any smooth function on S^{d-1} , the scheme (7) satisfies :

$$\int_{S^{d-1}} f(s)(d\mu(s) - d\bar{\mu}^h(s)) = O(h^2)$$

But :

$$Q(s) - \bar{Q}^h(s) = O(h)$$

Therefore, more accurate estimations are needed. In fact, the result going to be proved below shows :

$$\int_{S^{d-1}} (Q(s) - \bar{Q}^h(s)) d\mu(s) = O(h^2)$$

4.3.2 Two Lemmas

Let $n \in \mathbb{N}^*$ and $x \in S^{d-1}$ be fixed. The antipodal point of x is denoted by x^* .

Let U_x the set of points of S^{d-1} whose geodesic distance from x is less than $\frac{2}{3}L$, where L is the maximal geodesic distance on S^{d-1} .

Let $y \in U_x \rightarrow \phi_x(y)$ the stereographic projection of pole x^* .

Lemma 4.3 *Let us suppose that the hypothesis (H0) is satisfied.*

Let f be a real C^∞ function on S^{d-1} , and let us define the function $u(t, y)$ on $\mathbb{R}_+ \times S^{d-1}$ by :

$$u(t, y) = Ef(s(t, y))$$

Let μ be the unique invariant probability measure of the process $(s(t))$.

Then there exists strictly positive constants Γ and γ such that :

$$\forall x \in S^{d-1} \quad : \quad |u(t, x) - \int_{S^{d-1}} f(s) d\mu(s)| \leq \Gamma \exp(-\gamma t) \quad (11)$$

and, for any multi-index I , there exists strictly positive constants Γ_I and γ_I such that, for any x in S^{d-1} , any θ in $\phi_x(U_x)$, the spatial derivative $\partial_I u(t, \phi_x^{-1}(\theta))$ satisfies :

$$|\partial_I u(t, \phi_x^{-1}(\theta))| \leq \Gamma_I \exp(-\gamma_I t) \quad (12)$$

Proof of Lemma (4.3)

In Talay [29], a result similar to (12) was established for a diffusion process in the whole space, under some suitable conditions on the coefficients of the system ; here, instead of these conditions, we will use the fact that S^{d-1} is a compact manifold.

We begin by proving (11). The condition (H0) implies the existence of a continuous and strictly positive density for the transition probability of the process $(s(t))$; therefore, since S^{d-1} is compact, $(s(t))$ satisfies the so-called Doeblin condition : there exists $\delta > 0$, $\varepsilon > 0$, $t > 0$, such that, for all open set E of S^{d-1} with Lebesgue measure less than δ : $P(t, y, E) \leq 1 - \varepsilon$, uniformly in y . Consequently, the inequality (11) is satisfied (see Doob [9], p.193, e.g.).

Now, let us prove the second part of the Lemma.

Let us introduce the differential operators on S^{d-1} defined by :

$$\mathcal{L}_j = \sum_{i=1}^d h^i(B_j, \cdot) \partial_i$$

and let \mathcal{L} be the infinitesimal generator of the process $(s(t))$ solution of (3) on S^{d-1} .

It is well known that

$$\begin{aligned} \frac{d}{dt} u(t, y) &= \mathcal{L}u(t, y) \\ u(0, y) &= f(y) \end{aligned} \tag{13}$$

so that we deduce :

$$\frac{d}{dt} |u(t, y)|^2 - \mathcal{L}|u(t, y)|^2 = - \sum_{k=1}^r (\mathcal{L}_k u(t, y))^2$$

We multiply the previous equality by $e^{\delta_0 t}$, we integrate with respect to μ , and then we integrate from 0 to T (T being an arbitrarily large time). Using $\mathcal{L}^* \mu = 0$, we deduce that, for any $0 < \delta_0 < \gamma$:

$$\sum_{k=1}^r \int_0^{+\infty} e^{\delta_0 t} \int_{S^{d-1}} |\mathcal{L}_k u(t, y)|^2 d\mu dt < +\infty$$

(a similar computation is performed in Talay [29] (Section 6.1.2)).

One may also check that there exists strictly positive constants C_1 and C_2 such that :

$$\begin{aligned} \frac{d}{dt} \left(\sum_{k=1}^r |\mathcal{L}_k u(t, y)|^2 \right) - \mathcal{L} \left(\sum_{k=1}^r |\mathcal{L}_k u(t, y)|^2 \right) &\leq -C_1 \sum_{k,l=1}^r |\mathcal{L}_k \mathcal{L}_l u(t, y)|^2 \\ &+ C_2 \sum_{k=1}^r |\mathcal{L}_k u(t, y)|^2 \end{aligned}$$

Proceeding as just above, we obtain for any strictly positive $\delta_1 < \delta_0$:

$$\sum_{k=1}^r \int_{S^{d-1}} |\mathcal{L}_k u(t, y)|^2 d\mu \leq C e^{-\delta_1 t}$$

Let $d\tau$ be the Riemannian measure on S^{d-1} induced by the tensor field $(a_{ij})^{-1}$, where a is the matrix $\sigma\sigma^*$, with $\sigma(s) = \sum_{j=1}^r h(B_j, s)$.

The hypothesis (H0) implies that μ , the invariant probability measure of the process $(s(t))$, has a smooth density $p(\cdot)$ with respect to $d\tau$, which solves $\mathcal{L}^* p = 0$, and is strictly positive (cf Ikeda & Watanabe [10]), therefore we can bound it from below on S^{d-1} by a strictly positive constant.

From this remark, we deduce from the previous inequality the existence of strictly positive constants C, α , independent on x , such that :

$$\int_{\phi_x(U_x)} |\nabla u(t, \phi_x^{-1}(\theta))|^2 d\theta \leq C e^{-\alpha t}$$

By the same procedure, one may show that, for any sequence $J = (k_1, \dots, k_q)$ of integers in $1, \dots, r$, there exists strictly positive constants C_J and α_J such that :

$$\int_{S^{d-1}} |\mathcal{L}_{k_1} \dots \mathcal{L}_{k_q} u(t, y)|^2 d\mu \leq C_J \exp(-\alpha_J t) \quad (14)$$

Let us remark the existence of a constant C_n , independent on x , such that (\tilde{b} and $\tilde{\sigma}$ being the coefficients of \mathcal{L} in the local coordinates θ) :

$$\forall \theta \in \phi_x(U_x) : \begin{aligned} |\tilde{b}(\theta)| &\leq C_n \\ |\tilde{\sigma}_{ij}(\theta)| &\leq C_n \end{aligned}$$

and for all multi-index I of length less than n :

$$\forall \theta \in \phi_x(U_x) : \begin{aligned} |\partial_I \tilde{b}(\theta)| &\leq C_n \\ |\partial_I \tilde{\sigma}_{ij}(\theta)| &\leq C_n \end{aligned}$$

We deduce that for any multi-index J (referring to derivatives w.r.t. the coordinates $\theta_1, \dots, \theta_{d-1}$), there exists strictly positive constants C_J and α_J , independent on x , such that :

$$\int_{\phi_x(U_x)} |\partial_J u(t, \phi_x^{-1}(\theta))|^2 d\theta \leq C_J \exp(-\alpha_J t)$$

We conclude by applying the Sobolev imbedding Theorem. \square

Lemma 4.4 *Let us suppose that the hypothesis (H0) is satisfied, and let μ be the unique invariant probability measure of $(s(t))$.*

Let us define the Markov chain (\bar{s}_p^h) on S^{d-1} by :

$$\bar{s}_p^h = \frac{\bar{X}_p^h}{|\bar{X}_p^h|}$$

where (\bar{X}_p^h) is defined by the Milstein scheme (6) (resp. the scheme (7)), under the Condition (HU).

Then, for any x in $\mathbb{R}^d - \{0\}$, for any smooth function $f : S^{d-1} \rightarrow \mathbb{R}$:

$$\left| \int_{S^{d-1}} f(\theta) d\mu(\theta) - \lim_{N \rightarrow +\infty} \frac{1}{N} \sum_{p=1}^N f\left(\frac{\bar{s}_p^h(x)}{|x|}\right) \right| = O(h) \quad , \quad a.s. \quad (resp. \quad O(h^2))$$

Proof of Lemma (4.4)

We will follow Talay [29] (Section 7.2), and only consider the scheme (7), the other case being simpler.

First, we define the symbol $\stackrel{E}{=}$: we will write $X \stackrel{E}{=} Y$ instead of $E(X) = E(Y)$.

We will also write \tilde{x} for $\frac{x}{|x|}$.

Under (HU) , for any h small enough, almost surely $\bar{s}_{p+1}^h(\bar{x})$ takes its value in $U_{\bar{s}_p^h(\bar{x})}$.

With computations analogous to those of Talay [28], and performing a Taylor expansion up to order 6 of the function $\theta \rightarrow u(t, \phi_{\bar{s}_p^h(\bar{x})}^{-1}(\theta))$, one may check :

$$u(jh, \bar{s}_{p+1}^h(\bar{x})) \stackrel{E}{=} u(jh, \bar{s}_p^h(\bar{x})) + \mathcal{L}u(jh, \bar{s}_p^h(\bar{x}))h + \frac{1}{2}\mathcal{L}^2u(jh, \bar{s}_p^h(\bar{x}))h^2 + r_{j,p+1}^h h^3$$

with the remainder term $r_{j,p+1}^h$ expressed as a sum of terms, each one being of the form :

$$\text{Constant} \times E \left[\psi_I(\gamma) \partial_I u(jh, \phi_{\bar{s}_p^h(\bar{x})}^{-1}(\delta)) \right]$$

where :

- ψ_I is a continuous function of the coordinates $\theta_1, \dots, \theta_{d-1}$, then is bounded in $\phi_{\bar{s}_p^h(\bar{x})}(U_{\bar{s}_p^h(\bar{x})})$,
- δ and γ are in $\phi_{\bar{s}_p^h(\bar{x})}(U_{\bar{s}_p^h(\bar{x})})$.

Thus, using (12), one can check that the above remainder term satisfies for some strictly positive constants C_0, C and γ :

$$\exists \gamma > 0, \quad \sum_{j=0}^{+\infty} |r_{j,p+1}^h| \leq \frac{C_0}{1 - e^{-\gamma h}} \leq \frac{C}{h}$$

Now we use the equation (13) in order to write :

$$u((j+1)h, \bar{s}_p^h(\bar{x})) \stackrel{E}{=} u(jh, \bar{s}_p^h(\bar{x})) + \mathcal{L}u(jh, \bar{s}_p^h(\bar{x}))h + \frac{1}{2}\mathcal{L}^2u(jh, \bar{s}_p^h(\bar{x}))h^2 + \tilde{r}_{j,p+1}^h h^3$$

with a remainder term $\tilde{r}_{j,p+1}^h$ which can be expressed in the same manner as $r_{j,p+1}^h$.

Therefore, if we define $R_{j,p+1}^h$ by

$$R_{j,p+1}^h = r_{j,p+1}^h - \tilde{r}_{j,p+1}^h$$

$R_{j,p+1}^h$ satisfies for some positive constant C_1 :

$$\sum_{j=0}^{+\infty} |R_{j,p+1}^h| \leq \frac{C_1}{h} \tag{15}$$

and moreover :

$$u(jh, \bar{s}_{p+1}^h(\bar{x})) \stackrel{E}{=} u((j+1)h, \bar{s}_p^h(\bar{x})) + R_{j,p+1}^h h^3 \quad (16)$$

Remarking :

$$\frac{1}{N} \sum_{p=1}^N f(\bar{s}_p^h(\bar{x})) = \frac{1}{N} \sum_{p=1}^N u(0, \bar{s}_p^h(\bar{x}))$$

with successive uses of (16) one obtains :

$$\frac{1}{N} \sum_{p=1}^N f(\bar{s}_p^h(\bar{x})) \stackrel{E}{=} \frac{1}{N} \sum_{p=1}^N u(ph, \bar{x}) + \frac{1}{N} \sum_{p=1}^N \sum_{j=0}^{p-1} R_{j,p}^h h^3$$

But :

- under the hypothesis (H0), the process $(s(t))$ is ergodic and $u(t, \bar{x})$ satisfies

$$u(t, \bar{x}) = Ef(s(t, \bar{x}))$$

thus :

$$\lim_{N \rightarrow \infty} \frac{1}{N} \sum_{p=1}^N u(ph, \bar{x}) = \int_{S^{d-1}} f(s) d\mu(s)$$

- the estimation (15) implies

$$\frac{1}{N} \sum_{p=0}^N \sum_{j=0}^{p-1} R_{j,p}^h h^3 \leq C_1 h^2$$

- as the process (\bar{s}_p^h) is ergodic :

$$\lim_{N \rightarrow \infty} E \frac{1}{N} \sum_{p=1}^N f(\bar{s}_p^h(\bar{x})) = \int_{S^{d-1}} f(s) d\bar{\mu}^h(s) = a.s. \lim_{N \rightarrow \infty} \frac{1}{N} \sum_{p=1}^N f(\bar{s}_p^h(\bar{x}))$$

That ends the proof. \square

4.3.3 Proof of Theorem (4.2)

Again, we only treat the scheme (7).

We have previously shown :

$$\bar{\lambda}^h = \lim_{N \rightarrow \infty} \frac{1}{Nh} E \log |\bar{X}_N^h|$$

and therefore :

$$\bar{\lambda}^h = \lim_{N \rightarrow \infty} \frac{1}{Nh} \sum_{p=1}^N E \log |M_{p+1}^h \bar{s}_p^h|$$

Elementary (but long !) computations show that the scheme (\bar{X}_p^h) satisfies, for any smooth function f :

$$\begin{aligned} E f(\bar{X}_{p+1}^h) &= E f(\bar{X}_p^h) + E L f(\bar{X}_p^h) h + \frac{1}{2} E L^2 f(\bar{X}_p^h) h^2 \\ &\quad + E \psi(\bar{X}_p^h + \theta(\bar{X}_{p+1}^h - \bar{X}_p^h)) h^3 \end{aligned}$$

where ψ is a function which can be expressed as a sum whose each term is a product of polynomial functions (w.r.t the euclidian coordinates) and of derivatives of the function f , and θ is in $]0, 1[$.

Under (HU), for any integer n , there exists a strictly positive constant C_n such that :

$$|x + \theta(M_1^h - I)x|^{-n} \leq C_n$$

uniformly in h small enough, in θ in $[0, 1]$ and in x in S^{d-1} .

Therefore, applying the previous remark to $f(x) = \log |x|$, if Q is the function defined in (4), we obtain :

$$E \log |M_{p+1}^h \bar{s}_p^h| = E Q(\bar{s}_p^h) h + \frac{1}{2} E L Q(\bar{s}_p^h) h^2 + R_{p+1}^h h^3$$

with R_{p+1}^h uniformly bounded in $p \in \mathbb{N}$ and in h small enough.

We deduce :

$$\frac{1}{Nh} \sum_{p=1}^N E \log |M_{p+1}^h \bar{s}_p^h| = \frac{1}{N} \sum_{p=1}^N E Q(\bar{s}_p^h) + \frac{1}{N} \sum_{p=1}^N E L Q(\bar{s}_p^h) h + \frac{1}{N} \sum_{p=1}^N R_{p+1}^h h^2$$

Using the result of the previous Lemma, we deduce :

$$\bar{\lambda}^h = \int_{S^{d-1}} Q(s) d\mu(s) + \int_{S^{d-1}} \mathcal{L}Q(s) d\mu(s) h + O(h^2)$$

But, by definition of μ :

$$\int_{S^{d-1}} \mathcal{L}Q(s) d\mu(s) = 0$$

That ends the proof. \square .

5 APPLICATION TO AN ENGINEERING STABILITY PROBLEM

Our objective is to study the stability of the motion of a helicopter blade in terms of various physical parameters, such as the velocity of the helicopter, some geometric characteristics of the blade, the intensity or the coloration of the process modelizing the turbulency around the blade (this problem was given to us by the French Company Aérospatiale).

5.1 Introduction

In first approximation, the stability of the movement of a rotor blade with 2 freedom degrees is equivalent to the stability of the solution of a linearized ordinary differential equation in \mathbb{R}^4

$$\frac{dX(t)}{dt} = A(t)X(t) + F(t)$$

where the matrix-valued function $A(t)$ and the vector-valued function $F(t)$ are periodic of same period (the period of rotation of the blade).

When one takes into account the turbulent flow around the blade, one may consider the following linearized model

$$\frac{dX(t)}{dt} = A(t)X(t) + F(t) + [B(t)X(t) + G(t)]\sigma(t)\xi^\varepsilon(t) \quad (17)$$

where $B(t)$ (resp. $G(t)$) has the same property as $A(t)$ (resp. $F(t)$), and $(\xi^\varepsilon(t))$ is a one-dimensional noise. The intensity of the noise, $\sigma(t)$ is also a

periodic function of the azimuth angle Ωt , where Ω is the angular velocity of the blade.

All the coefficients $A(t)$, $B(t)$, $F(t)$, $G(t)$ are explicitly known in terms of different physical parameters of the blade.

Here the "stability" we are interested in, is the following : the system is stable when it admits a unique periodic in law solution $\{Y(t)\}$ and when, for each initial deterministic condition, the corresponding process $\{X(t)\}$ satisfies :

$$\lim_{t \rightarrow +\infty} |Y(t) - X(t)| = 0 \text{ a.s.} \quad (18)$$

First we will consider the white-noise case.

The system (17) becomes :

$$dX(t) = [A(t)X(t) + F(t)]dt + [B(t)X(t) + G(t)]\sigma(t) \circ dW(t) \quad (19)$$

where $(W(t))$ is a standard one-dimensional Wiener process.

Let us introduce the system

$$dX(t) = A(t)X(t)dt + B(t)X(t)\sigma(t) \circ dW(t) \quad (20)$$

One can show (cf Pardoux[18]) :

Theorem 5.1 *Let us suppose there exists $\lambda < 0$ such that the solution of (20) with any deterministic initial condition x satisfies*

$$\limsup_{t \rightarrow +\infty} \frac{1}{t} \log |X(t)| \leq \lambda \text{ a.s} \quad (21)$$

Then the system (19) is stable in the sense (18).

Of course, it remains to give conditions ensuring the existence of the Lyapunov exponent (21) and to check that the blade system satisfies these conditions. For these points (and the wide-band noise case) we refer to Maryse Pignol's thesis ([23]).

Now let us discuss the numerical computation of the Lyapunov exponent.

We have worked on a set of systems corresponding to different values of some parameters, namely the distance between the gravity center and the torsion center, the velocity of the helicopter and the rotation angular velocity.

The numerical values given below correspond to one particular case, but the conclusions are valid for all the situations we have considered.

5.2 The deterministic case

In the deterministic case (corresponding to $\sigma(t) \equiv 0$), only the Runge-Kutta methods of order larger than 4 give good results (because of the numerical instability of the system, due to the large coefficients of the matrix $A(t)$ and their very short period).

Let us illustrate that remark.

We have used 3 algorithms :

1. Runge-Kutta method of order 2
2. Runge-Kutta method of order 4
3. Gear's method (implemented in the NAG Library of Fortran subroutines)

The discretization step chosen by NAG is always smaller than : 0.0016 ; the Lyapunov exponent (in that case, the Floquet exponent) computed is 12.767.

- 1) with a discretization step $h = 0.00015$:

| method | Floquet exponent |
|------------------------|------------------|
| Runge-Kutta of order 2 | -12.717 |
| Runge-Kutta of order 4 | -12.767 |

- 2) with a discretization step $h = 0.003$:

| method | Floquet exponent |
|------------------------|------------------|
| Runge-Kutta of order 2 | -05.051 |
| Runge-Kutta of order 4 | -12.767 |

- 4) with a discretization step $h = 0.006$:

| method | Floquet exponent |
|------------------------|------------------|
| Runge-Kutta of order 2 | +20.154 |
| Runge-Kutta of order 4 | -12.767 |

These results show that, in the stochastic case, the discretization step will necessarily be chosen smaller than 10^{-4} .

We are going to see another consequence.

5.3 Numerical algorithm for the stochastic case

First, it is important to note that the formula $\bar{\lambda}^h \sim \frac{1}{Nh} \log |\bar{X}_p^h|$ is of poor interest in practice, because it leads to numerical instabilities, the process ($|\bar{X}_p^h|$) decreasing to 0 or increasing to infinity exponentially fast. Alternatively, one may use the following, also used in the proof of the Theorem (6.2) :

$$\bar{\lambda}^h \sim \frac{1}{Nh} \sum_{p=1}^N \log |M_{p+1}^h \bar{s}_p^h|$$

(with N large ; the choice of N will be discussed later on).

Now, let us discuss the choice of a convenient discretization algorithm.

We have tested the Milshtein method and the second-order method (7) on an example of Baxendale [4] for which there exists an explicit formula giving the Lyapunov exponent.

More precisely, let us consider a one-dimensional Wiener process ($W(t)$) and the system :

$$dX(t) = AX(t)dt + \sigma BX(t) \circ dW(t) \quad (22)$$

with

$$A = \begin{bmatrix} a & 0 \\ 0 & b \end{bmatrix}$$

$$B = \begin{bmatrix} 0 & -1 \\ 1 & 0 \end{bmatrix}$$

Then :

$$\lambda = \frac{1}{2}(a+b) + \frac{1}{2}(a-b) \frac{\int_0^{2\pi} \cos(2\theta) \exp(\frac{a-b}{2\sigma^2} \cos(2\theta)) d\theta}{\int_0^{2\pi} \exp(\frac{a-b}{2\sigma^2} \cos(2\theta)) d\theta}$$

By example, let us choose $a = 1$, $b = -2$, $\sigma = 10$. Then an accurate numerical computation gives $\lambda = -0.489$.

For a final integration time $Nh = 100$ and $h = 10^{-3}$, the second-order scheme (7) gives $\lambda = -0.35$, but for $h = 10^{-4}$, it gives $\lambda = -0.50$.

The Milshtein scheme leads to worse results : for the same integration time, and $h = 10^{-3}$, it gives $\lambda = 3.16$, for $h = 10^{-4}$, it gives $\lambda = -0.1$; one needs to choose $h = 10^{-5}$ to obtain $\lambda = -0.51$ (in that last case, the computation time is much longer than the time due to the second-order scheme with $h = 10^{-4}$, for the same result).

Therefore, for our helicopter problem, we have used a second-order scheme. But the above study of the deterministic case shows the necessity to improve the scheme (7), in order that it reduces to the Runge-Kutta scheme of order 4 when the intensity of the noise is nought.

Finally, our algorithm has been the following :

1. one chooses an initial condition on the unit sphere S^3
2. at step $(p + 1)$, one proceeds in two stages :
 - one applies to a single step the Runge-Kutta method of order 4 in order to integrate the system

$$\begin{aligned} y(0) &= \bar{X}_p^h \\ \dot{y}(t) &= \tilde{A}(ph + t)y(t) \end{aligned}$$

(the presence of \tilde{A} is due to the discretization of the system written in the Ito sense)

- then one calculates :

$$\begin{aligned} \bar{X}_{p+1}^h &= y(h) + \left\{ \sigma(ph)B\Delta_{p+1}^h W + \frac{1}{2}\sigma(ph)^2 B^2((\Delta_{p+1}^h W)^2 - h) \right. \\ &\quad + \frac{1}{2}(\sigma(ph)(\tilde{A}B + B\tilde{A} + B')) \\ &\quad \left. + \sigma'(ph)B)h\Delta_{p+1}^h W \right\} \bar{X}_p^h \end{aligned} \quad (23)$$

where we have used the following notations :

$(\Delta_{p+1}^h W) :=$ sequence of mutually independent gaussian

random variables $\mathcal{N}(0, \sqrt{h})$

B' : derivative of the matrix $B(t)$

all the matrices are calculated at time $t = ph$

3. one computes the new value of λ from the previous one by

$$\lambda(1 - \frac{1}{p+1}) + \frac{\log(|\bar{X}_{p+1}^h|)}{(p+1)h} \quad (24)$$

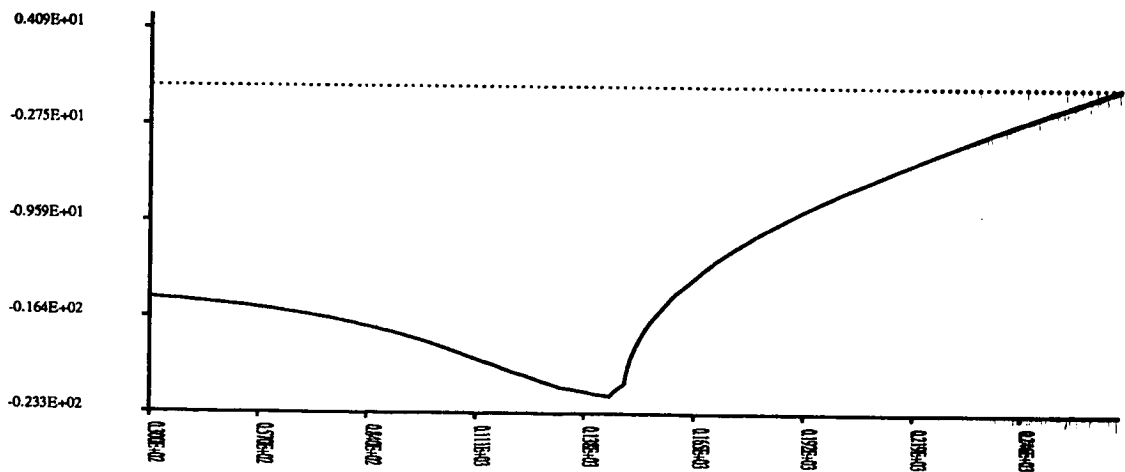
4. one projects \bar{X}_{p+1}^h on the unit sphere.

Just applying the methods of the previous Section, it is easy to check that this algorithm is of order 2.

Our system of automatic generation of FORTRAN programs of simulation of solutions of Stochastic Differential Systems (see Leblond & Talay [12] for a presentation) can generate the FORTRAN program corresponding to this algorithm, for each bilinear system given in entry.

5.4 Numerical results

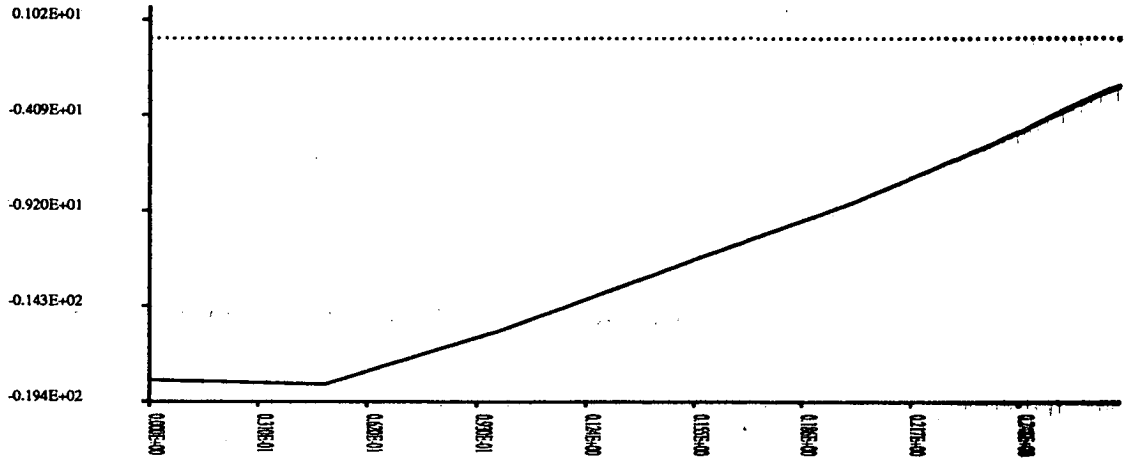
For the given models of blades, the deterministic system was extremely stable for admissible velocities, as shown in the following figure corresponding to one particular model but typical anyway :



- Variations of the Floquet exponent in terms of the velocity -

Let us suppose that $\sigma(t)$ is a constant function : $\sigma(t) \equiv \sigma_0$ (i.e the effects of the turbulency are independent of the azimuth angle).

For a velocity equal to $100m/s$, we obtain the corresponding diagram :



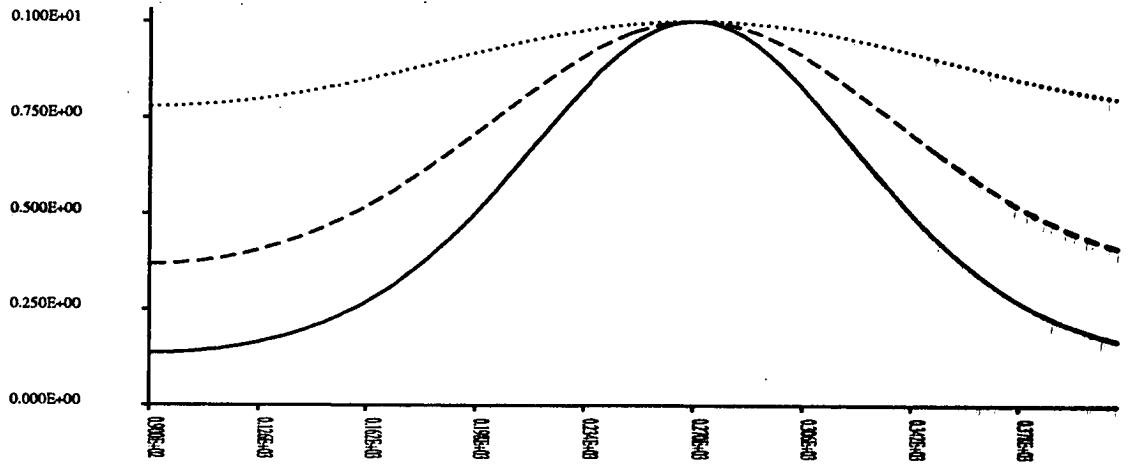
- Variations of the Lyapunov exponent in terms of σ_0 -

The destabilization of the system could occur only for intensities of the noise larger than 0.3 ; such intensities are not realistic for the turbulent winds around the blade.

Moreover, let us consider a more precise modelization of the noise. We suppose that its intensity is a periodic function of the azimuth angle $\Psi = \Omega t$, reaching its maximum for $\Psi = \frac{3\pi}{4}$, and defined by the function :

$$\sigma_0 \exp(\delta(\cos(0.75\pi - 0.5\Omega t)^2 - 1))$$

The figure below represents this function for $\sigma_0 = 1$ and $\delta = 0.25$, $\delta = 1.00$, $\delta = 2.00$.



- Variations of the intensity of the noise in terms of the azimuth angle (in degrees) -

In that case, we observe a strong dependency of the Lyapunov exponent upon δ , and the instability could not appear for realistic intensities :

| σ_0 | δ | Lyapunov exponent |
|------------|----------|-------------------|
| 0.2 | 0.0 | -8.83 |
| 0.2 | 0.25 | -11.83 |
| 0.2 | 1.0 | -16.63 |
| 0.2 | 2.0 | -18.06 |

| δ | σ_0 | Lyapunov exponent |
|----------|------------|-------------------|
| 1.0 | 0.2 | -16.63 |
| 1.0 | 0.5 | -6.1 |
| 1.0 | 0.6 | -2.11 |
| 1.0 | 0.7 | 3.1 |

5.5 Algorithm for the wideband noise case

Let us consider the system

$$\frac{dX(t)}{dt} = A(t)X(t) + B(t)X(t)\sigma(t)\xi^\epsilon(t) \quad (25)$$

with a wide-band noise of the form

$$\xi^\varepsilon(t) = \frac{1}{\sqrt{\varepsilon}} Z\left(\frac{t}{\varepsilon}\right)$$

where $(Z(t))$ is a stationary $\mathcal{N}(0,1)$ Ornstein-Uhlenbeck process.

The above system is an ordinary differential system, so that the pathwise simulation of the solution can be achieved using, by example, the Euler scheme :

$$\bar{X}_{p+1}^h = \bar{X}_p^h + (A(ph)\bar{X}_p^h + \sigma(ph)B(ph)\xi^\varepsilon(ph))\bar{X}_p^h h$$

It is well known that, when ε goes to 0, the solution of (25) converges in law to the solution of (20). Pardoux [18] has shown that, moreover, the Lyapunov exponent of (25) converges to the Lyapunov exponent of (20). Kushner [11] has shown that this convergence is a very particular case of a "pathwise uniform" convergence of a sample average cost per unit time.

But it appears that, even for small h , the Lyapunov exponent of that discrete-time process defined by the Euler scheme does not converge, when ε goes to 0, towards the Lyapunov exponent of the system (20).

One reason is that the process $\{\xi^\varepsilon(ph)\}$ does not converge in law, so that the scheme must rather involve the sequence

$$\Delta_{p+1}^h \xi = \int_{ph}^{(p+1)h} \xi^\varepsilon(s) ds$$

which converges in law to the sequence $(\Delta_{p+1}^h W)$.

But one has to be careful : the new scheme

$$\bar{X}_{p+1}^h = \bar{X}_p^h + (A(ph)h + \sigma(ph)B(ph)\Delta_{p+1}^h \xi)\bar{X}_p^h$$

does not converge to a discretization scheme of (20) ($A \neq \tilde{A}$).

Finally, we introduce a convenient second-order scheme, similar to (23).

First, one applies to a single step the Runge-Kutta method of order 4 in order to integrate the system

$$\begin{aligned} y(0) &= \bar{X}_p^h \\ \dot{y}(t) &= A(ph+t)y(t) \end{aligned}$$

and then

$$\begin{aligned} \overline{X}_{p+1}^h = & y(h) + \left\{ \sigma(ph)B\Delta_{p+1}^h\xi + \frac{1}{2}\sigma(ph)^2B^2(\Delta_{p+1}^h\xi)^2 \right. \\ & \left. + \frac{1}{2}(\sigma(ph)(AB + BA + B') + \sigma'(ph)B)h\Delta_{p+1}^h\xi \right\} \overline{X}_p^h \quad (26) \end{aligned}$$

It is interesting to note that the limit of the above scheme when ε goes to 0 is not the scheme (23), the difference including only terms of order $h\Delta_{p+1}^hW$ and h^2 . We have not succeeded to build a second-order scheme of the wideband system converging to a second-order scheme of the white noise system.

Let us describe our simulation of the integrals $\Delta_{p+1}^h\xi$.

Let $(V(t))$ is a Wiener process independent of $(W(t))$ such that :

$$dZ(t) = -Z(t)dt + \sqrt{2}dV(t)$$

Then we have the formula :

$$\int_{ph}^{(p+1)h} \xi^\varepsilon(s)ds = \sqrt{\varepsilon} \left(\frac{1}{2}(1 - e^{-\frac{2h}{\varepsilon}}) \xi^\varepsilon(ph) + \Delta_{p+1}^{\frac{1}{\varepsilon}}(V) - e^{-\frac{2(p+1)h}{\varepsilon}} \int_{ph}^{(p+1)h} e^{2s} dV_s \right)$$

Therefore, it is possible to simulate the markovian vector :

$$(\xi^\varepsilon(ph), \Delta_{p+1}^h\xi)$$

by the simulation of the gaussian vector :

$$\left(\Delta_{p+1}^{\frac{1}{\varepsilon}}(V), \int_{ph}^{(p+1)h} e^s dV_s, \int_{ph}^{(p+1)h} e^{2s} dV_s \right)$$

For our models, we observed that the coloration of the noise tended to stabilize the system (the limit case being the case of very large ε , equivalent to the deterministic case).

5.6 Remarks

The models for the blade and the noise were simplified ; in particular, only physical experiments during a flight could permit to improve the modelization of the noise, and overall a more realistic model should be non linear.

In this simplified context, the conclusion was that the turbulency around the blade has small effects on the stability of the blade.

5.7 Choice of the integration time

For the sake of simplicity, we again consider the case of matrices A and B , independent of t .

As already mentioned, we approximate $\bar{\lambda}^h$ by :

$$\bar{\lambda}^h \sim \frac{1}{Nh} \sum_{p=1}^N \log |M_{p+1}^h \bar{s}_p^h|$$

The following Central-limit Theorem gives an estimate of the distance between λ and (cf Theorem (2.2)) :

$$\frac{1}{t} \int_0^t Q(s(\theta)) d\theta$$

(this Theorem is due to Bhattacharya [5]).

Theorem 5.2 *Let us suppose (H).*

Let \mathcal{L} define the infinitesimal generator of the Markov process $(s(t))$, μ its unique invariant probability measure, and let the function Q be defined by (4).

For t tending to $+\infty$:

$$\frac{1}{\sqrt{t}} \int_0^t (Q(s(\theta)) - \lambda) d\theta \rightarrow \mathcal{N}(0, \nu^2) \text{ in distribution}$$

where the constant ν^2 depends only on the coefficients of the system and is given by $\langle \cdot, \cdot \rangle$ denoting the inner product in $\mathcal{L}^2(P^{d-1}, \mu)$:

$$\nu^2 = -2 \langle Q - \lambda, L^{-1}(Q - \lambda) \rangle$$

But it seems extremely difficult to numerically estimate the variance of the limit law, since, first, one needs to solve a Poisson P.D.E on S^{d-1} , namely :

$$Lu = Q - \lambda$$

and, second, since this P.D.E. depends on the unknown λ .

This question must be considered in the future.

6 APPENDIX:SECOND-ORDER SCHEMES

6.1 Preliminaries

Let us consider the general stochastic differential equation in the Ito sense :

$$dX(t) = b(X(t))dt + \sigma(X(t))dW(t)$$

The Milshtein scheme is defined by :

$$\bar{X}_{p+1}^h = \bar{X}_p^h + \sum_{j=1}^r \sigma_j(\bar{X}_p^h) U_{p+1}^j \sqrt{h} + b(\bar{X}_p^h)h + \sum_{j,k=1}^r \partial \sigma_j(\bar{X}_p^h) \sigma_k(\bar{X}_p^h) S_{p+1}^{kj} h \quad (27)$$

We define the matrix a and the vectors A_j by :

$$a = \sigma \sigma^* \\ A_j = \frac{1}{2} \sum_{k,l=1}^d a_l^k \partial_{kl} \sigma_j$$

Besides, we will denote by L the infinitesimal generator of the process $(X(t))$:

$$L = \sum_{i=1}^d b_i \partial_i + \frac{1}{2} \sum_{i=1}^d \sum_{j=1}^r a_{ij} \partial_{ij}$$

Now, we define a new scheme by :

$$\begin{aligned} \bar{X}_{p+1}^h &= \bar{X}_p^h + \sum_{j=1}^r \sigma_j(\bar{X}_p^h) U_{p+1}^j \sqrt{h} + b(\bar{X}_p^h)h + \sum_{j,k=1}^r \partial \sigma_j(\bar{X}_p^h) \sigma_k(\bar{X}_p^h) S_{p+1}^{kj} h \\ &+ \frac{1}{2} \sum_{j=1}^r \left\{ \partial b(\bar{X}_p^h) \sigma_j(\bar{X}_p^h) + \partial \sigma_j(\bar{X}_p^h) b(\bar{X}_p^h) + A_j(\bar{X}_p^h) \right\} U_{p+1}^j h^{\frac{3}{2}} \\ &+ \frac{1}{2} Lb(\bar{X}_p^h) h^2 \end{aligned} \quad (28)$$

The scheme (7) is a particular application of this scheme.

6.2 Second order discretization schemes

In this Section, \mathcal{F}_p will be the σ -algebra generated by $(\bar{X}_0^h, \dots, \bar{X}_p^h)$.

A discretization scheme will be called of **second order** if it satisfies (all the right-side terms of the equalities being understood evaluated at \bar{X}_p^h , and we make the usual convention for the summation indices) :

$$\begin{aligned}
 E\left(\Delta_{p+1}^h \bar{X} | \mathcal{F}_p\right) &= bh + \frac{1}{2}(Lb)h^2 + \xi_{p+1}, \quad E|\xi_{p+1}| \leq Ch^3 \\
 E\left((\Delta_{p+1}^h \bar{X})^{i_1} (\Delta_{p+1}^h \bar{X})^{i_2} | \mathcal{F}_p\right) &= \sigma_j^{i_1} \sigma_j^{i_2} h + (b^{i_1} b^{i_2} + \frac{1}{2} \partial_{k_1} \sigma_j^{i_1} \partial_{k_2} \sigma_j^{i_2} \sigma_l^{k_1} \sigma_l^{k_2} \\
 &\quad + \frac{1}{2} \partial_k b^{i_2} \sigma_j^{i_1} \sigma_j^k + \frac{1}{2} \partial_k b^{i_1} \sigma_j^{i_2} \sigma_j^k \\
 &\quad + \frac{1}{2} \sigma_j^{i_1} \partial_k \sigma_j^{i_2} b^k + \frac{1}{2} \sigma_j^{i_2} \partial_k \sigma_j^{i_1} b^k \\
 &\quad + \frac{1}{4} \sigma_j^{i_1} \partial_{kl} \sigma_j^{i_2} \sigma_n^k \sigma_n^l + \frac{1}{4} \sigma_j^{i_2} \partial_{kl} \sigma_j^{i_1} \sigma_n^k \sigma_n^l) h^2 \\
 &\quad + \xi_{p+1}^{i_1 i_2}, \quad E|\xi_{p+1}^{i_1 i_2}| \leq Ch^3 \\
 E\left((\Delta_{p+1}^h \bar{X})^{i_1} \dots (\Delta_{p+1}^h \bar{X})^{i_3} | \mathcal{F}_p\right) &= (b^{i_1} \sigma_j^{i_2} \sigma_j^{i_3} + b^{i_2} \sigma_j^{i_3} \sigma_j^{i_1} + b^{i_3} \sigma_j^{i_1} \sigma_j^{i_2} \\
 &\quad + \frac{1}{2} \sigma_l^{i_2} \partial_k \sigma_l^{i_3} \sigma_j^{i_1} \sigma_j^k + \frac{1}{2} \sigma_l^{i_3} \partial_k \sigma_l^{i_2} \sigma_j^{i_1} \sigma_j^k \\
 &\quad + \frac{1}{2} \sigma_l^{i_3} \partial_k \sigma_l^{i_1} \sigma_j^{i_2} \sigma_j^k + \frac{1}{2} \sigma_l^{i_1} \partial_k \sigma_l^{i_3} \sigma_j^{i_2} \sigma_j^k \\
 &\quad + \frac{1}{2} \sigma_l^{i_1} \partial_k \sigma_l^{i_2} \sigma_j^{i_3} \sigma_j^k + \frac{1}{2} \sigma_l^{i_2} \partial_k \sigma_j^{i_1} \sigma_j^{i_3} \sigma_j^k) h^2 \\
 &\quad + \xi_{p+1}^{i_1 i_2 i_3}, \quad E|\xi_{p+1}^{i_1 i_2 i_3}| \leq Ch^3 \\
 E\left((\Delta_{p+1}^h \bar{X})^{i_1} \dots (\Delta_{p+1}^h \bar{X})^{i_4} | \mathcal{F}_p\right) &= (\sigma_j^{i_1} \sigma_j^{i_2} \sigma_l^{i_3} \sigma_l^{i_4} + \sigma_j^{i_1} \sigma_j^{i_4} \sigma_l^{i_2} \sigma_l^{i_3}) h^2 \\
 &\quad + \xi_{p+1}^{i_1 \dots i_4}, \quad E|\xi_{p+1}^{i_1 \dots i_4}| \leq Ch^3 \\
 E\left((\Delta_{p+1}^h \bar{X})^{i_1} \dots (\Delta_{p+1}^h \bar{X})^{i_5} | \mathcal{F}_p\right) &= \xi_{p+1}^{i_1 \dots i_5}, \quad E|\xi_{p+1}^{i_1 \dots i_5}| \leq Ch^3 \\
 E\left((\Delta_{p+1}^h \bar{X})^{i_1} \dots (\Delta_{p+1}^h \bar{X})^{i_6} | \mathcal{F}_p\right) &= \xi_{p+1}^{i_1 \dots i_6}, \quad E|\xi_{p+1}^{i_1 \dots i_6}| \leq Ch^3
 \end{aligned}$$

We have the following Theorem (see Talay [27] or [28], Milshtein [16]) :

Theorem 6.1 *Let us suppose that b and σ are smooth functions with all their derivatives bounded, and only (i) of (HU).*

Then, for all function f of class C^∞ such that f and all its derivatives have an at most polynomial growth at infinity, the Mil'shtein scheme with $\bar{X}_0^h = X(0)$ satisfies : for any h small enough, for any $T > 0$, and any $h = \frac{T}{N}$ ($N \in \mathbb{N}^*$) :

$$\forall p = 1, \dots, N : |Ef(X_{ph}) - Ef(\bar{X}_p^h)| \leq Ch$$

whereas the scheme (28) satisfies, as well as any other second order scheme such that \bar{X}_p^h has all its moments finite for all p (under the condition $\bar{X}_0^h = X(0)$) :

$$|Ef(X_{ph}) - Ef(\bar{X}_p^h)| \leq Ch^2$$

The same respective orders of convergence are conserved (under another set of hypotheses) when the process $(X(t))$ has a unique invariant measure μ and the criterium of convergence is

$$|\int f(\theta)d\mu(\theta) - a.s. \lim_{N \rightarrow +\infty} \frac{1}{N} \sum_{p=1}^N f(\bar{X}_p^h(x))|$$

(see Talay [29]).

6.3 Extension of the main Theorem

Following the same procedure as previously, we may extend the results of Theorem (4.2) to second-order schemes, under some conditions concerning the law of the involved random variables.

Theorem 6.2 *Let us suppose that the system (3) satisfies the hypothesis (H0).*

Let $(\bar{X}_p^h, p \in \mathbb{N})$ be a discretization scheme of the form

$$\bar{X}_{p+1}^h = M_{p+1}^h \bar{X}_p^h$$

We suppose that there exists $h_0 > 0$ such that :

(H1) *for any $h < h_0$, (M_p^h) is a sequence of i.i.d. random matrices in $Gl(\mathbb{R}^d)$, with common distribution ν^h ;*

(H2) for any $h < h_0$:

$$E \log^+ |M_1^h| < +\infty \quad , \quad E \log^+ |(M_1^h)^{-1}| < +\infty$$

(H3) for any $h < h_0$, the smallest sub-group of $Gl(\mathbb{R}^d)$ containing the support of ν^h is irreducible, and, moreover the process $(\frac{\bar{X}_p^h}{|\bar{X}_p^h|})$ is ergodic on S^{d-1} ;

(H4) there exists $C(h)$ such that, almost surely, the distance between x and $M_1^h x$ can be bounded by $C(h)$ uniformly in x in S^{d-1} , and $C(h)$ tends to 0 with h .

Let us suppose : $(\bar{X}_p^h, p \in \mathbb{N})$ is a second-order scheme in the sense of Section (6.2).

Then :

(i) there exists a real number $\bar{\lambda}^h$ such that :

$$\forall x \in \mathbb{R}^d - \{0\} \quad : \quad \bar{\lambda}^h = \lim_{p \rightarrow +\infty} \frac{1}{ph} \log |\bar{X}_p^h(x)| \quad , \text{ a.s.}$$

(ii) moreover, if λ is the upper Lyapunov exponent of (1) :

$$|\lambda - \bar{\lambda}^h| = O(h^2)$$

7 CONCLUSION

We have built schemes which are of second-order for the approximation of the upper Lyapunov exponents of bilinear systems.

These schemes have been tested numerically and have served to solve an industrial problem of stability.

Some aspects are still to improve, by example the choice of the computation time.
