Galerkin finite element methods with symmetric pressure stabilization for the transient Stokes' equations: stability and convergence analysis

Abstract: We consider the stability and convergence analysis of pressure stabilized finite element approximations of the transient Stokes' equation. The analysis is valid for a class of symmetric pressure stabilization operators. Provided the initial data is chosen as a specific (pressure stabilization dependent) Ritz-projection, we get unconditional stability and optimal convergence for both pressure and velocity approximations, in natural norms. For arbitrary interpolations of the initial data, a condition between the space and time discretization parameters has to be verified in order guarantee pressure stability.

Key-words: Transient Stokes' equations, finite element methods, symmetric pressure stabilization, time discretization, Ritz-projection

Méthodes de Galerkin avec stabilisation symétrique de la pression pour l'équation de Stokes transitoire: analyse de stabilité et de convergence

Résumé : On considère l'analyse de stabilité et convergence de méthodes d'éléments finis stabilisées pour l'équation de Stokes transitoire. L'analyse est valable pour des stabilisations symétriques et faiblements consistantes de la pression. Si l'approximation de la vitesse initiale est donnée par un projection de Ritz spécifique, dépendante de la stabilisation, on montre stabilité inconditionnelle et convergence optimale pour la vitesse et la pression, dans des normes naturelles. Par contre, pour des approximations arbitraires de la vitesse initiale, la stabilité de la pression est soumise à une condition entre les paramètres de discrétisation en espace et en temps.

Mots-clés: Équation de Stokes transitoire, méthode d'éléments finis, stabilisation symétrique de la pression, discrétisation en temps, projection de Ritz

1 Introduction

In this paper we consider stabilized finite element methods for the transient Stokes' problem. For standard pressure stabilizations of Petrov-Galerkin (PSPG) or least squares (GaLS) type the analysis of time-discretization schemes is a difficult issue, unless a space-time approach is applied with a discontinuous Galerkin discretization in time. Indeed for standard finite difference type time discretizations the finite difference term must be included in the stabilization operator to assure consistency (see e.g. [8, 18]). It has been shown, in [3], that even for first order backward difference schemes (where the consistency does not improve convergence) this perturbs the stability of the numerical scheme when the time step is small, unless a condition between the space mesh size and the time step is verified, $\delta t \geq Ch^2$, where δt denotes the time-step and h the space discretization parameter. For higher order schemes such as Crank-Nicholson or second order backward differencing the strongly consistent scheme appears to be unstable (see e.g [1]). Similar initial time-step instabilities were observed, in [15], for the algebraic (static) sub-scale stabilization scheme applied to the Navier-Stokes' equations and they were cured by including time dependent sub-scales.

Our aim in this work is to consider a fairly large class of pressure stabilization methods and show that convergence of velocities and pressures for the Stokes' problem can be obtained without conditions on the space and time discretization parameters, provided the initial data is chosen as a specific (pressure stabilization dependent) Ritz-projection onto the space of stabilized discretely divergence free functions. If, on the other hand, the initial data is chosen as some interpolant that does not conserve the discrete divergence free character, a condition (similar to the one given above) has to be respected in order to avoid pressure oscillations in the transient solution for small times. The analysis is valid for pressure stabilization operators that are symmetric and weakly consistent. Recently, several different weakly consistent symmetric pressure stabilized finite element methods have been proposed. These methods take their origin in the work of Silvester [26] and the work by Codina and Blasco [13]. Further developments include the work by Becker and Braack [2] on local projection schemes, the extension of the interior penalty method using penalization of gradient jumps to the case of pressure stabilization by Burman and Hansbo [11] and the interpretation of these methods as minimal stabilization procedures by Brezzi and Fortin [6]. Similar approaches have been advocated in Bochev and Dohrmann in [16] and a review of the analysis (with special focus on discontinuous pressure spaces and the Darcy problem) is given in [9]. The main idea underpinning all these method is that, when using a velocity-pressure space pair $V_h \times Q_h$, the constraint of inf-sup stability of the spaces may be relaxed by the addition of an operator penalizing the difference between the discrete pressure variable and its projection onto a subspace $Q_h \subset Q_h$, such that $V_h \times Q_h$ is inf-sup stable. The penalization may either act directly on the pressure as in [16, 9] or on the gradient of the pressure as in [2, 14, 11]. Generally speaking, the pressure approximation properties of the numerical schemes will be given by Q_h expressed in the weak consistency satisfied by the penalty operator. In some cases [10, 4, 12], these stabilized methods may be extended to include high Reynolds number effects in the case of the Oseen's problem. The advantages and disadvantages of symmetric weakly consistent pressure stabilization methods compared to GaLS or PSPG approaches is discussed in a recent review paper [5].

The main results of the present paper are: unconditional stability of velocities and pressures and optimal convergence (in natural norms) when the initial data is chosen as a certain Ritz-type projection (see e.g. [27, 28]). In case a standard interpolation of the initial data is applied, an inverse parabolic CFL-type condition must be respected in order to maintain pressure stability for small time-steps. We give the full analysis only for the backward difference formula of order one, and we indicate how the analysis changes in the case of second order approximations in time. Indeed any A-stable implicit scheme is expected to yield optimal performance. We then discuss how various pressure stabilizations methods enter the framework. Finally, we illustrate the theoretical results with numerical experiments, using interior penalty stabilization of the gradient jumps. We present examples demonstrating the optimal convergence using finite element spaces consisting of quadratic functions, for the space discretization, and first and second order backward difference formulas and the Crank-Nicholson scheme for the time discretization. We also verify numerically that for small time steps the pressure is unstable for initial data that are not discretely divergence free.

2 Problem setting

Let Ω be a domain in \mathbb{R}^d (d=2 or 3) with a polyhedral boundary $\partial\Omega$. For T>0 we consider the problem of solving, for $\boldsymbol{u}:\Omega\times(0,T)\longrightarrow\mathbb{R}^d$ and $p:\Omega\times(0,T)\longrightarrow\mathbb{R}$, the following time-dependent Stokes problem:

$$\begin{cases}
\partial_{t} \boldsymbol{u} - \nu \Delta \boldsymbol{u} + \boldsymbol{\nabla} p = \boldsymbol{f}, & \text{in} \quad \Omega \times (0, T), \\
\boldsymbol{\nabla} \cdot \boldsymbol{u} = 0, & \text{in} \quad \Omega \times (0, T), \\
\boldsymbol{u} = \boldsymbol{0}, & \text{on} \quad \partial \Omega \times (0, T), \\
\boldsymbol{u}(\cdot, 0) = \boldsymbol{u}_{0}, & \text{in} \quad \Omega.
\end{cases} \tag{1}$$

Here, $\mathbf{f}: \Omega \times (0,T) \longrightarrow \mathbb{R}$ stands for the source term, $\mathbf{u}_0: \Omega \longrightarrow \mathbb{R}^d$ for the initial velocity and $\nu > 0$ for a given constant viscosity. In order to introduce a variational setting for (1) we consider the following standard velocity and pressure spaces

$$V \stackrel{\mathrm{def}}{=} [H^1_0(\Omega)]^d, \quad H \stackrel{\mathrm{def}}{=} [L^2(\Omega)]^d, \quad Q = L^2_0(\Omega),$$

normed with

$$\|\boldsymbol{v}\|_{H}\overset{\mathrm{def}}{=}(\boldsymbol{v},\boldsymbol{v})^{\frac{1}{2}},\quad \|\boldsymbol{v}\|_{V}\overset{\mathrm{def}}{=}\|\boldsymbol{\nu}^{\frac{1}{2}}\boldsymbol{\nabla}\boldsymbol{v}\|_{H},\quad \|q\|_{Q}\overset{\mathrm{def}}{=}\|\boldsymbol{\nu}^{-\frac{1}{2}}q\|_{H},$$

where (\cdot, \cdot) denotes the standard L^2 -scalar product.

Problem (1) can be formulated in weak form as follows: For all t > 0, find $\boldsymbol{u}(t) \in V$ and $p(t) \in Q$ such that

$$\begin{cases}
(\partial_t \boldsymbol{u}, \boldsymbol{v}) + a(\boldsymbol{u}, \boldsymbol{v}) + b(p, \boldsymbol{v}) = (\boldsymbol{f}, \boldsymbol{v}), & \text{a.e. in} \quad (0, T), \\
b(q, \boldsymbol{u}) = 0, & \text{a.e. in} \quad (0, T), \\
\boldsymbol{u}(\cdot, 0) = \boldsymbol{u}_0, & \text{a.e. in} \quad \Omega,
\end{cases} \tag{2}$$

for all $v \in V$, $q \in Q$ and with

$$a(\boldsymbol{u}, \boldsymbol{v}) \stackrel{\text{def}}{=} (\nu \nabla \boldsymbol{u}, \nabla \boldsymbol{v}), \quad b(p, \boldsymbol{v}) \stackrel{\text{def}}{=} -(p, \nabla \cdot \boldsymbol{v}).$$

From these definitions the following classical coercivity and continuity estimates hold:

$$a(\mathbf{v}, \mathbf{v}) \ge \|\mathbf{v}\|_{V}^{2}, \quad a(\mathbf{u}, \mathbf{v}) \le \|\mathbf{u}\|_{V} \|\mathbf{v}\|_{V}, \quad b(\mathbf{v}, q) \le \|\mathbf{v}\|_{V} \|q\|_{Q},$$
 (3)

for all $\boldsymbol{u}, \boldsymbol{v} \in V$ and $q \in Q$. It is known (see *e.g.* [17]) that if $\boldsymbol{f} \in C^0([0,T];H)$ and that $\boldsymbol{u}_0 \in V \cap H_0(\operatorname{div};\Omega)$ problem (2) admits a unique solution (\boldsymbol{u},p) in $L^2(0,T;V) \times L^2(0,T;Q)$ with $\partial_t \boldsymbol{u} \in L^2(0,T;V')$.

Thorough this paper, C stands for a generic positive constant independent of the physical and discretization parameters.

3 Space and time discretization

In this section we semi-discretize problem (2) in space, using pressure stabilized finite elments.

3.1 Space semi-discretization: pressure stabilized formulations

Let $\{\mathcal{T}_h\}_{0< h\leq 1}$ denote a family of triangulations of the domain Ω without hanging nodes. For each triangulation \mathcal{T}_h , the subscript $h\in(0,1]$ refers to the level of refinement of the triangulation, which is defined by

$$h \stackrel{\text{def}}{=} \max_{K \in \mathcal{T}_h} h_K, \quad h_K \stackrel{\text{def}}{=} \max_{e \subset \partial K} h_e,$$

with h_e the diameter of the face e.

Moreover we will assume that the family of triangulation $\{\mathcal{T}_h\}_{0 < h \leq 1}$ is quasi-uniform, i.e.,

$$\frac{h_K}{\rho_K} < C_R, \quad h_K \ge C_U h, \quad \forall K \in \mathcal{T}_h, \quad \forall h \in (0, 1],$$
 (4)

where ρ_K stands for the diameter of the largest inscribed ball in K and $C_R, C_U > 0$ are fixed constants.

In this paper, we let X_h^k and M_h^l denote, respectively, the standard spaces of continuous and (possibly) discontinuous piecewise polynomial functions of degree $k \geq 1$ and $l \geq 0$ $(k-1 \le l \le k),$

$$\begin{split} X_h^k &\stackrel{\text{def}}{=} \left\{ v_h \in H^1(\Omega) \, : \, v_{h|K} \in \mathbb{P}_k(K), \quad \forall K \in \mathcal{T}_h \right\}, \\ M_h^l &\stackrel{\text{def}}{=} \left\{ q_h \in L^2(\Omega) \, : \, q_{h|K} \in \mathbb{P}_l(K), \quad \forall K \in \mathcal{T}_h \right\}. \end{split}$$

For the approximated velocities we will use the space $[V_h^k]^d \stackrel{\text{def}}{=} [X_h^k \cap H_0^1(\Omega)]^d$ and for the pressure we will use $Q_h^l \stackrel{\text{def}}{=} M_h^l \cap L_0^2(\Omega)$. In order to stabilize the pressure we introduce a bi-linear form $j: Q_h \times Q_h \longrightarrow \mathbb{R}$ satisfying the following properties:

• Symmetry:

$$j(p_h, q_h) = j(q_h, p_h), \quad \forall p_h, q_h \in Q_h^l, \tag{5}$$

• Continuity:

$$|j(p_h, q_h)| \le j(p_h, p_h)^{\frac{1}{2}} j(q_h, q_h)^{\frac{1}{2}} \le C ||p_h||_Q ||q_h||_Q, \quad \forall p_h, q_h \in Q_h^l, \tag{6}$$

• Weak consistency:

$$j(\Pi_h^l q, \Pi_h^l q)^{\frac{1}{2}} \le C \frac{h^{s_p}}{l} \|q\|_{s_p, \Omega}, \quad \forall q \in H^s(\Omega), \tag{7}$$

with $s_p \stackrel{\text{def}}{=} \min\{s, \tilde{l}, l+1\}, \ \tilde{l} \geq 1$ denoting the order of weak consistency of the stabilization operator, and $\Pi_h^l: Q \longrightarrow Q_h^l$ a given projection operator such that

$$\|q - \Pi_h^l q\|_Q \le \frac{C}{\nu^{\frac{1}{2}}} h^{l+1} \|q\|_{l+1,\Omega},$$
 (8)

for all $q \in H^{l+1}(\Omega)$.

Finally, we assume that there exists a projection operator $\mathcal{I}_h^k:V\longrightarrow V_h^k$ satisfying the following approximation properties:

$$\|\mathbf{v} - \mathcal{I}_h^k \mathbf{v}\|_H + h\nu^{-\frac{1}{2}} \|\mathbf{v} - \mathcal{I}_h^k \mathbf{v}\|_V \le C_{\mathcal{I}} h^{r_u} \|\mathbf{v}\|_{r_u,\Omega},$$
 (9)

$$|b(q_h, \mathbf{v} - \mathcal{I}_h^k \mathbf{v})| \le C j(q_h, q_h)^{\frac{1}{2}} \left(\nu^{\frac{1}{2}} \|h^{-1} (\mathbf{v} - \mathcal{I}_h^k \mathbf{v})\|_H + \|\mathbf{v} - \mathcal{I}_h^k \mathbf{v}\|_V \right),$$
 (10)

for all $\boldsymbol{v} \in [H^r(\Omega)]^d$, $r_{\boldsymbol{u}} = \min\{r, k+1\}$ and $(q_h, \boldsymbol{v}_h) \in Q_h^l \times [V_h^k]^d$. Our space semi-discretized scheme reads: For all $t \in (0,T)$, find $(\boldsymbol{u}_h(t), p_h(t)) \in [V_h^k]^d \times [V_h^k]^d$ Q_h^l such that

$$(\partial_t \boldsymbol{u}_h, \boldsymbol{v}_h) + a(\boldsymbol{u}_h, \boldsymbol{v}_h) + b(p_h, \boldsymbol{v}_h) - b(q_h, \boldsymbol{u}_h) + j(p_h, q_h) = (\boldsymbol{f}, \boldsymbol{v}_h),$$

$$\boldsymbol{u}_h(0) = \boldsymbol{u}_h^0,$$
(11)

for all $(\boldsymbol{v}_h,q_h) \in [V_h^k]^d \times Q_h^l$ and with \boldsymbol{u}_0^0 a suitable approximation of \boldsymbol{u}_0 in $[V_h^k]^d$.

The following modified inf-sup condition states the stability of the discrete pressures in (11).

Lemma 3.1 There exists two constants $C, \beta > 0$, independent of h and ν , such that

$$\sup_{\boldsymbol{v}_h \in [V_h^k]^d} \frac{|b(q_h, \boldsymbol{v}_h)|}{\|\boldsymbol{v}_h\|_V} + Cj(q_h, q_h)^{\frac{1}{2}} \ge \beta \|q_h\|_Q, \tag{12}$$

for all $q_h \in Q_h^l$.

Proof. Let $q_h \in Q_h^l$, from [20, Corollary 2.4] there exists $\boldsymbol{v}_q \in H_0^1(\Omega)$ such that $\boldsymbol{\nabla} \cdot \boldsymbol{v}_q = \nu^{-1}q_h$ and

$$\|\mathcal{I}_h^k v_a\|_V \le C \|v_a\|_V \le C \|q_h\|_Q.$$
 (13)

Thus, from (10) we have

$$\begin{aligned} \|q_h\|_Q^2 &= b(q_h, \boldsymbol{v}_q) \\ &= b(q_h, \boldsymbol{v}_q - \mathcal{I}_h^k \boldsymbol{v}_q) + b(q_h, \mathcal{I}_h^k \boldsymbol{v}_q) \\ &\leq C j(q_h, q_h)^{\frac{1}{2}} \left(\|\boldsymbol{\nu}^{\frac{1}{2}} h^{-1} (\boldsymbol{v} - \mathcal{I}_h^k \boldsymbol{v})\|_H + \|\boldsymbol{v} - \mathcal{I}_h^k \boldsymbol{v}\|_V \right) + b(q_h, \mathcal{I}_h^k \boldsymbol{v}_q) \\ &\leq C j(q_h, q_h)^{\frac{1}{2}} \|q_h\|_Q + b(q_h, \mathcal{I}_h^k \boldsymbol{v}_q). \end{aligned}$$

We conclude the proof by dividing this last inequality by $\|\mathcal{I}_h^k \boldsymbol{v}_q\|_V$ and using (13). \square The above Lemma assures the wellposedness of problem (11), stated by the following Theorem.

Theorem 3.1 The discrete problem (11) with $\mathbf{u}_h^0 \in V_{h,k}^{\text{div}} \stackrel{\text{def}}{=} \{ \mathbf{v}_h \in V_j^k : b(q_h, \mathbf{v}_h) = 0, \quad \forall q_h \in Q_h \cap \text{Ker } j \}$ has a unique solution $(\mathbf{u}_h, p_h) \in C^1((0, T]; [V_h^k]^d) \times C^0((0, T]; Q_h^k)$.

To facilitate the analysis we introduce the following (mesh-dependent) triple-norm

$$\|(\boldsymbol{v}_h, q_h)\|_h^2 \stackrel{\text{def}}{=} \|\boldsymbol{v}_h\|_V^2 + j(q_h, q_h).$$
 (14)

3.1.1 The Ritz projection operator

For the purpose of the stability and convergence analysis below we introduce the Ritz projection operator

$$S^{k,l}_h: [H^1(\Omega)]^d \times L^2(\Omega) \longrightarrow V^k_h \times Q^l_h.$$

For each $(\boldsymbol{u},p) \in [H^1(\Omega)]^d \times L^2(\Omega)$, the projection $S_h^{k,l}(\boldsymbol{u},p) \stackrel{\text{def}}{=} (P_h^k(\boldsymbol{u},p), R_h^l(\boldsymbol{u},p)) \in [V_h^k]^d \times Q_h^l$ is defined as the unique solution of

$$\begin{cases}
a(P_h^k(\boldsymbol{u}, p), \boldsymbol{v}_h) + b(R_h^l(\boldsymbol{u}, p), \boldsymbol{v}_h) = a(\boldsymbol{u}, \boldsymbol{v}_h) + b(p, \boldsymbol{v}_h), \\
-b(q_h, P_h^k(\boldsymbol{u}, p)) + j(R_h^l(\boldsymbol{u}, p), q_h) = 0,
\end{cases}$$
(15)

for all $(\boldsymbol{v}_h, q_h) \in [V_h^k]^d \times Q_h^l$.

Problem (15) is wellpossed thanks to the inf-sup condition (12), in particular, we have the following a priori stability estimate:

$$\| (P_h^k(\boldsymbol{u}, p), R_h^l(\boldsymbol{u}, p)) \|_b^2 \le C (\|\boldsymbol{u}\|_V^2 + \|p\|_Q^2), \tag{16}$$

with C > 0 a constant independent of h and ν .

Finally, we have the following approximation result.

Lemma 3.2 Let $(\boldsymbol{u},p) \in C^1([0,T],[H^r(\Omega)\cap H^1_0(\Omega))]^d \cap H_0(\operatorname{div};\Omega) \times H^s(\Omega))$ with $r \geq 2$ and $s \geq 1$. The following error estimate for the projection $S_h^{k,l}$ holds with $\alpha = 0,1$:

$$\begin{split} \| \left(\partial_t^{\alpha} (\boldsymbol{u} - P_h^k(\boldsymbol{u}, p)), \partial_t^{\alpha} R_h^l(\boldsymbol{u}, p) \right) \|_h &\leq C \left(\nu^{\frac{1}{2}} h^{r_{\boldsymbol{u}} - 1} \| \partial_t^{\alpha} \boldsymbol{u} \|_{r_{\boldsymbol{u}}, \Omega} + \nu^{-\frac{1}{2}} h^{s_p} \| \partial_t^{\alpha} p \|_{s_p, \Omega} \right), \\ \| p - R_h^l(\boldsymbol{u}, p) \|_Q &\leq C \left(\nu^{\frac{1}{2}} h^{r_{\boldsymbol{u}} - 1} \| \boldsymbol{u} \|_{r_{\boldsymbol{u}}, \Omega} + \nu^{-\frac{1}{2}} h^{s_p} \| p \|_{s_p, \Omega} \right), \end{split}$$

for all $t \in [0,T]$ and with $r_{\mathbf{u}} \stackrel{\text{def}}{=} \min\{r,k+1\}$, $s_p \stackrel{\text{def}}{=} \min\{s,\tilde{l},l+1\}$ and C > 0 independent of ν and h. Moreover, provided the domain Ω is sufficiently smooth and if $\tilde{l} \geq 1$, there also holds

$$\|\partial_t^{\alpha}(\boldsymbol{u} - P_h^k(\boldsymbol{u}, p))\|_H \le Ch \|(\partial_t^{\alpha}(\boldsymbol{u} - P_h^k(\boldsymbol{u}, p)), \partial_t^{\alpha} R_h^l p)\|_h. \tag{17}$$

Proof. For simplicity we here use the notation $\boldsymbol{u}_h \stackrel{\text{def}}{=} P_h^k(\boldsymbol{u}, p)$ and $p_h \stackrel{\text{def}}{=} R_h^l(\boldsymbol{u}, p)$. From (14), the V-coercivity of $a(\cdot, \cdot)$ (3), and the orthogonality provided by (15) we have

$$\| (\boldsymbol{u}_h - \mathcal{I}_h^k \boldsymbol{u}, p_h - \Pi_h^l p) \|_h^2 = a(\boldsymbol{u} - \mathcal{I}_h^k \boldsymbol{u}, \boldsymbol{u}_h - \mathcal{I}_h^k \boldsymbol{u}) + b(p - \Pi_h^l p, \boldsymbol{u}_h - \mathcal{I}_h^k \boldsymbol{u}) + b(p_h - \Pi_h^l p, \boldsymbol{u} - \mathcal{I}_h^k \boldsymbol{u}) + j(\Pi_h^l p, p_h - \Pi_h^l p).$$

Finally, using (3) and (10), we have that

$$\begin{aligned} \| \left(\boldsymbol{u}_{h} - \mathcal{I}_{h}^{k} \boldsymbol{u}, p_{h} - \Pi_{h}^{l} \boldsymbol{p} \right) \|_{h}^{2} &\leq \left(\| \boldsymbol{u} - \mathcal{I}_{h}^{k} \boldsymbol{u} \|_{V} + \| \boldsymbol{p} - \Pi_{h}^{l} \boldsymbol{p} \|_{Q} \right) \| \boldsymbol{u}_{h} - \mathcal{I}_{h}^{k} \boldsymbol{u} \|_{V} \\ &+ C \left(\nu^{\frac{1}{2}} \| h^{-1} (\boldsymbol{u} - \mathcal{I}_{h}^{k} \boldsymbol{u}) \|_{H} + \| \boldsymbol{u} - \mathcal{I}_{h}^{k} \boldsymbol{u} \|_{V} + j (\Pi_{h}^{l} \boldsymbol{p}, \Pi_{h}^{l} \boldsymbol{p})^{\frac{1}{2}} \right) j (p_{h} - \Pi_{h}^{l} \boldsymbol{p}, p_{h} - \Pi_{l}^{k} \boldsymbol{p})^{\frac{1}{2}}. \end{aligned}$$

We obtain the estimation for the velocity ($\alpha = 0$) using the approximation properties of \mathcal{I}_h^k and Π_h^l ((9) and (8)), and the weak consistency (7) of the stabilizing term $j(\cdot, \cdot)$. The convergence for the time derivative ($\alpha = 1$) is obtained in a similar fashion after time derivation of (15).

For the pressure estimate we use the generalized inf-sup condition (12) and the orthogonality provided by (15). We then have

$$\beta \|\Pi_{h}^{l}p - p_{h}\|_{Q} \leq \sup_{\boldsymbol{v}_{h} \in [V_{h}^{k}]^{d}} \frac{b(\Pi_{h}^{l}p - p_{h}, \boldsymbol{v}_{h})}{\|\boldsymbol{v}_{h}\|_{V}} + Cj(\Pi_{h}^{l}p - p_{h}, \Pi_{h}^{l}p - p_{h})^{\frac{1}{2}}$$

$$\leq \sup_{\boldsymbol{v}_{h} \in [V_{h}^{k}]^{d}} \frac{b(\Pi_{h}^{k}p - p, \boldsymbol{v}_{h}) - a(\boldsymbol{u} - \boldsymbol{u}_{h}, \boldsymbol{v}_{h})}{\|\boldsymbol{v}_{h}\|_{V}} + Cj(\Pi_{h}^{l}p - p_{h}, \Pi_{h}^{l}p - p_{h})^{\frac{1}{2}}.$$

We conclude using the continuity of $a(\cdot,\cdot)$ and $b(\cdot,\cdot)$, approximability, the weak consistency of $j(\cdot,\cdot)$ and the previous error estimate. For a proof of the optimality in the *H*-norm we refer *e.g.* to [10, Theorem 4.14]. \square

3.2 Fully discrete formulation: time discretization

In this section we discretize (11) with respect to the time variable. To this aim, we shall replace the time derivative in (11) by a backward difference quotient. Given a positive integer N>0, we define as $\delta t \stackrel{\text{def}}{=} T/N$ the time step. In what follows, $(\boldsymbol{u}_h^n, p_h^n)$ stands for an approximation of $(\boldsymbol{u}(t_n), p(t_n))$ in $[V_h^k]^d \times Q_h^l$, with $t_n \stackrel{\text{def}}{=} n\delta t$ and $0 \le n \le N-1$.

Backward Euler scheme (BDF1)

By introducing the first order backward difference quotient

$$\bar{D}u_h^{n+1} \stackrel{\text{def}}{=} \frac{u_h^{n+1} - u_h^n}{\delta t},$$

our first fully discrete scheme reads as follows: For $0 \le n \le N-1$, find $(\boldsymbol{u}_h^{n+1}, p_h^{n+1}) \in [V_h^k]^d \times Q_h^l$ such that

$$(\bar{D}\boldsymbol{u}_{h}^{n+1},\boldsymbol{v}_{h}) + a(\boldsymbol{u}_{h}^{n+1},\boldsymbol{v}_{h}) + b(p_{h}^{n+1},\boldsymbol{v}_{h}) - b(q_{h},\boldsymbol{u}_{h}^{n+1}) + j(p_{h}^{n+1},q_{h}) = (\boldsymbol{f}(t_{n+1}),\boldsymbol{v}_{h}), \quad (18)$$

for all $(\boldsymbol{v}_h,q_h)\in V_h^k\times Q_h^l$ and with \boldsymbol{u}_h^0 a suitable approximation of \boldsymbol{u}_0 in $[V_h^k]^d$.

Crank-Nicholson scheme

Let us consider now the scheme given by: For $0 \le n \le N-1$, find $(\boldsymbol{u}_h^{n+1}, p_h^{n+1}) \in [V_h^k]^d \times Q_h^l$ such that

$$(\bar{D}\boldsymbol{u}_{h}^{n+1},\boldsymbol{v}_{h}) + a(\boldsymbol{u}_{h}^{n+\frac{1}{2}},\boldsymbol{v}_{h}) + b(p_{h}^{n+1},\boldsymbol{v}_{h}) - b(q_{h},\boldsymbol{u}_{h}^{n+\frac{1}{2}}) + j(p_{h}^{n+1},q_{h}) = (\boldsymbol{f}^{n+\frac{1}{2}},\boldsymbol{v}_{h}), \quad (19)$$

for all $(\boldsymbol{v}_h,q_h)\in [V_h^k]^d\times Q_h^l$, with the general notation $x^{n+\frac{1}{2}}\stackrel{\text{def}}{=}\frac{1}{2}(x^{n+1}+x^n)$ and \boldsymbol{u}_h^0 a suitable approximation of \boldsymbol{u}_0 in $[V_h^k]^d$.

Second order backward difference (BDF2)

Finally, by considering the second order backward difference quotient

$$\tilde{D}\boldsymbol{u}^{n+1} \stackrel{\text{def}}{=} \frac{1}{2\delta t} (3\boldsymbol{u}_h^{n+1} - 4\boldsymbol{u}_h^n + \boldsymbol{u}_h^{n-1}),$$

we obtain the BDF2 scheme: For $1 \le n \le N-1$, find $(\boldsymbol{u}_h^{n+1}, p_h^{n+1}) \in [V_h^k]^d \times Q_h^l$ such that

$$(\tilde{D}\boldsymbol{u}_h^{n+1}, \boldsymbol{v}_h) + a(\boldsymbol{u}_h^{n+1}, \boldsymbol{v}_h) + b(p_h^{n+1}, \boldsymbol{v}_h) - b(q_h, \boldsymbol{u}_h^{n+1}) + j(p_h^{n+1}, q_h) = (\boldsymbol{f}^{n+1}, \boldsymbol{v}_h), \quad (20)$$

for all $(\boldsymbol{v}_h, q_h) \in [V_h^k]^d \times Q_h^l$, and $(\boldsymbol{u}_h^1, p_h^1) \in [V_h^k]^d \times Q_h^l$ given by the first step of backward Euler scheme (18).

4 Stability

In this section we analyze the stability properties of the fully discrete schemes introduced in §3.2. For the sake of simplity, full details will be only given for the backward scheme (18). Nevertheless, in §4.2, we will discuss how the results extend to the second order time stepping schemes: Crank-Nicholson and BDF2.

4.1 First order A-stable scheme

The next result provides the unconditional stability of the velocity. It also provides a uniform estimate for the pressure, in terms of the discrete time derivative. Theorem 4.2 points out the role of the initial velocity approximation on the stability of the time derivative approximations. Finally, Corollary 4.1 states the (conditional or unconditional) stability of the pressure depending on the choice of the initial velocity approximation.

Theorem 4.1 Let \mathbf{u}_h^0 be a given H-stable approximation of \mathbf{u}_0 in $[V_h^k]^d$ and $\{(\mathbf{u}_h^n, p_h^n)\}_{n=1}^N$ be the solution of the fully discrete problem (18). The following estimate holds for $1 \le n \le N$:

$$\|\boldsymbol{u}_{h}^{n}\|_{H}^{2} + \sum_{m=0}^{n-1} \delta t \|(\boldsymbol{u}_{h}^{m+1}, p_{h}^{m+1})\|_{h}^{2} \leq \|\boldsymbol{u}_{0}\|_{H}^{2} + \frac{C_{P}^{2}}{\nu} \sum_{m=0}^{n-1} \delta t \|\boldsymbol{f}(t_{m+1})\|_{H}^{2},$$

$$\sum_{m=0}^{n-1} \delta t \|p_{h}^{m+1}\|_{Q}^{2} \leq \frac{C}{\beta^{2}} \sum_{m=0}^{n-1} \delta t \left(\|(\boldsymbol{u}_{h}^{m+1}, p_{h}^{m+1})\|_{h}^{2} + \nu^{-1} \|\bar{\boldsymbol{D}}\boldsymbol{u}_{h}^{m+1}\|_{H}^{2} + \nu^{-1} \|\boldsymbol{f}(t_{m+1})\|_{H}^{2}\right).$$
(21)

with $C_P > 0$ the Poincare's constant.

Proof. Taking $\boldsymbol{v}_h = \boldsymbol{u}_h^{n+1}$ and $q_h = p_h^{n+1}$ in (18), using the coercivity of the bi-linear form, the Cauchy-Schwarz's inequality and the Poincaré's inequality, we have

$$(\bar{D}\boldsymbol{u}_{h}^{n+1},\boldsymbol{u}_{h}^{n+1}) + \frac{1}{2} \|(\boldsymbol{u}_{h}^{n+1},p_{h}^{n+1})\|_{h}^{2} \leq \frac{C_{P}^{2}}{2\nu} \|\boldsymbol{f}(t_{n+1})\|_{H}^{2}.$$
(22)

Now, recalling that

$$(\bar{D}\boldsymbol{u}_{h}^{n+1},\boldsymbol{u}_{h}^{n+1}) = \frac{1}{2}\bar{D}\|\boldsymbol{u}_{h}^{n+1}\|_{H}^{2} + \frac{1}{2\delta t}\|\boldsymbol{u}_{h}^{n+1} - \boldsymbol{u}_{h}^{n}\|_{H}^{2}, \tag{23}$$

we have

$$\bar{D}\|\boldsymbol{u}_{h}^{n+1}\|_{H}^{2} + \|(\boldsymbol{u}_{h}^{n+1}, p_{h}^{n+1})\|_{h}^{2} \leq \frac{C_{P}^{2}}{\nu}\|\boldsymbol{f}(t_{n+1})\|_{H}^{2},$$

leading to, after summation over $0 \le m \le n-1$,

$$\|\boldsymbol{u}_{h}^{n}\|_{H}^{2} + \sum_{m=0}^{n-1} \delta t \|(\boldsymbol{u}_{h}^{m+1}, p_{h}^{m+1})\|_{h}^{2} \leq \|\boldsymbol{u}_{h}^{0}\|_{H}^{2} + \frac{C_{\mathrm{P}}^{2}}{\nu} \sum_{m=0}^{n-1} \delta t \|\boldsymbol{f}(t_{m+1})\|_{H}^{2}.$$

For the pressure estimate, from (12), (18) (with $q_h = 0$) and the Poincaré's inequality, we have

$$\beta \|p_h^{n+1}\|_Q \leq C \left(\|(\boldsymbol{u}_h^{n+1}, p_h^{n+1})\|_h + \nu^{-\frac{1}{2}} \|\bar{D}\boldsymbol{u}_h^{n+1}\|_H + \nu^{-\frac{1}{2}} \|\boldsymbol{f}(t_{n+1})\|_H \right),$$

which completes the proof. \Box

The next theorem states some a priori estimates of the approximations of the time derivative.

Theorem 4.2 Let $\{(\boldsymbol{u}_h^n, p_h^n)\}_{n=1}^N$ be the solution of the fully discrete problem (18).

• If $u_0 \in [H^1(\Omega)]^d$ and $u_h^0 = P_h^k(u_0, 0)$, the following estimate holds for $1 \le n \le N$:

$$\sum_{m=0}^{n-1} \delta t \|\bar{D}\boldsymbol{u}_{h}^{m+1}\|_{H}^{2} + \|(\boldsymbol{u}_{h}^{n}, p_{h}^{n})\|_{h}^{2} \le C \left(\|\boldsymbol{u}_{0}\|_{V}^{2} + \sum_{m=0}^{n-1} \delta t \|\boldsymbol{f}(t_{m+1})\|_{H}^{2}\right). \tag{24}$$

• If $\mathbf{u}_0 \in [H^r(\Omega) \cap H_0^1(\Omega)]^d \cap H_0(\operatorname{div}; \Omega)$, $r \geq 2$, and $\mathbf{u}_h^0 = \mathcal{I}_h^k \mathbf{u}_0$, the following estimate holds for 1 < n < N:

$$\sum_{m=0}^{n-1} \delta t \|\bar{D}\boldsymbol{u}_{h}^{m+1}\|_{H}^{2} + \|(\boldsymbol{u}_{h}^{n}, p_{h}^{n})\|_{h}^{2} \leq C \left(\|\boldsymbol{u}_{0}\|_{V}^{2} + \nu h^{2(r_{u}-1)}\|p_{h}^{1}\|_{Q}^{2} + \|\boldsymbol{u}_{0}\|_{r_{u}, \Omega}^{2} + \sum_{m=0}^{n-1} \delta t \|\boldsymbol{f}(t_{m+1})\|_{H}^{2}\right), \quad (25)$$

with $r_{\mathbf{u}} \stackrel{\text{def}}{=} \min\{k+1, r\}.$

Proof. For $0 \le n \le N-1$, by taking $\boldsymbol{v}_h = \bar{D}\boldsymbol{u}_h^{n+1}$ and $q_h = 0$ in (18) and using the Cauchy-Schwarz inequality, we have

$$\frac{1}{2}\|\bar{D}\boldsymbol{u}_{h}^{n+1}\|_{H}^{2} + a(\boldsymbol{u}_{h}^{n+1}, \bar{D}\boldsymbol{u}_{h}^{n+1}) + b(p_{h}^{n+1}, \bar{D}\boldsymbol{u}_{h}^{n+1}) = \frac{1}{2}\|\boldsymbol{f}(t_{n+1})\|_{H}^{2}, \tag{26}$$

On the other hand, for $1 \le n \le N-1$, testing (18) at the time levels n and n+1 with $v_h = \mathbf{0}$ and $q_h = p_h^{n+1}$ we have

$$b(p_h^{n+1}, \mathbf{u}_h^{n+1}) = j(p_h^{n+1}, p_h^{n+1}),$$

$$b(p_h^{n+1}, \mathbf{u}_h^{n}) = j(p_h^{n}, p_h^{n+1}).$$
(27)

Therefore, by substracting these equalities and using the bi-linearity of $j(\cdot,\cdot)$, we obtain

$$b(p_h^{n+1}, \bar{D}u_h^{n+1}) = j(\bar{D}p_h^{n+1}, p_h^{n+1}), \tag{28}$$

for $1 \le n \le N-1$. It then follows, from (26), that

$$\frac{1}{2}\|\bar{D}\boldsymbol{u}_{h}^{n+1}\|_{H}^{2} + a(\boldsymbol{u}_{h}^{n+1}, \bar{D}\boldsymbol{u}_{h}^{n+1}) + j(p_{h}^{n+1}, \bar{D}p_{h}^{n+1}) \le \frac{1}{2}\|\boldsymbol{f}(t_{n+1})\|_{H}^{2}.$$
(29)

On the other hand, using the symmetry and bi-linearity of $a(\cdot,\cdot)$ and $j(\cdot,\cdot)$, we have

$$\begin{split} a(\boldsymbol{u}_h^{n+1}, \bar{D}\boldsymbol{u}_h^{n+1}) &= \frac{1}{2}\bar{D}a(\boldsymbol{u}_h^{n+1}, \boldsymbol{u}_h^{n+1}) + \frac{\delta t}{2}a(\bar{D}\boldsymbol{u}_h^{n+1}, \bar{D}\boldsymbol{u}_h^{n+1}), \\ j(p_h^{n+1}, \bar{D}p_h^{n+1}) &= \frac{1}{2}\bar{D}j(p_h^{n+1}, p_h^{n+1}) + \frac{\delta t}{2}j(\bar{D}p_h^{n+1}, \bar{D}p_h^{n+1}). \end{split}$$

$$\|\bar{D}\boldsymbol{u}_{h}^{n+1}\|_{H}^{2} + \bar{D}\left(a(\boldsymbol{u}_{h}^{n+1}, \boldsymbol{u}_{h}^{n+1}) + j(p_{h}^{n+1}, p_{h}^{n+1})\right) \leq \|\boldsymbol{f}(t_{n+1})\|_{H}^{2},$$

for $1 \le n \le N-1$. After multiplication by δt and summation over $1 \le m \le n-1$, it follows

$$\sum_{m=1}^{n-1} \delta t \|\bar{D}\boldsymbol{u}_{h}^{m+1}\|_{H}^{2} + \|(\boldsymbol{u}_{h}^{n}, p_{h}^{n})\|_{h}^{2} \leq \|(\boldsymbol{u}_{h}^{1}, p_{h}^{1})\|_{h}^{2} + \sum_{m=1}^{n-1} \delta t \|\boldsymbol{f}(t_{m+1})\|_{H}^{2}.$$
(30)

In order to highlight the impact of the intial velocity approximation on the stability of the time derivative, we consider now the first time level (n=0) of (18). By testing with $\boldsymbol{v}_h = \bar{D}\boldsymbol{u}_h^1$, $q_h = 0$, after multiplication by $2\delta t$ and using the symmetry and bi-linearity of $a(\cdot,\cdot)$, we get

$$\delta t \|\bar{D}\boldsymbol{u}_{h}^{1}\|_{H}^{2} + a(\boldsymbol{u}_{h}^{1}, \boldsymbol{u}_{h}^{1}) - a(\boldsymbol{u}_{h}^{0}, \boldsymbol{u}_{h}^{0}) + 2\delta t b(p_{h}^{1}, \bar{D}\boldsymbol{u}_{h}^{1}) \le \delta t \|\boldsymbol{f}(t_{1})\|_{H}^{2}. \tag{31}$$

If the initial velocity approximation is given in terms of the Ritz-projection, $oldsymbol{u}_h^0$ = $P_h^k(\boldsymbol{u}_0,0)$ with $\boldsymbol{u}_0 \in [H^1(\Omega)]^d$, by setting $p_h^0 \stackrel{\text{def}}{=} R_h^l(\boldsymbol{u}_0,0)$ it follows that (27) also holds for n = 0. Therefore,

$$b(p_h^1, \bar{D}u_h^1) = j(\bar{D}p_h^1, p_h^1), \tag{32}$$

Thus, from the symmetry and bi-linearity of $j(\cdot, \cdot)$ and (31), we have

$$\delta t \|\bar{D}\boldsymbol{u}_{h}^{1}\|_{H}^{2} + \|(\boldsymbol{u}_{h}^{1}, p_{h}^{1})\|_{h}^{2} \leq \|(\boldsymbol{u}_{h}^{0}, p_{h}^{0})\|_{h}^{2} + \delta t \|\boldsymbol{f}(t_{1})\|_{H}^{2}.$$
(33)

Estimate (24) is obtained by adding this last inequality to (30) and using the stability of

the Ritz-projection (16), $\|(\boldsymbol{u}_h^0, p_h^0)\|_h^2 \leq C \|\boldsymbol{u}_0\|_V^2$. If the initial velocity approximation is given in terms of a general interpolant, $\boldsymbol{u}_h^0 = \mathcal{I}_h^k \boldsymbol{u}_0$ with $\mathbf{u}_0 \in [H^r(\Omega) \cap H_0^1(\Omega)]^d \cap H_0(\text{div}; \Omega)$, equality (32) does not hold in general. Instead, we can use an approximation argument to obtain

$$b(p_h^1, \bar{D}\boldsymbol{u}_h^1) = \frac{1}{\delta t} \left(j(p_h^1, p_h^1) - \left(p_h^1, \boldsymbol{\nabla} \cdot (\mathcal{I}_h^k \boldsymbol{u}_0 - \boldsymbol{u}_0) \right) \right)$$

$$\geq \frac{1}{\delta t} j(p_h^1, p_h^1) - \frac{C_{\mathcal{I}}}{\delta t} \left(\nu h^{2(r_u - 1)} \|p_h^1\|_Q^2 + \|\boldsymbol{u}_0\|_{r_u, \Omega}^2 \right),$$
(34)

with $r_{\mathbf{u}} \stackrel{\text{def}}{=} \min\{k+1,r\}$. As a result, from (31), it follows that

$$\begin{split} \delta t \| \bar{D} \boldsymbol{u}_h^1 \|_H^2 + \left\| (\boldsymbol{u}_h^1, p_h^1) \right\|_h^2 &\leq a(\boldsymbol{u}_h^0, \boldsymbol{u}_h^0) \\ &+ C_{\mathcal{I}} \left(\nu h^{2(r_u - 1)} \| p_h^1 \|_Q^2 + \| \boldsymbol{u}_0 \|_{r_u, \Omega}^2 \right) + \delta t \| \boldsymbol{f}(t_1) \|_H^2. \end{split}$$

We conclude the proof by adding this equality to (30) and using the stability of the Ritz-projection. \square

The next Corollary closes the problem of the stability of the pressures by combining the results of Theorems 4.1 and 4.2.

Corollary 4.1 Let $\{(u_h^n, p_h^n)\}_{n=1}^N$ be the solution of the fully discrete problem (18). Then:

• If $\mathbf{u}_0 \in [H^1(\Omega)]^d$ and $\mathbf{u}_h^0 = P_h^k(\mathbf{u}_0, 0)$, the following estimate holds for $1 \le n \le N$:

$$\sum_{m=0}^{n-1} \delta t \|p_h^{m+1}\|_Q^2 \le \frac{C}{\beta^2 \nu} \|\boldsymbol{u}_0\|_V^2 + \frac{C}{\beta^2} \sum_{k=0}^{n-1} \delta t \left(\|(\boldsymbol{u}_h^{m+1}, p_h^{m+1})\|_h^2 + \nu^{-1} \|\boldsymbol{f}(t_{m+1})\|_H^2 \right). \tag{35}$$

• If $\mathbf{u}_0 \in [H^r(\Omega) \cap H_0^1(\Omega)]^d \cap H_0(\operatorname{div}; \Omega)$, $r \geq 2$, $\mathbf{u}_h^0 = \mathcal{I}_h^k \mathbf{u}_0$ and

$$\frac{2C_{\mathcal{I}}}{\beta^2}h^{2(r_u-1)} \le \delta t,\tag{36}$$

the following estimate holds for $1 \le n \le N$:

$$\sum_{m=0}^{n-1} \delta t \| p_h^{m+1} \|_Q^2 \le \frac{C}{\beta^2 \nu} \left(\| \boldsymbol{u}_0 \|_V^2 + \| \boldsymbol{u}_0 \|_{r_{\boldsymbol{u}}, \Omega}^2 \right) + \frac{C}{\beta^2} \sum_{m=0}^{n-1} \delta t \left(\| (\boldsymbol{u}_h^{m+1}, p_h^{m+1}) \|_h^2 + \nu^{-1} \| \boldsymbol{f}(t_{m+1}) \|_H^2 \right), \quad (37)$$

with $r_{\mathbf{u}} \stackrel{\text{def}}{=} \min\{k+1, r\}.$

Proof. Estimate (37) is a direct consequence of Theorem 4.1 and estimate (24). On the other hand, from Theorem 4.1 and estimate (25), we have

$$\begin{split} \left(\beta^{2}\delta t - C_{\mathcal{I}}h^{2(r_{u}-1)}\right) \|p_{h}^{1}\|_{Q}^{2} + \beta^{2} \sum_{m=1}^{n-1} \delta t \|p_{h}^{m+1}\|_{Q}^{2} \\ &\leq \frac{C}{\nu} \left(\|\boldsymbol{u}_{0}\|_{V}^{2} + \|\boldsymbol{u}_{0}\|_{r_{u},\Omega}^{2}\right) + C \sum_{m=0}^{n-1} \delta t \left(\|(\boldsymbol{u}_{h}^{m+1}, p_{h}^{m+1})\|_{h}^{2} + \nu^{-1}\|\boldsymbol{f}(t_{m+1})\|_{H}^{2}\right), \end{split}$$

which combined with the stability condition (36) leads to (37). \square

A few observations are now in order. Corollary 4.1 states the unconditional stability of the pressure provided the intial velocity approximation \boldsymbol{u}_h^0 is given in terms of the Ritz-projection operator (15). In the general case, *i.e.* whenever \boldsymbol{u}_h^0 does not satisfy a discrete divergence free condition (as \boldsymbol{u}_h^1 does), only conditional stability can be guaranteed. As a matter of fact, from the stability condition (36), pressure instabilities are expected for very small time steps. This issue will be illustrated by numerical experiments in section 7.

Finally, let us mention that residual based stabilization methods, combined with finite differences time discretization schemes, are known to give rise to pressure instabilities in the small time step limit, see [3, 15]. Indeed, it has been shown in [3] that the finite diference/pressure coupling of the stabilization perturbs the coercivity of the discrete pressure operator unless a condition of the type

$$Ch^2 < \delta t, \tag{38}$$

is satisfied. It is worth emphasizing that, although the stability conditions (38) and (36) are somehow similar, their nature is different. Actually, the instabilities anticipated by Corollary 4.1 are related to the discrete divergence free character of the initial velocity approximation, but not to the structure of the pressure stabilization $j(\cdot, \cdot)$.

4.2 Second order A-stable schemes

In this paragraph we discuss how the results of Theorems 4.1 and 4.2 and Corollary 4.1 extend to the second order time stepping schemes Crank-Nicholson and BDF2.

Crank-Nicholson

The following theorem summarizes the resulting stability estimates.

Theorem 4.3 Let \mathbf{u}_h^0 be a given H-stable approximation of \mathbf{u}_0 in $[V_h^k]^d$ and $\{(\mathbf{u}_h^n, p_h^n)\}_{n=1}^N$ be the solution of the discrete scheme (19). Then the following estimate holds for $1 \le n \le N$:

$$\|\boldsymbol{u}_h^n\|_H^2 + \sum_{m=0}^{n-1} \delta t \|(\boldsymbol{u}_h^{m+\frac{1}{2}}, p_h^{m+1})\|_h^2 \le \|\boldsymbol{u}_0\|_H^2 + \frac{C_{\mathrm{P}}^2}{\nu} \sum_{m=0}^{n-1} \delta t \|\boldsymbol{f}(t_{m+\frac{1}{2}})\|_H^2.$$

Moreover, if $\mathbf{u}_0 \in [H^1(\Omega)]^d$ and $\mathbf{u}_h^0 = P_h^k(\mathbf{u}_0, 0)$, the following estimate holds for $1 \le n \le N$:

$$\sum_{m=0}^{n-1} \delta t \|p_h^{m+1}\|_Q^2 \leq \frac{C}{\beta^2 \nu} \|\boldsymbol{u}_0\|_V^2 + \frac{C}{\beta^2} \sum_{m=0}^{n-1} \delta t \left(\|(\boldsymbol{u}_h^{m+\frac{1}{2}}, p_h^{m+1})\|_h^2 + \nu^{-1} \|\boldsymbol{f}(t_{m+\frac{1}{2}})\|_H^2 \right).$$

On the other hand, if $\mathbf{u}_0 \in [H^r(\Omega) \cap H_0^1(\Omega)]^d \cap H_0(\operatorname{div}; \Omega)$, $r \geq 2$, $\mathbf{u}_h^0 = \mathcal{I}_h^k \mathbf{u}_0$ and the stability condition (36) is satisfied, the following estimate holds for $1 \leq n \leq N$:

$$\begin{split} \sum_{m=0}^{n-1} \delta t \| p_h^{m+1} \|_Q^2 & \leq \frac{C}{\beta^2 \nu} \left(\| \boldsymbol{u}_0 \|_V^2 + \| \boldsymbol{u}_0 \|_{r_{\boldsymbol{u}}, \Omega}^2 \right) \\ & + \frac{C}{\beta^2} \sum_{m=0}^{n-1} \delta t \left(\| (\boldsymbol{u}_h^{m+\frac{1}{2}}, p_h^{m+1}) \|_h^2 + \nu^{-1} \| \boldsymbol{f}(t_{m+\frac{1}{2}}) \|_H^2 \right). \end{split}$$

Proof. The first estimate, corresponding to Theorem 4.1, holds by taking $\boldsymbol{v}_h = \boldsymbol{u}_h^{n+\frac{1}{2}}$ and $q_h = p_h^{n+1}$ in (19).

The pressure estimates require an *a priori* estimation of the discrete time derivative. As

The pressure estimates require an a priori estimation of the discrete time derivative. As in Theorem 4.2, such an estimate can be obtained by taking $\boldsymbol{v}_h = \bar{D}\boldsymbol{u}_h^{n+1}$ and $q_h = 0$ in (19), for $0 \le n \le N-1$. The main difference, with respect to the proof of Theorem 4.2, arises in the treatment of the coupling term $b(p_h^{n+1}, \bar{D}\boldsymbol{u}_h^{n+1})$. Indeed, in the Crank-Nicholson scheme incompresibility is enforced on $\boldsymbol{u}_h^{n+\frac{1}{2}}$ instead of \boldsymbol{u}_h^{n+1} . We first note that, since

$$u_h^{n+1} - u_h^n = 2\left(u_h^{n+\frac{1}{2}} - u_h^n\right), \quad u_h^n = 2u_h^{n-1+\frac{1}{2}} - u_h^{n-1},$$

we have

$$oldsymbol{u}_h^{n+1} - oldsymbol{u}_h^n = 2oldsymbol{u}_h^{n+rac{1}{2}} + 4\sum_{l=1}^n (-1)^l oldsymbol{u}_h^{n-l+rac{1}{2}} - (-1)^n 2oldsymbol{u}_h^0,$$

for $0 \le n \le N-1$. Therefore, from (19) and using the bi-linearity of $j(\cdot,\cdot)$, we get

$$b(p_h^{n+1}, \boldsymbol{u}_h^{n+1} - \boldsymbol{u}_h^n) = j \left(2p_h^{n+1} + 4\sum_{l=1}^n (-1)^l p_h^{n-l+1}, p_h^{n+1} \right) - 2(-1)^n b(p_h^{n+1}, \boldsymbol{u}_h^0). \tag{39}$$

We now introduce the following change of variables for the pressure: Let $\tilde{p}_h^0 \in Q_h^l$ be given (to be specified later on), for $0 \le n \le N-1$ we define $\tilde{p}_h^{n+1} \in Q_h^l$ as $\tilde{p}_h^{n+1} \stackrel{\text{def}}{=} 2p_h^{n+1} - \tilde{p}_h^n$, so that (by construction)

$$p_h^{n+1} = \frac{1}{2} \left(\tilde{p}_h^{n+1} + \tilde{p}_h^n \right),$$
 (40)

for $0 \le n \le N-1$. By inserting this expression in (39) we obtain

$$b(p_h^{n+1}, \boldsymbol{u}_h^{n+1} - \boldsymbol{u}_h^n) = j\left(\tilde{p}_h^{n+1} - \tilde{p}_h^n, p_h^{n+1}\right) + 2(-1)^n \left[j\left(\tilde{p}_h^0, p_h^{n+1}\right) - b\left(p_h^{n+1}, \boldsymbol{u}_h^0\right)\right]. \tag{41}$$

If $\mathbf{u}_h^0 = P_h^k(\mathbf{u}_0, 0)$ and we choose $\tilde{p}_h^0 = R_h^l(\mathbf{u}_0, 0)$, from (15)₂ it follows that the last term in (41) cancels. Thus, using (40), we have

$$\begin{split} b(p_h^{n+1}, \bar{D} \boldsymbol{u}_h^{n+1}) &= j \left(\bar{D} \tilde{p}_h^{n+1}, p_h^{n+1} \right) \\ &= \frac{1}{2} \bar{D} j \left(\tilde{p}_h^{n+1}, \tilde{p}_h^{n+1} \right), \end{split}$$

which corresponds to the Crank-Nicholson's counterpart of (28).

Finally, when the initial velocity approximation is given in terms of a general interpolant, $\boldsymbol{u}_h^0 = \mathcal{I}_h^k \boldsymbol{u}_0$ with $\boldsymbol{u}_0 \in [H^r(\Omega) \cap H_0^1(\Omega)]^d \cap H_0(\operatorname{div}; \Omega)$, we take $\tilde{p}_h^0 = 0$. Therefore, from (41) and using an approximation argument (as in (34)), we get

$$b(p_h^{n+1}, \bar{D}\boldsymbol{u}_h^{n+1}) = \frac{1}{2}\bar{D}j\left(\tilde{p}_h^{n+1}, \tilde{p}_h^{n+1}\right) - \frac{2}{\delta t}(-1)^n b(p_h^{n+1}, \boldsymbol{u}_h^0)$$

$$\geq \frac{1}{2}\bar{D}j\left(\tilde{p}_h^{n+1}, \tilde{p}_h^{n+1}\right) - \frac{2C_{\mathcal{I}}}{\delta t}\left(\nu h^{2(r_{\boldsymbol{u}}-1)} \|p_h^{n+1}\|_Q^2 + \|\boldsymbol{u}_0\|_{r_{\boldsymbol{u}},\Omega}^2\right),$$
(42)

which leads to the stability condition (36). The rest of the proof follows with minor modifications. \square

Remark 4.1 By comparing the proofs of Corollary 4.1 and the previous Theorem we can notice that, when the initial velocity approximation is not discretely divergence free, the Crank-Nicholson scheme enforces the stability condition (36) at each time level (due to (42)), whereas for the Backward Euler scheme that condition is only needed at the first time step (thanks to (28) and (34)).

Second order backward difference

The following theorem summarizes the resulting stability estimates.

Theorem 4.4 Let \mathbf{u}_h^0 be a given H-stable approximation of \mathbf{u}_0 in $[V_h^k]^d$, (u_h^1, p_h^1) be the corresponding first time step of the Backward Euler scheme (18) and $\{(\mathbf{u}_h^n, p_h^n)\}_{n=2}^N$ be the solution of the discrete scheme (20). Then, the following estimate holds for $2 \le n \le N$:

$$\|\boldsymbol{u}_{h}^{n}\|_{H}^{2} + 2\sum_{m=1}^{n-1} \delta t \|(\boldsymbol{u}_{h}^{m+1}, p_{h}^{m+1})\|_{h}^{2} \leq C\left(\|\boldsymbol{u}_{0}\|_{H}^{2} + \|\boldsymbol{u}_{1}\|_{H}^{2}\right) + \frac{2C_{P}^{2}}{\nu}\sum_{m=1}^{n-1} \delta t \|\boldsymbol{f}(t_{m+1})\|_{H}^{2}.$$

Moreover, if $\mathbf{u}_0 \in [H^1(\Omega)]^d$ and $\mathbf{u}_h^0 = P_h^k(\mathbf{u}_0, 0)$, the following estimate holds for $2 \le n \le N$:

$$\begin{split} \sum_{m=1}^{n-1} \delta t \|p_h^{m+1}\|_Q^2 &\leq \frac{C}{\beta^2 \nu} \left(\|\boldsymbol{u}_0\|_V^2 + \|(\boldsymbol{u}_h^1, p_h^1)\|_h^2 \right) \\ &+ \frac{C}{\beta^2} \sum_{m=1}^{n-1} \delta t \left(\|(\boldsymbol{u}_h^{m+1}, p_h^{m+1})\|_h^2 + \nu^{-1} \|\boldsymbol{f}(t_{m+1})\|_H^2 \right). \end{split}$$

On the other hand, if $\mathbf{u}_0 \in [H^r(\Omega) \cap H_0^1(\Omega)]^d \cap H_0(\operatorname{div}; \Omega)$, $r \geq 2$, $\mathbf{u}_h^0 = \mathcal{I}_h^k \mathbf{u}_0$ and the stability condition (36) is satisfied, the following estimate holds for $2 \leq n \leq N$:

$$\begin{split} \sum_{m=1}^{n-1} \delta t \| p_h^{m+1} \|_Q^2 &\leq \frac{C}{\beta^2 \nu} \left(\| \boldsymbol{u}_0 \|_V^2 + \| \boldsymbol{u}_0 \|_{r_{\boldsymbol{u}},\Omega}^2 + \| (\boldsymbol{u}_h^1, p_h^1) \|_h^2 \right) \\ &+ \frac{C}{\beta^2} \sum_{m=1}^{n-1} \delta t \left(\| (\boldsymbol{u}_h^{m+1}, p_h^{m+1}) \|_h^2 + \nu^{-1} \| \boldsymbol{f}(t_{m+1}) \|_H^2 \right). \end{split}$$

Remark 4.2 A bound for the Backward Euler initialization term $\|(\mathbf{u}_h^1, p_h^1)\|_h$, appearing in the above pressure estimate, is provided by Theorem 4.2 with n = 1.

Proof. The first estimate, corresponding to Theorem 4.1, holds by taking $\boldsymbol{v}_h = \boldsymbol{u}_h^{n+1}$ and $q_h = p_h^{n+1}$ in (20) and applying the standard inequality

$$(3a - 4b + c)a = \frac{1}{2} \left[a^2 - b^2 + (2a - b)^2 - (2b - c)^2 + (a - 2b + c)^2 \right]. \tag{43}$$

providing the numerical dissipation of the BDF2 scheme.

Since the pressure estimate is based on the control of the time derivative, we take $\boldsymbol{v}_h = \tilde{D}\boldsymbol{u}_h^{n+1}$ and $q_h = 0$ in (20). In particular, for the coupling term $b\left(p_h^{n+1}, \tilde{D}\boldsymbol{u}_h^{n+1}\right)$, using (20) and (43), we have

$$b\left(p_{h}^{n+1}, \tilde{D}\boldsymbol{u}_{h}^{n+1}\right) = j\left(\tilde{D}p_{h}^{n+1}, p_{h}^{n+1}\right)$$

$$\geq \frac{1}{4}\bar{D}\left(j(p_{h}^{n+1}, p_{h}^{n+1}) + j(2p_{h}^{n+1} - p_{h}^{n}, 2p_{h}^{n+1} - p_{h}^{n})\right),$$
(44)

for $2 \le n \le N-1$, which corresponds to the BDF2 counterpart of (28). On the other hand for n=1, from (20) and (18), we obtain

$$b\left(p_h^2, \tilde{D}u_h^2\right) = \frac{1}{2\delta t} \left(3j(p_h^2, p_h^2) - 4j(p_h^1, p_h^2) + b(p_h^2, u_h^0)\right). \tag{45}$$

If the initial velocity approximation is given in terms of the Ritz-projection, $\boldsymbol{u}_h^0 = P_h^k(\boldsymbol{u}_0, 0)$, it follows that $b(p_h^2, \boldsymbol{u}_h^0) = j(p_h^0, p_h^2)$, with $p_h^0 \stackrel{\text{def}}{=} R_h^l(\boldsymbol{u}_0, 0)$. Thus, (45) reduces to

$$b\left(p_h^2, \tilde{D}\boldsymbol{u}_h^2\right) = j(\tilde{D}p_h^2, p_h^2),$$

so that (44) holds true also for n = 1.

Finally, if the initial velocity approximation is given in terms of a general interpolant, $\boldsymbol{u}_h^0 = \mathcal{I}_h^k \boldsymbol{u}_0$, we apply an approximation argument (as in (34)). Hence, from (45)

$$b\left(p_h^2, \tilde{D}u_h^2\right) \ge \frac{1}{2\delta t} \left[j(p_h^2, p_h^2) - 2j(p_h^1, p_h^1) - C_{\mathcal{I}}\left(\nu h^{2(r_u - 1)} \|p_h^2\|_Q^2 + \|u_0\|_{r_u, \Omega}^2\right) \right]$$
(46)

which is the BDF2 counterpart of (34) and leads to the stability condition (36). The rest of the proof follows with minor modifications. \square

Remark 4.3 When the initial velocity approximation is not discretely divergence free, the BDF2 scheme (20) enforces the stability condition (36) twice: At he first time step (according to (46)) and at the Backward Euler initialization (see Theorem 4.2).

5 Convergence

In this paragraph we provide optimal convergence error estimates for the discrete formulation (18), the Backward Euler scheme.

Theorem 5.1 concerns the convergence for the velocity and gives an estimate for the pressure in terms of the error in the time derivative. Theorem 5.2 closes the question of optimal convergence of the pressure by providing an optimal error estimate for the time derivative, provided the exact pressure is smooth. Finally, Theorem 5.3 provides an improved $L^{\infty}((0,T),H)$ estimate that justifies the initialization of the BDF2 scheme with a Backward Euler step.

The following result expresses the modified Galerkin orthogonality in terms of the consistency error in space and time.

Lemma 5.1 (Consistency error) Let (u, p) be the solution of (1) and $\{(u_h^n, p_h^n)\}_{0 \le n \le N}$ the solution of (18). Assume that $u \in C^0([0, T]; V) \cap C^1((0, T]; H)$ and $p \in C^0((0, T]; Q)$. Then, for $0 \le n \le N - 1$, there holds

$$(\bar{D}\boldsymbol{u}(t_{n+1}) - \bar{D}\boldsymbol{u}_{h}^{n+1}, \boldsymbol{v}_{h}) + a(\boldsymbol{u}(t_{n+1}) - \boldsymbol{u}_{h}^{n+1}, \boldsymbol{v}_{h}) + b(p(t_{n+1}) - p_{h}^{n+1}, \boldsymbol{v}_{h}) - b(q_{h}, \boldsymbol{u}(t_{n+1}) - \boldsymbol{u}_{h}^{n+1}) = j(p_{h}^{n+1}, q_{h}) + (\bar{D}\boldsymbol{u}(t_{n+1}) - \partial_{t}\boldsymbol{u}(t_{n+1}), \boldsymbol{v}_{h}),$$

for all $(\boldsymbol{v}_h, q_h) \in [V_h^k]^d \times Q_h^l$.

Theorem 5.1 Assume that $\mathbf{u} \in H^1(0,T;[H^r(\Omega)]^d) \cap H^2(0,T;[L^2(\Omega)]^d)$ and $p \in C^0((0,T];H^s(\Omega))$ with $r \geq 2$ and $s \geq 1$, and set $\mathbf{u}_h^0 \in [V_h^k]^d$ a given approximation of \mathbf{u}_0 . Then the following estimate holds for $1 \leq n \leq N$:

$$\begin{aligned} \|\boldsymbol{u}_{h}^{n} - \boldsymbol{u}(t_{n})\|_{H}^{2} + \sum_{m=0}^{n-1} \delta t \|(\boldsymbol{u}_{h}^{m+1} - \boldsymbol{u}(t_{m+1}), p_{h}^{m+1})\|_{h}^{2} &\leq \|\mathcal{I}_{h}^{k} \boldsymbol{u}_{0} - \boldsymbol{u}_{h}^{0}\|_{H}^{2} \\ &+ C h^{2r_{\boldsymbol{u}}} \left(\|\boldsymbol{u}\|_{C^{0}([t_{1}, t_{n}]; H^{r_{\boldsymbol{u}}}(\Omega))}^{2} + \nu^{-1} \|\partial_{t} \boldsymbol{u}\|_{L^{2}(0, t_{n}; H^{r_{\boldsymbol{u}}}(\Omega))}^{2} \right) \\ &+ C \left(\frac{\delta t^{2}}{\nu} \|\partial_{tt} \boldsymbol{u}\|_{L^{2}(0, t_{n}; H)}^{2} + \frac{h^{2s_{p}}}{\nu} t_{n} \|p\|_{C^{0}([t_{1}, t_{n}]; H^{s_{p}}(\Omega))}^{2} + \nu h^{2(r_{\boldsymbol{u}} - 1)} t_{n} \|\boldsymbol{u}\|_{C^{0}([t_{1}, t_{n}]; H^{r_{\boldsymbol{u}}}(\Omega))}^{2} \right) \end{aligned}$$

$$\sum_{m=0}^{n-1} \delta t \| p_h^{m+1} - p(t_{m+1}) \|_Q^2 \le C \left(1 + \frac{1}{\beta^2} \right) \frac{h^{2s_p}}{\nu} t_n \| p \|_{C^0([t_1, t_n]; H^{s_p}(\Omega))}^2$$

$$+ \frac{C}{\beta^2} \sum_{m=0}^{n-1} \delta t \left(\| (\boldsymbol{u}_h^{m+1} - \boldsymbol{u}(t_{m+1}), p_h^{m+1}) \|_h^2 + \nu^{-1} \| \partial_t \boldsymbol{u}(t_{m+1}) - \bar{D} \boldsymbol{u}_h^{m+1} \|_H^2 \right),$$

with C > 0 a positive constant independent of h, δt and ν .

Proof. The error estimate for the velocity follows standard energy arguments, and for the pressure we use the modified inf-sup condition (12). We start by decomposing the velocity and pressure error using, respectively, the projection \mathcal{I}_h^k and Π_h^l . This yields,

$$\mathbf{u}(t_{n+1}) - \mathbf{u}_{h}^{n+1} = \underbrace{\mathbf{u}(t_{n+1}) - \mathcal{I}_{h}^{k} \mathbf{u}(t_{n+1})}_{\boldsymbol{\theta}_{\pi}^{n+1}} + \underbrace{\mathcal{I}_{h}^{k} \mathbf{u}(t_{n+1}) - \mathbf{u}_{h}^{n+1}}_{\boldsymbol{\theta}_{h}^{n+1}} = \underbrace{\boldsymbol{\theta}_{\pi}^{n+1} + \boldsymbol{\theta}_{h}^{n+1}}_{\boldsymbol{\eta}_{h}^{n+1}},$$

$$p(t_{n+1}) - p_{h}^{n+1} = \underbrace{p(t_{n+1}) - \Pi_{h}^{l} p(t_{n+1})}_{\boldsymbol{y}_{\pi}^{n+1}} + \underbrace{\Pi_{h}^{l} p(t_{n+1}) - p_{h}^{n+1}}_{\boldsymbol{y}_{h}^{n+1}} = y_{\pi}^{n+1} + y_{h}^{n+1}.$$

$$(47)$$

The first term $\boldsymbol{\theta}_{\pi}^{n+1}$ can bounded using approximation (9). In order to estimate $\boldsymbol{\theta}_{h}^{n+1}$ we first note, using (23) and the coercivity of the bi-linear form $a(\cdot,\cdot)+j(\cdot,\cdot)$

$$\frac{1}{2}\bar{D}\|\boldsymbol{\theta}_{h}^{n+1}\|_{H}^{2} + \|(\boldsymbol{\theta}_{h}^{n+1}, y_{h}^{n+1})\|_{h}^{2} \leq (\bar{D}\boldsymbol{\theta}_{h}^{n+1}, \boldsymbol{\theta}_{h}^{n+1}) + \|(\boldsymbol{\theta}_{h}^{n+1}, y_{h}^{n+1})\|_{h}^{2} \\
\leq (\bar{D}\boldsymbol{\theta}_{h}^{n+1}, \boldsymbol{\theta}_{h}^{n+1}) + a(\boldsymbol{\theta}_{h}^{n+1}, \boldsymbol{\theta}_{h}^{n+1}) + b(y_{h}^{n+1}, \boldsymbol{\theta}_{h}^{n+1}) - b(y_{h}^{n+1}, \boldsymbol{\theta}_{h}^{n+1}) + j(y_{h}^{n+1}, y_{h}^{n+1}) \\
T_{1}^{n+1} \qquad (48)$$

In addition, using (47) we have

$$\begin{split} T_1^{n+1} &= -(\bar{D}\boldsymbol{\theta}_\pi^{n+1}, \boldsymbol{\theta}_h^{n+1}) - a(\boldsymbol{\theta}_\pi^{n+1}, \boldsymbol{\theta}_h^{n+1}) + j(\Pi_h^l p(t_{n+1}), y_h^{n+1}) - b(y_\pi^{n+1}, \boldsymbol{\theta}_h^{n+1}) \\ &+ b(y_h^{n+1}, \boldsymbol{\theta}_\pi^{n+1}) + (\bar{D}\boldsymbol{u}(t_{n+1}) - \bar{D}\boldsymbol{u}_h^{n+1}, \boldsymbol{\theta}_h^{n+1}) + a(\boldsymbol{u}(t_{n+1}) - \boldsymbol{u}_h^{n+1}, \boldsymbol{\theta}_h^{n+1}) \\ &+ b(p(t_{n+1}) - p_h^{n+1}, \boldsymbol{\theta}_h^{n+1}) - b(y_h^{n+1}, \boldsymbol{u}(t_{n+1}) - \boldsymbol{u}_h^{n+1}) - j(p_h^{n+1}, y_h^{n+1}). \end{split}$$

By the modified Galerkin orthogonality (Lemma 5.1) this expression reduces to

$$T_1^{n+1} = -\left(\bar{D}\boldsymbol{\theta}_{\pi}^{n+1}, \boldsymbol{\theta}_{h}^{n+1}\right) + \left(\bar{D}\boldsymbol{u}(t_{n+1}) - \partial_t \boldsymbol{u}(t_{n+1}), \boldsymbol{\theta}_{h}^{n+1}\right) - a(\boldsymbol{\theta}_{\pi}^{n+1}, \boldsymbol{\theta}_{h}^{n+1}) + j(\Pi_h^l p(t_{n+1}), y_h^{n+1}) - b(y_{\pi}^{n+1}, \boldsymbol{\theta}^{n+1}) + b(y_h^{n+1}, \boldsymbol{\theta}_{\pi}^{n+1}).$$

$$(49)$$

Now, using the Cauchy-Schwarz and the Poincaré's inequalities and (10), we have

$$T_{1}^{n+1} \leq \underbrace{\left(\|\bar{D}\boldsymbol{u}(t_{n+1}) - \partial_{t}\boldsymbol{u}(t_{n+1})\|_{H} + \|\bar{D}\boldsymbol{\theta}_{\pi}^{n+1}\|_{H}\right)}_{T_{2}^{n+1}} \underbrace{\frac{C_{p}}{\nu^{\frac{1}{2}}} \|(\boldsymbol{\theta}_{h}^{n+1}, y_{h}^{n+1})\|}_{T_{2}^{n+1}} + \left(\|\boldsymbol{\theta}_{\pi}^{n+1}\|_{V} + \|y_{\pi}^{n+1}\|_{Q} + \nu^{\frac{1}{2}} \|h^{-1}\boldsymbol{\theta}_{\pi}^{n+1}\|_{H} + j\left(\Pi_{h}^{l}p(t_{n+1}), \Pi_{h}^{l}p(t_{n+1})\right)^{\frac{1}{2}}\right) \|(\boldsymbol{\theta}_{h}^{n+1}, y_{h}^{n+1})\|.$$

$$(50)$$

The term T_2^{n+1} can be treated, in a standard way (see e.g [25]), using a Taylor expansion and the Cauchy-Schwarz inequality, which yields

$$T_{2}^{n+1} \leq \frac{1}{\delta t} \int_{t_{n}}^{t_{n+1}} (\delta t \| \partial_{tt} \boldsymbol{u}(s) \|_{H} + \| \partial_{t} \boldsymbol{\theta}_{\pi}(s) \|_{H}) \, \mathrm{d}s$$

$$\leq \delta t^{\frac{1}{2}} \| \partial_{tt} \boldsymbol{u}(s) \|_{L^{2}((t_{n}, t_{n+1}); H)} + \delta t^{-\frac{1}{2}} \| \partial_{t} \boldsymbol{\theta}_{\pi} \|_{L^{2}((t_{n}, t_{n+1}); H)}.$$
(51)

Thus, from (50), using Young's inequality, it follows that

$$T_{1}^{n+1} \leq \frac{1}{2} \|(\boldsymbol{\theta}_{h}^{n+1}, y_{h}^{n+1})\|^{2} + C \left[\frac{C_{P}^{2}}{\nu} \left(\delta t \|\partial_{tt} \boldsymbol{u}\|_{L^{2}((t_{n}, t_{n+1}); H)}^{2} + \delta t^{-1} \|\partial_{t} \boldsymbol{\theta}_{\pi}\|_{L^{2}((t_{n}, t_{n+1}); H)}^{2} \right) + \|\boldsymbol{\theta}_{\pi}^{n+1}\|_{V}^{2} + \|y_{\pi}^{n+1}\|_{Q}^{2} + \nu \|h^{-1} \boldsymbol{\theta}_{\pi}^{n+1}\|_{H}^{2} + j \left(\Pi_{h}^{l} p(t_{n+1}), \Pi_{h}^{l} p(t_{n+1}) \right) \right]$$

By inserting this expression in (48), multiplying the resulting expression by $2\delta t$ and after summation over $0 \le m \le n-1$ we obtain

$$\begin{split} \|\boldsymbol{\theta}_{h}^{n}\|_{H}^{2} + \sum_{m=0}^{n-1} \delta t \|(\boldsymbol{\theta}_{h}^{m+1}, y_{h}^{m+1})\|_{h}^{2} &\leq \|\boldsymbol{\theta}_{h}^{0}\|_{H}^{2} + C \bigg[\delta t^{2} \nu^{-1} \|\partial_{tt} \boldsymbol{u}\|_{L^{2}(0, t_{n}; H)}^{2} + \nu^{-1} \|\partial_{t} \boldsymbol{\theta}_{\pi}\|_{L^{2}(0, t_{n}; H)}^{2} \\ &+ \sum_{m=0}^{n-1} \delta t \bigg(\|\boldsymbol{\theta}_{\pi}^{m+1}\|_{V}^{2} + \|y_{\pi}^{m+1}\|_{Q}^{2} + \nu \|h^{-1} \boldsymbol{\theta}_{\pi}^{m+1}\|_{H}^{2} + j \Big(\Pi_{h}^{l} p(t_{m+1}), \Pi_{h}^{l} p(t_{m+1}) \Big) \bigg) \bigg]. \end{split}$$

Finally, the velocity error estimate is obtained using approximation (9) and the consistency of the pressure stabilization (7), which yields

For the pressure error estimate we first note that, from (47), it suffices to control $||y_h^{n+1}||_{0,\Omega}$. To this aim, we use the modified inf-sup condition (12):

As a result, from the above estimations we have:

Therefore,

$$\beta^{2} \sum_{m=0}^{n-1} \delta t \|y_{h}^{m+1}\|_{Q}^{2} \leq C \sum_{m=0}^{n-1} \delta t \Big(\|y_{\pi}^{m+1}\|_{Q}^{2} + \|(\boldsymbol{u}(t_{m+1}) - \boldsymbol{u}_{h}^{m+1}, y_{h}^{m+1})\|_{h}^{2} + \nu^{-1} \|\partial_{t} \boldsymbol{u}(t_{m+1}) - \bar{D}\boldsymbol{u}_{h}^{m+1}\|_{H}^{2} \Big),$$

and we conclude using approximation and the error estimate for the velocity. \square

We close the problem of the pressure convergence by providing an error estimate for the time derivative of the velocity.

Theorem 5.2 Under the assumptions of Theorem 5.1, assuming that $p \in C^0([0,T]; H^s(\Omega))$, $u_0 \in V \cap H_0(\operatorname{div}; \Omega)$ and if $u_h^0 \stackrel{\text{def}}{=} P_h^k(u_0, 0)$, for $1 \leq n \leq N$, we have

$$\begin{split} \sum_{m=0}^{n-1} \delta t \left\| \bar{D} \boldsymbol{u}_{h}^{m+1} - \partial_{t} \boldsymbol{u}(t_{m+1}) \right\|_{H}^{2} + \left\| \left(P_{h}^{k} \left(\boldsymbol{u}(t_{n}), p(t_{n}) \right) - \boldsymbol{u}_{h}^{n}, R_{h}^{l} \left(\boldsymbol{u}(t_{n}), p(t_{n}) \right) - p_{h}^{n} \right) \right\|_{h}^{2} \\ & \leq C \left(\delta t^{2} \| \partial_{tt} \boldsymbol{u} \|_{L^{2}(0,T;H)}^{2} + h^{2r_{\boldsymbol{u}}} \| \partial_{t} \boldsymbol{u} \|_{L^{2}(0,T;H^{r_{\boldsymbol{u}}}(\Omega))}^{2} \right) + C \frac{h^{2s_{p}}}{\nu} \| p(0) \|_{s_{p},\Omega}^{2}. \end{split}$$

Proof. In order to provide an optimal error estimate, we decompose the error in terms of the Ritz-projection operator (15)

= \boldsymbol{\theta}_{\pi}^{n+1} + \boldsymbol{\theta}_{h}^{n+1}, \\
p(t_{n+1}) - p_{h}^{n+1} = \underbrace{p(t_{n+1}) - R_{h}^{l}(\mathbf{u}(t_{n+1}), p(t_{n+1}))}_{\boldsymbol{y}_{\pi}^{n+1}} + \underbrace{R_{h}^{l}(\mathbf{u}(t_{n+1}), p(t_{n+1})) - p_{h}^{n+1}}_{\boldsymbol{y}_{h}^{n+1}} \\
= y_{\pi}^{n+1} + y_{h}^{n+1}.$$
(53)

Using the triangle inequality we then have

$$\sum_{m=0}^{n-1} \delta t \| \partial_t \boldsymbol{u}(t_{m+1}) - \bar{D} \boldsymbol{u}_h^{m+1} \|_H^2 \\
\leq C \sum_{m=0}^{n-1} \delta t \left(\| \partial_t \boldsymbol{u}(t_{m+1}) - \bar{D} \boldsymbol{u}(t_{m+1}) \|_H^2 + \| \bar{D} \boldsymbol{\theta}_{\pi}^{m+1} \|_H^2 + \| \bar{D} \boldsymbol{\theta}_h^{m+1} \|_H^2 \right). \quad (54)$$

For the first term we proceed as in (51) using a Taylor expansion, which yields

Finally, for the third term we use the modified Galerkin orthogonality (Lemma (5.1) with $q_h = 0$) and the definition of the Ritz-projection (15) to obtain

$$\begin{split} \|\bar{D}\boldsymbol{\theta}_{h}^{n+1}\|_{H}^{2} + a(\boldsymbol{\theta}_{h}^{n+1}, \bar{D}\boldsymbol{\theta}_{h}^{n+1}) + b(y_{h}^{n+1}, \bar{D}\boldsymbol{\theta}_{h}^{n+1}) \\ &= -(\bar{D}\boldsymbol{\theta}_{\pi}^{n+1}, \bar{D}\boldsymbol{\theta}_{h}^{n+1}) - a(\boldsymbol{\theta}_{\pi}^{n+1}, \bar{D}\boldsymbol{\theta}_{h}^{n+1}) - b(y_{\pi}^{n+1}, \bar{D}\boldsymbol{\theta}_{h}^{n+1}) + (\bar{D}\boldsymbol{u}(t_{n+1}) - \partial_{t}\boldsymbol{u}(t_{n+1}), \bar{D}\boldsymbol{\theta}_{h}^{n+1}) \\ &= -(\bar{D}\boldsymbol{\theta}_{\pi}^{n+1}, \bar{D}\boldsymbol{\theta}_{h}^{n+1}) + (\bar{D}\boldsymbol{u}(t_{n+1}) - \partial_{t}\boldsymbol{u}(t_{n+1}), \bar{D}\boldsymbol{\theta}_{h}^{n+1}). \end{split}$$

Young's inequality yields:

$$\frac{1}{2} \|\bar{D}\boldsymbol{\theta}_{h}^{n+1}\|_{H}^{2} + a(\boldsymbol{\theta}_{h}^{n+1}, \bar{D}\boldsymbol{\theta}_{h}^{n+1}) + b(y_{h}^{n+1}, \bar{D}\boldsymbol{\theta}_{h}^{n+1}) \\
\leq C \left(\|\bar{D}\boldsymbol{\theta}_{\pi}^{n+1}\|_{H}^{2} + \|\bar{D}\boldsymbol{u}(t_{n+1}) - \partial_{t}\boldsymbol{u}(t_{n+1})\|_{H}^{2} \right).$$

In addition, for $0 \le n \le N$, testing (15) at the time level n with $v_h = 0$ we have

$$b(q_h, P_h^k(\boldsymbol{u}(t_n), p(t_n))) = j(R_h^l(\boldsymbol{u}(t_n), p(t_n)), q_h).$$
(56)

On the other hand, for $1 \le n \le N$, testing (18) at the time level n with $\boldsymbol{v}_h = \boldsymbol{0}$ and since, by definition, $\boldsymbol{u}_h^0 \stackrel{\text{def}}{=} P_h^k(\boldsymbol{u}_0, 0)$ we have

for all $q_h \in Q_h^l$ and $0 \le n \le N$ and where we have defined $p_h^0 \stackrel{\text{def}}{=} R_h^l(\boldsymbol{u}_0, 0)$. As a result, from (56)-(57), we have

$$j(y_h^{n+1}, \bar{D}y_h^{n+1}) = \frac{1}{2}\bar{D}j(y_h^{n+1}, y_h^{n+1}) + \frac{\delta t}{2}j(\bar{D}y_h^{n+1}, \bar{D}y_h^{n+1}).$$

So that

$$\frac{1}{2} \|\bar{D}\boldsymbol{\theta}_{h}^{n+1}\|_{H}^{2} + \frac{1}{2} \bar{D} \left(a(\boldsymbol{\theta}_{h}^{n+1}, \boldsymbol{\theta}_{h}^{n+1}) + j(y_{h}^{n+1}, y_{h}^{n+1}) \right) \\
\leq \|\bar{D}\boldsymbol{\theta}_{\pi}^{n+1}\|_{H}^{2} + \|\bar{D}\boldsymbol{u}(t_{n+1}) - \partial_{t}\boldsymbol{u}(t_{n+1})\|_{H}^{2}.$$

So that, after multiplication by $2\delta t$ and summation over $0 \le n \le N-1$ we have

$$\sum_{m=0}^{n-1} \delta t \|\bar{D}\boldsymbol{\theta}_{h}^{m+1}\|_{H}^{2} + \|(\boldsymbol{\theta}_{h}^{n}, y_{h}^{n})\|_{h}^{2} \leq \|(\boldsymbol{\theta}_{h}^{0}, y_{h}^{0})\|_{h}^{2} + C \sum_{m=0}^{n-1} \delta t \left(\|\bar{D}\boldsymbol{\theta}_{\pi}^{m+1}\|_{H}^{2} + \|\bar{D}\boldsymbol{u}(t_{m+1}) - \partial_{t}\boldsymbol{u}(t_{m+1})\|_{H}^{2}\right).$$
(58)

For the initial terms we use the linearity of the Ritz-projection and its approximation properties (Lemma 3.2) to obtain

$$\begin{aligned} \|(\boldsymbol{\theta}_{h}^{0}, y_{h}^{0})\|_{h}^{2} &= \|(P_{h}^{k}(\mathbf{0}, p(0)), R_{h}^{l}(\mathbf{0}, p(0)))\|_{h}^{2} \\ &\leq \frac{C}{\nu} h^{2s_{p}} \|p(0)\|_{s_{p}, \Omega}^{2}. \end{aligned}$$

Therefore, using (55) and (51), we have

$$\sum_{m=0}^{n-1} \delta t \|\bar{D}\boldsymbol{\theta}_h^{m+1}\|_H^2 + \|(\boldsymbol{\theta}_h^n, y_h^n)\|_h^2 \leq C \left(\frac{h^{2s_p}}{\nu} \|p(0)\|_{s_p, \Omega}^2 + \delta t^2 \|\partial_{tt}\boldsymbol{u}\|_{L^2(0, t_n; H)}^2\right),$$

for $1 \leq n \leq N$. \square

Finally, for completeness we here give a result of optimal convergence in the $L^{\infty}((0,T),H)$ norm. For this we assume that the domain Ω is such that the optimal convergence in the H-norm holds for the Ritz-projection (see Lemma 3.2). This result is of importance since it shows that the initialization of the BDF2 method using one BDF1 step is justified (*i.e.* we keep error optimality in time).

We first prove the following Lemma, which provides a sort of *optimal invariance* of the Ritz-projection velocity, P_h^k , with respect to the pressure argument.

Lemma 5.2 Let $p \in H^s(\Omega)$ with $s \ge 1$. The following estimate holds

$$\| (P_h^k(\mathbf{0}, p), R_h^l(\mathbf{0}, p)) \|_h \le C \nu^{-\frac{1}{2}} h^{s_p} \| p \|_{s_p, \Omega}.$$

Moreover, if the domain Ω is sufficiently smooth and $\tilde{l} \geq 1$ there also holds

Proof. This is a corollary of Lemma 3.2 in the case $\alpha = 0$, $\boldsymbol{u} = 0$. \square

Theorem 5.3 Assume that the domain Ω is sufficiently smooth so that the H-estimate (17) holds. Assume also that $\mathbf{u} \in H^1(0,T;[H^r(\Omega)]^d) \cap H^2(0,T;[L^2(\Omega)]^d)$, $p \in C^0([0,T];H^s(\Omega))$ with $r \geq 2$, $s \geq 1$, $\mathbf{u}_0 \in V \cap H_0(\operatorname{div};\Omega)$ and $\mathbf{u}_h^0 \stackrel{\text{def}}{=} P_h^k(\mathbf{u}_0,0)$. Then the following estimate holds for $1 \leq n \leq N$:

$$\|\boldsymbol{u}(t_{n}) - \boldsymbol{u}_{h}^{n}\|_{H} \leq \frac{C}{\nu^{\frac{1}{2}}} \left(h^{r_{\boldsymbol{u}}} \|\boldsymbol{u}_{0}\|_{r_{\boldsymbol{u}},\Omega} + h^{s_{p}+1} \|p(0)\|_{s_{p},\Omega} + h^{r_{\boldsymbol{u}}} \|\partial_{t}\boldsymbol{u}\|_{L^{1}(0,t_{n};H^{r_{\boldsymbol{u}}}(\Omega))} + \delta t \|\partial_{tt}\boldsymbol{u}\|_{L^{1}(0,t_{n};H)} \right).$$

Proof. Since the proof is similar to that of Theorem 5.2 and we will only give the outline. Let $\boldsymbol{\theta}_h^{n+1}$ and y_h^{n+1} be defined as in (53). From (48) and (49), it follows that

Applying now the Cauchy-Schwarz inequality, we have

and by summation over n, we get

for $1 \le n \le N$. The first term in the righthand side can be estimated using Lemma (5.2) since, by definition,

$$\boldsymbol{\theta}_{h}^{0} = P_{h}^{k}(\boldsymbol{u}(0), p(0)) - \boldsymbol{u}_{h}^{0} = P_{h}^{k}(\boldsymbol{u}_{0}, p(0)) - P_{h}^{k}(\boldsymbol{u}_{0}, 0) = P_{h}^{k}(\boldsymbol{0}, p(0)).$$
(59)

Finally, for the finite difference consistency terms we use a standard argument (see e.g. [28, Theorem 1.5, Page 14]). \square

Remark 5.1 From (59), one could pretend to initialize the time-stepping procedure with $\mathbf{u}_h^0 = P_h^k(\mathbf{u}_0, p(0))$. In practice, however, the initial pressure is unknown, so that the choice $\mathbf{u}_h^0 = P_h^k(\mathbf{u}_0, 0)$ is more convenient. Lemma 5.2 shows that we can preserve optimality while keeping this choice.

Remark 5.2 Note that the above convergence proofs only use stability, Galerkin orthogonality and the truncation error of the finite difference time approximation scheme. Hence the extension to the second order Crank-Nicholson or BDF2 schemes is straightforward. In particular we recall that the estimate of Lemma 5.3 shows that the initialization using one BDF1 step does not make the convergence deteriorate provided the solution is sufficiently smooth under the first timestep. Indeed, for smooth solutions we expect $\|\partial_{tt}\mathbf{u}\|_{L^1(0,\delta t;H)}$ to be $O(\delta t)$ and hence the global convergence will be second order in spite of the intial low order perturbation.

6 Applications

In this section we will review some of the most well-known pressure projection stabilization methods and discuss how they enter the above framework. For detailed results on analysis for the respective methods we refer the reader to the references considering the stationary case.

6.1 The methods of Brezzi-Pitkäranta, Silvester and Bochev-Dohrmann

The original pressure stabilized finite element method was proposed by Brezzi and Pitkäranta in [7]. Here, the velocity and pressure discrete spaces are chosen as the standard finite element space of piecewise affine continuous functions, $[V_h^1]^d \times Q_h^1$. The operator $j(p_h, q_h)$ is given by

$$j(p_h, q_h) = \left(\frac{h^2}{\nu} \nabla p_h, \nabla q_h\right).$$

A variant of this method was recently proposed by Dohrmann and Bochev, in [16], using an equivalent stabilization operator, namely,

$$j(p_h, q_h) = \left(\frac{1}{\nu}(I - \pi_0)p_h, (I - \pi_0)q_h\right)$$

where $\pi_0: Q \longrightarrow Q_h^0$ denotes the (element-wise) projection onto piecewise constants. Property (10) is verified after an integration by parts, with \mathcal{I}_h^1 simply the Lagrange interpolant

$$\begin{aligned} b(q_h, \boldsymbol{v} - \mathcal{I}_h^1 \boldsymbol{v}) &= (\boldsymbol{\nabla} q_h, \boldsymbol{v} - \mathcal{I}_h^1 \boldsymbol{v}) \\ &\leq j(q_h, q_h)^{\frac{1}{2}} \left(h^{-1} \nu^{\frac{1}{2}} \| \boldsymbol{v} - \mathcal{I}_h^1 \boldsymbol{v} \|_H + \| \boldsymbol{v} - \mathcal{I}_h^1 \boldsymbol{v} \|_V \right). \end{aligned}$$

One readily verifies that (6) and (7) hold, and hence our analysis for the time discretization is valid.

Another low order scheme, covered by the analysis, is the method wich consists in using piecewise affine continuous velocities and element wise constants pressures (see e.g. [22]). Stability is obtained by the addition of the jump over element faces of the discontinuous pressure, namely,

$$j(p_h, q_h) = \sum_{K \in \mathcal{T}_h} \int_{\partial K \setminus \partial \Omega} \frac{h}{\nu} \llbracket p_h \rrbracket \llbracket q_h \rrbracket.$$

Here, $[q_h]$ denotes the jump of q_h over the inter-element boundary, defined by,

$$[q_h](x) \stackrel{\text{def}}{=} \lim_{\epsilon \to 0} (q_h(x + \epsilon n) - q_h(x - \epsilon n)), \quad \forall x \in F,$$

with n standing for a fixed, but arbitrary, normal to the internal face F. In this case, (10) is obtained after an integration by parts in the term $b(q_h, \mathbf{v} - \mathcal{I}_h^1 \mathbf{v})$ and an element-wise trace

inequality,

$$b(q_h, \boldsymbol{v} - \mathcal{I}_h^1 \boldsymbol{v}) = -\sum_K \int_{\partial K \setminus \partial \Omega} \llbracket q_h \rrbracket (\boldsymbol{v} - \mathcal{I}_h^1 \boldsymbol{v}) \cdot \boldsymbol{n}$$

$$\leq j(q_h, q_h)^{\frac{1}{2}} \left(h^{-1} \nu^{\frac{1}{2}} \| \boldsymbol{v} - \mathcal{I}_h^1 \boldsymbol{v} \|_H + \| \boldsymbol{v} - \mathcal{I}_h^1 \boldsymbol{v} \|_V \right).$$

In all these cases one may easily show that the following weak consistency property holds, both when l = 0 and l = 1,

$$j(\Pi_h^l p, \Pi_h^l p)^{\frac{1}{2}} \le \frac{C}{\nu^{\frac{1}{2}}} h \| \nabla p \|_H,$$

with Π_h^l being, for instance, the L^2 -projection onto Q_h^l . Hence $\tilde{l}=1$.

For details on the cases of stabilization of the pressure jumps only in macro elements, or the generalization to higher order finite element spaces of the Taylor-Hood family with discontinuous pressures, we refer to [9].

6.2 Orthogonal sub-scale stabilization

The orthogonal sub-scale stabilization was proposed by Codina and Blasco in [13]. Equal order $(k = l \ge 1)$ continuous approximation spaces are used for the velocities and the pressures.

Here the main idea is to penalize the difference between the pressure gradient and its projection onto the finite element space. This imposes the introduction of an auxiliary variable for the projection since it may not be localized and is given only implicitly. Hence, the stabilization operator is given by

$$j(p_h, q_h) = \left(\frac{h^2}{\nu} (\nabla p_h - \pi_h^k \nabla p_h), \nabla q_h\right),$$

where $\pi_h^k : [L^2(\Omega)]^d \longrightarrow [V_h^k]^d$ stands for the L^2 -projection onto $[V_h^k]^d$, which is given as the solution of the (global) problem

$$(\pi_h^k \nabla p_h, \boldsymbol{\xi}_h) = (\nabla p_h, \boldsymbol{\xi}_h), \quad \forall \boldsymbol{\xi}_h \in [V_h^k]^d.$$

One may readily show that (6) and (7) hold. Disregarding for simplicity the boundary conditions, the projection operator $\mathcal{I}_h^k = \pi_h^k$ of (10) is here chosen also as the L^2 -projection onto $[V_h^k]^d$. This can be justified if boundary conditions are imposed weakly for instance using Nitsche's method (see [24, 19]) and V_h^k includes the degrees of freedom on the boundary. Indeed, then we have

$$b(q_h, \boldsymbol{v} - \mathcal{I}_h^k \boldsymbol{v}) = (\boldsymbol{\nabla} q_h - \pi_h^k \boldsymbol{\nabla} q_h, \boldsymbol{v} - \mathcal{I}_h^k \boldsymbol{v})$$

$$\leq j(q_h, q_h)^{\frac{1}{2}} \left(h^{-1} \nu^{\frac{1}{2}} \| \boldsymbol{v} - \mathcal{I}_h^k \boldsymbol{v} \|_H + \| \boldsymbol{v} - \mathcal{I}_h^k \boldsymbol{v} \|_V \right).$$
(60)

Finally, one readily verifies the weak consistency

$$j(\Pi_h^k p, \Pi_h^k p)^{\frac{1}{2}} \le \frac{C}{\mu^{\frac{1}{2}}} h^{s_p} \|p\|_{s_p,\Omega}, \quad \forall p \in H^s(\Omega),$$

with $\Pi_h^k: Q \longrightarrow Q_h^k$ being the L^2 -projection onto $Q_h^k \stackrel{\text{def}}{=} V_h^k$ and $s_p = \min\{k+1, s\}$. In particular, $\tilde{l} = l = k$. The above analysis is hence valid also in this case (with some modifications of technical nature due to the weakly imposed boundary conditions).

6.3 Local projection stabilization

In the local projection stabilization, proposed in [2], stability is obtained by penalizing the projection of the gradient onto piecewise discontinuous functions defined on patches consisting of several elements, obtained by using hierarchic meshes or by penalyzing the gradient of the difference of the pressure and its projection on polynomials of lower polynomial order. The construction relies on the inf-sup stability of a velocity pressure pair typically of mini-element character or of the Taylor-Hood family. Similar ideas were advocated in [16]. The stabilization operator is written as

$$j(p_h, q_h) = \sum_{\tilde{K}} (\frac{h^2}{\nu} \kappa \nabla p_h, \kappa \nabla q_h)$$

where κ is the so called *fluctuation operator* defined as $\kappa \stackrel{\text{def}}{=} I - \tilde{\pi}_h$ where $\tilde{\pi}_h$ denotes a *local* projection operator onto either a polynomial of order k on a macro-patch consisting of three triangles (or four quadrilaterals) or a polynomial of order k-1 on the element. One may show that (10), (6) and (7) hold (for details on the construction of \mathcal{I}_h^k see [2, 4] and for general conditions on the finite element spaces and stabilization operators [23]). In case we consider the projection $\tilde{\pi}_h$ onto polynomials of order k-1 the stabilization operator may be written as

$$j(p_h, q_h) = \sum_{\tilde{K}} \left(\frac{h^2}{\nu} \nabla(\kappa p_h), \nabla(\kappa q_h) \right),$$
 (61)

or, equivalently, following [16],

$$j(p_h, q_h) = \sum_{\tilde{K}} \left(\frac{1}{\nu} \kappa p_h, \kappa q_h \right).$$

In these latter cases, the condition (10) is obtained by choosing \mathcal{I}_h^k as the Fortin interpolation operator associated to $[V_h^k]^d \times \tilde{Q}_h$ where \tilde{Q}_h is the space of continuous piecewise polynomial functions of order k-1. Clearly we then have

$$b(q_h, \boldsymbol{v} - \mathcal{I}_h^k \boldsymbol{v}) = b(\kappa q_h, \boldsymbol{v} - \mathcal{I}_h^k \boldsymbol{v})$$

$$\leq j(q_h, q_h)^{\frac{1}{2}} \left(h^{-1} \nu^{\frac{1}{2}} \| \boldsymbol{v} - \mathcal{I}_h^k \boldsymbol{v} \|_H + \| \boldsymbol{v} - \mathcal{I}_h^k \boldsymbol{v} \|_V \right),$$

since $b(\tilde{q}_h, \boldsymbol{v} - \mathcal{I}_h^k \boldsymbol{v}) = 0$ for all $\tilde{q}_h \in \tilde{Q}_h$. The form (61) is treated in a similar fashion after an integration by parts. One readily verifies the weak consistency

$$j(\Pi_h^l p, \Pi_h^l p)^{\frac{1}{2}} \leq \frac{C}{\nu^{\frac{1}{2}}} h^{s_p} \|p\|_{s_p,\Omega}, \, \forall p \in H^s(\Omega),$$

where $s_p = \min\{\tilde{l}, s, l+1\}$ and $\tilde{l}-1$ denotes the polynomial order of the space on which the local projection is taken. Clearly if we project on polynomials of order k-1 the stabilization operator looses one order in the weak consistency, however the estimates remain optimal since we expect the velocities to be one order more regular than the pressure.

6.4 Continuous interior penalty stabilization

The continuous interior penalty stabilization for the stationary Stokes' problem was proposed in [11] and generalized to the Oseen's problem in [10]. It uses equal order continuous approximation spaces for velocities and pressures $(k = l \ge 1)$ and relies on the fact that the global projection of the pressure gradient onto the finite element space may be controlled by the gradient jumps using an interpolation estimate between discrete spaces. Indeed it was shown on [10] that the following inequality holds

$$||h(\nabla p_h - \tilde{i}\nabla p_h)||_H^2 \le \sum_{K \in \mathcal{T}_h} \int_{\partial K \setminus \partial \Omega} h_K^3 [\![\nabla p_h \cdot \boldsymbol{n}]\!]^2, \tag{62}$$

for a certain Clément-type quasi-interpolation operator \tilde{i} . This motivates the use of the pressure stabilization operator

$$j(p_h, q_h) = \sum_{K \in \mathcal{I}_h} \int_{\partial K \setminus \partial \Omega} \frac{h^3}{\nu} \llbracket \nabla p_h \cdot \boldsymbol{n} \rrbracket \llbracket \nabla q_h \cdot \boldsymbol{n} \rrbracket.$$

Clearly (6) and (7) are verified in this case. Moreover, (10) may be shown to hold if \mathcal{I}_h^k is chosen to be the L^2 -projection onto $[V_h^k]^d$ and boundary conditions are imposed weakly [10]. To show the inequality we combine (60) with (62). Finally, one readily verifies the weak consistency

$$j(\Pi_h^k p, \Pi_h^k p)^{\frac{1}{2}} \le \frac{C}{\nu^{\frac{1}{2}}} h^{s_p} \|p\|_{s_p,\Omega}, \, \forall p \in H^s(\Omega),$$

with Π_h^k the L^2 -projection onto V_h^k and $s_p = \min\{k+1, s\}$, so that $\tilde{l} = l = k$. We refer to [10] for the details on the technical issue related to the weak imposition of the boundary conditions using Nitsche's method.

7 Numerical experiments

In this section we will consider some numerical examples using the continuous interior penalty stabilization (CIP), described in §6.4. All computations have been performed using FreeFem++ [21].

7.1 Convergence rate in time

We consider problem (1) in two dimensions, $\Omega = [0,1] \times [0,1]$ and T = 1, with non-homogeneous boundary conditions. The right hand side \mathbf{f} and the boundary and initial data are chosen in order to ensure that the exact solution is given by:

$$u(x, y, t) = g(t) \begin{pmatrix} \sin(\pi x - 0.7) \sin(\pi y + 0.2) \\ \cos(\pi x - 0.7) \cos(\pi y + 0.2) \end{pmatrix},$$

$$p(x, y, t) = g(t) (\sin(x) \cos(y) + (\cos(1) - 1) \sin(1)),$$

with
$$g(t) = 1 + t^5 + e^{-\frac{t}{10}} + \sin(t)$$
.

In order to illustrate the convergence rate in time of the discrete solution, we have used quadratic approximations in space and a mesh parameter h=0.01. In such case, the stability condition (36) is always satisfied for the range of time steps considered. Thus, the choice of the Lagrange interpolant or of the Ritz-projection as approximation of the initial velocity give similar results.

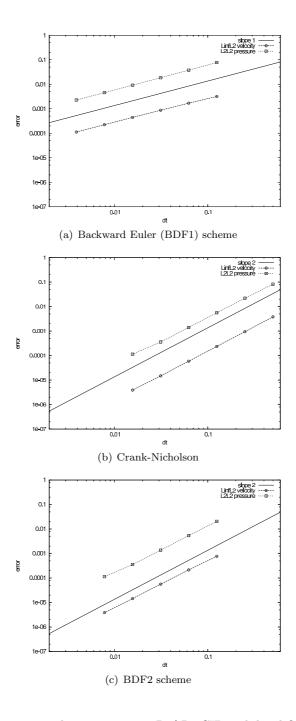


Figure 1: Convergence history in time: $\mathbb{P}_2/\mathbb{P}_2$ CIP stabilized finite elements

In figures 1(a)-(c) we report the convergences of the errors for the velocities ($\|\cdot\|_{L^{\infty}(0,T;L^{2}(\Omega))}$) and the pressures ($\|\cdot\|_{L^{2}(0,T;L^{2}(\Omega))}$) for the first order backward difference formula (BDF1), Crank-Nicholson and the second order backward difference formulas (BDF2). In all the numerical examples both the velocities and the pressures converge at the optimal rate $(O(\delta t))$ for BDF1 and $O(\delta t^{2})$ for Crank-Nicholson and BDF2). The BDF2 scheme was initialized using one step of BDF1.

7.2 Behavior in the small time step limit

In this paragraph we illustrate the impact of the initial velocity approximation on the approximate pressures for small time steps. For non discrete divergence free initial approximations, a pressure instability is predicted by Corollary 4.1 unless condition (36) is satisfied. In other words, pressure instabilities are expected for very small time steps.

We consider problem (1) in two dimensions and with non-homogeneous boundary conditions. We set $\Omega = [0, 1] \times [0, 1]$, and the right hand side f and the boundary data are chosen in order to ensure that the exact (steady) solution is given by:

$$u(x, y, t) = \begin{pmatrix} \sin(\pi x - 0.7)\sin(\pi y + 0.2) \\ \cos(\pi x - 0.7)\cos(\pi y + 0.2) \end{pmatrix},$$

$$p(x, y, t) = \sin x \cos y + (\cos(1) - 1)\sin(1).$$

This numerical experiment is, in some degree, motivated by the work reported in [3] (see also [15]), where pressure instabilities, with a different nature, are illustrated for residual based stabilizations. Let us emphasize that such kind of instabilities should not appear here, since the CIP pressure stabilization is no residual based. For different initial velocity approximations, we compare the behavior of the error in the pressure after one time step of the Backward Euler scheme, *i.e.*,

$$\delta t^{\frac{1}{2}} \| p(t_1) - p_h^1 \|_Q.$$

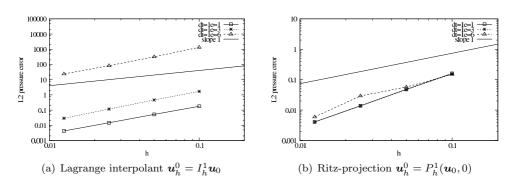


Figure 2: Convergence history: $\mathbb{P}_1/\mathbb{P}_1$ finite elements

We choose the initial data either as the Lagrange interpolant, $\boldsymbol{u}_h^0 = I_h^k \boldsymbol{u}_0$, or as the Ritz-projection, $\boldsymbol{u}_h^0 = P_h^k(\boldsymbol{u}_0, 0)$. In Figure 2 we have reported the convergence history (in space) of the pressure error,

In Figure 2 we have reported the convergence history (in space) of the pressure error, at the first time step, using $\mathbb{P}_1/\mathbb{P}_1$ finite elements for different time step sizes. The pressure instability for small time steps is illustrated in Figure 4(a), where the initial velocity approximation is given in terms of the Lagrange interpolant. Indeed, we can observe that the pressure error has the right convergence rate in space, but it grows when the time step is decreased. On the other hand, as shown in Figure 4(b), the instability is eliminated when the initial velocity approximation is provided by the Ritz-projection, as stated in Corollary 4.1. In this case the error remains bounded (dominated by the space discretization) while reducing the time step size.

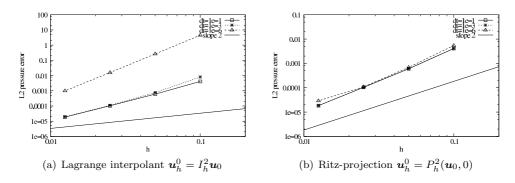


Figure 3: Convergence history: $\mathbb{P}_2/\mathbb{P}_2$ finite elements

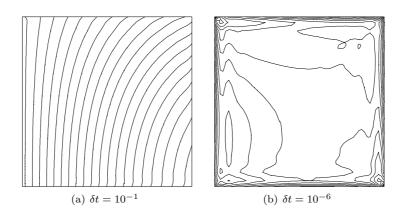


Figure 4: Pressure contour lines with $\mathbb{P}_2/\mathbb{P}_2$ finite elements in a 40 × 40 mesh: $\boldsymbol{u}_h^0 = I_h^2 \boldsymbol{u}_0$

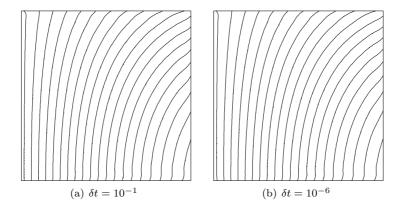


Figure 5: Pressure contour lines with $\mathbb{P}_2/\mathbb{P}_2$ finite elements in a 40×40 mesh: $\boldsymbol{u}_h^0 = P_h^2(\boldsymbol{u}_0,0)$

Similar results are found with $\mathbb{P}_2/\mathbb{P}_2$ finite elements, as shown in Figure 3. In particular, we can notice, from Figures 2(a) and 3(a), that for quadratic approximations the pressure instability shows up only for very small time steps. As a matter of fact, condition (36) is less restrictive for quadratic than for affine velocity approximations of smooth initial data. Finally, some pressure contours are reported in Figure 4 for the Lagrange interpolation, and in Figure 5 for the Ritz-projection. The pressure degradation is clearly visible in Figure 4, whereas with the Ritz-projection initialization (Figure 5) the pressure remains unconditionally stable.

8 Conclusion

In this paper we have proved unconditional stability and optimal error estimates, in natural norms, for pressure stabilized finite element approximations of the transient Stokes' problem. It should be noted that the extension of the present results to mixed formulations of the Poisson problem is straightforward. We have shown that for small initial time-steps the use of a pressure stabilization dependent Ritz-projection, for the initial data, is essential to avoid pressure instabilities, unless a condition between time and space discretization parameters is satisfied. From the analysis, we also conclude that a second order scheme (e.g. BDF2) can be initialized (without optimality loss) using a first step with BDF1, provided that the Ritz-projection (15) is used for the initial data.

It is interesting to note that for low order elements the weakly consistent stabilization operators still yield optimal convergence in time when used with a second order scheme. However, in case SUPG type stabilization is used for the convective term the convergence order in time will be lost unless full consistency is guaranteed in the stabilization term. This is why SUPG type stabilizations prompt space time finite element formulations with discontinuous approximation in time.

The methods proposed in Sections 6.2 - 6.4 on the other hand may be extended to the case of the Oseen equations, handling all Reynolds numbers, by applying the same type of stabilizing term for the convection (see [10, 4, 12, 5], for details).
