#### Abstract

The aim of this note is to prove estimates on mean values of the number of times that Itô processes observed at discrete times visit small balls in $\mathbb{R}^{d}$. Our technique, in the infinite horizon case, is inspired by Krylov's arguments in [2, Chap.2]. In the finite horizon case, motivated by an application in stochastic numerics, we discount the number of visits by a locally exploding coefficient, and our proof involves accurate properties of last passage times at 0 of one dimensional semimartingales.

# Sur les espérances de temps de passage pondérés dans des petites boules pour des processus d'Itô observés en temps discret 

Résumé : L'objectif de cette note est de démontrer des estimations sur le nombre moyen de visites dans des petites boules de $\mathbb{R}^{d}$ d'un processus d'Itô, observé à des instants discrets. En horizon de temps infini, notre technique est inspiré des arguments de Krylov dans [2, Chap.2]. En horizon de temps fini, motivé par une application en analyse numérique stochastique, nous pondérons le nombre de visites par un coefficient localement explosif; notre preuve utilise des propriétés fines sur le dernier temps de passage en zéro d'une semimartingale unidimensionnelle.

## 1 Introduction

The present work is motivated by two convergence rate analyses concerning discretzation schemes for diffusion processes whose generators have non smooth coefficients: Bernardin et al. [1] study discretization schemes for stochastic differential equations with multivalued drift coefficients; Martinez and Talay 3] study discretization schemes for diffusion processes whose infinitesimal generators are of divergence form with discontinuous coefficients. In both case, to have reasonable accuracies, a scheme needs to mimic the local behaviour of the exact solution in small neighborhoods of the discontinuities of the coefficients, in the sense that the expectations of the total times spent by the scheme (considered as a piecewise constant process) and the exact solution in these neighborhoods need to be close to each other. The objective of this paper is to provide two estimates for the expectations of such total times spent by fairly general Itô processes observed at discrete times; these estimates concern in particular the discretization schemes studied in the above references.

Let $\left(\Omega, \mathcal{F},\left(\mathcal{F}_{t}\right)_{t \geq 0}, \mathbb{P}\right)$ be a filtered probability space satisfying the usual conditions. Let $\left(W_{t}\right)_{t \geq 0}$ be a $m$-dimensional standard Brownian motion on this space. Consider two progressively measurable processes $\left(b_{t}\right)_{t \geq 0}$ and $\left(\sigma_{t}\right)_{t \geq 0}$ taking values respectively in $\mathbb{R}^{d}$ and in the space $\mathcal{M}_{d, m}(\mathbb{R})$ of real $d \times m$ dimensional matrices. For $X_{0}$ in $\mathbb{R}^{d}$, consider the Itô process

\begin{equation*}
X_{t}=X_{0}+\int_{0}^{t} b_{s} d s+\int_{0}^{t} \sigma_{s} d W_{s} \tag{1}
\end{equation*}
$$

We assume the following hypotheses:
Hypotheses 1.1. There exists a positive number $K \geq 1$ such that, $\mathbb{P}$-a.s.,

\begin{equation*}
\forall t \geq 0,\left\|b_{t}\right\| \leq K \tag{2}
\end{equation*}
$$

and

$$
\begin{equation*}
\forall 0 \leq s \leq t, \frac{1}{K^{2}} \int_{s}^{t} \psi(u) d u \leq \int_{s}^{t} \psi(u)\left\|\sigma_{u} \sigma_{u}^{*}\right\| d u \leq K^{2} \int_{s}^{t} \psi(u) d u \tag{3}
\end{equation*}
$$

for all positive locally integrable $\operatorname{map} \psi: \mathbb{R}^{+} \rightarrow \mathbb{R}^{+}$.

Notice that (3) is satisfied when $\left(\sigma_{t}\right)$ is a bounded continuous process; our slightly more general framework is motivated by the reduction of our study, without loss of generality, to one dimensional Itô processes: see section 2 .

The aim of this note is to prove the following two results.
Our first result concerns discounted expectations of the total number of times that an Itô process observed at discrete times visits small neighborhoods of an arbitrary point in $\mathbb{R}^{d}$.

Theorem 1.2 (Infinite horizon). Let $\left(X_{t}\right)$ be as in (1). Suppose that the hypotheses 1.1 are satisfied. Let $h>0$. There exists a constant $C$, depending only on $K$, such that, for all $\xi \in \mathbb{R}^{d}$ and $0<\varepsilon<1 / 2$, there exists $h_{0}>0$ (depending on $\varepsilon$ ) satisfying

$$
\begin{equation*}
\forall h \leq h_{0}, h \sum_{p=0}^{\infty} e^{-p h} \mathbb{P}\left(\left\|X_{p h}-\xi\right\| \leq \delta_{h}\right) \leq C \delta_{h}, \tag{4}
\end{equation*}
$$

where $\delta_{h}:=h^{1 / 2-\varepsilon}$.
Our second result concerns expectations of the number of times that an Itô process, observed at discrete times between 0 and a finite horizon $T$, visits small neighborhoods of an arbitrary point $\xi$ in $\mathbb{R}^{d}$. In this setting, the expectations are discounted with a multiplying function $f(t)$ that may tend to infinity when $t$ tends to $T$, which induces technical difficulties which might seem artificial to the reader. However this framework is necessary to analyze the convergence rate of simulation methods for Markov processes whose generators are of divergence form with discontinuous coefficients: see Martinez and Talay [3]. More precisely, we consider functions $f$ satisfying the following hypotheses:

## Hypotheses 1.3.

1. $f$ is positive and increasing,
2. $f$ belongs to $C^{1}\left([0, T) ; \mathbb{R}^{+}\right)$,
3. $f^{\alpha}$ is integrable on $[0, T)$ for all $1 \leq \alpha<2$,
4. there exists $1<\beta<1+\eta$, where $\eta:=\frac{1}{4 K^{4}}$, such that

$$
\begin{equation*}
\int_{0}^{T} f^{2 \beta-1}(v) f^{\prime}(v) \frac{(T-v)^{1+\eta}}{v^{\eta}} d v<+\infty \tag{5}
\end{equation*}
$$

Remember that we have supposed $K \geq 1$. An example of a suitable function $f$ is the function $t \rightarrow \frac{1}{\sqrt{T-t}}$ (for which one can choose $\beta=1+\frac{1}{8 K^{4}}$ ).

Theorem 1.4 (Finite horizon). Let $\left(X_{t}\right)$ be as in (1). Suppose that the hypotheses 1.1 are satisfied. Let $f$ be a function on $[0, T)$ satisfying the hypotheses 1.3. There exists a constant $C$, depending only on $\beta, K$ and $T$, such that, for all $\xi \in \mathbb{R}^{d}$ and $0<\varepsilon<1 / 2$, there exists $h_{0}>0$ (depending on $\varepsilon$ ) satisfying

$$
\begin{equation*}
\forall h \leq h_{0}, h \sum_{p=0}^{N_{h}} f(p h) \mathbb{P}\left(\left\|X_{p h}-\xi\right\| \leq \delta_{h}\right) \leq C \delta_{h}, \tag{6}
\end{equation*}
$$

where $N_{h}:=\lfloor T / h\rfloor-1$ and where $\delta_{h}:=h^{1 / 2-\varepsilon}$.
Remark 1.5. Since all the norms in $\mathbb{R}^{d}$ are equivalent, without loss of generality we may choose $\|Y\|=\sup _{1 \leq i \leq d}\left|Y^{i}\right|, Y^{i}$ denoting the $i^{\text {th }}$ component of $Y$.

Remark 1.6. Changing $X_{0}$ into $X_{0}-\xi$ allows us to limit ourselves to the case $\xi=0$ without loss of generality, which we actually do in the sequel.

## 2 Reduction to one dimensional $\left(X_{t}\right)^{\prime}$ 's

Notice that it suffices to prove that, for all $1 \leq i \leq d$ and $h \leq h_{0}$,

h \sum_{p=0}^{\infty} e^{-p h} \mathbb{P}\left(\left|X_{p h}^{i}\right| \leq \delta_{h}\right) \leq C \delta_{h},
$$

or, similarly,

$$
h \sum_{p=0}^{N_{h}} f(p h) \mathbb{P}\left(\left|X_{p h}^{i}\right| \leq \delta_{h}\right) \leq C \delta_{h} .
$$

Set

$$
M_{t}^{i}:=\sum_{j=1}^{m}\left(\int_{0}^{t} \sigma_{s}^{i j} d W_{s}^{j}\right)
$$

The martingale representation theorem implies that there exist a process $\left(f_{t}^{i}\right)_{t \geq 0}$ and a standard $\mathcal{F}_{t}$-Brownian motion $\left(B_{t}\right)_{t \geq 0}$ on an extension of the original probability space, such that

M_{t}^{i}=\int_{0}^{t} f_{s}^{i} d B_{s}
$$

and

$$
\forall t>0, \int_{0}^{t}\left(f_{\theta}^{i}\right)^{2} d \theta=\sum_{j=1}^{m} \int_{0}^{t}\left(\sigma_{\theta}^{i j}\right)^{2} d \theta
$$

Therefore it suffices to prove Theorems 1.2 and 1.4 for all one dimensional Itô process

$$
\begin{equation*}
X_{t}=\int_{0}^{t} b_{s} d s+\int_{0}^{t} \sigma_{s} d B_{s} \tag{7}
\end{equation*}
$$

such that, $\exists K \geq 1, \mathbb{P}$-a.s.,

$$
\begin{equation*}
\forall t \geq 0,\left|b_{t}\right| \leq K \tag{8}
\end{equation*}
$$

and

$$
\begin{equation*}
\forall 0 \leq s \leq t, \frac{1}{K^{2}} \int_{s}^{t} \psi(u) d u \leq \int_{s}^{t} \psi(u) \sigma_{u}^{2} d_{u} \leq K^{2} \int_{s}^{t} \psi(u) d u \tag{9}
\end{equation*}
$$

for all positive locally integrable map $\psi: \mathbb{R}^{+} \rightarrow \mathbb{R}^{+}$.

## 3 An estimate for a localizing stopping time

In this section we prove a key proposition which is a variant of Theorem 4 in [2, Chap.2]: here we need to consider time indices and stopping times which take values in a mesh with step-size $h$. We carefully modify Krylov's arguments.

Proposition 3.1. Let $\left(X_{t}\right)$ be as in (7). Suppose that conditions (8) and (9) hold true. Let $\theta: \Omega \rightarrow h \overline{\mathbb{N}}$ be a $\left(\mathcal{F}_{t}\right)$-stopping time. Then $\tau:=\inf \{t \in h \mathbb{N}, t \geq$ $\left.\theta,\left|X_{t}-X_{\theta}\right| \geq 1\right\}$ is a $\left(\mathcal{F}_{t}\right)$-stopping time, and

$$
\begin{equation*}
\mathbb{E}\left(\mathbf{1}_{\tau<+\infty} e^{-\tau} \mid \mathcal{F}_{\theta}\right) \leq \frac{1}{\operatorname{ch}(\mu)} e^{-\theta} \mathbf{1}_{\theta<+\infty} \text { a.s. } \tag{10}
\end{equation*}
$$

where

$$
\mu>0 \text { and } 1-K \mu-(1 / 2) K^{2} \mu^{2}=0 .
$$

Proof. Set $\pi(z):=\operatorname{ch}(\mu z)$ for all $z$ in $\mathbb{R}$ and

$$
L_{u} \pi(z):=b_{u} \pi^{\prime}(z)+\frac{1}{2} \sigma_{u}^{2} \pi^{\prime \prime}(z)
$$

Let $A \in \mathcal{F}_{\theta}$. Suppose that we have proven that, for all $t>0$,

\begin{equation*}
e^{-t \wedge \theta} \geq \mathbb{E}\left(e^{-\tau} \pi\left(X_{t \wedge \tau}-X_{t \wedge \theta}\right) \mid \mathcal{F}_{t \wedge \theta}\right) \tag{11}
\end{equation*}
$$

Then we would have

$$
\begin{aligned}
\mathbb{E}\left(\mathbf{1}_{A} \mathbf{1}_{\theta<+\infty} e^{-\theta}\right) & =\lim _{t \rightarrow+\infty} \mathbb{E}\left(\mathbf{1}_{A} \mathbf{1}_{\theta \leq t} e^{-\theta \wedge t}\right) \\
& \geq \lim _{t \rightarrow+\infty} \mathbb{E}\left(\mathbf{1}_{A} \mathbf{1}_{\theta \leq t} \mathbb{E}\left(e^{-\tau} \pi\left(X_{t \wedge \tau}-X_{t \wedge \theta}\right) \mid \mathcal{F}_{t \wedge \theta}\right)\right) \\
& =\lim _{t \rightarrow+\infty} \mathbb{E}\left(\mathbf{1}_{A} \mathbf{1}_{\theta \leq t} \mathbb{E}\left(e^{-\tau} \pi\left(X_{t \wedge \tau}-X_{t \wedge \theta}\right) \mid \mathcal{F}_{\theta}\right)\right) \\
& =\lim _{t \rightarrow+\infty} \mathbb{E}\left(\mathbf{1}_{A} \mathbf{1}_{\theta \leq t} e^{-\tau} \pi\left(X_{t \wedge \tau}-X_{t \wedge \theta}\right)\right) \\
& =\lim _{t \rightarrow+\infty} \mathbb{E}\left(\mathbf{1}_{A} \mathbf{1}_{\theta<+\infty} e^{-\tau} \pi(1)\right) \\
& \geq \mathbb{E}\left(\mathbf{1}_{A} \operatorname{ch}(\mu) \mathbf{1}_{\tau<+\infty} e^{-\tau}\right),
\end{aligned}
$$

and thus the desired result would have been obtained. We now prove the inequality (11).

Fix $t \geq 0$ arbitrarily and set

$$
B:=\{t \leq \theta\} \cap\{t \leq \tau\}=\{\theta \geq t\}
$$

and

$$
C:=\{t>\theta\} \cap\{t>\tau\}=\{t>\theta\} \cap\left\{\forall s \in[\theta, t] \cap h \mathbb{N},\left|X_{s}-X_{\theta}\right|<1\right\}
$$

The sets $B$ and $C$ are $\mathcal{F}_{t^{-}}$measurable. Consequently the set $\{t<\tau\}$ is $\mathcal{F}_{t^{-}}$ measurable and thus $\tau$ is a $\left(\mathcal{F}_{t}\right)$-stopping time.

To show (11), we start with checking that, $\mathbb{P}$-a.s, for all $0 \leq s \leq t$ and $z \in \mathbb{R}$,

\begin{equation*}
\int_{s}^{t} \psi(u)\left(\pi(z)-L_{u} \pi(z)\right) d u \geq \operatorname{ch}(\mu z)\left(1-K \mu-\frac{1}{2} K^{2} \mu^{2}\right) \int_{s}^{t} \psi(u) d u=0 \tag{12}
\end{equation*}
$$

for all positive locally bounded map $\psi: \mathbb{R}^{+} \rightarrow \mathbb{R}^{+}$. Indeed, for all $z \in \mathbb{R}$ and $u \geq 0$,

$$
\pi(z)-L_{u} \pi(z)=\operatorname{ch}(\mu z)-\mu b_{u} \operatorname{sh}(\mu z)-\frac{1}{2} \mu^{2} \sigma_{u}^{2} \operatorname{ch}(\mu z) .
$$

As $\operatorname{sh}(\mu|z|) \leq \operatorname{ch}(\mu z)$, we get (12) by using (8) and (9).
Now, we observe that $e^{\gamma X_{t}}$ is integrable for all $\gamma>0$ since $\left(b_{t}\right)$ and $\left(\sigma_{t}\right)$ are bounded processes. For all $y \in \mathbb{R}$ Itô's formula implies

\begin{aligned}
e^{-t \wedge \theta} \pi\left(X_{t \wedge \theta}+y\right)= & \mathbb{E}\left(e^{-t \wedge \tau} \pi\left(X_{t \wedge \tau}+y\right) \mid \mathcal{F}_{t \wedge \theta}\right) \\
& +\mathbb{E}\left(\int_{t \wedge \theta}^{t \wedge \tau} e^{-s}\left(\pi\left(X_{s}+y\right)-L_{s} \pi\left(X_{s}+y\right)\right) d s \mid \mathcal{F}_{t \wedge \theta}\right) \text { a.s. }
\end{aligned}
$$

Therefore, in view of 122 , there exists a set $\mathcal{N}_{y}$ with $\mathbb{P}\left(\mathcal{N}_{y}\right)=0$ such that

$$
\begin{equation*}
e^{-t \wedge \theta} \pi\left(X_{t \wedge \theta}+y\right) \geq \mathbb{E}\left(e^{-\tau} \pi\left(X_{t \wedge \tau}+y\right) \mid \mathcal{F}_{t \wedge \theta}\right) \quad \text { on } \Omega-\mathcal{N}_{y} . \tag{13}
\end{equation*}
$$

We now use the continuity of $\pi$ in order to replace $y$ by $-X_{t \wedge \theta}$. For all positive integer $q$, let $k_{q}(y)$ be the unique integer $\ell$ such that $\ell / 2^{q} \leq y<(\ell+1) / 2^{q}$. Then

\pi\left(X_{t \wedge \tau}-X_{t \wedge \theta}\right)=\lim _{q \rightarrow+\infty} \pi\left(X_{t \wedge \tau}-\frac{k_{q}\left(X_{t \wedge \theta}\right)}{2^{q}}\right)
$$

Therefore, by Fatou's lemma and (13),

$$
\begin{aligned}
\mathbb{E}\left(e^{-\tau} \pi\left(X_{t \wedge \tau}-X_{t \wedge \theta}\right) \mid \mathcal{F}_{t \wedge \theta}\right) & \leq \liminf _{q \rightarrow+\infty} \mathbb{E}\left(\left.e^{-\tau} \pi\left(X_{t \wedge \tau}+\frac{k_{q}\left(-X_{t \wedge \theta}\right)}{2^{q}}\right) \right\rvert\, \mathcal{F}_{t \wedge \theta}\right) \\
& \leq \liminf _{q \rightarrow+\infty} e^{-t \wedge \theta} \pi\left(X_{t \wedge \theta}+\frac{k_{q}\left(-X_{t \wedge \theta}\right)}{2^{q}}\right) \\
& =e^{-t \wedge \theta} .
\end{aligned}
$$

We now define two sequences of stopping times $\left(\theta_{p}^{h}\right)_{p}$ and $\left(\tau_{p}^{h}\right)_{p}$ taking values in $h \overline{\mathbb{N}}$ as

\begin{cases}\theta_{0}^{h} & =\tau_{0}^{h}=0  \tag{14}\\ \theta_{p+1}^{h} & =\inf \left\{t \geq \tau_{p}^{h}, t \in h \mathbb{N},\left|X_{t}\right| \leq \delta_{h}\right\}, p \geq 0 \\ \tau_{p}^{h} & =\inf \left\{t \geq \theta_{p}^{h}, t \in h \mathbb{N},\left|X_{t}-X_{\theta_{p}^{h}}\right| \geq 1\right\}, p \geq 1\end{cases}
$$

Lemma 3.2. For all $p \geq 0$,

$$
\begin{equation*}
\mathbb{E}\left(\mathbf{1}_{\theta_{p}^{h}<+\infty} e^{-\theta_{p}^{h}}\right) \leq\left(\frac{1}{\operatorname{ch}(\mu)}\right)^{p}, \tag{15}
\end{equation*}
$$

where $\mu$ is defined as in Proposition 3.1.
Proof. Apply Lemma 3.1 to the stopping times $\theta_{p}^{h}$ and $\tau_{p}^{h}$. It comes

$$
\mathbb{E}\left(\mathbf{1}_{\tau_{p}^{h}<+\infty} e^{-\tau_{p}^{h}} \mid \mathcal{F}_{\theta_{p}^{h}}\right) \leq \frac{1}{\operatorname{ch}(\mu)} e^{-\theta_{p}^{h}} \mathbf{1}_{\theta_{p}^{h}<+\infty} \mathbb{P}-\text { a.s. },
$$

from which

$$
\begin{aligned}
& \mathbb{E}\left(\mathbf{1}_{\theta_{p+1}^{h}<+\infty} e^{-\theta_{p+1}^{h}}\right) \leq \mathbb{E}\left(\mathbf{1}_{\tau_{p}^{h}<+\infty} e^{-\tau_{p}^{h}}\right)=\mathbb{E}\left(\mathbb{E}\left(\mathbf{1}_{\tau_{p}^{h}<+\infty} e^{-\tau_{p}^{h}} \mid \mathcal{F}_{\theta_{p}^{h}}\right)\right) \\
& \leq \frac{1}{\operatorname{ch}(\mu)} \mathbb{E}\left(\mathbf{1}_{\theta_{p}^{h}<+\infty} e^{-\theta_{p}^{h}}\right) \leq \cdots \leq\left(\frac{1}{\operatorname{ch}(\mu)}\right)^{p+1}
\end{aligned}
$$

Any subsequence of $\left(\theta_{p}^{h}\right)_{p}$ takes an infinite value in a finite time, or converges to infinity when $p$ tends to infinity. Therefore

$$
\begin{equation*}
\mathbb{E}\left(h \sum_{p=0}^{+\infty} e^{-p h} \mathbf{1}_{\left[-\delta_{h}, \delta_{h}\right]}\left(X_{p h}\right)\right)=\sum_{p=0}^{+\infty} \mathbb{E}\left(\mathbf{1}_{\theta_{p}^{h}<+\infty} \int_{\theta_{p}^{h}}^{\tau_{p}^{h}} e^{-\eta_{s}} \mathbf{1}_{\left[-\delta_{h}, \delta_{h}\right]}\left(X_{\eta_{s}}\right) d s\right), \tag{16}
\end{equation*}
$$

where

$$
\begin{equation*}
\eta_{s}:=h\lfloor s / h\rfloor \text { for all } s \geq 0 . \tag{17}
\end{equation*}
$$

In the next section we carefully estimate the right-hand side of (16).

## 4 Estimate for the localized problem in the infinite horizon setting

In this section we aim to prove the following lemma.
Lemma 4.1. Consider a one dimensional Itô process (7) satisfying (8) and (9). Let $\theta: \Omega \rightarrow h \overline{\mathbb{N}}$ be a $\mathcal{F}_{t}$-stopping time such that $X_{\theta} \in\left[-\delta_{h}, \delta_{h}\right]$ almost surely. Let $\tau$ be the stopping time $\tau:=\inf \left\{t \geq \theta, t \in h \mathbb{N},\left|X_{t}-X_{\theta}\right| \geq 1\right\}$. There exists a constant $C$, independent of $\theta$ and $\tau$, such that, for all $h$ small enough,

$$
\begin{equation*}
\mathbb{E}\left(\mathbf{1}_{\theta<+\infty} \int_{\theta}^{\tau} e^{-\eta_{s}} \mathbf{1}_{\left[-\delta_{h}, \delta_{h}\right]}\left(X_{\eta_{s}}\right) d s\right) \leq C \delta_{h} \sqrt{\mathbb{E}\left(\mathbf{1}_{\theta<+\infty} e^{-\theta}\right)} \tag{18}
\end{equation*}
$$

Proof. To start with, we construct a function $I$ whose second derivative is $\mathbf{1}_{\left[-2 \delta_{h}, 2 \delta_{h}\right]}$ in order to be able to apply Itô's formula. Let $I: \mathbb{R} \rightarrow \mathbb{R}$ be defined as

I(z)= \begin{cases}0 & \text { if } z \leq-2 \delta_{h}  \tag{19}\\ \frac{1}{2} z^{2}+2 \delta_{h} z+2 \delta_{h}^{2} & \text { if }-2 \delta_{h} \leq z \leq 2 \delta_{h} \\ 4 \delta_{h} z & \text { if } 2 \delta_{h} \leq z\end{cases}
$$

The map $I$ is of class $C^{1}(\mathbb{R})$ and of class $C^{2}\left(\mathbb{R} \backslash\left(\left\{-2 \delta_{h}\right\} \cup\left\{2 \delta_{h}\right\}\right)\right)$. In addition, for all $z \in \mathbb{R}, I^{\prime \prime}(z)=\mathbf{1}_{\left[-\delta_{h}, \delta_{h}\right]}(z)$ (we set $I^{\prime \prime}\left(-2 \delta_{h}\right)=I^{\prime \prime}\left(2 \delta_{h}\right)=1$ ). For $h$ small enough, there exists a constant $C$ independent of $h$ such that

q_{h}:=\mathbf{1}_{\theta<+\infty} \int_{\theta}^{\tau} e^{-\eta_{s}} \mathbf{1}_{\left[-\delta_{h}, \delta_{h}\right]}\left(X_{\eta_{s}}\right) d s, \tag{21}
\end{equation*}
$$

and observe that, for all $s \geq 0$,

\begin{aligned}
& \left\{X_{\eta_{s}} \in\left[-\delta_{h}, \delta_{h}\right]\right\} \\
= & \left(\left\{X_{\eta_{s}} \in\left[-\delta_{h}, \delta_{h}\right]\right\} \cap\left\{X_{s} \in\left[-2 \delta_{h}, 2 \delta_{h}\right]\right\}\right) \cup\left(\left\{X_{\eta_{s}} \in\left[-\delta_{h}, \delta_{h}\right]\right\} \cap\left\{X_{s} \notin\left[-2 \delta_{h}, 2 \delta_{h}\right]\right\}\right),
\end{aligned}
$$

so that

$$
\begin{equation*}
\mathbf{1}_{\left[-\delta_{h}, \delta_{h}\right]}\left(X_{\eta_{s}}\right) \leq \mathbf{1}_{\left[-2 \delta_{h}, 2 \delta_{h}\right]}\left(X_{s}\right)+\mathbf{1}_{\left[-\delta_{h}, \delta_{h}\right]}\left(X_{\eta_{s}}\right) \mathbf{1}_{\mathbb{R} \backslash\left[-2 \delta_{h}, 2 \delta_{h}\right]}\left(X_{s}\right) . \tag{22}
\end{equation*}
$$

From (21) and (22),

$$
\begin{equation*}
q_{h} \leq A^{h}+B^{h}, \tag{23}
\end{equation*}
$$

where

$$
\begin{equation*}
A^{h}=\mathbf{1}_{\theta<+\infty} \int_{\theta}^{\tau} e^{-\eta_{s}} \mathbf{1}_{\left[-2 \delta_{h}, 2 \delta_{h}\right]}\left(X_{s}\right) d s \tag{24}
\end{equation*}
$$

and

$$
\begin{equation*}
B^{h}=\mathbf{1}_{\theta<+\infty} \int_{\theta}^{\tau} e^{-\eta_{s}} \mathbf{1}_{\left[-\delta_{h}, \delta_{h}\right]}\left(X_{\eta_{s}}\right) \mathbf{1}_{\mathbb{R} \backslash\left[-2 \delta_{h}, 2 \delta_{h}\right]}\left(X_{s}\right) d s \tag{25}
\end{equation*}
$$

An upper bound for $A^{h}$. In view of (9), one has

$$
A^{h} \leq \mathbf{1}_{\theta<+\infty} K^{2} e^{-h} \int_{\theta}^{\tau} e^{-s} \mathbf{1}_{\left[-2 \delta_{h}, 2 \delta_{h}\right]}\left(X_{s}\right) \sigma_{s}^{2} d s=\mathbf{1}_{\theta<+\infty} K^{2} e^{-h} \int_{\theta}^{\tau} e^{-s} I^{\prime \prime}\left(X_{s}\right) \sigma_{s}^{2} d s .
$$

Notice that $\left(\int_{0}^{t} e^{-s} I^{\prime}\left(X_{s}\right) \sigma_{s} d W_{s}\right)$ is a uniformly square integrable martingale. Thus the limit $\int_{0}^{\infty} e^{-s} I^{\prime}\left(X_{s}\right) \sigma_{s} d W_{s}$ exists a.s. As $I^{\prime \prime}$ is continuous except at points $-\delta_{h}$ and $\delta_{h}$, an extended Itô's formula (see, e.g., Protter [4, Thm.71,Chap.IV]) implies

& A^{h} \leq \mathbf{1}_{\theta<+\infty} K^{2} e^{-h}\left\{e^{-\tau} I\left(X_{\tau}\right)-e^{-\theta} I\left(X_{\theta}\right)+\int_{\theta}^{\tau} e^{-s} I\left(X_{s}\right) d s\right. \\
&\left.\quad-\int_{\theta}^{\tau} e^{-s} I^{\prime}\left(X_{s}\right) b_{s} d s-\int_{\theta}^{\tau} e^{-s} I^{\prime}\left(X_{s}\right) \sigma_{s} d W_{s}\right\} \tag{26}
\end{align*}
$$

In view of 20 we have $\left|I\left(X_{s}\right)\right| \leq C \delta_{h}$ even on the random set $\{\tau=+\infty\}$. In addition,
$\mathbb{E}\left[\mathbf{1}_{\tau<\infty} \int_{0}^{\tau} e^{-s} I\left(X_{s}\right) d s\right] \leq \mathbb{E}\left[\mathbf{1}_{\tau<\infty} \int_{0}^{\tau} e^{-s}\left|I\left(X_{\eta_{s}}\right)\right| d s\right]+\mathbb{E}\left[\mathbf{1}_{\tau<\infty} \int_{0}^{+\infty} e^{-s}\left|I\left(X_{s}\right)-I\left(X_{\eta_{s}}\right)\right| d s\right]$.
The first expectation is bounded from above by $C \delta_{h}$ since, for all integer $k$ such that $\theta \leq k h \leq \tau-h$, one has $\left|X_{p h}\right| \leq 1+\delta_{h}$. The second one is obviously bounded from above by $C \sqrt{h}$. Thus

\mathbb{E}\left(A^{h}\right) \leq C \delta_{h} \mathbb{E}\left(\mathbf{1}_{\theta<+\infty} e^{-\theta}\right) . \tag{27}
\end{equation*}

An upper bound for $B^{h}$. Setting $M_{s}:=\int_{\eta_{s}}^{s} \sigma_{u} d W_{u}$, one has

B^{h} & \leq \mathbf{1}_{\theta<+\infty} \int_{\theta}^{\tau} e^{-\eta_{s}} \mathbf{1}_{\left[\delta_{h},+\infty\right)}\left(\left|X_{s}-X_{\eta_{s}}\right|\right) d s \\
& =\mathbf{1}_{\theta<+\infty} e^{-\theta} \int_{0}^{\tau-\theta} e^{-\eta_{s}} \mathbf{1}_{\left[\delta_{h},+\infty\right)}\left(\left|X_{s+\theta}-X_{\eta_{s}+\theta}\right|\right) d s \\
& \leq \mathbf{1}_{\theta<+\infty} e^{-\theta} \int_{0}^{+\infty} e^{-\eta_{s}} \mathbf{1}_{\left[\delta_{h},+\infty\right)}\left(\left|\int_{\eta_{s}+\theta}^{s+\theta} b_{u} d u+M_{s+\theta}\right|\right) d s \\
& \leq \mathbf{1}_{\theta<+\infty} e^{-\theta} \int_{0}^{+\infty} e^{-\eta_{s}} \mathbf{1}_{\left[\delta_{h}-K h,+\infty\right)}\left(\left|M_{s+\theta}\right|\right) d s \\
& \leq \mathbf{1}_{\theta<+\infty} e^{-\theta} \int_{0}^{+\infty} e^{-\eta_{s}} \mathbf{1}_{\left[\delta_{h} / 2,+\infty\right)}\left(\left|M_{s+\theta}\right|\right) d s
\end{aligned}
$$

where we have used (8) and $h$ is assumed small enough. We now successively use the Cauchy-Schwarz, Jensen and Bernstein inequalities (see, e.g., Revuz and Yor [5, Ex.3.16,Chap.IV] for the Bernstein inequality for martingales):

\mathbb{E} B^{h} & \leq \sqrt{\mathbb{E}\left(\mathbf{1}_{\theta<+\infty} e^{-\theta}\right)^{2}} \sqrt{\mathbb{E}\left(\int_{0}^{+\infty} e^{-\eta_{s}} \mathbf{1}_{\left[\delta_{h} / 2,+\infty\right)}\left(\left|M_{s+\theta}\right|\right) d s\right)^{2}} \\
& \leq \sqrt{\mathbb{E}\left(\mathbf{1}_{\theta<+\infty} e^{-\theta}\right)} \sqrt{\mathbb{E}\left(\int_{0}^{+\infty} e^{-\eta_{s}} \mathbf{1}_{\left[\delta_{h} / 2,+\infty\right)}\left(\left|M_{s+\theta}\right|\right) d s\right)} \\
& \leq \sqrt{\mathbb{E}\left(\mathbf{1}_{\theta<+\infty} e^{-\theta}\right)} \sqrt{\int_{0}^{+\infty} e^{-\eta_{s} \mathbb{P}}\left(\sup _{\eta_{s}+\theta \leq u \leq s+\theta}\left|M_{u+\theta}\right| \geq \frac{\delta_{h}}{2}\right) d s}  \tag{28}\\
& \leq C \sqrt{\mathbb{E}\left(\mathbf{1}_{\theta<+\infty} e^{-\theta}\right)} \sqrt{\int_{0}^{+\infty} e^{-\eta_{s}} \exp \left(-\frac{1}{2 K^{2}} \frac{\delta_{h}^{2}}{h}\right) d s} \\
& \leq C \delta_{h} \sqrt{\mathbb{E}\left(\mathbf{1}_{\theta<+\infty} e^{-\theta}\right)} h^{\varepsilon-1 / 2} \exp \left(-\frac{1}{4 K^{2}} h^{-2 \varepsilon}\right) .
\end{align*}
$$

One can then deduce (18) from (21), (23), (27) and (28).

## 5 End of the proof of Theorem 1.2

We apply Lemmas 4.1 and 3.2 and the equality (16) and deduce

h \mathbb{E}\left(\sum_{p=0}^{+\infty} e^{-p h} \mathbf{1}_{\left[-\delta_{h}, \delta_{h}\right]}\left(X_{p h}\right)\right) & =\sum_{p=0}^{+\infty} \mathbb{E}\left(\mathbf{1}_{\theta_{p}^{h}<+\infty} \int_{\theta_{p}^{h}}^{\tau_{p}^{h}-h} e^{-\eta_{s}} \mathbf{1}_{\left[-\delta_{h}, \delta_{h}\right]}\left(X_{\eta_{s}}\right) d s\right) \\
& \leq C \delta_{h} \sum_{p=0}^{+\infty} \sqrt{\mathbb{E}\left(\mathbf{1}_{\theta_{p}^{h}<+\infty} e^{-\theta_{p}^{h}}\right)} \\
& \leq C \delta_{h} \sum_{p=0}^{+\infty}\left(\frac{1}{\operatorname{ch}(\mu)}\right)^{\frac{p}{2}},
\end{aligned}
$$

which ends the proof of Theorem 1.2,

## 6 Proof of Theorem 1.4

In the finite horizon setting, we do not need to localize by means of an appropriate sequence of stopping times as in the preceding section. We may start from

\mathbb{E}\left(h \sum_{p=0}^{N_{h}} f(p h) \mathbf{1}_{\left[-\delta_{h}, \delta_{h}\right]}\left(X_{p h}\right)\right)=\sum_{p=0}^{N_{h}} \mathbb{E}\left(\int_{p h}^{(p+1) h} f\left(\eta_{s}\right) \mathbf{1}_{\left[-\delta_{h}, \delta_{h}\right]}\left(X_{\eta_{s}}\right) d s\right) . \tag{29}
\end{equation*}
$$

In all the sequel, $C_{T}$ denotes a constant depending on $K$ and $T$ only which may change from line to line.

In view of 22 ) we have

\begin{equation*}
\mathbf{1}_{\left[-\delta_{h}, \delta_{h}\right]}\left(X_{\eta_{s}}\right) \leq \mathbf{1}_{\left[-2 \delta_{h}, 2 \delta_{h}\right]}\left(X_{s}\right)+\mathbf{1}_{\left[-\delta_{h}, \delta_{h}\right]}\left(X_{\eta_{s}}\right) \mathbf{1}_{\mathbb{R} \backslash\left[-2 \delta_{h}, 2 \delta_{h}\right]}\left(X_{s}\right), \tag{30}
\end{equation*}
$$

and thus,

$$
\begin{align*}
\mathbb{E}\left(h \sum_{p=0}^{N_{h}} f(p h) \mathbf{1}_{\left[-\delta_{h}, \delta_{h}\right]}\left(X_{p h}\right)\right) & \leq \mathbb{E}\left(\int_{0}^{T} f\left(\eta_{s}\right) \mathbf{1}_{\left[-2 \delta_{h}, 2 \delta_{h}\right]}\left(X_{s}\right) d s\right)+\sum_{p=0}^{N_{h}} \mathbb{E}\left(D_{h}^{p}\right) \\
& =: A^{h}(T)+\sum_{p=0}^{N_{h}} \mathbb{E}\left(D_{p}^{h}\right), \tag{31}
\end{align*}
$$

where for all $p \in\{0, \ldots, N-1\}$

$$
\begin{equation*}
D_{p}^{h}:=\int_{p h}^{(p+1) h} f\left(\eta_{s}\right) \mathbf{1}_{\left[-\delta_{h}, \delta_{h}\right]}\left(X_{\eta_{s}}\right) \mathbf{1}_{\mathbb{R} \backslash\left[-2 \delta_{h}, 2 \delta_{h}\right]}\left(X_{s}\right) d s \tag{32}
\end{equation*}
$$

An upper bound for $A^{h}(T)$.
In view of (9), as the function $f$ is increasing, one has

$$
A^{h}(T) \leq K^{2} \mathbb{E}\left(\left(\int_{0}^{T} f(s) \mathbf{1}_{\left[-2 \delta_{h}, 2 \delta_{h}\right]}\left(X_{s}\right) \sigma_{s}^{2} d s\right)\right.
$$

Since we may have $\lim _{s \uparrow T} f(s)=+\infty$, the proof of Lemma 4.1 does not apply.
Set $\tau_{y}:=\inf \left\{s>0: X_{s}-y=0\right\}$. The generalized occupation time formula (see, e.g., Revuz and Yor [5, Ex.1.15,Chap.VI]) implies that

\mathbb{E}\left(\int_{0}^{T} f(s) \mathbf{1}_{\left[-2 \delta_{h}, 2 \delta_{h}\right]}\left(X_{s}\right) \sigma_{s}^{2} d s\right) & =\int_{\mathbb{R}} d y \mathbf{1}_{\left[-2 \delta_{h}, 2 \delta_{h}\right]}(y) \mathbb{E}\left(\int_{0}^{T} f(s) d L_{s}^{y}(X)\right) \\
& =\int_{\mathbb{R}} d y \mathbf{1}_{\left[-2 \delta_{h}, 2 \delta_{h}\right]}(y) \mathbb{E}\left(\mathbf{1}_{\tau_{y} \leq T} \int_{\tau_{y}}^{T} f(s) d L_{s}^{y}(X)\right), \tag{33}
\end{align*}
$$

where $\left\{L_{s}^{y}(X): s \in[0, T], y \in \mathbb{R}\right\}$ denotes a bi-continuous càdlàg version of the local time of the process $\left(X_{t}\right)_{t \geq 0}$.

Our aim now is to bound from above $\mathbb{E}\left(\mathbf{1}_{\tau_{y} \leq T} \int_{\tau_{y}}^{T} f(s) d L_{s}^{y}(X)\right)$ uniformly in $y$ in $\left[-2 \delta_{h}, 2 \delta_{h}\right]$. It clearly suffices to show that there exists a constant $C_{T}$ depending only $\beta, K$ and $T$, such that

\mathbb{E}\left(\int_{0}^{T} f(s) d L_{s}^{0}(Y)\right) \leq C_{T} \tag{34}
\end{equation*}
$$

where the semimartingale $Y$ is defined as $Y:=X-y$.
Because $f$ is not square integrable over $[0, T)$, we arbitrarily choose $\gamma>0$. Now $f$ is square integrable on $[0, T-\gamma]$ and the function $t \mapsto \int_{0}^{t} f(s) d L_{s}^{0}(Y)$ is the local time of the local semimartingale

$$
\left\{f\left(g_{t}\right) Y_{t}, t \in[0, T-\gamma]\right\}
$$

where $g_{t}:=\sup \left\{s<t: Y_{s}=0\right\}$ (see, e.g., Revuz and Yor [5, Sec.4,Chap.IV]). The Stieltjes measure induced by the function $s \mapsto f\left(g_{s}\right)$ has support $\mathcal{Z}:=$ $\left\{s \geq 0: Y_{s}=0\right\}$, and therefore

\int_{0}^{T-\gamma}\left|Y_{\theta}\right| d f\left(g_{\theta}\right)=0
$$

so that Itô-Tanaka formula implies
$\mathbb{E}\left(\int_{0}^{T-\gamma} f(s) d L_{s}^{0}(Y)\right)=\mathbb{E}\left(\left|f\left(g_{T-\gamma}\right) Y_{T-\gamma}\right|\right)-f\left(g_{0}\right)\left|Y_{0}\right|-\mathbb{E}\left(\int_{0}^{T-\gamma} f\left(g_{s}\right) \operatorname{sgn}\left(\left(Y_{s}\right)\right) d Y_{s}\right)$.
Apply Theorem 4.2 in [5]. It comes:

\mathbb{E}\left(\left|f\left(g_{T-\gamma}\right) Y_{T-\gamma}\right|\right)=\mathbb{E}\left(\left|f(0) Y_{0}+\int_{0}^{T-\gamma} f\left(g_{s}\right) d Y_{s}\right|\right)
$$

from which

$$
\begin{align*}
\mathbb{E}\left(\left|f\left(g_{T-\gamma}\right) Y_{T-\gamma}\right|\right) & \leq\left|f(0) Y_{0}\right|+\mathbb{E}\left(\left|\int_{0}^{T-\gamma} f\left(g_{s}\right) \sigma_{s} d W_{s}\right|\right)+\mathbb{E}\left(\left|\int_{0}^{T-\gamma} f(s) b_{s} d s\right|\right) \\
& \leq C_{T}+K^{2}\left(\int_{0}^{T} \mathbb{E}\left(f^{2}\left(g_{s}\right)\right) d s\right)^{\frac{1}{2}} \tag{36}
\end{align*}
$$

Coming back to (35) we deduce

$$
\mathbb{E}\left(\int_{0}^{T-\gamma} f(s) d L_{s}^{0}(Y)\right) \leq C_{T}+K^{2}\left(\int_{0}^{T} \mathbb{E}\left(f^{2}\left(g_{s}\right)\right) d s\right)^{\frac{1}{2}}
$$

Thus, as $\beta>1$ by assumption, (34) will be proven if we can show that

\begin{equation*}
\int_{0}^{T} \tilde{\mathbb{E}}\left[f^{2 \beta}\left(g_{s}\right)\right] d s<+\infty \tag{37}
\end{equation*}
$$

where $\tilde{\mathbb{P}}$ is the probability measure defined by a Girsanov transformation removing the drift of $\left(Y_{t}, 0 \leq t \leq T\right)$.

Set $\Lambda(t):=\langle Y\rangle_{t}$. Observe that

\sup \left\{\theta \leq s ; Y_{\theta}=0\right\}=\Lambda^{-1}\left(\sup \left\{\theta \leq \Lambda(s) ; Y_{\Lambda^{-1}(\theta)}=0\right\}\right)
$$

In addition, the Dubins-Schwarz theorem implies that there exists a $\tilde{\mathbb{P}}$-Brownian Motion $\left(\tilde{B}_{t}\right)_{t \geq 0}$ such that $Y_{s}=\tilde{B}_{\Lambda(s)}$. Therefore,

\tilde{\mathbb{P}}\left[g_{s} \geq u\right] & =\tilde{\mathbb{P}}\left[\Lambda_{\sup \left\{t<\Lambda(s): x_{\Lambda^{-1}(t)}=0\right\}}^{-1} \geq u\right] \\
& =\tilde{\mathbb{P}}\left[\sup \left\{t<\Lambda(s): \tilde{B}_{t}=0\right\} \geq \Lambda(u)\right] \\
& =\tilde{\mathbb{P}}\left[\inf \left\{t>\Lambda(u): \tilde{B}_{t}=0\right\} \leq \Lambda(s)\right] \\
& \leq \tilde{\mathbb{P}}\left[\inf \left\{t>0: Y_{u}+\tilde{B}_{u+t}-\tilde{B}_{u}=0\right\} \leq K^{2}(s-u)\right],
\end{aligned}
$$

from which

$$
\begin{aligned}
\tilde{\mathbb{P}}\left[g_{s} \geq u\right] & \leq \tilde{\mathbb{E}}\left[\int_{0}^{K^{2}(s-u)} \frac{1}{\sqrt{2 \pi \theta^{3}}}\left|Y_{u}\right| \exp \left(-\frac{Y_{u}^{2}}{2 \theta}\right) d \theta\right] \\
& \leq C \tilde{\mathbb{E}}\left[\exp \left(-\frac{Y_{u}^{2}}{4 K^{2}(s-u)}\right)\right]
\end{aligned}
$$

For $0 \leq v<s$ set

$$
m_{v}:=-\int_{0}^{v} \frac{Y_{\theta}}{2 K^{2}(s-\theta)} d Y_{\theta} .
$$

Itô's formula implies that

$$
\begin{aligned}
-\frac{Y_{v}^{2}}{4 K^{2}(s-v)} \leq & -\frac{1}{2 K^{2}} \int_{0}^{v} \frac{Y_{\theta}}{s-\theta} d Y_{\theta}-\frac{1}{8 K^{4}} \int_{0}^{v} \frac{Y_{\theta}^{2}}{(s-\theta)^{2}} d\langle Y\rangle_{\theta} \\
& -\frac{1}{4 K^{4}} \int_{0}^{v} \frac{d \theta}{s-\theta}
\end{aligned}
$$

from which

$$
\tilde{\mathbb{E}}\left[\exp \left(-\frac{Y_{v}^{2}}{4 K^{2}(s-v)}\right)\right] \leq \exp \left(-\frac{1}{4 K^{4}} \int_{0}^{v} \frac{d \theta}{s-\theta}\right) .
$$

As $f$ is increasing, we deduce

\begin{aligned}
\tilde{\mathbb{E}}\left[f^{2 \beta}\left(g_{s}\right)\right] & =\int_{f^{2 \beta}(0)}^{f^{2 \beta}(s)} \tilde{\mathbb{P}}\left[f^{2 \beta}\left(g_{s}\right) \geq u\right] d u+f^{2 \beta}(0) \\
& =\int_{f^{2 \beta}(0)}^{f^{2 \beta}(s)} \tilde{\mathbb{P}}\left[g_{s} \geq\left(f^{2 \beta}\right)^{-1}(u)\right] d u+f^{2 \beta}(0) \\
& =\int_{0}^{s} \tilde{\mathbb{P}}\left[g_{s} \geq v\right] 2 \beta f^{2 \beta-1}(v) f^{\prime}(v) d v+f^{2 \beta}(0) \\
& \leq C_{T} \int_{0}^{s}\left(\frac{s-v}{s}\right)^{\frac{1}{4 K^{4}}} f^{2 \beta-1}(v) f^{\prime}(v) d v+f^{2 \beta}(0) .
\end{aligned}
$$

Therefore, using the Fubini-Tonelli theorem for positive functions and the hypothesis (5), we get

$$
\begin{align*}
\int_{0}^{T} \tilde{\mathbb{E}}\left(f^{2 \beta}\left(g_{s}\right)\right) d s & \leq C_{T} \int_{0}^{T} d v f^{2 \beta-1}(v) f^{\prime}(v) \int_{v}^{T}\left(\frac{s-v}{s}\right)^{\frac{1}{4 K^{4}}} d s+C_{T} T f^{2 \beta}(0) \\
& \leq C_{T} \int_{0}^{T} \frac{d v}{\frac{1}{4 K^{4}}} f^{2 \beta-1}(v) f^{\prime}(v)(T-v)^{1+\frac{1}{4 K^{4}}}+C_{T} T f^{2 \beta}(0) \\
& <+\infty \tag{38}
\end{align*}
$$

In view of (33), we deduce that

$$
\begin{equation*}
A^{h}(T) \leq C_{T} \delta_{h} . \tag{39}
\end{equation*}
$$

An upper bound for $D_{p}^{h}$. We proceed as in the proof of Lemma 4.1. The main modification is the following one: As

$$
D_{p}^{h} \leq \int_{0}^{h} f(p h) \mathbf{1}_{\left[\delta_{h} / 2,+\infty\right)}\left(\left|M_{s+p h}\right|\right) d s,
$$

we deduce

$$
\begin{align*}
\mathbb{E} D_{h}^{p} & \leq \mathbb{E}\left(\int_{0}^{h} f(p h) \mathbf{1}_{\sup _{0 \leq u \leq s}\left|M_{u+p h}\right| \geq \delta_{h} / 2} d s\right) \\
& \leq f(p h) \mathbb{E}\left(\int_{0}^{h} \mathbf{1}_{\sup _{0 \leq u \leq s}\left|M_{u+p h}\right| \geq \delta_{h} / 2} d s\right) \\
& \leq f(p h)\left(\int_{0}^{h} 2 \mathbb{P}\left(\sup _{0 \leq u \leq s} M_{u+p h} \geq \delta_{h} / 2\right) d s\right)  \tag{40}\\
& \leq C f(p h) \exp \left(-\frac{1}{K^{2}} \frac{\delta_{h}^{2}}{h}\right) \\
& \leq C h f(p h) \delta_{h} .
\end{align*}
$$

From (31), (39), and (40), we deduce that

$$
\begin{aligned}
h \mathbb{E}\left(\sum_{p=0}^{N_{h}} f(p h) \mathbf{1}_{\left[-\delta_{h}, \delta_{h}\right]}\left(X_{p h}\right)\right) & \leq C_{T} \delta_{h}+C \delta_{h} \sum_{p=0}^{N_{h}} h f(p h) \\
& \leq C_{T} \delta_{h}+C \delta_{h} \int_{0}^{T} f(s) d s \\
& \leq C_{T} \delta_{h} .
\end{aligned}
$$

This ends the proof of Theorem 1.4.
