## Mechanical problem

Consider a mechanical system in dimension $d$ ( $d=2$ or 3 ) with

- finitely many degrees of freedom: $m$
- finitely many contact points: $n$
- Coulomb friction at contact points
- inelastic impacts for simplicity



## Notations

Problem: compute one time step
Unknowns:

- $v \in \mathbb{R}^{m}:$ (discretized) generalized velocities
- $u \in \mathbb{R}^{n d}$ : (discretized) relative velocities at contact points
- $r \in \mathbb{R}^{n d}$ : (discretized) contact forces or impulses

Previous example:

- $v \approx(\dot{x}, \dot{y}, \dot{\theta}) \in \mathbb{R}^{3}$
- $u \approx\left(u^{1}, u^{2}\right) \in \mathbb{R}^{4}$
- $r \approx\left(r^{1}, r^{2}\right) \in \mathbb{R}^{4}$


## Assumptions

## linear dynamics

$$
\begin{equation*}
M v+f=H^{\top} r \tag{1}
\end{equation*}
$$

## linear kinematics

$$
\begin{equation*}
u=H v+w \tag{2}
\end{equation*}
$$

for given

- $M$ (size: $m \times m$, symmetric positive)
- $f$ (size: $m \times 1$ )
- $H$ (size: $n d \times m$ )
- $w($ size: $n d \times 1)$


## Assumptions

Given normal vector $e$, define second-order cone $K_{\mu}$

$$
K_{\mu}=\left\{\left\|r_{T}\right\| \leq \mu r_{N}\right\} \subset \mathbb{R}^{3}
$$



Coulomb friction (at velocity level)

$$
\begin{cases}\text { or: take-off } & r=0 \text { and } u_{N} \geq 0 \\ \text { or: stick } & r \in \operatorname{int}\left(K_{\mu}\right) \text { and } u=0  \tag{3}\\ \text { or: slide } & r \in \partial K_{\mu} \backslash 0 \text { and } u_{N}=0 \\ & \text { with } u_{T} \text { opposed to } r_{T}\end{cases}
$$

We note (3) by

$$
(u, r) \in C(\mu, e)
$$

## Known reformulations of $C(\mu, e)$

Coulomb's law (3) can be equivalently reformulated

## Alart-Curnier

non-linear, non-smooth equation $f_{A C}(u, r)=r$ with

$$
f_{A C}(u, r)=\left[\begin{array}{c}
\mathrm{P}_{\mathbb{R}^{+}}\left(r_{N}-\rho u_{N}\right) \\
\mathrm{P}_{B\left(0, \mu r_{N}\right)}\left(r_{T}-\rho u_{T}\right)
\end{array}\right]
$$

## De Saxcé

complementarity constraint $K_{\mu}^{*} \ni \widetilde{u} \perp r \in K_{\mu}$ with

$$
\widetilde{u}:=u+\mu\left\|u_{T}\right\| e
$$

$K^{*}$ : dual cone of $K ; K_{\mu}^{*}=K_{\frac{1}{\mu}}$

## Interpretation of $\widetilde{u}$

The change of variables

$$
\widetilde{u}:=u+\mu\left\|u_{T}\right\| e
$$

introduces normality

but the value of $\left\|u_{T}\right\|$ is unknown a priori!

## Whole problem

- Finally, we want to solve the incremental problem

$$
\begin{cases}M v+f & =H^{\top} r  \tag{4}\\ u & =H v+w \\ K_{\mu}^{*} \ni \widetilde{u} & \perp r \in K_{\mu}\end{cases}
$$

- algorithms are available
- Newton iterations on Alart-Curnier function
- Uzawa iterations on De Saxcé's bipotential
- many variants (fixed-points iterations, "Gauss-Seidel" ...)
- ... but algorithms sometimes fail
- does a solution exist?
- if "yes", improve our algorithm !
- if "no", does our problem make sense ?

## Example

Consider a rigid bar under gravity with $d=2$ and

- imposed velocity $u_{0}$ in $A$
- one degree of freedom $\theta$
- $v=0$ at previous time step

Constants:

- do not fix yet $u_{0} \neq 0, \mu$ and $h_{0}$ (or $\left.\theta \in\right] 0, \frac{\pi}{2}[$ )
- other values fixed for convenience



## Incremental problem

After time discretization

$$
\left\{\begin{aligned}
v & =\cos (\theta) r_{x}+\sin (\theta) r_{y}-\sin \theta \\
u_{x} & =\cos (\theta) v+u_{0} \\
u_{y} & =\sin (\theta) v \\
(u, r) & \in C\left(u_{y}, \mu\right)
\end{aligned}\right.
$$

which can be solved by inspection

- one contact $\rightarrow$ only three cases
- $d=2 \rightarrow$ all constraints are linear


## Solving by hand

Consider the three possible cases

- take-off: $r=0$ implies $u_{y}<0$, impossible
- stick: $u=0$. If $u_{0} \neq 0$, impossible
- slide: $u_{y}=0$ implies $v=0$ and $u_{x}=u_{0}$ (to be continued...)


$$
u_{0}>0
$$


$u_{0}<0$

## Case $u_{0}<0$

If $u_{0}<0$,

- linear system (plus condition $r_{y} \geq 0$ )

$$
\begin{cases}\cos (\theta) r_{x}+\sin (\theta) r_{y} & =\sin (\theta) \\ -r_{x}+\mu r_{y} & =0\end{cases}
$$

- solution is

$$
r_{y}=\frac{\tan (\theta)}{\tan (\theta)+\mu} \geq 0
$$

- condition $r_{y} \geq 0$ is automatically satisfied

A (unique) solution exists

## Case $u_{0}>0$

If $u_{0}>0$,

- linear system (plus condition $r_{y} \geq 0$ )

$$
\begin{cases}\cos (\theta) r_{x}+\sin (\theta) r_{y} & =\sin (\theta) \\ r_{x}+\mu r_{y} & =0\end{cases}
$$

- solution is

$$
r_{y}=\frac{\tan (\theta)}{\tan (\theta)-\mu}
$$

for $\tan \theta \neq \mu$ (otherwise, no solution)

- condition $r_{y} \geq 0$ gives:

$$
\tan \theta>\mu
$$

A solution exists if and only if $\tan \theta>\mu$

## Conclusion

## Finally...

A solution exists iff $u_{0} \leq 0$ or $\left[u_{0}>0\right.$ and $\left.\tan (\theta)>\mu\right]$
Coherent with intuition:

- when $\tan \theta>\mu$, friction torque acts counter-clockwise,
- compensate effect of gravity
- if $\tan \theta<\mu$, friction torque acts clockwise,
- and increases effect of gravity



## Goal

- Given the data $M, f, H, w$ (plus $\mu$ and e)
- provide a checkable criterion
- that ensures existence of a solution

Validation:
the criterion can be checked on the Painlevé-Klein example

## Reformulation

- Introduce extra variable $s^{i}$ at each contact

$$
\begin{equation*}
s^{i}:=\left\|u_{T}^{i}\right\| \tag{5}
\end{equation*}
$$

- perform the change of variables (cf De Saxcé)

$$
u \longrightarrow \widetilde{u}:=u+\mu e s
$$

incremental problem

$$
\left\{\begin{array}{l}
M v+f=H^{\top} r  \tag{6}\\
\widetilde{u}=H v+w+\mu e s \\
K_{\mu}^{*} \ni \widetilde{u} \perp r \in K_{\mu}
\end{array}\right.
$$

## Why should we do that?

(6) are KKT conditions of two convex optimization problems (SOCP: second order cone programs)

## primal problem

$$
\left\{\begin{array}{l}
\min J(v):=\frac{1}{2} v^{\top} M v+f^{\top} v  \tag{s}\\
H v+w+\alpha s \in K_{\mu}^{*}
\end{array}\right.
$$

## dual problem

$$
\left\{\begin{array}{l}
\min _{r \in K_{\mu}} J_{s}(r):=\frac{1}{2} r^{\top} W r-b_{s}^{\top} r  \tag{s}\\
\end{array}\right.
$$

with $W=H M^{-1} H^{\top}$ and $b_{s}=\alpha s+\beta$
Side note: when $\mu=0$, incremental problem is a QP (Moreau)

## Final reformulation

- Introducing

$$
u(s):=\operatorname{argmin}_{u}\left(P_{s}\right)=\operatorname{argmin}_{u}\left(D_{s}\right)
$$

practically computable by optimization software, and

$$
F^{i}(s):=\left\|u_{T}^{i}(s)\right\|,
$$

- the incremental problem becomes


## fixed point problem

$$
F(s)=s
$$

## Assumption

## Assumption

$$
\exists v \in \mathbb{R}^{m}: H v+w \in K_{\mu}^{*}
$$

- Interpretation: it is kinematically possible to enforce

$$
u \in K_{\mu}^{*}
$$

at each contact

- not only the intuitive $u_{N} \geq 0$ !



## Consequence

Using the assumption,

- the application $F: \mathbb{R}_{+}^{n} \rightarrow \mathbb{R}_{+}^{n}$ is well-defined
- it is continuous
- it is bounded
- apply Brouwer's theorem


## Theorem

A fixed point exists

## Application to the Painlevé example

For the example

- the criterion is

$$
\exists v \in \mathbb{R} ;\left(u_{0}, 0\right)+(\cos \theta, \sin \theta) v \in K_{\mu}^{*}
$$

- we find exactly


## condition

$$
u_{0} \leq 0 \text { or }\left[u_{0}>0 \text { and } \tan (\theta)>\mu\right]
$$


$u_{0}>0$ and $\theta \leq \arctan (\mu)$

## Applicability of the criterion

- determine whether the intersection of a cone and a affine halfspace is empty of not
- easily checkable in general
- only a sufficient condition
- necessary and sufficient for Painlevé-Klein example ...
- ... and when when $\mu=0$ (QP case)
- not true in general

## Can this be used in practice?

The fixed point equation $F(s)=s$ can be tackled by

- fixed-point iterations

$$
s \leftarrow F(s)
$$

- Newton iterations

$$
s \leftarrow \mathrm{Jac}[F](s) \backslash F(s)
$$

- Variants possible (truncated resolution of inner problem...)


## Does it work ?

- fixed-point iterations:
- expensive
- not very robust
- Newton:
- usually very few iterations...
- ... but they are expensive
- bottleneck: SOCP solver
- practical interest is unclear yet
- more robust?
- faster ?


## Illustration

- Toy problem: $d=2, n=2$ (a bead stuck in a corner)
- plotting

$$
s \rightarrow \frac{1}{2}\|F(s)-s\|^{2}
$$

observe

- non-smoothness...
- . . . and non-convexity
- ... and non-uniqueness



## Convergence log (3D, 100 contacts)



## Summary

- a new formulation of (standard) incremental problem
- yields a checkable existence criterion
- and new numerical prospects

- anisotropic friction could be handled
- non-linear dynamics as well
