## INTRODUCTION

This report provides a reference guide to the CoSenS protocol stack. CoSenS provides a simple but efficient improvement of the MAC layer of IEEE 802.15.4 [1] in terms of reliability, delay and throughput. The network layer uses static routing or hierarchical tree routing of ZigBee standard [2].

The objective of CoSenS besides the improvement of IEEE 802.15.4 standard is to allow quality of service (QoS) support in wireless sensor networks. The MAC layer enables the implementation of scheduling policies and management mechanisms like congestion control and data aggregation.

## PROTOCOL DESIGN

### GENERAL PARAMETERS AND NETWORK ARCHITECTURE

We consider a wireless network composed of simple nodes and router nodes (named router in the rest of the document). A simple node is a device that generally has measurement sensors built in and has limited routing decisions capabilities. A router is a device that implements full routing and network management protocols. However, it can act like a simple device when its routing and management capabilities are disabled.

The network may be statically defined or dynamically organized into a tree. In the latter case, it uses the tree addressing scheme presented in ZigBee standard.

### CHANNEL ACCESS PROTOCOL

#### GENERAL DESCRIPTION

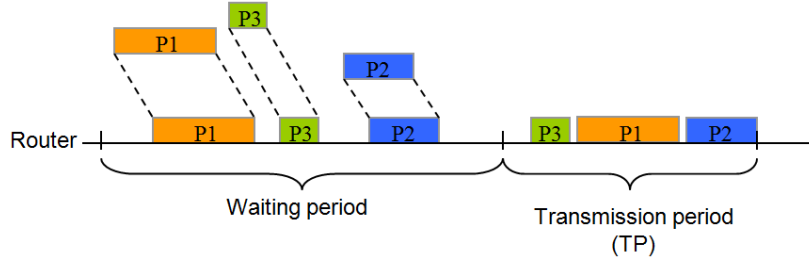


Fig. 1. An example of how the collecting and sending burst scheme operates

All nodes (simple nodes and routers) use CSMA/CA protocol to access the medium but with different maximum backoff intervals in order to give routers higher chance to access the medium; we used the unslotted version of CSMA/CA proposed by IEEE 802.15.4 (used in the non beacon enabled mode). CoSenS operates on the top of the "2450 MHz DSSS IEEE 805.15.4" physical layer; the data rate is equal to 250 kbps.

Routers use on the top of CSMA/CA protocol a collecting and sending burst scheme. In fact, a router does not transmit packets one by one upon their arrival. Instead, it waits for a period of time that we call *waiting period* (WP) and collects data either from its children or from its neighbor routers. After the end of the WP, the router starts transmitting all packets queued in its buffer in a single burst. We call this period of time the *transmission period*. Finally, at the end of the TP, the router starts another cycle and goes again to the waiting for reception state. WP and TP are illustrated in the example given by Fig. 1. Full details of the WP and TP are given next.

## WAITING PERIOD

We define

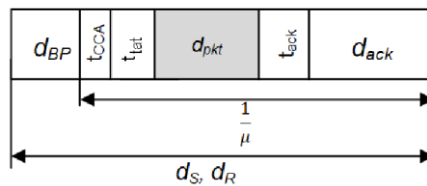


Fig. 2.  $d_S$ ,  $d_R$  and  $\frac{1}{\mu}$

- $d_S$  and  $d_R$  as the maximum amount of time needed by a simple node and a router, respectively, to perform collision avoidance procedure ( $d_{BP}$ ), sense the channel ( $t_{CCA}$ ) and detect that it is Idle (at the first attempt), change the antenna state from receiver to sender ( $t_{tat}$ ), send the packet ( $d_{pkt}$ ), wait for an acknowledgment ( $t_{ack}$ ), and receive it. See Fig. 2.
- $N_{max}$  as an integer which has a minimum value of 1. Its value depends on the amount of received traffic.
- $N_c^r$  as the number of children associated to the router  $r$ .

WP is given by the equation 2. When a router has no children, data packets come only from neighbor routers. Hence, we use  $d_R$  as a basis to calculate WP duration. In the other case, data packets can come either from children or neighbor routers. However, since  $d_S$  is greater than  $d_R$  (because  $d_{BP}$  is bigger for simple nodes), it is used as a basis to calculate WP duration.

$$WP = \begin{cases} N_{max} \cdot d_S & \text{if } N_c^r \neq 0 \\ N_{max} \cdot d_R & \text{otherwise} \end{cases} \quad (2)$$

## ESTIMATION ALGORITHM

Let's define first the set  $\Omega \in \mathbb{IN}$  as the set of  $WP$ s during which the router receives data and  $WP_k$ ,  $k \in \Omega$  these  $WP$ s. We define also,  $U_k$ ,  $k \in \Omega$  as the ratio giving the sum of the service times of received packets ( $\sum_{i \in E_k} \frac{1}{\mu_i}$ ,  $E_k$  is the set of received packets during  $WP_k$ ) divided by  $WP_k$  duration.  $\frac{1}{\mu_i}$  is the service time of packet  $i$  (Fig. 2).  $U_k$  is shown in (3). We note that  $U_k$  can exceed 1 in the case where the router is still receiving a packet from a child or data from a neighbor router while the  $WP$  ends (recall that the router is not preemptive).

$$U_k = \frac{\sum_{i \in E_k} \frac{1}{\mu_i}}{WP_k} \quad (3)$$

Let us denote by  $S_k$  the exponential moving average of  $U_k$ ,  $k \in \Omega$

$$S_k = (1 - \alpha)S_{k-1} + \alpha U_{k-1} \quad (4)$$

$\alpha$  is the smoothing factor. We used a non linear filter where  $\alpha$  is bigger when  $U_{k-1} \geq S_{k-1}$  allowing  $S_k$  to adapt more swiftly to traffic increase. After a number of trials, we found that values of  $\alpha$ ,  $\alpha_1 = 0.008$  and  $\alpha_2 = 0.01$ , gave the best of all-around performance. The computation of  $S_k$  resembles that of the average queue length in RED [3] and the round trip time in TCP [4].

$S_k$  is evaluated before the beginning of the  $k^{th}$   $WP$  and used in the Algorithm 1 to determine the value of  $N_{max}$  for the  $k^{th}$   $WP$  (thus its duration). In the algorithm,  $Thr_{max}$ ,  $Thr_{min}$  and  $NMAX$  designate the maximum threshold of  $S_k$ , the minimum threshold of  $S_k$  and the maximum value of  $N_{max}$ , respectively.  $Th_{max}$  allows the increase of the  $WP$ 's duration. When set too high, the  $WP$  will not respond rapidly to the network load growth. When set too low, bandwidth will be wasted since the  $WP$  will increase too fast.  $Th_{min}$  is the minimum utilization ratio under which the protocol performance will degrade significantly.  $Th_{min}$  is used to decrease the  $WP$ 's duration : set too high,  $WP$  decreases fast which diminish the benefits of our algorithm. When set too low,  $WP$ 's duration decreases too slowly compared to the network load growth. The values of  $Thr_{max}$  and  $Thr_{min}$  are set to 0.28 and 0.75, respectively (tuned using some preliminary simulations with fixed  $WP$ s).  $NMAX$  bounds the value of  $N_{max}$  to prevent a high increase in the  $WP$  duration. It is set to 15 in all simulations.

Intuitively,  $S_k$  calculates the average utilization ratio of the  $WP$ . If  $S_k$  exceeds  $Thr_{max}$ , the value of the  $N_{max}$  is increased which increases the duration of the  $WP$ . If  $S_k$  decreases below  $Thr_{min}$ , the value of  $N_{max}$  is decreased. We can see that changing the  $WP$  duration, affects the value of  $U_k$  (3) and so  $S_k$  which in its turn affects the value of  $N_{max}$ . Besides,  $S_k$  depends also on the traffic load. Hence, our algorithm appears like an iterative process where the objective is to find the good value of  $N_{max}$  that reflects the incoming traffic load while satisfying an utilization ratio between  $Thr_{min}$  and  $Thr_{max}$ .

## TRANSMISSION PERIOD

The collected data during the waiting period are transmitted in a burst. CSMA CA protocol is used to transmit only the first packet. Then, the remaining packets are transmitted directly upon the reception of the acknowledgement ( $ack$ )<sup>1</sup>. If an  $ack$  is not received for a given packet, it is retransmitted using CSMA/CA protocol. Then, the remaining packets will be sent directly.

CoSenS needs a finite amount of time to process data received by the PHY. So, a separation period between the acknowledgment frame and the next transmission shall be used (however, they are fixed to zero in the simulations).

## NETWORK LAYER

The network layer may use static routing or hierarchical tree routing (HTR) protocol defined in ZigBee standard. In this section we describe the tree formation procedure and the HTR protocol.

## NETWORK FORMATION

### ASSOCIATION

We denote by the root, the router that starts the network and specifies all its parameters (like the parameters needed for address attribution). The root is equivalent to the the ZigBee coordinator in the ZigBee standard.

The association procedure works as follows. A node that wants to join the network, checks immediately its neighbor table to find the best candidate for association (the one that has the minimum depth and number of children). If a candidate is found, an association request is sent to this router. The node goes then to the waiting for reply state. If the neighbor table is empty, the node sends an “advertise\_yourself” message, waits a defined amount of time and then checks the neighbor table again. The procedure is repeated until a candidate is found.

A router that receives an “advertise\_yourself” message sends a hello message containing its address, depth, the number of its associated routers and the number of its associated simple nodes.

A router that receives an “association\_request” message and accepts the association, sends an “association\_response” message to the originator of the request containing the assigned address and the network parameters.

The association messages are not acknowledged. A node that issued an “association\_request” message waits a given amount of time for the “association\_response” message. If it is not received, the whole procedure is repeated. During the association procedure, all application packets are destroyed.

## ADDRESS ATTRIBUTION

The network addresses are assigned using a distributed address allocation scheme that is designed to provide every potential parent with a finite sub-block of network addresses to distribute to its children. During network establishment, the root determines the maximum number of children per parent ( $Cm$ ), the maximum number of routers ( $Rm$ ) between these children as well as the maximum depth of the network ( $Lm$ ) (the root has a depth of 0). A function called  $Cskip(d)$  (equation 4) is used after that to calculate the size of the address sub-bloc being distributed by each parent located at depth  $d$ .

$$Cskip(d) = \begin{cases} 1 + Cm \cdot (Lm - d - 1), & \text{if } Rm = 1 \\ \frac{1 + Cm - Rm - Cm \cdot Rm^{Lm - d - 1}}{1 - Rm}, & \text{otherwise} \end{cases} \quad (4)$$

The network address distribution is as follows. The root has always the address 0. For routers, the address assignment uses the value of  $Cskip(d)$  as an offset: if the node is the first served, its address is one greater than its parent address. Otherwise, the addresses are separated from each other by  $Cskip(d)$ . For simple nodes, network addresses are assigned in a sequential manner using the following rule :

$$A_n = A_{parent} + Cskip(d) \cdot Rm + n \quad (5)$$

Here  $1 \leq n \leq (Cm - Rm)$  and  $A_{parent}$  represents the address of the parent.

## HTR PROTOCOL

End devices (simple nodes in our case) always send their data to their father. For routers, HTR protocol is based on some comparison rules: for a ZigBee Router with address  $A$  at depth  $d$ , if the following logical expression is true, then a destination device with address  $D$  is a descendant.

$$A < D < A + Cskip(d - 1) \quad (6)$$

If it is the case, the Next Hop is given by the following rule:

- $N = D$  for ZigBee end devices where  $D > A + Rm \cdot Cskip(d)$
- $N = A + 1 + \left\lfloor \frac{D - (A + 1)}{Cskip(d)} \right\rfloor \times Cskip(d)$  , otherwise

If the expression is not true, the destination is not a descendant and the message should be routed through  $A$ 's parent.

# SIMULATION MODEL

## NODE MODEL

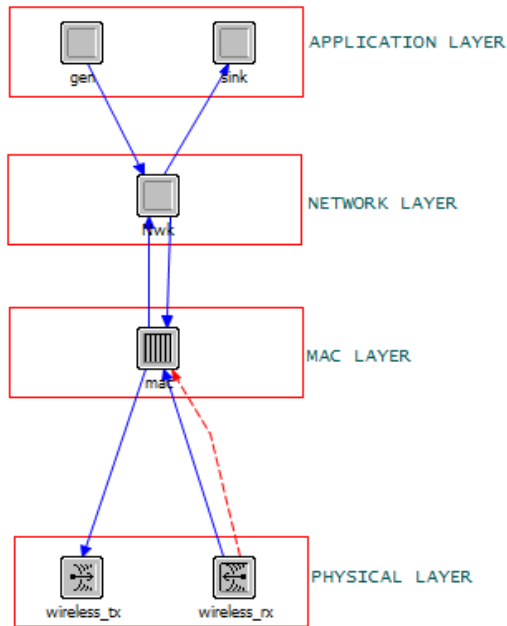


Fig. 3. Node model

CoSenS model is implemented within OPNET simulator [5]. The structure of the CoSenS sensor nodes (Fig. 3) used in the simulation model is composed of four functional blocks:

- The **Physical Layer** consists of a wireless radio transmitter (wireless\_tx) and receiver (wireless\_rx), operating at the 2.4 GHz frequency band and a data rate equal to 250 kbps. The transmission power is set to 0.05 W and the modulation technique is QPSK.

- The **MAC Layer** (mac) consists of an active queue where the server implements the CSMA/CA mechanism and the collect then send burst.
- The **Network Layer** (Nwk) implements the routing protocols and the association procedure.
- The **Application Layer** implements the traffic generator (gen) and the traffic sink (sink).

Routers and simple nodes have the same node model but with different attributes. Table. 1 gives a summary of node attributes of routers and simple nodes.

## MAC MODEL

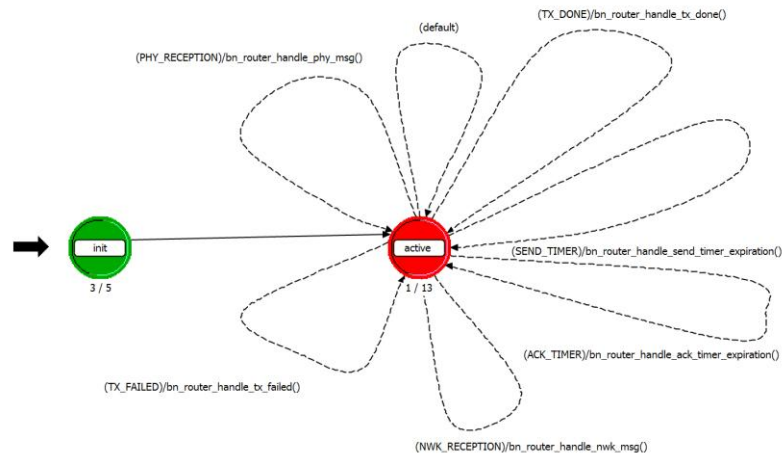


Fig. 4. MAC process model

The MAC process model is illustrated in Fig. 4. It consists of two states, **init** and **active**. In the init state, all the model parameters are initialized. The active state handles all the received events. Every transition handles an event. The pair “(my\_event)/my\_function()” means that the event “my\_event” is handled by the function “my\_function”. Here the list of the events.

- **PHY\_RECEPTION:** Reception of a packet from the physical layer.
- **TX\_DONE:** CSMA/CA process returns a transmission success.
- **TX\_FAILED:** CSMA/CA process returns a transmission fail.
- **SEND\_TIMER:** WP expired.
- **ACK\_TIMER:** Acknowledgment timer expired
- **NWK\_RECPTION:** Reception of a packet from the network layer

- **Default:** all other events

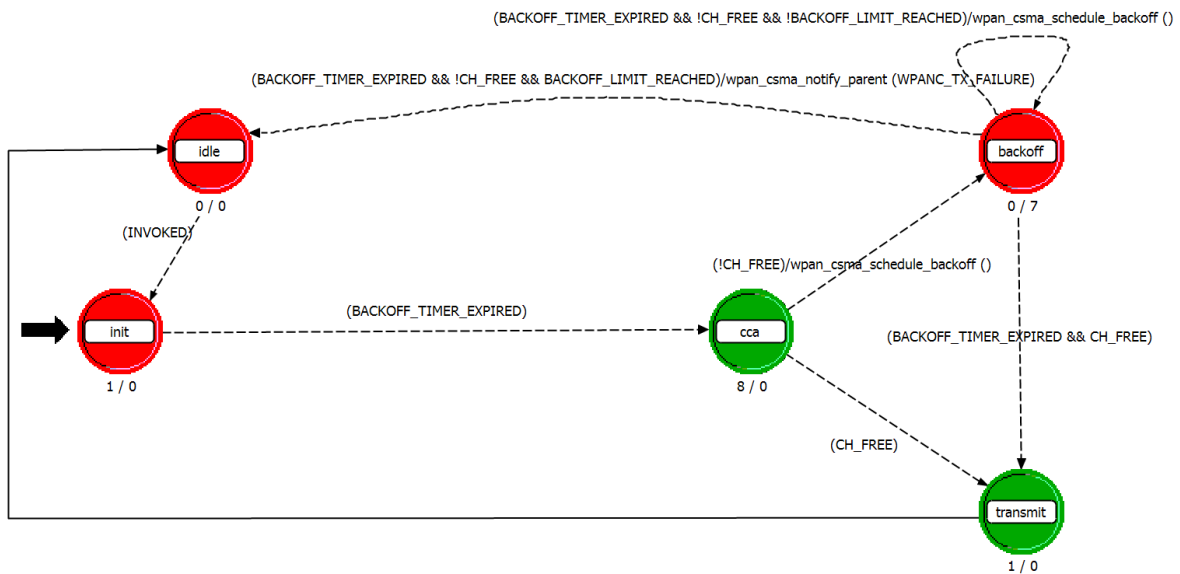


Fig. 5. CSMA/CA child process

CSMA/CA protocol is implemented as a process child of the MAC process. It is illustrated in Fig. 5. It is invoked either by *bn\_router\_handle\_nwk\_msg()* or *bn\_router\_handle\_tx\_done()* for simple nodes, *bn\_router\_handle\_send\_timer\_expiration()* for routers and *bn\_router\_handle\_tx\_failed()* for both node types.

## NWK MODEL

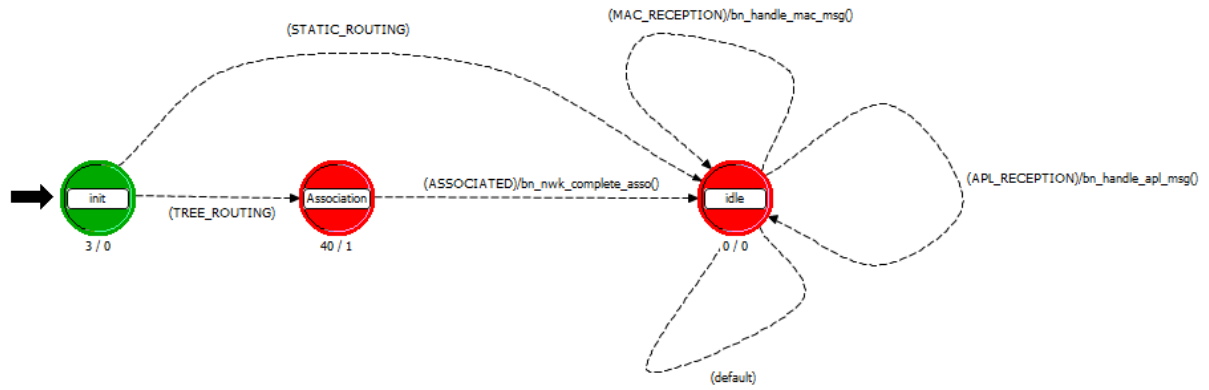


Fig. 6. Network process model

The network process is illustrated in Fig. 6. It consists of three states; **init**, **association** and **active**. After the initialization phase (init) and depending on the routing protocol used, the model goes to the idle state or association state. The idle state handles all network events which are in our model, reception of an application layer packet (**APL\_RECEPTION**) or an MAC packet (**MAC\_RECEPTION**).

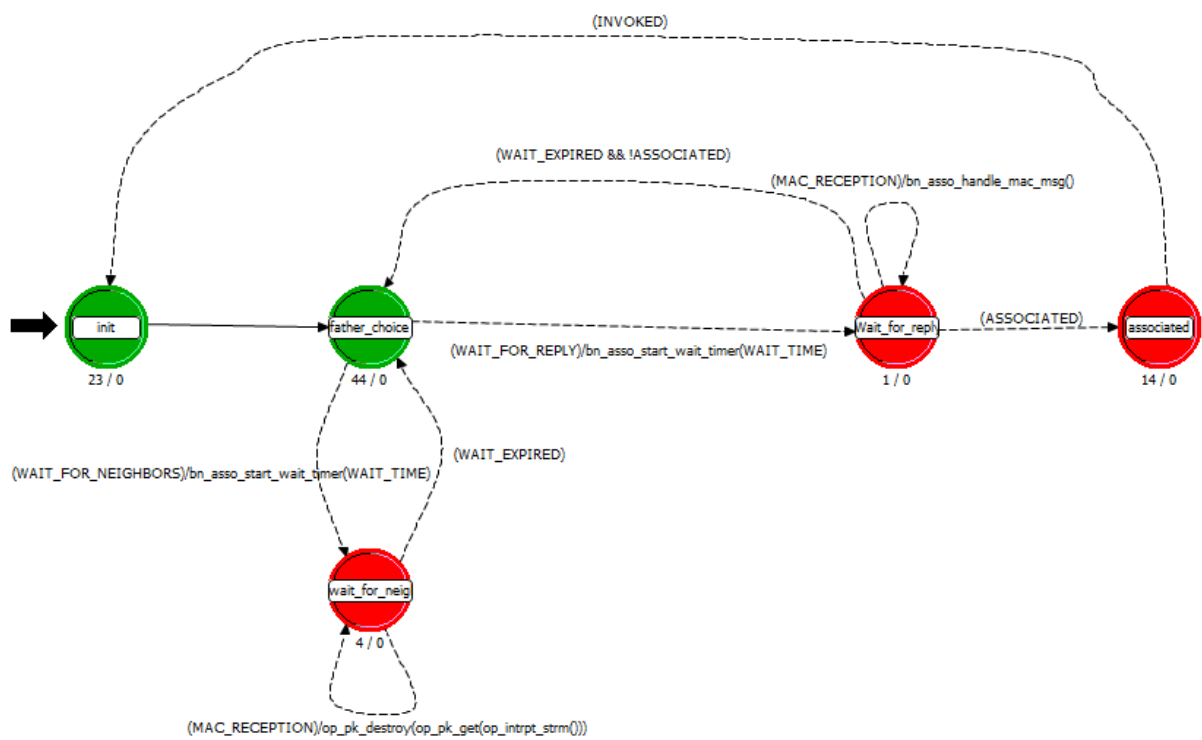


Fig. 7. Association child process model

The association procedure is performed only when tree routing is used. The association model is implemented as a child process. It is illustrated in Fig. 7. It is invoked in the association state. The association protocol is described in the association subsection

# PERFORMANCE ANALYSIS

## SIMULATION DESCRIPTION

In this set of scenarios, we will analyze the CoSenS performance regarding the self-synchronization between routers, end to end delay and throughput. The self-synchronization between routers is defined as the percentage of the simulated time where their TPs do not overlap.

For our simulations, the packet length is constant and equal to 400 bits. The generation is Poisson distributed. Simulation duration is equal to 15min and all simple nodes start transmitting at  $t = 10$  seconds.

In the first seven sections we used static routing and varied the topology and number of destinations. The objective is to study the influence of these parameters on protocol performance. The eighth section considers a random network with the use of HTR. The goal is to study the protocol performance under a more general topology. The last section analyzes the obtained results.

**SCENARIO 1: STAR TOPOLOGY**

**DESCRIPTION**

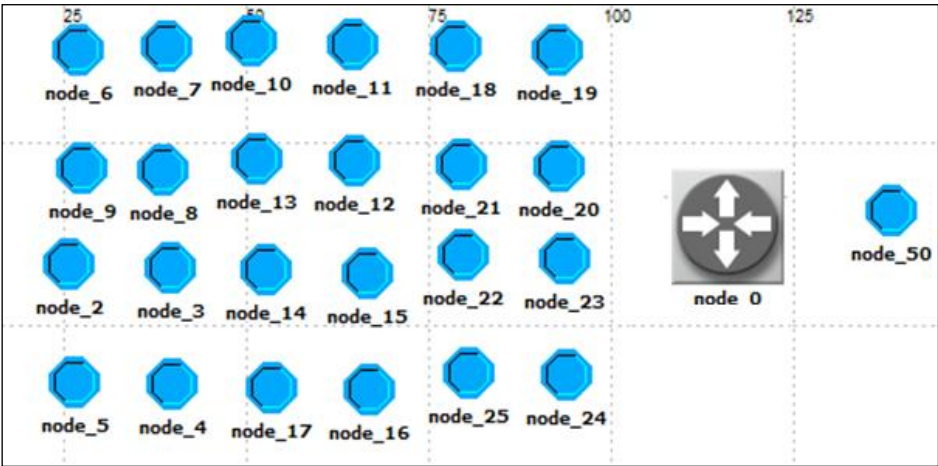


Fig. 8. Star topology

Nodes 6 to 24 send data to node 50 through the router 0. In this scenario we varied the inter arrival time and measured the transmission success rate and end to end delay.

**RESULTS**

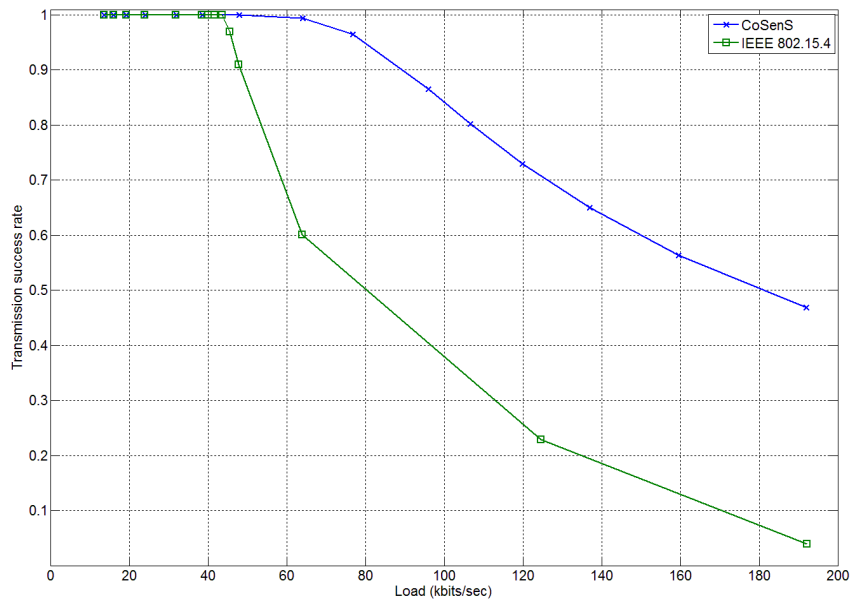


Fig. 9. Successful transmission rate comparison between CoSenS and IEEE 802.15.4 for star topology.

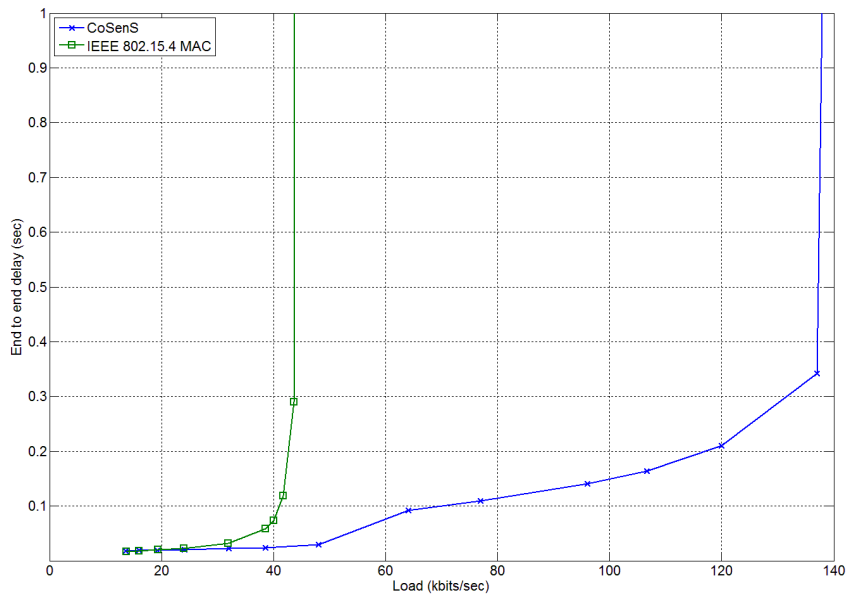


Fig. 10. End-to-end delay comparison between CoSenS and IEEE 802.15.4 for star topology.

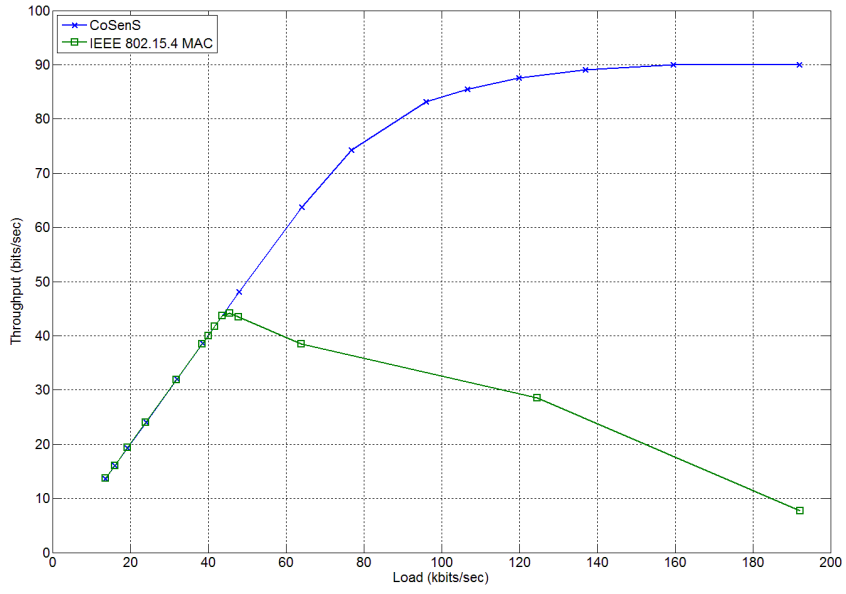


Fig. 11. Throughput comparison between CoSenS and IEEE 802.15.4 for star topology.

## SCENARIO 2: TWO ROUTERS – SINGLE BROADCAST ZONE – TWO DESTINATIONS

### DESCRIPTION

Nodes 6 to 24 are attached to router 0 and send data to node 50. Nodes 26 to 48 are attached to router 1 and send data to node 51. The inter arrival time is fixed to 0.3 seconds (~1.3 kb/s per node).

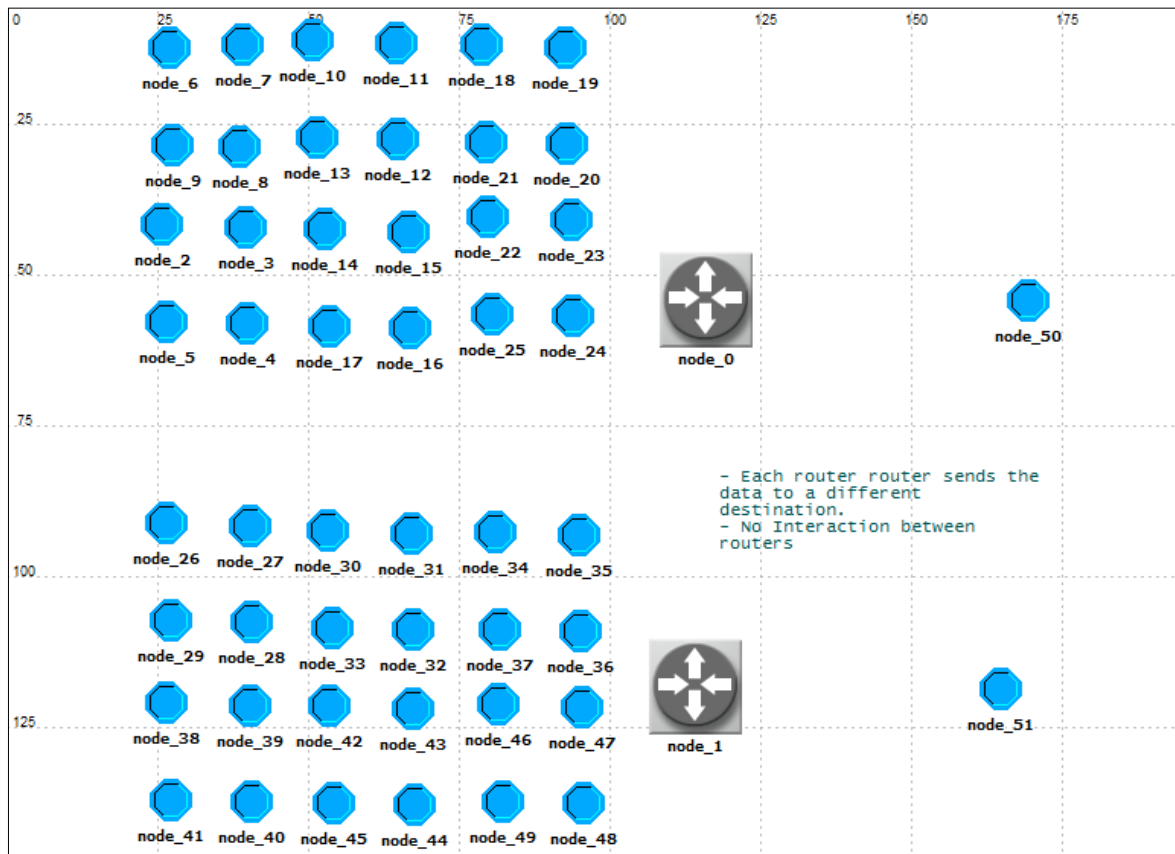


Fig. 12. Scenario 2.

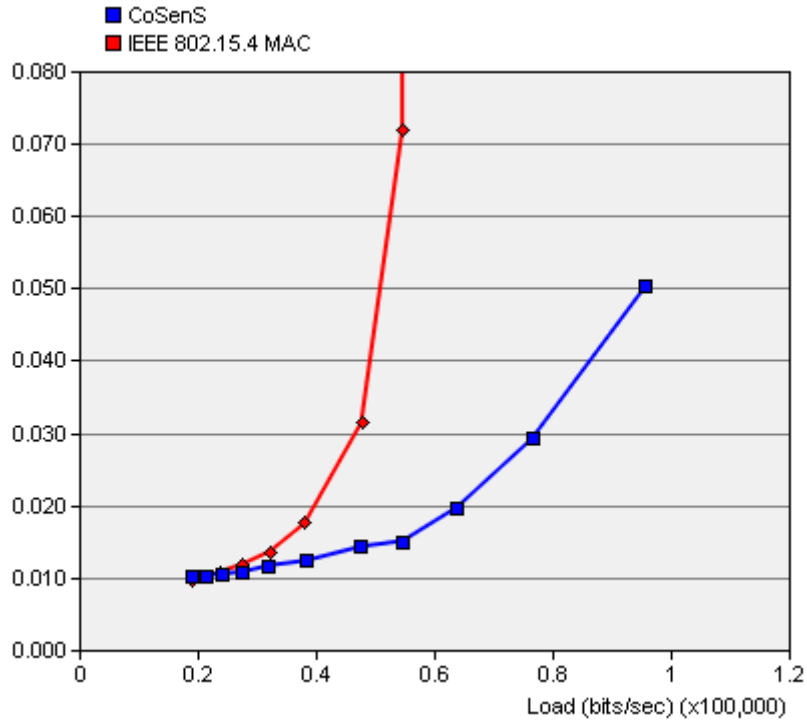


Fig. 13. End to end delay (s) for scenario 2.

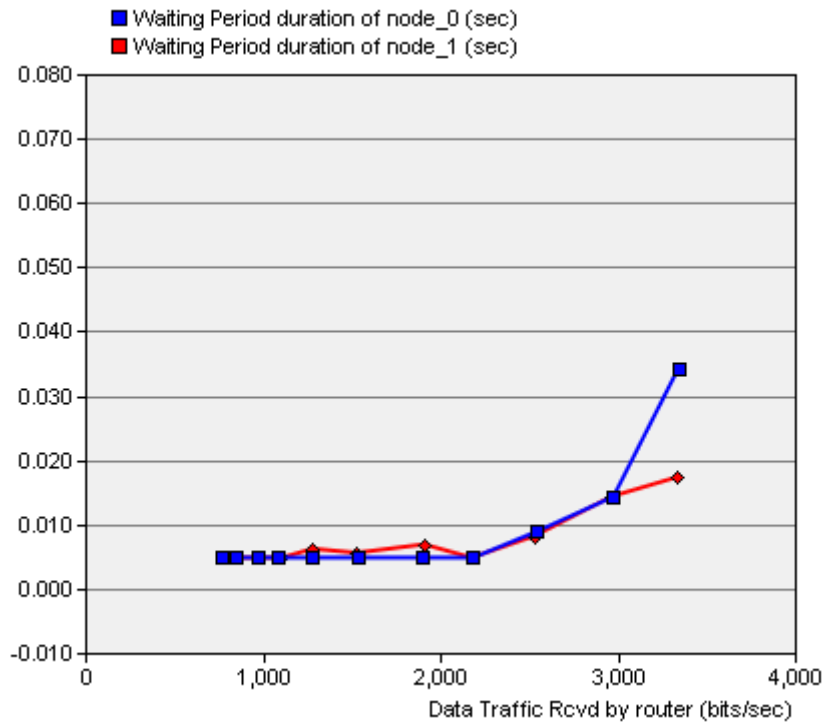


Fig. 14. Scenario 2 - WP duration.

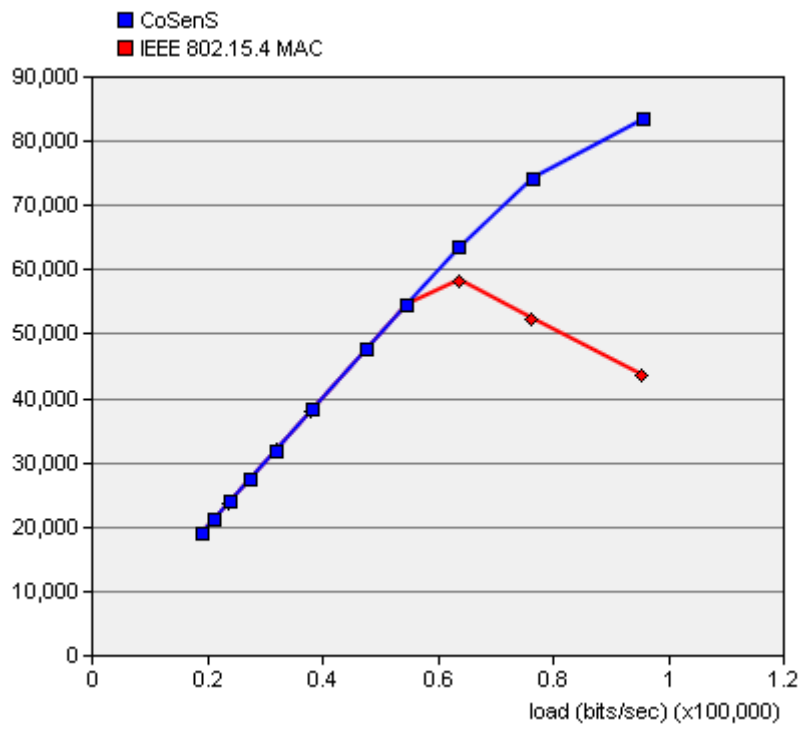


Fig. 15. Throughput (bits/s) results for scenario 2.

## SCENARIO 3: TWO ROUTERS – SINGLE BROADCAST ZONE – ONE DESTINATION

### DESCRIPTION

Two groups of nodes, each one attached to a router, send data to node\_50 which is associated to node\_0. So, node\_1 forwards data to node\_0. The inter arrival time is fixed to 0.3 seconds (~1.3 kb/s per node).

### RESULTS

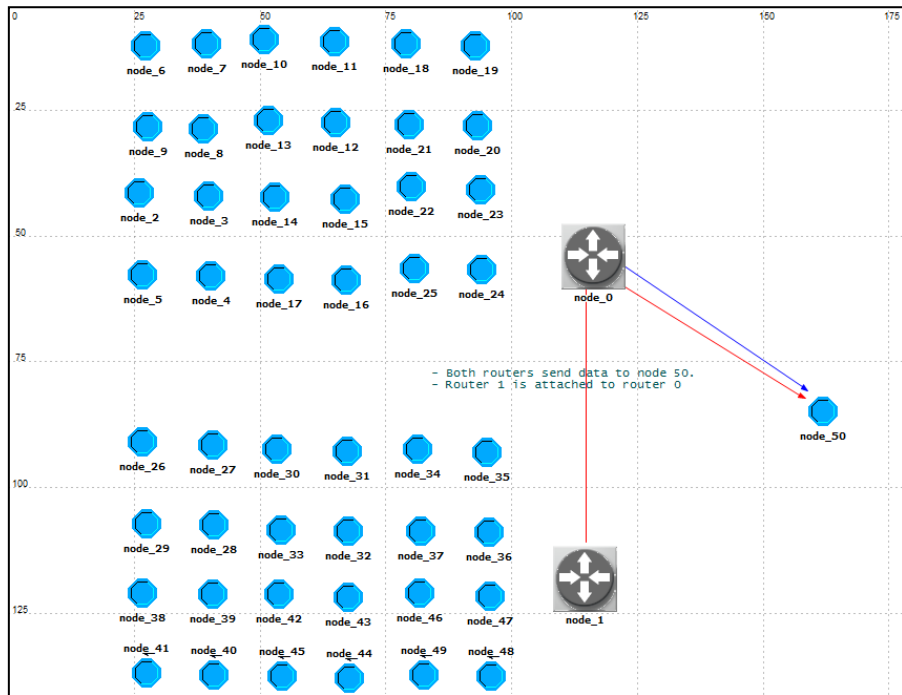


Fig. 16. Scenario 3.

### END-TO-END DELAY

The end-to-end delay increases in comparison with the first scenario since data generated by nodes 26 to 48 go through both routers to reach the destination.



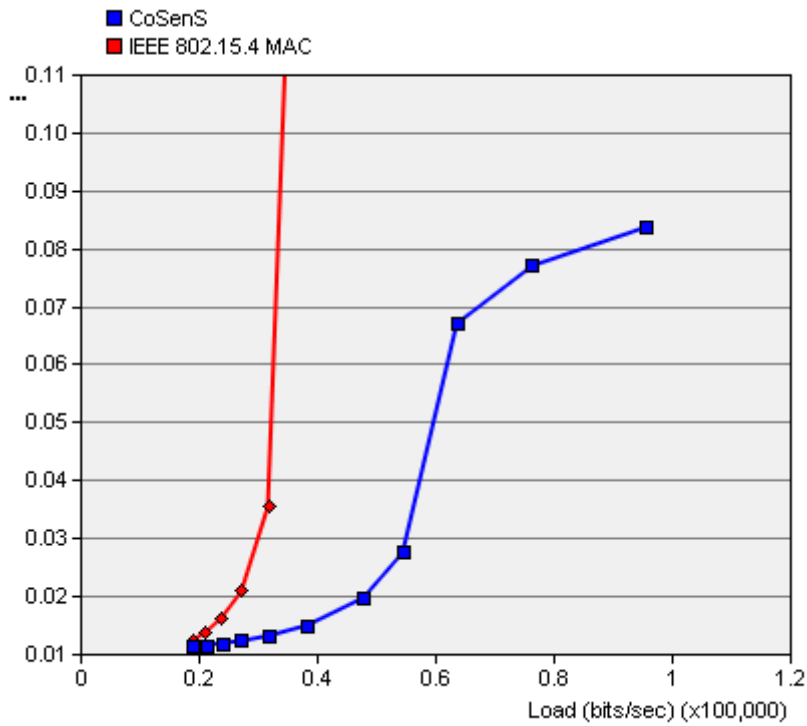


Fig. 17. End-to-end delay (s) for scenario 3.

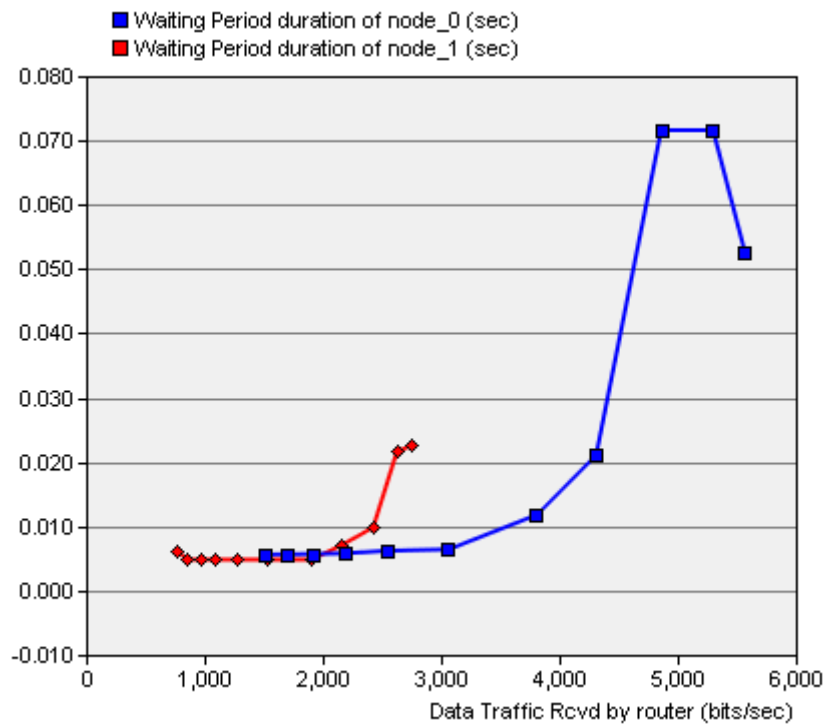


Fig. 18. WP duration for scenario 3.

#### WP DURATION (FIG. 18)

Observe the increase of the WP duration for node\_0 in comparison with scenario 2 as the data traffic received increases.

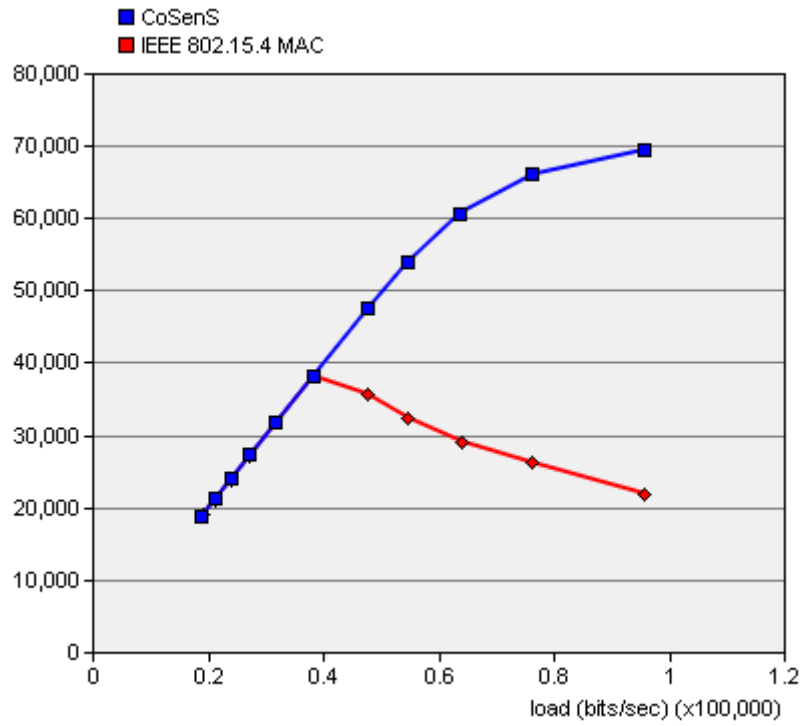


Fig. 19. Throughput (bits/sec) for scenario 3.

## SCENARIO 4: FOUR ROUTERS – ONE BROADCAST ZONE – FOUR DESTINATIONS

### DESCRIPTION

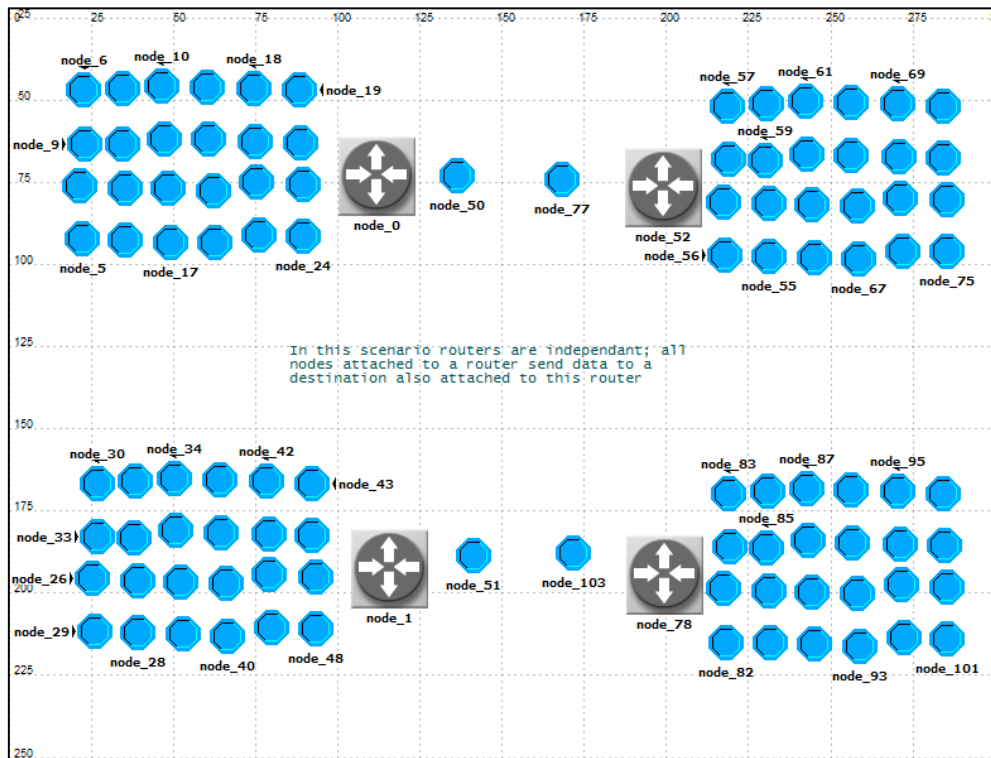


Fig. 20. Scenario 4.

This scenario resemble scenario 2 but we added two node groups each one associated to one new router (Fig. 20). The inter arrival time is fixed to 0.5 seconds ( $\sim 0.87$  kb/s per node).

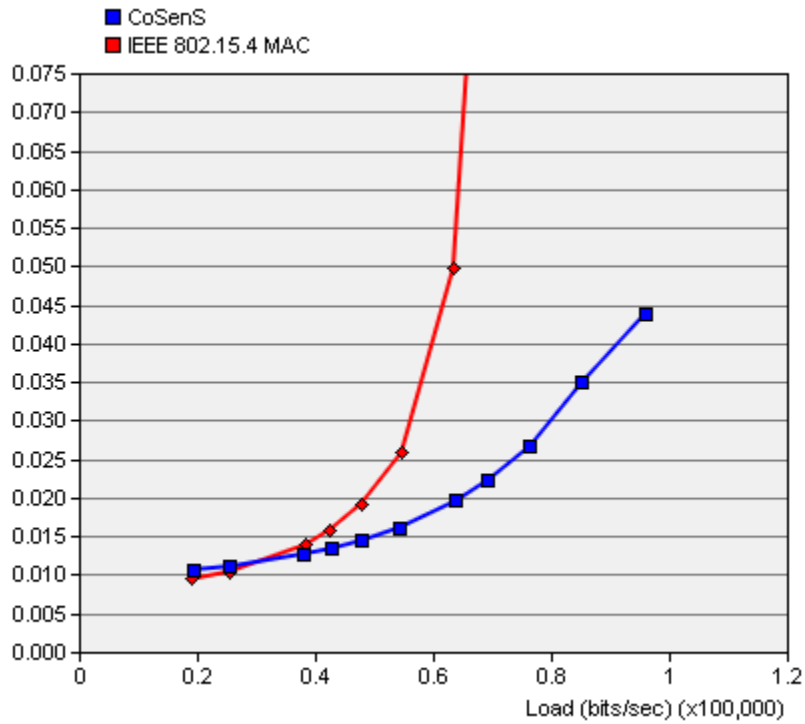


Fig. 21. End-to-end delay for scenario 4.

It is the same for the four routers since they receive the same amount of data.

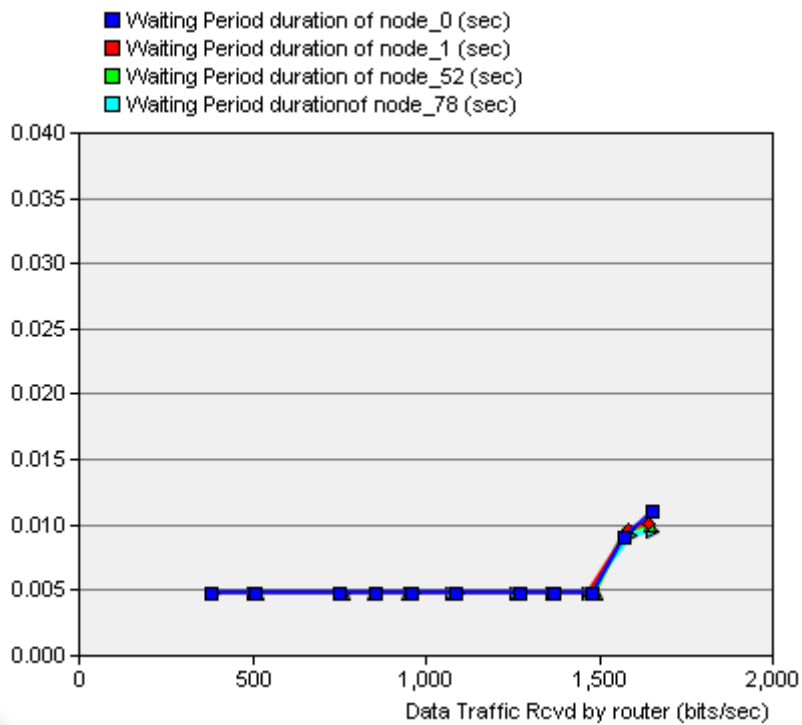


Fig. 22. WP duration for scenario 4.

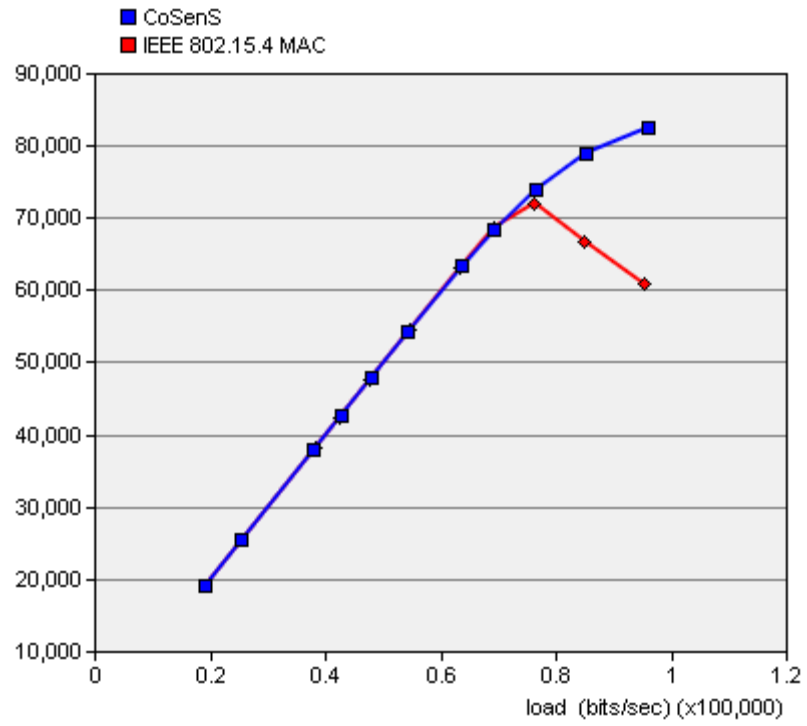


Fig. 23. Throughput for scenario 4.

## SCENARIO 5: FOUR ROUTERS – ONE BROADCAST ZONE – TWO DESTINATIONS

### DESCRIPTION

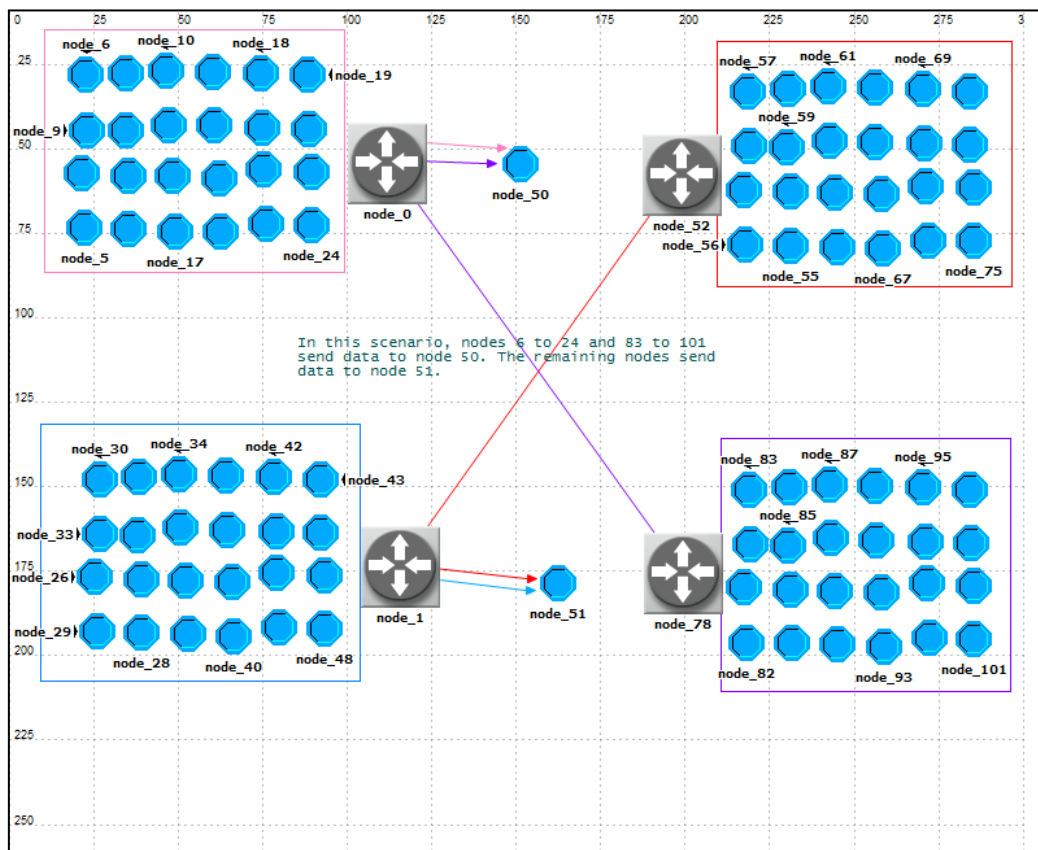


Fig. 24. scenario 5.

This scenario resemble scenario 3 but we added two node groups each one associated to one new router (Fig. 24).

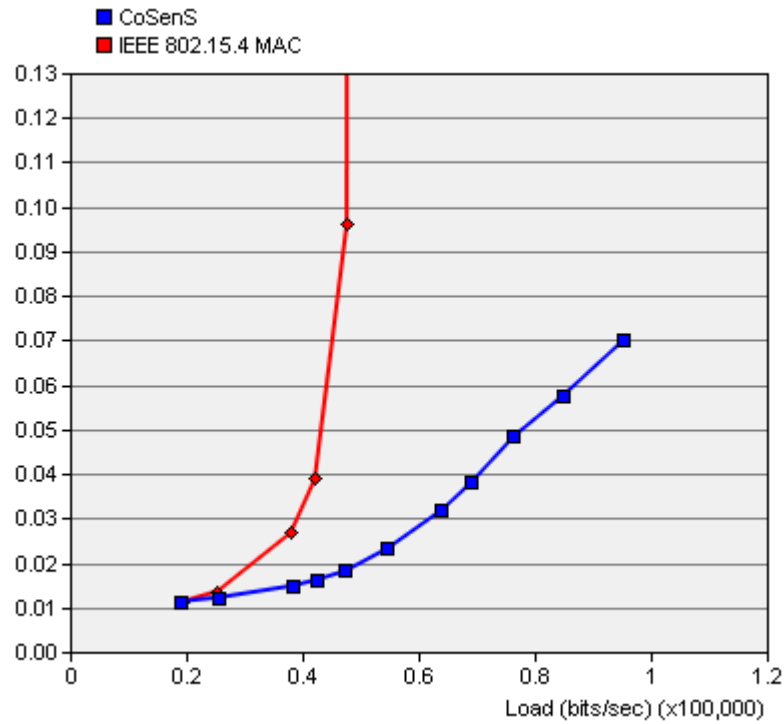


Fig. 25. End-to-end delay for scenario 5.

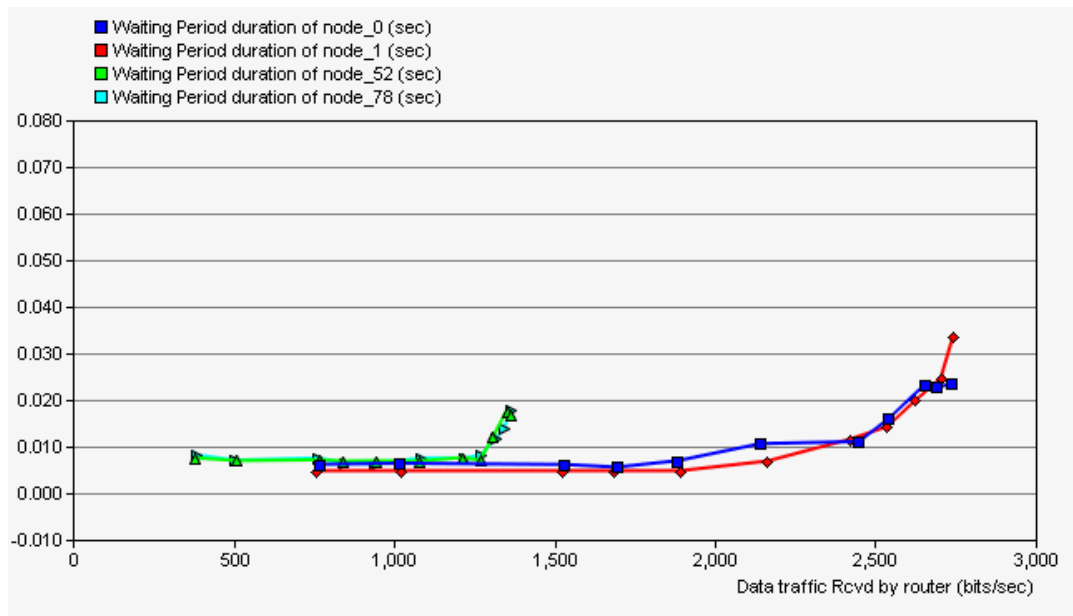


Fig. 26. WP duration for scenario 5.

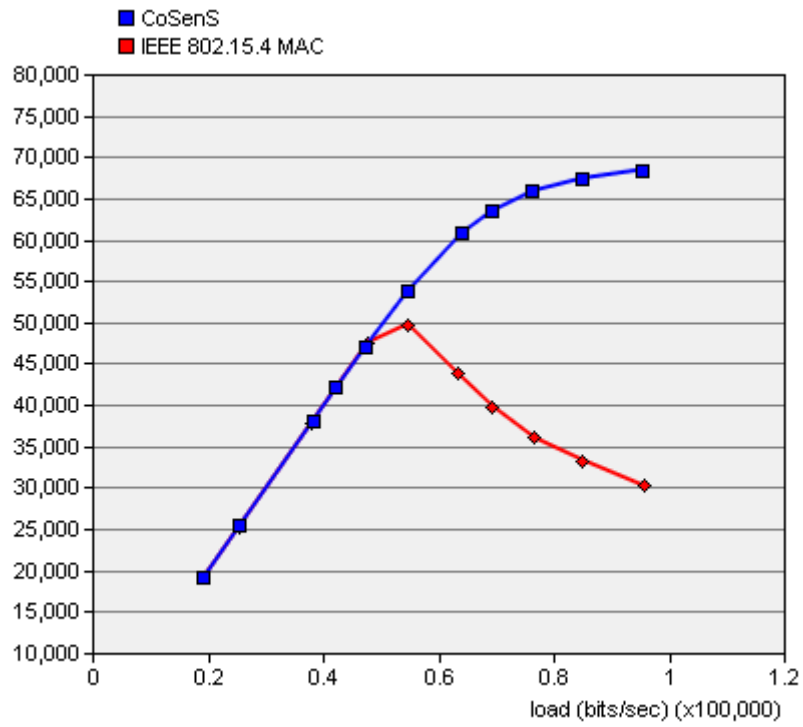


Fig. 27. Throughput for scenario 5.



## SCENARIO 6: THREE ROUTERS – MULTIPLE BROADCAST ZONES – ONE DESTINATION

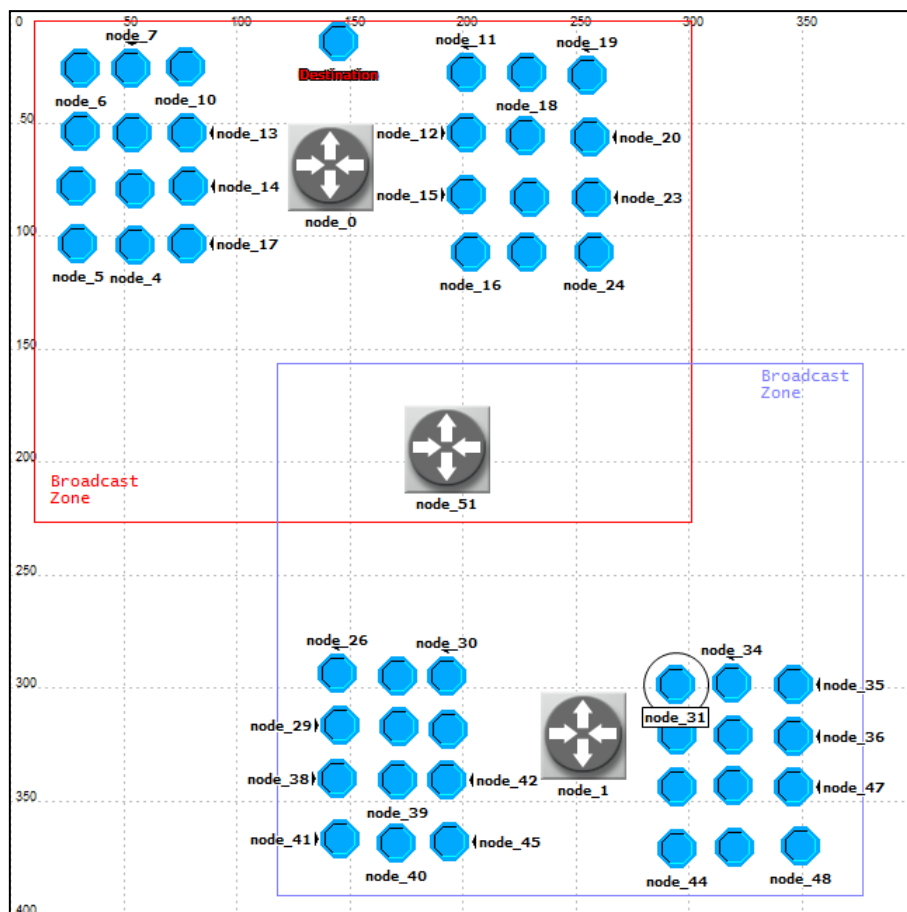


Fig. 28. Scenario 6.

### DESCRIPTION

This scenario is composed of three routers and four groups of children. Each two groups are associated to a router. The router in the middle does not have children and is used as gateway between the other ones. All nodes send data to a single destination (Fig. 28).

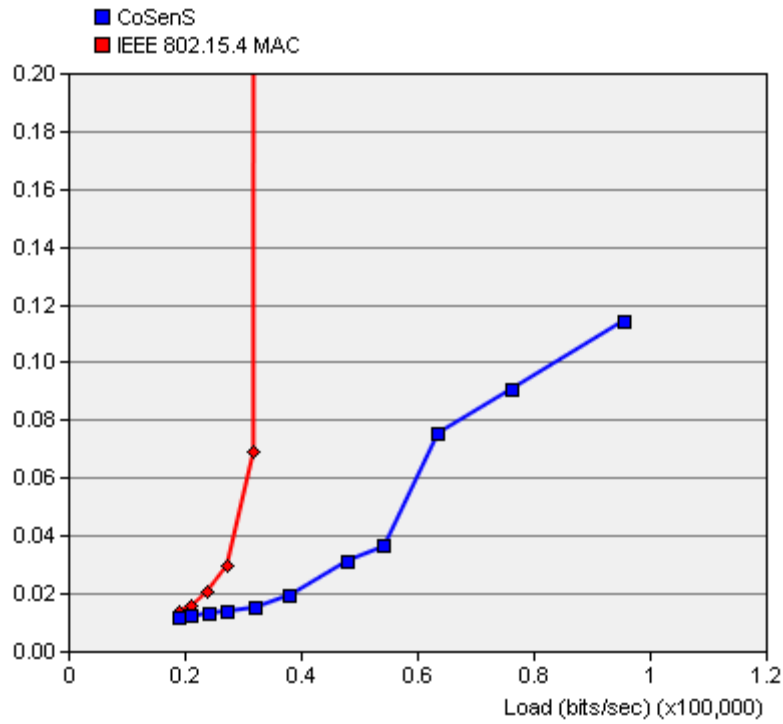


Fig. 29. End-to-end delay for scenario 6.

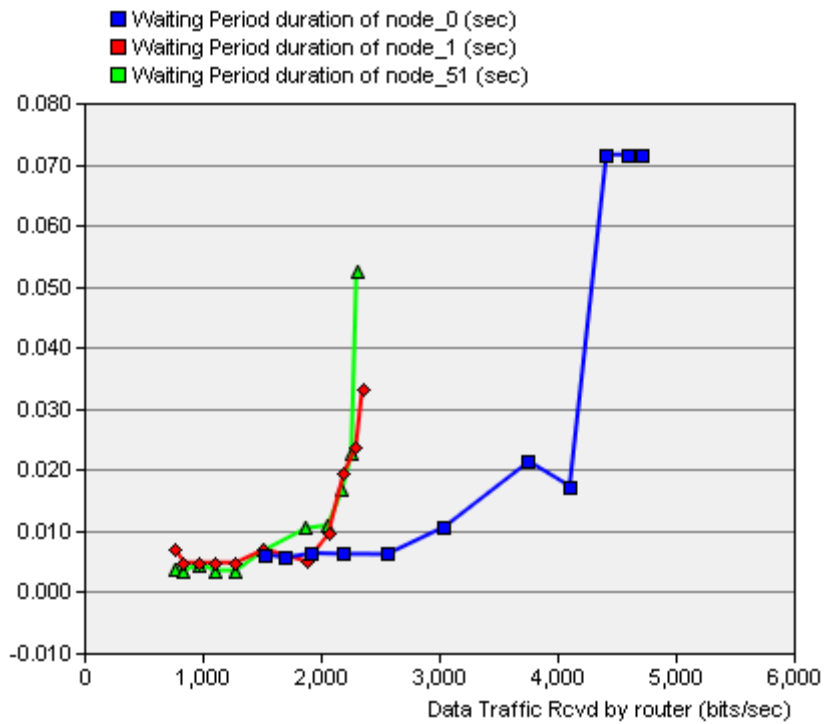


Fig. 30. WP duration for scenario 6.

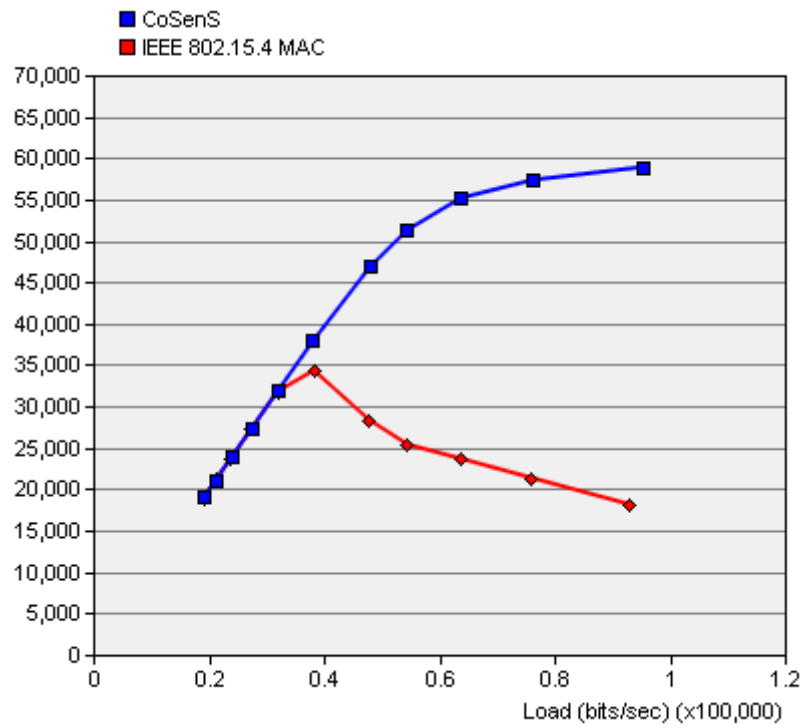


Fig. 31. Throughput (bits/sec) for scenario 6.

## SCENARIO 7: MULTIPLE ROUTERS – MULTIPLE BROADCAST ZONES – MULTIPLE DESTINATIONS

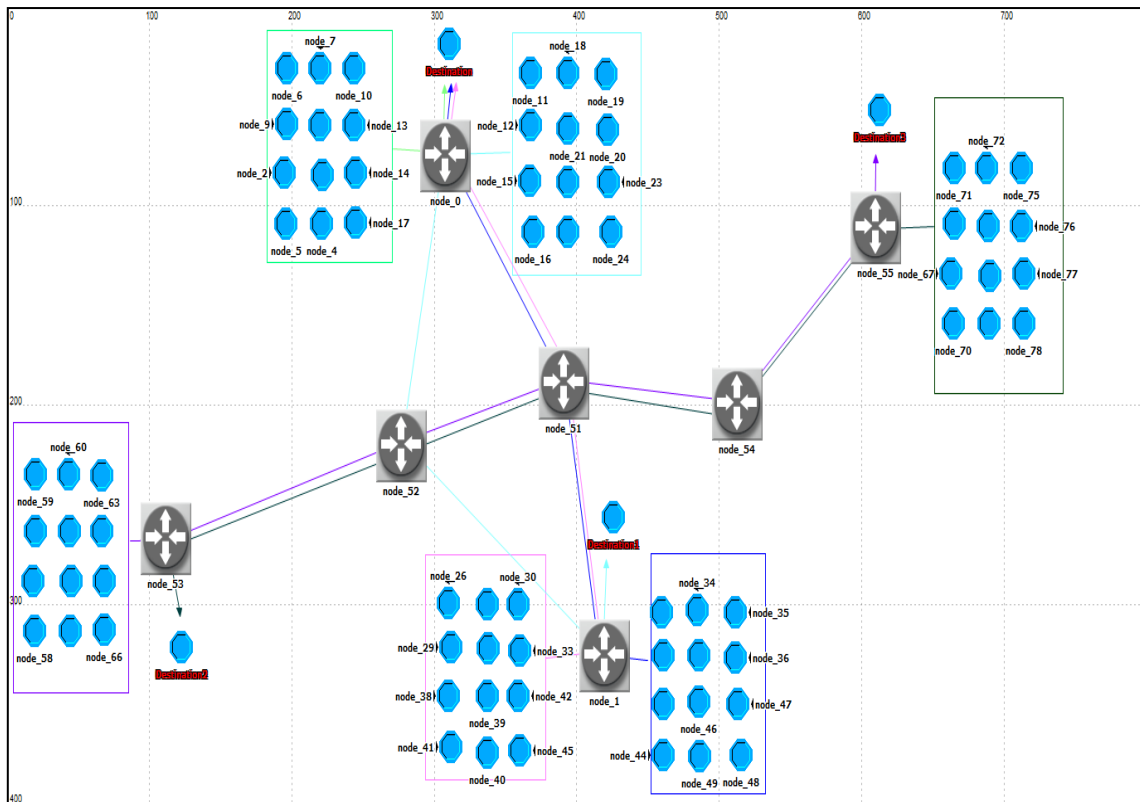


Fig. 32. Scenario 7.

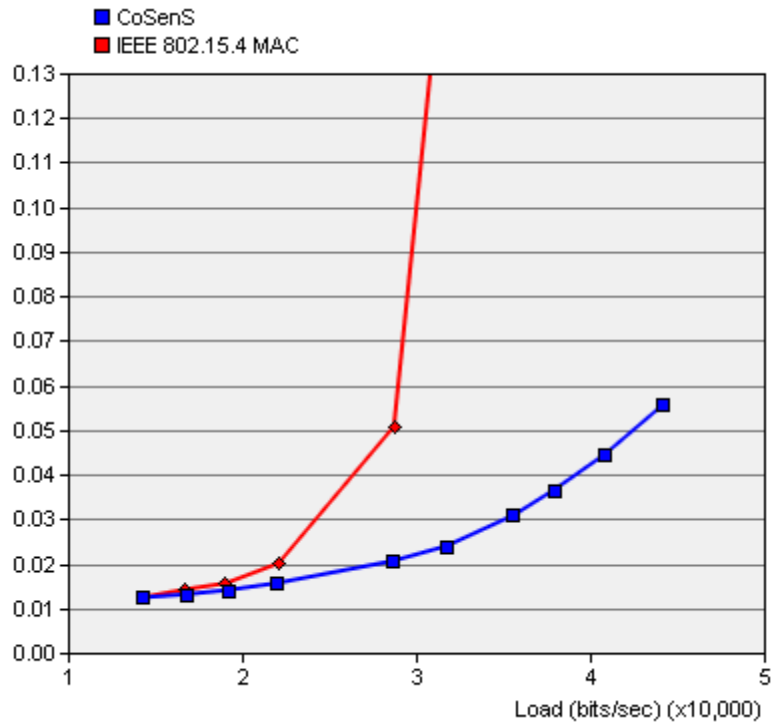


Fig. 33. End-to-end delay of scenario 7.

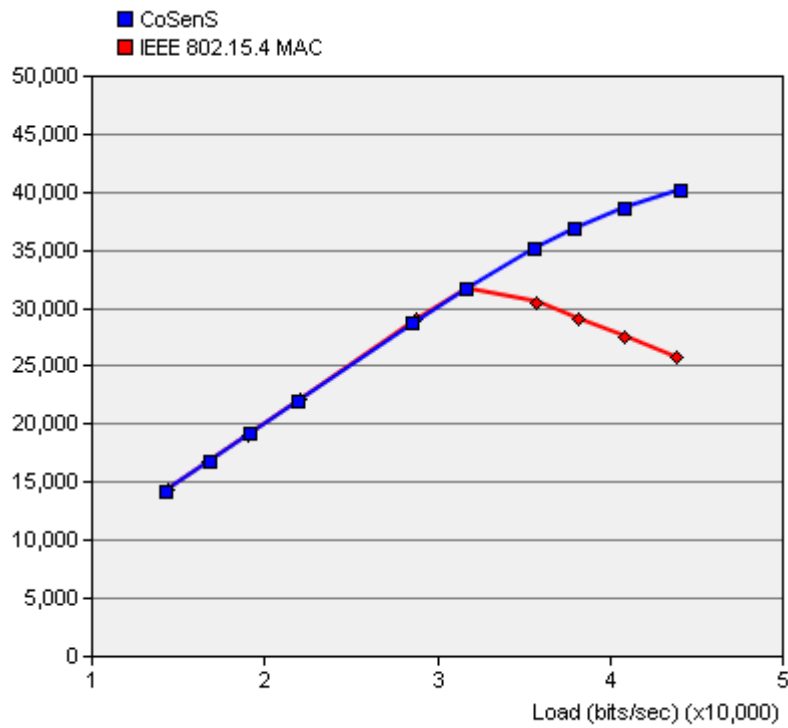


Fig. 34. Throughput of scenario 7.

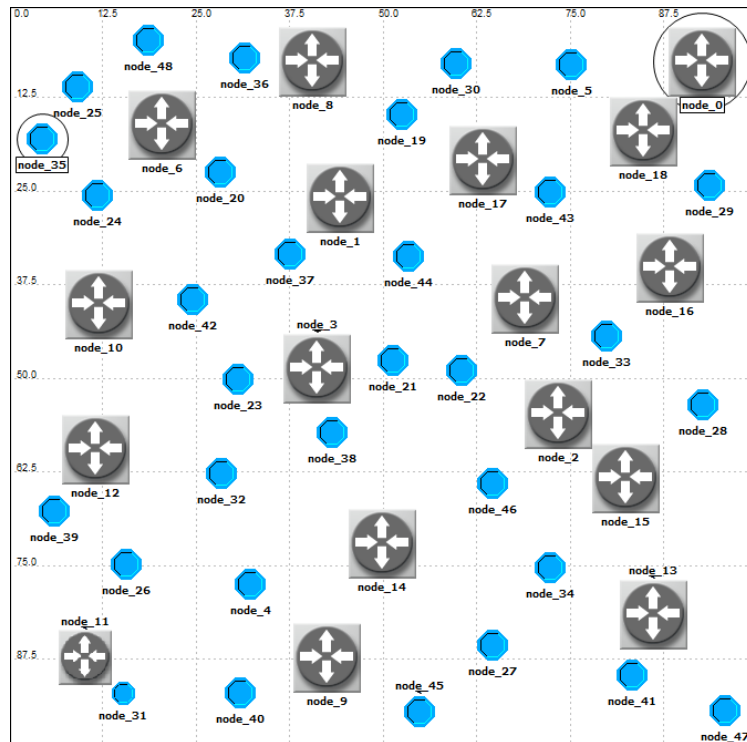


Fig. 35. Scenario 8.

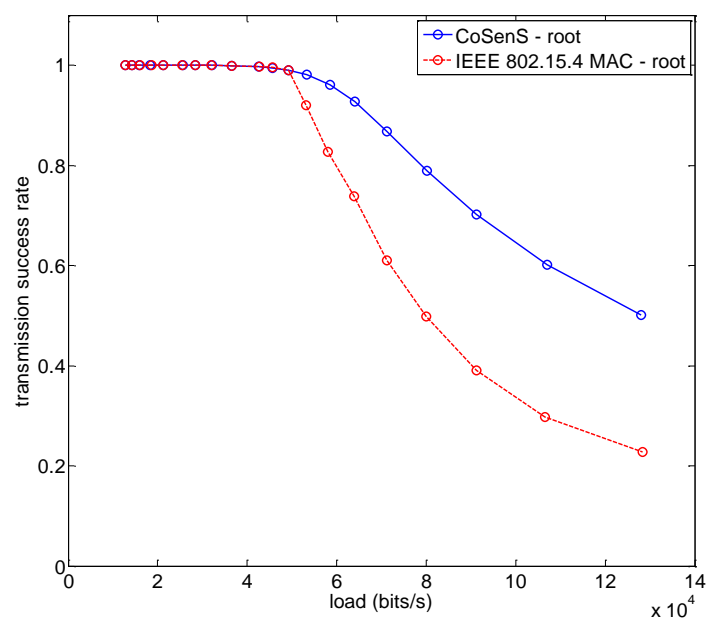


Fig. 36. Transmission success probability of scenario 8.

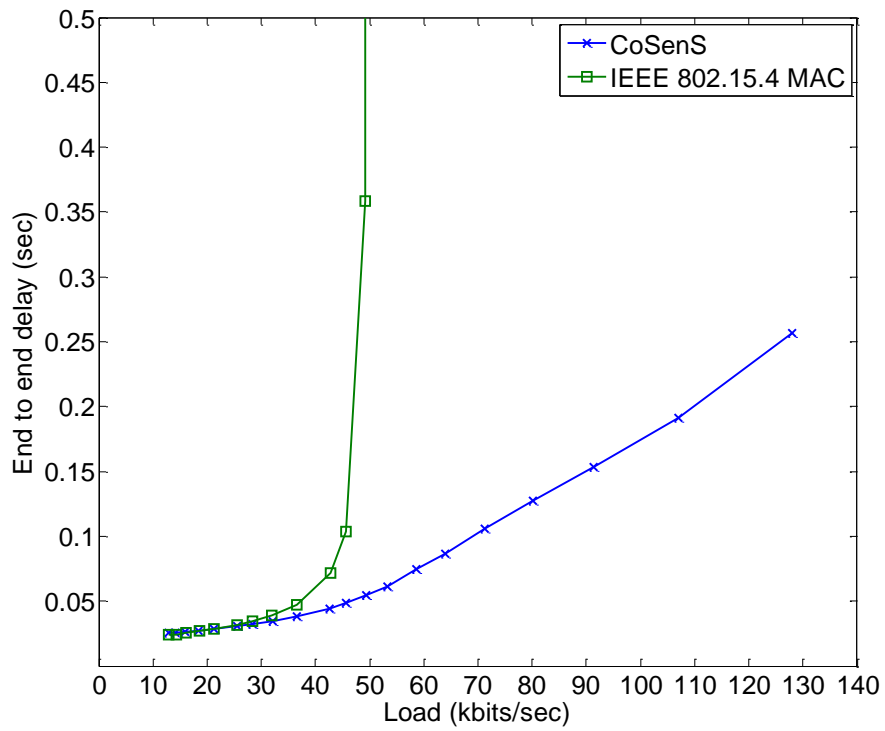


Fig. 37. End-to-end delay of scenario 8.

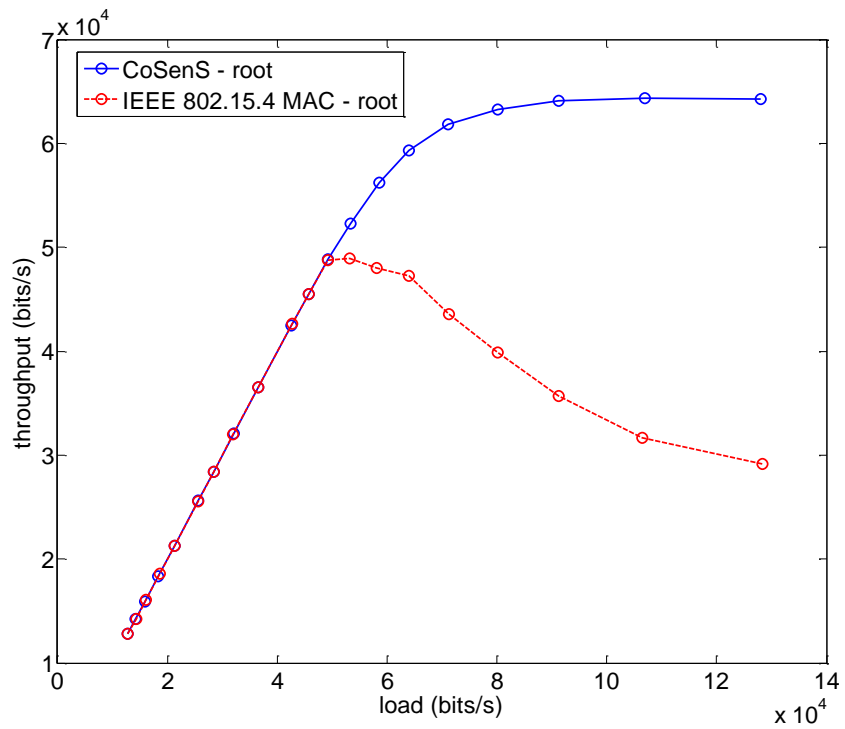


Fig. 38. Throughput of scenario 8.





All simulations scenarios show that the CoSenS provides better throughput, end to end delay and reliability than IEEE 802.15.4 MAC for medium and high traffic load. The results are similar for light traffic load. CoSenS ameliorates the weakness of CSMA/CA protocol namely the throughput, end to end delay and transmission success probability while preserving its simplicity and good scaling property. CoSenS is a collecting and sending burst scheme, the fact to queue the packets at routers allows us to design efficient scheduling algorithms, a key feature for providing differentiated QoS.

## CONCLUSION

This report describes CoSenS in details and gives the results of some simulation scenarios which have been carried out to analyze its performance in comparison to IEEE 802.15.4 MAC using the unslotted CSMA/CA protocol. The results show that CoSenS greatly enhance throughput, end-to-end delay and reliability.
