A robust sensorless output feedback controller of the induction motor drives: New design and experimental validation

In this paper, a sensorless output feedback controller is designed in order to drive the Induction Motor (*IM*) without the use of flux and speed sensors. Firstly, an observer that uses only the measured stator currents is synthesized to estimate the mechanical variables (speed and load torque) and the magnetic variables (fluxes) by structurally taking into account the unobservability phenomena of the Sensorless *IM* (*SIM*) and the parametric uncertainties. Secondly, a current-based field oriented sliding mode control, that uses the flux and the speed estimates given by the former observer is developed so as to steer the estimated speed and flux magnitude to the desired references. Since the observer error dynamic is independent from the known input control and depends on the *IM* parametric uncertainties, a kind of separation principle is introduced to guarantee the practical stability of the whole closed-loop system "observer -controller" ("O-C") according to observability and unobservability time variation. A significant benchmark taking into account the unobservability phenomena of the *SIM* is presented to show the performances of the whole control scheme against experimental set-up.

1 Introduction

High performance electrical drives based on the use of the *IM* can be implemented by means of speed/flux controllers which rely on field orientation concepts 'Blaschke *et al.* (1972)'. Generally speaking, a field orientation algorithm is an output feedback controller based on currents and rotor speed/position measurements. In such controllers, a shaft encoder or a resolver is usually used to measure the motor speed. Meanwhile, the presence of this sensor increases the cost and the complexity of the drive system and reduces the reliability of the overall system. Recently, considerable research efforts are focused on the *SIM* control problem, see 'Holtz *et al.* (2006)' for an exhaustive overview of *IM* sensorless control methods. The aim of sensorless techniques is to provide methods of estimating the mechanical speed by using only electrical applied voltages and line currents, as close as possible to the sensor case. Because the load torque is in general unknown, the resistances are temperature varying, the rotor flux and speed are not measurable, several theoretical and practical solutions have been proposed in the open literature. For instance, a speed estimation method is proposed in 'Tajima *et al.* (1993)' and incorporated in a field-orientation control scheme. In 'Kubota *et al.* (1994)' an algorithm for simultaneous estimation of motor speed and rotor resistance is proposed. In 'Peresada *et al.* (1999)', a backstepping output feedback controller based on an indirect field-oriented control is presented. Moreover, estimations of load torque and angle of rotor flux are obtained. By using the estimations of load torque and angle of rotor flux, the controller provides a global asymptotic tracking of smooth speed and flux reference trajectories. In addition, a rotor speed and rotor flux observer which is adaptive with respect to rotor resistance is presented in 'Lin *et al.* (2000)'. This observer is combined with a state feedback controller which is adaptive with respect to the load torque. In 'Feemster *et al.* (2001)' a semi-global exponential rotor velocity and flux tracking algorithm is proved assuming the machine parameters are well known and the rotor flux is measured. In 'Marino *et al.* (2005)' a sensorless controller based on a speed/flux observer is

designed under the assumptions of unknown rotor/stator fluxes but with known and smooth load torque. This controller guarantees the local exponential rotor flux tracking with explicit computable attraction domain. Other results dealing with the *SIM* control problem without load torque knowledge can be found in ‘Marino *et al.* (2007)’.

On the other hand, removing the speed sensors affects the *IM* observability properties. Important contributions in this direction have been reported in ‘Canudas de Wit *et al.* (2000)’, ‘Ibarra-Rojas *et al.* (2004)’ and ‘Ghanes *et al.* (2006)’, where under some operating conditions (low speed) the *IM* is not observable. Furthermore, strategies based on *IM* spatial saliency methods with fundamental excitation and high frequency signal injection ‘Holtz *et al.* (2006)’, extended Kalman filter techniques ‘Zein *et al.* (2000)’ and adaptive system approaches ‘Montanari *et al.* (2006)’ have been studied.

The first main contribution of this paper is to design an interconnected observer for the *SIM* by a structural consideration of the unobservability phenomena¹. It is also shown that this observer enables to estimate the speed, the load torque and the magnetic variables by using only stator current measurements according to the observability and unobservability time variation.

Secondly, by using the estimated *IM* flux and speed given by the observer, a sensorless control scheme is designed. This later is based on a combination of field oriented control (FOC) methodology and robust sliding mode technique. Due to parametric uncertainties of the *IM* and following partially a "separation principle" introduced in ‘Atassi *et al.* (1999)’ and ‘Jankovic *et al.* (1997)’, a practical stability of the closed loop system "O-C" is achieved according to the ratio between the unobservable and observable time intervals.

Furthermore, a Sensorless Control Benchmark is designed in order to test and to evaluate the performance of sensorless controllers, particularly when the *IM* remains in the unobservable conditions (very low speed: zero frequency).

This paper is organized as follows. In section 2, the *IM* model is reminded. In section 3, sufficient conditions to ensure the observer convergence by taking into account the *SIM* unobservability phenomena are given. To achieve the tracking control objective, a sensorless feedback controller combining the FOC and Sliding Mode techniques is designed in Section 4. In Section 5, the closed loop stability analysis using the proposed "O-C" scheme is presented. In Section 6, the benchmark and experimental results showing the efficiency of the proposed control methodology are given². Finally, some conclusions are drawn.

2 Observer design under unobservability phenomena of *IM*

2.1 *IM* Model

In the (α, β) fixed reference frame, the dynamics of the *IM* reads

where $i_{s\alpha}, i_{s\beta}, \phi_{r\alpha}, \phi_{r\beta}, u_{s\alpha}, u_{s\beta}, \Omega_r, T_l$ respectively denote the stator currents, the rotor fluxes, the stator input voltages, the angular rotor speed and the load torque. While, the subscripts *s* and *r* refer to the stator and rotor. The parameters $a, b, c, \gamma, \Upsilon, m$ and m_1 are defined by $a = (R_r/L_r)$, $b = (M_{sr}/\Upsilon L_s L_r)$,

$c = (f_v/J)$, $\gamma = \left(\frac{L_r^2 R_s + M_{sr}^2 R_r}{\Upsilon L_s L_r^2}\right)$, $\Upsilon = (1 - (M_{sr}^2/L_s L_r))$, $m = (pM_{sr}/JL_r)$, $m_1 = (1/\Upsilon L_s)$. In which R_s and R_r are the resistances, L_s and L_r are the self-inductances, M_{sr} is the mutual inductance between the stator and rotor windings, p is the number of pole-pairs, J is the inertia of the system (motor and load) and f_v is the viscous damping coefficient. The control inputs are the stator voltages. Only stator currents and stator voltages are measured. Furthermore, an operating domain \mathcal{D} is defined by:

Definition 2.1 : Operation Domain \mathcal{D}

$\Phi_{r\alpha}^{max}, \Phi_{r\beta}^{max}, I_{s\beta}^{max}, I_{s\alpha}^{max}, \Omega_r^{max}$ and T_l^{max} are respectively the actual maximum values for the fluxes, currents, speed and load torque such that $|\phi_{r\alpha}| \leq \Phi_{r\alpha}^{max}, |\phi_{r\beta}| \leq \Phi_{r\beta}^{max}, |i_{s\alpha}| \leq I_{s\alpha}^{max}, |i_{s\beta}| \leq I_{s\beta}^{max}, |\Omega_r| \leq \Omega_r^{max}, |T_l| \leq T_l^{max}$. In the following, the maximum values of parameter variations will be also included for the stability analysis.

2.2 Quick Recall on the Observability Phenomena of SIM

The observability phenomena of induction motor has been studied by several authors (see for instance Canudas de Wit *et al.* (2000), Ibarra-Rojas *et al.* (2004)). Following the ideas of these works, we have presented in Ghanes *et al.* (2006) some cases under which the induction motor is observable and unobservable. The problem was to characterize the condition under which the state x of the sensorless induction motor can be observed from measures (currents). The result is that the induction motor observability cannot be established in the particular case when the fluxes $\phi_{r\alpha}$, $\phi_{r\beta}$ and the speed Ω_r are constant even if we use the higher derivatives of currents. This is a sufficient condition for lost of observability. This operating case match to the following physically interpretation :

- 1) when the fluxes are constant ($\dot{\phi}_{r\beta} = \dot{\phi}_{r\alpha} = 0$), or equivalently, the excitation voltage is zero ($\Omega_s = 0$), it implies that: $p\Omega_r + \frac{R_r T_e}{p\phi_d^2} = \Omega_s = 0$ or: $T_{em} = -K\Omega_r$ where T_{em} is the electromagnetic torque and $K = \frac{p^2 \phi_d^2}{R_r}$.

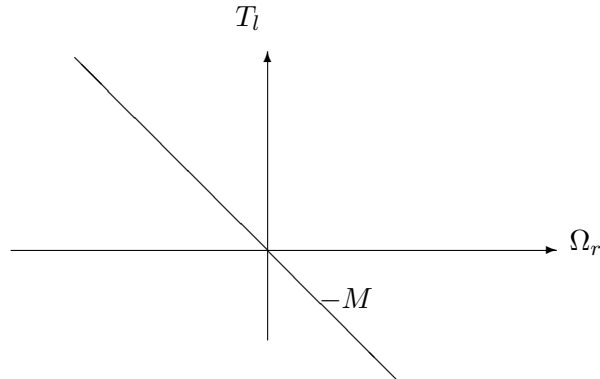


Figure 1. Unobservability curve in the map (T_l, Ω_r) .

- 2) if the speed motor is constant; thus: $T_{em} = (f_v \Omega_r + T_l) = -K\Omega_r$. This last equation defines the **unobservability curve** in the map (T_l, Ω_r) with $M = \frac{p^2 \phi_d^2}{R_r} + f_v$ (Figure 1).

Obviously, the observability is lost gradually when we approach this unobservability curve.

2.3 Observer design

This section is devoted to the *SIM* observer design. As it is already mentioned, this later takes into account the unobservability phenomena described in section 2.2. The observer design is based on the interconnection of several observers ('Besançon *et al.* (1998) and 'Besançon *et al.* (1999)') satisfying suitable properties, in particular the inputs persistency property ('Besançon *et al.* (1999)', 'Jankovic *et al.* (1997)'). The main

idea is to design a set of observers for the whole system from the individual synthesis of an observer for each subsystem. The key issue is that, for each of this observer, the state of the other subsystems is available. In this context, the *IM* model (1) can be rewritten in the following interconnected extended compact form with parametric uncertainties

where $X_1 = (i_{s\alpha}, \Omega_r, T_l)^T$ and $X_2 = (i_{s\beta}, \phi_{r\alpha}, \phi_{r\beta})^T$ are the state of the first and the second subsystem respectively. $u = [u_{s\alpha}, u_{s\beta}]^T$ and $y = [i_{s\alpha}, i_{s\beta}]^T$ are the input and the output vectors of the whole system, and

$$C_1 = C_2 = (1 \ 0 \ 0).$$

$u \in U$ is the set of admissible inputs and n_i is the dimension of each subsystem ($n_1 = n_2 = 3$). T_l is an unknown load torque which is assumed constant. The terms $\Delta A_1(X_2)$, $\Delta A_2(X_1)$, $\Delta g_1(u, y, X_2)$ and $\Delta \varphi(u, y)$ represent the uncertain terms of $A_1(X_2)$, $A_2(X_1)$, $g_1(u, y, X_2)$, $\varphi(u, y)$ respectively.

Let us now introduce the following property and definition:

- Property 2.2** a- Since $A_1(X_2)$ and $A_2(X_1)$ are linear, they are respectively globally Lipschitz with respect to X_2, X_1 .
b- $g_1(u, y, X_2)$ is Lipschitz with respect to the flux and uniformly with respect to (u, y) as long as the *IM* (1) state remains in \mathcal{D} .
c- Due to the fact that the matrix A_1 is Lyapunov stable ($\gamma > 0$ and $c > 0$), there exists a positive matrix $S_1 > 0$ such that $A_1^T S_1 + S_1 A_1 = -Q$ where $Q \geq 0$.
d- Due to the fact that the matrix A_2 is exponentially stable ($\gamma > 0$, $a > 0$), there exists a positive matrix $S_2 > 0$ such that $A_2^T S_2 + S_2 A_2 = -I$.

Definition 2.3 Let $\mathbf{D} = \det \mathcal{O}_J$, where $\mathcal{O}_J = \frac{\partial}{\partial \tilde{X}}(\mathcal{O})$ is the jacobian observability matrix and $\tilde{X} = (i_{s\alpha} \ i_{s\beta} \ \hat{\phi}_{r\alpha} \ \hat{\phi}_{r\beta} \ \hat{\Omega}_r \ \hat{T}_l)^T$. The *IM* associated observability subspace \mathcal{O} is generated by $\mathcal{O} = \begin{pmatrix} i_{s\alpha} & i_{s\beta} & i_{s\alpha}^{(1)} & i_{s\alpha}^{(1)} & i_{s\alpha}^{(2)} & i_{s\alpha}^{(2)} \\ i_{s\beta} & i_{s\beta} & i_{s\beta}^{(1)} & i_{s\beta}^{(1)} & i_{s\beta}^{(2)} & i_{s\beta}^{(2)} \end{pmatrix}^T$.

\mathbf{D}_{min} is the smallest value of \mathbf{D} chosen such that the *IM* is in the observable area.

Now, from property 2.2, definition 2.3 and taking into account the unobservability phenomena of the *SIM* described in section 2.2, sufficient conditions are given in the sequel such that system (3) is a practical exponential observer for the whole system (2).

where $Z_1 = (\hat{i}_{s\alpha}, \hat{\Omega}_r, \hat{T}_l)^T$, $Z_2 = (\hat{i}_{s\beta}, \hat{\phi}_{r\alpha}, \hat{\phi}_{r\beta})^T$, $S_i = S_i^T > 0$, $i=1,2$. θ_1 and θ_2 are positive constants. Note that $S_1^{-1}C_1^T$ and $S_2^{-1}C_2^T$ are the respective gains of observers (O_1) and (O_2) . Furthermore, when the *IM* is no longer in the observable area, observer (3) can not work any more. Then, a solution based on the *IM* observability property is introduced by using a soft switch function \mathbf{M} such that observer (3) operates as an estimator.

Remark 1 1. Z_2 and Z_1 are considered as inputs for subsystems (O_1) and (O_2) , the solutions of \dot{S}_1 and \dot{S}_2 are symmetric positive definite matrices (see annexe for the positiveness proof of $S_i(t)$, $i = 1, 2$).
 2. When the *IM* is in the observable area, Z_2 and Z_1 satisfy the regularly persistence condition.
 3. When the *IM* is in the unobservable area, Z_2 and Z_1 do not satisfy the regularly persistence condition and the observer operates as an estimator.
 4. It is worth noticing that $\|S_1\|$ and $\|S_2\|$ are bounded when the *IM* is in the observable area.

2.4 Observer convergence

In order to prove the convergence of the proposed observer (3), sufficient conditions are established. Defining the estimation errors

According to system (2) and observer (3), their errors dynamics read

PROPOSITION 2.4 Consider system (2) with property 2.2. Then, system (3) is a practical exponential observer¹ for system (2), for $\theta_1 > 0$ and $\theta_2 > 0$ sufficiently large.

Proof Consider the following Lyapunov function candidate

where $V_1 = \epsilon_1^T S_1 \epsilon_1$ and $V_2 = \epsilon_2^T S_2 \epsilon_2$.

Remark 2 The Lyapunov function candidate (5) is well chosen since $S_i(t)$, $i = 1, 2$ is positive definite (see annexe for more details)

Its time derivative along (4) is

By introducing the norm, it follows

From property 2.2-a-b, the set inequalities hold

Using the above inequalities and because the fact pointed in property 2.2-c and 2.2-d, (6) becomes

$$\begin{aligned} \dot{V}_o \leq & -M\epsilon_1^T C_1^T C_1 \epsilon_1 - M\theta_1 \epsilon_1^T S_1 \epsilon_1 - \epsilon_1^T Q \epsilon_1 (1-M) + 2\mu_1 \|\epsilon_1\| \|\epsilon_2\| + 2\mu_2 \|\epsilon_1\| \|\epsilon_2\| \\ & - \epsilon_2^T \epsilon_2 (1-M) + \mu_4 \|\epsilon_1\| - M\epsilon_2^T C_2^T C_2 \epsilon_2 - M\theta_2 \epsilon_2^T S_2 \epsilon_2 + 2\mu_3 \|\epsilon_2\| \|\epsilon_1\| + \mu_5 \|\epsilon_2\| \end{aligned} \quad (7)$$

where $\mu_1 = k_1 k_2 k_3$, $\mu_2 = k_1 k_4$, $\mu_3 = k_5 k_6 k_7$, $\mu_4 = 2(k_1 k_3 \rho_1 + k_1 \rho_3)$, $\mu_5 = 2(k_5 k_7 \rho_2 + k_5 \rho_4)$.

The parameters k_j , $j = 1, \dots, 8$ and ρ_i , $i = 1, \dots, 4$ are positives constants which are computed by determining the maximal values of A_1 , A_2 , g_1 , S_1 , S_2 , $\Delta A_1(X_2)$, $\Delta A_2(X_1)$, $\Delta g_1(u, y, X_2)$ and $\Delta \varphi(u, y)$ in the physical domain \mathcal{D} of IM (see definition 2.1).

Since $0 \leq M \leq 1$, $Q \geq 0$ and $C_i^T C_i \geq 0$, $i = 1, 2$, (7) follows

$$\begin{aligned} \dot{V}_o \leq & -M\theta_1 \epsilon_1^T S_1 \epsilon_1 + 2\mu_1 \|\epsilon_1\| \|\epsilon_2\| + 2\mu_2 \|\epsilon_1\| \|\epsilon_2\| \\ & + \mu_4 \|\epsilon_1\| - M\theta_2 \epsilon_2^T S_2 \epsilon_2 + 2\mu_3 \|\epsilon_2\| \|\epsilon_1\| + \mu_5 \|\epsilon_2\| \end{aligned} \quad (8)$$

Using the following inequalities

$$\begin{cases} \lambda \min(S_i) \|\epsilon_i\|^2 \leq \|\epsilon_i\|_{S_i}^2 \leq \lambda \max(S_i) \|\epsilon_i\|^2 \\ \|\epsilon_i\|_{S_i}^2 = \epsilon_i^T S_i \epsilon_i, i = 1, 2 \end{cases}$$

where $\lambda \min(S_i)$ and $\lambda \max(S_i)$ are respectively the minimal and maximal eigenvalues of S_i .

By writing (8) in terms of functions V_1 and V_2 , it follows that

$$\dot{V}_o \leq -M(\theta_1 V_1 - \theta_2 V_2) + 2(\tilde{\mu}_1 + \tilde{\mu}_2 + \tilde{\mu}_3) \sqrt{V_1} \sqrt{V_2} + \mu_4 \|\epsilon_1\| + \mu_5 \|\epsilon_2\| \quad (9)$$

where $\tilde{\mu}_i = \frac{\mu_i}{\sqrt{\lambda_{\min}(S_1)} \sqrt{\lambda_{\min}(S_2)}}$, $i = 1, 2, 3$.

Next, by using the following inequality $\sqrt{V_1} \sqrt{V_2} \leq \frac{v}{2} V_1 + \frac{1}{2v} V_2$, $\forall v \in]0, 1[$, one get

$$\dot{V}_o \leq -(\mathbf{M}\theta_1 - Nv)V_1 - (\mathbf{M}\theta_2 - \frac{N}{v})V_2 + \mu_4 \|\epsilon_1\| + \mu_5 \|\epsilon_2\|. \quad (10)$$

where $N = \tilde{\mu}_1 + \tilde{\mu}_2 + \tilde{\mu}_3$, $\tilde{\mu}_i = \frac{\mu_i}{\sqrt{\lambda_{min}(S_1)}\sqrt{\lambda_{min}(S_2)}}$, $i = 1, 2, 3$, $\mu_1 = k_1 k_2 k_3$, $\mu_2 = k_1 k_4$, $\mu_3 = k_5 k_6 k_7$, $\mu_4 = 2(k_1 k_3 \rho_1 + k_1 \rho_3)$, $\mu_5 = 2(k_5 k_7 \rho_2 + k_5 \rho_4)$.

Tacking account $\mu = \max(\mu_4, \mu_5)$, it follows that:

1) when $\mathbf{M} = 1$ (observable conditions), (10) becomes:

$$\dot{V}_o(\mathbf{M} = 1) \leq -\delta' V_o + r,$$

where

$$\begin{cases} \delta' = (\delta - \frac{1}{2v}) \\ r = \mu^2 \frac{v}{2} \\ \delta = \min(\delta_1, \delta_2) \\ \delta_1 = (\theta_1 - Nv) > 0 \\ \delta_2 = (\theta_2 - \frac{N}{v}) > 0 \end{cases} \quad (11)$$

By choosing $\delta > \frac{1}{2v}$, it implies that the origin of system (4) is practically exponentially stable (more details about practical stability can be found in ‘Laskhmikanthan *et al.* (1990)’ and ‘Panteley *et al.* (1998)’).

2) when $\mathbf{M} = 0$ (unobservable conditions), (10) becomes:

$$\dot{V}_o(\mathbf{M} = 0) \leq \tilde{K}' V_o + r,$$

where $\tilde{K}' = (\tilde{K} + \frac{1}{2v})$ and $\tilde{K} = \max(Nv, \frac{N}{v})$.

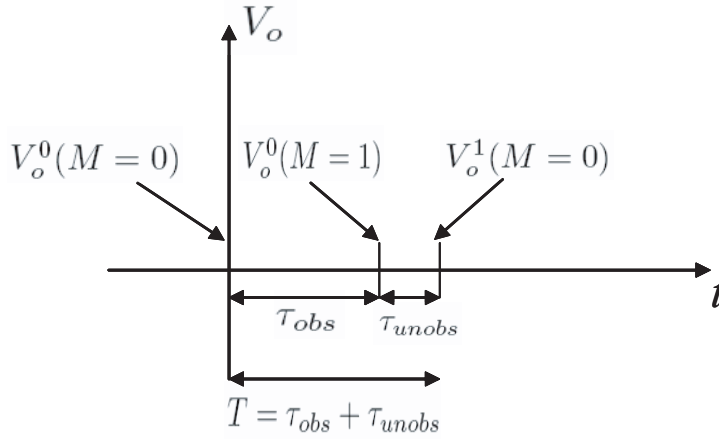


Figure 2. Lyapunov function V_o for $T = \tau_{obs} + \tau_{unobs}$.

By defining the time trajectory as $T = \tau_{obs} + \tau_{unobs}$ (see figure 2), then

For $\mathbf{M} = 1$:

$$V_o^0(\mathbf{M} = 1) \leq \exp^{-\delta' \tau_{obs}} V_o^0(\mathbf{M} = 0) + \frac{1 - e^{-\delta' \tau_{obs}}}{\delta'} r.$$

For $\mathbf{M} = 0$:

$$V_o^1(\mathbf{M} = 0) \leq e^{\tilde{K}' \tau_{unobs}} V_o^0(\mathbf{M} = 1) + \frac{e^{\tilde{K}' \tau_{unobs}} - 1}{\tilde{K}'} r.$$

Now, define the difference between the Lyapunov functions $V_o^1(\mathbf{M} = 0)$ and $V_o^0(\mathbf{M} = 0)$ (as introduced in Balluchi *et al.* (2003)) in order to study the sign of the variation of the Lyapunov function V_o at all T^1 :

¹cycle of observable and unobservable conditions

$$\begin{aligned} \Delta V_o \leq V_o^1(\mathbf{M} = 0) - V_o^0(\mathbf{M} = 0) &:= (e^{\tilde{K}'\tau_{unobs} - \delta'\tau_{obs}} - 1)V_o^0(\mathbf{M} = 0) \\ &+ [e^{\tilde{K}'\tau_{unobs}}(\frac{1 - e^{-\delta'\tau_{obs}}}{\delta'}) + \frac{e^{\tilde{K}'\tau_{unobs}} - 1}{\tilde{K}'}]r. \end{aligned}$$

It is obvious that only practical stability is obtained for

$$\tilde{K}'\tau_{unobs} - \delta'\tau_{obs} < 0. \quad (12)$$

(12) ensures that the Lyapunov function V_0 converges into the interval $[0, V_0^{max}]$ where

$$V_0^{max} = \frac{[e^{\tilde{K}'\tau_{unobs}}(\frac{1 - e^{-\delta'\tau_{obs}}}{\delta'}) + \frac{e^{\tilde{K}'\tau_{unobs}} - 1}{\tilde{K}'}]r}{1 - \tilde{K}'\tau_{unobs} - \delta'\tau_{obs}}.$$

If $r = 0$, then exponential convergence to zero is obtained. □

3 FOC via Sliding Mode Techniques

In this section, a controller is designed by combining the **FOC** method ('Blaschke *et al.* (1972)') with Sliding Mode Control method (**SMC**, 'Utkin *et al.* (1992)'). The design procedure is based on the assumption of current-fed *IM*.

Field Oriented Control. In the rotating (d-q) reference frame, the *IM* dynamic model (1) reads (Chiasson *et al.* (2005))

$$\begin{cases} \dot{\Omega}_r = m\phi_{rd}i_{sq} - c\Omega_r - \frac{1}{J}T_l \\ \dot{\phi}_{rd} = -a\phi_{rd} + aM_{sr}i_{sd} \\ \dot{\rho} = p\Omega_r + a\frac{M_{sr}}{\phi_{rd}}i_{sq} \\ \dot{i}_{sd} = -\gamma i_{sd} + ab\phi_{rd} + p\Omega_r i_{sq} + a\frac{M_{sr}}{\phi_{rd}}i_{sq}^2 + m_1 u_{sd} \\ \dot{i}_{sq} = -\gamma i_{sq} - bp\Omega_r \phi_{rd} - p\Omega_r i_{sd} - a\frac{M_{sr}}{\phi_{rd}}i_{sd}i_{sq} + m_1 u_{sq} \end{cases} \quad (13)$$

where respectively i_{sd} , i_{sq} and u_{sd} , u_{sq} are the stator currents and stator voltages. The electromagnetic

torque $T_{em} = \frac{pM_{sr}}{L_r}\phi_{rd}i_{sq}$ is proportional to the product of ϕ_{rd} and i_{sq} . Thus, by holding constant the magnitude of the rotor flux, a linear relationship between i_{sq} and T_{em} is obtained. In order to cancel the nonlinear dynamics of i_{sd} and i_{sq} , the system is forced into current-command mode using high gain feedback (see Chiasson *et al.* (2005)). More precisely, the following IP current controllers

$$\begin{cases} V_{sd} = Ki_{vd} \int_0^t (i_{sd}^* - i_{sd}) dt + Kp_{vd}(i_{sd}^* - i_{sd}) \\ V_{sq} = Ki_{vq} \int_0^t (i_{sq}^* - i_{sq}) dt + Kp_{vq}(i_{sq}^* - i_{sq}) \end{cases} \quad (14)$$

are used to force i_{sd} and i_{sq} to track their respective references i_{sd}^* and i_{sq}^* and produce fast responses when large feedback gains are used. Hence, assuming that i_{sd}^* and i_{sq}^* as the *new inputs*, it follows that

$$\begin{cases} \dot{\Omega}_r = m\phi_{rd}i_{sq}^* - c\Omega_r - \frac{T_l}{J} \\ \dot{\phi}_{rd} = -a\phi_{rd} + aM_{sr}i_{sd}^* \end{cases} \quad (15)$$

In order to solve the flux and speed trajectory tracking problem, the following assumption is introduced.

Assumption 3.1 a- The state initial conditions of the *IM* are in the physical domain \mathcal{D} .

b- The desired trajectories (ϕ_{rd}^* and Ω_r^*) are in the physical domain \mathcal{D} .

c- The actual load torque is assumed to be bounded by a maximal fixed value ϱ . This maximal value is chosen in accordance to the realistic torque characteristics of the chosen drive: $|T_l| < \varrho$.

Sliding Mode Control.

Flux controller design. From (15), consider the following *IM* flux dynamic equation with uncertainties

$$\dot{\phi}_{rd} = -a\phi_{rd} + \Delta a\phi_{rd} + \kappa i_{sd}^* \quad (16)$$

where $\kappa = aM_{sr}$ and Δa is the uncertainty term of parameter a . In order to design a flux sliding mode controller, define the flux tracking error $e_{\phi_{rd}} = \phi_{rd} - \phi_{rd}^*$ where ϕ_{rd}^* is the flux reference. The associated error dynamics is

$$\dot{e}_{\phi_{rd}} = -ae_{\phi_{rd}} + \kappa i_{sd}^* - a\phi_{rd}^* - \dot{\phi}_{rd}^* + \Delta a\phi_{rd} \quad (17)$$

From *SMC* theory, define the ϕ_{rd} flux sliding manifold as

$$\sigma_{\phi_{rd}} = e_{\phi_{rd}} - (k_{\phi_{rd}} - a) \int_0^t e_{\phi_{rd}}(\tau) d\tau.$$

The associated Lyapunov function is selected as

$$V_{\sigma_{\phi_{rd}}} = \frac{1}{2}\sigma_{\phi_{rd}}^2. \quad (18)$$

Its time derivative is given by

$$\dot{V}_{\sigma_{\phi_{rd}}} = \sigma_{\phi_{rd}}[\sigma_{\phi_{rd}1} + \sigma_{\phi_{rd}2}i_{sd}^* + \Delta a\phi_{rd}]$$

where $\sigma_{\phi_{rd}1} = k_{\phi_{rd}}e_{\phi_{rd}} + a\phi_{rd}^* + \dot{\phi}_{rd}^*$ and $\sigma_{\phi_{rd}2} = \kappa$.

Therefore, the sliding mode controller follows

$$i_{sd}^* = i_{sd, equ}^* + i_{sd, n}^* \quad (19)$$

In this equation $i_{sd, equ}^* = -\frac{\sigma_{\phi_{rd}}}{\sigma_{\phi_{rd}}^2} - l_{\phi_{rd}} \sigma_{\phi_{rd}}$ is the equivalent control and $i_{sd, n}^* = -\frac{u_{dn}}{\sigma_{\phi_{rd}}^2}$ is the discontinuous control where $u_{dn} = \eta_{\phi_{rd}} \text{sgn}(\sigma_{\phi_{rd}})$ with

$$\text{sgn}(\sigma_{\phi_{rd}}) : \begin{cases} 1 & \text{if } \sigma_{\phi_{rd}} > 0 \\ -1 & \text{if } \sigma_{\phi_{rd}} < 0 \\ \in [-1, 1] & \text{if } \sigma_{\phi_{rd}} = 0. \end{cases}$$

Then (18) becomes

$$\dot{V}_{\sigma_{\phi_{rd}}} = -l_{\phi_{rd}} V_{\sigma_{\phi_{rd}}} + \sigma_{\phi_{rd}} [-\eta_{\phi_{rd}} \text{sgn}(\sigma_{\phi_{rd}}) + \Delta a \phi_{rd}].$$

Choosing $l_{\phi_{rd}} > 0$ and $\eta_{\phi_{rd}} > \max\{\|\Delta a \phi_{rd}\|\}$ (defined hereafter) it follows that $\dot{V}_{\sigma_{\phi_{rd}}} \leq 0$. As $V_{\sigma_{\phi_{rd}}}$ is contracting and from assumption (3.1-a-b) then $\max\{\phi_{rd}\} := K_{\phi_{rd}}^{max}$ can not be greater than $\max\{\phi_{rd}(0), \phi_{rd}^*\} + |\Delta e_{\phi_{rd}}(0)|$. Consequently, $\Delta a \phi_{rd}$ is bounded and can be set as $\eta_{\phi_{rd}} = \Delta a^{max} K_{\phi_{rd}}^{max} + b_{\phi}$, with b_{ϕ} a small positive constant. Furthermore, all the trajectories reach the sliding manifold $\sigma_{\phi_{rd}} = 0$ in a finite time and remain there. Therefore $\sigma_{\phi_{rd}} = 0$ and equation (17) becomes

$$\dot{e}_{\phi_{rd}} = (k_{\phi_{rd}} - a)e_{\phi_{rd}}. \quad (20)$$

Hence, the flux tracking error e_{Ω_r} exponentially converges to 0 for $(k_{\phi_{rd}} - a) < 0$.

Now, choosing (19) to force ϕ_{rd} to track its reference ϕ_{rd}^* ensures that the flux is properly established in the motor. Hence, after the *IM* is fluxed ($\phi_{rd} = \phi_{rd}^* = \text{constant}$), the electromagnetic torque (T_{em}) can be rewritten as $T_{em} = K_T i_{sq}^*$, where K_T is the motor torque constant defined by $K_T = \frac{pM_{sr}}{L_r} \phi_{rd}$. As a consequence, the linear relationship between the input i_{sq}^* and the speed dynamics $\dot{\Omega}_r$ is obtained. Then, the speed control is obtained through the input i_{sq}^* via a speed controller described below.

Speed controller design. Consider the mechanical equation of (15) including uncertainties

$$\dot{\Omega}_r = -c\Omega_r - \frac{T_l}{J} + h i_{sq}^* + d_{\Omega_r} \quad (21)$$

where $h = m\phi_{rd}$ and $d_{\Omega_r} = -\Delta c\Omega_r - \frac{T_l}{J}$ is the term uncertainty. Defining the speed tracking error $e_{\Omega_r} = \Omega_r - \Omega_r^*$, it follows

$$\dot{e}_{\Omega_r} = -ce_{\Omega_r} + h i_{sq}^* - c\Omega_r^* - \dot{\Omega}_r^* + d_{\Omega_r} \quad (22)$$

Define now the sliding manifold as

$$\sigma_{\Omega_r} = e_{\Omega_r} - (k - c) \int_0^t e_{\Omega_r}(\tau) d\tau \quad (23)$$

The Lyapunov candidate function associated to the sliding manifold (23) is defined as

$$V_{\sigma_{\Omega_r}} = \frac{1}{2} \sigma_{\Omega_r}^2.$$

By computing its time derivative, one obtain

$$\begin{aligned}\dot{V}_{\sigma_{\Omega_r}} &= \sigma_{\Omega_r} \dot{\sigma}_{\Omega_r} \\ &= \sigma_{\Omega_r} [\sigma_{\Omega_r,1} + \sigma_{\Omega_r,2} i_{sq}^* + d_{\Omega_r}]\end{aligned}\quad (24)$$

where $\sigma_{\Omega_r,1} = ke_{\Omega_r} + c\Omega_r^* + \dot{\Omega}_r^*$ and $\sigma_{\Omega_r,2} = h$.

Then, the speed controller reads

$$i_{sq}^* = i_{sq,equ}^* + i_{sq,n}^* \quad (25)$$

where $i_{sq,equ}^* = -\frac{\sigma_{\Omega_r,1}}{\sigma_{\Omega_r,2}} - l_{\Omega_r} \sigma_{\Omega_r}$ is the equivalent control and $i_{sq,n}^* = -\frac{u_{qn}}{\sigma_{\Omega_r,2}}$, with $u_{qn} = \eta_{\Omega_r} \text{sgn}(\sigma_{\Omega_r})$ and

$$\text{sgn}(\sigma_{\Omega_r}) : \begin{cases} 1 & \text{if } \sigma_{\Omega_r} > 0; \\ -1 & \text{if } \sigma_{\Omega_r} < 0; \\ \in [-1, 1] & \text{if } \sigma_{\Omega_r} = 0. \end{cases}$$

(24) becomes

$$\dot{V}_{\sigma_{\Omega_r}} = -l_{\Omega_r} V_{\sigma_{\Omega_r}} + \sigma_{\Omega_r} [-\eta_{\Omega_r} \text{sgn}(\sigma_{\Omega_r}) + d_{\Omega_r}].$$

By choosing $l_{\Omega_r} > 0$ and $\eta_{\Omega_r} > \max\{\|d_{\Omega_r}\|\}$ (defined hereafter) it follows that $\dot{V}_{\sigma_{\Omega_r}} \leq 0$. As $V_{\sigma_{\Omega_r}}$ is contracting and from assumption (3.1-a-b) then $\max\{\Omega_r\} := K_{\Omega_r}^{max}$ can not be greater than $\max\{|\Omega_r(0)|, |\Omega_r^*|\} + |\Delta e_{\Omega_r}(0)|$. Consequently, as $d_{\Omega_r} = \Delta c\Omega_r + \frac{T_l}{J}$ then d_{Ω_r} is bounded. Finally, η_{Ω_r} is set as $\eta_{\Omega_r} = \Delta cK_{\Omega_r}^{max} + \frac{g}{J} + b_{\Omega_r}$, with b_{Ω_r} a small positive constant. Furthermore, all the trajectories reach the sliding manifold $\sigma = 0$ in a finite time and remain there. Therefore, $\sigma = 0$ and equation (22) implies

$$\dot{e}_{\Omega_r} = (k_{\Omega_r} - c)e_{\Omega_r} \quad (26)$$

which makes that the speed tracking error e_{Ω_r} exponentially converges to 0 for $(k_{\Omega_r} - c) < 0$.

PROPOSITION 3.2 . Consider *IM* model (15) and assume that assumption 3.1 is satisfied. Then under the action of speed controller (25) and flux controller (19), the rotor speed and the flux track their desired trajectories.

Proof

Using

$$V_c = \frac{1}{2}\sigma_{\phi_{rd}}^2 + \frac{1}{2}\sigma_{\Omega_r}^2$$

as a Lyapunov function candidate, then the time derivative

$$\dot{V}_c = -l_{\phi_{rd}} V_{\sigma_{\phi_{rd}}} + [-\eta_{\phi_{rd}} \text{sgn}(\sigma_{\phi_{rd}}) + \Delta a\phi_{rd}] - l_{\Omega_r} V_{\sigma_{\Omega_r}} + [-\eta_{\Omega_r} \text{sgn}(\sigma_{\Omega_r}) + d_{\Omega_r}]$$

is less than 0. □

4 Stability analysis of the closed-loop system

In order to implement controllers (19) and (25), the speed/flux measures are replaced by their estimates resulting in the new controllers

$$i_{sd}^* = -l_{\hat{\phi}_{rd}} \sigma_{\hat{\phi}_{rd}} + \frac{k_{\hat{\phi}_{rd}} e_{\hat{\phi}_{rd}} + a\phi_{rd}^* + \dot{\phi}_{rd}^* - \eta_{\hat{\phi}_{rd}} \text{sgn}(\sigma_{\hat{\phi}_{rd}})}{\kappa} \quad (27)$$

$$i_{sq}^* = -l_{\hat{\Omega}_r} \sigma_{\hat{\Omega}_r} + \frac{k_{\hat{\Omega}_r} e_{\hat{\Omega}_r} + c\Omega_r^* + \dot{\Omega}_r^* - \eta_{\hat{\Omega}_r} \text{sgn}(\sigma_{\hat{\Omega}_r})}{m\hat{\phi}_{rd}} \quad (28)$$

where

$$\begin{cases} e_{\hat{\phi}_{rd}} = \phi_{rd}^* - \hat{\phi}_{rd} \\ e_{\hat{\Omega}_r} = \hat{\Omega}_r - \Omega_r^* \\ \sigma_{\hat{\phi}_{rd}} = e_{\hat{\phi}_{rd}} + (k_{\phi} - a) \int_0^t e_{\hat{\phi}_{rd}} d\tau \\ \sigma_{\hat{\Omega}_r} = e_{\hat{\Omega}_r} + (k_{\Omega_r} - c) \int_0^t e_{\hat{\Omega}_r} d\tau \end{cases}$$

The *IM* observer must already be fluxed to ensure estimated speed tracking. In order to avoid the singularity in (28), the observer (3) is initialized with initial conditions different from zero. In practice, electrical engineers overcome this singularity by starting to track firstly the flux ϕ_{rd} to its reference $\phi_{rd}^* = \text{constant}$. The same trick is adopted for the estimated flux $\hat{\phi}_{rd}$ by adding an offset $\varepsilon = 0.05Wb$ such as

$$i_{sq}^* = -l_{\hat{\Omega}_r} \sigma_{\hat{\Omega}_r} + \frac{k_{\hat{\Omega}_r} e_{\hat{\Omega}_r} + c\Omega_r^* + \dot{\Omega}_r^* - \eta_{\hat{\Omega}_r} \text{sgn}(\sigma_{\hat{\Omega}_r})}{\max\{\hat{\phi}_{rd}, \varepsilon\}m} \quad (29)$$

To analyze the stability of the closed-loop system ("O-C"), the following procedure is adopted.

Argument 4.1 If it is proved that the controller (27)-(29) enables to track the estimated flux and estimated speed to their desired trajectory ($e = Z - X^* \rightarrow 0$ as $t \rightarrow \infty$), then, it is ensured that the *IM* flux and the speed practically converge to their desired trajectories.

-Estimated flux tracking. Define the candidate Lyapunov function $V_{\sigma_{\hat{\phi}_{rd}}} = \frac{1}{2}\sigma_{\hat{\phi}_{rd}}^2$, which time derivative is $\dot{V}_{\sigma_{\hat{\phi}_{rd}}} = -l_{\hat{\phi}_{rd}} V_{\sigma_{\hat{\phi}_{rd}}} - \sigma_{\hat{\phi}_{rd}} [\eta_{\hat{\phi}_{rd}} \text{sgn}(\sigma_{\hat{\phi}_{rd}}) + \mathbf{M}g_{\hat{\phi}_{rd}} \epsilon_{i_{s\beta}}]$, where $g_{\hat{\phi}_{rd}}$ is the gain of the estimated flux $\hat{\phi}_{rd}$. By choosing $l_{\hat{\phi}_{rd}} > 0$ and $\eta_{\hat{\phi}_{rd}} > \max\{\mathbf{M} \|g_{\hat{\phi}_{rd}}\| \|\epsilon_{i_{s\beta}}\|\}$ (defined hereafter) it follows that $V_{\sigma_{\hat{\phi}_{rd}}} \leq 0$. Now, imposing the initial states of the observer to be in \mathcal{D} and as $V_{\sigma_{\hat{\phi}_{rd}}}$ is contracting, then from assumption (3.1-b), $\max\{\hat{\phi}_{rd}\} := K_{\hat{\phi}_{rd}}^{\max}$ can not be greater than $\max\{\hat{\phi}_{rd}(0), \phi_{rd}^*\} + |\Delta e_{\hat{\phi}_{rd}}(0)|$. From where it can be deduced that $\|g_{\hat{\phi}_{rd}}\|$ is bounded. Moreover, as $V_0 = V_1 + V_2$ (see the proposition 2.4 proof) is practically stable and does not depend on u , then $\|\epsilon_{i_{s\beta}}\|$ is bounded. Finally, $\eta_{\hat{\phi}_{rd}}$ is set as

$$\eta_{\hat{\phi}_{rd}} = K_{g_{\hat{\phi}_{rd}}}^{\max} K_{\epsilon_{i_{s\beta}}}^{\max} + c_1, c_1 > 0. \quad (30)$$

-Estimated speed tracking. Consider the candidate Lyapunov function $V_{\hat{\Omega}_r} = \frac{1}{2}\hat{\Omega}_r^2$, which time derivative is $\dot{V}_{\hat{\Omega}_r} = -l_{\hat{\Omega}_r} V_{\hat{\Omega}_r} - \sigma_{\hat{\Omega}_r} [\eta_{\hat{\Omega}_r} \text{sgn}(\sigma_{\hat{\Omega}_r}) + \mathbf{M}g_{\hat{\Omega}_r} \epsilon_{i_{s\alpha}}]$, where $g_{\hat{\Omega}_r}$ is the gain of the estimated speed $\hat{\Omega}_r$. By choosing $l_{\hat{\Omega}_r} > 0$ and $\eta_{\hat{\Omega}_r} > \max\{\mathbf{M} \|g_{\hat{\Omega}_r}\| \|\epsilon_{i_{s\alpha}}\|\}$ it follows that $V_{\hat{\Omega}_r} \leq 0$. Following the same ideas as above leads to

$$\eta_{\hat{\Omega}_r} = K_{g_{\hat{\Omega}_r}}^{\max} K_{\epsilon_{i_{s\alpha}}}^{\max} + c_2, c_2 > 0. \quad (31)$$

LEMMA 4.2 Consider observer (3) initialized in \mathcal{D} and assume that assumption (3.1-a-b) holds. Then, under the action of the controller (27)-(29), the rotor flux and rotor speed estimations track their desired trajectories.

Proof Using

$$V_c = \frac{1}{2}\sigma_{\hat{\phi}_{rd}}^2 + \frac{1}{2}\sigma_{\hat{\Omega}_r}^2$$

as a Lyapunov function candidate, it follows

$$\dot{V}_c = -l_{\hat{\phi}_{rd}} V_{\sigma_{\hat{\phi}_{rd}}} - \sigma_{\hat{\phi}_{rd}} [\eta_{\hat{\phi}_{rd}} \text{sgn}(\sigma_{\hat{\phi}_{rd}}) + \mathbf{M}g_{\hat{\phi}_{rd}} \epsilon_{i_{s\beta}}] - l_{\hat{\Omega}_r} V_{\sigma_{\hat{\Omega}_r}} - \sigma_{\hat{\Omega}_r} [\eta_{\hat{\Omega}_r} \text{sgn}(\sigma_{\hat{\Omega}_r}) + \mathbf{M}g_{\hat{\Omega}_r} \epsilon_{i_{s\alpha}}] \leq 0.$$

□

Now, a practical stability result of the proposed observer based control for the IM is given.

THEOREM 4.3 Consider the controller (27)-(29) and property (2.2). If the observer (3) is initialized on \mathcal{D} and assuming the assumption (3.1) is satisfied, then

- The IM estimated state practically converges to the real state.
- The estimated flux and speed exponentially converge to their desired trajectories.
- Finally, the real flux and speed of IM converge practically to their desired trajectories.

Proof The proof follows from proposition (2.4), lemma (4.2) and argument (4.1). □

5 EXPERIMENTAL RESULTS

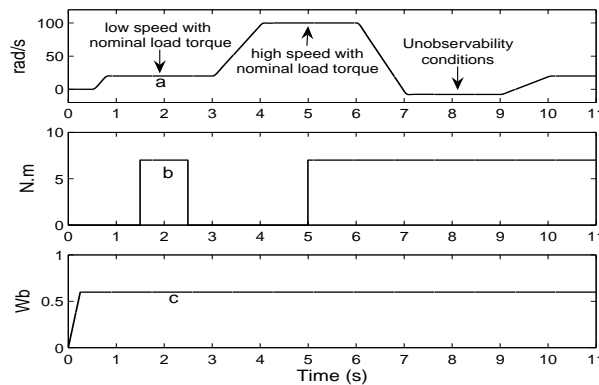
5.1 Control Benchmark

A Sensorless Control Benchmark defines the adequate reference trajectories to evaluate the performances of the sensorless control algorithms under the following operating conditions (Figure 3).

Area 1. Low speed with nominal load torque (from 1s to 3s).

Area 2. High speed with nominal load torque (from 4s to 6s).

Area 3. Very low speed (zero frequency) with nominal load (the IM is unobservable¹ from 7s to 9s).

5.2 Experimental results

Here, the experimental results obtained with the proposed controller using the observer are given. The tests have been performed with the following induction motor values:

Nominal rate power	1.5kW	R_s	1.47Ω
Nominal angular speed	1430 rpm	R_r	0.79Ω
Number of pole pairs	2	L_s	$0.105H$
Nominal voltage	220 V	L_r	$0.094H$
Nominal current	6.1 A	J, f_v	$0.0077Kg.m^2, 0.0029Nm/rad/s$

and the guidelines parameters tuning for the observer and the controller are given as follows :

- For the observer given by (3), θ_1 and θ_1 are chosen to satisfy (11). From (11), it is easy to see that $\theta_1 > Nv$ and $\theta_2 > \frac{N}{v}$ where $v \in]0,1]$. So, θ_1 is proportional to v while θ_2 is inversely proportional. We choose $\theta_1 = 1$ and $\theta_2 = 5000$.

- For the controller given by (14), the parameters Kp_{vd} , Kp_{vq} , K_{Ivd} , K_{Ivq} are determined as follows :

Considering the dynamic equations of i_{sd} and i_{sq} given by (13) without nonlinearities and coupling terms

$$\begin{cases} \dot{i}_{sd} = -\gamma i_{sd} + m_1 u_{sd} \\ \dot{i}_{sq} = -\gamma i_{sq} + m_1 u_{sq} \end{cases} \quad (32)$$

Writing the transfer function which lies the stator currents of (32) with their references given by (14) as a second order system in closed loop, it follows

$$\begin{cases} \frac{i_{sd}}{i_{sd}^*} = \frac{w_{nd}^2}{s^2 + 2\zeta w_{nd} + w_{nd}^2} \\ \frac{i_{sq}}{i_{sq}^*} = \frac{w_{nq}^2}{s^2 + 2\zeta w_{nq} + w_{nq}^2} \end{cases}$$

By imposing $\zeta = 1$ to avoid peaking and a currents bands-widths F_{BD} at least less than a middle of $F_e = 1/T_e$ where $T_e = 200\mu s$ is the sampling time:

$$\begin{cases} \zeta = 1 \\ w_{nd} = 2\pi F_{BD} \\ w_{nq} = 2\pi F_{BD}, \end{cases}$$

the parameters Kp_{vd} , Kp_{vq} , K_{Ivd} , K_{Ivq} can be established:

$$\begin{cases} Kp_{vd} = \frac{2\zeta - \gamma}{m_1}, & Ti_{vd} = \frac{2\zeta - \gamma}{w_{nd}^2} \\ Kp_{vq} = \frac{2\zeta - \gamma}{m_1}, & Ti_{vq} = \frac{2\zeta - \gamma}{w_{nq}^2} \end{cases}$$

where $K_{Ivd} = \frac{Kp_{vd}}{Ti_{vd}}$ and $K_{Ivq} = \frac{Kp_{vq}}{Ti_{vq}}$. We choose $Kp_{vd} = 2$, $Kp_{vq} = 2$, $K_{Ivd} = 0.05$, $K_{Ivq} = 0.05$.

- For the controller given by (27)-(29), $l_{\hat{\phi}_{rd}} > 0$, $l_{\hat{\Omega}_r} > 0$ and the parameters $k_{\hat{\phi}_{rd}}$, $k_{\hat{\Omega}_r}$, $\eta_{\hat{\phi}_{rd}}$ and $\eta_{\hat{\Omega}_r}$ are chosen to satisfy respectively (20), (26), (30), (31). We choose $\eta_{\hat{\phi}_{rd}} = 10$, $k_{\hat{\phi}_{rd}} = -80$, $l_{\hat{\phi}_{rd}} = 4$, $\eta_{\hat{\Omega}_r} = 5$, $k_{\hat{\Omega}_r} = -40$, $l_{\hat{\Omega}_r} = 2$.

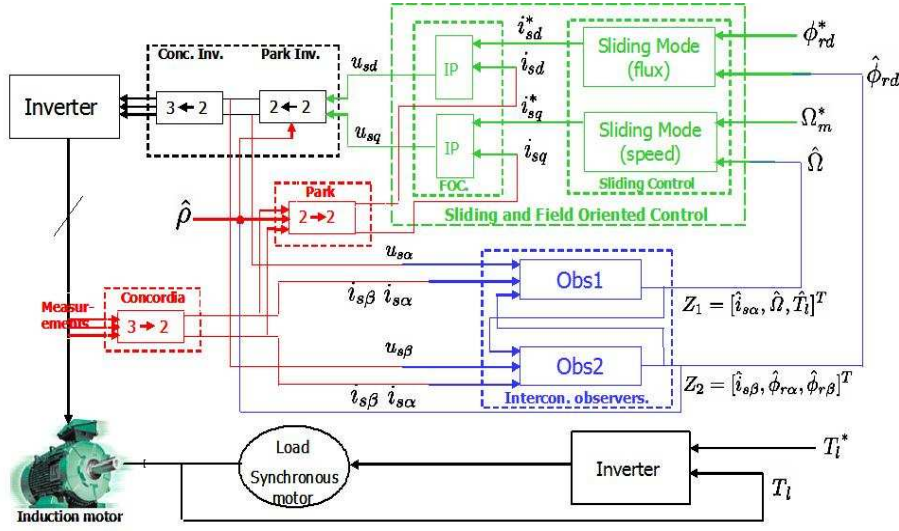


Figure 4. Diagram of the controller-observer scheme.

The block diagram scheme used in experimental set-up to test the law control with observer is presented in figure 4. The block "Intercon. observers" is constituted by the two interconnected observers we have designed. This block uses only the current and stator measurements in the reference fixed frame ($\alpha - \beta$) to estimate the speed, the flux amplitude and the flux angle. The block "Sliding and Field Oriented Control" contains the proposed controller. This block uses the estimates of speed, flux amplitude and flux angle given by the block "Intercon. observers" and the current measurements after using the transformation of Park and Concordia. Then, it gives the inputs control in the reference fixed frame (a,b,c) after using the inverse transformations of Park and Concordia. These control inputs drive the inverter to impose the speed and flux reference trajectories (defined by the "Control Benchmark"). The track of the reference load torque trajectory (also defined in the "Control Benchmark") is imposed by the connected synchronous motor.

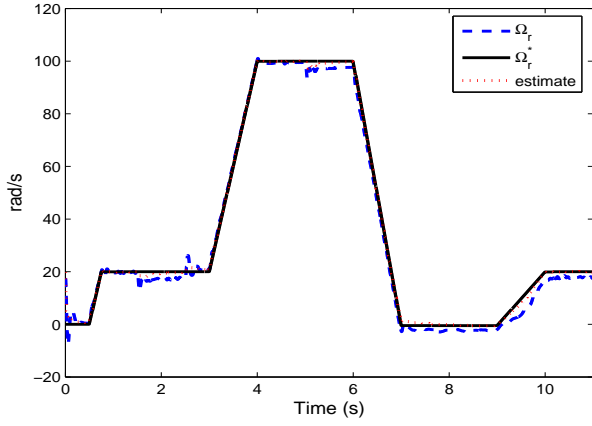


Figure 5. Reference speed Ω_r^* , motor speed Ω_r , estimated speed $\hat{\Omega}_r$ (rad/s)

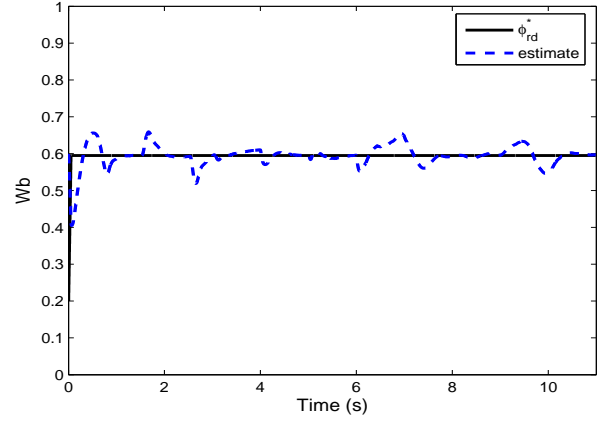


Figure 6. Flux, (Wb)

5.2.1 Case with identified parameters. Figures 5 and 6 show the experimental results in case where identified parameters are used to design the flux and speed sliding mode control with interconnected observers (Controller-Observer Scheme).

Remark 1 Due to experimental conditions (temperature, ...), the identified parameters are not exactly the real parameters of induction motor. The control experimental conditions are nearly different compared to the identification conditions and moreover the identification methodology has a certain uncertainty in its results. Thus this case is already a first robustness test.

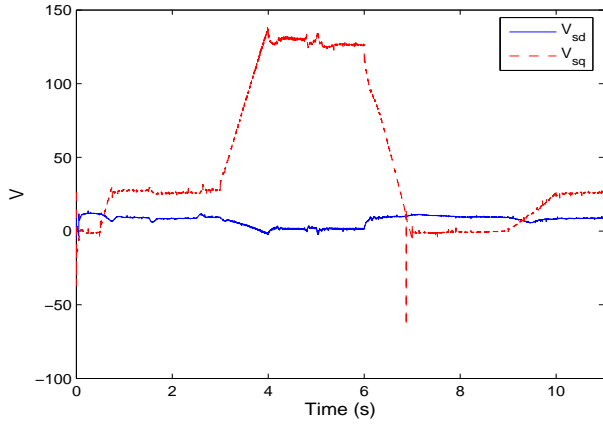


Figure 7. V_{sd} and V_{sq} (V)

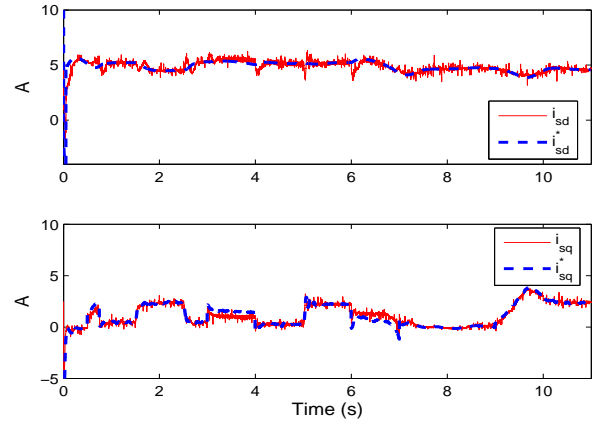


Figure 8. i_{sd} and i_{sq} , (A)

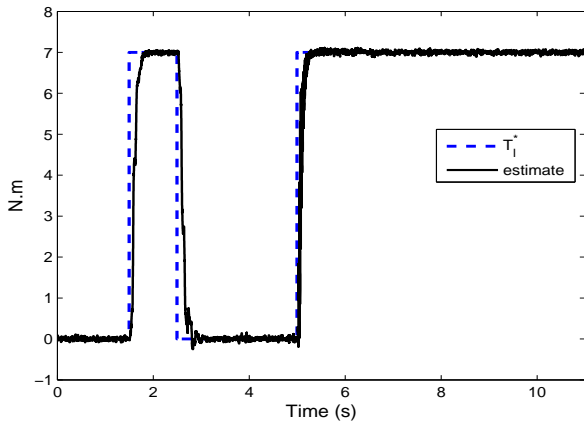


Figure 9. T_l^* and \hat{T}_l (N.m)

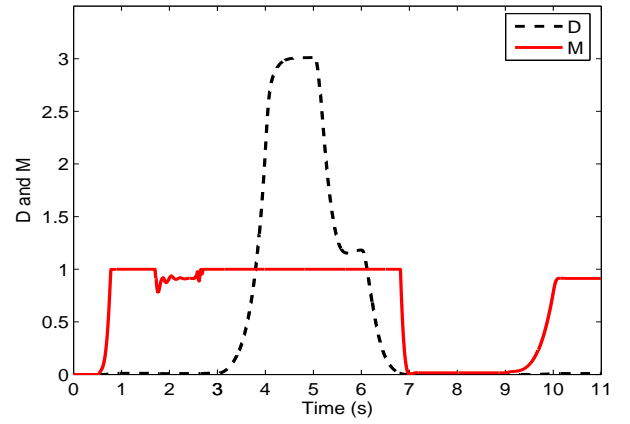


Figure 10. D and M

We can remark that both systems "Control+Observer" give good performances i) in term of trajectory tracking: the motor speed (Ω_r in figure 5) tracks correctly its reference (Ω_r^* in figure 5) even under unobservable conditions (between 7 and 9 sec), nevertheless it appears a small static error when the motor is under unobservable conditions, ii) in term of perturbation rejection: the load torque is well rejected under low speed and high speed. Nevertheless it appears a small static error when the load is applied (Figure 5: 1.5 s) and when it is removed (Figure 5: 2.5 sec). For estimated flux ($\hat{\phi}_{rd}$ in figure 6), the same conclusion is given and moreover it exists a small peaking at the beginning (Figure 6) which is due to initial conditions. Load torque estimate is plotted in figure 9. The determinant \mathbf{D} and the switch function \mathbf{M} introduced respectively by definition (2.3) and observer (3) are shown in figure 10 with $D_{min} = 0.05$. The control efforts V_{sd} and V_{sq} are shown in figure 7. In figure 8 the measured and reference currents of i_{sd} and i_{sq} are displayed.

Case 1: experimental results with identified parameters.

5.2.2 Robustness cases. The interest now is to check the robustness of the designed Control-Observer with respect to motor parameters variation. We have considered two robustness cases : a stator resistance variation of +50% and a rotor resistance variation of +50% with respect to the values of the previous case.

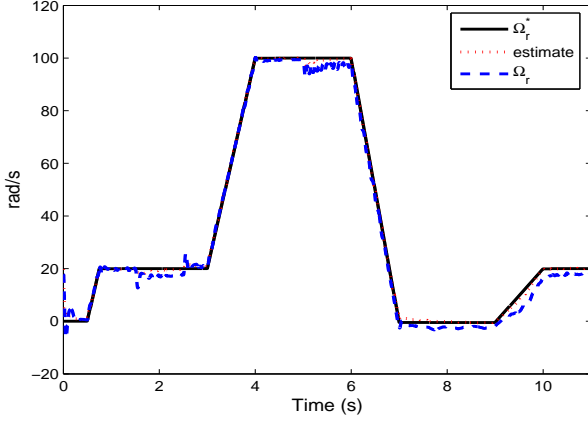


Figure 11. Reference speed Ω_r^* , motor speed Ω_r , estimated speed $\hat{\Omega}_r$ (rad/s)

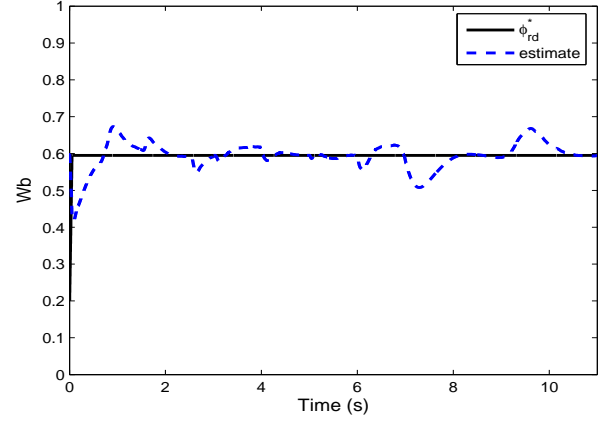


Figure 12. Flux, (rad/s)

Case with +50% of R_r : the results that we have obtained are depicted in figures 11 and 12.

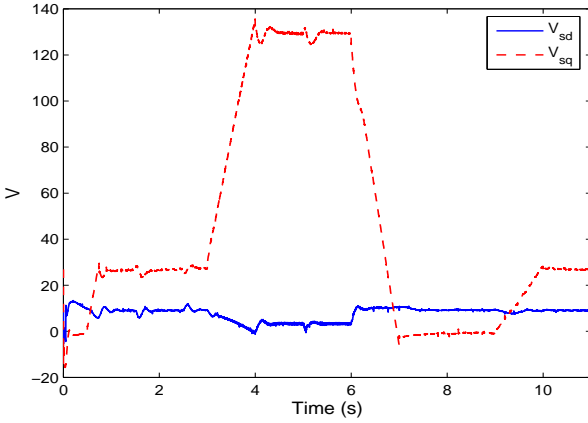


Figure 13. V_{sd} and V_{sq} (V)

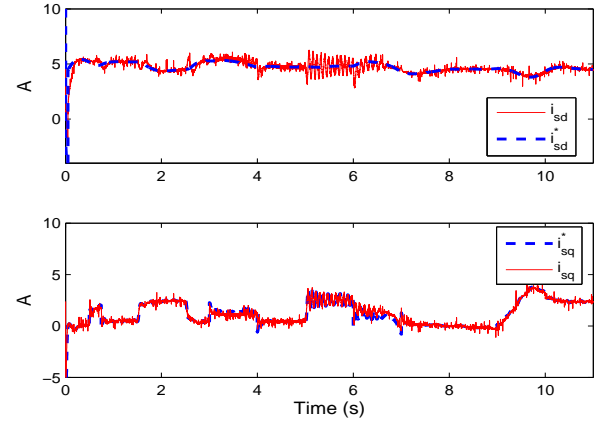


Figure 14. i_{sd} and i_{sq} , (A)

Compared with case 1, the motor speed (Ω_r in figure 11) is more affected by the increase of the rotor resistance at high speed when the load torque is applied (Figure 11: 5 s). But the speed tracking when the motor is under unobservable conditions remains same (Figure 11: from 7 to 9 s). For estimated flux (Figure 12), the results are nearly similar compared with the case 1. The control efforts V_{sd} and V_{sq} are shown in figure 13. In figure 14 the measured and reference currents of i_{sd} and i_{sq} are displayed. The load torque estimate is not depicted because it is nearly similar to the one of case 1.

Case 2: experimental results with rotor resistance variation (+50%).

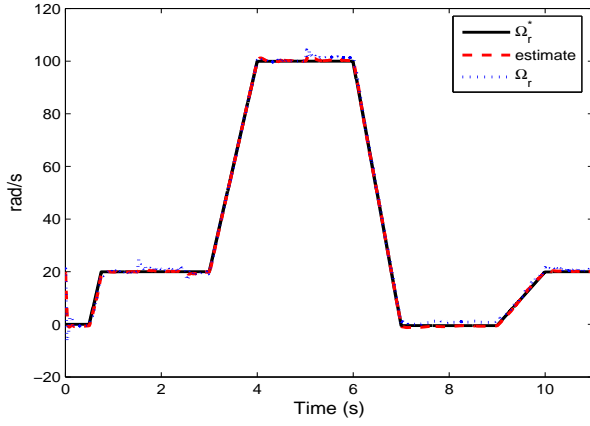


Figure 15. Reference speed Ω_r^* , motor speed Ω_r , estimated speed $\hat{\Omega}_r$ (rad/s)

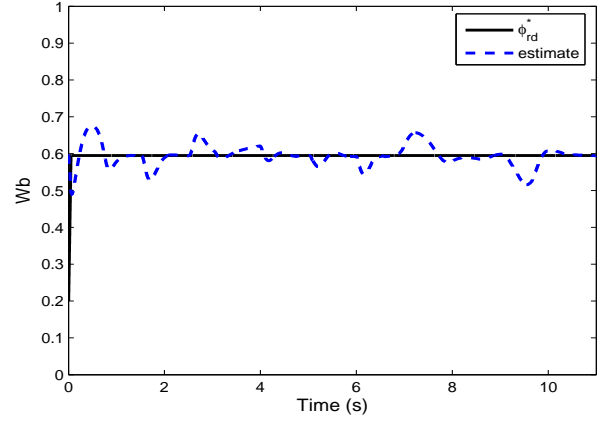


Figure 16. Flux, (rad/s)

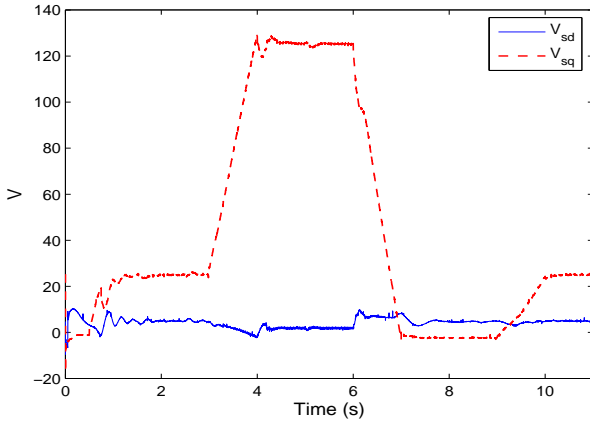


Figure 17. V_{sd} and V_{sq} (V)

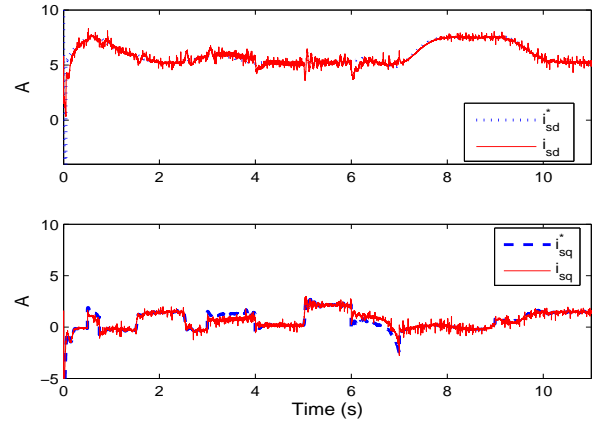


Figure 18. i_{sd} and i_{sq} , (A)

Case with +50% of R_s : in figures 15 and 16, the sensitivity of both "Control+Observer" with respect to the variation of the stator resistance is showed. The performances of both "Control+Observer" are nearly similar with the case 1 for the speed motor (Figure 15. b) and estimated flux (Figure 16. b). However, an improvement can be remarked for motor speed at high speed when the load torque is applied (Figure 11: 5 s): the oscillations are removed, it remains only a small static error. This improvement can be explained by the fact that the parameters are close to the real parameters of induction motor as it can be obtained by simulation with the same parameters for model and both "Control+Observer". The control efforts V_{sd} and V_{sq} are shown in figure 17. In figure 18 the measured and reference currents of i_{sd} and i_{sq} are displayed. The load torque estimate is not depicted because it is nearly similar compared to case 1.

Case 3: experimental results with stator resistance variation (+50%).

6 CONCLUSION

In this paper, a *SIM* observer has firstly been designed. This later structurally takes into account the unobservable conditions of the *IM*. The gains are chosen according to the ratio between the unobservable and observable time intervals. Secondly, the estimated speed and flux are used to design a FOC-SMC in order to steer the estimated speed and flux magnitude to their desired trajectories in a finite time. Consequently, the performance of the observer based control scheme "O-C" scheme is related to the observer behavior, which is a natural consequence of the unobservable¹ sequences. Finally, this scheme has been tested and validated on an experimental set-up using the reference trajectories of a realistic proposed benchmark where the *IM* remains in the unobservable sequences and not just go across.

Annexe: Positiveness proof of $S_i(t)$

Consider the expressions of \dot{S}_i , $i = 1, 2$ given by observer (3):

$$\dot{S}_i = \mathbf{M}(-\theta_i S_i - A_i^T(Z_j)S_i - S_i A_i(Z_j) + C_i^T C_i), \quad (33)$$

with $j = 2$ if $i = 1$ and $j = 1$ if $i = 2$.

We denote by $\Phi_i(t, r)$ the unique solution of:

$$\dot{\Phi}_i(t, r) = \frac{d\Phi_i(t, r)}{dr} = A_i(Z_j)\Phi_i(t, r) \quad (34)$$

such that

$$\Phi_i(t, t) = I \quad (35)$$

where I is the identity matrix and r vary from 0 to t .

Two cases are considered:

$M = 1$: observable conditions where r vary from 0 to t_1 .

$M = 0$: unobservable conditions where r vary from t_1 to t .

1) Case where $M = 1$ (observable conditions) $r \in [0, t_1]$:

Multiplying each term of (33) by $\Phi_i(t_1, r)^T$ in left side and by $\Phi_i(t_1, r)$ in right side, we get

$$\begin{pmatrix} \Phi_i(t_1, r)^T \dot{S}_i(r) \Phi_i(t_1, r) + \theta_i \Phi_i(t_1, r)^T S_i(r) \Phi_i(t_1, r) \\ + \Phi_i(t_1, r)^T A_i^T(Z_j) S_i(r) \Phi_i(t_1, r) \\ + \Phi_i(t_1, r)^T S_i(r) A_i(Z_j) \Phi_i(t_1, r) \end{pmatrix} = \Phi_i(t_1, r)^T C_i^T C_i \Phi_i(t_1, r) \quad (36)$$

By multiplying both sides of (36) by $\exp^{\theta_i r}$ it follows:

$$\begin{pmatrix} \exp^{\theta_i r} \Phi_i(t_1, r)^T \dot{S}_i(r) \Phi_i(t_1, r) \\ + \theta_i \exp^{\theta_i r} \Phi_i(t_1, r)^T S_i(r) \Phi_i(t_1, r) \\ + \exp^{\theta_i r} \Phi_i(t_1, r)^T A_i^T(Z_j) S_i(r) \Phi_i(t_1, r) \\ + \exp^{\theta_i r} \Phi_i(t_1, r)^T S_i(r) A_i(Z_j) \Phi_i(t_1, r) \end{pmatrix} = \exp^{\theta_i r} \Phi_i(t_1, r)^T C_i^T C_i \Phi_i(t_1, r) \quad (37)$$

It can be remarked that the left side of (37) is the derivative of $\exp^{\theta_i r} \Phi_i(t_1, r)^T S_i(r) \Phi_i(t_1, r)$ with respect to r . Then we can write:

$$\overbrace{(\exp^{\theta_i r} \Phi_i(t_1, r)^T S_i(r) \Phi_i(t_1, r))}^{\cdot} = \exp^{\theta_i r} \Phi_i(t_1, r)^T C_i^T C_i \Phi_i(t_1, r) \quad (38)$$

The solution $S_i(t_1)$ is obtained by integrating the equation (38) with r vary from 0 to t_1 as

$$\int_0^{t_1} \overbrace{(exp^{\theta_i r} \Phi_i(t_1, r)^T S_i(r) \Phi_i(t_1, r))}^{\dot{}} dr = \int_0^{t_1} exp^{\theta_i r} \Phi_i(t_1, r)^T C_i^T C_i \Phi_i(t_1, r) dr \quad (39)$$

Then, equation (39) gives

$$exp^{\theta_i t_1} \Phi_i(t_1, t_1)^T S_i(t_1) \Phi_i(t_1, t_1) - \Phi_i(t_1, 0)^T S_i(0) \Phi_i(t_1, 0) = \int_0^{t_1} exp^{\theta_i r} \Phi_i(t_1, r)^T C_i^T C_i \Phi_i(t_1, r) dr \quad (40)$$

Finally, by using the property (35) in equation (40), the solution $S_i(t_1)$ yields

$$S_i(t_1) = exp^{-\theta_i t_1} \Phi_i(t_1, 0)^T S_i(0) \Phi_i(t_1, 0) + \int_0^t exp^{-\theta_i(t_1-r)} \Phi_i(t_1, r)^T C_i^T C_i \Phi_i(t_1, r) dr \quad (41)$$

From (41), we can remark that $S_i(t_1)$ is definite positive with $S_i(0) > 0$ due to the fact that Z_1 and Z_2 of equations (34) are regularly persistent (see remark 1.2). Then the positiveness of $S_i(t_1)$ is demonstrated.

2) Case where $M=0$ (unobservable conditions) $r \in [t_1, t]$:

Equation (33) becomes:

$$\dot{S}_i(r) = 0 \quad (42)$$

By integrating equation (42) with r varying from t_1 to t , we get

$$S_i(t) = S_i(t_1) \quad (43)$$

It can be noted that the final condition $S_i(t_1)$ of the interval time where IM is observable is equal to the final condition $S_i(t)$ of the interval time where IM is unobservable since S_i remains constant during this unobservable interval of time. Then $S_i(t)$ (equation 43) is positive definite.

This ends the proof.
