## Chattering-free digital sliding-mode control with state observer and disturbance rejection

**Abstract:** In this paper a novel discrete-time implementation of sliding-mode control systems is proposed, which fully exploits the multivaluedness of the dynamics on the sliding surface. It is shown to guarantee a smooth stabilization on the discrete sliding surface in the disturbance-free case, hence avoiding the chattering effects due to the time-discretization. In addition when a disturbance acts on the system, the controller attenuates the disturbance effects on the sliding surface by a factor  $h$  (where  $h$  is the sampling period). Most importantly this holds even for large  $h$ . The controller is based on an implicit Euler method and is very easy to implement with projections on the interval  $[-1, 1]$  (or as the solution of a quadratic program). The zero-order-hold (ZOH) method is also investigated. First and second order perturbed systems (with a disturbance satisfying the matching condition) without and with dynamical disturbance compensation are analyzed, with classical and twisted sliding-mode controllers.

## Commande par modes glissants en temps discret avec suppression du phénomène de “chattering”

**Résumé :** Ce travail concerne la commande par modes glissants en temps discret. L'aspect multivalué est pleinement exploité, ce qui permet de supprimer le chattering dû à la discrétisation en temps, et d'autre part d'atténuer les perturbations par un facteur  $h$  ( $h$  le pas d'intégration ou la période d'échantillonnage) ou par un facteur  $h^2$ . Les méthodes d'Euler implicite et ZOH (zero order holder) sont étudiées.

**Mots-clés :** sliding-mode, backward Euler method, zero-order-hold method, discrete-time sliding mode, disturbance compensation, twisting controller

## 1 Introduction

Sliding-mode control is an important field of feedback control, with many applications, see *e.g.* [6, 15, 19, 22, 27, 28]. The issue related to the digital definition and implementation of sliding mode systems, has been the object of many works since the publication of pioneering works [9, 20], see *e.g.* [4, 12, 17, 27, 31, 28, 24, 25]. It appears however that such control methods are not yet fully understood and their implementation is still prone to serious problems like numerical chattering [13, 30, 14, 18, 16, 29, 28, 32, 5]. The objective of this paper is threefold: a) to show that an *implicit* Euler controller permits to numerically implement the multivalued part of discontinuous sliding-mode controllers and consequently suppress the *numerical chattering* that is present in the explicit implementations, b) to extend it to the case when one part of the state is observed, c) to show that when a disturbance acts on the system (full-state or partial-state feedback) the numerical chattering is still suppressed and the disturbance is rejected. By disturbance rejection it is meant that in the ideal (analytical) continuous-time system, the disturbance is exactly rejected, while in the digital implementation it is attenuated by a factor  $h$  where  $h > 0$  is the sampling time. The major features of the implicit causal discrete-time input are on one hand that the continuous-time system sliding surface (that may be of codimension larger than one) is not changed after the discretization, on the other hand a finite sampling frequency is sufficient to assure the sliding motion of the discrete-time system, and finally the chattering effects observed on explicit controllers (named the numerical chattering) are suppressed.

**Definition 1** *The numerical chattering corresponds to the oscillations (limit cycles) which are solely due to the digital implementation of the controller.*

**Definition 2** *The disturbance chattering corresponds to the oscillations that can appear due to a high frequency disturbance acting on the system.*

A first fundamental step is to eliminate the numerical chattering with the application of a suitable *implicit* discrete-time controller. The disturbance chattering will not be eliminated in the system's state around the sliding surface, but the disturbance is attenuated by a factor  $h$  (of a factor  $h^2$  on the system's position for an order-two system). In practice it is expected that this corresponds to a high compensation of the disturbance. The control input obtained by the implicit method is not of the bang-bang type when the state evolves on the sliding surface. On the contrary it is a continuous input which evolves inside the multivalued part of the sign multifunction (the multivalued part corresponds in the Filippov case to the set representing the closed convex closure of the vector fields on the switching surface, which is a segment if the codimension is equal to one).

**Definition 3** *Let  $h = t_{k+1} - t_k > 0$  be the sampling period,  $k \geq 0$ . An  $m$ -discrete-time sliding surface  $\Sigma_d$  is a codimension  $m$  subspace of the state space, such that the discrete state vector  $x_k \triangleq x(t_k)$  satisfies  $x_k \in \Sigma_d$  for all  $k_{\min} \leq k \leq k_{\max}$ ,  $k_{\min} < k_{\max} - 1$ ,  $k_{\min} \geq 0$ . Moreover this holds whatever  $h > 0$ .*

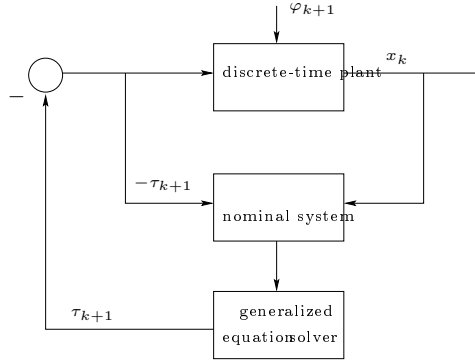


Figure 1: The discrete-time closed-loop system.

A very attractive feature of the digital method based on the implicit Euler method is that the numerical sliding surface  $\Sigma_d$  and the continuous-time sliding

surface  $\Sigma_c$  satisfy  $\Sigma_d = \Sigma_c$ : the discretization does not modify the sliding surface [1]. If, for instance,  $\Sigma_c = \{x \in \mathbb{R}^n \mid Cx + D = 0\}$ ,  $C \in \mathbb{R}^{m \times n}$ ,  $D \in \mathbb{R}^m$ , then  $\Sigma_d = \{x_k \in \mathbb{R}^n \mid Cx_k + D = 0\}$ . The controllers which are designed in this paper consist of the stabilization of an unperturbed *nominal* plant, coupled to the plant's dynamics (see figure 1). Both the nominal and the real plant have to be discretized with the same method (implicit Euler or zero-order holder).

The paper is organized as follows: section 2 is dedicated to the analysis of a simple first-order system, without and with disturbance compensation. An extension to higher-order systems is also presented, with the Euler and the ZOH methods. In section 3 second-order systems are treated and several types of controllers are analyzed. In all cases the continuous-time system is introduced, then its time-discretization is studied, and finally simulation results are shown. Conclusions end the paper.

**Notation:** In the sequel  $\text{sgn}(x)$  is the multivalued sign function:  $\text{sgn}(x) = \begin{cases} +1 & \text{if } x > 0 \\ -1 & \text{if } x < 0 \\ [-1,1] & \text{if } x = 0 \end{cases}$ . Let  $K \subset \mathbb{R}^n$  be a closed non empty convex set. The normal cone to  $K$  at  $x \in K \subset \mathbb{R}^n$  is  $N_K(x) = \{z \in \mathbb{R}^n \mid z^T(y - x) \geq 0 \text{ for all } y \in K\}$ . Let  $M = M^T > 0$  be an  $n \times n$  matrix. For any  $x \in \mathbb{R}^n$  and  $y \in \mathbb{R}^n$ , one has

$$-x + y \in M^{-1}N_K(x) \Leftrightarrow x = \text{proj}_M(K; y) \Leftrightarrow x = \underset{z \in K}{\text{argmin}} \frac{1}{2}(z - y)^T M(z - y) \quad (1)$$

where  $\text{proj}_M(K; y)$  denotes the orthogonal projection of  $y$  on  $K$  in the metric defined by  $M$ . For any reals  $x$  and  $y$ , one has

$$x \in \text{sgn}(y) \Leftrightarrow y \in N_{[-1,1]}(x). \quad (2)$$

For  $x \in \mathbb{R}^m$ ,  $\text{Sgn}(x) = (\text{sgn}(x_1) \dots \text{sgn}(x_m))^T$ ,  $\|x\|_\infty = \max(|x_1|, \dots, |x_m|)$ ,  $\|x\|_1 = \sum_{i=1}^m |x_i|$ . For any matrix  $M$  and vector  $x$ , the norms  $\|M\|$  and  $\|x\|$  are supposed to be compatible norms so that  $\|Mx\| \leq \|M\| \|x\|$ . For a function  $f: \mathbb{R} \rightarrow \mathbb{R}$  one has  $\|f\|_\infty = \text{esssup}_{t \in \mathbb{R}} |f(t)|$ .  $I_n$  is the  $n \times n$  identity matrix.

## 2 A first-order system

We analyze in this section the simplest case to illustrate how the method works. Two cases are treated: without and with disturbance compensation (in the continuous-time system). The basic ideas are illustrated on a simple first-order system.

### 2.1 The case without disturbance compensation

Let us start by considering the following basic sliding mode system:

$$\begin{cases} \dot{x}(t) = -a\tau(t) + \varphi(t) \\ \tau(t) \in \text{sgn}(x(t)), \end{cases} \quad (3)$$

where  $\varphi(\cdot)$  is the perturbation such that  $\|\varphi\|_\infty < \rho < a$ . The control input is here  $u(t) = \tau(t)$ . It may be seen, in the language of differential inclusions theory, as a *selection* of the set-valued right-hand-side of the system. Choosing correctly this selection is the object of the following discretization. The system (3) has  $x = 0$  as its unique equilibrium point, which is globally asymptotically stable and is reached in finite time (this may be shown with the Lyapunov function  $V(x) = x^2$ ). The discrete-time sliding mode system is implemented as follows:

$$\begin{cases} \tilde{x}_{k+1} = x_k - ah\tau_{k+1} \\ \tau_{k+1} \in \text{sgn}(\tilde{x}_{k+1}) \\ x_{k+1} = x_k - ah\tau_{k+1} + h\varphi_{k+1} \end{cases} \quad (4)$$

The first two lines of (4) may be considered as the *nominal unperturbed* plant, from which one computes the input at time  $t_k$ . The third line is the backward Euler approximation of the plant, on which the disturbance is acting. One has  $u(t) = \tau_{k+1}$  on the time-interval  $[t_k, t_{k+1})$ .

**Proposition 1** *Suppose that the initial state in (4) satisfies  $|x_0| > ah > 0$ . Then after a finite number of steps  $k_0$  one obtains that  $\tilde{x}_k = 0$  and  $x_k = h\varphi_k$  for all  $k > k_0$ . In other words, the disturbance is attenuated by a factor  $h$ . Moreover the approximated derivative of the state satisfies  $\frac{x_{k+1} - x_k}{h} = \varphi_{k+1} - \varphi_k$  for all  $k > k_0 + 1$  whereas  $\frac{\tilde{x}_{k+1} - \tilde{x}_k}{h} = 0$  for all  $k > k_0$ . The control input takes values inside the sign multifunction multivalued part on the sliding surface for all  $k > k_0$ .*

**Proof:** The generalized equation  $\tilde{x}_{k+1} = x_k - ah\tau_{k+1}$  and  $\tau_{k+1} \in \text{sgn}(\tilde{x}_{k+1})$  is found to be equivalent, using (1) and (2), to the inclusion  $\tau_{k+1} - \frac{x_k}{ah} \in -N_{[-1,1]}(\tau_{k+1})$  which is equivalent to  $\tau_{k+1} = \text{proj}([-1, 1]; \frac{x_k}{ah})$ . Thus one obtains:

- If  $x_k > ah$  then  $\tilde{x}_{k+1} = x_k - ah$  and  $\text{sgn}(\tilde{x}_{k+1}) = 1$ ,
- If  $x_k < -ah$  then  $\tilde{x}_{k+1} = x_k + ah$  and  $\text{sgn}(\tilde{x}_{k+1}) = -1$ ,
- If  $0 > x_k > -ah$  then  $\tilde{x}_{k+1} \in (0, ah)$ , and  $\text{sgn}(\tilde{x}_{k+1}) = -1$ ,
- If  $0 < x_k < ah$  then  $\tilde{x}_{k+1} \in (-ah, 0)$ , and  $\text{sgn}(\tilde{x}_{k+1}) = 1$ .



From the above we infer that:

- If  $x_k > ah$  then  $x_{k+1} = x_k + h\varphi_{k+1} - ah = x_k + h(\varphi_{k+1} - a) < x_k + h(\rho - a)$ . Since  $\rho - a < 0$  the state is strictly decreased from step  $k$  to step  $k + 1$ .
- If  $x_k < -ah$  then  $x_{k+1} = x_k + h\varphi_{k+1} + ah = x_k + h(\varphi_{k+1} + a) > x_k + h(a - \rho)$ . Since  $a - \rho < 0$  the state is strictly increased from step  $k$  to step  $k + 1$ .

One deduces that if the initial data satisfies  $|x_0| > ah$  then after  $k_0 = \lceil \frac{x_0}{h|a-\rho|} \rceil$  steps one gets  $\tilde{x}_{k_0} = 0$ . Indeed at  $k_0$  the state  $x_k$  reaches the interval  $(-ah, ah)$  and then the unique solution for  $\tilde{x}_k$  is zero. From  $\tilde{x}_{k_0} = 0$  one deduces that  $|x_{k_0}| < ah$ . To compute the next value of  $\tilde{x}_k$  one has to solve the generalized equation

$$\begin{cases} \tilde{x}_{k_0+1} = x_{k_0} - ah\tau_{k_0+1} \\ \tau_{k_0+1} \in \text{sgn}(\tilde{x}_{k_0+1}), \end{cases} \quad (5)$$

whose unique solution is found by inspection to be  $\tilde{x}_{k_0+1} = 0$ <sup>1</sup>. The reasoning can be repeated to conclude that  $\tilde{x}_k = 0$  for all  $k \geq k_0$ . Therefore  $\frac{\tilde{x}_{k+1} - \tilde{x}_k}{h} = 0$  for all  $k > k_0$ . Now let us assume that for  $k \geq k_0$  we have

$$\tilde{x}_{k+1} = x_k - ah\tau_{k+1} = 0, \quad k \geq k_0, \quad (6)$$

that is

$$\tau_{k+1} = \frac{x_k}{ha}. \quad (7)$$

In this case, the state  $x_{k+1}$  is given by

$$x_{k+1} = h\varphi_{k+1}, \quad (8)$$

and therefore

$$x_k = h\varphi_k, \tau_{k+1} = \frac{\varphi_k}{a} \text{ for all } k \geq k_0 + 1, \quad (9)$$

so that  $\frac{x_{k+1} - x_k}{h} = \varphi_{k+1} - \varphi_k$  for all  $k > k_0 + 1$ . ■

Notice that the backward (or implicit) Euler discretization of the unperturbed plant coincides for (3) with the zero-order holder (ZOH) discretization. Considering the perturbed plant, the only difference between (4) and the ZOH discretization is that  $h\varphi_{k+1}$  becomes  $\int_{[t_k, t_{k+1})} \varphi(t) dt$ . And  $h\varphi_{k+1}$  in (8) and (9) has to be replaced by  $\int_{[t_k, t_{k+1})} \varphi(t) dt < ah$ . The attenuation of the disturbance still holds with the ZOH method. In other words the state  $x(\cdot)$  of the plant satisfies  $x(t) = \int_{[t_k, t)} \varphi(t) dt \leq h\rho$ . In a more general setting, the discretization of the controller and the discretization of the plant have to be the same (both implicit Euler, or both ZOH) in order for the disturbance attenuation to hold. Notice that the above shows that  $V_k = |\tilde{x}_k|$  is a Lyapunov function for the nominal system.

<sup>1</sup>The underlying crucial property that makes this hold is the maximal monotonicity of the sign multifunction.

## 2.2 The case with disturbance compensation

Let us consider the case with disturbance compensation. Let us define  $\dot{\hat{x}}(t) = -a\tau_1(t)$ ,  $\tau_1(t) \in \text{sgn}(x(t))$ ,  $e = x - \hat{x}$ , and the controller  $u = -a\text{sgn}(x(t)) - \alpha\text{sgn}(e(t))$ ,  $a > 0$ ,  $\alpha > 0$  and  $a < \alpha$ . Thus the closed-loop system is given by:

$$\begin{cases} \dot{x}(t) = -a\tau_1(t) - \alpha\tau_2(t) + \varphi(t) \\ \dot{e}(t) = -\alpha\tau_2(t) + \varphi(t) \\ \tau_1(t) \in \text{sgn}(x(t)) \\ \tau_2(t) \in \text{sgn}(e(t)) \end{cases} \quad (10)$$

where  $\varphi(\cdot)$  is a disturbance such that  $\|\varphi\|_\infty < \rho < \min(a, \alpha)$ . The fixed point  $(x, e) = (0, 0)$  of the system may be shown in a rather standard way [27] to be globally strongly asymptotically stable with the nonsmooth Lyapunov function  $V(x, e) = |x| + |e|$ . Moreover, the system attains in a finite time the sliding surface  $e = 0$  where it evolves according to the sliding dynamics  $\dot{x}(t) = -a\tau_1(t) + \varphi(t)$ . The condition  $a < \alpha$  implies that the origin is not attained directly, but first the system slides on the surface  $e = 0$ . On this surface it is apparent from (10) that the dynamics in  $x$  evolves as a disturbance-free system. The discrete sliding mode system is implemented as follows:

$$\begin{cases} \tilde{x}_{k+1} = x_k - ah\tau_{1,k+1} - \alpha h\tau_{2,k+1} \\ \tilde{e}_{k+1} = e_k - \alpha h\tau_{2,k+1} \\ \tau_{1,k+1} \in \text{sgn}(\tilde{x}_{k+1}) \\ \tau_{2,k+1} \in \text{sgn}(\tilde{e}_{k+1}), \end{cases} \quad (11)$$

and the update procedure representing the plant dynamics is given by:

$$\begin{cases} x_{k+1} = x_k - ah\tau_{1,k+1} - \alpha h\tau_{2,k+1} + h\varphi_{k+1} \\ e_{k+1} = e_k - \alpha h\tau_{2,k+1} + h\varphi_{k+1}. \end{cases} \quad (12)$$

**Proposition 2** *Assume that  $|e_0| > \alpha h > 0$ . Then after a finite number of steps  $k_0$  one obtains  $\tilde{e}_k = 0$  and  $e_k = h\varphi_{k+1}$  for all  $k > k_0$ . Let  $|x_{k_0} - h\varphi_{k_0+1}| > \alpha h > 0$ . Then there exists  $k_1 < +\infty$  such that  $\tilde{x}_k = 0$  for all  $k > k_0 + k_1$  and  $x_k = h\varphi_k$  for all  $k \geq k_0 + k_1$ .*

**Proof:** From (11) we have

$$\begin{cases} \tilde{e}_{k+1} = e_k - \alpha h\tau_{2,k+1} \\ \tau_{2,k+1} \in \text{sgn}(\tilde{e}_{k+1}), \end{cases} \quad (13)$$

which is exactly the first two lines in (4). Therefore the conclusions drawn for (4) apply, just replacing  $a$  by  $\alpha$ . Thus the  $e_k$ -dynamics is  $e_{k+1} = e_k - \alpha h \text{proj}([-1, 1]; \frac{e_k}{\alpha h}) + h\varphi_{k+1}$ . After  $k_0$  the discrete trajectory evolves on the sliding surface  $\tilde{e}_k = 0$  while  $\tau_{2,k+1} = \frac{e_k}{\alpha h}$  and  $e_k = h\varphi_{k+1}$ , and one obtains using (1):

$$\begin{cases} \tilde{x}_{k+1} = x_k - h\varphi_{k+1} - ah\tau_{1,k+1} \\ \tau_{1,k+1} \in \text{sgn}(\tilde{x}_{k+1}) \\ x_{k+1} = x_k - ah\tau_{1,k+1} \end{cases} \Leftrightarrow x_{k+1} = x_k - ah \text{proj}([-1, 1]; \frac{x_k - h\varphi_{k+1}}{ah}) \quad (14)$$

Then we can redo again the same calculations as in the proof of Proposition 1 (by replacing  $x_k$  by  $x_k - h\varphi_{k+1}$  in the first line of (4), and  $x_k + h\varphi_{k+1}$  by  $x_k$  in the third line), to infer that after a finite number of steps one gets  $\tilde{x}_k = 0$ ,  $\tau_{1,k+1} = \frac{x_k - h\varphi_{k+1}}{ah}$ , and

$$x_{k+1} = x_k - e_k - (x_k - h\varphi_{k+1}) + h\varphi_{k+1} = h\varphi_{k+1} \quad (15)$$

Indeed let us now assume that:

$$\begin{cases} \tilde{x}_{k+1} = x_k - ah\tau_{1,k+1} - \alpha h\tau_{2,k+1} = 0 \\ \tilde{e}_{k+1} = e_k - \alpha h\tau_{2,k+1} = 0, \end{cases} \quad (16)$$

that is

$$\begin{cases} \tau_{1,k+1} = \frac{x_k - e_k}{ah} \\ \tau_{2,k+1} = \frac{e_k}{\alpha h}. \end{cases} \quad (17)$$

After the update procedure (12), we get

$$\begin{cases} x_{k+1} = h\varphi_{k+1} \\ e_{k+1} = h\varphi_{k+1}. \end{cases} \quad (18)$$

We can conclude that once the sliding mode in  $\tilde{x}$  and  $\tilde{e}$  is reached we have,

$$\begin{cases} x_{k+1} = h\varphi_{k+1} \\ e_{k+1} = h\varphi_{k+1} \end{cases}, \text{ for all } k \geq k_0 \quad (19)$$

and

$$\begin{cases} \tau_{1,k+1} = 0 \\ \tau_{2,k+1} = \frac{\varphi_k}{\alpha} \end{cases}, \text{ for all } k \geq k_0 + 1. \quad (20)$$

■

Consequently the discrete-time controller guarantees the convergence of the state of the nominal system in finite time to the origin, while the plant's state is equal to the disturbance attenuated by a factor  $h$ . To summarize, from (11) and (12) the discrete-time closed-loop system is therefore:

$$\begin{cases} x_{k+1} = x_k - ah\tau_{1,k+1} - \alpha h\tau_{2,k+1} + h\varphi_{k+1} \\ e_{k+1} = e_k - \alpha h\tau_{2,k+1} + h\varphi_{k+1} \\ \tau_{1,k+1} = \text{proj}([-1, 1]; \frac{x_k - \alpha h\tau_{2,k+1}}{ah}) \\ \tau_{2,k+1} = \text{proj}([-1, 1]; \frac{e_k}{\alpha h}) \end{cases} \quad (21)$$

One sees that this is very easily implementable with nested projections.

### 2.3 Extension to higher-order systems

In order to show that the foregoing method extends to  $n$ -th order systems with the equivalent-control-based sliding-mode-controller (ECB-SMC [28, Chapter 2]) and also to better fix the ideas on the structure of the proposed controllers, let us consider the linear time-invariant system with disturbance  $\dot{x}(t) = Ax(t) + Bu(t) + D\varphi(t)$  with  $\|\varphi(t)\|_1 \leq p\varphi_{\max}$  for all  $t$ ,  $\varphi_{\max} \geq |\varphi_i|_{\infty}$  for all  $1 \leq i \leq p$  and

$D \in \mathbb{R}^{n \times p}$ . Let us choose a sliding surface  $\Sigma = \{x \in \mathbb{R}^n \mid Cx = 0, C \in \mathbb{R}^{m \times n}\}$ , where  $m$  is the dimension of the input vector  $u(t)$ . The ECB-SMC takes the form  $u \in -(CB)^{-1}CAx - \alpha(CB)^{-1}\text{Sgn}(Cx)$ , provided  $CB$  is full-rank. Let  $z \triangleq Cx$ . The reduced closed-loop dynamics is  $\dot{z}(t) = -\alpha\tau + CD\varphi(t)$ ,  $\tau \in \text{Sgn}(z)$ , which is globally asymptotically stable and  $\Sigma$  is reached in finite time provided  $\alpha > p\|CD\|\varphi_{\max}$  (this can be shown with the Lyapunov function  $V(z) = \frac{1}{2}z^T z$  that satisfies along the closed-loop trajectories  $\dot{V}(t) \leq \|z\|_1(-\alpha + p\|CD\|\varphi_{\max})$ ). The system is discretized as

$$x_{k+1} = x_k + hAx_k + hBu_{k+1} + hD\varphi_{k+1}, \quad (22)$$

and the nominal system is simply given by  $\tilde{x}_{k+1} = (I + hA)x_k + hBu_{k+1}$ . The implicit Euler controller is defined as

$$\begin{cases} u_{k+1} = -(CB)^{-1}CAx_k - \alpha(CB)^{-1}\tau_{k+1} \\ \tau_{k+1} \in \text{Sgn}(C\tilde{x}_{k+1}). \end{cases} \quad (23)$$

Therefore  $\tau_{k+1}$  is given by (see (1) and (2)):

$$\tau_{k+1} \in \text{Sgn}(Cx_k - \alpha h\tau_{k+1}) \Leftrightarrow \tau_{k+1} = \text{proj}([-1, 1]^m; \frac{1}{\alpha h}Cx_k), \quad (24)$$

where  $[-1, 1]^m = [-1, 1] \times \dots \times [-1, 1]$   $m$ -times. Thus the controller to be applied at time  $t_k$  is

$$u_{k+1} = -(CB)^{-1}CAx_k - \alpha(CB)^{-1}\text{proj}([-1, 1]^m; \frac{1}{\alpha h}Cx_k). \quad (25)$$

We therefore obtain, with  $z_k = Cx_k$  and  $\tilde{z}_k = C\tilde{x}_k$ :

$$\begin{cases} \tilde{z}_{k+1} = z_k - \alpha h\tau_{k+1} \\ \tau_{k+1} \in \text{Sgn}(\tilde{z}_{k+1}) \\ z_{k+1} = z_k - \alpha h\tau_{k+1} + hCD\varphi_{k+1}, \end{cases} \quad (26)$$

that is similar to (4). Thus the same conclusions as in Proposition 1 may be drawn for this discrete-time system provided that  $\alpha > p\|CD\|\varphi_{\max}$ : the sliding surface  $C\tilde{x}_k = 0$  is attained after a finite-number of steps whatever the bounded initial state, and the discrete-time system evolves smoothly on this surface while the disturbance effects on the variable  $Cx_k$  are attenuated by a factor  $h$ .

**Remark 1** *The discrete-time input obtained from [28, Equ.(9.36)] (see also [4, 17] and [9] for the original contribution) when applied to (22) is calculated to be:  $u_{k+1} = -(hCB)^{-1}C(I + hA)x_k = -(CB)^{-1}\frac{Cx_k}{h} - (CB)^{-1}CAx_k$ , which is linear. The discrepancy with (25) is the projection on the set  $[-1, 1]^m$  that is intrinsically present in the implicit Euler input (that is nonlinear Lipschitz continuous), and is not a consequence of adding saturations because of actuator limitations. Also the controller in (25) remains bounded when  $h \rightarrow 0$ , a property shared by all the controllers considered in this paper. One may say that both controller designs share the same “philosophy” since they are both calculated in order to force the discrete sliding surface to be zero, with a suitable input. However they are not at all equivalent. In practice the controllers proposed in this paper may be calculated using a suitable complementarity problem solver [2].*

As alluded to in section 2.1, the plant and the controller have to be discretized with the same method (backward Euler or ZOH) in order to assure the disturbance attenuation. Let us investigate the zero-order-holder method (ZOH) on this example. The input is assumed to be constant on  $[t_k, t_{k+1}]$  and is computed at  $t = t_k$ . The ZOH discretization of the ECB-SMC controller on  $[t_k, t_{k+1}]$  takes the form [32]:

$$x_{k+1} = A^*(h)x_k - \alpha B^*(h)\tau_{k+1} + \varphi^*(h), \quad (27)$$

with  $A^*(h) = e^{Ah} - \int_0^h e^{At} dt B(CB)^{-1}CA$ ,  $B^*(h) = \int_0^h e^{At} dt B(CB)^{-1}$ ,  $\varphi_k^*(h) = \int_0^h e^{At} D\varphi((k+1)h - \tau) d\tau$ . Notice that as  $h \rightarrow 0$  then  $A^*(h) \approx I_n + Ah - hB(CB)^{-1}CA + \mathcal{O}(h^2)$ ,  $B^*(h) \approx hB(CB)^{-1} + \mathcal{O}(h^2)$ , consequently the implicit Euler and ZOH methods yield the same discrete-time system when the sampling period is small. Also one may compute that  $\|\varphi_k^*(h)\|_1 \leq hp \|D\| \varphi_{\max} + \mathcal{O}(h^2)$ . This yields the generalized equation:

$$(a) \begin{cases} \tilde{x}_{k+1} = A^*(h)x_k - \alpha B^*(h)\tau_{k+1} \\ \tau_{k+1} \in \text{Sgn}(C\tilde{x}_{k+1}) \\ x_{k+1} = A^*(h)x_k - \alpha B^*(h)\tau_{k+1} + C\varphi_k^*(h) \end{cases} \Rightarrow (b) \begin{cases} C\tilde{x}_{k+1} = CA^*(h)x_k - \alpha CB^*(h)\tau_{k+1} \\ \tau_{k+1} \in \text{Sgn}(C\tilde{x}_{k+1}) \\ Cx_{k+1} = CA^*(h)x_k - \alpha CB^*(h)\tau_{k+1} \\ \quad + C\varphi_k^*(h) \end{cases} \quad (28)$$

Suppose that the matrix  $CB^*(h)$  is symmetric positive definite (since  $CB^* = hI_m + \mathcal{O}(h^2)$  it follows that for  $h$  small enough  $CB^* > 0$  is guaranteed if  $CB$  is invertible). Then from (1) and (2) the first two lines of (28) (b) are equivalent to:

$$\begin{aligned} CA^*(h)x_k - \alpha CB^*(h)\tau_{k+1} \in N_{[-1,1]^m}(\tau_{k+1}) &\Leftrightarrow \tau_{k+1} = \text{proj}_{CB^*(h)}([-1,1]^m; \frac{1}{\alpha}(CB^*(h))^{-1}CA^*(h)x_k) \\ \Leftrightarrow \tau_{k+1} = \underset{z \in [-1,1]^m}{\text{argmin}} \frac{1}{2} \left( z - \frac{1}{\alpha}(CB^*(h))^{-1}CA^*(h)x_k \right)^T CB^*(h) \left( z - \frac{1}{\alpha}(CB^*(h))^{-1}CA^*(h)x_k \right), \end{aligned} \quad (29)$$

where  $\text{proj}_{CB^*(h)}$  is the projection in the metric defined by  $CB^*(h)$ . Therefore at each step the controller is calculated as the solution of a quadratic programme and is unique. Notice that when  $h$  is small then  $CB^*(h) \approx hI_m$  and  $CA^*(h) \approx C$  so that

$$\tau_{k+1} = \underset{z \in [-1,1]^m}{\text{argmin}} \frac{1}{2} \left( z - \frac{1}{h\alpha}Cx_k \right)^T \left( z - \frac{1}{h\alpha}Cx_k \right) \Leftrightarrow \tau_{k+1} = \text{proj}([-1,1]^m; \frac{1}{h\alpha}Cx_k).$$

The input remains bounded when the sampling time decreases. The next result is obvious from (28) (b):

**Lemma 1** *Let  $C\tilde{x}_{k+1} = 0$  for some  $k \geq 0$ . Then  $\|Cx_{k+1}\|_1 = \|C\varphi_k^*(h)\| \leq hp \|C\| \|D\| \varphi_{\max}$ .*

Thus the disturbance attenuation on the nominal discrete-time system sliding surface holds with the ZOH method. If the higher order terms in  $h^2$  are neglected, one sees that (28) (b) is the same as (26) where only the disturbance term is modified, so that once again the conclusions of Proposition 1 apply: the discrete-time system reaches the nominal system sliding surface in a finite number of steps. The analysis for any  $h > 0$  is more involved because the terms in  $h^2$  introduce a coupling between (28) (b) and (a). However since we are focusing

on the sliding modes and finite-time convergence to the sliding surface only, we may assume that the solution  $x(\cdot)$  of the closed-loop system is bounded for any bounded initial data, and that the solution  $x_k$  of its ZOH counterpart in (28) (a) is bounded as well, *i.e.*  $\|x_k\| \leq M$  for all  $k \geq 0$  and some  $M$ . Then the following holds:

**Proposition 3** *Let  $h > 0$  be given. Suppose that the solution of (28) (a) satisfies  $\|x_k\| \leq M$  for all  $k \geq 0$  and some  $M < +\infty$ , and that  $CB^*(h)$  is symmetric positive definite, with  $CB^*(h) \geq \gamma I_m > 0$  for some known  $\gamma$ . Then there exists a constant  $\delta(h^2, M)$  such that if  $\alpha > \frac{m}{\gamma} \|C\| h \rho \|D\| \varphi_{\max} + \delta(h^2, M)$ ,  $C\tilde{x}_{k+1} = 0$  for some  $k \geq 0$  implies  $C\tilde{x}_{k+n} = 0$  for all  $n \geq 2$ .*

**Proof:** from Lemma 1 the first line of (28) (b) rewrites at step  $k + 2$  as:

$$\begin{aligned} C\tilde{x}_{k+2} &= (C + \mathcal{O}(h^2))x_{k+1} - \alpha CB^*(h)\tau_{k+2} \\ &= C\varphi_k^*(h) + \mathcal{O}(h^2)x_{k+1} - \alpha CB^*(h)\tau_{k+2} \end{aligned} \quad (30)$$

Thus (30) and  $\tau_{k+2} \in \text{Sgn}(C\tilde{x}_{k+2})$  form a generalized equation which possesses a unique solution because  $\alpha CB^*(h)$  is positive definite. We may rewrite it as:

$$0 \in \frac{1}{\alpha} (CB^*(h))^{-1} C\tilde{x}_{k+2} - \frac{1}{\alpha} (CB^*(h))^{-1} (C\varphi_k^*(h) + \mathcal{O}(h^2)x_{k+1}) + \text{Sgn}(C\tilde{x}_{k+2}) \quad (31)$$

Therefore if  $\frac{1}{\alpha} (CB^*(h))^{-1} (C\varphi_k^*(h) + \mathcal{O}(h^2)x_{k+1}) \in [-1, 1]^m$  then  $C\tilde{x}_{k+2} = 0$  is the unique solution of (31). From the proposition's assumptions one has  $\| (CB^*(h))^{-1} (C\varphi_k^*(h) + \mathcal{O}(h^2)x_{k+1}) \|_1 \leq \frac{m}{\gamma} \|C\| h \rho \|D\| \varphi_{\max} + \delta(h^2, M)$ , where  $\delta(h^2, M)$  is an upper bound for  $\mathcal{O}(h^2)x_{k+1}$ . This upper bound depends only on  $M$ , the system's matrices, and  $h$ . It is therefore uniform with respect to the step number  $k$ . ■

Then Lemma 1 may be applied to show the disturbance attenuation on the nominal system discrete-time sliding surface.

## 2.4 Numerical simulations

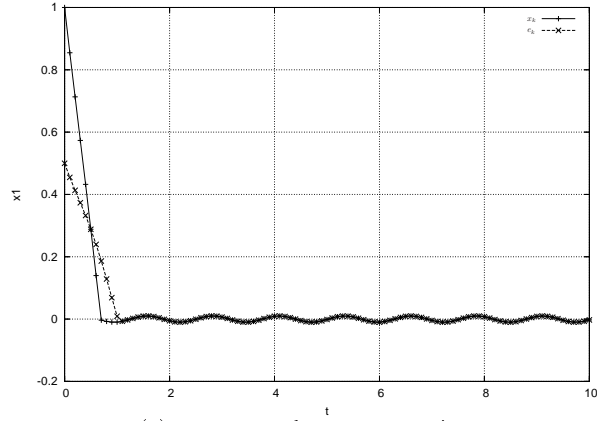
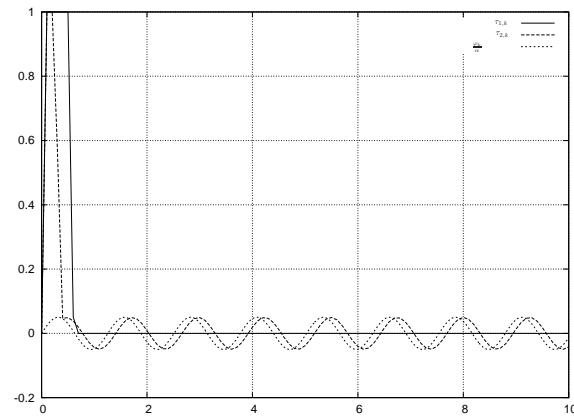
The numerical simulations are obtained with the SICONOS software package of the INRIA<sup>2</sup> that is dedicated to non-smooth dynamical systems. In order to reproduce the continuous-time nature of the plant, the plant dynamics is integrated in all the simulations with the machine precision, whereas the controller sampling time is much larger:  $h = 10^{-1}$ s. This is equivalent to implementing a ZOH method. The disturbance is taken as  $\varphi(t) = \phi \sin(\omega t)$  and we simulate the system in (10).

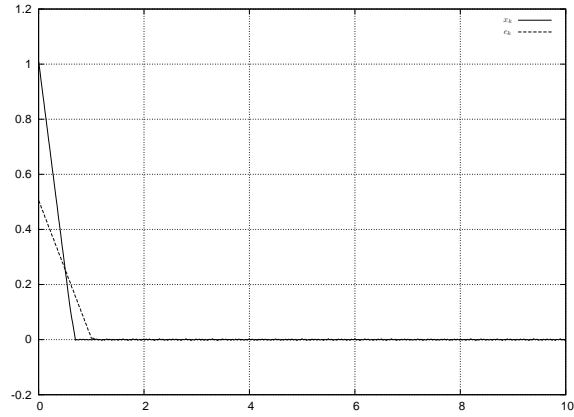

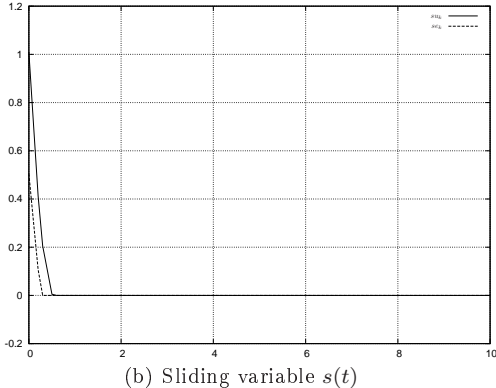
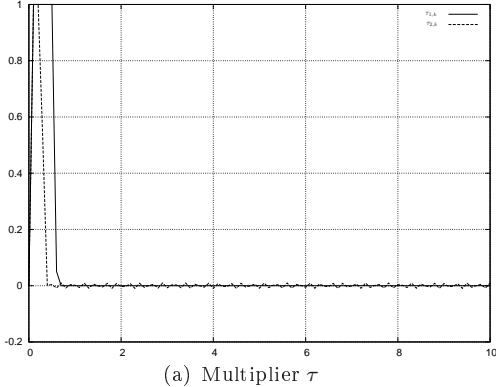


Figure 4: Simulation of the system (10) with  $\varphi(t) = \phi \sin \omega t$ ,  $\omega = 100$ .

The above developments are illustrated on figure 2 with  $a = 1$ ,  $\alpha = 2$ ,  $\omega = 5$  and  $\phi = 0.1$ . Illustrations are given on Figures 3 and 4 with  $a = 1$ ,  $\alpha = 2$ ,  $\omega = 100$  and  $\phi = 0.1$ . The disturbance attenuation is clearly shown.

## 3 Second order systems

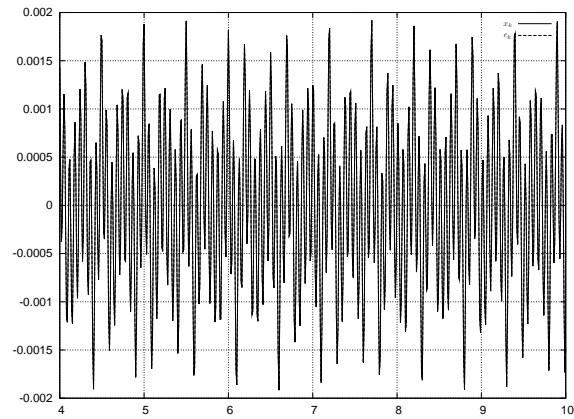
Let us now focus on a more general class of systems and perform the same steps as for the first order case (a short recall of the continuous-time case, and

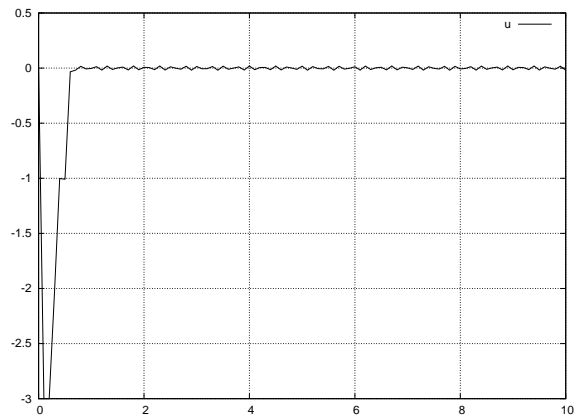

then the time-discretization). The simulations will be given after the theoretical presentations.

### 3.1 First-order sliding-mode stabilization with disturbance compensation

#### 3.1.1 The continuous-time system

The plant dynamics is given by

$$\ddot{x}(t) = u(t) + \varphi(x(t), t), \quad (32)$$

where  $x(t) \in \mathbb{R}$  is the state vector,  $u(t) \in \mathbb{R}$  is the control input. The disturbance  $\varphi(x, t) \in \mathbb{R}$  represents the system uncertainty and its influence on the control process should be rejected. It is assumed that  $\varphi(x, t)$  is an unknown function with an *a priori* known upper estimate  $\varphi_{\max} > 0$  such that

$$|\varphi(x, t)| < \varphi_{\max} \quad (33)$$

for almost all  $x, t \in \mathbb{R}$ . The model repeats the structure of the plant and is given by:

$$\ddot{\hat{x}}(t) = u(t) + v(t), \quad (34)$$

where  $v(t) \in \mathbb{R}$  is the model input. The error dynamics is then written as follows:

$$\ddot{e}(t) = -v(t) + \varphi(x(t), t), \quad (35)$$

where  $e = x - \hat{x}$  is the deviation of the model state from the plant state. The error dynamics, driven by the sliding-mode input, is given by:

$$v(t) \in k_e \dot{e}(t) + k_s s_e(t) + M_v \text{sgn}(s_e(t)), \quad (36)$$

and it is globally asymptotically stabilized provided that  $M_v > \varphi_{\max}$  and  $s_e = \dot{e} + k_e e$  where  $k_e$  and  $k_s$  are positive constants. To reproduce this conclusion it suffices to rewrite the state equation for  $s_e$ , thus arriving at the equation

$$\dot{s}_e(t) \in -k_s s_e(t) - M_v \text{sgn}(s_e(t)) + \varphi(x(t), t), \quad (37)$$

which has  $s_e^* = 0$  as its unique fixed point, which is globally finite-time stable. Thus, by the equivalent control method one has that:

$$v_{eq}(t) = \varphi(x(t), t) \quad (38)$$

on the surface  $s_e = 0$  and it is expected that the control law

$$u \in -v - M_x \text{sgn}(s_x) - k_x \dot{x}, \quad (39)$$

with  $s_x = \dot{x} + k_x x$ , asymptotically compensates for the disturbance  $\varphi(x, t)$ . Indeed, once the sliding mode occurs on the surface  $s_e = 0$ , the plant equation takes the disturbance-free form

$$\begin{cases} \dot{s}_x(t) \in -M_x \text{sgn}(s_x(t)) - k_e \dot{e}(t) \\ \dot{e}(t) = -k_e e(t). \end{cases} \quad (40)$$

because on this sliding surface one has  $M_v \text{sgn}(s_e(t)) = \varphi(x(t), t)$ . Since the dynamics (40) has  $s_x^* = 0$  as a globally asymptotically stable fixed point, the desired disturbance compensation is thus provided. Summarizing, the following result, guaranteeing the global asymptotic stability of the closed-loop system, is obtained. Let us denote by  $z$  the state vector  $z = [e \ s_e \ x \ s_x]^T$ . The coupled plant/error dynamics in the closed-loop system is given by:

$$\begin{cases} \dot{z}(t) = \begin{bmatrix} -k_e & 1 & 0 & 0 \\ 0 & -k_s & 0 & 0 \\ 0 & 0 & -k_x & 1 \\ -k_e & -k_s & 0 & 0 \end{bmatrix} z(t) - \begin{bmatrix} 0 & 0 \\ M_v & 0 \\ 0 & 0 \\ M_v & M_x \end{bmatrix} \tau(t) + \begin{bmatrix} 0 \\ \varphi(x(t), t) \\ 0 \\ \varphi(x(t), t) \end{bmatrix} \\ \tau(t) \in \text{Sgn} \left( \begin{bmatrix} 0 & 1 & 0 & 0 \\ 0 & 0 & 0 & 1 \end{bmatrix} z(t) \right), \end{cases} \quad (41)$$

It is noteworthy that the  $(e \ s_e)$  subdynamics is decoupled from the  $(x \ s_x)$  subdynamics.

**Proposition 4** *Consider the closed-loop system (41) with positive gains  $k_e, k_s, M_x, M_v$  and an external disturbance  $\varphi(x, t)$  such that (33) holds for almost all  $x \in \mathbb{R}$ ,  $t \in \mathbb{R}$  and  $M_v > \varphi_{\max}$ . Then after a finite time, this system evolves in the sliding mode along the surfaces  $s_e = 0$  and  $s_x = 0$ , and along these surfaces, the system dynamics is governed by the asymptotically stable, disturbance-free equations (40).*

The proof of Proposition 4 is rather standard [27] and it is therefore omitted. The parameter subordination  $k_v \gg k_x$  ensures a faster convergence of the error dynamics compared to the state variables of the plant whereas the controller magnitude  $M_x$  is required to be positive only. As a matter of fact, the higher  $M_x$  the higher the plant convergence rate.

### 3.1.2 The backward Euler time-discretization

Let us proceed with the same discretization as in the above first-order examples. For this let us consider the first error dynamics in (37), and discretize it on  $[t_k, t_{k+1})$  as:

$$\begin{cases} \tilde{s}_{e,k+1} = s_{e,k} - hk_s s_{e,k} - hM_v \tau_{1,k+1} \\ \tau_{1,k+1} \in \text{sgn}(\tilde{s}_{e,k+1}) \\ s_{e,k+1} = s_{e,k} - hk_s s_{e,k} - hM_v \tau_{1,k+1} + h\varphi(x_{k+1}, t_{k+1}) \\ e_{k+1} = e_k + h\dot{e}_{k+1} \end{cases} \quad (42)$$

for all  $k \geq 0$ . The first two lines are a generalized equation with unknown  $\tilde{s}_{e,k+1}$ , which we may rewrite as  $0 \in F(\tilde{s}_{e,k+1})$  for some multifunction  $F : \mathbb{R} \rightarrow 2^{\mathbb{R}}$ . It has a unique solution since the sign multifunction is maximal monotone and  $F(\cdot)$  is 2-monotone as the sum of a monotone and a 2-monotone multifunctions (see Definition 2.3.1 and Theorem 2.3.3 in [10], and Exercise 12.4 in [26]). Notice that if  $\tilde{s}_{e,k+1} = 0$  then  $(1 - hk_s)s_{e,k} = hM_v \tau_{1,k+1}$  and  $s_{e,k+1} = h\varphi(x_{k+1}, t_{k+1})$ . Also  $\tau_{1,k+1}$  is a function of  $s_{e,k}$  only, that is of  $\dot{e}_k = \frac{e_k - e_{k-1}}{h}$  and  $e_k$ . So there is

not an exact compensation as in the continuous-time case, but a disturbance-attenuation by a factor  $h$ . Notice that (42) is exactly (4), replacing  $x_k$  by  $(1 - hk_s)s_{e,k}$ ,  $-a$  by  $-M_v$ . Hence the conclusions of Proposition 1 hold for (42). We infer that after a finite number of steps  $k_0$ , one obtains  $\tilde{s}_{e,k} = 0$  and  $s_{e,k} = h\varphi(x_{k+1}, t_{k+1})$  so that  $|s_{e,k}| < h\varphi_{\max}$  for all  $k \geq k_0$  for some finite  $k_0$ .

The next result characterizes the evolution of  $e_k$  on the sliding surface  $\tilde{s}_{e,k} = 0$ .

**Lemma 2** *Suppose that the sliding surface  $\tilde{\Sigma}_e = \{\tilde{s}_{e,k} \in \mathbb{R} \mid \tilde{s}_{e,k} = 0\}$  is attained at  $k = k_0$  and that the system stays on it. Take for simplicity  $k_0 = 0$ . Then:*

$$e_{k+1} = (1 + hk_e)^{-k-1}e_0 + h^2(1 + hk_e)^{-1} \sum_{i=0}^k (1 + hk_e)^{i-k} \varphi(x_i, t_i). \quad (43)$$

**Proof:** One has  $e_k = e_{k-1} + h\dot{e}_k$  and  $s_{e,k} = \dot{e}_k + k_e e_k$ . We infer that

$$e_k = (1 + hk_e)^{-1}e_{k-1} + (1 + hk_e)^{-1}h^2\varphi_{k+1} \quad (44)$$

from which (43) follows. ■

Notice that if we implement  $e_{k+1} = e_k + h\dot{e}_k$  then we obtain  $e_k = (1 - hk_e)e_{k-1} + h^2\varphi_k$  and similar calculations may be done, using the fact that for  $h > 0$  small enough  $0 < 1 - hk_e < 1$ . Therefore on the sliding surface the discrete-time error is the sum of an asymptotically vanishing term, plus a term that depends on the disturbance, attenuated by a factor  $h^2$ . The second part of the error dynamics in (40) is now discretized as follows:

$$\begin{cases} \tilde{s}_{x,k+1} = s_{x,k} - hk_e \dot{e}_k - hk_s s_{e,k} - hM_v \tau_{1,k+1} - hM_x \tau_{2,k+1} \\ \tau_{2,k+1} \in \text{sgn}(\tilde{s}_{x,k+1}) \\ s_{x,k+1} = s_{x,k} - hk_e \dot{e}_k - hk_s s_{e,k} - hM_v \tau_{1,k+1} - hM_x \tau_{2,k+1} + h\varphi(x_{k+1}, t_{k+1}) \\ x_{k+1} = x_k + h\dot{x}_{k+1} \end{cases} \quad (45)$$

Notice that if  $k \geq k_0$  then  $(1 - hk_s)s_{e,k} = hM_v \tau_{1,k+1}$  and  $s_{e,k} = h\varphi(x_{k+1}, t_{k+1})$ . For  $k > k_0$  the system evolves on the sliding surface  $\tilde{s}_{e,k} = 0$  and we obtain:

$$\begin{cases} \tilde{s}_{x,k+1} = s_{x,k} - h\varphi(x_{k+1}, t_{k+1}) - hM_x \tau_{2,k+1} \\ \tau_{2,k+1} \in \text{sgn}(\tilde{s}_{x,k+1}) \\ s_{x,k+1} = s_{x,k} - hk_e \dot{e}_k - hM_x \tau_{2,k+1} \end{cases} \quad (46)$$

From (43) we infer that  $hk_e \dot{e}_k = \epsilon_k + h^2\alpha_k$  where  $|\alpha_k| \leq \varphi_0 \sum_{i=0}^k (1 + hk_e)^{i-k-1}$  and  $\epsilon_k$  is exponentially decreasing since  $1 + hk_e > 1$ . It follows also that  $|\alpha_k|$  is upper bounded by a constant not depending on  $k$  and we may write  $|\alpha_k| \leq \alpha\varphi_{\max}$  for some constant  $\alpha$ . We therefore rewrite (46) as

$$\begin{cases} \tilde{s}_{x,k+1} = s_{x,k} - h\varphi(x_{k+1}, t_{k+1}) - hM_x \tau_{2,k+1} \\ \tau_{2,k+1} \in \text{sgn}(\tilde{s}_{x,k+1}) \\ s_{x,k+1} = s_{x,k} - \epsilon_k - h^2\alpha_k - hM_x \tau_{2,k+1}. \end{cases} \quad (47)$$

It is noteworthy that (47) is similar to (14) and to (4) except for the exponentially decaying term  $\epsilon_k$ . Thus the following holds, which shows that the disturbance effects are still attenuated by a factor  $h$ :

**Proposition 5** Consider the discrete-time system (47) that represents the system's dynamics on the sliding surface  $\tilde{\Sigma}_e = \{\tilde{s}_{e,k} \in \mathbb{R} \mid \tilde{s}_{e,k} = 0\}$ , i.e. for  $k \geq k_0$ . Suppose that  $M_x > \varphi_{\max}$ . There exists  $k_1 < +\infty$ ,  $k_1 > k_0$ , such that for all  $k \geq k_1$  one has  $\tilde{s}_{x,k} = 0$ . Then  $|s_{x,k+1}| \leq h\varphi_{\max} + |\epsilon_k| + h^2\alpha\varphi_{\max}$ .

**Proof:** The first part of the proof follows the same lines as the above proofs of finite-time convergences and is omitted. The second part follows easily from (47) by imposing  $\tilde{s}_{x,k+1} = 0$  and inserting the value of  $hM_x\tau_{2,k+1}$  into the third line of (47). ■

The next result characterizes the dynamics of  $x_k$  on the sliding surface  $\tilde{x}_k = 0$ . For simplicity we take  $k_1 = 0$  in Proposition 5.

**Lemma 3** Suppose that for  $k \geq 0$  the system evolves on the sliding surface  $\tilde{s}_{x,k} = 0$ , so that (neglecting terms in  $h^2$ )  $|s_{x,k+1}| \leq h\varphi_{\max} + |\epsilon_k|$ . Then

$$x_k = (1 + hk_x)^{-1}x_0 - h(1 + hk_x)^{-1} \sum_{i=0}^{k-1} (1 + hk_x)^{-i} (\epsilon_{k-1-i} + h^2\alpha_{k-1-i} + h\varphi_{k-i}). \quad (48)$$

**Proof:** From  $s_{x,k+1} = 0$  one easily derives:

$$x_{k+1} = (1 + hk_x)^{-1}x_k - h(1 + hk_x)^{-1}(\epsilon_k + h^2\alpha_k + h\varphi_{k+1}) \quad (49)$$

from which (48) is deduced. ■

The disturbance is therefore attenuated by a factor  $h^2$  on the state “position”  $x_k$ . Similarly to (21), using (1) we may rewrite the discrete-time closed-loop system as:

$$\begin{cases} s_{x,k+1} = s_{x,k} - hk_e\dot{e}_k - hk_s s_{e,k} - hM_v\tau_{1,k+1} - hM_x\tau_{2,k+1} + h\varphi(x_{k+1}, t_{k+1}) \\ s_{e,k+1} = s_{e,k} - hk_s s_{e,k} - hM_v\tau_{1,k+1} + h\varphi(x_{k+1}, t_{k+1}) \\ x_{k+1} = x_k + h\dot{x}_{k+1} \\ e_{k+1} = e_k + h\dot{e}_{k+1} \\ \tau_{1,k+1} = \text{proj}([-1, 1]; \frac{s_{e,k} - hk_s s_{e,k}}{hM_v}) \\ \tau_{2,k+1} = \text{proj}([-1, 1]; \frac{s_{x,k} - hk_e\dot{e}_k - hk_s s_{e,k} - hM_x\tau_{1,k+1}}{hM_x}). \end{cases} \quad (50)$$

One has also  $s_{e,k} = \dot{e}_k + k_e e_k$ ,  $s_{x,k} = \dot{x}_k + k_x x_k$ , so that  $x_{k+1} = (1 + hk_x)^{-1}(x_k + hs_{x,k+1})$  and  $e_{k+1} = (1 + hk_e)^{-1}(e_k + hs_{e,k+1})$ . The controller has a nested-projection structure and is easily implementable at time  $t = t_k$  with the knowledge of  $x_k$ ,  $x_{k-1}$  and  $e_k$ ,  $e_{k-1}$ .

### 3.2 Position feedback stabilization of a double integrator

Let us now pass to other types of sliding-mode discontinuous controllers which have been proposed in the literature, known as the twisting and super-twisting algorithms [11] [28, §3.6.2, 3.6.3]. They possess advantages (finite-time stability of the origin, better disturbance attenuation), however their stability analysis is more intricate.

### 3.2.1 Finite-time stabilizing state feedback synthesis

To begin with, we present a static feedback controller that globally stabilizes the double integrator:

$$\dot{x}(t) = y(t), \quad \dot{y}(t) = u(t). \quad (51)$$

A feedback law  $u(x, y)$  is further referred to as finite-time stabilizing if it renders the origin of the closed-loop system (51) a finite-time stable equilibrium as defined in [22]. The following state feedback

$$u = -\mu \operatorname{sgn}(y) - \nu \operatorname{sgn}(x) \quad (52)$$

with parameters  $\nu > \mu > 0$  is proposed to globally stabilize the double integrator (51).

**Theorem 1** *Consider the dynamics of the closed-loop system in (51) (52). This dynamics has a unique fixed point  $(x, y) = (0, 0)$  which is globally finite-time stable, provided that the controller parameters are such that  $\nu > \mu > 0$ .*

The proof may be found in the Example 3.2 and section 4.6 of [22]. Let us now consider the disturbance-corrupted version:

$$\dot{x}(t) = y(t), \quad \dot{y}(t) = u(t) + \varphi(x(t), y(t), t) \quad (53)$$

and investigate the robustness properties of the closed-loop system (52), (53) against external disturbances  $\varphi(x, y, t)$ , being a locally integrable function on all potential trajectories  $x(t), y(t)$ . According to [22, Theorem 4.2], the disturbed system in (52) (53) renders the system finite-time stable, regardless of whichever disturbance  $\varphi(\cdot)$  with a uniform upper bound

$$\operatorname{ess\,sup}_{t \geq 0} |\varphi(x(t), y(t), t)| \leq \varphi_{\max} \quad (54)$$

on its magnitude such that

$$0 < \varphi_{\max} < \mu < \nu - \varphi_{\max} \quad (55)$$

affects the system. This robustness property is achieved due to the high frequency controller switching in the sliding mode of the second order that occurs in the origin.

**Theorem 2** [22, Section 4.6] *Given  $\mu$  and  $\nu > 0$ , the closed-loop system in (52) (53) has a unique fixed point  $(x^*, y^*) = (0, 0)$  which is globally asymptotically finite-time stable, regardless of whichever disturbance  $\varphi(\cdot)$ , satisfying (54) and (55), affects the system.*

Let us propose the following implicit Euler time-discretization, where  $\varphi_{k+1} \triangleq \varphi(x_{k+1}, y_{k+1}, t_{k+1})$ :

$$\left\{ \begin{array}{l} \tilde{x}_{k+1} = x_k + h\tilde{y}_{k+1} \\ \tilde{y}_{k+1} = y_k - h\nu\tau_{1,k+1} - h\mu\tau_{2,k+1} \\ \tau_{1,k+1} \in \operatorname{sgn}(\tilde{x}_{k+1}) \\ \tau_{2,k+1} \in \operatorname{sgn}(\tilde{y}_{k+1}) \\ x_{k+1} = x_k + hy_{k+1} \\ y_{k+1} = y_k - h\nu\tau_{1,k+1} - h\mu\tau_{2,k+1} + h\varphi_{k+1}, \end{array} \right. \quad (56)$$

from which it follows applying (1) to the second and the fourth lines of (56) that

$$\tau_{2,k+1} = \text{proj}([-1, 1]; \frac{y_k - h\nu\tau_{1,k+1}}{h\mu}). \quad (57)$$

The discrete-time system in (56) is still constructed along the same lines as the ones in the foregoing sections: one computes the input from a nominal unperturbed system (the first four lines of (56)) and then one injects the computed input into the plant dynamics (the last two lines of (56)). However this time there is no decoupling between the  $\tilde{x}_k$ -dynamics and the  $\tilde{y}_k$ -dynamics. Let us now calculate the control input. One has  $\tilde{y}_{k+1} = y_k - h\nu\tau_{1,k+1} - h\mu\text{proj}([-1, 1]; \frac{y_k - h\nu\tau_{1,k+1}}{h\mu})$ . Therefore  $\tilde{y}_{k+1} = y_k - h\nu\tau_{1,k+1} - \text{proj}([-h\mu, h\mu]; y_k - h\nu\tau_{1,k+1})$ . Thus three “modes” are possible:

- **(i)** if  $y_k - h\nu\tau_{1,k+1} > h\mu$  one gets  $\tilde{y}_{k+1} = y_k - h\nu\tau_{1,k+1} - h\mu$ ,  $y_{k+1} = y_k - h\nu\tau_{1,k+1} - h\mu + h\varphi_{k+1}$  and  $\tilde{x}_{k+1} = x_k + h(y_k - h\nu\tau_{1,k+1}) - h^2\mu$ ,  $x_{k+1} = x_k + h(y_k - h\nu\tau_{1,k+1}) - h^2\mu + h^2\varphi_{k+1}$ . Also  $\tau_{1,k+1} = \frac{1}{h^2\nu}\text{proj}([-h^2\nu, h^2\nu]; x_k + hy_k - h^2\mu)$ ,  $\tau_{2,k+1} = 1$ .

There are three sub-modes:

- **(i-1)** let  $x_k + hy_k - h^2\mu > h^2\nu$ : then  $\tau_{1,k+1} = 1$ ,  $y_k > h(\nu + \mu)$ ,  $x_{k+1} = x_k + hy_k - h^2(\nu + \mu) + h^2\varphi_{k+1}$ ,  $y_{k+1} = y_k - h(\nu + \mu + \varphi_{k+1})$ .
- **(i-2)** let  $x_k + hy_k - h^2\mu < -h^2\nu$ : then  $\tau_{1,k+1} = -1$ ,  $y_k > h(\mu - \nu)$ ,  $x_{k+1} = x_k + hy_k + h^2(\nu - \mu) + h^2\varphi_{k+1}$ ,  $y_{k+1} = y_k + h(\nu - \mu + \varphi_{k+1})$ .
- **(i-3)** let  $|x_k + hy_k - h^2\mu| \leq h^2\nu$ : then  $x_k < 0$ ,  $\tau_{1,k+1} = \frac{x_k + hy_k - h^2\mu}{h^2\nu}$ ,  $x_{k+1} = h^2\varphi_{k+1}$ ,  $y_{k+1} = -\frac{x_k}{h} + h\varphi_{k+1}$ ,  $\tilde{x}_{k+1} = 0$ ,  $\tilde{y}_{k+1} = -\frac{x_k}{h}$ .

- **(ii)** if  $y_k - h\nu\tau_{1,k+1} < -h\mu$  one gets  $\tilde{y}_{k+1} = y_k - h\nu\tau_{1,k+1} + h\mu$ ,  $y_{k+1} = y_k - h\nu\tau_{1,k+1} + h\mu + h\varphi_{k+1}$  and  $\tilde{x}_{k+1} = x_k + h(y_k - h\nu\tau_{1,k+1}) - h^2\mu$ ,  $x_{k+1} = x_k + h(y_k - h\nu\tau_{1,k+1}) + h^2\mu + h^2\varphi_{k+1}$ . Also  $\tau_{1,k+1} = \frac{1}{h^2\nu}\text{proj}([-h^2\nu, h^2\nu]; x_k + hy_k + h^2\mu)$ ,  $\tau_{2,k+1} = -1$ .

There are three sub-modes:

- **(ii-1)** let  $x_k + hy_k + h^2\mu > h^2\nu$ : then  $\tau_{1,k+1} = 1$ ,  $y_k < h(\nu - \mu)$ ,  $x_{k+1} = x_k + hy_k - h^2(\nu - \mu - \varphi_{k+1})$ ,  $y_{k+1} = y_k + h(\nu - \mu - \varphi_{k+1})$ .
- **(ii-2)** let  $x_k + hy_k + h^2\mu < -h^2\nu$ : then  $\tau_{1,k+1} = -1$ ,  $y_k < -h(\nu + \mu)$ ,  $x_{k+1} = x_k + hy_k + h^2(\nu + \mu + \varphi_{k+1})$ ,  $y_{k+1} = y_k + h(\nu + \mu + \varphi_{k+1})$ .
- **(ii-3)** let  $|x_k + hy_k + h^2\mu| \leq h^2\nu$ : then  $\tau_{1,k+1} = \frac{x_k + hy_k + h^2\mu}{h^2\nu}$ ,  $x_{k+1} = h^2\varphi_{k+1}$ ,  $\tilde{x}_{k+1} = 0$ ,  $y_{k+1} = -\frac{x_k}{h} + h\varphi_{k+1}$ ,  $\tilde{y}_{k+1} = -\frac{x_k}{h}$ .

- **(iii)** if  $|y_k - h\nu\tau_{1,k+1}| \leq h\mu$  one gets  $\tilde{y}_{k+1} = y_k - h\nu\tau_{1,k+1} - (y_k - h\nu\tau_{1,k+1}) = 0$ ,  $y_{k+1} = h\varphi_{k+1}$  and  $x_{k+1} = x_k + h^2\varphi_{k+1}$ . Also  $\tau_{1,k+1} \in \text{sgn}(x_k)$ ,  $\tau_{2,k+1} = \frac{y_k - h\nu\tau_{1,k+1}}{h\mu}$ .

One sees that the controller  $(\tau_{1,k+1}, \tau_{2,k+1})^T$  is a causal input at time  $t = t_k$  and there is no singularity in  $\tau_{1,k+1}$  as  $h$  tends to zero. In **(i)** and **(ii)** the value for  $\tau_{1,k+1}$  is obtained from the generalized equation  $\tau_{1,k+1} \in \text{sgn}(x_k + hy_k - h^2\nu\tau_{1,k+1} - h^2\mu)$  and using (1). In all cases  $\tau_{2,k+1}$  is obtained from (57).

It is easily checked that  $(x^*, y^*) = (0, 0)$  is the unique fixed point of the unperturbed system (56) (take  $\varphi_{k+1} = 0$  in (56)). The next result holds.

**Lemma 4** Suppose  $\varphi_k \equiv 0$ . **(a)** Let  $|y_{k_0} - h\nu\tau_{1,k_0+1}| \leq h\mu$  and  $x_{k_0} = 0$  for some  $k_0 \geq 0$ . Then  $|y_k - h\nu\tau_{1,k+1}| \leq h\mu$  for all  $k \geq k_0$ , so that  $x_{k+1} = y_{k+1} = 0$  for all  $k \geq k_0$ . **(b)** If  $x_{k_0} = y_{k_0} = 0$  for some  $k_0 \geq 0$ , then  $x_k = y_k = 0$  and  $|y_k - h\nu\tau_{1,k+1}| \leq h\mu$  for all  $k > k_0$ .

**Proof:** **(a)** From **(iii)** above it follows that  $|y_{k_0} - h\nu\tau_{1,k_0+1}| \leq h\mu$  and  $x_{k_0} = 0$  imply  $y_{k_0+1} = x_{k_0+1} = 0$ . Therefore  $|y_{k_0+1} - h\nu\tau_{1,k_0+2}| = h\nu|\tau_{1,k_0+2}|$ . Now suppose that  $h\nu|\tau_{1,k_0+2}| > h\mu$ , one obtains from **(i)** and **(ii)** that  $\tau_{1,k_0+2} = \frac{1}{h^2\nu}\text{proj}([-h^2\nu, h^2\nu]; x_{k_0+1} + hy_{k_0+1} \pm h^2\mu) = \frac{1}{h^2\nu}\text{proj}([-h^2\nu, h^2\nu]; \pm h^2\mu) = \frac{\mu}{\nu}$  since  $\mu < \nu$ . So indeed  $|y_{k_0+1} - h\nu\tau_{1,k_0+2}| = h\mu$ , a contradiction. It follows that  $h\nu|\tau_{1,k_0+2}| \leq h\mu$  and therefore  $|y_{k_0+1} - h\nu\tau_{1,k_0+2}| \leq h\mu$  and  $x_{k_0+2} = y_{k_0+2} = 0$ . Now  $x_{k_0+2} = x_{k_0+1} = 0$ . We can repeat the reasoning at the next step and **(a)** is proved. **(b)** From  $x_k = y_k = 0$  we deduce that  $x_{k+1} = hy_{k+1}$  and  $y_{k+1} = -h\nu\tau_{1,k+1} - h\mu\tau_{2,k+1}$ . Also  $\tau_{1,k+1} \in \text{sgn}(-h\nu\tau_{1,k+1} - h\mu\tau_{2,k+1})$  from which we infer that  $\tau_{1,k+1} = \text{proj}([-1, 1]; -\frac{\mu}{\nu}\tau_{2,k+1})$  while  $\tau_{2,k+1} = \text{proj}([-1, 1]; -\frac{\nu}{\mu}\tau_{1,k+1})$ . Since  $\mu < \nu$  it follows that  $\tau_{1,k+1} = -\frac{\mu}{\nu}\tau_{2,k+1}$ . Also  $|\frac{\mu}{\nu}\tau_{1,k+1}| \leq 1$  so that  $|\tau_{1,k+1}| \leq \frac{\mu}{\nu} < 1$ . Hence since  $\tau_{1,k+1} \in \text{sgn}(x_{k+1})$  necessarily  $x_{k+1} = 0$ . From the fact that  $x_{k+1} = hy_{k+1}$  it follows that  $y_{k+1} = 0$ . The reasoning can be repeated at the next step. Furthermore it easily follows that  $|\tau_{1,k+1}| \leq \frac{\mu}{\nu}$  so part **(b)** is proved. ■

Lemma 4 says that (in the unperturbed case), once the system has reached the fixed point it stays on it without any spurious oscillations. This is an interesting property of implicit Euler schemes [1]. The lemma shows also that mode **(iii)** is the unperturbed system's mode at the equilibrium point. The following results characterize the disturbance attenuation on the nominal system sliding mode.

**Proposition 6** Suppose that  $\tilde{x}_{k+1} = 0$  and  $\tilde{y}_{k+1} = 0$ . Then  $y_{k+1} = h\varphi_{k+1}$  and  $x_{k+1} = h^2\varphi_{k+1}$ . Therefore  $|y_{k+1}| \leq h\varphi_{\max}$  and  $|x_{k+1}| \leq h^2\varphi_{\max}$ .

**Proof:** From the first line of (56) it follows that  $x_k = 0$ . From the third and last lines one has  $y_{k+1} = h\varphi_{k+1}$ . From the fifth line it follows that  $x_{k+1} = h^2\varphi_{k+1}$ . ■

There is however a major difference between (56) and the systems in the foregoing sections. Indeed the conditions of Proposition 6 can hold only at one time step. Assume that  $\tilde{x}_{k+1} = \tilde{y}_{k+1} = 0$ . Then  $x_{k+1} = h^2\varphi_{k+1}$  and  $y_{k+1} = h\varphi_{k+1}$ , so that  $\tilde{x}_{k+2} = x_{k+1} + h\tilde{y}_{k+2}$  implies  $\tilde{y}_{k+2} = -h\varphi_{k+1}$ . One must refine Proposition 6.

**Proposition 7** Suppose that  $\tilde{x}_{k+1} = 0$  for some  $k \geq 0$ . Then  $x_{k+1} = h^2\varphi_{k+1}$ . Moreover if  $\tilde{x}_{k+1} = 0$  for all  $k \geq 0$ , then  $y_{k+1} = h(\varphi_{k+1} - \varphi_k)$  and  $\sum_{k=1}^n y_k = h(\varphi_n - \varphi_0)$ , while  $\tilde{y}_{k+1} = -h\varphi_k$  for all  $k \geq 0$ .

**Proof:** Let  $\tilde{x}_{k+1} = 0$ . Then  $x_k = -h\tilde{y}_{k+1}$ . Thus  $-h\tilde{y}_{k+1} = x_k = -hy_k + h^2\nu\tau_{1,k+1} + h^2\mu\tau_{2,k+1}$ , so that  $x_k + hy_k = h^2\nu\tau_{1,k+1} + h^2\mu\tau_{2,k+1}$ . Thus  $x_{k+1} = x_k + hy_k - h^2\nu\tau_{1,k+1} - h^2\mu\tau_{2,k+1} + h^2\varphi_{k+1} = h^2\varphi_{k+1}$ . Now we have  $\tilde{x}_{k+1} = 0$  implies  $x_{k+1} = h^2\varphi_{k+1}$  and  $\tilde{x}_{k+2} = 0$  implies  $x_{k+2} = h^2\varphi_{k+2}$ . Thus  $x_{k+2} = x_{k+1} + hy_{k+1} = h^2\varphi_{k+1} + hy_{k+1} = h^2\varphi_{k+2}$  so that  $y_{k+1} = h(\varphi_{k+2} - \varphi_{k+1})$ . The



same can be done for the next step if  $\tilde{x}_{k+3} = 0$ . The sum immediately follows. Finally  $y_{k+1} = h(\varphi_{k+1} - \varphi_k) = \tilde{y}_{k+1} + h\varphi_{k+1}$  so that  $\tilde{y}_{k+1} = -h\varphi_k$ .  $\blacksquare$

Propositions 6 and 7 show that the disturbance attenuation holds for (56), however the nominal system's trajectories cannot slide along both  $\tilde{x}_k = 0$  and  $\tilde{y}_k = 0$ .

**Remark 2** *The differential inclusions in (3), (10), (41) and (52) (53) are written more compactly as:*

$$\begin{cases} \dot{z}(t) = Az(t) - B\tau(t) + \Phi(z(t), t) \\ \tau(t) \in \text{Sgn}(Cz(t)), \end{cases} \quad (58)$$

with obvious definitions of  $z$ ,  $A$ ,  $B$ ,  $C$  and  $\Phi(\cdot)$ . The results in [1] do not apply to (10), (41) and (52) (53) because the "input-output" condition  $PB = C^T$  with  $P = P^T > 0$  that is central in [1] is not satisfied for these systems. This means that the underlying maximal monotonicity arguments which allow one to draw conclusions about the convergence in [1], are absent in (10), (41) and (52) (53). The same applies to (53) (59) (64). Finally the twisting algorithm is more complex than (10) and (41) because it is the equilibrium that is reached in finite time, not a codimension one sliding surface that allows one to treat the problem as a two-stage problem.

### 3.2.2 Finite-time velocity observer design

The focus of the present study is on the stability analysis of the velocity observer of the supertwisting observer

$$\begin{cases} \dot{\hat{x}}(t) = \hat{y}(t) + k_1|x(t) - \hat{x}(t)|^{\frac{1}{2}}\text{sgn}(x(t) - \hat{x}(t)) + k_2(x(t) - \hat{x}(t)), \\ \dot{\hat{y}}(t) \in u(t) + k_3\text{sgn}(x(t) - \hat{x}(t)) + k_4(x(t) - \hat{x}(t)), \end{cases} \quad (59)$$

that was first proposed in [8] with  $k_2, k_4 = 0$  and is now augmented with non-trivial linear gains  $k_2, k_4 > 0$ . Clearly, the observation error  $e = (e_1 \ e_2)^T$ ,  $e_1 = x - \hat{x}$ ,  $e_2 = y - \hat{y}$  between the state of the double integrator (51) and that of the velocity observer (59) proves to be governed by the following second-order system

$$\begin{cases} \dot{e}_1(t) \in e_2(t) - k_1\sqrt{|e_1(t)|}\text{sgn}(e_1(t)) - k_2e_1(t) \\ \dot{e}_2(t) \in -k_3\text{sgn}(e_1(t)) - k_4e_1(t). \end{cases} \quad (60)$$

The following result is extracted from [21, 23].

**Theorem 3** *Given  $k_1, k_3 > 0$ ,  $k_2, k_4 \geq 0$ , the system (60) is globally finite-time stable.*

In the rest of this section, we carry out the subordination for the observer gains  $k_i$ ,  $i = 1, 2, 3, 4$  that ensures the robustness of the perturbed dynamics:

$$\begin{cases} \dot{e}_1(t) = e_2(t) - k_1\sqrt{|e_1(t)|}\text{sgn}(e_1(t)) - k_2e_1(t) \\ \dot{e}_2(t) = \varphi(x(t), y(t), t) - k_3\text{sgn}(e_1(t)) - k_4e_1(t). \end{cases} \quad (61)$$

As a matter of fact, this dynamics corresponds to the observation errors  $e = (e_1 \ e_2)^T$ ,  $e_1 = x - \hat{x}$ ,  $e_2 = y - \hat{y}$  between the state of the velocity observer (59) and that of the double integrator (53), affected by an admissible external disturbance.

**Theorem 4** *Let the system (61) be affected by a uniformly bounded disturbance (54). Furthermore, let the system gains be such that*

$$k_1, k_3 > 0, \quad k_2, k_4 \geq 0, \quad \text{if } k_4 = 0 \text{ then } k_2 = 0. \quad (62)$$

*Then the system (61) is globally finite-time stable whenever the upper bound  $\varphi_{\max}$  on the magnitude of the external disturbance  $\varphi(x, y, t)$  meets the condition*

$$\varphi_{\max} < \min\left\{\frac{k_1}{2}, \frac{k_1 k_3}{1 + k_1}\right\}. \quad (63)$$

The proof of Theorem 4 follows the same line of reasoning as that proposed in [21, 23] and it is therefore omitted.

### 3.2.3 Finite-time stabilizing position feedback synthesis

In this section, we proceed with the design of the position feedback, stabilizing the double integrator in finite time. For this purpose, we substitute the velocity estimate  $\hat{y}$  in the state feedback (52) for  $y$  and, if desired, augment the resulting control law with the term  $k_3 \text{sgn}(e_1)$  that compensates the disturbance  $w$  on the sliding manifold  $e_1 = e_2 = 0$ , to arrive at the finite-time stabilizing position feedback law:

$$u \in -\mu \text{sgn}(\hat{y}) - \nu \text{sgn}(x), \quad (64)$$

(or at that

$$u \in -\mu \text{sgn}(\hat{y}) - \nu \text{sgn}(x) - k_3 \text{sgn}(e_1) \quad (65)$$

with the disturbance compensating term). Then the closed-loop system (53) (59), driven by (64) (or by (65), respectively) proves to be globally finite-time stable regardless of whichever admissible disturbance affects the system.

**Theorem 5** *Let the system (53) be affected by a uniformly bounded disturbance (54) and let it be driven by the observer-based dynamic feedback (59) (64) (respectively (65)) with positive controller gains  $\mu, \nu$  subject to (55), and with observer parameters  $k_i$ ,  $i = 1, 2, 3, 4$ , satisfying conditions (62) (63). Then the closed-loop system (53) (59) (64) is globally finite-time stable.*

**Proof:** the closed-loop system (53) (59) (64) rewritten in terms of the observation error (61), meets the conditions of Theorem 4. By applying Theorem 4 to the observation error system (61), we conclude that starting from a finite time instant  $T$ , the closed-loop system evolves on the manifold  $e = 0$  where  $\hat{y} = y$ , thereby ensuring that the position control signal (64) coincides with the state feedback signal (52). To complete the proof it remains to apply Theorem 2 to (53) (59) (64) for  $t \geq T$  when the position feedback equals the state feedback.

The global asymptotic stability of the closed-loop system (53) (59) (64) is thus established. ■

The system in (53) (64) and (59) is discretized as follows:

$$\begin{cases} \tilde{x}_{k+1} = x_k + h\tilde{y}_{k+1} \\ \tilde{y}_{k+1} = y_k - h\mu\tau_{2,k+1} - h\nu\tau_{1,k+1} \\ \hat{x}_{k+1} \in \hat{x}_k + hk_1|x_k - \hat{x}_k|^{\frac{1}{2}}\text{sgn}(\tilde{x}_{k+1} - \hat{x}_{k+1}) + hk_2(\tilde{x}_{k+1} - \hat{x}_{k+1}) + h\hat{y}_{k+1} \\ \hat{y}_{k+1} \in \hat{y}_k - h\mu\tau_{2,k+1} - h\nu\tau_{1,k+1} + hk_3\text{sgn}(\tilde{x}_{k+1} - \hat{x}_{k+1}) + hk_4(\tilde{x}_{k+1} - \hat{x}_{k+1}) \\ x_{k+1} = x_k + hy_{k+1} \\ y_{k+1} = y_k - h\mu\tau_{2,k+1} - h\nu\tau_{1,k+1} + h\varphi_{k+1} \\ \tau_{1,k+1} \in \text{sgn}(\tilde{x}_{k+1}), \tau_{2,k+1} \in \text{sgn}(\hat{y}_{k+1}) \end{cases} \quad (66)$$

**Lemma 5** *The unperturbed discrete-time multivalued system (66) possesses the unique equilibrium point  $(\tilde{x}^*, \tilde{y}^*, \hat{x}^*, \hat{y}^*, x^*, y^*)^T = (0, 0, 0, 0, 0, 0)^T$ .*

**Proof:** recall that in the unperturbed case we may consider that  $\tilde{x}_k = x_k$  and  $\tilde{y}_k = y_k$  for all  $k$ . From the first line of (66) it follows that  $x^* = x^* + hy^* \Rightarrow y^* = 0$ . From the second line one has  $y^* = y^* - h\mu\tau_2^* - h\nu\tau_1^*$ , so that  $\mu\tau_2^* + \nu\tau_1^* \ni 0 \Leftrightarrow 0 \in \text{sgn}(x^*) + \frac{\nu}{\mu}\text{sgn}(\hat{y}^*)$  which is satisfied if and only if  $x^* = \hat{y}^* = 0$  because  $\nu > \mu$  from (55). From the third line  $\hat{x}^* = \hat{x}^* + hk_1\sqrt{|x^* - \hat{x}^*|}\text{sgn}(x^* - \hat{x}^*) + hk_2(x^* - \hat{x}^*) + h\hat{y}^*$  which is equivalent to  $0 \in k_1\sqrt{|x^* - \hat{x}^*|}\text{sgn}(x^* - \hat{x}^*) + k_2(x^* - \hat{x}^*)$ . The unique solution of this generalized equation is  $x^* = \hat{x}^*$ , therefore  $\hat{x}^* = 0$ . ■

Notice from the fourth and seventh lines of (66) that

$$\tau_{2,k+1} = \text{proj}([-1, 1]; \frac{\frac{\hat{y}_k}{h} - \nu\tau_{1,k+1} + k_3\text{sgn}(\tilde{x}_{k+1} - \hat{x}_{k+1}) + k_4(\tilde{x}_{k+1} - \hat{x}_{k+1})}{\mu}) \quad (67)$$

where (1) has been used. Similarly to the twisting algorithm we may determine three main modes for (66):

- (i) if  $\frac{\hat{y}_k}{h} - \nu\tau_{1,k+1} + k_3\text{sgn}(\tilde{x}_{k+1} - \hat{x}_{k+1}) + k_4(\tilde{x}_{k+1} - \hat{x}_{k+1}) \geq \mu$ :  $\tau_{2,k+1} = 1$ ,  $\tau_{1,k+1} = \text{proj}([-1, 1]; \frac{y_k - h\mu + \frac{x_k}{h}}{h\nu})$ ,  $\tilde{y}_{k+1} = y_k - h\mu - h\nu\text{proj}([-1, 1]; \frac{y_k - h\mu + \frac{x_k}{h}}{h\nu})$ ;
- (ii) if  $h\frac{\hat{y}_k}{h} - \nu\tau_{1,k+1} + k_3\text{sgn}(\tilde{x}_{k+1} - \hat{x}_{k+1}) + k_4(\tilde{x}_{k+1} - \hat{x}_{k+1}) \leq -\mu$ :  $\tau_{2,k+1} = -1$ ,  $\tau_{1,k+1} = \text{proj}([-1, 1]; \frac{y_k + h\mu + \frac{x_k}{h}}{h\nu})$ ,  $\tilde{y}_{k+1} = y_k + h\mu - h\nu\text{proj}([-1, 1]; \frac{y_k + h\mu + \frac{x_k}{h}}{h\nu})$ ;
- (iii) if  $|\frac{\hat{y}_k}{h} - \nu\tau_{1,k+1} + k_3\text{sgn}(\tilde{x}_{k+1} - \hat{x}_{k+1}) + k_4(\tilde{x}_{k+1} - \hat{x}_{k+1})| < \mu$ : then one obtains  $\tau_{2,k+1} = \frac{\frac{\hat{y}_k}{h} - \nu\tau_{1,k+1} + k_3\text{sgn}(\tilde{x}_{k+1} - \hat{x}_{k+1}) + k_4(\tilde{x}_{k+1} - \hat{x}_{k+1})}{\mu}$ ; let  $\alpha = \frac{1 + h^2k_4 + hk_2}{h^2k_3 + hk_1|x_k - \hat{x}_{k+1}|^{\frac{1}{2}}}$  and  $\beta = \frac{x_k - \hat{x}_k + hy_k}{h^2k_3 + hk_1|x_k - \hat{x}_{k+1}|^{\frac{1}{2}}}$ , then  $\tilde{x}_{k+1} - \hat{x}_{k+1} = \frac{1}{\alpha}(\beta - \text{proj}([-1, 1]; \beta))$ ; finally  $\tau_{1,k+1} = \text{proj}([-1, 1]; \frac{x_k + hy_k - h\mu\tau_{2,k+1}}{h\nu})$ ;

The decomposition into sub-modes becomes cumbersome and is not done here for the sake of paper's brevity. To provide an idea on how this works let us calculate  $\hat{x}_{k+1}$  in a sub-mode of mode (i). Let us consider (i-1) such that  $y_k - h\mu + \frac{x_k}{h} > h\nu$ . Then  $\tau_{1,k+1} = 1$ . The condition for the activation of mode

(i) thus boils down to  $\frac{\hat{y}_k}{h} - \nu + k_3 \text{sgn}(\tilde{x}_{k+1} - \hat{x}_{k+1}) + k_4(\tilde{x}_{k+1} - \hat{x}_{k+1}) \geq \mu$ , which is equivalent to  $k_3 \text{sgn}(\tilde{x}_{k+1} - \hat{x}_{k+1}) + k_4(\tilde{x}_{k+1} - \hat{x}_{k+1}) > \mu + \nu - h\hat{y}_k \Leftrightarrow \tilde{x}_{k+1} - \hat{x}_{k+1} > \max(0, \frac{\hat{y}_k + \mu + \nu - k_3}{k_4})$ . Then  $\hat{x}_{k+1} = \hat{x}_k + hk_1|x_k - \hat{x}_k|^{\frac{1}{2}} + hk_2(\tilde{x}_{k+1} - \hat{x}_{k+1}) + h\hat{y}_{k+1}$ . Since  $\tau_{2,k+1} = 1$  we have  $\tilde{x}_{k+1} = x_k + h(y_k - h\mu - h\nu) > 0$  so that  $\hat{x}_{k+1} = \hat{x}_k + hk_1|x_k - \hat{x}_k|^{\frac{1}{2}} + hk_2(x_k + hy_k - h^2\mu - h^2\nu) - hk_2\hat{x}_{k+1} + h\hat{y}_{k+1}$ , and  $\hat{y}_{k+1} = \hat{y}_k - h\mu - h\nu + hk_3 + hk_4(\tilde{x}_{k+1} - \hat{x}_{k+1})$ . Hence

$$(1 + hk_2 + h^2k_4)\hat{x}_{k+1} = \hat{x}_k + hk_1|x_k - \hat{x}_k|^{\frac{1}{2}} + h(k_2 + hk_4)x_k - h^2(h^2k_4 + hk_2 + 1)(\mu + \nu) + h^2(k_2 + hk_4)y_k + h\hat{y}_k. \quad (68)$$

The computation of  $\hat{y}_{k+1}$  is done in the same way, showing that the discrete-time observer dynamics (the third, fourth and seventh lines of (66)) is causal. Similar calculations may be done for the sub-modes (i-2):  $y_k - h\mu + \frac{x_k}{h} < -h\nu$ , (ii-1):  $y_k + h\mu + \frac{x_k}{h} > h\nu$ , (ii-2):  $y_k + h\mu + \frac{x_k}{h} < -h\nu$ , and so on. Let us now prove that the disturbance attenuation holds on the nominal system sliding mode:

**Lemma 6** *Suppose that  $\tilde{x}_{k+1} = 0$ , then  $x_{k+1} = h^2\varphi_{k+1}$ . If  $\tilde{x}_{k+n} = 0$  for all  $n \geq 1$  then  $y_{k+n+1} = h(\varphi_{k+n} - \varphi_{k+n-1})$ .*

**Proof:** From (66) it follows that  $\tilde{x}_{k+1} = 0 \Rightarrow \tilde{y}_{k+1} = \frac{-x_k}{h}$ . Thus  $-\frac{x_k}{h} = y_k - h\mu\tau_{2,k+1} - h\nu\tau_{1,k+1}$ , so that  $y_{k+1} = y_k - \frac{x_k}{h} - y_k + h\varphi_{k+1} = -\frac{x_k}{h} + h\varphi_{k+1}$ . Thus  $x_{k+1} = x_k - h\frac{x_k}{h} + h^2\varphi_{k+1} = h^2\varphi_{k+1}$ . The second part of the lemma follows easily. ■

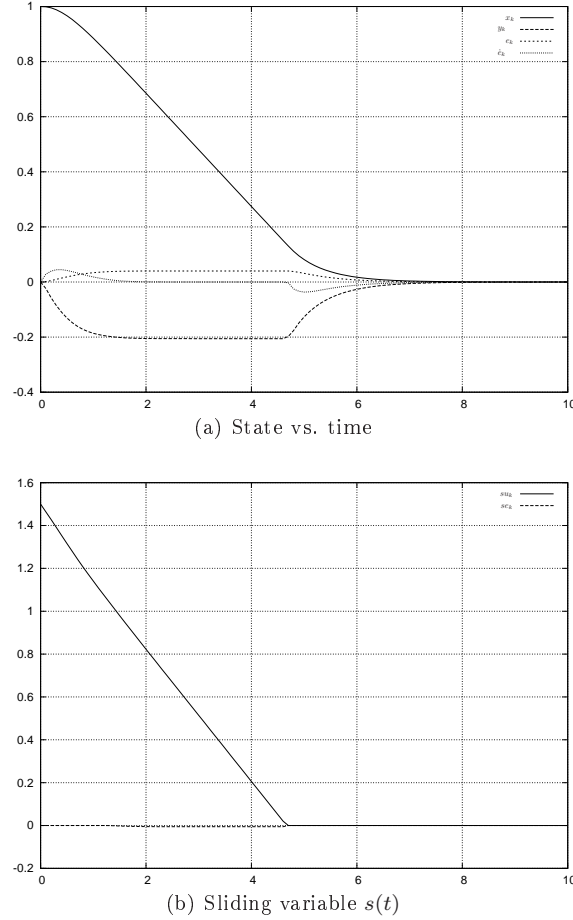
**Remark 3 (Twisting controllers implementation)** *For both the twisting (section 3.2.1) and the super-twisting (section 3.2.3) controllers, we have shown that in all cases the inputs  $\tau_{1,k+1}$  and  $\tau_{2,k+1}$  can be computed from the knowledge of the state values at  $t = t_k$  only. In practice the controller may be computed as follows. Let  $z_k \triangleq (\tilde{x}_k \tilde{y}_k \hat{x}_k \hat{y}_k)^T$  and  $\tau_k \triangleq (\tau_{1,k} \tau_{2,k})^T$ . Then the first four lines in (66) are rewritten compactly as:*

$$\begin{aligned} z_{k+1} &= hFz_{k+1} + Gz_k - hB\tau_{k+1} + hH(z_k)\text{Sgn}(Cz_{k+1}) \\ &\quad \Downarrow \\ z_{k+1} &= (I_4 - hF)^{-1}[Gz_k - hB\tau_{k+1} + hH(z_k)\text{Sgn}(Cz_{k+1})] \\ &\quad \Downarrow \\ z_{k+1} &= (I_4 - hF)^{-1}[Gz_k + h \begin{pmatrix} -B & H(z_k) \end{pmatrix} \text{Sgn}(Dz_{k+1})] \end{aligned} \quad (69)$$

where the matrices  $F$ ,  $G$ ,  $H(\cdot)$ ,  $B$ ,  $C$ ,  $D$  can be easily identified from (66). The generalized equation (69) with unknown  $z_{k+1}$  may be solved at each step using a specific iterative solver like those implemented in the software package SICONOS [1, 2, 3] (on Figure 1 this is the “generalized equation solver” block). In the simulations of this paper Lemke’s algorithm has been used. The control algorithms presented in this paper can therefore easily be implemented on-line. The same applies to (56).

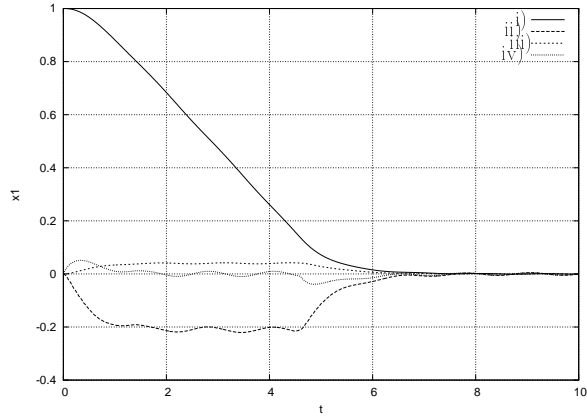
### 3.3 Numerical simulations

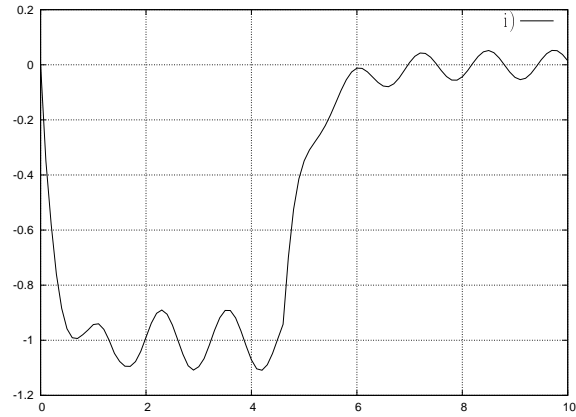
Figure 5: Simulation of (50) with  $\varphi(t) = 0$ .

The system in (50) is simulated with  $\varphi = \varphi(t)$  under the same conditions as those of section 2.4, with the software package SICONOS. With  $\varphi(t) \equiv 0$ , the results are depicted on Figure 5. With  $\varphi(t) = \phi \sin(\omega t)$   $\phi = 0.1$ ,  $\omega = 5$ , the

results are depicted on Figure 6. We have chosen  $k_e = k_s = 5$ ,  $k_x = 1.5$ ,  $M_x = 1$ ,  $M_v = 2$ . On Figure 6(c) and 6(d), since  $\tau_{1,k}$  and  $\tau_{2,k}$  are inside  $(-1; 1)$ , one notices that the sliding surfaces  $s_e = 0$  and  $s_x = 0$  are reached in finite time as expected from Proposition 4.

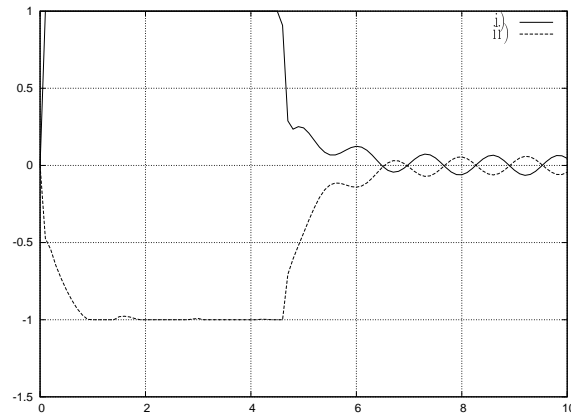

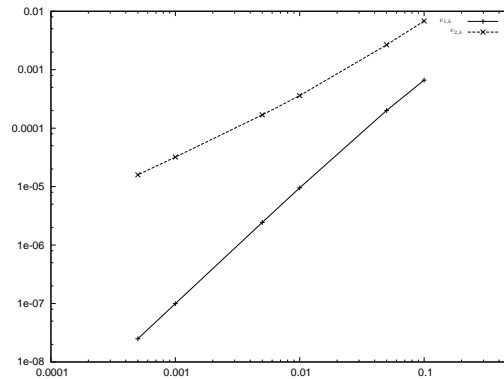


Figure 8: Double logarithmic plot of the attenuation of the disturbance with respect to the sampling time.

The system in (66) is simulated with  $\varphi = \varphi(t)$  with the same condition except for the sampling time chosen as  $h = 10^{-2}$ . The initial conditions are  $x_0 = 2, y_0 = 6, \hat{x}_0 = 1, \hat{y}_0 = 1$ . We have chosen  $\mu = 1, \nu = 2$  and  $k_1 = k_2 = k_3 = k_4 = 5$ . With  $\varphi(t) = \phi \sin(\omega t)$   $\phi = 0.1, \omega = 5$ , the results are depicted on Figure 7. On Figure 7(d), one notices again that the sliding surfaces are reached in finite time as expected in Theorem 5. The attenuation is shown on Figure 8 and we notice that  $e_{1,k} = \mathcal{O}(h^2)$  and  $e_{2,k} = \mathcal{O}(h)$ . It is worth noting that the origin is attained after an infinite number of events (the switches of the sign functions) in the continuous-time twisting controllers. This can be seen on Figures 7(b) and 7(d). Despite we have no convergence proof for the discrete-time solutions of the twisting algorithms, it is known that a very nice feature of backward Euler time-stepping methods is that they can handle accumulations



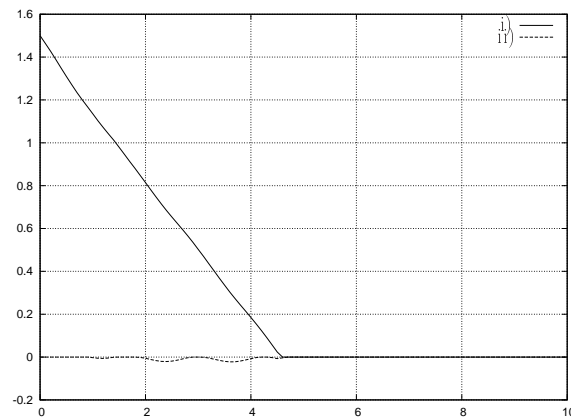

(c) Multiplier vs. time: i)  $\tau_{1,k}$ , ii)  $\tau_{2,k}$



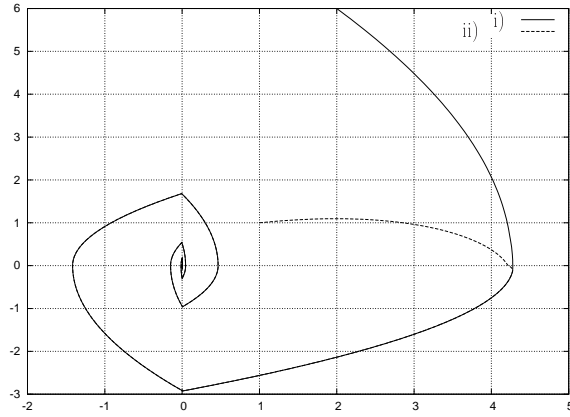
of events (Zeno phenomena), see *e.g.* [2, Chapters 1 and 10]. For this reason they are sometimes called *event-capturing* methods.

## 4 Conclusion

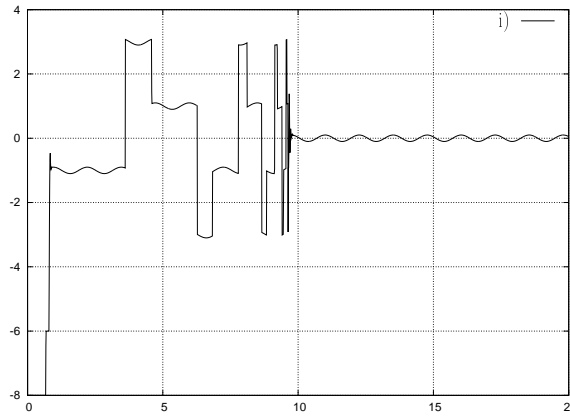
In this paper a novel discrete-time implementation of sliding-mode controllers is proposed. It is based on an implicit Euler method, and also applies to the zero-order holder discretization. The controllers are simple and take the form of projections on the interval  $[-1, 1]$ , or may be computed from simple quadratic programs. Most importantly the discrete-time controllers are able to represent the intrinsic multivalued feature of their continuous-time counterparts hence avoiding fast switches and high-gain behaviours. The analysis shows that a smooth stabilization on the sliding surfaces is obtained in the case there is no disturbance (chattering-free controllers), while when a disturbance is present its effects are attenuated by factors  $h$  or  $h^2$ . These properties are independent of the sampling period magnitude, which can be large. The controller has the nice property that the continuous-time and the discrete-time sliding surfaces are the same. Many simulation results illustrate the theory. Future works should concern the proof of convergence to the origin in a finite number of steps for the discrete-time twisting and super-twisting algorithms (as a complement to the numerical simulations presented in this paper), the extension towards other sliding-mode controllers (like systems with mismatched uncertainties), the numerical study of some optimal control problems that take the form of nonlinear variable-structure systems [6], and experimental comparisons with existing solutions for chattering reduction [5].

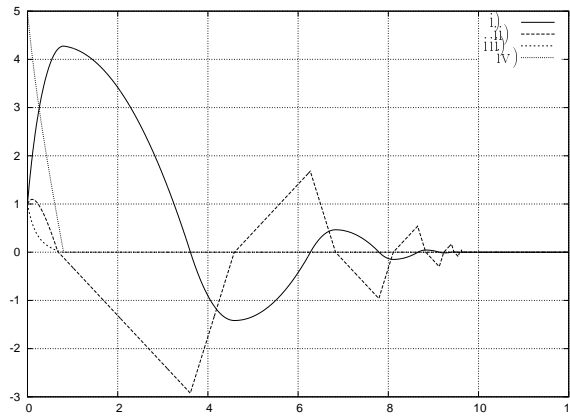

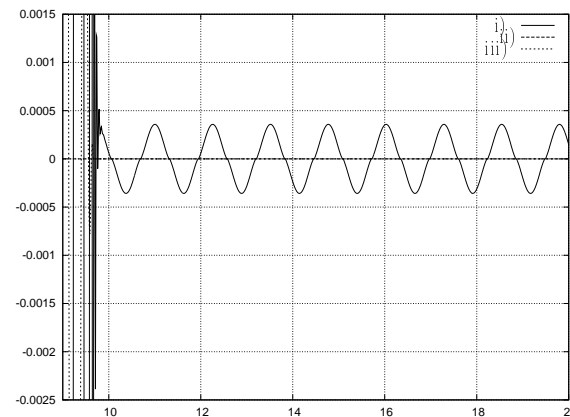
