1.1 Temporaldocuments

A specific characteristic of all audiovisual docume nts is their temporal dimension. This temporal dimensionhastwosides:themulti-layeredaspecto fdocuments,andtheirstructuralaspect.

The most basi Eachlayercontainstemporalinformationconcerning c layer is the shot layer, which is basically the segmentation of the audiovis ual data into a set of discrete temporal objects. Shots are usually considered as the smallest syntac ticunits of film language [2]. Shots maybedefinedaswhatisfilmedduringonerunof thecamera, withoutedit. However, amost interest ing information for indexing and understanding document s is the transition between shots. A cut means a brutal transition between two shots: the last image of the first shot is immediately followed by the f irst image of the second one. It can therefore be repres ented as a temporal objet with no duration (an even t). Gradualtransitions, such as a fade(inor out), dissolve, etc, are represented as standard temporal objects intertwinedbetweentwoshotobjects. Other typical layers are: the dialog layer for repr esenting dialogs between characters. Yet another la yer

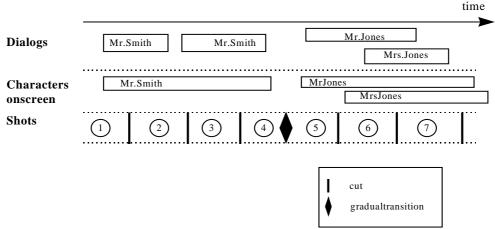


Figure 1: example of multi-layered description

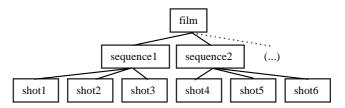


Figure 2: hierarchical structure

Usually, TV researchers know more about documents, and can classify them into document types: for instance, the newscast of CNN at 8pm, specific sitc oms, variety shows, western movies, etc. Within one specific document type, documents share several cha racteristics, such as film sets, news readers, or t he organization of shots or sequences overtime. Fore xample, the temporal structure of some particularn ews programs could be described in general as an alternation of in sets sequences and report sequences, where in sets sequences are composed for example of still shots (no camera motion) of the news reader (sayMr.Smith)separatedbycuts, with the logo of the channel in the top right corner of the screen.

1.1.3 Thetaxonomyoffilmevents

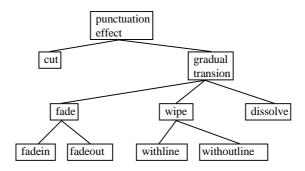


Figure 3: taxonomy of punctuation effects

If we consider only subsets of the taxonomy where r ole fillers can be automatically extracted from the signal(ascolorhistograms)itisimportanttonot icethatsomepartsofthistaxonomyareentirelym with *primitive* concepts, i.e. that no classification process can assign to an instance a position in the hierarchy. In the example above, an algorithm may d etect a shot transition as a gradual transition, and thenrefinethedescriptionto fade in . However, concerning for example camera motions, a nalgorithmis unlikelytoclassifyacameramotionas pan, and then refine the description to panright.

1.1.4 Classification of temporal segments

2.1 DescriptionLogicsandtemporalclassification

Description logics are knowledge representation lan guages; they allow to represent knowledge in a structuredwaybyseparatingdefinitionsof concepts(terminological representation systemor description of *individuals* (assertional representation system or Abox). Concepts are sets of individuals and roles represent binary relations between individuals. Co ncepts and roles descriptions are organized in hierarchies with the subsumption relation [6]. Several description logics systems a reavailable; the ideas proposedinthispaperareimplementedwiththeCLA SSICsystem[7]. Variousworkshavebeenconductedtoclassifytempo ralstructures, mainlyinthefield of planrecogni tion. [8] and [9] propose to extend the notion of subsump tion to plans, while [10] propose a formal language for reasoning about time and action. However, these results are difficult to apply in our context beca use mporal structure of type documents. This temporal we have only partial descriptions of the general te structureismadeofwithseveral«plans»whicho nlyapplylocallyonaportionofthedocument.Thu s,it is not known a priori what segments may intervene in what plan. Moreover , some segments may participateinseveralplansatonce.

2.2 Filmeventsasconcepts

It is natural to represent film events in our taxon omy as concepts in the sense of description logics. For instance, the concepts of a shot of the news reader in the example illustrated by the Figure 1 may represented by a CLASSIC concept as follows:

2.3.3 Astrategyforgroupingsegments

The principle of grouping presented here is based on the rule-based mechanism of fered by CLASSIC. In CLASSIC, it is possible to associate rules to a continuous cept definition. These rules are triggered each time an instance of this concept is created. XXXTudis 2 for islamê mephrase...

When an instance anof the concept Aiscreated, the rule is triggered. In our case, for the rule ARB à G, the rule consist in searching all instances big of the concept B such that big Ra. a and big are then grouped

together in a new in stance of G.

3. Conclusion

We have defined the problem of indexing audiovisual documents, and have shown that it involves classifying temporal structures using multi-layered information. The classification problem is made ev more complex by the fact that only subsets of the i nitial temporal structures must be classified, and that these subsets are not known apriori.

We have presented a method in the framework of desc audiovisualdocuments by expressing temporal struct implementation with CLASSIC of the ideas expressed approach on small examples. Some work is left to d rules, and ensuring that the approach may be used o
