Improving convergence in numerical analysis using observers

The wave-like equation case

Abstract

We propose an observer-based approach to circumvent the issue of unbounded approximation errors – with respect to the length of the time window considered – in the discretization of wave-like equations in bounded domains, which covers the cases of the wave equation *per se* and of linear elasticity as well as beam, plate and shell formulations, and so on. Namely, taking advantage of some measurements available on the system over time, we adopt a strategy inspired from sequential data assimilation and by which the discrete system is dynamically corrected using the discrepancy between the solution and the measurements. In addition to the classical cornerstones of numerical analysis made up by *stability and consistency*, we are thus led to incorporating a third crucial requirement pertaining to *observability* – to be preserved through discretization. The latter property warrants exponential stability for the corrected dynamics, hence provides bounded approximation errors over time. Special care is needed to establish the required observability at the discrete level, in particular due to the fact that we focus on an original observer method adapted to measurements of the main variable, whereas measurements of the time-derivative – admissible, of course, albeit less frequent in practical systems – lead to a stability analysis in which existing results can be more directly applied. We also provide some detailed application examples with several such wave-like equations, and the corresponding numerical assessments illustrate the performance of our approach.

1 Introduction

The numerical analysis of evolution partial differential equations is a well-established field, in particular as regards second-order problems in the time variable – see e.g. [9, 24] – such as “wave-like” equations in bounded domains, which covers the cases of the wave equation *per se* and of linear elasticity as well as beam, plate and shell formulations, and so on. In this context, it is well-known that, not only the error estimates derived in numerical analysis, but also the *actual errors* observed in numerical experiments frequently suffer from a steady deterioration over time – even when only spatial semi-discretization is considered – rendering the numerical solution virtually useless beyond a rather limited time range. Concurrently, it should be noted that these classical discretization procedures heavily rely on the accurate knowledge of the initial condition – a rather strong assumption – as the only type of information at hand on the solution. However, in many instances of actual systems a more reasonable assumption is instead that a limited accuracy prevails on the initial condition, albeit some measurements are also available on the solution of interest at subsequent times, e.g. measured values in a specific subset of the domain with a given time sampling. The key idea in this paper is to take advantage of such measurements in order to circumvent the above difficulty of unbounded error estimates over time.

To that purpose, we adopt an *observer* approach, namely, we incorporate in the system a consistent perturbation based on the discrepancy between the solution and the measurements.

This type of methodology, introduced in the 60’s in the control community with the pioneering “Luenberger observers” [16] – and later developed somewhat independently in engineering under the “nudging” terminology – was primarily devised in the framework of state estimation to cope with uncertain initial conditions, and relies on the idea that a well-chosen such perturbation may stabilize the system dynamics. As a consequence the estimation error which follows the stabilized dynamics can effectively converge to zero. These methods were initially proposed for systems of rather limited sizes, and indeed only much more recently have they been considered for infinite-dimensional systems modeled by PDEs and their discretizations under the impetus of *data assimilation* [18, 1], as an effective alternative to sequential methods based on optimization principles – in particular the Kalman filter or various methods derived thereof – which are not easily suited to such systems due to the “curse of dimensionality” coined by R.E. Bellman.

In our case, we also aim at exploiting the stabilization principle underlying the concept of observers, albeit here in order to tackle consistency errors arising from the discretization rather than – or in addition to – initial condition errors usually considered in data assimilation. Therefore we will undertake the complete numerical analysis of the “closed-loop” observer system for wave-like equations and show that – under some natural observability conditions – we can obtain error estimates that no longer deteriorate with the simulation duration, thereby providing a dramatic improvement over direct discretizations of the original system. As our strategy will crucially rely on the analysis of the discrete error equations – for which the continuous counterpart is a stabilized equation as already mentioned – we will be able to benefit from earlier works on the numerical analysis of stabilized systems and the preservation of uniform stability at the discrete level [10, 11]. Indeed, to the classical cornerstones of numerical analysis formed by *stability* and *consistency*, we add an *observability* condition associated with the data employed and required to ensure the enhanced stability in the observer, including at the discrete level. However, stabilization terms considered in earlier works are mainly based on time-derivatives of the equation unknown – i.e. velocity-like quantities – hence the corresponding observers require measuring the same type of quantities. Here, we rather focus on direct (although partial) measurements of the unknown itself, in a context where time-differentiating the data should be avoided because of measurement errors – which is frequently the case in practice – and our preferred observer method is the so-called “Schur Displacement Feedback” proposed in [19]. The resulting error equation is then rather non-standard and necessitates some further analysis.

The outline of the paper is as follows. In Section 2 we introduce the problem setting and state our main error estimation result (Theorem 1). Section 3 is then devoted to establishing the required discrete observability property, while in Section 4 we complete the proof of Theorem 1 by deriving and analyzing the discrete system obeyed by the approximation error. Next, in Section 5 we demonstrate the potential of our approach on application examples concerning the wave equation, with numerical assessments given in space dimensions 1 and 2, before turning our attention to beam and plate models in Section 6.

2 Problem setting and main result

Let \mathcal{H} be a Hilbert space of inner product and associated norm denoted by $\langle \cdot, \cdot \rangle$ and $\|\cdot\|$, respectively. Let $A_0 : \mathcal{D}(A_0) \rightarrow \mathcal{H}$ be a self-adjoint, definite positive operator with compact resolvent. We consider the following system

$$\begin{cases} \ddot{w}(t) + A_0 w(t) = 0, & t > 0 \\ w(0) = w_0, & \dot{w}(0) = w_1 \end{cases} \quad (1)$$

which we refer to as a “wave-like system”. Let \mathcal{Z} be another Hilbert space and let $H_0 \in \mathcal{L}(\mathcal{D}(A_0^{\frac{1}{2}}), \mathcal{Z})$ defining the following output function

$$z(t) = H_0 w(t). \quad (2)$$

DEFINITION 1

System (1)-(2) is exactly observable in time $T > 0$ if there exists $k_T > 0$ such that any solution of (1) for $(w_0, w_1) \in \mathcal{D}(A_0) \times \mathcal{D}(A_0^{\frac{1}{2}})$ satisfies

$$\int_0^T \|H_0 w(t)\|_{\mathcal{Z}}^2 dt \geq k_T \left(\|A_0^{\frac{1}{2}} w_0\|^2 + \|w_1\|^2 \right). \quad (3)$$

System (1)-(2) is said to be exactly observable if there exists any $T > 0$ so that (1)-(2) is exactly observable in time T .

Denoting $x(t) = \begin{pmatrix} w(t) \\ \dot{w}(t) \end{pmatrix}$, we can rewrite (1) as the first-order system

$$\begin{cases} \dot{x}(t) = Ax(t), & t > 0 \\ x(0) = x_0, \end{cases} \quad (4)$$

where $A : \mathcal{D}(A) \rightarrow \mathcal{X}$ with

$$\mathcal{D}(A) = \mathcal{D}(A_0) \times \mathcal{D}(A_0^{\frac{1}{2}}), \quad \mathcal{X} = \mathcal{D}(A_0^{\frac{1}{2}}) \times \mathcal{H}, \quad A = \begin{pmatrix} 0 & I \\ -A_0 & 0 \end{pmatrix},$$

and $x_0 = \begin{pmatrix} w_0 \\ w_1 \end{pmatrix}$. Moreover, we define $H \in \mathcal{L}(\mathcal{X}, \mathcal{Z})$ by

$$H = \begin{pmatrix} H_0 & 0 \end{pmatrix}, \quad (5)$$

and H is called the observation operator.

The essential aim of this paper is to show that when discretizing (1) we can obtain better convergence properties if we use the measurements of the system state corresponding to (2), via an adequate observer methodology. In order to state this result precisely we now introduce some definitions and notation. Assume that there exists a family $(\mathcal{V}_h)_{h>0}$ of finite dimensional subspaces of $\mathcal{D}(A_0^{\frac{1}{2}})$ such that for some $\theta > 0$ and $h^* > 0$, we have for every $h \in (0, h^*)$

$$\|\varphi_h\|_{\mathcal{D}(A_0^{\frac{1}{2}})} \leq Ch^{-1} \|\varphi_h\|, \quad \forall \varphi_h \in \mathcal{V}_h, \quad (6)$$

$$\|\pi_h \varphi\|_{\mathcal{D}(A_0^{\frac{1}{2}})} \leq C \|\varphi\|_{\mathcal{D}(A_0^{\frac{1}{2}})}, \quad \forall \varphi \in \mathcal{D}(A_0^{\frac{1}{2}}), \quad (7)$$

$$\|\pi_h \varphi - \varphi\| \leq Ch^\theta \|\varphi\|_{\mathcal{D}(A_0^{\frac{1}{2}})}, \quad \forall \varphi \in \mathcal{D}(A_0^{\frac{1}{2}}), \quad (8)$$

$$\|\pi_h \varphi - \varphi\|_{\mathcal{D}(A_0^{\frac{1}{2}})} \leq Ch^\theta \|\varphi\|_{\mathcal{D}(A_0)}, \quad \forall \varphi \in \mathcal{D}(A_0), \quad (9)$$

$$\|\tilde{\pi}_h \varphi - \varphi\| \leq Ch^\theta \|\varphi\|_{\mathcal{D}(A_0^{\frac{1}{2}})}, \quad \forall \varphi \in \mathcal{D}(A_0^{\frac{1}{2}}), \quad (10)$$

$$\|\tilde{\pi}_h \varphi - \varphi\|_{\mathcal{D}(A_0^{\frac{1}{2}})} \leq Ch^\theta \|\varphi\|_{\mathcal{D}(A_0)}, \quad \forall \varphi \in \mathcal{D}(A_0), \quad (11)$$

where π_h and $\tilde{\pi}_h$ are the orthogonal projectors onto \mathcal{V}_h with respect to the inner products of \mathcal{H} and $\mathcal{D}(A_0^{\frac{1}{2}})$, respectively, and with C denoting a generic strictly positive constant independent of h . Note that (6) is a standard inverse inequality, while (8) and (11) represent usual interpolation properties of projection operators for finite element spaces. As regards (7) and (9), they would typically be established by using the inverse inequality (6), whereas (10) would be proven by a duality argument “à la Aubin-Nitsche” assuming some regularity on the domain. Now, defining $A_{0h} \in \mathcal{L}(\mathcal{V}_h)$ by

$$\langle A_{0h}\varphi_h, \psi_h \rangle = \langle A_0^{\frac{1}{2}}\varphi_h, A_0^{\frac{1}{2}}\psi_h \rangle, \quad \forall \varphi_h, \psi_h \in \mathcal{V}_h, \quad (12)$$

we consider $0 < \lambda_1^h \leq \lambda_2^h \leq \dots \leq \lambda_{n_h}^h$ the eigenvalues of A_{0h} , with associated normalized eigenvectors $(\phi_j^h)_{j=1, \dots, n_h}$, and we can define

$$\mathcal{C}_h(\eta) = \text{span} \left\{ \phi_j^h \text{ such that } \lambda_j^h \leq \eta \right\}. \quad (13)$$

We also introduce the operator $H_{0h} \in \mathcal{L}(\mathcal{V}_h, \mathcal{Z})$ given by the restriction of H_0 to \mathcal{V}_h , and we define $\mathcal{Z}_h = \text{Im } H_{0h}$. By construction, the adjoint operator H_{0h}^* is in $\mathcal{L}(\mathcal{Z}, \mathcal{V}_h)$.

In order to construct a first-order discrete system, we introduce $\mathcal{X}_h = \mathcal{V}_h \times \mathcal{V}_h$ endowed with the inner product of \mathcal{X} – namely, $\mathcal{D}(A_0^{\frac{1}{2}}) \times \mathcal{H}$ – and we define $A_h \in \mathcal{L}(\mathcal{X}_h)$ and $H_h \in \mathcal{L}(\mathcal{X}_h, \mathcal{Z})$ given by

$$A_h = \begin{pmatrix} 0 & I \\ -A_{0h} & 0 \end{pmatrix}, \quad H_h = (H_{0h} \ 0).$$

In addition we define the combined projector

$$\Pi_h : \mathcal{X} \times \mathcal{H} \rightarrow \mathcal{X}_h, \quad \Pi_h \begin{pmatrix} \varphi \\ \psi \end{pmatrix} = \begin{pmatrix} \tilde{\pi}_h \varphi \\ \pi_h \psi \end{pmatrix}.$$

We can now consider the full discretization of (4) using the following midpoint time discretization

$$\begin{cases} \frac{x_h^{k+1} - x_h^k}{\Delta t} = A_h \frac{x_h^k + x_h^{k+1}}{2}, & k \in \mathbb{N} \\ x_h^0 = \Pi_h x_0 \end{cases} \quad (14)$$

where x_h^k is meant to approximate $x(k\Delta t)$. The numerical analysis of this totally discrete scheme is classical, e.g. using discrete Gronwall inequalities or Duhamel’s formula combined with the conservative property of the discrete operators, and with adequate regularity assumptions leads to estimates of the type

$$\|x_h^n - x(n\Delta t)\|_{\mathcal{X}} \leq C(T)(h^\theta + h^2),$$

where the constant $C(T)$ indicates a dependence – typically linear – on the total simulation time $T = n\Delta t$, namely, this estimate is not bounded with respect to T .

By contrast, the main objective – and result – of the present paper is to show that, *using some available data* on the system (4), we can propose a fully discrete numerical scheme which approximates (4) with an error controlled by the discretization parameters (namely, h and Δt) uniformly over time, i.e. *without any dependence on the total simulation time*.

To that purpose the key idea is to construct a discrete scheme inspired from the so-called observer system defined by

$$\begin{cases} \dot{\hat{x}}(t) = A\hat{x}(t) + H^*(z - H\hat{x}(t)), & t > 0 \\ \hat{x}(0) = \hat{x}_0 \end{cases} \quad (15)$$

Such an observer is designed to “track” the reference system, starting from a different initial condition, and we have the following dynamics for the observation error $\tilde{x} = x - \hat{x}$

$$\begin{cases} \dot{\tilde{x}}(t) = (A - H^*H)\tilde{x}(t), & t > 0 \\ \tilde{x}(0) = x_0 - \hat{x}_0 \end{cases} \quad (16)$$

It is well-known that the exact observability property (3) is equivalent to the asymptotic (exponential) stability of this error system – see e.g. [13, 15] and references therein – hence to the exponential convergence of the observer towards the reference. Noting that $(A - H^*H)$ also represents the governing operator in the dynamics of \hat{x} , we shall then proceed to discretize the observer system in place of the reference system, in essence to benefit from the enhanced stability of $(A - H^*H)$ compared to A . This in fact will lead to discrete error systems with accordingly modified dynamics, albeit non-homogeneous – unlike (16) – due to consistency error terms. In addition, in practice these discrete error systems should also incorporate measurement errors which may influence the accuracy of the proposed method depending on the specific measurement technology considered. Here, we do not want to dwell on the details of measurement error modeling, so we disregard these terms for simplicity, but they are further discussed in Remark 4 below, see also [18] and [5] for probabilistic and deterministic treatments, respectively.

REMARK 1 (STABILIZED DYNAMICS)

With the observation operator applying on the first part of the state variable as assumed in (5), denoting $\hat{x} = \begin{pmatrix} \hat{w} \\ \hat{w}_t \end{pmatrix}$ the first-order dynamics equation can be decomposed into

$$\begin{cases} \dot{\hat{w}} = \hat{w}_t + H_0^*(z - H_0\hat{w}) \\ \dot{\hat{w}}_t + A_0\hat{w}_t = 0 \end{cases}$$

namely, the observer changes the canonical equation relating w and \dot{w} , and likewise for the error equation (16), see [20]. Therefore, while of course in this case “ H^*H ” cannot be used to stabilize a *physical* system, it is perfectly admissible for an *observer* system – synthetic by construction, in the sense that it is always eventually numerically simulated – and leads to original closed-loop dynamics.

However, as discussed in particular in [11] (for a different observation operator) some special care must be exercised in order to preserve the exponential stability of such stabilized dynamics operators, since standard discretizations – in time and space – in general do not retain this property. As this difficulty is due to the (numerical) high frequency poles for which the real part is not adequately controlled, we can handle this as in [11] – see also [26, 23] for similar ideas – by incorporating a small perturbation based on a so-called “viscosity operator” $V_\varepsilon \in \mathcal{L}(\mathcal{X}_h)$, assumed to be self-adjoint and definite negative, and satisfying the additional requirements:

1. Defining the orthogonal projector $\Pi_{1/\varepsilon}$ from \mathcal{X}_h onto $(\mathcal{C}_h(1/\varepsilon))^2$ we have the commuting property

$$\Pi_{1/\varepsilon}V_\varepsilon = V_\varepsilon\Pi_{1/\varepsilon}; \quad (17)$$

2. There exist $c > 0$ and $C > 0$ such that

$$\begin{cases} \sqrt{\varepsilon}\|(-V_\varepsilon)^{\frac{1}{2}}y\|_{\mathcal{X}} \leq C\|y\|_{\mathcal{X}}, & \forall y \in (\mathcal{C}_h(1/\varepsilon))^2 \\ \sqrt{\varepsilon}\|(-V_\varepsilon)^{\frac{1}{2}}y\|_{\mathcal{X}} \geq c\|y\|_{\mathcal{X}}, & \forall y \in (\mathcal{C}_h(1/\varepsilon)^\perp)^2 \end{cases} \quad (18)$$

3. We have the continuity estimate

$$\left\| V_\varepsilon\Pi_h \begin{pmatrix} \varphi \\ \psi \end{pmatrix} \right\|_{\mathcal{X}} \leq C\varepsilon \left(\|\varphi\|_{\mathcal{D}(A_0^{\frac{3}{2}})} + \|\psi\|_{\mathcal{D}(A_0)} \right), \quad \forall (\varphi, \psi) \in \mathcal{D}(A_0^{\frac{3}{2}}) \times \mathcal{D}(A_0). \quad (19)$$

With this viscosity operator and the data collected on the reference system assumed to be in the form

$$z^k = Hx(k\Delta t),$$

we can finally define the following modified discretized system

$$\begin{cases} \frac{\tilde{x}_h^{k+1} - \bar{x}_h^k}{\Delta t} = A_h \frac{\bar{x}_h^k + \tilde{x}_h^{k+1}}{2} + \gamma H_h^* \left(\frac{z^k + z^{k+1}}{2} - H_h \frac{\bar{x}_h^k + \tilde{x}_h^{k+1}}{2} \right) \\ \frac{\bar{x}_h^{k+1} - \tilde{x}_h^{k+1}}{\Delta t} = \varepsilon V_\varepsilon \bar{x}_h^{k+1} \\ \bar{x}_h^0 = \Pi_h x_0, \end{cases} \quad (20)$$

where $\gamma > 0$ is a fixed parameter. As stated in the following theorem, with this discretization scheme we can establish uniform-in-time error estimates, which shows that the above-mentioned objective is achieved.

THEOREM 1

Let $A_0 : \mathcal{D}(A_0) \rightarrow \mathcal{H}$ be a self-adjoint, definite positive operator with compact resolvent and let $H_0 \in \mathcal{L}(\mathcal{D}(A_0^{\frac{1}{2}}), \mathcal{Z})$ be a bounded linear operator such that System (1)-(2) is exactly observable. Let $(\mathcal{V}_h)_{0 < h < h^*}$ be a family of finite dimensional subspaces of $\mathcal{D}(A_0^{\frac{1}{2}})$ such that (6)–(11) hold, and let $\Delta t \in (0, \Delta t^*)$ be the time discretization step. Set $\varepsilon = \max\{\Delta t, h^\theta\}$ and let $V_\varepsilon \in \mathcal{L}(\mathcal{X}_h)$ be a viscosity operator satisfying the properties (17)–(19).

Then, considering the discrete system (20), for an initial condition $x_0 \in \mathcal{D}(A_0^{\frac{3}{2}}) \times \mathcal{D}(A_0)$ there exists a positive constant $C(x_0)$, independent of h , Δt and n , such that

$$\|\bar{x}_h^n - x(n\Delta t)\|_{\mathcal{X}} \leq C(x_0) \max(\varepsilon, \varepsilon^2 h^{-1} \Delta t), \quad \forall n \in \mathbb{N}. \quad (21)$$

Note that one natural – very straightforward for implementation purposes, indeed – example of viscosity operator is given by the following extension of the so-called “Rayleigh damping”,

$$V_\varepsilon = \varepsilon(A_h)^2 = \varepsilon \begin{pmatrix} -A_{0h} & 0 \\ 0 & -A_{0h} \end{pmatrix},$$

which satisfies by construction the requirements (17)–(18) with $c = C = 1$, while showing (19) is also quite straightforward. Therefore, the major difficulty in devising such a discretization scheme consists in ensuring that the observation operator satisfies the observability property (3), see Sections 5 and 6 for examples and corresponding numerical assessments. This being ascertained, the “closed-loop” discretization (20) thus provides a much more effective strategy – for arbitrary simulation times – than the direct discretization approach.

3 Uniform observability of the spatial semi-discrete system

We consider the following spatial semi-discretization of the system (1)

$$\begin{cases} \ddot{w}_h(t) + A_{0h} w_h(t) = 0, & t > 0 \\ w_h(0) = w_{0h}, & \dot{w}_h(0) = w_{1h} \end{cases} \quad (22)$$

with $w_{0h}, w_{1h} \in \mathcal{V}_h$.

The aim of this section is to establish a discrete counterpart of the observability property (3), obtained by extending the result given in [10, Th. 8.1] to the case of operators $H_0 \in \mathcal{L}(\mathcal{D}(A_0^{\frac{1}{2}}), \mathcal{Z})$ using the characterization of observability by resolvent inequalities, see also [15, 17, 22]. Our main result in this respect is stated in the following theorem.

PROPOSITION 2

Let A_0 be a self-adjoint positive definite operator with compact resolvent and $H_0 \in \mathcal{L}(\mathcal{D}(A_0^{\frac{1}{2}}), \mathcal{Z})$. Assume that (6)–(11) are satisfied, and that System (1)–(2) is exactly observable. Then there exist $\eta > 0$, $k^* > 0$, $T^* > 0$ such that any solution of (22) with

$$(w_{0h}, w_{1h}) \in \left(\mathcal{C}_h(\eta/h^\theta)\right)^2 \quad (23)$$

satisfies

$$\int_0^{T^*} \|H_{0h}w_h(t)\|_{\mathcal{Z}}^2 dt \geq k^* \left(\|A_{0h}^{\frac{1}{2}}w_{0h}\|^2 + \|w_{1h}\|^2 \right). \quad (24)$$

We will need the following preliminary results, see also [10].

LEMMA 3

For any $\phi_h \in \mathcal{V}_h$, define $\Phi_h \in \mathcal{D}(A_0)$ such that

$$A_0\Phi_h = A_{0h}\phi_h.$$

Then,

$$\|\phi_h - \Phi_h\| \leq Ch^\theta \|\phi_h\|_{\mathcal{D}(A_0^{\frac{1}{2}})}, \quad (25)$$

$$\|\phi_h - \Phi_h\|_{\mathcal{D}(A_0^{\frac{1}{2}})} \leq Ch^\theta \|A_{0h}\phi_h\|, \quad (26)$$

$$\left| \|A_{0h}^{\frac{1}{2}}\phi_h\|^2 - \|A_0^{\frac{1}{2}}\Phi_h\|^2 \right| \leq \|A_{0h}\phi_h\| \|\phi_h - \Phi_h\|. \quad (27)$$

Proof. By the definition of Φ_h and A_{0h} we have

$$\langle A_0^{\frac{1}{2}}\phi_h, A_0^{\frac{1}{2}}v \rangle = \langle A_0^{\frac{1}{2}}\Phi_h, A_0^{\frac{1}{2}}v \rangle, \quad \forall v \in \mathcal{V}_h,$$

namely, $\phi_h = \tilde{\pi}_h\Phi_h$. Therefore, by (11)

$$\|\phi_h - \Phi_h\|_{\mathcal{D}(A_0^{\frac{1}{2}})} \leq Ch^\theta \|A_0\Phi_h\| = Ch^\theta \|A_{0h}\phi_h\|$$

Moreover,

$$\begin{aligned} \|\Phi_h\|_{\mathcal{D}(A_0^{\frac{1}{2}})} &= \sup_{v \in \mathcal{D}(A_0^{\frac{1}{2}})} \frac{\langle A_0\Phi_h, v \rangle}{\|v\|_{\mathcal{D}(A_0^{\frac{1}{2}})}} = \sup_{v \in \mathcal{D}(A_0^{\frac{1}{2}})} \frac{\langle A_{0h}^{\frac{1}{2}}\phi_h, A_{0h}^{\frac{1}{2}}\pi_h v \rangle}{\|v\|_{\mathcal{D}(A_0^{\frac{1}{2}})}} \\ &\leq \|\phi_h\|_{\mathcal{D}(A_0^{\frac{1}{2}})} \sup_{v \in \mathcal{D}(A_0^{\frac{1}{2}})} \frac{\|\pi_h v\|_{\mathcal{D}(A_0^{\frac{1}{2}})}}{\|v\|_{\mathcal{D}(A_0^{\frac{1}{2}})}} \\ &\leq C \|\phi_h\|_{\mathcal{D}(A_0^{\frac{1}{2}})} \end{aligned}$$

due to (7), and then (25) immediately follows by applying (10) with Φ_h . Next,

$$\|A_{0h}^{\frac{1}{2}}\phi_h\|^2 - \|A_0^{\frac{1}{2}}\Phi_h\|^2 = \langle A_{0h}\phi_h, \phi_h \rangle - \langle A_0\Phi_h, \Phi_h \rangle = \langle A_{0h}\phi_h, \phi_h - \Phi_h \rangle,$$

and we conclude. ■

Proof of Proposition 2. The exact observability of System (1)-(2) is equivalent to the existence of two positive constants m and M such that the following resolvent estimate is satisfied

$$\|A_0^{\frac{1}{2}}\phi\|^2 \leq M^2\|(A_0 - \lambda I)\phi\|^2 + m^2\|H_0\phi\|^2, \quad \forall \phi \in \mathcal{D}(A_0), \quad \forall \lambda > 0, \quad (28)$$

see [10, Th. 8.2]. The idea of the proof is then to show that there exist $\eta > 0$, $m_* > 0$, and $M_* > 0$ such that

$$\|A_{0h}^{\frac{1}{2}}\phi_h\|^2 \leq M_*^2\|(A_{0h} - \lambda I)\phi_h\|^2 + m_*^2\|H_{0h}\phi_h\|_{\mathcal{Z}}^2, \quad \forall \phi_h \in \mathcal{C}_h(\eta/h^\theta), \quad \forall \lambda \in (0, \eta/h^\theta], \quad (29)$$

where $\eta > 0$ is a parameter independent of h and to be specified later. As explained in [10] the observability estimate (24) will then follow.

In order to obtain (29) we adapt the proof of [10, Th. 1.1]. For an arbitrary $\phi_h \in \mathcal{V}_h$, we introduce Φ_h as in the proof of Lemma 3 above, and applying (28) yields

$$\|A_0^{\frac{1}{2}}\Phi_h\|^2 \leq M^2\|(A_0 - \lambda I)\Phi_h\|^2 + m^2\|H_0\Phi_h\|^2, \quad \forall \lambda > 0. \quad (30)$$

We have

$$(A_0 - \lambda I)\Phi_h = (A_{0h} - \lambda I)\phi_h + \lambda(\phi_h - \Phi_h),$$

hence,

$$\|(A_0 - \lambda I)\Phi_h\|^2 \leq 2\|(A_{0h} - \lambda I)\phi_h\|^2 + 2\lambda^2\|\phi_h - \Phi_h\|^2. \quad (31)$$

Also,

$$H_0\Phi_h = H_{0h}\phi_h + H_0(\phi_h - \Phi_h),$$

with

$$\|H_0(\phi_h - \Phi_h)\|_{\mathcal{Z}} \leq \|H_0\|_{\mathcal{L}(\mathcal{D}(A_0^{\frac{1}{2}}), \mathcal{Z})} \|\phi_h - \Phi_h\|_{\mathcal{D}(A_0^{\frac{1}{2}})},$$

which implies

$$\|H_0\Phi_h\|_{\mathcal{Z}}^2 \leq 2\|H_{0h}\phi_h\|_{\mathcal{Z}}^2 + 2\|H_0\|_{\mathcal{L}(\mathcal{D}(A_0^{\frac{1}{2}}), \mathcal{Z})}^2 \|\phi_h - \Phi_h\|_{\mathcal{D}(A_0^{\frac{1}{2}})}^2. \quad (32)$$

Note that, if $\phi_h \in \mathcal{C}_h(\eta/h^\theta)$, we have $\|A_{0h}\phi_h\| \leq \eta^{\frac{1}{2}}h^{-\frac{\theta}{2}}\|A_{0h}^{\frac{1}{2}}\phi_h\|$. With this, gathering now (27), (31) and (32), and recalling (25)-(26), we get for any $\phi_h \in \mathcal{C}_h(\eta/h^\theta)$ and any $\lambda \in (0, \eta/h^\theta]$

$$\begin{cases} \|A_{0h}^{\frac{1}{2}}\phi_h\|^2 \leq \|A_0^{\frac{1}{2}}\Phi_h\|^2 + C\eta^{\frac{1}{2}}h^{\frac{\theta}{2}}\|A_{0h}^{\frac{1}{2}}\phi_h\|^2 \\ \|(A_0 - \lambda I)\Phi_h\|^2 \leq 2\|(A_{0h} - \lambda I)\phi_h\|^2 + C\eta^2\|A_{0h}^{\frac{1}{2}}\phi_h\|^2 \\ \|H_0\Phi_h\|_{\mathcal{Z}}^2 \leq 2\|H_{0h}\phi_h\|_{\mathcal{Z}}^2 + C\eta h^\theta\|A_{0h}^{\frac{1}{2}}\phi_h\|^2 \end{cases} \quad (33)$$

We can substitute these inequalities in (30), which gives with $h \leq 1$

$$(1 - C(\eta^{\frac{1}{2}} + \eta + \eta^2))\|A_{0h}^{\frac{1}{2}}\phi_h\|^2 \leq 2M^2\|(A_{0h} - \lambda I)\phi_h\|^2 + 2m^2\|H_{0h}\phi_h\|_{\mathcal{Z}}^2. \quad (34)$$

Finally, there is no difficulty in setting η – independently of h – so that (29) holds. \blacksquare

REMARK 2 (RESOLVENT CONDITIONS)

In fact, in [10, Th. 8.2] the resolvent inequalities (28) and (29) are stated for λ in the convex hull of the spectrum, but they are also shown to be equivalent to the corresponding inequalities taken for $\lambda > 0$.

4 Numerical analysis of the “closed-loop” discretization scheme

The objective of this section is to establish the error estimate given in Theorem 1. To that end, we will use a stability-consistency approach in which the stability argument is essentially based on the discrete observability property proven in the previous section. Denoting

$$E_h^k = \bar{x}_h^k - \Pi_h x(k\Delta t),$$

the idea of the proof is – indeed – to show that E_h^k satisfies a discrete system with exponentially stable dynamics fed by well-controlled consistency error terms. Introducing also

$$\tilde{E}_h^k = E_h^k - \varepsilon \Delta t V_\varepsilon E_h^k,$$

we have

$$\begin{aligned} \frac{\tilde{E}_h^{k+1} - E_h^k}{\Delta t} &= \frac{E_h^{k+1} - \varepsilon \Delta t V_\varepsilon E_h^{k+1} - E_h^k}{\Delta t} \\ &= \frac{\bar{x}_h^{k+1} - \Pi_h x((k+1)\Delta t) - \varepsilon \Delta t V_\varepsilon (\bar{x}_h^{k+1} - \Pi_h x((k+1)\Delta t)) - \bar{x}_h^k + \Pi_h x(k\Delta t)}{\Delta t} \\ &= \frac{\bar{x}_h^{k+1} - \varepsilon \Delta t V_\varepsilon \bar{x}_h^{k+1} - \bar{x}_h^k}{\Delta t} - \Pi_h \frac{x((k+1)\Delta t) - x(k\Delta t)}{\Delta t} - \varepsilon V_\varepsilon \Pi_h x((k+1)\Delta t) \\ &= \frac{\tilde{\bar{x}}_h^{k+1} - \bar{x}_h^k}{\Delta t} - \Pi_h \frac{\dot{x}(k\Delta t) + \dot{x}((k+1)\Delta t)}{2} + \Delta t O_h^k - \varepsilon V_\varepsilon \Pi_h x((k+1)\Delta t), \end{aligned}$$

where O_h^k is a term coming from the first-order finite difference approximation of $\dot{x}(k\Delta t)$ and remains bounded in \mathcal{X} with respect to h and k , since from semigroup theory it is well-known (see, for instance [21, Theorem 1.3, p. 102]) that $x_0 \in \mathcal{D}(A_0^{\frac{3}{2}}) \times \mathcal{D}(A_0)$ implies

$$x \in C([0, \infty), \mathcal{D}(A_0^{\frac{3}{2}}) \times \mathcal{D}(A_0)) \cap C^1([0, \infty), \mathcal{D}(A_0) \times \mathcal{D}(A_0^{\frac{1}{2}})) \cap C^2([0, \infty), \mathcal{D}(A_0^{\frac{1}{2}}) \times \mathcal{H}),$$

and moreover the conservative nature of the system can be invoked with

$$A^2 x = - \begin{pmatrix} A_0 & 0 \\ 0 & A_0 \end{pmatrix} x = \ddot{x},$$

to show that \ddot{x} is uniformly bounded in $\mathcal{D}(A_0^{\frac{1}{2}}) \times \mathcal{H}$.

Next, from (20) and (4) we obtain

$$\begin{aligned} \frac{\tilde{E}_h^{k+1} - E_h^k}{\Delta t} &= A_h \frac{\bar{x}_h^k + \tilde{\bar{x}}_h^{k+1}}{2} + \gamma H_h^* \left(\frac{z^k + z^{k+1}}{2} - H_h \frac{\bar{x}_h^k + \tilde{\bar{x}}_h^{k+1}}{2} \right) \\ &\quad - \Pi_h A \frac{x(k\Delta t) + x((k+1)\Delta t)}{2} + \Delta t O_h^k - \varepsilon V_\varepsilon \Pi_h x((k+1)\Delta t) \\ &= A_h \frac{E_h^k + \tilde{E}_h^{k+1}}{2} + A_h \frac{\Pi_h x(k\Delta t) + \Pi_h x((k+1)\Delta t) - \varepsilon \Delta t V_\varepsilon \Pi_h x((k+1)\Delta t)}{2} \\ &\quad - \gamma H_h^* H_h \frac{\bar{x}_h^k + \tilde{\bar{x}}_h^{k+1} - \Pi_h x(k\Delta t) - \Pi_h x((k+1)\Delta t)}{2} \\ &\quad + \gamma H_h^* H (I - \Pi_h) \frac{x(k\Delta t) + x((k+1)\Delta t)}{2} \\ &\quad - \Pi_h A \frac{x(k\Delta t) + x((k+1)\Delta t)}{2} + \Delta t O_h^k - \varepsilon V_\varepsilon \Pi_h x((k+1)\Delta t) \end{aligned}$$

Hence,

$$\begin{aligned}
\frac{\widetilde{E}_h^{k+1} - E_h^k}{\Delta t} &= A_h \frac{E_h^k + \widetilde{E}_h^{k+1}}{2} - \gamma H_h^* H_h \frac{E_h^k + \widetilde{E}_h^{k+1}}{2} \\
&\quad + A_h \frac{\Pi_h x(k\Delta t) + \Pi_h x((k+1)\Delta t) - \varepsilon \Delta t V_\varepsilon \Pi_h x((k+1)\Delta t)}{2} \\
&\quad + \varepsilon \gamma \Delta t / 2 H_h^* H_h V_\varepsilon \Pi_h x((k+1)\Delta t) \\
&\quad - \Pi_h A \frac{x(k\Delta t) + x((k+1)\Delta t)}{2} + \Delta t O_h^k - \varepsilon V_\varepsilon \Pi_h x((k+1)\Delta t) \\
&= A_h \frac{E_h^k + \widetilde{E}_h^{k+1}}{2} - H_h^* H_h \frac{E_h^k + \widetilde{E}_h^{k+1}}{2} \\
&\quad + (A_h \Pi_h - \Pi_h A) \frac{x(k\Delta t) + x((k+1)\Delta t)}{2} \\
&\quad + \gamma H_h^* H (I - \Pi_h) \frac{x(k\Delta t) + x((k+1)\Delta t)}{2} \\
&\quad + \left(-\frac{\Delta t}{2} A_h + \frac{\Delta t \gamma}{2} H_h^* H_h - 1 \right) \varepsilon V_\varepsilon \Pi_h x((k+1)\Delta t) + \Delta t O_h^k.
\end{aligned}$$

Let us now analyze the term $A_h \Pi_h - \Pi_h A$, which we will see does not vanish. Indeed, for every $\begin{pmatrix} \varphi \\ \psi \end{pmatrix} \in \mathcal{D}(A_0^{\frac{3}{2}}) \times \mathcal{D}(A_0)$ and $\begin{pmatrix} \varphi_h \\ \psi_h \end{pmatrix} \in \mathcal{X}_h$, we have, on the one hand,

$$\begin{aligned}
\left\langle A_h \Pi_h \begin{pmatrix} \varphi \\ \psi \end{pmatrix}, \begin{pmatrix} \varphi_h \\ \psi_h \end{pmatrix} \right\rangle_{\mathcal{X}} &= \left\langle \begin{pmatrix} \pi_h \psi \\ -A_{0h} \check{\pi}_h \varphi \end{pmatrix}, \begin{pmatrix} \varphi_h \\ \psi_h \end{pmatrix} \right\rangle_{\mathcal{X}} = \langle \pi_h \psi, \varphi_h \rangle_{\mathcal{D}(A_0^{\frac{1}{2}})} - \langle A_{0h} \check{\pi}_h \varphi, \psi_h \rangle \\
&= \langle \pi_h \psi, \varphi_h \rangle_{\mathcal{D}(A_0^{\frac{1}{2}})} - \langle A_0^{\frac{1}{2}} \check{\pi}_h \varphi, A_0^{\frac{1}{2}} \psi_h \rangle \\
&= \langle \pi_h \psi, \varphi_h \rangle_{\mathcal{D}(A_0^{\frac{1}{2}})} - \langle A_0^{\frac{1}{2}} \varphi, A_0^{\frac{1}{2}} \psi_h \rangle.
\end{aligned}$$

On the other hand,

$$\begin{aligned}
\left\langle \Pi_h A \begin{pmatrix} \varphi \\ \psi \end{pmatrix}, \begin{pmatrix} \varphi_h \\ \psi_h \end{pmatrix} \right\rangle_{\mathcal{X}} &= \left\langle \begin{pmatrix} \check{\pi}_h \psi \\ -\pi_h A_0 \varphi \end{pmatrix}, \begin{pmatrix} \varphi_h \\ \psi_h \end{pmatrix} \right\rangle_{\mathcal{X}} = \langle \check{\pi}_h \psi, \varphi_h \rangle_{\mathcal{D}(A_0^{\frac{1}{2}})} - \langle \pi_h A_0 \varphi, \psi_h \rangle \\
&= \langle \psi, \varphi_h \rangle_{\mathcal{D}(A_0^{\frac{1}{2}})} - \langle A_0^{\frac{1}{2}} \varphi, A_0^{\frac{1}{2}} \psi_h \rangle.
\end{aligned}$$

Therefore,

$$\begin{aligned}
\left\| (A_h \Pi_h - \Pi_h A) \begin{pmatrix} \varphi \\ \psi \end{pmatrix} \right\|_{\mathcal{X}} &= \sup_{\substack{(\varphi_h) \in \mathcal{X}_h, \\ \|(\varphi_h)\|_{\mathcal{X}} \leq 1}} \left| \left\langle A_h \Pi_h - \Pi_h A \begin{pmatrix} \varphi \\ \psi \end{pmatrix}, \begin{pmatrix} \varphi_h \\ \psi_h \end{pmatrix} \right\rangle_{\mathcal{X}} \right| \\
&= \sup_{\substack{(\varphi_h) \in \mathcal{X}_h, \\ \|(\varphi_h)\|_{\mathcal{X}} \leq 1}} \left| \langle \pi_h \psi - \psi, \varphi_h \rangle_{\mathcal{D}(A_0^{\frac{1}{2}})} \right| \\
&\leq \|A_0^{\frac{1}{2}}(\pi_h \psi - \psi)\| \\
&\leq C_0 h^\theta \|\psi\|_{\mathcal{D}(A_0)}, \tag{35}
\end{aligned}$$

using (9).

Finally, denoting

$$\begin{aligned} G_h^k &= \left(-\frac{\Delta t}{2} A_h + \frac{\Delta t \gamma}{2} H_h^* H_h - 1 \right) \varepsilon V_\varepsilon \Pi_h x((k+1)\Delta t) + \Delta t O_h^k \\ &\quad + (A_h \Pi_h - \Pi_h A) \frac{x(k\Delta t) + x((k+1)\Delta t)}{2} \\ &\quad + \gamma H_h^* H (I - \Pi_h) \frac{x(k\Delta t) + x((k+1)\Delta t)}{2}, \end{aligned}$$

E_h^k satisfies

$$\begin{cases} \frac{\tilde{E}_h^{k+1} - E_h^k}{\Delta t} = A_h \frac{E_h^k + \tilde{E}_h^{k+1}}{2} - \gamma H_h^* H_h \frac{E_h^k + \tilde{E}_h^{k+1}}{2} + G_h^k \\ \frac{E_h^{k+1} - \tilde{E}_h^{k+1}}{\Delta t} = \varepsilon V_\varepsilon E_h^{k+1} \\ E_h^0 = 0 \end{cases} \quad (36)$$

LEMMA 4

Under the assumptions of Theorem 1, there exists a constant $C > 0$, independent of h and Δt , such that the solution of (36) satisfies

$$\|E_h^n\|_{\mathcal{X}} \leq C \max_{0 \leq k < n} \|G_h^k\|_{\mathcal{X}}, \quad \forall n \in \mathbb{N}^*. \quad (37)$$

Proof. Let F_h^k be the solution of the following discrete *homogeneous* system

$$\begin{cases} \frac{\tilde{F}_h^{k+1} - F_h^k}{\Delta t} = A_h \frac{F_h^k + \tilde{F}_h^{k+1}}{2} - \gamma H_h^* H_h \frac{F_h^k + \tilde{F}_h^{k+1}}{2} \\ \frac{F_h^{k+1} - \tilde{F}_h^{k+1}}{\Delta t} = \varepsilon V_\varepsilon F_h^{k+1} \end{cases} \quad (38)$$

Combining the assumptions of Theorem 1 with the uniform observability result for truncated initial data given by Proposition 2, all the assumptions of Theorem 3.7 in [11] are fulfilled. Therefore, the latter provides two positive constants M_0 and μ_0 such that

$$\|F_h^k\|_{\mathcal{X}} \leq M_0 e^{-\mu_0 k \Delta t} \|F_h^0\|_{\mathcal{X}}. \quad (39)$$

We can easily see that F_h^k can be explicitly computed as

$$F_h^k = \mathcal{Q}_1 \mathcal{Q}_2 F_h^{k-1} = (\mathcal{Q}_1 \mathcal{Q}_2)^k F_h^0, \quad (40)$$

where we denote

$$\mathcal{Q}_1 = (I - \varepsilon \Delta t V_\varepsilon)^{-1} \left[I - \frac{\Delta t}{2} (A_h - \gamma H_h^* H_h) \right]^{-1}, \quad \mathcal{Q}_2 = I + \frac{\Delta t}{2} (A_h - \gamma H_h^* H_h). \quad (41)$$

Since both semigroups generated by $(A_h - H_h^* H_h)$ and by V_ε are contraction semigroups, using e.g. Corollary 2.3.3 in [27] we easily have that $\|\mathcal{Q}_1\|_{\mathcal{L}(\mathcal{X}_h)} \leq 1$. Substituting (40) in (39), we obtain that

$$\|(\mathcal{Q}_1 \mathcal{Q}_2)^k F_h^0\|_{\mathcal{X}} \leq M_0 e^{-\mu_0 k \Delta t} \|F_h^0\|_{\mathcal{X}}, \quad \forall k \in \mathbb{N}^*, \quad F_h^0 \in \mathcal{V}_h. \quad (42)$$

With this notation, the solution of (36) is given by

$$E_h^n = (\mathcal{Q}_1 \mathcal{Q}_2)^n E_h^0 + \Delta t \sum_{i=0}^{n-1} (\mathcal{Q}_1 \mathcal{Q}_2)^i \mathcal{Q}_1 G_h^{n-1-i}. \quad (43)$$

Therefore, taking into account that $\|Q_1\|_{\mathcal{L}(\mathcal{X}_h)} \leq 1$ and combining (36)₃, (42) and (43), we infer

$$\begin{aligned} \|E_h^n\|_{\mathcal{X}} &\leq \Delta t \sum_{i=0}^{n-1} M_0 e^{-\mu_0 i \Delta t} \|G_h^{n-1-i}\|_{\mathcal{X}} \leq M_0 \max_{0 \leq i < n} \{\|G_h^i\|_{\mathcal{X}}\} \Delta t \sum_{i=0}^{n-1} (e^{-\mu_0 \Delta t})^i \\ &\leq M_0 \max_{0 \leq i < n} \{\|G_h^i\|_{\mathcal{X}}\} \frac{\Delta t}{1 - e^{-\mu_0 \Delta t}}. \end{aligned}$$

Since $0 < \Delta t \leq \Delta t^*$, it is elementary to deduce that

$$\|E_h^n\|_{\mathcal{X}} \leq \frac{M_0 \Delta t^*}{1 - e^{-\mu_0 \Delta t^*}} \max_{0 \leq i < n} \{\|G_h^i\|_{\mathcal{X}}\},$$

which completes the proof of the lemma. \blacksquare

From the definition of G_h^k and the bounds (19) and (35), there exists a constant $C_0(x_0)$ such that

$$\|G_h^k\|_{\mathcal{X}} \leq C_0(x_0) \max(\varepsilon, \varepsilon^2 h^{-1} \Delta t), \quad \forall k \in \mathbb{N}. \quad (44)$$

Note in particular that the last term in the right-hand side comes from combining (19) with

$$\left\| A_h \begin{pmatrix} \varphi_h \\ \psi_h \end{pmatrix} \right\|_{\mathcal{X}} = \left\| \begin{pmatrix} \psi_h \\ A_{0h} \varphi_h \end{pmatrix} \right\|_{\mathcal{X}} \leq Ch^{-1} \left\| \begin{pmatrix} \varphi_h \\ \psi_h \end{pmatrix} \right\|_{\mathcal{X}}$$

where we used the inverse inequality (6). Finally, combining (44) and the result of the Lemma 4, we obtain the conclusion of Theorem 1.

REMARK 3 (TIME DISCRETIZATION SHARPNESS)

The error estimate appears to be sub-optimal with respect to time discretization since the mid-point time scheme in itself could be expected to be of second-order. This may be improved by revisiting [11] with a different weight on the viscosity operator.

We emphasize that the case of a measurement operator H applying on the second part of the state variable – namely, on \dot{w} – would be much more straightforward to analyze using [11] and more standard observability inequalities, and would lead to similar error estimates for the discretization. Here, we focused on measurements of w itself primarily because they are often more readily available in practice, and of course time-differentiating such data is frequently very detrimental due to measurement errors. Nevertheless, in some instances measurements on the time derivatives – e.g. velocities – are directly available, in which case the observer approach can be effectively used, see also [18]. Moreover, this clearly extends to separate simultaneous measurements of w and \dot{w} , namely, with observation operators of the type

$$H = \begin{pmatrix} H_0 & 0 \\ 0 & H_1 \end{pmatrix},$$

since the observability properties provided by both sub-parts H_0 and H_1 then concur in the required global observability.

REMARK 4 (MEASUREMENT NOISE)

Measurement errors would typically directly enter the error system (36) as additional terms in G_h^k , hence could be easily included in the above numerical analysis. This holds in particular for errors arising from the measurement time sampling, which in practice is likely to be coarser than the computational time step, and which can be handled by interpolating the measurements at all (computational) time steps, leading to straightforward interpolation errors. This also further illustrates how time-differentiating measurements on w as a substitute for measurements on \dot{w} would enter the error system in the form of amplified measurement errors.

5 Application to the wave equation

Let $\Omega \subset \mathbb{R}^n$ be a bounded open connected set with a Lipschitz boundary $\partial\Omega$ and let $\omega \subset \Omega$ be an open and non-empty subset of Ω . We consider the following wave equation

$$\begin{cases} \ddot{w}(x, t) - \Delta w(x, t) = 0, & (x, t) \in \Omega \times (0, \infty) \\ w(x, t) = 0, & (x, t) \in \partial\Omega \times (0, \infty) \\ w(x, 0) = w_0(x), \quad \dot{w}(x, 0) = w_1(x), & x \in \Omega. \end{cases} \quad (45)$$

The aim of this section is to apply the discretization method proposed in (20) to the wave equation, considering as measured data

$$z(t) = w(\cdot, t)|_\omega, \quad t \geq 0. \quad (46)$$

To that purpose, the careful definition of an observation operator and the choice of the associated \mathcal{Z} -norm are crucial [19], and we follow the original construction of [6] to introduce the operator

$$\mathcal{L}_\omega : H^1(\omega) \rightarrow H_0^1(\Omega), \quad \mathcal{L}_\omega \phi = \psi, \quad (47)$$

such that ψ is the solution of the following elliptic equation

$$\begin{cases} \Delta \psi = 0, & \text{in } \Omega \setminus \omega \\ \psi = 0, & \text{on } \partial\Omega \\ \psi = \phi, & \text{in } \bar{\omega} \end{cases} \quad (48)$$

namely, a harmonic lifting operator. In what follows, we recast the wave equation (45) in the abstract formalism of Section 2.

Denote $\mathcal{H} = L^2(\Omega)$ and let $A_0 : \mathcal{D}(A_0) \rightarrow \mathcal{H}$ be the Dirichlet Laplacian, i.e.,

$$A_0 \varphi = -\Delta \varphi, \quad \mathcal{D}(A_0) = \{\varphi \in H_0^1(\Omega) \mid \Delta \varphi \in L^2(\Omega)\},$$

and $\mathcal{D}(A_0) = H^2(\Omega) \cap H_0^1(\Omega)$ under some regularity assumptions on the domain, e.g. $\partial\Omega$ of class C^2 [12]. Moreover, it is easy to see that $\mathcal{D}(A_0^{\frac{1}{2}}) = H_0^1(\Omega)$. We now define the measurement space $\mathcal{Z} = H^1(\omega)$, equipped with the norm $\|\mathcal{L}_\omega(\cdot)\|_{H_0^1(\Omega)}$, which is equivalent to the usual norm of $H^1(\omega)$ [6]. Therefore, we define the observation operator $H_0 \in \mathcal{L}(\mathcal{D}(A_0^{\frac{1}{2}}), \mathcal{Z})$ by

$$H_0 \varphi = \varphi|_\omega, \quad \forall \varphi \in \mathcal{D}(A_0^{\frac{1}{2}}),$$

which implies $H_0^* = \mathcal{L}_\omega$, since

$$\langle H_0^* \varphi, \zeta \rangle_{H_0^1(\Omega)} = \langle \varphi, H_0 \zeta \rangle_{H^1(\omega)} = \langle \varphi, \zeta|_\omega \rangle_{H^1(\omega)} = \langle \mathcal{L}_\omega \varphi, \mathcal{L}_\omega \zeta|_\omega \rangle_{H_0^1(\Omega)} = \langle \mathcal{L}_\omega \varphi, \zeta \rangle_{H_0^1(\Omega)}.$$

Clearly, with this notation, the equations (45)–(46) fit in the abstract form (1)–(3). Moreover, [6, Prop. 2.2] gives the exact observability of (45)–(46) – in the sense of Definition 1 – under a quite natural condition on the measurement domain, namely, the existence of a strict subset $\tilde{\omega} \subsetneq \omega$ and with $\text{dist}(\Omega \setminus \omega, \tilde{\omega}) > 0$ such that the geometric control condition of Bardos, Lebeau and Rauch [2] holds for $\tilde{\omega}$.

Assume now that (\mathcal{V}_h) is a family of finite-dimensional spaces approximating $\mathcal{D}(A_0^{\frac{1}{2}})$ and such that (6)–(11) are satisfied for a given value of θ , and let A_{0h} and H_{0h} be the corresponding discrete operators. As in Section 2 we also define the operators A and H , with their discrete counterparts A_h and H_h , and we choose as a viscosity operator $V_\varepsilon = \varepsilon A_h^2$ which satisfies the required conditions (17)–(19) as already discussed. Therefore, all the assumptions of Theorem

1 are fulfilled and, considering the numerical scheme given by (20), we have the uniform-in-time error estimate (21).

Of course, we can use spectral decomposition to write closed-form expressions of the solutions of the reference system. Since A_0 is a strictly positive, self-adjoint operator with compact resolvent, it has strictly positive eigenvalues λ_k with $\lambda_k \rightarrow \infty$, and there exists an orthonormal basis formed by the corresponding eigenvectors denoted by ϕ_k . Decomposing the initial data in this basis

$$w_0 = \sum_{m=1}^{\infty} a_m \phi_m, \quad w_1 = \sum_{m=1}^{\infty} b_m \phi_m, \quad \text{with } a_m, b_m \in \mathbb{R}, \quad (49)$$

the solution of (45) is

$$w(x, t) = \sum_{m=1}^{\infty} \left(a_m \cos(\sqrt{\lambda_m} t) + \frac{b_m}{\sqrt{\lambda_m}} \sin(\sqrt{\lambda_m} t) \right) \phi_m(x). \quad (50)$$

In the sequel we consider various examples of one- and two-dimensional wave equations, discretized with usual \mathbb{P}_1 -Lagrange finite elements, which satisfy the conditions (6)–(11) with $\theta = 1$ under standard assumptions for the meshes considered, see e.g. [3, p. 106]). For each initial condition we first compute a reference solution given by:

- either the approximation of the exact solution obtained by truncating the spectral decomposition (50) at a controlled level for which the truncation error is negligible compared to the discretization error (when the eigenvalues and the eigenvectors of A_0 can be explicitly computed);
- or the solution of (20) with $\varepsilon = \gamma = 0$ numerically computed for values of the discretization parameters h and Δt much smaller than for the assessed numerical solutions (when the eigenvalues and the eigenvectors of A_0 cannot be explicitly computed, as is the case for an arbitrary two-dimensional domain).

We then compare the interpolation of this reference solution in $\mathcal{V}_h \times \mathcal{V}_h$ – namely, obtained by computing the nodal values of the reference solution – with the solutions of (20) associated with the following choices of ε and γ :

- $\gamma = 0, \varepsilon = 0$: no measurements, nor numerical viscosity used. This is the standard numerical solution of the wave equation using finite elements in space and a midpoint discretization scheme in time. We refer to the norm of the difference between this solution and the reference solution by the term “*No observer error*”;
- $\gamma > 0, \varepsilon = 0$: measurements are used without numerical viscosity. The norm of the difference between this solution and the reference solution is termed “*Non-viscous observer error*”;
- $\gamma > 0, \varepsilon = \max\{h, \Delta t\}$: both measurements and numerical viscosity are used. The norm of the difference between this solution and the reference solution is called “*Viscous observer error*”.

All the error norms are plotted in relative values, namely, rescaled by dividing by the norm of the initial condition.

5.1 One-dimensional wave equation

Let $\Omega = (0, 1)$ be the spatial domain in which we consider the one dimensional wave equation, and we take $\omega = (0.3, 0.7)$ as the observation interval. The mesh underlying the \mathbb{P}_1 -Lagrange finite element approximation subspace of $\mathcal{D}(A_0^{\frac{1}{2}}) = H_0^1(0, 1)$ is given by a uniform subdivision of the interval $(0, 1)$ formed by N internal points, and we denote $h = 1/(N + 1)$. We choose the time step $\Delta t = h$, hence in the framework of Theorem 1 we have $\varepsilon = h$.

5.1.1 Numerical assessments

We performed some numerical experiments for various choices of initial conditions. In this case, the exact eigenmodes are the Fourier modes, hence we used the truncation of the modal decomposition as the reference solution.

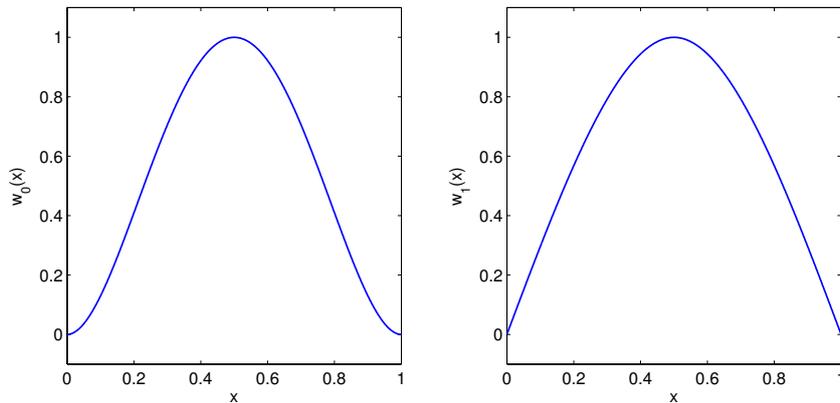


Figure 1: Initial conditions in (51): w_0 (left) and w_1 (right)

Smooth initial data We consider the following initial conditions

$$w_0(x) = 16x^2(1-x)^2, \quad w_1(x) = \begin{cases} 3x - 4x^3, & \text{if } x \in (0, 0.5) \\ 4x^3 - 12x^2 + 9x, & \text{if } x \in (0.5, 1), \end{cases} \quad (51)$$

displayed in Figure 1, and which satisfy the regularity assumptions of Theorem 1. The closed-form computation of the Fourier coefficients gives, $\forall k \in \mathbb{N}^*$,

$$\begin{cases} a_k = \frac{2\sqrt{2}(\pi^2 k^2 - 12)(\cos(\pi k) - 1) - 12\sqrt{2}\pi k \sin(\pi k)}{\pi^5 k^5} \\ b_k = \frac{48\sqrt{2} \sin \frac{\pi k}{2}}{\pi^4 k^4} \end{cases}$$

and we use $M = 1000$ eigenmodes for the representation of the reference solution.

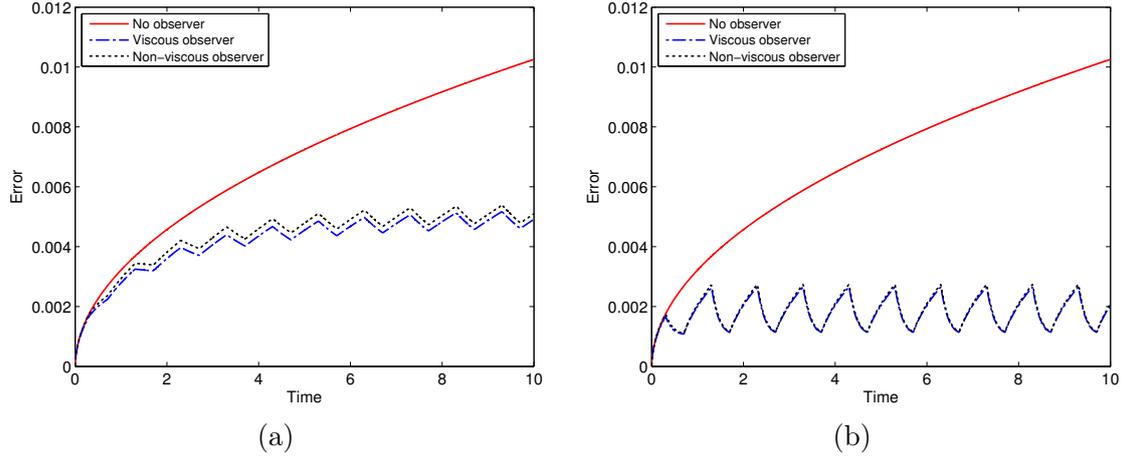


Figure 2: Relative errors obtained for $N = 1000$ and initial conditions (51) – Gain values: (a) $\gamma = 1$; (b) $\gamma = 9$

The relative errors obtained for the observer-based discretization (20) with $N = 1000$ are displayed in Figure 2 for the two gain values $\gamma \in \{1, 9\}$. The numerical behavior observed is consistent with the above analysis, as the error for the viscous observer appears to reach an upper bound in time for the two gain values considered, whereas that of the standard discretization steadily deteriorates. Nevertheless, it is interesting to note that a very similar dramatic improvement is obtained with the observer-based discretization without added numerical viscosity. This will be further discussed in Section 5.1.2.

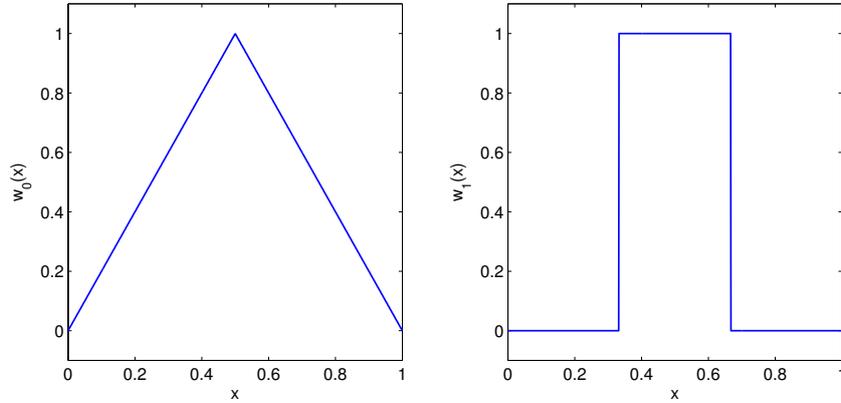


Figure 3: Initial conditions in (52): w_0 (left) and w_1 (right)

H_0^1 **initial displacement - discontinuous initial velocity** We consider initial conditions defined by

$$w_0(x) = 1 - |2x - 1|, \quad w_1(x) = \begin{cases} 1, & \text{if } x \in \left(\frac{1}{3}, \frac{2}{3}\right) \\ 0, & \text{if not,} \end{cases} \quad (52)$$

and plotted in Figure 3, which gives the following Fourier coefficients

$$\begin{cases} a_k = \frac{4\sqrt{2} \sin \frac{\pi k}{2} - 2\sqrt{2} \sin(\pi k)}{\pi^2 k^2} \\ b_k = \frac{\cos \frac{\pi k}{3} - \cos \frac{2\pi k}{3}}{\pi k} \end{cases}$$

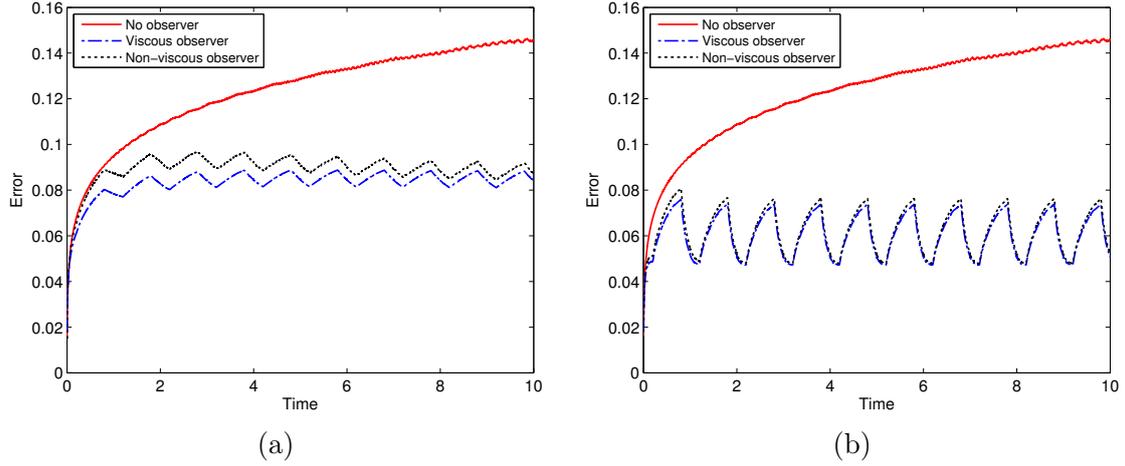


Figure 4: Relative errors obtained for $N = 1000$ and initial conditions (52) – Gain values: (a) $\gamma = 1$; (b) $\gamma = 9$

The corresponding relative errors are displayed in Figure 4. In this case the initial conditions do not fulfill the regularity assumptions of Theorem 1, and as a matter of fact all the computed errors are significantly larger than in the previous case. Nevertheless, all the other observations made for the results obtained with the smooth initial conditions also hold here.

5.1.2 Pole locus analysis

The location of the poles of the “closed-loop” operator $A - H^*H$ provides some valuable insight into the stability of the associated dynamical system, although of course the decay rate – in case

of exponential stability – is only *bounded* by the opposite of the spectral abscissa (itself defined as the supremum of the real parts of the spectrum) for general infinite-dimensional systems [8]. Note, however, that in some instances a complete stability analysis may be performed by analyzing the eigenpairs, see e.g. [7]. Nevertheless, here we can compute the spectrum for the related discrete operators of interest, in which case the decay rate is *exactly* given by the opposite of the spectral abscissa. Hence, we will compute the eigenvalues (generically denoted by $(\lambda_h^k)_k$) of the following operators:

- $A_h \in \mathcal{L}(\mathcal{X}_h)$ which is the operator governing the discrete conservative system (22);
- $A_h - \gamma H_h^* H_h$ which governs the dynamics of a semi-discrete observer system without added viscosity;
- $A_h - \gamma H_h^* H_h + \varepsilon V_\varepsilon$ which governs the semi-discrete observer system with added viscosity, namely, the “theoretical” semi-discrete system associated with our proposed fully discrete scheme (20).

Moreover, since we are still more directly concerned with the fully discrete schemes themselves, we will compute the eigenvalues (generically denoted by $(\lambda_{h,\Delta t}^k)_k$) of the following corresponding operators:

- $(I - \frac{\Delta t}{2} A_h)^{-1} (I + \frac{\Delta t}{2} A_h)$;
- $(I - \frac{\Delta t}{2} A_h + \gamma \frac{\Delta t}{2} H_h^* H_h)^{-1} (I + \frac{\Delta t}{2} A_h - \gamma \frac{\Delta t}{2} H_h^* H_h)$;
- $(I - \frac{\Delta t}{2} A_h + \gamma \frac{\Delta t}{2} H_h^* H_h - \Delta t \varepsilon V_\varepsilon + \frac{\Delta t^2}{2} \varepsilon A_h V_\varepsilon + \gamma \frac{\Delta t^2}{2} \varepsilon H_h^* H_h V_\varepsilon)^{-1} (I + \frac{\Delta t}{2} A_h - \gamma \frac{\Delta t}{2} H_h^* H_h)$.

In the totally discrete case we will represent the post-processed values given by $\frac{\log(\lambda_{h,\Delta t}^k)}{\Delta t}$ to allow a direct comparison with the eigenvalues of the corresponding semi-discrete operators.

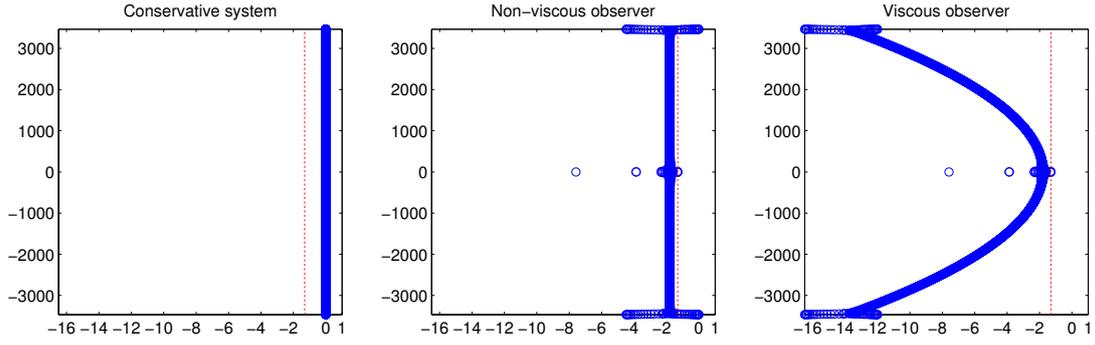


Figure 5: Eigenvalues for space semi-discrete systems

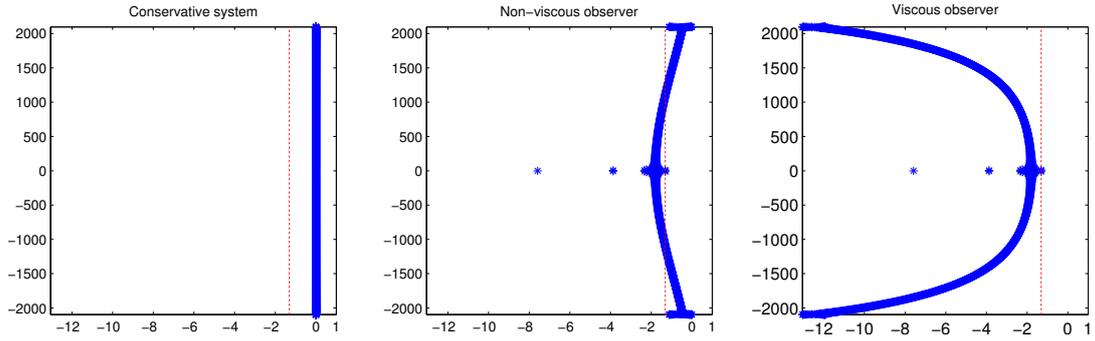


Figure 6: Post-processed eigenvalues for fully discrete systems

We display in Figures 5 and 6 the pole loci of the semi-discrete and fully discrete operators, respectively. For both figures we considered $N = 1000$ discretization points, $\omega = (0.3, 0.7)$ and $\gamma = 9$. We observe similar trends in both cases, namely,

- the closed-loop observer term $-\gamma H_h^* H_h$ provides some damping by itself; however, this is not uniform for all eigenvalues, and some high-frequency poles have “vanishing” real parts;

- this difficulty is effectively tackled by the added viscosity operator, which ensures uniform damping.

This in fact provides an interpretation of the limited effect of the added numerical viscosity in our above numerical assessments, as the modal components corresponding to the weakly-damped high-frequency poles are likely to be very small due to the relative regularity of the initial conditions.

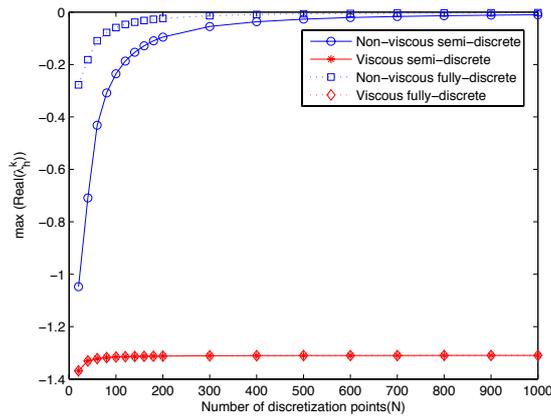


Figure 7: Maximum of $\text{Re}(\lambda_k^h)$ (semi-discrete) and $\text{Re} \log(\lambda_{h,\Delta t}^k)/\Delta t$ (fully discrete) when varying N - Gain value $\gamma = 9$

It is also interesting to analyze the variations of these eigenvalues with respect to various parameters. To that effect we first investigate in Figure 7 the impact of the spatial discretization parameter by displaying the spectral abscissa as a function of the subdivision number N . We observe that without viscosity operator this indicator deteriorates for both semi-discrete and totally discrete cases when refining the discretization, as expected from Figures 5 and 6. By contrast, a very uniform behavior is obtained when numerical viscosity is present.

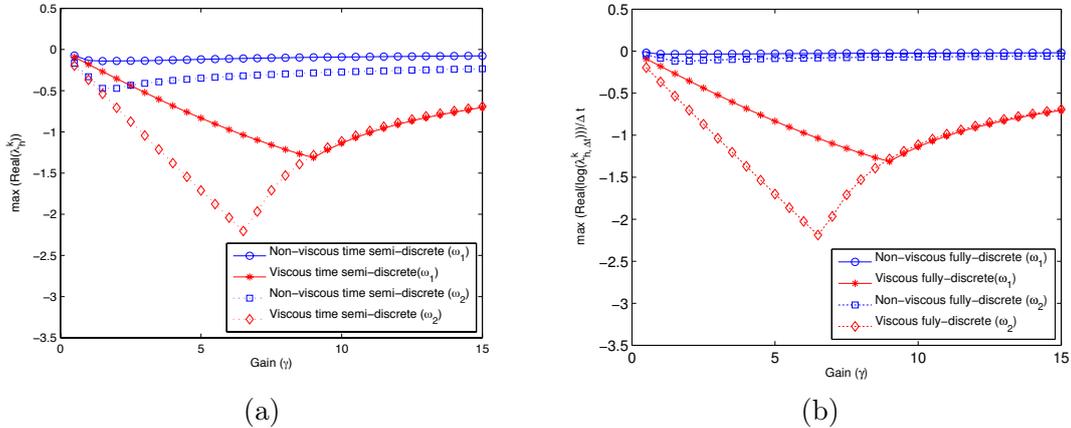


Figure 8: Effect of gain parameter and observation set: (a) Max. of $\text{Re}(\lambda_k^h)$ – (b) Max. of $\text{Re} \log(\lambda_{h,\Delta t}^k)/\Delta t$

Finally, we study the issue of the γ gain parameter adjustment for a given observation set. In Figure 8 we plot the spectral abscissa for varying values of γ and for two observation sets $\omega_1 = (0.3, 0.7)$ and $\omega_2 = (0.1, 0.8)$. As expected, the optimal spectral abscissa is improved for a larger observation range. Moreover, the value $\gamma = 1$ is clearly too small to provide effective damping whereas $\gamma = 9$ is close to the optimal value for ω_1 , and this explains the differences observed for these two values in Figures 2 and 4. Nevertheless, while optimal gain parameter values can be identified for each observation set, in the presence of numerical viscosity the system is effectively stabilized for a wide range of gain values. This behavior – together with the already mentioned stability with respect to the discretization parameter – allows to easily calibrate the gain parameter to achieve best performance.

5.2 Two-dimensional wave equation in a square

Let $\Omega = (0, 1)^2$ be the unit square, for which we can easily compute the eigenfunctions of the Laplacian, namely, the tensor products of the above Fourier modes

$$\phi_{kl} = \sin(k\pi x) \sin(l\pi y), \quad k, l \in \mathbb{N}^*.$$

An interesting feature of this domain is that – unlike in the 1D case and more “arbitrary” 2D shapes – we can devise a measurement set that does not satisfy the *geometric control condition* of [2]. In particular, in addition to

$$\omega_1 = \left\{ (0, 1) \times \left(\left(0, \frac{1}{10}\right) \cup \left(\frac{9}{10}, 1\right) \right) \right\} \cup \left\{ \left(\left(0, \frac{1}{10}\right) \cup \left(\frac{9}{10}, 1\right) \right) \times (0, 1) \right\},$$

which fulfills the condition, we will consider

$$\omega_2 = \left(0, \frac{1}{10}\right) \times (0, 1),$$

which does not.

The triangular meshes are obtained by subdividing the domain into $(N-1)^2$ square elements, and splitting each resulting square into two triangles, hence we have a uniform element diameter $h = 1/(N-1)$. We again take $\Delta t = h$, hence $\varepsilon = h$. In practice, in our numerical assessments we will take $N = 50$, compute the reference solution using 50^2 analytically computed eigenmodes, and set the observer gain to $\gamma = 6$ based on a preliminary calibration performed with the poles.

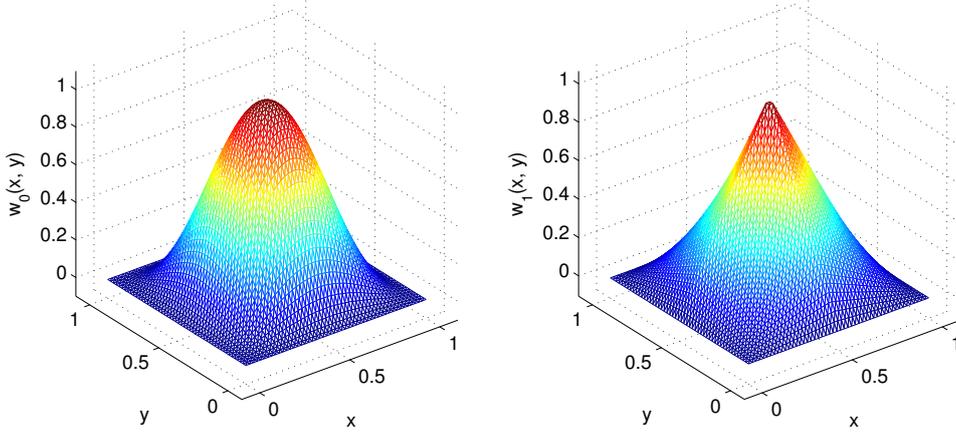


Figure 9: Initial conditions in (53)

Smooth initial displacement - H_0^1 initial velocity We first consider the initial conditions given by

$$w_0(x, y) = 256 x^2(1-x)^2 y^2(1-y)^2, \quad w_1(x, y) = (1 - |2x - 1|)(1 - |2y - 1|), \quad (53)$$

see Figure 9, with associated modal coefficients

$$\begin{cases} a_{kl} = \frac{32\sqrt{2}((\pi^2(k^2+l^2)-12)(\cos(\pi\sqrt{k^2+l^2})-1)-12\pi\sqrt{k^2+l^2}\sin(\pi\sqrt{k^2+l^2}))}{\pi^5(k^5+l^5)}, \\ b_{kl} = 4\sqrt{2} \frac{2\sin\frac{\pi\sqrt{k^2+l^2}}{2} - \sin(\pi\sqrt{k^2+l^2})}{\pi\sqrt{k^2+l^2}}, \end{cases}$$

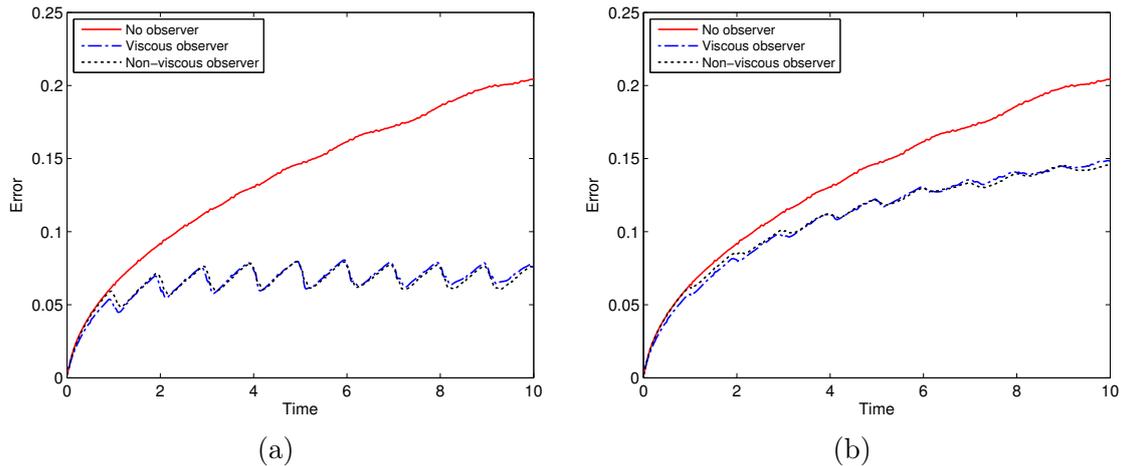


Figure 10: Relative errors corresponding to initial conditions (53) for measurement sets $\omega = \omega_1$ (a) and $\omega = \omega_2$ (b)

The errors obtained in this case are plotted in Figure 10. When the measurement domain satisfies the observability condition the resulting behavior is very similar to the 1D case. By contrast, without the observability condition the errors associated with observer discretizations do not appear to be bounded in time, albeit still grow more slowly than for the standard discretization.

$H_0^1(\Omega)$ initial displacement - discontinuous velocity We then consider the less regular initial conditions

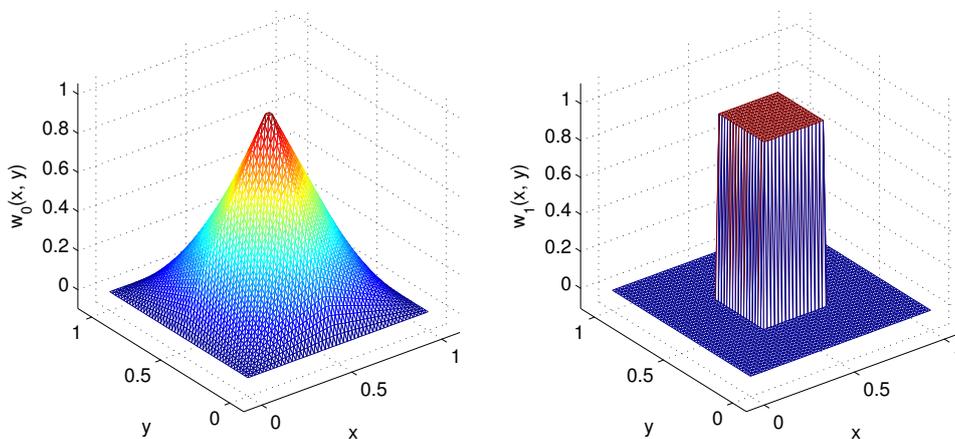


Figure 11: Initial conditions in (54)

$$w_0(x, y) = (1 - |2x - 1|)(1 - |2y - 1|), \quad w_1(x, y) = \chi_{(\frac{1}{3}, \frac{2}{3})^2}(x, y), \quad (54)$$

where $\chi_{\mathcal{O}}$ denotes the characteristic function of the set $\mathcal{O} \subset \Omega$, see Figure 11. The corresponding modal coefficients are

$$\begin{cases} a_{kl} = 4\sqrt{2} \frac{2\sin\frac{\pi\sqrt{k^2+l^2}}{2} - \sin(\pi\sqrt{k^2+l^2})}{\pi\sqrt{k^2+l^2}} \\ b_{kl} = \sqrt{2} \frac{\cos\frac{\pi\sqrt{k^2+l^2}}{3} - \cos\frac{2\pi\sqrt{k^2+l^2}}{3}}{\pi\sqrt{k^2+l^2}} \end{cases}$$

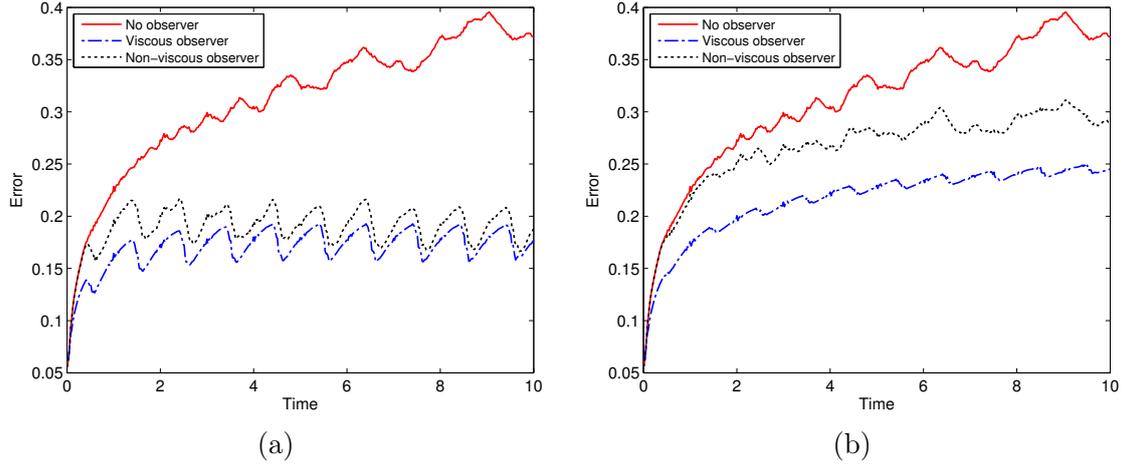


Figure 12: Relative errors corresponding to initial conditions (54) for measurement sets $\omega = \omega_1$ (a) and $\omega = \omega_2$ (b)

In the resulting errors plotted in Figure 12, the main differences with the previous smoother case is that the error values are larger – as expected – and the performance of the viscous observer is now more clearly distinguished. A natural interpretation of this fact is that high-frequency poles are much more present here due to the reduced regularity in the initial condition.

5.3 Two-dimensional wave equation in an arbitrary domain

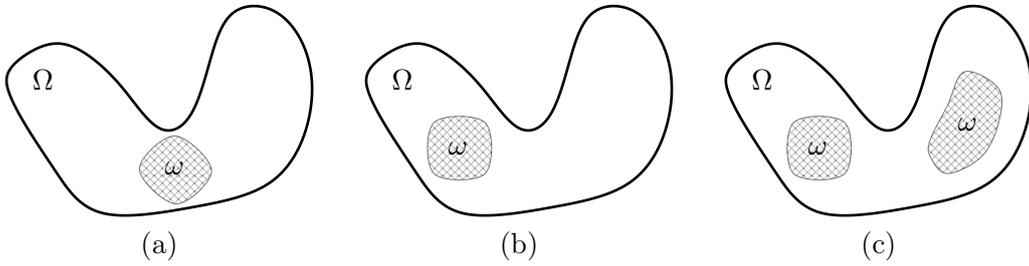


Figure 13: Domain and observation sets for two-dimensional wave equation

In this section we demonstrate some applications of our proposed method to the two-dimensional wave equation in a spatial domain of more general shape, see Figure 13.

Of course, unlike in the previous cases here we cannot compute the eigenfunctions or the eigenvalues of the operator A_0 analytically, and therefore we need to resort to approximate reference solutions. To that purpose we will consider two categories of meshes for the domain Ω : target computational meshes for which we want to assess our numerical strategy, and substantially more refined meshes to compute the numerical reference solution. In order to have conformity of the meshes between the measurement subset and the rest of the domain, we thus define one pair of triangular meshes for each ω considered, see Table 1 listing the number of nodes in Ω in each case corresponding to Figure 13.

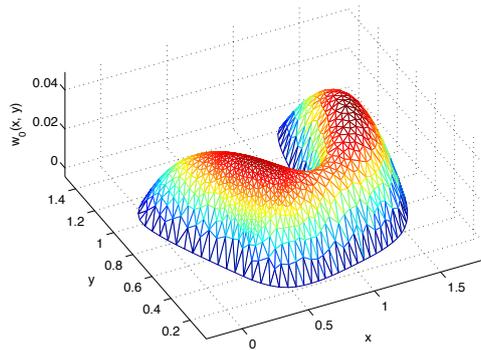


Figure 14: Initial displacement for the wave equation

We consider the initial displacement displayed in Figure 14 – given by a static response to a uniform surface-distributed loading – and zero initial velocity. The time step is $\Delta t = 0.01$, and based on a spectral calibration we choose $\gamma = 3$. The numerical errors – in relative norm values – with respect to the reference solutions computed with the refined meshes are shown in

Figure 15, for each observation set displayed in Figure 13. It is very interesting to correlate the measured accuracy with the “degree of observability” associated with each case, as here while observability always holds in the strict sense the observability constant can be expected to vary. In case (a) the measurement set is rather limited in extent, but centrally located, and indeed the observer then performs slightly better than in case (b). Then, when incorporating an additional measurement patch in case (c) we obtain a dramatically improved accuracy, in what can be naturally interpreted as a configuration of rather high observability. In this last case we have a simulation error consistent with what would be the interpolation error for the type of – rather coarse, see Figure 14 – mesh considered, albeit *stable over time*.

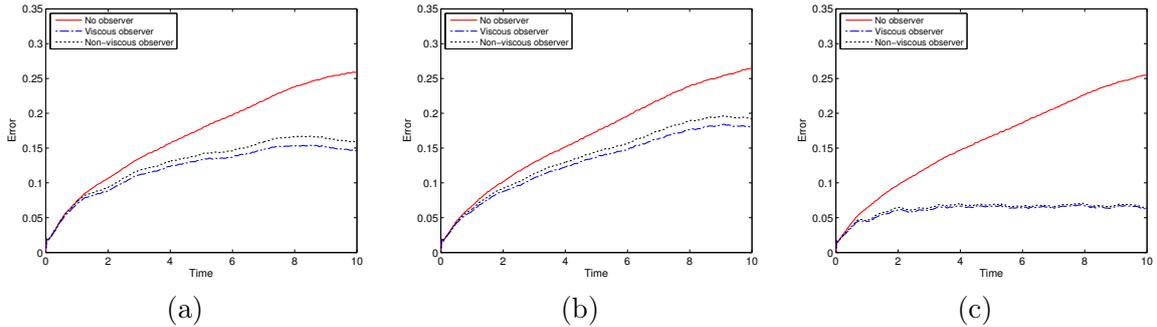


Figure 15: Error between the reference solution and the solution computed on the low resolution mesh, for each observation set displayed in Fig. 13.

6 Application to beam and plate models

In this section we now adapt the method developed in this paper to the case where the governing operator A_0 is fourth-order in space. More specifically, let $\Omega \subset \mathbb{R}^n$ be an open and non-empty set with Lipschitz boundary and consider the following equations

$$\begin{cases} \dot{w}(t, x) + \Delta^2 w(t, x) = 0, & (t, x) \in (0, T) \times \Omega \\ w(t, x) = \Delta w(t, x) = 0, & (t, x) \in (0, T) \times \partial\Omega \\ w(0, x) = w_0(x), \quad \dot{w}(0, x) = w_1(x), & x \in \Omega. \end{cases} \quad (55)$$

This model covers the cases of the Euler-Navier-Bernoulli beam model in dimension 1, and of the Kirchhoff-Love plate model in dimension 2, both for so-called simply-supported boundary conditions, and in these cases w represents the deflection of the structure, see e.g. [4].

6.1 Mathematical setting

We denote $\mathcal{H} = L^2(\Omega)$, and $A_0 : \mathcal{D}(A_0) \rightarrow \mathcal{H}$ is defined by

$$\mathcal{D}(A_0) = \{\varphi \in H^4(\Omega) \mid \varphi = \Delta\varphi = 0 \text{ on } \partial\Omega\}, \quad A_0\varphi = \Delta^2\varphi \text{ for all } \varphi \in \mathcal{D}(A_0).$$

It is easy to verify that A_0 is a self-adjoint positive definite operator with compact resolvent, and $A_0^{\frac{1}{2}} : \mathcal{D}(A_0^{\frac{1}{2}}) \rightarrow \mathcal{H}$ is given by

$$\mathcal{D}(A_0^{\frac{1}{2}}) = H^2(\Omega) \cap H_0^1(\Omega), \quad A_0^{\frac{1}{2}}\varphi = -\Delta\varphi \text{ for all } \varphi \in \mathcal{D}(A_0^{\frac{1}{2}}).$$

Accordingly, with measurements given by

$$z(t) = w(\cdot, t)|_{\omega}; \quad t \geq 0 \quad (56)$$

we need to select a lifting operator \mathcal{L}_ω compatible with the required regularities, hence we define $\mathcal{L}_\omega : \mathcal{Z} = H^2(\omega) \rightarrow \mathcal{D}(A_0^{\frac{1}{2}}) = H^2(\Omega) \times H_0^1(\Omega)$ by $\mathcal{L}_\omega \phi = \psi$ with

$$\begin{cases} \Delta^2 \psi = 0, & \text{in } \Omega \setminus \omega \\ \psi = \Delta \psi = 0, & \text{on } \partial\Omega \\ \frac{\partial \psi}{\partial n} = \frac{\partial \phi}{\partial n}, & \text{on } \partial\omega \setminus \partial\Omega \\ \psi = \phi, & \text{in } \bar{\omega} \end{cases} \quad (57)$$

We equip $\mathcal{Z} = H^2(\omega)$ with the inner product

$$\langle \phi, \psi \rangle_{H_\omega^2} = \langle \Delta \mathcal{L}_\omega \phi, \Delta \mathcal{L}_\omega \psi \rangle_{L^2(\Omega)}, \quad \phi, \psi \in H^2(\omega), \quad (58)$$

and it is quite straightforward to see that the associated norm is equivalent to the usual norm of $H^2(\omega)$, under the standard regularity assumptions on the domain boundary. Let now $H_0 \in \mathcal{L}(\mathcal{D}(A_0^{\frac{1}{2}}), \mathcal{Z})$ be the observation operator defined according to (56), namely,

$$H_0 \phi = \phi|_\omega. \quad (59)$$

It is easy to check that $H_0^* \in \mathcal{L}(\mathcal{Z}, \mathcal{D}(A_0^{\frac{1}{2}}))$ is nothing else than \mathcal{L}_ω .

In this case, we can also prove an observability inequality in the form (3), see Proposition 5 in Appendix. Therefore we can consider the discretization scheme (20) and Theorem 1 applies.

6.2 Beam equation and numerical assessment

We now particularize System (55) to the one-dimensional setting, namely, corresponding to the beam model. We thus consider

$$\begin{cases} \ddot{w}(t, x) + w_{,xxxx}(t, x) = 0, & (t, x) \in (0, T) \times (0, 1) \\ w(t, 0) = w_{,xx}(t, 0) = 0, & t \in (0, T) \\ w(t, 1) = w_{,xx}(t, 1) = 0, & t \in (0, T) \\ w(0, x) = w_0(x), \quad \dot{w}(0, x) = w_1(x), & x \in (0, 1) \end{cases} \quad (60)$$

with a finite element discretization obtained with \mathbb{P}_3 -Hermite elements in a uniform subdivision of the interval $(0, 1)$ formed by N internal points, and we denote $h = 1/(N + 1)$. The corresponding projectors π_h and $\tilde{\pi}_h$ then satisfy all the required assumptions (6)–(11) with $\theta = 2$, see e.g. [25, p. 144]. For the time discretization we take $\Delta t = 2h^2$, and $\varepsilon = \max\{h^2, \Delta t\}$ in the numerical viscosity.

In our numerical assessment we set $N = 100$, $\omega = (0.3, 0.7)$ and we consider the initial condition $\begin{pmatrix} w_0 \\ w_1 \end{pmatrix} \in \mathcal{D}(A_0^{\frac{3}{2}}) \times \mathcal{D}(A_0)$ given by

$$w_0(x) = \alpha x^7(1-x)^5, \quad w_1(x) = 0, \quad x \in (0, 1), \quad (61)$$

where α is a scaling constant such that $\|w_0\|_{\mathcal{D}(A_0^{\frac{1}{2}})} = 1$. Here again, the exact eigenmodes are the Fourier modes and we can compute the modal coefficients for the above initial conditions to provide a reference solution of arbitrary accuracy, given here for completeness, viz.

$$\begin{aligned} a_k = & -120\alpha \frac{42\pi^6 k^6 - 280\pi^4 k^4 + 15120\pi^2 k^2 - 95040}{\pi^{13} k^{13}} \cos(\pi k) \\ & -120\alpha \frac{\pi^7 k^7 - 882\pi^5 k^5 + 105840\pi^3 k^3 - 2328480k\pi}{\pi^{13} k^{13}} \sin(k\pi) \\ & + 1680\alpha \frac{\pi^4 k^4 - 180\pi^2 k^2 + 2376}{\pi^{13} k^{13}} \sqrt{2}. \end{aligned}$$

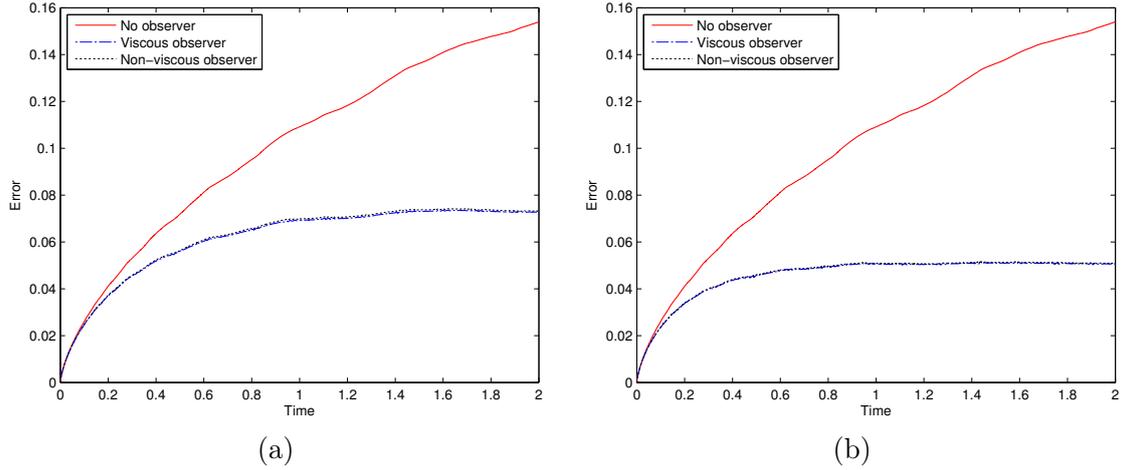


Figure 16: Relative errors for beam equation with $N = 100$ and initial condition (61) – Gain values: (a) $\gamma = 5$; (b) $\gamma = 10$.

The assessment results are shown in Figure 16. Here again, the effectiveness of our approach is fully confirmed in the numerical results, while the very limited effect of numerical viscosity can be attributed to the regularity of the initial condition.

Appendix: An observability inequality for the space-wise fourth-order equation

Let $\tilde{\omega} \subset \Omega$ be an open and non-empty subset of Ω . It is well-known that if $\tilde{\omega}$ satisfies the geometric control condition of [2] the following observability inequality holds for the solution of (55),

$$\int_0^{\tilde{T}} \int_{\tilde{\omega}} |\dot{w}(t, x)|^2 dx dt \geq k_T (\|w_0\|_{\mathcal{D}(A_0^{\frac{1}{2}})}^2 + \|w_1\|_{\mathcal{H}}^2), \quad (62)$$

for any $\tilde{T} > 0$, see e.g. [14]. The aim of this appendix is to prove an alternative observability inequality for our observation operator H_0 in (59).

PROPOSITION 5

Assume that $\tilde{\omega} \subset \Omega$ and $\tilde{T} > 0$ are such that the inequality (62) holds. Then, for every open set $\omega \in \Omega$ with $\tilde{\omega} \subsetneq \omega$ and $\text{dist}(\Omega \setminus \omega, \tilde{\omega}) > 0$ and for every $T > \tilde{T}$ the following observability inequality holds

$$\int_0^T \|w(t, \cdot)\|_{H^2(\omega)}^2 dt \geq k_T^2 (\|w_0\|_{\mathcal{D}(A_0^{\frac{1}{2}})}^2 + \|w_1\|_H^2). \quad (63)$$

Proof. The proof is quite similar to that performed in [6, Prop. 2.2] for the wave equation, hence we only outline the main steps for completeness. Let $\psi \in C_c^\infty(\bar{\Omega})$ be a smooth function with values between 0 and 1 and such that

$$\psi(x) = \begin{cases} 0, & x \in \Omega \setminus \omega \\ 1, & x \in \tilde{\omega} \end{cases}$$

and $\phi(t) = t^2(\tilde{T} - t)^2$. Multiplying the first equation in (55) by $\psi\phi w$ and integrating by parts,

we obtain

$$\begin{aligned}
0 &= \int_0^{\tilde{T}} \int_{\omega} \phi \psi (\ddot{w} + \Delta^2 w) w \, dx \, dt = \int_0^{\tilde{T}} \int_{\omega} \ddot{\phi} \psi \frac{|w|^2}{2} \, dx \, dt - \int_0^{\tilde{T}} \int_{\omega} \phi \psi |\dot{w}|^2 \, dx \, dt \\
&\quad + \int_0^{\tilde{T}} \int_{\partial\omega} \phi \psi w \frac{\partial}{\partial n} (\Delta w) \, d\sigma(x) \, dt - \int_0^{\tilde{T}} \int_{\omega} \phi \nabla(\psi w) \cdot \nabla(\Delta w) \, dx \, dt. \quad (64)
\end{aligned}$$

The third term in the right-hand side vanishes because $\psi|_{\partial\omega} = 0$. Performing some further manipulations on the last term we obtain

$$\begin{aligned}
& - \int_0^{\tilde{T}} \int_{\omega} \phi \nabla(\psi w) \cdot \nabla(\Delta w) \, dx \, dt \\
&= \int_0^{\tilde{T}} \int_{\omega} \phi \Delta(\psi w) \Delta w \, dx \, dt - \int_0^{\tilde{T}} \int_{\partial\omega} \phi \frac{\partial}{\partial n} (\psi w) \Delta w \, d\sigma(x) \, dt \\
&= \int_0^{\tilde{T}} \int_{\omega} (\phi \Delta \psi) w \Delta w \, dx \, dt + \int_0^{\tilde{T}} \int_{\omega} \phi \psi |\Delta w|^2 \, dx \, dt + \int_0^{\tilde{T}} \int_{\omega} 2\phi (\nabla \psi \cdot \nabla w) \Delta w \, dx \, dt.
\end{aligned}$$

Substituting into (64) we get

$$\begin{aligned}
\int_0^{\tilde{T}} \int_{\omega} \phi \psi |\dot{w}|^2 \, dx \, dt &= \int_0^{\tilde{T}} \int_{\omega} \phi \psi |\Delta w|^2 \, dx \, dt + \int_0^{\tilde{T}} \int_{\omega} \ddot{\phi} \psi \frac{|w|^2}{2} \, dx \, dt \\
&\quad + \int_0^{\tilde{T}} \int_{\omega} (\phi \Delta \psi) w \Delta w \, dx \, dt + \int_0^{\tilde{T}} \int_{\omega} 2\phi (\nabla \psi \cdot \nabla w) \Delta w \, dx \, dt
\end{aligned}$$

Since all the derivatives of w appearing in the right-hand side are only up to second-order, and given the positiveness of the cutoff functions ϕ and ψ , we infer that for any $\varepsilon > 0$ we have

$$C_{\varepsilon} \int_{\varepsilon}^{\tilde{T}-\varepsilon} \int_{\tilde{\omega}} |\dot{w}(t, x)|^2 \, dx \, dt \leq \int_0^{\tilde{T}} \|w(t, \cdot)\|_{H^2(\omega)}^2 \, dt, \quad (65)$$

and we conclude the proof like in [6] by time-shifting the solution of (55). ■
